2BHK houses ready for allocation to beneficiaries

Mahbubnagar: District Collector B Vijayendira Boi conducted an inspection of the newly constructed double bedroom housing colony at Maulali Gutta in Mahbubnagar town on Monday. The colony, which has 672 double bedroom houses, is part of a major housing initiative aimed at providing guality living spaces for the residents. The District Collector reviewed the 28 blocks of G+2 structures, which were built by the Engineering Department of the Housing Department. Each block consists of 24 houses, with eight double bedrooms per floor. The construction project was divided into two phases, with 588 houses completed in the first phase and an additional 84 in the second, totaling 672 houses. During the inspection, the District Collector was briefed by the Executive Engineer of the Housing Construction Department, Bhaskar, and AE Vijay Kumar. They provided detailed information on the construction progress and the allocation of houses. Of the 672 houses, 588 have been allocated to beneficiaries, with handover procedures pending. Housing Construction Executive Engineer Vidyam Bhaskar also apprised the Collector that proposals amounting to Rs. 7.8527 crore have been submitted to the government for the sanctioning of essential infrastructure facilities in the colony. This includes Rs. 69.30 for setting up poles, power lines, and a transformer for electricity supply, Rs. 1.7618 crore for the supply of drinking water, Rs. 53.69 lakh for sewerage systems, and Rs. 4.8610 crore for internal roads. The district Collector instructed the officials to immediately expedite all the pending works of the double bed room houses and ensure that they are completed on time. These inspections by the collector are also regarded as significant as there are many allegations that under earlier BRS government rule there were many misappropriations and violations of rules were observed by certain district officials in the allocation of double bedroom houses to ineligible persons.



Prime Minister Narendra Modi, during his visit to Varanasi on Tuesday will release the 17th installment of the PM-KISAN scheme, in which more than 9.26 crore farmers will receive the benefits amounting to over Rs 20,000 crore. The Prime Minister will also distribute the certificates to more than 30,000 self-help groups trained as Krishi Sakhis to work as para extension workers. The event is being organised by the Union Ministry of Agriculture and Farmers Welfare in coordination with the Uttar Pradesh government.After assuming office for the third term, PM Modi authorised the release of the 17th installment of the PM Kisan Nidhi, which aims to benefit 9.3 crore farmers and distribute around Rs 20,000 crore.

PM-KISAN scheme was launched in 2019, to supplement the financial needs of all land-holding farmers subject to certain exclusion criteria of higher income status. Till

now over Rs 3.04 lakh crores has been disbursed to more than 11 crore farmers across the nation and with this release, the total amount transferred to the beneficiaries since the inception of the scheme will cross well over Rs 3.24 lakh crores.Union Agriculture Minister Shivraj Singh Chouhan said that around 2.5 crore farmers will join the event across the country. Additionally, 732 Krishi Vigyan Kendras (KVKs), over 1 lakh Primary Agricultural Cooperative Societies, and 5 lakh Common Service Centres (CSCs) from across the country will also participate in the event to raise awareness among farmers. Several Union Ministers will also be visiting 50 KVKs to interact with farmers and raise awareness about the various schemes of the Department. They will also distribute certificates to the trained Krishi Sakhis of the area, he added.Later, in the day around 7 pm, PM Modi will also witness the Ganga Aarti at Dashashwamedh Ghat. 'Even if there is 0.001% negligence, it should be dealt with': Supreme Court tells NTA over NEET row



New Delhi, GNS News Agency, June 18,

The Supreme Court on Tuesday said even if there was "0.001 per cent negligence" on the part of anyone in the conduct of the NEET-UG 2024 examination, it should be thoroughly dealt with. Observing that students have to labour hard while preparing for these examinations, the apex court said the litigation pertaining to the National Eligibility-cum-Entrance Test (Undergraduate)-2024 examination ought not be treated as adversarial."Even if there is 0.001 per cent negligence on the part of anyone, it should be thoroughly dealt with," a vacation bench of Justices Vikram Nath and SVN Bhatti told the advocates appearing for the Centre and the National Testing Agency (NTA).

counsel.Stressing on timely action by the authority, the top court said the pleas would come up for hearing on July 8 along with other pending petitions, including those which have sought a direction to conduct the exam afresh.It said the NTA and the Centre would file their responses on these fresh petitions within two weeks.When one of the advocates appearing for some petitioners raised the issue pertaining to a question asked in the exam, the bench said, "They (NTA and Centre) will respond to it"."Let us understand the purpose of your submissions. In these matters, we are prepared to sit up to evening," it observed.

While hearing separate petitions raising grievances over the NEET-UG 2024, the apex court had last week sought responses from the Centre and the NTA on a plea for a Central Bureau of Investigation (CBI) probe into allegations of question paper leak and other irregularities in the exam. The Centre and the NTA had on June 13 told the top court that they had cancelled the grace marks given to 1,563 candidates who took the examination for admission to MBBS and other such courses. They will have the option to either take a retest or forgo the compensatory marks awarded to them for the loss of time, the Centre had said. The examination was held on May 5 oss 4,750 centres and around 24 lakh candida it. The results were expected to be declared on June 14 but were announced on June 4, apparently because the evaluation of the answer sheets got completed earlier. There have been allegations of guestion paper leaks in states like Bihar and other irregularities in the prestigious exam. The allegations have led to protests in several cities and filing of petitions in several high courts as also the Supreme Court. Scores of students protested in Delhi on June 10 seeking a probe into alleged irregularities. As many as 67 students scored a perfect 720, unprecedented in the NTA's history, with six from a centre in Haryana's Faridabad figuring in the list, raising suspicions about irregularities. It has been alleged that grace marks contributed to 67 students sharing the top rank. The NEET-UG examination is conducted by the NTA for admissions to MBBS, BDS, AYUSH and other related courses in government and private institutions across the country

More than 200 stranded tourists evacuated from Sikkim's Lachung

Gangtok: More than 200 tourists have been evacuated while around 1,000 are still stranded in Lachung in Sikkim's landslide-hit Mangan district, a senior police officer said on Tuesday. The tourists were evacuated via Chungthang and taken to Mangan town from where the vehicles have been arranged by the Transport department to take them to Gangtok, Superintendent of Police (SP) Sonam Detchu Bhutia said. Around 150 stranded tourists were evacuated on Tuesday while 64 were evacuated on Monday from North Sikkim's Lachung and moved to Mangan town, officials said. The district administration along with Border Roads Organisation (BRO), State Disaster Response Force (SDRF), National Disaster Response Force (NDRF) and other volunteers are taking the stranded tourists to safer grounds, he said.More tourists are likely to be evacuated and moved to safer places as the day progresses, he said. The district administration had to set up log bridges over the slides to facilitate movement by foot and by vehicles where roads were motorable, they said.

The Kerala High Court on Tuesday sought response of Chief Minister Pinarayi Vijayan on Congress MLA Mathew Kuzhalnadan's plea for a probe against the CM over the alleged financial transactions between his daughter's now defunct IT firm and a private mining

company.Besides the CM, Justice K Babu also issued notice to Vijayan's daughter, her defunct firm and the mining company, seeking their stand on the MLA's revision petition.Kuzhalnadan moved the high court after a vigilance court rejected his plea for an investigation against Vijayan over the alleged financial transactions between the private mining company and the IT firm of his daughter, T Veena. The vigilance court had said that necessary facts constituting corruption were absent in the plea.Kuzhalnadan had initially approached the Special Vigilance Court here, saying the Vigilance Department refused to probe the financial transactions between Cochin Minerals and Rutile Ltd (CMRL) and Veena's company, Exalogic.Later, he changed his stance and sought a court-monitored probe into the alleged financial transactions."Even if the facts stated in the complaint are accepted on face value, they do not constitute the offence alleged. Of course, there are allegations of corruption which have sprouted from certain suspicions and doubts entertained by the complainant. But allegations of such doubts and suspicions are not factual allegations constituting the offence," the vigilance court had observed. The Congress has been targeting the chief minister, his daughter, and the CPI(M) after a Malayalam daily reported that the CMRL had paid a total of Rs 1.72 crore to the CM's daughter between 2017 and 2020. The report cited the ruling of an interim board for settlement and said that CMRL previously had an agreement with Veena's IT firm for consulting and software support services. It was also alleged that though no service was rendered by her firm, the amount was paid on a monthly basis "due to her relationship with a prominent person."

Based on those complaints, the Bengal Police filed 107 FIRs.While 92 complaints had no merit, preliminary investigations by the police in 114 plaints revealed that no offense had been committed, the report stated.As per the report, 88 complaints were repetitions of the plaints made earlier, while 18 complaints had no connection with post-poll violence. In case of three complaints, the sender was anonymous. The remaining 138 complaints are in the preliminary investigation stage and in those cases necessary legal steps will be taken after the initial probe is completed, the report stated.

After Verdict 2024, Modi 3.0 will struggle to survive: Rahul Gandhi's big claim

Congress MP Rahul Gandhi has described the outcome of the 2024 Lok Sabha elections as a "tectonic shift" in Indian politics, claiming that the Modi government will struggle to survive after failing to secure a majority.In an interview with the UK's Financial Times, Gandhi said, "The space in the Indian political system has been blown open. A tectonic shift has taken place in Indian politics. The numbers are such that they are very fragile, and the smallest disturbance can drop the government.

In the 2024 Lok Sabha polls, the opposition INDIA bloc beat expectations by winning 234 of 543 seats, powered by strong showing in the bellwether state of Uttar Pradesh. Congress also delivered its best performance in 15 years by bagging 99 seats. The BJP-led National Democratic Alliance won 293 seats and secured a third term, but the saffron party, with 240 seats, failed to get the magic number.Gandhi claimed there was "great discontent" within Prime Minister Narendra Modi's camp and hinted at possible defections. "There are people who are in touch with us from within it," he stated, without going into specifics. "Basically, one ally has to turn the other way," he added.

The Gandhi scion characterised the 2024 election results as a mandate against the BJP's divisive politics. "The idea that you can spread hatred, you can spread anger and you can reap benefits of that - the Indian people have rejected it in this election," he said.During the campaign, PM Modi referred to the Muslim community as "infiltrators" and alleged that a Congress-led government would give away employment and quotas set aside for the marginalised. The INDIA bloc, however, won votes among Dalits by playing on fears that the BJP would use a bigger majority to amend the constitution and deprive them of benefits.

This year, the crisis is slowly nching back toward the dreaded 2018 levels. Rationng has been announced. Water will be supplied after a ap of two days. Residents of some localities, mainly on the periphery, claim they are getting supply after hree or four days. Much like in Delhi, the alarm bells are ringing

An expert analysis of the 2018 crisis focused on he man-made factors. In the popular narrative, however, a repeat is being played out six years down the ine. The prolonged dry spell is being blamed for the eduction in the water level at all sources of supply chemes. Several are on the verge of drying up due to excessive heat and less snowfall during the winter seaon. Any hope of relief has been pinned on a spell of ainfall. In short, since nature did us in, nature will bail is out. We pretend that none of it is our doing: neither limate change, nor man-made folly like reckless concretisation or the encroachment of catchment areas. So unabashedly self-destructive are our ways.

(File Image)Delhi High Court calls for meeting among stakeholders after students file plea over lack of facilities at Faculty of Law. The Delhi High Court has called for a meeting of various stakeholders after a few Delhi University students filed a plea alleging that the Faculty of Law lacked purified drinking water, air conditioning, Wi-Fi and other infrastructure facilities.A single-judge bench of Justice Amit Sharma, which also appointed advocate Rajesh Mishra as an amicus curiae in the matter, said in its order on Wednesday, "Keeping in view the issues raised in the present petition, it is imperative that a meeting be convened amongst all the stakeholders, i.e., Dean Student's Welfare, Delhi University, Dean Faculty of Law, Petitioner No. 2 (Ankur Singh Mavi) and the Learned amicus curiae appointed by this Court with regard to assessing the facilities provided to the students with regard to the water coolers/provision for purified drinking water as well as the other infrastructural facilities including the availability of Wi-Fi services."During the hearing on Wednesday, the university's counsel submitted, "on instructions", that the necessary provisions with regard to water cooler or drinking water are "in existence". The high court said the meeting would be convened with the mutual convenience of the parties within one week from Wednesday and that the university's counsel should coordinate with the stakeholders. The court also called for a report to be placed before it before the date of next hearing, July 4. The court also impleaded the Bar Council of India and the dean of student's welfare as parties to the matter. In their plea, Ronak Khatri, Ankur Singh Mavi and Umesh Kumar, all students at the Faculty of Law, claim that the "deplorable condition of the faculty infrastructure" has severely affected their ability to pursue education. The law faculty has three colleges under it-Campus Law Centre (where Khatri and Mavi are enrolled), Law Centre-1, Law Centre-2 (where Kumar is enrolled). There are four buildings in the faculty on the university's north campus. "The lack of air conditioning in classrooms has created unbearable conditions, especially during peak summer months when temperatures in Delhi can reach up to 48°C. The classrooms in Building 1 have no air conditioners installed whatsoever whereas building 2, and 3 are not equipped with functional air conditioning, making it extremely difficult for students to focus and study. This situation is contrasted by the presence of multiple air conditioners in administrative offices and staff rooms, indicating a significant disparity in the allocation of resources," the plea submits. The plea adds that there is an "acute shortage of drinking water" in the law faculty, having "upwards of 5,000 students", as it is equipped with only "four water coolers". "The quality of available water is poor, characterized by high total dissolved solids and a strong chlorine taste, leading to health problems among students," the plea states. On the other hand, the plea states, the college administration daily orders "20-litre water bottles for the administrative staff, Dean's office, PIC office, staff room and other administrative areas". The plea further submits that the washrooms in the faculty are not maintained well and are insufficient-"building 1, building 2 and building 3 have eight washrooms (4 for girls, 4 for boys)". The plea states that though Wi-Fi is available in buildings 1 and 2, its signal strength is "exceptionally weak and the connection speeds are abysmally slow'

Foremost priority should be human life: Gujarat CM **Bhupendra Patel while referring to Rajkot fire tragedy**

Referring to the recent Rajkot TRP game zone fire accident that claimed 27 lives, Gujarat Chief Minister Bhupendra Patel on Thursday asked officers and elected office bearers of urban local bodies (ULBs) to give top priority to human life."The pursuit of development will be of no use if the very people for whom it is being done are not being taken care of," the CM added.

The CM said this while addressing an official function of the Urban Development Department at the Mahatma Mandir in Gandhinagar to distribute cheques worth Rs 2,111 crore to various municipal corporations and municipalities in the state for developmental works. Top officials and elected office bearers of the ULBs were present on the occasion.Referring to the Rajkot game zone fire tragedy, the CM said, "We think that despite

doing so much development, we commit some mistakes. Why do they (such mistakes) happen?""Our foremost priority should be the life of a human being. There cannot be any compromise on it whether it is at the level of officers or (elected) office-bearers," he added.

The state government on Wednesday published the draft rules for the regulation of game zones and amusement parks while inviting people's suggestions/objections to them.Referring to the draft rules, Patel said, "We have framed the SOPs for the game zones. We have put them in the public domain as well. Let us ask the public if they want anything to be added; then we can add... So that, no such accident is repeated. All of us should be careful about that."Emphasising the need to maintain quality in developmental works, the CM also suggested that the ULBs sit for two days in a year to monitor and discuss the quality of works being executed.

CM Patel said that what the media show should not be viewed as criticism of the government."They are not criticising us. By showing our small mistakes, they let us know that these issues need to be addressed," he said.In this regard, he referred to a media report showing a government office with stains of tobacco spitting. "They (me-dia) show it because we are doing it."The CM, in this context, also said that he has suggested that during office hours, officers, office bearers, and even the public should be restricted from consuming tobacco.

Change in eligibility criteria for overseas education scholarship worries students

Maharashtra government provides scholarships to meritorious students coming from marginalised sections of society for their higher education plans abroad.Maharashtra government provides scholarships to meritorious students coming from marginalised sections of society for their higher education plans abroad. The Maharashtra government has changed the the eligibility criteria to apply for the overseas education scholarship.As per the recently declared advertisement inviting applications for the scholarship given to students coming from OBC and SC category, applicants need to have scored 75 per cent and above in graduation as opposed to 60 per cent mark, which was the cut-off till last year.

This last-minute change, according to students, is going to hamper higher education plans of many of them. Eknath Wagh, son of a small-scale farmer from Buldhana district who secured admission to prestigious Harvard University for MA in Education Policy and Analysis, said that the new change in poliy has made him ineligible to apply for the scholarship.A first-generation learner from his family, Eknath had scored 71 per cent in his Bachelor of Arts (BA) from Fergusson College in Pune.He said, "The gold medallist from my batch had scored 76 per cent. This is proof that in the Arts stream 71 per cent is a good score. Even Harvard University, which takes approval as per international standards, has accepted it."

Eknath highlighted that eligibility criteria for similar scholarship by the central government too prescribes a 60 per cent score.Students complain that they came to know of this change only when the advertisement inviting applications from OBC students was out on June 5.As per the revised criteria, whether a candidate is seeking the scholarship to pursue post-graduation or PhD, he/ she needs to have scored 75 per cent and above in graduation and post-graduation, respectively.Maharashtra gov-



higher education plans abroad.Students from SC, ST, OBC, Maratha and EWS category can avail the facility. As of now, advertisements inviting applications from SC and OBC students are out with the changed eligibility criteria.But students believe that eligibility criteria for others will also be changed as per this. Raju Kendre, founder of Eklavya Global Scholars Program where aspiring students from marginalised communities, especially from interiors of Maharashtra are mentored for higher education opportunities in India as well as abroad, said, "If someone is already admitted to top-tier universities, criteria like this still gatekeep opportunities for students from marginalised communities. This reflects the elite-centric, meritocratic approach of the Indian education system. It shows how our policies are ultimately not centered on serving the marginalized sections."Kendre said that more than 30 students from Eklavya Global Scholars Program have already received offers from many global universities in the top QS 100 ranking. But due to this last -minute change in eligibility criteria, they are all now stressed. "Many global opportunities increase their stipends yearly to match inflation. But recently, the state and the central governments have slashed the fund amount by putting a

Gurgaon man barges into former wife's house, tries to kill her and children

The police on Monday arrested a man from a house in a Gurgaon village where he had barged into, with an intention to kill his divorced wife and their two children. The police have recovered a shroud, backpack, pistol with a loaded magazine, and dagger from the accused, identified as Chatrasal Tomar. The woman who lives with her children in Bhimgarh Khedi village, Gurgaon, told the police that she divorced Tomar in 2019 due to his improper behaviour and frequent threats to her life. She also mentioned that her husband had previously attempted to kill her in 2018, and the incident was reported at Sector-9 police station.

"Around 8.45 pm on Monday, her husband suddenly kicked the door and entered the house, attacking her and threatening to kill her and their two children. Their son managed to hold him from behind, while their daughter grabbed his other hand, in which he had a sharp weapon. They overpowered him and immediately called the police. Upon checking his bag, the police found a pistol magazine, sharp knife, and a cutter. The police arrived and arrested him," said ASI Sandeep of Gurgaon police station.On interrogation, Chatrasal Tomar, a resident of Laxman Vihar Phase-II, Gurgaon, failed to produce any documents regarding the permit licence for the pistol.Police said that after the couple's separation, Chatrasal Tomar, out of resentment, had planned to kill his divorced wife and children as well. Prior to the incident, he had carried a shroud, sharp weapon, a dagger, and a packet of red chilli powder.Based on the complaint, a case was registered at Sector-5 police station under sections 307, 452 Indian Penal Code (IPC) and sections 25, 54 and 59 of Arms Act.Police said that Tomar is an accused in another case of attempt to murder under section 302, 34 of the IPC and section 27 of Arms Act, registered on May 29, 2023, at a police station in Bihar, which is pending trial.

The original deadline for starting the operations from Civil Court to Swargate was March 31, but it was extended due to the Lok Sabha elections in 2024.

The start of the underground service would mean completing Phase 1 of the project from Pimpri-Chinchwad Municipal Corporation (PCMC) to Swargate and Vanaz to Ramwadi. The Vanaz to Ramwadi route is fully operational, while the PCMC to Civil Court route is partly functional, except for the underground stretch. Sonawane said



Pune Metro had begun work on extending the route from PCMC to Nigdi as part of phase I. The Centre's decision regarding the extension of the route from Swargate to Katraj was still pending. Additionally, the proposal for the second phase of Pune Metro was submitted to the Maharashtra government for approval. Once approved, he said it would be forwarded to the Centre.

Supreme Court asks Delhi to approach Yamuna board amid water shortage after Himachal U-turn on surplus water

With the Himachal Pradesh government retracting its statement on availability of surplus water, the Supreme Court Thursday directed the Delhi government to approach the Upper Yamuna River Board (UYRB) for water supply.A vacation bench of Justices Prashant Kumar Mishra and Prasanna B Varale directed the Delhi government to submit its application for the supply of water on "humanitarain grounds" to the Board by 5 pm today (June 13), if not already submitted."We are of the view that the issue concerning sharing of water between states already signatory to an agreement is complex and sensitive and this court does not have the expertise to decide the formula," the court said. It asked the UYRB to convene a meeting tomorrow (June 14) and take a decision on the matter at the earliest. "If need be, the Board can convene the basis on day to day basis," the court said. The court noted the Himachal Pradesh government's submissions that its earlier statement on the availability of 137 cusecs of water was "not correct" and that they be "permitted to withdraw the statement".

"In view of the statement made by the Advocate General (AG) of Himachal Pradesh, the very basis of our interim order of June 6 does not survive, and we have reached square one to the stage where we were pleased before," the court said. On June 6, the court had directed the Himachal Pradesh government to release on 137 cusecs of surplus water available with it to resolve the drinking water crisis in Delhi, and Haryana to facilitate its smooth flow into the national capital.Amid the ongoing heatwave, the Delhi government had filed a plea before the Supreme Court, stating that the high temperatures had caused an excessive surge in water demand, further leading to an extraordinary shortage in the National Capital Territory (NCT). Water Minister Atishi has alleged that the Haryana government was stopping the flow of water to Delhi

'Trapped' by fake travel agents, dozen Punjab youths 'stranded' in Armenia send video SOS

punajb youth trapped in armeniaWhen the video (inset) was brought to the attention of MP Balbir Singh Seechewal, he promptly wrote a letter to the Ministry of External Affairs, seeking action. Over a dozen youths from Punjab are apparently stranded in Armenia after falling prey to deceptive travel agents promising greener pastures to them in Europe, if a video circulating on social media is anything to go by.

In the footage, these stranded youths are seen making fervent appeals for help, revealing the ordeal they've endured at the hands of unscrupulous travel agents.Speaking in Punjabi, one of the youths in the video recounts their ordeal, stating they were deceived and trapped on false promise of work opportunities abroad by fake travel agents."We have been kept in Armavir jail and are threatened with prison sentences of three to six years. We were coerced into signing documents we couldn't even comprehend, as we are unfamiliar with the language. We are also not getting proper food in this Asian country. We are around 10-15 youths."The youth, however, could not give the details of their whereabouts in India in the brief video clip that has gone viral.



When this video was brought to the attention of MF Balbir Singh Seechewal, he promptly wrote a letter to the Ministry of External Affairs and the Indian Embassy there (Armenia), urging swift identification of and assistance for these stranded youths. Also, he shared the clip on his social media platforms, appealing to the public to help locate the families of these youths."These fake travel agents are preying on the dreams and vulnerabilities of our youth," Seechewal said, urging the government to crack down on such exploitative practices to prevent such incidents in future

How Thane police got juvenile accused of Gujarat businessman's murder back from Nepal

In May last year, a 65-year-old businessman from Gujarat visited Thane for work. Hours after he checked into a hotel near Thane railway station, he was found murdered in his room. It took the police 10 days to catch the accused, a juvenile, but not before the trail led them to Bengaluru, Uttar Pradesh and Nepal. The murder took place on the afternoon of May 27, 2023. Businessman Karabhai Rambhai Suva checked into a hotel in Thane after arriving from Rajkot in Gujarat. Needing some money, Suva handed over his debit card to a housekeeping staff at the hotel and asked him to withdraw Rs 16,000 for him, the police said.

"Suva had come to Thane for some business. We assume he was feeling lazy to go down and withdraw cash so he handed over his debit card to the staffer and gave him his PIN," a police official said. While withdrawing the money, the staffer allegedly saw the balance amount in Suva's bank account and decided to kill him and run away with his cash and debit card, the police said. The staffer went to a nearby shop, bought a sharp object, went to Suva's room and stabbed him to death, according to the police. The incident came to light around 6.30 pm and the hotel staffers informed the local Thane Nagar police station. A case of murder and robbery was registered.

During the investigation, the police checked the CCTV footage at the hotel and learnt that one of the housekeeping staff was repeatedly entering Suva's room."When

we started looking for him, the hotel staffers told us he left the hotel abruptly in the afternoon, saying that he was going back to his native place as his mother was unwell," a police official said. "He had escaped with the senior citizen's mobile phone, ATM card and Rs 16,000 that he had withdrawn," he added. The police decided to track Suva's bank transactions and his mobile phone."When we went through the staffer's records, we learnt that he hailed from Kaptanganj in Uttar Pradesh. While we were getting ready to leave for his native place, a withdrawal of Rs 80,000 was made from Suva's bank account in Ratnagiri," a police official said.

Suspecting that the hotel staffer was headed to South India, the police checked to see if he had any friends there. Subsequently, a police team went to Bengaluru but the accused's friends could not give any clues about his location. The investigation team then realised that the accused had bought a new SIM card and inserted it into Suva's mobile phone. They started tracking his location. "We learnt that he was in Uttar Pradesh so we went there and enquired with all his friends and relatives. It was confirmed that he was there the night before," an official said. The police team then learnt that the accused had gone to Nepal along with his grandfather to stay with his relative. Through their informers in Uttar Pradesh, the police team comprising Assistant Police Inspector Sachin Barate got in touch with a few locals in Nepal and the relative with whom the accused was allegedly staying."We took the relative into confidence and told him that the accused was wanted in a murder case after which the relative called the boy's grandfather and refused to provide him shelter," said Barate. The police team were then informed that the accused and his grandfather were returning to Uttar Pradesh. "Our informers were providing us live updates. After waiting for over 26 hours at the border, at around 8 pm on June 6, 2023, the accused was spotted crossing the border and getting into a vehicle," an officer said. The Thane Nagar police followed the vehicle and apprehended him. The accused was then produced before a local court in Gorakhpur and brought to Mumbai on transit remand. Though the accused had claimed that he was 20 years old while seeking employment at the hotel, he produced an Aadhaar card in court to show that he was only 17.

'Breakdown of potential marriage does not amount to cheating': Karnataka HC quashes rape cases filed by woman against fiance

The Karnataka High Court on June 7 quashed a rape case filed by a woman against her fiance, observing that the breakdown of a potential marriage did not amount to cheating. The man and his family members had approached the court to quash a case filed against them on charges of rape and cheating, among others

In this case, a United States resident posted his profile on a matrimonial website and got to know a woman. They and their families later met and had an engagement ceremony on January 11, 2023. The woman also asked him to invest Rs 4 lakh in a fund which he did. The man returned to the US the next day. Seven months later, a complaint was filed alleging that on noticing that the house was empty on the engagement date, he had forced her to engage in sexual intercourse on the pretext of their upcoming marriage. The man's counsel argued that the alleged rape was highly improbable as the family members had not left the house that day. They also argued that the woman was demanding money over the seven months after the engagement, following which the wedding was called off, doubting her bonafide. The woman's counsel, on the other hand, argued, apart from this aspect, the date of the wedding had been fixed and invitations printed.

The Gujarat Anti Corruption Bureau (ACB) on Wednesday booked Captain Ajay Chauhan, former chief executive officer of Gujarat State Aviation Infrastructure Company Limited (GUJSAIL) and former director of Civil Aviation, along with two others, under the Anti Corruption Act. The ACB said they allegedly "misused powers" and caused a loss of around Rs 72 lakh to the government treasury.Chauhan, GUJSAIL accountant Alpesh Prajapati, and Alpesh Tripathi, a director of Kasmc Aviation, were booked in an FIR lodged at the Ahmedabad city ACB police station on Wednesday. The chief security officer and general manager of GUJSAIL filed an official complaint with the ACB after receiving a go-ahead from the state government. The development comes after a preliminary inquiry report of the ACB was submitted to the state government. GUJSAIL is a public sector company of the Gujarat government.

Deputy Superintendent of Police (ACB) G V Padheriya said the period of the alleged corruption was between 2017 and 2023. Padheriya said, "GUJSAIL is a company that is supposed to manage and operate stateowned aircraft for the movement of VVIPs... Ajay Chauhan, who worked as a Captain in GUJSAIL, was under the scanner after the government ordered a primary inquiry by the ACB into his conduct. The primary investigation has revealed that Chauhan misused his power and used the government aircraft to fly his family and for other private uses. We also came across other corruption committed by Chauhan during his tenure."

Speaking to The Indian Express, Padheriya said, "One of the major misdeeds was that Chauhan used the government aircraft to ferry his family and for personal use, making payments for the fuel and ground handling charges from the government treasury... Moreover, he could not have offered any flying service as an employee of GUJSAIL, but despite drawing a government salary, he offered private flying services to Aryan Aviation Private Limited and received Rs 47.52 lakh in his accounts. He also embezzled funds in connivance with Prajapati and Tripathi by awarding an outsourcing contract for manpower to Tripathi's firm without a contract. He received Rs 10 lakh in his account from Tripathi's firm."A senior police officer said Chauhan had used the government aircraft for personal use and to ferry his family from Mumbai to Ahmedabad at least once. The officer also told this newspaper that Chauhan is facing an investigation for disproportionate assets.

Angry with wife, Hyderabad man climbs high-tension electricity tower



Chaos unfolds at Saidabad as cops, power department officials try to persuade him to get off the tower

Hyderabad: Fed up with the harassment by his wife, a man created commotion at Sankeshwar Bazaar in Saidabad when he climbed on to a high-tension electricity tower.Mohan Babu (25), a casual labourer, lives with his wife at Singareni Colony in Saidabad. His wife scolded him for returning home drunk. Furious, Babu went to the nearest high-tension electricity tower on the Sankeshwar Bazaar road and climbed it.Passersby noticed this and informed the local power department officials, who turned off the power supply. Police arrived at the spot and tried to persuade Babu to get down. As their persuasion failed, police personnel planned to climb the tower and bring him down themselves.Noticing that police and power department officials were climbing the tower, Babu came down. He was detained and taken to the police station.Babu told police that his wife was harassing him, following which he got angry and resorted to the act. A huge crowd had gathered at the place to watch the chaos unfold, causing traffic jam.

When the wedding was called off seven months after the engagement, the impact on the family was so huge that it would amount to cheating, the woman's counsel argued. The bench of Justice Nagaprasanna stated, "In the considered view of the court, it is not a false promise of marriage. It was a betrothal ceremony and ensuing was the marriage. The bench also noted, "Seven months passed by. Communications galore between the two, including WhatsApp chats. Nowhere in any WhatsApp chat even a line of narration is made by the complainant about the 1st petitioner or the complainant indulging in sexual intercourse on the day of the betrothal ceremony at 6 pm."The court concluded, "For manifold reasons, as averred in the petition, the marriage has tumbled down. It is not a case where the family of the 1st petitioner or the 1st petitioner had lured the complainant or her family members to get into the marriage.... Merely because the engagement breaks at a later date cannot amount to an offence of cheating against the 1st petitioner or his family members."

Delhi HC issues notice on plea to add 'sponsor' of article as party in businessman's defamation suit

The Delhi High Court on Wednesday issued notice on a plea seeking to add an entity as a party in a lawsuit for "sponsoring" a newspaper article that allegedly contained defamatory statements about a US-based businessman. The court was hearing a lawsuit moved by the plaintiff Gaurav Srivastava, an entrepreneur-investor based in Los Angeles, USA, who claimed that various media houses and online platforms published "false articles" accusing him of misconduct "without verification, intending to boost their own revenues" at the cost of his reputation

Srivastava said that he was aggrieved by the publication of a "statement/article" in the newspaper The Tribune, which he claimed "maliciously made defamatory statements and allegations" against him.At the outset, the counsel for The Tribune submitted before a singlejudge bench of Justice Neena Bansal Krishna that his client had complied with the court's earlier directions and had disclosed the details of the original sponsor of the article to the plaintiff. The high court had on May 30 issued summons to The Tribune and had also asked it to disclose the details of the sponsor of the article. The court said this after noting that the article carried a disclaimer which stated that the "article is part of a sponsored content programme". During the hearing on Wednesday, senior advocate Rajesh Yadav, appearing for Srivastava, submitted that the newspaper had disclosed the details of one - Examplad Media Private Limited. Yadav said that on June 8, the plaintiff had filed an application for impleadment of Examplad Media Private Limited as defendant no. 16 in the lawsuit.Yadav, who appeared along with advocates Bharat Arora and Abhishek Singh, said that Examplad Media in its June 10 email had in turn informed that the article was supplied to it by one Sachin

Bharadwaj. Yadav said that both Examplad and Bharadwaj be added as defendants in the matter."Notice of the application to be issued to proposed defendant Examplad Media Private Limited and be also issued to Sachin Bharadwaj through ordinary and electronic mode," the high court said, listing the matter on July 4. The high court also said that the "notice of the suit be issued" to the other defendant entities in the lawsuit. The suit seeks to restrain certain media houses and online platforms from publishing any allegedly defamatory content about Srivastava. On May 30, the high court had said after hearing the matter, "Considering the fact that The Tribune itself claims that the publication was a sponsored content programme, the details of the said sponsor may be disclosed to the plaintiff (Srivastava) by 10th June". The court had said that Srivastava would then be free to take steps as per law, including for "seeking impleadment" of the said sponsor.Srivastava said that he discovered these "defamatory publications" last month and issued a legal notice to the defendants on May 20, demanding cessation of these activities, removal of the defamatory content, and Rs 5 crore in damages. He, however, said that the defendants did not comply or respond, prompting him to file the suit."The entire false publications have accused the plaintiff even when there is no shred of evidence and iota of truth in such acquisitions which are a part of a paid campaign to tarnish and harm the reputation of the plaintiff," the suit submits.Among various reliefs, Srivastava has sought a permanent injunction against the defendant entities including The Tribune, India Today and Times of UP among others - for restraining them from publishing any defamatory material. Srivastava has sought an unconditional apology from the defendants for publishing unverified content and a direction to them to remove the allegedly defamatory content.



Two senior bureaucrats among six arrested for allegedly murdering 82-year-old man in Nagpur

A woman and her brother, both senior bureaucrats, along with four others have been arrested in connection with the murder of her 82-year-old father-in-law over a property dispute in Nagpur district, said police .To evade arrest, the accused had initially tried to pass off the murder as a hit-and-run case, said the police. The crime branch of the Nagpur police arrested assistant director of town planning, Archana Puttewar, and her brother Prashant Parlewar, director of MSME Nagpur, with four others for allegedly conspiring and killing Puttewar's fa-ther-in-law, Puroshattam Puttewar. Police identified the other accused as Neeraj Nimje, who ran over the victim with his car, Nimje's accomplice Sachin Dharmik, Archana's driver Sarthak Bagde and her secretary Payal Nageshwar.A senior police official from the Nagpur police said, "The attack is an outcome of a property dispute.

Sharing details of the crime, the police said on May 22. the victim was on the way to his daughter's residence in Balaji Nagar when Nimje mowed him down with his car around 10.30 am.Before this, at least two attempts were made to injure Puroshattam, said the police, Nagpur Police Commissioner Ravinder Singhal said, "The two other attempts to injure him were made on May 8 and 16. In the first instance, Dharmik had tried to mow him down while in the second, Dharmik and Nimje had hit Puroshattam on head with a rod and escaped on a scooter. As he had not sustained much injury, the senior citizen and his son Manish, who is a doctor, did not lodge any police complaint."Following his death on May 22, the police said that Ajni police station had registered a case of negligence and arrested Nimje. The car used in the crime was also seized and he was released on bail on the same day.

The police started reinvestigating the case as multiple suspicious activities came to the fore during the probe, including renewal of car insurance. Additionally, Nimje, who is unemployed, was spotted spending money in pubs and bars, around the time of the incident.The crime branch started scrutinising the CCTV footage of the accident.

"Through the CCTV grabs, we came to know that it was not a mere accident as Puroshattam was walking right on the corner of the road and the driver on purpose knocked him down. He even dragged him to ensure that he causes serious injuries," said Deputy Commissioner of Police (DCP) Nimit Goyal."During the probe we found an Activa constantly following Puroshattam. The Activa was also found near the accident spot and had fled the area after the mishap. Based on this, Nimje was probed again during which he revealed the role of his accomplice Sachin Dharmik," said the DCP.An FIR was then registered under relevant sections of murder, conspiracy and destruction of evidence of the Indian Penal Code and Motor Vehicle Act after which Nimje and Dharmik were arrested on June 4.

Further scrutiny of Dharmik's call records revealed that he was constantly in touch with Archana. He later confessed to the crime and revealed her driver Sarthak Bagde's role. The police said that Puttewar tried to mislead the cops claiming that she sacked Bagde six months ago and he must have "committed the crime to take revenge from the family". However investigation revealed that Bagde was employed with her till May 20 following which Puttewar and the driver were arrested on June 6 and June 10 respectively.

"Archana Puttewar is the main conspirator in the case. Her father-in-law owned property worth over Rs 40 crore. His daughter, who is a widow was also eyeing a part in it and Puroshattam was supporting her due to which Archana wanted to teach him a lesson," said an officer familiar with the probe.She conspired with her brother Parlewar as he is also one of the direct beneficiaries of the property, said police, adding he was arrested on Tuesday. "The two only wanted to physically incapacitate Puroshattam for which they had hired Dharmik, Bagde and Nimje. They had bought the car recently and renewed its insurance on May 21," the officer quoted above said.Dharmik agreed to do the job as the two bureaucrats, both in their fifties, had promised him a liquor shop license while Nimje was paid Rs 4 lakh, said police.Sharing details of the sixth accused, the police said that Puttewar's secretary, Payal Nageshwar, had paid Nimje cash and she was also part of the (conspiracy) meeting conducted on May 20. She was arrested by the crime branch on Tuesday. Another officer said, "Four other deaths have taken place in the family under mysterious circumstances. We will try to find out if there is any foul play involved.'

Yediyurappa moves HC for quashing of Pocso case after victim's brother questions progress in probe

Senior BJP leader and former chief minister B S Yediyurappa on Wednesday filed a petition in the Karnataka High Court seeking to quash a case filed against him in March this year under the Protection of Children from Sexual Offences (Pocso) Act.In a parallel development, the Criminal Investigation Department (CID) of the Karnataka Police has moved a special court for Pocso cases seeking an arrest warrant for the former chief minister. Yediyurappa was summoned by the CID on Wednesday for investigations of the case but reported that he was away from Bengaluru and sought time to appear, sources said.Yediyurappa approached the High Court after the brother of the minor victim in the alleged Pocso case also filed a petition on Tuesday seeking the High Court's intervention to speed up investigations in the police case filed under the Pocso Act on March 14, 2024. The brother filed the petition through the senior criminal and human rights lawyer S Balan. The former Karnataka chief minister has refuted the allegations of sexual harassment and said that he had helped the mother and daughter in the past.Both cases, which have received filing numbers, are yet to be registered by the High Court, and are expected to be taken up over the weekend.In his petition, Yediyurappa said the case registered against him based on a complaint by the mother of a teenage girl is false and that it should be quashed under Section 482 of the Criminal Procedure Code (CrPC)

Its pump runs dry, Punjab village demands new borewell; to bathe cattle, says pvt firm

For the residents of Patton village in Fatehgarh Sahib, the demand is urgent and simple: dig a new borewell to draw underground water as the only pumpset, installed by water supply and sanitation department, has stopped lifting water since August last year. The residents claim that the aquifers in the village have dried up completely and they are not getting any water for past several months. The claim, alarming as it sounds, has failed to find any sympathy with a KNK Projects Private Limited, a firm that has set up a plant at Nanowal to treat canal water that is further supplied by the water supply and sanitation department to several villages, including Patton.

The canal water is supplied via an automated system - for three hours in the morning and three in the evening. "The villagers used to get water supply 24/7 through the pump set only bathe their cattle and waste it. The automated system of water supply has stopped the wastage. They seem to be annoyed over this. They do not understand that they are already facing a shortage of drinking water," says Naveen Kumar Dubey, a Supervisory Control and Data Acquisition (SCADA) engineer associated with KNK Projects Private Limited. For the nondescript village, however, the problem is not that simple. A few days ago, when the water resources department cleaned the canal network in the area, the water supply got hit resulting in SOS calls by villagers, who took to social media claiming "aquifers in the village have dried up". Upon visiting Patton on Wednesday, The Indian Express learnt that the groundwater there had high concentration of fluoride - caused by indiscriminate extraction and excessive use of phosphatic fertilisers - making it unfit for consumption

"Several villages in Fatehgarh Sahib are affected. As many as 69 villages in Khera block alone are drinking canal water. The underground water has a high fluoride content," Sanjay Giri, Junior Engineer handling canal water supply in Khera block, said."We cannot say there is no water. Water is there, but it is highly concentrated.

Residents having submersible bored to 350 feet can extract water, but it is unfit for consumption," he added. However, SOS calls by villagers brought into sharp focus the issue of shortage of drinking water due to the overdrawing of underground water and the use of fertilisers.Paddy crop, a water guzzler, is often blamed for water woes in Punjab but the area under cultivation does not seem to have decreased. Several parts of Punjab are facing a similar situation. According to a 2022 report by the Central Ground Water Board, "Groundwaters with fluoride above 1.50 mg/L are found mainly in Bathinda, Faridkot, Fazilka, Muktsar and Mansa districts and also at isolated places in Firozepur, Sangrur, SAS Nagar and Taran Tarn districts. High fluoride water found in areas with predominant agriculture activities, indicating the possibility of fluoride coming from phosphatic fertilisers containing fluoride as an impurity."However, Patiala and Farehgarh Sahib districts have also reported the lowering of groundwater and the presence of fluoride.AAP's Dera Bassi MLA Kuljit Singh Randhawa has repeatedly been raising the issue of lowering the water table to 1,200-1,300 feet in his Assembly segment and the presence of fluoride. "I raised the matter in the Assembly. My constituency does not have drinking water due to the presence of industries. The underground water table has receded and there is a higher concentration of chemicals in the shallow groundwater, which makes it unfit for drinking. I urged the government to supply canal water to my area also," he said.

Dubey says, "I manage operations. I drank several glasses of canal water before the villagers, but they did not listen. They do not want canal water."Patton Sarpanch Manjit Kaur says the district administration should not have any problem in providing a new borewell. "Only Rs 16 lakh is required for digging a new bore well, but they are not doing it despite the inconvenience we face without water."Kamaljit Singh, a village resident, said, "Left with no option, we started a sit-in outside the DC office on Wednesday. Why don't they install a tube well? A few days ago, we had to get water from tankers because submersible water does not wash soap. It halted cooking also. When we bathe, the soap remains on the body."Despite facing a shortage, villagers want more water to be extracted from aquifers. Asked whether they would reduce the area under paddy cultivation, the Sarpanch said, "No, paddy will be cultivated as usual. The government allowed it to be transplanted from June What is the option?"During the recent cotton season, the area under cotton cultivation shrank by 80,000 hectares. Cotton is considered an option for crop diversification.Chief Minister Bhagwant Mann often bemoans that 78 per cent of land in 150 blocks was in the extreme dark zones due to the depletion of the groundwater table

Consumer panel asks hospital to pay Rs1.2 lakh to elderly Mohali man for inflating Covid bill

For INFLating Covid-19 treatment bill of an elderly Mohali man, the District Consumer Disputes Redressal Commission of Chandigarh has ordered the Max Super Speciality Hospital to pay Rs 1.20 lakh to the affected person.VK Agarwal (76) from Chandigarh stated in his complaint that he was admitted in Max Super Speciality Hospital at Mohali, on January 23, 2021, as a Covid patient, and was discharged on February 12, 2021.

Aggarwal submitted that for the treatment, the hospital raised a bill of Rs 7,62,445, out of which Rs 1,11,851 was charged from the complainant and the balance was charged from insurance company.Meanwhile, after he was discharged, when he checked the bills, he came to know that the hospital has wrongly charged him for the visit of dietician, the amount of which was not paid by insurance company. The complainant also added that he was surprised to note that the dietician of the hospital advised him to take milk at night, which could lead to serious consequences on his health as he is a patient of ulcerative colitis. Aggarwal also alleged that some breathing exercises were demonstrated by a physiotherapist on the first visit and thereafter she just asked the patient to continue doing the exercises. However, the bill mentioned physiotherapy procedures and physiotherapist's visits twice a day, both of which are not true, according to the complainant.Aggarwal said that after the cashless permission was denied by Raksha Health Insurance, due to wrong information given by the hospital, and later the reimbursement was done by the insurance company due to his personal efforts. Aggarwal also alleged that there are many types of extraneous charges in the bill, like alpha bed, PPE kits, which are wrong, and the charges of Rs 6,620 towards CT contrast was wrongly mentioned in the bill as the same was not done. The hospital, in its reply, stated that the total bill amount was Rs 762,445, out of which Rs 44,108 was discounted and an amount of Rs 606,486 was approved by insurance company and the balance amount of Rs 1,11,851 was paid by the patient.Max Super Speciality claimed that the bill was raised as per the hospital tariff and according to the memorandum of understanding between the insurance company and hospital. It also pleaded that the hospital bill and treatment record shows the visits and diet chart which was followed under the supervision of a professional dietician. It is further pleaded that the physiotherapy was done as per regular medical treatment of patient, and there are no excessive charges charged by the hospital. The Oriental Insurance Company, in its reply, submitted that its third party administrator, Raksha Health Insurance, has already processed the claim and released the payable amount, and that the coverage is limited to the extent of the amount as mentioned in the Schedule of Policy of Insurance and nothing more has been found payable by the competent authority, further denying other allegations made by the complainant and prayed that the complaint be dismissed. The Commission on hearing the matter held that the claim of the complainant is that the hospital has wrongly billed him for dietician visit who allegedly advised him milk at night whereas he is a patient of ulcerative Colitis, for visit of physiotherapist twice a day whereas no physiotherapy was done, and illegal charges for the use of 230 surgical gloves among other equipment."The advice of the dietician to take milk at night to the patient/ consumer, who is suffering from ulcerative colitis is a wrong advice which could lead to serious consequences on the health of the patient/ consumer, which is a clear cut negligence on the part of the dietician and amounts to deficiency in service," the commission noted."Further the



The victim's brother approached the High Court after the death of their mother on May 26. According to the brother's petition, the Karnataka Police have not progressed with the investigations into the Pocso case after the registration of the case. "Accused was not arrested and not even 41(A) notice was given, hence this petition as there is no efficacious remedy other than approaching this Hon'ble Court for invoking its extraordinary writ jurisdiction," says the petition. The plea indicates that the victim's mother had also written to the Chief Justice of Karnataka for a CBI probe into the matter.

The mother of the victim filed the Pocso case against Yediyurappa in March this year alleging that he had touched her daughter inappropriately in February when she went to the residence of the senior BJP leader seeking help for justice in a 2015 case of assault on the child. The mother, 54, who relentlessly pursued justice for her daughter in the 2015 and the recent case died on May 26 this year.CID has obtained voice samples of the former chief minister for comparison with voices on a video recording done by the mother on the day of the alleged incident. Yediyurappa appeared before CID investigators on April 12 to provide the voice samples, sources said.

2 Punjab Police employees arrested for accepting over 26 lakh bribe: VB

Punjab Vigilance Bureau busted a recruitment scam and arrested two Class IV employees, a sweeper and a barber of the Punjab Police, for accepting bribes to the tune of more than Rs 26 lakh from 102 people on the pretext of getting them Class IV jobs in the state police, a VB official said "Tarlochan Pal (No. 207/S), posted in the 3rd India Reserve Battalion as a sweeper, residing at Mohalla Begampur in Adampur, Jalandhar district, and co-accused Surinderpal (No. 3B), posted as a barber at the Punjab Police Academy in Phillaur, a resident of village of Sikri in Nilokheri, Karnal district, Haryana, were arrested following an investigation into a complaint lodged at the Chief Minister's Anti-Corruption Action Line portal by complainant Surinder Singh, a resident of Nanglan village, Garhshankar tehsil, Hoshiarpur district," a VB official spokesperson said.

The Bureau on Wednesday produced the duo in a Jalandhar court which sent them to a two-day remand with the bureau. The spokesperson said, "During the preliminary investigation by the VB Jalandhar range, the charges made by the complainant were found to be accurate, leading to the registration of a fraud case against both the accused.""The investigation revealed Tarlochan and Surinderpal had falsely assured the gullible persons that about 560 Class IV vacancies were to be filled in the Punjab Police in the coming months. Acting in collusion, they demanded Rs 25,000 per person to secure jobs as Class IV employees in the state police and thereby collected huge money from numerous individuals across the state. Consequently, Tarlochan received a total of Rs 18,09,100 as bribes, which were deposited in his various bank accounts. Out of this amount, Tarlochan had transferred Rs 5,45,000 to Surinderpal's HDFC bank account. In addition to this, accused Surinderpal had received Rs 7,93,826 in his bank account separately," the spokesperson said.

The spokesperson further said, "During the probe, it was found that a total of Rs 26,02,926 were collected as bribes by both accused from about 102 people on the pretext of getting them jobs. Consequently, a case under sections 420 and 120-B of the IPC, and under section 7 of the Prevention of Corruption Act has been registered against both accused at VB police station, Jalandhar range."

"Accused Surinderpal, during interrogation, told the VB that he and Tarlochanpal took the said money from job aspirants and gave about Rs 9 lakh to two employees posted at the Punjab Police Headquarters in Chandigarh. He revealed that out of Rs 9 lakh, they had returned some money to him after they failed to get recruited job seekers but the rest of the money was never returned," the spokesperson said. The spokesperson added, "During the investigation, the statements of various victims of this fake recruitment scam are being recorded and more affected persons could appear before the Bureau to provide information in this regard." hospital failed to lead any cogent and convincing documentary evidence to justify the said charges billed from the complainant. Therefore, it is held that the Max Super Speciality Hospital, Mohali has illegally exaggerated the medical bill of the complainant by adding wrong charges for the services, which were never provided to the complainant, and this (behaviour) amounts to deficiency in service as well as adoption of unfair trade practice on the parts of the hospital," held the commission. It directed Max Super Speciality Hospital to compensate the complainant by paying a lump sum amount of Rs 1,20,000 for "causing loss, harassment and mental agony due to its deficient services" as well as "indulgence into unfair trade practice", which also includes litigation expenses.

To ease congestion, police reintroduces 'One Minute Traffic Plan' in Shimla city

Taking note of the heavy traffic in Shimla, police have reintroduced the 'One Minute Traffic Plan' in the city to make the state capital jam-free and reduce the commute time.The decision to implement the 'One Minute Traffic Plan' was taken after assessing the number of vehicles – 4.89 lakh – especially from other states, that has entered the state capital in the last 11 days since June 1, the day when summer vacations start in most states. The vehicular population of Shimla itself is over 80,000, including two-wheelers and four-wheelers.

According to the plan, at points 6-8 km from entering Shimla city, every minute motor vehicles will be released for 20 to 30 seconds and stopped for 40 to 30 seconds."The plan is very simple. It is based on time, number, and space. In the last two months, a trial on all bottlenecks was carried out along with studying the capacity of inflow and outflow of vehicles. Based on the study, the effectiveness of measures to decongest roads was tested. Halting points have a limited capacity to hold up vehicular traffic. Surplus vehicles are held up at 1-Minute holding points as a need-based arrangement. At each point, vehicles are released every minute in the ratio of 40/20 or 30/30, meaning every minute, vehicles will be stopped for 40 seconds and released for 20 seconds. No constant holding-up of vehicles lasts more than 1 minute. This takes a maximum of 10 minutes in the line segment of 500 metres, which will be the maximum line at each halting point," SP (Shimla) Sanjeev Gandhi told

Sources said, "In the first two weeks of June, over 4 lakh vehicles entered and exited Shimla from all directions. This is a significant number for a hill city like Shimla. In previous years, Shimla faced acute traffic jams.









Former Trump aide John McEntee sparks fury over outrageous TikTok video, 'I give fake money to poor so that...'

Donald Trump's White House aide John McEntee has sparked online fury after he arrogantly admitted to giving fake money to homeless people so they can get arrested when they use it.McEntee said in a now viral TikTok video that he wants to help "clean up the community". The video posted a week back has over 7 million views and almost half a million likes.His outrageous video was posted on the account for The Right Stuff, a dating app for U.S. conservatives that McEntee co-founded."So I always keep this fake Hollywood money in my car so when a homeless person asks for money, then I give him like a fake \$5 bill, so I feel good about myself, they feel good," McEntee said in the video."And then, when they

go to use it, they get arrested so I'm actually like helping clean up the community. You know, getting them off the street."After the backlash caption on the video read, "Just a joke. Everyone calm down #fyp"John started his career as Donald Trump 'body guy,' carrying around the thenpresidential candidate's bags and relaying messages, at the age of 25. McEntee, now runs a right-wing dating app named The Right Stuff, he is also currently working on HR for Donald Trump's campaign and is a senior adviser for the Heritage Foundation's 2025 Presidential Transition Project. The former UConn college grad recently turned heads after hiring Instagram influencer Camryn Kinsey, 20, as external-relations director. 'Only in Trump's America could I go from working in a gym to working in the White House, because that's the American dream,' she said. The netizens can't believe what they heard from a person who has served with the US President at the White House. "Pretty sure that passing off counterfeit bills as real, even to people he views with such disdain as the unhoused, is still illegal, " asserted an X User. Using the incident to attack Trump's supporters another said, "This is your maga party and today's Heritage Foundation, now owned by maga. This is how they think.""So #GeorgeFloyd was murdered by a cop in broad daylight for this crime while this douchebag insurrectionist MAGAt from @TeamTrump and #Project2025 gets to go about his privileged life like it's just another day," commented another user

Israeli forces push deep into Gaza's north, Rafah

Israeli forces pushed deep into the ruins of Gaza's northern edge on Monday to recapture an area where they had claimed to have defeated Hamas months ago, while at the opposite end of the enclave tanks and troops pushed across a highway into Rafah.With some of the most intense fighting for weeks now taking place on both the northern and southern edges of Gaza, hundreds of thousands of Palestinians have again taken flight, and aid groups warn that a humanitarian crisis could sharply worsen.

Israel described its latest return to the north, where it pulled out most of its troops five months ago, as part of a "mop-up" stage of the war to prevent fighters from returning, and said such operations had always been part of its plan. Palestinians say the need to keep fighting amid the ruins of previous battles is proof Israel's military objectives are unattainable.

In sprawling Jabalia, the biggest of Gaza's eight camps built 75 years ago to house Palestinian refugees from what is now Israel, tanks pushed towards the heart of the district. Residents said tank shells were landing at the centre of the camp and air strikes had destroyed clusters of houses. Thick clouds of black smoke from explosions could be seen rising over northern Gaza from the Israeli border on Sunday.Israeli troops are seeking to wipe out Hamas, which has said it is committed to Israel's destruction. The militant group burst into Israel on Oct. 7, killing 1,200 and taking more than 250 hostages, by Israeli tallies. The Palestinian death toll in the war has now surpassed 35.000, according to Gaza health officials who fear many more bodies are lost under the rubble. The fighting has laid waste to the coastal enclave and caused imanitarian crisis, with the Gaza health ministry warning in a statement on Monday that the medical system is on the verge of collapse due to a shortage of fuel to power generators and ambulances.Palestinian health officials on Monday said they had so far recovered 20 bodies of Palestinians killed in the overnight air strikes on Jabalia, while dozens were injured. At the opposite end of Gaza in Rafah, against the border fence with Egypt, Israel stepped up aerial and ground bombardments on the eastern areas of the city, killing people in an air strike on a house in the Brazil neighbourhood.Israel ordered residents out of the east of the city last week, and extended that order to central areas in recent days, sending hundreds of thousands of people, most of whom are already displaced, fleeing for new shelters. Residents said Israeli air and ground bombardments were intensifying and tanks had cut off the main north-south Salahuddin Road that divides the eastern part of the city from the central area."The tanks cut the Saladuddin road east of the city, the forces are now in the



southeast side, building up near the built-up area, the situation is dreadful and the sounds of explosions never stopped," said Bassam, 57, from the Shaboura neighbourhood in Rafah."People continue to leave Rafah, even far away near the western areas as no place looks safe now and also because people do not want to escape at the last minute should tanks make sudden incursions and moving out becomes too late," he told Reuters via a chat app.

The assault on Rafah has caused one of the biggest splits in generations between Israel and its main ally the United States, which put some deliveries of weapons on hold for the first time since the war began. Washington has said Israel must not assault Rafah without a plan in place to protect civilians there, which it has yet to see.Jack Lew, the U.S. ambassador to Israel, signalled on Sunday that the Rafah incursion was still on a scale that Washington considers acceptable."The president was clear in the interview he gave the other evening that what Israel has done so far hasn't crossed over into the area where disagreements lie," Lew told Israel's Chan without elaborating on what that area entails."I'm hoping we don't end up with real disagreement."Hamas' armed wing said its fighters were engaged in gun battles with Israeli forces in one of the streets east of Rafah, and in the east of Jabalia. In Israel, the military sounded sirens several times in areas near Gaza, warning of potential Palestinian cross-border rocket and or mortar launches.Hamas and the armed wing of Islamic Jihad said in a joint statement that they fired mortar bombs against Israeli forces massing up inside the Rafah crossing, the sole checkpoint linking Gaza to Egypt, which Israel captured last week.Late on Saturday, the Israeli military said forces operating in Jabalia were preventing Hamas, which rules Gaza, from re-establishing its military capabilities there."They were bombing everywhere, including near schools that are housing people who lost their houses," Jabalia resident Saed, 45, told Reuters via a chat app on Sunday. "War is restarting, this is how it looks in Jabalia.

Indonesia's Ibu volcano erupts, spews ash clouds as high as 5 km

Indonesia's Ibu volcano erupted on Monday morning, spewing thick columns of grey ash several kilometres into the sky, the country's volcanology agency said. The volcano on the remote island of Halmahera erupted at 9.12 a.m. (0012 GMT) for about five minutes, projecting ash into the sky as high as 5 km (3.1 miles), officials said.

The alert status of the volcano remains at the second-highest level, Hendra Gunawan, head of Indonesia's Volcanology and Geological Hazard Mitigation Centre, said in a statement.All activities within a five-kilometre radius of the volcano were prohibited, he added." If it starts to rain ash, we recommend people who are near the volcano to wear a mask and glasses," Hendra said. Footage of the eruption shared by the centre showed clouds of grey ash billowing from the crater. The official said a booming noise was also heard.No evacuation of residents has been reported so far.Indonesia sits on the Pacific "Ring of Fire" and has 127 active volcanoes, according to the volcanology agency. In recent weeks North Sulawesi's Ruang volcano has erupted, spewing incandescent lava as lightning flashed from its crater. The eruption prompted authorities to evacuate more than 12,000 people living on a nearby island. In December, more than 20 people were killed after Marapi volcano, one of Sumatra's most active volcanoes, erupted and belched grey clouds of ash as high as 3 km.

Ukraine's first lady and foreign minister visit Russia-friendly Serbia

BELGRADE, Serbia — Ukrainian Foreign Minister Dmytro Kuleba made a surprise visit to Russia-friendly Serbia on Monday, together with Ukraine's first lady, Olena Zelenska, in a sign of warming relations between the two states.On his first visit to Serbia since the start of the Russian aggression on Ukraine in 2022, Kuleba met new Serbian Prime Minister Milos Vucevic, whose government includes several pro-Russian ministers, including two who have been under U.S. sanctions.

Although Serbia has condemned the Russian aggression on Ukraine, it has refused to join international sanctions against Moscow and has instead maintained warm and friendly relations with its traditional Slavic ally.Serbia has proclaimed neutrality regarding the war in Ukraine, and its authorities repeat that Serbia does not supply weapons to any parties. However, there are reports that Serbia has delivered weapons to Ukraine through intermediary countries.The visit by Kuleba and Zelenska, who toured the Serbian capital with Serbian first lady Tamara Vucic on Sunday, was met with criticism in Moscow. Comments by readers in the Russian staterun media such as "shameful" were published by RIA Novosti.

In what appears to be damage control, soon after his talks with Kuleba on Monday, Vucevic was to meet the Russian ambassador to Belgrade and the two were to tour a big storage facility for Russian gas that is being



imported to Serbia.Pro-Russian President Vucic has informally met Ukrainian President Volodymyr Zelenskyy three times on the sidelines of international conferences. Serbia has supplied Ukraine with humanitarian and financial aid.Vucic has for years claimed to follow a "neutral" policy, balancing ties among Moscow, Beijing, Brussels and Washington.

Although he has repeatedly said that Serbia is firm on its proclaimed goal of seeking European Union membership, under his authoritarian rule the Balkan country appears to be shifting closer to Russia and especially China.During a high-stakes visit by Chinese President Xi Jinping to Belgrade last week, China and Serbia signed an agreement to build "ironclad" relations and a "shared joint future."

United Kingdom General Elections 2024 Race for 10 Downing Street: What To Expect

The United Kingdom elections for the lower house are scheduled for July 4, 2024, with the two major political parties engaging in a battle to secure the majority. The elections seek to elect the representatives who will form the government for the subsequent tenure. The United Kingdom general elections are scheduled for July 4, 2024. The election will seek to elect representatives for 650 seats, and the political party securing 326 seats will be able to form their government. The UK general election 2024 will determine the composition of the House of Commons and, subsequently, the Government of the United Kingdom. The election seeks to elect 650 representatives to the House of Commons, the majority standing at 326 seats. Like India, the United Kingdom has several powerful political parties. The two major political parties of the United Kingdom are the Conservative Party and the Labour Party, both having dominated the United Kingdom political scene for the past 100 years. The Conservatives are currently in power, led by Prime Minister Rishi Sunak. The conservatives pride themselves on having traditional views, opting for a method of stable, responsible governance, rather than radical changes and growth. They give importance to defence and national security, building the UK army to have a strong military capability. While the popular perception of the Conservatives is that they are dominated by the rich and the elites, they are also traditionally seen as strong and effective administration. Facing the conservatives on July 4 will be the Labour Party, which has constantly pressurised and acted as a strong opposition in the past 14 years of

the conservative government in the country. The Labour Party, considered as the voice of the working class, is a progressive party that stands for social justice and believes in a stronger government involvement in the economy, as opposed to the Conservatives who believe in a free and liberal economic policy. The Labour Party also believed in maintaining strong foreign relations, and not building a strong defence. Other parties contesting for election in the United Kingdom General Election 2024 are the Liberal Democrats and the Greens. The country is currently in a pre-election period where ministerial and departmental activities are restricted, and the lower house of the United Kingdom stands dissolved. In the previous elections, the Conservatives secured 345 seats, labour secured 205 seats and the other oppositions as well as independent candidates bagged a total of 305 seats. Although the conservatives have been in power since 2010, there is a growing dispute amongst British nationals who are unsatisfied with the economy, rise in immigration and deteriorating national health services. The United Kingdom is currently suffering through low growth and performing much worse than other developed countries. The slow rise in their economy has led to a housing crisis, as the cost of living has shot up, making the United Kingdom a lot more expensive in a very short period. Nepal President's economic advisor resigns after criticising inclusion of Indian territories in map on Nepal 100 notes

Kathmandu, The economic advisor to Nepal's President Ram Chandra Paudel has resigned after his controversial remarks on the government's decision to issue new hundred-rupee notes with a map that includes three Indian territories, a move already rejected by India.The President approved Chiranjivi Nepal's resignation on Sunday, according to a press release issued by the Office of the President."I made the remarks as an economist and a former governor of the central bank but some news media have twisted it in an attempt to unnecessarily drag the respectful institution of the president into controversy, which made me feel sad," Chiranjivi Nepal

The new map includes territories such as Kalapani, Lipulekh and Limpiyadhura.India maintains Lipulekh, Kalapani and Limpiyadhura belong to it."I, therefore, tendered my resignation taking the moral obligation of the attempt made by some online news portals which have tried to drag the president into controversy based on my statement," he said."My intention in the statement was just to make people aware as a conscious citizen that such acts could create practical problems to the country and the people at a time when discussions are underway at diplomatic levels," he clarified.A Cabinet meeting last week decided to replace the old map with the new one while printing new notes of 100.CPN-UML chairman and former Prime Minister KP Sharma Oli had publicly criticised Chiranjivi Nepal for his remarks.

Earlier, a group of civil society leaders had demanded the removal of Chiranjivi Nepal over his remarks against the government's decision to print new hundredrupee notes with the map of Nepal as per the amended Constitution.They argued that he had gone against national interest and breached decorum while speaking to the national and international media on the matter.Nepal's government unveiled its new political map with the inclusion of Lipulek, Kalapani and Limpiyadhura areas within its territory in May 2020 during the government led by Oli. It was later endorsed by the Parliament unanimously. After that, the government replaced the old map used in all the official documents with the new map despite India's objection."

This artificial enlargement of claims is not based on historical fact or evidence and is not tenable. In biggest corporate exit since Ukraine war, search engine Yandex's owner to leave Russia in \$5.2 billion deal



Yandex NV has struck a 475-billion-rouble (\$5.21 billion) deal to sell what has been dubbed "Russia's Google" to a group of Russian investors, marking the biggest corporate exit from the country since Moscow invaded Ukraine almost two years ago.The Kremlin-engineered deal would see Russia's largest technology player fall entirely under Russian ownership, including a fund ultimately owned by oil major Lukoil, and cement Yandex's departure from Western tech circles.

Once seen as one of the few Russian companies with the potential to become a global business, Nasdaqlisted Yandex had developed leading online services, including search, advertising and ride-hailing in Russia.lts co-founder Arkady Volozh, who moved from Russia to Israel in 2014, slammed Russia's invasion of Ukraine as "barbaric" in August, leading some within the Kremlin to push to nationalise Yandex, people familiar with the matter said.But ultimately, fear of a technology brain drain helped keep that prospect at bay and has resulted in a complicated deal under which Yandex businesses accounting for more than 95% of revenues would remain in Russia and come under Russian control. The Kremlin, which welcomed the deal, has been engaged in negotiations with Yandex for around 18 months to try and spin off the Russian businesses from Yandex NV, its Dutch parent. Yandex has always sought to portray itself as free from Kremlin influence, a task that has become more challenging as the company has become such a strategic national asset. The deal calculates Yandex's market capitalisation at \$10.2 billion, based on a three-month weighted average for its shares on Moscow Exchange. In late 2021, before Russia's invasion, Yandex's market value had approached \$30 billion. The sale price reflects "a mandatory discount of at least 50% to 'fair value", Yandex NV said. Russia's government must approve deals involving foreign asset sales and demands a discount of at least 50%. Almost 88% of Yandex's ownership structure is currently free-float, with many Western funds among its shareholders. Yandex NV said in a statement that the deal would consist of a cash equivalent of at least 230 billion roubles and up to around 176 million Yandex NV Class A shares."The cash consideration will be paid in Chinese Yuan (CNH) outside of Russia," Yandex NV said, adding that it would cease using the Yandex brand following completion of the deal.

The buyer, Consortium.First, is a newly-formed investment fund managed by trustee Solid Management. It was led by members of Yandex's senior management team in Russia and supported by four financial investors including Argonaut, an investment fund ultimately owned by Lukoil.Three other companies – Infinity Management, IT.Elaboration and Meridian-Servis – owned by Alexander Chachava, Pavel Prass and Alexander Ryazanov

Jio Platforms gets approval to launch satellite internet in India

Jio Platforms' approval marks an important step in the competition for satellite communication services, alongside efforts by Amazon and Elon Musk's Starlink.Reliance Industries' Jio Platforms, in partnership with Luxembourg's SES, has received the green light from India's space regulator to operate satellites for high-speed internet, reported news agency .According to a government official, three approvals were granted to Orbit Connect India, a venture set to deliver the internet via satellite.These clearances, issued by the Indian National Space Promotion and Authorisation Centre (IN-SPACe) in April and June, allow Orbit Connect to position satellites above India.However, further approvals from the Department of Telecommunications are still required before the service can begin.

The approval comes as an important development in the race to offer satellite communication services, where companies like Amazon and Elon Musk's Starlink are also seeking permission.IN-SPACe Chairman Pawan Goenka told Reuters that Inmarsat and others have also received nods to operate satellites, highlighting the growing interest in the satellite broadband market.

Deloitte forecasts strong growth for India's satellite broadband market, estimating a 36% annual increase over the next five years, with revenues expected to reach Rs 1.9 billion by 2030.Globally, the competition to connect rural areas via satellite internet has picked up pace. Amazon's Kuiper initiative, with a planned \$10 billion investment, and SpaceX's Starlink, already operational, are



key players in this space. Recently, Starlink also received preliminary approval from Sri Lanka to offer its services there.Goenka highlighted the benefits of increased competition in India's satellite internet sector, suggesting that competitive pricing would drive innovation to meet consumer expectations, similar to developments seen in the automotive industry.IN-SPACe is set to further authorise private companies to operate ground stations in India, facilitating satellite data downloads. The government's recent policy changes, including opening up the space sector to foreign direct investment, have sparked investor interest, with an increase in funding compared to previous years."Last year investments into private companies were \$2 million-\$7 million. This year they are talking \$20 million-\$30 million. The proof of concept has happened," Goenka told

Scientists say exercising 22 mins daily can cut death risk from prolonged sitting; here's a routine to try



In recent years, office workers forced into extended periods of sitting have been bombarded with alarming headlines about the dire consequences of this inactivity, suggesting even regular exercise couldn't fully mitigate the damage.

However, a study published in the British Journal of Sports Medicine offers a beacon of hope, finding that as little as 22 minutes of moderate to vigorous activity a day can counter the ill effects of prolonged sitting. Moreover, the researchers discovered a decrease in the risk of premature death from any cause as a person's activity level increases.

What does the research say?

According to the study's lead author, Edvard Sagelv, a researcher at The Arctic University of Norway, the current recommendation of 150 minutes per week of moderate to vigorous activity "is sufficient to offset the detrimental health effects of prolonged sitting." Quoted by NBC News, he elaborated, "The beauty of this is that we're talking about activities that make you breathe a bit harder, like brisk walking, gardening, or tackling a hill."Seeking to determine whether physical activity could affect the relationship between sedentary time and mortality, the researchers investigated the amount of activity and sitting time necessary to influence this risk. Their findings revealed a decline in the risk of death with increased physical activity. Among those who sat for less than 101/2 hours daily, an extra 10 minutes of activity translated to a 15 per cent lower death risk, while for those exceeding

Why is prolonged sitting associated with a high risk of death?

Dr Sanjay Kumar, general physician, Cygnus Laxmi Hospital, explained that prolonged sitting increases the risk of death due to its association with several adverse health outcomes, including obesity, cardiovascular disease, type 2 diabetes, and certain types of cancer. "When you sit for extended periods, your muscles are inactive, leading to decreased metabolism, poor blood circulation, and increased inflammation, all of which contribute to higher mortality rates," he added.

Exercise helps decrease the risk of death associated with prolonged sitting by counteracting its negative effects on the body, according to Dr Kumar, who said that regular physical activity strengthens muscles, improves circulation, boosts metabolism, and reduces inflammation. "Engaging in exercise, such as brisk walking, jogging, cycling, or strength training, helps offset the harmful effects of sitting for long periods, promoting overall health and longevity."

What can you include in your 25 minute workout routine?

According to Joel Arun Benjamin, professional track field athlete and fitness trainer, India has one of the highest burdens of cardiovascular diseases (CVD) worldwide."Brisk walking for 15 minutes can help us to take down the risk of CVD. Along with 15 minutes of strength training at least twice a week is most important thing which every human being should must do it, specially after the age of 30," Benjamin explained in an interaction with indianexpress.com.Human body starts losing lean muscles after the age of 30th by 8 per cent per decade, said Benjamin, adding that by the age of 60 that percentage gose upto 15 per cent per decade and he recommided strength training to prevent this Bejamin noted, "You have many problems in life unless you have a health problem, once you have a health problem you only have one problem."

Tesla CEO Elon Musk said that the shareholders are voting in favour of his disputed \$56 billion pay package and to relocate the electric vehicle manufacturer's legal home to Texas, in a social media post on Wednesday, adding that passage was by wide margins."Both Tesla shareholder resolutions are currently passing by wide margins. Thanks for your support," said Musk on X.A vote in favour strengthens the electric carmaker's position in a Delaware court, where a judge voided the 2018 compensation package, the largest in US corporate history at that time, citing the board was "beholden" to Musk, reported news agency Reuters.

This outcome represents a victory for Musk and the board, who have risked their credibility to secure shareholder approval, despite opposition from major investors such as Glass Lewis and Institutional Shareholder Services (ISS). The results will be announced at a meeting at Tesla's Texas headquarters on Thursday. A source aware of the preliminary vote count told Reuters that the 'yes' result was achieved with the support of both major institutional investors and retail investors. However, shareholders have the option to change their votes until the start of the annual meeting.

Tesla shareholders also voted on other proposals, including relocating the company's legal headquarters from Delaware to Texas, and the re-election of two board members: Kimbal Musk, Elon Musk's brother, and James Murdoch.Some investors saw the vote on Musk's compensation as a measure of their trust in his leadership. While Musk has been the driving force behind Tesla and is credited with much of its success, the company has recently experienced a slowdown in sales and profits.

The board said that Musk, the world's richest person, deserved the pay package because he achieved all the ambitious targets related to market value, revenue, and profitability.

They further said that the package is necessary to

keep Musk focused on Tesla, even though a Delaware judge pointed out that the 2018 pay plan did not ensure Musk would dedicate a huge amount of time to the company.Musk has indicated that he might develop AI and robotics products outside of Tesla if he doesn't secure enough voting control, which hinges on the approval of the 2018 pay package.Some large shareholders, including Norway's sovereign wealth fund and California's two largest pension funds, have declared their opposition to the compensation, calling it excessive. Tesla has been actively seeking support for Musk's pay package, especially from retail investors, who form a important part of its ownership base but often do not vote.Company executives have posted messages on social media, highlighting Musk's importance to Tesla's success. Tesla has also run social media advertisements, and Musk has promised a personal tour of Tesla's Texas factory to some shareholders who vote. Previously, a Delaware judge rejected the same package, describing it as an "unfathomable sum" granted by a board with close personal and financial ties to Musk. The board organised the shareholder vote to strengthen its appeal against the ruling, which criticised the board for not fully informing shareholders before approving the 2018 pay package.Musk may have to wait months or years for his pay package to be restored as the appeals process moves through Delaware's Supreme Court.Tesla could also face additional litigation from some shareholders. Recently, one shareholder filed a lawsuit challenging the upcoming vote on Musk's pay package and the change of domicile

Rampant sexual harassment, hostile work environment: Fired employees sue SpaceX

NEW YORK: Eight former employees sued SpaceX and its CEO Elon Musk, alleging that Musk fired them after they challenged what they called rampant sexual harassment and a hostile 'Animal House'-style work environment at the company.

The employees, who filed a suit in a California state court, detailed their complaints in a 2022 open letter to the management, which they shared via a company intranet. The next day, four of the plaintiffs were fired, they alleged; others were terminated later after an internal investigation.In January, the federal National Labor Relations Board filed its own complaint against SpaceX based on issues raised by nine fired employees



New Zealand lose to West Indies, but can Black Caps still reach Super 8 at T20 World Cup? Yes, with lot of help

New Zealand lost to the West Indies by 13 runs in their group stage clash at the Brian Lara Stadium in Tarouba, Trinidad in the ongoing T20 World Cup. It's a result that seals the co-hosts' entry into the Super 8s and leaves the Black Caps almost eliminated. Almost.

Yes, despite the Black Caps suffering their second defeat in two games in the Group C, which leaves the team at the bottom of the five-team standings with zero points and a NRR of -2.425, New Zealand still have two games in hand against Uganda and Papua New Guinea.Mathematically, New Zealand are still not out of the contention for securing a spot in the Super 8 stage where only two teams from each group will progress. In Group C, co-hosts West Indies have already secured the top spot with three wins in three games. How New Zealand can still qualify for the Super 8New Zealand now need several things to go in their favour if they are to stand a chance to qualify.

New Zealand will have to pray that somehow Afghanistan - who are currently claiming the second spot in the Group C standings thanks to two wins from two games, including over New Zealand, and a net run rate of 5.225 - lose their remaining two games. This is the tricky part because the high-flying Afghan team meets Papua New Guinea in one of those two games. If they somehow lose that, New Zealand will still have a shot. But if Afghanistan win that game tomorrow morning, it's game over for New Zealand. Even if that game gets rained out, New Zealand are out. Afghanistan also play a match against West Indies, which might be a tough contest favouring the hosts for the moment.Now coming to New Zealand's own games, they will have to win their two remaining matches - against Uganda and PNG - by heavy margins. The margins they need to win by will depend on how bad Afghanistan's losses are in their two games (if they lose that is).

Tactically, it is similar football."It's not the first time the new Real Madrid signing has invited fire from South American football. Tintin tribute, Barbie-pink at Euro 2024...which football kit is the best? Jersey expert weighs in

"Nobody wants to have that!". It has been a popular response in Germany for their away kit at a home Euros. Dropping the old black or green, this one blends hazy purple with pink. "Barbie-pink? That's not a German jersey." Such was the uproar against it that German football and Adidas partnered together in a satirical advert to stand their ground: "Yes it is." In England, the furore has been over a small St. George's cross on the back of the shirt collar. Usually stitched in traditional red and white colors, it's been given a blue, purple and red update. UK Opposition party leader Keir Starmer rued, "It's a big unifier. I'm not even sure they can explain why they needed to change it."The big international football summer is here, and with it are its many colors. No longer are football kits mere differentiators between two teams.

"They are totems," Neal Heard, a football shirt expert, consultant and exhibition curator, tells The Indian Express. "If you then put them on the nationhood, they become sacrosanct because you're saying this is exactly who we are. This is the national brand. The brands who are making these have a tough job because if anywhere football fans are more conservative, it's the national team,' Heard says.Staring at the catalog for the upcoming European Championships, the author of 'The Football Shirts Book - A Connoisseurs Guide' is largely impressed. "Not all are amazing but there are enough good ones," Heard concedes before picking his favorites.

"Belgium away, based on the Tintin story, is a really cool one. France - hands down, the best footballing nation in kits - home and away are probably my favorites. Even Germany away is quite nice. As is England away. Actually, I adore that one." Looks a bit like the French home kit, doesn't it. "It does. Same sort of color. They're referencing a track suit, funnily enough, an iconic one from '66-'70." Speaking over a video call from Wales, he turns behind to access his 400-shirt strong collection and handpicks two - Germany and Holland from 1988 Euros. "Both these jerseys are quite bold even though they're paying homage to the tradition," says Heard.

 \pounds 1000. That's how much a replica of the Dutch kit Heard is holding costs currently. "Not match worn, just the replica," he presses. "If it was match worn, you'll be talking millions."The gigantic size of the football shirts market can be gauged better through one half of it. Heard equates the retro shirts market in itself to that of the trainers/sneakers. Classic Football Shirts, the biggest players in the game were recently offered private equity of £38 million. "Not to buy the brand, just to actually come and take it to the next level."Heard tracks the beginning of the obsession back to the 1970s with an increase in the number of traveling fans in the two hotbeds of world football -Europe and South America. "In the 70s, teams were traveling in Europe or even with the Intercontinental World Cup, which was a really exotic thing. Once the fans started going to another place, they began swapping kits with

one another." A popular culture that extends to the players.An even bigger development has taken place in the last decade with football shirts becoming a strong fashion product.Heard explains, "You've got the team badge; they can be more visually appealing than one another's. Then the maker's logo. Nike, Adidas or Puma, there are people who specifically love those brands. And then, there are sponsors on the chest. Sometimes they can be a bit more prosaic, like a betting firm which is less attractive, but if you get a really good sponsor on the chest, you've got a treble whammy of brands and logos. I'd say they are one of the most strong-branded things that you'll ever find."Euro 2024: Neal Heard collection Heard's 400 shirt strong collection includes the rarest of football treasures including a 1988 Netherlands home kit replica.The Connoisseur believes a significant credit of the new appropriation of football shirts goes to football backwaters - India, Australia, Korea, and definitely America. "They are the drivers of this fashion thing. Countries who don't have a 150-year-old backlog of knowing everything about the sport. Most football fans in Europe wear a kit to a game or while playing five-a-side. People in America don't have that sort of loyalty associated with the kits. That appropriation of football shirts essentially drove them to being a fashion item."

What makes a kit stand out?

Does it take a big tournament triumph for a football shirt to be revered? It certainly adds to the aura. "The ones which are kind of the apex tick both boxes - an amazing kit coupled with team success. Holland won the Euros in that amazing shirt in '88."But then there's Nigeria at the 2018 World Cup. A team who were knocked out of the group stage but a kit that had the consensus of being "the best" at the tournament. Similarly, some of the Mexico kits have stood out despite underwhelming outings at World Cups. Talking about the other side of the spectrum, Heard believes that even winning a major trophy sometimes may not ensure that a kit goes down well in history. "Thinking back to when Argentina won the World Cup. They obviously wore the blue and white - because that's what they do wear - but was it an amazing shirt? Will I remember it? I won't. Using Maradona as a reference, when Argentina won that World Cup (1986) having that massive le coq sportif logo, I think everybody would remember that jersey.'

"I'm kind of waiting for somebody to release that kit where I go....wow," Heard says. The kind that leaves him in an awe similar to what those two classics from the 80s did. He takes us to the Adidas designer labs in the decade. The story goes that when Horst Dassler, son of the German company's founder Adi Dassler, was designing the Germany and Holland kits, rather than working with professionals in their labs, he went to a local art college in search of a new designer. "He got an outsider, someone who looked at things with fresh eyes. And that's how they came out with those amazing kits."Heard believes it is no coincidence that two of the most iconic football kits were designed by a woman. "It's no accident that the Women's World Cup had vastly better kits. Because it was coming from the women's aesthetic, a little bit more freer and fashion led design. I wish they could bring some of that thinking for the men's game," he says. It rarely happens that a bold-unique design is accepted instantly by the majority. "The 90s kits are really hot because that's that generation of kids that have become adults now. They look back to the kits they had growing up, once they maybe couldn't afford at the time. Something that is certainly going to happen is that we will move to kits of the early 2000s." The fresher takes from Germany and England this summer can expect history to be much kinder to them.

Turkey aims to bounce back from Euro flop against debutants Georgia

Turkey begin their Euro 2024 campaign against newcomers Georgia on June 18 knowing a winning start in one of the tournament's weaker groups would give them a great chance of making the knockout stages after disappointing last time around.Tipped as dark horses going into Euro 2020, Turkey crashed out having lost all three groupstage games but they impressed in qualifying for Germany as they topped a group including 2022 World Cup finalists Croatia.

Their more recent form has been mixed: since beating Germany 3-2 in Berlin in November, Turkey have not won in five games and were hammered 6-1 by Austria in a friendly in March before holding reigning champions Italy to a draw this month.Turkey's ambitions of progressing from a group also containing Euro 2016 winners Portugal and Czech Republic rest in large part on captain and midfielder Hakan Calhanoglu, a key part of Inter Milan's Serie A-winning side.Hopes are also high for attacking midfielder Arda Guler after the 19year-old came back from injury to score five goals in five games at the end of Real Madrid's victorious La Liga campaign.

UEFA.com."But we didn't come here just to attend, we wish to leave our mark on Euro 2024, to write a new page of history."With a Portugal side full of talent expected to top Group F, Turkey and Czech Republic, who face each other on June 26, will be the likely contenders for second place.Turkey, though, must first overcome a Georgia team who may be unburdened by expectation as they aim to become only the fifth side to win the title on their debut in a European Championship.
