# Delhi court cited lack of direct evidence by ED for grant of bail to CM Kejriwal

New Delhi: While granting bail to Chief Minister Arvind Kejriwal in the excise policy case on Thursday, a Delhi court's order had cited the Enforcement Directorate's (ED) failure to present direct evidence linking him to the proceeds of crime.In a turn of events on Friday, the Delhi High Court has stayed the release of Aam Aadmi Party (AAP) leader Arvind Kejriwal on bail and the hearing in the case is going on today. In its observations, the trial court noted that the ED admitted the evidence on record was insufficient to proceed against CM Kejriwal, suggesting that the agency was still attempting to procure further evidence. The court in its order expressed strong reservations about the credibility of the approvers, criticising the ED's tactics. The court said, "The argument that 'investigation is an art' raises concerns. If taken to its logical extreme, it implies any person could be implicated and detained based on selectively-procured evidence, which indicates bias from the investigating agency."

The judge said that the ED must act "promptly and fairly" to uphold the principles of natural justice. The court pointed out several issues: 1. Kejriwal was not named in either the CBI case or the ECIR FIR. 2. Allegations against the Delhi CM emerged only after statements from certain co-accused. 3. Despite not being summoned by the court, Kejriwal remained in judicial custody at the ED's behest.Further, the court found no evidence that co-accused Vijay Nair acted on CM Kejriwal's instructions.It also questioned the ED's conclusions regarding Vinod Chauhan's connections and the alleged proceeds of crime, including an unclarified sum of Rs 1 crore and an unsubstantiated amount of Rs 40 crore.Quoting the legal maxim, "Justice should not only be done but seen to be done," Judge Bindu stated the importance of perceived fairness in judicial proceedings.

A petitioner urged the court to bring the NEET exam under its direct monitoring."We are seeking re-conduct of the exam as NTA has withheld material information," a lawver argued.

Unreasonably long duty hours and peretual staff shortage cannot be the foundational basis of a team that is otherwise ready or even motivated to ead a sustained fight against drugs. Stopping the flow f drugs, through drones from across the border or from orts in Gujarat and Maharashtra, needs constant vigil and thus, enhanced state-Centre coordination. A reducionist view confining the drug menace to being a Punjab-centric issue and notions of victimhood may be appealing for politicians to indulge in the customary lame game, but that would be a waste of effort. # Prohibitory orders in Noida until June 19 in view of religious festivals, protests

In view of religious festivals and protests proposed by various organisations, the Gautam Buddha Nagar police on Sunday announced prohibitory orders under Section 144 of the Code of Criminal Procedure (CrPC) in Noida and Greater Noida until "Due to Ganga Dussehra on June 16, Bakrid on June 17, and the three days of Kurbaani observed by the Muslim community, along with protests by various organisations, there is a possibility of disturbing the peace by anti-social elements. Peace may also be disturbed due to protests by various party workers, farmer organisations, and other protesters," said Hirdesh Katheriya, Additional Deputy Commissioner of Police (law and order).

"Considering the seriousness and urgency of the situation and due to time constraints, it is impossible to provide an opportunity to hear to any other party. Therefore, this order is being passed ex parte (done with respect to or in the interests of one side only or of an interested outside party)," added the officer.As per the order, there will be a complete ban on drone cameras within a 1 km radius of government offices. Additionally, there will be a limited ban on playing loudspeakers from 10 pm to 6 am in religious places. Moreover, there will be a prohibition of rallies, religious activities, worshipping, namaaz, and other events in public places.Officials stated that no procession or rally of five or more people can occur, nor can five or more people gather at a public spot without police permission.

The order said that permission must be obtained from the police commissioner, additional commissioner, or deputy commissioner in unavoidable circumstances. It added that no religious flags, banners, or posters should be placed on religious places or walls."No person shall let animals like pigs, dogs, etc. roam on the routes of religious places and near religious places during religious gatherings, which may hurt the sentiments of any individual or community," it said.Officials said violators would be punished under Section 188 (disobedience to order duly promulgated by public servants) of the Indian Penal Code (IPC). The order further said the Noise Pollution (Control and Regulation) Rules, 2000, regarding the sound intensity of loudspeakers during festivals must be followed.As per regulations, the maximum sound intensity levels are set at 40 to 75 decibels for religious places, 65/55 decibels in commercial areas, 55/44 decibels in residential areas, 50/40 decibels in guiet areas, and 75/ 70 decibels in industrial areas during both day and night

# **'Never lost his appetite for justice': Family and friends remember 66-year-old who fought for 1984 anti-Sikh riot victims**

Wazir Singh's eyes glistened with tears when he recalled his years of friendship with Mohan Singh. They had met at the Sikh Camp in Farsh Bazaar in the aftermath of the anti-Sikh riots in 1984. "We were hungry for justice back then," he said. "Mohan ji never lost his appetite for it."On November 1, 1984, the day after Indira Gandhi's assassination, when mobs began attacking Sikh communities across Delhi, Mohan watched his two brothers - Kewal and Mewal Singh - be killed and set on fire. He barely escaped. When he tried to alert the police at Kalyanpuri about the situation unfolding in Trilokpuri's Block 32, he was beaten and turned away. He then rushed to alert his reporter friends, Alok Tomar, Rahul Bedi and Joseph Maliakan, about the violence - leading the men to witness one of Delhi's most blood-curdling chapters of history.

Mohan hid for the next three days. When his family met him in the Farsh Bazaar camp after 10 days, they were taken aback. "I thought he had died...," said his wife, Sunita Kaur (65), as she took off her glasses to wipe her tears.On April 29, the 66-year-old passed away after a long battle with liver complications and jaundice. Family and friends recalled how he helped the community get back on its feet and was unafraid of standing up to those in power. "It was like he was bitten by a bug after that," said Harvinder Singh (40), Mohan's nephew. "He left autodriving and took up social work..."Mohan's nephew still lives in the two-bedroom apartment given to their family by the government after the riots in Tilak Nagar's Widow Colony. Sunita cannot help but note the irony of the situation. "They killed all our men and then gave us empty



#### houses to fill," she scoffed.

Yet even these houses were not easily given to the victims of the riots. "He fought to get us our allotted houses from the government," said Vijay Singh (52), who runs a general store in the area. "Even after we got our homes, we didn't have a single thing... not a bed to sleep on, not a utensil to cook in... Mohan ji helped the community stand on its feet again," he said. In 2009, when Congress's Sajjan Kumar and Jagdish Tytler, accused in the riots, were declared candidates from Delhi for the Lok Sabha election, the Sikh community in Tilak Nagar was shocked. "Mohan ji had helped us organise a protest in front of Sonia Gandhi's office then," said a 74-year-old tent business owner, also named Mohan Singh. "He helped witnesses go to Karkardooma court and present their testimony against Tytler...," he said."People who knew him are slowly getting to know that he's passed away ... so many people I didn't even know he was associated with

General S I Bhatia Museum for the History of Medicine, tucked away at St John's Medical College Hospital in Koramangala.Major General Sohan Lal Bhatia, the museum's namesake, had a notable career, holding prestigious titles such as the Order of the Indian Empire, and a Fellowship of the Royal Society at Edinburgh. He also served with the British Indian Army as a doctor, winning a Military Cross for his service at the famous Battle of Megiddo in 1918 against the Ottomans.

While his efforts to preserve the history of medicine immediately after Independence did not bear fruit, he went on to start the Department of History of Medicine at St John's in 1964. The museum came 10 years later. While the phrase "medical museum" might bring bones and jars of formaldehyde to mind, a large part of the museum also contains literary and artistic representations of the history of medicine. For instance, one of the first things that visitors are likely to see is a 1945 copy of the Field Service Hygiene Notes issued to the Royal Army Medical Corps. Also displayed throughout the museum is a set of artistic prints from 1960 produced by Parke-Davis and Company. These prints, which are part of the second edition of a series titled A History of Medicine in Pictures, memorialise major events such as the first vaccinations against smallpox.Older medical instruments - such as vintage stethoscopes and over a century-old Bausch & Lomb microscope, Major Gen Bhatia's medical kits can also be seen at the museum.An old Commodore computer that was used at St John's is also an appropriate display in India's Silicon Valley. Dating back to the late 70s, this device ran on a 1 Megahertz CPU (modern consumer processors operate in the multi-gigahertz range). Other items seem archaic but are only a few decades removed from modern medical practice. A portable midwife kit would have helped midwives perform deliveries at home around the 1920s, while mortars for compounding and grinding medicine were essential until the development of the modern pharmaceutical industry

An archive section above the museum also contains medical texts and papers as old as the early 19th century. While the core of the collection is from Major Gen Bhatia's bequest, it has been expanded by other donors as well. The collection is currently being digitised on account of the frailty of some of the books. According to curator Radhika Hegde, the museum is also working on an Indian medicine section, complete with a herb garden for younger visitors to interact with. Also of note is an upcoming museum event scheduled for June 22 and June 29. Archiving Health Histories is an event intended to "create a safe space for community members to share their lived experiences and personal health histories.....and contribute to a people's medical archive". More details about the registry may be found in the attached poster. The museum is open from 10 to 4 pm on weekdays, and until 1 pm on Saturdays. # How a couple that met on Instagram became serial vehicle thieves

During their questioning, the police found out two had already spent time in prison for vehicle thefts, were released on bail in February, and resumed stealing. Their modus operandi was to steal motorcycles and then use them to steal the cars.A team from Sinhagad Road Police Station led by Assistant Inspectors Sachin Nikam and Santosh Bhandwalkar were pursuing the thieves who had stolen bikes and cars in February. Earlier this month, Constables Uttam Taru, Rahul Olekar, and Shivaji Kshirsagar received a concrete lead. On June 7, as the team finally zeroed in on their location, the two were traced and caught when they were in a car in the Wadki Nala area of Loni Kalbhor. The police arrested the man, 24, who is from Baramati, and detained the woman, 21, who hails from Solapur. The man is in police custody till June 18.

Nikam said both are school dropouts from very weak financial backgrounds who battled family issues at a young age. "Their questioning revealed the two had met on Instagram more than three years ago and subsequently got married. They were arrested in October last year by another police unit for a series of vehicle thefts and were in prison till February when they were released on bail. Since then, our probe now suggests, the couple has stolen 17 vehicles, including eight cars and nine bikes," said Nikam.According to Nikam, six of these 17 thefts were from Sinhagad Road police jurisdiction and 11 from Bharti Vidyapeeth, Kondhwa, Hadapsar, Koregaon Park, and Wanawadi areas in Pune and also from Nagpur. "After stealing these vehicles in Pune they sold them in Nagpur, Shirdi, and Shrirampur areas of Maharashtra. After their arrest, we have recovered and seized all the 17 stolen vehicles, based on the information they provided," he said

A police officer, who is part of the probe, said the couple started stealing vehicles over two years ago to earn easy money and continued to do so. "They have been on the move since. The two never had a permanent place to live... primarily to evade arrest or getting caught. People are less likely to have suspicions of thefts when a man and woman are seen together and the couple took advantage of this idea. They used to steal a bike and then move to the area from where they intended to steal



cars. The two kept watch on the target by renting a room in lodges. They stole cars mainly in the night hours. They sold these stolen vehicles outside Pune," said the officer."Our preliminary information suggests that before the two were arrested in October last year, the two had stolen at least 14 vehicles from various parts of Maharashtra. We have recovered from them a large bunch of duplicate keys and the tools they used to steal the vehicles," added the officer.

## **Unsung heroes of Mumbai's beaches**

It's a cohort of 93 men, the neon orange of their uniforms a sharp contrast to the sea blues stretching out ahead of them. And yet, Mumbai's heroic lifeguards are easy to miss amid the sound and fury of the beaches. Home to several beaches, the coastal city of Mumbai is flanked by the Arabian Sea on three sides and has a shoreline of 149 km. Come monsoon, the city's shores witness a surge, alongside the swell in the sea currents, in the incidents of drowning.

Take a case in point from last year when less than a month of monsoon onset, nine persons including eight minors lost their lives by drowning in the sea at various beaches in Mumbai.To tackle these mishaps, Brihanmumbai Municipal Corporation (BMC) and Mumbai Fire Brigade (MFB) have deployed 93 lifeguards, provided by a private agency, along the coast throughout the year, while a team of 11 personnel from the civic body are also kept on standby and roped into action in the event of any major drowning incident. The lifeguards are deployed at six city beaches - Girgaon, Dadar, Juhu, Versova, Aksa and Gorai, which are thronged by lakhs of tourists annually, with many tourists also arriving at the beaches during monsoon to enjoy the high tidal waves.Even as the city has a shoreline of 149 km, a senior MFB official maintained that the civic body deploys lifeguards at only the six beaches as these receive the maximum footfall.An official told The Indian Express, "During a court case when a PIL had been filed in light of the increasing drowning incidents in Maharashtra, the tourism department had conducted a survey of locations where people can venture into the seas easily

Following their survey which studied the footfall, sea currents, surface of the beach etc, they identified six beaches which include Girgaon, Dadar in the city alongside Juhu, Versova, Aksa and Gorai in the suburbs as spots which were most prone to cases of drowning. Therefore, as per the orders, we provide lifeguards at these beaches."Data procured from the civic body shows that between 2019 and 2023, a total of 435 cases of drowning were reported across beaches, nullahs, lakes, wells etc. The highest number of incidents were reported in the sea waters, particularly at Juhu Chowpatty.

According to civic officials, 73 people have died in several incidents of drowning between 2019 and 2022. In 2023, meanwhile, within a month of monsoon onset, nine persons drowned in the sea. In the gap between the drowning reports and the actual cases of deaths lie in huge part the city's unsung heroes - its lifeguards."Through a private agency, we deploy 93 lifeguards across the city. They guard the beach throughout the year. However, as per our tender contract, during high footfall periods, the personnel are increased by 25 per cent

Alongside this, the BMC also has its own team of 11 lifeguards. Whenever we get a call related to big accidents wherein 3 or 4 people have drowned, our team also comes in to aid the rescue operations," said a senior MFB official.Last year, in the light of the tragic deaths by drowning, the BMC had announced the deployment of additional lifeguards with officials stating that the total number of rescuers would be increased to 120 during the 2023 monsoon.Adding that the civic body has a fleet of equipment to aid in the rescue operations, he told Express, "We have seven jet skis, floating stretchers, boats, lifebuoys, tubes, ropes among other equipment. Depending on the type of calls that we receive, we dispatch these devices."At 5.30 pm on Juhu beach, teeming with tourists to enjoy the sunset, lifeguards-Santosh Tandel and his cousin Yadnesh Tandel— watch over the shoreline with hawk-eyed precision. Their pet dog, Bobby, stands by closely. "In the evenings, there is a sharp rise in visitors. But it is during weekends when the crowd increases drastically. On such days, some lifeguards stay in the sea at all times," says Santosh Tandel, who works with Drishti Lifesaving, the agency appointed by the civic body.

Monsoon, when the water currents are strong, pose the hardest hurdles during a rescue operation. "During monsoon, the underwater currents are much more intense. Therefore, in peak monsoon, we install ropes on the 11 entrances to the beach and try our best to prohibit entry by visitors during high sea levels," he says.Dhamendra Jadhav, a training instructor with Drishti Lifesaving told Express, "Despite our warnings, people often venture in the seas and during monsoon, the currents being strong are pulled away into the sea. Since the waves are very strong, this makes it difficult for us.Blue bottle jelly fishes that populate the beach during monsoon and often sting the visitors, are another problem faced in this period." Each lifeguard undergoes a thorough training spanning 45 days where they receive physical training alongside education on several rescue techniques. Hailing predominantly from the Koli community, the lifeguards are also trained in identifying the people entering the sea and categorise them as swimmers, non-swimmers, injured swimmers and weak swimmers. Pointing to his rescue kit, Tandel says, "If a person's head is above the sea when holding the equipment, there is a high chance of their survival. It's very difficult, meanwhile, to save a drowning person whose body is submerged in the water."In a bid to ensure familiarity with all types of shores, the lifeguards work on a rotational basis with the rescuers deployed at different beaches. While the lifeguards work in two shifts of eight hours each, their days are often marked with boredom, unless there is a rescue operation.

Despite being a coastal city, Mumbai faces a significant crunch of lifeguards, according to rescuers. "Lack of manpower amid the high footfall is one of the key issues in Mumbai. Ideally, there should be a lifeguard at every 100 metres. But in reality, at many locations there are no lifeguards for several kilometres," said a lifeguard.Explaining the difficulties, Dharmendra Jadhav added, "At Juhu beach, for instance, we have deployed lifeguards at every 300-metre stretch. However, even that isn't enough. When we see someone drowning a short distance from us, we can rush very fast and save them. However, if a lifeguard spots someone drowning 300 metres away, it takes a while to even reach them. The shortage of manpower becomes more challenging during footfall periods like Ganesh visarjan, when thousands flock the beaches." Many echoed that often their requests during high alert situations at beaches fall on deaf ears, since lifeguards are not legally empowered to prevent people from entering the seas.

Requesting anonymity, another rescuer at Versova beach told Express, "Our work only pertains to rescue when there are accidents or mishaps. Barring that, we have no authority to stop anyone from venturing into the waters or do anything that may lead to any accident. If we are given some rights, it will enable us to prevent any drowning incident even occurring in the first place."The lifeguards are deployed at six city beaches - Girgaon, Dadar, Juhu, Versova, Aksa and Gorai, which are thronged by lakhs of tourists annually. Speaking to The Indian Express, a senior official from Mumbai Fire Brigade said that there is a need to strengthen rules as well as improve awareness among citizens to prevent deaths by drowning." Even as we deploy the lifeguards and our own staff, people's attitude cannot be changed. Often when people are asked not to go to sea, they pick up fights with the rescuers and there have been incidents where they even injured the lifequards. In other cases, people evade the rescuers and deliberately go to secluded pockets and get swept away by the waves," the official said. He added, "Currently, the rules are very lenient. But more importantly, there is a lack of sensible approach among the public. That needs to change."Meanwhile, seeking to strengthen its rescue ops during drowning incidents, the BMC-in its fiscal budget for 2024-2025-announced a new project where six robotic life-saving buoys will be procured by the fire brigade.Last year, the MFB also started testing unmanned drones which have the capacity to carry a maximum payload of 100 kg and can carry out operations by going deep into the sea.

# **GMSH-16** sends proposal to **Chandigarh for super-specialty block**

ON average, the OPD numbers of the Government Multi Specialty Hospital (GMSH 16) are about 3,000 patients from across the region, plus attendants. Built in 1952 for a population of about five lakh, the district hospital now has patients being referred to its various departments from across the region, with the highest of about 350 to 400 in the gynaecology department itself."We are a district hospital, but work like a medical college, and are now bursting at the seams, as we have no space to expand. If we do go vertical, it means shifting many departments, and the question is where. The hospital cannot close any facility, with a high number of patients being referred to from across the region. Apart from improving health facilities and infrastructure, on the periphery, the need of the hour is to have super-specialty services here at GMSH-16, starting with cardiology, nephrology and neurology...Also as a hospital, we need to grow and move ahead, so we have sent a proposal to the Adminis-

tration for a super-specialty block here," says Dr Suman Singh, Director, Health Services.

As per Dr Singh, the idea of having specialty services here is to also decrease the hospital's dependency on PGI, which is already overburdened with patients, and always facing a shortage of beds. "We have to refer patients to the institute and GMCH-32 due to lack of specialty departments and that causes a delay in treatment and a lot of running around for patients," she adds. The director is keen to bridge the gap between government and private hospitals in terms of infrastructure, facilities, amenities, and patient care, and so a few areas in the hospital are being upgraded and renovated, with work on for the last two months on the renovation of the gynaecology private rooms, with about 200 beds being shifted to other areas of the hospital.

The emergency of the hospital is also being renovated for space, better placement of beds, and modern amenities. The area caters to 250 to 300 patients daily, with a provision of 70 beds, and more make-shift ones created on trolleys and wheelchairs. In the season of viral fever, dengue, and other seasonal illnesses, the number goes up, with the area inadequate to give the best care."Better and more powerful lighting, oxygen supply to every bed, pull-in curtains for privacy, separate entry and exit points, modern toilets, and restructuring of the entire area is on the cards so that patients can be given amenities like private hospitals. Due to lack of space, our advanced gynaecology centre is on hold, as we cannot shift the existing set-up. Several proposals for expansion have been sent and we hope we get a positive reply," sums up Dr Singh.

# Protest at Delhi Jal Board office leads to smashed windows; AAP sees BJP hand, it hits back

She also alleged that BJP Yuva Morcha district president Dheeraj Singh Rajput was part of the violent protest and that BJP flags were visible during the protest. A senior Delhi Police officer said men and women who had gathered outside the office broke the glass using pots. CCTV footage of the incident has been collected, he added."We've received a complaint in the vandalism incident inside the Delhi Jal Board office in Chhattarpur from an official of the agency on Sunday evening... We are looking into it. The scene has been inspected by the crime team and statements of witnesses will be taken before an FIR is lodged," the officer said.Ex-MP Ramesh Bidhuri did not respond to calls seeking a response. The Delhi BJP said the party does not approve of any kind of violence but whatever happened at Chhattarpur was not a "case of violence"

Delhi BJP Vice-President and Kalkaji councillor Yogita Singh said, "The BJP does not approve of any kind of violence but whatever happened today was not a case of violence. The entire South Delhi is parched, there is no water supply for days at a stretch. Be it local AAP MLAs or DJB employees, all have been evading people."At a press conference Sunday, Atishi said the attack was part of a conspiracy and shared footage from the incident that purportedly showed people wearing BJP



sashes throwing pots and stones at the DJB office."First the BJP is stopping water supply to Delhi through its government in Haryana. You go to Wazirabad Barrage, there is not a drop of water... If the BJP will not provide water to Delhi, if water will not reach the treatment plant, then how will water be supplied?" she said. She also questioned the leakage in pipelines. "Yesterday (Saturday), the main pipeline that supplies water to South Delhi from Sonia Vihar was broken... was this another part of a conspiracy under which water pipelines are being damaged?" she asked.She added, "The third step of their conspiracy has come to light, in which BJP 'goons' vandalised the DJB office.

She also urged the police to take action. "We have complained... Now, we will wait to see whether the Delhi Police will file an FIR against Ramesh Bidhuri...," she said.Singh hit back and said, "During a demonstration today, the people of totally parched Chhattarpur grew restless and threw a matka leading to breaking of a glass pane... it is shocking to see Ministers Atishi and Saurabh Bharadwaj calling parched demonstrators goondas... Delhiites will never forgive such ministers..."

# **Palace, observatory?** Many shades of Sher Mandal, where Humayun met his end



A popular legend about Humayun, the Mughal emperor who succeeded his father Babar to the throne in the 16th Century, is that he fell to his death after tripping down the stairs of his observatory - some versions say it was a library — to answer a prayer call but few know that the ruler's beloved structure is situated in the heart of Delhi.

A little over four kilometres away from his final resting place, the iconic Humayun's Tomb, is the centuriesold Purana Qila which has borne witness to the rise of empires and horrors of Partition when it served as a home for refugees.Enter its main gate, take a right from the Tpoint and one will be greeted by a lone, red sandstone structure, with a cupola on the top. This is the Sher Mandal.

It is widely believed that Sher Mandal was built by Sher Shah Suri, ruler of Bihar who had managed to defeat the Mughal Empire to establish his rule, until his life was cut short in an accident, paving the way for Humayun's return. Historian and author Rana Safvi writes in her book, The Forgotten Cities of Delhi, "Emperor Sher Shah constructed this in 1541 AD as a 'Jahannuma' (or, 'reflecting the world'), naming it Sher Mandal. It is said this small palace could not be completed."However, author and historian Swapna Liddle writes in her 14 Historic Walks of Delhi: "Sher Mandal is a name familiar in history as a palace built by Sher Shah, though it is not at all certain if this was that building; it may have been Humayun who actually had this constructed. This is because, in style, this building is quite similar to some Mughal Pavilions described in historical accounts or seen in illustrations of that period. It certainly does not look like a palace..."According to reformer and educationist Sir Syed Ahmed Khan's book Asar-us-Sanadid (The Remnant Signs of Ancient Heroes), the entire fort was once called Sher Mandal "because of this beautiful building, which is constructed completely of red sandstone. The design includes a narrow circumambulatory aisle constructed around a central room.<sup>3</sup>

Going by Sir Syed's book, first published in 1847, the structure served both as a library and an informal observatory. "He (Hum-ayun) would also climb to the top



to study the sun, moon and stars [astronomy was a passion]."Throwing further light on the architecture of the monument, Safvi writes in her book: "Sher Mandal is an octagonal three-storeyed monument with a narrow balcony running all around the second. On the third floor is an open pavilion with a parapet running around it. This is surmounted by a small eight-columned cupola, which is decorated with floral and geometric design..."In January 1556, barely months after he had regained the throne, Humayun fell to his death at Sher Mandal.

Sir Syed writes in his book: "Death needs but an excuse? Once, while going down the stairs he heard the call for evening prayers and sat down until the call was completed. Then, as he pulled himself up, holding on to the chain that acted as a banister [jarib], it slipped from his hands and he fell down the length of the staircase, dying a few days later from the severity of the injuries he sustained."Later-day historians, however, refute this theory, saying the staircase was winding and he could not have fallen from it, according to Safvi. "Humayun was a keen astronomer, and that night Venus was rising late. He was studying it when he fell over," Safvi told T"Mountstuart Elphinstone and John Clark Marshman say that he fell headlong from the parapet of the roof. The chronogram of his death is: 'Humayun Badshah az baam uftad [Emperor Humayun fell down from the roof]'.

Passing through the heart of Ludhiana, Punjab's industrial hub grappling with extreme air pollution and other environmental concerns since decades now, the 4/ 6 lane Elevated Highway has changed city's landscape, guite literally. In a first such view for Ludhianvis, the old establishments on Ferozepur road such as the iconic Punjab Agricultural University (PAU) or Hotel Park Plaza, the city's first 'five-star' facility are now half-visible, with huge flyover erected at their front. The city has also sacrificed iconic spots such as Aarti Chowk, which had the statue of noted Punjabi poet Prof Mohan Singh, for the project.

However, the 12.65-km-long Elevated Highway, from Samrala Chowk to MC limits (towards Jagraon) via city's bottleneck Bharat Nagar Chowk and Amar Shaheed Sukhdev Thapar bus terminal (main bus stand), has come as a breather for residents of Ludhiana, who have been relieved of constant congestions and traffic woes, to a great extent. The end to end travelling time from Samrala Chowk to MC limits has been reduced from 30-40 minutes to 8-10 only, thus saving at least 20-25 minutes. What still remains a major concern is the lack of greenery under the long flyover, where the patches of soil beds are lying barren and parched, without a single sapling planted either by the National Highways Authority of India (NHAI), which has undertaken the entire project, or the local Municipal Corporation. Started in October 2017, the project initially had met with a lot of resistance from city residents as at least 3,000 trees were chopped for it from Ferozepur road, the city's lifeline (previously NH-95 and new NH-5).Executed by the NHAI, the elevated road has been constructed for Rs 756.27 crore (entirely funded by the

Centre via Union Ministry of Road Transport and Highways). It was finally completed in March this year. What has come as another major relief is the accessibility to the city's main bus stand, also near the perennial bottleneck Bharat Nagar Chowk, and now residents of colonies on Ferozepur road such as Aggar Nagar, Rajguru Nagar, BRS Nagar, Sarabha Nagar, PAU residents, etc can reach bus stand in less than 10 minutes, which earlier took at least half an hour.

ACP (traffic) Charanjiv Lamba says that the Elevated Road has become the lifeline of the city, relieving residents from congestions and traffic snarls on the Ferozepur road, which is also a national highway. "Places such as Samrala Chowk, bus stand have become easily accessible. It is not only reducing the travelling time for the people but also saving fuel and will help in reducing pollution due to congestion-free drive on the flyover," says ACP Lamba. However, some issues with the design still remain. "I have also written to the NHAI for extending the median at Bhai Wala Chowk by 200 metres and some redesign work which is required at Bharat Nagar Chowk," says ACP Lamba. The project will also help residents in reaching the upcoming Halwara Airport in lesser time.

No green coverLack of green cover under and along the new flyover has made the new project merely a concrete jungle. Ludhiana is among the most polluted cities in the world, the major sources being industry and massive vehicular burden.Navratan, project director, NHAI, Ludhiana, said that they have already compensated for the lost greenery by carrying out plantations elsewhere as per original plan. He said that planting saplings under the flyover was not a "part of the original project". "Planting saplings under the flyover was not a part of the original project. But seeing the demand of the residents, we are taking it up and might plant saplings in coming months," said the NHAI official."Directly, the project has reduced travel time and congestion but indirectly, it will also reduce vehicular emission and save fuel due to hasslefree driving," said NHAI official.Rahul Verma, member. Punjab State Road Safety Council, said that greenery was not only missing under the flyover but also along the highway from where trees were chopped for the project. "It is NHAI's moral responsibility to restore green cover on Ferozepur road from where they had chopped several grand-old trees for the project," said Verma

# Over 2 lakh people fined so far this year for improper parking in Delhi, most from Punjabi Bagh

Over 2 lakh commuters have been challaned by the Delhi Traffic Police so far this year for the offence of improper parking, officials said.According to statistics, Delhi Traffic Police booked 2,40,152 violators for improper parking until May 31, a significant rise from 1,77,800 for the same period in 2023 – marking an increase of 35% in prosecutions. According to data, Punjabi Bagh area saw the highest number of challans for improper parking, around 14,170, followed by Rohini with 9,615.

Said an officer, "We have also conducted a comprehensive analysis of the 10 traffic circles where the highest number of challans were issued in 2024 due to improper parking. The investigation has identified specific areas where the violations are most frequent. By pinpointing these locations, targeted enforcement measures can be implemented to improve adherence to traffic laws."According to the Delhi Traffic Police, "In addition to issuing challans, the Delhi Traffic Police has also been actively towing vehicles that are parked illegally, especially in areas that are prone to heavy traffic or are designated as no-parking zones. This immediate removal of improperly parked vehicles has helped maintain smoother traffic flow and reduce the risk of accidents."

# Teachers protest SOPs by Daulat Ram, DU for appointment as assistant professors; varsity free to choose criteria, says UGC

Two notifications — one issued by Daulat Ram College, and the other by Delhi University (DU) — has triggered discontent among several teachers who claimed that they go against UGC guidelines. While one notification asked faculty appointed as Assistant Professors at Daulat Ram to undergo rigorous training in computeraided teaching within six months, and submit its proof, the other, issued by DU, requires aspirants to the same post to make a presentation of their body of work to the interviewers in the first round following which they will be permitted to sit for the interview round conducted by the final selection committee.

The UGC chairman, meanwhile, said being autonomous bodies, universities were free to choose qualifications and other processes over and above the minimum standards provided in the UGC regulations with the approval of their statutory bodies. In a notification last week, Daulat Ram College said, "All the faculty appointed as Assistant Professor at Pay level-10 have been directed...to undergo rigorous training in teaching pedagogy/computer-aided teaching methodology including digital technology useful for classroom teaching... The proof...must be submitted to the principal office for their cases to be considered for confirmation."In an email to Vice Chancellor Yogesh Singh on June 15, teacher members of the Academic Council, Executive members, along with Delhi University Teachers' Association members wrote: "Directly linking teacher training programmes and confirmation is a clear cut violation of University Ordinance."College Principal Savita Roy told The Indian Express: "It (the notification) is self-explanatory. It was decided by the Governing Body. My teachers are already meeting this criterion; so why the hue and cry?"Officials at the DU administration stated that this was not a university-wide directive. Said an official: "If a policy is being implemented, it should be done so in consultation with the university administration, and it must be the same for all colleges

Earlier, DU, on June 3, issued a Standard Operating Procedure (SOP) for recruitment of Assistant Professors, the process for which now includes a separate round for "Assessment through Presentation Assessment



Campus Director Shri Prakash Singh said, "This procedure was already in place for recruitment in departments. Now, this is being implemented in appointments across colleges too. This was passed by the Executive Council in December last year. This has been put in place to ensure transparency so that candidates get more time to present their case for a fair appointment. It is not a violation of the UGC."

According to M Jagadesh Kumar, chairman of University Grants Commission (UGC): "If candidates are required to make presentations, it provides an opportunity for them to demonstrate their abilities in ways that written applications or traditional interviews cannot capture. It will help the committee identify candidates with teaching proficiency, depth of subject matter knowledge, and alignment with the objectives of the teaching post." However, a section of teachers disagrees with this. A statement issued by Dr Maya John, Elected Member, Academic Council, DU, on June 11 said, "The new SOP does not restore any transparency to the hiring process...as there is neither any mention of reducing the full weightage assigned to the interview, nor the assigning of higher weightage to more objective parameters like academic record, teaching experience, and research work during the interview stage."Abha Dev Habib, Associate Professor at Miranda House College, said the SOP was unacceptable. "The SOP is against the interests of serving teachers as it reduces the number of candidates who can appear before the Selection Committees. Appointments in many colleges are pending and many colleagues wi

# From treatment plants to taps, why over half of city's water goes missing in transit

Delhi may be pumping out over 900 million gallons of water from its water treatment plants, but less than half of this can be accounted for.According to the Economic Survey of Delhi 2023-24, 58% of the water produced by the Delhi Jal Board is "non-revenue".

## But what does non-revenue water mean?

After water is pumped by water treatment plants, it goes to reservoirs and is ultimately transmitted to different parts of the city. Not all of it reached the destination, though, and some was lost in transmission. The difference between the water that leaves the water treatment plants and the water that is billed - domestic or commercial - or can be accounted for, is considered nonrevenue.It is either stolen or leaked. Across the globe, the average of non-revenue water is around 25% to 30%. In Delhi, official records say the percentage is much higher.In 2021, of the 925 MGD of water produced on an average from April to December, only around 419 MGD was delivered to consumers and billed. In 2020-21, the percentage of non-revenue water stood at 51%, up from 42% in 2019-20. The reason cited for high non-revenue water is "non-billing of consumers in quarter four of 2020-21 and quarter one of 2021-22 due to Covid-19 and non availability of billing agency."

## Where does this water go?

While a large amount is stolen by those operating water tankers, a significant amount is also lost because Delhi's pipeline network is old."Because these lines are not laid in a dedicated corridor, leakages come forward only when there is a big road cave-in, or when water makes it to the surface and people start noticing. Several pipelines in Delhi are many decades old and are rotting," said a senior Delhi government official on condition of anonymity.But leakages in arterial pipelines, which are



mostly above the ground, are rarely accidental, officials say."There are elements of unequal and unfair circumstances and criminality here. There are times when locals may not be getting adequate water for several days and out of compulsion they may loosen a few screws to release some water. But more probable is the private water tanker owners puncturing the lines to steal water," the official added.While losses in transmission are common across utilities, non-revenue water is among the biggest in terms of size, globally.

But why can the DJB not cut these losses?

Over the past few years, a project to install flow meters at different stages of distribution had been underway. Flow meters can indicate the difference in flow between two points. If the flow is measured at point A and falls by the time water reaches point B, it indicates a leak or pilferage between the two points. The project is at the stage of implementation. A total of 2,715 flow meters were to be installed in the first phase, of which 2,691 were in place. The project cost for all packages was Rs 224 crore. Another 1,537 meters are to be placed in phase 2, which is underway.

# Before Rajkot fire, how game zones sprang up: No clear guidelines, lure of quick money

What goes into the setting up of a game zone? How hastily are these gaming areas set up amid rising demand? Was it all fun and games until tragedy struck Rajkot? ADITI RAJA & PARIMAL DABHI delve into the gaming business in the wake of the deadly TRP Game Zone blaze.

A gigantic model of a piranha fish that stood tall in Ahmedabad's GMDC Ground was hard to miss on the busy 132 Feet Ring Road. The huge installation that housed an "underwater aquarium" was the highlight of a summer fun fair that was set to open in the last week of May on the GMDC Ground. Or so was the plan until a massive fire at Rajkot's TRP Game Zone claimed 27 lives, including two children, on May 25.A statewide crackdown on game zones and amusement parks in the aftermath of the tragedy ensured that the fun fair that promised "foreign rides in Ahmedabad" — as claimed on its Instagram handle — was never opened to the public.

Nearly Rs 2 crore was spent to rent the GMDC ground from its custodian — Gujarat University, said Vakil Ahmed Khan, manager of the fun fair. The organisers also got No-Objection Certificates (NOCs) from various authorities, including the Ahmedabad Fire & Emergency Services (AFES), the Light Inspector of the state government, and the city traffic police. In addition, they got a fitness certificate of rides and the foundation certificate from a team of Roads & Buildings Department following spot inspections by the department officials concerned. According to Khan, all the permissions and NOCs can be obtained in 15-20 days on average to run such fun fairs. He says they planned to start the fair on May 23 and run it till July 31. But a delay in the police permission and then the Rajkot fire disrupted their plans. (Express Photo by Nirmal Harindran) According to state government data, 20 of 101 game zones across eight municipal corporations that lacked fire NOCs and Building Use (BU) certificates were sealed after inspections. The rest have been asked to "shut down temporarily".In Rajkot, eight of 12 gaming zones were sealed — the highest in the state. It was followed by five of 34 in Ahmedabad and three of seven in Bhavnagar. Junagadh saw all four of its game zones getting sealed.Started in 2021, TRP Game Zone stood on JPS Party Lawns and one other adjacent party plot on the posh Nana Mava Road owned by Ashoksinh Jadeja and his brother Kiritsinh Jadeja. The duo are partners at Raceway Enterprise, a firm running gaming facilities. The game zone comprised a tin shed supported by steel frames, two floors as tall as a three-storey building, and 50 metres wide and 60 metres long, police say. Notably, the facility was given a licence by the police commissioner. The proprietors had applied for licences under the Gujarat Entertainment Tax Act, 1977 for ticketed entry. Dhaval Thakkar, another partner at TRP Zone and proprietor of Dhaval Corporation, had sought a booking licence in 2021. Owner Yuvrajsinh Solanki sought a licence for go-karts in November last year. The licence was renewed in January this year and is valid till December. Solanki and Rahul Rathod are the other partners of Raceway Enterprise. Prakashchand Hiran, one of the coowners who was also named as an accused, was among the 27 dead. Ten, including the six co-owners and four Rajkot civic body officials, of the 11 people booked for culpable homicide (not amounting to murder) have been arrested so far. Investigations so far have revealed that a 'snow park' was being added for which welding work was underway at the game zone. It is suspected that the fire started there after a stack of inflammable material got caught in the sparks. "The structure put up by TRP Game Zone does not fall in the definition of the term 'temporary structure' and therefore, statutorily stipulated 'development permission' as prescribed under Regulation 3 of the Comprehensive General Development Control Regulations (CGDCR) from the Rajkot Municipal Corporation (RMC) was required," the Gujarat government submitted in an affidavit before the High Court.Come summer vacations, the "lucrative" business of game zones and amusement parks begins to mushroom across Gujarat. Such facilities have gained popularity among the middle class who seek weekend recreation but cannot afford expensive vacations or club memberships. "Family entertainment zones that are not multiplexes are a new concept that has caught up with the imagination of the upper middle class. The adults who accompany the children also engage in activities at the game zones. Usually, there is a nominal entry fee that often works on a debit card system where you make a one-time card purchase and add the balance as you like to enjoy the rides," says a businessman, who is a partner at two game zones in Surat and Ahmedabad.

On average, ticket prices start at Rs 2,000 at highend amusement parks. In contrast, the entry fee at TRP Game Zone was Rs 20 per person, says the FIR. The cheapest activity was archery for Rs 50, while each snow park experience would have cost Rs 250. However, after the fire accident on May 25, The Indian Express spotted a poster at TRP Game Zone that announced "free entry" along with various other offers, including a discount from Rs 150 to Rs 99 for bowling. "We had plans to charge an entry fee of Rs 100 per person," Ahmedabad fun fair's Khan says. The rides were to be charged between Rs 50 and Rs 150.On average, a game zone well-equipped with entertainment for children and adults gets around 250 patrons on weekends and 100 patrons on weekdays. "While the ticket prices vary, the average cost of soft play in gaming zones for children upto 12 years could

# Leaky, damaged pipelines compound Delhi water crisis — and AAP govt's woes

In the early hours on Sunday, near Kondli Bridge under the Kalyanpuri crossing in East Delhi, a Delhi Jal Board (DJB) staffer got out of his car to check the main pipeline — only to find a local resident atop it. The employee took out his phone and started shooting a video.

The staff member, who showed the video of the interaction to The Indian Express, said locals then closed in, grabbed him, and threatened him to stop recording the video. He said he left the spot after encountering men equipped with a valve-cutting machine to "tamper" with the main pipeline. Around 20 km away, the South Delhi Rising Mains pipeline near Garhi Mendu (Northeast Delhi) was found to have a big leak. Water Minister Atishi said six bolts were removed, which allegedly led to the leak. It took a six-hour shutdown to fix. Roughly 15 km from here, at Anna Nagar near ITO, a new pipeline had to be put in after the old one was damaged. Across localities, the challenges are different but the underlying issue of tampering with the main pipeline is common. In one of Delhi's hottest summers in 80 years, ensuring water availability has proved to be the AAP government's biggest challenge and the point of contention between it and the opposition BJP and Congress.Nitin Tyagi, a former AAP MLA who switched over to the BJP on Sunday, posted a video of locals taking a bath at the Kondli pipeline on X. "Delhi Jal Board has made arrangements for everyone to bathe in front of Pillar 267 near Kondli Bridge. This has been happening smoothly for two months. Is Haryana and BJP to blame for this, Atishi?" he posted.

Atishi, on her part, alleged a "conspiracy" by the BJP to stop the Haryana government from supplying water and to tamper with pipelines at several locations to disrupt the Delhi government's functioning and worsen the Capital's water crisis. When The Indian Express visited Kondli around 1 pm, a crowd of around 50 people, mostly living in nearby areas of Kichripur and Trilokpuri, had gathered to take a bath in the water leaking from the pipe. A few also came with bottles and bigger containers to take home some water.

Dheeraj, 45, a resident of Old Kondli said, "We have come here to enjoy; since it is a Sunday, there are many people. This water is cold and clear, better than what we get at home so I came to collect this."At Anna Nagar, residents complained to The Indian Express about people damaging the pipeline and water contamination. "People in vehicles come frequently to puncture the pipelines. The water we get here is not suitable for drinking," said a

resident who did not want to be named.A DJB official, requesting anonymity, explained the reasons for the poor water quality: "The sewer pipes run parallel to the main pipeline which is why if there are holes, the water gets mixed and there is a chance for contamination."DJB officials too have their work cut out in carrying out constant repairs.

According to an official, repairs have been undertaken at Kondli after a consumer in the locality lodged a complaint. "We have been taking care of this matter for over a month now. Even after three repairs, we find bolts open or the valves cut. If the valves are cut, we need to do welding work which is not easy to do repeatedly," said the DJB official who did not want to be named.He also alleged that illegal water tankers fill up water from the line at night.The official added, "In summer, people are in a frenzy to get relief from the heat; pipelines are tampered with and our efforts to repair them are in vain."Atishi, meanwhile, in a letter to the Commissioner of Police, urged the police to patrol for 15 days and provide protection for the main pipeline network range from Rs 400 per hour to Rs 600 per hour. Arcade and vending games are charged individually ranging from Rs 30 to Rs 150 for a single round of each game that lasts about three minutes," says an owner.

"Adults spend anywhere between Rs 1,500-2,000 per session of arcade games, bowling and other activities, while younger children popularly opt for hour-long soft play sessions with a few video games strategically placed around the soft play areas," he adds. While anyone who can afford to invest Rs 5 lakh can set up softplay areas at malls, a standalone adventure and gaming zone needs more than a basic investment. "It is set up by those who have the means - a businessman with capital, a partner with real estate or an influential partner who has access to government permissions... These are locally owned facilities where the system of operation is almost the same as advised by consultants who have designed play areas in other cities," the businessman explains.All you need to set up such facilities is a vacant plot, a lease agreement with a party for using it for commercial purposes, and consultants to design various activities. The land owner can be a partner in the business or simply a 'lessor'. One needs a space of about 10,000 square feet to set up a profitable gaming zone that has a soft play area as well as arcade games, vending games and a bowling alley. "The investment could range from Rs 1.5 crore to Rs 5 crore depending on the design. This is in addition to the cost of leasing the land or property inside a mall," says an owner. Then comes the staffing costs. A game zone could have 20 to 30 staff members depending on the size of the facility. "When done well, one can generate up to 60 per cent return on investments in a year," he says. Once the land has been acquired, consultancy firms are hired to prepare a detailed model of the gaming zone, including the play areas. The equipment for the soft-play zone as well as gaming consoles, trampolines and other indoor areas are custom-made and imported from China and assembled as per the design. A Vadodara-based owner says the equipment set up at the play areas in his game zone is made of steel with an outer covering of a fire-retardant material for a vibrant and colourful look."Since the lands are on lease, one would not spend on masonry construction. Therefore, pre-engineered buildings (PEB) are given the first preference" the source adds.PEBs are different from pre-fabricated buildings (PFBs) that were used at the TRP Game Zone. "PEBs are globally accepted structures that are designed using CAE (computer-aided engineering) software and made from steel.

They fired back, accusing the New York Post of spinning tall tales. Senior Deputy Press Secretary Andrew Bates took to X to set the record straight, saying Biden was just soaking in the love from the audience

"Fresh off being fact-checked by at least 6 mainstream outlets for lying about @ POTUS with cheap fakes, Rupert Murdoch's sad little super PAC, the New York Post, is back to disrespecting its readers & itself once again. Their ethical standards could deal with a little unfreezing," Bates quipped.

He added, "By pretending the President taking in an applauding crowd for a few seconds is somehow wrong, all they're really admitting — once again — is they can't take on the leadership that's fueling the strongest economic growth in the world & bringing violent crime to a 50-year low."The star-studded event wasn't just about political theatre; it was a blockbuster hit for Biden's campaign, raking in a record-breaking \$30 million-plus. The night sparkled with the presence of Hollywood A-listers like George Clooney, Julia Roberts, and Barbra Streisand.During their chat with Kimmel, Biden and Obama underscored the mission to keep Donald Trump out of power in what's shaping up to be a history-defining electoral showdown.

# Afghan Taliban agree to attend UN's Doha conference

The Taliban government's participation in the conference of foreign special envoys to Afghanistan had been in doubt after it was not included in the first round and then refused an invitation to the second round in February.Taliban authorities will attend the third round of United Nations-hosted talks on Afghanistan in the Qatari capital, a government spokesman said on Sunday, after snubbing an invitation to the previous round.

They will represent Afghanistan there and express Afghanistan's position," Zabihullah Mujahid told AFP.The talks in Doha are scheduled to be held on June 30 and July 1.

Mujahid told Afghan media on Sunday that a delegation — yet to be announced — would attend because the agenda of the talks appeared "beneficial to Afghanistan".The agenda includes "topics such as aid for Afghanistan and creating opportunities for investors in Afghanistan, which are important", he said.Civil society groups that included women were invited to the February talks but the Taliban government refused to participate unless its members could be the sole representatives of Afghanistan.It also requested to meet UN Secretary-General Antonio Guterres.Guterres said in a state-



ment after the February talks the set of conditions to participate "were not acceptable", but that delegates hoped for Taliban officials to attend future meetings.Diplomatic sources told AFP there were plans to consult with civil society groups before and after the third round. The sources said the talks were due to cover finance and economic issues, as well as counternarcotics efforts.Several civil society groups have also urged the UN to prioritise issues involving women's rights at the meeting. The international community has wrestled with its approach to Afghanistan's new government, which has not been recognised by any other state, in the aftermath of the Taliban's return to power in 2021. The Taliban government has imposed a strict interpretation of Islam, with women subjected to laws characterised by the UN as "gender apartheid".

# Michigan splash pad attack: Couple shot combined 7 times while protecting their 2 little daughters

A couple who live in Rochester were shot a combined seven times while protecting their little daughters during the Michigan splash pad shooting. 42-year-old Michael William Nash opened fire at the Brooklands Plaza Splash Pad in Rochester Hills, wounding nine people, before dying by suicide.Micayla and Eric Coughlin were both injured, having been shot a combined seven times, while trying to protect their two-year-old and sevenmonth-old daughters. The shooting site, where the attack took place at around 5 pm on Saturday, June 15, is near

their home.

A GoFundMe set up for the couple says they took their children to the Brooklands Plaza Splash Pad to "enjoy a day with beautiful weather" when they came under the brutal attack. They each grabbed a child to protect them, and were shot and wounded."Shortly after grabbing ice cream they walked to the splash pad and were not even there for a minute when Micayla and Eric heard gunfire," the page states. "In an effort to save their children, they each grabbed a child to protect them."The husband and wife are hospitalised and undergoing treatment at present. The fundraiser, set up by Micayla's friend Noel Wakula, has urged people to help the family with their medical bills."Because of their heroic actions, their children were protected and able to go home that evening," the page reads. "Micayla and Eric face a long and unknown recovery from this unthinkable tragedy." Other victims of the tragedy included three members of the same family - an eight-year-old boy, a fouryear-old boy and a 39-year-old woman. The oldest of the victims was a 78-year-old man who was shot in the abdomen.Nash reportedly suffered mental health issues. His motive is being investigated, but he reportedly had no connection to the victims, according to Detroit Free

# China coast guard says Philippine supply ship bumped Chinese ship in South China Sea

BEIJING, - A Philippine supply ship dangerously approached a Chinese ship resulting in a slight collision after it illegally intruded into waters adjacent to the Second Thomas Shoal in the South China Sea, the Chinese coast guard said on Monday, a claim which Manila's military said was "deceptive and misleading".

The Philippine transport and replenishment ship ignored China's repeated solemn warnings, the coast guard said in a statement. The guard said the vessel deliberately and dangerously approached the Chinese ship in an unprofessional manner, resulting in a collision. The statement made no mention of injuries or damage to either vessel. "We will not dignify the deceptive and misleading claims of the China Coast Guard ," Xerxes Trinidad, chief of the Philippine armed forces' public affairs office, told reporters, adding they would not discuss operational details of resupply missions. "The continued aggressive actions of the CCG are escalating tensions in the region."

The main issue remains to be the illegal presence and actions of Chinese vessels within the Philippines' exclusive economic zone, the military said.Philippine Coast Guard spokesperson Jay Tarriela said the agency was not in a position to provide any details as it was not a coast guard operation.For months, China and the Philippines have traded accusations over dangerous maneu-



vers and collisions at the Second Thomas Shoal, an atoll in the Philippines' EEZ.Several incidents have happened when the Philippines deploys resupply missions for Filipino soldiers living aboard an aging warship there deliberately run aground to protect Manila's maritime claims.China claims almost the entire South China Sea, a conduit for more than \$3 trillion of annual ship-borne commerce, including parts claimed by the Philippines, Vietnam, Indonesia, Malaysia and Brunei.China had previously warned the Philippines about intruding into its territorial waters and the country has issued new rules, which went into effect on June 15, that would enforce a 2021 law allowing its coastguard to use lethal force against foreign ships in waters that it claims.

The military had announced the daily pauses from 0500 GMT until 1600 GMT in the area from the Kerem Shalom Crossing to the Salah al-Din Road and then northwards."When the prime minister heard the reports of an 11-hour humanitarian pause in the morning, he turned to his military secretary and made it clear that this was unacceptable to him," an Israeli official said. The military clarified that normal operations would continue in Rafah, the main focus of its operation in southern Gaza, where eight soldiers were killed on Saturday. The reaction from Netanyahu underlined political tensions over the issue of aid coming into Gaza, where international organisations have warned of a growing humanitarian crisis.National Security Minister Itamar Ben-Gvir, who leads one of the nationalist religious parties in Netanyahu's ruling coalition, denounced the idea of a tactical pause, saying whoever decided it was a "fool" who should lose their job. The spat was the latest in a series of clashes between members of the coalition and the military over the conduct of the war, now in its ninth month.It came a week after centrist former general Benny Gantz quit the government, accusing Netanyahu of having no effective strategy in Gaza.

The divisions were laid bare last week in a parliamentary vote on a law on conscripting ultra-Orthodox Jews into the military, with Defence Minister Yoav Gallant voting against it in defiance of party orders, saying it was insufficient for the needs of the military.Religious parties in the coalition have strongly opposed conscription for the ultra-Orthodox, drawing widespread anger from many Israelis, which has deepened as the war has gone on.Lieutenant-General Herzi Halevi, the head of the military, said on Sunday there was a "definite need" to recruit more soldiers from the fast-growing ultra-Orthodox community.Despite growing international pressure for a ceasefire, an agreement to halt the fighting still appears distant, more than eight months since the Oct. 7 attack by Hamas fighters on Israel triggered a ground assault on the enclave by Israeli forces.

Since the attack, which killed some 1,200 Israelis and foreigners in Israeli communities, Israel's military campaign has killed more than 37,000 Palestinians, according to Palestinian health ministry figures, and destroyed much of Gaza.Although opinion polls suggest most Israelis support the government's aim of destroying Hamas, there have been widespread protests attacking the government for not doing more to bring home around



120 hostages who are still in Gaza after being taken hostage on Oct. 7.Meanwhile, Palestinian health officials said seven Palestinians were killed in two air strikes on two houses in Al-Bureij refugee camp in central Gaza Strip.As fighting in Gaza has continued, a lower level conflict across the Israel-Lebanon border is now threatening to spiral into a wider war as near-daily exchanges of fire between Israeli forces and the Iran-backed Hezbollah militia have escalated.In a further sign that fighting in Gaza could drag on, Netanyahu's government said on Sunday it was extending until Aug. 15 the period it would fund hotels and guest houses for residents evacuated from southern Israeli border towns.

## 14 Jordanian Haj pilgrims die due to 'extreme heatwave', 17 missing

At least 14 Jordanian pilgrims have succumbed to death while on the Haj pilgrimage in Saudi Arabia due to an "extreme heat wave."Jordan's foreign ministry said on Sunday that "14 Jordanian pilgrims died, and 17 others were missing" during the Haj pilgrimage. It stated that its nationals passed away "after suffering a stroke due to the extreme heat wave," news agency AFP reported. The ministry said that it has been coordinating with Saudi authorities to either bury the dead in Saudi Arabia or transfer them to Jordan.

Iran also reported that a total of five Iranian pilgrims lost their lives during the Haj pilgrimage; however, they did not specify the cause behind their deaths.Saudi Arabia has not released any official statement regarding the fatalities yet. However, Saudi Health Ministry spokesperson Mohammed AI-Abdulaali told reporters that over 2,760 pilgrims suffered from sunstroke and heat waves on Sunday.

# Motilal Oswal says Paytm revenue to fall by 24%. Google Pay, PhonePe to benefit?



Motilal Oswal said, "We remain watchful on the ongoing business transition and Paytm's ability to recover lost business and resume growth trajectory."Following Reserve Bank of India's (RBI) decision to impose business restrictions on Paytm Payments Bank Limited (PPBL) over regulatory concerns, Motilal Oswal Financial Services said that Paytm's FY25 revenue ,could decline by 24 per cent. In an analysis report, Motilal Oswal said, "We remain

watchful on the ongoing business transition and Paytm's ability to recover lost business and resume growth trajectory over FY25- 26E. We thus estimate FY25E revenue to decline by 24 per cent, while contribution profit declines 30 per cent."It also said that the company's contribution margin is expected to sustain at 51 per cent, adding, "We will revisit our rating post Q4 results and in the interim maintain our Neutral stance on the stock."The restrictions could result in the company losing customers and merchants, it warned, noting that even Paytm could lose 15-20 per cent of merchants but the impact on customers may be moderate.

This comes as, earlier this month, the National Payments Corporation of India (NPCI) gave its nod to Paytm's parent company One97 Communications Ltd (OCL) to become a third party UPI app under the multi-bank model under which four banks– YES Bank, State Bank of India, HDFC and Axis Bank- will be included.

Motilal Oswal also said that there will be a major decline in the revenue of the company which is expected to fall by 27 per cent as it projected a 28 per cent cut in payment processing margin to a range of ~7bp which it primarily attributed to reduced business volumes. It said,

# Anti-Israel Google employees arrested after occupying CEO's office with demands against 'apartheid state'

Google employees with anti-Israel demands of ceasing "business with the Israeli apartheid government and military" were arrested on Tuesday after they took over Google Cloud CEO Thomas Kurian's California office. Occupying the space for over 8 hours, the employees broadcast their Pro-Palestine protest on a Twitch livestream, which ultimately also captured their arrest. The 'notech4apartheid' video shows a man informing the employees that they've been put on administrative leave before he asks them to leave voluntarily. To which, the protesters refused, leading to their arrest by the police. The peaceful protestors approached by the man were intimated that it was getting late and they should cooperate accordingly. "You've been placed on admin leave and we'd like to see if you'd just voluntarily [leave] it's been a while," he said

As the employees refused to comply, he threatened to bring in law enforcement. The protestors acknowledged his remarks, and moments later, the police came in and took them in. At this point, the livestream also abruptly ends. If viewed carefully, the clip puts the focus on a banner, that reads "DROP NIMBUS," attached to the room's entrance. Per a Daily Wire report, these protests were organised internally via email exchanges between the employees, highlighting a set of demands. The paramount call was for Google to sever its ties with Israel by dropping the \$1.2 billion contract for Project Numbus - a cloud computing project of the Israeli government. The employees have driven a case for Google to divest from its business ties with the "Israeli apartheid government and military" and put an end to "harassment, intimidation, bullying and silencing" of Palestinian and Muslim workers. They've



also pushed the organisation to focus on the "health and safety crisis" that caused concern among all those employees who can't bear with their office hours and hard work being used to "enable a genocide." On April 16, Google employees led a national day demanding the company to "stop powering Israel's genocide of Palestinians in Gaza." The No Tech for Apartheid movement has the workers staying in office as part of their protests until Google parts ways with Project Nimbus.In a letter to the Google Cloud CEO, the workers wrote: "By choosing to provide the Israeli government and military with our powerful cloud computing and AI technologies, we have continuously enabled Israel's apartheid state in Palestine and ongoing genocide in Gaza."They also highlighted that they'll sit in Kurian's office until the demands are met. No Tech for Apartheid website reported that workers showed up in solidarity at Google offices in New York City, Sunnyvale, CA and Seattle.

# IIT study says groundwater in Mandi,

The upcoming full budget will outline the economic agenda of the Modi 3.0 government, with focus on stimulating growth without exacerbating inflation.Low income earners can expect some tax relief in the upcoming budget.The government is reportedly considering reforms to the current income tax structure, particularly targeting lower income levels, to boost consumption, reported The Indian Express.

The report, quoting two government officials, suggests the budget announcement in July might prioritize tax cuts for low earners instead of increasing welfare spending. These proposed tax cuts are intended to enhance disposable income, thereby stimulating economic activity and consumption. The report highlights concerns about the steep rise in marginal income tax rates under the new tax system.

#### Relief likely for low-earner

The officials noted that tax cuts may be more efficient in enhancing consumption, rather than increasing welfare spending. One of the officials quoted in the report said rationalising tax slabs will lead to greater disposable income, which translates to "greater consumption, economic activities, more GST greater collection". Currently, the tax rate begins at 5% for income starting at Rs 3 lakh, but escalates sharply to 30% for income at Rs 15 lakh. This sixfold increase in tax rate, despite only a fivefold increase in income, is deemed excessive and in need of rationalisation.Implementing these tax cuts is expected to significantly boost consumption, a crucial factor for reviving demand and restarting the investment cycle, particularly in consumer-driven sectors. This move could also lead to increased GST collections

As the budget for the fiscal year 2024-25 approaches, with a likely presentation in Parliament in late July, Finance Minister Nirmala Sitharaman is set to begin prebudget discussions with industry groups around June 20, following a meeting with Revenue Secretary Sanjay Malhotra on June 18. This budget will outline the economic agenda of the Modi 3.0 government, focusing on stimulating growth without exacerbating inflation, while securing resources for coalition commitments. The overarching goal is to position India as a USD 5-trillion economy and transform it into a 'Developed India' by 2047. The Reserve Bank of India (RBI) forecasts a 7.2 percent growth for the Indian economy this fiscal year, driven by improving rural demand and easing inflation.Key priorities for Prime Minister Modi's third term include addressing agricultural challenges, job creation, sustaining capital expenditure, and enhancing revenue growth to maintain fiscal consolidation. The economic policies of the past decade have been positively received, with rating agency S&P upgrading India's sovereign rating outlook to positive, and a potential further upgrade in the next 1-2 years contingent upon meeting fiscal deficit



targets.Despite strong tax revenues, non-tax revenue remains a challenge due to limited progress in strategic disinvestment, with the sale of Air India being a notable exception.

## Zomato in preliminary talks to acquire Paytm's movie, ticketing business

Zomato confirmed in a stock exchange filing that it is in talks to acquire Paytm's ticketing business, but no final decision has been made.

Paytm also confirmed the discussions regarding the potential transfer of its entertainment business. Food delivery firm Zomato has confirmed that it is in discussions to acquire Paytm's movies and ticketing business, as per an exchange filing, putting an end to speculations."We acknowledge that we are in discussions with Paytm for the aforementioned transaction, however, no binding decision has been taken at this stage that would warrant a board approval and subsequent disclosure in accordance with applicable law," said Zomato in the exchange filing."The above discussion is being undertaken with an intent to further strengthen our Going-out business and is in line with our stated position of focusing only on our four key businesses currently," it further added.Paytm also confirmed the discussions regarding the potential transfer of its entertainment business in an exchange filing, stating that all discussions are preliminary and non-binding at this stage. If the deal goes through, it will be one of the largest buyouts for Zomato. Previously, Zomato acquired Uber Eats in 2020 and took over the quick commerce platform Blinkit (formerly known as Grofers) in 2021 in an all-stock deal valued at Rs 4,447 crore. This potential acquisition fits well with Zomato's goal to expand its "Going-out" segment, which covers dining out, events, and entertainment services.

# Himachal Pradesh contaminated with 'cancercausing' agents; here's how it affects health

A new study by the Indian Institutes of Technology Mandi and Jammu has revealed a disturbing truth the groundwater in Himachal Pradesh's Baddi-Barotiwala (BB) industrial area is heavily contaminated with cancercausing pollutants. The research, published in the journal Science of the Total Environment, employed advanced techniques to groundwater analyze samples and pinpoint the sources of contamination. The results paint a concerning picture: Geogenic uranium, a naturally occurring radioactive element, is present in the water Industrial activity has significantly increased levels of toxic metals like zinc, lead, cobalt, nickel, and chromium, exceeding safe limits

These contaminants pose a serious threat to public health, according to Dr Manish Singhal, Senior Consultant, Medical Oncology at Indraprastha Apollo Hospitals, as they can cause cancer after prolonged exposure. India already faces a water quality crisis, especially in the where north, rapid urbanisation and industrial growth have put a strain on groundwater resources

The case of the BB industrial area exemplifies this problem. Untreated, contaminated groundwater is suspected to be a major factor behind the high rates of cancer and kidney diseases reported in the re-

Sudeep also noted the widespread blame directed at the film industry and expressed hope that it would be exonerated once the real culprit is punished.

Without directly naming Darshan, Sudeep remarked, "We are only aware of what the media is showing to us because we are not going to the police station to get the information. It looks like the media and the police are working hard to uncover the truth. There's no doubt about that." Sudeep and Darshan were once close friends but had a falling out due to irreconcilable differences.Sudeep then called for justice for Renukaswamy's family, stating, "That family deserves justice. That girl deserves justice. Renukaswamy, who died on the streets, deserves justice. The unborn child deserves justice. Above all, everyone should have faith in justice, and justice should prevail in this case."

Sudeep also commented on the negative impact the murder case has had on the Kannada film industry. "Everyone's heart goes out to that family. The atmosphere doesn't feel right. The film industry should get justice. All the blame seems to be placed on the film industry. The industry needs a clean chit. There are many artistes in-



volved. Cinema is not just one or two people. The film industry will be relieved if the culprit is punished," he said.Earlier, Kannada actress and former Congress leader Divya Spandana addressed Darshan's arrest. The actor wrote, "There's a block option given on social media for a reason. If the trolling persists, you file a complaint. The trolls have trolled me incessantly using filthy language. Not just me, they've trolled other actors too. They haven't spared their wives and children either. What a sad society we live in. I have filed cases like any lawabiding citizen should. Sometimes post a warning from the police to the trolls I've taken back the case too on compassionate grounds."

Condemning the incident, she added, "I've also considered the fact that these people are young and have a future ahead and they're ruining/wasting their lives by trolling using anonymous handles. No one is above the law. No one should take the law into their hands. You don't go around beating up people and killing them. A simple complaint would suffice whether you believe justice will be served or not."

# Digangana Suryavanshi slaps defamation case on Show Stopper director Manish Harishankar, calls his extortion allegations a 'cheap publicity stunt'



Actor Digangana Suryavanshi recently filed a defamation case against Show Stopper maker Manish Harishankar after she was accused of deceptive practices and financial misconduct by the director. Digangana sent a defamation notice and lodged a complaint under IPC sections 420, 406, 509, 499, 500, 503, 506, 63, 199, and 211. She has refuted the allegations put forth by Manish, who accused the actor of "extortion" and "breach of trust".A few days ago, MH films, the production house behind Show Stopper, made a formal complaint to law enforcement against Digangana. They accused her of serious offenses under sections 420 and 406 of the IPC. According to the complaint, Digangana allegedly provided false information claiming actor Akshay Kumar, along with his organisation, were going to be sponsors of the project.

Now, Digangana Suryavanshi has refuted the claims


and said, "Manish's narrative is his twisted imagination, it's all untrue. A cheap publicity stunt of simply dragging names, clearly he's trying to find a bakra so he can bail out from not being able to sell the show even after more than two years. I don't want to waste any more time explaining further, I've already wasted too much time trying to help him."

Her lawyer Rajendra Misha, in a statement, said, "We would like to officially quote that all the allegations made against our client Digangana are absolutely baseless and an outcome of someone's criminal intention and trying to cover up their own shortcomings. Our client has known Manish for 7 years and is an actress on his series showstopper, when Manish was in a situation where he clearly couldn't help himself, he asked for help from our client and proposed a business deal where his team had executed an MOU between him and our client."He added, "Strangely, Manish Harishankar doesn't understand that extortion doesn't happen in legal binding; it's called business. Under the terms of the MOU. Our client had gotten a presenter on board, and honoured her side of the commitment.""Which is when our client further requested the presenter and after re-editing the show (for which our client invested 4 days at the edit suit) the presenter watched the episodes and agreed to present the show, although a lot of changes were still required, but Manish promised to fix them after their agreement," concluded Mishra.Previously, MH Films served a legal notice to Rakesh Bedi and Krishan Parmar, who is known to work closely with Digangana Suryavanshi.

Why Kylian Mbappe is all set to light up Euro 2024 for France, three years after a forgettable campaign for France

Kylian Mbappe is in the place he wants to be. In Real Madrid, in his dreamland; in the galaxy of his idols, Zinedine Zidane, Cristiano Ronaldo. He is smiling more; he is joyful and relaxed, almost liberated from the goldcaged prison that PSG was in the last few years, the French newspapers would diligently note. It's how France wants him to be in the European Championship, a smiling and happy Mbappe, unshackled and unchained, in the freest of spirits, in the mood to sweep away every human obstacle in his path. "A happy man is more likely to play well," he would say before the friendlies, ahead of the European Championship.Last European Championship, he was not in the place he wanted to be. The world was not in a space it wanted to be, picking broken pieces of life from the pandemic, stumbling in fear. He might have been just a victim of his circumstances, as the world around him; he failed to score in all four games of his country; had just 14 tries at goal, of which only four were on target. Later he fluffed a spot-kick in the round of 16 shootout defeat against Switzerland. When he walked back to the tunnel, spectators abused him racially. "They called me a monkey," he would say. When he checked his phone, he discovered a volley of messages with racial undertones in his social media accounts. He cried that night. A sole assist (penalty in the group against Portugal) and a delightful back-heel pre-assist for Antoine Griezmann to set up a goal in the Switzerland game were but rare flickers of fire in a frosty tournament for him.

His form pained him; the criticism ripped him apart. "I received the message that my ego was what made us lose, that I wanted to take up too much space, and that without me, therefore, we might have won. The most important thing is the French national team and if the French national team is happier without me, I'll go," he would say before the next season, in a moment of rare emotional outpouring

But France would cajole back their unearthliest talent since Zidane. A year later, he netted a hat-trick of more steel-will rather than silken-skill in the World Cup final, a night where he ended the most tragic of tragic heroes in football folklore. In reality, there is a note of melancholia in his career. He was only 19 when he held the World Cup aloft, but thereafter, precious silverware has cruelly tantalised him. Second-place finishes in World Cup and Champions League, a heartbreaking European Championship, a continuing streak of unfulfilled renown in Champions League, endless years waiting for the transfer to Real Madrid. Boredom of the pointless pursuit of stacking titles, accolades and trinkets of trophies in the French league. Suddenly, the teenager is a full-blown adult, 25, going on 26. Where are the trophies? Where is the glory? Where is the Ballon d'Or?Of course, Mbappe is still 25, nudging to his peak years, the best yet to be. But with outrageous talents like him, the expectations are thrust too much too soon. It's the fate of all super-athletes, the scales that measure their success and failure are more stringent than they are for lesser talents. So six barren years outside of the French league title was a slight at his inability to inspire his team. It cannot be further from reality, but that is the capricious burden of being an otherworldly talent.

man. These days, manager Didier Deschamps has given him a free roaming role on the left, much like how Barcelona and later Argentina let Lionel Messi be. Rather than tweaking his fellow forwards to enable the optimisation of Mbappe's gifts, he has picked a forwardline that is naturally programmed to ally him. Olivier Giroud is a physically-imposing link-up man, a master at dragging the defenders to the back-line and providing Mbappe with the cut-backs. The young and pacey Randal Kolo Muani's movement off the ball is imperious, he forces the defenders deeper and creates space behind him for Mbappe to rampage; Marcus Thuram does both. Resultantly, Mbappe assumes a more central role when in possession

The frontline has not quite synced in friendlies against strong nations, and teams have looked to exploit Mbappe's free-roaming role and defensive vulnerabilities, by overloading the left-flank when in possession. England almost pulled off a coup in the World Cup quarterfinal by attacking Mbappe. The strategy carried risk, if Mbappe somehow managed to win the ball, he would be in acres of space and would blitz past them. But such a strategy would take a huge degree of precision and courage to pull off.Besides, it's not just Mbappe that the opponents have to stop. Muani is a trickster with twinkle toes. Ousmane Dembele could flick on the afterburners on the right wing; Griezmann, in many ways Deschamps's Man Friday, has evolved into a sublime No 8, performing various duties of play-making, disrupting and goal-scoring with ease and finesse.Deschamps, ever the man behind the scenes, insists his is a team rather than a collection of brilliant individuals and that no one is more equal than others. But Mbappe is an exception, more so because he would crave for redemption in the European Championships, which he considers tougher than the World Cup, and he is where he wants to be at the moment. Happy, smiling, and ready to take on Europe.

Formational flexibility: Since the start of the 2022 World Cup, Didier Deschamps has persisted with a back four on all but one occasion. His forwards are so versatile that they could be deployed in a variety of roles and functions. Mbappe could be the lone front-man, a false nine, an inside left, or a wide winger. Muani can play on either flank, or drop back as a double No 10 with Griezmann. The latter could perform a variety of roles with equal efficiency, a 10, an 8, or a deep-lying playmaker with an exceptional positional sense. Not to forget, he can slot anywhere into the forward line too. There is pace (imagine Deschamps throwing in Kinglsey Coman too into the pack), subtlety, creativity, and flair.Midfield maestros: The bad news for opponents is that as if France's midfield was not versatile enough already, now N'Golo Kante, though playing in Saudi Arabia, is "back to beast mode", according to the manager. There is no shortage of central midfield generals who can dictate the game's tempo, both of the pass-master and hard-tackling brands. Among the array of established stars such as Griezmann, Eduardo Camavinga, Aurelien Tchouameni (returning from an injury) and Adrien Rabiot, watch out for PSG's Warren Zaire-Emery too. How this midfield could fail would be a mystery that could catch the fancy of Fred Vargas, the gueen of French crime fiction and archaeologist

Defensive depth: Raphael Varane's international retirement injected temporary instability but Deschamps quickly covered the cracks, installing Dayot Upamecano and Ibrahima Konate at the heart of it. That Arsenal centre back William Saliba is their third choice attests to their depth. The biggest strength is a variety of those who could don multiple roles. Both Jules Kounde and Benjamin Best plan to derail South Africa: take out the openers, watch the middle-order marauders Klassen, Markram, Miller wobble

They severely depend on one of the openers to click in tall chases. Else, the mounting strike-rate pressure triggers indecisiveness and impatience in the middle order of Markram, Klaasen and Miller. After trying to straddle anchor/attack duties for a brief while, they then tend to pre-meditate their big shots a touch frantically in trying to accelerate, which further upsets the apple cart. And while their fate was sealed due to intervention from the weather, Pakistan's performance has copped plenty of flak back home.Now, a video has emerged where former Pakistan player Mohammad Hafeez, who was the national team director from November 2023 to February 2024, has lashed out against Pakistan players due to their attitude.Recalling an incident from a Test match in an interview with former cricketers Adam Gilchrist and Michael Vaughan,

Arda Guler had done it before. His first-ever goal for Turkey was a delightful curler from outside the box. And so, when he let the ball fly on his Euros debut against Georgia, the 'Turkish Messi' had little doubt about the shot's outcome - piercing through the crisp Dortmund air and bending beautifully to ruffle the top corner. The goal made Guler the youngest scorer at the Euros; the talk of the tournament's early stages. More significantly, it put long-range goals in vogue. Guler's isn't the only one.

Twelve out of the 42 goals scored so far in the Euros (until the Scotland-Switzerland match) were screamers from outside the box. This, the game's stats-keepers said, is an anomaly. Everywhere else, the number of goals and shots from outside the box is decreasing.Long rangers, they argued, were out of fashion and on a sharp decline, if not on the verge of extinction. Numbers backed this theory: at Euro 2012, only 8 out of the total 76 goals were scored from outside the box. Four years later, the figure doubled to 16 but so did the total goals, which increased to 108 meaning the long-rangers accounted for 14.8 per cent. And at Euro 2020, 19 out of the 142 goals were scored from a distance (all stats from Opta). Even in the English Premier League, only 11.5 percent of goals were scored from outside the box last season, the lowest since 2010/11 according to Opta. And at the 2022 World Cup, zero long-range goals were scored in the first round of group-stage matches.

Of course, the sample size of Euro 2024 is pretty small yet and the average might come down as the tournament progresses. Some of the long-range shots have gone in because of deflection and in a few cases, poor goalkeeping might have contributed.But goals from the likes of Guler and Razvan Marin, finding the corner from a distance, have lit up the tournament and contributed to the increasing number of long-range goals.Euro 2024: Arda Guler goal His goal made Guler the youngest scorer at the Euros; the talk of the tournament's early stages. The threadbare analysis will take place in the days to come but prima facie, two compelling reasons stand out. The tactical factorUEFA's technical review of the previous Euros noted that teams were more inclined to 'work the ball into areas' to produce a goal 'rather than the low-percentage option of striking at goal from distance.'

The trend, Sky Sports noted, is in continuation of what is preached and practised at the club level, where more and more players are discouraged from having a wild go at goal and are instead coached to play in patterns in the attacking third.In international football, that's not always the case and smaller nations aren't Real Madrids or Manchester Citys who are managed by su-



per coaches who are quick to reprimand their players if they go slightly off-script. In the first round of the group stage at the ongoing Euros, the best long-rangers have been scored by players from Romania and Turkey. Six out of the nine shots Romania managed against Ukraine, in fact, were from outside the box. This could be because the players lack the telepathic understanding in the final third, where they can find teammates even without looking up, the quality of playmakers and attackers too might not be at the same level as the traditional favourites and the rewards of a long-range effort far outweigh the risThat could be a basic explanation for why more technically superior players would be cautious of having a go from a distance. This isn't to say, however, that Guler lacks guality. For the Real Madrid starlet, whose youth coach vows he is more talented than Messi, a long-ranger could be as normal as a tap-in for a poacher. Another standout factor in Guler's goal was how the ball stayed true to its trajectory and did exactly what the Turkish scorer intended. The pick of the long-rangers have all been curlers rather than shots thumped in from a distance. That, according to The Athletic, is because of the evolution of the ball. "The Euro 2024 ball is not a major outlier from other balls of the current era, although it appears fast through the air. But the key is that it moves in the correct manner," the report said.Guler got the ball to start from outside of the goal and then got it to bend inwards. Romania's Nicolae Stanciu used the spin of the ball to curl it away from the goalkeeper, while Nicolo Barella scored a half-volley that swung inwards ever-so-slightly. In almost all cases, the ball did exactly what the goal-scorer wanted it to do.Early indications are that it has to do with the ball as much as the skill of the player. The Adidas Fussballliebe - the official Euro 2024 ball - has indentations on its 20 panels on the outer shell, which control the airflow over the ball and provide maximum precision, according to the ball's makers
