KCR should apologise for engineering defections: **Revanth Reddy**

Hyderabad: Telangana Chief Minister A. Revanth Reddy on Thursday demanded that Bharat Rashtra Samithi (BRS) president K. Chandrasekhar Rao apologise for engineering defections of legislators when he was the chief minister. Stating that KCR has no moral right to speak about defections, Revanth Reddy claimed that it was KCR who started this and "bought" 61 MLAs and MLCs.Addressing a news conference in Delhi, the Chief Minister demanded that the BRS supremo should come to Telangana Martyrs' Memorial and apologise for encouraging defections. Revanth Reddy was replying to a question about the BRS finding fault with the defection of its five MLAs to the Congress. The Chief Minister recalled the statements by BRS leaders K. T. Rama Rao and Harish Rao that the Congress government would collapse within 100 days. He said the BJP leaders had also made similar statements. The Congress leader remarked that KCR's eyes have not opened even after BRS drew a blank in recent Lok Sabha elections.

He mentioned that the vote share of BRS has plunged to 16 per cent.He reiterated that KCR helped BJP win Lok Sabha seats to defeat the Congress party.Revanth Reddy remarked that KCR, who was not evn allowing his MLAs to come closer to him till recently, had now opened the doors of his farmhouse. He slammed the former chief minister for not accepting the invitation to attend state formation day celebrations.

"Is there any tradition of the leader of the opposition speaking at state formation day celebrations," he asked while responding to a statement by BRS leaders that KCR did not attend the ceremony as he was not given an opportunity to speak. The Chief Minister said the Congress party would benefit from the experience and services of senior Congress leader T. Jeevan Reddy.He alleged that the opposition tried to take advantage of Jeevan Reddy's reported unhappiness.Jeevan Reddy, a member of the Legislative Council, had come out openly against the Chief Minister's move to admit BRS MLA M. Sanjay Kumar into the party without consulting him. The Congress leadership summoned the senior leader to Delhi to pacify him.Revanth Reddy, who is also the president of Telangana Pradesh Congress Committee (TPCC), said that the term of PCC president was three years and he had already requested the high command to appoint a new president. The Chief Minister, who is camping in Delhi for three days, said with the formation of new government at the Centre, he was trying to secure pending funds for the state. He reiterated that the state government would work with the Centre for the state's development. Revanth Reddy said he was meeting central ministers to request adequate budgetary allocations. He also plans to meet Prime Minister Narendra Modi and Union Home Minister Amit Shah

Congress, BJP conspiring to privatise Singareni coal mines, says KTR

Hyderabad: BRS working president KT Rama Rao charged the Congress and the BJP of colluding with each other and auctioning Telangana's coal mines to privatise the Singareni Collieries Company Limited (SCCL). Chief Minister A Revanth Reddy had joined hands with the BJP-led goverment at the Centre to undermine the profitable State-run enterprise, he said.

"By not allocating coal mines, they aim to push Singareni into losses and eventually privatise the company. Every Singareni worker understands the conspiracy by the Congress and the BJP whose representatives were seen smiling at the auction of coal mines," he said. In a meeting with the leaders of BRS and its affiliated Telangana Boggu Gani Karmika Sangham (TGBKS) from the Singareni area at Telangana Bhavan on Thursday, Rama Rao remembered the role of employees and workers of Singareni and other public sector organisation in the Telangana Statehood movement. He recalled that during the Sakala Janula Samme, the stalling of operations in Singareni mines affected coal supplies to five States, grabbing the attention of the entire nation. He stated that strengthening public sector undertakings has always been a policy of the BRS. "We resisted private pressures and opted for LIC for implementing Rythu Bima and other life insurance coverage schemes. Similarly, we assigning works to PSUs like BHEL for building thermal power and irrigation projects, over private entities," he noted.

Rama Rao said during the BRS's nine and a half years regime, they worked tirelessly for Singareni's development and expansion. He said former Chief Minister K Chandrashekhar Rao opposed auction of coal mines in Telangana for over nine years. "Even when the Central government auctioned two mines to private companies, we could successfully stop them from mining," he added.The BRS working president criticised both the Congress and the BJP over their attempts to privatise the Singareni coal mines within a short span of coming to power. "They put Telangana coal mines up for auction under the illusion that Telangana's voice is absent in Parliament. But BRS has always fought for Singareni and will continue its fight notwithstanding its presence in the Parliament," he said. He vowed that the BRS would safeguard the interests of Singareni workers under any circumstances.

Trial run of first pump of Seetarama LIS completes successfully

Hyderabad: The trial run of the first pump of 25 MW capacity of the Sitarama Lift Irrigation Scheme was successfully completed by on Thursday. The Minister for Agriculture Thummala Nageshwar Rao switched on the pump at 9 am in the presence of the senior irrigation officials and local elected representatives. Only two of the six pumps of the project were ready for the wet run. Four other pumps of the pump houses will also be ready for operations very soon to commence water drawl from Godavari river. This marks a significant milestone for the project, which aims to provide irrigation and drinking water to over seven lakh acres in Bhadradri Kothagudem, Khammam and Mahabubabad districts. The successful trial run indicates that the pump house is ready for operational use, bringing the project closer to its goal of improving water supply and agricultural productivity in the area

Kothagudem as a tier-II city, he said, also announcing that the State government was planning a supercritical thermal power project (SCTPP) in Ramagundam as there enough land, water and coal were available. A decision with regard to the project would soon be taken, he said.

The Deputy Chief Minister along with district incharge minister Komatireddy Venkat Reddy, ministers Tummala Nageswara Rao and Ponguleti Srinivas Reddy laid the foundation stone for a drinking water supply improvement scheme here on Thursday. Addressing the gathering later, he said the Congress government was committed to deliver its promise of the crop loan waiver before August. The government had deposited Rs.7,500 crore in the farmers' account at once towards Rythu Bandhu and in a similar way, the crop loan would be waived off.With regard to Rythu Bharosa, the government was collecting public opinion about beneficiary selection and how it should be distributed. After formulating the procedures, the matter would be discussed in the As-

sembly to make a law as the government did not want to waste the public money, Vikramarka noted.He promised to look into the possibility of forming a municipal corporation by connecting Kothagudem and Paloncha towns by taking the matter to the notice of the State Cabinet. He also assured to complete the pending bypass road in Kothagudem. The land acquisition for the construction of the bypass road was over and Roads and Buildings Minister Komatireddy Venkat Reddy had sanctioned funds for the construction of a road over bridge as part of the bypass road, Vikramarka revealed. The government had identified all the projects which could be completed within six months, in one year, in three years and in a five year period to ensure irrigation facilities to farmers. The projects would be completed in order of priority, he added.

BRS demands job calendar, two lakh government jobs within a year

Hvderabad: Giving a fresh boost to the ongoing fight of the government job aspirants, the Bharat Rashtra Samithi (BRS) issued an ultimatum to the Congress government, demanding for immediate redressal of the genuine issues raised by the candidates. The main opposition party also demanded that the Congress fulfill its electoral promises by releasing a job calendar and filling two lakh government posts within a year. Following a meeting with government job aspirants at his residence on Thursday, BRS working president KT Rama Rao came down heavily on the State government over its unfulfilled promises. "Before the elections, the Congress government advertised about job calendars and even announced dates for about 10 exams. Not a single notification has been issued even after seven months," he said, demanding that government release these notifications the immediately.Rama Rao criticised Chief Minister A Revanth Reddy for failing to deliver on promises made during the election campaign, including increasing Group-2 jobs by 2,000 and adding a few thousand more jobs in Group-3. "In the first Cabinet meeting itself, they deceived the unemployed by claiming to conduct a Mega DSC. Rather than giving notification for 20,000 jobs as promised, the government added only 5,000 more posts compared to the previous notification," he added. Highlighting the lack of progress on Group-1 jobs, the BRS working president pointed out that only 60 positions were added since the previous notification issued during the BRS regime. "When asked to increase jobs, they are trying to escape by citing technical reasons. BRS will not tolerate



this. We will question the government in the Assembly and stand by the unemployed in their fight for justice," he asserted.Rama Rao called for fair selection in Group-1 Mains, reminding Deputy Chief Minister Mallu Bhatti Vikramarka of his past demand for a 1:100 selection ratio from the prelims. "Why is this not being implemented now to benefit the candidates?" he asked. Rao emphasized the need for adequate gaps between exams such as TET, Group-1 Prelims, DSC, Group-2, Group-1 Mains, and Group-3 to accommodate students who write multiple exams. "Exams should be scheduled with enough time in between to ensure fair preparation for all candidates," he stated. He warned that if these demands are not met, the BRS leaders would fight alongside the unemployed youth.Speaking on the occasion, the Groups aspirants made it clear that they had no political affiliations as was being propagated by the ruling Congress and were fighting only for their future.

'No love lost for BJP', says Uddhav Thackeray on lift ride with Devendra Fadnavis

On political suspicions about why the 'elevator meeting' and what transpired in the closed metal box with several BJP leaders around him, Thackeray jocularly shot back: "It is said that walls have ears... so henceforth, any secret conversations must be held only in lifts!"About BJP Minister Chandrakant Patil - who 'dropped' in for a surprise meeting at the SS (UBT) office in the legislature building -- when journalists questioned as to who winked at whom -- Thackeray dismissed the query with a retort: '... from tomorrow, I shall sport goggles."The Parliamentary Affairs and Higher Education Minister Patil presented a large packet of milk chocolate to Thackeray, while Leader of the Opposition (Council) Ambadas Danve whipped out a box of 'pedas' (milk-sweetmeat) and offered it to the visitor, saying "this is for our victory in the Lok Sabha elections" amid much laughter and bonhomie.Later, Thackeray took potshots at Patil saying that, like the free higher education for girls, the BJP Minister (Patil) should stop doling out 'free chocolates' as the people of the state are tired of the MahaYuti government.

Trees uprooted, branches falling: Over 100 incidents since monsoon hit Mumbai

Within two weeks of the monsoon arriving in Mumbai, more than 100 incidents of trees having been uprooted or branches falling have been recorded in the city, according to Brihanmumbai Municipal Corporation (BMC) data. The civic body recorded 106 complaints related to uprooting of trees or branches falling due to rains between June 9 and 22. Furthermore, 24 such incidents were reported within the past 24 hours between June 21 and 22.Between June 9 and 10, when the monsoon hit Mumbai, 51 such incidents were reported as rains lashed the city. The data shows out of the total incidents reported, 58 were in the western suburbs, and 24 each in the eastern suburbs and island city. Every year, ahead of the monsoon, the BMC carries out pruning of trees in Mumbai as a precautionary measure, so that heavy branches don't fall during storms or gusty winds. This year, the BMC had set a target of pruning 1.11 lakh trees between April and June

Civic officials attributed the ongoing digging in Mumbai related to infrastructure projects like road widening, concretisation and laying of sewage lines as a major contributing factor for incidents of uprooting of trees in Mumbai."Over the past few years, several roads have been dug up for infrastructure projects, which has badly affected the basins of most trees. In such a situation, there are high chances of uprooting of trees as the roots be-

come loose, and during rain leaves and branches also becomes heavy as they soak water," a civic official said.

The official added that many of the trees that were uprooted were in the periphery of private buildings and maintained that several residential societies don't carry out annual pruning of trees, posing a threat to residents living there. "Most incidents that have been recorded are of branches falling and incidents where full-grown trees were uprooted are not very high," the official said.Stalin D, environmentalist and director of NGO Vanashakti, told The Indian Express that the reason behind such incidents is concretisation of the tree basins, which prevents the roots to grow. "This kind of incidents happen only in Mumbai because no other city concretises the tree basins. As a result the tree is only left with 2 square metres of soil and the base becomes loose. Due to this, the trees miss out on soil moisture and become dehydrated from inside as the roots can't grow further. These factors cause them to lose moisture and due to unavailability of water inside them the trees lose equilibrium and collapse at the first blow of rains," Stalin said.

"We had approached the National Green Tribunal in 2015, following which the court had ordered BMC to implement remedial measures but as of now nothing has been implemented on the ground. As a damage control measure they are just pruning the branches, which is of no use because by removing a few branches you can't restore balance in a tree," he said. In a report published on March 26, The Indian Express had pointed out that between 2018 and 2023, 21,028 trees were cut by the civic authorities to make way for several infrastructure projects. Furthermore, the report also highlighted that only 22% of the trees that are transplanted in Mumbai survive.Mumbai also has a very low tree-human ratio; at present there are 29.75 lakh trees in Mumbai and going by the current estimated population of 1.29 crore, there is only one tree for four people, while an Indian Institute of Science report published in 2014 highlighted that the ideal human-to-tree ratio should be seven trees for every

Delhi Police nabs 16 suspected criminals in separate operations in two weeks

In a major crackdown on gangs operating in the national capital, the Delhi Police's Special Cell arrested 16 suspected criminals in separate operations in the past two weeks, an official said .Deputy Commissioner of Police (Special Cell) Amit Kaushik said they began a drive following a surge in organised gang activity in the city, leading to 16 criminals, including a woman, belonging to different gangs being arrested.

Ten pistols and 56 live rounds were seized from the arrested accused, who include members of gangs being run from abroad, he said.During the drive, the suspected criminals were monitored through technical means to identify their means of communication, Kaushik said.It was found during the surveillance exercise that the gang leaders, who are settled abroad or incarcerated in different jails, recruited juveniles and youngsters without prior criminal records or involved in minor cases to avoid detection, the senior officer said.

Social media and popular songs glamorising the gangster life are used to attract these youngsters to join the gangs, he said. The gangsters lure these youngsters for shooting at and even killing people and later dump them and move on to others, he added.

OBC activists end fast in Jalna after meeting govt delegation

OBC activists Laxman Hake and Navnath Waghmare on Saturday withdrew their indefinite fast opposing reservation for the Maratha community under OBC after a ministerial delegation led by Chhagan Bhujbal visited the site of the fast in Jalna district in Marathwada region. "The Maharashtra government will ensure that caste tension doesn't erupt in society," said Chief Minister Eknath Shinde. His statement comes in the backdrop of instances of violence in Beed district where protesters burned tyres and disrupted traffic on the Ahmednagar highway opposing inclusion of Marathas in OBC list.

Both Hake and Waghmare were on fast since June 13 demanding that OBC quota not be diluted. Bhujbal, who led the delegation that met them, promised that OBC reservation will not be harmed at any point. "Some people are trying to create animosity within communities over the issue of reservation... we neither offend anyone nor threaten anyone. Pankaja Munde did not hurt anyone's feelings but still some people tried communal politics, came together and defeated her. If this continues then OBCs will need reservation in the Lok Sabha and Assembly as well," he said.

Bhujbal added that the reservation fight has not ended and irrespective of political affiliations every OBC worker should stick together. "If we stick together, Dalits, tribals will join us," he said. In January, the state government came out with a draft notification to grant Kunbi status to the 'sage soyare' (relatives by birth or marriage) of Marathas who have already established that they belong to the agrarian Kunbi community, an OBC group.Activist Manoj Jarange Patil has demanded that all Marathas should get reservation under OBC category. OBC leaders, on the other hand, have demanded that the government scrap the draft notification. The delegation of ministers included Bhujbal, Girish Mahajan, Dhananjay Munde, Atul Loke, Sandipan Bhumare and Uday Samant.Bhujbal maintained that nobody has opposed Maratha reservation. "We have always supported independent reservation for Marathas. But why do you want to get into OBC reservation. Let our reservation be as it is and don't reduce it," he said.

Sharad Pawar recalls mother's contributions towards his success, formulating women's policy

Speaking at an event that honoured women achievers, NCP (SP) chief and former union minister Sharad Pawar recalled his mother's contribution towards his success and said that she inspired him to formulate the pioneering "women's policy" that provided 33 per cent reservation for women in the Panchayat Raj system. A division bench of the Karnataka High Court on Saturday issued an interim stay on a single judge order of June 18 allowing the resumption of horse racing and betting activities at the Bengaluru Turf Club.

The division bench, comprising Chief Justice N V Anjaria and K V Aravind, ordered the stay while admitting a writ appeal filed by the Karnataka government against the June 18 order of a single judge bench to allow racing and betting activities to resume at the turf club. The stay order came even as preparations were on at the turf club for the start of the racing season on Saturday afternoon. The division bench has issued notices to the turf club, jockeys and punters associations in the writ appeal by the state government and has adjourned the hearing to August 13.

The state sought the stay on the June 18 order by indicating ongoing investigations into a case of alleged illegal betting activities at the turf club over which a police

case was registered in Bengaluru in January this year.Earlier on June 18, following petitions by the BTC, associations of the horse owners and trainers, jockeys and punters, a single judge of the High Court had ruled that a Karnataka government order of June 6 not to renew licenses for horse racing and betting was unjustified.The state government had not renewed licences for horse racing by citing a police investigation that had unearthed illegal betting activities at the turf club.Justice S R Krishna Kumar had granted the stay on the June 6 orders of the Karnataka Home department and the state Finance department rejecting the application of the BTC for conducting racing activities and an application for grant of betting license respectively.

'PM Modi used same consultant for 2047 vision document': Karnataka minister counters BJP's 'East India Company' jab

Karnataka Industries minister M B Patil questioned the BJP's criticism for engaging an international consultant to assist the government in bringing investments and revenue generation. The minister said the services of the same consultant was taken by Prime Narendra Modi to prepare a Vision 2047 document. The Congress government in Karnataka has come under attack from the BJP state president B Y Vijayendra for awarding a Rs 9.5 crore consultancy contract to the Boston Consulting Group to assist the government in investment and revenue planning for the state.

"Outrageous decision by the Siddaramaiah government to hire a foreign consultant to oversee our State's finances. This is akin to handing over the reins to the East India Company!The Siddaramaiah government is disrespecting the State electorate and insulting them for electing this government," Vijayendra said on social media on Friday."The Congress government is effectively declaring itself unfit & incompetent. When the state government operates under the directions of an external agency, the welfare of the people takes a backseat, and innocent citizens are the ones who suffer!" the BJP state chief added.In response to the criticism, a senior minister in the Congress government pointed out that the Boston Consulting Group were consultants for the vision 2047 document of PM Modi and to the Karnataka government when Vijayendra's father B S Yediyurappa and his successor Basavaraj Bommai were the BJP chief ministers of Karnataka between 2019 and 2023.

"BCG is an advisor for investments in Karnataka. Earlier when the BJP was in power the same company was an investment consultant. When Yediyurappa and Bommai were the CMs the same BCG was advising the BJP government. They have again applied for a state tender and have qualified for a contract," Patil said."BJP state chief Vijayendra is saying that it is an 'East India Company' but it will be good if he speaks with some understanding. Narendra Modi's central government works with the same BCG that the state BJP chief is calling it an 'East India Company'. It is the same BCG that has worked on the PM's vision 2047 document," Patil said."Let Vijayendra first question Narendra Modi," he said on Friday.

"Basically, it is a multinational company and he is speaking without knowledge about the company. Companies like the BCG, Ernst and Young, KPMG, and Deloitte are international companies," whose consultancy services are used in the public and private sectors, he said.Incidentally, the BCG has been a long time advisor to the industries ministry in Karnataka and has played a pivotal role in helping the state attract global investment in areas like battery manufacturing while the Karnataka government attempted to create an electric vehicle manufacturing cluster in and around Bengaluru during the BJP tenure in the state. One of the consultants for the signing of an MOU in 2021 for a Rs 4,015 crore lithium ion battery technology plant to be set up by the US-based firm C4V in Karnataka – during the tenure of former industries minister and senior BJP leader Jagadish Shettar - was the BCG group. The group has now won a consultancy contract with the state Finance department. The consultancy will reportedly help the state government "raise additional non-tax revenues from sectors such as mining, advertisements in urban areas, naming rights, etc" to help meet pro-poor initiatives which cost annual outgo of Rs 50,000 crore."Further, the focus of the global consultant is on rapid development of large industrial townships and urban amenities by tapping private investments," the state government said in an official statement.

Human-leopard conflict: State forest dept, Wildlife SOS step up awareness, mitigation methods

While human deaths as a result of attacks by big cats are rare, an analysis by the State forest department has recorded 11 deaths due to the human-leopard conflict in the last three years in Junnar, Ambegaon, Shirur and Khed taluka in Pune district.Due to this rise in human-leopard conflicts in Junnar, Wildlife SOS, in collaboration with the Maharashtra Forest Department, has expanded awareness sessions within the region.

The combined team actively addresses human-leopard interface scenarios in the state through a variety of initiatives aimed at fostering peaceful coexistence between leopards and local villagers.State forest department officials said leopards in Maharashtra often face agitations and conflicts with humans, responding with either a "fight or flight" reaction.Unfortunately, this often leads to negative outcomes, with leopards either being vilified or ending up trapped, incarcerated, or even killed by angry mobs.

Wildlife SOS officials also pointed out that the root cause of this conflict stems from human activities such as deforestation, encroachment, and poaching, which disrupt leopard habitats and force them to adapt to living near human settlements. "This close proximity increases the risk of retaliatory killings, severely impacts leopard survivability and increases conflict incidences," the official said. From 2022 to 2024, 11 persons died in this human leopard conflict. Another 25 persons suffered injuries according to state forest department data. An ongoing Wildlife Institute of India survey indicates that there are approximately 400-450 leopards in Junnar, Shirur,



Khed and Ambegaon region. To combat this issue, Wildlife SOS, along with the forest department, focus on public awareness and education campaigns. Operating out of the Manikdoh Leopard Rescue Centre in Junnar, the organisation works closely with local farmers and villagers to train and sensitise them about leopard avoidance behaviour."This hands-on approach further minimises negative interactions between leopards and humans, ensuring a safer environment for both," Mahendra Dhore, project manager Wildlife SOS said. Recently, an awareness session was conducted at R P Sabnis Vidyalaya in Narayangaon in Junnar, Maharashtra by Wildlife SOS in collaboration with the forest department, addressing the escalating human-leopard conflict in Junnar region. The session, attended by approximately 1,200 students, aimed to educate the community on the do's and don'ts in conflict-prone areas

Workers resorted to protest and even pelted stones after a migrant labourer died while a bus was being reversed in Gurgaon's Sector-35 on Saturday.

"Upon receiving the information (of the accident), a police team arrived at the spot... The police team informed the higher authorities about the agitation. Considering the situation, Siddhant Jain, Deputy Commissioner of Police (South), arrived at the spot," said Gurgaon police spokesperson ASI Sandeep.As per the complaint by an eyewitness at the accident site, "Around 8.20 am, the company bus arrived with employees, and all employees alighted from the bus. Monu also alighted from the bus and was walking towards me. Suddenly, the bus driver, due to negligence, reversed the bus at high speed and hit Monu. Monu fell and the bus tyre ran over him, causing his immediate death."In the videos that went viral soon after the accident, many people could be seen vandalising buses and vehicles in the area. The police said the bus driver fled after the incident. Based on the complaint, a case has been registered at Badshahpur



police station under IPC Sections 279 (driving a vehicle in a negligent manner) and 304A (causing the death of any person by doing any rash or negligent act not amounting to culpable homicide). The situation at the accident site is now completely peaceful and under control, the police said."As per protocol, the police team will conduct a post-mortem of the deceased Monu and hand over his body to his family. The bus driver responsible for the accident has been identified. Various police teams have been deployed to apprehend the driver, who will soon be arrested as per the law," the ASI added.

Pune civic body gives another chance for resident owners to apply for property tax concession; deadline August 15

With many eligible citizens failing to avail the 40 per cent concession in property tax of their residential premises by the end of the previous deadline of March-end, the Pune Municipal Corporation (PMC) has once again extended the deadline to apply for a concession till August 15 while undertaking a survey to verify the beneficiaries' eligibility through a door-to-door survey. The discount scheme was applicable since 1970 after the general body had passed a resolution, citing damage to properties due to flooding of the Mutha river due to a breach in the Khadakwasla dam in 1961. The PMC withdrew the 40 per cent discount in 2019 after objections were raised over it by the state audit department. Meanwhile, the civic body approached the state government following severe opposition from the public. In April last year, the state government decided to allow the PMC to continue with the decades-old 40 per cent concession scheme on property tax for self-occupied residential properties. Consequently, the scheme was restored. The citizens have to submit at least two documents from a list that includes LPG connection, Aadhaar Card, Voters ID card, Passport, Driving Licence or No Objection Certificate of housing society along with PT-3 form to the civic staff doing survey or civic facilitation centre. Finally, when the deadline to submit papers got over in March, many citizens complained that they were being made to suffer unnecessarily and sought more time to apply for the scheme. The eligible property owners have to claim tax concession by submitting the PT-3 forms along with the documents. According to the Pune Municipal Corporation, the concession scheme is only for self-occupied residential property and for only one property."The civic staff has begun the survey of residential properties. Those eligible will have to submit their documents along with PT-3 form by August 15. The fees of Rs 25 for the purpose would be recovered in the property tax bill next year," said Prithviraj B P, PMC additional municipal commissioner.Madhav Jagtap, in-charge of civic Property Tax department, said the PMC will also soon publish the list of residential properties that have not been given concession in property tax, he said.In 2018, the PMC, while withdrawing the scheme, had cancelled the benefit to old 96,122 properties and did not apply the scheme to 1,98,296 new properties as well as 1,68,771 old properties from 23 villages merged in civic jurisdiction. Of the total 4,63,189 residential properties not being given the benefit of scheme, only 90,749 applied to avail the ben-



11-year-old boy found dead in Pune district's Shirur; probe on as family alleges leopard attack

Hours after an 11-year-old boy was found dead in a sugarcane farm in a village in Shirur in Maharashtra's Pune district, a probe is on to confirm the cause of death as family members and villagers suspect that he was killed by a leopard. The incident took place in Dahiwadi village. Yash Gaikwad, a Class 5 student, was found dead with injuries on his body at a farm in the Devmala area of Dahiwadi on Friday evening. When the boy, who left his house to answer nature's call in the afternoon, did not return home, his family members started searching for him. With leopards being frequently spotted in the area, the villagers informed the forest department.A team led by range forest officer Pratap Jagtap reached the spot. Yash was found lying unconscious in a sugarcane farm. Though he was taken to a hospital, he was pronounced dead.

"So far, our investigation has revealed that there are no signs of an animal attack in this case. We are waiting for the post-mortem report. Nevertheless, considering it



to be a leopard attack case, we have laid six trap cages in the area. Trap cameras have also been installed and drones are being used to track leopard movements. The police are conducting a parallel investigation," Jagtap said.Meanwhile, an accidental death case was registered at the Shikrapur police station. "The post-mortem report is awaited. Investigation is on," Police Inspector Deepratan Gaikwad said.

Karnataka court remands actor Darshan to judicial custody till July 4 in Renukaswamy murder case

A court here on Saturday remanded Kannada actor Darshan Thoogudeepa to judicial custody in the Renukaswamy murder case till July 4. His four alleged accomplices too were sent to judicial custody. The Special Public Prosecutor prayed the court for a direction to lodge the accused persons separately and in different jails across Karnataka, which was opposed by Darshan's lawyers. A huge number of his fans gathered at the court and raised slogans in favour of Darshan. The actor too waved at the them from the caged police van. Thirteen other accused, including the actor's friend Pavithra

Gowda, were remanded to 14 days' judicial custody two days ago.A total of 17 people are accused in the murder case.According to police sources, Renukaswamy, a fan of the actor, had sent obscene messages to Gowda, which enraged Darshan, allegedly leading to his murder.Renukaswamy's body was found near a stormwater drain adjacent to an apartment in Sumanahalli here on June 9.According to the post-mortem report, Renukaswamy's death was caused due to shock and haemorrhage as a result of multiple blunt injuries sustained.

The (Shri Amarnath) Shrine Board and the J-K administration have made special arrangements for the pilgrims. In the last two years, the facilities for the yatris have improved a lot."Sinha said the roads leading to the cave shrine have been upgraded and some stretches have been widened by the Border Roads Organisation (BRO) this year. "I think the yatris will be able to undertake a smoother pilgrimage this time," he said at Raj Bhavan after the puja. The LG said people from all religions have always supported the vatra.

"I appeal to the people of J-K, especially those in the areas from where the yatra passes through, to keep alive the tradition of supporting the yatra and taking care of the pilgrims this year also. Peaceful and smooth pilgrimage helps create a good image of J-K across the world," he added. Driver, owner of vehicle held after viral clip shows kids tumbling out of school van in Vadodara

A day after a video of two schoolgirls falling out of a moving van went viral on social media, the Makarpura police station in Vadodara city, on Saturday, arrested two persons, including the owner of the van and the driver, for rash and negligent driving and also for endangering the life of persons

The alleged incident occurred at noon on Wednesday when the driver of the school van was dropping off students of a private school in the Makarpura area. The FIR, lodged by police sub-inspector R J Kalsava of the Vadodara city traffic department at Makarpura police station states that on examining the viral CCTV footage, it turned out to be that of Tulsidham society on Novino Road.The driver of the vehicle has been identified as Pratik Padhiyar while the owner has been identified as Jigneshkumar Joshi.In the video, two schoolgirls are seen tumbling out of the van with their school bags as the vehicle moves ahead. The clip further shows residents rushing to help the students, one of whom is seemingly in discomfort.

Another student from the van as well as the driver are seen rushing into the frame a few seconds later even as a resident picks up one of the students — an eightyear-old girl — and takes her inside a house to administer first aid.

Kalsava, in his FIR said, "After identifying the driver, when he was called for questioning, he told the police that he had forgotten to lock the rear passenger door of the school van (a Maruti Eeco model) and therefore, as the door suddenly slid open, two students fell off the moving van along with their bags. On being questioned, the driver shared the details of the two students. When we contacted the mother of one eight-year-old, she said that since the child had only sustained minor injuries, they did not report to the police."The FIR further states that Padhiyar had no permanent license and was driving the van on a learners' license while the owner of the van had not sought an RTO permit to ferry school students.

The complaint further reads, "The driver, aged 23, has a learner's license that is valid from January 1, 2024 to July 3, 2024. He produced his application number for a permanent license. On inquiring about an RTO permit to use the van for ferrying school students, it came to light that the owner of the vehicle did not apply for one."The two accused have been booked under Indian Penal Code (IPC) Sections 336 (act rashly or negligently as to endanger human life or the personal safety others), 337 (causing hurt to any person by doing any act rashly or negligently as to endanger human life, or the personal safety of others) and 114 (abettor present when crime committed) as well as relevant sections of the Motor Vehicle Act.

Speaker refused to give time to speak about Kallakurichi hooch tragedy: K Palaniswami

Chennai: AIADMK party general secretary and Leader of the Opposition, Edappadi K Palaniswami on Saturday, staged a walkout alleging that Speaker M Appavu has refused to allot time to speak about the Kallakurichi hooch tragedy. "Speaker M Appavu refused to give time to speak about the Kallakurichi hooch tragedy. The government is so lethargic. According to the information we have, 55 people died and 183 people are affected by the hooch tragdey," Palaniswami alleged. "The Minister says people died because they came for treatment with delay. But what is the reason for that? Government is the reason. The first day the District Collector denied the illicit liquor in Kallakurichi," he said.

"As this is people issue what would be important than this to discuss in assembly? Each day people are losing their life. So we asked for time. CM says we are doing drama. We are just explaining what is happening. If CM really had guts he would have given an explanation yesterday when we asked for. AIADMK asks for demand for resignation of CM M K Stalin," Palaniswami said.The opposition leaders staged a walkout after Speaker M Appavu rejected AIADMK leaders' demand to adjourn the Question Hour to discuss the issue. On Friday, AIADMK MLAs were evicted from the House after they staged a sit-in protest.Meanwhile, the death toll in the Kallakurichi Hooch tragedy has risen from 50 to 53, officials said on Saturday.

Kallakurichi District Collector MS Prasanth said that out of the total 193 patients, who consumed illicit liquor, 140 are currently safe."193 people who have consumed illicit liquor have come to the hospital. Out of which 193, 140 are currently safe, while few of them are on ventilators. Right now, 53 people have passed away," he



said."So far, seven people have been arrested in the case. The case has been given to the CBI CID branch of Tamil Nadu Police. The patients are being given best treatment. Special doctors were mobilised in the initial stage. About 56 doctors were brought in from different medical colleges. Many patients who had respiratory problems, have recovered too," the Kallakurichi Collector said.Earlier, the Tamil Nadu government had ordered a judicial inquiry into the tragedy. IGI police bust fake passport racket in Delhi, 3 held

Three persons were held by the Indira Gandhi International (IGI) Airport police in Delhi, including two on June 18 and one on June 19, for being a part of a syndicate that creates fake Indian documents, the police said on Saturday.On June 18, three male passengers — Mohammad Mehdi Khan, 27, Mohedul Shekh, 33, and Mohammad Soziv Khan, 24 — arrived at the IGI Airport to fly to Bangkok. Upon inspection during immigration clearance, their Indian passports aroused suspicion.

Further scrutiny and questioning revealed that all three were allegedly Bangladeshi nationals in possession of birth certificates issued by Bangladeshi authorities. Their true identities were disclosed as Mohammad Mehdi Hasan, 25, Mohedul Mir, 33, and a 16-year-old minor, who had allegedly fraudulently obtained Indian passports. Consequently, a case was registered, and an investigation commenced.During the investigation, Hasan and Mir were interrogated and arrested. Hasan allegedly revealed that he was a Bangladeshi national who came to India illegally in 2019 with the help of his brother, Rezaul Khan alias Rezaul Karim who had been living in Noida for 10-12 years with fake Indian documents.Khan, the police say, is a part of the gang that helps Bangladeshis with fake Indian documents so that they can travel abroad.

Khan had allegedly facilitated Hasan's illegal entry and obtained a fake Aadhaar card and passport for him, enabling Hasan to travel to Kuwait in 2020 and visit Bangladesh multiple times.Khan had also allegedly arranged the journey to Bangkok for Hasan and two other Bangladeshi nationals in exchange for a substantial fee. Hasan reportedly disclosed that Khan had helped several Bangladeshis obtain Indian documents and passports for international travel.Mir reportedly told the police that he entered India illegally in 2016 with the assistance of a Bangladeshi agent and started working in Bengaluru. With the help of agents, he obtained fake Aadhaar and PAN cards.He reportedly frequently travelled back to Bangladesh, where he was introduced to Khan, who promised to arrange an Indian passport and facilitate his travel abroad for Rs 1 lakh. Khan updated Mir's address on his Aadhaar card and secured an Indian passport from Ghaziabad. Through local intelligence and technical surveillance, the police arrested Rezaul Khan from Noida. Khan allegedly confessed to his crimes, revealing that he came to India illegally 10-12 years ago and began working in Noida with fake Indian documents. He eventually started working as an agent and allegedly began creating fake Indian documents and arranging passports for Bangladeshi nationals to travel abroad. Khan reportedly admitted to facilitating his brother's illegal entry and travel, as well as assisting other Bangladeshi nationals in exchange for money.Khan has been booked under Sections 419 (cheating by personation), 420 (cheating), 468 (forgery for cheating), 471 (using forged documents), and 120B (criminal conspiracy) of the Indian Penal Code, sections 12 of the Passport Act, and section 14 of the Foreigners Act.

Shadows pass through her body like moments of anxiety.The effect is a visceral awareness of what artists, Karishma Harlalka, who is the dancer, and photographer-videographer Sugat Gaikwad want to tell the people of Pune about – a fundamental but less-spoken concern about power dynamics: consent and boundaries.

An exhibition, "No Positive", at Sudarshan Kaladalan from June 22 will feature this video of Harlalka dancing as well as photographs of her. "I have faced issues because I could not say no to things. Ghar pe sikhaya jata hain, 'Na nahin bolte'. (We are taught at home not to say no.) I wanted to say no many times but felt pressured to say yes," says Gaikwad, who has been shooting theatre and dance productions in the city for several years.Gaikwad had to face multiple social challenges and realised that many friends had troubled lives because refusal was made impossible. "I talked to them and realised that we consider 'No' to be a negative word due to social conditioning. The truth is that setting boundaries and refusing to do something that you do not want is ok, says Gaikwad, who has conceptualised this project.Harlalka, co-founder of Artsphere and Soulsphere, Pune, a space for performing arts and therapy, mental health services, and mental wellness, was already working with the concept of boundaries in terms of mental health "and how it is difficult for most people to say No even if it is healthy for them" when Gaikwad approached her for this piece. "The idea that saying No makes one a bad person is why most people struggle with it. People, who usually say no, are also looked at as not being



friendly and warm. The idea behind the dance piece was to break that ideology and talk about first taking care of oneself," says Harlalka. The dance, a fully embodied and felt experience, was unrehearsed and performed impromptu as Gaikwad shot it in one take.

When consent came into the limelight during the Me Too movement in India, with models, journalists, and artists taking to social media to share their experiences of sexual exploitation, it prompted many regular women and men, too, to overcome shame and speak among themselves. The movement, however, was short-lived and did not create a healthier living and work environment in society.Gaikwad has extended the theme of boundaries to understand consent and refusal in a variety of situations, for instance, when parents decide the careers of their children and juniors unwillingly agree with bosses. "It is not important if what you want is right or wrong. Our concern is that your wish should be respected.

Demands for banning exit polls childish, says Axis My India chief

New Delhi: Facing opposition fire for exit polls allegedly being used for stock market manipulation, Axis My India's chief Pradeep Gupta has said he is open to facing all kinds of investigations and it would help do business in a much better way if the government frames specific regulations for pollsters.Opposition parties and several civil society groups have been asking for thorough investigations, including by capital markets regulator SEBI and a Joint Parliamentary Committee (JPC), after the stock markets witnessed a massive rally when exit polls gave a huge majority to the BJP but fell sharply after the actual results showed the ruling party falling short of a clear majority on its own.In an interaction with PTI, Gupta said he has been demanding formulation of norms and regulations for pollsters since five years.

Gupta, the chairman and managing director of Axis My India that had predicted 361-401 seats for the BJPled alliance as against the actual tally of 240 seats, also termed as "childish" the demands for banning exit polls, saying every single citizen and organisation wants to know the election results and banning exit polls would serve no purpose."We have no connection with stock market whatsoever but I am happy to know these allegations because our data and system is so foolproof that any probe will give me an opportunity to showcase all of that is used to predict exit polls to the world. In a way it is an opportunity for us, I support the demand as it will give us a chance to show our credentials," he said. Asked about whether he is open to a probe by a JPC or SEBI, the pollster said, "I am open to facing all kind of investigations.""As far as me deriving any benefit from stock market jump is concerned... Axis My India has no demat account. It is a limited company, not listed and till

today not a single external investment is there in the company. There is no investment by promoters. My personal investment in stocks since April has been merely Rs 35,000. Where have I benefited?" he asserted. The pollster also responded to allegations of Axis My India also conducting exit polls for foreign investors and sharing different results with them."We have never been approached by any FII, neither we have worked for any foreign investors, we have not conducted any exit poll survey for them ever," Gupta, 55, said. Terming the demands for banning exit polls as "childish", Gupta said specific regulations for pollsters will not only help us do business better but also add more credibility to the exit polls.He also said Axis My India's 70 per cent clients are corporate clients including bigwigs like Bill Melinda Gates Foundation and denied any conflict of interest with exit polls."First they used to call exit polls unscientific, now they want exit polls to be banned. These are childish talks. Every single citizen and organisation wants to know the election results and banning exit polls would serve no purpose. Exit polls are not just to tell who is winning and losing, it also helps political parties analyse the result," he said."As far as we are concerned, I mentioned 70 per cent of my clients are corporate clients. Even if they are banned, it won't impact our business. I am with the law whatever is decided," he added.Questioned about whether the dent in image caused by 2024 poll results has also impacted his corporate clients, Gupta said, "They give us business for the work we do for them and not on basis of how rightly we predict election results"."Since the last five years, I am running from pillar to post seeking some regulations. When our people go on ground, they are seen with a suspicious mindset. We have to convince that we are not salespersons, we aren't frauds and we are not sent by a political party. We are often asked who gave you permission? And we ask please tell where we need to take permission?""We wrote to the home ministry, we were guided to the law ministry that there is no law so first we need a law. From there we were referred to the information and broadcasting ministry that you get yourself registered there and set up a cell. We were told that you will publish a survey but who will monitor who is right and wrong ... nothing has moved but I strongly believe that we need regulations," he said. Axis My India has been conducting exit polls since 2013 after Gupta returned from the Harvard Business School and claims a track record of predicting 61 out of 65 elections correctly.

Israeli strikes kill at least 42 in Gaza, enclave's government media office says



CAIRO GNS News Agency, June 27, - At least 42 people were killed in Israeli attacks on districts of Gaza City in the north of the Palestinian enclave on Saturday, the director of the Hamas-run government media office said.One Israeli strike on houses in Al-Shati, one of the Gaza Strip's eight historic refugee camps, killed 24 people, Ismail Al-Thawabta told Reuters. Another 18 Palestinians were killed in a strike on houses in the Al-Tuffah neighborhood.The Israeli military released a brief statement saying: "A short while ago, IDF fighter jets struck two Hamas military infrastructure sites in the area of Gaza City."It said more details would be released soon.

Hamas did not comment on the Israeli claim to have hit its military infrastructure. It said in a statement the attacks targeted the civilian population and vowed in a statement "the occupation and its Nazi leaders will pay the price for their violations against our people."Footage obtained by Reuters showed dozens of Palestinians rushing out to search for victims amid the destroyed houses. The footage showed wrecked homes, blasted walls, and debris and dust filling the street in Shati refugee camp.

Israel's ground and air campaign in Gaza was triggered when Hamas-led militants stormed into southern Israel on Oct. 7, killing around 1,200 people and seizing more than 250 hostages, according to Israeli tallies. The offensive has left Gaza in ruins, killed more than 37,400 people, of whom 101 were killed in the past 24 hours, according to Palestinian health authorities, and left nearly the entire population homeless and destitute.More than eight months into the war, Israel's advance is now focused on the two last areas its forces had yet to seize: Rafah on Gaza's southern edge and the area surrounding Deir al-Balah in the centre. Residents said Israeli tanks deepened their incursion into western and northern Rafah areas in recent days. On Saturday Israeli forces bombed several areas from air and the ground, forcing many families living in areas described as humanitarian-designated zones to leave northwards. The Israeli military said forces continued "precise, intelligence-based" targeted operations in Rafah, killing many Palestinian gunmen and dismantling military infrastructure. On Friday, the Gaza health ministry said at least 25 Palestinians were killed in Mawasi in western Rafah and 50 wounded. Palestinians said a tank shell hit a tent housing displaced families. The Israeli military said that the incident was under review. The draft UN General Assembly resolution establishing the International Day of Yoga was proposed by India and endorsed by a record 175 member states."The International Day of Yoga recognises the ancient practice's unmatched power to deliver healing, inner peace and physical, spiritual and mental well-being," Mr. Guterres said in his message on June 21 as the world celebrated the 10th International Yoga Day."With roots in India but now embraced worldwide by people of all faiths and cultures, Yoga unites people with its values of balance, mindfulness and peace with people and planet alike," Mr. Guterres said in the message posted on X by the Permanent Mission of India to the UN.

He noted that this year's theme 'Yoga for Self and Society' reminds "us of Yoga's important role in enhancing people's lives and the wider community. On this important day, let us all be inspired by Yoga's timeless values and its call for a more peaceful and harmonious future," the UN chief said. The Permanent Mission of India to the UN organised the commemoration of the 10th International Yoga Day at the North Lawn Area of the UN Headquarters, where Prime Minister Narendra Modi led the Yoga Day last year in a historic celebration, nine years after he proposed from the UN General Assembly podium for June 21 to be marked as International Yoga Day. The event was attended by UN envoys, personnel, officials and members of the diaspora as well as yoga enthusiasts and practitioners. UN Deputy Secretary-General Amina Mohammed greeted the attendees with a 'Namaste' and said that at its heart, yoga is about unity, the unity of mind, body and spirit."It is about you, it is about me, it is about us. UN envoy defends failure to include Afghan women in upcoming meeting with Taliban in Qatar

The United Nations' (UN) top official in Afghanistan defended the failure to include Afghan women in the upcoming first meeting between the Taliban and envoys from 22 countries, insisting that demands for women's rights are certain to be raised.UN special envoy Roza Otunbayeva was pummelled with questions on June 21 from journalists about criticism from human rights organisations at the omission of Afghan women from the meeting in Qatar's capital, Doha, on June 30 and July 1.

The Taliban seized power in 2021 as United States and NATO forces withdrew following two decades of war. No country officially recognises them as Afghanistan's government, and the UN has said that recognition is almost impossible while bans on female education and employment remain in place.Human Rights Watch Executive Director Tirana Hassan said that, in the face of the Taliban's tightening repression of women and girls, the UN plans to hold a meeting "without women's rights on the agenda or Afghan women in the room are shocking."Amnesty International Secretary General Agnes Callamard said, "The credibility of this meeting will be in tatters if it doesn't adequately address the human rights crisis in Afghanistan and fails to involve women human rights defenders and other relevant stakeholders from Afghan civil society."

Ms. Otunbayeva, a former president and Foreign Minister of Kyrgyzstan, insisted after briefing the United Nations Security Council that "nobody dictated" conditions to the United Nations about the Doha meeting, but she confirmed that no Afghan women will be present."UN political chief Rosemary DiCarlo will chair the meeting," Ms. Otunbayeva said. She will attend and a few of the 22 special envoys on Afghanistan who are women will also be there. The meeting is the third UN-sponsored gathering on the Afghan crisis in Doha. The Taliban weren't invited to the first and Secretary-General Antonio Guterres said they set unacceptable conditions for attending the second in February, including demands that Afghan civil society members be excluded from the talks and that they treated as the country's legitimate be rulers.Undersecretary-General DiCarlo visited Afghanistan in May and invited the Taliban Foreign Minister, Amir Khan Muttaqi, to attend the upcoming meeting. The Taliban accepted and said they are sending a

delegation."We do hope that delegation will be led by de facto Foreign Minister Muttaqi," Ms. Otunbayeva said, but the Taliban may send another Minister."Just before the Doha gathering, there will be a hybrid meeting with Afghan civil society representatives from inside and outside the country," Ms. Otunbayeva said. And on July 2, immediately after Doha, "we'll be meeting all the civil society people."The Taliban have used their interpretation of Islamic law to bar girls from education beyond age 11, ban women from public spaces, exclude them from many jobs, and enforce dress codes and male guardianship requirements.Ms. Otunbayeva said the upcoming gathering will be the first face-to-face meeting between the Taliban and the envoys and will focus on what she said were "the most important acute issues of today" private business and banking, and counter-narcotics policy.Both are about women, she said, and the envoys will tell the Taliban, "Look, it doesn't work like this. We should have women around the table. We should provide them also access to businesses." She added that "if there are, let's say, five million addicted people in Afghanistan, more than 30% are women.'

Ms. Otunbayeva told the Security Council the UN hopes the envoys and the Taliban delegation will speak to each other, recognise the need to engage, and "agree on next steps to alleviate the uncertainties that face the Afghan people."The UN expects a continuation of the dialogue at a fourth Doha meeting later in the year focused on another key issue: the impact of climate change on the country.Lisa Doughten, the UN humanitarian office's finance director, told the council that "the particularly acute effects of climate change" are deepening Afghanistan's humanitarian crisis, saying more than 50% of the population - some 23.7 million people - need humanitarian aid this year, the third-highest number in the world."Extreme weather events are more frequent and more intense," she said. "Some areas in Afghanistan have warmed at twice the global average since 1950" with the country experiencing increasing droughts and deadly flash flooding.Ms. Otunbayeva said another outcome from the Doha meeting that the UN would like to see is the creation of working groups to continue talks on how to help farmers replace poppies producing opium with other crops, how to provide pharmacies with medication to help addicted people, and how to address crime and improve banking and private businesses. As for what the UN would like to see, she said, "we need badly that they will change their minds and let girls go to school." Ms. Otunbayeva said Afghanistan is the only country in the 57-nation Organisation of Islamic Cooperation that doesn't let girls go to school, which she called "a big puzzle." "Afghanistan has been very male-dominated and "we want to change the minds" of young people from such a traditional society towards women," Ms. Otunbayeva said. The humanitarian office's Doughten told the council "the ban on girls' education is fueling an increase in child marriage and early childbearing, with dire physical, emotional and economic consequences." She also cited reports that attempted suicides by women and girls are increasing

U.S. aircraft carrier arrives in South Korea as show of force against nuclear-armed North Korea

A nuclear-powered United States aircraft carrier arrived on June 22 in South Korea for a three-way exercise stepping up their military training to cope with North Korean threats that escalated with its alignment with Russia. The arrival of the USS Theodore Roosevelt strike group in Busan came a day after South Korea summoned the Russian Ambassador to protest a pact reached between Russian President Vladimir Putin and North Korean leader Kim Jong Un this week that pledges mutual defence assistance in the event of war.South Korea says the deal poses a threat to its security and warned that it could consider sending arms to Ukraine to help fight off the Russian invasion as a response — a move that would surely ruin its relations with Moscow.Following a meeting between their defence chiefs in Singapore earlier in June, the United States, South Korea and Japan announced Freedom Edge. The new multidomain exercise is aimed at sharpening the countries' combined response in various areas of operation, including air, sea and cyberspace. The Theodore Roosevelt strike group will participate in the exercise that is expected to start within June. South Korea's military didn't immediately confirm specific details of the training.South Korea's navy said in a statement that the arrival of Theodore Roosevelt dem-



onstrates the strong defence posture of the allies and "stern willingness to respond to advancing North Korean threats." The carrier's visit comes seven months after another U.S. aircraft carrier, the USS Carl Vinson, came to South Korea in a show of strength against the North. The Theodore Roosevelt strike group also participated in a three-way exercise with South Korean and Japanese naval forces in April in the disputed East China Sea, where worries about China's territorial claims are rising. In the face of growing North Korean threats, the United States, South Korea and Japan have expanded their combined training and boosted the visibility of strategic U.S. military assets in the region, seeking to intimidate the North.

San Francisco: Fifty years ago, scientists discovered a nearly complete fossilized skull and hundreds of pieces of bone of a 3.2-million-year-old female specimen of the genus Australopithecus afarensis, often described as "the mother of us all." Though Lucy has solved some evolutionary riddles, her appearance remains an ancestral secret.Popular renderings dress her in thick, reddish-brown fur, with her face, hands, feet and breasts peeking out of denser thickets.This hairy picture of Lucy, it turns out, might be wrong.

Technological advancements in genetic analysis suggest that Lucy may have been naked, or at least much more thinly veiled. According to the coevolutionary tale of humans and their lice, our immediate ancestors lost most of their body fur 3 to 4 million years ago and did not don clothing until 83,000 to 170,000 years ago. That means that for over 2.5 million years, early humans and their ancestors were simply naked.As a philosopher, I'm interested in how modern culture influences representations of the past. And the way Lucy has been depicted in newspapers, textbooks and museums may reveal more about us than it says about her. The loss of body hair in early humans was likely influenced by a combination of factors, including thermoregulation, delayed physiological development, attracting sexual partners and warding off parasites. Environmental, social and cultural factors may have encouraged the eventual adoption of clothing.

Both areas of research - of when and why hominins shed their body hair and when and why they eventually got dressed - emphasize the sheer size of the brain, which takes years to nurture and requires a disproportionate amount of energy to sustain relative to other parts of the body.Because human babies require a long period of care before they can survive on their own, evolutionary interdisciplinary researchers have theorized that early humans adopted the strategy of pair bonding - a man and a woman partnering after forming a strong affinity for one another. By working together, the two can more easily manage years of parental care.Pair bonding, however, comes with risks.Because humans are social and live in large groups, they are bound to be tempted to break the pact of monogamy, which would make it harder to raise children.Some mechanism was needed to secure the social-sexual pact. That mechanism was likely shame. In the documentary "What's the Problem with Nudity?" evolutionary anthropologist Daniel M.T. Fessler explains the evolution of shame: "The human body is a supreme sexual advertisement... Nudity is a threat to the basic social contract, because it is an invitation to defecAs human civilization developed, measures must have been put in place to enforce the social contract – punitive penalties, laws, social dictates – especially with respect to women.That's how shame's relationship to human nudity was born. To be naked is to break social norms and regulations. Therefore, you're prone to feeling ashamed.What counts as naked in one context, however, may not in another.Bare ankles in Victorian England, for example, excited scandal. Today, bare tops on a French Mediterranean beach are ordinary.

When it comes to nudity, art doesn't necessarily imitate life.In his critique of the European oil painting tradition, art critic John Berger distinguishes between nakedness - "being oneself" without clothes - and "the nude," an art form that transforms the naked body of a woman into a pleasurable spectacle for men. Feminist critics such as Ruth Barcan complicated Berger's distinction between nakedness and the nude, insisting that nakedness is already shaped by idealized representations. In "Nudity: A Cultural Anatomy," Barcan demonstrates how nakedness is not a neutral state but is laden with meaning and expectations. She describes "feeling naked" as "the heightened perception of temperature and air movement, the loss of the familiar boundary between body and world, as well as the effects of the actual gaze of others" or "the internalized gaze of an imagined other." Nakedness can elicit a spectrum of feelings - from eroticism and intimacy to vulnerability, fear and shame. But there is no such thing as nakedness outside of social norms and cultural practices.Regardless of her fur's density, then, Lucy was not naked.But just as the nude is a kind of dress, Lucy, since her discovery, has been presented in ways that reflect historical assumptions about motherhood and the nuclear family. For example, Lucy is depicted alone with a male companion or with a male companion and children. Her facial expressions are warm and content or protective, reflecting idealized images of motherhood. The modern quest to visualize our distant ancestors has been critiqued as a sort of "erotic fantasy science," in which scientists attempt to fill in the blanks of the past based on their own assumptions about women, men and their relationships to one another. In their 2021 article "Visual Depictions of Our Evolutionary Past," an interdisciplinary team of researchers tried a different approach. They detail their own reconstruction of the Lucy fossil, bringing into relief their methods, the relationship between art and science, and decisions made to supplement gaps in scientific knowledge. Their process is contrasted with other hominin reconstructions, which often lack strong empirical justifications and perpetuate misogynistic and racialized misconceptions about human evolution. Historically, illustrations of the stages of human evolution have tended to culminate in a white European male. And many reconstructions of female hominins exaggerate features offensively associated with Black women. One of the co-authors of "Visual Depictions," sculptor Gabriel Vinas, offers a visual elucidation of Lucy's reconstruction in "Santa Lucia" - a marble sculpture of Lucy as a nude figure draped in translucent cloth, representing the artist's own uncertainties and Lucy's mysterious appearance.

GST Council meet: Uniform rate of 12% on milk cans and carton boxes; no tax on platform tickets, hostels



Union Finance Minister Nirmala Sitharaman Saturday said the 53rd GST Council Meeting has taken numerous decisions on trade facilitation, easing compliance burden and providing relief to taxpayers. It also decided on key issues related to Goods and Services Tax (GST) rates, exemptions and clarifications.Addressing media after the meeting, Sitharaman added that these decisions will benefit traders, MSMEs and taxpayers.

The Council has recommended a uniform GST rate of 12 per cent on all milk cans. It also recommended a uniform GST rate of 12 per cent on all carton boxes, and clarified that all types of sprinklers, including fire water sprinklers, will attract 12 per cent GST. The Council also recommended to prescribe 12% GST on all solar cookers whether it has single or dual energy source.Meanwhile, services provided by the Indian Railways such as the sale of platform tickets, facility of retiring rooms, waiting rooms, cloakroom services, battery operated car services are exempt from GST. Further, intrarailway supplies are also being exempt.

Hostels, which are for students outside of educational institutions are also exempt from GST. The Council has also recommended exempting accommodation services having a value of supply up to Rs 20,000 per person per month. "These services are supplied for a minimum continuous period of 90 days," Sitharaman said.Stating that the intention of the Central government has always been to bring petrol and diesel under GST, Sitharaman said it is now up to the states to come together and decide on the rate. The GST Council also recommended waiving interest and penalties for demand notices that have been issued under Section 73 of the


GST Act, including cases not involving fraud, suppression or misstatements, the minister said."For all those notices which were issued under Section 73 for the Fiscal Years 2017-18, 2018-19 and 2019-20, the Council has recommended waiving interest and penalties on the demand notices which have been served," she added.In order to reduce government litigation, the minister said the Council has recommended a monetary limit of Rs 20 lakh for GST appellate tribunal, Rs 1 crore for High Court and Rs 2 crore for Supreme Court for filing of appeals by the department. The Council has also recommended that the maximum amount for pre-deposit for filing appeal before the appellate authority be reduced from Rs 25 crore CGST and 25 crore SGST to Rs 20 crore CGST and Rs 20 crore SGST, which is the maximum amount of predeposit for filing appeals before the appellate authority.Further, in order to help small taxpayers, the Council has recommended extending the time limit to furnish the detail and the returns in the form GSTR 4 from April 30 to June 30, Sitharaman said, adding that this will apply for returns for the Financial Year 2024-25 onwards. The Finance minister also informed the rolling out of biometric-based Aadhaar authentication on a pan-India basis. "This will help us to combat fraudulent input tax credit claims made through fake invoices in the cases, she said.At the pre-budget meeting with state finance ministers earlier in the day, Sitharaman had underlined Centre's support to states through timely tax devolution and GST compensation arrears to stimulate growth.She also nudged states to take advantage of the scheme under which the Centre gives 50-year interest free loan to states for undertaking specified reforms.

Persistent Covid infections may be more common than thought: Study



New Delhi: A high proportion of COVID-19 infections in the general population lead to persistent infections lasting a month or more, according to a study.

It has long been thought that prolonged COVID-19 infections in immunocompromised individuals may have been the source of the multiple new variants that arose during the pandemic and seeded successive waves of infection, the researchers said. However, until now, the prevalence of persistentS-CoV-2 infections in the general population and how the virus evolves in these situations remained unknown, they said. The study, published in the journal Nature, used data from the UK Office for National Statistics COVID-19 Infection Survey (ONS-CIS), which tested participants monthly.

Of the over 90,000 participants, 3,603 provided two or more Covid positive samples between November 2020 and August 2022. Of these, 381 individuals tested positive for the same variant over a period of a month or longer. Within this group, 54 individuals had a persistent infection lasting at least two months."Our observations highlight the continuing importance of community-based genomic surveillance both to monitor the emergence and spread of new variants, but also to gain a fundamental understanding of the natural history and evolution of novel pathogens and their clinical implications for patients," said

Obesity, depression link found in middle-aged and older adults

New Delhi: New research has found a significant association between obesity and depression among middle- and older-aged adults in Ireland, with severe depressive symptoms likely among younger women having type 2 diabetes or less physical activity. Researchers said that a possible reason behind the link could be poorer self-esteem, self-image and body satisfaction, all known risk factors for depression, and could be exacerbated socially through prejudice, discrimination and stigma.Chronic pain conditions as a direct effect of obesity, such as joint and back pain, and fibromyalgia, too are known to result in depressive symptoms, they said.

Further, the researchers from University College Cork, Ireland, also said that biologically, obesity and depression share similar pathways, primarily through neurotransmitter imbalances, inflammation abnormalities and disturbances in energy production. Other factors include genetics and hormonal imbalances.

The positive relationship between obesity and depression is independent of lifestyle factors and disease conditions, they said, and that targeted interventions to address depression should include weight management measures.For the study, the researchers included more than 1,800 Caucasian-European individuals in the 46-73 years age bracket from urban and rural settings.

The researchers estimate that between one in a thousand to one in 200 of all infections may become persistent, and last for at least 60 days. In some cases, individuals remained infected with viral variants that had gone extinct in the general population, they said.In contrast, the researchers found that reinfection with the same variant was very rare, likely due to the host developing immunity to that variant and the strain reducing in frequency to very low levels after a few months. Of the 381 persistent infections, 65 had three or more PCR tests taken over the course of their infection. Most (82 per cent) of these individuals demonstrated rebounding viral dynamics, experiencing high, then low, then high viral load dynamics. According to the researchers, this demonstrates that the virus can maintain the ability to actively replicate during prolonged infections.

In the study, people with persistent infections were 55 per cent more likely to report having Long COVID symptoms more than 12 weeks since the start of the infection than people with more typical infections.Certain individuals showed an extremely high number of mutations, including the ones that define new coronavirus variants, alter target sites for monoclonal antibodies, and introduce changes to the coronavirus spike protein, which the virus uses to enter and infect human cells.

However, most individuals did not harbour a large number of mutations, suggesting that not every persistent infection will be a potential source for new concerning variants."Although the link between viral persistence and Long Covid may not be causal, these results suggest persistent infections could be contributing to the pathophysiology of Long Covid," said study co-lead author Katrina Lythgoe from the University of Oxford."Indeed, many other possible mechanisms have been suggested to contribute to Long Covid including inflammation, organ damage, and microthrombosis," Lythgoe added.

In an interview with Siddharth Kannan, when asked what the actor is doing wrong and if he needs to do something drastically different, Ahmed said the audience has the right to feel let down, but added that Tiger checks every box when it comes to superstardom. "Usually, people say, 'You have to work hard, but for Tiger you have to say, 'Mehnat mat kar!' Now what advice would you give him? What soothes me though, is the fact that it was the highest opener of 2020 despite COVID restrictions and would have had a great run had the pandemic not broken its knees," the filmmaker added. Tiger Shroff will be next seen in a special appearance in Singham Againthe third instalment of Ajay Devgn-led cop actioner. The film is gearing up for a Diwali release.

Paatal Lok creator Sudip Sharma says Amazon doesn't share data with creators so they can't ask for bigger budgets: 'Information is power'



Sudip Sharma, the creator of acclaimed shows such as Paatal Lok and Kohrra, spoke about the differences in collaborating with the two major international streaming platforms in India, Netflix and Amazon Prime Video. Sudip co-created the crime drama Kohrra for Netflix last year, and created Paatal Lok for Prime Video in the first wave of Indian streaming nearly half-a-decade ago. In an interview, he appeared to prefer working with Netflix, because he finds Prime Video to be too guarded with crucial data.

Chatting with Suchin Mehrotra on The Streaming Show, Sudip was asked if he'd want to highlight the differences in his experience working with the two platforms. He said, "Beyond a point, they're all the same... They have different cultures, and the personality of the person you're dealing with... Because the systems and processes aren't well defined, they're still finding their space in India. The processes at Netflix are more attuned to doing this, they take their role of being a media company very seriously, because that's all they are. If s**t happens to these processes, s**t goes down, that's how they look at it. Compared to Amazon, where (producing films and shows) is a small part of the beast, it's a hobby. If I was the richest man in the world, I would also want a few Hollywood stars to come to my party, it's that..."Sudip said that based on the information that Amazon has given him about Paatal Lok's viewership, he has no idea if it was a hit or not. He said that no platform is entirely transparent with numbers, but Amazon is extremely secretive. "Netflix shares more information than Amazon does. Amazon shares no information. I honestly have no idea how big a hit Paatal Lok was," he said.

He speculated that the reason behind this lack of transparency is to not allow creators to have a bargaining room. "There's a deliberate reason why they don't tell you. Information is power. I would ask for a bigger budget if I knew how big a hit it was. By that, I mean I'd ask for the right budget. I would have more bargaining power. Also, I would be comparing like-for-like; that comparison is not available to me. I cannot ask them why they gave another show a bigger budget even though it did fewer numbers."

In a recent interview on The Comment Section, Sacred Games creator Vikramaditya Motwane revealed that he wanted Sudip as a writer on the show as a writer, but Netflix put their foot down because he was working with Prime Video. Vikram told them that this isn't how they're going to make progress, because there is anyway a small talent pool to choose from.Sudip is now gearing up for the release of the second season of Paatal Lok, which will be released over four years after the first one. He didn't discuss the reasons behind the delay, but admitted that the process was 'tough' and has 'aged' him. He did, however, tease that it's the best thing he's ever done. After Paatal Lok 2, he'll begin work on the second season of Kohrra.

'You carry on, I'm off to eat tandoori chicken': How Javed Akhtar would excuse himself when Shabana Azmi was on hunger strike in the '80s



Actor Shabana Azmi spoke about her activism, and what drew her to joining a hunger strike in support of slum dwellers in the 1980s. She said that as the daughter of a card-carrying communist, poet Kaifi Azmi, she was always exposed to certain social realities as a child, but her mother was very concerned about her when she decided to step up and join the protests. In a chat with filmmaker Mira Nair, the veteran actor recalled how her husband, writer-lyricist Javed Akhtar reacted to her demonstration, and the sole Bollywood personality who silently supported her from the sidelines.

Shabana and Mira chatted with each other at the New York Indian Film Festival, where the actor spoke about her youth, and what drew her to raising her voice against injustice. She said that she was moved when she heard a group of slum dwellers speak about their homes being demolished by the government, and no compensation being offered in return. "Instinctively, I decided that I would like to go as well," she said.She continued, "I was supported by Javed. And without thinking, I joined the strike, and then, of course, we were in the limelight. My mother was really, really scared. My father was in Patna at that time. My mother sent a message to him, saying, 'Your daughter is doing this, please put some sense into her head'. And I got a telegram from my father, saying, 'Best of luck, comrade'. My mother would come, all white in the face, but then she would say, 'Inqilab zindabad'."

Shabana said that the experience transformed her, because she realised the level of misinformation that was being fed to the people. "I had support from Javed. Why referees took nearly three minutes to rule out Netherlands' goal against France

Netherlands disallowed goal Euro 2024Referee Anthony Taylor is surrounded by players as he waits for a fourth official decision on a goal by Xavi Simons of the Netherlands that was then disallowed for offside during the Group D match between the Netherlands and France at the Euro 2024 soccer tournament in Leipzig, Germany,

The Netherlands believed they had finally broken the deadlock after nearly 70 minutes of play against France. Xavi Simons' shot from outside the box – like many other goals in the Euro 2024 – was phenomenal. But his joy didn't last long after the linesman raised his flag for offside.For 2 minutes and 47 seconds after that, the referee and the team of video assistants analysed the goal before ruling it out. Simons was not at fault. In fact, it came down to the interpretation of the offside law.

Both teams struggled to find the back of the net so

when Simons finally scored in the 69th minute, it felt like a significant moment, with the Netherlands thinking they could sneak a famous victory. Unfortunately for them, the goal was immediately ruled out for offside, with the assistant referee deeming that Dutch full-back Denzel Dumfries was standing past France's backline. However, Dumfries was neither directly involved in the move nor did touch the ball. The question then was whether he impacted play in any way and obstructed French goalkeeper Mike Maignan. After a lengthy consultation, the officials ruled that Dumfries not only stood at an off-side position but obstructed Maignan's line of vision, making it impossible for him to either see the ball or make the save.

What do the rules say?

According to the International Football Association Board (IFAB), which determines the rules of the game, Dmfries was guilty of the rule that states — A player in an off-side position at the moment the ball is played or touched by a team-mate is only penalised on becoming involved in active play by: preventing an opponent from playing or being able to play the ball by clearly obstructing the opponent's line of vision

Could the goalkeeper have saved the shot?

It doesn't matter if Maignan could've saved the shot or not as that's not a consideration for the officials — they cannot decide about a keeper's ability. The officials have to ask themselves whether Dumfries had an impact on Maignan, and if that affected his decision not to make a dive to attempt the save. In this case, they ruled that it did and so, it was given an offside.

Babar Azam files defamation notice against journalist over match-fixing allegations during T20 World Cup

Pakistan cricket captain Babar Azam has filed a defamation notice against journalist Mubashir Luqman after he alluded to match-fixing allegations for Pakistan's dismal show in the T20 World Cup. Pakistan made an early exit from the tournament after they failed to chase down a run-a-ball target against India and lost to the US in a major upset. In the notice, which the Indian Express has access to, Luqman has been asked to apologise within 14 days. The defamation suit is of Rs 1 billion PKR "You are hereby called upon to tender an unconditional apology and retraction in the same manner in which you issued the defamatory statements on your YouTube show and with the same prominence within a period of 14 days, failing which our client reserves the right to institute legal proceedings in a court of competent jurisdiction, against you, under the Defamation Ordinance 2002 for damages of Rs 1 Billion," read the notice.

Babar Azam's lawyer Qazi Umair Ali has accused Luqman for not respecting a generational talent, who has won so many games for Pakistan. "We have got a player of Babar's calibre after a long time. Maybe after Younis Khan. The things which have been said are absolutely ridiculous. In the past, such things have also happened in Pakistan cricket. Yes, he didn't perform well. It happens. Virat Kohli struggled for three years, and we never heard a word about anything negative from India about Virat, instead, the entire country was backing him," Ali tells The Indian Express.Ali says the Pakistan captain doesn't want to drag the issue but only wants an apology from Luqman.

fixing. "Just a few days ago, Babar Azam received an Audi E-Tron. It's a fantastic car, and I also own one, but he will regret it when its electric boards start bursting in the rain. Babar mentioned that his brother gifted him the car, but I found out his brother does absolutely nothing," Luqman had said on his YouTube channel.

"When I inquired about the car, a source told me, 'If you lose matches against America, Afghanistan, the Netherlands, or Ireland, won't you get cars, houses in DHA, plots in Australia, and apartments in Dubai?"Pakistan cricket team's assistant coach Azhar Mahmood has also released a statement stating he will be "pursuing legal advice against those responsible for making these false allegations"."This culture of falsely accusing and misleading people to believe a false narrative is now getting ridiculous and dangerous. Speaking without evidence and misconstruing facts is a criminal offence, and those engaging in such behaviour will be dealt with through legal action," Azhar Mahmood wrote on X."Pursuing an increase in followers and media attention by spreading falsehoods is downright unacceptable. I will be pursuing legal advice against those responsible for making these false allegations towards me and my family, and strict action will be taken accordingly. We will not be discussing this matter further on social media. I urge everyone to avoid engaging with or entertaining these harmful narratives as it is essential to put an end to such behaviour in our media culture.

Euro 2024: If this is the end of Luka Modric's international career, it'll be the most heartbreaking farewell

An Italian journalist took the mic and made more of a request to Luka Modric rather than asking him a question in the post-match press conference. "I'd like to ask you," he began, "to never retire from your playing career because you are one of the finest players I have ever commentated on, thank you."

His eyes still red from crying after Croatia drew with Italy, a result that all but knocked them out of Euros, Modric at last smiled. He winked at the journalist and replied: "I'd also like to keep playing forever but there probably will come a time when I have to hang up my boots..."If that time is now, if this is the last time we see Modric in the famous chequered Croatia shirt, there wouldn't be a more heartbreaking farewell.

Like they have done in tournament football for the last six years, Croatia were coming out on top in a scrappy, stuttering tie. Neither they nor Italy had been particularly good in the group stage finale. But Modric - who else had been the difference between the two sides.Croatia had to win this one to progress out of the group, after being outclassed by Spain and frustrated by Albania. Briefly, when Modric saw his tired-looking penalty saved by Gianluigi Donnarumma in a game of few chances, the writing seemed on the wall. But instead of wallowing in self-pity and losing focus, Modric did what Modric does staying alert and staying in the right position. He asked for the ball when Josip Stanisic marched forward to launch another Croatian attack. Sprinted inside the box when he saw the pass being played wide towards Luka Sucic, sensing a cross might be swung in. His reading was spot on, but the cross found Ante Budimir in front of Modric. Donnarumma saved Budimir's first shot. The Italian goalkeeper tried to catch the loose ball. But there he was -Modric ready to pounce on the rebound, turning and wrapping his left boot around the ball to put it past Donnarumma.1-0, Croatia. If it remained like that, the perennial overachievers would once again sneak out of the group and jeopardise Italy's chances.Modric sprinted to the corner and collapsed to the ground, his teammates piling on top of him. Beneath that mountain, the goal scorer buried his face in his hands, hiding his tears; re-

lieved that he had made it right seconds after missing the penalty half-a-minute ago.

Then again, what's 30-something seconds compared to 18-plus years? That's how long Modric has been rescuing Croatia. That's how long he's been defying age with his untiring, relentless scheming in an international career that's older than some of the tournament's breakout stars. The goal made Modric the oldest scorer at Euros at 38 years and 289 days. And at that moment, it also felt like it would put him – and Croatia – on course for another fairytale.

Like the one at the 2018 World Cup, where Modric inspired Croatia to the final – the closest the tiny country of 38.6 lakh people has come to lifting the trophy. Modric's elegant ways of running the game – relying more on sensibilities, escaping tackles, passing and dribbling – saw Croatia reach the semifinal of the 2022 World Cup, a feat as improbable as them reaching the final four years earlier, and then the final of the 2023 UEFA Nations Cup.Indeed, none of this translated into a trophy. But that doesn't mean Modric won't be counted among football's immortals. In the decade of complete dominance by two individuals, Lionel Messi and Cristiano Ronaldo, only Modric stood up to them gracefully and consistently.

Those Croatian sides never got tired. They'd keep coming at you, outrun you and fight for the scraps. Never pretty, but always effective. And that is the big difference between then and now.Zlatko Dalic, who has overseen this golden era from the touchline, went with the same midfield of Modric, Mateo Kovacic and Marcelo Brozovic in the three group-stage matches. All three of them are in their 30s, and though Kovacic and Brozovic are much younger than Modric, they couldn't play two full matches in a row.Kovacic was subbed off in the 70th minute. A top-class ball carrier and a beautiful passer, the void he left was immediately felt as Croatia began to lose control of the midfield. And when Modric was substituted in the 81st minute, it felt like Croatia were happy to hold on to the slender lead they had. The change in mindset allowed Italy, poor in almost all areas until then, to impose themselves for the first time in the match. And with his team's fate no longer in his control, Modric began biting his tshirt in the dugout, anxiously waiting for the final whistle to blow. The referee had already glanced at his watch when Riccardo Calafiori slalomed down the midfield, dragging Croatian midfielders towards him and opening up space for Mattia Zaccagni on the left. Calafiori slipped a pass towards his teammate, who cut into the box, dropped a shoulder and curled a stunning shot into the top right corner.Like the goal he scored, Modric broke down after Zaccagni's goal too. For it meant that Croatia, with just two points in three games, are all but out of the Euros. Around him, the 25,000 Croatian fans inside the stadium were stunned into silence and his teammates collapsed to the ground.

face is his eyes. The alert, almond eyes, offset by thick and curved eyebrows, could glow with affection, sparkle with pride or reflect a vague dullness within seconds. Those eyes are a window to his mind and reflect the ebbs and flows of the match. The joy that sparked when a wicket fell, the rage that flashed when a catch was dropped, the dejection when Bangladesh batsmen hit a four, the desperation when rain lashed down and his team was behind on DLS.

He shut those eyes when Naveen-ul-Haq nailed Mustafizur Rahman in front and sealed Afghanistan's historic entry into the World Cup semifinals. He shut his emotions to the world. Perhaps he just wanted to experience in flash what he had experienced to fully soak the hour of glory, of pure bliss. Childhood years spent in stifling fear in the saffron-rich Nangarhar province in Jalalabad; the escape to Peshawar, his falling in love with the game, his first love that was fast bowling, the reluctant embracing of leg-spin, the rapid progress, the memorable journey to stardom, and now the guiding light to his team's most historic moment in the game.In many ways, Afghanistan's cricketing journey is Rashid's journey, intertwined and inseparable. You tell his story, you are telling the story of his country's stirring cricketing journey too. He is his country's cricketing icon and identity, he defines his country's cricketing ethos; he defined their World Cup dream run. His four-wicket spell set up the match, his 14 wickets captured the romance of Afghanistan dream run in the tournament. It has been a tournament in which cricket's master of disguise took on at least half a dozen guises: talisman, calm head, voice, identity, hope and googly-whipping spellcaster. It's no mystery, he emphasises. "I happen to have strong fingers," he almost whispers, almost apologetically. "Gift of nature," he reemphasizes.

When he doesn't get the flow of energy in his fingers, he feels like someone else. "It is something that matters to me more than the numbers on the board. I get a feeling that it's not me, it's some other person because it is not coming out of my hand as I want it to, even if I had delivered the goods," he explains. This World Cup, the ball has come out of his hands the exact way he wants it.



He demolished Bangladesh with his staple wrong'uns; he kept Australia guessing with a cocktail of wrong'uns and top-spinner: he traded all three wickets against India with his leg breaks. You watch him bowl and you realise why he treasures his fingers more than most leg-spinners. "My grip is in the tips of the fingers. It gives me more pace, control and the ball snaps out from the top of my fingers. It's the reason I am different from other legspinners."Rashid is an antithesis. He does the opposite. He bowls both the leg-break and wrong one from the back of his hands. It means the release points are the same and the batsmen can't decode the variation by watching his wrists alone, which in itself is a difficult art. His wrong ones are quicker than the leg-breaks. The legbreaks turn less than the wrong ones as well. The classicists swirl the leg-breaks from the side of their elastic palms. There are more wrists and flourish, transforming it to the realm of magic. But Rashid has translated the prosaic finger-spun leg-spin into improvisational verse.lt helped that he had little formal training. "Maybe, if I would have changed my action I would have lost my speed and rhythm." The leg-break, he says, was already there. From the moment he decided to quit bowling fast and try legspin, with the taped ball. There is a striking influence of his idol Shahid Afridi, an upgraded version perhaps. He holds the ball on the tip of the first three fingers. The index finger, wrapped beside the seam, and middle finger, placed just above the seam like a molar, and the thumb acting like a backrest. The gap between the index and middle fingers is massive, more like an off-spinner.

Unlike the conventional legspinners, the ball rests mostly on his fingers rather than the inside of the palm. He releases the ball from the top of the middle finger. "It came naturally and then you try your best to practise on it and get better and better when I was a kid. Later I found it was unique, that you are opposite to all the leg-spinners who are traditional. But I realized I need to make it better and better," he says. The first resort was the wrong one, now his most dreaded weapon. Paradoxically, his first experiments with it involved a lot of wrists into the release. "But I had little control and used to get hit. I realised I was using more of my wrists. So I tried bowling the wrongun with the same leg-spin grip. and I worked really hard on it. Practise, practise and a lot of spot bowling, before I perfected it," he says.
