### SC asks IIT Delhi panel to give opinion on contentious Physics question in NEET-UG exam

New Delhi: The Supreme Court on Monday asked IIT Delhi to form an expert panel to give its opinion on the decision of the National Testing Agency (NTA) to treat two options as the correct answers to a Physics question in the NEET-UG examination.A bench, headed by CJI D.Y. Chandrachud, said: "We request the Director of IIT Delhi to constitute a team of three experts of the subject concerned. The expert team is requested to formulate its opinion on the correct option and to remit its opinion to the registrar of this court by 12 noon on July 23.

The bench, also comprising Justices J.B. Pardiwala and Manoj Misra, directed that a copy of its order may be forwarded on Monday itself to the Director, IIT Delhi for expeditious action. In the batch of petitions alleging irregularities in the conduct of the NEET-UG exam, petitioners questioned the award of grace marks in respect of a contentious Physics question, adding that as many as 44 candidates were able to secure full marks on account of the ambiguous question. They contended that the NTA's decision to award compensatory marks contradicts its own instruction asking students to follow the latest NCERT textbook.

The matter will be taken up for further hearing on Tuesday.In the previous hearing, the apex court had sought a copy of the report of Bihar Police and its Economic Offences Unit (EOU) in relation to the NEET question paper leak case.Solicitor General Tushar Mehta undertook that he will place on record the copy of the report filed by Patna police as well as the report filed by EOU of Bihar Police. The NEET question paper leak case was cracked by Patna police on May 5, the day of the examination and an FIR was registered at the city's Shastri Nagar Police Station. The case was later transferred to the EOU of Bihar Police for investigation. On June 23, the Centre decided to transfer the investigation to the Central Bureau of Investigation (CBI). The SC also asked the NTA to release on its website centre-wise results after redacting personal information, including the roll number of the candidates. During the hearing, the apex court had asked the petitioners to illustrate that the leak was so systematic that the exam must be cancelled in its entirety and conducted afresh. It reiterated that if tainted cases cannot be segregated from untainted ones, the entire examination has to go.

### BRS MLC Kavitha's Default Bail Hearing Adjourned to August 5

The hearing of BRS MLC Kavitha's petition for default bail in the Delhi Liquor CBI case has once again been adjourned. The proceedings took place at Delhi's Rouse Avenue Court on Monday, with the court rescheduling the hearing to August 5.

On July 8, Kavitha's legal team submitted a petition arguing that the Central Bureau of Investigation (CBI) had failed to file a complete charge sheet within the mandated 60-day timeframe. During the hearing, Kavitha's lawyers contended that her arrest on April 11, 2024, was unlawful, pointing out that the CBI submitted an incomplete charge sheet on June 7. The court noted discrepancies in the CBI's charge sheet, raising concerns about its accuracy. Under the Criminal Procedure Code (CrPC) 167(2), Kavitha is eligible for default bail as the charges faced carry a punishment of seven years, allowing for a maximum custody period of 60 days. Kavitha had completed 86 days in custody by July 6, thus prompting her legal team to file for default bail. Despite previous discussions on the matter, the court has now set the next hearing date for August 5, leaving the outcome of Kavitha's bail petition pending.

### **KTR Demands Telangana State Government to Clarify Stance on New National Criminal Laws**

Hyderabad: BRS Working President KT Rama Rao has demanded the Telangana state government and the ruling Congress Party to publicly declare their positions on the implementation of new criminal laws. In his open letter, KTR highlighted that the draconian laws, which have elicited substantial opposition from diverse groups, are being condemned for encroaching upon fundamental civil rights and personal freedoms. He pointed out that critics fear these laws could potentially establish a police state within the nation.KTR points out that Chief Ministers of West Bengal, Tamil Nadu, and Karnataka have already opposed these laws and emphasizes that the Telangana state government must take a clear stance to uphold the State's historical reputation as a champion of civil rights. He insists that the Telangana government must clarify whether it will implement these new criminal laws as is or introduce amendments, following the examples set by other states

KTR demands immediate action from Revanth Reddy's Congress government, asking them to send a letter to the central government demanding amendments to the autocratic sections of these new laws. He also calls for a resolution in the upcoming assembly session to be sent to the central government. Failure to do so, KTR warns, will risk the State government being perceived as authoritarian and anti-people. The new criminal laws, which have replaced the Indian Penal Code (IPC), Code of Criminal Procedure (CrPC), and Indian Evidence Act (IEA) with the Bharatiya Nyaya Sanhita (BNS), Bharatiya Nagarik Suraksha Sanhita (BNSS), and Bharatiya Sakshya Adhiniyam (BSA), have been in effect nationwide since July 1. Numerous provisions and sections of these laws are viewed as serious violations of basic civil rights and individual freedoms. Civil rights activists and legal experts argue that these laws disproportionately favor the police and the government, suppressing legitimate protests and agitations. The new laws have already led to confusion, as cases must be tried under different



laws depending on when they were filed.

The reintroduction of the sedition law as "treason" is particularly concerning, as it could be used to suppress criticism of government policies. The new laws have the potential to usher in a police state, KTR remarked. He noted that for the past seven months, the state government has been using the police extensively to suppress protests by students, youth, and social media activists. Under these new laws, such actions could lead to an even more oppressive environment in Telangana, he added.BRS Working President underscores the need for extensive discussion on these new laws, pressing the Telangana state government and the ruling Congress party to clarify their positions. The Congress party at the national level has already expressed its opposition to these dangerous laws, but the local Congress government and party has not yet spoken a word on this issue. He insists that CM Revanth Reddy should publicly declare his stance, similar to other state Chief Ministers, and take immediate action to address the autocratic sections of these new laws.KTR demands that the Congress party, which came to power promising democratic governance. must fulfill its promise by opposing these dangerous laws at the state level and taking necessary actions to protect civil rights.

### Supreme Court stays UP Government's order to eateries to display names of owners along Kanwar Yatra route

#### New Delhi, GNS News Agency, July 22

The Supreme Court on Monday ordered an interim stay on the Uttar Pradesh Government's directive to eateries on the Kanwar Yatra route to display the names of their owners. The ex-parte order came from a Bench of Justice Hrishikesh Roy and Justice SVN Bhatt on petitions filed by the Association for Protection of Civil Rights, TMC MP Mahua Moitra, Prof Apoorvanand Jha and others challenging the validity of the directive.Issuing notices to the governments of Uttar Pradesh, Madhya Pradesh, Uttarakhand and some other states where Kanwar Yatra takes place, the Bench posted the matter for July 26."We deem it appropriate to pass an interim order prohibiting the enforcement of the above directives. In other words, the food sellers, hawkers etc, may be required to display the kind of food they are serving to Kanwariyas but they must not be forced to disclose the names of owners and staff employed," the Bench said, staying the UP government's order till the next date of hearing.On behalf of the petitioners, senior counsel AM Singhvi, C Uday Singh and Huzefa Ahmadi submitted that the UP government's directive went against secularism and was aimed at exclusion by identity."Impugned directives encourage discrimination on grounds of caste and religion and cannot be seen to serve any 'legitimate purpose'. These directives promote discrimination solely based on religious and caste identity, as they do not require the display of food items being served or a statement that no non-vegetarian or non-satvik food is being served, but only the display of religious or caste identity explicit in one's name. This directly breaches Article 15 of Constitution," one of the petitions the submitted.Maintaining that the decision was in the interest of law and order, the Uttar Pradesh government had on July 19 made it mandatory for food and beverage shops along the Kanwar Yatra routes to display the names/ identity of the operator/owner of such establishments.

### **JD(U)** reminds Centre of basis of alliance after special status for Bihar ruled out

The Janata Dal (United) has reminded the BJP-led NDA government of their "promise" of fulfilling the special category status demand of Bihar after the Centre asserted in Lok Sabha that such a demand was not made out, sources said. This comes a day after the JD(U), a key member of the NDA, demanded the Centre to grant special category status to Bihar in the all-party meeting before the beginning of the Monsoon session of Parliament.

In a written reply in the Lok Sabha on the first day of the Monsoon session, Minister of State for Finance Pankaj Chaudhary cited an inter-ministerial group report prepared in 2012 to assert that a case for granting special category status to Bihar is not made out. The minister further said that the special category status for plan assistance was granted in the past by the NDC to some states that were characterised by a number of features necessitating special consideration.

These features included hilly and difficult terrain, low population density or sizeable share of the tribal population, strategic location along borders with neighbouring countries, economic and infrastructural backwardness and non-viable nature of state finances. The decision was taken based on an integrated consideration of all the factors listed above and the peculiar situation of the state."Earlier, the request of Bihar for special category status was considered by an inter-ministerial group which submitted its report on March 30, 2012. The group came to the finding that based on existing NDC criteria, the case for special category status for Bihar is not made out." the minister said.

Reacting to the government's reply in Lok Sabha, top JD(U) sources told India Today TV that the party is very much committed to the special category status for Bihar."If there is some technical issue, the government must give us a special package for the development of Bihar. We want to make it very clear that we are part of this alliance only because we have been promised special status for Bihar," JD(U) sources said.Notably, in the all-party meeting on Sunday, July 21, Lok Janshakti Party (Ram Vilas) and Rashtriya Janata Dal also raised the demand for special category status for Bihar.Similar demands were also raised for states like Odisha and Andhra Pradesh by parties like Biju Janata Dal and YSR Congress Party, respectively. The special category status demand involves a state receiving benefits like financial aid, tax concessions, and other forms of support from the central government. The primary reasons states demand special status include economic backwardness, geographical challenges, and socio-economic disadvantages

Test results are awaited from 13 close contacts of the victim, a resident of Malappuram, Health Minister Veena George said on Monday. The boy's death, confirmed on Sunday, marks the first Nipah fatality in Kerala since 2023.George said results for nine samples sent to the Kozhikode Medical College Virology Lab and four sent to the Thiruvananthapuram Advanced Virology Institute are expected today. Six of those tested have exhibited symptoms.

### Short-term inflation outlook for India is benign, says Economic Survey

New Delhi: The short-term inflation outlook for India is benign, and the expectation of a normal monsoon and moderating global prices of key imported items give credence to the projections made by the RBI and IMF, the Economic Survey said on Monday. However, to ensure long-term policy stability, the Survey 2023-24 suggested making focused efforts to increase the production of major oilseeds, expanding the area under pulses, and assess the progress in developing modern storage facilities for specific crops. The Economic Survey 2023-24, tabled in Parliament by Finance Minister Nirmala Sitharaman, also suggested linking of price monitoring data for essential food items collected by different departments to help monitor and quantify the build-up of prices at each stage from the farm gate to the final consumer."The ongoing efforts to construct the producer price index for goods and services may be expedited to have a greater grasp of episodes of cost-push inflation," said the Survey authored by a team of economists led by Chief Economic Adviser V Anantha Nageswaran.

# Bengaluru sees spike in Pocso cases even as disposal rate slumps in special courts

Even as Bengaluru sees a growing registration of cases of sexual offences against children under the Protection of Children from Sexual Offences Act, 2012, the city's special courts for Pocso cases have witnessed a slowdown in the disposal of cases in 2024. This has resulted in long waits for justice for young victims of sexual offences despite courts mandating that the statement of the victim should be recorded within a month of a court taking cognisance of a Pocso case and that trials should be ideally completed in a year.

The analysis of data for pending cases in the five special fast-track courts in Bengaluru for Pocso cases until June 30 this year has revealed that only 15 (seven per cent) of the 216 cases charge-sheeted in 2024 have been disposed of so far, with 201 cases still pending trial. The low seven per cent disposal this year is in comparison to 43 per cent disposal in 2023 (117 of 274 cases that were charge-sheeted), 81 per cent in 2022 (307 of 377 charge-sheeted cases), 84 per cent in 2021 (195 of 231 charge-sheeted cases) and 82 per cent in 2020 (201 of 243 cases).Court officials have attributed the lag in case disposal in 2024 to the absence of a presiding officer/judge in one of the five fast-track Pocso courts for three months between March and May.Experts who help child victims of Pocso cases to cope with the police and trial procedures, however, suggest several reasons for the clogging of the judicial system, including a large number of cases of romantic and consensual relationships between teens falling under the category of cases when parental opposition is involvedIncrease in cases registered in last five years

While there is an apparent slowdown in the disposal of Pocso cases, the number of Pocso cases registered by the police in Bengaluru has also increased since the Pocso law came into existence in 2013. According to data from the Bengaluru police, as of June 30, 2024, there were 298 Pocso cases reported in Bengaluru. In 2023, there were 592 cases, in 2022, there were 482 cases, in 2021, there were 401 cases, and in 2020, there were 286 cases. According to data from the National Crime Records Bureau (NCRB), Bengaluru city registered 408, 393, and 350 Pocso cases in 2017, 2018, and 2019, respectively."The Pocso law came into effect around 2013 and there has been a steady increase in awareness and as result the law is invoked in cases of sexual offences against children. This has resulted in a regular increase every year in the number of registered cases. There is also some amount of misuse," a senior Karnataka police officer said."I think at least in a place like Karnataka, the police do register cases. Previously the same police officer or police station which said that it is not a case of rape are now taking up cases as soon as they know it is a case of sexual abuse or violence," said Kushi Kushalappa, director of support and rehabilitation team at Enfold India, an NGO that offers support to child victims and their family at the instance of the state Child Welfare Committee.In one of the high-profile Pocso cases registered in Bengaluru in March this year, a former chief minister is accused of sexual assault and harassment of a minor girl. The CID police filed a chargesheet in the case on June 27 and a Pocso fast-track court took cognisance of the case on July 6 and issued summons to the accused. The Karnataka High Court exempted the former CM from appearing in court after the former CM and three other accused challenged the Pocso chargesheet. Though the Karnataka High Court in a 2021 judgment by Justice B V Nagaratna and Justice M G Uma directed judges of special courts for Pocso cases to comply with Section 35 of the Pocso Act in the matter of recording of evidence of the victim child and the conclusion of the trial within the stipulated time (one month after taking cognisance and one year respectively) Pocso cases tend to drag on due to various circumstances.

The high court stated in 2021 that the statement of the victim should be recorded within a month of a special court taking cognisance of a chargesheet and that the trial should be completed in a year "so that the justice delivery system does not in any way contribute to the trauma, mental disturbance and anxiety of the victim child, which could lead to severe impact on the behaviour and personality of the child"."I would not say that, in any case, the child's evidence is completed within the first month of the court taking cognisance. I would also say that trials are not completed within 12 months of when it begins,' said Enfold India's Kushi Kushalappa."Having said this, I would say that things are a little faster these days. From having one court to three courts, we now have five fasttrack courts in Bangalore for Pocso cases. Things are a little bit better but other kinds of procedures are not being followed," she said.Long wait at courts for child victims"One of the consequences of long waiting periods for trials in Pocso cases is that victims and their families have to also wait for long periods in the court complexes which is quite inhuman but the presiding officers are also under a heavy burden," said a special public prosecutor at the sessions courts in Bengaluru.

Although a waiting room has been created in the court complex, the special fast-track courts for Pocso cases are spread over multiple floors, leaving victims and their families waiting outside court halls and very often in the proximity of the accused persons.

"Now, if the judge has to decide between a very young child or a girl who is pregnant or a person with disabilities or a person who has come from far, it becomes hard for the court to prioritises whose case should be taken up first. Then, the wait becomes quite long for the victim. If a system can be devised for when the child can come to court, it would really help," said Kushi Kushalappa.Romantic and consensual relationship cases among Pocso casesOne of the other factors contributing to the clogging of the judicial system with Pocso cases is the large number of cases of young people in romantic, consensual relationships or elopement cases that are categorised as Pocso cases, say officials dealing with such cases."There are pregnancies in some of these cases, so we are waiting for DNA reports and so many other things, which are also causing delays. We cannot only say that there are judicial delays since there are also other factors in cases not being disposed within one year of registration or taking cognisance," said Kushi Kushalappa. The Enfold Proactive Health Trust conducted an 18-month study on the implications of the Pocso Act on adolescent sexuality two years ago. The study found that out of 7,064 Pocso cases registered in Assam, Maharashtra, and West Bengal between 2016 and 2020, 1,715 were identified as romantic cases.

The Enfold study did not say that romantic relationships should be removed from Pocso cases because romantic and elopement cases could also have coercion, threats and promises to marry and other aspects, according to Enfold India officials."It is not that Enfold said that when there are elopement cases all of them should go away or anything but just to take a relook at the way the system is responding to these young people. On the one hand, a young man or a minor boy is being seen as an accused and criminalised while the girl is being institutionalised," said Kushi Kushalappa, "It is not as simplistic as we would like it to be but it is a complex situation. The state of Tamil Nadu has issued a circular where the police unit head has to assess whether there is a component of elopement/consensual romantic relationship and then decide whether to arrest the boy or the man," she said."This is also something for us to consider or at least start talking about," she pointed out. In its April 2021 order on handling of Pocso cases by special courts, the Karnataka High Court division bench quoted Jyoti Mathur, director of the 'Kailash Satyarthi Children's Foundation', to say that "a victim of sexual abuse is not a victim of one abuse but multiple abuses - physical abuse, emotional abuse, mental abuse, stigma, neglect and overall deprivation of the right to live with dignity"."While a timebound legal process and child-centric jurisprudence is non-negotiable, the role of experts in helping him walk this arduous journey is equally essential," the high court noted.

### ED raids locations linked to Haryana Congress MLA Rao Dan Singh in Mahendragarh

rao dan singh, ed raids, chandigarh news, indian expressRao Dan Singh, the Mahendragarh MLA, contested the Lok Sabha elections 2024 from the Bhiwani-Mahendragarh seat as the Congress candidate. (FB)The Enforcement Directorate (ED) on Thursday searched the house of Haryana Congress MLA Rao Dan Singh at Shankar Colony in Mahendragarh, his brother's nearby residence and his farmhouse on Rewari Road.

Security forces have been deployed at all these locations and nobody was allowed to enter or exit the premises. No official version was yet available from the ED's side and Rao Dan Singh was also not available to comment.Sources said the ED team was also searching the locations of a metal fabricating company, Allied Strips Limited (ASL), and its promoters Mohhinder Agrawal, Gaurav Agrawal and a few others as part of a money laundering probe linked to an alleged Rs 1,392 crore worth bank loan fraud case. About 15 locations were being searched across Haryana's Bahadurgarh, Rewari, Mahendragarh and Gurgaon. The ED has reportedly found that certain companies owned by Rao Dan Singh's son took loans from this ASL which were later written off.Mahendragarh MLA Rao Dan Singh contested the Lok Sabha elections 2024 from the Bhiwani-Mahendragarh seat as a Congress nominee. He, however, lost to the BJP's Dharambir Singh, who won for a third consecutive time (2014, 2019 and 2024) from this seat. According to Rao Dan Singh's election affidavit, he faced no cases against him

Incidentally, the searches occurred two days after Union Home Minister Amit Shah addressed a well-attended Samman Sammelan for backward classes organised by the Haryana government in Mahendragarh. According to preliminary information, Rao Dan Singh's family's name cropped up in the ED's investigation into the infamous Adarsh Cooperative Society scam. In 2019, the ED's Jaipur branch took over the investigation in this case. The investigations revealed the names of a company that had purchased land assets in Haryana's Rewari, Mahendragarh, and Narnaul areas. Over 100 people appeared on the ED's radar in the case, including Rao Dan Singh's son Akshat Rao.During his Lok Sabha election campaign, Rao Dan Singh said his family had no connection with this case, and the case against his son had also been closed. He also mentioned that his son's name figured in the ED's investigation due to a transaction with a company and he had no role in the alleged scam.Ahmedabad-based Mukesh Modi and Rahul Modi were named as prime accused in the Adarsh scam.

### File suo-moto cases against hate speeches and fake news peddlers: Karnataka top cop to officers

Accused in multicrore crytocurrnecy scam arrested from Kolkata in a bid to escape Dubai. cryptoAccused in multicrore crytocurrnecy scam arrested from Kolkata in a bid to escape Dubai.A 35-year-old fugitive wanted in a ?1,740-crore cryptocurrency scam unearthed in Himachal Pradesh last year, was arrested in Kolkata on Wednesday, two days after being detained by immigration officials at Netaji Subhas Chandra Bose International Airport, the police said. Accused Milan Garg, a resident of Uttar Pradesh's Meerut in UP, was brought to Shimla later in the day and will be produced in court for police custody on Thursday. Police said that Milan Garg, an expert in creating digital content, had escaped to Dubai after the massive fraud was unearthed last October but returned in June either through Bangladesh or Nepal.According to the police, around one lakh people in Himachal Pradesh were swindled through various websites and crypto coins, by luring them with promises of double returns. "The masterminds of the crypto racket created around 2,50,000 fake IDs for the fraudulent activity. The maximum number of victims hailed from the districts of Mandi, Kangra, Hamirpur, and Una in Himachal Pradesh," said an officer.

Police said Garg made digital coins such as DGT Coin, Fish Token, Hypnext Coin, Corvio Coin, etc., which were reportedly purchased by investors hoping high returns.So far, at least 70 suspects involved in the cryptocurrency scam have been arrested. Investigators, however, said that the mastermind of the multi-crore scam, Subhash Sharma, is still absconding. Earlier, a Special Investigation Team (SIT) discovered that Sharma was hiding in Dubai, but later learned that he had moved to another country."On Monday, Garg tried to go to Dubai from Netaji Subhas Chandra Bose International Airport in Kolkata, where immigration officials apprehended him as a lookout notice had already been issued against him. He was handed over to Kolkata police, who informed us about the development. We sent an investigation team to Kolkata, and they returned with Garg," said DIG Abhishek Dular, who is heading the SIT.

Meanwhile, investigation had revealed that Sharma had created five shell companies to adjust the money collected from investors, the police said. These companies – Soymans India Pvt Ltd, UBB Associates LLP, UBB Records LLP, Subro Technologies Pvt Ltd, and Him Jan Sewa Foundation – were registered with the Registrars of Companies (ROC) in Chandigarh, Delhi, and Himachal Pradesh.The SIT has filed four chargesheets against the suspects in the Special Court constituted for hearing matters related to the stringent Banning of Unregulated Deposit Schemes (BUDS) Act, 2019.

### To fight crime using AI, Maharashtra Police create MARVEL

With it becoming clear that artificial intelligence (AI) is here to stay, the Maharashtra government has decided to efficiently leverage this powerful tool to solve crimes with the help of a new company — the Maharashtra Research and Vigilance for Enhanced Law Enforcement (MARVEL).MARVEL has been created to enhance intelligence capabilities and improve crime prediction, enabling the state police force to tackle law enforcement more effectively using AI. With this, Maharashtra has become the first state in the country to create an independent entity for AI in law enforcement.

#### What is MARVEL?

A special purpose vehicle (SPV) owned completely by the Maharashtra government, MARVEL has been created in collaboration with the Indian Institute of Management (IIM) Nagpur. The Maharashtra government, IIM Nagpur and Chennai-based Pinaca Technologies entered a tripartite agreement on March 22 this year and the company was registered under The Companies Act. 2013."We are trying to use AI positively in crime detection. MARVEL is a platform where we are creating different modules for crime detection assistance. Any unit can send their case to MARVEL for technological assistance. For instance, if a car involved in a crime needs to be traced using footage from standard CCTV cameras and the registration number is captured, this footage can be sent to MARVEL. The platform can analyse the data using AI to help identify and apprehend the suspect. This is a simple example. There can be multiple complex applications like data mining etc.," Deputy Chief Minister and state Home Minister Devendra Fadnavis told The Indian Express. The company will come under the state home ministry, he added.Chief Secretary Sujata Saunik told The Indian Express that MARVEL can be used across all verticals within the Maharashtra home department. She also highlighted its potential in handling large data sets and its capability to narrow down police investigations by tracing the location of culprits or identifying crime scenes, thereby leading to concrete investigationsThis initiative marks the first formal implementation of AI within a police

setup by any state. MARVEL is currently exclusive to Maharashtra's departments, which need to present problem statements to receive tailored AI solutions for their cases.AI to help with data

"Al works on large volumes of data using which one can train digital algorithms. This is not just necessary to make predictive analysis but can also provide solutions for which one might need a human entity," informed Harssh Poddar, Superintendent of Police of Nagpur Rural police, who is also the ex-officio director of this company and the CEO of the SPV.Poddar explained that for organised crimes generating large amounts of data, MARVEL will use AI algorithms to analyse, visualise, and alert on key entities, allowing the police to take action. These AI algorithms will help make sense of the data, aiding in resolving cyber and financial fraud cases.

"There are two approaches to product development," explained Poddar. "One option is for MARVEL to host and run the platforms in-house. Alternatively, the platform can be handed over to the respective government departments with MARVEL providing support and training their personnel. The decision will be made on a caseby-case basis. If training is needed, it can be conducted at the IIM Nagpur campus."The Maharashtra Government holds complete shares in the company and will release funds in parts for five years. The first instalment of Rs 4.2 crore was recently released.Pinaca Technologies is MARVEL's tech partner. The company will create AI algorithms, with MARVEL retaining the copyright. Ten generic products are already available for rollout and the state will soon issue instructions on their use. The AI tools developed by MARVEL will enable the analysis of more data dimensions with reduced human labour and assist the cyber cell when needed.MARVEL is a corporate entity set to be commercialised in due course. Once commercialised, a business model will be necessary and IIM Nagpur will provide resources, training and AI expertise for the same. Bhimaraya Metri, Director of IIM Nagpur, said that the campus will offer research and development support to MARVEL, making Maharashtra a pioneer state in AI research initiatives.

### HC stays proceedings against police officer for 'destroying' evidence

The Punjab and Haryana High Court has stayed the proceedings against the then ASP (Assistant Superintendent of Police) Guriqbal Singh Sidhu for allegedly destroying evidence in the murder case of Sukhmanpreet Singh, alias Sippy Sidhu.An Inspector of Chandigarh Police, Poonam Dilawari, has already been granted similar relief from the HC in April this year.

The then ASP had moved the HC seeking quashing of order dated February 26, 2024, passed by Special Judge, CBI Court, Chandigarh, which had set aside the order of Special Judicial Magistrate, CBI Court, Chandigarh, which had dismissed the protest petition filed by Sippy Sidhu's mother and brother, seeking action against Inspector Poonam Dilawari and the then ASP Guriqbal Singh Sidhu for allegedly destroying evidence in the case.Sippy Sidhu, a national-level shooter and corporate lawyer, 35, was shot dead on September 20, 2015. Initially, the Chandigarh Police investigated the case, but it was handed over to the CBI in 2016. After six years, the CBI filed an untraced report in December 2020. The complainants filed a protest petition against it. Later when the CBI filed a chargesheet against accused Kalyani Singh, the complainants told the court that they would like to pursue the protest petition qua the role of Sidhu and Dilawari as well. The protest petition was, however, dismissed against the duo, Sidhu and Dilawari, by the court of Judicial Magistrate of CBI on February 4, 2023, stating that the protest petition filed by the complainant "was not maintainable, and infructuous in view of the report filed under Section 173 (8) of Criminal Procedure Code by the CBI".

The applicants, Deepender Kaur (mother of Sippy) and Jasmanpreet Singh Sidhu (brother of Sippy), challenged the Judicial Magistrate order before the appellate CBI court of Additional District and Sessions Judge, Jagjit Singh, by filing a revision application. The Special CBI court of Additional District and Sessions Judge in February this year had then remanded back the case for appreciating afresh the allegations as levelled in the protest petition against Guriqbal Singh Sidhu and Dilawari, and to pass afresh order therein. The special CBI court further directed the two police officials to appear before the court of Special Judicial Magistrate, CBI, Chandigarh.

Guriqbal Singh Sidhu, however, challenged the order of special CBI judge before the HC through counsel, Senior Advocate Bipin Ghai and advocate Nikhil Ghai, contending that the order passed by the CBI court is inherently illegal and flawed. Additionally, it was asserted that the CBI conducted further investigation leading to the presentation of a supplementary challan against accused Kalyani Singh, thus rendering the alternative prayer for cognisance gua the petitioner - accused unmaintainable, following the partial allowing of the main prayer. The counsel for Sippy Sidhu argued that the CBI court also committed a serious error by instructing the learned Special Judicial Magistrate, CBI, to consider the protest petition and subsequently proceed with the case, despite the record indicating that the main case was already committed to the CBI court. Hearing the matter, the bench of Justice Manjari Nehru Kaul issued notice to the CBI and adjourned the matter for July 29.Meanwhile, further proceedings qua the petitioner before the trial court shall remain stayed till the next date of hearing," ordered the

# After release from jail, farm activist says will march to Delhi once barricades are removed

After spending 111 days in jail, farmer activist Navdeep Singh Jalbera walked out of Ambala Central Jail on Tuesday evening after he was granted bail by the Punjab and Haryana High Court in a case registered in connection with farmers' February 13 'Dilli Chalo' march.On Wednesday farmer leaders went to Ambala to bring Navdeep Singh to the Shambhu border to honour him. Farmers took out a "victory march' celebrating his release from the jail. A stage was set up at Shambhu border where he was felicitated. While talking to The Indian Express, Navdeep Singh said, "I will never bow down to pressure. I have never yielded to it in the past either. I fully endorse the call of our leaders to march towards Delhi once the barricades are removed from Shambhu border. No matter, even if they lodge another case against me.

Navdeep Singh, a native of Jalbera village near Ambala, became famous as the "water cannon man" after he climbed atop a police water cannon in November 2020 during the farmers' agitation against the now-repealed farm laws. He was arrested by Haryana Police from Mohali on March 28 on various charges, including rioting and attempt to murder. The case lodged against him related to the February 13 commotion between farmers and police at Shambhu border when farmers were trying to march ahead and they were stopped by cops.Although Navdeep Singh was released from jail on Tuesday evening, the farm outfits decided to go ahead with their call for a gathering in Ambala (grain market) even though they postponed the call for a protest in front of the SP office. For the past few days, the farm outfits in Ambala were preparing for a protest in front of Ambala SP office to press for the release of Navdeep Singh.Sources say the farmer unions wanted to felicitate Navdeep Singh at a gathering in Ambala. However, the police started detaining the farmers when they reached the town on Wednesday morning. Farmers were not allowed to reach the grain market and over 25 farmer union leaders, including Navdeep Singh, were detained by cops and released in the evening. The day-long tussle between the police and the farm protesters in Ambala ended on Wednesday evening after the cops released the detained farmers.Bharatiya Kisan Union (Shaheed Bhagat Singh) president Amarjeet Singh Mohri was one among the detained farmer leaders, said union spokesperson Tejveer Singh.Getting information, the farmers from Shambhu border started moving towards Ambala after holding march in the neighbouring villages to mobilise more farmers for the



protest. However, the Ambala police did not allow them to enter the town. Then, the farmers started protesting near Ambala. Meanwhile, they received information that the detained farmers and their leaders have been released. After that the protesters again moved towards Shambhu border via neighbouring villages. Tejveer Singh said: "A 'fateh' march (victory march) was held in the villages as the struggle of farmers had resulted in the release of Navdeep Singh. He was felicitated at an event at Shambhu border. Navdeep Singh came out of jail on Tuesday evening and in the morning, cops detained him along with others so that they couldn't reach the grain market (Ambala)."

These artefacts will form the core of the museum's collection, offering a tangible link to the institute's storied past. From the beam and open staircase design in Research Block A to the heritage furniture in the main library, the sun shades, and brick work, the spaces of the institute boast the vision of the architects.

In conjunction with the museum, PGIMER will also introduce a coffee table book, published periodically, to highlight the institute's milestones and achievements. This publication will serve as a valuable source of information and inspiration for aspiring medical profession-als. The court also directed the Punjab government to ensure that the protesters gathered in its territory are "duly controlled as and when the situation so requires". The Haryana government has moved the Supreme Court challenging the high court order. The top court will hear the plea on July 22.


## In Malerkotla, 20 armed men attack Muslim activist, chop ear; victim blames land mafia

One of his ears was also chopped using a sharp-edged weapon.Khan said that the attackers were carrying revolvers, swords and other sharp-edged weapons and they were at least 20 in number. Fearing threat to his life, he has urged the AAP government and Punjab Police to give him security cover.Khan, who had recently formed an organisation – "Muslim Tiger Force" – while blaming "Muslim land mafia" for the attack, said that he was targeted as he has been speaking out against the mafia that have encroached on Waqf Board property in Punjab including mosques, burial grounds and others.

"Recently I got a chunk of land vacated from encroachers in Raikot. That's why I have been targeted. I have been requesting for long to Punjab CM and DGP to provide me security but no one bothered. I fear serious threat to my life," he alleged.Khan said that on Wednesday he was present at a typist's shop in the market of Malerkotla when a group of at least 20 men, armed with swords and weapons, opened attack on him. "My one ear has been chopped and I have received 15 stitches. They wanted to kill me," said Khan, alleging that the local police was not registering the FIR under attempt to murder sections.

"I request CM and DGP to take strict action against this Muslim land mafia who almost killed me and left me blood-soaked on road. Thanks to the crowd which took me to hospital. Malerkotla police is not putting serious charges like attempt to murder on them because of local MLA's pressure. There are 15 stitches on my head and ear. I can't hear properly as they pierced a sharp weapon in my ear," said Khan.In the recently concluded Lok Sabha

### Digging rainwater pit, MGNREGA workers stumble upon coins dating back to 1826, gold ornaments

The women workers last week handed over the collection to local panchayat authorities, who in turn informed the archaeology department.On July 13, MGNREGA workers in Kerala's Chengalayi village in Kannur were digging pits for rainwater harvesting when they found a pot. At first, they thought it contained a crude bomb as Kannur had seen incidents of abandoned articles exploding on being opened.

They threw it in fear and it broke, but instead of an explosive, what remained scattered across the ground were coins and objects that looked like gold and silver ornaments. The women workers last week handed over the collection to local panchayat authorities, who in turn informed the archaeology department.

On Wednesday, the state archeology department examined the items and said they were of archeological value. State Archeology Department Director E Dineshan said the most recent coin in the collection was minted in 1826, indicating that they might have been buried around



200 years back. The pot contained 13 golden lockets, 17 studs, five lockets, five rings and a bunch of coins, all of them either gold or silver. Another section of coins belong to the category of Venetian ducat, believed to be minted in Venice, he said. The recovered Venetian ducats were minted between 1670 and 1700. These ducats were formed into a chain and worn as jewellery, he said. The director said the recovered collection comprised coins from French India and those used by the Ali Raja of Arakkal dynasty (a Muslim King of present day Kannur region which ruled from 16th century to 19th century). He said the Archeology department had so far not conducted any study or excavation in this part of Kannur where these objects were found in a pot. But since the village is near a river, the region might have been a place of trade.

### Sharp surge in fees of most courses at skills university triggers criticism and concerns

A fourfold increase in the fee for Diploma in Architecture, and a nearly twofold surge for a Bachelor in Computer Applications - the fresh academic session has seen a significant hike in fees for most of the 80 courses, barring master programmes, at the Delhi Skills and Entrepreneurship University (DSEU). Even as the surge has drawn criticism from students and teachers, the administration has cited a fund crunch and said that the increase was long due.Last month, the fee surge prompted a protest from students. A group of 20 students from 19 different campuses of DSEU on June 11 protested in front of the office of the Directorate of Technical Education. They also put forward their requests in a letter but received no response. The protest was held by Aawaz, a students' union.Earlier, in a letter to Lieutenant Governor V K Saxena on June 12, a delegation of students raised concern over a "dramatic increase in tuition fees". The L-G later sent a letter to the varsity to "consider fee relaxation", according to V-C Dr Ashok K Nagawat. Every year, the course fees are increased by 10%, and the changes are adjusted in the semester fees. This academic session, however, the surge has been much higher.

For example, till last year, the Diploma in Architecture, and Diploma in Pharmacy had Rs 15,750 as the first-year course fee; the fee for Bachelor in Optometry and Bachelor in Library Sciences was Rs 42,700. It was Rs 52,700 for Bachelor in Computer Applications and Rs 60,250 for Bachelor in Data Analytics. While the first-year fee for Diploma in Architecture and a Diploma in Pharmacy has now been surged to Rs 63,000, it has been doubled for B S Optometry and B Library Sciences (Rs 1,13,000). For BCA and BS Data Analytics and Digital Marketing (course name changed), students have to pay Rs 1,13,000 — almost double the last year's fee.

The surge was long due, said V-C Nagawat. "The Diploma in Architecture course earlier was a slab-1 course - its tuition fee was Rs 10,000. Now, it has been shifted to slab-2 with a tuition fee of Rs 25,000. Minimal fees were being charged for many years but this year, considering the demand of the course and the resources required, we have increased the fees."The DSEU is also facing a fund crunch, Nagawat further said, adding that he is hoping for more funds so that the faculty strength can be expanded to 1,200 from 500 at present. The annual budget allocated by the Government of the National Capital Territory of Delhi to DSEU has been halved from Rs 290 crore in 2023-24 to Rs 165 crore in 2024-25, it was further highlighted. On the surge in fees for Diploma in Pharmacy course, the V-C said that limited funds would have impacted the quality of the laboratory, studio, or workshop training.A Bachelor in Technology student said, "I cannot submit my college fees... my father is a rickshaw driver. I have applied for a loan but my father's credit score is not enough to get the loan. I have tried as hard as possible to get a scholarship but to no avail."Nagawat said, "We are observing financial discipline because till last year we were very lenient and many students still failed to pay fees."A teacher said, pleading anonymity, "Such a hike in fees is unjustified... It will deprive the financially weaker sections from pursuing technical education."When asked about the implication of the jump in fees, the teacher said that students would prefer other institutes. "The Jawaharlal Nehru University (JNU) offers courses for much less."A sister of an 18-year-old student who was considering applying to the DSEU said the sudden hike in the fees has "forced them to look for other options like IGNOU". Fearing that her sister might have to drop a year and prepare for CUET (Common University Entrance Test)-UG, she said, "But I want her to study. If she drops one year, she may be forced into marriage. We are dealing with a lot of financial struggles. I want her to become independent.""On DSEU's website I read that the diploma courses 'skills poor', but after the fee hike, it does not seem like it anymore," she added.

Enhance patrolling near exam centres, deploy adequate

They need to be brought back and made to benefit from skilling and vocational training."Nearly two out of three students who failed class IX twice in Delhi government schools this year face the possibility of dropping out of school as they have not enrolled themselves to the National Institute of Open School in Delhi.

As per data accessed by The Indian Express, this year out of 17,308 students across 903 Delhi government schools, who could not clear the Class IX final for the second time during 2023-24, only 6,200 students are under process for enrolment through NIOS portal of Directorate of Education, as of July 16. As per Delhi government's policy, students who fail twice in Class IX are asked to pursue further education through open schooling." As part of our ongoing efforts to reduce the dropout rate among students, it has been observed that the students who have failed twice are at the risk of discontinuing their education. These students need immediate attention and support so they do not drop out," said a directive issued by the Directorate of Education to the Heads of Government schools guiding them to counsel students and parents to not discontinue school."This initiative aims to give them an opportunity to continue their education at their own pace and in the subjects of their own choice so that they can be mainstreamed into their parent school once they pass class X" it added. The Delhi government did not respond to questions despite repeated attempts.While the Delhi government has been celebrating improvements in pass percentage in classes 10 and 12 in CBSE board examinations, class 9 results have been a persistent issue.

In the academic year 2023-24, in class 9, around 36% students had to be held back after failing to clear their exams even after a remedial or compartment exam. The pass percentage of Class IX and Class XI students in Delhi government schools has dipped below pre-pandemic levels. For Class IX students, the pass percentage for the years 2019, 2020 and 2021 stood at 84.72%, 87.13% and 88.49%.

In 2022, the pass percentage of students saw a sharp dip from 84.72% in 2019-20 to 65.52% in 2022-23 In 2018-19, around 42% failed. At the time, the Delhi government had said that 40% percent of those who did not pass dropped out of school.Around 2.5 lakh students from government schools appear for the Class IX exam each year. Delhi government came up with a two-fold strategy, then Education Minister Manish Sisodia had said, "Statistics on dropouts should be responded to with urgency. These students must be traced. We need to apply a twofold strategy. They need to be brought back and made to benefit from skilling and vocational training."

NIOS, meanwhile, has the option to enrol students online or in person. "The NIOS has 100% online admis-



sion at the Secondary and the Senior Secondary Education levels in order to facilitate learners to register," states its official website. Facilitation centres and regional centres have also been set up to help students register online. A Delhi government school teacher said, "There are two ways to enrol a student in NIOS. Either a student privately enrols himself/herself or they enrol themselves in the NIOS centres which have been established in different schools. In the second case, the school will carry out the process of admitting the students who failed class IX twice into the NIOS centres."Students' kin, however, alleged that help is not readily available. Ifrar, 45, a daily wage worker in Khajoori Khas, whose niece has failed to clear Class IX twice, said, "My niece couldn't pass class IX and failed twice due to family issues the first time around and the second time she was admitted in the hospital as she got typhoid. My sister and I went to speak to the principal of the school yesterday but they directed us to different places and offices to get rid of us. They did not offer to help us out in applying for admission, even in the open school," he added. He said his niece passed in mathematics but got a compartment in science and couldn't clear her compartment examination.

Image: Abhinav SahaDepute an officer at Central Police Control Room (CPCR) to monitor the conduct of examinations, enhance patrolling by PCR vans near examination centres, and deploy adequate force to maintain peace and public tranguility: These are among the instructions Delhi Police Commissioner Sanjay Arora has issued to police personnel in the district with regard to the conduct of various examinations to be held in the Capital. This comes days after the Union Home Ministry asked all state Chief Secretaries and DGPs to provide assistance to the National Testing Agency (NTA), National Board of Examination (NBE), and other Central Testing Agencies (CTAs).

Union Home Secretary Ajay Bhalla held a meeting earlier this month with all state Chief Secretaries and DGPs where he is learnt to have asked them to issue standard operating procedures (SOPs) for proper and safe conduct of national-level examinations.While issuing SOP on July 12, Arora said that the DCP (headquarters-II) should circulate the schedule of an upcoming examination to be conducted by NTA, NBE and CTAs among the districts concerned in order to work out necessary arrangements.Officers should be categorically deployed to visit the centre on the previous day and ensure that it is sanitised and sealed properly in the presence of the officials of the testing body concerned, he added.

Currently, only one beat constable along with another police official visits the exam centre and takes action in case of a call related to impersonation. However, recent controversies over several centrally conducted entrance tests, including the NEET-UG paper, have necessitated a review of systems around all such entrance tests. "The DCP (headquarters-II) should also share the schedule with DCP (PCR), who will, upon receipt of the same, brief and alert the PCR vans located near the examination centres to enhance patrolling and to respond to any call that may concern the conduct of the examination in a professional manner. The DCP (PCR) should also depute an officer in PCR to monitor the conduct of examinations from the perspective of law and order situation." Arora said.

Arora further said that an advanced and adequate police force will be deployed at the centres commensurate to the strength of candidates appearing for the examination to maintain peace and public tranquility in and around the premises. "Detailed staff will remain present



at the centres till the examination teams depart from there after conclusion of the examination," he said."...There should be a standing committee at the headquarter level, chaired by Joint/Additional CP (headquarter), having DCP (headquarters-II) and ACP/Coordination-I as its members," he stated. "On behalf of Delhi Police, DCP (headguarters-II) should be the nodal officer for all communications between Delhi Police, the NTA, NBE and CTAs. Headquarter-level committee should have all district Additional DCP-1 as co-opted members. There should also be a standing committee in each district, chaired by district DCP and comprising Additional DCP-1 and ACP (headquarter)," he further added. According to the SOP the DCP (headquarters-II), being the nodal officer for Delhi Police, should share the official mobile/landline numbers of Additional DCPs-1 of all districts with the NTA, NBE and CTAs for information and localised coordination. "In case of restriction on movement in certain areas, admit cards issued to the candidates by the NTA, NBE and CTAs should be treated as a 'Movement Pass'," Arora said.

### **Bangladesh quota protesters announce nationwide shutdow**

Student protesters demanding reforms in the quota system in government jobs on Wednesday announced plans to enforce a complete nationwide shutdown on Thursday in response to the actions of the security forces that left at least six people, including four students, dead across the country. A key coordinator of the movement, Asif Mahmud, in a Facebook post said all establishments, barring hospitals and emergency services, will remain closed, and only ambulance services will be permitted to operate.

The movement urges students from all educational institutions to participate and calls on guardians to support their cause, the newspaper reported.Bangladesh Prime Minister Sheikh Hasina, in an address to the nation on Wednesday, "deeply regretted" the casualties in the violence over student protests and said that a judicial inquiry committee will be formed. Hasina asked demonstrators to keep faith in the country's apex court as the issue is pending with it."I believe our students will get justice (in the apex court). They will not be disappointed," she said in an unscheduled nationwide address a day after six people were killed as the protest spread in major cities across the country on Tuesday and continued on Wednesday.Donning a black saree, she appeared on a live TV broadcast coinciding with the Muslim mourning day of "Ashura", which is a public holiday in Bangladesh, and said the casualties over the student protests were "very saddening and unfortunate" adding "for no justified reason some valuable lives were lost".She declared a judicial investigation into the killings and said, "I will do whatever support is necessary for the families of those who have been killed in the violence.'

"I declare unequivocally that action will be taken to ensure that those who have committed murder, looting and terrorist activities, whoever they may be, receive appropriate punishment," the premier said. Hasina, however, held responsible "some vested quarters" for instigating the violence saying the protesting students were not involved in the "terrorist acts" and urged them not to give chance to miscreants to take advantage of the situation. The violence prompted the government to close all public and private universities alongside schools and colleges across Bangladesh for an indefinite period on late Tuesday asking residential students to leave dormitories. According to media reports, four of the deceased were students and the remaining two were small traders. Two people were killed in the capital Dhaka, three in the southeastern port city of Chattogram and one in northwestern Rangpur.

A second-year student of northwestern Rangpur University was the first casualty on Tuesday when he was shot dead by police during a protest on the university campus."He stood, arms spread wide, alone, challenging the police crackdown against protesters. He was suddenly shot by a police officer. He tried to get back to protesting (students), but collapsed to the ground mere minutes later," a newspaper reported.But media reports and witnesses said violence continued on Wednesday when scores of protesters were wounded in clashes with alleged ruling Awami League's student activists and police.They said police used rubber bullets, tear gas and sound grenades on the campuses of premier Dhaka University, Jahangirnagar University on the outskirts of the capital and northwestern Rajshahi University.

Despite the premier's call, the protestors vowed to carry on their protests with their coordinator Asif Mahmud saying the country will be under complete shutdown on Thursday.He said they decided to protest against "the killings, beatings of protesters and others" by police, paramilitary Border Guard Bangladesh (BGB), elite anti-crime Rapid Action Battalion (RAB) and police's SWAT unit."Other than hospitals and emergency no institution's doors will open. Other than ambulances, no cars will ply the street. I am calling on students of every school, college, university, private university, and Madrasah to help make tomorrow's programme a success," he announced in a Facebook post. Fifty-six per cent of government jobs are reserved under the current quota system with 30 being for the decedents of the 1971 Liberation War freedom fighters, 10 per cent for backward administrative districts, 10 per cent for women, five per cent for ethnic minority groups and one per cent for the handicapped people.Every year some 3,000 government jobs open up to nearly 400,000 graduates. The protestors waged the campaign for the reform of the system saying it was debarring meritorious students' recruitment in first-class and second-class government jobs.UN Human Rights chief Volker Turk on Wednesday urged Bangladesh authorities to engage with protesting students adding "all acts of violence and use of force, especially resulting in loss of life, must be investigated and perpetrators held to account". In a message on X handle, he said freedom of expression and peaceful assembly are fundamental human rights.

His comment came a day after Amnesty International urged Bangladesh authorities to "immediately guarantee the safety of all peaceful protesters" while the US State Department also denounced the "violence against peaceful protesters", prompting a rebuke from Bangladesh's foreign ministry. The protesters in 2018 waged a nearly identical street protest demanding quota system "reforms" when after an initial reservation the government "abolished" the quota system, which was overturned recently by a High Court division bench, dragging the issue to the apex Appellate Division of the Supreme Court. The Appellate Division of the unitary Bangladesh's Supreme Court last week, however, halted the High Court's order for four weeks while Chief Justice Obaidul Hassan asked protesting students to return to classes, saying the apex court would issue a decision in four weeks.Authorities at the premier Dhaka University on Wednesday announced an indefinite closure of the institution. The students have been asked to vacate their dormitories by Wednesday evening. This decision was taken at an emergency syndicate meeting at the office of Vice Chancellor ASM Maksud Kamal, Pro-VC (Academic) Prof Sitesh C Bachar was quoted as saying by the Dhaka Tribune."Considering the security of the students, we have decided to close the university indefinitely and evacuate the halls," Bachar told The Daily Star. However, students of the university are protesting the decision, and they have thronged the VC's residence, the report added.

Firefighting aircraft from Serbia, Montenegro, Croatia, Romania and Turkey responded to the country's call for assistance.In western Turkey, firefighters — aided by more than a dozen waterdropping aircraft - managed to bring a wildfire near the town of Bergama under control several hours after it ignited. The cause of the blaze, which was fanned by strong winds, was not immediately known. Rahr also acknowledged the case has been covered extensively by the media."I recognise that it is unusual for a chief to explain a disciplinary decision to an entire organisation," Rahr wrote."This is, however, an unusual enough circumstance that I believe I owe it to all of you to do so. This case has been covered extensively in the public, has garnered international media and diplomatic attention, and I am confident that everyone in this organisation has had the opportunity to learn about the case and hear for themselves the officer's words."

"I am choosing to share the outcome of this case with all of you because the far-reaching impact of the officer's actions reflect on all of us, not just as members of the Seattle Police Department but on the profession of law enforcement," Rahr's email stated.Internal police sources told KIGN 5 that Rahr was strongly considering a 30-day suspension for Auderer.However, in the end, the chief went with termination to not appear too lenient.The



23-year-old Indian student, Kandula, died after she was struck by a police vehicle driven by another cop, Kevin Dave, when she was crossing a street in Seattle on January 23, 2024.The officer was driving at more than 119 kmph speed as he was responding to a drug overdose call.Kandula was thrown 100 feet when she was struck by the speeding police patrol vehicle.The officer Auderer, who was not involved in the January collision, was captured in a video saying, "But she is dead" and laughing while on the phone.He continued, "She was 26 anyway. She had limited value."

The previous auction record of \$31.8 million for a dinosaur skeleton was set in 2020 for a Tyrannosaurus Rex nicknamed "Stan."Sotheby's had expected Apex to fetch between \$4 million and \$6 million,

but the price quickly skyrocketed as telephone bidders deluged the sale, prompting gasps and clapping in the auction room.After the record-breaking sale, the auctioneer asked her colleague Cassandra Hatton, Sotheby's global head of science, "do you need a cigarette?" Apex was discovered in May 2022 on the private land of paleontologist Jason Cooper. The auction house says it has collaborated with Cooper to "document the entire process, from discovery and excavation to restoration, preparation and mounting," in order to guarantee the "highest standards and transparency."In 2022, Christie's auction house had to withdraw a T-rex skeleton a few days before auction in Hong Kong, due to doubts about its authenticity.Wednesday's auction follows an increasing trend for the sale of dinosaur remains. Stegosaurus skeletons are already on display around the world, but according to Sotheby's, Apex is 30 percent larger than Sophie, the most complete stegosaurus on public display to date, which is housed in the Natural History Museum in London

## Toronto, tornado hits New York

The relentless series of storms has caused deaths or damage from the Plains to New England this week. Hundreds of thousands of people have lost power and air conditioning during days of sweltering heat.As much as 11 inches (nearly 28 centimeters) of rain fell overnight into Wednesday on parts of the Ozarks in Arkansas and Missouri, the National Weather Service said.Buses and ambulances evacuated 86 people from a nursing home in Yellville, Arkansas, where water rose to about 4 feet (1.2 meters) during flash flooding, Marion County Sheriff Gregg Alexander said. A section of a bridge washed out and a historic courthouse flooded.

Cities across upstate New York were cleaning up after a storm swept through Tuesday with high winds and spectacular lightning and flying debris that killed one person.In the small city of Rome, New York, a tornado ripped off roofs, tipped over vehicles and turned several buildings into piles of rubble.Steeples crumbled and roofs were torn apart at First Presbyterian Church and the St. Mary's Church, both built in the 1800s. Copper sheets from the roof of First Presbyterian were found wrapped around utility poles a quarter mile away. The winds were fierce enough to move a multi-ton tourist attraction, a B-52 bomber displayed at Griffiss Business and Technology Park. A mural of a Revolutionary War figure on horseback - a Rome landmark - was destroyed, along with the building on which it was painted. All that remained was an image of a horse hoof.

Speaking outside St. Mary's, Gov. Kathy Hochul said it was "miraculous" no one was killed in the city of 31,000. She toured the downtown Wednesday and said 22 buildings were damaged or destroyed. She described seeing trees "collapsed like toothpicks" and told of mobile homes tipped over with people inside. The governor marveled at narrow escapes, including two children in a medical waiting room who emerged unscathed even though the building was partially "obliterated."A National Weather Service preliminary damage survey released Wednesday night estimated the Rome tornado's top winds at 135



mph (217 kph) and gave it an EF2 rating, considered "significant," on the Enhanced Fujita scale. Chiropractor Kingsley Kabari was with a patient in his second-floor office in Rome when his cellphone blared with a tornado alert Tuesday afternoon. By the time he could pick it up to mute it, the storm had arrived, he said, blowing out windows, tearing at the roof of the two-story brick building and sending debris flying."It was like a bomb dropped on the building with very high-power wind. Things were just flying everywhere - and this was inside," he said Wednesday. The tornado cut a path between two nursing homes operated by Grand Healthcare, sparing them of the most severe damage but pelting the buildings with powerful winds and heavy rains that knocked out their power, regional vice president Bruce Gendron said.He said he was at one of the nursing homes when the storm hit, and staffers moved residents away from the windows in case trees came toppling into the building. The facilities' backup generators kicked in, keeping most systems intact until normal power was restored Wednesday afternoon, he said."To our residents of Rome: Do not be discouraged. This community is resilient and we will build back," Mayor Jeff Lanigan said.

A weaker tornado given an initial EF1 rating, with a top estimated wind speed of 110 mph (177 kph), also touched down about 230 miles (370 kilometers) away in Lyme, New Hampshire on Tuesday night, the weather service said. It remained on the ground for about 1.8 miles (2.9 kilometers) and knocked down at least 100 trees, said Jon Palmer, a weather service meteorologist in Gray, Maine.About 30 miles (48 kilometers) away in Canastota, storm debris hit and killed an 82-year-old man, village administrator Jeremy Ryan said. Hochul said three homes collapsed and 30 other structures were damaged in the community.A thousand miles (1,600 kilometers) away in Flippin, Arkansas, people went door to door to get as many as 40 residents to flee dangerous conditions before floodwaters began to recede. At least 30 residents were evacuated from an apartment complex in Greenbrier, 34 miles (55 kilometers) north of Little Rock, state emergency managers said







### **Elevating our education ecosystem**



The Indian education sector is at a crucial crossroads today, reflecting a landscape of opportunities and challenges. The National Education Policy (NEP) is nearing the completion of its fourth year and will continue to act as a guiding blueprint, broadly laying down the strategic direction and shared objectives for all stakeholders in the sector.

While budgetary allocations for improving infrastructure, quality, and access to education have increased over the last three years (Rs 1.12 lakh crore in FY 2024 as against Rs 99,300 crore in FY 2021), the allocation for Research and Development (R&D) continues to stand at an abysmal level of 0.7 per cent of the GDP, much below the global average of 1.8 per cent.Additionally, the industry-academia collaborations, skilling and research ecosystem continue to remain at a nascent stage, with more work to be done to strengthen it further.Government's educational endeavoursSince the NEP was implemented in 2020, the sector has witnessed a regulatory overdrive. In line with the outlined vision, the government has introduced policy initiatives to foster internationalisation through academic collaborations, such as dual/joint degrees, twinning programmes, and enabling foreign institutions to set up campuses in India.

To bring more strategic focus and transparency to the Indian education ecosystem, formalising the Institutional Development Plan (IDP), mandating public selfdisclosure of information by higher education institutions (HEIs) on their websites, and formulating a student grievance redressal mechanism have bolstered efforts towards this cause. Enacting the Anusandhan National Research Foundation (ANRF) Act, 2023, aims to improve the country's research ecosystem. Expectations from the impending budgetThe lack of private capital for investment has often been a barrier for those wishing to establish educational institutions in India. Additionally, the regulatory and legal framework restricts foreign investments in trusts or societies (which is a regulatory pre-requisite), and this also makes foreign borrowings (External Commercial Borrowings or ECBs) an unattainable funding source for educational institutions in the country. Therefore, it is crucial to liberalise foreign investment and loan funding for educational institutions established as notfor-profit entities. The Honourable Finance Minister announced in February 2020 that foreign investment and the ECB would be enabled for this sector, but four years later, it has yet to see the light of day.

Furthermore, the process and timelines for attracting donations from foreign sources continue to be long drawn and need to be urgently streamlined. To facilitate new institutions, the government may consider establishing dedicated education zones with built-up infrastructure, either independently, through the private sector, or via public-private partnerships (PPP). These zones could act as plug-and-play lease-based models for institutions, thereby reducing their capex requirements. Also, common infrastructure facilities like student/ faculty housing, sports amenities, entertainment centres, research centres, etc., could be made available to multiple universities in such zones on a shared basis.

While reducing capital costs for institutions and students, these zones would offer opportunities for multicultural exchanges and cross-learning. To encourage private sector participation, the government could provide support and incentives in the form of subsidised land, tax rebates, or GST exemptions. Although the NEP mentions Special Education Zones, these are intended for disadvantaged areas. To benefit from industryacademia collaboration and improve accessibility for students, these zones should be established near metropolitan cities.

With respect to strengthening the research ecosystem, while the ANRF Act mentions a broad fund to be utilised, detailing out-of-fund allocation mechanisms, monitoring outcomes and eligibility for the participation of all needs to be defined clearly.GST adds to the cost base of educational institutions. While inward supplies are taxable, outward educational services are exempt from GST, increasing the cost of education and making it more expensive for students. Therefore, either exemption for inward supplies should be granted or the supply of educational services by universities and educational institutions should be zero-rated, allowing them to receive refunds on GST paid for input procurement.

Government-to-government (G2G) dialogueWith geo-political headwinds, we see many countries impose caps on international student mobility and visa grants, probably due to their internal pressures due to lack of student housing, employment for their own citizens, etc. For internationalisation and student mobility to happen in the true spirit, mutual recognition of qualifications between countries is essential.While India has taken steps towards this with Australia and the UK, G2G dialogue with other countries should also be initiatedalong with dialogue to ensure wider student mobility, skilling opportunities and research collaborations.I guess the sector still has miles to go before it realises its true potential, but all hands are on deck for the next few years as we consider preparing our youth for tomorrow!

### Nirmala Sitharaman to present Budget on July 23, jobs in focus

I am expecting the budget to be in sync with the people aspirations from the Government's unprecedented third term win. The focus, I believe, will be on strengthening the existing policy framework, focus on ease of business and put in the building blocks for a "Vikasit Bharat" by 2047.

### **Pooping frequency is linked** with overall health, finds study

A new study conducted by scientists in Seattle suggests that the bowel movement frequency is linked to the long-term health of humans.The research, which was conducted by Institute for Systems Biology (ISB), revealed that the popping routine of individuals can have an effect on their long-term health.

The scientists found that an optimal pooping frequency appeared to be one to two times a day. The study suggested that for a better pooping frequency, certain factors are associated with it like consuming more vegetables and fruits. The ISB research was conducted on 1,400 healthy adults whose clinical, lifestyle, and multiomic data was examined. The study suggested that the frequency of an individual's poop can have an influence on one's health physiology. The study by ISB was published in a journal Cell Reports Medicine.

Johannes Johnson-Martinez, the lead author of the research, said "Prior research has shown how bowel movement frequency can have a big impact on gut ecosystem function," as quoted by the ISB Science."Specifically, if stool sticks around too long in the gut, microbes use up all of the available dietary fiber, which they ferment into beneficial short-chain fatty ac-



ids," Martinez further added. The research team had categorized the bowel movement into four different categories. Constipation (one or two bowel movements per week), low-normal (between three and six bowel movements per week), high-normal (between one and three bowel movements per day), and diarrhea. The researchers also found that even in people who were completely healthy, timing for poop appeared to be significant.

# Uncertain over tech, MeitY reaches out to industry

Unable to narrow down on a conclusive technological intervention to allow tech companies gathering parental consent before processing children's personal data, the IT Ministry has reached out to the industry for inputs on how the requirement can be implemented under the upcoming data protection rules, The Digital Personal Data Protection Act, 2023 requires tech companies to develop a consent framework to verify a child's age (people below the age of 18) and gather their parents' consent before they can use an online service. This has been a major sticking point for the industry since the Act itself does not suggest ways in which platforms can perform age-gating. In an internal meeting involving senior IT Ministry officials on Tuesday, it was discussed that though the ministry has explored a number of options for implementing the provision, it has become a significant challenge as to how the relationship between a child and her parents can be reliably established, a senior government official said, requesting anonymity."There will be a meeting now between the ministry and the tech industry sometime this week, likely today (July 18) to come up with a workable solution and figure out what is technically feasible," a second official said on condition of anonymity. While the data protection Act has largely been welcomed by the industry for its relatively easy compliance structure, the provision on gathering verifiable parental consent has been the final thorn in the bush which has divided the industry and the government.Previous solutions not found feasibleLast year, as part of its internal deliberations on the data protection rules, the ministry was considering two ways to establish the relationship between children and their parents – one was to use parents' DigiLocker app, which is based on their Aadhaar details, and the other is for the industry to create an electronic token system which will be allowed only if the government authorises it. However, the ministry no longer thinks these solutions could be implemented at scale and is understood to have dropped the idea. The inability to arrive at a conclusive decision on how to proceed with the verifiable parental consent provision is the biggest reason behind the delay in releasing the data protection rules. Without the rules, the data protection Act can not

be operationalised as it depends on at least 25 such provisions to implement the modalities of the Act As per the data protection Act, some entities can be exempted from obtaining verifiable parental consent and age gating requirements including healthcare and educational institutions. It is also understood some entities can be exempted from the norms on a restricted basis, that is, depending on the specific purpose for which they need to process a child's data.Global laws don't prescribe tech measureGlobally, privacy legislations have not prescribed a technology to gather verifiable parental consent, and have left it to data collectors to use relevant technology through which such consent can be gathered.For instance, the United States' Children's Online Privacy Protection Act (COPPA) does not mandate the method a company must use to get parental consent. Instead, it says that an operator must choose a method "reasonably designed" in light of available technology to ensure that the person giving the consent is the child's parent. The COPPA, however, has prescribed some basic standards that any technological measure to gather a child's parent's consent should adhere to. These include signing a consent form and sending it back to them via fax, mail, or electronic scan; using a credit card, debit card, or other online payment system that provides notification of each separate transaction to the account holder; calling a toll free number staffed by trained personnel; connecting to trained personnel via a video conference; or verifying a picture of a driver's licence or other photo ID submitted by the parent and then comparing that photo to a second photo submitted by the parent, using facial recognition technology, among othersThe European Union's General Data Protection Regulation (GDPR) - considered to be among the strictest privacy laws globally - on the other hand, requires data collectors to make "reasonable efforts" using available technology to verify that consent provided on behalf of a child under the age of 13 has, in fact, been provided by the holder of parental responsibility for that child.In the event of a complaint, the law will consider whether a data collector has made reasonable efforts to verify that the data subject is old enough to provide their own consent.

Sharing his research work during an event recently organized at the National Institute of Technology (NIT) Warangal, Dr. Polisetty said in Ayurveda, the key to health is maintaining the balance of VPK in individual tissues and organs. This requires detecting imbalances of VPK in specific areas."The device I am referring to will prove invaluable as metabolic fingerprinting has never been done to personalise patient treatment. This innovative digital technology has the potential to revolutionize traditional medicine practice and potentially advance Indian healthcare by 15 years," he said.He said just as modern medicine, Ayurvedic practitioners were also prescribing specific herbs or formulations for particular symptoms. "The issue with this approach overlooks the fundamental tenets of Ayurveda, which emphasize the importance of balancing the three doshas: Vata, Pitta, and Kapha," he added.Dr Polisetty was on the panel of keynote speakers among Dr Venkatesh Balasubramanian, Professor, Department of Engineering Design, IIT Madras, Dr M. Aamir Khan was yet to make his debut in the movies when he met his first wife Reena Dutta and fell in love with her. Aamir was head over heels in love when he was trying to woo her and in trying to impress her, he did something quite dangerous. In an earlier interview, Aamir confessed that he wrote a love letter in blood to Reena. She was quite upset with him and in hindsight, even Aamir could see why Reena reacted this way.

In a 1999 interview with Simi Grewal, Aamir was asked about writing letters in blood and to this, he said, "Well once [I wrote a letter in blood], after which I was appropriately put in my place by her. She didn't like it at all. She was quite upset with me." When asked what made Aamir do that, he shared that it was his immature way of interpreting love. "You know I was young and I thought that... I thought it's a way to express the deep love that I have for her but today I feel that... I mean I hear of lot of kids doing that and I receive a lot of letters in blood and I think that it's not a nice thing to do. You don't need to do that to express your love for a person so I wouldn't advice youngsters to do that," he said.

In the same chat, Aamir recalled that he and Reena eloped when he was 21 and she was 19. He said that their parents didn't know about their love, and Reena's parents were "quite upset that she was seeing somebody." Aamir and Reena were both scared of losing each other and found themselves making the "tough decision" of eloping as they knew that this would "hurt" their parents. "It wasn't out of disrespect or rebellion, it was more out of insecurity," he said. Aamir said that he wasn't even 21 when they decided to get married so they had to wait a couple of months before they could legally marry each other.In another interview, Aamir had said that his wedding to Reena cost him only Rs 10. He shared with Rediff, "I got married to Reena secretly through court marriage, with three witnesses. My wedding with Reena was most economical. I took Bus 211 and bought a ticket of 50 paise. I got down at Bandra station West, crossed the bridge, landed in the east and walked towards the highway. I crossed that highway and entered Griha Nirman Bhavan, where there is a marriage registrar office. So my wedding cost me less than Rs 10.

## Kalki contributes 15% of total revenue, Malayalam shows threefold increase, no Tamil films in top 10



The year 2024 is pacing ahead of 2023 in terms of box office revenue, with the recent Kalki 2898 AD having revived the Indian film industry with its strong performance across languages. Hindi movies have shown a minor decline in box office revenue in the first six months of the year, while Malayalam films have shown a threefold increase in numbers, thanks to a trio of hits.

According to an Ormax Media half-yearly report, films from the first half of 2024 generated just over Rs 5000 crore at the box office, across languages. This is 3% higher than the same period in 2023. Kalki 2898 AD leads with over Rs 772 crore in India. This contributes to 15% of total box office revenue this year. Malayalam cinema has already generated more money in six months than it did in all of 2023, with its revenue share rising from 5% in 2023 to 15% in 2024. This is mainly due to the performance of three films – Aavesham (Rs 101 crore in India), Aadujeevitham: The Goat Life (Rs 104 crore in India), and Manjummel Boys (Rs 170 crore).

June was the top-grossing month, thanks to Kalki 2898 AD, which contributed to 60% of total revenue this month. Other films that made an impact in June were Munjya, Maharaja, Jatt & Juliet 3 and Chandu Champion. Interestingly, no Tamil films found spots in the top 10 list in the first half of 2024. There were three films in the top 10 for the same period last year. As a result, Tamil cinema's contribution to overall revenue dropped by 5% this year, while Hindi movies dropped by 2%, and the Telugu industry remained stable, thanks to Kalki and Hanu-Man. Two of the top-grossing Indian films of the year, Kalki and Fighter, star Deepika Padukone.Only one Hollywood movie found a spot in the top 10; Godzilla x Kong: The New Empire grossed Rs 136 crore in India, which is higher than the lifetime business of films such as Crew, Mr & Mrs Mahi, and Chandu Champion. The second half of the year is expected to deliver bigger grosses, with highly anticipated movies such as The Greatest of All Time, Pushpa 2: The Rule, Singham Again, Stree 2, and Devara lined up for release.

Admitting that he experiences a 'lack of control' over these performances, he said, "When I'm doing something like Raman Raghav, I am in command of my emotions, my thoughts, my soul. When I do South films, I'm not so sure. But because I'm being paid so well, I go ahead with it. I have guilt. Itna saara paisa de diya lekin samajh nahi aa raha kya kar rahe hain (They're paying me so well, but I have no idea what's happening)."

Nawaz said that 'cheating is the right word' to describe what he does in those films. "The audience wouldn't get to know, but I know. It's like doing an advertisement. I don't have any emotion for that product, all I can see is the money I'm being paid for it," he said. But in the same interview, Nawaz claimed that he didn't become an actor for the money, but for the love of the craft."We have a sugar factory in our village Budhana. I could've made just as much money if I'd stuck around there," he said, explaining why he doesn't do theatre anymore. He said that he lost the desire to perform on the stage because he'd struggled for so long trying to crack it in the movies, and that working in theatre would remove the possibility of him taking on any other jobs at the same time. Nawaz was most recently seen in the ZEE5 film Rautu Ka Raaz. In the South, he has done films such as Saindhav and Petta.

### Marvel in talks with Russo Brothers to direct next two Avengers movies; studio eyes 2026 release: Reports

According to a source quoted by the publication, the Russo brothers will return to the franchise to oversee the next two Avengers outings, a position which earlier also saw Deadpool & Wolverine director Shawn Levy being in contention for.If it materialises, it will mark the return of Russo brothers to Marvel studios after delivering global blockbusters like Captain America: The Winter Soldier (2014), Captain America: Civil War (2016), Avengers: Infinity War (2018) and Avengers: Endgame (2019).

The publication revealed that the fifth Avengers movie was previously titled Avengers: The Kang Dynasty and was to star Jonathan Majors as time-traveling villain Kang. ### Hardik's demotion: Vice-captaincy a fancy designation with no perks, power or immunity

Perceptions in Indian cricket change in a matter of weeks. And at times it can have nothing to do with the performance of the players. Hardik Pandya went from being T20 World Cup final's game-changer, designated vice-captain, captain-in-waiting to a powerless foot-soldier in new commander Suryakumar Yadav's unit. Shubman Gill, on the other hand, leap-frogged from being a reserve player to being the vice-captain. So should this be seen as Gill's promotion and Hardik's demotion? Not really, would say those familiar with the power equations of the Indian dressing room. On paper, a captain's deputy is the team's designated No.2 and also the heir apparent. But that's a misconception. Vice-captaincy, as the name suggests, doesn't come with a time-bound captaincy guarantee. Actually, it's far from that.

Like in the simplest popular board games, the snake that waits for the ladder climbers to reach the late 90s to time their bite, many captaincy contenders have got their final throw of the dice wrong. Virender Sehwag, Yuvraj Singh, KL Rahul, Rishabh Pant, Ajinkya Rahane, Jasprit Bumrah and even Hardik have over the past decade come close to sealing their spot at the top, but failed. They have led Team India in some games or a few odd sessions but they couldn't win the trust of selectors to be long-term leaders. Will Gill buck the trend and become a true blue leader like Dhoni, Virat or Rohit remains to be seen. If he doesn't, the curse will continue.Cricket needs to be sensitive to the intriguingly amorphous character of the dressing room - the vice-captain. He has the position but no real privilege. He gets to wear the captain's armband occasionally but doesn't have the aura to automatically command respect. Being slightly ahead in the captaincy race by virtue of the official position, he can also be the target of others with leadership ambitions. Many a time he isn't even the captain's sounding board since there are former skippers or other seniors in the team. Being a deputy can get lonely.Vice-captaincy in cricket is just a fancy designation. It has the limited usefulness of a spare car tyre that spends most of its life in the darkness of the bonnet. And even when he takes the place of the captain on the field, he often merely implements the orders given by the captain and the coach from the dressing room. The deputy plays the waiting game, and for most, the wait is endless.

Selectors have a different rationale when they sit to

decide the team's vice-captain. As is the case with Gill, the most popular reason, of course, is the one about grooming a youngster with leadership potential. But there are other reasons too. Sometimes the national selectors have picked the likes of Rahane and Pujara as vice-captains as they didn't have options or they were not sure about the hierarchy among the youngsters.

At this T20 World Cup, Pakistan selectors had faced a similar dilemma. From the team full of super seniors, they had to pick Babur Azam's deputy. In contention were Babur's contemporaries Shaheen Shah Afridi, Shadab Khan and Mohammad Rizwan. There were also the two seniors making a comeback - Mohammad Amir and Imad Wasim. Naming one would mean undermining the leadership acumen of others. So what did they do? They came up with a novel solution, a typical Pakistan jugaad - they did away with the vice-captaincy position. For years, the profile or the purpose of a vice-captain to the team wasn't clear. It was arbitrary and ambiguous. In his book Sunny Days, India great Sunil Gavaskar mentions what he calls the "most embarrassing incident of my cricketing career". It was from a Deodhar Trophy game and it was about the confusion over the vice-captain in the middle of the game.

It all started with West Zone skipper Ajit Wadekar getting injured. Since Gavaskar was Wadekar's deputy when they played for Bombay, he took charge. And then it happened. ".. I led the side for three overs before the 12th man came in and told me that the senior most player in the side, Ashok Mankad, was to act as captain. Kaka, as we called Ashok, was most apologetic about it but took command." Gavaskar says to this day he shudders to recall the moment. "For me, however, it was most embarrassing to be told to hand over the charge to another player in full view of more than twenty thousand people who must have seen the change".

The team selection processes have evolved over the years but still the vice-captains don't have the perks of an important member of the leadership. They don't have immunity - one match they could be the stand-in captain, the next they could be carrying drinks. Rahane in his long career had seen it all. Even the game's greats have suffered the same fate. Shane Warne's biography No Spin gives a detailed account of the time when he was Steve Waugh's deputy and terribly out of form. Waugh wanted to drop Warne but coach Geoff Marsh was not sure

They decided to ask the long-retired Aussie veteran Allan Border, who was in the West Indies with a tour group. AB couldn't believe what he was being asked. "Jesus Christ, I back Warney every time ... we owe him. Think of what he's done for Australian cricket," he said. This pitch would have convinced every captain in the world but Waugh. "No, I appreciate your thoughts, AB, but Warney's not playing." Warne wouldn't be the last vice-captain who would have been shown his place.Hardik can take heart from the Warne story but the national selectors need to answer a question. How did Hardik, after gaining his batting and bowling form, suddenly become a lesser leader? Maybe, the unshielded, powerless vice-captains don't deserve that courtesy.

### **Paris Olympics, hockey: With Hardik** as heartbeat, India will aim for the sky with aerial passes as a key tactic

For starters, the stars must align if India are to repeat or better their famous bronze from Tokyo, in what is going to be a tough campaign from the word go. But more relevantly, going aerial with their passing has been a rather common sight in India's gameplay in the months leading up to the Games. And in their quest to return to the podium, it is an art India's skilled technicians have been trying to perfect.

India have a few who can throw a mean aerial, but the bulk of those will be shared between current captain Harmanpreet Singh, former captain Manpreet Singh and star midfielder Hardik Singh - three of the best practitioners of passing the ball on and above a hockey field. Think of the FIH Pro League match in Rourkela on February 21. India trailed the Netherlands 0-1 after conceding an early goal. In the third quarter, with around 8 minutes to go, the hosts were pinned to the right flank, looking for an opening as the Dutch stayed tight on defence. Harmanpreet went forward with a ground pass, but it came back to him because there was no space to be found.

The moment he received the ball, Hardik faked making a short pass back into the midfield, quickly changed his body position and sent a stunning aerial ball into the Netherlands circle. Because, as he was weighing up his options, Hardik had spotted Lalit Upadhyay willing to make a run and the midfielder trusted his gut to open up the play.Lalit came up with a gorgeous piece of skill to leap in the air, control the ball and force an infringement from the Dutch defender to win a penalty corner. That it was Hardik who eventually converted the play from close range to make it 1-1 was a fitting full circle. The new trend

India might not be the only team to use this tactic frequently in Paris. It's an increasingly frequent sighting in the men's game especially."I think Belgium was the first to tactically use it from 2018, and now a lot more teams have practiced and seen the benefits of it," India head coach Craig Fulton told The Indian Express in Bengaluru. "There are a lot more aerial passes being played now, I'd say at least a third of the passes in the final third. The skill level has improved, so teams can do it on the move. Hardik, of course, is one of the best exponents of it in the world. "For me, almost every training session I practice my aerials and it has become a part of my natural game. I just think that if I am able to hit 20 really good aerial balls in a session, then it becomes easier for me to hit 2-3 good ones during a match," the Indian vice captain told this daily at SAI Bengaluru before the team left for Europe."There are some sessions when we work as a team on structures and strategies, and if my aerials work well in those, then it's OK. But if not, I work on it more on my own time. I come 30 minutes early to the training, finish warmup and just throw some aerials. I do this quite a lot. I want to hit, say, 30-40 really good aerials in a week of training."But it is not lost on Hardik that quality matters more than quantity. So he forces himself to play these long balls with the same body language, and mindset as he would do in a match. Behind it is a simple motivation. "For me, it's a self confidence thing, I \*have\* to do extra work on this, because in my mind I have to feel like I have done more work than the opposition, and that I am better at it than them," Hardik added.Need for spaceSiddharth Pandey, a FIH Level 3 Coach, says the objective of an aerial pass is to eliminate opponents, break defensive lines, to break the press.

With teams pressing fast, marking the opponents closely and closing down the hotlines - the fastest route to goal - the space has shrunk to play a ground pass. The other option then is to play an overhead pass to beat these tactics. And that's where the likes of Hardik, Harmanpreet, Manpreet have a key role to play. "Hardik is clinical with his aerials, especially the 35-40m range," Pandey explained. "Apart from good peripheral and open vision, it has a lot to do with torso rotation strength. If you see Hardik, he doesn't possess the broadest shoulders in the world, but he has incredible core strength, possibly second to none. You see his Instagram stories, you see him very often in a plank position with plates on his back. It also helps with his injection, he is India's No 1 for PC routines. He plays with a stick that is known as the low-bow stick. Basically, the bend on the stick (bow) is quite low and it helps with 3D skills, close control, and is very useful for aerial passing."Interpretation issuesBut a key aspect of this tactical play is interpretation of the rules, with defending teams penalised for encroaching an attacker while receiving the aerial pass."The rule changes recently have made it a little more advantageous for attacking sides, every team is trying to use that. We have to change our structure based on the aerial strategies," Hardik said.Fulton actually sees it as a source of frustration, if the referees are not adjudicating it properly. He recalled the match against Great Britain in London last month when a penalty stroke was given against India for a defensive infringement inside the circle.

"And the exact same thing happened in the second half, just outside the D and that was their ball. You're hoping that the best umpires and video referrals will be on at the Olympics. I'm really hoping that we have the same standard of interpretation," the South African said.Fulton hoped for high standards and fewer inconsistency at the Olympics. He'll expect from his players, who'll aim for the sky, literally.

World Cup 2023 1st Semi-Final Highlights: Rohit Sharma and Mohammed Shami celebrateThe pacer, who took 24 wickets in the 2023 World Cup, missed the T20 World Cup, the five-match Test series against England and also sat out of the IPL after having undergone surgery for Achilles tendon in February.

India pacer Mohammed Shami - a notable absentee in India's squad for the recently concluded 2024 T20 World Cup - has conceded that missing out on the team owing to an injury is another adversity that is bound to make him stronger and that his big dream is still to win a World Championship for India.When asked if he felt that he deserved a winner's medal around his neck for his contributions to Indian cricket - including a stellar 24 wicket haul from seven games at last year's World Cup -Shami told Shubhankar Mishra on his YouTube channel, "I believe that whoever took part in that competition, whoever was part of the team, deserved to win it."If I'm unfit today and sitting at home, I can only watch the sport as a fan. Those players are my friends and colleagues, I can only let them know what I feel from the outside to help them play better. There isn't much in our hands. As far as the winners medal is concerned, I also dream to win the World Cup," he added.

Missing out on the recent triumph, Shami believes, will only make him stronger. "I've never run away from situations, nor have I taken an easy way out of things. The more adversities I face, the stronger I become. I have more clarity. You look at 2015, I had most wickets. In 2019, I was the best performer. Same in 2023. Whenever I will get the opportunity, I will give my 100 percent."Shami was the leading wicket taker of last year's ODI World Cup that saw India being bested by Australia in the final, after an 11-game unbeaten run to the summit clash.

The 33-year-old admitted that as he was watching the recent T20 World Cup final with South Africa needing 30 runs to win from as many deliveries - he felt the same eerie feeling that he did in Ahmedabad as the game slipped away from India's hands.I'd felt the same watching this World Cup. I was feeling the same watching it from the outside, as I was on the ground that day. In 2023, when we won 10 games in

last year, Shami believes that despite a sub-par total on the board, not many saw India losing the final until the Travis Head-Marnus Labuschagne partnership started taking roots. "Even in 2023, you wouldn't have heard anyone say that India will lose. When we had 80 runs in the first 10 overs, the feeling (of invincibility) was the same as it was when we had nabbed three wickets in the beginning. There were no doubts on if India are winning the World Cup or not. But then luck...jo naseeb mai hai uske aage aap jaa hi nahi sakte (you can't go against what's been written)."The pacer, who has been out of action since the ODI World Cup last year, also updated on his fitness. 'I'm feeling better now. I'm able to train better now. The pain has started to subside. But when you start giving your body load, the stiffness begins to take over. But one gets used to it over time. I'm starting to get back on the track. I hope (the comeback) is soon.'

### Medals on mind as India eye best-ever performance at Paris Olympics

Mumbai: Indian sports underwent a renaissance in 1996 in Atlanta when Leander Paes won a bronze medal in men's singles tennis, ending a 44-year-old drought for the country's second individual medal at the Olympics.As the clock ticks down for the upcoming Olympic Games in Paris, the question is whether India will undergo another transformation in the French capital.

That medal bagged by Leander Paes kind of triggered the growth points in Indian sport and since then the country has claimed at least one medal from the subsequent editions of the Olympic Games with at least one medal and 12 years after Atlanta, Abhinav Bindra added gold to glory by bagging India's first individual gold medal in shooting. It was from the same Beijing Olympic Games in 2008 that India, after a gap of more than half a century, returned with multiple medals as Vijender Singh clinched a bronze medal in middleweight boxing and wrestler Sushil Kumar came through the repechage rounds to bag bronze in men's 66kg freestyle.India hit another peak four years later when an 83-member contingent returned with six medals - two silver and four bronze. And in the last edition of the games in Tokyo, which were held in 2021 due to the Covid-19 pandemic, India set another record by achieving their best-ever medal haul of seven including a historic maiden gold in Athletics by javelin thrower Neeraj Chopra and a bronze in men's hockey that ended a 41-year wait for glory in the sport that India has dominated for decades, winning eight gold medals.

### Neeraj Chopra at Paris Olympics: Who are javelin thrower's biggest rivals at Paris 2024?

After Neeraj Chopra threw the javelin into the night sky in Tokyo, turned around and celebrated with gusto even before the spear landed, a nation rejoiced. And three vears later, Neeraj Chopra enters the Paris Olympics as not just the reigning Olympic champion but the reigning World Champion as well.Neeraj Chopra's preparations have perhaps not been the most ideal as he has participated in just three events this year. In the 2024 season's top list, Neeraj Chopra is placed fourth. But very few Indian athletes have risen to the big occasion as frequently as him. Will Neeraj Chopra add another Olympic gold medal to his already glittering collection? Here's a look at the challengers for his crown: The Czech athlete has been a near everpresent alongside Neeraj Chopra on the men's javelin podiums around the world in recent times. The Olympic silver medallist when Neeraj Chopra won



gold in Tokyo. The Worlds bronze medallist when Neeraj won gold in Budapest. And he started the 2024 season by pipping Neeraj Chopra to the top spot at Qatar Diamond League, albeit by just 2 cms. He won a thrilling European gold in June with 88.65m, the second best mark of the 2024 season. Make no mistake, he will be a favourite in Paris 2024 as well.India's Neeraj Chopra javelin throw event. (Screengrab)The German is a powerfully-built athlete and will be itching to make up for the lost opportunity Tokyo where he in agonisingly finished fourth. Weber has had a good

season so far, with a best of 88.37m and a silver medal at the European championships behind Vadlejch.The young German turned heads in the athletics community with a stunning throw of 90.20m at the start of 2024 and that is the only 90m mark achieved in men's javelin so far this year. But he is further down this list because Dehning hasn't quite managed to get close to that mark again in his subsequent events, hovering around the high 70s and early 80s since. But just the fact he has been able to pull off a 90m throw once, keeps his name in the mix.The former world champion has made a solid start to 2024 after a tough time on the international circuit. Peters has gone past the 90m mark in four events over his career, and

all of those were in 2022. After his world championships gold in 2022, Perers was involved in a nasty accident that made his 2023 season largely below par. But with a 88.62m throw in Qatar, he has put himself firmly in the mix for a podium finish in Paris 2024.It is perhaps not entirely logical to add an athlete who is placed 16th on the season's top list to the mix of medal contenders in Paris. But the Pakistan athlete has always been something of an enigma. Be it his almost nonchalant throwing style, or his ability to come up with a massive throw when he turns up on a big stage. Even in his season's only appearance at Paris DL, Arshad started with a lukewarm sub-75m throw before going up to 84.21m in a matter of minutes.
