Pilot captain Manish Shakya, 37, is undergoing treatment at Kathmandu Model Hospital.

Of the deceased, 15 died on the spot while three died during treatment at a local hospital, authorities said.Following the accident, services at the Kathmandu airport were halted briefly before being resumed, the airport authorities said.Saruya Airlines operates flights to five tourist destinations within Nepal, with a fleet of three Bombardier CRJ-200 jets, according to the company's website.Nepal has been criticised for its poor air safety record in recent years, but the reasons also include partly sudden weather changes and partly airstrips located in hard-to-access rocky terrains apart from human error. According to Nepal's civil aviation body, 914 people have died in air crashes in the country since the first disaster was recorded in August 1955. In January last year, all 72 people on board, including five Indians, were killed when a Yeti Airlines aircraft crashed in the resort city of Pokhara. The crash was attributed to a human error. Yeti Airlines' 9N-ANC ATR-72 aircraft crashed on the bank of the Seti River between the old airport and the new airport minutes before landing on January 15, 2023, which was the 104th crash in Nepali skies and third biggest in terms of casualties.

The only incidents in which more people were killed took place in July and September 1992. Those crashes involved aircraft of Thai Airways and Pakistan International Airlines and left 113 and 167 people dead, respectively. On May 29, 2022, all 22 people on board, including four members of an Indian family, were killed as a Tara Air plane crashed in Nepal's mountainous Mustang district. In 2016, all 23 people aboard were killed when a plane of the same airline flying the same route crashed after take-off.In March 2018, a US-Bangla Air crash occurred at the Tribhuvan International Airport, killing 51 people on board.

Oppn walks out of RS over 'neglect' of States; FM hits back

New Delhi: The I.N.D.I.A opposition bloc parties, led by the Congress, staged a walkout from Rajya Sabha on Wednesday, in protest against all States, except two, being "ignored" in the Budget, an allegation termed "outrageous" by Finance Minister Nirmala Sitharaman, who said all the States never found a mention in any of the previous Budgets, including those presented by the Congress.After Chairman Jagdeep Dhankhar rejected notices under Rule 267 that called for the suspension of the listed agenda to take up the issue, Leader of Opposition and Congress president Mallikarjun Kharge said the Union Budget for 2024-25 fiscal provided funds and schemes for only two States - Bihar and Andhra Pradesh.All other States did not find any mention, he said, terming the Budget a "kursi-bachao" document. The ruling Bharatiya Janata Party (BJP) lost the majority in the recently-concluded general election and had to seek support from regional parties ruling in Bihar and Andhra Pradesh for forming the government. The Janata Dal (United), which is in power in Bihar, and the Telugu Desam Party (TDP), the ruling party in Andhra Pradesh, have been demanding special economic packages for their States.

In the Budget presented on Tuesday, Sitharaman announced Rs 60,000 crore for Andhra Pradesh and pledged support to get Rs 15,000-crore assistance from multilateral agencies for the southern State.Kharge said the Congress and the other parties in the Indian National Developmental Inclusive Alliance (I.N.D.I.A) "condemn" this discrimination. As Dhankhar gave Sitharaman the floor to respond, Kharge led the opposition bloc out of the House, saying they were walking out in protest. The Finance Minister said she did not name many States either



in the interim Budget presented in February ahead of the general election or in the full Budget tabled in Parliament on Tuesday, but that does not mean that government schemes are not working for the States.She cited the example of Maharashtra, which was not named in either of the Budgets, and said that did not prevent the Union Cabinet from approving the Rs 76,000-crore Vadhavan port project in Dahanu in the State last month. "Did Maharashtra get ignored because I did not mention the name of Maharashtra? (An amount of) Rs 76,000 crore has been announced for that project," she said.Sitharaman said she can go on to cite several other States that have got major projects. "If the speech does not mention the name of a particular State, does it mean that the schemes of the Government of India, the programmes of the Government of India, the externally-aided assistance which we obtain from the World Bank, ADB, AIIB and institutions like that do not go to these States? They go as per a routine," she said. The expenditure statement of the government gives out the item-wise allocation, the Finance Minister pointed out. '

Inside the Ambanis' favourite 88-year-old Cafe Mysore in Matunga

The mood at Mumbai's Cafe Mysore is jubilant after owner Shanteri Nagesh Nayak, 75, received a heartening reception from Anant Ambani and Radhika Merchant Ambani at their wedding function on Monday. The newlyweds touched her feet and expressed that the entire Ambani family eagerly looks forward to Cafe Mysore's food every weekend. Established in 1936, Cafe Mysore is arguably the oldest Udupi eatery in Mumbai. Located in Matunga, it has a loyal base of customers flocking to the double-storey restaurant from around the city for its soft and fluffy idlis, crispy Mysore masala dosa, flavourful rasam and delectable sheera.

As legend has it, in pre-Independent India, a young A Rama Nayak stowed away on a ship from Mangalore to then Bombay without a shirt on his back and went on to become a formidable figure in Matunga, successfully running multiple restaurants in the neighbourhood."After losing his father, he and his mother came to Mumbai. They staved at Rama Krishna Ashram and cooked there in exchange for their stay. He later started working as a cook, got married, and moved into a chawl in Brahmanwada. He was so good at his work that he was appreciated by the owners," recalled Shanteri about her father-in-law, adding that he was a celebrated man when she got married and joined the family in 1975. "Between 1942 and 1960, he took over several hotels to manage, which was common practice at the time, and Cafe Mysore was one of them.

Thomas Cook, Red Apple Travel directed to pay Rs 1 crore to man who lost his family on a trip to Sri Lanka

Thomas Cook Delhi Consumer CommissionSaigal, along with his wife, son, daughter, and father-in-law, had booked a vacation package to Sri Lanka through Thomas Cook in November 2019 for Rs 3.56 lakh. This package included accommodations, sightseeing, transportation, and travel insurance. The Delhi Consumer Commission earlier this month directed travel companies Thomas Cook and Red Apple Travel to pay Rs 1 crore as compensation to Yogesh Saigal for the death of his family members in a road accident during a vacation in Sri Lanka.

Considering the mental and physical trauma faced due to the loss of his family caused by the negligence of the two travel companies, the Delhi State Consumer Disputes Redressal Commission sided with Saigal in an order dated July 1. The loss of livelihood and future prospects of Saigal's wife were also taken into account. Saigal along with his wife, son, daughter, and father-in-law, had booked a vacation package to Sri Lanka through Thomas Cook in November 2019 for Rs 3.56 lakh. This package included accommodations, sightseeing, transportation, and travel insurance.

On December 23, 2019, the vehicle carrying Saigal's family collided with a container truck in Colombo, resulting in the immediate deaths of his wife, son, and fatherin-law. Saigal himself sustained severe injuries, including multiple fractures, and his daughter, Aishwarya, also suffered physical trauma. The complainant further alleged that a few hours before the commencement of their journey, he was informed that the arrangements in Sri Lanka would be managed by Red Apple Travel, a fact that was not disclosed to him during the booking process.Saigal further alleged that the involvement of Red Apple Travel was only revealed 36 hours prior to the journey, leaving the family with no option but to proceed or risk forfeiting the entire amount paid. The aftermath of the accident led to Saigal issuing a legal notice to Thomas Cook on February 24, 2021, seeking Rs. 8.99 crore in damages for negligence, deficiency in services, unfair trade practices, and misleading advertisements. In his complaint, Saigal argued that Thomas Cook had failed in its duty of care by not ensuring safe and reliable contractors for the tour.

Onion slices in vegetable curry; kanwariyas damage eatery in UP's Muzaffarnagar

A group of kanwariyas from Haryana allegedly damaged a roadside dhaba in Uttar Pradesh's Muzaffarnagar district after they claimed to have found onion slices in the food. The eatery named 'Tau Hukkewalah Haryanvi Tourist Dhaba' is located on the Delhi-Haridwar highway in the Sisauna block of the Muzaffarnagar district. The incident happened when the kanwariyas on their way to collect Ganga water from Haridwar decided to stop at the eatery for lunch on Friday. After allegedly finding onion slices in the vegetable curry served to them, the kanwariyas assaulted the dhaba workers and damaged the furniture and the refrigerator. They also ran after the cook who scampered to safety.


"The devotees had vowed not to consume onion and garlic during the yatra. They lost their temper when they found onion slices in their vegetable curry. We pacified them and appealed that they should carry on with the yatra," said Rogent Tyagi, Station House Officer, Chapar police station. The dhaba owner, Pramod Kumar, a resident of the nearby Perai village, said Friday's incident was the result of confusion."I have been running this dhaba for the last few years and did not know that even onions are prohibited while serving meals to the devotees. I will keep this in mind to save my business from damage," added Kumar."We asked the cook if he was preparing the dish without garlic and onion, and he told us that he wouldn't be using them while preparing the



dish. But despite this, we found onion slices in the curry. We avoid consuming onion and garlic till offering the Holy water to Lord Shiva in our village," claimed Hari Om, the leader of the kanwar group.Raju Kumar Sab, Deputy SP (Sadar), said elaborate arrangements have been made to ensure that the devotees do not face any hassle either while walking on the road or having their lunch and dinner. "We will try to ensure that such mistakes are not repeated in the future," he added.Meanwhile, Ashutosh Shivam, Deputy SP, Garhmukteshwar (Hapur district), directed restaurant owners selling non-vegetarian food on the Garh-Haridwar highway to not only do away with meat dishes during the 12-day kanwar yatra starting Monday but to also buy new utensils to cook food for devotees during the period.

24 Indian armed forces personnel to test their mettle at 2024 Paris Olympics

New Delhi: Twenty-four personnel from the armed forces, including ace javelin thrower Neeraj Chopra and two women participants, are among the 117 Indian athletes who are set to test their mettle at the 2024 Paris Olympics. The presence of these two women athletes in the contingent marks the maiden participation of women service athletes at the Olympics, the Ministry of Defence said in a statement. Chopra, the 2020 Tokyo Olympics gold medallist, is a subedar in the Indian Army.

Twenty-four personnel from the armed forces are among the 117 Indian athletes who are all set to make the nation proud at the Paris Olympics, beginning July 26, it said. Among these 24 athletes, 22 are men, including javelin thrower Subedar Neeraj Chopra, and two are women, it said. Chopra will again vie for the top honours as his participation in the Paris Olympics comes on the back of exceptional performances which earned him a gold medal each at the 2023 Asian Games, 2023 World Athletics Championship, 2024 Diamond League, and

The eatery was much smaller then and in a dilapidated state. The late A Rama Nayak turned it around, and in 1973-74, he passed it on to his son Nagesh Rama Nayak. Shanteri's husband Nagesh, an engineer from Veermata Jijabai Technological Institute (VJTI), is credited with expanding the restaurant.

"He was a visionary and had a lot of ideas - he introduced the three-cavity-plate for serving efficiently, hot water washing of utensils, steam boilers for cooking, and himself designed the spiral staircase to save space. The first major renovation happened in the early 1980s," noted his son, Naresh Nagesh Nayak, 44, who currently owns the restaurant and handles its day-to-day operations. "When he passed away in 2009, my mother - one of the first graduates in her village near Mangalore - took over the reins of the restaurant and ran it efficiently alongside my sister Neha. I took over during the Covid period," added Naresh, who added a digital kiosk at the entry and a hands-free washing station in the restaurant, to keep up with the times. It was during his father's time that Reliance Industries' Chairman and MD Mukesh Ambani then a student at the University Department of Chemical Technology (now ICT) - started frequenting Cafe Mysore, a tradition that continues to this day.Naresh reminisced about his earliest memories of Mukesh Ambani dining at the restaurant. "I was barely seven years old, sitting on the manager's lap, when he pointed to the television screen showing two young gentlemen and then to a table in the restaurant. Those gentlemen were Mukesh and Anil Ambani, and my young brain could not comprehend how someone could be in two places at once," he laughed.

He recounted another instance when Mukesh Ambani dined upstairs in the air-conditioned section with his wife Nita and their three children. "When they finished their meal, the staff rushed to get the car but Mr Ambani walked leisurely with his kids, took out a hundred-rupee note, and bought them balloons from a roadside vendor," he shared.

"Mr Ambani has remained humble and still treats everyone as an equal. Even the children reflect his values. They did not have to touch my mother's feet but the way they treated her brought tears to my eyes," he added. To this day, food from Cafe Mysore is delivered to the Ambani residence every weekend with their F&B team placing and picking up the order in advance. Payment is made promptly. "Mr Ambani has spoken about only one brand in the media that's not theirs-it is Cafe Mysore," Naresh added with pride.

Over the years, many Udupi eateries have had to shut down. While Naresh admits that business is not what it was before Covid, he also shares that their boiler runs non-stop from 6 am to 10 pm, producing fresh plates of idlis - their most popular item - of which they sell over a thousand daily. When asked about their success mantra, Naresh said, "Our goal is to provide very honest value to the customer at the right price" - a practice upheld since his grandfather's time

Turning the tables on the Maha Vikas Aghadi (MVA), Maharashtra BJP president Chandrashekhar Bawankule on Saturday dared the Congress, the Nationalist Congress Party (SP) and the Shiv Sena (UBT) to publicly clarify their stand on Maratha reservation."Are MVA leaders supporting Jarange Patil who wants Maratha reservation under Other Backward Class (OBC) category? Will the Opposition support the dilution of the OBC quota? These are some key issues that the Opposition needs to answer first, instead of attacking the state government," he said, speaking to the media "Instead of attacking Mahayuti, the Opposition MVA should make its views clear. I dare them to mention their support for Jarange Patil's demand of Maratha reservation under the OBC category in their manifestos," Bawankule added.Bawankule's remarks came on a day when Maratha activist Manoj Jarange Patil began an indefinite fast at Antarwali Sarathi village. Jarange Patil is demanding the implementation of the draft notification that will ensure that the 'sage soyare' or blood relatives of Marathas will get Kunbi certificates so that they can avail of reservation under the OBC quota.In Maharashtra, nobody will want dilution of the existing OBC quota or any existing quota, Bawankule said. "While we are committed to Maratha reservation, it cannot be at the expense of OBCs," he added.

Last week, Maharashtra Chief Minister Eknath Shinde had convened an all-party meeting at the Vidhan Bhavan to discuss the Maratha reservation issue. However, Opposition parties boycotted the meeting.Reiterating the Mahayuti's commitment to give Marathas reservation, Bawankule said, "The chief minister has already said that the government is committed to the welfare of Marathas. It has given 10 per cent quota to Marathas under the Socially and Educationally Backward Class (SEBC) Act. What is unacceptable is Jarange Patil insisting that Marathas should be allowed to avail reservation under the OBC category."The Maratha versus OBC issue has become a polarising issue ahead of the Assembly polls in Maharashtra.Jarange Patil, who started the Maratha reservation agitation last August, has gone on a fast and held protests several times. During the 2024 Lok Sabha elections, he extensively toured the Marathwada region, giving a clarion call to his followers to teach the BJP a lesson. The BJP bore the brunt as it failed to win a single seat in the drought-prone region which has eight Lok Sabha seats and 46 Assembly seats.Officially, OBC leaders across party lines are opposed to Jarange Patil's demand for reservation within the OBC category. But Opposition leaders say it is for the government to resolve the issue.Senior NCP minister Chhagan Bhujbal had approached NCP (SP) chief Sharad Pawar this week seeking his intervention to resolve the Maratha versus OBC dispute. "Sharad Pawar with his vast experience should come forward to resolve the reservation issue as polarisation between Marathas and OBCs does not augur well for a progressive state like Maharashtra," Bhujbal said

While Pawar has assured he would speak to the chief minister, he said he was unaware of what transpired



between the government and Jarange Patil, or between the government and OBC activist Laxman Hake.In 2018, after 58 silent rallies undertaken by the Maratha Kranti Morcha, the then government led by chief minister Devendra Fadnavis gave 12 and 13 per cent quota to Marathas in government education and jobs under the SEBC Act. The Act was unanimously adopted by both Houses of the legislature. In May 2021, during the tenure of the MVA government led by chief minister Uddhav Thackeray, the Supreme Court scrapped the Maratha quota."The stated objective of the Maratha reservation was the upliftment of the poor backward Marathas in education and employment. Instead, it has become a political issue which is being used by mainstream parties to settle scores," Vanchit Bahujan Aghadi (VBA) chief Prakash Ambedkar said. "Nobody wants OBC guota compromised. What needs to be discussed is how to uplift poor Marathas who have long been neglected by dominant ruling classes," he added.

The actions would be coordinated according to the Standard Operating Procedure (SOP) formulated as per the government order with regard to Nipah prevention, it said. The Health Minister would reach Malappuram soon and lead the Nipah prevention activities, the statement added.Various higher officials, including the Health Secretary, National Health Mission State Director, District Collectors of Kozhikode and Malappuram and Health Director, took part in the meeting, it added. The State government had announced recently that a special action calendar was being prepared for the prevention of a Nipah outbreak, which has haunted the State on four occasions in the past.



Jarange launches fresh hunger strike for Maratha quota

Jalna: Maratha quota activist Manoj Jarange on Saturday launched a fresh indefinite hunger strike in Maharashtra's Jalna district, demanding implementation of the draft notification that recognises Kunbis as blood relatives of the Maratha community members.Launching the fast in his native Antarwali Sarati village in the district, he said he had to undertake this step as the Maharashtra government has failed to fulfil the promise on the reservation issue.Earlier, Jarange had suspended his indefinite fast over the reservation issue on June 13, six days after launching it, and set a deadline of one month before the government to accept the community's demands.

Speaking to reporters on Saturday, Jarange said, "I had to launch this fast as the government did not keep its word. I will continue the strike till my death."He said a crucial meeting will be held on August 29, where the Maratha community will decide whether to contest the upcoming Maharashtra Assembly elections. During the indefinite fast, he would undertake a State-wide tour from August 7-13, he said. "I will tour Maharashtra in an ambulance and address meetings. Following this, a series of meetings will be held at Antarwali Sarati from August 14 to 20 to discuss Assembly polls. On August 29, if the community decides against fielding any candidate, we will not field any. But we will then work towards defeating those who oppose Maratha reservation and support them who are in its favour," he said. He urged the Maratha community members to collect data on probable candidates to be fielded in the assembly polls, so that discussion can be held on them between August 14 and 20.

He further said the ruling Mahayuti alliance and the opposition Maha Vikas Aghadi (MVA) were trying to take advantage of his agitation."The Mahayuti wants me to field 288 candidates in the elections, while the MVA hopes that I would support it instead. But I know their tricks and I will not let their plans succeed," he said. He alleged that the Eknath Shinde-led Maharashtra government launched the 'Ladki Bahin' and 'Ladka Bhau' schemes in view of the upcoming elections."There were several welfare schemes that were shut down in the past," he said.Jarange accused Deputy Chief Minister Devendra Fadnavis of betraying the Dhangar community by failing to include them in the Scheduled Tribe (ST) category, and alleged that OBC leaders were trying to create discord between Marathas and OBCs.On the Prakash Ambedkar-led Vanchit Bahujan Aghadi's plan to launch 'Aarakshan Bachao Janyatra' on the reservation issue in parts of Maharashtra, he said, "We expect that Ambedkar will support us as he is the leader of the poor and weaker sections of the society."

Shed paternalistic approach towards junior lawyers, pay them dignified sum: CJI Chandrachud

Chief Justice of India D Y Chandrachud on Saturday asked the advocates to shed away paternalistic approach towards junior lawyers and said paying them pretty low amounts leads to 'gatekeeping' of the profession.After inaugurating celebrations here to mark the 20th anniversary of the setting up of the Madurai Bench of the Madras High Court, the chief justice hailed the contribution of the bench in serving as a repository of data and software backup for the Delhi High Court.

Raising the issue of entry-level juniors getting paid a "meagre" salary, Justice Chandrachud said "please shed away the paternalistic approach that they have come to learn and get exposure and experience, and that you are mentoring them." He pointed out that there was much to learn from the junior lawyers. Paying lower amounts such as Rs 5,000 per month to the juniors leads to "gatekeeping" of the profession, he said.

Maintaining that the juniors were particularly more cognizant of the contemporary realities, he advocated that the junior lawyers should be provided a "dignified sum commensurate with their hard work." "This overromanticisation of hard work, especially work without sufficient pay, is not merely rhetorical, it leads to people being expected to work for long hours with less sleep and for lesser monetary value," Justice Chandrachud said and stressed that the entire Bar should raise competent lawyers unfettered by their social or economic background.Lauding the Bench for its latest "remarkable feat", the CJI said the Delhi High Court had set up a Disaster Recovery Centre at Madurai Bench this year to ensure regular backup of its data and softwares.

"So, Delhi has to look towards Tamil Nadu for a so-lution if it faces problems," Justice Chandrachud said in a



lighter vein. The CJI unveiled the Vigentennial Stupa at the Madurai Bench premises through a video conference. The celebrations at the Madurai Convention Centre, Tamukkam grounds, here, was attended among others by Supreme Court judges: Justice B R Gavai, Justice Surya Kant, Justice M M Sundresh, Justice K V Viswanathan, Justice R Mahadevan.Madras High Court Acting Chief Justice D Krishnakumar and Justices R Suresh Kumar, S S Sundar, and R Subramanian besides Advocate General of Tamil Nadu P S Raman, and Additional Solicitor General of India A R L Sunderesan also participated.Justice Sundresh unveiled a new name board for the Madurai Bench.Addressing the gathering, the CJI said establishing the bench of the high court was not just about setting up infrastructure or creating courtrooms or furnishing those courtrooms."

The curbs imposed by Canadian government on India in the past eight months is not going to reverse the rampant migration of students happening in India, according to retired economic professor Kuldeep Singh of Punjabi University.

Singh who was invited as a special guest in a seminar organised by the Canadian Punjabi Cultural Society in Brampton recently stated that though the intake of students has reduced, reverse migration can happen only when India's social- economic condition would be better than Canada. "Only then one can imagine reverting back, but still this is a fantasy, far from reality," he said.Quoting World Development Report, Prof Singh said, "Indian students going across the globe as international students has risen from 2 per cent in 2000 to 41 per cent in 2023."

While speaking on 'Global immigration of youth:

Reasons and Challenges', he said, as per the data of regulated Canadian immigration consultancy, there has been a 50 per cent increase in migration of Indian students to Canada - 50% upwards trend from 2014 to 2019. "In 2019 alone 198,235 students came from India to Canada and out of this, 71% ratio was from Punjab," he

He said that despite Punjab being one of the advanced states in India, the state government is not serious about creating job opportunities for the youth. "Major factors of migration from Punjab was due to agrarian crisis, slow pace of Industrialisation, fading away of Indian education system, declining employment opportunities due to which the Punjabi youth are forced to migrate to foreign countries for their education, employment and living facilities," he said. According to Immigration Refugees and Citizenship Canada(IRCC) data, the population of international students rose from 3.26 lakh in 2014 to more than 8 lakhs in 2022. By the end of December 2023, the number of study permit holders had crossed a million according to IRCC data with more than half of them living in Ontario. Professor Dr Joga Singh, also a former faculty of Punjabi University, Patiala, pointed out that the previous Punjabi generation, which used to be against leaving the country, are now motivating youth to settle abroad for a better future. However, at an older age, this generation is facing the difficulty of family separation, he remarked. According to Prof Kuldeep Singh said the phenomenon of migration has been going on for centuries. In most countries, wars and upheavals have also uprooted people and forced them to migrate."Countries like Canada, America, Australia have given new opportunities to many immigrants and opened new ways by welcoming them. People do face mental and physical challenges during the initial settlement in new countries."Hardeep Singh Atwal, convener of the Punjabi Society, appreciated the contributions and achievements made by the immigrants in the progress of Canada, despite the fierce struggle.

Bombay HC tells social media firms to take prompt action against deepfakes of NSE's MD

The Bombay High Court has directed social media intermediaries to take prompt action against alleged deepfake videos of NSE's managing director and chief executive officer giving stock recommendations

A single bench of Justice R I Chagla in the order of July 16 also directed social media platforms like Facebook, WhatsApp, Instagram and Telegram to remove or delete all accounts infringing upon the trademark of NSE "The balance of convenience also lies in favour of the Plaintiff (NSE) and irreparable loss and/or harm will be caused to the Plaintiff, unless the ad-interim (temporary) relief sought for is granted," the HC said. The bench directed the social media platforms to remove or delete the content within ten hours upon receiving a complaint against such morphed videos and profiles where the plaintiff's trademark is infringed. The court said social media firms are mandated by the Information Technology Rules to take prompt action on the complaints of entities like NSE about unauthorised use of their trademark on dubious "web pages and/or profiles, accounts and/or advertisement and/or videos and/or contents and/ or social media groups". The NSE had moved HC claiming that the platforms featured a fabricated video of its managing director (MD) and chief executive officer (CEO) Ashishkumar Chauhan doling out investment and stock tips. The video was allegedly generated using sophisticated AI (artificial intelligence) technology to imitate his voice and facial expressions. The NSE sought an order directing the paltforms to take down and remove the unauthorised videos. The NSE further claimed that some perpetrators have allegedly used its trademark and circulated false and misleading advertisements on social media platforms like Facebook, Instagram and WhatsApp.The NSE in its



plea said that in April this year, it had also filed a complaint with the cyber police.Senior counsel Birendra Saraf, appearing for the NSE, told the court that despite complaining to the grievance cell of the social media intermediaries no action has been taken against such deepfake videos and those infringing upon the trademark.

This deceptive behaviour of the violators is capable of manipulating the markets and thereby resulting in unfair trade practices as well as breach of various regulations of market regulator SEBI (Security Exchange Board of India) enacted from time to time, Saraf argued.Justice Chagla said NSE had made out a "strong prima facie case" for grant of ad-interim relief sought not only against the intermediaries but also against the unknown perpetrators for infringing its rights. The HC has restrained any persons from infringing the plaintiff's registered trademark "NSE". The court directed the intermediaries to file their affidavits giving details of all those accounts and the persons handling those accounts involved in publishing the fake videos and content similar to fake videos or using the stock exchange's registered trademark "NSE". The affidavits shall be filed within three weeks, the court said and posted the matter for further hearing on August 19.The court in its order noted that in the alleged deepfake videos, the NSE's MD and CEO can be seen recommending viewers to join a WhatsApp community where the company would allegedly recommend stock picks.The videos further assure "full reimbursement by the plaintiff" of the losses caused to investors executing the suggested trades with diligence, the bench noted.

Contractor booked after labourer dies in mishap in Malad

The Dindoshi police have booked the site supervisor and the contractor of a private construction company on charges of causing death by negligence after a 39year-old labourer died after a portion of an excavated area at an under-construction SRA building site in Malad East caved in, following heavy showers on Friday afternoon. Three labourers were stuck in the soil inside the foundation pit of an under construction building. Two were rescued while a third labourer, identified as Premchand Jaiswal, died.

Amethi construction of the United Infra company is carrying out construction on the site belonging to Vora and Developers and called the labourers to the site on Friday morning. Jaiswal, along with another labourer, had reached the construction site behind Samudra Bar in Malad East on Friday morning. Jaiswal and his friend Saniav Kumar Nishad were asked to enter the pit made for the foundation of the building.

While the two were clearing the soil from the pit, suddenly more soil fell into the pit. Jaiswal, Nishad and another labourer Shashti Das, who was already working under the pit, got stuck in the muddy soil, said police.

They screamed for help and other people present at the site pulled out Nishad and Das. Jaiswal could not be



pulled out as he was completely buried under the soil. The police and officials from the fire brigade pulled him out of the soil. Jaiswal was taken to the Trauma Care hospital in Jogeshwari, along with Nishad. While Nishad was discharged after primary medication, Jaiswal was declared dead, said a police officer. When police recorded Nishad's statement, he told police that when he and Jaiswal had asked for a helmet, the supervisor did not entertain their request.On the complaint of Nishad, police have booked the unidentified site supervisor and contractor Pravin Patel under Sections 116 (1) (causing death by negligence) and 3(5) (common intention) of Bhartiya Nyay Sanhita (BNS).

The CID started investigating the case after a complaint was filed by Jatinkumar Patel, an executive engineer at the GWSSB.According to the FIR, the accused siphoned off funds meant for water distribution works at Navsari, Vansda, and Bilimora under the Rejuvenation Tribal Programme without following the tender procedure between April 1, 2022, and August 25, 2023. According to the FIR, officials of the GWSSB vigilance department had carried out physical checks at 94 of the 163 locations where the works were said to be undertaken.

Unscientific construction along NH-66 caused landslide near Shirur, says Karnataka minister Krishna Byre Gowda

Karnataka Revenue Minister Krishna Byre Gowda has claimed that unscientific road construction along National Highway 66 was responsible for the landslide near the Shirur region of Ankola in the Uttara Kannada district on July 16. Seven people have died in the incident and several others are still missing."In Karwar, near Ankola, a landslide has occurred on the national highway. While constructing the national highway, they have cut the hill in a steep manner, it is almost a vertical cut. When a hill is cut for an infrastructure project, a slope is usually provided in order to prevent landslides in the rainy season," Byre Gowda said in the state legislature on Friday, speaking about the road construction measures deployed to expand the highway.

"If you cut the hill in a vertical manner at a 90-degree angle, it is a manner of welcoming a disaster during the monsoon. The national highway has been designed in an unscientific manner and this is the cause of the landslide is what the people are saying," Byre Gowda said."On one side there is a landslide, on the other side there is water that is standing at a height of five feet on the national highway. Our officials had to travel in a truck on account of high water levels on the highway to reach the spot of the landslide," he said. "The chief secretary has spoken to the NHAI (National Highways Authority of India) about the unscientific manner of design," he added."So far we have recovered seven bodies including that of a family and two lorry drivers. There is news that a lorry belonging to Sagar Timber Company is miss-



ing. The GPS location is provided. The family of the lorry driver from Kozhikode has said that there has been no communication for four days. Heavy vehicles are working 24/7 to remove the debris from the highway to find the missing lorry and its driver," the Uttara Kannada district Superintendent of Police M Narayana said. The last GPS location for truck driver Arjun S from Kerala has been identified as the landslide spot, the district police said earlier on Friday. Arjun, who is from Kozhikode, was driving a Benz lorry with the registration number KA-15-A-7427.Rescuers are using heavy equipment at the site of the landslide to find the truck driver and several others who are believed to have stopped at a roadside hotel when the landslide occurred on July 16. The landslide occurred near Shirur village under the Ankola police station limits of the Uttara Kannada district, on the edge of National Highway 66, at around 8.30 am on July 16.

Mizoram on Saturday bid farewell to Zadingi, the fearless woman who carved her name into India's gallantry history by killing a tiger with her axe.Zadingi, who achieved this remarkable feat 46 years ago, passed away on Friday at the age of 72 in her native village of Buarpui in south Mizoram's Lunglei district, near the Bangladesh border, after a prolonged battle with cancer.She is survived by five children and a grandchild.

Her funeral program was held at noon in her native village during which church leaders, community leaders, and several dignitaries paid their last respects, family sources said.Chief Minister Lalduhoma also mourned the death of Zadingi and extended his deepest condolences to the bereaved family. "Zadingi, one of the bravest Mizo women, who was worth imitating and also an awardee of India's bravery award 'Shaurya Chakra' has passed away. I deeply mourn her death and extend my deepest condolences to the bereaved family," Lalduhoma said on his social media handle.Zadingi was just 26 when she encountered the tiger while gathering firewood in a jungle near her village.

She recounted the event in an interview when she was alive, explaining that she first mistook the noise in a bush for a wild boar. Despite her calls for help, her friends, terrified by the sound, did not come to her aid. When the tiger emerged, Zading had no time to escape. Standing just three feet from the big cat, she struck it on the fore-head with her axe, killing it with a single blow. Although the tiger scratched her finger with its paw, she remained composed and managed to inform the villagers of the incident. The encounter took place on July 3, 1978. After killing the tiger, Zadingi learned that her friends had been too scared to assist her. The mummified body of the tiger is now on display at the state museum. Zading's bravery earned her the Shaurya Chakra in 1980.

Her heroic act has transcended Mizoram, making her a celebrated figure beyond the state's borders.She remains the only recorded Mizo woman, and perhaps the only woman in India, to have killed a tiger with an axe.Her heroic act was included in the Hindi curriculum of the Mizoram elementary syllabus for many years.In August 2021, Zading was diagnosed with colon cancer, just a month after her husband Lalthanmawia died of cancer. Despite undergoing two major surgeries, her condition worsened earlier this year before she finally passed away on Friday.

Flash floods in UP village after Nepal releases 'excess' water; over 100 stranded people rescued

Kerala's spending increased by 30-35 per cent despite Centre's restrictions: Minister Balagopal

Kerala Finance Minister K N Balagopal on Saturday said that the government's expenditure on development and welfare measures has increased by 30-35 per cent despite the Centre's attempts to "financially choke" the state.Speaking to mediapersons ahead of the upcoming Union Budget, Balagopal said that the average yearly expenditure of the state under the first Pinarayi Vijayan government was around Rs 1.20 lakh crore.During the second Vijayan regime, the state's average yearly expenditure increased to Rs 1.60 lakh crore."This is despite the severe financial restrictions on us, including cuts in our borrowing limits. We even implemented a pay revision. Ours was one of the few states that did it," Balagopal said.He said that if the UDF had come to power in 2021, then the pay revision would not have been implemented.

He further claimed that the average spending of the second LDF government would have been much higher if the expenditures by the Kerala Infrastructure Investment Fund Board (KIIFB) were also included. The finance minister said that since 2016, KIIFB has spent around Rs 30,000 crore on development of which about Rs 20,000 crore was spent during the second LDF government's tenure.He said that around Rs 27,000 crore has been spent on social welfare pension in the three years of the current LDF government and only about four months arrears remain to be paid. The minister further said that the government had to pay more than the amounts allocated to each department in the budget in order to ensure the public did not face any issues."The government is doing all this and carrying out development work despite the Centre's attempts to financially choke us," he claimed.

Balagopal said that the government also spent more than Rs 3,000 crore out of its pocket on initiatives like National Health Mission (NHM), Anganwadis and ASHA on behalf of the Centre which is yet to reimburse the



amount. The minister said that in view of the financial restrictions by the Centre, priorities would be restructured but there would not be any huge cuts in spending.He said preference would be given to general public needs, employment generation, labour and necessary works. The minister also reiterated the requests made by the state to the Centre during the pre-budget meeting held in June in the national capital. He said that the Centre has been requested to announce a special package of Rs 24,000 crore for the southern state in the Union Budget 2024-25.He said the amount sought was actually what was cut from the state's borrowing limits in the financial years 2022-23 and 2023-24. "We asked for what we were entitled to," he added.Balagopal, in the press conference, also said that the state urgently needed a special capital investment of Rs 5,000 crore for fulfilling Kerala's part in the development of the Vizhinjam port and the surrounding region. He also pointed out that Kerala was the only state which had spent 25 per cent of the land acquisition cost of the National Highway widening, which amounted to around Rs 6,000 crore. Besides these, the minister also referred to the state's long pending demand for establishing an AIIMS in Kerala.

The ED slapped criminal charges under the PMLA against these cyber criminals after taking cognisance of a Jharkhand Police FIR and charge sheet that charged them with illegal withdrawal and transfer of money from the ATMs/bank accounts of gullible people in guise of being a bank official. The ED had said its investigation found that the accused "in connivance with other persons acguired funds in their bank accounts and family member's bank accounts by cheating the bank customers, some other individuals and invested the same in the construction of houses and purchase of vehicles.'


The police department has directed the district Superintendents of Police to conduct monthly surprise visits. The officers in-charge of respective police stations have also been directed to compile a list of police officials who indulge in such activities for "necessary action", The Indian Express has learnt. The note, issued by the office of Superintendent of Police (Headquarters) earlier this week, states, "It has been reported that nowadays there is (an) increase in the number of alcohol and drug addicts among the police officials, thus spoiling their physical as well as mental health."The note claims that the police stations and restrooms have become places where "officers and lower staff consume alcohol and other drugs on duty", and "gambling is also a part of activities in police stations/unit premises". "The SPs of the district/unit shall make surprise visits once a month and take action against such officials/personnel who are addicted to alcohol, drugs and gambling activities while on duty," it stated

A senior police official, requesting anonymity, said, "It is a cautionary note, which was to be circulated within the police department. The Union Health Ministry has rubbished reports highlighting a higher number of deaths in 2020, during the COVID-19 pandemic in India. The Ministry claims that the study, published in the Science Advances,was based on untenable and unacceptable estimates. "It is strongly asserted that an excess mortality of about 11.9 lakh deaths reported in the Science Advances paper in 2020 over the previous year is a gross and misleading overestimate. It is noteworthy that excess mortality during the pandemic means an increase in deaths due to all causes, and cannot be equated with deaths that were directly caused by COVID-19," the Ministry said.

According to the Ministry, the paper reports results on age and sex, which are contrary to research and program data on COVID-19 in India. The paper claims that excess mortality was greater in females and in younger age groups (particularly 0-19 year old children). Data on about 5.3 lakh recorded deaths due to COVID-19 virus, as well as research data from cohorts and registries consistently shows higher mortality due to the virus in males than females (2:1) and in older age groups (several fold higher in > 60 years olds than in 0-15 year old children). These inconsistent and unexplainable results in the published paper further reduce any confidence in its claims.In a statement issued on Saturday, the Ministry said that "the excess mortality reported in the Science Advances paper in 2020 over the previous year is a gross and misleading overestimate. The study is erroneous and methodology followed by the authors has critical flaws; the claims are inconsistent and unexplainable. The all-cause excess mortality in 2020 compared with the previous year in India is markedly less than the 11.9 lakh deaths reported in the Science Advances paper.

It added that discrepancies between the study's findings and established COVID-19 mortality patterns further undermine its credibility. "Study fails to acknowledge India's robust Civil Registration System (CRS), which recorded a substantial increase in death registrations (over 99%) in 2020, not solely attributable to the pan-

demic," the Ministry maintained. While the authors claim to follow standard methodology of analysing the National Family Health Survey-5 (NFHS-5), there are critical flaws in methodology.

It noted that the most important flaw is that the authors have taken a subset of households included in the NFHS-5 survey between January and April 2021, compared mortality in these households in 2020 with 2019, and extrapolated the results to the entire country. "The NFHS sample is representative of the country only when it is considered as a whole. The 23% of households included in this analysis from part of 14 States cannot be considered representative of the country. The other critical flaw is related to possible selection and reporting biases in the included sample due to the time in which these data were collected, at the peak of the COVID-19 pandemic," the Ministry said, adding that the paper is methodologically flawed and shows results that are untenable and unacceptable. It elaborates that the paper erroneously argues for the need for such analyses claiming that the vital registration system in low and middle income countries including India is weak. This is far from being correct. The CRS in India is highly robust and captures over 99% of deaths. This reporting has constantly increased from 75% in 2015 to over 99% in 2020. Data from this system shows death registration has increased by 4.74 lakh in the year 2020 compared to 2019. There was a similar increase of 4.86 lakh and 6.90 lakh in death registration in the year 2018 and 2019 over the respective previous years. Notably, all excess deaths in a year in the CRS are not attributable to the pandemic. Excess number is also due to an increasing trend of death registration in CRS (it was 92% in 2019) and a larger population base in the succeeding year.

Biden pushes party unity as he resists calls to step

All eyes on poll date in Sri Lanka amid concern over Bill

The date of Sri Lanka's presidential election will be announced next week, the country's Election Commission said on July 19, amid fresh speculation in the wake of a gazette issued by President Ranil Wickremesinghe.

Dated July 18, 2024, the gazette notification pertains to amending a constitutional provision on whether a referendum is required to extend the term of office of the President or the duration of Parliament. While the existing article refers to such a term extension to "over six years", the proposed Bill seeks to substitute that with the text "over five years". When contacted, Chairman of the Election Commission R.M.A.L. Rathnayake told The Hindu: "We will announce the date of the presidential election next week. The gazette is not related to this election. The two are separate matters."While constitutional experts, too, noted the gazette had no implication on the coming presidential election - scheduled to be held on a date between September 17 and October 16 this year - government critics and lawyers guestioned the timing of the gazette. Citizens are awaiting the first election since a mass uprising dislodged former President Gotabaya Rajapaksa in 2022, when the country's economy crashed.

According to senior lawyer and constitutional expert Jayampathy Wickramaratne, who has been involved in drafting key legislation, there is no ambiguity in the current term of the President. "The term limit of the President and what this gazette addresses are two distinct issues, he told The Hindu. "The Supreme Court has ruled that the presidential term is five years," he said, referring to the apex court's decisions in 2015, 2018, and twice earlier this month

President Wickremesinghe - who has repeatedly stated elections will be held as per schedule - on Friday said he is "dedicated to preserving Sri Lanka's democratic tradition", and that the constitutional amendment should not be feared, according to a statement from his office. All the same, he faces criticism for the postponement of local body election last year, and the indefinite delay in holding elections to the country's provincial councils, whose terms expired at least five years ago.

Meanwhile, leaders from his party and some supporters have called for a postponement of the election, contending that it could disrupt the Wickremesinghe administration's ongoing economic recovery programme. Further, two petitions filed at the Supreme Court, seeking a postponement of polls, were dismissed."What is the necessity to bring this Bill now?" asked Opposition legislator and senior lawyer M.A. Sumanthiran. In his view, it "only confuses the electorate and potentially complicates" the holding of the presidential election as mandated by the Constitution, at the end of a five-year term.

"Should the Bill be passed with a two-thirds majority, the Constitution empowers the President to decide on the date of a referendum. With an impending election, this could potentially complicate the process. It is absolutely unnecessary at this particular point in time to decide whether an extension beyond five years or six years requires a referendum, when that has no bearing on the term of the current President," he said Earlier this week. the 'Lawyers' Collective', with senior attorneys and prominent legal scholars as its members, emphasised that "there is no urgency whatsoever in lowering the upper limit of the terms of the President and Parliament," and denounced the Bill as "an attempt to manipulate the electoral process".

Russia convicts U.S. journalist Evan Gershkovich of spying in a trial widely seen as politically motivated

Wall Street Journal reporter Evan Gershkovich was convicted on July 19 of espionage and sentenced to 16 years in a maximum-security prison on charges that his employer and the U.S. government have rejected as fabricatedThe swift conclusion of the secretive trial in Russia's highly politicized legal system could potentially clear the way for a prisoner swap between Moscow and Washington.Gershkovich, his head shaved and looking thin in a dark T-shirt, was calm as he stood in a glass defendants' cage in the Sverdlovsk Regional Court. He listened impassively to the verdict but gave an occasional smile. When Judge Andrei Mineyev asked him if he had any questions about the verdict, he replied "No, your honor."After Mineyev read the verdict, someone in the courtroom shouted, "Evan, we love you!"

Closing arguments took place behind closed doors where Gershkovich did not admit any guilt, according to the court's press service. Prosecutors requested an 18year sentence, but the judge opted for a shorter term.U.S. President Joe Biden said after the conviction that Gershkovich "was targeted by the Russian government because he is a journalist and an American.""We are pushing hard for Evan's release and will continue to do so," he said in a statement. "As I have long said and as the U.N. also concluded, there is no question that Russia is wrongfully detaining Evan. Journalism is not a crime. Almar Latour, CEO of Dow Jones and publisher of The Wall Street Journal, and Editor in Chief Emma Tucker called it a "disgraceful, sham conviction.""Evan has spent 478 days in prison, wrongfully detained, away from his family and friends, prevented from reporting, all for doing his job as a journalist," they said in a statement. "We will continue to do everything possible to press for Evan's release and to support his family. Journalism is not a crime, and we will not rest until he's released. This must end now. Latour later told The Associated Press in an interview it was "deeply disconcerting" to see Gershkovich in a defendants' cage with a shaved head "and the more emaciated look," but he added: "We do believe that he's otherwise healthy."Commenting on the unusually swift trial, he said, "It just goes to show that in an autocracy and a regime like this, trials can move at any speed, with an invisible hand deciding that." It further underscores "the fake nature of these charges," he added.Gershkovich, 32, was arrested March 29, 2023, while on a reporting trip to the Ural Mountains city of Yekaterinburg. Authorities claimed, without offering any evidence, that he was gathering secret information for the U.S. He has been behind bars since his arrest, time that will be counted as part of his sentence. Most of that was in Moscow's notorious Lefortovo Prison - a czarist-era lockup used during Josef Stalin's purges, when executions were carried out in its basement. He was transferred to Yekaterinburg for the trial.Gershkovich was the first U.S. journalist arrested on espionage charges since Nicholas Daniloff in 1986, at the height of the Cold War. Foreign journalists in Russia were shocked by Gershkovich's arrest, even though the country has enacted increasingly repressive laws on freedom of speech after sending troops into Ukraine. Unlike the trial's opening June 26 in Yekaterinburg and previous hearings in Moscow where reporters could see Gershkovich briefly before proceedings began, there was no access to the courtroom Thursday when the trial resumed. Media were allowed in Friday for the verdict. Espionage and treason cases are typically shrouded in secrecy. Russian courts convict more than 99% of defendants, and prosecutors can appeal sentences that they regard as too lenient. The U.S. State Department has declared Gershkovich "wrongfully detained," committing it to assertively seek his release. Asked Friday about a possible prisoner swap involving Gershkovich, Kremlin spokesman Dmitry Peskov refused to comment. Foreign Minister Sergey Lavrov said Wednesday that Moscow and Washington's "special services" are discussing an exchange. Russia has previously signaled a possible swap, but said a verdict must come first. Even after a verdict, a deal could take months or years.U.S. officials offered to swap Gershkovich last year but it was rejected by Russia, and they have not made public any possible deals since then.

A rapidly growing chorus of Democratic lawmakers called on July 19 for President Joe Biden to drop his reelection bid, even as the President insisted he's ready to return to the campaign trail next week to counter what he called a "dark vision" laid out by Republican Donald Trump.As more Democratic members of Congress urged him to drop out - bringing the total since his disastrous debate against Trump to nearly three dozen - Mr. Biden remained isolated at his beach house in Delaware after being diagnosed with COVID-19. The president, who has insisted he can beat Trump, was huddling with family and relying on a few longtime aides as he resisted efforts to shove him aside.Late Friday, Ohio Sen. Sherrod Brown, a Democrat who is in a tough race for reelection, called for Mr. Biden to step aside.Brown said in a statement that he agrees with "the many Ohioans" who have reached out to him. "I think the president should end his campaign," he said. And in a statement later Friday, Rep. Morgan McGarvey, D-Ky., also called on Biden to drop out while saying, "there is no joy in the recognition he should not be our nominee in November. But the stakes of this election are too high."Mr, Biden said Trump's acceptance speech at the Republican National Convention showcased a "dark vision for the future." The President, seeking to move the political conversation away from his fate and onto his rival's agenda, said Friday he was planning to return to the campaign trail next week and insisted he has a path to victory over Trump, despite the worries of some of his party's most eminent members."Together, as a party and as a country, we can and will defeat him at the ballot box," Biden said. "The stakes are high, and the choice is clear. Together, we will win."Earlier in the day, his campaign chair, Jen O'Malley Dillion, acknowledged "slippage" in support for the president but insisted he's "absolutely" remaining in the race and the campaign sees "multiple paths" to beating Trump."We have a lot of work to do to reassure the American people that, yes, he's old, but he can win," she told MSNBC's "Morning Joe" show. She said voters concerned about Biden's fitness to lead aren't switching to vote for Trump.

Meanwhile, the Democratic National Committee's rulemaking arm held a meeting Friday, pressing ahead with plans for a virtual roll call before Aug. 7 to nominate the presidential pick, ahead of the party's convention later in the month in Chicago."President Biden deserves the respect to have important family conversations with members of the caucus and colleagues in the House and Senate and Democratic leadership and not be battling leaks and press statements," Sen. Chris Coons of Delaware. Biden's closest friend in Congress and his campaign cochair, told The Associated Press.

It's a pivotal few days for the President and his party: Trump has wrapped up an enthusiastic Republican National Convention in Milwaukee on Thursday. And Democrats, racing time, are considering the extraordinary possibility of Biden stepping aside for a new presidential nominee before their own convention. Among the democrats expressing worries to allies about Biden's chances were former President Barack Obama and Speaker Emerita Nancy Pelosi, who has privately told Biden the

Senate Democrat to do so."By passing the torch, he would secure his legacy as one of our nation's greatest leaders and allow us to unite behind a candidate who can best defeat Donald Trump and safeguard the future of our democracy," said Heinrich, who's up for reelection.And Reps. Mr. Biden has been told the campaign is having trouble raising money, and key Democrats see an opportunity as he is away from the campaign for a few days to encourage his exit. Among his Cabinet, some are resigned to the likelihood of him losing in November. "It's clear the issue won't go away," said Vermont Sen. Peter Welch, the other Senate Democrat who has publicly said Biden should exit the race. Welch said the current state of party angst - with lawmakers panicking and donors revolting - was "not sustainable." However, influential Democrats including Senate Majority Leader Chuck Schumer and House Democratic Leader Hakeem Jeffries are sending signals of concern."There is of course work to be done, and that in fact is the case because we are an evenly divided country," Jeffries said in an interview on WNYC radio Friday.But he also said, "The ticket that exists right now is the ticket that we can win on. ... He usually spent the rest of his time reading books in English and Russian and writing letters to friends and family. He relied on his sense of humor to get through the days, according to those close to him.As he marked his second year in captivity in March, Milman said he was "telling people not to freak out," but she admitted the strain for friends and family was "taking a toll.

Israeli occupation of Palestinian territory 'illegal': U.N. top court

The U.N.'s top court on July 19 said Israel's decadeslong occupation of Palestinian territory was "illegal" and needed to end as soon as possible. The advisory opinion of The Hague-based International Court of Justice is not binding, but it comes amid mounting concern over Israel's war against Hamas sparked by the group's brutal October 7 attacks."The court has found that Israel's continued presence in the Palestinian Territories is illegal," ICJ presiding judge Nawaf Salam said, adding: "Israel must end the occupation as rapidly as possible."The ICJ added that Israel was "under an obligation to cease immediately all new settlement activities and to evacuate all settlers" from occupied land.Israel's policies and practices including the building of new settlements and Israel's continued maintainance of a wall between the territories "amount to annexation of large parts" of the occupied territory, it said.Netanyahu slams ruling as a 'decision of lies'Israeli Prime Minister Benjamin Netanyahu said the court had made a "decision of lies"."The Jewish people are not occupiers in their own land - not in our eternal capital Jerusalem, nor in our ancestral heritage of Judea and Samaria (the occupied West Bank)," Mr. Netanyahu said in a statement.

"No decision of lies in The Hague will distort this historical truth, and similarly, the legality of Israeli settlements in all parts of our homeland cannot be disputed."A separate, high-profile case that South Africa has brought before the court alleges that Israel has committed genocidal acts during its Gaza offensive. 'Extreme danger'The U.N's General Assembly asked the ICJ in late 2022 to give an "advisory opinion" on the "legal consequences arising from the policies and practices of Israel in the Occupied Palestinian Territory, including East Jerusalem". The ICJ held a week-long session in February to hear submissions from countries following the request - supported by most countries within the Assembly.During the hearings, most speakers called on Israel to end its 57-year occupation. They warned a prolonged occupation posed an "extreme danger" to stability in the Middle East and beyond.But the United States said Israel should not be legally obliged to withdraw without taking its "very real security needs" into account. Israel did not take part in the oral hearings.Instead, it submitted a written contribution in which it described the questions the court had been asked as "prejudicial" and "tendentious".'Ongoing violation'

The General Assembly asked the ICJ to consider



two questions.Firstly, the court should examine the legal consequences of what the U.N. called "the ongoing violation by Israel of the right of the Palestinian people to self-determination". This relates to the "prolonged occupation, settlement and annexation of the Palestinian territory occupied since 1967" and "measures aimed at altering the demographic composition, character and status of the Holy City of Jerusalem".

In June 1967, Israel crushed some of its Arab neighbours in a six-day war, seizing the West Bank including east Jerusalem from Jordan, the Golan Heights from Syria, and the Gaza Strip and Sinai Peninsula from Egypt.Israel then began to settle the 70,000 sq. km of seized Arab territory. The U.N. later declared the occupation of Palestinian territory illegal, and Cairo regained Sinai under its 1979 peace deal with Israel.Non-binding opinionThe ICJ was also asked to look into the consequences of what it described as Israel's "adoption of related discriminatory legislation and measures". Secondly, the ICJ was asked to advise on how Israel's actions "affect the legal status of the occupation" and what are the consequences for the U.N. and other countries. The ICJ rules in disputes between states. Normally, its judgements are binding but it has few means to enforce them. In this case however, the opinion is non-binding, although most advisory opinions are in fact acted upon. The ICJ has previously issued advisory opinions on the legality of Kosovo's 2008 declaration of independence from Serbia and apartheid South Africa's occupation of Namibia. It also handed down an opinion in 2004 declaring that parts of the wall erected by Israel in the occupied Palestinian territory were illegal and should be torn down.Israel has not complied with the ICJ ruling, and has resisted calls to route the barrier along the Green Line, the 1949 Armistice Line established after the end of fighting that accompanied Israel's establishment a year earlier

Airport systems working normally, says Aviation Ministry, day after Windows outage hit flights



airlinesThe impact of the outage was most pronounced in the aviation sector, with hundreds of flights delayed and several cancelled as airline operators found their systems inoperative and had to switch to manual processes. After the Microsoft outage severely impacted flight operations across the country, airline systems across airports in India resumed operations normally from 3 am Saturday, the civil aviation ministry said.

The official statement, posted by Civil Aviation Minister Ram Mohan Naidu Kinjarapu on X, also travel adjustments and refund processes are being taken care of. "Since 3 am, Airline systems across airports have started working normally. Flight operations are going smoothly now. There is a backlog because of disruptions yesterday, and it is getting cleared gradually. By noon today, we expect all issues to be resolved," the statement read.

The impact of the outage of Microsoft 365 and Azure services was most pronounced in the aviation sector. Hundreds of flights including those by Indigo, Air India, SpiceJet and Akasa Air were delayed and several cancelled as airline operators found their systems inoperative and had to switch to manual processes. At the Delhi Airport for instance, more than 400 flights faced delays and over 50 were cancelled, as per data compiled by flightradar24.

The global technical downtime seemed to partly emanate from a faulty software update issued by major US cybersecurity firm CrowdStrike. Major corporations across the world use software developed by CrowdStrike, which is why all their systems faced the outage at the same time.Cloud-based services keep flights on time and our airports running smoothly. So when these services went down, it was as if someone pulled the plug on their operations.

What different airlines said on the disruptions?

India's largest airliner Indigo said that its systems "across the network" were impacted by the issue with Microsoft Azure, "which has resulted in increased wait times at our contact centres and airports". In a statement on Friday, it said: "You may experience slower check-ins and longer queues... Our digital team is also coordinating closely with Microsoft Azure to resolve these issues swiftly."In a post on social media platform X, the airliner said that its online services like booking, check-in and manage booking services will be temporarily unavailable."Digital infrastructure issues have temporarily impacted online and airport operations across multiple airlines and airports globally. Please plan your travel and keep sufficient time in hand for airport procedures. We regret the inconvenience and appreciate your patience and understanding during this time," it said on X."We're currently facing a technical issue in providing updates on flight disruptions. Our team is actively working to resolve this issue. We regret any inconvenience caused and will update you once the issue is resolved. Thank you for your patience and cooperation," Spicejet said.

Not thinking of giving banking license to business houses at present: RBI Governor Shaktikanta Das

Reserve Bank of India Governor Shaktikanta Das on Friday spoke on host of issues related to relationship between central bank and the government, giving banking license to business houses, interest rates, action on regulated entities due to non compliance of norms and rise in rural consumption. In an interaction with Shyamal Majumdar, Editor, Financial Express, the Governor said the RBI is currently not contemplating giving banking license to corporate houses.

" Experience world over has shown that when real sector companies enter into the banking space, there are potential conflicts of interest. The problem around relatedparty transactions is also a major issue," Das said when asked if the RBI will shed its hesitations over allowing business houses, private equity and venture capital funds to have larger stakes in banking entities.

It will be very difficult to monitor or to regulate or prevent the related-party transactions and so, the risks involved are very high, he added.Related-party transaction refers to any transaction, or relationship, in which the company or any of its subsidiaries is or will be a participant, and any related party has or will have a direct or indirect interest. When asked if RBI, at present, was ruling out entry of corporate houses into the banking sector, Das said, "at this point, there is no thinking in that direction."He said the banking penetration in India has been quite wide. Today, the number of bank branches have become less relevant because the reach is being achieved through technology."Therefore, what India needs is not proliferation in the number of banks. What India needs is sound, healthy and well governed banks which, we feel, will be able to mobilise savings and meet credit requirements throughout the country through technology," Das said. The Governor, however, said that the RBI was open to receiving new applications for setting up universal banks. As and when an appropriate fit and proper application comes, the RBI will not hesitate in examining it, he said.When asked to respond to former RBI Governor D Subbarao' statement, in his recent book, that there was a demand that RBI should be a cheerleader for the government, Das said, "At least I am saying from my experience that nobody expects the RBI to be a cheerleader."He said he has never experienced any such demand in his ten-



ure as the RBI Governor.Das said the coordination between the RBI and the government during the crisis like the COVID was very smooth, which ensured that the country's economy revived very fast and stronger from the pandemic.

He said differences in opinion between the RBI and the government are bound to happen but those are resolved amicably. When asked about the view that higher interest rates can affect growth, the Governor said the RBI's mandate is to maintain price stability, keeping in mind the objective of growth. "Even with the current interest rates, the growth in India has been very robust. In the last three years, the average growth rate has been 8.3 per cent. This year (FY2025), our projection is 7.2 per cent, and we are very optimistic that it will be achieved,"

RIL profit declines 5.45% in June quarter on weak oil-to-chemicals business, higher depreciation

Reliance Industries Ltd (RIL) has posted a 5.45 per cent fall in the net profit at Rs 15,138 crore during the quarter ended June 2024 as against Rs 16,011 crore during the same period a year ago following weak O2C business and higher depreciation. On a sequential basis, net profit declined by 20.12 per cent from Rs 18,951 crore in the March 2024 quarter.Total income of RIL rose by 11.90 per cent to Rs 240,200 crore during June 2024 quarter from Rs 214,644 crore a year ago.

The company's oil-to-chemicals (O2C) EBITDA was lower by 14.3 per cent on account of lower gasoline cracks (-30 per cent) and lower downstream chemical deltas, particularly PE (-17 per cent), PP (-16 per cent) and integrated polyester margin (-15 per cent). Depreciation increased by 15.5 per cent to Rs 13,596 crore (\$ 1.6 billion) on expanded asset base across all the businesses, higher network utilization in digital services business, higher retail store count and ramp-up in upstream production.

RIL's digital arm Reliance Jio Platform made a 11.7 per cent rise in net profit at Rs 5,698 crore during June 2024 as against Rs 5,101 crore a year ago and a 12.8 per cent increase in revenue of Rs 34,548 crore (Rs 30,640 crore).Reliance Retail Ventures Ltd reported a 4.6 per cent rise in net profit at Rs 2,549 crore in the latest quarter as against Rs 2,436 crore last year. Gross revenue increased by 8.1 per cent to Rs 75,615 crore from Rs 69,948 crore.Reliance Jio Infocomm has posted a net profit of Rs 5,445 crore for the June quarter as against Rs 4,863 crore a year ago, showing a rise of 11.96 per cent. Revenue rose by 10.13 per cent to Rs 26,478 crore for Q1 from Rs 24,042 in the same period a year ago.

RIL Chairman and MD Mukesh D. Ambani said: "Consolidated EBITDA for the quarter improved from a year ago with strong contribution from consumer and upstream businesses offsetting weak O2C operating environment. 'Business class ticket, five-star room': Bollywood makeup artist Shaan Mu lists his demands

.Makeup artist Shaan Mutthathil, who has worked in Bollywood for several years, spoke about how much money he makes amid controversy around escalating entourage costs in the film industry. He said that he has worked hard to get to where he is, and that he asks for the money that his experience and reputation command. He also addressed complaints made by filmmaker Anurag Kashyap, and admitted that he earns more on movies than even first assistant directors and managers.

Appearing on the Phitte Muh with Sik & Jaz podcast, he said that his contract spells out exactly what he expects in addition of his regular payment. "If your art is good, you can ask exactly like everyone else. For me right now, it's in my contract that if a bride takes me, (I would need) one business class ticket, two economy class tickets, one five-star hotel room that is closest to the bride. It's a rule. Of course, they do say, 'Even assistants are so expensive?' If the assistant stays somewhere else, he needs to have a car that he can take anytime to come with my kit. I'm very particular when I do a bride right now, I say one business class, two economy, a good hotel for (my assistants), but for me, the closest five-star hotel. They can put you anywhere they want," he said. He continued, "For shoots, it's hours. When you're young, you can do 14 hours or 15 hours. Bollywood shoot or any other shoot, it doesn't finish (on time). So, I'm very clear, I'll give halfan-hour extra, but after that it's one-and-a-half day shift. Whatever you have paid me I need half amount more, and the actresses I work with know me, and they back me up. I give 12 hours plus half-an-hour, but after that, the



people who are making us shoot are making money..."He said that even he would like stars to be on his chair for an hour extra, but he doesn't make such demands. "Let's be clear, nobody is doing seva here," he said, adding that he doesn't see a cut of the profits when a film does well at the box office, which is why he asks what he does upfront. But you have to be prepared to be replaced.Shaan said that someone in his position can ask for upwards of Rs 1 lakh per day on a shoot, and defended his right to do so, even as others working on a film remain under-paid in comparison.

Football – the world's most popular sport, but plagued by indecision and lack of identity at the Games

The grandest sporting exhibition in Paris, the Olympics, would unfold without the country's most famous sportsperson, Kylian Mbappe. The French superstar footballer had, in the past, expressed his desire to compete in the event and win the "holy grail", but his transfer to Real Madrid, which prohibits those that had competed in the Euros and COPA America from participating in the Olympics, meant he would miss out. Unlike continental events and the World Cup, clubs have the power to decide a player's participation in the Olympics.Some French politicians, rumours swirled, negotiated an exemption with the Spanish football giants, but Madrid did not relent. So when the Olympic torch is lit and the contingents parade in boats along the River Seine, past the city's historic landmarks, Mbappe would be in Madrid, soaking in the fanfare and tuning up for the pre-season that begins on August 1.

(AP Photo/Antonio Calanni)Not only Mbappe, most of France's rich pool of footballing talent would be absent from the Games and wouldn't be even in their country. So much so that France's Olympic football team coach Thierry Henry would say: "The last time I received so many rejections was at university."France is not an aberration, the powerhouses among the 16 nations would be without their stars -Nico Williams and Lamine Yamal are not in the Spain squad; Argentina is minus Messi and a host of COPA America winners; Mohammed Salah, the anointed flagbearer of Egypt in Paris, has chosen Liverpool over his country in a last-minute u-turn, Christian Pulisic wouldn't feature for the USA either. Some of the storied football nations, such as Uruguay, Italy, the Netherlands and England, have historically detached themselves from the Olympics. Both Asian and African champions, Qatar and Ivory Coast, did not qualify through the continental U-23 championships. Instead, on show in Paris, would be a clutch of minnows such as Mali, Uzbekistan and Dominican Republic. At the heart of this indifference is football's identity crisis, specifically in the men's stream, at the Olympics. No one really knows what it is, whether it is an exhibition of superstardom, or a youth development vehicle, or even an accidental parody. It is a paradox — it's not a fully amateur competition as it once was; it is not a professional grandee like the World Cup or the Euros either. It's meant for U-23s - though the best in the group are already established and occupied in pre-season rigours but all teams could field three older than 23. It starts before the opening ceremony and ends after most big events have concluded; it is among the most featured disciplines in the event, yet a gold medal is not considered the pinnacle. Lots of goals are scored, but there is hardly any recall value. The Olympics adds little to football, just as football, in its current iteration, adds little to the Olympics. Thus, football at the Olympics is a mix of everything, and like all things without a sharp, pinpoint focus, it is complex and confused. The great minds that have shaped and influenced the Olympics have not yet discovered the formula to package football so that it could embellish the spectacle, lighten each other's existence, rather than exist as a half-baked counterfeit, wandering in a state of purposelessness. The sport has been a regular fixture since 1896, even though it was a club affair in the initial edition. Post the first World War, it was briefly the most coveted medal in football, as no other major international tournament existed yet. British broadcaster David Goldblatt called Uruguay's defeat of Argentina in the final of the 1928 Olympics, "football's first world championship".But two years later, Uruguay would host the first World Cup and change the history of the sport and its relationship with the Olympics. The sport was absent from the Los Angeles Games of 1932. FIFA feared the Olympics would take lustre off the nascent World Cup tournament; American organisers contested the "amateurism" of football, now that a fully professional football tournament has been held. Besides, stories go, that they were fearful of the sport taking root in the country and displace established ones like baseball and American football

German organisers successfully lobbied for it to be reinstated for the Berlin Games, although the teams had to meet the definition of amateurism. It took another Los Angeles sojourn, in 1984 to tweak the rules again. Teams could now field professional players, but teams from Europe and Americas should not have competed in the World Cup or continent tournaments.

Eight years on, it was reformed into an U-23 format, though at the next edition, three players over 23 were allowed.Football at the Olympics, thus, feels like a forced coexistence, showing both in poor light. Perhaps, football and Olympics in this era are not made for each other, perhaps both need a mutually beneficial divorce. Or maybe a functional solution could be worked out — like making it a wholly U-21 or U-19 event, or revamping the qualification route, or breathing some context into it, rather than packing an already packed calendar and letting football unfold as a farce — to liberate it from its state of purposelessness.

Gambhir would later play the last two Tests of his career under Kohli's captaincy in 2016. The first clash between Kohli and Gambhir came in an IPL 2013 match in Bengaluru. Gambhir and Kohli exchanged words after the RCB skipper was dismissed for 35 in a chase. Kohli, walking back to the dugout, returned briefly to have a heated argument with his counterpart, before other KKR players intervened to douse the fire.

Between 2016 and 2020, Gambhir post-retirement, had made several remarks lambasting Kohli's leadership during his captaincy tenure with the Indian team. Gambhir even labelled Kohli "not a shrewed captain", stating that he was "lucky" to be retained as RCB captain for long.In a nail-biting finish in Bengaluru, Lucknow Super Giants pipped RCB by one wicket. The decision was made considering the test workload coming up soon after," he said. "We should have clarified that after selection that 'No he [Jadeja] has not been dropped'. India New Head Coach Press Conference Highlights: Newly appointed India cricket team head coach Gautam Gambhir addressed his first press conference in Mumbai since taking over the role earlier this month. This, ahead of his first assignment with the national team – the upcoming tour of Sri Lanka that will see India play three T20Is and as many ODIs.On agenda at the press conference, were questions about the recent leadership change in the dressing room with Suryakumar Yadav having been named as the T20I captain and Hardik Pandya, who was Rohit Sharma's deputy in the T20 World Cup win, snubbed from the role. Gambhir also spoke about what the future holds for Rohit and Virat Kohli, the two seniors who retired from the shortest format after the World Cup win.

Gambhir took over the role from Rahul Dravid, who was the head coach of the team since November 2021 and signed off after India's triumph at the 2024 T20 World Cup in June. Gambhir's arrival in the dressing room comes ahead of a packed international schedule.
