CM Revanth Reddy invites US firms to invest in 'future State' of Telangana

Hyderabad: With game-changing projects such as the AI city, Net Zero Future City, and the massive reimagining of Hyderabad, Telangana will deserve the sobriguet of 'The Future State,' said Chief Minister A Revanth Reddy.He was addressing the CEOs of tech unicorns at an AI business roundtable hosted by the Indian Consulate General at Palo Alto in California. According to a statement from the Chief Minister's Office, he mentioned how every State in the US has a motto."In America, every State has a motto. So far, I have been to New York, New Jersey, Washington DC, Texas, and now we are here in California. New York State motto - Out Of Many, One. Texas is known as Lone Star State. California has the motto: Eureka. In India, we don't have a motto for a State. But I will now like to give my State - Telangana - a motto. My State Telangana can be called - The Future State," the statement quoted him as saying.

"I invite you to Telangana. I invite you to the future. Together, let us make the future," he declared. Industry and IT Minister D Sridhar Babu presented the key highlights of the policies of Telangana and the inherent strengths that make it attractive for global and tech investors.Most of the leading CEO and founders of Artificial Intelligence unicorns expressed the desire to visit Hyderabad and explore options to invest and build capacities there in the near future. Earlier, at Dallas, IT Serve Alliance meet, CM Revanth Reddy and IT Minister Sridhar Babu pitched Hyderabad strongly for Indian diaspora investments

with repeated obstructions and disruptions.Leader of the house JP Nadda later proposed a resolution condemning the opposition after leaders of the ruling NDA questioned the conduct of the Congress with former prime minister HD Deve Gowda accusing "two Congress members of provoking others when Mallikarjun Kharge appeared to have reconciled to the issue of Tiwari following Dhankhar's move to strike a truce between the two earlier today". Deve Gowda of the JD (S) slammed the opposition for "ignoring the appeals of the chair" and with folded hands urged Dhankhar to continue the house proceedings and let the opposition walk out if they must."Nothing can prevent the Modi government from completing five years," Gowda said.NDA leaders -- Sanjay Jha of the JDU and Jayant Chaudhry of RLP condemned Jaya Bachchan for "making light of the institution of the presiding officer". Jha went to the extent of accusing Congress parliamentary party leader Sonia Gandhi of instigating the opposition to create ruckus."Please don't be soft, use a baton," Jha urged Dhankhar, who earlier cited the imposition of Emergency by late Congress veteran Indira Gandhi to draw parallels to today's opposition and the Congress of emergency era times. The resolution Nadda proposed read: "This house unanimously condemns the events of the day."Dhankhar earlier in veiled references to Congress leader Salman Khurshid asked how an ex foreign minister could say things like "what has happened in a neighbouring country (Bangladesh) could happen in India."It has become a pattern. Some leaders on their side make objectionable comments. They suspend the leader and then take him back," added Dhankhar in reference to Sam Pitroda who had spoken of wealth redistribution on Lok Sabha poll eve stepping down as overseas Congress chief after uproar only to be brought back post polls. The Raiva Sabha chairman said attacks on the chair are a reflection that the opposition could not digest the BJP government for a third term. The events of the day led to adjournment of the Rajya Sabha at 1 pm until 2 pm and then again from 2 pm to 2.30 pm.

The police advised the people to use the following alternate routes to reach their destination. Route 1: From Bio-Diversity Junction to IIIT Junction, bypass the flyover and travel beside it via Bichareddy sweets (Telecom Nagar) to Gachibowli Junction, then to IIIT Junction.

Inspired by Quit India, PM Modi wants country to get rid of dynasty politics

New Delhi: Prime Minister Narendra Modi on Friday said inspired by the Quit India movement, the country wants to get rid of all evils - corruption, dynasty politics and appeasement. While paying homage to participants of the Quit India movement, Prime Minister shared a video on social media platform X in which he spoke about the movement and how it gained steam. The Prime Minister said in Hindi, "Our new generation should know what happened on August 9, 1942. Mahatma Gandhi had given the mantra, and Quit India movement provided a fresh impetus to the country's fight for freedom.""This movement united the country to get rid of the British rule. It was the time, when all strata of society (poor, rich, urban and rural people) participated in the Bharat Chodo Andolan," he said. "Lakhs of youths left education, books. If we go into the pages of history, then we will know that the country's first freedom struggle started in 1857. From 1857 to 1942, this movement reached its crescendo, and in five years, in 1947, Britishers were forced to leave the country," he added. The Prime Minister said, "Inspired by the movement, the country wants to get rid of all the evils. Only one thing is reverberating in the country Corruption Quit India, Dynasty Quit



India, Appeasement quit India."Quit India Movement or Bharat Chodo Andolan, launched in Bombay, was a turning point in the country's freedom struggle. In a speech, Mahatma Gandhi said, "Here is a mantra, a short one that I give you. You may imprint it on your hearts and let every breath of yours give expression to it. The mantra is: 'do or die'. We shall either free India or die in the attempt; we shall not live to see the perpetuation of our slavery.

SC grants bail to Manish Sisodia, to walk out of jail after 17 months



cise policy scam, noting that he has been in custody for 17 months.A Bench of justices BR Gavai and KV Viswanathan said Sisodia has been in custody for 17 months and trial has not yet commenced, depriving him of the right to speedy trial. The Bench said it would be a travesty of justice to relegate him to the trial court for seeking bail in these cases. The top court said it is high time that the trial courts and High Courts recognise that the principle of bail is a rule and jail is an exception.

It directed that Sisodia be released on bail on a personal bond of Rs 10 lakh with two sureties of the like amount. The former deputy Chief Minister of Delhi was arrested by the Central Bureau of Investigation (CBI) on February 26, 2023 for the purported irregularities in the formulation and implementation of the now-scrapped Delhi excise policy 2021-22. The Enforcement Directorate (ED) arrested him in the money laundering case stemming from the CBI FIR on March 9, 2023. He resigned from the Delhi cabinet on February 28, 2023. Sisodia had sought bail contending that he has been in custody for 17 months and the trial against him has not yet started. The ED and the CBI had opposed his bail pleas.

A BJP member's alleged objectionable remarks about leader of opposition Mallikarjun Kharge on Friday plunged the House of Elders into chaos with the opposition walking out, the chairman issuing an "enough is enough, this virus will destroy democracy" warning and the government proposing a resolution by the house to condemn the "undignified and indecorous conduct of the opposition". It all started with Kharge rising in zero hour to flag unsavoury remarks made against him by BJP's Ghanshyam Tiwari and Congress demanding an apology -- something Dhankhar turned down saying Tiwari had actually praised Kharge in Sanskrit.

"Apologise for what," asked the chairman when Congress leaders sought an apology from Tiwari. At this point, SP's Jaya Bachchan got up and said she understands gestures and body language."You may be sitting there but we are all colleagues," she said to Dhankhar who took strong exception to her remarks and castigated the opposition for "repeated attempts to destabilise the country and Parliament". At this point, the opposition walked out with Dhankhar slamming the move and later saying "enough is enough, they want to put democracy in peril."Dhankhar also opened the floor for other leaders to speak and said he needed counsel of the house to deal

Centre sets up BIS department to ensure quality in Ayush sector

New Delhi: The Centre on Friday informed that the Bureau of Indian Standards (BIS) has set up a new department to bring standardisation to the growing Ayush sector. The new department focuses on promoting safety, efficacy and quality of Ayush products and practices, encompassing traditional Indian systems of medicine such as ayurveda, yoga, naturopathy, unani, siddha, sowarigpa and homoeopathy, said the Ministry of Consumer Affairs. According to Pramod Kumar Tiwari, Director General, BIS, the Ayush department at BIS has formed seven sectional committees, each addressing a specific Ayush system."These committees work collaboratively with various stakeholders, including experts, scientific and technical institutions, industry representatives, and regulatory bodies, to ensure comprehensive, evidence-based standards aligned with national and international guidelines," Tiwari noted.BIS has published 91 standards covering diverse subjects like single herbs, ayurveda and yoga terminology, Panchakarma equipment, yoga accessories, and test methods for pesticide residues in herbs. The bureau said that the publication of 80 indig-

enous Indian standards for herbs used in traditional medicine promotes their safe and effective use, benefiting both consumers and the industry.Additionally, the first-ever national standards for Panchakarma equipment ensure uniformity in prophylactic and therapeutic procedures, enhancing the quality of Ayush healthcare practices.BIS has also formulated an indigenous Indian standard for the "Cotton Yoga Mat," supporting domestic manufacturers and farmers.

The department also identified future standardisation areas, including terminology, single herbs, yoga attire, Siddha diagnostics, and homoeopathic preparations.As more people turn to traditional healthcare systems, the need for consistent quality, safety, and efficacy in Ayush products and services is imperative."BIS has reflected its commitment in this area by establishing this dedicated department and developing critical standards, such as 'Cotton Yoga Mat'. These are critical milestones in promoting and developing traditional Indian medicine," said Vaidya Rajesh Kotecha, Secretary, Ayush, adding that BIS is committed to enhancing the acceptance and growth of Ayush systems nationally and internationally.

BRS blames Telangana CM for collapse of Sunkishala project's retaining wall

Hyderabad: Bharat Rashtra Samithi (BRS) working president K. T. Rama Rao on Friday blamed Chief Minister A. Revanth Reddy for collapse of retaining wall of the under-construction intake well and pump house complex at Sunkishala project at Nagarjuna Sagar. Rama Rao said that as the Chief Minister holds the portfolio of municipal administration, he should own the responsibility for this incident.He told media persons that Revanth Reddy's "incompetence" resulted in the collapse of the retaining wall.

The former minister for municipal administration wanted to know if there was no lapse on part of the government, why it kept the incident a secret for a week. The Sunkishala intake well project was stated by the earlier BRS government to be a significant component of the Krishna Drinking Water Supply Project (KDWSP) to supply water to Greater Hyderabad until 2050.KTR, as the BRS leader is popularly known, said the incident occurred on August 2 when the Assembly was in session. The government should have made a statement in the Assembly."Had the government no knowledge of the incident or was it deliberately ignored? If the government was not aware of it, then it is shameful," he said.

He claimed officials as saying that the haphazard manner in which the work was undertaken led to the incident.Fortunately, the incident occurred when there was a change in the shift of workers. Otherwise, this could have resulted in major loss of lives, he said. The BRS leader demanded a judicial probe into the collapse of the retaining wall. He said Deputy Chief Minister Mallu Bhatti Vikramarka should announce this from the site where this incident happened.Stating that there was no engineering defect in Sunkishala project, he said the defect was in the government's approach.KTR said when this incident happened Chief Minister was in Hyderabad and he left for the United States without holding a review meeting on it."If you are sincere, blacklist the contracting agency and take action against those responsible," he said.KTR mentioned that the previous BRS government launched the project to meet the drinking water needs of Hyderabad for the next 50 years. The project was designed to lift water from Nagarjuna Sagar at the dead storage level (462 feet)

He claimed that Sunkishala works were completed



expeditiously and only motor fitting works were remaining."We had fixed the target of completing the project by 2024 summer but this government kept the works pending." he said.

Property tax relief

THE government's decision to restore the indexation benefit for long-term capital gains (LTCG) on property sales marks a pragmatic reversal in response to public backlash.

The Union Budget's proposal to eliminate the indexation benefit while reducing the LTCG tax rate to 12.5 per cent aimed to simplify the tax regime. However, it failed to account for the nuanced financial impacts on property owners, especially those with longneld assets. Indexation adjusts the purchase price of an asset to account for inflation, ensuring taxpayers are not disproportionately taxed on nominal gains. Without t, taxpayers could face substantial tax burdens, misepresenting the real value of their gains.

The government's revised stance offers a choice: bay 20 per cent LTCG tax with the indexation benefit or 12.5 per cent without it, applicable to properties acquired before July 23, 2024. This flexibility not only addresses mmediate financial concerns but also reflects a more houghtful approach to tax policy, acknowledging the liverse economic realities faced by people. However, properties purchased after this cut-off date will only be eligible for the 12.5 per cent rate without indexation. There are fears that the new regime might increase secondary market sales as investors may not retain their properties for too long.

Ultimately, this rollback underscores the imporance of nuanced policy-making that considers both economic principles and public sentiment. The restored ndexation benefit is a welcome relief for many, reafirming the government's ability to adapt and refine its iscal policies in the face of legitimate public concerns.

In a first in Pimpri-Chinchwad, mother, 2 sons slapped with stringent MCOCA in murder case

In a first in Pimpri-Chinchwad, a 42-year-old woman and her two sons were recently slapped with the stringent Maharashtra Control of Organised Crime Act (MCOCA).The woman, Lata Rokde, who was sent to judicial custody by a local court on Tuesday had allegedly helped her two sons, both history-sheeters, flee to Uttar Pradesh after committing a murder in June last year.

The Rokdes became the third family in six years to face the stringent Act in the jurisdiction of the Pimpri-Chinchwad police and the first one which involves a mother and two of her sons, officials said.

"We arrested her on August 1. She was sent to police custody by a court. Her police custody ended today. The court has now remanded her to judicial custody,' Assistant Commissioner of Police Devidas Ghevare told .Ghevare said in 2023, the Rokde brothers - Karan and Mungya - allegedly murdered a man, Sonya Tapkir, in Chikhli area after which their mother helped them flee to Mathura in Uttar Pradesh in an Innova that was registered in her name. "The second-hand Innova was bought by the woman after the crime," he said, adding that the men later abandoned the car in Mathura and fled ACP Ghevare said the woman then went to Mathura and took the vehicle to her 'rakhi' brother's house in Akola, Maharashtra. The police had arrested the two brothers, who collectively have 20 criminal cases against them, in July 2023 from Mathura."The woman, though had no criminal case against her, had been long supporting her sons in their unlawful activities. All the three are part of a gang. Therefore the application of MCOCA was appropriate," he said.Lata had eluded the police for more than a year and had also sought anticipatory bail from Bombay High Court which rejected it,' he said. According to Pimpri-Chinchwad police, Lata Rokde is the eighth woman to be slapped with MCOCA by the Pimpri-Chinchwad Police Commissionerate since its launch in 2018. In all, 941 accused have been slapped with MCOCA, of which 933 are males and eight are females."Earlier, last year, three brothers were slapped with MCOCA in a murder case in Chinchwad. In 2018, a man, his son and son's wife were slapped with MCOCA for deceiving people by promising them gold after digging mud," the police said.

Karnataka not likely to take up Centre's offer of rice at Rs 28 per kg to implement Anna Bhagya welfare scheme


The Congress government in Karnataka is unlikely to accept a new offer from the Centre to supply rice at a cost of Rs 28 per kg for the implementation of the Anna Bhagya welfare scheme, according to Food and Civil Supplies Minister K H Muniyappa.Muniyappa indicated on Tuesday that the Centre's August 1 decision to allow states with welfare schemes to directly purchase rice from the Food Corporation of India (FCI) under the Open Market Sale Scheme (OMSS-domestic) for Rs 28 per kg carried uncertainty since supplies would be available only until buffer stocks lasted."How long will they supply the rice? They will provide rice only as long as the buffer stocks last, and after that, they will stop supplying rice," Muniyappa said, referring to the new proposal. The Congress in Karnataka had made an election promise in 2023 to supply 5 kg of free rice to people living below the poverty line but could not implement the promise due to the non-availability of rice supplies from the Centre. The Congress's promise of 5 kg rice was in addition to the 5 kg of rice provided by the Centre under the Pradhan Mantri Garib Kalyan Anna Yojana (PMGKAY).

After coming to power, Congress was compelled to offer Rs 170 per month in cash transfers to each member of a below-poverty-line (BPL) family instead of providing 5 kilograms of free rice. This decision was made due to the shortage of rice supplies from the FCI as a result of restrictions on states from purchasing rice under the OMSS. However, many families still consider the free rice scheme to be more advantageous than cash transfers."Union minister Pralhad Joshi has come up with a new scheme, he is saying the Centre is willing to provide rice for Rs 28 per kg. The chief minister and deputy chief minister had earlier promised to provide 10 kg of rice in Karnataka. We requested the Centre to provide rice supplies," the Karnataka minister said at a Congress rally Tuesday."The then Union minister did not provide rice even though there were stocks. This was done for politics. With a loss of Rs 12 to Rs 14 for a kg of rice to the national exchequer, they have now come forward to provide rice to the states," Muniyappa said."When we asked for rice they did not provide it. Now they are willing to provide rice at a loss of several crores of rupees. However, they are paying the farmer Rs 40 per kg," he said.In June 2023, the Ministry of Consumer Affairs, Food and Public Distribution decided to exclude state governments from the ambit of the OMSS (domestic) "to maintain sufficient stocks for market intervention/control prices of wheat and rice through OMSS(D)". The Centre's order to prevent states from buying rice stocks from the FCI to control inflation came a day after an FCI official communicated in two separate letters on June 12 that the FCI was willing to supply 2.08 lakh metric tonnes and 13,819 metric tonnes of rice to Karnataka. The move by the Centre to prevent Karnataka access to the FCI stocks for its populist scheme of providing five kg of rice to every member of BPL families - in addition to 5 kg being supplied by the Centre resulted in the Congress government in Karnataka crying foul.

"The central government is trying to scuttle a scheme that provides rice to the poor people. They should not have politicized this. Despite the availability of stock, they (FCI) are refusing to supply," Karnataka Chief Minister Siddaramaiah said after the order of June 13, 2023.The Karnataka government outlined a requirement of 2.28 lakh metric tonnes of rice per annum for its own 5 kg free rice scheme. This is in addition to the 2.17 lakh metric tonnes of rice provided per year under the National Food Security Act, 2013, or the PMGKAY.

The Karnataka scheme had outlined a total of 1.19 crore BPL card-holding families for the scheme. In contrast, the central scheme authenticated 96.19 lakh regular BPL card holders plus 10.36 lakh state BPL card holders - making up a total of 1.06 crore Aadhaar-authenticated ration cards. The Karnataka government identified 4.42 crore individual beneficiaries for the scheme, nearly 39 lakh more than the central beneficiaries. The state scheme was expected to cost the Karnataka government Rs 890 crore per month or Rs 10,092 crore per year if the rice is sourced from FCI at the rate of Rs 34 per kg, as initially agreed by the FCI with an additional Rs 2.60 per kg for transportation costs.Many senior officials in the Karnataka government regarded the failure to secure rice supplies for the Anna Bhagya scheme as a benefit for the state since it facilitated direct fund transfers to beneficiaries and prevented corruption, such as the black marketing of rice procured for the scheme and inflation of transportation and storage costs. The Anna Bhagya scheme was among the five guarantees made by Congress ahead of the 2023 Karnataka polls. The Karnataka government also launched four other schemes. The Shakti scheme offers free bus travel for women, the Gruha Lakshmi scheme provides Rs 2,000 per month for women who are heads of families, the Gruha Jyothi scheme offers free power of up to 200 units, and the Yuva Nidhi scheme pays allowances of Rs 3,000 to graduates who have been unemployed for two years.

Shimla's Woodfield where Rabindranath Tagore created some of his finest works crying for attention

As the nation remembers Nobel laureate Rabindranath Tagore on his 83rd death anniversary today (Wednesday), Woodfield, a pre-Independence era cottage located on Boileauganj Road, which stands testimony to the Bard of Bengal's Shimla connections is crying for authorities' attention with regard to its upkeep. The world renowned poet, composer, playwright, and painter had spent at least eight months of his life in the queen of hills, Shimla.Woodfield, hardly 150 metres from the Indian Institute of Advanced Study (IIAS) where a Tagore Centre for the Study of Culture and Civilization exists, is where Tagore penned eight of his poems, which later became part of his celebrated literary work 'Sonar Tari', during his stay in Shimla between 1893 and 1894. Tagore corresponded in his unique style of puzzle paintings with his two contemporary artists - Abanindranath Tagore and Surendranath Tagore – from this place. These paintings are regarded among the finest artistic works of the social reformer.A huge plaque describing Tagore's literary work done between October 1893 and May 1894 at Woodfield, which was rented by his elder brother Satyendranath Tagore (famous as the first Indian to join the ICS) in October 1893, on Boileauganj Road adjoining a narrow path leading downwards to the cottage is perhaps the only object that currently reminds people about the importance of this place. The plaque, divided into two parts written in Hindi and English, was unveiled by former Himachal Pradesh chief secretary M S Mukherjee in April 1993.A visit to the single-story sprawling Woodfield standing amidst the deodars and pines suggests that the cottage, originally owned by a Britisher and later purchased by a local businessman Satpal Sood after Independence, currently houses many tenants. One of them, Nirmala Sharma, a retired government employee, says, "Whoever resides here is a tenant. I have been living here for more than five decades. We know that it is the house where Rabindranath Tagore stayed briefly. There have not been many changes to this house. The original structure is intact. Sometimes we repair the inner portion according to our requirements."When The Indian Express took a close look, it found it lying in a state of neglect. There were unkempt grass and bushes all around the front of the cottage. A 'takhatposh' (wooden bed) was seen in the veranda, a wooden door lying on the floor and a small paint box kept there too drew one's attention. At least two doors out of three inside the cottage facing the veranda were locked, while the third one was bolted from inside. Two pairs of wet shirts were seen hanging on a rope."Woodfield is a place that should be preserved in view of the legacy of Rabindranath Tagore, where he stayed in the late 1890s and created some of his finest works. I tried to access it for my study on Tagore but did not get a response from the people staying there. My efforts are going on. Besides Woodfield in Shimla, there is another place, Snowdown House, at Bakrota Hills, Dalhousie, in Chamba district, where Tagore stayed in 1873. At that time, Tagore was only 12. I have decided to do research on that place also," Prof (Dr) Om Prakash Sharma, Tagore Fellow at the Indian Institute of Advanced Study (IIAS), Shimla, sHe said, "I learned that there were futile efforts to preserve this place when former chief secretary M S Mukherjee took the initiative to install a plaque near the cottage." Pankaj Lalit, Director of Language, Art, and Culture, who also looks after the Himachal Pradesh State Museum, said, "It is always difficult to undertake projects involving private places of historical importance without the consent of the legitimate owners of the property. Despite these challenges, a plaque was installed, keeping in mind the importance of this place. There are cases in the state where our department has undertaken certain private properties with historical importance, compensating the owners who are willing to sell.""We have come across many plans by the government to preserve Woodfield, where Tagore stayed, but nothing has materialised. The original structure of this place is intact. I am not sure whether any objects such as beds, chairs, tables and others that were present in the cottage when the Tagores stayed there are still in the cottage or not, but the structure of the cottage is intact." said Saniav Laul. son-in-law of the owner Satpal Sood, who passed away years ago.Curator Hari Chauhan at the Himachal State Museum said, "Many years ago, a delegation from Calcutta came here and expressed their desire to visit Woodfield. Our staff members took them to the place. The delegation did not report their experience to us. We have not seen many tourists coming here who are aware of Tagore's brief stay in Shimla."The collection of poems 'Gitanjali' won Tagore the Nobel Prize for literature in 1913. He was also the author and composer of the national anthems of India ('Jana Gana Mana') and Bangladesh .

Delhi police rescued 18 underage children from jute factory, 9 arrested

The Delhi Police in collaboration with the departments of Labour and Revenue rescued children, aged between 11 and 17, from a jute bag factory in North-East Delhi's Bhajanpura. An NGO, Sahyog Care for You, which specialises in rehabilitating abused children also helped in the rescue operations.

Officials reported that the rescue operations took place on Tuesday, after they received a tip-off on Monday about underage children working in a jute bag manufacturing and printing factory in Seelampur's Gamri village. "During the search operation, 18 children between the age group of 11-17 years were found employed in the factory and printing work," said Deputy Commissioner of Police (North-East), Joy Tirkey, adding that all the children working as labourers "were rescued and medically examined". He said that the children belonged to Uttar Pradesh, Bihar and Uttarakhand.

The police arrested nine people from the factory and booked them under sections 75 and 79 of the Juvenile Justice (Care and Protection of Children) Act, and sections 3 and 14 of the Child Labour (Prohibition and Regulation) Act.

The children will be produced before the Child Welfare Committee for further assistance and rehabilitation, the police said.

Karnataka High Court reinstates 'outsourced employee' of State Govt removed after maternity leave

maternity leave, karnataka high court, indian expressThe bench directed that the employee be allowed to resume her post until regular appointments were made for it, and said she would also be eligible for back wages and the benefits under the Maternity Benefit Act. The Karnataka High Court has directed that an "outsourced employee" whose work was discontinued after she availed of maternity leave be reinstated to her post with the attendant benefits. The order was passed on July 26 by the Dharwad Bench of Justice MGS Kamal. The bench also strongly criticised the state's actions, stating, "The State and its instrumentalities, who are expected to act as 'model employers', are finding one after the other reason not only to brazenly flout the constitutional mandate, which they are obligated to uphold and implement in the process of public employment".

In this case, the petitioner was working as an accountant at the office of an assistant director of agriculture via an agreement with a manpower agency. After she returned from her maternity leave, availed from May 2023 to August 2023, she was informed that another person was working in her place. Her salary was also stopped. She then approached the court after allegedly no action beyond assurances was taken. The Karnataka Government argued there was no "privity of contract" involving them since the agreement was with the manpower agency, and grievance if any should be taken up with them. It also argued that while the employee's maternity



leave went on till the end of August, the State's contract with the agency expired in June. The bench observed that based on existing laws and previous cases, "...it is clear that when the doctrine of 'lifting of the veil' is applied to the facts of the instant case, the petitioner has indeed made out a case for outright rejection of the contentions of the respondent - State of there being no relationship of employer and employee.""It is necessary to note that the requirement of the services of the employees like petitioner is continuous with the compelling need to the respondent authorities. The services of the petitioner therefore cannot be termed either as temporary or ad hoc in nature. In fact, from the records it is clear that the respondent authorities were depending on the services of the petitioner and her absence had caused them extreme inconvenience," added the bench.

'We are scared... Don't know what will happen when we return home' : at Petrapole land port on Bangladesh border

After getting her documents checked at the immigration counter of the Petrapole border check-post in North 24 Parganas district of West Bengal, 60-year-old Radharani hurriedly walked towards Bangladesh."I am hearing that houses, shops and even temples are being ransacked. I don't know what will happen to me. But I have to return to my family as soon as possible," a worried Radharani said.

"I have heard that miscreants have started to ransack, loot, and burn houses in my area. We are very scared. We do not know what will happen when we return. But I have to. My family, my sons, all are there," she added.A resident of Jhenaidah in Bangladesh, almost 90 km from Petrapole, Radharani had come to see her daughter in Barasat in North 24 Parganas before protests broke out in her home country.Radharani was not the only one in the group of people heading back to Bangladesh through Petrapole - the South Asia's largest land port that plays a key role in the trade between India and Bangladesh - gripped by uncertainty and fear.Parimal Chandra Ghosh (65), a resident of Barishal in Bangladesh, said: "I'm hearing that violence has started. I am scared. But where else will I go ... Today is the last day of my visa to expire. I have to return home. Don't know whether I will get any transport there. Don't know how I will reach home."Ghosh is a businessman who has relatives in West Bengal.

"We are all tense about what will happen when we return home. I have heard from neighbours that violence is taking place," said Basudeb Bayen, who stays near the residence of Ghosh. "Everything is uncertain. I don't know what to say," echoed Noor Haq (32), who was heading to his home in Satkhira.So far, authorities at the Petrapole land port are allowing Bangladesh citizens to return back to their country, and also allowing both Indian and Bangladesh nationals entering India.Russel Mondol (21), a resident of Jhenaidah, studies engineering at a college in Meghalaya. Entering India through the border checkpost he said: "I saw with my own even miscreants looting



shops and setting fire to them. Houses of Awami League leaders are being ransacked and set on fire."

"Somehow, I managed to make it to Petrapole. Now, I will go to Howrah station to catch a train to Meghalaya. The violence and ransacking of statues of our nation's founding fathers are unacceptable," Russel said, referring to the statues of Sheikh Mujibur Rahman being vandalised in his country.Meanwhile, with further deterioration of the situation in Bangladesh, authorities have started calling back drivers of 724 goods-laden trucks. Till date, 105 Indian drivers are still in the Bangladesh side of the land port. At least 724 trucks loaded with goods are still stranded at Benapole, the Bangladesh side of the border. Trade has completely stopped at the land port since 3 pm on Monday as news poured in of Prime Minister Sheikh Hasina fleeing the country. The land port, which on a normal day sees an average 450 to 500 trucks going to Bangladesh and 150 to 200 trucks coming in, wore a deserted look on Tuesday."Local drivers have started to return since yesterday (Monday) evening. But today we have been given orders to bring back 105 Indian drivers... Bypolls nearing, UP BJP tries to set house in order: Dy CMs, state chief brainstorm strategy with CM

AS THE stakes are high for the ruling BJP in the forthcoming bypolls on 10 Assembly seats in Uttar Pradesh, the party has apparently made yet another attempt to resolve alleged "internal issues" and showcase the "coordination" between the state government and organisation.Chief Minister Yogi Adityanath, who held a meeting with ministers around a fortnight ago to discuss preparations for the polls during which senior organisational leaders as well as the two deputy Chief Ministers were not present, convened another meeting on Monday.

This time, both Deputy CMs — Keshav Prasad Maurya and Brajesh Pathak — were in attendance, as well as the BJP's state president Bhupendra Chaudhary. The meeting comes days after the party and state government sought to clear the air over the Nazul Properties Bill, which was passed by the Legislative Assembly but put on hold in the Legislative Council and then sent to a select panel forThe government claimed that the decision was "unanimously" taken after the CM spoke to the two Deputy CMs and Bhupendra Chaudhary, who is a member of the Legislative Council, too. After the Bill was cleared by the Assembly, where CM Adityanath is the leader of the house, it was put on hold by the Legislative Council, where too the BJP has majority and Deputy Chief Minister Keshav Prasad Maurya is the leader of the house. This move had again led to talks of "differences" within the party and the government. However, sources said that in the meeting chaired by the CM on Monday to discuss the preparations for the bypolls, several other organisational leaders in the BJP as well as a number of state ministers were present.

"The notification for bypoll is yet to be announced but before that, the organisation needs to be strengthened till the booth level. Considering the recent Lok Sabha poll results, work needs to be done at the booth level. Thus, discussion took place regarding this in the presence of the CM, both the Deputy CMs as well as leaders at the organisational level," said UP BJP chief Bhupendra Chaudhary, who also attended the meeting.Asked if any specific responsibilities were assigned to him or the deputy CMs, Chaudhary said, "All of us would monitor and camp in the regions (going to polls). Before the work begins on the ground, first the organisation structure, booth structure needs to be set right."Amid speculation that CM Adityanath would personally take over responsibility of Ayodhya and Ambedkarnagar, he began a two-day visit to Ayodhya on Tuesday. He visited the Ram Temple, offered prayers at Hanuman Gari temple and also held meetings with the party's organisational leaders.

The 10 seats that will vote in the bypolls are Milkipur in Ayodhya, Karhal in Mainpuri (vacated by Samajwadi Party chief Akhilesh Yadav, who has become Member of Parliament), Khair in Aligarh, Katehri in Ambedkarnagar, Kundarki in Moradabad, Phulpur in Prayagrah, Ghaziabad in Ghaziabad, Majhwan in Mirzapur, Meerapur in Muzaffarnagar and Sisamau in Kanpur.Of these, the maximum - five - were won by the SP, including Milkipur in Ayodhya, where MLA Awadhesh Prasad has now become MP from Faizabad, while three were won by the BJP, one each were won by the Rashtriva Lok Dal and Nishad Party – both of which are are NDA alliance partners at present. The BJP, which lost Milkipur in the 2022 Assembly polls, is focusing on winning it back in a bid to make up for the 2024 Lok Sabha loss in Faizabad.Meanwhile, the SP too has started contemplating the candidates on these seats, especially Faizabad, where sources say that Awadhesh Prasad's son Ajit Prasad is "frontrunner." Although the Congress and the SP are yet to finalise a seat-sharing arrangement for the coming bypolls, it is clear that the seats won by SP in 2024 will again go to the party, including Milikupur, and the Congress will support the SP candidate.Later in the day, in Ayodhya, Adityanath reviewed the preparations for the Milkipur Assembly bypoll with the party's election in-charges, laving emphasis on booth management.He directed the leaders to establish contact with every family regarding the 'Har Ghar Tiranga' campaign of the party (from August 13-15) and urged them to expose the "double standards of the opposition" before the publicHe pointed out that the workers should connect with the common people and take development issues to the people.State Ministers Surya Pratap Shahi, Satish Chandra Sharma, Girish Chandra Yadav and Mayankeshwar Sharan Singh were also present during the review meeting. Fall of Sheikh Hasina regime: BSF DG assesses 'operational readiness' on Bangladesh border, villagers told not to move at night



GNS News Agency, August 9,Border Security Force (BSF) Director General Daljit Singh Chawdhary on Tuesday reviewed security along the Indo-Bangladesh border in West Bengal's North 24 Parganas district on the second day of his visit to the state in the wake of a political crisis in the neighbouring country.Accompanied by Additional Director General Ravi Gandhi and Inspector General Maninder PS Pawar, Chawdhary assessed the force's tactical and operational readiness at critical locations, it is learnt.

He visited the Integrated Check Post (ICP) at Petrapole and the sensitive Ranaghat border outpost. At Petrapole, Chawdhary inspected the passenger and cargo terminals, "gaining firsthand insights on the operational challenges faced by troops".He was briefed on the battalion's procedures by its commanding officer and the newly constructed ICP building.Later, the DG held a meeting with BSF officers at the Ranaghat border outpost to discuss the prevailing situation in Bangladesh and strategise counter-measures against infiltration and smuggling.

It was also decided that all shops in the markets should be closed by 9 pm and announcements will be made from mosques that villagers should stay away from the border areas. The farmers were instructed to use the gates only for essential work and were assured of immediate assistance from the BSF. The key issues discussed in the meeting included the management of tall crops and problem of jute dumping by civilians near the border, civilian movement on border roads after curfew and land acquisition for fencing in unfenced areas.

Calling its actions an "overreach" and "disregard" for legal proceedings, the Gujarat High Court Tuesday admonished the Godhra Municipality in Panchmahal for issuing a work order to construct a fire station on a contentious graveyard regarding which a writ petition is subjudice. It directed the civic body's Chief Officer to be present before the court on August 13 to show cause as to why the HC should not issue a suo motu contempt notice in the matter. The matter pertains to City Survey Number 477 of Godhra, which is 'prima facie' a land being used as a graveyard (qabrastan) from the early 1990s. The HC had, in its order dated March 20, 2023, directed a survey by the District Inspector of Land Records (DILR) to file a report along with the measurement map of the land.In its report, the DILR had stated that several graves had been found on the land during the measurements undertaken, the court observed. However, on March 3, 2024, the Chief Officer of the Godhra Municipality issued a work order to construct a fire station on the contentious land

Objecting to the decision, the court of Justice Nikhil S Kariel rebuked the Godhra Municipality for "showing disregard" and "considering itself higher than the court". The court also questioned the Godhra Municipality counsel on why the "officer of the state" had disregarded the sub-judice status of the case. "To this court, it would appear that the respondent (Chief Officer) has not given any due regard to the fact that a writ petition (WP) on the said land was in pending consideration of this court... As the Chief Officer of the municipality, more particularly as the officer of the state, (the officer) was required to stay his hands and not precipitate the issue any further...as an officer of the state, (the CO) was under the obligation to ensure that due process of law is not derailed by the action of the said respondent by issuing work order... It prima facie appears that (CO) had no regard whatsoever for the WP pending before this court... (CO) was doing nothing but overreaching the due process of law," the court stated.

When counsel KP Champaneria, on behalf of the municipality, argued that the said land was allotted by the district collector as part of the construction of 32 fire stations at district-levels, the High Court issued instructions to government pleader Aakash Gupta to file a reply as to why the state government could not "allot any other land" in Godhra for the purpose of construction of the fire station."Why this land and no other land? The municipality shall explain as to why pursuant to the measurement of the land by the DILR, the land should not be treated as a graveyard land... The state shall also take instructions on the above aspects, more particularly, if the land is to be treated as a graveyard land, then some other land should be allotted to the municipality for building a fire station," the court directed, barring any "further construction activity" on the contentious land until the next hearing. The court also termed the Chief Officer's action "undefendable". "When a petition is pending, why should your municipality pass a resolution? Authorities of the state have no business to say that there was no interim relief (granted to the petitioner by the court) and so, we are not bound (to respect the sub-judice status)... You (municipality) should have come to the court to say that we are in urgent need for the land and we are alloting the same for this purpose and informing the court so that we are not held in contempt," the court noted.

Markfed to change food packaging, to use cardboard cartons

Amid row over alleged sub-standard food and panjiri being supplied to beneficiaries by Aanganwadi centres in the state, the Punjab State Co-op Supply & Marketing Federation Ltd (Markfed) has decided to change the packaging of food material being supplied to the beneficiaries under the Integrated Child Development Service (ICDS) programme, "forgoing one per cent of its profit".Denying the allegations of foreign materials being found in food packets as "concocted", Markfed said it would pack foodstuff in air-tight bags and supply these bags in cardboard cartons.

A government source said Markfed has decided to provide better packaging of food material, including sweet and salty dalia and millet khichdi, after complaints of foreign particles in these food products received."We

checked the entire supply process and found packets of panjiri, dalia and khichdi damaged during transportation. Sometimes, these packets were punctured to ensure they were not damaged due to pressure while handling. We have now directed them to stop this. Air-tight packets of international standards will be used and transported in cartons. This will cause our input cost to go up, but we will forgo one per cent of our profit," said a government officer. The officer added these cartons would be handy for Anganwadi centres which sometimes do not have proper storage space and food packets will remain protected in the cartons. "We know sometimes Anganwadi centres supplying food material to beneficiaries do not have proper storage space. This becomes an issue, especially during monsoon, as some food packets get wet. Now, there would be no such issues," the officer said.A

row ensued after several videos of foreign objects like small stones in food packets distributed by Anganwadi centres went viral. The Centre took cognisance of the matter after SAD MP Harsimrat Kaur Badal had raised it in Parliament. Union minister Annapurna Devi wrote to the state government over the issue. Punjab Women and Child Welfare Minister Dr Baljit Kaur denied such reports in her reply to the Centre.Under the ICDS programme, supplementary nutrition is provided to beneficiaries, funded by the state and the Centre in a ratio of 60:40. Sources said the programme is worth Rs 125 crore. The Women and Child Welfare Department is considering replacing panjiri with some other item, Dr Kaur told The Indian Express Monday. Sources said Markfed was told not to use millets in panjiri, so they are looking at some alternatives. "It is still in the nascent stage. We do not have millets available now.

In a first, Punjab farmers take home cheque worth **Rs 1.75 cr as carbon credit compensation**

Farmer Parminderjit Singh Cheema, of village Pur Hiran in Hoshiarpur, Tuesday received a cheque of Rs 20,985 from Punjab Chief Minister Bhagwant Mann. It is the first installment out of the total four that the Punjab government will pay him as carbon credit compensation.Similarly farmer Navjinder Singh from Saleran village received a cheque of Rs 94,772. Ram Pal and Punit Kumar, from Chak Sadhu, received Rs 49,417 and Rs 47,386, respectively, while Dr Vikas Sood got Rs 6,702.

These payments are part of the pilot project that covers 3,686 farmers across Kandi region including Hoshiarpur, Ropar, Mohali, Pathankot, and Nawanshahr. The project will disburse a total of Rs 45 crore in carbon credit compensation in four installments to these registered farmers. On Tuesday, Mann disbursed Rs 1.75 cores into the accounts of 818 farmers of Hoshiarpur during an event to mark 73rd Van Mahotsav at Hoshiarpur. In a significant step towards environmental sustainability and farmer welfare, Punjab's Forest Department, in collaboration with The Energy and Source Institute (TERI) and an international company, has launched a pioneering carbon credit compensation programme. Under this initiative, farmers are receiving financial compensation for planting and maintaining trees on their agricultural land, contributing to CO2 reduction and benefiting from an additional income stream

The programme requires farmers to plant trees and maintain them for at least five years to be eligible for carbon credit. After this period, the trees can be sold, providing farmers with income. If these trees are sold to paper making, furtniture making and plywood making factories, then they are also helping in storing carbon in furniture and paper products, thereby preventing additional pollution, which could be caused through burning timber.In case of Parminderjit Singh Cheema, he grows tress on his 17 acres farm land instead of doing traditional wheat and paddy cultivation. He plants eucalyptuses and poplar trees in rotation. The trees get mature for harvesting in 5-6 years, when he cuts them down and plants the new batch."This initiative not only helps reduce carbon emission, but also provides farmers with the opportunity to earn from their trees after five years, by selling them and by continuing to receive carbon credit payments. Also, we farmers are practicing intercropping for the first three years in the fields where tree plants are grown, making extra income. This dual approach offers immediate agricultural benefits and long-term financial gains," said Cheema.Mann said Punjab is the country's first state to launch the carbon credit scheme to preserve the environment and check global warming. He also highlighted its potential to enhance environmental sustainability, control pollution, and provide economic benefits to farmers. He emphasized the need for wider awareness and participation in such programs to maximize their impact."The initiative aims to create a sustainable model that benefits both the ecosystem and the farming community," said Dr SanjeevTiwari, Forest Conservator of the North Circle. He added that farmers who had grown tree plants in 2016-17, 2017-18 and so on are enrolled under this programme. Teams from the international company and TERI visit the farms to inspect the Verified Emission Reductions (VER) to calculate compensation based on the quality and duration of the trees.

Dr Sood, who grows tress on 18 acres of land, emphasized that the carbon credit payments help cover the costs of plantation and maintenance, providing significant relief to farmers. However, he stressed the need for greater awareness of the scheme to encourage more farmers to adopt agro-forestry practices. This will help address environmental imbalances and control diseases related to pulmonary health, he said.Punjab, with its forest cover at just 6.6 percent-well below the minimum required 20 per cent-faces significant challenges. The extensive cultivation of water-intensive paddy crop has led to a drastic decline in the water table, while overuse of fertilizers, insecticides, and pesticides has polluted the soil and air. The state urgently needs crop diversification, making it an ideal candidate for agro-forestry. The National Forest Policy aims to increase the country's green cover to 33 percent.

Farmers involved in agro-forestry note that the rainy season is optimal for planting trees. Agro-forestry requires 80-90 per cent less pesticides, insecticides, and fertilizers compared to traditional crops, and its water consumption is less than 20 per cent of that required for paddy. After two to three years, the trees primarily rely on rainwater. Additionally, agro-forestry requires less labor compared to other crops and significantly improves soil quality. According to experts, trees such as poplar, safeda, dek, subabul, and kikar can be successfully integrated with main crops in Punjab's climate conditions.

Earlier, Mann gave a clarion call to people to take up tree plantation as mass movement for checking environmental pollution on one hand and enhancing the state's green cover on other. Highlighting severe environmental damage caused by deforestation, Mann said by reckless cutting of trees, human beings have created havoc with nature."Owing to this only, we are witnessing a lot of natural fury across the country," said Mann, adding the only solution for this is to plant more and more trees.Mann also appealed to the farmers, who get free electricity to plant at least four saplings around their tubewells. He said this is currently a suggestion, but a law can also be enacted in this regard if needed.



The village is located around six kilometres from the town centre."At around 3.30 pm, the inmates of the primary school left under the supervision of the District Collector and the

The state counsel had also produced an order dated March 16, 2023, vide which an expert committee was constituted to devise further course of action regarding suspension of fresh building plan approval cases for 'stilt-plus-four' floors in the residential plots. The bench adjourned the matter to September 9.Stilt-plus-four floors refer to a building that has a stilt floor, which is raised above the ground

level, and an additional four floors above it, making a total of five floors. The Air India chartered flight, which took off for the Bangladesh capital late Tuesday, was operated with an A321 neo aircraft. Air India operated the flight, which took off from the national capital without any passengers, at a very short notice despite infrastructure challenges at the airport there, said the official in the know of the developments.

On Tuesday, Air India had cancelled its morning flight but operated the evening flight to Dhaka.Vistara will also be operating their services to the Bangladesh capital as per schedule. It operates daily flights from Mumbai and three weekly services from Delhi to Dhaka.Both Vistara and IndiGo had cancelled their Tuesday flights to the Bangladesh capital. Opp demands rollback of GST on life, health insurance

MEMBERS OF INDIA bloc parties staged a protest near the Makar Dwar (main entrance) of Parliament on Tuesday demanding a rollback of 18% GST on life and health insurance premiums.Lok Sabha Speaker Om Birla called the protest "not appropriate" and reminded the members of the "consensus" reached earlier of not holding any demonstration at the House entrance.

MPs from various parties, including Trinamool Congress, Congress, AAP, Samajwadi Party and NCP (Saradchandra Pawar) among others, participated in the protest on the steps leading to the Makar Dwar. They were carrying placards reading "tax terrorism" and other messages in different regional languages. Leader of Opposition in the Lok Sabha Rahul Gandhi too joined the protest.Later, in a post in Hindi on X, Congress president Mallikarjun Kharge said, "Today on the Parliament premises, INDIA parties demanded immediate removal of 18% GST on health and life insurance premiums as this extortion is a severe blow to our people, especially the middle class.""The middle class is already struggling under the burden of the Modi government's tax collection policies. India's medical inflation rate is the highest in Asia in 2024 — at 14%. On top of that, this 'Gabbar Singh Tax' on life and health insurance is inhuman and another condemnable example of the BJP's policy of plundering from 'opportunity in disaster'." Calling it an "insensitive thinking of the BJP government", Rahul Gandhi said, "The Modi government collected Rs 24,000 crore from millions of Indians who pay health insurance premiums every year by saving every penny to ensure that they do not have to bow down before anyone in case of a 'health crisis' in life... Looking for a 'tax opportunity' in every disaster is proof of the insensitive thinking of the BJP government. INDIA Alliance opposes this opportunistic thinkina.

Senior Congress leader Shashi Tharoor said the INDIA bloc parties' demand is absolutely justified. "India is already the country whose citizens pay the highest out-



of-pocket expenses for health crises in the world. Senior citizens who have taken health insurance are now paying the highest GST rates in the world. How does the government intend to attain the goal of 'insurance for all by 2047', when it is instead ensuring the unaffordability of insurance to most," Tharoor asked on X.TMC MPs have been raising this issue in Parliament. TMC president and West Bengal Chief Minister Mamata Banerjee last week had written to Union Finance Minister Nirmala Sitharaman on the matter.

Kamala Harris picks Minnesota **Governor Tim Walz as running mate**

U.S. Vice-President Kamala Harris picked Minnesota Governor Tim Walz to be her running mate on Tuesday (August 6, 2024), according to three people who spoke to AP on condition of anonymity. In choosing Mr. Walz, she is turning to a Midwestern Governor, military veteran and union supporter who helped enact an ambitious Democratic agenda for his state, including sweeping protections for abortion rights and generous aid to families

Ms. Harris hopes to shore up her campaign's standing across the upper Midwest, a critical region in presidential politics that often serves as a buffer for Democrats seeking the White House. The party remains haunted by Republican Donald Trump's wins in Michigan and Wisconsin in 2016. Trump lost those states in 2020 but has zeroed in on them as he aims to return to the presidency this year and is expanding his focus to Minnesota.Mr. Walz, 60, is joining Ms. Harris during one of the most turbulent periods in modern American politics, promising an unpredictable campaign ahead. Republicans have rallied around Trump after his attempted assassination in July. Just weeks later, President Joe Biden ended his reelection campaign, forcing Ms. Harris to unify Democrats and consider potential running mates during an exceedingly compressed time frame. The three people spoke on condition of anonymity to avoid preempting the official announcenment later Tuesday.

Harris vs Trump: Who will determine the defining issues of the Presidential race? | In Focus podcastMs. Harris, the first Black woman and person of South Asian descent to lead a major party ticket, initially considered nearly a dozen candidates before zeroing in on a handful of serious contenders, all of whom were white men. In landing on Mr. Walz, she sided with a low-key partner who has proven himself as a champion for Democratic causes.Mr. Walz has been a strong public advocate for Ms. Harris in her campaign against Trump and J.D. Vance, labelling the Republicans "just weird" in an interview last month. Democrats have seized on the message and amplified it since then. During a fundraiser for Ms. Harris on Monday in Minneapolis, Mr. Walz said: "It wasn't a slur to call these guys weird. It was an observation." Mr. Walz, who grew up in the small town of West Point, Nebraska, was a social studies teacher, football coach and union member at Mankato West High School in Minnesota before he got into politics. He won the first of six terms in Congress in 2006 from a mostly rural southern Minnesota district, and used the office to champion veterans issues. Mr. Walz served 24 years in the Army National Guard, rising to command sergeant major, one of the highest enlisted ranks in the military. He ran for Governor in 2018 on the theme of "One Minnesota" and won by more than 11 points.As Governor, Mr. Walz had to find ways to work in his first term with a legislature that was split between a Democratic-controlled House and a Republican-led Senate. Minnesota has a history of divided government, though, and the arrangement was surprisingly productive in his first year. But the COVID-19 pandemic hit Minnesota early in his second year, and bipartisan cooperation soon frayed.

won reelection in 2022 by nearly 8 points over his GOF challenger, Dr. Scott Jensen, a physician and vaccine sceptic. Not only did Mr. Walz win, Democrats kept control of the House and flipped the Senate to win the "trifecta" of full control of both chambers and the Governor's office for the first time in eight years. A big reason was the Supreme Court's Dobbs decision, which held that the Constitution doesn't include a right to abortion. That hurt Minnesota Republicans, especially among suburban women."Tim has been in the news because the country and the world is seeing the guy we love so much," U.S. Sen. Amy Klobuchar Klobuchar said on Monday.Ken Martin, Chairman of the Minnesota-Democratic-Farmer-Labour Party said young people he spoke to on the campaign trail were "Walz pilled".

Mr. Walz and other Democrats went into the 2023 legislative session with an ambitious agenda - and a whopping \$17.6 billion budget surplus to help fund it. Their proudest accomplishments included sweeping protections for abortion rights that included the elimination of nearly all restrictions Republicans had enacted in prior years, including a 24-hour waiting period and parental consent requirements. They also enacted new protections for trans rights, making the state a refuge for families coming from out of state for treatment for trans children. Their other major accomplishments included tax credits for families with children that were aimed at slashing childhood poverty, as well as universal free school breakfasts and lunches for all students, regardless of family income. They also enacted a paid family and medical leave program, legalised recreational marijuana for adults and made it easier to vote.Republicans complained that Mr. Walz and his fellow Democrats squandered a surplus that would have been better spent on permanent tax relief for everyone. And they've faulted the Governor and his administration for lax oversight of pandemic programs that cost taxpayers hundreds of millions of dollars.

Federal prosecutors charged 70 people with defrauding federal food programmes that funded meals for kids during the pandemic out of \$250 million on Mr. Walz's watch. Known as the Feeding Our Future scandal, it's one of the country's largest pandemic aid fraud cases. The Office of the Legislative Auditor, a nonpartisan watchdog, delivered a scathing report in June that said Mr. Walz's Department of Education "failed to act on warning signs," did not effectively exercise its authority and was ill-prepared to respond. Republicans still criticise Mr. Walz for his response to the sometimes violent unrest that followed the murder of George Floyd by a Minneapolis police officer in 2020, which included the torching of a police station.During a May fundraiser in St. Paul, Trump repeated his false claim that he was responsible for deploying the National Guard to quell the violence. "The entire city was burning down. ... If you didn't have me as president, you wouldn't have Minneapolis today," Trump said.It was actually Mr. Walz who gave the order, which he issued in response to requests from the mayors of Minneapolis and St. Paul. But within Minnesota, GOP legislators said both Mr. Walz and Minneapolis Mayor Jacob Frey were too slow to act. And there was fingerpointing between Mr. Frey and Mr, Walz on who was responsible for not activating the Guard faster.

Mr. Walz has served often as a Biden-Harris surrogate, and has made increasingly frequent appearances on national television. They've included an interview on Fox News that irritated Trump so much that he posted on ruth Social, "They make me fight battles I shouldn't have to fight." Mr. Walz is also co-chair of the rules committee for the Democratic National Convention. And he led a White House meeting of Democratic Governors with Mr. Biden following the President's disastrous performance in his debate with Trump.Putting Mr. Walz on the ticket could help Democrats hold the state's 10 electoral votes and bolster the party more broadly in the Midwest. No Republican has won a statewide race in Minnesota since Tim Pawlenty was re-elected Governor in 2006, but GOP candidates for attorney general and state auditor came close in 2022. Trump finished just 1.5 percentage points behind Democrat Hillary Clinton in the state in 2016. While Mr. Biden carried Minnesota by more than 7 points in 2020, Trump has taken to falsely claiming that he won the state last time and can do it again.

Hamas names Yahya Sinwar, mastermind of the Oct. 7 attacks, as its new leader in show of defiance

Hamas on Tuesday (August 6, 2024) named Yahya Sinwar, its top official in Gaza who masterminded the Oct. 7 attacks in Israel, as its new leader in a dramatic sign of the power of the Palestinian militant group's hardline wing after his predecessor was killed in a presumed Israeli strike in Iran. The selection of Sinwar, a secretive figure close to Iran who worked for years to build up Hamas' military strength, was a defiant signal that the group is prepared to keep fighting after 10 months of destruction from Israel's campaign in Gaza. His selection is likely to provoke Israel, which has put him at the top of its kill list after the Oct. 7 attack, in which militants killed 1,200 people in southern Israel and took about 250 as hostages. Hamas said in a statement it named Sinwar as the new head of its political bureau to replace Ismail Haniyeh, who was killed in Tehran last week in a blast Iran and Hamas blamed on Israel. Israel has not confirmed or denied responsibility. Also last week, Israel said it had confirmed the death of the head of Hamas' military wing, Mohammed Deif, in a July airstrike in Gaza. Hamas has not confirmed his death.

In reaction to the appointment, Israeli military spokesman Rear Adm. Daniel Hagari told Saudi-owned Al-Arabiya televsion, "There is only one place for Yahya Sinwar, and it is beside Mohammed Deif and the rest of the October 7th terrorists. That is the only place we're preparing and intending for him."The two assassinations left Sinwar as the most prominent figure in Hamas. His selection signals that the leadership on the ground in

Gaza - particularly the armed wing known as the Qassam Brigades — has taken over from the leadership in exile, which has traditionally maintained the position of the overall leadership to navigate relations with foreign allies and diplomacy.

Haniyeh, who had lived in self-imposed exile in Qatar since 2019, had played a direct role in negotiations over a cease-fire in Gaza through U.S., Qatari and Egyptian negotiators - though he and other Hamas officials always ran proposals and positions by Sinwar.Speaking to Al-Jazeera television after the announcement, Hamas spokesman Osama Hamdan said Sinwar would continue the cease-fire negotiations."The problem in negotiations is not the change in Hamas," he said, blaming Israel and its ally the United States for the failure to seal a deal.But he said Hamas "remains steadfast in the battlefield and in politics ... The person leading today is the one who led the fighting for more than 305 days and is still steadfast in the field."As Hamas' leader inside Gaza since 2017, Sinwar rarely appeared in public but kept an iron grip on Hamas' rule over the territory. Close to Deif and Qassam Brigades, he worked to build up the group's military capabilities. He has been in deep hiding since the Oct. 7 attacks, which triggered Israel's campaign of bombardment and offensives aimed at destroying Hamas. The death toll among Palestinians is now nearing 40,000, most of the population of 2.3 million has been driven from their homes, and large swaths of Gaza's towns and cities have been destroyed. In May, prosecutors at the International Criminal Court sought an arrest warrant against Sinwar on charges of war crimes over the Oct. 7 attack, as well as against Israeli Prime Minister Benjamin Netanyahu and Israel's defense minister for war crimes.Hugh Lovatt, an expert on the Israeli-Palestinian conflict at the European Council on Foreign Relations. said Israel's killing of multiple senior Hamas figures over the past months cleared the way for Sinwar. "Two weeks ago, few would have expected Sinwar to be the group's next leader despite the strong influence he exerts from Gaza," he said. The killing of Haniyeh, a relative moderate, "not only opened the path for Sinwar to claim full control of Hamas, but also appears to have tipped the group into a more hardline direction," he said.

Nuclear disarmament must be tackled as a pressing issue, not an ideal: Hiroshima Governor

Hiroshima officials urged world leaders on Tuesday (August 6, 2024) to stop relying on nuclear weapons as deterrence and take immediate action toward abolishment - not as an ideal, but to remove the risk of atomic war amid conflicts in Ukraine and the Middle East and rising tensions in East Asia. They commented as Hiroshima remembered its atomic bombing 79 years ago at the end of World War II. The memorial comes days after Japan and the U.S. reaffirmed Washington's commitment to "extended deterrence," which includes atomic weapons, to protect its Asian ally. That is a shift from Japan's past reluctance to openly discuss the sensitive issue as the world's only country to have suffered atomic attacks.Hiroshima Gov. Hidehiko Yuzaki said nucleararmed nations and supporters of atomic deterrence "deliberately ignore ... the fact that once people invented a weapon, they used it without exception. "As long as nuclear weapons exist, they will surely be used again someday," Mr. Yuzaki said in his address at the Hiroshima Peace Memorial Park.

"Nuclear weapons abolition is not an ideal to



attended the ceremony, said global conflicts and divided views over approaches to nuclear disarmament make achieving that goal "all the more challenging," but pledged to do his utmost in pursuing "realistic and practical measures" to build momentum within the international community. Many others, including those who say they were victims of the radioactive "black rain" that fell outside the initially designated areas of Hiroshima and Nagasaki, are still without support. Hiroshima officials called on Fumio Kishida's government to do more to provide support and address their wishes. The aging survivors, known as "hibakusha," continue to push for a nuclear arms ban as they desperately campaign to have their effort kept alive by younger generations.

Pakistani man with ties to Iran charged in plot to carry out political assassinations on U.S. soil

The case disclosed by the Justice Department on Tuesday is the latest murder-for-hire plot originating from abroad to target American public figures, coming two years after officials disrupted a separate scheme that they said was aimed at former Trump administration national security adviser John Bolton.Asif Merchant traveled to New York in June for the purpose of meeting with men he thought he was recruiting to carry out the killings, even paying a \$5,000 advance to two would-be assassins who were actually undercover law enforcement officers, federal officials said. He was arrested last month as he prepared to leave the U.S. and after having told the men that he would provide further instructions, including the names of the intended targets, in August or September after he returned to Pakistan.Court documents do not identify any of the potential targets. But U.S. officials acknowledged last month that a threat on Donald Trump's life from Iran prompted additional security in the days before a Pennsylvania rally in which Trump was injured by a gunman's bullet. That July 13 shooting, carried out by a 20-year-old Pennsylvania man, was unrelated to the Iran threat and Merchant's arrest has no connection to the Trump assassination attempt, a law enforcement official said.But an FBI agent's affidavit suggests Merchant had current or former high-level officials like Trump in mind. He told an associate who was secretly cooperating with law enforcement that he wanted a "political person" to be killed, the complaint said, mapping out on a napkin the different scenarios in which the target could be assassinated and warning that there would be security "all around."U.S. officials have warned for years about Iran's desire to avenge the 2020 killing of Qassem Soleimani, who led the Iranian Islamic Revolutionary Guard Corps' Quds Force. That strike was ordered by Trump when he was

President. The U.S. government since then has paid for security for multiple Trump administration officials, and in 2022, the Justice Department charged an Iranian operative in a foiled plot to kill Bolton.FBI Director Christopher Wray said at a House hearing last month that the Iranian government had been "extremely aggressive and brazen" in recent years, and Attorney General Merrick Garland said Tuesday that "we expect that these threats will continue and that these cases will not be the last."The Justice Department will spare no resource to disrupt and hold accountable those who would carry out Iran's lethal plotting against Americans," he said. White House press secretary Karine Jean-Pierre told reporters Tuesday during an afternoon press briefing that the U.S. had been "tracking Iranian threats against former politicians.""We consider this a national and homeland security matter of the highest priority. We have repeatedly met at the highest levels of our government to develop and implement a comprehensive response," she said. Federal officials identified Merchant, 46, as a Pakistani citizen who has said he has a wife and children in Iran and who traveled frequently to Iran, Syria and Iraq. A lawyer for Merchant declined to comment Tuesday when reached by The Associated Press.After Merchant's arrest, Justice Department prosecutors urged a judge to keep him locked up, writing in a detention memo that before flying from Pakistan to the U.S., "the defendant had spent two approximately two weeks in Iran. Given the seriousness of the murder for hire charges, the defendant has every incentive to flee to either Pakistan or Iran, significantly reducing the likelihood of his appearance in this case should he flee."He was ordered detained following a court appearance.Court documents trace the foiled plot to this past April, when Merchant flew to the U.S. to recruit participants in the murder-for-hire scheme. He contacted a person he thought would help him but who instead alerted law enforcement. That person became a confidential source for investigators, including by introducing Merchant to the purported hitmen, officials said. After meeting the two undercover officers posing as hitmen, the affidavit says, Merchant told them the work would be longterm. He instructed them that in addition to the killings, he would expect them to arrange protests at political rallies, steal documents and launder money for him.

Hiroshima remembers atom bomb victims as 'global tragedies' unfold

The Mayor of Hiroshima said on Tuesday (August 6, 2024) that wars in Ukraine and Gaza were deepening fear and distrust worldwide while observing the 79th anniversary of the atomic bombing that devastated the Japanese city.Kazumi Matsui made a sombre speech at a memorial event to commemorate the victims of the U.S. nuclear attack on August 6, 1945 that left around 1,40,000 people dead."Russia's protracted invasion of Ukraine and the worsening situation between Israel and Palestine are claiming the lives of countless innocent people and shattering normal life", he said."These global tragedies are deepening distrust and fear among nations, reinforcing the public assumption that to solve international problems we have to rely on military force, which we should be



rejecting."

Days after the 1945 Hiroshima attack, a second U.S. nuclear bomb hit Nagasaki in southwest Japan, killing around 74,000 people. The two strikes led to the end of the Second World War, and to this day Japan remains the only country to be hit by atomic weapons in wartime.During Tuesday's (August 6, 2024) ceremony, dignitaries including Prime Minister

Fumio Kishida — all clad in black suits - bowed deeply and laid wreaths at the memorial cenotaph featuring the inscription "rest in peace".Today, Hiroshima is a thriving metropolis of 1.2 million people, but the ruins of a domed building stand in the city centre as a stark reminder of the attack's horrors.

Apparel exporters see global orders partly shifting to India amid crisis in Bangladesh

Global textile orders could partly shift to India as the political turmoil in Bangladesh has brought economic activity in that country's key sectors such as the garment industry to a standstill, Indian garment and apparel exporters said Tuesday. Given Bangladesh's prominent position in the global clothing industry, the Indian apparel industry might have to step in, at least temporarily, to fill the gap for global buyers. This comes after the Bangladesh Garment Manufacturers and Exporters Association (BGMEA), fearing vandalism, reportedly asked all factory owners to keep their units shut until further notice. Violence in Bangladesh has reportedly left at least 300 dead amid countrywide curfews and curbs on mobile internet

"India has no intention or inclination to exploit this unfortunate situation in our friendly neighbouring country. The Indian garment industry is making serious efforts to grow RMG (ready-made garment) exports on its own, based on its merit. However, it is quite likely that in the short-term garment orders may shift to India and the Indian apparel industry may be asked to fill the gap caused by this severe disruption," said Mithileshwar Thakur, Secretary General of the Apparel Export Promotion Council (AEPC).Ready-made garments represent more than 85 per cent of Bangladesh's merchandise exports and over 70 per cent of its total exports. The expectations of a shift in orders to India comes as Dhaka has a bigger share in global trade of clothing at 7.9 per cent compared to New Delhi's 3.2 per cent, according to the World Trade Statistical Review 2023. Bangladesh's \$45-billion clothing industry that employs over four million workers was already affected due to the weakening electricity generation infrastructure that was hit by higher input costs following the start of the Russia-Ukraine war and adverse weather events, as per S&P Global.A senior executive with a listed textile company said that Indian industry might not be able to fulfil orders that might shift from Bangladesh as the supply chain is already stressed to fulfil domestic orders."If this situation keeps Bangladesh occupied for more than 6 months then there could be a lot of shifts to India. But Vietnam may benefit from this more than Indian garment manufacturers since the supply chain is already stressed to fulfil domestic orders. Workforce and production capacity isn't elastic that can be increased overnight. Moreover, Ahmedabad textile processing industry which manufactures huge fabric quantities is already shut due to pollution checks," said the executive, who did not wish to be identified

The Confederation of Indian Textile Industry (CITI) said that several major global brands that rely on Bangladesh for their sourcing needs will also be affected by these disruptions and that brands with significant portions of their supply chain rooted in Bangladesh may experience delays and a decrease in the availability of their products. "This, in turn, could lead to a ripple effect across the global retail market, affecting inventory levels and sales," CITI said."The ongoing scenario in Bangladesh poses significant concerns for the Indian textile and apparel sector, particularly for companies operating factories in Bangladesh and exporting products from those units. Any supply disruption in Bangladesh will have immediate impacts on the supply chain, potentially affecting production schedules and delivery timelines," CITI said.S&P Global Ratings in its ratings report on July 30 had said that Bangladesh's economic growth continues to moderate following two years of fast expansion in 2021 and 2022. As high inflation, rising domestic interest rates, limited access to foreign exchange, and policies aimed at compressing imports continue to bite, domestic demand will likely remain modest in comparison to the longterm trend, the report said. Modest per capita income, which we estimate at about US\$2,600 in the fiscal year ended June 2024, remains one of Bangladesh's main rating constraints. But the country's strong underlying growth helps to mitigate this weakness. We calculate its 10-year weighted-average real per capita GDP growth rate at about 5.4 per cent. This is much stronger than the average for sovereigns at a similar level of income. We expect this long-term performance to remain largely intact, despite current policy headwinds," the report said.

Rupee ends at record closing low due to weakness in Asia FX


The Indian rupee fell on Tuesday and closed at its weakest level on record, pressured by a decline in its Asian peers and strong dollar demand in the non-deliverable forwards market, traders said. The rupee hit an all-time low of 83.96 per US dollar before closing at 83.9525, down 0.1% from its close of 83.8450 in the previous session.

Concerns about a US economic slowdown and the unwinding of carry trades that used the Chinese yuan to fund long bets on the rupee have pressured the local currency this week.But the Reserve Bank of India's (RBI) interventions across the non-deliverable forwards (NDF), spot over-the-counter (OTC) and futures market have kept volatility in check, traders said.State-run banks intermittently sold dollars during Tuesday's session, likely on behalf of the RBI, which helped cap the rupee's weakness, a foreign exchange trader at a private bank said.The dollar index was up 0.2% at 103.1, while most Asian currencies weakened, led by the Malaysian ringgit's over 1% drop.Meanwhile, dollar-rupee forward premiums eased slightly but managed to hold on to much of their gains from a climb to a 14-month high on Monday.



A rise in corporate hedging demand, arbitrage between onshore and NDFs, and a broad decline in US yields have helped lift far forward premiums in recent sessions, traders said. Treasury yields pared their losses after economic data and remarks from Fed officials helped soothe concerns about a US slowdown. The 10-year US bond yield was last up 6 basis points at 3.84%. "Barring a US CPI surprise next week, the USD rate appeal appears compromised and we expect a softer dollar against pro-cyclical FX after the dust has settled," ING Bank said in a note.

Tracing the roots of Banarasi saris: How Varanasi's pride became a wedding staple



Woven from the finest silks and adorned with intricate zari work, Banarasi saris are considered symbols of wealth and luxury. Indian weddings seem incomplete without the bride in a red Banarasi, replete with gold jewellery. For generations, our mothers and grandmothers have treasured their heirloom Banarasis for special occasions, reveling in their understated opulence and grandeur. "The Banarasi sari commonly features motifs of jasmine flowers, marigolds, paisleys, animals, and birds. These motifs are not just decorative but also carry meanings of fertility, beauty, and eternity, which are poignant for a new marital journey," said Roli Mehra, founder of Roliana.

Our next dispatch in the ongoing series on Indian textiles explores the vibrant legacy of Banarasi saris, that carry deep cultural and spiritual significance tied to the ancient, holy city of Varanasi. We learn about the intricate weaving process, tips for identifying authentic Banarasis, their association with traditional weddings, and the future of the Banarasi industry. "Since the Vedic period, Varanasi has been a prominent center for the silk weaving industry," said Mehra. Banarasi textiles, that peaked during emperor Akbar's era, graced the wardrobes of Indian royalty and were staples in princesses' dowries.

Varanasi's pivotal position on the Silk Route facilitated the exchange of goods, ideas, and artistry, introducing Chinese silk and Persian designs to its looms. Weavers used specialised techniques like "Jamdani," known for its labour-intensive detailing, and "Kinkhab," famed for its lavish use of gold and silver threads, making these fabrics so luxurious they were called the "cloth of the gods". "Kin means gold and khwab means dreams, making it a golden dream and very precious," Mehra said.Sagrika Rai, founder and creative director of Warp 'n Weft, said, "The Vedic and Buddhist periods saw fine muslin fabrics, referred to as Kasav or Kasika. The Mughal and Persian invasions introduced sumptuous silken fabrics, and the Vijayanagara Empire celebrated opulent

gold-threaded brocades. The textile history of Banarasi shows a unified evolution and transition in yarns and patterns across eras."According to Rai, Banarasi silk stands the test of time and is perceived today as a slow luxury due to its painstakingly indigenous and age-old weaving techniques.A peek into the weaving process

'The process of weaving a Banarasi sari begins with the careful selection and dyeing of silk yarns," said Mehra. "The dyed yarns are set to dry and then loaded onto the handloom, where skilled weavers use various techniques like Kadiyal, Meenakari, Tanchoi, and Kadhwa to intricately weave the silk threads."Kadiyal involves weaving with multiple silk threads to create a vibrant border that contrasts with the body of the sari. Meenakari incorporates colourful resham (silk) threads into the weave, creating elaborate patterns depicting nature, mythology, or royal motifs. The craftsmanship is evident in the intricate weave, each perfect "Boota," and the soft folds of "Janglas" and "Kinkhabs". Other popular motifs in Banarasi weaves include latifa boota, kalgi boota, dollar boota, and anaar boota."The motifs and patterns of Banarasi silk weaves have undergone a slow, deliberate transformation over centuries. Early designs may have been plain textures or stripes, then progressively featuring floral, animal, and bird patterns, which were popular between 350 AD and 500 AD. By the 13th century, 'Butidar' designs gained prominence," said professor John Varghese, School of Fashion, World University of Design."The 16th-century Mughal influence introduced Islamic patterns like florals and 'Jali' or 'Jaal', while the 19th century saw a blend of Indian designs with Victorian-style geometrical patterns. Butidar brocades, Jangla featuring foliate patterns spread all over, Tanchoi with multi-coloured silk inter-lacings are all-time favourites," he added. How to identify authentic Banarasi saris

"An authentic Banarasi must be a pure handloom weave created on the traditional pit loom; it takes months to complete," said Rai. "The touch and feel of these saris, along with government authentication of Geographical Indication (GI) for Banarasi saris and brocades, are key indicators of authenticity."According to Mehra, an authentic Banarasi sari can be recognised by its elegant fluidity and delicate lightness of its zari work. The reverse side is nearly as refined as the front, with minimal thread tails and an almost invisible weave of zari. She also stressed on the beauty of human flaws. "Anything made by hand cannot have the exact same weaves printed across, there will always be some difference, some curves and threads that will not perfectly match," she said.benarasi Radhika Merchant wore a Banarasi lehenga designed by Manish Malhotra for her wedding celebrations.

'The slow, meticulous art of handloom weaving is losing appeal among the younger generation, drawn to faster, more lucrative job opportunities," said Mehra. "This cultural shift, coupled with the slow pace of handloom production, pushes many weavers towards power looms, which offer quicker production and lower costs but lack the unique, intricate quality of hand-woven sarees."Shedding light on the economic challenges faced by weavers, who are often underpaid and undervalued in a market dominated by middlemen, who control both wages and work distribution, Rai said, "Traders promote power looms for faster production, reduced costs, and higher profits, sometimes even mixing art silk in the warp to cut costs."This raises an important question: Banarasi fabrics are booming, are they truly handloom? Are we safeguarding our heritage and supporting our artisanal community, a craft-skill that is a national pride for India?

GST notices to foreign airlines may dampen India's strong aviation potential: IATA



Global airlines' grouping IATA on Tuesday raised concerns over show cause notices issued to some foreign airlines operating to India with respect to Goods and Services Tax (GST), saying the issue can dampen and risk the country's strong aviation potential.Urging the government to resolve the matter, the International Air Transport Association (IATA) said it is disappointed that the Directorate General of GST Intelligence (DGGI) has proceeded to issue show cause notices to some foreign airlines operating to India despite a number of representations made by the industry on this matter.IATA represents more than 330 airlines, including Indian carriers, and its members account for more than 80 per cent of the global air traffic.

"DGGI's assertion that GST should apply to expenses incurred by the headquarters of foreign airlines (with a branch office in India) in the course of providing air transport services is flawed. It does not take into consideration the nature and conventions involved in the provision of international air transport," Xie Xingquan, IATA's Regional Vice President for North Asia and Asia Pacific (ad interim), said in a statement.He also said India is alone in its approach and that nowhere else around the world is this practised. "Indian carriers operating to destinations outside India do not face similar situations or demand," he added.

As many as 10 foreign airlines are under the scanner of DGGI and the carriers received notices since October 2023.IATA had also submitted a detailed representation to the Indian government on the matter. "The interna-

tional nature of air transport necessitates a clear and consistent policy framework globally. IATA continues to work closely with the government of India on this subject. IATA has also urged the government to urgently help resolve this matter, which can dampen and risk India's strong aviation potential," Xie Xingquan said.At a briefing in Dubai in June, IATA Country Director for India Amitabh Khosla had said that for now, 10 foreign airlines have been picked up for investigation and the move was "unprecedented". The statement from IATA also comes at a time when concerns have been expressed over GST demand received by IT major Infosys. On August 1, apex IT body Nasscom said the latest tax demand reflects a lack of understanding of the industry's operating model and sheds light on sector-wide issues wherein multiple companies are facing avoidable litigation and uncertainty.

It's official! X decides to move HQ out of San Francisco, Musk says 'no choice'

San Francisco: As the news about X moving its headquarters from the State of San Francisco in the US became viral, its owner Elon Musk on Tuesday said he had no choice as it has become "impossible" to operate in the city on the West Coast.

The Tesla and SpaceX CEO last month announced his decision to move the headquarters of its aerospace company as well as social media platform X from the US State of California. X, or Twitter as it was earlier known, has been in the city since it was founded in 2006.

"No choice. It is impossible to operate in San Francisco if you're processing payments," Musk posted on X. "That's why Stripe, Block (CashApp) and others had to move," the tech billionaire added.According to reports, X CEO Linda Yaccarino has sent an email to employees, alerting them that the company will move out of its office in San Francisco.

Olympics; know what happens to the body

Two-time world champion Nikhat Zareen's Olympic journey came to a premature end with a disheartening loss to China's Wu Yu in the pre-quarterfinals at the Paris Olympics. The defeat, a stark contrast to the high expectations placed on her, was a bitter pill to swallow for Nikhat herself, as well as those back home. "I will come back strong," Nikhat kept repeating, PTI reported.

The once-world champion looked visibly shaken by the loss as she asked her coach to pass her some water. "Sorry guys, I could not win a medal for the country. I have made a lot of sacrifices to reach here. I had prepared myself well mentally and physically for this Olympics," PTI reported her as saying when referring to the time spent away from her family and the hard training sessions she went through. The days leading up to the match were marked by immense pressure and physical strain. Nikhat revealed enduring a sleepless night and forgoing meals to make the weight qualifications. Despite these challenges, she entered the ring with unwavering determination."I had not eaten in the last two days, I had to maintain weight. I did not even have water, and only after weigh-in I had some water but I had no time to recover, I was first in the ring," Nikhat said in the press conference. When Aamir Khan said Yash Chopra 'removed' him from Darr, casted Shah Rukh Khan later: 'My policy with two heroes is that...'



Superstar Aamir Khan was almost on board to star as the antagonist Rahul Mehra in Yash Chopra's 1993 thriller Darr, but turned the project down, making way for Shah Rukh Khan to step in and make the part iconic.Darr also starred Sunny Deol and Juhi Chawla and followed the story of her obsessive stalker (Khan), who wreaks havoc in the couple's lives. Darr was a milestone film for Shah Rukh Khan, who reached a wider audience with his menacing lover boy turn, earning praise for his act.But before he was on board, it was Aamir Khan, who was considered for the same part by Yash Chopra. In an interview with Sushma Dutt in Vancouver at the time, Aamir, who was touring Canada then, had revealed why he let go off the film despite liking the story.

Yash Chopra is a very good director. I have worked with him on Parampara and was very keen on working with him again. But, I have a principle, or you could say a policy, that if I'm working on a film with two heroes or more on one hero, I request the director for a joint narration. I prefer the director to narrate the story to both heroes together," he had said. Aamir recalled his comedy film Andaz Apna Apna co-starring Salman Khan and said both of them had received a joint narration for the film. "This approach ensures that both of us are satisfied with our roles and helps prevent any issues later on. This is how I like to work. But in this case, it was not possible. Yash ji did not feel that he should give a joint narration. On that basis, I was removed from the project."

Raj Kapoor's son, Rishi Kapoor, wrote about this chapter in his autobiography, Khullam Khulla, and addressed it as 'a part of history' in an interview some years before his death in 2020. He said that both families developed a cordial relationship eventually, and that affairs are bound to happen. Appearing on Aap Ki Adalat, Rishi Kapoor was asked about his father's affair with Nargis, and he said, "We respect that a filmmaker, while working, develops friendships. Sometimes, these friendships transform into something else. We work in the creative field, we seek inspiration from each other, we rely on each other. We are human beings, after all. And a human being will love only another human being. Kabhi kabhi shaadishuda logon ka aisa haadsa ho jaata hai. It is part of life. I auess.

When Pran feared people would abuse him at a wedding, was touched when they gave him 'respect'

Actor Pran, who was billed as one of the greatest villains ever in the history of Indian cinema, once feared that the audience would abuse him if he stepped out in public. The journalist recalled Pran's daughter, frustrated with his bad-man image, telling him to do a "good role" for a change. "My classmates keep telling me that my father is a villain, so please do a good role for a change, she had told him. Around the same time, he signed Manoj Kumar's Upkar, where he played Malang chacha, who became everyone's favourite after the film released and became a huge hit," the journalist said.Set in the backdrop of the Indo-Pakistani War of 1965, Upkar was the directorial debut of Manoj Kumar and stared Pran as the noble man Malang, who was the moral compass to Manoj Kumar. His non-villainous turn after years of being synonymous with the bad guy in movies completely win over the audience, as Pran later confessed of being respected perhaps for the first time in his career.

Filmmaker Rakeysh Omprakash Mehra recalled the heartbreak of his debut film, Samjhauta Express, being shut down mere months before its scheduled start date, because the industry felt that its subject matter was too risky. He was set to collaborate on the film with Abhishek Bachchan, for whom it would serve as a long-awaited acting debut. In an interview, the filmmaker said that the industry felt that they were 'playing with fire', because the movie would've featured Abhishek in the role of a Pakistani terrorist.Appearing on Shiv Talwar's YouTube channel, he was asked about the epic journey of his wouldbe debut film, and he said, "Samjhauta Express, which I'd written with Kamlesh Pandey, was meant to be my debut film, and Abhishek Bachchan's debut film. We worked on it for a year, and Abhishek kept a diary in which, every day, he would write what the character thinks. It turned out well, but, as the market said, it was a very sensitive subject."The filmmaker explained why. He said that the movie would've featured Abhishek as a Pakistani terrorist whose heart



has been filled with hate for India because his innocent father was framed for being a terrorist himself. Abhishek's character infiltrates India in an effort to break his father free from jail, and inadvertently develops a bond with a police officer, who is forced to kill him in the climax. His body is repatriated on the Samjhauta Express.The filmmaker continued, "Until there are these dark holes of hatred between our two nations, we will keep filling them up with the bodies of our children. But Amitabh they will never get filled. The only way we can build a bridge is through love. The industry felt that for Abhishek Bachchan to play

a Pakistani terrorist in his first film would be playing with fire, so the intelligent minds decided... The shoot was called off just three months before (it was supposed to start)." Neeraj Chopra braces to defend javelin crown in what promises to be a cracker of a final

In January this year, India's superstar athlete Neeraj Chopra had the chance to meet the legendary Roger Federer in Switzerland. It was a once-in-a-lifetime opportunity to pick the brains of someone who has seen it all in his career, from the highest of highs to some crushing lows. After a quick chat about Indian food, Neeraj wanted to know something specific from the 20-time Grand Slam champion, who had one of the longest elite sporting careers in the world

"Javelin and tennis are very different but the main thing I wanted to ask him was about his longevity at the top and his mentality. He said that maintaining a balance between competition, training and recovery was the most important thing, and I agree with that. I try to do that as well," Neeraj had said before his season began, recalling that chat with the Swiss great.Neeraj, 26 years old, will enter the Stade de France on Thursday night as the reigning Olympic and World Champion in men's javelin throw. He might already know a thing or two about longevity. He's still young, but has been at the centre of all Indian athletics hopes since the time he broke the junior world record back in 2016.

But striking a balance between competing and staying healthy is something he has had to learn in 2024. The temptation to test his preparation for the title defence in Paris might have been strong, but he and his team have been cautious in taking part in meets in the lead-up to the Olympics.While he has largely remained tight-lipped about his fitness concerns, Neeraj said after his qualification throw of 89.34m that he decided to focus on remaining fit for Paris instead of participating in meets to warm himself up. But if there were any concerns over his competitive level, he allayed some of those fears with the second- best throw of his career so far. One and done, into the final.

The clash for the podium, though, promises to be a thrillerr given how the main contenders of the medal fared

during qualification. "The final will be a cracker, the Tokyo final mark has already been surpassed in qualification," Neeraj said. It could be a different final too, if Neeraj finds himself playing catch-up early on unlike Tokyo where he laid down the early marker. While he is a good starter naturally, Neeraj has also shown he can dig deep if needed, as he did at the 2022 Oregon Worlds to win silver, at the Hangzhou Asian Games last year to respond to Kishore Kumar Jena's challenge, and at the Doha Diamond League meet earlier this year

Pressure is a privilegePressure? Of course, there will be pressure. He has been asked that question pretty much in every single one of his media interactions since Tokyo. His response, however, has always been uniform. He prefers to look at the weight of expectations as a motivation. But even for someone who has stepped up repeatedly on big occasions, the atmosphere at a potentially packed Stade de France will be a new experience. Once again though, in a sea of global superstars, Neeraj vill have to stand up as the solitary Indian title contender. It's a privilege he enjoys.Not a good day on track & field

That Neeraj will be in action on a day after a series of disappointments in track and field only adds to the heft of his consistent showings at international events since Tokyo. Officials' claims of India being a fast-rising athletics contender haven't quite played out so far as the likes of Jyothi Yarraji and Annu Rani went below their best on Wednesday.While there are no expectations from most of the athletics contingent to win medals at the Olympics yet, a basic benchmark for performance usually is how close they can get to their personal bests, or at the very least, Season Bests.Jyothi, on her debut, was expected to dip below her own 100m hurdles national record (12.78s) but instead ran one of her rare recent races where she went 13s+ (13.16s). But she will get another chance to race on the lavender track as athletics has introduced repechage for racers who don't meet the automatic qualification criteria in the opening round.For Annu, even matching her season best of 60.68m wouldn't have been enough for qualifying for the final, but 55.81m was well below her capabilities. (Her 2nd and 3rd throws were in the 53m range). In men's high jump qualification, Sarvesh Anil Kushare was 25th overall in the qualification round as he finished with a clearance of 2.15m, and three misses at 2.20m. (SB: 2.25m)Away from the Stade de France, Suraj Panwar and Priyanka Goswami did not finish the race in marathon race walk mixed relay, a debut Olympic event.

As seconds tick by, a wave of anxiety clutches P Raveendran. His big bright eyes wander to the wallmounted grandfather clock, before he reconfirms the time on his mobile phone screen. The first half of the day had breezed along-he had gone to the airport to pick his eldest son Sreejith, coming home after five years. But the second half is meandering along to the promised hour, that is 5.30 pm, when his youngest son PR Sreejesh turns up for his country for the one last time. "I am always nervous before his games, but this time I am ever more, maybe because it is his last game, and might not experience it ever in my life," he says, staring past the window panes reeking of fresh paint and into the courtyard, where a hunched rambutan tree is swaying in the mild breeze. This afternoon, he says, is different from all other evenings. Longer and tenser. "A chapter ends in our life," he says with a mix of pride, pain and relief. "Though reality has not sunk in yet. For the past 20 years we have seen him more on TV than at home. Now we could finally spend some time at home," he says, although he worries he would soon take up a coaching gig and leave home. "We often joke, he visits us like the Maveli (the mythical demon king) during Onam, but for parents the Onam or Vishu is when the children are at home," he says.

Sreejesh's wife Aneeshya chimes in: "I don't know how it is to see him as a retired sportsman. From the day I first met him, he has been a sportsman,"she says, peels of giggles echoing the dining hall. They were classmates at the GV Raja Sports School in Thiruvananthapuram. "He was the class topper and in the ninth standard, she came and began competing with him," the father says. Love blossomed-Raveendran thought this was a passing infatuation of the teenager. "But he exceeded my expectations. I was happy when they decided to marry because their bond would be so strong to last 13 years," he says.Unlike Raveendran, Aneeshya has little time to meditate on the sluggish arms of the tick-tocking clock. She has to manage a herd of children-her own pair, three of Sreejesh's brother, and those of the extended family, who have come to watch the game together. "It's fun and a big mess too," she says, as one of them zips off on a skating board. Sreejesh's mother, Usha, is busy in the kitchen, mixing the dough for her son's favourite snack, unni appam (sweet rice fritters).

Neighbours-most of them their relatives-jostle in and out of the house, asking whether Sreejesh, fondly called Kannan, had called them, or if he was nervous and that typical irritating query: "What's his next plan? Is he going to revive the farms?"

Sreejesh calls his parents before every match. Often it turns out into a conference call, with the brother and his children too dropping by. He has not called yet, and Raveendran fidgets his thumb along the phone screen. Every time it buzzes, his heart pounds and eyes sparkle. No, no not him this time and he brusquely cuts the calls. His eyes light up. The name Kannan flashes on the screen and he rushes inside to call Sreejith for a private family chat As though a siren has blared those in the house throng in front of the tiny screen of love. The last clock would never meander along as sluggishly as it had time Raveendran has seen his house this vibrant was

during the childhood years of his sons. Sreejith can't resist guffawing. "We used to turn this house upside down, playing, fighting, playing music, fighting for the remote control. Loads of nostalgia. Can't wait to see him after five long years," says Sreejith, settled in Canada as a real estate agent. His youngest son has seen his uncle only through video calls. "For him every bearded man on the TV is his uncle. The other day he saw Virat Kohli and then suddenly began shouting Kannan chittapan (father's younger brother)," he says. They have never played hockey-but a lot of cricket with cousins. "Perhaps it has helped him (Sreejesh) in that he learned to be tough playing with boys older than him. Hockey, I must confess I didn't know it until he started playing it," he says. There was no hockey in Kerala; the presence is still scant. There is a lone astroturf in the entire state, built as recent as 2014 for the National Games. Their shirts don't peer from the ceiling of shops; sports shops, even in big cities, seldom stock hockey sticks and gears. His native Kizhakkambalam is a village in the guise of a town. The narrow road, aptly named Olympian Sreejesh Road, that winds past his house, transports you back in time to the rustic charms of countryside life. Paddy fields, waiting for the harvest, ambles far into the horizon. Brooks and rivulets slither along like slumberous snakes.

The agriculture forebears of the Sreejesh household is evident. A traditional brass nelpara (large cylindrical bowl to keep rice) is proudly displayed in the visitor's hall. "We are proud sons of the soil. Behind Sreejesh's growth is the sweat and mud of the field. Kannan too used to help us during the harvest season,' says Ravindra, who has stopped cultivating paddy after a heart attack four years ago. He points to his chest: "Full of stents

(Credit: Sandip G)To the ears of the hardened farmer, the game with a crooked stick hardly struck a chord. "Especially in that era (late 90s). I was skeptical, because I had never heard of anyone getting a job through sports quota playing hockey. At that time we had not even the faintest idea that he would be an international player. But I let it be, let life take its course," he says. It did, taking Sreejesh along 329 senior international games, numerous league games, a showcase stacked with medals, the most glittering the gold from Asian Games in 2022 and the bronze medal from the 2021 Olympics. A second Olympic bronze would squeeze for space.

He claims he was an unfussy parent, who seldom interfered in his son's sport. He remembers the only time he did with fondness. "He got into the junior selection camp in 2003-04. A friend of mine told me that if I talk to O Rajagopal (then a central minister) he could recommend him and get into the team. I conveyed this to him and he shot back at me and told me, "If I get into the team through recommendation, they will pick me once and then drop. Don't worry, a time will come when ministers will knock on our doors," he recollects. Though he didn't understand the game, and at times cynical, he always supported. He was reminded of one such incident when he took a stroll along the empty cattle shed. "Once I went to buy a hockey kit. The shopkeeper told me it costs Rs 10,000. All I had was Rs 3,000. I didn't hesitate, and sold a dairy cow," he says. The old stories warmed his heart, but the hands of the clocks were still walking heavily. "Sometimes you get anxious for no reason. I'm sure he will come back with the bronze," he said. So Sreejesh did, but a long and storied chapter in Indian hockey and Raveendran's household ended, leaving both the country and family immensely content. But the hands of the wall-mounted

To avoid that struggle, Phogat chose to become a 53 kg wrestler after the Asian Games, and at one point after the Tokyo Games, was also wrestling in the 55 kg category. She won a bronze at the 2022 World Championships in 53 kg but after spearheading the protests against ex-WFI chief Brij Bhushan Sharan Singh, her return was curtailed by a knee ligament injury.

During that time, Antim Panghal won a bronze at the 2023 World Championships, thus getting India a Paris Olympics quota in the 53 kg category. Former Wrestling Federation of India rules gave the quota winner the goahead for the Olympics, and so Phogat was in a fix, because the ad-hoc committee was running wrestling in India at the time and they had promised her that there would be a trial for the 53 kg category. But that decision might have been taken away from their hands as the WFI was set to return to power after conducting their election and selecting Sanjay Singh as its new president.

And thus when March 12 came, Phogat believed that a WFI return wouldn't necessarily guarantee her a shot at the Olympics in the 53 kg category. Which meant she either had to switch to the 50 kg category, or the 57 kg. She chose 50 - a weight class she had last been part of in 2018."I had no clarity about the 53kg quota situation, whether there would be trials or not. Usually, the quota is won by the country but they hadn't held trials before. They (ad hoc committee) said that it wouldn't be the case this time. I had no option but to do this because I have to participate in the Olympics," the 29-year-old had said then, confirming that the decision to take part in the 50 kg category was to ensure that her Paris dreams remained in her own hands.Phogat's walk-around weight is usually around 55-56 kgs. Cutting down to 50 on consecutive days takes its toll. That's why United World Wrestling president Nenad Lalovic said that it wasn't a matter of one kilo, rather the large amount she had to cut in the first place to reach that figure of '100 grams' that caused the issue

American wrestling legend Jordan Burroughs proposed some immediate rule changes on social media to avoid a repeat of the Phogat-like situation. "1.) 1kg second Day Weight Allowance, 2.) Weigh-ins pushed from 8:30am to 10:30am, 3.) Forfeit will occur in future finals if the opposing finalist misses weight, 4.) After a semifinal victory, both finalists' medals are secured even if weight is missed on Day 2. Gold can only be won by a wrestler who makes weight on the second day, 5.) Give Vinesh the Silver medal.

Wrestler Antim Panghal faces deportation trying to 'smuggle' sister into Games Village

Indian wrestler Antim Panghal, who lost in the 53kg category, was summoned by the police inside the Athletes' Village in Paris. Antim was accused of 'smuggling' her sister inside the village, in a major violation of the rules.It is learnt that Antim and her sister are likely to be 'deported' back to India on Thursday."The Indian Olympic Association has decided to fly wrestler Antim and her support staff back after a disciplinary breach was brought to IOA's notice by the French authorities," an IOA statement said.Moreover, Antim's support staff - coaches Bhagat Singh and Vikas - were embroiled in another police case. According to sources, they took a cab from

the Village to their hotel on Wednesday evening. Upon reaching the hotel, they refused to pay the cab driver and misbehaved with him before rushing inside the premises. The cab driver, sources added, also approached the police following the incident. Antim made her Olympic debut on Wednesday in the 53 kg category — the pet weight class of Vinesh Phogat. Considered one of India's medal prospects, she lost in a one-sided first round bout against Zeynep Yetgil. The 19-year-old left the Champ-de-Mars Arena in tears and was accompanied by her sister and coaches to the hotel where they were staying.She then asked her sister to pack her belongings and travel with her to the Village, where Antim passed the heavy security checkpoints with her accreditation card.

From a boy who liked playing harmonium to scoring two goals against Spain to help India win bronze medal in Paris Olympics

Father Sarabjeet Singh still remembers when a young Harmanpreet Singh returned with a harmonium from the annual village fair held in the memory of Baba Gurditta ji, son of Sikhism's sixth guru Guru Hargobind Singh, instead of a usual hockey stick. The Indian captain, who had a flair for singing in his pre teens days, has been the highest scorer for the Indian team in Paris Olvmpics with 10 goals including a brace in the bronze-medal game against Spain that India won."Nikke hunde bas gaun da shaq si Harmanpreet nu (While he was a child, he only had passion for singing)," the father recalls. "Whichever village fair we went to, he would urge me to get him a harmonium and once I got him, he would spend his time with the musical instrument. It was only at his school when a coach enrolled him in hockey that Harmanpreet's interest in the sport grew. With his dragflicks, he has made the goal-keepers sing to his tune and to see him play his role in getting India back to back Olympics medals for India is a special feeling for all of us," Singh Senior tells "At our village, most of the youngsters would play hockey at the village ground and there were days when I would play hockey with my friends after assisting my father on the farmland to relax," a young Harmanpreet Singh had told this newspaper in 2014. "Slowly, my interest in hockey grew and I would attend trials for various academies in Jalandhar in a hope to get a seat there." It was at the St Soldier's School at Jandiala Guru that Singh first started as a hockey trainee at the age of ten.Singh, who was trained initially as a full-back by coach Yadwinder Singh at Malwa Academy in Ludhiana, would join the Surjit Singh Academy in 2010 under coaches Avtar Singh and Gurdev Singh.While a young Harmanpreet would often hear tales about full back Surjit Singh, a member of the 1975 World Cup winning Indian hockey team who died in a road accident, his well built physique led the coaches to train the youngster for drag flicks.

"When Harmanpreet joined us, we were impressed by his physique. Most of the trainees, who come from villages, are built like that and Harmanpreet knew how to

make use of his physique as a fullback at a young age. We made him play as right as well as left fullback and he understood the strengths needed for both the positions at a young age," remembers coach Avtar Singh.Since the academy had two drag-flickers Varun Kumar and Gagandeep Singh, Singh's current team-mates, he was put on the drill by the coaches for a month initially.

"There was some of the Astro Turf patch remaining after new turf was laid out and we got the small astro-turf patch installed behind the main stadium in front of a goalpost and some nets surrounding the goal-post. Harmanpreet and other trainees would initially learn how to stop the ball and pull the ball. He had very strong wrists and it would help him to impart the speed to the ball. Initially he started with hitting 30-40 balls per session, which later increased to 50-60 balls per session," says coach Avtar Singh. He made his junior India debut in 2014, starred with nine goals in the Sultan of Johor Cup for the Indian U-21 team and 14 goals in the Junior Asia Cup in 2015, before making it to the Indian team for 2016 Rio Olympics where he was one of the drag-flickers for the team. The same year, Harmanpreet played his maiden junior world cup, scoring three goals."Apart from staying low and rotating, Harmanpreet would also stay upright too and fall into the ball which helped him generate speed as well the different angles. He knows how to utilize his upper body. But his favourite was to hit the ball towards goal-keeper right or to hit the ball past the first rusher. It helped him develop low angles and that has always been his strength. That's what he showed in Paris too in some of his drag-flicks and his accuracy has helped him despite the urges to hit to his favourite positions."Yes, it was a bit of bad luck in the semis against Germany where his variations could not be executed but he showed his accuracy with the low corner penalty corner equaliser towards the left of the Spanish goal-keeper for India today,' says Avtar Singh.Former Indian goal-keeper Baljit Singh Dadhwal saw a young Harmanpreet in a domestic trial in 2016. "People in the IOCL teams used to call Harmanpreet as Pehlwaan (Wrestler). It was due to his strong physique and that has remained his strength till date.
