Heavy rains drench Hyderabad, city braces for more

Hyderabad: Relentless rains pounded Hyderabad for the second consecutive day, turning the city's streets into deluge of water on Friday.Following a stormy Thursday night, residents woke up to a humid Friday, only to be greeted by overcast skies and heavy downpour by evening. Water stagnantion was reported in several neighbourhoods, prompting officials to caution citizens against venturing out unless necessary. According to data by Telangana Planning and Developmebt Society (TGDPS) by 7 pm, Patancheru recorded a significant 61.5 mm of rainfall, followed by Quthbullapur at 45.8 mm, and Golconda at 42.8 mm.

In phone talks with PM Modi, Bangladeshs Yunus assures safety of Hindus, other minorities

In his first direct contact with New Delhi after becoming the head of Bangladesh's interim government, Mohammad Yunus on Friday conveyed to Prime Minister Narendra Modi in a phone conversation that Dhaka would prioritise protection and safety of Hindus and all other

In the talks initiated by Yunus, Modi reaffirmed India's support for a democratic, stable, peaceful and progressive Bangladesh and underlined the importance of ensuring the safety of Hindus and other minority communities in the violence-hit country. The assurance by Yunus came a day after Modi, in his Independence Day speech, said 140 crore Indians are concerned over the safety of Hindus and minorities in the neighbouring country."Received a telephone call from Professor Muhammad Yunus, @ChiefAdviserGoB. Exchanged views on the prevailing situation," Modi said on X."Reiterated India's support for a democratic, stable, peaceful and progressive Bangladesh. He assured protection, safety and security of Hindus and all minorities in Bangladesh," he said. In a statement, the Ministry of External Affairs (MEA) said the two leaders also discussed ways to take the bilateral relationship forward in line with the "respective national priorities". "During the call, the prime minister reaffirmed India's support for a democratic, stable, peaceful and progressive Bangladesh. He emphasised India's commitment to supporting the people of Bangladesh through various development initiatives," it said."The prime minister also underlined the importance of ensuring the safety and protection of Hindus and all other minority communities in Bangladesh," it said. "Prof Yunus, in turn, assured that the Interim Government would prioritise protection, safety and security of Hindus and all minority groups in Bangladesh," the MEA said.

There have been mounting concerns in New Delhi over widespread incidents of attacks on the minority Hindu community in Bangladesh after Prime Minister Sheikh



Hasina resigned and fled to India on August 5 following weeks of violent unrest. Days after Hasina fled to India, the interim government, headed by Nobel laureate Yunus, was sworn in on August 8, along with 16 advisers.On Tuesday, Yunus reached out to Hindus in Bangladesh as he visited the Dhakeshwari temple in Dhaka and said his government would punish those who attacked the minority community members. Hasina (76), who ruled Bangladesh with an iron hand for 15 years, resigned as the prime minister following massive protests that initially began as an agitation against a job-quota scheme but weeks later, morphed into a mass movement demanding her ouster from power. In his Independence Day speech from the ramparts of the Red Fort in the national capital, Modi on Thursday said India is committed to peace and that it will remain a well-wisher of Bangladesh in its development journey."As a neighbouring country, I can understand the concern regarding whatever has happened in Bangladesh. I hope that the situation there will become normal soon," Modi said. "In particular, the concern of 140 crore countrymen is that the safety and security of Hindus and minorities there is ensured. India always wants the neighbouring country to march on the path of peace

Doctors from major private hospitals in Hyderabad to suspend duties on Saturday

Hyderabad: The protests against the alleged rape and murder of a trainee doctor in Kolkata spread in the Telangana on Friday with the medical fraternity here staying away from outpatient and elective services. Today, doctors from private hospitals too joined the protests announcing suspension of their outpatient and elective services. Major corporate hospitals including Apollo Hospitals, Yashoda Hospitals, Basavatarakam Indo American Cancer Hospital and state-run Nizam's Institute of Medical Sciences (NIMS) have announced suspension of their outpatient and elective services for 24 hours from 6 am on Saturday.

All the major associations representing senior government doctors, faculty, non-clinical staff, nurses, senior residents, junior doctors and nurses in government hospitals continued their protests today and intend to continue their boycott for one more day, between Saturday and Sunday. While the emergency/casualty wings functioned normally, the elective surgeries at Gandhi Hospital, Osmania General Hospital (OGH) and NIMS, had to be postponed due to the boycott call. Healthcare services at the OP wings at Gandhi and Osmania Medical College were impacted, as senior doctors, who reported to their regular duties wearing black badges, did their best to make-up for the absence of medicos. Later, the senior



doctors at OGH and Gandhi Hospital also took one hour off from their routine medical duties and participated in protests. More than 200 elective surgeries lined up to at Gandhi hospital and OGH on Thursday and Friday were postponed due to the ongoing boycott by Telangana Junior Doctors Association, TTGDA, AIFGDA and TGDA and NIMS Resident Doctors Association. With the Resident Doctors and Nurses union at NIMS also deciding to join the boycott, the hospital management announced that the OP services and elective surgeries will be curtailed and postponed respectively. Emergency/casualty services, however, will continue in all government and pri-

Kothagudem: Tension prevailed Purushothapatnam in Andhra Pradesh on Telangana borders on Friday as the Bhadradri temple authorities tried to evacuate those who encroached the temple lands.

Sri Seetha Ramachandra Swamy Devasthanam, Bhadrachalam executive officer L Rama Devi along with staff went to Purushothapatnam of Yetapaka mandal in erstwhile East Godavari district in Andhra Pradesh on receiving information that a land opposite the temple's goshala was being encroached.

The EO and the temple executive staff asked the encroachers to remove the structures built on the temple lands. The encroachers refused to do so and warned the temple staff against obstructing the construction of the houses and manhandled the staff who tried to enter the encroached land. It led to heated arguments between the two groups, temple staff accompanied by Lord Rama devotees tried to demolish the encroachments. It was said that the temple owns about 890 acres of land at Purushothapatnam and a large extent of land was already encroached. The devotees wanted the Chief Minister of AP and Telangana to look into the issue and take measures for the protection of the temple lands. They also complained that the local revenue officials and the police remained mute spectators when the encroachers attacked the temple staff.

IN the age of so-called smart cities, the term 'urban looding' sounds almost like an oxymoron. After all, a mart city ought to have an efficient stormwater drainge system that can handle a few hours' downpour, at he very least. On the contrary, flooded roads are a comnon sight during the monsoon in cities across the counry, right from Delhi and Chandigarh in the north to Chennai and Bengaluru in the south. Gurugram, the Millennium City, has failed to solve this problem depite having spent more than Rs 100 crore on anti-waerlogging measures in the past three years. What else an you expect when nearly half of the drains are not leaned before the onset of the rainy season? Incidenally, Gurugram is not part of the Centre's Smart City Mission. When asked why, the Haryana CM had said in November 2022 that the state government wanted to nake it the 'smartest' city and not just 'smart'. Well, smart marter or smartest, the watery nightmare continues for Gurugram residents

Stormwater drainage systems often don't operate o their designed capacities because of poor maintenance; in some cases, the capacities have not been augmented despite the rapid pace of urbanisation. Enroachments and unplanned growth have worsened he situation. Adequate preparedness is half the battle von when it comes to flood control. However, high-inensity rainfall in a short duration invariably catches the nunicipal and urban development authorities off guard. And hapless citizens are left to sink or swim in water-

Bengaluru court extends judicial custody of actor Darshan & other accused till Aug 28

Bengaluru, A court here on Wednesday extended till August 28 the judicial custody of Kannada actor Darshan Thoogudeepa along with his friend Pavithra Gowda and others, who are accused in the Renukaswamy murder case. All the 17 accused, including Darshan and Pavithra, were produced before the magistrate through video conferencing from Bengaluru and Tumakuru prisons, where they are lodged, as their judicial custody ended today. The extension of judicial custody follows a remand application filed by the Kamakshipalya Police, who have requested more time to continue their investigation. Authorities claim that substantial evidence ties all the accused to the crime, and that ongoing investigations are scrutinising their involvement. Key scientific evidence collected from the crime scene has been sent to the Forensic Science Laboratory , but the final reports are still pending. The case has expanded, with additional charges and cases under investigation, necessitating further judicial supervision. There are also concerns about potential threats or coercion directed at the family of the deceased, which could undermine the integrity of the case. The investigation is expected to be bolstered by additional FSL reports and further input from the Central Forensic Science Laboratory, which is analysing technical evidence, officials said. According to police sources, 33-year-old Renukaswamy, a fan of the actor, had sent obscene messages to Gowda, which enraged Darshan, allegedly leading to his murder. His body was found near a stormwater drain next to an apartment in Sumanahalli here on June 9. Raghavendra, one of the accused who is part of Darshan's fan club in Chitradurga, had brought Renukaswamy to a shed in R R Nagar here, on the pretext that the actor wanted to meet him. It was in this shed that he was allegedly tortured and murdered. According to the post-mortem report, Renukaswamy, a native of Chitradurga, died due to shock and haemorrhage as a result of multiple blunt injuries. Police sources said Pavithra, who is accused number one, was the "major cause" for Renukaswamy's murder, claiming that it has been proved from the probe that she instigated other accused, conspired with them, and took part in the crime.

Telangana BJP seniors not happy with Maheshwar Reddy's style of functioning

Hyderabad: The Bharatiya Janata Party in Telangana appears to be caught in a cold war between party State senior leaders and BJP Legislative Party Leader A Maheshwar Reddy. Sources say State leadership was not happy with the way Maheshwar Reddy was functioning and taking independent decisions without informing them. Of late, Maheshwar Reddy has been holding press conferences at the BJPLP office on the Assembly premises, which has been objected to by a few senior leaders. They claim that Maheshwar Reddy was supposed to inform the State office bearers about his activities and press conferences so that they could inform the State leadership.On the other hand, Maheshwar Reddy argues that he was legislative party leader and that he has a right to hold press conferences at his will at BJLP office. The party office bearers complain that Reddy was forcing the party media cell staff to give coverage to his press conferences and statements. In fact, he has created a special WhatsApp group to invite media representatives for his press conferences and activities. This has not gone well with the State leadership. The senior BJP leaders are of the opinion that Maheshwar Reddy was working on his personal agenda rather than peoples' issues. "He is targeting Congress and BRS leaders keeping in mind his personal agenda. His action is causing harm to the party," a BJP leader said. Reduce GST on digital news subscriptions: MIB to revenue department

New Delhi: The ministry of information and broadcasting (MIB), in a letter dated July 22, requested the department of revenue to either exempt digital news subscriptions from goods and services tax (GST) or to reduce it from 18% to 5%. In the letter, addressed to revenue secretary Sanjay Malhotra, information and broadcasting (I&B) secretary Sanjay Jaju said that newspapers were exempted from GST because the significance of giving "correct and factual information" to Indian citi-

A brief note annexed to the letter said that a higher tax burden could skew the growth of the online news sector towards the advertising model, which could affect the quality and credibility of the news content. "With the growing internet penetration in India and the nascent stage of the online news industry, it is requested that the disparity between GST on printed newspapers and digital/online news subscriptions may be addressed by either exempting the GST on the latter or rationalizing it from 18% to 5% at par with that on e-books," the letter

The MIB mentioned a September 29, 2023, office memorandum in which it had recommended exempting

online news subscriptions from GST to bring parity between printed newspapers and digital/online news subscriptions. The revenue department, however, in an office memo dated June 5, 2024, said that the proposal to exempt digital news subscriptions was discussed by the GST Council in its meeting on July 11, 2023, but the proposal was not recommended by the Council. The MIB cited how a similar disparity between printed books and ebooks was addressed in 2018 when the GST Council reduced the GST rate on e-books from 18% to 5% through a notification dated July 26, 2018. The 54th GST Council meeting is scheduled to be held on September 9, and the last meeting was held on June 22.In the attached background note, the MIB noted that very few internet users in India pay for online news. Thus, a higher rate of GST on digital news subscriptions could encourage the online news sector to adopt an advertising model "which may impact the quality and credibility of the news content on the internet through practices such as use of clickbait and sensational headlines, and fake and misleading news, etc."It also noted that the 18% GST on online news subscriptions brings a tax revenue of about Rs. 21.6 crore from a total revenue of Rs. 120 crore. The MIB argued that reducing it to nil or five percent "may not lead to substantial revenue forgone by the government exchequer." Currently, printed newspapers, journals, and periodicals are exempted from the GST. Under the IGST Act, online news subscriptions are taxed at 18% as Online Information Database Access and Retrieval (OIDAR) services, that is, an internet service that has no physical interface between the supplier and recipient of the service. Online news subscriptions are included in the sub-category of services for "supply of images, text, and information and making available of databases.". The MIB noted that providing "credible and factual information in the nature of news" is different from other online content services as it "empowers the citizens to take informed decisions and be aware of their rights and responsibili-

PM Modi to visit US in September, address major community event in New York

Around 15,000 people are expected to attend the gathering that will be "unique and different" in its format, flow and themes compared to past events. Prime Minister Narendra Modi will address a major community event in New York on September 22 during a visit to the city to attend the UN's Summit of the Future. The event's theme is 'Modi & US: Progress Together', and its stated aim is to celebrate India and the US and the "cultural ethos" of viewing the "world as one family, diversity a strength, and the well-being of all people and the planet an inspiration for building a better world together". A person familiar with the development said that around 15,000 people are expected to attend the gathering that will be "unique and different" in its format, flow and themes compared to past events that Modi has addressed in the US. "The main aim of the event is to celebrate the diaspora, their progress and future and ties with India." Aware that the event is being planned in the middle of the American election season, in a departure from the past, organisers intend to keep it avowedly non-political. "There will be no elected officials invited for the event this time."

This is the fifth time Modi will address the Indian community in the US at an event. In 2014, he spoke at the Madison Square Garden in New York that saw tens of thousands of Indian-Americans and dozens of elected officials including Congressional representatives and Senators. In 2015, he addressed Indians in California's San Jose with a focus on the tech community in Silicon Valley and the political leadership in the West Coast. In 2017, Modi spoke to community organisation leaders at a smaller event in Washington DC. In 2019, a year before the last presidential elections, Modi and then American president Donald Trump addressed the biggest ever gathering of Indian-Americans in Houston, an event that drew criticism from Democrats who saw India as taking sides in the election, a perception that Delhi had to work hard to counter. During his state visit to the US last year, 8000 Indian-Americans attended the ceremonial welcome at the White House itself while Modi spoke to Indian-American professionals at Kennedy Center and addressed another community event in Reagan Center in Washington DC, both much smaller in scale.

This year, Modi's event comes at a time when the American election has a strong Indian-American dimension. The Democratic nominee for the presidency, Kamala Harris, identifies as both Black-American and Indian-American; her mother was a Tamil and migrated from India in 1958. The wife of the Republican nominee for vice president, JD Vance, is Usha Vance, daughter of immigrants from Andhra Pradesh. The Indian-American community, according to 2020 survey conducted by political scientists Devesh Kapur, Milan Vaishnav and Sumitra Badrinathan, remains overwhelmingly Demo-



crats. And while a slight shift towards Republicans was discernible in recent years, Harris's nomination has galvanised the community for the Democratic ticket. Those familiar with the development are careful to emphasise that Modi's event has nothing to do with American elections nor with Indian-American participation and preferences in the elections. "This is purely to celebrate the bonds between our countries in the spirit of 'Vasudhaiva Kutumbakam' and the ideas of one earth, one family and one future," the person quoted above said. The official purpose of Modi's visit is to attend the Summit of the Future, a flagship event being organised by the UN Secretary General Antonio Guterres in his final year in the position. Guterres has been supportive of India's aspirations in recent years, including its G20 presidency. He travelled to Gujarat to attend the launch of Mission LIFE, Modi's personal environmental initiative to tackle climate crisis by encouraging a lifestyle change, and has embraced India's digital public infrastructure as a model worth emulating. Modi may also then address the UN General Assembly on September 26, according to a provisional list of speakers for the general debate put out by

Modi is also expected to have a range of bilateral meetings on the sidelines of the summit. While India is slated to host the Quad Leaders' Summit this year, given the vagaries of the political calendar in different member states - India held elections earlier in the year, there is political instability in Japan with PM Fumio Kishida announcing his decision to step down, and it is unclear if and when President Joe Biden can travel to India — there has also been speculation that the meeting may be held in New York itself. The community event is being organised by the Indian-American Diaspora Association (IADA), which describes itself as a non-profit that encourages India-US cooperation to advance the "shared values of democracy, inclusive economic development, and mutual respect". The event site states that community donations will cover the costs of the event and registration is open for partner organisations that wish to participate.

Ram Lalla sculptor Arun Yogiraj denied US visa for 3-day conference

Arun Yogiraj was scheduled to attend a three-day World Kannada Conference, set to take place at the Greater Richmond Convention Center in Richmond, Virginia. Renowned sculptor Arun Yogiraj, who carved the Ram Lalla idol installed at the newly built Ram Temple in Ayodhya, has been denied a US visa to attend a threeday conference in Virginia. Arun Yogiraj was reportedly scheduled to attend the 12th AKKA World Kannada Conference (WKC 2024), set to take place from August 30 to September 1."Your remarkable contributions to the field of sculpture have caught our attention, and we believe that your artistic vision would greatly enrich our conference. Your work embodies the spirit of creativity and innovation, qualities that align perfectly with the objectives of our event," the invitation letter read. The family members of Yogiraj said that all necessary arrangements were made, and the denial was particularly surprising given that the sculptor's wife, Vijeta, has previously travelled to the US without any issues, reported Republic Kannada. According to the family, the sole purpose of the trip was to attend the conference, and the couple had intended to return to India promptly after the event."I don't know any reasons why it was denied, but we have submitted all the documents related to the visa," Republic



World quoted Yogiraj as saying.

Who is Arun Yogiraj? Arun Yogiraj's journey into the world of sculpting began at a young age, inspired by his father and grandfather, who were also renowned sculptors. After a brief stint in the corporate sector, Arun returned to his passion for sculpting in 2008. Congress names Abhishek Manu Singhvi as its candidate for Rajya Sabha bypoll in Telangana

The Congress party has nominated Abhishek Manu Singhvi as its candidate for the upcoming Rajya Sabha bypoll in Telangana. "The Congress President, Shri Mallikarjun Kharge, has approved the candidature of Abhishek Manu Singhvi as Congress candidate to contest the ensuing bye-election to the Council of States from Telangana," Congress general secretary KC Venugopal said in a release.

Earlier this year, the party had fielded Singhvi from Himachal Pradesh but a cross-voting by some disgruntled Congress MLAs saw the senior advocate losing the election to BJP candidate Harsh Mahajan. The Congress had a strength of 40 members and the support of three Independents in the 68-member Himachal Assembly. However, both the candidates polled 34 votes each as six Congress rebels and three Independents voted in favour of the BJP candidate. The winner was announced by a draw of lots. The Rajya Sabha bypoll in Telangana has been necessitated due to the resignation of K Keshava Rao from the upper house. Rao quit the Congress party in 2013 and joined the Telangana Rashtra Samithi (now Bharath Rashtra Samithi). However, the veteran leader returned to the grand old party in July, months after Congress's sweeping victory in Telangana, and resigned from Rajya Sabha. The Election Commission of India (ECI) last week announced bypolls for 12 Rajya Sabha seats in nine states.Of the 12 seats, 10 fell vacant after the members were elected to Lok Sabha in the 2024 general elections. These include Piyush Goyal, Sarbananda Sonowal, Jyotiraditya Scindia, Deepender Hooda, Biplab Deb, KC Venugopal, and Misa Bharti among others. The last date for filing nominations is on August 21 and the elections, if required, will be held on September 3. Singhvi is likely to win the bypoll this time and enter the Upper House with the Congress having a majority in Telangana.

Kolkata doctor's rapemurder: BJP alleges delay in investigation

New Delhi: The Bharatiya Janata Party (BJP) on Wednesday attacked the West Bengal government, alleging delay and mishandling of the Kolkata trainee doctor's alleged rape and murder case. "The first 48 hours following such a brutal crime are essential for collecting and preserving evidence. Delays or blunders during this period can severely hinder the investigation and potentially allow the perpetrators to escape justice," emphasised party spokesperson Gaurav Bhatia.

The party said that the Mamata Banerjee-led government delayed transferring the case to the Central Bureau of Investigation (CBI). The CBI took over the case on Tuesday following the Calcutta high court's on Tuesday, which ordered the agency to probe the "brutal rape and killing" of a postgraduate trainee doctor at Kolkata's RG Kar Medical College Hospital last Friday.

Bhatia further criticised the initial classification of the death as "unnatural" by local police, suggesting that this misclassification might have led to significant evidence being compromised or mishandled. "The chief minister's decision to postpone the transfer of the investigation raises serious questions about her commitment to delivering justice," Bhatia added as he accused the CM of failing to take decisive action, thereby worsening the situation and undermining justice for the victim's family. The handling of the case by local authorities further compounds the issue, with the principal of the college where the crime occurred, as alleged by the BJP, involved in destroying evidence. Instead of being suspended, this principal was transferred to the principal of the Calcutta Medical College (CMC), which the BJP spokesperson described as a 'disturbing reward for failing to uphold his responsibilities'. Furthermore, "evidence was being destroyed under the veil of construction," claimed Bhatia as he pointed out that there was renovation taking place in the area where this heinous act was committed. Critics, including the BJP, have raised significant concerns about the broader implications of this case for governance and law enforcement in West Bengal. Bhatia's criticism extends to Banerjee's overall handling of the situation, calling for her resignation and suggesting that her administration's failures have compromised the safety and security of women in West Bengal. The Trinamool Congress (TMC), however, iterated its sympathy for the deceased. Condemning the act, TMC spokesperson Sagarika Ghose posted on X (formerly Twitter), stating, "The incident in R G Kar Hospital is very unfortunate and disturbing." Ghose further expressed the West Bengal government's stance toward the victim and her family members and deplored the politicisation of the incident. "The law will bring justice and the TMC and Mamata Banerjee are committed to ensuring so".

SC affirms decision not to hold NEET super speciality exam in 2024

The Supreme Court on Wednesday refused to interfere with the National Medical Commission's (NMC) decision not to conduct the NEET-Super Speciality Exam (NEET-SS) 2024 this year. A bench, comprising Chief Justice of India (CJI) Dhananjaya Y Chandrachud and justices JB Pardiwala and Manoj Misra, noted that the data provided by the NMC indicated that at least 40% of the candidates who take the NEET-SS are drawn from the most recent graduating batch.

The court observed that the petitioners, who have previously taken the NEET-SS, would not be unduly harmed if the exam is postponed to next year. However, it noted that holding the exam this year would disadvantage students from the 2021 post-graduate batch, who are set to complete their courses only in January 2025, by denying them an opportunity to appear. In light of this,

the bench held that the NMC's decision is "fairly equi cannot 'arbitrary."Simultaneously, the court accepted the petitioners' request for the NMC to promptly lay down a schedule for the NEET-SS 2024 exam. The bench ordered that the schedule be announced within 30 days, taking into account the number of students completing their PG courses in January 2025. Furthermore, the bench directed that the exam be conducted within three months of January 2025. Thirteen doctors had moved the Supreme Court assailing the NMC's decision to not hold NEET-SS in 2024. The NMC justified its decision to defer the NEET-SS 2024 exam due to the delayed admissions for MD, MS, and DMB courses through the NEET-PG exam in the 2021 academic year. These admissions, delayed by the COVID-19 pandemic, occurred between January 2022 and May 2022, resulting in course completion being pushed to January 2025. To accommodate these students, the NMC decided to postpone the NEET-SS 2024 exam. Advocate Rashmi Nandkumar, representing the petitioners, argued that only 40% of students who join the Super Speciality course are from the most recent PG batch. Therefore, the decision to cancel NEET-SS this year was arbitrary, as it would deprive the remaining 60% of students of their opportunity. On behalf of the NMC, senior advocate Gaurav Sharma countered that conducting the NEET-SS this year would result in the 2021 PG batch students losing their chance to appear for the exam. While acknowledging that the delay in the exam would cause some inconvenience to the petitioners, the bench emphasised that this hardship must be balanced against the broader concerns highlighted by the NMC.

The court asked the petitioner's lawyers to inform them by the next date of hearing about the place where trial in all cases can be conducted. However, the bench added, "You have to go out of Tamil Nadu."

Punjab govt creating obstacles in NHAI projects, land acquisition responsibility of state government: BJP leader Anil Sarin

Wading into the war of words between the Centre and the Aam Aadmi Party (AAP)-ruled Punjab government over National Highway Authority of India (NHAI) projects, BJP general secretary Anil Sarin said on Wednesday that the state government was creating obstacles for them. "State government-sponsored individuals are creating obstacles for prestigious projects because it is worried that the completion of these projects on time will further increase the popularity of Prime Minister (Narendra Modi)," said Sarin in Jalandhar.

He stated that the Centre has no direct role in land acquisition and compensation settlement. "Both of these are carried out by the state government, and the Centre is responsible for making the payment, which it is currently fulfilling," said Sarin, who was accompanied by former Jalandhar MP Sushil Kumar Rinku and former MLA Sheetal Angural, among others. "The state government must carry out all work related to land acquisition and decisions about the compensation amount. The Right to Fair Land Compensation Act of 2013 clearly outlines the rules and regulations for calculating compensation based on the collector rate of the specific area, which the state government determines," he said. "The sub-divisional magistrate (SDM) of the area or the district deputy commissioner is responsible for claim settlement. The Centre must provide funds according to the compensation determined by the state government after the land has been acquired. Therefore, blaming the Centre for compensation issues reflects negatively on the AAP government, showing an anti-Punjab, anti-Punjabi, and antidevelopment stance," he added

On Tuesday, three days after Union Minister of Road Transport and Highways Nitin Gadkari wrote to the Punjab government threatening to terminate eight NHAI projects in the state due to the "prevailing law and order situation," Chief Minister Bhagwant Mann responded, reaffirming his government's commitment to completing these projects. The government also questioned the Centre's 'warning' to scrap road projects over 'law, order'. The AAP pointed to NCRB data to refute law order claims in the letter from Gadkari, saying problems were localised. Delay tactics, lack of will to develop Punjab'Sarin, meanwhile, said that the Union government had already given Punjab Rs 17,325 crore for land acquisition. Of this, Rs 13,626 crore has already been disbursed, while Rs 3,699.37 crore is still with the state government, he said. He said the Union government had announced 42 highway projects in Punjab, measuring 1,764 km in length and costing over Rs 58,000 crore.



He stated that the Centre has no direct role in land acquisition and compensation settlement. "Both of these are carried out by the state government, and the Centre is responsible for making the payment, which it is currently fulfilling," said Sarin, who was accompanied by former Jalandhar MP Sushil Kumar Rinku and former MLA Sheetal Angural, among others."

However, the projects were progressing very slowly due to obstacles created by the state government.

He said contracts for three projects measuring 104 km had already been terminated, while seven more projects with a cost of Rs 8,245 crore had been stalled due to a delay in land acquisition. Sarin said, "Not only this, according to the information available from NHAI, the 31 other projects coming up on 1,150 km of length are also running behind the schedule of appointed date as more than 80 per cent of land hasn't been acquired in these cases as well. The cost of these 31 projects is Rs 42,175 crore out of the over Rs 58,000 crore of total announced projects. In short, we can say that the projects are running too late because of delay tactics and a lack of will to develop the state." The Delhi-Amritsar-Katra Expressway is a prestigious project that everyone knows about, and so is the Amritsar-Bathinda-Jamnagar project and various other projects that can encourage more industries to invest in Punjab. The development of these projects will also improve the lives of local residents. However, AAP is not focused on the welfare of the people and is instead engaged in cheap blame-game politics," Sarin added.On the alleged manhandling of an NHAI engineer in Jalandhar and the attack on a project officer in Ludhiana, he said, "The CM has indicated that it was a fight between two groups. Does that mean that to settle a dispute, one group will resort to an attack? Where is the law and order of Punjab? I can only feel sorry for the vague explanations of the CM about these incidents."

BMC to spend Rs 20 crore per km on south Mumbai road concretisation

The Brihanmumbai Municipal Corporation (BMC) is set to shell out Rs 20 crore per kilometer for concretisation of roads in the island city. The civic body has finalised the rates for the work order, which will be issued to the contractor, NCC Limited. The total cost of concretising the roads of south Mumbai has been pegged at Rs 1,362 crore, which includes concretising 214 different roads spread across 65.5 KM. While the contractor was selected in May, the final work order is yet to be issued. BMC

officials claim the final cost is only 4% higher than the initial estimate of Rs 1,300 crore.

'After winning the contract, negotiation was underway for carrying out works at the best possible rate. Since the rates have been finalised now, the work will start immediately after the monsoon season," said a senior official. Former municipal corporator Makarand Narwekar told The Indian Express that earlier, the BMC was set to issue work orders at 9 per cent to the contractor. "I was told that the contractor is getting the work order at 4% above estimate. Earlier, the administration was set to issue work orders at 9%, following which we intervened. This effectively will result in saving of around Rs 70 crore of public money. I have written to the civic administration and have requested them to ensure CCTV monitoring is carried out of the work done, along with a third party audit of the quality of work that is being executed by the authorities," Narwekar told The Indian Express. The island city's road concretisation is part of the larger Rs 6,000 crore project announced by Chief Minister Eknath Shinde in 2022. While work is underway in the suburbs, the island city's initiative has faced delays. A previous contract was terminated due to the contractor's inaction, leading

However, after the term of the deposit ended, PNB allegedly released only Rs 13 crore. Meetings and repeated communication with bank officials did not yield fruit, the circular said, adding that the case had been



heard by a court for the last 10 years. The other case was related to a fixed deposit at the erstwhile State Bank of Mysore, which merged with the SBI in 2017. The Karnataka State Pollution Control Board had a fixed deposit of Rs 10 crore at the bank's Avenue Road branch. According to the Government, the amount was adjusted to the loans taken by a private company using forged documents. Attempts to recover the amount are said to have suffered the same fate as that of the fixed deposit in PNB. These issues attracted severe objections in the Comptroller and Auditor General of India reports. Dr Sandip Ghosh resignation, RG Kar Medical College principal, Kolkata doctor rape and murder, Dr Ghosh, an orthopaedic professor, assumed the role of principal in mid-2021 after being promoted from his previous position at Calcutta National Medical College. The complaint, filed by Advocate Shayan Sachin Basu, has been sent to the Director General of West Bengal Police Rajeev Kumar, and Kolkata Police Commissioner Vineet Goyal. The complaint alleged that on August 12, Dr Sandip Ghosh "egregiously disclosed the identity of the rape victim by using her name on no fewer than six occasions". "This deliberate and reckless act of naming the victim was done in the presence of various media outlets, thereby amplifying the violation and causing ir-

reparable harm to the dignity and privacy of the victim, the complaint read. "The public disclosure of the victim's identity is not merely a breach of law but also a moral transgression that perpetuates the trauma of the victim and deters others from seeking justice," it added. Advocate Basu, the complainant, said, "It is well-established under the law that the identity of rape victims must be safeguarded to protect their dignity, as enshrined under Section 72 of the Bharatiya Nyaya Sanhita (BNS). Furthermore, this protection is reinforced by the Hon'ble Supreme Court of India and the Hon'ble Calcutta High Court, both of which have consistently upheld the sanctity of such provisions. The actions of Sandip Ghosh not only contravene these legal provisions but also exhibit a blatant disregard for the directives laid down by the highest echelons of our judiciary." Repeated calls to the DGP office, office of the Kolkata Police Commissioner, office of the Joint Commissioner of Police (Crime) and office of the Additional Commissioner of Police, Kolkata went unan-

Amid protests by junior doctors, Ghosh resigned as the principal of R G Kar Medical College and Hospital on Monday, taking "moral responsibility" for the rape and murder of the trainee doctor. While Ghosh's ouster was one of the demands of the protesting doctors at RG Kar Hospital, his appointment as the principal of Calcutta National Medical College and Hospital within hours sparked further outrage and protests. A court in Chhattisgarh's Bilaspur Tuesday sentenced a 34-yearold man to death for having murdered his wife and three children this January saying the act was "predetermined, grave, barbaric, (and) horrifying where innocent and helpless children were murdered by a man who was supposed to be their natural guardian". According to court records, the incident occurred on the night of January 1 in Hiri village, where the convict Umendra Kevat is said to have strangled his 32-year-old wife Sukrita and then used the same rope to kill his three children — two daughters Khushi (5) and Lisa (3) and son Pawan (18 months). The couple had been married in 2017 and Umendra is stated to "suspect" his wife of cheating. He is also known to have assaulted his wife in the past but the couple's families' are believed to have intervened to settle it

Umendra tried to hang himself using the same rope with which he killed his family but it broke. He eventually surrendered to the police. The court's sentence came after it examined 16 witnesses and 54 documents. In its ruling, the court said the accused was "neither mentally ill nor of unsound mind". "There are no signs of remorse on his face. Reason for the crime, cruelty, method, rela-



tionship of the parties and the trust between them, three children being innocent, helpless and unarmed, motivation of the accused, weakness of the deceased, horror of the crime and execution of the crime. All these facts and circumstances make the case rarest of the rare," the order, written in Hindi, saidlt further said that in view of the crime, "he (the accused) does not have the right to live in the society and if judicial humility is shown to him, then considering it as judicial paralysis, he will be encouraged to commit such crimes and then it will be difficult to run this society with the help of law""There is no scope for improvement in this matter and he is not fit to rejoin society. In this case, it would be appropriate in the better interest of the society to give (the) death penalty to the accused," court held.

Donald Trump loses third bid for judge to step aside in hush money case: Defendant has provided nothing new...'

A New York judge declined for a third time to step aside from the case in which Donald Trump was convicted of charges involving hush money paid to a porn star, dismissing the former U.S. president's claim of conflict of interest related to political consultancy work by the judge's daughter.

As he did in April and in August 2023, Justice Juan Merchan in a decision released on Wednesday denied a request by Trump's lawyers that he recuse himself from the first case involving criminal charges against a former U.S. president. Merchan is scheduled to sentence Trump on Sept. 18."Defendant has provided nothing new for this Court to consider. Counsel has merely repeated arguments that have already been denied by this and higher courts" and were "rife with inaccuracies and unsubstantiated claims," Merchan wrote in the ruling, dated Aug. 13.

A spokesperson for the Manhattan District Attorney's Office declined to comment. "The Highly Conflicted Judge should have long ago recused himself from this case, Trump campaign spokesperson Steven Cheung said in a statement. Trump was found guilty by a jury on May 30 on 34 felony counts of falsifying business records for having covered up former personal lawyer and fixer Michael Cohen's \$130,000 payment to adult film actress Stormy Daniels to avert a sex scandal before the 2016 U.S. election. Two months later, his lawyers made their third request that Merchan step aside, arguing that his daughter's work for a political consultancy that has counted Democratic campaigns among its clients - including the unsuccessful bid by Kamala Harris for the 2020 Democratic presidential nomination - posed a conflict of interest. Harris, now vice president, is the Democratic presidential candidate facing Republican nominee Trump in the Nov. 5 U.S. election.

Falsifying business records is a crime punishable by up to four years in prison, though sentences such as fines or probation have been more common for others convicted of that crime. Prosecutors with Manhattan District Attorney Alvin Bragg's office, which brought the charges, had called Trump's recusal request a "frivolous" attempt to relitigate an issue that was resolved twice before. "No amount of overheated, hyperbolic rhetoric can cure the fatal defects in defendant's ongoing effort to impugn the fairness of these proceedings," prosecutors wrote

The payment to Daniels was made in exchange for her silence before the 2016 election about a sexual encounter she has said she had with Trump a decade earlier, which Trump denied. Trump went on to win the presidency by defeating Democrat Hillary Clinton.Merchan rejected a recusal request in April before jury selection in the trial and last year after an ethics panel found that his daughter's work did not pose reasonable questions about the judge's impartiality. During the trial, Trump took to his social media platform to deride Merchan as a "highly conflicted" overseer of a "kangaroo court." Ahead of the trial. Trump wrote on social media that Merchan's daughter 'makes money by working to 'Get Trump,'" comments that in part contributed to Merchan's decision to expand a gag order to bar the former president from commenting publicly about family members of court staff or prosecutors. Trump's lawyers separately have asked the judge to throw out his conviction in light of the U.S. Supreme Court's July ruling giving former presidents broad immunity from prosecution for official acts taken in office. Merchan has said he will decide on Trump's arguments

Kamala Harris' campaign manipulating headlines within Google search ads to suggest major publishers backing her:

Vice President Kamala Harris' campaign team has been subtly manipulating news headlines in Google search results to give the impression that major media outlets support her, according to Axios. This revelation comes amidst critics questioning Harris for keeping a distance from significant interviews and media appearances since declaring her candidacy for president. The modified headlines, which were all accompanied by a banner that read "Paid for by Harris for President," were altered without the news outlets' knowledge, the report stated. The fake headline campaign involved around a dozen publishers, including well-known outlets including CBS News, PBS, Reuters, The Guardian, and The Associated Press.Her campaign has even changed headlines of even small publications, such as WDay Radio in North

Launching sponsored ads on Google, Harris' campaign has been linking to actual news articles from different sources with customised headlines and descriptions created, a tactic that Google and industry analysts referred to as "common." The headline of one sponsored advertisement that directs viewers to NPR's website reads, "Harris will Lower Health Costs." while another healine from AP says, "VP Harris' Economic Vision - Lower Costs and Higher Wages," as per Axios. In another instance, the Guardian headline saying, "VP Harris Fights Abor-

tion Bans - Harris Defends Repro Freedom," includes supporting text beneath it reading, "VP Harris is a champion for reproductive freedom and will stop Trump's abortion bans". Representatives from the impacted firms, including CNN, USA Today, and NPR, all of which had released positive stories for Harris in recent weeks, claimed they were unaware that their organisations were linked with the campaign.

"While we understand why an organisation might wish to align itself with the Guardian's trusted brand, we need to ensure it is being used appropriately and with our permission. We'll be reaching out to Google for more information about this practice," a spokesperson for the Guardian asserted. A representative for Gannett, the parent company of USA TODAY, clarified that they were unaware about the Harris campaign's move about using their content. As a news organisation, the spokesperson said that they are dedicated to making sure that their stories are disseminated responsibly, upholding the greatest standards of accuracy and integrity. Despite being deceptive, the strategy does not break Google's guidelines because the phony advertisements are clearly marked as "sponsored" and "easily distinguishable from search results.3

An insider close to the Harris campaign's advertising staff claims that the campaign purchases search advertisements that include news links to provide people looking for information regarding the Democrat presidential candidate with more context. The campaign adhered to Google's regulations, although some advertisements may not have had the required disclosures when they appeared due to a technical issue in Google's Ad Library. A Google representative verified the glitch and stated that the company is conducting an inquiry into what went wrong. "Election advertisers are required to complete an identity verification process and we prominently display in-ad disclosures that clearly show people who paid for the ad," said the spokesperson.

US consumer inflation records smallest annual rise since March 2021, clearing way for Fed to begin cutting rates

Year-over-year inflation reached its lowest level in more than three years in July, the latest sign that the worst price spike in four decades is fading and setting up the Federal Reserve for an interest rate cut in September. Wednesday's report from the Labor Department showed that consumer prices rose just 0.2% from June to July after dropping slightly the previous month for the first time in four years. Measured from a year earlier, prices rose 2.9%, down from 3% in June. It is the mildest year-over-year inflation figure since March 2021.

The government said nearly all the increase last month reflected higher rental prices and housing costs, a trend that, according to real-time data, is easing.

For months, cooling inflation has provided gradual relief to America's consumers, who were stung by the price surges that erupted three years ago, particularly for food, gas, rent and other necessities. Inflation peaked two years ago at 9.1%, the highest level in four decades.Inflation has taken a central role in the presidential election, with former President Donald Trump blaming the Biden administration's energy policies for the price increases. Vice President Kamala Harris on Saturday said she would soon unveil new proposals to "bring down costs and also strengthen the economy overall." Excluding the volatile food and energy categories, so-called core prices climbed 0.2% from June to July, after a 0.1% increase the previous month. Compared to a year ago, core inflation rose 3.2%, down from 3.3% in June, the lowest since April 2021. Core prices are closely watched by economists because it typically provides a better read of where inflation is headed.

Fed Chair Jerome Powell has said he is seeking additional evidence of slowing inflation before the Fed begins cutting its key interest rate. Economists widely expect the Fed's first rate cut to occur in mid-September. When the central bank lowers its benchmark rate, over time it tends to reduce the cost of borrowing for consumers and businesses. Mortgage rates have already declined in anticipation of the Fed's first rate reduction.At a news conference last month, Powell said that cooler inflation data this spring had strengthened the Fed's confidence that price increases are falling back to a 2% annual pace. Another inflation report will be issued next month before the Fed's Sept. 17-18 meeting, with economists expecting that report to also show that price increases remained mostly tame. Inflation has eased substantially in the past two years as global supply chains have been repaired, a spate of apartment construction in



many large cities has cooled rental costs and higher interest rates have slowed auto sales, forcing dealers to offer better deals to potential car buyers. Consumers, particularly lower-income ones, are also becoming more price-sensitive, forgoing high-priced items or shifting to cheaper alternatives. This has forced many companies to rein in price hikes or even offer lower prices. Prices are still rising sharply for some services, including auto insurance and nealth care. Auto insurance costs have shot up as the value of new and used vehicles has soared compared with three years ago. Economists, though, expect those costs to eventually grow more slowly.

As inflation continues to decline, the Fed is paying increasingly close attention to the job market. The central bank's goals, as defined by Congress, are to keep prices stable and support maximum employment. This month, the government reported that hiring slowed much more than expected in July and that the unemployment rate rose for a fourth straight month, though to a still-low 4.3%. The figures roiled financial markets and led many economists to boost their forecasts for interest rate cuts this vear. Most analysts now expect at least three guarterpoint rate cuts at the Fed's September, November and December meetings. The Fed's benchmark rate is at a 23-year high of 5.3%. Still, the rise in the unemployment rate has reflected mainly an influx of job-seekers, especially new immigrants, who haven't immediately found work and so have been classified as unemployed. That is a much more positive reason for a higher unemployment rate than if it came from a jump in layoffs. Measures of job cuts remain low.On Thursday, the government will release its latest data on retail sales, which are expected to show that consumers increased their spending modestly in July. As long as shoppers are willing to spend, businesses are likely to hold onto their workers and may

Raygun accused of scoring zero points at Olympics 'on purpose' as netizens call Holy Molly more 'skilled'

Shortly after the Olympics breakdancing event, footage of Chapman, AKA Holy Molly's performance, started making rounds on social media, with several users claiming that Gunn won solely because her husband was one of the judges. Various media reports suggest they have urged for an increase in the PM-KISAN installment from Rs 6,000

to Rs 8,000 annually. They also seek all subsidies to be directly transferred to farmers through DBT, along with additional funds for agricultural research in Budget 2024.

Introduced on February 24, 2019, the PM-KISAN scheme aims to assist land-holding farmers financially, provided they meet specific income-based criteria. Under the PM Kisan scheme, eligible farmer families across India receive Rs 6,000 annually in three instalments every four months via Direct Benefit Transfer (DBT). As of now, over 11 crore farmers have received payouts totalling more than Rs 3.04 lakh crore. With the upcoming disbursements, the total payout since the scheme's inception will exceed Rs 3.24 lakh crore. Recently, upon his third term's start, Prime Minister Narendra Modi's initial decision was to release the 17th instalment, benefiting 9.3 crore farmers and involving an approximately Rs 20,000 crore distribution. The PM-KISAN scheme, a central sector initiative, provides income support to all landholding farmers' families nationwide. These individuals are exempt from paying tax

Filing the income tax return (ITR) is an essential duty of an Indian citizen and failure to do so can attract legal repercussions such as penalties, increased tax scrutiny, etc.lt is important to note that every individual in the country needs to file their income tax returns, even if their income is not taxable or they are not paying any income tax. Filing the ITR by July 31 of a financial year helps avoid penalties.

Under the Income Tax Act in India, specific groups residing in certain regions of select states are eligible for exemptions from paying income tax. These exemptions are given based on predefined criteria such as income thresholds, socio-economic standing, and occupations of individuals within these communities. These targeted tax relief measures aim to reduce the financial burden on marginalised populations in these areas, promoting fair opportunities for all. Exemptions for residents of Northeastern States and UTs

"Under Section 10(26) of the Income Tax Act in India, members of Scheduled Tribes residing in Tripura, Mizoram, Manipur, Nagaland, Assam, Arunachal Pradesh, and the Ladakh region of the Union Territory of Jammu and Kashmir are exempt from paying income tax," said Rohit Jain, Managing Partner, Singhania & Co.Exemptions for individuals in certain areasAs outlined in Section 10(26) of the Income Tax Act, a specific category of income is exempt from income tax obligations. This exemption pertains to income generated within specified areas or states, in the form of dividends or interest on securities. More specifically, this exemption applies to members of a Scheduled Tribe who reside in regions designated within the Constitution.

"This exemption also applies to those living in specific areas within these regions, including the North Cachar Hills District, Karbi Anglong District, Bodoland Territorial Areas District, Khasi Hills District, Jaintia Hills District, and Garo Hills District in Meghalaya. The exemption covers income generated within these specified areas, including income from dividends or interest on securities. However, income from renting property or conducting business outside these regions is not eligible for the exemption," said Rohit Jain, Managing Partner, Singhania & Co.Additionally, the states of Manipur, Tripura, Arunachal Pradesh, Mizoram, Nagaland, and the



Ladakh region are also covered under this exemption. Claiming tax exemption

One can claim tax exemption under Section 10(26) by filing an income tax return (ITR). Since their incomes qualify for tax exemptions based on the nature of that income, these individuals need to disclose the income generated and the exemption. Individuals belonging to Scheduled Tribes residing in several northeastern states and the Ladakh region of the Union Territory of Jammu and Kashmir are required to submit Income Tax Returns (ITRs) if their earnings exceed the limit set by the Income Tax Department. It is essential for them to declare their total income and avail the exemptions provided under Sections 10(26) and 10(26AAA) of the Income Tax Act. ITR exemption for certain senior citizens

An individual resident aged 60-79 is considered a Senior Citizen for Income Tax purposes, while a Super Senior Citizen is someone aged 80 years or older. These classifications impact tax benefits and exemptions, and compliance with regulations for each category is crucial for accurate tax filing and financial planning. Under Section 194P of the Income Tax Act, individuals who are 75 years old or above and receive pension income along with interest income from a specified bank account are eligible to opt out of filing their Income Tax Return (ITR). To proceed with this option, qualifying seniors need to complete a declaration in Form 12BBA. The form must be submitted to the designated bank where the pension and interest income is received. The bank will then assess and deduct the applicable income tax based on the information provided in the form.

SMEs on IPO spree in April, May as corporates mobilise nearly Rs 85,000 crore from equity offerings

In just the first two months of financial year 2024-25 (FY25), Indian corporates have mobilised Rs 84,866 crore through equity issuances, including initial public offerings (IPO), follow-on public issues and preferential allotment. In the twelve months of FY24, corporates had raised Rs 67,956 crore from the IPO market and are expected to mobilise over Rs 1 lakh crore through primary issuances in the current fiscal.Leading the equity issuance surge during the first two months were IPOs from the small and mid-cap (SME) segment, with 44 of these companies getting listed in the first two months of the current fiscal (FY25). This comes amid the Securities and Exchange Board of India (Sebi) Chairperson Madhabi Puri Buch raising concerns over manipulation in the listing of SMEs a few months back.

While 44 companies got listed on SME platforms of the BSE and the NSE in April and May, there were a total of 52 listings (main board IPOs plus SME IPOs) during the two month period. In fiscal 2023-24, the total number of SME companies that were listed was 196.A total of 21 SMEs got listed in April, raising Rs 527 crore, while there were 23 SME IPOs which mobilised Rs 673 crore in May, according to the data from Sebi data.

In March this year, the Sebi Chairperson had said that there were signs of price manipulation in SME IPOs and trading of such shares in the secondary market. "The reality is that SMEs are relatively small entities, the market is small, the free float is small, it is relatively easy to manipulate both at the IPO level and the trading level," Buch had said. Some of the SMEs that raised capital through IPO route in April and May 2024 included ABS Marine Services (Rs 96.29 crore), Trust Fintech Ltd (Rs 63.45 crore), Creative Graphics Solutions India (Rs 54.4 crore), Quest Laboratories (Rs 43.16 crore) and Indian Emulsifiers (Rs 42.39 crore). All SME IPOs witnessed higher participation from retail investors and also were listed at a premium. In order to check volatility in the listing of SMEs, NSE, on Thursday, introduced an overall capping of 90 per cent on the opening price discovered during a special pre-open session for IPOs on its SME platform. This means the listing day price of any SME cannot go above 90 per cent of the issue price.On an overall basis, Indian corporates mobilised Rs 84,866 crore through equity issuances, including initial public offering (IPO), both mainboard and SME platform, follow-on public offering and preferential allotment in the first two

months of fiscal 2024-24, the SEBI data showed.

Indian corporates raised Rs 67,956 crore from the IPO market in FY24 and they are expected to mobilise over Rs 1 lakh crore through primary issuances in the current fiscal. The rise in the number of companies raising money through IPOs can be attributed to the strong macroeconomic growth of the country, stable government and interest rates, and ease in inflation. According to Sebi data, corporates did not raise money through the followon public offer route in May this year. However, in April, Rs 18,000 crore was raised through a single FPO of Vodafone Idea, which was the largest issue in the country. Funds amounting to Rs 3,798 crore were raised through 20 rights issues in April and May. Funds raised through preferential allotment during the two months stood at Rs 32,695 crore. The amount raised through QIP (Qualified Institutional Placement) stood at Rs 14,512 crore in the period.In May 2024, Rs 1,207 crore was mobilised through the public issue of debt, compared to the Rs 687 crore raised during April. Private placement of debt raised Rs 61,227 crore in May, compared to Rs 30,508 crore in

What's your pick: Ready to cook or ready to eat?



Managing work, family and personal commitments often leaves us with limited time to cook. Pre-packaged food alternatives like ready-to-cook and ready-to-eat meals become increasingly attractive in these situations. While both offer undeniable convenience, the question still persists: are these convenient meals as healthy as cooking from scratch? Garima Dev Verman, a Certified Nutritionist and Medical Content Analyst with The Healthy Indian Project (THIP), breaks down the key differences and sheds light on their nutritional value. Garima clarifies the distinction between these two categories:

"Ready-to-cook meals are already prepared to some extent, but might require further cooking steps like microwaving. Think of Haldiram's retort pouches. Ready-to-eat options, on the other hand, are good to go straight from the package, like popcorn, namkeen (savoury snacks), or khakras (flatbreads)."Convenience Comes at a CostWhile convenience is a major benefit, Garima cautioned against the potential downsides. "Ready-to-cook and ready-to-eat meals often lack the robust nutritional value of fresh ingredients," she explained. "They tend to be higher in sodium to enhance shelf life." This raises a

red flag, as excessive sodium intake can contribute to health problems like high blood pressure.

"Similar to how pickles use salt and mustard oil for preservation, pre-packaged meals rely heavily on sodium and sometimes sugar to extend shelf life. While these preservatives benefit the companies, they're not exactly health-friendly."Hidden sugars can also lurk in sauces and dressings. Nutritionists emphasise the importance of freading labels. "Consumers need to become label detectives. Companies create mass-produced products, and preservation is a necessity. This is why they use sugar and other additives. It's crucial to be aware of these hidden ingredients."

Garima acknowledged the ideal scenario: "If time allows, cooking a fresh meal with whole ingredients is always the best option for optimal nutrition." However, she recognises the realities of busy lifestyles. "For those short on time, ready-to-cook or ready-to-eat options can be an occasional solution. But remember, anything packaged, whether it's namkeen or biryani, isn't the healthiest choice."She recommended making informed choices: "Read the ingredient lists and nutrition labels carefully. When possible, prioritise fresh ingredients. Remember, India has a rich culinary tradition, and cooking delicious meals doesn't have to be complicated. It's a skill worth investing in for your health."While ready-to-cook and ready-to-eat meals offer convenience, they shouldn't become the norm. By understanding their nutritional limitations and developing label-reading skills, you can make informed choices and maintain a healthy balance in your diet. If a person is not able to cook a meal every day, what you can do is make dal, deep freeze it, suggested Garima, adding that resist the urge to rely on pre-made snacks as

If you're familiar with the concept of purple shampoo, this won't come as a shocker! The internet has been abuzz with purple toothpaste, claiming to whiten yellow teeth and spread happy smiles all around. What's got us curious, is to find out how these toothpastes work and whether they are safe to use in the long run.Dr Aditya Sharma, dentist, said, "It doesn't whiten the teeth as such, but just uses the colour theory, which ends up hiding the yellow hue and gives the appearance of much whiter teeth. While it removes stains to a lesser extent, purple toothpaste work better as colour correctors compared to teeth whitening agents."

"Unlike traditional ones, purple toothpaste contains V34 colour corrector serum which is the main differentiator. Much like what is used in purple hair toners," said Dr Kamlesh Kothari, cosmetic dentist and maxillofacial surgeon, Kolkata. According to him, the toothpaste releases purple micro-particles (Red 33 and Blue 1 dyes) onto your teeth, which when mixed with yellow stains produces a white colour. While it does not change the internal colour of teeth, it does remove surface stains and enhance your smile for a few hours. This colour correction is akin to makeup for your teeth, not a substitute for your daily oral hygiene routine, Kothari further explained.Dr Niyati Arora BDS, MDS (prosthodontist) at Krown Hub Dental Clinic, Pitampura, said that oral care solutions containing purple dyes can frequently be used regularly, but it's crucial to adhere to the unique directions that come with each prod-

The initiative comes after France experienced a bedbug scare in the lead-up to the Olympics. To prevent a similar crisis, South Korea has deployed Ceco and his team at its main airport to inspect arriving passengers and their belongings. According to Dr Narendra Singhla, Lead Consultant - Internal Medicine at CK Birla Hospital, Delhi, the effects of bedbug exposure can range from mild to severe. "Short-term consequences include itchy skin, irritation, and even allergic reactions in susceptible individuals," he explains. The psychological toll is also considerable, as the constant worry and discomfort associated with bedbug infestations can lead to heightened stress and anxiety. The long-term implications of bedbug exposure are equally concerning. Chronic skin issues can develop due to repeated bites and scratching, Dr Singhla said. Sleep disturbances are common, as the knowledge of these pests sharing your bed can make it difficult to relax. Moreover, the persistent mental anguish caused by the infestation can contribute to broader mental health concerns. While the risk of transmitting diseases like Chagas disease through bedbugs is relatively low, Dr Singhla emphasises the importance of taking preventive measures. Chagas disease, also known as American trypanosomiasis, is a serious parasitic illness primarily found in Latin America. It's caused by the parasite Trypanosoma cruzi and is typically transmitted through the bite of an infected triatomine bug, often called a "kissing bug."





Vinesh Phogat to return to India on August 17, says Bajrang Punia

Paris Olympics: Wrestler Vinesh Phogat will land in New Delhi on Saturday, August 17, Bajrang Punia said in a social media post. The Court of Arbitration for Sport (CAS) will announce the verdict on Vinesh Phogat's disqualification Vinesh Phogat will return from Paris and land in New Delhi on Saturday, August 17 at 10 am IST, fellow wrestler Bajrang Punia said in a social media post on Wednesday. Vinesh left the Games Village on Monday but did not return home even as the verdict on her appeal against disqualification was pending. The Court of Arbitration for Sport (CAS) verdict was expected to be out on Tuesday. However, an ad-hoc panel of the CAS deferred the verdict until Friday, August 16.Bajrang Punia shared a poster on social media, announcing the details of Vinesh Phogat's arrival and celebrations that have been planned along her route on Saturday, August 17.

Vinesh Phogat was feeling 'a little better' and began eating on Monday before leaving the Games Village. In exclusive photos accessed by India Today, the wrestler was seen carrying her bags out for the Games Village. The rest of the Indian contingent, including flagbearers at the closing ceremony Manu Bhaker and PR Sreejesh, returned to India earlier in the week and were felicitated in the capital city by Union Sports Minister Mansukh Mandavya. Notably, Prime Minister Narendra Modi will host the Indian athletes from the Paris Olympics at his

residence on Independence Day and congratulate the Olympians who competed hard at the Games. Vinesh was disqualified from her women's 50kg gold medal match after failing a weigh-in ahead of the final. Vinesh was found 100 grams overweight on the second day of the weigh-in. Vinesh had cleared the weigh-in on the opening day of the event and went on to win three matches and reach the final. One of those three victories included a sensational upset of Yui Susaki, the Japanese wrestler, who had an 82-0 international record until facing the Indian on the mat on Tuesday.

The International Olympic Committee (IOC) disqualified Vinesh Phogat and allowed Cuba's Guzman Uzneylys, who lost to the Indian in the semi-final, to compete in the gold medal bout against USA's Sarah Ann Hilderbrant on August 7Vinesh appealed against her disqualification, knocking on the doors of the ad-hoc panel of the Court of Arbitration for Sport in Paris. The appeal against her disqualification was filed as early as August

Notably, the Sole Arbitrator of the ad-hod division of the CAS, Dr Annabelle Bennett, initially extended the deadline for the announcement of the verdict until August 13, allowing both parties -- applicant Vinesh Phogat, the respondents United World Wrestling and the International Olympic Committee, as well as Indian Olympic Association as an interested party -- to submit more evidence and proofs, backing their arguments.Dr. Annbelelle heard the arguments of both parties in a hearing that lasted three hours on August 9 after registering Vinesh Phogat's appeal a day earlier. While the initial appeal was filed by French pro-bono lawyers for Vinesh, the IOA roped in senior counsels Harish Salve and Vidushpat Singhania to represent the wrestler at the hearing. The lawyers argued the weight gain on Tuesday evening was due to the body's natural recovery process and that it is the athlete's fundamental right to look after his/her body. They argued her body weight was under the prescribed limit on Day 1 of the competition, and the weight gain only happened because of recovery and that's not a fraud.
