## Vinesh Phogat cries inconsolably on return to heros welcome after Paris Olympics heartbreak

New Delhi, GNS News Agency, August 17

Celebrated wrestler Vinesh Phogat on Saturday received a grand welcome on her return to the country with hundreds of supporters gathering outside the IGI airport, showing immense solidarity with her. Stars such as Bajrang Punia, Sakshi Malik and panchayat leaders received Vinesh, who endured a heartbreaking exit at the Paris Olympics where she was disqualified for being overweight on the day of her 50kg final. Heavily garlanded, Vinesh stood in an open Jeep and thanked all the supporters. "I thank the entire country," she said, her hands folded in humility.

There was a thick security cover as Phogat, who was found 100 grams overweight, landed in the national capital. Vinesh's caravan left for her native village Balali in Haryana and on the way she met her supporters, positioned at different spots. A group of 50 followed her jeep. They offered prayers at a temple in Delhi's Dwarka before continuing their journey towards Balali. Vinesh had stayed back in Paris after challenging her disqualification in the Court of Arbitration for Sport (CAS) and demanding a joint silver. The application was dismissed on Wednesday. "She has come back to her country after such a long time. She is very emotional also. She will spend time with family and calm herself. What Vinesh has done for women is praiseworthy. She might not have received a medal, but she is a champion for us," said Sakshi Malik.

London Olympics bronze medal-winning shooter Gagan Narang, who was the chef de mission of the Indian contingent in Paris, called her a champion, posting a photo with Phogat at the Paris airport. Both of them were on the same flight to Delhi. "She came as a champion on day 1 into the games village and she will always



remain our champion. Sometimes one doesn't need an Olympic medal to inspire a billion dreams.. @vineshphogat you have inspired generations. Salute to your grit," Narang posted on X. "People are waiting to welcome her at our village. People are exciting to meet Vinesh and encourage her," her brother Harvinder Phogat said. The feisty wrestler, in her first reaction after her disqualification, on Saturday said that under "different circumstances" she could see herself competing till 2032 because she still has a lot of wrestling left in her but is now unsure about her future as things "might never be same again". Vinesh had announced her retirement from the sport after her disqualification. In an emotional post on social media, Vinesh shared her childhood dream, the hardships she faced after losing her father and also put on record the contribution made by people in her extraordinary journey that ended in heartbreak in Paris.

#### 'I haven't committed any mistake':

#### Karnataka CM Siddaramaiah rules out resignation

In the wake of sanction for prosecution granted by Karnataka Governor Thawar Chand Gehlot in connection with the alleged Mysuru Urban Development Authority (MUDA) scam against Chief Minister Siddaramaiah, the CM said on Saturday that he has not committed any mistake and will not resign from his post. Siddaramaiah, while speaking to reporters in Bengaluru, said that the prosecution sanction issued against him was a conspiracy of the Central Government, the BJP and JD(S) leaders.

"The Governor had taken the decision without having any authority or jurisdiction. It is totally unconstitutional and we will fight it out legally.... Because it is an illegal sanction given by the Governor who is a puppet of the Central Government," Siddaramaiah said. The CM said that there was no case against him or anybody in connection with the MUDA scam. "The BJP has no moral right to ask for my resignation. The Governor is biased against me," he said, noting that the Governor was sitting on prosecution sanction requests against Union Minister and former CM H D Kumaraswamy, former state ministers Shashikala Jolle, Murugesh Nirani and Janardhan Reddy. "They (the BJP) are not tolerating this government. This government has implemented all guarantee schemes which is for poor people of all communities and religions. The Central Government is against social justice, poor people," he said. To a question, he said that the Congress high command was with him and the entire Cabinet was with him. Siddaramaiah has been facing flak from the Opposition in the state for an alleged land deal involving the allotment of 14 housing sites in Mysuru to his wife and the theft of Rs 89.73 crore from a state development corporation for the welfare of Scheduled Tribes.

### Centre's olive branch to striking doctors: Will form panel for safety measures

The Central Government has proposed the formation of a committee to address the safety concerns of doctors on strike. This committee will include input from all relevant stakeholders, including state governments.

Doctors and students protest against the alleged rape and murder of a trainee doctor at the RG Kar Medical College and Hospital, in Kolkata. The Union Health Ministry on Saturday asked doctors to end their nationwide strike against the gruesome rape and murder of the trainee doctor at Kolkata's RG Kar Hospital and assured them that a committee tasked with proposing safety measures for healthcare professionals will be formed. This committee, as per the centre, will include input from all relevant stakeholders, including state governments, who will be invited to share their insights and suggestions. This came as doctors across the nation are holding a 24-hour strike in protest against the brutal murder and rape of a trainee doctor at a state-run medical college in Kolkata. During the protest, all health services — except for essential services and emergency care — were suspended. The medical community is demanding justice

and urgent reforms, including an overhaul of resident doctors' working and living conditions and the implementation of a central law to protect healthcare professionals from workplace violence.

Doctors, paramedics and support staff take out silent protest march in south Delhi demanding justice in the Kolkata rape-murder case. Union Health Ministry officials met the representatives of the Federation of Resident Doctors Association (FORDA), the Indian Medical Association (IMA), and Resident Doctors' Associations of Governmental Medical Colleges and Hospitals in Delhi today.

#### Union Minister Rammohan Naidu meets Chandrababu in Delhi, says Aviation Services will be enhanced

In a statement issued here on Saturday, the IDA announced withdrawal of dental services for 24 hours from August 17 to August 18 and said, "it is imperative that the entire nation recognizes the gravity of this situation and the pressing need for enhanced protection and respect for all healthcare workers."

#### PM Modi proposes Global Development Compact to propel Global South

New Delhi: Prime Minister Narendra Modi on Saturday proposed a comprehensive 'Global Development Compact' on behalf of India to the countries of the Global South. "The foundation of this Compact will be based on the experiences of India's development journey and development partnerships. This Global Compact will be driven by the development priorities set by the countries of the South themselves," PM Modi said in his closing remarks at the Inaugural Leaders' Session of the Voice of Global South Summit 3.0.

"It will be human-centric, multi-dimensional and promote a multi-sectoral approach to development. It will not burden needy countries with debt in the name of development finance. This will contribute to the balanced and sustainable development of partner countries," the Prime Minister said. He further clarified that the 'development compact' will focus on trade for development, capacity building for sustainable growth, technology sharing, project-specific concessional finance and grants.

"To boost trade promotion activities, India will launch a special fund of \$2.5 million. Training in trade policy and trade negotiation will be provided for capacity building. A fund of one million dollars will be provided for this," PM Modi said.He said that India is contributing to the SDG Stimulus Leaders group for financial stress and development funding in the countries of the Global South and will



also work to provide affordable and effective generic medicines to the Global South. "We will also cooperate in the training of drug regulators. We will be happy to share our experiences and technology of natural farming in the agriculture sector," he added. He also said that global tensions and conflicts which were highlighted at the conference were a serious matter and addressing these concerns depends on just and inclusive global governance. Such institutions must give priority to the Global South while developed countries also fulfil their responsibilities and commitments. "There is also a need to take action to reduce the gap between the Global North and South and the Summit of the Future at the UN to be held next month could become an important milestone for all this," PM Modi added.

### Closely monitoring monkeypox situation, no new reported cases in India: Centre

New Delhi: The government on Saturday said they are closely monitoring the global monkeypox situation, and preparedness and cautionary measures are being put in place to prevent and control the spread of the disease. There are no new reported cases of monkeypox in India as of date, said the Health Ministry. In the meeting with senior ministry officials, chaired by Health Minister JP Nadda, it was decided that as a matter of abundant caution, certain measures are put in place. These are sensitising the health units at all the airports, seaports and ground crossings, readying the testing laboratories and gearing up health facilities for detecting, isolating and managing any case. The meeting was called in view of the World Health Organisation (WHO) declaring Monkeypox a public health emergency of international concern (PHEIC). In the meeting, it was noted that Monkeypox infections are usually self-limiting lasting between 2-4 weeks and patients generally recover with supportive management.

The transmission requires prolonged close contact with an infected case and is generally through the sexual route, direct contact with body/lesion fluid, or contaminated clothing/linen of an infected person. Globally, since 2022, WHO has reported 99,176 cases and 208 deaths due to monkeypox from 116 countries. Since the 2022 declaration by WHO, a total of 30 cases were detected in



India with the last case in March 2024. The Centre said that a joint monitoring group meeting, under the chairmanship of the Director General of Health Services consisting of experts from relevant fields, was held to review the situation. Although the possibility of a few imported cases being detected in the coming weeks is not entirely ruled out, it was assessed that the risk of a large outbreak with sustained transmission is presently low for India.

After reports of Mpox cases in Sweden and Pakistan surfaced, infectious disease experts urged health authorities to begin screening for the deadly infectious disease at key airports in India to help curb the spread.

#### Befitting reply to BJP govt's conspiracies: Rahul Gandhi on HC order on assistant teachers' selection in UP

Leader of Opposition in Lok Sabha Rahul Gandhi on Saturday said the Allahabad High Court's decision on the recruitment of 69,000 assistant teachers is a befitting reply to the "conspiracies of the BJP government which is playing with the reservation system"

The former Congress chief's remarks came after the Allahabad High Court directed the Uttar Pradesh government to prepare a fresh selection list for the appointment of 69,000 assistant teachers in the state."The Allahabad High Court's decision on the recruitment of 69,000 assistant teachers is a befitting reply to the conspiracies of the BJP government which is playing with the reservation system," Gandhi said in a post in Hindi on X.

This is not only the victory of thousands of youths like Amit Maurya who have been struggling in the streets in winter, summer and rain for the last five years but also of every warrior fighting the battle for social justice, he

said."The BJP's stubbornness to snatch away reservation has pushed the future of hundreds of innocent candidates into darkness," Gandhi alleged. The BJP is the culprit for those who will get jobs through the new list after facing hardships for five years and also those whose names will now be removed from the selected list."The BJP government, which is forcing those who want to study to fight, is the enemy of the youth in the true sense," Gandhi said. He also tagged one of his posts from February in which he had said, "UP's 69,000 teacher recruitment scam is proof of BJP's anti-reservation mentality. By ignoring Basic Education Rules, 1981 and Reservation Rules, 1994, the BJP government snatched the rights of Dalits and backward classes from them." "The aggrieved students met me and told me that in this recruitment, OBC category got only 3.86% reservation instead of 27% and SC category got only 16.6% reservation instead of 21%. This irregularity is related to about 19,000 posts and not making the original list brings this entire recruitment process under suspicion," he had said.

The HC set aside the selection lists issued in June 2020 and January 2022, which included 6,800 candidates. A bench comprising Justice A R Masoodi and Justice Brijraj Singh issued the order while disposing of 90 special appeals filed by Mahendra Pal and others, challenging a March 13 single-judge order.

The court upheld the single-judge's decision to cancel the January 5, 2022 selection list of 6,800 candidates belonging to the reserved category. The bench instructed the state government and other authorities concerned to complete the process of issuing the new selection list within three months. The court said that while preparing the new selection list, any adverse impact on the currently employed assistant teachers should be mitigated by allowing them to complete the ongoing academic session. This is intended to prevent disruption in the students' education, it said.

#### How school children from Kerala's Kozhikode are using class breaks to help their peers in Wayanad

Lubna Raihana, a Class 4 student at the aided Jinarajadas Lower Primary School in the coastal Marad village of Kerala's Kozhikode district, has had a busy few days. Every school break this past week, she and her classmates would quickly finish their food and then hurry back into class to complete a major task at hand: meticulously and painstakingly copying down notes for the first semester in new notebooks.

These notes, made under the guidance of their teachers, were meant for the 138 lower primary students of two government schools at Mundakkai and Chooralmala — the two villages most affected by the land-slide last month. Nearly closed down after communal riots tore through the serene fishing village of Marad 20 years ago, the Jinarajadas school is now scripting a chapter on compassion. Over the last week, these students were sorted into different groups to make notes in five subjects — Malayalam, English, Arabic, Maths and Environmental Science. While some students read out from their own notes, others copied it down while their teacher stood by, guiding and correcting them where needed.

Each class was tasked with making notes for their corresponding peers from the two government schools. The notes for the entire first semester, which ends by the end of August, were made ready for their peers in Wayanad since the landslide is expected to significantly disrupt their regular schooling. Notes of all five subjects, now in a single bound book, will be handed over to the schools in Wayanad Thursday.

Said school headmaster E.M.Pushparajan: "These students have lost their study materials in the tragedy. Many agencies have offered to replace the lost textbooks, bags and other items. But their lost school notes could not be supplied in that manner. Hence, at our school, we decided to help them by preparing their school notes". The idea, according to teacher E.Dijesh Kumar, is to ensure that their learning is not lost.

But for students like Lubna, this is the only help they could give their peers in Wayanad. "We're all saddened by the stories of our fellow students, who lost their dear ones and belongings in the landslide... When teachers told us about the plan, we were all in for it," she said. The 110-year-old Jinarajadas school had hit headlines after the Marad communal riots in 2003 and 2004, which left 14 people, both Hindus and Muslims dead. Soon after the riots, both communities were reluctant to send their children to school, pushing it to the brink of closure. The school eventually went on to play a key role in bringing the strife-torn village back together by organising outreach programmes and camps. In 2007, then Communist Party of India (Marxist) legislator and businessman VKC Mammed Koya took over the management of the school and upgraded its infrastructure. As the embers of the hatred cooled off over the years, attendance to the school also grew. Today, Jinarajadas LP School has a total of 450 students on its roll.

### IPS Nalin Prabhat appointed new DGP of Jammu and Kashmir, set to assume charge from Oct 1

The Ministry of Home Affairs (MHA) Thursday appointed 1992-batch IPS officer Nalin Prabhat as the Director General of Police (DGP) of Jammu and Kashmir. He is set to assume charge from October 1. Till then, he will work as the Special Director-General (DG) of the Jammu and Kashmir Police. had reported that the Centre was considering appointing Prabhat, 56, as the new DG of the Jammu and Kashmir Police amid the rising terror attacks in the Jammu region since June 9 in which the security forces have suffered casualties.

In an order on Thursday, the Centre said, "Consequent upon joining the AGMUT cadre on inter-cadre deputation from AP cadre, Prabhat is hereby posted as Special DG, J&K police with immediate effect and till September 30. Further, upon retirement of R R Swain, IPS of 1991-batch of AGMUT-cadre on September 30, Prabhat is appointed as DGP, J&K police from October 1, and until further orders..."On Wednesday, the Appointments Committee of the Cabinet (ACC) sanctioned the intercadre deputation of Prabhat, who was the DG of the National Security Guard (NSG), from Andhra Pradesh to Arunachal Pradesh-Goa-Mizoram and Union Territory (AGMUT) cadre for three years. The decision to change Prabhat's cadre came just three months after he was appointed as the NSG DG. Earlier, ACC approved his appointment as the NSG DG until August 31, 2028.Before joining the NSG, Prabhat was the additional director general and Special DG of the Central Reserve Police Force (CRPF), and headed its formation in Jammu and Kashmir. He also previously held the post of the Deputy Inspector General (DIG) of the Kashmir and the South Kashmir sectors, among others. He did his BA (Hons) and MA from St Stephen's College. Prabhat is a threetime police gallantry medal winner and has headed the specialised anti-Naxal police force 'Greyhounds' of Andhra Pradesh, his former cadre state. Union Home Minister Amit Shah chaired multiple meetings with senior officials including Ajit Doval, National Security Advisor; J-K Lieutenant Governor Manoj Sinha, along with Indian Army and CRPF officers, to come up with new strategies in the wake of an uptick in terror attacks in the Union

### Congress slams PM Modi's 'communal civil code' remark, says his 'capacity for malice knows no bounds'

Targeting Prime Minister Narendra Modi for his Independence Day speech where, while mentioning the need for a Uniform Civil Code (UCC), he called the existing one "communal" and "discriminatory", the Congress said on Thursday that it was "a gross insult" to Dr B R Ambedkar.Congress communications chief Jairam Ramesh wrote on X, "The non-biological PM's capacity for malice, mischief, and maligning of history knows no bounds. It was on full display today in his Red Fort speech. To say that we have had a 'communal civil code' till now is a gross insult to Dr Ambedkar, who was the greatest champion of reforms in Hindu personal laws that became a reality by the mid-1950s. These reforms had been bitterly opposed by the RSS and the Jana Sangh."

Ramesh also quoted a 21st Law Commission's Consultation Paper on Reform of Family Law, dated August 31, 2018, which said that a UCC "is neither necessary nor desirable at this stage". "While diversity of Indian culture can and should be celebrated, specific groups or weaker sections of society must not be disadvantaged in the process. Resolution of this conflict does not mean abolition of all differences. This commission has therefore dealt with laws that are discriminatory rather than providing a uniform civil code which is neither necessary nor desirable at this stage. Most countries are moving towards recognition of differences and the mere existence of difference does not imply discrimination, but is indicative of a robust democracy," he wrote in his X post, quoting the paper. The Uniform Civil Code has been a part of the BJP's Lok Sabha election manifestos since

"In our country, the Supreme Court has repeatedly discussed the Uniform Civil Code. It has given orders many times because a large section of the country believes, and there is truth in it, that the civil code with which we are living is really a kind of communal civil code, a discriminatory civil code," Modi said in his address from the Red Fort.Congress president Mallikarjun Kharge said in his speech at the party headquarters after the flag hoisting ceremony that the Government was "promoting divisive thinking"



"Instead of remembering the contribution of freedom fighters and following the path shown by them, today's Government is promoting divisive thinking. With the intent to spread hatred, they celebrate the 'Vibhajan Vibhishika Diwas' (Partition Horrors Remembrance Day). Those who didn't take part in the freedom struggle are giving advice to the Congress and are trying to show they were part of the struggle. This is a factual truth that it was their hatred-filled politics which divided the country into two parts. This partition happened because of them," said the leader of the Opposition in the Rajya Sabha. "For their selfish gains, the British ideology of divide and rule is being taken forward by the Sangh family, and there is no lack of evidence for the same," he added. Rashtriya Janata Dal MP Manoj Kumar Jha said that after making "Islamophobic remarks, the prime minister has now started talking of a secular civil code". "The most worrying aspect is that in his 11th year, the PM couldn't understand that he is the PM of the country, and those who didn't vote for him or are in Opposition don't have a separate PM. Whenever we have hoped that he will show a bid heart, we have been disappointed. We must under stand something which is decent is said in an indecent manner, then it looks odd and doesn't suit your post. Whether it is (you) saying that some want destruction. #### '140 crore Indians want Hindus, minorities to be safe in Bangladesh': PM Modi in Independence Day speech

At a time when Hindus and minorities in Bangladesh have borne the brunt of numerous attacks, Prime Minister Narendra Modi, speaking from the ramparts of the Red Fort on the 78th Independence Day Thursday, called for peace. "I hope things will soon be normal in Bangladesh. 140-crore people want that Hindus, and minorities there be safe. We want that our neighbouring countries tread the path of peace and happiness," PM Modi said. The PM added that India will always be supportive of Bangladesh's growth and development.

Bangladesh's minority Hindus have faced more than 200 attacks in 50-odd districts since the fall of Sheikh Hasina's Awami League government on August 5. As policing collapsed, at least five people were reported killed in attacks on Hindu families, institutions, and temples. According to Bangladesh's 2022 census, a little more than 13.1 million Hindus reside in the country, making up for 7.96% of the country's population. Other minorities (Buddhists, Christians, etc.) together constituted less than 1%. In an attempt to reach out to the Hindu community, Chief Advisor Muhammad Yunus, who is heading the interim government, also reached out on Tuesday with a visit to the Dhakeshwari Temple where he met community leaders and assured "justice" and "equal rights" for all.

'Rights are equal for everyone. We are all one people with one right. Do not make any distinctions among us. Please assist us. Exercise patience, and later judge what we were able to do and not do. If we fail, then criticise us," Yunus said, after meeting minority leaders. He said the administration would work towards a situation where Hindus and other minorities don't have to fear for their safety. On August 8, as Yunus was sworn in, Prime Minister Narendra Modi had extended his best wishes and urged him to ensure "the safety and protection of Hindus and all other minority communities". This direct reference to the safety of Hindus and other minorities in Bangladesh underlined Delhi's expectations from the new players in Dhaka."In our democratic aspirations, we should not be seen as Muslims, Hindus or Buddhists, but as human beings. Our rights should be ensured. The root of all problems lies in the decay of institutional arrangements. That is why such issues arise. Institutional arrangements need to be fixed," Yunus said on Tuesday. "We have to establish human rights and freedom of speech. That is our

#### Maoists kill 16-year-old boy for being 'police informer' in Chhattisgarh's Sukma district

A 16-year-old boy was allegedly beaten to death by Naxalites in Puarti village in Chhattisgarh's Sukma district late Tuesday evening. According to the police, Soyyam Shankar was killed on suspicion of being a police informer. Significantly, over a dozen civilians have been murdered in Naxalite violence in Sukma this year. Puarti is a Naxal stronghold and home to at least two dreaded Naxal leaders - Barse Deva, chief of People's Liberation Guerrilla Army (PLGA), and his predecessor Madvi Hidma, now the Maoist commander-in-chief for South Bastar.Sukma Superintendent of Police Kira Chavan said Soyvam was still wearing his school uniform when he was killed at around 8-9 pm Tuesday. "His family had shifted to Palnar (in the neighbouring Dantewada) but he had gone to Puarti to meet his relatives to mourn the death of his sister-in-law," Chavan said. The scene of the alleged incident is barely 3 km away from a new police camp in Puarti. The camp was made in February after security forces pushed a PLGA unit further back into the dense Sukma forest. Soyyam's body was brought to Sukma district headquarters, where a postmortem was conducted at the district hospital. An FIR for murder has been registered at Jagargunda police station, police said. Puarti is a few kilometres from Tekulagudem, a site of several Naxalite encounters. On January 31, two elite Commando Battalion for Resolute Action (CoBRA) commandos and a Central Reserve Police Force (CRPF) jawan were killed in a gun battle between security forces and the PLGA in Tekulagudem.In April 2021, 23 jawans were killed in an encounter with

#### Govt's plan to control vegetable prices: New urban farming clusters to boost supply

The Centre plans to develop 50 vegetable clusters near cities having over 20 lakh population over the next five years with an investment of `2,000 crore to ramp up vegetable production and supply chains through public private partnership.

According to sources, the Agriculture Ministry is in the process of drawing up contours of the scheme, which is expected to be finalised and approved by the Union Cabinet soon. According to a source, the scheme is expected to benefit over 2 lakh farmers near big cities and aimed at providing remunerative prices to them while curbing the role of middlemen. It also aims to ensure uninterrupted supply of fresh vegetables at reasonable prices to consumers, the source said.

The scheme will engage Farmer Producer Organizations (FPOs) and cooperative bodies to control volatility in prices and supply of tomato, onion and potato. When there is glut in the market, the crop does not fetch a good price for farmers, and during shortage, consumers feel the heat of price rise, the source said. Data released by the National Statistical Office (NSO) Monday showed that the food inflation rate slipped to a 13-month low of 5.42% in July, from 9.36% in June. Food inflation has hovered between 8-9% during the last eight months as prices of vegetables, cereals and pulses have stayed consistently elevated. Among food items, the inflation rate of vegetables eased to 6.83% in July from 29.32%. In her Budget speech on July 23, Union Finance Minister Nirmala Sitharaman had proposed setting up vegetable clusters near big cities for ramping up production and supply chains. "Large-scale clusters for vegetable production will be developed closer to major consumption centres. We will promote Farmer Producer Organisations, cooperatives and start-ups for vegetable supply chains including for collection, storage, and marketing," Sitharaman had said. A source said the clusters, to be developed in partnership with implementation agencies from private sector, FPS and cooperative bodies for fresh vegetables, would be set up in a radius of 50 km from cities like New Delhi, Mumbai, Chennai, Kolkata, Bengaluru and Hyderabad among others. Consumers can buy vegetables in their locality from retail shops and vending trucks/vans.Under the scheme, support will be provided to select implementing agencies, decentralised cold storage facilities, procurement of vending trucks/vans and for fruit and vegetable processing, a source said. The scheme will have a provision to support the agencies to set up at least 10 kiosks/retail outlets at 10 strategic locations in residential areas like apartment complexes, soci-

#### 45% Indian-Americans went after 2010, median age below US average: Report

AROUND HALF of the over 5 million Indians residing in the United States migrated after 2010. With a median age of 36 years, the Indian-American community is, in fact, younger than that of the US average. Also, around 3,20,000 work visas — a staggering 73% of the total work visas the US allocated in 2022-23 — were issued to Indians. These findings figure in the latest report of USbased non-profit organisation Indiaspora, prepared in collaboration with the Boston Consulting Group. Titled 'Small Community, Big Contributions, Boundless Horizons: The Indian Diaspora in the United States', the report takes note of the ways in which this relatively small community 1.5 per cent of the total US population — continues to have an impact on multiple aspects of American life, from the economic to the cultural. Quoting data from the Migration Policy Institute, the impact report says that of the Indian diaspora's 5.1 million people in the US, about 2.8 million are first-generation immigrants. Approximately 30 per cent of them migrated to the US before 2000, while around 45% made the move after 2010. The community is largely concentrated in New York State and California. According to the most recent census, their median age is 36 years — a bit younger than the median population of the US as a whole, says the report, which was released by External Affairs Minister S Jaishankar and US Ambassador to India Eric Garcetti in Delhi on Tuesday. The median income of the Indian-Americans around \$136,000 - is almost double than that of the US average, according to the report.

"Indian-Americans account for only 1.5% of the US population, yet they continue to have an outsized and positive impact across different aspects of US society." said Indiaspora founder M R Rangaswami.Incidentally, former PepsiCo CEO and Chairman Indra Nooyi and former US Ambassador to India Ken Juster are members of the Steering Committee in preparing the report. While the United Arab Emirates is home to the largest segment of the Indian diaspora, the US is home to the second largest, the report says. The biggest draw for them is the educational offerings in the US.

According to the report, 78% Indian-Americans hold

bachelor's degrees or higher, which outpaces the US national average of 36%. According to Boston Consulting Group estimates, members of the community contribute 5-6% (\$300 billion) in tax revenues annually, on top of the \$370-\$460 billion in annual spending, which translates into a major economic wave in terms of sales tax, business growth, and support of employment. From Silicon Valley tech giants to global conglomerates, Indianorigin leaders are steering some of the most influential companies, the report says.Indian-origin CEOs were at the helm of 16 Fortune 500 companies in 2023 (3%), managing enterprises that generated roughly \$978 billion (5%) in revenues and employed 2.5 million people (9%) across the globe that year. As many as 72 unicorn startups out of 648 in the US are led by Indian-origin founders, with their collective value eceeding \$195 billion, employing 55,000 people (approximately 13% of the unicorn workforce). Quoting a 2020 study by the National Bureau of Economic Research and Harvard University, the report says the Indian diaspora's share of patents increased from 1.9% in 1975 to 10% in 2019.

Many diaspora members come to the US to study. According to Open Doors data for 2022-2023, around 2,70,000 students from India pursue graduate and undergraduate degrees in US universities. This accounts for 25% of the international student population in the US, says the report. There is a preference for studies in STEM (Science, Technology, Engineering, and Mathematics) subjects among the Indian students, with over 70% enrolled in engineering, computer science, or life science programmes — along with 10% in business/management programmes - as of 2023. Around 60% of them are enrolled in graduate-level programmes. In healthcare, Indian-origin physicians comprise 10% of all doctors in the US, serving 30% of the patients. According to data collected by the Asian American Hotel Owners Association, Indian Americans own around 60% of all US hotels, generating \$700 billion in revenue and creating over 4 million jobs, directly and indirectly. Indian Americans also own an estimated 35%-50% of all convenience stores in the US.However, the Pew Research Center estimates that about 6% of the group lives below the poverty line with the complexities of undocumented migration comprising a significant contributing factor. Approximately 14% Indian-Americans were undocumented in 2021, making them the third-largest undocumented migrant group in the country. The report is the first volume in a series to look at the impact of the Indian diaspora, with a focus on public service, business, culture and innovation. In addition to various statistics, the project also profiles the diaspora leaders across economic and cultural

#### Indian Army to procure cutting-edge tech to detect enemy drones near border areas

Army to procure advanced system to detect enemy dronesParameters such as range of detection and other technical parameters will be submitted by the vendors when they submit their bids. The Indian Army is set to procure an advanced version of the Integrated Drone Detection and Interdiction system (MK IIA) to counter the growing threats from unmanned aerial systems, particularly along the western and northern borders. As per the Army, the proposed system should have a surveillance, detection and tracking capability, microprocessor for computing a targeting solution and a LASER weapon system for hard kill or destruction and jamming capability for soft kill or denial. A Request for Information (RFI) was published last month by the Army to seek details about the system from prospective vendors.

The fresh RFI comes within months after the Army inducted indigenous integrated drone detection and interdiction systems in the northern border along the China border in the northern sector and is reflective of the efforts to develop and procure counter drone systems in the wake of an increase in threats from enemy unmanned aerial systems. Developed by Defence Research and Development Organisation (DRDO) and Bharat Electronics, the Army Air Defence had got seven of these systems, five of which were inducted for deployment close to the northern borders. These systems too had both soft and hard kill options.



Apart from these indigenous systems, other improvised systems with different counter-UAS capabilities have been deployed by the Armed Forces. This includes prototypes of laser-based systems developed indigenously with Army Air Defence, improvised versions of ZU-23 and L/70 guns for drone detection and killing, adhoc handled jammers, low-level lightweight radars, among others. The Armed Forces have inducted antidrone systems from Indian private firms and the Israeli SMASH 2000 plus systems to tackle enemy drone threats. Parameters such as range of detection and other technical parameters will be submitted by the vendors when they submit their bids. However, the RFI states that it should have a radar system that should be able to detect and track low RCS targets, and assist in designation of the hostile targets to the weapon system.

#### EC reviews J-K security situation with Home Secy for holding Assembly polls

THE ELECTION Commission Wednesday held a meeting with Union Home Secretary Ajay Bhalla to review the security situation and the requirement of forces for holding Assembly elections in Jammu and Kashmir.EC sources said the deployment of forces would be "over and above" that for the Lok Sabha polls held earlier this year. The commission, comprising Chief Election Commissioner Rajiv Kumar, Election Commissioner Gyanesh Kumar and Election Commissioner Sukhbir Singh Sandhu, had visited the Union Territory last week to review preparations on the ground. On Wednesday, the EC met Bhalla and discussed the possible increase in the number of security personnel for the Assembly polls compared to the Lok Sabha polls, sources said.

Given the security situation in the UT, all candidates would require security cover, leading to an increase in the requirement, sources said. The Assembly elections are also expected to be more contested, they said. The EC's review also took into account the recent spike in terror activities in Jammu, sources said. Since the last Assembly elections in J&K were held in 2014, the morerecent Lok Sabha elections would be taken as the benchmark for deciding force deployment, said an official.


While upholding the abrogation of Article 370, the Supreme Court last year had directed the Election Commission to hold Assembly elections in J&K by September 30, 2024. Ahead of the deadline, the EC has started the process of preparing the updated electoral roll, which is scheduled to be published on August 20. The ongoing Amarnath Yatra pilgrimage is scheduled to end on August 19. Speaking at a press conference in Jammu last week, the CEC said the commission was committed to holding Assembly elections in the UT at the earliest. Jammu and Kashmir hasn't had Assembly elections since 2014 and had no Assembly since it was dissolved in 2018. If held, the upcoming elections would be the first in 10 years and the first since the state was split into two Union Territories - Jammu & Kashmir and Ladakh - in

#### Amid growing Ukraine threat, India issues advisory to nationals in Russia: 'Temporarily relocate to safer areas'

The Embassy of India in Russia issued an advisory on Wednesday for Indian nationals living in the Bryansk, Belgorod, and Kursk regions. The advisory states that citizens, including students, residing in these regions are advised to temporarily relocate to safer areas due to recent "security incidents" following the intensification of the Russia-Ukraine war.

The advisory was issued shortly after Russia's Belgorod border region declared an emergency due to heavy shelling by Ukrainian forces, who are continuing a major cross-border incursion into the adjacent Kursk region for a second week. An emergency had already been declared in Kursk last Saturday after Ukrainian forces launched an incursion on August 6, marking a significant escalation in the conflict, with both sides reporting casualties and territorial gains."In view of the recent security incidents in Bryansk, Belgorod and Kursk regions, Indian nationals are advised to take necessary precautions and temporarily relocate outside these regions," the Indian embassy stated. For those needing assistance or guidance, the embassy has provided a dedicated email address and telephone number. "Any Indian national or stu-



dent requiring any assistance may contact the Embassy at email: edul.rnoscow@mea.gov.in or telephone number +7 965 277 3414," the advisory added. #### Over 800 birth certificates issued from single ID in UP village in 2 years, probe ordered

Authorities in Uttar Pradesh's Hathras have found out that a single user ID from a village was used to issue birth certificates for 814 individuals in multiple states in less than two years, prompting them to launch a probe.Officials said Sinchawali Sani village has a population of roughly 1,100. However, over the last 19 months, a total of 814 birth certificates were issued using the village's user ID for the Civil Registration System (CRS).

"These certificates have been issued not only for residents of Uttar Pradesh but also for individuals in other states, including Jharkhand, Bihar, Madhya Pradesh, Haryana and Karnataka," an official said. "So far, it has been found that 780 certificates were issued in Uttar Pradesh, 13 in Jharkhand, 12 in Bihar, four each in Madhya Pradesh and Haryana, and one was issued in Karnataka. The number of such cases may increase as the investigation progresses," the official said. Gram Panchayat Officer Ishwar Chand, who is responsible for Sinchawali Sani, said he received access to the CRS portal on August 5. "By then, 814 birth certificates were already issued through the ID. All of these certificates listed Sinchawali Sani as the place of birth," Chand, who reported the matter to senior officials, said District Magistrate Ashish Kumar said a probe has been initiated. Chief Medical Officer (CMO) of Hathras Dr Manjeet Singh, who has been tasked with leading the investigation, said efforts are on to determine how the ID was leaked. "The ID was recently assigned to the panchayat secretary of Sinchawali Sani. The inquiry will focus on uncovering the source of the leak and the extent of the misuse," he

#### CBI summons 5 doctors for interrogation; 9 held in vandalism incident

The CBI has requested the call details of the civic volunteer arrested in the rape and murder of a trainee doctor in Kolkata. The special crime branch of the Central Bureau of Investigation (CBI) in Kolkata summoned five doctors on Thursday for interrogation in connection with the rape and murder of a post-graduate trainee last week.

The crime branch team also questioned the officerin-charge of Tala police station, which has jurisdiction over the area where the incident took place. Abhijit Mondal, the officer-in-charge at Tala police station, was seen arriving at the CBI special crime branch office earlier today, intensifying the focus on the local police's role in the case.

A large group of unidentified men stormed into the hospital around 12.40 am in the middle of the junior doctors' ongoing agitation. The attackers vandalised the emergency department and nursing station and did not spare the medicines stores. They also damaged CCTV cameras and ransacked a stage where junior doctors had been demonstrating since August 9. The police resorted to lathi-charge and lobbed tear gas shells to dis-

perse the mob.TMC national general secretary Abhishek Banerjee condemned the vandalism at RG Kar as exceeding "all acceptable limits," urging Kolkata Police Commissioner Vineet Goyal to arrest everyone responsible "within the next 24 hours, regardless of their political affiliations."Goyal said an investigation is underway and mentioned that a "malicious media campaign" might have exacerbated the situation.

"My men have also been injured in the attack... What have police not done to crack this case? But there has been a malicious media campaign that has been going on," he said. A mobile forensic unit from the West Bengal Police arrived at the hospital's emergency ward on Thursday to gather evidence. West Bengal chief minister Mamata Banerjee said that those who vandalised RG Kar Hospital were not connected to the student movement

"They are outsiders. I have seen as many videos, I have three videos as I can see, in which some people are holding national flags, they are BJP people, and some are DYFI are holding white and red flags," she alleged.Banerjee also commended the police for their restraint during the chaotic event. "Yesterday, the police were also attacked...Police were attacked... I would like to congratulate them that they did not lose patience, they did not hurt anyone," she added. Governor Bose visited the hospital on Thursday afternoon to assess the situation and spoke with agitating doctors."Yesterday's vandalism is a shame to civil society. It's a shame to all of humanity that young girls are not protected. This bloodbath cannot be allowed anymore. This must stop," Bose told reporters. ### 'Certain political parties...': Mamata Banerjee on mob attack at Kolkata's RG Kar Hospital

Mamata Banerjee on Thursday claimed 'certain political parties' were behind the mob attack at Kolkata's RG Kar Medical College and Hospital, where doctors are protesting the August 9 rape and murder of a junior doctor. The West Bengal chief minister also stated that she has 'no complaints' against the striking medics.

"Police are looking into the matter. I don't have any complaints against the students or the agitating doctors. But there are certain political parties trying to foment trouble. If you go through the video (of the attack), you will get to see what happened," she told reporters, according to PTI.According to India Today, Banerjee specifically named opposition BJP and Left as having orchestrated the violence. "I saw flags of the Left and BJP...the way they attacked the police. One of my officers-in-charge was missing for one hour. Later, he was found wounded. But the police did not list the patients. They did not use force. We have done a lot of aandolan (agitation) and never done things like that inside hospital," it quoted the Trinamool Congress supremo as saying.

Banerjee's statement came a day after she alleged that the opposition was trying to 'capture power' in West Bengal through 'Bangladesh-like protests' in the RG Kar

#### Assam police launch search ops after ULFA-I claim bombs planted across state

According to the police, the outfit purportedly sent an email to several media houses, after which the news became public, creating panic among the peopleGuwahati: The Assam police on Friday launched a massive search operation after the United Liberation of Asom-Independent (ULFA-I), a banned insurgent organisation, claimed they had placed 24 bombs across the state on independence day, officials said. Officials said that during the searches, which were carried out by bomb squads, several bomb-like items were recovered, adding that no blasts occurred at any place.

According to the police, the outfit purportedly sent an email to several media houses, after which the news became public, creating panic among the people.In the email, the outfit mentioned the areas where the so-called bombs were placed, said police. It named two locations in Sibsagar and Lakhimpur, one in Lakuwa, Dibrugarh, Laluk, Borghat, Nagaon, Nalbari, and Tamulpur, and eight locations in Guwahati.The outfit stated that bombs were placed at five other places in Tinsukia, Dibrugarh, Golaghat, and Sarupathar but did not specify their exact locations. However, it asserted that the bombs did not explode due to "technical failure".According to a state-



ment from ULFA-I's publicity wing, the blasts were scheduled to take place between 6am and 12pm on independence day, but it did not happen due to technical failure and urged the public to find the bombs and deactivate them.In a post on X, Assam police chief GP Singh said that at two places in Guwahati, suspicious articles were found by the bomb disposal squad. He added that these articles did not have ignition devices. "The substance inside is being sent for forensic/chemical examination". He added that similar articles were recovered from Lakhimpur, Sibsagar, Nalbari, and Nagaon, which have been safely disposed of.

### 2 IED-like objects found in Guwahati after ULFA(I) claims 24 bombs planted across Assam

GNS News Agency, August 17

The banned militant outfit United Liberation Front of Asom (ULFA) (Independent) on Thursday claimed to have planted bombs at 24 locations across Assam, triggering a massive search operation by security forces. In an email sent to media houses, the anti-peace talk faction of ULFA asserted that the bombs failed to detonate due to "technical failure" and urged public cooperation in defusing the explosives. While it provided details for 19 specific locations, the outfit said the locations of five more explosives could not be ascertained. The Assam Police swung into action, deploying bomb disposal squads, metal detectors, and sniffer dogs to all the locations identified in the email."Bomb disposal squads, metal detectors and sniffer dogs have been dispatched to every location. So far we have not got any information on recovery of bombs," a senior officer at Assam Police headquarters said. Of the 24 locations named by ULFA(I), eight are in Guwahati, including an open field at Last Gate in Dispur, near the official residences of Assam chief minister Himanta Biswa Sarma and other ministers. Other areas mentioned in the email include Satgaon Road near the Army cantonment in Narengi, as well as Ashram Road, Panbazar, Jorabat, Bhetapara, Maligaon, and Rajgarh. While the police couldn't find any suspicious objects at six locations, they



recovered two IED-like objects in Panbazaar and Gandhi Basti. "We thoroughly searched eight locations. Out of these locations, we could not find any suspicious objects in six of them, however, in Panbazaar and Gandhi Basti, we found two IED-like objects," Guwahati Commissioner of Police Diganta Barah told reporters. Sivasagar, Dibrugarh, Lakhimpur, Nagaon, Nalbari, Tamulpur, Tinsukia and Golaghat districts were also named by ULFA(I) in its list of 24 locations. Police have closed all roads in and around the places mentioned in the mail. Senior police officials have rushed to all the places and are monitoring the search operations.

### 'Deploy central forces at RG Kar Hospital': BJP's Suvendu Adhikari urges Union home secretary

BJP's Suvendu Adhikari, Leader of Opposition (LoP) in the West Bengal assembly, on Thursday sought deployment of central paramilitary forces at the RG Kar Medical College and Hospital, following the 'mob attack' at the Kolkata-based institute.

In a letter to Union home secretary Ajay Kumar Bhalla, he claimed that 'goons' sent by the state's Trinamool Congress government, attacked the hospital to 'destroy' evidence of last week's rape-murder of a


trainee doctor, an incident that has led to protests by the country's medical fraternity.

However, there were no reports of casualties. Weather forecast The Srinagar Meteorological Centre had issued an advisory predicting light to moderate rainfall across Jammu and Kashmir. The advisory warned of "light to moderate rain/ thundershower at most places of J&K on August 15" and similar weather conditions extending into the early morn-



ing of August 16-20. Fairly widespread to widespread light to moderate rainfall is expected over Himachal Pradesh and Uttarakhand, with scattered to fairly widespread rainfall across Jammu and Kashmir, Haryana, Chandigarh, Delhi, Uttar Pradesh, and Rajasthan over the next four to five days, according to the IMD. ### Bangladesh developments 'clear reminder of how precious liberty is for us': CJI D Y Chandrachud

Chief Justice of India (CJI) D Y Chandrachud on Thursday said that the happenings in Bangladesh are "a clear reminder of how precious liberty is for us" and cited the Emergency to underline why "it is important that we dwell on the stories of the past to remind ourselves how precious liberty is".He was speaking at the Independence Day celebrations organised by the Supreme Court Bar Association

CJI Chandrachud said that in one of Rabindranath Tagore's poems, two birds, one of them caged, engage in a conversation, where one bird asks the other, "Would you prefer the security of being caged to the uncertainty of freedom?" He added. "Our Constitution made the choice for us. We chose in 1950, the uncertainty of freedom. And what is happening today, say in Bangladesh, is a clear reminder of how precious liberty is for us".CJI Chandrachud went on to add, "Many of the young lawyers today or most of them are the post-Independence generation. I am myself, I am the post-independence generation. But many of you are the post-Emergency generation. Therefore, it is very easy to take freedom for granted. It is simple to take liberty for granted, but it is important that we dwell on the stories of the past to remind ourselves how precious liberty is and what an important role which we as judges and lawyers play at our institution for the preservation of liberty."The CJI said that when India attained independence in 1947, the first task was for the Constituent Assembly to devise a Constitution that would serve the goals of a social revolution and

"Our Constitution put the marginalised and the disenfranchised front and centre in our national project of emancipation. It ushered in a reign of deliberative democracy inspired by the ideals of justice, liberty, equality and fraternity. And to meet these aims, the Constitution weaved an intricate network of democratic institutions. It established a representative, responsive and responsible government premised on parliamentary democracy and universal adult franchise," he said. "These ideas were no less than revolutionary for a country coming out of the



brutal clutches of colonialism. But our nation builders charted on a historic experiment of democracy – the largest to ever be conducted anywhere in the world. They did so because they realised the vitality of democratic institutions and universal adult franchise," CJI Chandrachud added. The CJI said that the "freedom struggle allowed us to reimagine the framework of our governance...many lawyers gave up their lucrative legal practices and dedicated themselves to the cause of the nation. They were instrumental, not only in achieving freedom for India but also in establishing a fiercely independent judiciary."

He added that the "task of patriotic lawyers did not end with India achieving her independence. Lawyers and the Bar have been a constant force of good in our country even after independence."The CJI said, "As a judge for the past 24 years, I can keep my hand on my heart and say that the work of the courts reflects the struggles of ordinary Indians navigating the rough and tumble of their daily lives." Pointing out that a modern judiciary requires an accessible and inclusive infrastructure, he said that in the last six months, the Supreme Court took many infrastructural initiatives. He, however, added that the work has only begun and much more is in store.CJI Chandrachud said that he is "of the firm opinion that the legal community has a responsibility to keep the moral consciousness of our society and the courts". "The Bar has been responsible for the direction of many important constitutional and legal developments in our country which have furthered the aspirations of our freedom fighters,"

#### Nalin Prabhat appointed Special DG of Jammu and Kashmir

GNS News Agency, August 17Hyderabad: One of the top notch counter-terrorism experts in the country, Nalin Prabhat, has been appointed as the Special Director General of Police of Jammu and Kashmir with immediate effect and till September 30, 2024. The IPS officer of 1992 batch will take over as the Director General of Police, after the retirement of the current DGP of Kashmir RR Swain on September 30.

Nalin Prabhat's posting as the Special DG 'with immediate effect' comes at a crucial juncture, as militancy in Jammu and Kashmir is believed to be resurfacing with intensified attacks on the Army personnel in the recent times. Known for his tough stand against subversive elements, Nalin Prabhat served in the maoist affected areas of Telangana, Andhra Pradesh and Chhattisgarh in vari-

ous capacities and is considered as one of the driving forces for containing the left wing extremism in different parts of the country. The highly decorated officer is currently serving as the Director General of the elite National Security Guards (NSG). Just a day before the Appointments Committee of the Cabinet (ACC) has issued orders curtailing his service as the NSG Chief and later his inter-cadre deputation from Andhra Pradesh to Arunachal Pradesh – Goa – Mizoram and Union Territories (AGMU) for three years was cleared by the Ministry of Home Affairs.

The 55-year-old officer is a highly decorated with three Gallantry medals and had a long stint in Kashmir as the CRPF's IG and Additional DG operations. While in Andhra Pradesh cadre, he served as SP of Karimnagar, Warangal and Andhra Pradesh Grey Hounds.

### Myanmar's Aung San Suu Kyi's house auctioned again, no bids received



The bidding was set at 300 billion kyats -- around \$140 million -- at the auction, according to the junta's official exchange rate of 2,100 kyat to the dollar.Myanmar's Aung San Suu Kyi's mansion goes without any bids at a second auction attempt

The lakeside mansion where Myanmar democracy leader Aung San Suu Kyi spent years under house arrest was put up for auction for the second time on Thursday but once again attracted no bids, AFP reporters said. The two-storey house and 1.9 acres of land were put up for sale following a decades-long dispute over the property between the Nobel laureate -- who has been detained since a 2021 military coup -- and her brother. The auction set the floor for bidding at 300 billion kyats -- around 140 million US Dollars at the junta's official exchange rate of 2,100 kyat to the dollar. Similar-sized properties in upmarket Yangon neighbourhoods might go for around one or two million dollars, a local realtor told AFP in

March.Ahead of the auction, a small crowd of mostly journalists gathered outside the colonial-era house on leafy University Avenue, a few doors from the US embassy.Above the gate, a portrait of Suu Kyi's father, independence hero Aung San, watched over the proceedings while armed police stood guard behind sandbags.A notice pasted to the door by a local court advertised "Buildings and every heirloom under the name of Daw Khin Kyi" -- Suu Kyi's mother.An auctioneer came out of the compound and asked three times for any buyers, then announced the auction was unsuccessful when none came forward.For around 15 years, Suu Kyi was confined within the house's crumbling walls by the military after shooting to fame during huge demonstrations against the then-junta in 1988.

Cut off from her husband and children in England, Suu Kyi spent time playing the piano, reading detective novels and meditating as her status as a democracy leader grew. Hundreds gathered regularly on the pavement outside the property to hear her talk about democracy and fighting military rule through non-violence. After her release in 2010, she continued to live in the villa, where she received a string of foreign leaders, journalists and diplomats.In 2012, then-US president Barack Obama lionised her as an "icon of democracy" during a visit to the home.Suu Kyi left Yangon in 2012 and moved to the capital Naypyidaw to govern as part of an uneasy powersharing arrangement with the military. She was detained there in the early hours of February 1, 2021 when the military seized power again, ending a 10-year experiment with democracy and plunging the Southeast Asian nation into bloody turmoil.

### Russian-American woman jailed for 12 years for donating \$50 to Ukraine charity

The woman, who pleaded guilty to the charges, was accused of sending money to fund equipment and ammunition for the Ukrainian army. A Russian court has sentenced Ksenia Karelina, a 33-year-old Russian-American woman, to 12 years in prison on charges of treason after she made a small donation of just over 50 US Dollars to a US-based charity that supports Ukraine. The verdict was delivered after a closed trial at the Sverdlovsk regional court, following Karelina's detention earlier this year while she was visiting her grandparents. Karelina, who pleaded guilty to the charges, was accused of sending money to fund equipment and ammunition for the Ukrainian army, according to RIA Novosti. Her lawyer, Mikhail Mushailov, has indicated plans to appeal the decision.

The sentencing comes just days after a major prisoner swap between Russia and Western countries, which saw the release of 24 individuals, including former US Marine Paul Whelan and Wall Street Journal reporter Evan Gershkovich. The Russian government has recently increased penalties for treason, with President Vladimir Putin raising the maximum sentence from 20 years to life imprisonment last year amid the ongoing war. Karelina, a resident of Los Angeles who became a US citizen in 2021, was visiting Russia for the first time in several years. Her



boyfriend, Chris Van Heerden, revealed that she had been excited about the trip, which he had arranged as a birthday gift. Van Heerden emphasised that Karelina was not politically engaged and had never spoken about the conflict between Russia and Ukraine. The New York-based non-profit Razom for Ukraine, the organisation to which Karelina allegedly donated, expressed its dismay at her arrest and conviction. The case has drawn significant attention, particularly due to the court's involvement in previous high-profile cases, including the conviction of Evan Gershkovich for espionage. Karelina's legal team remains hopeful for a potential inclusion in a future prisoner swap, although her lawyer acknowledges that such negotiations cannot proceed until the verdict is finalised.

### Bangladesh court begins genocide probe against Sheikh Hasina



The International Crimes Tribunal of Bangladesh launched an investigation against former PM Sheikh Hasina and nine others on charges of genocide and crimes against humanity that took place from July 15 to August 5 during student-led mass protests.

Bangladesh's International Crimes Tribunal has started an investigation against former prime minister Sheikh Hasina and nine others on charges of genocide and crimes against humanity that took place from July 15 to August 5 during students' mass movement against her government.A complaint was filed on Wednesday with the investigation agency of Bangladesh's International Crimes Tribunal against Hasina, Awami League general secretary and former road transport and bridges minister Obaidul Quader, former home minister Asaduzzaman Khan Kamal, and several other prominent figures within the party. The complainant's lawyer Gazi MH Tamim confirmed on Thursday that the Tribunal started the probe, The Dhaka Tribune newspaper reported. He said the investigation agency started the investigation on Wednesday night. The Hasina-led Awami League along with its affiliated organisations is also named in the petition. The petition was filed by Bulbul Kabir, the father of Arif Ahmed Siam, a Class IX student who was killed during the antidiscrimination student movement.

Kabir's application accuses Hasina and others of orchestrating a violent crackdown on student protestors, resulting in widespread casualties and human rights violations. The complaint came on a day when the interim government said that the murders conducted within the period from July 1 to August 5 would be tried by the International Crimes Tribunal.

Separately, a case of enforced disappearance was filed on Wednesday against Hasina and several others, including former ministers of her cabinet, on the charge of kidnapping a lawyer in 2015.On Tuesday, a murder case was filed against Hasina and six others over the death of a grocery shop owner during last month's violent clashes that led to the fall of her government.Meanwhile, a Dhaka court on Thursday asked police to submit by September 15 the probe report of the case filed against Hasina and six others over the death of grocery shop owner Abu Saeed in police firing in the capital's

Mohammadpur area during the quota protests on July 19. Dhaka Metropolitan Magistrate Md Zaki Al Farabi set the date after the case was placed before his court for the next course of action. The student-led protests demanding reforms in government job quotas evolved into a government-toppling movement in early August. Over 230 people died in Bangladesh in the incidents of violence that erupted across the country following the fall of the Hasina government on August 5, taking the death toll to 560 during the three weeks of violence. Following Hasina's resignation, a caretaker government led by Nobel laureate Muhammad Yunus was formed in the country, promising to address administrative and political reforms and hold accountable those involved in the violence.

## Resignations of officials close to Sheikh Hasina legal, says Yunus

ment, Nobel laureate Muhammad Yunus, says the highprofile resignations of authorities close to ousted Prime Minister Sheikh Hasina are legal after student leaders who organised protests against Hasina's government issued ultimatums for them to quit. "Legally ... all the steps were taken," Yunus, 83, told a group of journalists Sunday night. The country's chief justice, five justices and central bank governor have all resigned in the past few days, part of a dramatic transformation after weeks of protests against a quota system for government jobs turned into a mass uprising. Hasina resigned and fled to India last week. Yunus said a key priority of the interim government is to restore the independence of the judiciary. He called former chief justice Obaidul Hassan "just a hangman". Syed Refaat Ahmed was appointed the new chief justice on Sunday after his name was proposed by student leaders of the protests. Students vow to cleanse the political system of Hasina's rule, which they have denounced as autocratic. More than 300 people, including students and police officers, were killed in the weeks of violence. Yunus took over on Thursday after student leaders reached out. He said the students told him he was the only one they could trust. He said he accepted "because these are the guys who broke the local government," describing it as a "student-led revolution". "It's not my dream, it's their dream. So I'm kind of helping them to make it come true," Yunus said. The interim government is expected to announce a new election, but it is not clear when it will be held. Yunus had been a longtime critic of Hasina and her government. ### Iranian woman 'shows hair in public while driving', cops shoot her

On a darkened road beside the Caspian Sea, Iranian police officers opened fire last month on a 31-year-old woman who had tried to speed away likely knowing they wanted to seize her vehicle. Police had been ordered to impound her car, activists say, because of an earlier violation of Iran's headscarf law for showing her hair in public while driving. Now unable to walk and confined to a bed at a police hospital, Arezou Badri — a mother of two — is the latest casualty of Iran's renewed crackdown over headscarves, or hijabs. Her shooting occurred nearly two years after 22-year-old Mahsa Amini died while in police custody over an alleged headscarf violation, sparking nationwide protests over women's rights and against the country's theocracy.

As the September 16 anniversary of Amini's death approaches, Iran's new reformist President Masoud Pezeshkian has promised to ease enforcement of the headscarf law. But the murky details of Badri's shooting and a recent video of a girl being manhandled in the streets of Tehran show the dangers still lurking for those willing to disobey it. "They have elevated it to the most serious crime, where the police is allowed basically to shoot to kill," said Hadi Ghaemi, executive director of the New York-based Centre for Human Rights in Iran. "That's really a war on women."

Badri's shooting occurred around 11 pm on July 22 along a coastal road in Iran's northern Mazandaran province as she drove home from a friend's house with her sister, activists say. A brief account published by Iran's state-run IRNA news agency quoted police Col. Ahmad Amini as saying patrol officers had ordered a vehicle with tinted windows to stop, but that it didn't. It made no mention of the hijab violation or impound notice. Officers appear to have first fired at Badri's car's tires, according to the group Human Rights Activists in Iran, which spoke to people with knowledge of the shooting. As Badri continued driving, officers fired into the vehicle, the group said; the gunfire pierced her lung and damaged her spine. Under Iranian law, police must fire a warning shot, then aim to wound below the waist before taking a potentially fatal shot at a suspect's head or chest. If the suspect is driving, officers typically aim first for the tires.

Why police initially stopped Badri's car remains unclear, though activists blame it on the impound alert over the hijab violation. It's also unknown whether any police vehicle at the scene had a camera that recorded the shooting or if any officer there wore a body camera. There are no public statistics of fatal police shootings in Iran. Police firearms training and tactics vary widely, as some officers face more paramilitary duties in areas like Iran's restive Sistan and Baluchestan provinces. Iran's Interior Ministry, which oversees the country's police, did not respond to questions about the shooting from The Associated Press.

Authorities are holding Badri at a police hospital in Tehran under tight security, restricting her family's visits and stopping them from taking photographs of her, activists say. Despite that, an image of Badri was published by the BBC this week, highlighting her case."She has no sensation from the waist down and doctors have said that it will be clear in the coming months whether she is completely paralysed," said one activist in Iran, who requested anonymity for fear of reprisal. The hijab became a focal point of demonstrations after the death of Amini in 2022. She died after being arrested for not wearing her headscarf to the liking of police. A United Nations panel has found that Amini died as a result of "physical violence" used against her by the state.

Amini's death sparked months of protests and a security crackdown that killed more than 500 people and led to the detention of more than 22,000. After the mass demonstrations, police dialled down enforcement of hijab laws, but it ramped up again in April under what authorities called the Noor — or "Light" — Plan.The hijab crackdown remains widely discussed in Iran, even as police and state media rarely report on it. Many women continue to wear their hijabs loosely or leave them draped around their shoulders while walking in Tehran. Women driving without wearing hijabs are believed to have been tracked via surveillance camera technology provided by Chinese firms, matching their faces against a government-maintained photo database, Ghaemi said. If they are stopped, that can lead to physical altercations between women and the police. Surveillance footage published last week by the Iranian reformist news website Ensaf showed a 14-year-old girl manhandled by the morality police in Tehran. Her mother described her daughter's head as being rammed into an electrical box, a female officer pulling her hair and another putting their foot on her neck. Police described the officers' behaviour as unprofessional, but also accused the girl of using bad language"I saw my daughter with a wounded face, swollen lips, a bruised neck, torn clothes and she couldn't even speak," her mother, Maryam Abbasi, told the website. "Her eyes were so swollen from crying that they wouldn't

### Airports in Germany suspend flight ops after climate activists block runways

The Last Generation campaign group said in a statement that activists had stopped or reduced traffic at the Berlin, Cologne-Bonn, Nuremberg and Stuttgart airports. The group also published pictures of activists with their hands glued to the tarmac. Two German airports have temporarily suspended flights on Thursday morning after climate activists breached the airfields as part of a larger protest targeting four airports nationwide.

The Last Generation campaign group said in a statement that activists had stopped or reduced traffic at the Berlin, Cologne-Bonn, Nuremberg and Stuttgart airports and published pictures of activists with their hands glued to the tarmac. The Nuremberg airport said on its website that flights were suspended until further notice since 0342 GMT and warned that passengers would face delays, while the Cologne-Bonn airport said on social media platform X that flights are currently suspended while police are dealing with "unauthorised persons." Police were on site at the Berlin airport and were able to remove the two protesters, who had entered the airfield by cutting through a fence, and flight operations were unaffected, said a police spokesperson.



A Stuttgart airport spokesperson was not immediately available for comment. The group has listed several countries across Europe and North America where they said similar disruptions are planned as part of a protest campaign calling for the German government to pursue a global agreement to exit oil, gas and coal by 2030. German politicians have demanded better protection for the country's airports after climate activists were able to breach fences and disrupt air traffic, including at the country's busiest airport, Frankfurt, for two days in a row last menth.

#### UN team to visit Bangladesh next week to probe killings of protesters during students' agitation

Dhaka, A team of UN experts will visit Bangladesh next week to investigate the killings of the protesters ahe ad of and in the aftermath of Sheikh Hasina's resignation as the prime minister last week, it was announced on Thursday. This will be the first time the UN is sending a fact-finding mission to Bangladesh since its independence in 1971 to investigate widespread human rights abuses in the country, according to a UN official, said a post on X by the Chief Adviser of the Government of Bangladesh. Muhammad Yunus took oath as the Chief Adviser of the interim government on August 8, days after Sheikh Hasina's government collapsed and she fled to India on August 5 amid violent protests over quota reforms for government jobs.

"The United Nations is sending a UN fact-finding team next week to probe atrocities committed during the Student Revolution in July and early this month. UN human rights chief Volker Turk announced the move when he called Chief Adviser Professor Muhammad Yunus late Wednesday," the Chief Adviser of Government of Bangladesh said in a post on X, the handle for which is run by Yunus' office.Bangladesh descended into chaos last week after Hasina's departure while the Army stepped in to fill the power vacuum on August 5. Before that, the anti-government protests had killed more than 500 people since mid-July. Meanwhile, Turk assured his support and said an inclusive, human rights-centred approach will ensure the transition succeeds. "A team of UN experts would soon visit the country to investigate [the killings]," Volker Turk told Chief Adviser Professor Muhammad Yunus today during a phone conversation. Yunus said in a connecting post on X: The UN rights chief said a UN-led investigation will be launched very soon to probe the killing of the protesters during the Student Revolution. Human rights will be the cornerstone of his administration and the protection of every citizen is the top most priority of the government, Yunus, who has sought UN cooperation to uphold human rights, said. "The Chief Adviser thanked him and his long-time friend Antonio Guterres, the UN Secretary-General, for supporting the Bangladesh students' revolution and championing their rights during unprecedented and devastating killings of student protestors," Yunus said in the series of posts. Meanwhile, a complaint was filed on Wednesday with the investigation agency of Bangladesh's International Crimes Tribunal against Hasina and eight others, accusing them of committing genocide and crimes against humanity during the mass movement of the students against her government. #### Mining tax dues: Ruling to have large financial impact on mining cos; 'pass-on of costs may be inflationary'



According to a senior official in the Ministry of Mines, the ruling will have a major financial implication on mining companies, especially those mining coal and iron ore. These include both private companies and public sector undertakings (PSUs) that come under the mines ministry, the official said, adding that future investments in the mining sector could also be impacted by the ruling to tax retrospectively.

The ruling will lead to more costs being imposed on a primary sector like mining, which will make it "unviable", stakeholders from the industry said at the sidelines of a mines ministry event on Wednesday. Most metal stocks reflected this sentiment and closed in the red after the SC's ruling. India's largest iron ore miner NMDC Ltd fell 6.02 per cent to Rs 210.94. Coal India, the country's largest coal producer, dropped 3.26 per cent to Rs 504.70. JSW Steel dropped 1.93 per cent to Rs 890.30, Tata Steel 1.82 per cent to Rs 146.17, and Vedanta 0.50 per cent to Rs 420.20.Earlier, Solicitor General Tushar Mehta had told the SC that if the verdict is applied retrospectively, the tax demand on PSUs would be between Rs 70,000 to 80,000 crore. For the entire sector, the cumulative impact could be well around Rs 2 lakh crore, according to industry estimates.

"The burden would eventually go to the common man. Whether directly or indirectly, he will be the person who will bear the burden because no industry can absorb this. For example we made a rough estimate only for the public sector undertakings. This is rough and ready, it is still the process of calculation is going on, but the approximate demand, which the only PSU's are expecting would be somewhere in the vicinity of 70,000 to 80,000 crore," Mehta had said on July 31.

The nine-judge SC bench on Wednesday said the levy of interest and penalty on demands made for the period before July 25, 2024 shall stand waived and the

time for payment of tax "shall be staggered in instalments over a period of twelve years commencing from 1 April 2026". The July 25 judgment overruled the 1989 decision of a seven-judge bench in India Cement Ltd vs State of Tamil Nadu, which said royalty is tax and state legislatures lack competence to levy taxes on mineral rights because the subject matter is covered by an act of the Parliament in exercise of powers under the Union List of the Constitution. The verdict has paved the way for states to collect greater revenue from mining operations.

Now, with states empowered to tax royalty on mining production, experts said costs of primary goods, especially iron ore, may go up. "Typically, you need 1.6 to 1.8 tons of iron ore for a ton of steel. If you consider the total cost of steel production and work backwards, royalty is roughly 5 to 8 per cent of the selling price. It's not a small cost at all," said Rakesh Surana, a partner with Deloitte India. "What if the costs go up? If the costs go up, margin is eaten into. If the margin is eaten into, you can either pass it on or if not, it's obviously not good for the company. It impacts expansion plans, the ability to repay debt, etc. Even if you can pass it on, it creates an inflationary impact... there is a risk of that happening if this isn't well calibrated," Surana added. After the July 25 judgment, each state can now decide the quantum of cess on mining operations, as opposed to a relatively more uniform taxation regime prior to the judgement. Surana said this may create a new dynamic of competition among states in terms of attracting mining-related investments. Moving forward, the industry is also bracing for the revival of previously stayed GST demand cases on mining operations, as the court has now clarified that royalty payments are a contractual consideration rather than a tax. "After April 2016, there is a liability under reverse charge mechanism with respect to services provided by the government. Therefore, royalty is something which will be considered as a mining rights service provided by the government to the mining community. Now, all the petitions which are currently pending in high courts and the demands which have been stayed in most of the cases will get revived," said Gopal Mundhra, partner at Economic Laws Practice (ELP). Mundhra noted that the centre has the authority to provide relief on pending GST demands after the insertion of Section 11A in CGST Act at the 53rd GST Council Meeting last month. The amendment gives the central government the powers to forgive non-collection or under-collection of GST in situations where businesses followed a common practice that led

#### Cognizant's new campus opened in Hyd



Hyderabad: Chief Minister A Revanth Reddy inaugurated the new campus of IT major Cognizant at Kokapet in Hyderabad on Wednesday. With an office space of 10 lakh sq.ft, the new campus will provide employment to around 15,000 people, making Hyderabad its largest base in the world.

Established in Chennai in 1994, Cognizant began operations in Hyderabad in 2002 and now has five campuses in the IT corridor. The IT firm is currently the second-largest IT employer in Telangana. While workforce in Chennai currently stands at around 55,000 to 56,000 employees, Hyderabad is all set to surpass it with 57,000 employees. The new campus will focus on advanced technologies, including artificial intelligence (AI), machine

learning (ML), digital engineering, and cloud solutions.

Speaking on the occasion, the Chief Minister announced that the State government would constitute an investors task force to attract investments to Telangana. He claimed that his recent trip to the US and South Korea, attracted investments worth Rs 31,500 crore which would create around 30,750 jobs.He said with Hyderabad in its tow, Telangana would compete with the world rather than its neighbouring States of Karnataka or Andhra Pradesh in attracting investments. He also claimed that while former Prime Minister Rajiv Gandhi laid the foundation for the IT sector in Hyderabad, former Chief Ministers N Chandrababu Naidu and YS Rajasekhara Reddy fueled its growth.

### Lenders in talks with govt for "amicable resolution" after Karnataka halts transactions with SBI, PNB

Karnataka government SBI PNBSBI and PNB in separate statements issued on Thursday said they are committed for amicable resolution of the matter and are in discussion with the Karnataka government. (File)Days after Karnataka government ordered all its departments and public sector units to close all their accounts at State Bank of India (SBI) and Punjab National Bank (PNB), both the lenders on Thursday said they are in talks with the state government for a 'amicable resolution' of the issue

On August 12, the Karnataka's finance department issued an order asking all state government departments, public sector units, boards, corporations, local bodies, universities and other institutions to close accounts at SBI and PNB. The state government has set a September 20 deadline for all departments to comply with the direction, according to a circular issued by P C Jaffer, secretary in the department, on Monday. SBI and PNB in separate statements issued on Thursday said they are committed for amicable resolution of the matter and are in discussion with the Karnataka government. However, both the lenders did not provide any specific comment as the matter is currently sub judice.

The Karnataka government's decision followed two fraudulent transactions reported at these banks. The first is related to PNB's Rajajinagar branch, Bangalore, where



the Karnataka Industrial Area Development Board had started a fixed deposit of Rs 25 crore on September 14, 2011. However, after the term of the deposit ended, PNB allegedly released only Rs 13 crore, citing fraud by bank officials. The other case was related to a fixed deposit at the erstwhile State Bank of Mysore, which merged with the SBI in 2017. The Karnataka State Pollution Control Board had a fixed deposit of Rs 10 crore at the bank's Avenue Road branch, Bangalore. According to the state government, the amount was adjusted to the loans taken by a private company using forged documents. Attempts to recover the amount are said to have suffered the same fate as that of the fixed deposit in PNB.

### Is garlic a vegetable or a spice? This is what the Madhya Pradesh HC says; We asked a dietician to weigh in



The humble garlic clove found itself at the heart of a legal tussle in India. What began as a seemingly simple question – is garlic a vegetable or a spice? – escalated into a full-blown legal battle that reached the Madhya Pradesh High Court. The dispute arose when the state's market board declared garlic a vegetable in 2015, only to be reversed by the agriculture department, which reclassified it as a spice. This bureaucratic ping-pong had significant implications for farmers and traders, affecting where garlic could be sold and taxed.

After years of legal wrangling, the high court finally ruled in favour of garlic's vegetable status, citing its perishable nature. Kanikka Malhotra, a consultant dietician and diabetes educator, explained that botanically, garlic is classified as a vegetable. It belongs to the Allium genus, which includes other vegetables like onions, leeks,

and shallots. The edible part of garlic is the bulb, which grows underground and consists of several cloves wrapped in a thin, papery skin. This bulb structure makes garlic a vegetable, similar to other root and bulb vegetables, she said.

Vegetables are generally defined as the edible parts of plants, such as roots, stems, leaves, flowers, or fruits.

Garlic, being a bulb, fits this definition perfectly. It is cultivated and harvested like other vegetables and provides nutritional value, including vitamins, minerals, and antioxidants. Despite its botanical classification, garlic is often used as a spice in cooking due to its strong flavour and aroma. Spices are typically derived from seeds, fruits, bark, or other plant parts and are used primarily to season and flavour food rather than for their nutritional content. Garlic is used in small quantities to add depth and complexity to dishes, much like a spice would be. The potent flavor of garlic comes from compounds like allicin, which are released when garlic is chopped or crushed Malhotra explained. These compounds give garlic its characteristic pungent smell and taste, which can dominate or enhance the flavor of a dish. Malhotra said that while garlic is botanically a vegetable, its culinary use aligns more with that of a spice. This dual role makes garlic a versatile ingredient, capable of providing both flavour and nutritional benefits. Its classification as a vegetable does not diminish its powerful role as a flavouring agent, making it a staple in kitchens worldwide.

# Butter chicken to sambar, macher jhol to vada pav, dishes with deep-rooted significance in India's Independence movement





India's journey to Independence is not only a tale of political struggle but also a story etched in the flavours and aromas of its diverse cuisine. Food, an integral part of India's cultural fabric, mirrors the nation's historical journey, regional diversity, and the spirit of unity that defines its identity. As we celebrate the 78th Independence Day, let's explore the deep connection between food and national identity through insights from Chef Yashraj Dharadar, culinary chef at Academy of Pastry and Culinary Arts (APCA) Mumbai branch, and food historian Manisha Singh, who shed light on how various dishes across India reflect the nation's evolution.

"Each region has its unique culinary traditions that represent local customs, beliefs and practices," Chef Dharadar tells indianexpress.com. Indian cuisine, with its mosaic of flavours and ingredients and dishes like biryani and chole bhature, not only transcend regional boundaries but also symbolises "unity in diversity". Singh says, "Food (in India) transcends mere sustenance, embodying regional pride, social bonds, and cherished beliefs." Culinary traditions act as a unifying force, strengthening cultural ties and national identity across diverse linguistic and cultural boundaries. North India: Chhole bhature and butter chicken as symbols of resilience and growthIn the context of India's independence, North Indian cuisine reflected the region's resilience and postindependence growth. Chef Dharadar says chhole bhature is a dish that gained immense popularity after Independence. Originating in Punjab, this hearty combination of spicy chickpea curry and fried bread symbolises the region's vibrant spirit. Dharadar notes, "After Independence, as people migrated to the newly-formed country, chhole bhature became a favourite street food." It embodied cultural change and the expression of newfound freedom and solidarity.

Singh adds butter chicken to the list, saying it became synonymous with North Indian cuisine in the 50s. "In the 50s, at Delhi's Moti Mahal restaurant, a culinary accident turned leftover tandoori chicken into this iconic dish, simmered in a creamy tomato gravy enriched with butter," she explains. Chef Dharadar explained the role of food in fostering unity during the independence movement, using Idli as a poignant example. These simple steamed rice cakes were vital during the freedom struggle, offering a convenient and nutritious meal for community gatherings and rallies. Freedom fighters and activists often gathered in homes and community centers where idlis were served, he says. The variety of chutneys and sambar made idlis a versatile and interesting choice. Idli became a symbol of collective effort, embodying the common purpose necessary for achieving independence. Singh echoes this sentiment with the history of sambar, a lentil-based stew that has become a cornerstone of South Indian cuisine. Originally introduced to Thanjavur by the Marathas, sambar evolved into a dish that transcends linguistic and cultural boundaries.

Eastern India: How machher jhol became a testament to resilienceEastern India's contribution to the culi-

nary narrative of Independence is best captured by machher jhol, says Dharadar. This simple fish curry, rooted in Bengali traditions, embodies the resilience of a region that faced many challenges — from floods to political unrest. She says, "The dish's simplicity, relying on fresh fish, mustard oil, turmeric, and a few essential spices, reflects the ability to create flavourful and nourishing meals even in the face of adversity. Machher Jhol is more than just a dish; it is a symbol of survival, adaptation, and the unwavering spirit of the people of Eastern India."Machher jhol underwent a "transformation in its preparation techniques," post Independence, according to Dharadhar. The incorporation of various fish species and spices reflects both economic upliftment and changing tastes. The dish transitioned from a humble, everyday meal to a celebrated staple in both home kitchens and fine-dining restaurants, but while maintaining its traditional roots. Western India: Vada pav and puran poli become symbols of fusion and festivityThe culinary evolution of Western India in the post-Independence era is vividly captured through vada pav and puran poli. Chef Dharadar describes vada pav as a symbol of cultural fusion, epitomising Mumbai's melting-pot nature. "Originally a quick lunch for textile mill workers, it has a spicy potato fritter (vada) served in buttered bread rolls (pav). This dish reflects the convergence of diverse communities in Mumbai," he explains. The combination of Portuguese-influenced bread rolls with local spices embodies the spirit of a newly-unified nation embracing its multifaceted identity. Similarly, puran poli, a sweet flatbread from Maharashtra, is a symbol of abundance and prosperity, Singh says. With references dating back centuries, it involves the slow cooking of lentils and jaggery to create a rich, fragrant filling. The flatbread, made from whole wheat flour, is rolled thin, stuffed with the sweet filling, and cooked on a griddle until golden brown. Singh notes, "Its preparation during festive occasions reflects the warmth and generosity of the region, uniting families and communities in celebration."

## Expansion plans of foreign investors in Telangana shrouded in uncertainty

Hyderabad: After multinational companies like Corning International Corporation and Kaynes Semicon pulled out of Telangana and the Amara Raja Group having second thoughts on its expansion plans since the Congress government came to power in the State, doubts are now being raised about the future of other industry giants like Foxconn in Telangana. Foxconn had previously announced plans for investment of Rs 4,000 crore in Hyderabad and to create around one lakh jobs. The ground-breaking ceremony for its manufacturing unit in about 200 acres at Kongara Kalan in Rangareddy district was performed in May last year. The facility was expected to commence operations by the end of August this year. A Foxconn delegation had also met Chief Minister A Revanth Reddy after the Congress government was formed in December last year, but there has been no further update. There were reports that the firm had plans to invest an additional \$400 million USD, but there has been no news on the same so far.

The brutal rape and murder of a young trainee doctor in Kolkata has sent shockwaves across India. The heinous crime, which unfolded at the prestigious RG Kar Medical College and Hospital, has ignited a firestorm of anger and demands for justice. Social media has been flooded with heartwrenching messages, criticisms and calls for action. Bollywood celebrities, including Alia Bhatt, Swara Bhasker, Vijay Varma, Parineeti Chopra, Ayushmann Khurrana, Kangana Ranaut, Kareena Kapoor Khan, Preity Zinta, Richa Chadha, and Tisca Chopra, have joined the chorus of voices condemning the horrific incident.

"Another brutal rape, Another day of realisation that women are not safe. Don't tell women to change their path - change the terrain. Every woman deserves better," Alia wrote on Instagram, echoing the sentiments of millions. Swara Bhasker, on X (formerly Twitter), called the crime a "painful reminder that India is no country for women," while stressing that "the accused must be put on trial and justice must be served speedily." Parineeti Chopra's powerful Instagram post described the brutality of the attack with stark honesty. "If it's too difficult for you to read, imagine what it was for her. Disgusting. Horrific. Hang him by his b\*\*\*s," she wrote. Ayushmann Khurrana's poignant poem, "Kaash Main Bhi Ladka Hoti," captured the deep-rooted inequality faced by women in India. The actor's video, shared widely on social media, has sparked a powerful conversation about gender-based violence.

Actor and BJP MP Kangana Ranaut took to her Instagram handle and demanded that the CBI must intervene in the case. "Murder of a trainee woman doctor at state-run RG Kar Medical College and Hospital in Kolkata is horrible & horrific. The semi-nude body of the woman post-graduate trainee doctor was found inside the seminar hall on Friday morning. She was brutally murdered and her body bore multiple injury marks. The preliminary autopsy report indicated sexual abuse before her murder. I hope case is transferred to CBI for complete inquiry and the assaulter is punished harshly," she urged. The medical community is in mourning, with doctors across the country demanding increased safety measures and a thorough investigation into the circumstances surrounding the crime. The arrest of the accused, a civic volunteer,



and the subsequent transfer of the case to the CBI have offered a glimmer of hope for justice. However, as Kareena Kapoor Khan pointed out, "12 years later, the same story, the same protest. But we are still waiting for change." The Nirbhaya case, a horrific gang rape in Delhi in 2012, remains a stark reminder of the challenges India faces in ensuring women's safety.

Preity Zinta's impassioned plea for prioritising women's safety highlighted the systemic failures that have allowed such atrocities to continue. She called for stricter punishments, accountability for those in charge, and a united front among women to demand change. "It's time women's safety is prioritized by the government. It's heartbreaking and disgusting to see a rapist's face hidden/ covered when arressted, while victims of rape and violent sexual crime have their names and faces leaked in the media. Justice is never swift, punishment is never severe and people are never held accountable," she urged in her post. Richa Chadha and Tisca Chopra also added their voices to the growing echo of outrage, demanding justice for the victim and systemic reforms to prevent such tragedies from happening again. Richa took to her X handle urging West Bengal Chief Minister Mamata Banerjee to ensure justice for the victim. "The women of this country expect a fair and impartial investigation from you @MamataOfficial, and swift justice. You're the only woman currently to occupy the post of Chief Minister. #JusticeForMoumita," she tweeted. Tisca Chopra, sharing a picture of herself in white, wearing a tricolour dupatta, wrote, about concerns she has as a mother. "As the mother of a young girl, how do I feel when another woman is raped? An 'Independent', educated working woman at her place of work, after working a 36 hour shift. A doctor," she wrote in her post. The actor added, "Hope we can say Happy Independence Day, by next year .. because Independence without safety means nothing.

# Raghu Thatha Movie Review: Keerthy Suresh, Ravindra Vijay shine in a simple tale that needed more sting

Raghu Thatha Movie Review: The opening credits of writer Suman Kumar's directorial debut is an interesting start. It traces a few pages of India's legislature landmarks through newspaper cuttings and gives us insights into the different issues that would be discussed in the Keerthy Suresh-starrer. And like clockwork, every one of those headlines in the newspaper becomes a conversation between the characters in the film. If one topic becomes the reason for the title, then another is a passing line about women and their dreams. If one topic is about Hindi imposition, then another is a reference to the ugly head of patriarchy. Raghu Thatha is like flipping through the newspaper to read just the headlines. Even if the film doesn't delve too deep into the various issues it takes up, it gives us enough cliff-notes to get the idea.

Raghu Thatha is set in the 1970s, and the protagonist Kayalvizhi Pandian (an effective Keerthy Suresh) is a feminist, writer, and bank employee. She fiercely opposes the opening of a Hindi Sabha in her town of Valluvanpettai. Supported by her rebellious grandfather Raghothaman (MS Bhaskar), Kayalvizhi continues her crusade against the imposition of Hindi in society, and the imposition of marriage on her. But Kayalvizhi finds herself in a conundrum that threatens everything she stands for. While this does sound like a film, straight out of the K Balachander textbook, Suman and his team of writers, add quirky characters played by convincing actors, outlandish situations, and dish out a screwball comedy. Take, for instance, a doctor who smokes telling a fairly no-vice vayasaanavan (elder person) that he has cancer. The patient's reactions and the song that follows soon after are what happens when seemingly innocuous characters are placed in oddball situations. Raghu Thatha aims to do a lot of this but doesn't always work because there is many a slip between the joke and the laugh.

Raghu Thatha is held together by the earnestness of Keerthy Suresh and the downright whimsical and effectively caricaturish performance of Ravindra Vijay, who plays Kayalvizhi's suitor, Selvan. Undoubtedly, Selvan is one of the most fun characters recently, and Ravindra plays it to the gallery. On the other hand, Kayalvizhi is bound by the limits of having strict moral values and yet manages to be a hoot in situations that make her bend those rules. The film is a lot of fun when it focusses on the blossoming love story between Kayalvizhi and Selvan. While the proverbial twist in the tale is thrust upon us, it is slightly unfortunate that the 'twist' isn't exactly a twist because we are left with visible clues about what is going to happen. It is no fun to know what is going to happen in a film like Raghu Thatha, which elicits a lot of laughs every single time it resorts to clever subversion.

Despite Sean Roldan dialling up the quirkiness factor with his music, and the scenes setting the stage right, the jokes are hit-and-miss. It is slightly disappointing that despite earnest performances from Rajeev Ravindranathan, Devadarshini, Chu Khoy Sheng, and Ismath Banu, the film doesn't give them enough. They dial up the fun whenever they appear on screen, but Raghu Thatha needs more of them, and less of the round-about way of reaching the finale where Kayalvizhi has a meltdown. It takes such a long time to get there that her speech falls flat despite everything before that working in favour of the film. The last act is of the chaotic funny type, and that is the film's strong suit too. Every scene involving the motley group of characters is a hoot, and you almost miss this controlled chaos in many of the previous

scenes. But it becomes a classic case of too little too late.

Coming to the central theme of Hindi imposition, the



film doesn't do enough justice to it either. However, the film, with its sharp dialogues, works as a commentary on patriarchy and how the liberal nature of many is just a means to an end. Even before reaching the showdown, the film does a decent job of asking these questions. However, they don't feel like tough holding-the-collar questions, but gentle raps on the knuckles. The entire angle of the imposition feels out of place in the film because of the lack of exploration. The issues remain on a very superficial level, and it doesn't allow us to throw our weights behind Kayalvizhi and Raghu Thatha's clarion call for fighting against the imposition of Hindi. Instead, if they asked us to join them in the fight against patriarchy, a lot of us might just do it because... even today, many are liberals just as a means to an end.


#### Boman Irani celebrates Independence Day with Mumbai police

# Manu Rishi breaks down recalling how he buried Irrfan; recalls the time late actor praised him for standing up to a bigshot director

Manu Rishi, who worked with the late actor Irrfan Khan in Angrezi Medium, recently recalled the painful memory of bidding farewell to the actor. The writer-actor broke down while remembering Irrfan and the emotional experience of burying him with his own hands. Manu also shared how Irrfan supported him when he stood up against a prominent director.

During an interaction on a YouTube channel, Manu recounted how Irrfan had recommended him to write a film for a bigshot director. Despite having written 11 films, Manu faced skepticism from the director, who asked him to write a scene as a test before offering him the project. Manu said, "I told the director, 'Either you trust my work or you trust Irrfan bhai's recommendation. You haven't seen my work, otherwise, you wouldn't ask me that question. If I asked you to direct a scene and show it to me, how would you feel?' He told me he has directed six films, and I told him I have written 11. I said, 'I'm upset not because you haven't seen my work but because you didn't trust Irrfan bhai's recommendation."Manu also shared that Irrfan visited him that same night, and instead of reprimanding him for standing up to the director, he praised him for holding his ground. "I opened the door, and Irrfan bhai immediately said, 'Ya toh tu mar jayega ya tu tar jayega (Either you will die, or you will survive). This selfrespect that you have is very correct," Manu recalled.

During the interaction, Manu Rishi became emotional while reminiscing about his memories with Irrfan. "When Hindi Medium started, I called the director and said, 'You don't have a small role for me after I played a




significant role in the prequel Angrezi Medium? You don' have a small part where I can just hug Irrfan bhai?' Irrfan bhai then called me and said, 'I'm sending you tickets; come to Udaipur in two days.' I went there just to hug Irrfan bhai. I couldn't act at that moment. I realized that this man was slipping away, and I needed to gather as many memories with him as I could. He didn't survive, but still have his message with me."Manu also recalled how he almost missed seeing Irrfan for the last time but managed to bury him with his own hands after his demise. He said, "I nearly missed seeing him for the last time, but the burial ground was close to my house. I reached there and everyone was standing at the gate of the burial ground. Due to Covid restrictions, the police weren't allowing anyone in. I didn't have a special relationship with the officer standing there, but he let me in. I placed sandalwood on Irrfan before burying him with my own hands."

It's: What are these last years going to be? Because I see my parents are very... I see just what George was explaining. In your 80s, the body becomes more frail. And yet I look at Frank Gehry. He's just the loveliest man. And he's 95 and still making great art and he's got a beautiful family. And I think that's kind of the formula to stay creative and keep loving your life."This isn't the first time Pitt has mused about the final phase of his career. According to The Hollywood Reporter, in an earlier interview, he had already begun contemplating what this next stage might entail. George Clooney, who joined Pitt for the discussion, commented on their professional longevity, noting, "We're in a profession that doesn't force you into retirement."

As per The Hollywood Reporter, Clooney also ad-



dressed the common fear among actors about the decline in job opportunities as they age, suggesting that there are "two ways" to handle this challenge. "The phone stops ringing if your decision is that you want to continue to be the character that you were when you were 35, and you want a softer lens," Clooney explained. "But if you're willing to, say, move down the call sheet a little bit and do interesting character work, then you can kind of... you have to make peace with the idea that you're going to die," he added, as per The Hollywood Reporter. Clooney humorously added, "I will walk up to people and they'll be like, 'Oh, you're older than I thought.' And I'm like, 'I'm 63, you dumb shit!' It's just: That's life. And so as long as you can make peace with the idea of change, then it's okay. Nunakuzhi movie review: There's something enchanting about seeing Basil Joseph on screen, whether he's falling in love, making mistakes, getting into trouble, lashing out, or breaking down in tears. It's not so much that he's an extraordinary actor, but his physique and mannerisms closely mirror those of many Malayali youths who, like his characters, are often clueless and reckless. It is this relatability, combined with his ability to tackle physical comedy, that Drishyam director Jeethu Joseph has tapped into this time with Nunakuzhi, which also features a talented ensemble known for their comedic prowess. Following the death of his business magnate father, Eby (Basil) is thrust into the role of managing their sprawling empire. A man-child with no understanding of or interest in business matters, Eby's only obsession is his newlywed wife Rimi (Nikhila Vimal). Perpetually horny, Eby, one night, convinces his wife to film them having sex

on his personal laptop. However, things take a turn for the worse when an Income Tax raid occurs at his office and I-T officer Bhamakrishnan (Siddique) seizes the laptop. When Rimi discovers this, she is furious and threatens to end her life if Eby doesn't retrieve the laptop immediately. Panicked, Eby embarks on a mission, but his stupid decisions only lead him deeper into trouble. #### Suryakumar Yadav back in Test reckoning; will be in action in Buchi Babu and Duleep Trophy



After returning from Sri Lanka after his first stint as India's full-time T20 captain, Suryakumar Yadav asked the Mumbai Cricket Association to include him in the squad for the Buchi Babu Invitational Tournament in Tamil Nadu. It came after the Indian team management and selectors indicated that they were looking at Surya as a possible option in red-ball cricket, some 18 months after his only Test, against Australia in Nagpur, where his solitary innings brought only 8 runs.

And now with Surya also finding a place in the Duleep Trophy, turning out for Team C under Ruturaj Gaikwad, he seems to be firmly in the picture for the home Test summer featuring Bangladesh and New Zealand. The Duleep Trophy marks the official start of the Indian domestic season in the first week of September, but with the Buch Babu tournament kicking off at four centres in Tamil Nadu - Coimbatore, Salem, Dindigul and Tirunelveli on Thursday, it feels as if the season is already up and running. And over the next three weeks, an audition for middle-order slots in the Test side will take place in Coimbatore, thanks to Mumbai's star-studded team. After Surya made himself available, Shreyas Iyer too requested the MCA to include him in the squad for the second match against a Tamil Nadu team. Before the two arrive, it will be Sarfaraz Khan looking for a headstart in the audition. Captaining the Mumbai side here, he knows runs are the only currency that matters in the current scenario.It's not just Mumbai stars who will be in action at the Buchi Babu event. Ishan Kishan, who refused to turn up for Ranji Trophy fixtures last season, will be leading Jharkhand and his comeback will begin in Tirunelveli. Highly-rated Railways wicketkeeper Upendra Yadav and Ashutosh Sharma will also feature in the tournament. Healthy com-

But all eyes will be on the Mumbai side, in which there is a three-way competition for one of the slots in India's Test squad. In the last Test India played, their middle order featured Shubman Gill, Devdutt Padikkal, Sarfaraz Khan, Ravindra Jadeja and Dhruv Jurel. But come September 19 when India take the field against

Bangladesh in Chennai, there is no guarantee that the batting order will remain unchanged. Although Bangladesh and New Zealand at home are India's immediate challenges, the think tank is already setting its sights on the tour of Australia that begins in mid-November. With India scheduled to play five Tests Down Under, there's a lot of focus on red-ball cricket with the selectors announcing four-strong squads for the Duleep Trophy on Tuesday. "When Duleep Trophy begins, you have to be ready and that's why this tournament is important from my point of view," Sarfaraz told The Indian Express. "We have been training mostly indoors in Mumbai. We even had a good camp in Alur, where we focused on fitness and skills. But before the season begins, we need to get into match groove." After missing out initially from the India squad for the series against England, a spate of injuries handed Sarfaraz his long-awaited Test debut. But with Virat Kohli and KL Rahul available for the Bangladesh series and Surya back in Test fray, there is no guarantee that he will retain his spot in the 15.

When Surya and Shreyas join the Mumbai side for the second game, the competition will only intensify."I don't want to look that far ahead because a lot of it is not in my control. It is important to be in the present. I've to be ready at all times and follow the same routines that have got me this far," Sarfaraz said. Different motivations The Buchi Babu tournament is older than the Ranji Trophy, with the first edition being played in 1909. In 2018, the tournament disappeared from the Tamil Nadu Cricket Association calendar but was revived last season after the state team's red-ball fortunes went on a downward spiral. Mirroring the playing conditions of the Ranji Trophy, the tournament featuring four-day contests is beginning to enjoy the status it once had. While the audition for India's middle order would be the biggest takeaway, teams like Madhya Pradesh, Haryana, Railways, Baroda, Gujarat and Chhattisgarh have come with the purpose of gaining some much-needed game time before the Ranji Trophy begins in October. "This season, we have the Ranji Trophy beginning early and we will face varied conditions as the tournament will be played in October-November and January-February. We need this sort of exposure. Nowhere in the north, we would find conditions that will help us improve our game against spinners. We don't have much representation in the Duleep Trophy, so for a lot of us these four-day matches are a big part of our preparations," Haryana captain Ashok Menaria says. Among the teams in fray, Madhya Pradesh, amongst the most consistent teams in Ranji Trophy, are using the tournament to give exposure to youngsters. One look at the squad list, where every single player is born in this century, gives enough indication that they are investing

"I don't like waiting to bat, so I thought why don't I put my hand up and have a crack up top? That way, you can get Cameron Green in and you're playing your best six batters," Smith would give rationale earlier this year on



Fox Cricket. "I am (excited). I like facing the newer ball. If you look back to the 2019 Ashes, I was in pretty early there most of the time when I was facing the new ball." I batted no.3 from a number of years as well and was in early and did pretty well against the new ball. So it's nothing new or foreign to me. I enjoy getting in there and getting amongst it and I'm looking forward to that challenge," he further said at the time. Smith's biggest challenge as opener would come later this year when Australia face India for a match Test series at home.

#### Devon Conway and Finn Allen become latest to deny New Zealand Central Contracts

"I'm excited to be part of the upcoming Test squads for an important period in the ICC World Test Championship cycle and am looking forward to being involved in the ICC Champions Trophy in Pakistan next February if selected," he added.

Additionally, young Finn Allen has opted out of the contract. However, he will not be provided with a casual



contract. His selection will be decided based on a case-by-case scenario. Earlier talisman Williamson has stepped down as white-ball captain after the team's early exit from the T20 World Cup and has also declined the national contract for the 2024-25 season. However, he assures his commitment to the Blackcaps going forward whenever needed and also leaves the door open to potentially accepting the central contract in the future. "The 33-year-old has opted to take advantage of a particular set of circumstances this summer in which very little international cricket is being played in New Zealand during the January window," stated New Zealand Cricket in their statement at the time.

### After disappointing CAS verdict, sporting fraternity rally behind the 'Kohinoor of India'

New Delhi: The Indian sporting fraternity reacted with disappointment at the Court of Arbitration for Sport's (CAS) verdict rejecting wrestler Vinesh Phogat's appeal against her Olympic disqualification but said she will remain a champion for them. The ad-hoc division of the CAS on Wednesday rejected Vinesh's appeal against a gutwrenching disqualification from the Paris Olympics 50kg final for being 100gm overweight, which dashed any hopes of securing a belated silver medal. "It's disappointing but we can't do anything about that," hockey legend PR Sreejesh, who retired after inspiring the Indian team to a second consecutive Olympic bronze medal in the Paris Games, said. Tokyo Olympics bronze medallist Bajrang Punia said a medal has been snatched away from Vinesh. "I believe your medal was snatched away in this darkness. You are shining like a diamond in the whole world today," Punia, who led a long sit-in protest along with Vinesh and Sakshi Malik accusing former WFI chief Brij Bhushan Sharan Singh of sexually harassing women grapplers, posted on 'X'.

The 29-year-old Vinesh was disqualified on the morning of the women's 50kg freestyle final last week. In her appeal, Vinesh had demanded that she be given a joint silver with Cuban wrestler Yusneylis Guzman Lopez, who lost to her in the semifinals but was promoted to the summit clash following the Indian's disqualification. The gold was claimed by American Sarah Ann Hildebrandt. A decision on Vinesh's appeal was postponed three times. Despite extending the deadline till August 16 to announce the verdict, the decision against the star grappler came out Wednesday evening and it was a terse one-line statement. "It is a sad news but what can we say. A sportsperson works extremely hard and if something like this happens with anyone, it hurts.
