'No conflict can be resolved on battlefield': In Poland, PM Modi vows cooperation to ensure peace in Ukraine

Prime Minister Narendra Modi on Thursday said no conflict can be resolved on the battlefield, while also assuring all possible cooperation from India for restoration of peace and stability, as the Russia-Ukraine war crosses the 900-day mark. During a statement issued during his visit to Poland and a day ahead of his visit to Ukraine, the Prime Minister voiced "deep concern" over the ongoing conflicts in Ukraine and West Asia. "The conflicts in Ukraine and West Asia are matters of deep concern for all of us. It is India's firm belief that a solution to any problem cannot be found on the battlefield," Modi said after talks with Polish Prime Minister Donald Tusk. "The loss of lives of innocent people in any crisis has become the biggest challenge for the entire humanity. We support dialogue and diplomacy for the early restoration of peace and stability. For this, India, along with its friendly countries, is ready to provide all possible support," Modi said. Modi arrived in Warsaw on Wednesday, in the first visit by an Indian prime minister to Poland in 45 years. Talks between the leaders saw the elevation of India-Poland ties to the level of strategic partnership. "This year we are celebrating the 70th anniversary of our diplomatic relations. On this occasion, we have decided to transform the relationship into a strategic partnership," Modi said. Modi thanked Tusk for Poland's assistance in facilitating the evacuation of Indian students from war-torn Ukraine in 2022. He also reiterated the need for a reform in the United Nations and other international institutions in the face of global challenges. The next leg of Modi's journey will see him travelling to Kyiv on boarding a train that will take 10 hours. He will spend around seven hours in the Ukrainian capital at the invitation of President

Full emergency at Thiruvananthapuram airport over bomb threat on Al flight

Thiruvananthapuram: A full emergency was declared at the Thiruvananthapuram International Airport on Thursday following a bomb threat on an Air India flight from Mumbai, airport sources said. The aircraft is currently being inspected by security agencies, including a bomb detection squad, they said, adding the passengers who travelled on the flight are presently waiting for their luggage to be delivered. Meanwhile, Air India, in a statement, said that a specific security alert was detected on flight AI 657 during cruise from Mumbai to Thiruvananthapuram and "the crew carried out all the laid down security drills keeping passenger safety as top priority. All passengers and crew disembarked safely. Air India accords top priority to the safety of its passengers and crew," an airline spokesperson said. The flight with 135 passengers landed safely at the airport around 8 am and was moved to an isolation bay, airport sources said earlier. Passengers were safely evacuated from the flight by 8.44 am, they said. The bomb threat was communicated by the pilot at 7.30 am as the aircraft approached the Thiruvananthapuram airport, the sources said. Subsequently, a full emergency was declared at the airport at 7.36 am, they said. "There has been no impact on life. Airport operations are currently uninterrupted," the sources said. Details on the origin of the threat and other information are awaited, they added.

PM Modi in Warsaw for talks, will leave today for war-torn Kyiv

As the conflict in Ukraine entered a new phase following Kyiv's deep inroads into Russia's Kursk region, Prime Minister Narendra Modi reached neighbouring Poland's capital Warsaw Wednesday for talks with Prime Minister Donald Tusk and President Andrzej Sebastian

Modi will head to Kyiv later Thursday where he will meet President Volodymyr Zelenskyy — this is the first visit to Poland by an Indian Prime Minister after 45 years, and the first to Ukraine since it gained independence in 1991. After reaching Warsaw, Modi, in a post on X, said, "Landed in Poland. Looking forward to the various programmes here. This visit will add momentum to the India-Poland friendship and benefit the people of our nations." Earlier in the day, he said, "My visit to Poland comes as we mark 70 years of our diplomatic relations. Poland is a key economic partner in Central Europe. Our mutual commitment to democracy and pluralism further reinforces our relationship. I look forward to meeting my friend Prime Minister Donald Tusk and President Andrzej Duda to further advance our partnership." "From Poland, I will be visiting Ukraine at the invitation of President Volodymyr Zelenskyy. This is the first-ever visit by an Indian Prime Minister to Ukraine," he said. "I look forward to the opportunity to build upon earlier conversations with President Zelenskyy on strengthening bilateral cooperation and share perspectives on peaceful resolution of the ongoing Ukraine conflict," he said.

Not an era for war: Modi addresses Indian diaspora in Poland

Warsaw: Ahead of his maiden visit to Ukraine. Prime Minister Narendra Modi has said India was an advocate of permanent peace in the region, as he reaffirmed his view that "this is not an era of war" and any conflict should be resolved through diplomacy and dialogue. Addressing an enthusiastic Indian diaspora in the Polish capital on Wednesday evening, Modi also said for decades, India had a policy to maintain distance from all the countries. However, the policy of today's India is to remain close to all countries, he added, amid chants of Modi-Modi. "India is an advocate of permanent peace in this region. Our stand is very clear - this isn't an era of war. This is the time to come together against those challenges which threaten humanity. Therefore, India believes in diplomacy and dialogues...," Modi told the gathering

His remarks come ahead of his trip to Kyiv — the first visit by an Indian Prime Minister to Ukraine since the country became independent in 1991. Modi, who is visiting Ukraine at the invitation of President Volodymyr Zelenskyy, has said he will share with the Ukrainian leader perspectives on peaceful resolution of the ongoing conflict. His visit to Kyiv comes nearly six weeks after his high-profile trip to Moscow and meeting with Russian President Vladimir Putin which triggered criticism from

the US and some of its Western allies. At the meeting with the diaspora in Warsaw, Modi lauded their contribution to strengthening bilateral relations and commended their role in the success of Operation Ganga, an evacuation mission carried out by the Indian government to rescue its citizens stranded in neighbouring countries of Ukraine after Russia attacked it in 2022. "Today's India wants to connect with all. Today's India talks about the development of all. Today's India is with all and thinks about the interests of all," Modi said. Modi said that if any country faces a crisis, India is the first country to extend a helping hand. "Wherever in the world there is an earthquake or any disaster, India has only one mantra - Humanity first," he added. Prime Minister Modi's visit to Poland is the first trip by an Indian Prime Minister to the country in the past 45 years. In his address, Modi said he was eagerly looking forward to meeting President Andrzej Duda and Prime Minister Donald Tusk to strengthen India-Poland ties.He stated that India as the Mother of Democracy and its shared values with Poland bring the two countries closer. He called upon the community to become a brand ambassador of tourism to India and be part of its growth story. To further strengthen the special bond with Poland, the Prime Minister announced a new initiative called Jamsaheb Memorial Youth Exchange Program under which 20 Polish youth would be invited to India each year. He also recalled the help provided by Poland during the massive earthquake in Gujarat in 2001. The Prime Minister spoke about the transformative progress India has achieved in the last 10 years. He expressed confidence that India will become the third-largest economy in the next few years. He also spoke about his vision for the country to become a developed nation — Viksit Bharat — by 2047. He stated that Poland and India were enhancing their partnership in areas of new technology and clean energy and driving green growth.Prime Minister dwelt on India's belief in 'Vasudhaiva Kutumbakam' – the world is one family – which inspires it to contribute to global well-being and to

be the First Responder in humanitarian crises.

Mamata Banerjee Urges PM Modi For Stricter Rape Laws Amid Kolkata Hospital Tragedy

In the wake of a devastating rape and murder case at a Kolkata government hospital, West Bengal Chief Minister Mamata Banerjee has reached out to Prime Minister Narendra Modi, advocating for more stringent laws concerning rape cases. This move comes as public outrage intensifies over the tragic incident involving a trainee doctor. The Trinamool Congress-led state government has

come under fire for its handling of the case and the subsequent vandalism at RG Kar Hospital, where the crime occurred. The Supreme Court expressed dismay at the state's inability to control the vandalism, stating they were "unable to comprehend" the situation. Banerjee has pointed fingers at the BJP and Left parties, accusing them of instigating the hospital vandalism and potentially tampering with evidence. She had initially promised to seek capital punishment for the perpetrator and issued an ultimatum to the police to solve the case by August 18, failing which it would be transferred to the CBI. However, on August 13, the Calcutta High Court intervened, handing the investigation over to the CBI. The court's decision highlighted "serious lapses" in the hospital administration and noted the lack of progress in the investigation five days after the incident. In a show of solidarity with the victim, Banerjee led a large rally in Kolkata on August 17, calling for justice and the hanging of the accused, who was identified as a civic volunteer associated with the police. This case has become a focal point in West Bengal, intersecting with broader discussions on women's safety, law enforcement effectiveness, and political accountability.

Don't politicise RG Kar rape-murder, law will take its course: SC

New Delhi: The Supreme Court on Thursday asked political parties not to politicise the rape and murder of a trainee doctor at Kolkata's RG Kar Medical College and Hospital, and said "law will take its course".

A three-judge bench headed by Chief Justice D Y Chandrachud told Solicitor General Tushar Mehta, appearing for the CBI, and senior advocate Kapil Sibal, representing West Bengal government, that across the political spectrum, parties have to realise that law will take its course. Submitting that statements should not be made, Mehta said, "A sitting minister of the State of West Bengal has made a statement that if anybody talks anything against our leader (Mamata Banerjee), his fingers will be chopped off." Retorting to his submission, Sibal said that "leader of opposition Suvendu Adhikari has said bullets will be fired".

The bench, also comprising Justices J B Pardiwala and Manoj Misra, said, "Do not politicise the situation. Across the political spectrum, parties have to realise that law will take its course. We are ensuring that law does take its course after quick investigation." The top court said it is concerned with safety and welfare of doctors and will pass enforceable directions on the issue.TMC minister Udayan Guha has sparked controversy by claiming that fingers of those blaming West Bengal Chief Minister Mamata Banerjee and demanding her resignation over the RG Kar hospital incident would be broken. While talking to a news channel, Adhikari had allegedly said, "Resign by Monday or you (Mamata Banerjee) will be held responsible or bullets are fired on Tuesday." The rape and murder of the junior doctor in a seminar hall of the state-run hospital has sparked nationwide protests.

Righting a wrong

THERE was an air of inevitability about the Sureme Court setting aside an order of the Calcutta High Court in which the latter had not only acquitted an accused in a sexual assault case but also advised adoescent girls to control their sexual urges. Having taken uo motu cognisance of the contentious verdict, the apex ourt had said in December last year that while writing judgment, the judges were not expected to preach or express their personal views. The bottom line is that any ruling should be based on the merits of the case, not the prejudices and perceptions of the judges. After all, the Bench is not a pulpit and should not be treated s one.It is appalling that a Division Bench of the high ourt chose to sermonise and went to the extent of sayng that 'in the eyes of the society, she (every female idolescent) is the loser when she gives in to enjoy the exual pleasure of hardly two minutes'. Reeking of inensitivity, this observation was no doubt objectionable as well as unwarranted. It seems that these judges were lissfully unaware of the Supreme Court's Handbook n Combating Gender Stereotypes, which was released n August last year. It offers much-needed guidance on now to avoid harmful gender stereotypes, particularly hose about women, in judicial decision-making and vriting. A bigger push by the SC is needed to ensure hat this document is widely circulated and read by various stakeholders in courts across the country. What's vorrisome is that high courts continue to come up with butrageous statements despite being rapped by the topnost judiciary. In 2017, for instance, the Delhi High Court ad shockingly observed that a woman's feeble 'no' nay mean 'yes'. Judges who stoop so low are a disrace to the judiciary. Amid its welcome intervention in he Kolkata rape-murder case, the SC would do well to ay greater emphasis on gender sensitisation.

After red flags raised over MP tiger deaths, wildlife dept admits officials were negligent, 'lacked interest'

After the National Tiger Conservation Authority (NTCA) sought a response from the Madhya Pradesh Wildlife Department regarding the red flags raised by an SIT regarding tiger deaths in the state – highlighted by a report in The Indian Express earlier this month - the department has acknowledged that some officials were "negligent in their duties and show a lack of interest in tiger conservation". had published a report on August 6 highlighting the red flags raised by the Special Investigation Team regarding the deaths of 43 tigers between 2021 and 2023 in the Bandhavgarh Tiger Reserve (BTR) and Shahdol Forest Circle. Shoddy investigations by wildlife officials into possible poaching cases, lapses during the postmortem process, and medical negligence that led to tiger deaths were some of the issues flagged by the SIT.After the publication of the news report, the NTCA sought a clarification from the Wildlife Department.

Subharanjan Sen, Principal Chief Conservator of Forests (Wildlife), the wrote to the NTCA on August 9, acknowledging that in "some cases, it was found that the NTCA Standard Operating Procedures (SOP) and the guidelines issued by the Wildlife Headquarters were not fully adhered to following the death incidents of the tigers."He said the SIT found that a total of 34 tiger deaths occurred in BTR. Shahdol Forest Circle saw nine tiger deaths during the same period.

In a separate report dated August 9 and addressing the alleged negligence of former field directors of the tiger reserve, Sen wrote, "As per the investigation report, 30 of these deaths occurred during the tenure of the thenposted regional directors, and it was found that the officers did not follow the SOP set by the NTCA."The three field directors mentioned in the letter are Vincent Rahim. who served from August 5, 2019 to October 8, 2021, and under whose tenure nine tigers died; B S Anigeri, who served from October 8, 2021 to September 9, 2022, whose tenure also saw the deaths of nice tigers; and Rajiv Kumar Mishra, who served from September 9, 2022 to August 31, 2023, during which period 12 tigers died, "This suggests that the officers concerned did not show interest in fulfilling their responsibilities. This act demonstrates negligence towards official duties...In this regard, it would be appropriate to obtain an explanation at the government level regarding the negligence of the officers mentioned in the above list during their tenure at Bandhavgarh Tiger Reserve," Sen wrote.

Rajiv Kumar Mishra denied there were any lapses during his tenure. "I have not received any letter and have been retired for some time now. During my tenure, there were demands that were raised for better staff and equipment for the postmortem of dead tigers. Tigers were our No 1 priority, and there was no question of any lapse during my tenure," he told The Indian Express.B S Anigeri also flagged the issue of staff shortage and denied any lapses. "There were many issues of staff shortage and budget that were raised during my tenure. I did not see any case of lapses in procedures surrounding tiger deaths during my tenure." Vincent Rahim did not respond to calls and messages seeking his comment.

On the "unprecedented increase in the number of tigers in Bandhavgarh Tiger Reserve", the Principal Chief Conservator of Forests (Wildlife) said "a natural explanation" could be the "internal fights". He also said the lack of a regular field director was also a major reason "for the shortcomings in the smooth operation and management" of BTR. "Based on the committee's report, necessary action is being taken against the concerned government servants, and the implementation of the committee's suggestions has been initiated... Incompetent officers/employees for tiger conservation and management are being transferred elsewhere. The field staff is also being trained for tiger conservation and management," Sen said. Wildlife activist Ajay Dubey, who has filed a petition in court on tiger poaching incidents in the state, told The Indian Express: "We are now going to approach the High Court for a CBI investigation. The tigers' deaths report was kept under wraps for months and action has now been taken on August 9 after media reports. The whole purpose of justice is defeated if action is not taken swiftly and errors rectified.'

SC seeks Odisha's reply on remission plea of convict Dara Singh

The Supreme Court on Tuesday sought a response of the Odisha government on the remission plea of Ravindra Pal alias Dara Singh, who is serving life sentence for the ghastly killings of Australian missionary Graham Stuart Staines and his two minor sons in Keonjhar district in the state in 1999. Singh has sought application of a more liberal remission policy to ensure his premature release from a prison in the state where he is lodged for more than 24 years. While seeking a response from the state government within two weeks, a bench comprising Chief Justice D Y Chandrachud and Justices JB

Pardiwala and Manoj Misra said the offence was very serious in nature.

The bench took note of the submissions of lawyer Vishnu Shanker Jain, appearing for the convict, that a more liberal policy on remission has to be applied in his case. Singh, he said, has already served 24 years and six months. "We have issued the notice and sought response in two weeks," the bench said. A mob led by Dara Singh had attacked Staines and his two sons – 11-year-old Philip and 8-year-old Timothy – while they were sleeping in their station wagon. It set the vehicle on fire in Manoharpur village of Keonjhar district on the intervening night of January 22-23, 1999.

Dara Singh, the main accused in the triple murder, was convicted and sentenced to death by a CBI court in 2003. The Orissa High Court had commuted his death sentence to life imprisonment in 2005 and it was upheld by the Supreme Court in 2011. Mehendra Hembram, an accomplice of Dara Singh, is also serving life imprisonment in the case, while 11 other accused were acquitted by the high court due to lack of evidence. Staines and his wife Gladys worked with Mayurbhanj Evangelical Missionary organisation and cared for leprosy patients. Gladys Staines, who was awarded the Padmashree in 2005, had said she had forgiven the killers of her husband and sons and that she holds no bitterness against themAnother bench of the top court is also seized of Singh's another petition seeking similar relief.

(File Photo)The West Bengal government on Tuesday sought an urgent hearing by the Supreme Court of its appeal against the Calcutta High Court verdict striking down the OBC status of several castes, mostly Muslim groups, in the state for granting them reservation in public sector jobs and admissions in state-run educational institutions. The top court said it will hear the pleas on the issue on August 27.

Senior advocate Kapil Sibal, appearing for the state government, told a bench comprising Chief Justice D Y Chandrachud and Justices JB Pardiwala and Manoj Misra that the high court verdict needed to be stayed as it was affecting the admission of candidates who have cleared the NEET-UG, 2024. "We need a stay of the high court's verdict... the issue of scholarships is pending and the NEET admissions will be effected," Sibal said, adding that the plea be heard during the day. A counsel, representing the state's Other Backward Classes (OBC) panel, said students are lining up for authentication of their OBC status for securing admissions to medical colleges and other institutions

"We will hear it on Tuesday (August 27)," the CJI said. The top court had on August 5 asked the state gov-

ernment to provide quantifiable data on social and economic backwardness of fresh castes it has included in the OBC list and on their inadequate representation in public sector jobs. While issuing notices to the private litigants on the plea of the state government against the high court verdict, it had asked West Bengal to file an affidavit giving details of the consultations, if any, made by it and the state's backward classes panel before including 37 castes, mostly Muslim groups, in the OBC list. The high court had on May 22 struck down the OBC status of several castes in West Bengal granted since 2010, holding as illegal the reservation for them in public sector jobs and state-run educational institutions. While striking down the OBC status of these castes, the high court had said, "Religion indeed appears to have been the sole criterion" for declaring these communities as

The high court had said that it is of the view that the selection of 77 classes of Muslims as backwards is an "affront to the Muslim community as a whole." Maintaining that this court's mind is not free from doubt that "the said community (Muslims) has been treated as a commodity for political ends," the bench had said, "This is clear from the chain of events that led to the classification of the 77 classes as OBCs and their inclusion to be treated as a vote bank." Passing the judgment on petitions challenging the provisions of the state's reservation Act of 2012 and reservations granted in 2010, the high court had clarified that the services of citizens of the struckdown classes, who are already in service or have availed the benefit of reservation or have succeeded in any selection process of the state, will not be affected by the order. The high court also struck down 37 classes chosen for grant of reservation as OBC under The West Bengal Backward Classes (Other than Scheduled Castes and Scheduled Tribes) (Reservation of Vacancies in Services and Posts) Act, 2012. While the court had scrapped the // classes over "illegality" of reports recommending such classification, other 37 classes were removed from the OBC list for non-consultation by the West Bengal Backward Classes Commission. The bench had also struck down an executive order of May 11, 2012 creating several sub-classes. The high court ruled that the directions will take effect prospectively.

Kolkata doctor rape-murder: SC pulls up Bengal government, police; sets up panel to look into medical professionals' issues

Saying that it was "deeply concerned" about the "virtual absence of safe conditions of work for young doctors across the country", the Supreme Court on Tuesday pulled up the West Bengal government over the August 9 rape and murder of a woman doctor at R G Kar Medical College and Hospital in Kolkata, questioned the role of the state police and the former principal of the institution, and put in place a nine-member panel to recommend solutions to issues related to the safety and well-being of medical professionals. Terming the rape and murder "horrific given the nature of the crime", a three-judge bench presided by Chief Justice of India (CJI) D Y Chandrachud asked the Central Bureau of Investigation (CBI) to furnish a status report on the investigation by August 22.

"We would want CBI to file a state report before this court on Thursday. We want CBI to appraise us on the status of the investigation. Investigation obviously will be at sensitive stage, therefore report should be submitted to court," the bench also comprising Justices J B Pardiwala and Manoj Misra said. The court also directed the Central Industrial Security Force (CISF) to provide security to the hospital, wondering "what was the police doing?" when a mob gathered at the hospital on the night of August 14, attacked protesters, and vandalised the premises. "It's a matter of very serious concern. The doctors... they were all working with her... doctors are on protest ... a mob assembles at the hospital. The hospital is invaded and critical facilities are damaged... What was the police doing?" asked the CJI. It recorded in the order, "We are unable to comprehend how the authorities were not able to deal with the vandalism...". The bench also posed questions on the role of Sandip Kumar Ghosh, the former principal of R G Kar Medical College and Hospital, and said it seems there was an attempt to pass off the murder as a suicide. "After the crime was detected in the early hours of the morning, the principal of the hospital tries to pass this off as a suicide. Parents are not allowed to see the body for almost three hours," the CJI observed. Senior Advocate Kapil Sibal appearing for the

state sought to deny this and said he would place the true

facts before the court. The court asked why the First Information Report (FIR) was registered only at 11.45 pm even though it was evident from the autopsy conducted much earlier in the day that it was a case of rape and murder. It also sought to know why Ghosh was appointed to another college when he was under cloud. "After the principal resigns, he is appointed as principal of another college!...his conduct is under scrutiny and he is appointed as a principal somewhere else!" Chandrachud exclaimed. The court also asked the state to ensure that the power of the state of West Bengal is not unleashed on peaceful protestors. "Let not the power of the State of West Bengal be unleashed upon peaceful protesters. Let us deal with them with great sensitivity. This is a moment for national catharsis," the CJI said.

Solicitor General of India Tushar Mehta said that a mob of 7,000 people would not assemble without the knowledge and the connivance of the police. "Even in a well organised function if we want the presence of 500 people in an auditorium, we all know we need to make efforts. Seven thousand people in the middle of the night, armed with lathis and hockey sticks can never be without the knowledge or consent of the police force. It's complete failure of law and order in the entire state," said Mehta. The court also expressed its concern over the name and details of the victim being published in the media. "We are deeply concerned of the fact that the name of the deceased who was assaulted and murdered has been published all over the media. Photographs, published all over the media, video clips either, obviously before or after the postmortem have been published showing her body after she was subjected to the assault," the CJI said. Terming it "extremely concerning", the CJI added, "We are the first to recognise the right to free speech, but there are well settled parameters which have been laid down in the new criminal procedure code and in the judgments of our court...that you will not publish the names of the survivors of the sexual assault."He further asked, "Is this the way we provide dignity and respect the privacy of an individual, young doctor, who has lost her life?"Sibal said the state police had filed 50 FIRs in this connection

We will protect Constitution, reservation at all costs: Rahul after govt's lateral entry U-turn

With the Centre withdrawing the latest advertisement for lateral entry in bureaucracy, Leader of Opposition in the Lok Sabha Rahul Gandhi on Tuesday said the Congress will protect the Constitution and the reservation system at all costs and foil "conspiracies" of the BJP.

His remarks came after Union Minister of State for Personnel Jitendra Singh wrote to Union Public Service Commission (UPSC) Chairman Preeti Sudan and asked her to cancel the advertisement so that marginalised communities get their rightful representation in government services. "We will protect the Constitution and the reservation system at all costs. We will foil the BJP's conspiracies like that of 'lateral entry' at any cost," Gandhi said in a post in Hindi on X. "I am saying it again – by removing the 50 per cent reservation cap, we will ensure social justice based on caste census," the former Congress chief

On August 17, the UPSC issued a notification for recruiting 45 joint secretaries, directors, and deputy secretaries through lateral entry, referred to as the appointment of specialists (including those from the private sector) in government departments. The decision had ignited criticism from opposition parties, which claimed it undermined the reservation rights of OBCs, SCs, and STs. In his letter, Singh said that for the prime minister, reservation in public employment is "a cornerstone of our social justice framework aimed at addressing historical injustices and promoting inclusivity"

The ward boy and the nurse have also been arrested for forcibly taking her to the doctor's room," Sandeep Kumar Meena, Superintendent of Police (Rural), Moradabad, said. The doctor was booked under the Scheduled Caste and Scheduled Tribe (Prevention of Atrocities) Act, 1989, and under Section 63 (rape) of the Bharatiya Nyaya Sanhita (BNS), and the nurse and the ward boy were booked under Section 61 (criminal conspiracy) of the BNS, Meena added. "Heavy deployment has been made in the victim's native village in Moradabad district as a precautionary measure," Meena further said. all three accused were produced before a local court and sent to judicial custody. Ahead of winter, Delhi urges Centre to facilitate interstate coordination to contain air pollution

Delhi air pollution, winter air quality, Environment Minister Gopal Rai, collaboration with neighboring states, Union Environment Minister Bhupender Yadav, crossborder pollution, crop residue burning, thermal plants, brick kilns, diesel generators, non-electric vehicles, industrial emissions, coordinated response, Delhi demographic location, long-term solution, common strategy meeting, Delhi government initiatives, odd-even vehicle scheme, electric vehicles, public transport, air quality improvement, Save Environment Round Table Conference, winter action plan. Among these factors, Rai highlighted crop residue burning in neighbouring states, thermal plants, brick kilns, use of diesel generators because of disrupted power supply, and influx of private and commercial non-electric vehicles along with industrial emissions from neighbouring states. Months ahead of winter, when Delhi's air quality notoriously plummets, Environment Minister Gopal Rai has urged the Centre to facilitate collaboration between the administration in the national capital and its neighbouring states to address sources of cross-border sources of air pollution. In a letter to Union Environment Minister Bhupender Yadav, Rai wrote on Tuesday that the air pollution crisis loomed large despite several efforts as the air quality "remains hazardous" mainly between November and December. He attributed the situation largely to factors "beyond the control of this state government".

Among these factors, Rai highlighted crop residue burning in neighbouring states, thermal plants, brick kilns, use of diesel generators because of disrupted power supply, and influx of private and commercial non-electric vehicles along with industrial emissions from neighbouring states. Adding to the woes, according to the minister, is Delhi's "peculiar" demographic location as it is "sandwiched among various states". "The scale of this challenge requires a more robust and coordinated response among all neighbouring states of Delhi," Rai



to the crisis, Rai requested the Union minister to arrange a meeting to devise a common strategy. In his letter, the Delhi environment minister listed the initiatives the state government has taken. "We regularly undertake several initiatives to combat this issue, such as implementing the odd-even vehicle scheme, promoting electric vehicles, and enhancing frequency of public transport etc," he

Rai said there was a 35.5 per cent increase in days with good or moderate air quality from 2017 (152 days) to 2023 (206 days) and attributed this improvement to the Government's efforts. Among such efforts listed in Rai's letter are steps taken to reduce vehicular pollution, such as electric vehicle subsidies, strengthening of charging infrastructure and awareness campaigns. Other initiatives include banning firecrackers, increasing the electric bus fleet, undertaking large-scale plantation drives and ensuring a switch to clean PNG in industrial units. The Government, however, is yet to roll out its winter action plan. According to a press release issued on August 2, the Government will organise a Save Environment Round Table Conference on Wednesday at the Delhi Secretariat and the action plan will be prepared on the basis of opinions arising from the event.

Nearly 10,000 voters over 100 years in Haryana, EC officials surprised

In a surprising discovery, the number of voters aged over 100 in Haryana has been found to be significantly higher than in neighbouring Punjab and Himachal Pradesh, prompting election officials in the poll-bound state to verify the data at the booth level. Haryana is set to hold the assembly elections

Haryana Chief Electoral Officer Pankaj Agarwal revealed on Sunday that 9,554 voters in the state are aged over 100. "When our staff inquired from neighbouring states, they found that Punjab has 4,116 such voters, while Himachal Pradesh has 1,216," Agarwal told .Agarwal expressed skepticism about the high numbers, stating, "We will verify the data of those voters aged over 100 again, as the number seems unusually high. I am not satisfied with these figures. Therefore, we will conduct a verification with the help of booth level officers (BLOs)."

Interestingly, the number of such voters was even higher during the recent Lok Sabha elections in Haryana. At that time, 10,759 voters were in the 100 to 109 age group, and 41 voters were over 120 years old, including eight from Gurgaon. A total of 1.98 crore voters were eligible to participate in those elections in Haryana.In Punjab, 2.13 crore voters were eligible to cast their votes during the Lok Sabha polls, with 5,162 voters reported to



be over 100 years old.

Election officials in Haryana are particularly surprised by the high number of centenarian voters when compared to a larger state like Punjab. One official noted, "A few decades ago, people were often registered as voters based on estimated age as reported to the election officials. The practice of registering voters with documentation only started recently, which may explain the ambiguity in the ages of those over 100 years." However, another official suggested that the large number of centenarians in Haryana might be attributed to the state's rural residents, who often maintain healthy lifestyles, including vegetarian diet and physical work, which may have contributed to their longevity.

Bombay HC junks PIL seeking ban on noisy sound systems, laser beams

The Bombay High Court Monday disposed of a Public Interest Litigation (PIL) that sought to ban high-decibel sound systems and hazardous laser beams, citing a failure by the state government and police to effectively implement noise pollution rules. The court clarified that petitioners have other remedies available to address grievances related to the non-implementation of the 2016 HC verdict on noise pollution guidelines. Individuals can make representations to the relevant authorities, including the police. A division bench comprising Chief Justice Devendra Kumar Upadhyaya and Justice Amit R. Borkar ruled on the PIL filed by the Akhil Bharatiya Grahak Panchayat, Pune. The petition sought a complete ban on the sale, lease, import, and use of loudspeakers and

sound systems emitting noise levels that exceed permis sible limits and cause hearing loss.

The petitioner, represented by advocate Sattyendra Muley, cited a report from the College of Engineering, Pune, indicating that noise pollution levels in Pune during the 2023 Ganesh Festival reached hazardous levels. The PIL also requested a directive for authorities to submit a report on the use of hazardous laser beams during processions and ceremonies and sought a ban on their sale and use until appropriate regulations are established by the state. The petitioner argued that the recent trend of using dangerous light laser beams, particularly during the Ganesh festival, necessitated immediate action. Despite the 2016 HC judgement that set noise pollution guidelines, the petitioner claimed that authorities had not effectively implemented them.Government Pleader Priyabhushan P. Kakade countered that the directions issued in the 2016 judgement had been fully complied with. The court noted that some aspects of the PIL were vague and speculative, lacking concrete factual evidence. It ruled that the petitioner did not establish a prima facie case for the requested measures. In disposing of the plea, the HC advised that in the absence of specific legislation or regulations governing the use of light laser beams in public places, the petitioner could submit detailed representations to the relevant authorities and file complaints with the police under the Bharatiya Nyaya Sanhita, 2023.

AIIMS issues treatment advisory, 3 Delhi govt hospitals to set up isolation rooms

AIIMS Delhi monkeypoxAccording to the protocol upon arrival, patients with fever, rash, or a history of contact with confirmed Monkeypox cases should be flagged for immediate assessment.AIIMS Delhi Tuesday issued an advisory on handling suspected patients of mpox. The Delhi government also directed three of its hospitals — Lok Nayak, GTB and Baba Saheb Ambedkar — to set up isolation rooms to manage suspected and confirmed cases, officials said while stressing that no patient has been detected so far. The World Health Organisation, sounding its highest level of alarm, declared mpox, earlier referred to as monkeypox, as a Public Health Emergency of International Concern last week in view of its prevalence and spread across many parts of Africa. It is a viral zoonosis with symptoms similar to those seen in the past in smallpox patients, although clinically less severe.At AIIMS, an SOP has been issued to handle cases in the Emergency Department. Any patient coming to AIIMS will be screened in the triage area — patients will be assessed for fever, rash, or a history of contact with a confirmed mpox case and will be then flagged for

The symptoms include fever, headache, muscle aches, back pain, swollen lymph nodes, chills, exhaustion, and characteristic skin lesions. Beds have been earmarked in isolation areas for suspected patients; these will be allotted on the recommendation of the Emergency CMO and treated by the Medicine department. "AB-7 shall remain a temporary holding area for the patient till he/ she is shifted to the hospital earmarked for the definitive care (Safdarjung Hospital)," said the AIIMS advisory.AIIMS will refer patients to Safdarjung Hospital, which has been designated to manage and treat cases. For this, a dedi-



cated ambulance has been allotted to shift patients to Safdarjung. "The Emergency staff has to inform the ambulance coordinator on the mobile number -8929683898 — to shift the suspected patient to Safdarjung hospital," said the AIIMS advisory. An official from Safdarjung Hospital said discussions are ongoing on bed allocation and steps regarding treating patients.

The AIIMS advisory further said all suspected cases, when identified, will be notified to officials of the Integrated Disease Surveillance Programme (IDSP).At Lok Nayak, Delhi government's largest hospital which has been designated as the nodal facility, there will be 20 isolation rooms, including 10 for confirmed cases. GTB and Baba Saheb Ambedkar hospitals, which will be on standby, will have 10 rooms each for such patients, with five for suspected cases. At least 99,176 cases and 208 deaths due to mpox have been reported from 116 countries since 2022, according to WHO data. Since 2022, 30 cases have been reported in India. The last case was

Amid MUDA row, Siddaramaiah says won't give up social justice fight 'whether in power or not'

Efforts to suppress backward communities that have gone on for centuries continues even in the present times, Karnataka Chief Minister Siddaramaiah said in a veiled reference to attempts to implicate him in a corruption case over housing plots allotted to his wife. Speaking at an event held to mark the birth anniversary of former chief minister and backward classes leader Devaraj Urs, to whom he is often compared, Siddaramaiah suggested that the attempts to taint his record with a corruption charge were part of a larger conspiracy to suppress backward

"I became a minister for the first time in August 1984. It has been 40 years. There is no black mark against me. They have now started efforts to taint me. Even if I have not committed any mistake they are saying that I have committed a mistake. They are saying it daily and demanding that I resign. This is the conspiracy that is underway," Siddaramaiah said. "All those who are deprived of social justice must fight against this conspiracy, all those who have been suppressed and discriminated against must unite to fight this conspiracy. If you do not fight back, you will not get justice."He said the caste system is entrenched in the state and the country. "Even today there are efforts being made to suppress the backward classes," he added."I will not give up the fight for social justice whether I am in power or not. I will not give up the principles that I believe in," Siddaramaiah said.

Governor Thawar Chand Gehlot has granted sanction to three activists to seek investigations against Siddaramaiah over the grant of 14 housing sites to his wife in Mysuru in exchange for 3.16 acres of land "wrongly acquired" from her by the Mysore Urban Development Authority (MUDA). In a minor relief for Siddaramaiah, the Karnataka High Court on Monday asked a special court not to conduct proceedings till August 29 on private complaints filed against him by the people who were granted sanction by the Governor on August 16. "See, if you venture to touch the entrenched system, it becomes very difficult. It is very difficult to change the system. This is happening in the entire state and the country," Siddaramaiah said during the Devaraj Urs birth anniversary event in Bengaluru.Siddaramaiah suggested that he was being targeted by some sections of society for his pro-backward and pro-poor policies. "We have done the caste survey. Is it not necessary to understand the situation of various communities? They are angry that I have done it and want to finish me off politically. There is a conspiracy underway," he said. The survey report was submitted to Siddaramaiah in February but is yet to be accepted by his Congress Government for fear of drawing a backlash from dominant communities such as the Lingayats and the Vokkaligas, whose standing may be diminished by the survey's findings.'Land reform law tweaks to be re-



Karnataka Chief Minister Siddaramaiah suggests certain sections of society want to finish him off politically because he has carried out a caste survey.

Siddaramaiah said his government would change modifications made to the Karnataka Land Reforms Act 1961 by the BJP government in 2020. Amendments had removed the Act's section 79A, which allowed only those earning less than Rs 25 lakh annually to buy agricultural land, and section 79B, which said only people earning a living through agriculture could buy agricultural land. The amendments also removed section 79 C, which empowered the revenue department to investigate violations of sections 79A and B. "The policy of land reforms carried out by Devaraj Urs allowed agricultural communities to own land through sections 79 A and B. We will restore the land laws when we have a majority in the Legislative Council," he said. "Those who oppose pro-poor programmes are those who cannot tolerate change? This has been in existence since Independence, during Devaraj Urs's time and even now," he said in a reference to the Congress's guarantees. "Our people support those who give pro-poor programmes and those who oppose it also. This is the problem. This is what happened during the time of Devaraj Urs."Siddaramaiah said a recommendation would be made to the Central Government to award the Bharat Ratna posthumously to Devaraj Urs. He also said Electronic City in Bengaluru would be named as Devaraj Urs Electronic City. "Last time I had said that Electronics City will be renamed as Devaraj Urs Electronics City and it is under process. We will carry out the change of name," the chief minister said.

What's behind jailed Imran Khan's bewildering Oxford chancellor bid

Former Pakistan Prime Minister Imran Khan has applied for the post of Chancellor of Oxford University. In jail for over a year, Imran will run in the Oxford election in October. What does his application mean for Imran and Pakistani politics? Is it just an attempt to attract global attention or a signal to Pakistan's powerful military?

Former Pakistan Prime Minister Imran Khan is doing more than just stare at jail walls. He has applied to be the Chancellor of Oxford University. In jail for a year now, Imran Khan's surprise move to run for the elections for the Oxford top post could be a bid to attract global attention while his party holds rallies in Pakistan on the anniversary of his jailing. It could also be a signal to the powerful military of Pakistan that Imran is done with Pakistani politics and is interested in a third career, after cricket and politics. Imran's adviser Syed Zulfi Bukhari revealed that he submitted an application to run in the October election. He has applied at a time when elections and nominations for the position of the Chancellor have become online.

The former Pakistani Prime Minister will contest to replace Chris Patten, the former Conservative minister. Patten, the chancellor of Oxford University, announced he was stepping down from the post in February.Imran's journey in Pakistan's politics started with his promise of "Naya Pakistan" or "new Pakistan". He is now languishing in jail, facing several charges, which his supporters allege are part of a political conspiracy.

IMRAN KHAN: THE CHANCELLOR OF OXFORD UNIVERSITY?"It's a ceremonial post but one with the utmost prestige and importance and Imran Khan, being one of the larger or more popular names coming out of Oxford, it would be brilliant to see him as chancellor," Bukhari told AFP.The list will not be made public till October.But an entry into the prestigious British university might also be a going away from Pakistan's politics for Imran Khan.Imran Khan had a playboy lifestyle during his cricket career, regularly becoming the subject of Britain's gossip magazines.He later turned to philanthropy and politics, serving as Pakistan's Prime Minister from 2018 to 2022 as the leader of the Pakistan Tehreek-



e-Insaf (Movement for Justice). The party has now been banned.

He was removed as PM through an army-backed vote of no confidence in Pakistan's parliament and has been in prison for the past one year. Khan has alleged that this is part of a political scheme against him. The Chancellor's post won't be something exceptional for him. Imran has also been the Chancellor of the University of Bradford for eight years, from 2005 to 2014. If he does become the Chancellor, this time of Oxford, will he bid adieu to Pakistan's politics? Or is this a signal to Pakistan's powerful military, which he had taken on as the PM, that he is moving on?

CAN IMRAN KHAN MAKE IT IN THE UK?Imran Khan is also a graduate of Oxford, where he studied politics, philosophy and economics at Oxford's Keble College in the 1970s. He earned an honours degree for the university's cricket team."If he does become the chancellor, he would be the first of Asian descent. It wouldn't be something only for Pakistan, but it would be a great achievement for all of Asia and the rest of the world," Bukhari added. Voting will take place from October 28. But only Oxford graduates and members of the university can vote. As for his chances of winning, his competitors are: UK ex-PM Tony Blair and Boris Johnson. Mpox outbreak in Africa neglected



Mpox's recent history is yet another reminder that an infectious disease in one corner of the world should not be regarded as someone else's problem, as it can suddenly start to spread fast and far. It also highlights global inequities in resource allocation and access to vaccines, diagnostics and treatments. These were made available in many industrialised countries and helped curb the global outbreak, but are still largely lacking in most of AfricaThe mpox outbreak in Africa is yet another example of how infectious diseases perceived to be "someone else's problem", and affecting mainly poor, developing countries, may suddenly pose unexpected global threats.

Mpox was discovered in 1958 (in captive monkeys, hence the original misnomer "monkeypox") and the first human case was identified in 1970. Then for decades it was largely neglected by the scientific and public health communities, regarded as an uncommon infection in remote rural areas in tropical Africa without relevance for the rest of the world. When a massive mpox outbreak hit developed countries in 2022, increased research funding led to a surge in scientific studies. On just one medical search engine, there's been more research produced since April 2022 than in the preceding 60 years.

The 2022-23 global mpox outbreak happened despite repeated calls from African researchers for increased global investment in diagnostic, therapeutic and infection prevention tools for mpox. The WHO has now declared the current upsurge of mpox in central Africa a public health emergency of international concern. This is the highest alert level for events that constitute a public health risk to other countries and requires a coordinated international response. We are infectious disease researchers who have worked on HIV, SARS-CoV-2 and other viral infections. Mpox's recent history is yet another reminder that an infectious disease in one corner of the world should not be regarded as someone else's problem, as it can suddenly start to spread fast and far. It also highlights global inequities in resource allocation and access to vaccines, diagnostics and treatments. These were made available in many industrialised countries and helped curb the global outbreak, but are still largely lacking in most of Africa. The disease has been renamed "mpox" but the name of the virus, for now, remains "monkeypox" (MPXV). It is closely related to the smallpox virus. MPXV was considered a zoonotic disease endemic in parts of central and west Africa. It was acquired mainly through close contact with wild mammals, especially handling bush meat, but there was no sustained human-tohuman transmission.

Only very occasionally were cases seen outside the endemic areas, due to infected travellers or import of infected small mammals. This changed abruptly in 2022: a massive, rapidly evolving global outbreak caused over 99,000 laboratory-confirmed cases in 116 countries. At its peak in August 2022, over 6,000 cases were reported each week. This outbreak came as a total surprise: most cases were reported from non-endemic countries, mostly in men who have sex with men who had become infected during recent sexual encounters.

Even though most cases were clinically not particularly severe and the death toll stands at just over 200, the global outbreak was declared a public health emergency of international concern by the World Health Organization on 23 July 2022. Fortunately, case numbers soon plummeted due to a combination of behavioural changes and vaccination in at-risk groups. Modern vaccines and antiviral drugs with activity against mpox were made available in many affected high-income countries. These had been developed and stockpiled in the US and Europe, mostly in preparation for a potential bioweapon attack

using a poxvirus. The global outbreak in 2022 was caused by clade II of MPXV, which is endemic in west Africa and not as virulent as clade I MPXV, which so far has only been seen in the Congo Basin. That first mpox public health emergency of international concern was declared over in May 2023. Clade II MPXV infections are still occurring globally, but the worst seems over – for now. Complacency would be misguided, as illustrated by the current mpox outbreak that is gathering steam.

The African region is experiencing an upsurge in mpox cases which started in 2023. As the continent which includes the areas where mpox has been endemic for a long time, Africa now presents a complex mosaic: cases arising from the endemic, largely zoonotic, pattern that used to be predominant in the past cases linked to the 2022 global outbreak, for example in South Africa most worryingly, ever increasing numbers of MPXV clade lb infections reported from the Democratic Republic of Congo.

The current clade I MPXV (formerly called Congo Basin strain) is more virulent than the clade II (west African) strain, resulting in a higher case fatality rate. The ongoing outbreak has its epicentre in South Kivu province, eastern DRC, and has the potential to fuel a large pandemic. It has a distinct epidemiological pattern with sustained chains of numan-to-numan transmission, of ten via the sexual route. It may have increased transmissibility (we don't know yet). The virus which causes it is the newly defined clade Ib lineage. It displays mutations that are the hallmark of human-to-human spread that is estimated to have been happening since September 2023. Case numbers are rising rapidly, even though many suspected cases are likely not tested and thus not counted as confirmed. Complicating matters, a commonly used test was found to miss infections with this lineage of the virus. It affects mostly adults. The case fatality rate is higher than it was in the 2022 global outbreak. Already, this outbreak has resulted in mpox cases occurring in several neighbouring countries, including some (like Kenya) with no previous record of mpox. The challenge is enormous. The eastern DRC is an area beset by multiple problems. This includes natural disasters, violence and infectious diseases including measles, cholera and poliomyelitis for the DRC.In recent years the second-largest Ebola outbreak ever took place in the wider area and, despite the availability of vaccines and treatments, posed considerable challenges. A recent article we co-authored in The Lancet Global Health outlines what needs to be done to contain this outbreak and prevent it from turning into an epidemic, possibly even a pandemic. Equitable access to diagnostic tests, vaccines and antiviral treatments requires political commitment and financial investments. Scientific investigations are needed to learn more about exposure settings, transmission routes and clinical presentations. It's important to find the best ways to make these interventions. We have proposed the establishment of an African-led, multidisciplinary, multi-country Mpox Research Consortium (MpoxReC) in Africa. It should conduct research towards the elimination of mpox as a public health problem. There is no doubt that a disease in one corner of the world can suddenly become a global heath threat. It's time the global health system woke up to



Possible work stoppage at Canada's two largest railroads could disrupt US supply chain next week

Canada's two largest railroads are starting to shut down their shipping networks as a labour dispute with the Teamsters union threatens to cause lockouts or strikes that would disrupt cross-border trade with the US.Both the Canadian Pacific Kansas City and Canadian National railroads, which haul millions of tons of freight across the border, have stopped taking certain shipments of hazardous materials and refrigerated products.

Both are threatening to lock out Teamsters Canada workers starting Thursday if deals are not reached.On Tuesday, CPKC will stop all shipments that start in Canada and all shipments originating in the US that are headed for Canada, the railroad said Saturday. The Canadian Press reported that on Friday, Canadian National barred container imports from US partner railroads. Jeff Windau, industrials analyst for Edward Jones & Co., said his firm expects work stoppages to last only a few days, but if they go longer, there could be significant supply chain disruptions."If something would carry on more of a longer term in nature, then I think there are some significant potential issues just given the amount of goods that are handled each day," Windau said. "By and large the rails touch pretty much all of the economy."The two railroads handle about 40,000 carloads of freight each day, worth about USD 1 billion, Windau said. Shipments of fully built automobiles and auto parts, chemicals, forestry products and agricultural goods would be hit hard, he said, especially with harvest season looming.

Both railroads have extensive networks in the US, and CPKC also serves Mexico. Those operations will keep running even if there is a work stoppage.CPKC said it remains committed to avoiding a work stoppage that would damage Canada's economy and international reputation. "However we must take responsible and prudent steps to prepare for a potential rail service interruption next week," spokesman Patrick Waldron said in a



statement. Shutting down the network will allow the railroad to get dangerous goods off IT before any stoppage, CPKC said. Union spokesman Christopher Monette said in an email Saturday that negotiations continue, but the situation has shifted from a possible strike to "near certain lockout" by the railroads.

CPKC said bargaining is scheduled to continue on Sunday with the union, which represents nearly 10,000 workers at both railroads. The company said it continues to bargain in good faith. Canadian National said in a statement Friday that there had been no meaningful progress in negotiations and it hoped the union "will engage meaningfully" during a meeting scheduled for Saturday. "CN wants a resolution that allows the company to get back to what it does best as a team, moving customers' goods and the economy," the railroad said. Negotiations have been going on since last November, and contracts expired at the end of 2023. They were extended as talks continued. The union said company demands on crew scheduling, rail safety and worker fatigue are the main sticking points. Windau said the trucking industry currently has a lot of excess capacity and might be able to make up some of the railroads' shipping volumes, but, "You're not going to be able to replace all of that with trucking."

Venezuelan opposition protests as election dispute drags on

Venezuela's political opposition and its supporters gathered in cities around the country on Saturday to demand recognition of what they say is their candidate's resounding victory in a presidential vote nearly three weeks ago. The country's electoral authority, considered by the opposition to be an arm of the ruling party, has said President Nicolas Maduro won his third term in the July 28 contest, with just under 52% of the vote.

But the opposition, led by former lawmaker Maria Corina Machado, has published online what it says are 83% of voting machine tallies, which give its candidate Edmundo Gonzalez a hearty 67% support. The disputed vote has thrown the economically beleaguered nation into political crisis, and a government crackdown on protests has led to at least 2,400 arrests. Clashes connected to the protests have also led to at least 23 deaths. (REUTERS)The international community has offered a raft of suggestions for overcoming the nearly three-weekold election crisis - including a new vote - but most have been rejected outright by both the ruling party and opposition. In the capital Caracas, thousands gathered in the eastern part of the city along its main thoroughfare. Standing on a truck in the center of the crowd, Machado called for independent, international verification of the election and for her supporters to stay in the streets. "There is nothing above the voice of the people and the people have spoken," she said. Jesus Aguilar, a 21-year-old theology student, said he turned out to support the opposition in hope of a better future. We know that with this government there are no possibilities for growth. I've even seen myself trying to leave the country."In cities across the country, Venezuelans were in the streets. In Maracaibo, Venezuela's once oil-rich city in the northwest, hundreds had gathered by 9 a.m. (1300 GMT).

"We have already been through the worst, we don't have any more fear," Noraima Rodriguez, 52, told Reuters. "My daughter died because there were no medical supplies in the university hospital. I have nothing to lose, but I want a future for my grandchildren."In the cities of Valencia, San Cristobal and Barquisimeto, hundreds demonstrated, many waving Venezuelan flags, protest signs or copies of voting tallies. In Maracay, about 110 km (70 miles) west of Caracas, about a hundred protest-

ers were dispersed with tear gas.



From Bogota to Madrid, the Venezuelan diaspora turned out in droves. In downtown Mexico City, nearly 1,000 people gathered at the central Plaza de la Revolucion. "This is the moment for a free Venezuela," said Jesus Mata, 30, a street vendor who arrived in Mexico two years ago.

Motivated by economic and political crisis, he was among tens of thousands of Venezuelans to cross the treacherous jungle between Colombia and Panama known as the Darien Gap, notorious for robberies, kidnappings, rapes and other dangers. Venezuela protest Supporters of Venezuelan President Nicolas Maduro attend a march amid the disputed presidential election, in Caracas, Venezuela.

"I hope for an end to 25 years of darkness, that there is freedom so that the almost 8 million Venezuelans who are outside the country can go back home," he added.Maduro has presided over economic collapse, with a loss of over 73% of Venezuela's gross domestic product since 2013, according to researchers from the Institute of Superior Administration Studies in Caracas.The opposition is still pushing for recognition of its victory, but its options are narrowing as international attention moves elsewhere, opposition sources and analysts told Reuters this week.

Many Western countries have urged full publication of results, while Russia, China and others have congratulated Maduro on his victory. Washington, which hardened oil sanctions in April on the OPEC member for what it said was Maduro's failure to comply with a deal on electoral conditions, and other Western countries are showing little sign of swift, tough action over what many of them have condemned as voting fraud. Latin American leaders will discuss the crisis this weekend when many are in the Dominican Republic to attend the inauguration of that country's new president, Panama's president has said.

Pakistan blames users for slow internet amid firewall rumors



For weeks, Pakistan has been grappling with slow internet speed, leaving users frustrated and sparking a debate over the cause. While activists claim that the government is constructing a China-style internet firewall to tighten control over online spaces, officials have pointed fingers at the widespread use of secure connections or VPNs as the reason for the sluggish speeds.

The Pakistani government has a history of shutting down the internet to suppress dissent, particularly after the riots following former Prime Minister Imran Khan's ousting last year. Social media platforms have been blocked, and connection speeds throttled as the government seeks to control public sentiment, which has increasingly shifted to digital platforms. The micro-blogging site X has been blocked since February due to "national security" concerns, a move that has particularly affected Mr. Khan's supporters, who are heavy users of the platform. However, Minister of State for Information Technology Shaza Fatima denied that the government is behind the recent internet slowdown. On Sunday, she stated

that her team has been "working tirelessly" with internet service providers and telecommunications companies to resolve the issue. According to Ms. Fatima, the problem stems from a "large population" using VPNs, which has "strained the network, causing the internet to go slow." She dismissed claims that the government was intentionally slowing down connections as "completely false."

Despite these reassurances, Ms. Fatima acknowledged that the government has been upgrading its systems to improve cybersecurity. "It is the right of the government to [take such measures] given the cyber security attacks that this country has to go through," she said. Activists, however, are not convinced. Shahzad Ahmad, director of the local digital rights group Bytes for All, stated that his organization has "ample tech evidence" to support the existence of a firewall."It seems its purpose is to monitor online traffic and limit dissemination [of information] in online spaces, particularly curbing political expression," Mr. Ahmad said. The impact of the slow internet is also raising concerns beyond civil liberties. Farieha Aziz, co-founder of the free speech advocacy group Bolo Bhi, warned that the issue is now affecting livelihoods and the economy. Business leaders have echoed these concerns, with the Pakistan Software Houses Association warning that the slow connections could cost the IT sector up to \$300 million. The association described the situation as a "direct, tangible, and aggressive assault on the industry's viability" and cautioned that a "mass exodus of IT companies is not just a possibility but an imminent reality if immediate and decisive action is not taken."In response to the growing discontent, activists have filed a petition with the Islamabad High Court, urging that access to the internet be recognized as a fundamental right under Pakistan's constitution.

Global warming may be factor in deadly Italian shipwreck, climatologist says

Global warming may have contributed to the freak storm that sank a luxury British-flagged yacht off the coast of Sicily on Monday, Italian climatologist Luca Mercalli told Reuters. One man died and six people were missing, including British tech entrepreneur Mike Lynch, after the "Bayesian", a 56-metre-long (184-ft) sailboat, was suddenly hit by ferocious weather.

Mercalli, president of the Italian meteorological society, said the episode could have been a water spout, essentially a tornado over water, or else a downburst, a more frequent phenomenon that doesn't involve the rotation of the air."We don't know which it was because it all happened in the dark in the early hours of the morning, so we have no photographs," he said.In Italy water spouts can involve winds of up to 200 kilometres (124 miles) per hour, while downbursts can produce gusts of more than 250 km per hour.Statistics show that downbursts are becoming more frequent around the country, which Mercalli said may be connected to global warming. Storms and heavy rainfall have swept down Italy in recent days after weeks of scorching heat.

"The sea surface temperature around Sicily was around 30 degrees Celsius (86 Fahrenheit), which is almost 3 degrees more than normal. This creates an enor-



mous source of energy that contributes to these storms," Mercalli said. "So we can't say that this is all due to climate change, but we can say that it has an amplifying effect." A similar freak storm killed four people, when their tourist boat sank on Lake Maggiore in northern Italy in May last year. The country's varied geology makes it prone to floods and landslides, while the fact it is flanked by rapidly warming seas means it is vulnerable to increasingly powerful storms. "Climate-driven catastrophes in Italy will become more frequent and more intense," Mercalli said.

'Banksy woz ere.' London Zoo is the latest to remove street artist's animal mural for protection

The gorilla and other animals that appeared to have escaped from the London Zoo in Banksy 's most recent work have been taken into safekeeping. The zoo said it removed the elusive street artist's mural on its gate Friday evening to preserve it and return its entrance to full operation after mobs of visitors came to see it over five days last week. It was covered with a reproduction of the work and a sign using British slang that said: "Banksy woz ere." "We're thrilled by the joy this artwork has already brought to so many, but primarily, we're incredibly grateful to Banksy, for putting wildlife in the spotlight," Kathryn England, the zoo's chief operating officer, said on its website. "This has become a significant moment in our history that we're keen to properly preserve."

The work spraypainted with a stencil showed an ape holding up part of the roll-down gate, allowing birds to fly off and a sea lion to waddle away as three sets of eyes peered out from the darkness inside. It was the final animal-themed work by the artist to pop up over nine consecutive days around London.Britain Banksy People take pictures of a new mural by elusive street artist Banksy at the London Zoo. And it's the most recent one to disappear from public view. The meaning of works by the artist known for making political statements has been widely debated online. The zoo said its mural had sparked thought-provoking conversations from people ranging from a 5-year-old to Banksy buffs. Some suggested it was a play on guerrilla art or a comment on the role of zoos. A representative for Banksy, whose real identity is not known, told the Observer that the series was intended to be uplifting and amusing during tough times. The zoo mural is at least the fifth in the animal series to be either stolen, defaced or moved to a secure place for protection. A howling wolf painted on a satellite dish to look like it's silhouetted against a full moon was taken by masked men hours after the artist confirmed it was his work by posting photos of it on his Instagram page. A rundown old billboard that featured a big cat stretching out was removed by a crew as onlookers jeered them. The billboard's owner told police it would be reassembled at an art gallery, the BBC reported.A rhinoceros painted on a brick wall that appeared to be mounting a broken-down Nissan parked on the sidewalk was tagged with graffiti and the car was taken away.

Democratic Convention: Biden passes baton to Harris, says she will be 'historic President'

"Are you ready to elect Kamala Harris as the President of the United States of America," Biden said, amidst cheers from thousands of members and leaders of the Democratic Party at its national convention here in this windy city as he urged his countrymen to vote and elect his deputy of four years. Biden said Harris would be a "historic President". "I love my job. I love my country more. We need to preserve our democracy. We need you to beat Donald Trump and elect Kamala and Tim as President and Vice President of the United States," Biden said.

He said Trump is going to find out the power of women in 2024. Harris will soon serve as the 47th President of the United States, Biden said, amidst cheers from his party members and leaders. "We saved democracy in 2020 and we must do it again in 2024," he said urging his countrymen that America's future is in their hands.

"America, America, I gave my best to you. I made a

lot of mistakes in my career. But I gave my best to you," he said. "Let me ask you: Are you ready to vote for freedom? Are you ready to vote for democracy and for America? And let me ask you: Are you ready to elect Kamala Harris and Tim Waltz as President and Vice President?" he asked.Biden appeared to wipe away a tear as he hugged his daughter Ashley Biden who introduced him at the four-day convention. Observing that the decisions that were being made now would determine the fate of the world and the country, Biden said he and Kamala had four years of extraordinary progress in the United States.

Making a strong pitch to elect Harris as the next President of the United States, Biden said Donald Trump promised infrastructure week every week for four years. He never built a damn thing, he alleged. "Together, we are building a better America," he said as he listed out some of the key achievements of the Biden-Harris Administration. "You cannot say you love your country only when you win," he said. "More Americans have health insurance today than ever before. "That is the perfect name," he replied to a user who proposed the name of the Ministry for Musk who has been supporting Trump on his social media platform. In an audio interview on X last week, Trump and Musk discussed a wide range of issues — from immigration to the economy, education, climate change, Russia and Ukraine, the relationship with North Korea's Kim Jong Un, Russia's Vladimir Putin and China's Xi Jinping in the context of the 2024 presidential election. Musk even tried to educate climate change sceptic Trump on greenhouse gas peril and renewable energy. Later, venture capitalist Vinod Khosla slammed Musk over his climate-talk tutorial, saying his



thoughts about CO2 ppm (parts per million) levels and their consequences were simply 'dumb'. The X owner endorsed the former President against his Democrat rival, Vice President Kamala Harris. Trump said that illegal immigration saved his life while talking about the assassination attempt on him at an election rally. The interview broadcast was delayed by a cyber attack. The former President was permanently suspended from X in January 2021, when the social media platform was known as Twitter. The ban was lifted by Musk after he bought the

Harris and Walz embark on a bus tour in Pennsylvania before the Democratic convention in Chicago

Democratic presidential nominee Kamala Harris and running mate Tim Walz embarked on a bus tour in southwestern Pennsylvania on Sunday, hoping to ride a wave of enthusiasm for her candidacy to their party's nominating convention in Chicago this week. Vice President Harris and Walz, the governor of Minnesota, were joined by their spouses, Doug Emhoff and Gwen Walz, as they arrived at Pittsburgh International Airport and greeted supporters. They will make stops in the Pittsburgh area to glad-hand with voters. Harris and Emhoff were scheduled to deliver remarks at an event in the borough of Rochester, in Beaver County, which Donald Trump, the Republican presidential nominee, won in 2020. The stop came exactly four weeks after President Joe Biden Biden dropped his reelection bid and endorsed Harris to replace him on the ticket. Southwestern Pennsylvania is a critical part of a key battleground state that has long commanded the attention of presidential candidates. The state voted for Trump in 2016 and for Biden in 2020. Both Harris and Trump are vying to see who can put Pennsylvania in their column on November 5. Most polls, including the New York Times/Siena College poll and Fox News, find Harris and Trump locked in a tight race statewide. Trump held a rally Saturday in Wilkes-Barre in the northeastern part of the state, following his earlier rallies in July in Harrisburg and Butler, where he survived an assassination attempt. The bus tour marks Harris' eighth trip to Pennsylvania this year, and her second this month. The vice president's August 6 announcement that Walz would be her running mate came hours before their first joint appearance as a ticket later that day in Philadelphia. "This is a state that traditionally has been super important, but southwestern Pennsylvania has been really kind of the battleground part of the battleground state," said Kristin Kanthak, associate professor of political science at the

University of Pittsburgh. Allegheny County, which includes Pittsburgh, is a diverse county with urban, suburban and rural areas, and a lot of people who haven't decided how they will vote, she said. It makes sense to come here and ask for votes because there are votes up for grabs here," Kanthak said of Harris. "It's not just about turning out your base. It's about having an opportunity to speak to truly undecided voters." In the 2020 race, Biden won Allegheny County with 60 per cent of the vote, while Trump won neighbouring Beaver County, which includes Rochester, with about 58 per cent of the vote. After Trump's surprise win in the state in 2016, Biden flipped Pennsylvania in 2020 — and, in so doing, won the White House in part by running up his vote totals in heavily Democratic Pittsburgh, the state's second-largest city and the county seat of Allegheny County. Biden assiduously courted the area's blue-collar labour unions, kicking off his 2020 presidential campaign at a Teamsters hall in Pittsburgh by declaring, "I am a union man." As president, he opposed the acquisition of Pittsburgh's storied US Steel by a Japanese company, saying it "should remain totally American," and enacted steeper tariffs on Chinese steel. Trump, who is counting on strong turnout from his base of white, working-class voters, is not conceding the area. The counties around Pittsburgh have shifted from Democrat to Republican in recent presidential contests, delivering for Trump in both of his earlier runs. Trump has also embraced protectionist trade policies and insists he is proworker. His vow to increase US energy production and "drill, baby, drill" has resonated in southwestern Pennsylvania blue-collar counties like Washington, where a natural gas drilling boom has helped make Pennsylvania the nation's No. 2 producer after Texas. Harris once wanted to ban fracking, an oil and gas extraction pro-

cess, before recently disavowing her earlier position.

Dana Brown, director of Chatham University's Penn-



sylvania Center for Women & Politics, said in an interview that Harris will use the bus trip to reach out to voters in the state's southwestern region "while she still has a great deal of momentum at her back" and spin up local media coverage. "She is going to garner a lot of that free media attention," Brown said. "I believe their hope, right, is to keep that momentum up and focused on her and less so on her opponent." Bus tours have become a staple of political campaigns partly because of the free media coverage they generate. Such trips get the candidates out of their power suits and out of Washington so they can travel the country and score face time with voters in small venues like diners and mom-and-pop shops. Biden rolled across Iowa on an eight-day bus tour he dubbed "No Malarkey" in December 2019. During his 2012 reelection campaign, President Barack Obama travelled though small-town Ohio on his "Betting on America" bus tour. "It's always fun just being out of Washington, and for me to be able to interact with folks is wonderful," Obama said at one stop. Presidents George W. Bush and Bill Clinton also travelled by bus when they campaigned for a second term. The Democratic National Convention

US alerts Indian companies on export of defence tech to Russia



US government officials are sensitising Indian companies and exporters to deter them from supplying Russia with items and technology that could end up being used in Russian missiles and other defence equipment, which would attract Western sanctions, a government official said on condition of anonymity. This follows reports of sanctions on Bengaluru-based Si2 Microsystems in November last year for its alleged role in supplying dual-use technology to Russia. Electronic components, machine tools, drones, and software for drones are some of the dual-use items that can be used for both civil and military applications and are included in the sanctions list imposed by the West in the backdrop of the Ukraine war. "They (US government officials) are leading consultation and sensitisation meetings with the industry to make Indian companies more aware of the importance of not exporting specific types of products, such as chemicals, aeronautic parts, and components that can be used in missile systems and other defence equipment," the offi-

Moreover, a US Treasury official had also warned India's banks that financial institutions that do business with Russia's military industrial base risk losing access to the US financial system, Reuters had reported in July this year. "We know that the Russian military relies on importing sensitive goods, like machine tools and microelectronics, and it looks to foreign financial institutions to facilitate these transactions," Deputy Treasury Secretary Wally Adeyemo said in the letter to the Indian Banks' Association, as per the Reuters report. Also, US Treasury Secretary Janet Yellen in June this year had expressed concerns over Chinese exports of dual-use goods. By

placing over 300 companies on an export blacklist, the US said that China is the top supplier of machine tools, microelectronics, and nitrocellulose, which are critical for manufacturing munitions and rocket propellants, as well as other dual-use items that Russia is using to bolster its defence capabilities.

The Ministry of Commerce and Industry in January 2024 had said that the government is working to liberalise export norms for certain products with dual-use applications. However, the official clarified that the items identified by the US are not Special Chemicals, Organisms, Materials, Equipment and Technologies (SCOMET) items, which require licensing for trade. Dual-use goods are categorised under the SCOMET list in India. "There are many items that the US is scrutinising. They are not SCOMET items, but the US believes they are entering the (Russian) defence manufacturing system. The two or three firms identified by the US do not export SCOMET items," the official clarified. India's exports of machines, auto parts, steel and aluminium products, internal combustion (IC) engines, pumps, and other items to Russia are on the rise. Official data from the ministry showed that India's total exports to Russia in 2023 surged by 40 per cent to exceed \$4 billion, largely driven by engineering goods, which nearly doubled to \$1.32 billion in 2023 from \$680 million in 2022. Significant gains were also seen in the drugs and pharmaceutical category, as well as in organic and inorganic chemicals. This increase in exports comes as Russia has ramped up its defence investments. In July, the World Bank reported that economic activity in Russia was influenced by a significant increase in military-related activity in 2023. Russia's military spending grew by 24 per cent in 2023 to an estimated \$109 billion, as per Stockholm International Peace Research Institute (SIPRI) states. "After the initial recessionary impact of sanctions in 2022, the (Russian) economy returned to growth in 2023, supported by fiscal stimulus, including military spending and credit expansion, and by successfully mitigating the impact of the sanctions. Restrictions on trade and financing from the G7 countries and the EU resulted in trade diversion to China, India, Türkiye, Central Asia, and the South Caucasus, as well as investment in new infrastructure and logistics," the World Bank noted. A query emailed to the Ministry of External Affairs on Monday evening remained unanswered till press time.

Cautious monetary policy needed if food price pressures continue: RBI

A cautious monetary policy approach is warranted if food price pressures persist and continue to spill over, a Reserve Bank of India (RBI) report said on Monday. "Monetary policy is the only active disinflationary agent in the economy. The conventional treatment of food price perturbations as transitory in the setting of monetary policy is increasingly becoming untenable," the report authored by RBI Deputy Governor Michael Patra and others said.

"A large part of this increase in persistence is driven by the secular upward drift in food inflation expectations. Past high food inflation episodes — intrinsic persistence — have a bearing in shaping these expectations," the report said. The inelasticity of the demand for food to price shocks makes food inflation persistence all the more worrying, it cautioned. The report, titled 'Are food price spilling over', said the conventional treatment of food price perturbations as transitory in the setting of monetary policy is increasingly becoming untenable. "A large part of this increase in persistence is driven by the secular upward drift in food inflation expectations," it said.

Headline inflation moderated from its spike in June to 3.5 per cent in July, but this was primarily due to the downward statistical pull of base effects. "If high food inflation persists, however, a more cautious monetary policy approach is warranted to squelch the propagation of food inflation pressures into a more generalised inflation," it said. The Monetary Policy Committee of the RBI had kept the Repo rate unchanged at 6.5 per cent in its review earlier this month. "Past high food inflation episodes — intrinsic persistence — have a bearing in shaping these expectations. The inelasticity of the demand for food to



price shocks makes food inflation persistence all the more worrying," the report said. With spillovers to costs, service charges and output prices, the danger of food inflation surfacing as a more generalised phenomenon has increased," it said. Under these circumstances, the sources of food price shocks may lie outside the realm of monetary policy but when they result in food inflation acquiring persistence and spilling over into other components of inflation and into consumer behaviour, monetary policy must be disinflationary to quell these price pressures in order to achieve its mandate of price stability and thereby retain credibility, the report said. It said failing to act against persistent food inflation risks expectations getting unanchored, generalisation of price pressures and loss of control over inflation, undermining of consumer and business confidence, and erosion of external sector sustainability and competitiveness. The report said persistence in food inflation has increased due to repeated climatic shocks of rising intensity. "The increase in food inflation persistence is driven by the secular upward drift in its time varying trend, signifying rising expectations of higher food prices due to overlapping supply shocks. Empirical evidence points to spillovers to non-food components, which is being offset by disinflationary monetary

Pronounced income gaps evident in case of stigmatised-caste business owners: new study

Business owners from stigmatised groups such as Dalits experience a business income gap of around 16 per cent compared with others, including those business owners who are from communities that are disadvantaged but are not similarly stigmatised, a new study has revealed. This gap increases at higher levels of social capital, reflecting the social processes of stigmatisation that limit the benefits that Dalits can reap from social capital, a research article titled "It's not who you know, but who you are: Explaining income gaps of stigmatized-caste business owners in India" has stated.

The research report published in PLOS ONE journal on August 7 this year is authored by Prateek Raj, Assistant Professor in Strategy at Indian Institute of Management Bangalore (IIMB) along with Thomas J Roulet, Professor of Organisational Sociology and Leadership at Cambridge Judge Business School and Co-Director of the King's Entrepreneurship Lab at King's College; and Hari Bapuji, Professor in the Department of Management and Marketing, Faculty of Business and Economics, The University of Melbourne, Australia. The report, which states human capital and social capital as two potential tools to facilitate economic mobility and to reduce inequalities, has attempted to find out whether these tools work equally well for stigmatised groups, particularly in societies with systemic inequalities.

There is a high income gap for stigmitased groups and instead of getting reduced, this gap increases at higher levels of social capital. However, Dalits can reap similar income benefits as others from human capital, the report said, adding that human capital helps stigmatised groups mitigate the implications of stigma, but social capital does not.Community business, income gaps, stigmatised-caste business, news business study, Dalits



We know from past research that social capital benefits people in business. So, it is commonly assumed that they will benefit everyone equally. Our study shows that that is not the case. We were surprised to find that other groups, including groups that are disadvantaged due to caste (e.g., OBCs, STs) and religion (e.g., muslims) benefit from having social capital and improve their incomes. But, for Dalits (SCs), the social capital does not help as much. We argue that this is because Dalits face a stigma that is attached to them as persons and is perpetuated in social interactions," the research paper's author Prateek Raj told The To address income disadvantages faced by the marginalised groups, that is, OBCs, adivasis/STs and muslims, it is adequate to provide them opportunities, for example, in the form of business leads, credit facilities, collaterals for large orders, Hari Bapuji, the co-author of the study, said. While noting that the government has developed several initiatives for the mobility of Dalits and other disadvantaged communities, the study states that the stigmatised groups (Dalits) and other historically disadvantaged-but not similarly stigmatised groups) face different social processes, which need to be considered in designing initiatives to reduce inequalities. There is a need to rethink development strategies involving human capital and social capital, the study said. "Since Dalits/ SCs not only face marginalisation but also experience institutional stigma, it is necessary to counter the social processes that stigmatise them. For example, the destigmatisation strategies can include education (e.g., curriculum that discusses the historical injustices and educates on the ways inclusion is achieved globally),





No toilets, 19-hour shifts, sexual abuse: Junior artistes treated 'worse than slaves in Malayalam cinema'; Justice Hema Committee reports



In addition to the ordeals faced by actors and technicians, Justice Hema Committee report also delved into the problems faced by junior artistes, who are unorganised workers since they are neither recognised as artistes nor technicians. Justice Hema Committee report states that junior artistes are not provided even basic facilities, including toilets, on movie sets.

The release of the Justice Hema Committee report, which looked into the problems faced by women working in Malayalam cinema, has sent shockwaves across Kerala. The report vehemently states that women in the film industry face extreme discrimination and exploitation. From the casting couch and lack of basic facilities on sets to pay disparities and ostracism if they refuse to comply with demands from perpetrators, the report has unmasked the industry and exposed its vile side. The threemember committee, chaired by former Kerala High Court judge K Hema and comprising veteran actor T Sarada and retired IAS officer KB Valsalakumari, was constituted by the Kerala government in July 2017 in the aftermath of the sexual assault of a prominent actor in a moving vehicle in February that year. In addition to the ordeals faced by actors and technicians, the panel also delved into the problems faced by junior artistes, who are unorganised workers since they are neither recognised as artistes nor technicians and therefore are not members of the Association of Malayalam Movie Artistes (AMMA) or the Film Employees Federation of Kerala (FEFKA). During its study, the committee discovered that junior artistes face very serious issues in the Malayalam film industry and are "treated worse than slaves on certain sets." The report clearly states that this group is not provided even basic facilities, including toilets, on sets despite being required to be present on-site for as long as 19 hours on

One junior artiste shared with the panel that during a shoot on a large open ground, they were all made to stand in the hot sun for a long period without any provision for shade, while the bigger artistes were at least given an umbrella. "The junior artistes who were all made to stand in the hot sun were not even given anything to eat or drink on many sets," the report states, emphasising

certain days. No food, no water, no chairs to sit

that generally, they aren't even provided water by the production team.

Further asserting the extremely inhumane treatment they receive, the report mentions that although only 100 persons are required for a shoot, thousands of junior artistes are told to come to the set. From this large group, the movie's team selects those they deem fit and only they receive food coupons. The others, instructed to remain on set, are seldom given food or water and are not provided any space to sit. One person recalled how a junior artiste with a heart condition was fired from a set merely because she sat on a chair after becoming exhausted from standing under the hot sun for a long time.

Sexual exploitation of junior artistes rampant"Women come for cinema shooting as junior artistes only because of their very bad financial position," the report states, asserting that those in power shamelessly exploit their situation. The report also emphasises that junior artistes are rarely paid on time. "The junior artiste would have to meet the producer or the person who has engaged them for the work repeatedly and they have to beg for the money which they owe to the artiste.' The panel also found that middlemen/coordinators take a lion's share of the wages meant for each person. Another shocking revelation in the report is that many individuals in the industry exploit women for sex. "The girls who are called for working as junior artistes are told that they would be given a chance in the cinema if they comply with the demands for sex." The report states, "WhatsApp groups are created by certain coordinators or managers with both men and women as members and thereby give them the opportunity to contact each other and they get acquainted. Their acquaintance leads to undesirable results and even ends up in the flesh trade." The panel also found that there are many fake junior artiste coordinators in the industry exploiting women.

No time limit for the work of junior artistesFurthermore, the committee revealed that many production teams abandon junior artistes after late-night shoots without providing accommodation or transport. "The women will have to go home all alone and there were occasions where they have to sleep even in the railway stations for safety."The report also states that film personnel show little concern for junior artistes who sustain injuries during work. "One of the witnesses stated that while shooting was going on for a high-budget movie recently, in which very famous artistes were working, a 70-year-old woman got burn injuries when hot oil happened to spill over her body. Even though she was taken to the hospital by the production team, no amount was paid for her treatment," it adds. The same was the case with another person who fractured his leg on the same set. The report also mentions that there is no time limit for the work of junior artistes, and they are not given any

In the same chat, Madhur also spoke about the rising entourage cost of actors and insisted that this should be controlled as it increases the cost of the film exponentially. When asked how much does a star's entourage cost. Madhur revealed that he had never faced unnecessary demands and said that the cost for these things de-

pends on the film's budget. Madhur Bhandarkar has previously received National Film Awards for his films like Traffic Signal, Page 3, Chandni Bar. He said that he is planning to make a sequel for his Privanka Chopra-starrer film Fashion but added that he isn't sure if he wants to make a film or an OTT series. Madhur said that he has enough material that can go on for 2-3 seasons.

without informing its owners besides causing damages to the property. Begum's brother filed the complaint with the Nungambakkam police station on Saturday, claiming that despite multiple requests, Raja didn't pay rent nor did he respond. In his career spanning 25 years, Raja has composed music for around 170 films. He began his career at the age of 16 when he composed music for the film 'Aravindhan'. His breakthrough Tamil movie was 'Thullavadho Ilamai' (2002), which established himself as one of the most sought after music composers in the Tamil film industry. Who after PR Sreejesh? Goalkeeper Krishan Interview series with Neeraj Chopra, other top Pathak ready to take over with Suraj Karkera, Mohit HS and Pawan as backups

In the happy family photo, he isn't in the centre of the frame. You can see him in the bottom corner, sitting second from right. He flashes a big, hearty smile. But unlike others, there isn't a medal around his neck. The image was taken on the podium of the Paris Olympics. But it might as well have been the Tokyo Games.It must be tough being Krishan Pathak. The only player to be with the hockey squad for the last two Olympics, as a reserve, and not receive a winner's medal at both. On the eve of the Paris Olympics, the International Hockey Federation shared a photo of the 27-year old Pathak and PR Sreejesh - a complete brothers-in-arms vibe - with a caption: The future and the legend.

That one frame captured two unusual happenings in Indian hockey. Sreejesh, the custodian of India's dreams for more than a decade, had announced the Paris Games would be his last dance. Indian hockey players don't say they'll hang the boots - they just fade away into twilight. Sardar Singh was a rare breed who started the trend of formally announcing retirement. But it was unheard of for a player to do it before a tournament.It's equally rare to have a succession plan in place. Sreejesh's might be ultra-large boots to fill. But in Pathak, a veteran of 125 games, India have a ready replacement, a worthy successor. "Oh, he's definitely eager. One hundred per cent," says Dennis van de Pol, a Dutch goalkeeping expert who works closely with the Indians. "Yes, they are big shoes to fill. But I also know that Pathak can do that. And it can only be better as he grows in confidence." Next month's Asian Champions Trophy could be the first time Pathak enters a tournament as the firstchoice goalkeeper. One of Suraj Karkera and Mohit HS - the two keepers who were in the core probables for the continental competition — would be Pathak's backup.

Sreejesh's role in the revival of Indian hockey is profound. Without him, it would have been next to impossible for India to win the 2014 Asian Games - their first since 1998 - that triggered a momentum shift leading to the two Olympics bronze medals, which would be tough to imagine without Sreejesh's match-defining interventions. He was unlike typical Asian goalkeepers

who, according to Van de Pol, 'have a tendency to just stay there (in the goal), drop down and hopefully save the shots.' Sreejesh charged out, was aggressive from the get-go and doubled up as an on-field coach, barking instructions to the players in front of him and organising the defence. Pathak is a polar opposite in nature. If Sreejesh talked non-stop, Pathak's voice can barely be heard on the field. If Sreejesh liked engaging in one-on-one duels with the attacker, Pathak remains in control and doesn't leave the line so frequently. If Sreejesh made himself big in the goal, Pathak deceives the attackers with his relatively small frame. "Pathak knows he is really powerful, and maybe his opponents think, 'hey, you're a little bit smaller than the average goalkeeper (so) we can beat you in the corners'," Van de Pol says. "But since he's so powerful, he can still cover the corners easily."In Tokyo, Pathak was conscious of the gap between him and Sreejesh, who mentored the goalkeeper 9 years younger than him during the 2016 Junior World Cup. Pathak used the Tokyo experience and the lessons learnt by playing along with Sreejesh to narrow the gap to the extent that there remained very little to choose between the two.

Former coach Graham Reid began giving both the goalkeepers equal amount of playing time and his successor Craig Fulton continued the philosophy. "They split the match times 50-50 not because we wanted to give the other some more experience... but also because we thought they are quite equal," Van de Pol says. "It didn't matter to us who we put in the goal, who started the first quarter or ended the game because we thought they were equals. Just months before the Olympics, Sree really just stepped up a bit." Pathak might not have a medal to show but the experience of being at two Olympics, Van de Pol adds, will be 'immense'; 'just like how Sreejesh benefited from being at London' as the back-up to then captain Bharat Chetri. "Yes, it is another four years, but there are so many big tournaments before that that he can attend. So, he will only grow because I know for sure that if he gets more playing time now, he will only be better and better." As the second choice after Pathak, India have the option of picking 28-year old Suraj Karkera, who has made 43 international appearances, and Mohit, a promising 19-year old who's been a part of the senior set-up but has yet to make his debut. Pawan, sparingly used in the last cycle, is also knocking on the door.

"When Sreejesh had some time off during his injury, or when Pathak got married, had kids, then it was mostly Suraj or Pawan who stepped in and they did amazing," Van de Pol says. "They are also both completely different goalkeepers. Suraj is more like Pathak; more relaxed, more on the line. Pawan is like Sreejesh, a lot of energy, always talking. Mohit, from the under-21s, is more like Pathak and Suraj." As India look at life after Sreejesh, it'll be up to these players to ensure the team does not sorely miss the goalkeeping stalwart. And as the leader of this pack, and based on the succession plan laid out, they'll turn to Pathak, who will hope to move from the corner of

Samoan Darius Visser breaks Yuvraj SIngh's record, sets new T20I record

a new world record has been set for the maximum number of runs in a single over in T20 international cricket. Samoa middle-order batter Darius Visser smashed 39 runs against Vanuatu in the T20 World Cup East Asia-Pacific Region Qualifier in the capital city of Apia. Visser got hold of pacer Nalin Nipiko who also stepped over the popping crease thrice in the over. Playing his third T20I the 28-year-old made a blistering 132 off just 62 balls.

Visser is the first Samoan batter to score a hundred in this format, and his knock guided the side to a competitive 174 all out. The next highest score in Samoa innings was 16 by captain Caleb Jasmat. In reply, Vanuatu gave a strong chase but ended up at 164 for nine, losing the match by 10 runs. Opener Nipiko nearly amended his waywardness with the ball with a 73 off 52 balls with six fours and three sixes. He had good support from skipper Joshua Rasu (23 off 14 balls) and Tim Cutler (21 off 11 balls) but Vanuatu fell short. Previously, there were five occasions when a bowler conceded 36 runs in an over and they were Stuart Broad (2007), Akila Dananjaya (2021), Karim Jannat (2024), Kamran Khan (2024) and Azmatullah Omarzai (2024). Yuvrai Singh smacked Broad



for six sixes. West Indies hard-hitting batter Kieron Pollard too got hold of Sri Lankan offie Dananjaya during a T20I game. On the other two occasions although the batters did not hit six sixes the bowlers still managed to concede 36 runs courtesy of their lack of discipline and slipping in extras. Warner seals deal with Sydney Thunder; Smith to play for Sixers

Svdney: David Warner is set to be a full-time presence in the Big Bash League (BBL) for the first time in his career after signing a new two-year contract with Sydney Thunder while Steven Smith would continue to grace the competition beyond his Test career, with a new threeyear deal with Sydney Sixers.

Warner's availability for the entire season marks a significant boost for Thunder. After recently ending his international career, the explosive opener is now free to focus solely on the BBL. Warner, who had only featured in eight games for Thunder over the past two seasons due to international commitments, will now bring his nearly 20 years of T20 experience to bear across the entire tournament, including the finals.

"Davey is popular wherever he plays, right around the world, particularly in India, and I know the South Asian communities in Sydney's west will get right behind him at Thunder," said Thunder general manager Trent Copeland in a statement released on Tuesday

"In Davey we get a world-class talent, and now that

he has retired from international cricket, we can count on his full focus and commitment for the entire tournament." Smith, meanwhile, has secured his future with the Sixers through a three-year contract. While Smith is currently one of Australia's Test openers, the deal gives him the option to play a full BBL season if he decides to retire from international cricket within the next three years. Smith, however, remains noncommittal about his Test future, stating, "I don't have any plans. I'm just enjoying playing at the moment, I'm pretty relaxed and looking forward to this summer." Smith, who was part of the Sixers team that won the inaugural BBL in 2012, made a memorable return two summers ago with back-to-back centuries in a five-game stint. His presence in the upcoming season, even if only for a few games, is expected to add a significant edge to the Sixers' campaign. In addition to Warner and Smith, other Australian Test stars like Marnus Labuschagne and Alex Carey have re-signed with their respective BBL teams. Labuschagne will return to Brisbane Heat, the reigning champions after Australia's tour of India concludes in early January.

athletes, taking sports 'a little easier': What long jumper Sreeshankar Murali did on missing Olympics due to injury



Long jumper Sreeshankar Murali, who had to withdraw from the Olympics due to a knee injury, still kept a close eye on the action unfolding at Paris. As an expert commentator on India's official broadcasters for the Games, the Commonwealth and Asian Games silver medallist found another perspective on the track and field events."I thoroughly enjoyed my stint as a commentator and got to learn about different sports. Although I had great fun while doing commentary for the long jump finals, I can't deny I was feeling a little bad that I wasn't on the field. The way my practice was going this season, I had a very strong chance of finishing on the podium,"

The knee injury also gave Sreeshankar time to reassess his goals and take sports "a little easier". Earlier, he was fully consumed in training, workouts and competitions, turning a blind eye on life beyond sports. This injury-induced break helped him realise that the approach could lead to burnout.It also gave him an opportunity to produce an interview series ahead of the Games where he managed to get Neeraj Chopra, Hamish Kerr (Paris high jump gold medallist) and friend Miltiadis Tentoglou (long jump gold medallist)."I made this video series for the Indian audience. I wanted to get these international champions to tell us how they train. Our Indian athletes believe that training as hard as you can is the best approach. But you will see these international athletes talking about how they train just five days a week and not more than three hours a day. It's something our young athletes can watch and learn from," he says. The injury came just months before the Olympics during a light training session at Sreesankar's hometown of Palakkad, Kerala, shattering him emotionally. What made things worse for the athlete was the fact his family had come to the stadium to watch him train. No one fathomed that Sreeshankar, who was in excellent form until then, would leave the stadium with a ruptured tendon and a broken

"It wasn't even a full motion jump but the moment I landed, I heard a pop. I immediately knew what it meant. I had to be lifted off the ground. The next few days I just spent weeping. When doctors took a look at my scans, they said such injuries only happen in car crashes. I still don't know how it happened," Sreeshankar says. The athlete knew he did not have much time and needed surgery at the earliest to address the "career-threatening injury". After consulting with Dr Sameul Pullinger, head of sports science at JSW's Inspire Institute of Sports (IIS), Sreeshankar boarded a flight to Doha to get his knee operated on at Aspetar Hospital, known for treating top football stars like Lionel Messi and Neymar.

Post surgery in late April, Sreeshankar decided to fly down directly to Bellary to begin his rehab program instead of heading home. "His rehabilitation isn't a oneman job. A huge team is involved. The medical department is always in contact, alongside the nutrition department that assists him with any additional supplementation needs for his injury," says Pullinger. Sreeshankar was in constant touch with his family, giving them daily updates during this period but didn't really understand the toll the injury took on them, especially his dad, until he visited home. "More than the physical strain, it was an emotional toll on my family. After returning home two months after my surgery in Doha and initial rehab, I noticed nothing had changed. All the stuff at home hadn't moved an inch. The resistance band I was using on the day of injury was still wrapped around the railing, Sreeshankar says."I didn't have time to sit in despair for too long. My family was quite upset, and I needed to reassure them. My father was deeply involved in every step of my journey. It was hard for him initially, but the support he received from various quarters was very helpful," he says.During that phase, Sreeshankar received calls from top athletes on the circuit, including Chopra, but it was one special call from an athlete friend in Delhi that turned the tide for him. Asian and Commonwealth Games medallist Tejaswin Shankar's short, but effective, pep talk was enough to lift Sree's spirits."Tejaswin was actually surprised that I picked the call. He said, 'Brother, if there is anyone who can make a comeback from here, it's you'. The belief he had in me renewed my faith," says Sreeshankar. He has no qualms in admitting that he needed professional help to take care of his mental health. Sessions with sports psychologist Maithili Bhuptani, who is part of the national camp, helped the youngster and his father immensely."Dad was 100 times more involved than I was. He was soaking in the entire process with training, recovery, rest, planning. It was so hard for him initially. A lot of athletes, friends spoke to him, as did my sports psychologist," recalls Sreeshankar. Sreeshankar has already been cleared to do light running and weight training, though the jump sessions have to wait for now. The Kerala athlete is eyeing a return to competition by June next year. "I will return to action in a domestic meet and then travel to Europe to get some good 7.90m jumps that will help me earn ranking points for the Tokyo World Championships," he says.

Could Vinesh Phogat's Day 1 results have been retained? Breakdown of key findings from CAS' full verdict

Indian wrestler Vinesh Phogat's disqualification from the women's 50kg event at Paris 2024 Olympics after being 100 grams over the weight limit on the day of the gold medal match after being eligible to compete on day one, is 'draconian' but still cannot be disputed under existent rules, the Court of Arbitration for Sport stated in the detailed report that it published on Monday. "The consequences of the failed second weigh-in, which do not arise from any illegal or wrongful act on the part of the Applicant are, in the opinion of the Sole Arbitrator, draconian," one of the points in the CAS report said. "A consequence of elimination without ranking from the round for which the Athlete was found ineligible, having been eligible for the rounds for which she competed, would seem to be a fairer solution." Could Vinesh Phogat's Day 1 results have been retained? Here's a breakdown of key findings from CAS' full verdict:The Applicant (Vinesh Phogat) fought three difficult competitions on August 6 and needed to eat and drink for her health. Short time between bouts. due to the distance between the venue and the Athletes' Village, which left Vinesh Phogat with little time for losing weight before the second weigh-in. The IOA produced a medical certificate dated August 8, 2024 that Vinesh Phogat was in her pre-menstrual phase and cited medical literature on body weight changes during menstruation. "The biological difference in the bodies of male and female wrestlers, particularly in light of the menstruation of women, needs to be taken into account whilst determining the eligibility of female wrestlers on the second day of the weigh-in," the IOA submitted.

CAS: There is no evidence in this case of the consequences of differences in the bodies of male and female athletes with regard to weigh-in and weight categories. The weight categories generally and the 50 kg weight category for Vinesh Phogat as a woman wrestler are not challenged. The effects of any such differences, and of steps to mitigate such effects, are speculative and unsupported by evidence and cannot be considered for the purposes of this application.

The IOA brought up that the weighing machine when empty showed a measurement of 50 grams, being half of the athlete's excess weight.CAS: The fact remains that the Applicant was above the 50 kg limit at the second weigh-in. There is no evidence to support the contention that, somehow, the scales were faulty. Vinesh Phogat submitted that there was insufficient training of, and explanation to, athletes from diverse backgrounds and levels of understanding



of the procedures.CAS: However, it is apparent from Vinesh Phogat's evidence that she did understand the need to weigh-in at under 50 kg and that she made efforts to do so, both before presenting for the second weighin and on the occasion of the second weigh-in during the 15 minutes available to her to repeat the standing on the scales. The IOA argued that Article 8 does allow a 2 kg tolerance, as such tolerance is allowed for International Tournaments. Article 8 provides in part: "2 kg weigh tolerance is allowed for World Cup, UWW Ranking Series Tournaments and for the International Tournaments". The argument that was put forward was that this means that a 2 kg weight tolerance is allowed for the Olympic Games, as an International Tournament.CAS: The Sole Arbitrator concluded that... the preferred construction of "the International Tournaments" in Article 8 of the Rules, as used in that Article, does not include the Olympic Games and that the Athlete was not entitled to that tolerance on her second weigh-in. Vinesh Phogat mainly contested that she should not be deprived of the rights that had accrued prior to her failed second weigh-in, for which she had been eligible. This, she submits, applies to entitle her to a silver medal and all rankings and scores and points, as to which she had a "legitimate expectation".CAS: Much as the Sole Arbitrator sees the logic in a rule that limits the consequences to the round for which the wrestler is not eligible while maintaining the results of rounds for which shewas eligible, the Rules do not provide for such an outcome - to the contrary. The Rules use the words "eliminate" and, further, provide that the wrestler is ranked last, without rank. CAScase law is replete with the conclusion that it is not the prerogative of CAS Panels or Sole Arbitrators to rewrite federation rules. Vinesh Phogat did not seek orders that the Rules be overturned or otherwise declared unenforceable. Her challenge is to their implementation and application to her situation. Many of her submissions would be relevant to such a challenge of validity but that is not the relief that Vinesh Phogat seeks. The consequences of the failed second weigh-in, which do not arise from any illegal or wrongful act on the part of the applicant are, in the opinion of the Sole Arbitrator, draconian.
