TGSRTC to operate special buses from Hyderabad to Nagarjuna Sagar

Hyderabad: The Telangana State Road Transport Corporation (TGSRTC) will be operating special bus services from the city to Nagarjuna Sagar. In view of the rains in the State, the flood water has been heavily flowing into the dam for the past one week. Due to this the water in the reservoir reached its full level and there has been a gradual increase in the number of visitors, particularly from Hyderabad.RTC officials said special deluxe buses are being operated from MGBS to Nagarjuna Sagar. These special buses will leave at 5 am, 6.45 am, 7.15am, 7.30am, 8am, 9.45am, 10.45am, 2.30 pm, 5pm and 5.40pm from MGBS to Nagarjuna Sagar.

Property worth lakhs gutted in Hyderabad's Puranapul warehouse fire mishap

Hyderabad: Property worth a few lakhs of rupees was gutted down when fire broke out in a warehouse of a decoration material supplying company at Puranapul on Tuesday. No casualties were reported in the incident.

According to fire officials, the fire broke out in the Swastik Supplying Company located at Puranapul in the afternoon. Except for one worker, the remaining workers who stayed at the place had gone out for some work. When the fire broke out, a worker Shahed Alam, who is a native of Bihar was asleep and woke up on being alerted by local people.

Dera Sacha Sauda chief Gurmeet Ram Rahim Singh granted 21-day furlough

Dera Sacha Sauda chief and rape convict Gurmeet Ram Rahim Singh has been granted a 21-day furlough, official sources said on Tuesday.During his temporary release period, Singh will go to the Dera ashram in Barnawa in Uttar Pradesh's Baghpat, they further said.

The Sirsa-headquartered Dera sect chief was granted the temporary release days after the Punjab and Haryana High Court disposed of the Shiromani Gurdwara Parbandhak Committee's (SGPC) petition against Singh's temporary release. The high court on August 9 observed that a plea for temporary release by the Dera chief should be considered by the competent authority without any "arbitrariness or favouritism". In June, Singh moved the high court and sought directions to grant him a 21-day furlough.On February 29, the high court directed the Haryana government not to grant further parole to the Dera Sacha Sauda chief without its permission. He had been granted a 50-day parole on January 19. Singh is serving a 20-year sentence for raping two of his disciples and is lodged in the Sunaria jail in Haryana's Rohtak district. The Dera chief and three others were also convicted in 2019 for the murder of a journalist more than 16 years ago. In May, the high court acquitted Singh and four others in the 2002 murder of the sect's former manager Ranjit Singh, citing "tainted and sketchy" investigations in the matter. A special CBI court had sentenced them to life imprisonment in the nearly 20-year-old murder case. Singh had been held guilty of hatching a criminal conspiracy with his co-accused.

Telangana insists on Krishna water sharing on 50:50 ratio from 2024-25

Hyderabad: The State has requested the Krishna Waters Disputes Tribunal (KWDT -II) to issue orders for utilisation of waters available in the basin by both the Telugu States in the ratio of 50:50 with effect from the water year 2024-25 pending final decision.

Submitting its counter to the Statement of Case (SOC) filed by the Andhra Pradesh before the Tribunal, Telangana contended that formulation of an operational protocol for distribution of water can be thought of only after determination of the State-wise and project-wise shares. Hence the State-wise and project-wise shares of each State shall be determined first. Thereafter, an effective operational protocol can be developed either by an independent agency or otherwise only after completion of the mandatory finalisation of allocations. But ad-hoc water sharing arrangement in the ratio of 66:34 is meant only for one year. Until the Tribunal came out with its final verdict, the State has pressed for utilisation of the available waters in 50:50 ratio with immediate effect. Pursuant to its request, Telangana, by its letter dated May 13, 2023 wanted a meeting of the Apex Council to be convened to resolve the issue. The government of India, in response vide letter dated October 20, 2023, stated that this issue relating to water sharing is pending with the Tribunal. The State also wanted the water available due to diversion of the Godavari waters to Krishna to be permitted to be exclusively utilised by Telangana as this water has to be utilised in the in-basin projects upstream of Nagarjuna Sagar as per the agreement between the riparian States signed on August 4, 1978. As per the ad hoc arrangement, Telangana has been receiving 299 TMC as against 512 TMC by Andhra Pradesh. The KWDT-II is actively involved in resolving disputes between the two States. As per the statements of both States presented before the tribunal, Telangana has staked claim for 954.9 TMC and Andhra Pradesh had sought 1144 TMC. The water release is regulated by a committee consisting of Chief Engineers from both States and a Member-Secretary from the Krishna River Management Board (KRMB).

In the State Budget for 2024-25, Rs.1,525 crores were allocated for Regional Ring Road, which will connect Hyderabad to other parts of the state. RRR will be constructed with the standards of the expressway. It was announced in the Budget speech that RRR will be initially constructed as a four-lane highway and will be extended to 8 lines commensurate with the increase in traffic. The region between ORR and RRR will attract industries, services and transport parks. As per initial estimates, the northern part of RRR will cost Rs 13,522 crores and the southern part will cost Rs 12,980 crores.

Calcutta HC orders CBI probe into Kolkata doctor's rape & murder

Kolkata: The Calcutta High Court on Tuesday ordered a CBI probe into the alleged rape and murder of a woman junior doctor at the state-run R.G. Kar Medical College & Hospital in Kolkata last week. Hearing a clutch of petitions in the matter, a division bench of the high court comprising Chief Justice T.S. Sivagnanam and Justice Hiranmay Bhattacharya ordered a court-monitored probe by the Central Bureau of Investigation (CBI), as demanded by the victim's family members. The bench also directed the Special Investigation Team (SIT) of the Kolkata Police, which is currently probing the matter, to immediately handover all the relevant documents, CCTV footage, and evidence to the CBI officials. Examining the case diary submitted by the police, the division bench observed that the progress of the investigation has not been satisfactory. On Monday, Chief Minister Mamata Banerjee had said that the state administration will hand over the probe to the CBI if the SIT is unable to conclude the investigation by Sunday. However, on Tuesday, the counsels for the petitioners argued that that time-frame might have a negative impact on the investigation since there were chances of tampering with the evidence during the interim period.

The bench accepted the arguments and observed that during the last few days after the body of the victim was found in the seminar hall of the R.G. Kar MCH, there had not been any significant progress in the probe. The bench was also in agreement with the arguments that



further loss of time would leave chances for tampering with the evidence. The court also questioned the communication goof-up on the part of the hospital authorities, including keeping the victim's parents waiting for information even after her bruised body was found on the morning of August 9. The counsel for one of the petitioners, Bikas Ranjan Bhattacharya, pointed out that after the body was found, the victim's family members received a phone call from the hospital at around 10.30 a.m. informing that she was 'sick'. However, 15 minutes later, the victim's parents were told that their daughter committed suicide. The family members were also made to sit for three hours during which they were not allowed to see the body. There are also complaints that the police advised the family members to somehow 'settle' the matter," he argued.

KTR slams Congress's 'double standards' on Adani, questions Telangana investment

His remark came shortly after the Congress announced a nationwide protest on August 22 over the Hindenburg report alleging Sebi-Adani nexus.Bharat Rashtra Samithi (BRS) leader KT Rama Rao on Tuesday lashed out at the Congress, accused the party of showing "double standards" on the Adani issue. KTR drew comparison between the Congress's attitude towards the Adani Group nationally and the Congress government's attitude towards it in Telangana.

His remark came shortly after the Congress announced a nationwide protest on August 22 over the Hindenburg report alleging Sebi-Adani nexus. "Glad that the Congress had called for a nationwide protest in light of the Hindenburg Report on Adani-Sebi nexus on Aug 22, but we at BRS see through their double standards," KTR said. He went on to ask, "If Adani is wrong for India, why and how is he right for Telangana?" Notably, Adani Group had inked four agreements with Telangana government in January this year to invest over Rs 12,400 crore across multiple sectors.

KTR questioned if Rahul Gandhi would demand Telangana Chief Minister and Congress leader Revanth Reddy to roll back Adani Group's investment in the state. "Or is it just about convenience and not about con-

viction?" KTR said, taking a swipe at Congress.He added, "BRS stands firm for Telangana's future—does Congress?"Hindenburg Research on August 10 alleged that Sebi Chairperson Madhabi Puri Buch and her husband Dhaval Buch had stakes in obscure offshore funds used in the alleged Adani money siphoning scandal.The allegations triggered a political slugfest, with the Congress and other INDIA bloc parties demanding her removal and a Joint Parliamentary Committee (JPC) probe into the matter. The BJP, on the other hand, accused the Opposition of being a part of a conspiracy to create financial instability and chaos in India.

Ex-DMK functionary's brother arrested by ED in money laundering case

The Enforcement Directorate on Monday arrested Mohammed Saleem, the brother of expelled DMK functionary Jaffer Sadiq, in connection with the investigation into a money laundering case. He was remanded to judicial custody by a local court. Saleem has been detained under the provisions of the Prevention of Money Laundering Act (PMLA), 2002, for his involvement in laundering proceeds linked to the Jaffer Sadiq case. The action follows an investigation by the Narcotics Control Bureau. It exposed Jaffer Sadiq Abdul Rehman, a former DMK functionary, as the mastermind behind a sophisticated scheme to smuggle pseudoephedrine to Australia, New Zealand, and Malaysia, camouflaged as health-mix powder and desiccated coconut. The case also stands on previous seizures by customs authorities, including pseudoephedrine by Chennai Customs in 2015 and ketamine by Mumbai Customs in 2018.

Adivasi-Dalit groups call hartal in Kerala on Aug 21 over SC reservation verdict

Various Adivasi-Dalit organisations on Tuesday called for a state-wide hartal in Kerala on August 21, to protest the recent Supreme Court verdict on the subcategorisation of reservations for Scheduled Castes and Scheduled Tribes as granted under the Constitution.In a joint statement signed by leaders of various Adivasi-Dalit organisations, it was alleged that the verdict aimed to divide the SC/ST list on a caste basis and introduce a 'creamy layer' within SC/ST categories.

They said the hartal will exempt Wayanad district due to the recent natural disasters. The outfits announced that the state-wide hartal is part of the Bharat Bandh called by Bhim Army and various Dalit-Bahujan movements. The primary demand is for Parliament to pass legislation overturning the Supreme Court verdict, according to the statement. Despite the BJP government's assurance that it will not implement the creamy layer, the central government has yet to acknowledge that the creamy layer division is the basis for categorising the list, they alleged.

Earlier this month, a seven-judge Bench of the Supreme Court led by Chief Justice D Y Chandrachud ruled in a 6:1 majority judgment that state governments were permitted to sub-classify communities within the SC list based on empirical data. Supreme Court judge Justice B R Gavai had said that States must evolve a policy for identifying the creamy layer even among the Scheduled Castes (SC) and Schedule Tribes (ST) and deny them the benefit of reservation. Justice Gavai penned a separate but concurring judgment in which the top court by a majority verdict said the states are empowered to make sub-classifications of Scheduled Castes and Scheduled Tribes for granting quotas within the reserved category to uplift those who belong to the more underprivileged castes.

Countries like Turkey which have historically grappled with the role of religious symbols in secular institutions, might find the Inlian approach instructive. This ruling emphasises that ducational institutions should focus on empowering tudents rather than on imposing restrictive dress codes. By navigating the fine line between tradition and molernity, the SC has taken a significant step towards ensuring that educational institutions remain inclusive, espectful and progressive spaces for all students.

Police confirm homicide and sexual assault, say open to another agency conducting probe

The Kolkata Police Commissioner Saturday confirmed that a junior doctor who was found dead at the state-run R G Kar Medical College and Hospital was raped and murdered. "This is an unfortunate incident. Yesterday, at 10:30 am, the Tala police station was informed that a lady was found lying in the seminar hall of the hospital," said CP Vineet Kumar Goyal.

"We are extremely sad, anguished and angered because of the incident. We are with the family members and the doctors. Whatever needs to be done from our end, we are following a transparent process of investigation. If there is a demand from the family for some other agency to conduct the investigation, we have no problem. By analysing CCTV evidence, proof from the place of occurrence, and a thorough interrogation of doctors and other witnesses, we have concluded that there is strong evidence as far as the accused is concerned," he said.Police have arrested one Sanjoy Roy in connection with the crime.The police chief said an SIT has been formed, and CCTV footage has been collected from the vicinity of the crime scene.

"On the basis of the evidence, one person has been arrested. The probe is still on. He will be produced in court today," said the CP. The police chief said that once information was received, the homicide department rushed to the spot. The forensic team was also called in, and for the inquest, the services of a judicial magistrate were requested. "In the presence of the judicial magistrate, the parents and the medical college students, an inquest was done," he said. "After the inquest, the postmortem examination was done. A board was formed with three doctors, out of which two were women. The whole procedure was documented through videography. Students and family members were present as witnesses during the post-mortem proceedings," he said. Asked about the background of the accused, he said, "For us, he is a criminal of the highest order. We will see to it that he gets punishment of the highest order. We are collecting more evidence and examining more people. We will let you know once we get anything. We are interrogating him and trying to find the reason for him being present there at such a time," he said. This is not the conclusion of the investigation; it is at a preliminary stage. We are examining more people. Not even 24 hours have passed. We have cross-checked and it is confirmed that he was there," said the CP.Additional Commissioner of Police Murli Dhar said also said there were signs of sexual assault. "This is a sensitive case. As per Supreme Court guidelines, we cannot divulge each and every detail of the investigation before the media. This is a case of homicide as well as sexual assault," he said.

Rescue teams bank on lessons from August 2023 Shiv Bawari tragedy amid ops following July 31 Himachal cloudbursts

Joint teams from agencies, including the National Disaster Response Force, State Disaster Response Force, Civil Defence, and defence personnel are engaged in the rescue operation to locate over 55 people who went missing after five cloudbursts hit Himachal Pradesh in July. These teams are drawing on their past experiences, particularly those learnt in the aftermath of last year's August 13 Shiv Bawari Temple tragedy at Summer Hill in Shimla.

As many as 28 people went missing in the incident. Although the bodies of all 28 victims were eventually recovered — some recognizable and many beyond recognition — it took at least nine days of search and rescue efforts to spot them. Thirteen of the 28 bodies were found at a distance of around 6 to 9 kilometre from the Shiv Bawari Temple, which was buried under a major landslide. Sanjeev Gandhi, Shimla Superintendent of Police (SP), who supervised last year's search and rescue operation, on Saturday said, "On August 1, when the rescue teams reached the worst-affected village of Samej, we concluded that the victims might have been swept

away more than 20 k from where they had been residing."He added, "We divided the entire stretch of the Samej Khad rivulet, from the village of Samej to the confluence where it meets the Sutlej River, into six points. Two bodies were found between the village of Samej and the confluence point, but we had to extend the search area up to 85 km, reaching as far as the Sunni Dam on the Sutlej River. We have been following the same procedure we used last year to recover the missing victims of the Shiv Bawari Temple tragedy." Another aspect of the search and rescue operation is identifying the victims. Although DNA profiling of the victims' kin was considered during the Shiv Bawari tragedy, it wasn't needed as the victims were identified through their belongings. Gandhi said, "This year, when 34 people went missing from Samej in Shimla. We decided to collect DNA samples from the kin of the missing people on the second day of the rescue operation. A mutilated body of a woman has been identified through DNA profiling. DNA samples were collected by a team of forensic and medical experts. Our search and rescue operation is based on five aspects: rescue, food and shelter, restoration and rehabilitation of displaced families, search and retrieval of the living and the dead, and identification and handling of post-mortem investigations."The five cloudbursts, including three in Kullu and one each in Mandi and Shimla, occurred on the night of July 31. The village of Samei in Shimla witnessed the most casualties, followed by the districts of Mandi and Kullu. Over 55 people, including 34 in Shimla alone, are missing. The bodies of 28 victims have been recovered so far, 15 of which were found by rescue teams in Shimla. Meanwhile, Commandant of the 14th Battalion of NDRF, Baljinder Singh, visited all the areas affected by the cloudbursts in Himachal Pradesh. The NDRF personnel from the 14th Battalion have been deployed in

The last major agitation by doctors in Bengal that started from NRS Medical College: a recap

Kolkata doctor killed protestThe earlier agitation was triggered by an attack on two doctors at Kolkata's NRS Medical College and Hospital by the neighbours and relatives of a patient who died during treatment on June 10, 2019. The recent agitation by doctors in West Bengal bears similarity with the week-long protests that rocked medical colleges in the state in 2019.

The ongoing protest started after the semi-naked body of a woman postgraduate trainee (PGT) doctor was discovered inside the seminar hall of the government-run R G Kar Medical College and Hospital on Friday. The deceased was on duty the previous night, and her body was found the next day. The earlier agitation was triggered by an attack on two doctors at Kolkata's NRS Medical College and Hospital by the neighbours and relatives of a patient who died during treatment on June 10, 2019. The subsequent strike called by doctors affected most health services, including OPDs, in state-run hospitals.

Expressing their inability to contain the crisis, the then-principal of the NRS Medical College and Hospital, Saibal Kumar Mukherjee, and the medical superintendent-cum-vice-principal, Saurabh Chattopadhyay, resigned from their posts.On June 13, agitating doctors



defied Chief Minister Mamata Banerjee's ultimatum to join work by 2 pm, and declared that the agitation would continue till their demands related to security matters in government hospitals were met. A team of doctors also met former West Bengal governor Keshari Nath Tripathi in Raj Bhavan and said the chief minister's reaction to their protest was unexpected. However, the doctors withdrew their protest after meeting CM Banerjee at Nabanna a couple of days later. Banerjee also announced steps to scale up security in hospitals.

Himachal changes parameters of judging performances of bureaucrats, HPPSC officers

In a significant development, Chief Minister Sukhvinder Singh Sukhu decided to change the parameters to access Annual Performance Appraisal Report (APAR) of Indian Administrative Service (IAS) officers posted in Himachal Pradesh and the officers of Himachal Pradesh Public Service Commission (HPPSC) officers from Saturday.

The traditional descriptive categories such as 'Outstanding', 'Very Good', 'Good,' and 'Average' would be replaced with a numerical grading scale and officers would be assessed based on three key indicators: the accomplishment of their annual work plan, other work-related attributes and personal and functional attributes.

Interestingly, the reforms also introduce negative marking, with officers potentially losing two points from their overall grade, on a scale of 1-10, for non-compliance of government orders or advisories.CM Sukhu said, "From now on, all officers, including administrative secretaries and deputy commissioners posted in districts, would be evaluated solely on their performance for their APARs". Under the new system, performance appraisals would be directly linked to the work outputs of all officers. The reforms aim to enhance accountability and transparency by linking officer evaluations directly to their work outputs, he added. Sukhu highlighted transparency as a key feature of the system noting that officers would receive their finalised evaluations which would foster professional development and encourage improvement in their work performances. The APAR process would now be entirely online, streamlining operations and enforcing a December 31 deadline for submissions. He said that these changes were designed to ensure a fair and objective evaluation process, particularly for field-level officers, whose performance would be closely tied to meeting quantitative targets. He said that the higher management officers would continue to be assessed on qualitative aspects and personal attributes. According to CM Sukhu, these reforms were a crucial step toward strengthening governance and further enhance the accountability within the state administration. Recently, CM Sukhu government decided that government officers applying for study leaves will be entitled of their 40 per cent salary, instead of 100

The Sardar Sarovar dam in Gujarat's Narmada district recorded a water level of 133.02 metres on Saturday, a rise of six metres in the last two days. Following the development, officials of the Sardar Sarovar Narmada Nigam Limited (SSNNL) said they would decide on opening the radial gates of the dam for a safe filling up to the Full Reservoir Level (FRL) of 138.68 metres, once the water level crosses the 134-metre mark.At 133.02 metres on Saturday afternoon, the Sardar Sarovar dam was 80 per cent full with a gross storage of 7,525 Million Cubic Metre (MCM), of which 3,825 MCM is the live storage of the dam. SSNNL officials said the inflow from the Indira Sagar and Omkareshwar dams in Madhya Pradesh was recorded at 4.8 lakh cusecs while the discharge from the Narmada dam was 55,760 cusecs after the generation of power.

A marked rise has been recorded since August 1, when the water level at the Sardar Sarovar dam stood at 122.17 metres. Officials added that to maintain a "cushion level" for any unforeseen inflow of water, the Riverbed Power House and the Canal Head Powerhouse (RBPH) will continue to generate power and release about 44,000 cusecs of water - the amount of water released after a full cycle of operating six Francis-type reversible turbine generators of the RBPH with a capacity of 200 MW each. "Since the average inflow during the day is currently high, we are continuing to release the water directly downstream through the operation of the RBPH. Beyond 134 metres, we will have to maintain a cushion level to allow the dam to rise up to the FRL in a balanced way and there is a possibility of opening a few radial gates once the dam crosses the level of 134 metres," an official added.

DRI Hyderabad seizes Rs.60 lakhs worth Ephedrine

Hyderabad: The Directorate of Revenue Intelligence (DRI) Hyderabad unit caught two persons who were attempting to send ephedrine drug valued at Rs. 60 lakh to New Zealand on Friday.

According to the officials, the two persons had come to the city carrying the white powder in two packets. "Upon thorough examination of the said package, two vacuum sealed transparent packets were recovered. A white substance in powder form was recovered from both the packets and, when tested with field test kit, indicated positive for Ephedrine/Pseudoephedrine," said the DRI officials,

The packets containing 3 kg Ephedrine/Pseudoephedrine valued at Rs.60 lakhs (illicit market value) have been seized and two Individuals have been arrested under the provisions of the NDPS Act,1985, the officials

Ephedrine and Pseudoephedrine are classified as controlled substances under the Narcotic Drugs and Psychotropic Substances (NDPS) Act. These chemicals serve as precursors for the illicit manufacture of amphetamine and methamphetamine, collectively referred to as Amphetamine-Type Stimulants (ATS).

'Despicable, loss personal'—As pressure mounts over doctor's death, CM Mamata Banerjee promises action

Chief Minister Mamata Banerjee Saturday called the death of a 31-year-old junior doctor whose body was found in a Kolkata Hospital "despicable", saying that the loss "felt personal". She also said the doctors protesting over the incident were "free to approach any other agency if they had no faith" in the state government. Speaking to a television channel Saturday, Banerjee said she had extended her "full support" to the doctors who have been holding protests over the incident. The woman doctor's body was discovered inside the seminar hall of the government-run R G Kar Medical College & Hospital Friday. She had been on duty the previous night. One person has been arrested in the case.

The remarks come at a time when the pressure mounts on Banerjee's Trinamool Congress state government to take immediate action that Opposition claims is one of rape and murder in the case. "Their anger and demand are justified. I support it. Police have also accepted their demands," she said.Banerjee said she was

at Jhargam when the body was discovered. "However, I was keeping track of all the developments. I spoke to the family of the victim and assured them of proper action. I have directed for the case to be taken to a fast-track court. If needed, the accused will be hanged, even though I am not pro-capital punishment. But they should be given the strictest punishment," she said. Banerjee added that those who were protesting were "free to approach any other law enforcement agency" if they had no faith in the state administration. She was referring to the demands of getting a central agency to investigate the doctor's death. The CM also said there would be a probe to find out if there was any negligence on the part of the hospital.

"We want proper and thorough investigation and stringent punishment for the culprits. Just as we have a responsibility, the hospital's superintendent too has a responsibility. We will also probe if there was negligence on any part. Meanwhile, one accused has already been arrested. We have ensured that not a single doctor who is protesting faces any kind of problem," she said. At the same time, she also appealed to the doctor to resume their jobs. "The doctors can keep protesting, but at the same time, they should also treat the patients... The person arrested in the case used to work there. There should be proper vigilance," she said, adding that she would order the principal secretary and the police commissioner "if needed".Banerjee's remarks come at a time when pressure is mounting on her establishment for action, with principal opposition BJP calling it a case of rape and murder. While Kolkata Police's Special Investigation Team (SIT) investigates the case, the hospital has set up its own 11-member internal inquiry committee.

Show-cause notices issued to 2 former Vadodara municipal commissioners in Harni boat tragedy case: Gujarat Govt informs HC

The state government on Friday informed the Gujarat High Court bench hearing the Harni boat capsize case that it issued show-cause notices to two former municipal commissioners of Vadodara - Vinod Rao and H S Patel - who had a role in awarding a contract to Kotia Projects to redevelop and manage Harni lake. Fourteen people including 12 students of the New Sunrise School died after a boat capsized in Harni lake on January 18.Patel was the commissioner when bids for the redevelopment of the lake were submitted. While Rao was the commissioner when the Kotia Projects' bid was evaluated and forwarded to the standing committee and the general body for approval.

Advocate General Kamal Trivedi informed the division bench of Chief Justice Sunita Agarwal and Justice Pranav Trivedi that show-cause notices were issued on July 19, following the July 9 order of the Gujarat HC directing the state government that "disciplinary action" initiated by the government based on a fact-finding report "shall be brought to its logical conclusion by adopting due procedure of law, and the result of the same shall be brought before the Court".

Trivedi also informed the Court that Rao had approached the Supreme Court, challenging the July 9 order of the Gujarat HC. The advocates appearing for the families of the Harni boat tragedy victims also informed the Court that notices issued to Kotia Projects and the New Sunrise School on July 12, seeking them to be re-



spondents in the case for "exemplary compensation" for the victims, have gone 'unserved' as no entity was present at the registered addresses to accept the notices.

The Court directed that fresh notices be issued to both parties and asked the Vadodara district collector to ensure that the notices were served. The fact-finding committee had recorded in its inquiry report that the entire process of granting the contract to Kotia Projects in the second attempt after the company failed to qualify in the first attempt "is what is generally followed at Vadodara Municipal Corporation as also similar to what is followed in other urban local bodies and, therefore, no fault can be found in the process."The Court expressed its dissatisfaction with the committee's effort "to mellow down the affairs of the Corporation".

Indian Railways begins survey for less steep Mumbai-Pune route that will reduce travel time

Central Railway is in the middle of a survey to work out a lower-gradient alternate rail route to the present Pune-Mumbai connectivity through the steep Bhor Ghat. The Railway Board has approved a project that will reduce travel time by 20-30 minutes, but it will be longer in length than the present alignment and won't require additional engine strength to manoeuvre trains, officials with Central Railway said. "The survey commenced about five months ago. It's an elaborate survey to decide alternate routes that will make the ghat section alignment less steep. The present between alignment Mumbai and Pune in the ghat section is very steep with a gradient of 1.37. The aim of the project is to bring down the gradient to 1.100, said Swapnil Neela, chief public relations officer, Central Railway.

Neela said that the reduced gradient will reduce the need for a banker locomotive while manoeuvring trains through the ghats' steep slopes. "Passenger coach trains may not require the banker locomotives due to the reduced slope. They might be used for goods trains," said Neela. He said that the survey will throw up available options and then decisions will be made about the most feasible route alignments. "It may be slightly longer than the present route but

The engineering team had to face many unprecedented challenges while working in Bhor Ghat and had to come up with ingenious local so-

lutions - one of them was

Designed to help trains navigate the steep gradient, the section consisted of zigzag or switchback tracks where the train would move forward in one direction, then reverse onto another track, and continue in the opposite direction. Meet the Tunnel Man of India who transformed barren Karnataka hill into bountiful farms

Speaking of tunnels in Bengluru's context can possibly be 'disastrous' as pointed out by some, but for Dakshina Kannada's Amai Mahalinga Naik, 79, tunnels have been a tipping point of agricultural success and a story of great perseverance. Naik, a farmer from the small village of Adyanadka, has transformed a once-barren hilltop into a lush, thriving oasis. Known as the 'Tunnel Man of Karnataka', Naik is credited for transforming an arid sloping hill into a fertile farm through the innovative zero-energy micro-irrigation system. Naik's early life was far from easy. Born in 1945 in a remote village in Dakshina Kannada, Naik grew up without the privilege of formal education. Naik said that he usually spent his early years working as an agricultural labourer. He would pluck areca nuts and coconuts in and around his village, eking out a meager living through sheer hard work and determination. Despite the hardships, Naik's sincerity and work ethic did not go unnoticed. In 1978, Amai Mahabala Bhat, a local landlord, recognised Naik's dedication and gifted him two acres of barren land perched atop a hill. The land, though barren and desolate, represented an opportunity-an opportunity that Naik was determined to

The land Naik received came with one significant challenge: the absence of nearby water sources. For a farmer, water is life, and without it, the land was virtually useless. But Naik, undeterred by the odds, set out on a mission to find water where none seemed to exist. The idea of digging tunnels to access groundwater was not new in the region. In fact, there was an age-old tradition in the area of digging horizontal tunnels into hillocks, known locally as Surangas to tap into underground water sources. However, the process was labour-intensive, risky, and often yielded little success. Nevertheless, Naik took up the challenge with unwavering resolve.

Six attempts and a breakthroughNaik's early attempts at digging tunnels were met with disappointment. He dug five Surangas, each extending at least 35 meters into the hillside, only to find that they were dry. With each tunnel, he learned more about the land and its hidden secrets. Finally, in his sixth attempt, Naik struck water. The tunnel, which extended 315 feet into the hill, tapped into a reliable source of groundwater. This moment was

a turning point for Naik and his farm. The water from the tunnel was channeled through a zero-energy micro-irrigation system that Naik had ingeniously developed, allowing him to cultivate the land and transform it into a green oasis."When faced with barren land and a lack of resources, many would have given up. But I saw it as an opportunity to prove that with determination, even the harshest environment can be transformed," said Naik.But Naik's work didn't stop there. After securing a consistent water supply for his crops, he dug yet another tunnel, this time to provide water for drinking and household use. His relentless pursuit of water, combined with his innovative irrigation system, earned the moniker 'The Tunnel Man of Karnataka'.

With water now flowing through his land, Naik set about transforming the barren hilltop into a thriving agricultural haven. He single-handedly constructed around 300 percolation trenches in the surrounding hills, ensuring that rainwater was captured and stored to recharge the groundwater table. He also built two stone revetments and a 12,000-litre capacity tank to manage and distribute the water effectively. Today, his farm is a lush landscape of areca nut palms, coconut trees, cashew trees, banana saplings, and pepper vines. The once-desolate plot of land has become a model for sustainable farming, attracting over 1,000 visitors each year, including farmers, environmentalists, and tourists from around the world. "People often ask me how I managed to dig tunnels through solid rock without any formal training. My answer is simple: nature is both our greatest challenge and our greatest ally. It tests us, but it also rewards those who respect it and work in harmony with it. My tunnels were not just about finding water - they were about understanding the land and listening to what it needed," said Naik.Step farming and honey bee farming

One of the major highlights of Naik's farm is the adoption of 'step farming' that incorporates a series of steps on the slopes known as terraces or steps. This helps in conserving soil and water and additionally reduces the dependency on electricity for irrigation of crops. "One of the major advantages of step farming is that it increases the surface area of sunlight needed for the crops. Moreover, irrigation can be carried out without the help of electricity. It also reduces soil erosion and sedimentation," said Naik. Further, if you are in Naik's farm you cannot escape the buzzing of the bees. His farm is home to 10 honey bee boxes, which are integral to the pollination process. They carry the pollen from one plant to the other aiding in the pollination process contributing for a good yield in his farm."I believe in living a minimalistic and simple lifestyle. My wife and I consume what we grow and we depend very little on the outside market for our daily essentials. I strongly believe in passing on this organic and sustainable farming practices to the upcoming generations and encourage more youngsters to take up sustainable farming models to make the world a better



Maldives opposition party backs President Muizzu's recalibration of India policy

The Maldivian Democratic Party has welcomed President Mohammad Muizzu-led government's "sudden recalibration" of its India policy and said Male has always been confident that India will always be the first responder any time the Maldives "dials an international 911". Abdulla Shahid, the president of the main opposition, the Maldivian Democratic Party (MDP), made remarks after he met External Affairs Minister S Jaishankar on Satur-

The MDP president said that his party "calls on the Muizzu government to issue a public apology for the actions, lies and irresponsible comments from its officials which have resulted in significant damage to the Maldives' foreign and economic outlook." Jaishankar is on a threeday official visit to the Maldives to reset the bilateral relationship, the first high-level trip from India after the archipelago nation's pro-China President Muizzu assumed office last year. "Great pleasure to warmly welcome and meet Indian External Affairs Minister @DrSJaishankar to the Maldives with my colleagues from @MDPSecretariat," Shahid, the former foreign minister, said in a statement posted on 'X' late Saturday night.

"The Maldives has always been confident that India will always be the first responder any time the Maldives "dials an international 911"," he said. He said the "current government's initial stoking of anti-India sentiments through aggressive slogans, mockery and the branding of a time-tested friend and development partner as a regional bully, has caused a decline in the Maldives international standing, economic loss, and many other unnecessary difficulties, and challenges.""With this in mind, the MDP welcomes the sudden recalibration of the Maldives-India policy of President Muizzu's government, from its previous India Out policy," Shahid said.India's relationship with the Maldives has come under severe strain since Muizzu took charge as the President late last

Within hours of his oath, he had demanded the withdrawal of Indian military personnel manning three aviation platforms gifted by India to the Maldives. After talks between the two countries, the Indian military personnel were replaced by civilians. On Saturday, President Muizzu described India as "one of the closest allies" and reaffirmed his administration's full commitment to strengthening the historic and close connections between the two countries."The MDP hopes that this shift will not be temporary or superficial, but consistent and meaningful in the best interests of the people of the Maldives," Shahid said. In a separate statement, the MDP welcomed Jaishankar's visit to the Maldives. "The Maldives-India relationship has always been based on the principles of mutual respect, respect for international law, territorial integrity, a common desire for regional security, and an open and peaceful Indian Ocean, it said.

The MDP thanked India for its steadfast support of the people of the Maldives

Karnataka seer claims government diverting welfare funds meant for SCs, STs

Valmiki seer Prasannananda Puri has alleged that the Karnataka government was diverting the welfare funds meant for the Scheduled Castes (SCs) and Scheduled Tribes (STs) and using them to fulfill the schemes of the five quarantee schemes."We won't hinder your welfare schemes. We won't oppose your government's stand. The country's development is people's development. The poor, SCs, STs and Other Backward Classes (OBCs) must prosper," the seer said in Chitradurga.

"To uplift them, you made promises in your manifesto and implemented it. We don't oppose that. We oppose the funds reserved in the budget for SCs and STs being misused," he added. The five guarantee schemes, a major poll plank of Congress during campaigning for last year's assembly polls, are: Shakti (free bus rides for women), Anna Bhagya (additional five kilos of rice to ration card members), Gruha Lakshmi (monthly allowance for women heads of family), Gruha Jyothi (free power to households) and Yuva Nidhi (a monthly unemployment dole of Rs 3,000 for graduates and Rs 1,500 for diploma

Meanwhile, the Siddaramaiah-led Congress government is accused of diverting over Rs 14,000 crore funds from the SCs and STs welfare plans for "other purposes". The National Commission for Scheduled Castes (NCSC) issued a notice to the Karnataka government over allegations that it was diverting funds from the



SCs and STs for fulfil its five guarantee schemes. The notice came after a media report claimed the diversion of Scheduled Caste Sub Plan (SCSP) and Tribal Sub Plan (TSP) funds in the state. In its notice to the Chief Secretary, the NCSC highlighted that the state government has decided to reallocate Rs 14,730 crore, originally earmarked under SCSP and TSP, to implement various welfare schemes known as the "five guarantee schemes".

Reacting to the NCSC notice, Karnataka Deputy Chief Minister DK Shivakumar said that everything was being done as per the law and there was nothing wrong with it."We have made a law in the state that a particular amount of money will be spent on a particular community. There is nothing wrong with it. Earlier, Andhra Pradesh had brought a similar law," he said.

Uddhav's convoy targeted in Thane after attack on MNS chief Raj Thackeray

A day after Maharashtra Navnirman Sena (MNS) chief Raj Thackeray's convoy was attacked by Shiv Sena (UBT) workers with betel nuts in Beed district, MNS supporters retaliated by pelting Uddhav Thackeray's convoy with dung, tomatoes, coconuts, and bangles in Thane on Saturday evening. The incident occurred as Uddhav's convoy was en route to the Gadkari Rangayatan Hall, where he was scheduled to address party workers. MNS supporters raised party flags and chanted slogans against Uddhav, leading to a commotion that required intervention from the Thane police, which detained several MNS workers, including women.MNS leaders defended the protest, describing it as a spontaneous reaction to the earlier attack on Raj's convoy during his Marathwada tour, which was related to Maratha reservation.

Following the attack on his convoy, Raj Thackeray had warned of retaliation if such incidents continued. "The protesters were office-bearers of the Shiv Sena (UBT) and the NCP SP, and they had nothing to do with Maratha reservation. They are using the issue for their political benefit. I urge them not to fuel tensions between communities... Do not cross my path in the future, or you will not be able to hold any election rallies in the state. I cannot

predict what my supporters will do if they start retaliating," he told reporters on Saturday. The attack on Uddhav's convoy in Thane, a stronghold of Chief Minister Eknath Shinde, came shortly after Raj's statement. Shinde commented on the incident, stating, "The protest by MNS workers was a response to the actions of the Shiv Sena (UBT). Whenever there is an action, a reaction follows."

Adani terms Hindenburg allegations malicious, manipulative of selective public info

New Delhi: The Adani Group on Sunday termed US short-seller Hindenburg Research's latest allegations as malicious and manipulative of select public information, saying it has no commercial relationship with the Sebi Chairperson or her husband. "The latest allegations by Hindenburg are malicious, mischievous and manipulative selections of publicly available information to arrive at pre-determined conclusions for personal profiteering with wanton disregard for facts and the law. We completely reject these allegations against the Adani Group which are a recycling of discredited claims that have been thoroughly investigated, proven to be baseless and already dismissed by the Hon'ble Supreme Court in January 2024," the group said in a filing.

Hindenburg on Saturday stated that Sebi head Madhabi Puri Buch and her husband invested in offshore entities that were allegedly part of a fund structure managed by India Infoline and in which Vinod Adani, Gautam Adani's brother, also had investments.

As a new era dawns over Cantonments, a look at one of the first ones in Ambala

The Raj-era cantonments spread across the country are preparing to don a new look with excision of civilian areas from them. It is time to look back in history on how the 'modern' cantonments came into being in the middle of 19th century in India. And it all began right here in this region called Ambala.In May 1843 a young Captain in the Bengal Engineers was busy laying down the first bricks of what would come to be known as the Umballa (later Ambala) Cantonment. Rushed from Darjeeling to Karnal to scout location for a new cantonment, Capt Robert Napier, later rose to the rank of Field Marshal and was Commander-in-Chief of the Indian Army

The fact that Karnal in Haryana was also a cantonment once upon a time has largely been forgotten. An important outpost of the then British empire in Punjab, Karnal and Sirhind Cantonments ceased to exist in the mid-1800s and their military establishments moved to Ambala. The primary reason for Karnal to be abandoned was the spread of disease which caused large number of deaths among the British rank and file.

It is for this reason that Robert Napier laid out an extensive and extravagant design, by the standards of his time, of Ambala cantonment which stands testimony even today to the designers idea of open spaces to ensure that a repeat of Karnal does not take place. Napier was convinced that one cause of disease at Karnal had been the want of adequate ventilation. The massive old bungalows built in several acres of land, the bazars and havelis criss cross Ambala cantonment and the titles to these properties are embroiled in a maize ot litigation which has been going on for decades. At the heart of the legal battles is the ownership of the land which rests with the Army and the residents have the properties on lease which continues from the times of the British. Interestingly, it was Robert Napier who also designed the cantonment of Kasauli along with another one in nearby Subathu. The details of Napier's endeavours are mentioned in his biography 'Field Marshal Lord Napier of Magdala, a Memoir' written by his son Lt Col HD Napier. What makes Ambala cantonment and its bungalows special is the fact that this was the first place where the British adopted the vast expansive style of building bungalows and barracks. The success achieved here in reducing fatalities due to illness made them replicate the style in other cantonments across India. The size of plots of the bungalows varies from 1.2 acres to 2.6 acres.

The vast acreage of these bungalows is what makes them a very lucrative possession today even though the residents have no ownership rights over the land and only the superstructure built on the land is legally accepted as theirs to dispose. "Convinced that one cause of disease at Karnal had been the want of adequate ventilation, Napier conceived the bold and novel idea of laying out the lines in echelon, so as to secure the maximum of air to all the buildings. The result proved so satisfactory that the government subsequently adopted this system in other cantonments," the memoirs mention.

The memoirs further say, "...the wide roads and spacious gardens and the lofty barracks of 'Umballa' constituted the beginning of a new epoch in the structure of Indian Cantonments . . . the shady avenues of that station were all planted by Napier . . . while the Napier barrack for the British soldier was cited in those days as a patent example of the innate extravagance of the Engineer. It is now (1890) recognised to be in reality of a most economical kind."Ambala-based Eva Prasher has done extensive research on the bungalows of Ambala. The study titled 'Bungalows and their Typology in the Colonial Town: Ambala Cantonment' explores the history of these bungalows and their design

Prasher says Ambala cantonment was originally designed with two major grid layouts, one housing all the basic requirements of a garrison and the other as the civic area, which was occupied by thirty-six odd families of diferent professions as a support system. "The bungalows of Ambala Cantonment were constructed in and after the year 1843 and by this time; the bungalows had flourished as a typology. Thus, these bungalows bear the basic elements of what had developed as a style for this particular part of the country. Typically, the bungalows are placed in the middle of the plot with gardens on all sides. This feature grants the bungalow its gigantism and authoritative ambience. Besides this, the gardens or the open green spaces on all sides help tackle the harsh summers in the composite climate of Ambala. Unlike the indigenous houses, the shophouses, the bungalows did not have the central courtyard to bring down the temperature of the rooms and keep the air circulating. It was rather the green space around that brought in the fresh and cool air to the interior spaces," says Prasher in her study. As is usual in all Cantonments, Ambala also has an imposing church and a very old graveyard. The foundations of St Paul's church were laid around 1852 and it was consecrated in 1857. The imposing structure of the church still survives to this even though it was partially destroyed in bombing in 1965 Indo-Pak war. As with the man who laid the foundations of Ambala cantonment, Capt Robert Napier, the church too was designed by an officer of the Bengal Engineers, Capt George Atkinson.Interestingly, apart from designing Army buildings in Ambala, Atkinson also devoted time to writing books on Indian cooking. Some of his writings include 'Curry and Rice on forty plates-the ingredients of social life at our station in India' and 'Indian spices for English Tables, or, A rare relish of fun from the Far East'. Today, Ambala cantonment has come a long way from being just a tract of land lying between the rivers "Ghuggar (now Ghaggar) and Sursuti (Saraswati), about 4 miles south of the town of Umballa," as mentioned in Napier's memoirs. A cantonment which awaits new beginnings after 180

Our life, finances an open book: Sebi chief, husband deny Hindenburg allegations

New Delhi: Capital markets regulator Sebi Chairperson Madhabi Puri Buch and her husband on Saturday denied allegations levelled against them by shortseller Hindenburg as baseless and asserted that their finances are an open book. In a statement, Madhabi Puri Buch and Dhaval Buch also said it is unfortunate that Hindenburg Research, against whom Sebi has taken an Enforcement action and issued a show cause notice, has chosen to attempt character assassination in response to the same.

US short-seller Hindenburg Research alleged that Sebi Chairperson Madhabi Puri Buch and her husband had stakes in obscure offshore funds used in the Adani money siphoning scandal. In a blogpost, Hindenburg said 18 months since its damning report on Adani, "SEBI has

shown a surprising lack of interest in Adani's alleged

undisclosed web of Mauritius and offshore shell entities."Citing "whistleblower documents", it said, "Madhabi Buch, the current chairperson of SEBI, and her husband had stakes in both obscure offshore funds used in the Adani money siphoning scandal."Responding to the allegation, Buchs said in their statement, "In the context of allegations made in the Hindenburg Report dated August 10,2024, against us, we would like to state that we strongly deny the baseless allegations and insinuations made in the report. The same are devoid of any truth. Our life and finances are an open book. All disclosures as required have already been furnished to SEBI over the years." Buchs further said they have no hesitation in disclosing any and all financial documents, including those that relate to the period when we were strictly private citizens,

UK 'dine and dash' couple flaunts Rs 12,000 meal on Facebook, ditches bill



A British couple has been accused of leaving a restaurant without paying a £120 bill (approximately Rs 12,000) after enjoying a lavish meal and posting photos of it on Facebook.A British couple is accused of dining and dashing at a local restaurant, racking up a £120 tab (approximately Rs 12,000) before fleeing and posting photos of their meal on Facebook, the Mirror reported.

The pair allegedly enjoyed gourmet burgers, halloumi fries, and cocktails at the Lazy Fox restaurant in Westbourne on August 5, before stepping outside on the

pretext of a cigarette break and disappearing. Restaurant co-owner Mauricio Spinola said, "It was probably about 10 minutes after they went outside we realised they had gone." Spinola said the incident was a financial blow to the small business and that police have been notified.

"It's a big hit for a small business like ours, we just can't afford to lose over £100 in the current climate. We can't ask people to give us their phone or wallet when they go out for a cigarette. The vast majority of our customers are great and would think that is weird," said Spinola. A waitress who served the couple described them as energetic and noted that the woman was intoxicated. She said, "He was with a blonde woman who had heavy red lipstick and wore a white top under a white dress... We were keeping a close eye on them especially when it came to serving them drinks."Co-owner Enoely Fernandez criticised the couple for brazenly boasting about their free meal on Facebook, calling their actions "silly."Since the incident, other local eateries have come forward claiming similar experiences with the pair. The couple is also suspected of a dine-and-dash incident at the Urban Garden restaurant in Bournemouth, where they allegedly ordered £170 worth of food and drink.

Drone attack in Syria leads to injuries among US, coalition troops: Report

Several US and coalition personnel were wounded in a drone attack on Friday in Syria, a US official told Reuters, in the second major attack in recent days against US forces amid soaring tensions in the Middle East. The US military initially assessed no casualties in the drone attack, but a more in-depth review found that some personnel had minor injuries including smoke inhalation and moved some to a different location. The official, speaking on the condition of anonymity on Saturday, said none of the injuries were serious but some personnel were also being examined for traumatic brain injuries. Several troops were moved to a different location for further evaluation, the official added. No group has claimed responsibility for the attack, the official said, but similar attacks in the past have been carried out by Iran-backed groups.

The injuries from the drone attack followed a rocket strike by suspected Iran-backed militia on Monday that wounded five US personnel at Ain al-Asad airbase in western Iraq on Monday. News of the latest injuries came as the Middle East region braces for a possible new wave of attacks by Iran and its allies. Ismail Haniyeh, the political leader of Iran-backed Hamas, was killed in the Iranian capital Tehran on July 31, an attack that drew threats of revenge by Iran against Israel, which is fighting the Palestinian Islamist group in Gaza. Iran blamed Israel for the killing. Israel has not claimed responsibility. The assassination and the killing of the senior military com-



mander of the Iran-backed Lebanese group Hezbollah, Fuad Shukr, by Israel in a strike on Beirut, have fueled concern the conflict in Gaza was turning into a wider Middle East war.Iran has said the US bears responsibility in the assassination of Haniyeh because of its support for Israel.US Defense Secretary Lloyd Austin has said the United States would not tolerate attacks on US personnel but Washington was also trying to de-escalate tensions in the region.Friday's attack took place at Rumalyn Landing Zone, which hosts US troops along with those from the US led coalition.The US has 900 troops in Syria and 2,500 in neighbouring Iraq, who it says are on a mission to advise and assist local forces trying to prevent a resurgence of Islamic State, which in 2014 seized large swaths of both countries but was later pushed

Bangladeshis vow to protect 'Bengali identity' amid attack on Hindus

As Bangladesh tries to limp back to normalcy following weeks of deadly protests that saw the ouster of Sheikh Hasina as Prime Minister, locals in Dhaka disapproved of the attacks and looting of houses belonging to Hindus and temples. They claimed those involved in such attacks did not belong to their community.

Speaking to India Today TV, the locals said Jamaate-Islami, an Islamic party, wants to establish Islamic rule in Bangladesh and stated that the Bengali identity will not be allowed to be tarnished."Whatever happened in the past few days was not good. Those who attacked Hindus and temples were not our people. The Jamaat wants Islamic rule, but the identity of Bengali-speaking Bangladesh will not change," a local said. "We believe in Islam and we want it to be kept in the forefront. But here, Hindus and Muslims are brothers and everyone will live together," the local said. Another local said he was disappointed with the way Sheikh Hasina handled the students' protests that began over a controversial job quota system but later became an anti-government movement. "Sheikh Hasina did the wrong thing. She should have engaged more with the students. She is also from this country. Dialogue, not repression, was needed," he said. Amid student protests, violence erupted on August 5 after Sheikh Hasina resigned and fled to



neighbouring India, where she is currently staying. During the violence, houses and businesses belonging to Hindus and temples were vandalised, looted and set ablaze. On Thursday, Prime Minister Narendra Modi asked Nobel Peace Prize winner Muhammad Yunus, who took charge as the chief adviser of the interim government, to ensure the safety and protection of Hindus and all other minority communities in the crisis-hit country. On Saturday, thousands of Hindus staged protests in Dhaka and Chattogram, demanding protection and justice after a series of attacks on their temples, homes, and businesses. Yunus condemned the attacks on minorities, labelling them as "heinous", and reiterated that restoring law and order remains the top priority.

US officials urge sanctions on Bangladesh regime officials over brutal crackdown

Some lawmakers in the US Congress have urged sanctions on Bangladeshi officials under Sheikh Hasina who recently quit as prime minister and fled, while the US government has formally welcomed the appointment of a new caretaker government there. An interim government, led by Nobel Peace laureate Muhammad Yunus, was sworn in on Thursday with the aim of holding elections in the Asian nation. Bangladesh was engulfed by demonstrations and violence after student protests last month against quotas that reserved a high portion of government jobs for certain groups. The demonstrations escalated into a campaign to oust Hasina, who won a fourth straight term in January in an election which the opposition boycotted and which the US State Department said was not free and fair.

Hasina's exit came after at least 300 people, many of them students, were killed in a crackdown on demonstrations."The Bangladeshi leaders who orchestrated this brutal crackdown must be held accountable, which is why we're calling upon the administration to sanction General Secretary Quader and Home Affairs Minister Khan, as we continue working to support a peaceful and democratic Bangladesh," said US Senator Van Hollen, a Democratic member of the Senate Foreign Relations Committee.

The lawmaker referred to Asaduzzaman Khan Kamal, who was Hasina's home minister, and Obaidul Quader, who was the general secretary of Hasina's Awami



League party. A letter by Hollen and five other congressional Democrats was sent to US Secretary of State Antony Blinken and Treasury Secretary Janet Yellen, urging sanctions on those officials. The State Department said it did not preview sanction-related actions."I welcome the swearing in of Dr. Muhammad Yunus to lead the interim government in Bangladesh. The United States supports his call for calm and peace," Blinken said separately on social media. Human rights groups had accused Hasina of using excessive force against protesters, a charge she denied. Since her departure, the student protests have widened to demand the exit of more officials appointed from her time in office. Hasina went to New Delhi after leaving Bangladesh, ending her uninterrupted rule of 15 years in the nation of 170 million people. Hasina's fall triggered both jubilation and violence.

Top officials forced out of office, Hindus protest attacks

Bangladesh continues to grapple with widespread unrest as student protests force key officials to resign and minority communities, including Hindus, demand protection in the face of targeted violence. Members of the Bangladeshi Hindu community hold banners and chant slogans against violence targeting the country's minorities during a protest in Dhaka. Bangladesh remains in a state of turmoil as student-led protests forced key officials to resign, including the country's Chief Justice and central bank governor. The unrest has also sparked massive demonstrations by the minority Hindu community, who have become targets in the ongoing violence.

On Saturday, thousands of Hindus staged protests in Dhaka and Chattogram, demanding protection and justice after a series of attacks on their temples, homes, and businesses. Interim leader Muhammad Yunus condemned the attacks on minorities, labelling them as "heinous", and reiterated that restoring law and order remains the top priority. Here are the top developments in the Bangladesh crisis: The law and order situation in Bangladesh remains precarious, with several Hindu temples, households, and businesses vandalised and at least two Hindu leaders killed since Sheikh Hasina resigned as Prime Minister and fled to India.


Members of the Hindu community, facing attacks, have taken to the streets demanding the creation of special tribunals to expedite trials of those who persecute minorities. They also sought the allocation of 10 per cent of parliamentary seats for minorities and the enactment of a minority protection law. Muhammad Yunus, Chief Advisor to the newly formed caretaker government, condemned the attacks on minority communities and urged the youth to protect them. "You have been able to save the country; can't you save some families?... They are my brothers; we fought together, and we will stay together," he stated.

The political crisis has forced several top officials out of office. Chief Justice Obaidul Hassan, appointed last year and seen as a Hasina loyalist, was compelled to resign on Saturday after students surrounded the Supreme Court in Dhaka and threatened "dire conse-Bangladesh Bank governor Abdur Rouf Talukder also resigned amid the upheaval, although his resignation has not yet been accepted. ASM Maksud Kamal, Vice-Chancellor of Dhaka University, where the student protests initially burgeoned, stepped down from his post, reported Reuters. In response to the crackdown that left at least 300 people dead, US lawmakers have called for sanctions against key figures in Hasina's government. Senator Chris Van Hollen and five other congressional Democrats have urged the Biden administration to impose sanctions on former Home Minister Asaduzzaman Khan Kamal and Awami League General Secretary Obaidul Quader. Home Affairs Advisor Brig Gen (retd) M Sakhawat Hossain expressed optimism that law and order would be restored within the next three to four days. "Some initiatives have already been taken, but the police have not yet been able to fully mobilise," he said. The ongoing unrest has seen many police officers targeted and killed by vengeful mobs. "It is completely illegal. If any officers are found to have acted improperly, it will be tried through investigations," Hossain said.

Ukraine military ops in Russia's Kursk region is 'to restore justice': Zelenskyy

President Volodymyr Zelenskyy acknowledged for the first time on Saturday that Ukrainian forces were fighting in Russia's Kursk region and said the operation was part of Kyiv's drive to restore justice after Russia's 2022 invasion. Russia said Ukrainian forces pushed into Kursk region last Tuesday and Russian military bloggers have acknowledged they made some headway, while saying the situation had since stabilised.

Zelenskyy had previously stayed silent about the operation. In his nightly video address, the president said he had discussed the operation with top Ukrainian commander Oleksandr Syrskyi, while not forgetting the battles troops face on the difficult eastern front. "Today, I received several reports from commander-in-chief Syrskyi regarding the front lines and our actions to push the war onto the aggressor's territory," he said. "I am grateful to every unit of the defence forces for ensuring that. Ukraine is proving that it can indeed restore justice and ensure the necessary pressure on the aggressor. "Zelenskyy had previously alluded to the operation, praising the military's ability "to surprise" and thanking them for taking Russian



soldiers prisoner to be used in future negotiations, specifically referring to the past week. In paying tribute to Ukrainian forces along the 1,000-kilometre front line, Zelenskyy made special mention of actions in northern Sumy region, across the border from Russia's Kursk region. Russia has stepped up its attacks of guided bombs and other aerial strikes in Sumy, prompting mass evacu-

US veteran pawns jewellery for sick wife's care, gets surprise from TikToker

A Tiktok user raised \$320,000 for a 90-year-old air force veteran in the US who was selling off his jewellery to take care of his wife suffering from dementia. Finance Minister to banks: Innovate, focus on small deposits to plug gap with credit growth



Finance Minister Nirmala Sitharaman, credit growth, small deposits, low deposit growth rate, Reserve Bank of India, RBI Governor Shaktikanta Das, RBI Central Board of Directors, structural liquidity management issue, Indian expressFM Nirmala Sitharaman addressed RBI Central Board in the presence of Governor Shaktikanta Banks need to take the old-fashioned route to bring back focus on mobilising "small deposits" and not just big deposits in order to reverse the flagging deposit growth rate, Finance Minister Nirmala Sitharaman said Saturday.

Reserve Bank of India (RBI) Governor Shaktikanta Das echoed the same, stating that it is an "advance cautioning to the banks" so that the trend of low deposit growth rate does not go unattended and result in "structural liquidity management issue". Sitharaman, after addressing the Central Board of Directors of the RBI at the customary post-Budget meet, said the bread and butter of banks lies in mobilisation of small deposits, and huge bank deposits have always been a lazy banker's job. "It's right that credit is going through digital format and collection of deposits is not. Huge big deposits have always been a very lazy banker's job but the trickles which come are going to be the bread and butter money to lend regularly. So that trickle (small deposit mobilisation) was the emphasis a long, long time ago...the requisite small deposits, that's also one of the very critical jobs of the bank. It might be grinding monotony but that's where your bread and butter lies." she said

The Finance Minister further said that at present, even those families who have small savings, they also have got new options to invest even if via stock markets and banks have to compete with those options to attract deposits. "More portfolios are available for more returns

on money, that's why retail investment in markets has gone up. When they have so many options, banks also have to make use of innovative portfolios for attracting investment and deposit mobilisation," she said. Sitharaman said she would be meeting banks to discuss the priority sector lending areas, some government schemes, as well as the importance for them to revert to deposits collection in the old fashioned way. She is likely to hold a meeting with heads of public sector banks on August 19.RBI Governor Das said rates, both on credit and deposit sides, are deregulated and it can be "very retrograde and distortive going back on economic reforms". Das said there is always some mismatch between deposit and credit growth but it's a proactive caution to banks to arrest the slide in deposits. "Two questions arise: what is the gap in the growth rate between deposits and loans. Second thing is how persistent it is and how long it is going on. In our case, we have been witnessing a 300-400 basis points gap between deposits and credit growth, deposits are lower, it has been observed in the last few months...going forward this may create structural issues with regard to liquidity management. As it stands today, we don't see a crisis or anything but it has to be attended to and dealt with by the individual banks. If it goes on like this unattended, it can lead to a potential structural liquidity management issue. So it's an advance cautioning to the banks," he said. On Thursday during the monetary policy review address, Das had expressed worries over banks and non-banking finance companies (NBFCs) not following regulatory norms while offering top-up loans on other collateralised loans such as home and gold loans and the need for lenders to garner deposits amid concerns over a shift in household savings from banks to

Garment sector facing uncertainty, normalcy may return soon: Sitharaman'

The Indian garment and knitted fabric sector is seeing a "bit of uncertainty" amid the ongoing political developments in the neighbouring country of Bangladesh, Finance Minister Nirmala Sitharaman said on Saturday. "I have held discussions on our textile garment investments in Bangladesh, many of which are from Tamil Nadu. The investments went there in good faith and they did well having gone there; exports from Bangladesh had also increased. The garment and knitted fabric sector is currently seeing a bit of uncertainty," she said at the media briefing held after the Central Board of Directors of the Reserve Bank of India (RBI).

She expressed hope that the interim government there will settle things "sooner rather than later", adding that efforts are being taken to ensure that borders with the neighbouring country are safe.

She said the textile industry particularly from Tamil Nadu has made investments there in good faith. "The exports from Bangladesh also increased because of the duty and quota liberal approach that we have towards low-income countries. They (Indian garment industry based in Bangladesh) could even export to India."The garment and knitted fabric sector is seeing a bit of uncertainty because of the political upheaval in the neighbouring country. "I hope that the investments are all safe... it's too early for me to see what kind of an impact this situation in Bangladesh will have on our economy. I hope that the interim government will settle things sooner rather than later so that both the people of Bangladesh



and India can get back to normalcy," she said.

Earlier this week, political turmoil happened in Bangladesh when Sheikh Hasina resigned as the Prime Minister and fled the country. Soon after Parliament was dissolved leading to the creation of an interim government. Nobel laureate Muhammad Yunus took oath on Thursday as the head of the interim government. Readymade garments represent more than 85 per cent of Bangladesh's merchandise exports and over 70 per cent of its total exports. In trade terms, Bangladesh is India's biggest partner in the subcontinent, and India is Bangladesh's second biggest partner in Asia after China. Their total bilateral trade amounted to \$13 billion in the financial year 2023-24, according to the Commerce Ministry.

Sebi chief Madhabi Buch had stake in Adani offshore entities, hence didn't act: new Hindenburg report; She says 'baseless', 'our finances an open book'

IN WHAT RAISES questions of conflict of interest related to the market regulator, the US-based Hindenburg Research on Saturday alleged that "it suspects SEBI's unwillingness to take meaningful action against suspect offshore shareholders in the Adani Group may stem from SEBI Chairperson Madhabi Buch's complicity in using the exact same funds used by Vinod Adani, brother of Gautam Adani." Madhabi Puri Buch and her husband Dhaval Buch said in a statement that they strongly denied the "baseless allegations and insinuations made in the report". "The same are devoid of any truth. Our life and finances are an open book," they said in a joint statement.In an exchange filing, the Adani Group said: "The latest allegations by Hindenburg are malicious, mischievous and manipulative selections of publicly available information to arrive at pre-determined conclusions for personal profiteering with wanton disregard for facts and the law. We completely reject these allegations against the Adani Group which are a recycling of discredited claims that have been thoroughly investigated, proven to be baseless and already dismissed by the Hon'ble Supreme Court in January 2024."This report by Hindenburg Research comes almost 18 months after it

had first kicked up a political storm in January 2023, al-

leging the Adani Group of "brazen stock market manipulation" and "accounting fraud". The port-to-energy conglomerate had denied all these allegations; the Supreme Court had rejected the demand for a CBI or court-monitored probe. Continuing with the saga and quoting "whistleblower documents", Hindenburg Research has now claimed that the Sebi chairperson "had stake in obscure offshore entities used in the Adani money siphoning scandal." To date, SEBI has taken no action against other suspect Adani shareholders operated by India Infoline: EM Resurgent Fund and Emerging India Focus Funds, it alleged. While Congress said the Hindenburg revelations only reinforced its demand for setting up a joint parliamentary committee to investigate the full scope of the Adani mega scam", the Trinamool Congress said the Sebi chairperson must resign. "This raises fresh questions about Gautam Adani's two 2022 meetings in quick succession with Ms Buch shortly after she became SEBI chairperson. Recall that SEBI was supposedly investigating Adani transactions at the time," Congress's Jairam Ramesh said. "Sebi Chairman should be suspended in no time pending Supreme Court monitored investigation and look out notices to be issued to all airports and interpol from preventing her and the husband to leave

Curious kids: Why do I need to yawn when someone else yawns?

Yawning happens when you open your mouth, take a deep breath and take in air without even thinking about it. You might be tired, bored or waking up. Most people yawn six to 23 times a day – even animals yawn!You may have noticed that you often yawn after you see someone else yawn. This is called "contagious yawning".

Contagious yawning feels automatic, like a reflex you don't have to think about. But scientists know it's not completely automatic because we are not born knowing how to do it. In fact, contagious yawning only starts around ages four or five, which is when kids begin to develop better empathy. Empathy means understanding and sharing the feelings of others. So, without even thinking about it, seeing someone yawn can make you want to yawn, too.

How do scientists know this?

Scientists have noticed that people yawn more when the other person they see yawn is someone they know well – like a best friend or a parent.

This supports the idea that empathy plays a big role in contagious yawning. When you see a friend or family member yawn, your brain understands their feelings, and you might yawn, too. Contagious yawning can also help strengthen social connections and coordination within a group. In other words, it's one way our brains help us connect with others. In fact, some animals like dogs and chimpanzees also experience contagious yawning. When a chimpanzee sees another chimpanzee yawn, it often yawns, too. Like for us humans, this helps them build social connections with each other. Scientists found that both in humans and in animals like chimpanzees and bonobos, contagious yawning is more common among those who share a strong bond. This means you're more likely to catch a yawn from your best friend or family member than from a stranger.



As people get older, they become better at understanding others' feelings, and they yawn more when they see others yawn. However, this ability to catch yawns might decrease in very old age. This is seen in both humans and chimpanzees. Humans can have a contagious yawn from many different types of animals – not just their pets that they love and know well. This shows that yawning helps us connect and understand each other, whether it's with another person or an animal.

What happens in the brain when we catch yawns?

Your brain has special cells called mirror neurons. These neurons activate when you see someone do something, and they make you feel like doing the same thing – for example, yawning. It's like your brain is mirroring what the other person is doing. So, the next time you see someone yawn and feel the urge to yawn too, you'll know it's your brain's way of building a connection with your friends, family and even pets.

Just 8 minutes of TikTok 'thinspiration' content is enough to affect body image

Nearly half of Australian young people are dissatisfied with the way their body looks. Social media have only made body image issues worse for young people, leading them to compare themselves with others and strive for often unattainable – and unhealthy – beauty standards. TikTok, which allows people to create and consume short videos, has amassed more than 1 billion users. Harmful content, including videos that glamorise disordered eating and extremely thin bodies, circulate readily on the platform.

Given most TikTok users are young, we wanted to explore how such content affects young women's body image. Our new study found watching just eight minutes of TikTok content focused on dieting, weight loss and exercise had an immediate negative effect on body image satisfaction. Body image and beauty standardsWe recruited 273 female-identifying TikTok users aged 18 to 28 and randomly allocated them into two groups. People with a past or current eating disorder diagnosis were excluded from the study.

Participants in the experimental group were shown a 7–8 minute compilation of "pro-anorexia" and "fitspiration" content taken directly from TikTok. These video clips featured young women restricting their food intake and giving workout advice and dieting tips, such as describing their juice cleanses for weight loss.Participants in the control group watched a 7–8 minute compilation of TikTok videos featuring "neutral" content such as videos of nature, cooking and animals.

Using a series of questionnaires, we measured levels of body image satisfaction and attitudes towards beauty standards before and after participants watched the TikTok content.Both groups reported a decrease in body image satisfaction from before to after watching the videos. But those exposed to pro-anorexia content had the greatest decrease in body image satisfaction. They also experienced an increase in internalisation of beauty standards.Internalisation occurs when someone accepts and identifies with external beauty standards. Exposure to harmful social media content doesn't always result in harm — it's when this content is internalised that body image is likely to suffer.

Before the video experiment, we asked participants some general questions about their TikTok use. We also measured preoccupation with "healthy" eating and symptoms of disordered eating. We found participants who used TikTok for more than two hours a day reported more disordered eating behaviours than less frequent users. However, this difference was not statistically significant. This means the difference between groups did not meet the threshold required for us to conclude it was unlikely to be due to chance.

to chance.

On a scale used to rate eating disorder symptoms,

participants who reported high (2–3 hours a day) and extreme (more than 3 hours a day) rates of TikTok use averaged scores just below the cut-off for clinically significant eating disorder symptoms. This suggests more than two hours a day of exposure to TikTok content may be linked to disordered eating, but further research is needed to explore this.body everyday users can circulate dangerous diet-related videos without the backlash a celebrity or well-known influencer might receive for sharing socially irresponsible content.

The content we showed participants in the experimental group is widely circulated on TikTok, not just within "pro-ana" communities. "Clean" eating, detoxing and limited-ingredient diet trends are the wolf in lamb's clothing of disordered eating, allowing diet culture to be rebranded as "wellness" and "self-care". This content, alongside fitspiration, often rewards and gamifies excessive exercise and disordered eating. Social media wellness influencers play an important role in normalising disordered eating and fitspiration content. But hashtags like #GymTok and #FoodTok allow any TikTok user to create and consume content around theirs and others' daily eating routines, weight-loss transformations and workout routines. What's more, everyday users can circulate dangerous diet-related videos without the backlash a celebrity or well-known influencer might receive for sharing socially irresponsible content.

Our study only looked at short-term consequences of exposure to this sort of content on TikTok. Longitudinal research is needed to see if the negative effects we observed endure over time. It remains difficult to censorTikTok users have limited control over the content they're exposed to. Because they spend much of their time on a personalised "For You" page formulated by an algorithm, a user doesn't need to search for or follow disordered eating content to be exposed to it. In our study, 64 percent of participants reported seeing disordered eating content on their For You page.

Examples could include videos portraying binge eating, laxative use or excessive exercise. Paradoxically, searching for body positivity content may make users vulnerable to seeing disordered eating content. The most important thing TikTok users can do is to be aware that following or searching for any kind of content related to food, body or exercise may lead to inadvertent exposure to distorted body ideals. Limiting time on TikTok will limit exposure, but our findings show even less than ten minutes can have a negative effect. Ultimately, online safety for young people depends on appropriate social media regulation. Without this, upskilling young women on how to avoid harm on social media is a bit like giving them an inflatable life jacket, then leaving them to swim indefinitely against a rip.

Why was Prakash Padukone justified in his blunt assessment of Lakshya Sen's medal miss?

There are many ways to interpret Prakash Padukone's blunt assessment of the performance of Indian athletes, though his focus was on badminton returning with no medals. Mercifully, the one man who this was meant for, later stated he was "determined to reflect on what went wrong and where I need to improve." Lakshya Sen knew the bronze was there for the taking, and he couldn't nail it down. He is self-aware and not particularly foolish to not know it was an opportunity badly missed.

Shuttlers - the very old and the young elite alike really aren't too fond of theatrics and public meltdowns, be it when they split with coaches or when coaches honestly lay out the facts, post failures. You will not get a "you are still a winner" platitude from Padukone, Vimal Kumar or Pullela Gopichand, because their time and mindspace is heavily and obsessively invested in getting the shuttlers to win internationally, planning, plotting and scything through severely difficult playing fields. They neither mince words, nor sugarcoat what needs to be done to dust up from defeats and start the grind again. It's why India had three medals from three Olympics and 10 straight World Championship medals every single edition since 2011. Missing a medal in the 2024 Olympics, despite receiving the highest financial and coaching support, will sting at least till the next Olympic medal is secured. Satwik-Chirag and Lakshya Sen are bona-fide successes on the international circuit and will carry forward their ambitions, and the likes of Priyanshu Rajawat and Treesa Jolly-Gayatri Gopichand will need to step up, and deliver in the next Olympic cycle.But Padukone's disappointment and urgency in hauling up Sen, soon after his bronze playoff loss, needs to be understood in the context of a larger reality. The men's singles circuit is terribly competitive and will remain extremely tough to crack even in coming years. HS Prannoy was the only Indian singles male to win a Super 500 level title in the last two years, Sen was tending to myriad injuries and not in form for most part. His defensive game style is dazzlingly gritty, but so bruising and brutal on his body, that he cannot be expected to be a year-round workhorse aiming for every title. One nasty back / shoulder injury can set him back by years. His fitness just won't permit a round-the-year calendar. Sen will need to prioritise Olympics over mindless pursuit of Tour titles and points, just

like PV Sindhu did in her early years.

Having peaked for the Olympics, he did well to reach

semifinals. An opportunity to fight for bronze isn't a guarantee at Los Angeles in a sport like badminton, where 70 percent of the top names in both singles, were nursing niggles, and felled by fitness. Carolina Marin had recovered, and re-emerged, but still went out in tears to injury on the brink of the final. Tai Tzu Ying just couldn't move in her final effort. The male Chinese and Indonesians, in the 23 to 29 age bracket, were soundly thrashed. So when you earn the chance to gun for bronze and are at your fittest like Sen was, a set and 8-3 up too, but still flub the opportunity due to nerves, your straight-shooting coach isn't going to mollycoddle. With badminton and its bustling Top 15, you just cannot sit back, tell yourself you are still young, fit and raring, with time on hand, and project a hopeful medal four years from now. Coaches seethed in Paris, because they pretty much know 24×7, 365 days. 4 years, how excruciatingly tough medalling is. There's a reason they don't waste their time penning pretty inane inspirational scribbles on Twitter and instead honestly parse through what went wrong, instead of promising a medal next time. So for Satwik-Chirag and Sen, this was a sucker punch. Padukone is a legend who slogged without any support, in times when there was none on offer, to win his All England in 1980, before he got roundly criticised for chiding Lakshya, a player whom he had talent-scouted and singled out for perhaps the maximum funding made available to anyone who was in Paris, for

Sen's coach Vimal Kumar had stood on the court for high-intensity multi-feed shuttle sessions till age 60. One of the sharpest feeders, the ace coach had plotted gameplans for every Olympic and All England upset Sen has scored. And Pullela Gopichand got India the first two Olympic podiums, besides multiple World Championship medals, both with 6 am sessions, and analysing on the spot opponents barking out pinpoint instructions in competition crucibles that helped Nehwal, Sindhu, Srikanth, Sai Praneeth and Prannoy nail down wins. Even double Olympic champion Viktor Axelsen was brought down at the 2023 Worlds for Prannoy's medal with Gopichand plotting. You don't need to give him credit, but players will acknowledge his timely interventions that nick a point in sticky 17-17 kind of situations. And nail down careerdefining medals. He missed his own, hence knows how much it hurts when you can't win the podium knockouts. Badminton medals have always needed strong tactical backroom work. These coaches know what they're doing, and are also aware of the crucial difference between a medal and a non-medal. They live the disappointment with the player, unlike fans with their hot-takes, before moving onto the next topic to mutter. The same is true for players. Olympic medals matter to athletes. They are the stamps of recognition tattooed onto your identity, which nobody can take away from you. No amount of sentimental Twitter poetry of loyal legions can replace that medal on the mantelpieceThis explains Neeraj Chopra's disappointment at missing the gold and Padukone's out-burst after Sen's loss in the bronze-medal play off. Sen might see a lifetime of opportunities ahead of him in his young life, Padukone knows how fate can be fickle. The medal

India finish events with 6 medals after Reetika Hooda shows promise but exits 76 kg wrestling class

Aman Sehrawat would be the only Indian wrestler to pick up a medal from the Paris Olympics after women's 76 kg grappler Reetika Hooda failed to go past the quarterfinals of her category, finishing at the wrong end of a 1-1 bout against two-time World Championship medallist Aiperi Medet Kyzy of the Kyrgyz Republic Hooda's exit from the 76 kg competition meant that India's medal count at the Paris Olympics stood at 6, a number that could go up or stay the same depending upon the Court of Arbitration for Sport's (CAS) decision on Vinesh Phogat's appeal for a shared silver medal.At 21, Hooda came into her maiden Olympics as a wildcard of sorts. She had beaten Blades only last year for the U23 World Championship crown, but was unseeded at this Olympics - a dangerous proposition for many seeded wrestlers. Once the draw came out, it became clear that she would have to go through some of the best wrestlers in the 76 kg category to medal in Paris.

Over a minute into their bout, the Hungarian had the passivity timer struck against her. She immediately tried to earn a takedown by tripping Hooda first, but the Indian wrestler kept control of Nagy's left arm as they both went to the floor. Once her opponent's arm was out of the way, it was a quick scramble and two points were awarded in the Indian's favour, which soon became four when she rolled Nagy over. With nine seconds left in the first period, Nagy attempted a takedown of her own, grabbing Hooda's left leg and converting the position into two points right as the buzzer rang. It would be the last bit of offence she would be allowed in the entire match. Hooda is the first woman from India to make the heavyweight categories at the Olympics and comes from Sakshi Malik's stable at Sir Chhotu Ram Stadium in Rohtak. And even though she occupies the topmost weight category in the women's division, her insistence on remaining an offensive wrestler makes her a dangerous opponent in her weight category. At the Asian Olympic Qualifiers, the scores of her four bouts read 10-0, 11-0, 9-6 and 7-0. Relentless of-

The second period against Nagy showed that Hooda had the endurance to continue charging forward. Less than a minute in and she had control of her opponent's left hand again and pushed her sideways until Nagy lost control and found herself giving up another two points. The Hungarian, knowing her Olympic dreams were about to fizzle out, dropped to grab Hooda's legs and managed to lunge forward. But the Indian, once again, didn't give

an inch and converted what could have been a potential takedown against her into a counter, which earned her two points and then almost converted that position into a pin.Nagy managed to wriggle out of trouble, but not before giving up another two points. With the score at 10-2, and 45 seconds remaining in the bout, Hooda managed to land the final two points to win by technical superiority and move on to meet the Worlds silver medallist.

Against the Kyrgyz wrestler though, Hooda's constant pressure found its match. Kyzy started off on a better note, gathering Hooda's leg and almost converting the position into two points. But the Indian held on and defended the position well. From there, she closed all doors for the Kyrgyz and the referee soon started the passivity timer on the Asian Games gold medallist. The Indian went into the first period with a slender one-point lead. In the second period, Hooda had her chances to capitalise and possibly add some more points to the board. But her offence never really got going, like it had in her previous bout. Soon it was her turn to land an attack or lose a point and even with the timer against her, a takedown never materialised. A point apiece, the 21-yearold from Rohtak desperately needed to either push Kyzy out of the mat or land one of her attacking moves. Neither happened as the second period ended with the Kyrgyz wrestler controlling the Indian's head and holding off any chance of an attack. The score was 1-1 but Kyzy went through to the semi-finals on account of having scored the last technical point of the match. She then lost to Blades 8-6 to end Hooda's maiden Olympics.

China pip USA to go on top of Paris Olympics medal tally, India on 71st

Paris: China moved past USA to sit on top of the Paris Olympics medal tally, enter the concluding day of the Games on Sunday with 39 golds, 27 silver and 24 bronze medals. The USA, on the other hand, with 122 medals, including 38 gold, 42 silver, and as many bronze medals, are placed second. Australia are on third with a total of 50 medals, including 18 gold, 18 silver and 14 bronze. Japan, however, jumped to fourth with 18 gold, 12 silver, 13 bronze for a total of 43 medals.

Bling of Imane Khelif boxing Gold could soften the blows of bullying she faced

As Algeria's Imane Khelif began her quest for a dream Olympic gold, little did she know that during the course of that journey, her life would change. On Friday, in the background of a fortnight-long furore over who she is and what she represents, the shrillness of the polarised online outrage was replaced by the roars of the Algerian diaspora in France that made themselves known in a 15,000-strong crowd at Court Philippe Chatrier at Roland Garros, as Khelif stormed past China's Yang Liu to win the women's 66kg boxing gold.

Of course, it is not boxing that has fast-tracked Khelif into the limelight. An unorthodox conclusion to one of her bouts kicked off an unorthodox debate, which, at its core, put her womanhood on trial. In reality, there is little to suggest anything other than a mix of bad and good-faith actors, fighting for women's sport, health and inclusion, weighing in on a divisive isolated incident from a sport they might know little to a lot about, while repeating their agendas. (AP)For the uninitiated, Khelif, and Taiwan's Lin Yu Ting who will fight in the 57kg final on Saturday, were at the centre of a gender row. The duo had been disqualified by the International Boxing Association (IBA) from last year's World Championships in New Delhi for failing IBA-administered gender tests.

Opinions are iron-clad and voiced with conviction but the facts remain blurry. In a press conference in Paris this week, the IBA chief executive Chris Roberts said that Khelif had failed a "sex chromosome test", but since he could not reveal the details of the test, he prompted those listening to "read between the lines". The International Olympic Committee (IOC) rejects these tests as "arbitrary" and "illegitimate", instead using eligibility rules that were in place in Rio 2016 and Tokyo 2021 which do not include gender testing. IOC president Thomas Bach stood firm on the Committee's stance ahead of the two boxers' gold medal bouts. "This is not a question of inclusion. This is a question of justice," he said. "This is not as easy as some in this cultural war may now want to portray it."

He added that he was uncomfortable with the uncertainty of the IBA's testing formula: "If somebody is presenting us a scientifically solid system how to identify men and women, we are the first ones to do it." At its heart, this issue has gone beyond the sport of boxing. The IOC has cut ties with the IBA over alleged corruption and irregularities in its finances and

governance. The IBA has hit back, often accusing their accusers of the same. The initial row between Khelif and Italian Angela Carini, precipitated a tussle between rival factions with rival national benefactors — the IBA backed by Russia, the IOC by the global West.What is also clear, though, is how the tussle villainised a sportsperson who did little wrong other than competing with ferocity. And even as the noise around this was allowed to reach a deafening pitch, despite the claims and counterclaims about the reasons for her natural strength, Khelif has won this gold medal despite the odds stacked against her.Coming from nothing

Khelif, 25, picked up boxing while growing up in the rural village of Tiaret in Algeria. Coming from a conservative family and little to no wealth, things were never too easy. The pugilist claimed that it was dodging the punches of boys on sports fields at 16 that got her into the sport. Travelling 10km to the nearest gym to train and finding the money for her routines were obstacles, but ones she could only overcome once she got the approval of her family, with her father believing boxing is not a sport for girls (the irony is lost, but must not be lost). Eventually, they came around and found the money to fuel her aspirations. "I started with nothing and now I have everything. Both my parents come to support me. They are my biggest fans," she was quoted as saying by UNICEF, with whom she became an ambassador earlier this year. "It's being able to overcome the obstacles in my life," she said, in response to a question about which of her accomplishments she is most proud of. The larger sporting world has been roped into this scandalous drama, and, otherwise obsessed with ragsto-riches folktales of inspiration, has forgotten to acknowledge the two people at the centre of this. Lin and Khelif have been active boxers for years. The former, too, was born and raised as a girl in Taiwan. Back home, she has a big following too - fans call her 'Ting' (meaning graceful) on Taiwanese social media- and they have been prompted into action to protect their icon as these allegations have been made against her.Khelif has already overcome tough tides to represent Algeria at the grand stage a few times and is finally in the form of her life. She neither prompted nor deserved this storm around her. After winning gold by a unanimous 5-0 decision following a fascinating final bout on Friday, Khelif stood defiant. "I am fully qualified to take part in this competition. I'm a woman like any other woman. I was born a woman, I lived a woman, I competed as a woman, there's no doubt about that," she was quoted as saying by The Guardian. "As for the IBA... they hate me and I don't know why. I send them a single message: with this gold medal, my dignity, my honour is above everything else."The storm may have made Khelif a sporting success in Algeria, as videos emerged of fans celebrating the victory, including a raucous blowout in Tiaret according to a video published by AP. The Algerian president, Abdelmadjid Tebboune. honoured her too. "We are all proud of you, Olympic champion Khelif, your victory today is Algeria's victory and your gold is Algeria's gold.," he said on X.

Perhaps storming to victory in this event and these celebrations will do little to change the enormous hate and bullying she has faced this fortnight; how her life has turned upside down. But the bling of the gold, one hopes, softens the blow.

Legendary shooter Abhinav Bindra says Vinesh Phogat's disqualification most brutal moment in Indian sports; CAS extends deadline for decision



Wrestler Vinesh Phogat is likely to know whether she will be awarded a silver medal or not only on Tuesday, two days after the end of the Paris Olympics. This, after the Court of Arbitration for Sport (CAS) extended time till 6 pm, Paris time — 9:30 pm IST— on August 13 to come to a decision on the wrestler's appeal. It was the second time on Saturday that the sports court sought more time to arrive at a decision. Phogat has challenged her disqualification after she failed to make the weight for her 50 kg final against USA's Sarah Hildebrandt last Wednesday. The Indian wrestler was found 100grams overweight on the morning of the final and was subsequently disqualified from the competition. Earlier in the day, the president of the CAS ad-hoc division extended the time limit for the panel to give a verdict until 6 pm on Saturday. Minutes after the deadline, the Indian Olympic Association (IOA) said in a brief statement that an extension of another two days was made.

The ad hoc division of CAS has extended time till 6 pm on August 13, 2024, for Sole Arbitrator Hon. Dr Annabelle Bennet in the Vinesh Phogat vs. United World Wrestling & the International Olympic Committee to issue a decision. The reasoned order will be issued at a later date," the IOA said. The hearing in the case took place on Friday. As per the CAS rules, the ad hoc panel 'shall give a decision within 24 hours of the lodging of the application. In exceptional cases, this time limit may be extended by the President of the ad hoc Division if circumstances so require.'Dismayed and heartbroken at the turn of events and her dreams of a gold medal shattered, Phogat subsequently announced her retirement from the sport. Even as the wait continued for the decision, Beijing Olympics gold medallist Abhinav Bindra termed her disqualification from the Paris Games on the morning of the 50 kg final as the 'most brutal day in the history of Indian sport'.

Bindra, who received the IOC's Olympic Order award during the Session on Saturday, told The Indian Express he felt like throwing up after learning about Phogat's disqualification from the Games."It was a very brutal day. (My first reaction) was of disbelief. Shock. I wanted to vomit. Early in the morning, somebody sent me a message. Frankly, I had no idea what was going on. It was crazy," Bindra said.

Bindra acknowledged that from 'a sports perspective, it is governed by rules and regulations'. "I am referring to the human side. She has gone through a tough time over the course of the last year and a half. To come back, qualify for the Games and come up with this perfor-

mance. Incredible. To have misfortune, bad luck...Sport as life can be brutal. And I think it was perhaps the most brutal day for Indian sport in our history. I don't think there could be anything that could even come close," he added.Support has been pouring in for Phogat from the world over. On Saturday, it was Japan's Rei Higuchi who showed solidarity. Few would understand Phogat's plight better than the 57 kg gold medal winner, who had missed his home Olympics in Tokyo three years ago after being found 50 grams overweight. "I understand your pain the best. same 50g. Don't worry about the voices around you. Life goes on.Rising from setbacks is the most beautiful thing. Take a good rest," he wrote on X.

Members of the IOC's athlete safeguarding committee, too, have checked on Phogat's well-being. On Thursday morning, Bindra — the vice chair of IOC's Athletes' Commission — travelled to the Olympic Village, where Phogat is staying, to meet her. He called the former Asian Games champion his 'hero'. He admitted there wasn't a lot to say to console her. "What can I tell her? To be there for another athlete, another human being. To show empathy. For her to understand that, you know, there's one thing about winning on the field of play. There's another thing of gaining the respect of not just the entire country, but immense support flooding in from across the world. I just wanted her to realise that. "But of course, she is an athlete and her mission here was not to win hearts but to win a gold medal. Frankly, no words, nobody can do anything for her. I don't know what the CAS ruling will be. Only time can be a healer in this situation," Bindra said.
