TGSRTC offers 10pc discount on Hyderabad-Vijayawada route amid rains, floods

Hyderabad: To reduce the financial burden of passengers traveling between the two Telugu States in view of the heavy rains and flood situation, the Telangana State Road Transport Corporation (TGSRTC) has decided to provide a 10 per cent discount on Hyderabad-Vijayawada route on all the Rajdhani AC and Super Luxury buses.

RTC officials said that since Hyderabad - Vijayawada route is witnessing heavy passenger traffic, particularly during the weekends, it was decided to provide discounts on certain high-end services with the intention of reducing their financial burden. This concession is applicable from Hyderabad up to Vijayawada and vice-versa.

Man claiming to be close aide of HYDRAA Commissioner demands Rs. 20 lakh from builders, arrested

Sangareddy: Exploiting the fear of Hyderabad Disaster Response and Assets Protection Agency (HYDRAA), a physiotherapist blackmailed and demanded Rs.20 lakh from a construction company threatening to call the demolition agency to take action against them. However, the company owner alerted the police about the blackmailer and he was caught red-handed while accepting Rs.2 lakh from the complainant. The accused, Dr Bandla Viplav Sinha (42), was residing in Sail Villas Colony in Ameenpur municipality. With the HYDRAA focusing on illegal constructions near nalas and lakes, Viplav saw it as an opportunity to threaten builders. As MCOR builders had taken construction of villas in the Ameenpur area, Viplav decided to exploit the opportunity.

Congress Govt in Telangana yet to submit flood situation report, says Centre

Hyderabad: In sharp contrast to Chief Minister A Revanth Reddy's claims of the State government moving proactively to ensure speedy relief to the flood-hit, the Ministry of Home Affairs has said the State government was yet to submit even a situation report on the flood, besides requisite documents for release of the Centre's share of to the State Disaster Response Funds. In a letter to Chief Secretary A Santhi Kumari on Tuesday, Ministry of Home Affairs Disaster Management Division Director Ashish V Gawai asked the State government to submit the details in established procedure. Since August 31, some districts were facing flood like situation and were reported to have been adversely affected due to heavy rains. However, as per the established procedure, no formal situation report was received so far in the MHA Control room, he said

As reported by the State Accountant General, Rs.1,345.15 crore was available in the State Disaster Response Fund (SDRF) account as on April 1, 2024 for management of relief in the affected areas during 2024-25"It has been observed from our records that the State government has not submitted requisite information for release of Central share under the SDRF for the current financial year," he said, adding that the second installment of the Central share of SDRF of Rs.188.80 crore for 2022-23 was released to the State government on July 10, 2023. This apart, both the installments of central share of SDRF amounting to Rs.198 crore each for 2023-24 were also released to the State government on March 13, 2024 and March 28, 2024 respectively, he said. The first installment of Central share of SDRF of Rs. 208.40 crore for 2024-25 was due for release since June 1. However, the State government had not made any request for release nor submitted information relating to crediting of earlier released funds, interest earned, utilization certificate etc. The MHA Disaster Management Director also wanted the State government to direct the officers concerned in the State Emergency Operation Centre (SEOC) to furnish a daily situation report on natural disasters on a regular basis. The MHA official also said the Central government had deployed seven teams of NDRF along with boats and life-saving equipment in the State for rescue and relief operations. This apart, two IAF helicopters were also deployed in the State and they were at standby at

Harish Rao fires salvoes at government for failing to submit crucial disaster relief reports

Hyderabad: Former Minister T Harish Rao fired salvoes at the Congress government in Telangana for its gross negligence to submit the situation report to the union Ministry of Home Affairs (MHA) on the destruction caused by the heavy rains and subsequent flooding in the State. The reports are crucial for accessing disaster relief funds. "Shocking. The MHA's letter exposes the Congress government's complete failure to submit the required situation report on the flood crisis," he said. Taking to X, Harish Rao condemned the government's inaction, stating that it is delaying relief funds even as people continue to suffer. "The Congress government is turning a blind eye to the suffering of Telangana's people. This is not just inefficiency, it is a betrayal of the people's trust," he said. He urged immediate corrective action and submit necessary documents to expedite relief efforts. The MHA noted that Rs 208.40 crore in State Disaster Response Fund (SDRF) allocations for June 2024 could not be released because the Telangana government failed to submit both the Utilization Certificate and the requisition for the current fiscal. Meanwhile, the Telangana Accountant General confirmed that Rs 1,345.15 crore in SDRF funds remain un-

SC to hear Arvind Kejriwal's pleas



The Supreme Court is scheduled to hear on Thursday (September 3, 2024) Delhi Chief Minister Arvind Kejriwal's pleas seeking bail and challenging his arrest by the Central Bureau of Investigation (CBI) in the alleged excise policy scam. According to the cause list, a bench of Justices Surya Kant and Ujjal Bhuyan is likely to hear the matter. The top court had on August 23, 2024, allowed the CBI to file its counter affidavit in the matter and gave two days to Mr. Kejriwal to file a rejoinder.Mr. Kejriwal has filed two separate petitions challenging the denial of bail and against his arrest by the CBI in the case. He has challenged the August 5, 2024 order of the Delhi High Court upholding his arrest.

On August 14, the top court refused to grant interim bail to Mr. Kejriwal in the case and sought a response from the probe agency on his plea challenging his arrest. The Delhi High Court had on August 5, 2024, upheld the arrest of the Chief Minister as legal, and said

there was no malice in the acts done by the CBI which was able to demonstrate how the AAP supremo could influence witnesses who could muster the courage to depose only after his arrest. The high court had asked him to move the trial court for regular bail in the CBI case.It had noted that the loop of evidence against the Chief Minister closed after the collection of relevant evidence following his arrest by the CBI and it cannot be said that it was without any justifiable reason or illegal.It said Mr. Kejriwal is not an ordinary citizen but a distinguished recipient of the Magsaysay Award and the convenor of the Aam Aadmi Party.

The high court had dismissed Mr. Kejriwal's plea challenging his arrest, saying it was only after sufficient evidence was collected and sanction was obtained in April 2024 that the agency proceeded with further probe against him. It was noted that the links to the crime extended even to Punjab, but material witnesses were not coming forward due to the influence exercised by Mr. Kejriwal by virtue of his position. It was only after he got arrested that the witnesses came forward to record their statements, the high court had said.

The Chief Minister, who was arrested by the ED on March 21, was granted bail by the trial court in the money laundering case on June 20, 2024. However, the trial court's order was stayed by the high court.On July 12, 2024, the top court granted him interim bail in the money laundering case. The excise policy was scrapped in 2022 after the Delhi lieutenant governor ordered a CBI probe into alleged irregularities and corruption involving its formulation and execution. According to the CBI and the ED, irregularities were committed while modifying the excise policy and undue favours extended to licence holders.

Brakes on bulldozer

IN recent years, the bulldozer has been all over he place, riding roughshod over laws, rules and procedures — especially in BJP-ruled states. People booked n cases of rioting and violence, particularly those beonging to a certain minority community, have seen their shanties and shops being flattened well before their puilt (or innocence) could be proved. In some cases, action has been taken without giving any notice to the accused. Such rare 'efficiency' of the authorities is nothing but a vengeful ploy to punish the accused and their amilies. The contentious exercise, which is carried out n full public view, is meant to send out a stern message o the entire community: Stay out of trouble or face the music.

Municipal laws mandate that unauthorised construction or encroachments on public land be razed. But the devil is in the timing and selectivity. Illegal structures come up right under the nose of the administration, which wakes up to the perennial problem mostly when a communal clash takes place. Making a wellome intervention, the Supreme Court has proposed to ay down guidelines to be implemented across the country to ensure that such demolitions stay within the legal ambit. The court has made it clear that even if someones convicted, his or her house cannot be demolished vithout following the procedure prescribed by law.

The guidelines must include the provision of strict action against officials who bypass due process in their realousness to show 'results' to their political masters. Proceedings should also be initiated against politicians who encourage illegal construction or promise to get it egalised in order to woo voters. The removal of encroachments ought to be a year-round activity, not restricted to the election season or confined to a section of the offenders

The first Vande Bharat sleeper train is expected to be operational by the end of the year. Vande Bharat sleeper train is meant for long-distance overnight journeys, covering 800 to 1,200 km. Railway Minister Ashwini Vaishnaw on Sunday unveiled the prototype of the first Vande Bharat sleeper coach at Bharat Earth Movers Limited (BEML)'s Bangalore Complex. "After Vande Bharat chair cars, we were working on Vande Bharat sleeper cars. Its manufacturing has now been completed. This train will go out for the trial and testing from the BEML facility today," Vaishnaw said.

"This is a historic moment for the country. The muchawaited Vande Bharat Sleeper train set is now set to run on Indian Railways tracks, providing our people with a world-class travel experience and best-in-class amenities. The dedication and expertise of BEML's leadership and engineers have made this remarkable achievement possible," he said. Speaking about the ticket pricing, Vaishnaw said it will be on par with Rajdhani fares. The first Vande Bharat sleeper train is expected to be operational by the end of the year. Vande Bharat sleeper train is meant for long-distance overnight journeys, covering 800 to 1,200 km. The train will have 16 coaches - 11 AC three-tier, four AC two-tier, and one AC first-class - with 823 berths in total. The first Vande Bharat sleeper train is expected to be operational by the end of the year.ccording to the railways, the Vande Bharat sleeper train offers a passenger experience on par with European standards. The maximum operational speed will be 160 km/hr. It will have a hot water shower for 1st AC car, a public announcement and visual information system, ergonomically designed odour-free toilets, automatic exterior passenger doors, special berths and toilets for differentlyabled people, and integrated reading lights with USB charging provision, among other provisions.

To maximise passenger safety, the train set features authentic stainless-steel construction and is equipped with advanced crash-proof elements, such as specially designed crash buffers and couplers. All materials and components used in the train set adhere to the highest fire safety standards, meeting the stringent EN45545 HL3 grade requirements, as per the railways. Vaishnaw on Sunday also inaugurated and laid the foundation stone for a hangar facility spanning 9.2 acres near BEML's Bengaluru facility. It is dedicated to the export of standard and broad-gauge rolling stock, further expanding the BEML's global reach.

Migrant worker from West Bengal lynched in Haryana, 5 held

Chandigarh: Five people, who are part of a cow vigilante group, have been arrested for allegedly beating a migrant worker from West Bengal to death in Haryana's Charkhi Dadri district over suspicion that he had eaten beef, police said on Saturday. Suspecting that the victim had eaten beef, the accused — Abhishek, Mohit, Ravinder, Kamaljit and Sahil — called Malik at a shop under the pretense of selling empty plastic bottles and then beat him, the officer said. He added that after some people intervened, the accused took Malik to another location and beat him again, leading to his death. Malik lived in a shanty near Bandhra village in Charkhi Dadri district and collected waste and rag for a living, the police

SpiceJet flight from Mumbai to Dubai delayed over 12 hours, leaving passengers stranded and frustrated

SpiceJet flight from Mumbai to Dubai delayedPassengers complained that the ground staff was uninformed about the issue and could not provide clear answers regarding the delay. A SpiceJet flight from Mumbai to Dubai faced a major delay, leaving over 150 passengers stranded at the Chhatrapati Shivaji Maharaj International Airport for over 12 hours. The flight, initially scheduled to depart at 11.30 pm on August 31, eventually took off at noon on September 1.

Ruhaan Chawla, 19, a student from Mumbai studying in London, was among those affected by the delay. "The airport ground staff was poorly managed, and we received no clear information about what was happening. I had to make do with a single burger provided by them," Chawla said. Passengers complained that the ground staff was uninformed about the issue and could not provide clear answers regarding the delay. Many were left to find alternative ways to reach Dubai, especially those with pre-planned schedules. Chhaya Aurangabadwala, a senior citizen from Borivali traveling to Dubai to visit her son, faced a particularly tough experience. Unfamiliar with air travel, she endured the extended delay with little support. "The airport staff was

uncooperative, even though I am a senior citizen. I was shivering all night, but the ground staff didn't provide even a blanket. I had to survive on a single burger meal and some refreshments while waiting the entire night," she said. This incident follows another SpiceJet issue just a day earlier. On the intervening night of Friday and Saturday, a different SpiceJet flight to Dubai was delayed and eventually cancelled. Despite the inconvenience, the airline offered no compensation, only advising passengers to board the next scheduled flight on August 31. Some passengers had to adjust their plans, while others were left waiting.

Priyanka Pandure, a Dubai resident in Mumbai for a business trip, said, "I was supposed to depart for Dubai on August 31 at 2 am, arriving at the airport on the evening of August 30. After multiple delays, the flight was eventually cancelled. I had to repeatedly seek updates from the uncooperative staff, and in doing so I twisted my ankle, leaving myself wheelchair-bound. I had no place to stay in Mumbai and had to beg for accommodation, which I finally secured after hours of waiting." My fellow passengers and I spent two nights at the airport without any assistance. We were promised food and other facilities, but nothing was provided. The ground staff treated us poorly. I was frustrated and starving; this was the worst flight experience of my life," Pandure added. The delays and chaos were reportedly caused by a combination of issues, including a strike by a section of the cabin crew over unpaid salaries and staff shortages, which led to operational disruptions. A SpiceJet spokesperson told The Indian Express: "On August 31, SpiceJet flight SG 13 from Mumbai to Dubai was delayed due to a technical issue. While the problem was resolved promptly, the operating crew had exceeded their Flight Duty Time Limitations (FDTL), necessitating a crew change, which caused further delays. We sincerely apologize to our passengers

Zoological Survey of India announces discovery of 2 spider species in Western Ghats

The Zoological Survey of India (ZSI), Kolkata, has announced the discovery of two species of spiders from the southern part of the Western Ghats, a biodiversity hotspot. The new species—mimetus spinatus and mimetus parvulus-were collected from the Mookambika Wildlife Sanctuary in Karnataka and Kerala's Ernakulam district, respectively. The discoveries brought the number of mimetus species in India to three, all of which have been spotted in the southern part of the country.Dr Dhriti Banerjee, Director, ZSI, said, "The Western Ghats play a crucial role in the climatic conditions of the country and continue to surprise scientists with their high levels of endemism. These new discoveries highlight the need for continued exploration and conservation efforts in this region, which is one of the world's hottest biodiversity hotspots."The previous discovery of a mimetus species in India (mimetus indicus) was made 118 years ago. This long gap emphasises the need for more extensive surveys and research into the taxonomy and biogeography of pirate spiders in India, the ZSI said in a statement. The discoveries were made by a team led by the ZSI's Dr Souvik Sen. Dr Sudhin P P, also from the ZSI, and Dr Pradeep M Sankaran of Sacred Heart College at Thevara in Kerala, were also part of the research team. The discovery has been published in the ZOOTAXA journal.Both species belong to the spider family mimetidae, commonly known as pirate or cannibal spiders owing to their unique predatory behaviour. These spiders are known for their



aggressive mimicry, where they infiltrate the webs of other spiders, mimicking the vibrations of prey or mates to deceive and kill the host spider. Additionally, they exhibit kleptoparasitism, stealing prey and even feeding on the eggs of other spiders. Mimetus spinatus is characterised by its medium size, pale yellow head and dull grey white abdomen, with scattered light green mottling. "Notably, it possesses long, black, flattened spine-like hairs on the dorsal head, which inspired its name. In contrast, mimetus parvulus is distinguished by its pale creamy rose head with dense grey black mottling and a triangular-shaped, dull grey white abdomen covered with numerous tubercles. The species' name, parvulus, refers to the short copulatory ducts of the female reproductive organ," the ZSI said in the statement.

Fugitive Dipakkumar Thakkar extradited to India from UAE, arrested by Gujarat Police

A team from the Gujarat Police earlier this week brought back wanted fugitive Dipakkumar Thakkar from the United Arab Emirates (UAE), where he was already under arrest on the basis of a Red Corner Notice (RCN) issued by the Interpol. A security escort team of the Gujarat Police, led by DIG Nirlipt Rai of the State Monitoring Cell (SMC), headed to Dubai on August 27, 2024. They took custody of Dipakkumar Thakkar and brought him to India. He was placed under arrest in Gandhinagar at 12.30 pm on Sunday. A statement from the Central Bureau of Investigation (CBI) said Thakkar was wanted in a criminal case registered on March 25, 2023, at Madhavpura Police Station, Ahmedabad, Gujarat, for being a kingpin of an international illegal criminal gambling racket, operating through the use of special software applications and utilising Hawala channels for dispersal of proceeds of crime reported to be over Rs 2,273 crore. Notably, the State Monitoring Cell (SMC) of the Gujarat Police had been investigating this case that was filed under sections of the Prevention of Gambling Act, the IT Act, as well as the Securities Contract Regulation Act. The complaint stated that the accused person had, in an office in Vejalpur, engaged in stock market dabba trading through the Meta Trader Application on the Velocity Server. They had made illegal trades in the stock market. The main accused or kingpin named in the police complaint was Thakkar. He hailed from Bhabhar in Banaskantha but was residing in Dubai. The SMC obtained an open-dated arrest warrant under CrPC section 70 against him.

When the police realized Thakkar had fled India on July 12, 2023, a lookout circular (LOC) was issued against him. The State Monitoring Cell (SMC) then approached the Central Bureau of Investigation (CBI), who put in a request to Interpol. The international agency then issued a Red Corner Notice (RCN) against Thakkar on December 15, 2023. The RCN was circulated to all Interpol member countries to locate and arrest the accused. Through

Interpol, the subject was geolocated in Dubai. Based on the RCN, the UAE police arrested Thakkar from Dubai on March 13 this year. The Ministry of Home Affairs (MHA) sent an Extradition Proposal for Thakkar to the UAE government on June 25, 2024. The UAE granted this request for extradition on August 8. After this, the team led by DIG Rai headed to Dubai. Thakkar was one of the 36 accused arrested in this case. Earlier, the SMC seized all electronics and froze 47 illegal trading accounts run from the Veialpur office. Further investigation is underway.

Brother, sister-in-law arrested for killing Pune woman, chopping her body over property dispute

The Pune police Sunday said they have arrested a married couple for the murder of a woman whose headless torso was found a few days ago. Those held for the crime are the brother and sister-in-law of the victim. The police have identified the deceased woman as Sakina Abdul Khan, 48, a resident of Bhaiyya Wadi near Dalvi Hospital in Shivajinagar, and the accused as Ashpak Abdul Khan, 51, and his wife Hamida, 45.

Sakina Khan's torso was found in the Mula-Mutha riverbed near a construction site in Kharadi around 11 am on August 26. Her head, both hands and legs were missing. Thereafter, an FIR for murder was lodged at the Chandan Nagar police station against unidentified persons under Sections 103 and 238 of the Bharatiya Nyaya Sanhita (BNS). To identify the deceased, the investigators checked the details of about 200 women between 30 and 60 years who were reported missing in Pune and Pimpri Chinchwad since August 1. The police teams also checked multiple CCTV footage to get clues about the deceased and her murderers. On August 30, the police got information that a woman named Sakina Khan was missing from the Shivajinagar area. They traced her family members and got a missing report registered as per which she was not seen after August 23.

During the investigation, the police found out that Sakina Khan was murdered by her brother Ashpak Khan and sister-in-law Hamida following a dispute over property, which included their residential house and other valuables. Sakina Khan was unmarried. During a press conference on Sunday, joint commissioner of police Ranjan Kumar Sharma said, "Probe so far has revealed that Ashpak and Hamida had a quarrel with Sakina regarding the property dispute on the night of August 23. During the quarrel, Ashpak and Hamida murdered Sakina by strangling her with a wire. Then they chopped her body into pieces with a sharp weapon."The police said the accused threw the body pieces into the river to destroy evidence. While Sakina Khan's torso was recovered, her head, legs, and hands have not been found yet. Attempts are on to recover the remaining body parts of the deceased and seize the weapon used by the accused to cut the victim's body into pieces. The police said Ashpak Khan is a garage mechanic and he was also working as a watchman. His children are out of town. The police are probing if more persons were involved in the crime. The police produced the two accused before a court in Pune on Sunday. "The court has remanded the accused in police custody till September 9," said police inspector Anil Mane, the investigation officer of this case. Meanwhile, cash rewards have been announced for police teams led by DCP (zone 4) Himmat Jadhav and DCP (crime) Nikhil Pingle for cracking the case.

Cop-out? Punjab AIG seeks premature retirement after transfer to Bathinda jail

After being transferred to the high-security jail in Bathinda as superintendent, an assistant inspector general (AIG) of the Punjab prisons department sought premature retirement from service on Saturday. He requested to be relieved with immediate effect after he paid a three-month salary as compensation. AIG Manjit Singh Sidhu, who was posted in Patiala Central Jail, submitted an application for premature retirement from service to the office of Punjab Additional Director General of Police (ADGP), triggering buzz that he was unhappy with the transfer. Along with the application, he attached a demand draft for Rs 3.96 lakh (three months' salary) and sought that the department approve his request for premature retirement with immediate effect.

An official of the jails department said it was "unprecedented" that any officer had sought premature retirement by paying in advance the salary for the notice period months. The official added that this was indicative of the officer being very "miffed" at the department's func-

tioning. The application moved by Sidhu, a class-I gazetted officer, would be considered by the additional chief secretary of the prisons department for a decision. Sidhu, who, according to a jail official, cited "domestic" reasons to seek premature retirement, was not available for comment despite phone calls and texts sent to him on his mobile number.IG (prisons) Roop Kumar Arora said Sidhu was transferred to the Bathinda jail due to his "past experience" and since he was a "competent officer". Arora said, "There are 11 posts of AIG-cum superintendent in central jails of Punjab. We have only two officers, Manjit Singh Sidhu and Rajiv Kumar Arora, who are regular AIGs after promotion. Three years ago, we posted seven officers, who came on deputation from the Border Security Force (BSF), as jail superintendents. Out of them, a few retired. Now, three such BSF officers — N D Negi, who was posted in Bathinda jail; Anurag Azad, who was posted in Amritsar jail; and Gurnam Lal, who was posted in Ropar jail - were to be repatriated to the BSF after completion of their deputation period."

"We have transferred AIG Manjit Singh Sidhu to the Bathinda as jail superintendent. He has prior experience serving in Bathinda twice and is considered a competent officer. Bathinda jail is one of the most important jails where CRPF personnel are deployed, in addition to state-of-the-art security measures, including the jammer," Arora added. The IG said in the order on Wednesday, Rajiv Kumar Arora was transferred to the headquarters in Chandigarh as two officers were to retire next year. In the application seeking early retirement from service and immediate relieving, Sidhu mentioned that he joined as an assistant superintendent in the Punjab prisons department on December 5, 1997, and completed 26 years, eight months, and 16 days of service by August 31, 2024.

A consumer court in Karnataka has ordered the agriculture department to pay Rs 2.25 lakh in compensation to a farmer's family for providing substandard groundnut seeds.

The District Consumer Disputes Redressal Commission in Dharwad granted relief to Prakash Mahadeappa Huded's family in an order on August 27.According to the petition, on June 24, 2019, the Huded family bought five groundnut packets of 30 kg each from the agriculture department's Raitha Samparka Kendra, which was supplied seeds by the University of Agriculture Sciences in Dharwad and the Regional Seeds Growers Cooperative Society.

The groundnut seeds were sown on July 27, 2019, and ought to have sprouted within six days. But they did not, even after 10 days. An agricultural expert who inspected the seeds said he would report the matter to higher authorities. After 14 days, the university's director visited the farm and agreed that the seeds were substandard, and promised that he would take appropriate action. However, Huded's family did not get any reply or compensation. The family contended that the market value of groundnuts was Rs 5,000 per quintal when it



bought the seeds and that the family should have earned an income of Rs 5 lakh. The university submitted before the consumer court that it had not engaged with the family in any way. The court said the Raitha Samparka Kendra had collected breeders' seeds from the university and the Regional Seeds Growers Cooperative Society, adding that breeder seeds should not be sold as certified-foundation seeds to farmers, according to the National Seeds Policy of 2002. In his order, E K Bhute, president of the consumer court, however, dismissed charges against the university and directed the cooperative society and Raitha Samparka Kendra to pay Rs 2.25 lakh as compensation for selling substandard groundnut seeds. The court further ordered Rs 25,000 to be paid to Huded's family for causing mental agony and loss, as well as Rs 10.000 to be paid towards litigation costs.

AAP councillor Ram Chander's son accuses BJP of abducting his father

Rander's Ek Khamba Masjid, an architectural marvel built on a single pillar

Across the Tapi river from Surat is Rander, a district known for its street food and mosques. Standing out among its architectural wonders is the Quwat-e-Islam Masjid, also called Ek Khamba Masjid (one-pillar mosque), as it stands on a single pillar, on Variyavoli Street adjacent to Botawala Street

From the single pillar in the basement stem out four arches and three minarets, each 50 ft tall, and on it rests the entire structure of mezzanine plus one floor.Rander is now a part of the Surat Municipal Corporation. It had a population of Jains, Parsis and others and it was famous for its international trade network. Historians say the Rander port was built before the Surat port. Way back in 1200, Jains would trade different goods from the Rander area with Arabs, Africans, South East Asians and Middle Easterners. In 1225, Arab traders from Kufa in Iraq settled in Rander.Quwat-e-Islam Masjid at Rander The mosque was renovated in 1920 by Haji Ahmed Ibrahim Bharucha, a wealthy businessman of Rander.

Rander town is now dominated by the wealthy Sunni Bohra community, which has many of its members settled in the US, UK, South Africa, among other countries. Sunni Bohras settled in Rander and Mumbai after returning from Burma, where they had migrated to. They built mosques, burial grounds, schools, hospitals and banks in Rander town, which is spread over a 2 square km radius. Suleman Mitchla, 75, a retired high school teacher who was a trustee of the Quwat-e-Islam Masjid, said, "Through our grandfather we know that the land was purchased from a Parsi family in 1850 by the Angulia family and others of Rander for Rs 5,000 and that the mosque was constructed at a cost of Rs 1.18 lakh. Around 15 people of Rander had contributed money for the construction of this mosque. For a long time, we have seen visitors including architecture students from the US, UK, Germany and other countries as well as different parts of India.

The mosque was renovated in 1920 by Haji Ahmed Ibrahim Bharucha, a wealthy businessman of Rander, its pastel shades and ornate minarets adding to its beauty. The elevation has a light green colour base, the shades changing on the engravings on the minarets and arch on the main gate. A stairway 4 ft wide, each step a foot high, leads one to another arch-shaped door, which is around 15 ft above ground level, to enter into the main hall—85 ft long and 60 ft wide, which is 2 ft below the main prayer hall (jamaat khana). The main hall is also used for large gatherings.

The mosque's hauz (water tank for ablutions) is built around a wooden deck. People also pray on the deck. The single pillar that bears the mosque is around 4 ft tall. The two arches stemming from it are around 15 ft long and the two others 10 ft long. The entire mosque structure rests on these four arches and the pillar. Next to the pillar is a grave. A 10-ft-deep water tank has been made in the basement to harvest rainwater. The first floor of the mosque has a large prayer hall, from where a wroughtiron stairway leads to the three minarets, each 50 feet tall



from ground level. The minarets have pointed arches built in Gothic style with floral carvings and domes that have grooves flanked by ornate edges. Even though this mosque is geometrically laid out, unlike other mosques it has minarets only on three sides. The fourth corner has a kitchenette on the floor above it. The internal prayer hall has a carved marble pulpit from where the imam delivers sermons. This prayer hall also has an exquisite lime-plaster fresco ceiling and chandeliers that are lit up during prayers.

The outer prayer hall (jamaat khana next to the inner prayer hall) is surrounded by Rajasthani arches. The prayer hall also receives natural skylight and air ventilation through large glass pane windows. Amar Hatiya, who is a civil engineer and one of the mosque trustees, said, "The engraving on the entry arch gate towards the prayer hall mentions that it was renovated in 1920 AD. The three minarets with equal weight are at three different corners of the mosques equidistant to each other. The fourth minaret was not built as there was no space due to the adjacent property of some private person. They constructed three minarets and to keep the balance of structure, with no possibility of a fourth minaret, they made a small room, which is used as kitchen, so that the structure stands still."Rander Masjid Income for the mosque comes in the form of donations made by Rander natives who have

The mosque has six rooms, three entrance gates and 50 windows, with three stairs going toward the top of the minarets. "The pillar has been made so strong that no earthquake or flood has ever been able to cause any damage. The outer wall has been made with limestone and other materials and plaster thickness is 50 mm, which protects it from sun and rain," Hatiya added. There are two more trustees for the mosque-Bilal Mehtar and Mohammed Modan, who take care of its maintenance expenses. Income for the mosque comes in the form of donations made by Rander natives who have settled abroad. Nikhil Shah, a Surat-based researcher, wrote about the mosque on the Sahapedia website, "The architectural styles identified are as follows: vernacular, colonial, baroque and Arabesque, an eclectic mix which has been carefully designed with visual harmony and proportions that appropriate the building within the setting."

Female medics won't feel safe without central protection law, say doctors at Jantar Mantar

New Delhi: Doctors in the national capital gathered at Jantar Mantar Saturday to protest against the rape and murder of a trainee doctor at a Kolkata hospital, asserting that without a central law to protect healthcare workers, female doctors would never feel safe during work. Protestors began gathering at Jantar Mantar from 3 pm onwards to demand justice for the victim of the incident at Kolkata's RG Kar Medical College and press the government to expedite the enactment of the Central Healthcare Protection Act, doctor associations said.

Dr Deepika, a protesting doctor, told PTI, "I will never allow my daughters to become doctors here... Can you imagine that all of us female doctors are scared now? We feel fearful while working, and we need protection. Can you imagine if she was raped and murdered at her workplace?" "We want protection so that all female doctors can work again without fear," she said.Chairman of Federation of All India Medical Association (FAIMA) Rohan Krishnan said they had earlier called off the protest due

to the Supreme Court's intervention."...despite one arrest, there has been no significant progress in the case. That's why we want to continue our silent protest. We want our female doctors and nurses to feel safe again while working, and justice should be served," he said. The apex court constituted a task force, which will take note of suggestions of all stakeholders while formulating a national protocol for the safety of healthcare professionals, including the associations representing resident doctors.

A statement by FAIMA issued on Saturday said it "is profoundly disturbed by this heinous act, which has not only shattered the medical fraternity but also exposed the alarming vulnerabilities that healthcare professionals face daily." "Our fight will continue until justice is served," said Manish Jangra, founder and chief advisor of FAIMA. He added that members of the Resident Doctors of India (RDA) from hospitals around Delhi-NCR, such as Aligarh and Rohtak, will be part of the protest. Earlier this month, resident doctors across the country went on an indefinite strike on August 12 after the body of the trainee doctor was found on the premises of the state-run hospital in Kolkata on the morning of August 9. Following the incident, doctors held the strike for 11 consecutive days, during which all elective services, wards, and OPDs were suspended. However, after the Supreme Court hearing on August 22, the doctors called off their strike, stating that they will resume work following the court's appeal, assurances and intervention in the RG Kar incident and the safety of doctors. The key demands of the protest include a prompt and thorough investigation into the crime, ensuring swift justice for the victim and the immediate enactment of the Central Healthcare Protection Act to safeguard the lives and wellbeing of healthcare workers across the nation.

Bengaluru court sentences West Bengal man to 6 years of imprisonment in a fake currency case

When the accused were interrogated, they revealed that they were circulating counterfeit notes., fake notes, bengaluru, fake currencyNIA investigations revealed that he had conspired with six others to traffic 41 fake Indian currency notes, with a face value of Rs 82,000, from the Bangladesh border to different parts of India.

A special National Investigation Agency (NIA) court in Bengaluru has sentenced a man to six years of imprisonment in a 2018 fake currency case. Sariful Islam, a native of West Bengal, was convicted and fined Rs 5,000 in the case. He is the seventh accused to be convicted in the case.NIA investigations revealed that he had conspired with six others to traffic 41 fake Indian currency notes, with a face value of Rs 82,000, from the Bangladesh border to different parts of India. Islam fraudulently obtained a SIM card to communicate with his co-accused for the procurement of the fake notes from West Bengal and their circulation across the country, as per the NIA.Investigations uncovered a series of similar transac-



tions involving the accused, who had previously supplied counterfeit notes worth Rs 10.30 lakh to the primary convict, Dalim Mia, in West Bengal. According to the NIA, the scheme was designed to destabilise India's financial and economic security. In this case, the NIA continues its investigation of two Bangladeshi nationals who supplied the currency notes to the convicts. So far, the agency has filed three chargesheets.

"The accused is a resident of our village. I could not imagine that he could do such a thing. My daughter, who is nine years old, was coming to my shop from home. At that time he assaulted her. I demand exemplary punishment for him," the girl's father said. As soon as the alleged sexual assault in the Rajbari area of Rohanda panchayat came to light on Saturday night, locals started protesting in front of the home of the accused. The TMC leader whose alleged interference ignited widespread public anger is the husband of a panchayat member. As the mob also targeted the panchayat member's home, police and Rapid Action Force personnel were deployed in the area and tear gas was used to disperse the crowd. Doctors assaulted by outsiders at medical college in Himachal Pradesh's Mandi, 2 apprehended

Unknown people in two vehicles entered Shri Lal Bahadur Shastri Medical College and Hospital, Nerchowk, in Himachal Pradesh's Mandi district, and assaulted trainee doctors late on Saturday night, said the police. Sources said the trainee doctors also retaliated, damaging two vehicles belonging to the outsiders around 12.30 am. The police registered an FIR at the Balh police station and apprehended two suspects after two trainee doctors sustained minor injuries in the attack. Meanwhile, a heavy police force under the supervision of DSP (head-quarters) Dev Raj was deployed at the hospital to prevent any further law and order situation.

Speaking to The Indian Express, Raj said, "Some outsiders in two vehicles entered the medical college and hospital premises without any apparent reason. They began roaming around unnecessarily, raising suspicion among the trainee doctors about their intentions. When a few trainee doctors questioned their purpose for entering the hospital, the outsiders attacked them. Security guards were present and intervened, but the clash escalated. At least three police teams rushed to the hospital after receiving the information. The situation is now under control, and some suspects have been detained for questioning."Several faculty members and principal Dr DK Verma arrived at the scene late at night after being informed of the incident.Dr Verma said, "It was around



12.40 am when the trainee doctors informed me about the clash. I rushed to the scene. By that time, many of the outsiders had managed to escape. Security guards and students had apprehended one or two suspects. We have two entrance gates, one for the hospital and another for the college. The outsiders had entered through one of the gates and reached the area between the college and the hospital

The purpose of their entry into the institute is a matter of investigation. Work is ongoing at the hospital. I remained on the scene until 3.30 am."The SHO of the Balh police station, Inspector Purshotam Dass, said, "An FIR has been registered. The clash is unrelated to any complaint about the standard of treatment at the hospital. The investigation is ongoing."

No political slogans on answer sheets: Amid protests over Kolkata doctor rape-murder, West Bengal issues guidelines for higher secondary exams

The council stated that if any "political slogans" are written in the answer sheet, the candidate's candidature may be cancelled. The Council of Higher Secondary Education

publishes guidelines before the exam to address misconduct. According to the council, this year's guidelines were issued in response to the R G Kar incident and the subsequent public protests from various corners.

"A candidate shall held guilty of misconduct or malpractice if found indulging in indecorous writing or indecorous drawing or political slogans in the answer script/ OMR of the candidate," the guidelines noted. It also said, "A candidate shall be held guilty of misconduct or malpractice if he/she encloses a currency note with answer script with the intention of offering illegal gratification or inducements to the invigilator or any other person connected with the examination or in any way tries to take illegal or unfair advantages..."A senior official of the School Education Department said, "After the rape and murder of a postgraduate trainee doctor at R G Kar Medical College and Hospital, people from all sectors across the state came out to protest this heinous crime and demanded justice. Specifically, students and teachers actively participated in the protest, and alumni from different colleges and schools also participated." "Even supporters of football clubs displayed banners demanding justice at the football stadium. The overwhelming protests made the council think that some students might conduct similar acts during the higher secondary examination. This is why the council published guidelines for

Covid a distant memory, why supermarkets in Bengaluru are forcing customers to take off their masks

There was a time when wearing masks at supermarkets and other public places was mandatory due to Covid-19. But now, the tables have turned, as many supermarkets in Bengaluru have banned customers from wearing masks. The reason: a rise in thefts. According to an employee of a supermarket chain, they have experienced significant losses because of people wearing masks committing theft. The police also noted that masks have become a common attire for criminals such as thieves, chain snatchers, and robbers in the post-Covid era.

Rajesh Aradhya, an employee of a supermarket chain located in Kengeri, said in the last month, Items worth Rs 3 lakh have been stolen from two of their supermarkets, which made the management take such a decision. "In the outlet I work at, we have lost about Rs 1.2 lakh worth of materials. We have installed CCTV cameras inside and when checked, we found that the faces (of suspected thieves) were covered with masks. The theft came to light only during an audit which happens once a week."When Rajesh was asked how the thieves hide stolen stuff, he said, "They will keep stolen items inside their college bags or in shirts or pants. Then, they will bring some items to the cash counter to bill, which will be of a lower cost. There are stores that do not allow bags inside. However, smaller outlets don't have that privilege."

Asked why they don't file a police complaint, he said, "It is not about one person. They steal items worth Rs 1,000-2,000, and the police would laugh at us if we said this. The same person rarely returns, and there are mul-



tiple people who do it."A senior police officer said while theft cases are not commonly reported at supermarkets, incidents such as robbery and other crimes where masks are involved pose a challenge to the police.

"In many recent thefts and robberies, we have observed that masks are being used to shield the perpetrators from being identified by the police. In cases of chain snatchings and thefts, we had similar issues before Covid-19 where the culprits used to wear helmets. However, with the subsequent capture on CCTV, we were able to catch them as they had to remove the helmets somewhere along their escape route. The use of masks has made it easier for them to evade identification," the officer explained. "It's not just about minor thefts. Even in the case of the Rameshwaram cafe bomb blast, the main suspect who left the IED in the restaurant was also wearing a mask. It has become a kind of uniform for thieves," the officer said.

Bengaluru PG murder: Police file charges, say woman killed for sheltering colleague from ex-boyfriend

Bengaluru PG murderKriti Kumari, who was a business development associate, was killed around 11.15 pm on July 23 after she helped her colleague move out of the flat of her ex-boyfriend, Abhishek Ghosi. Police investigating the murder of a 24-year-old woman at a Bengaluru paying guest facility have filed a chargesheet and stated that the accused, the former boyfriend of a colleague, had bought the knife used in the crime just four hours before the murder. Kriti Kumari, who was a business development associate, was killed around 11.15 pm on July 23 after she helped her colleague move out of the flat of her ex-boyfriend, Abhishek Ghosi, who belongs to Madhya Pradesh, after their relationship soured. According to the police, Ghosi entered the Bhargavi Staying Homes for Ladies, located at Venkatareddy Layout in Koramangala, southeast Bengaluru, made his way to the third-floor room where Kumari was staying, and knocked on the door. When she opened it, Ghosi forced his way inside. As Kumari attempted to escape, Ghosi chased her down and allegedly stabbed her multiple times before slitting her throat. That night, Ghosi's estranged girlfriend was staying at a different place that Kumari had arranged for her.

Speaking about the motive behind the murder, a police officer said, "He believed that Kriti was responsible for his estranged girlfriend ending their relationship. Ghosi's estranged girlfriend was Kriti's roommate and the two had been in a relationship since childhood. When Ghosi's girlfriend moved to Bengaluru from Bhopal for a job, Ghosi struggled with loneliness and eventually relocated to Bengaluru as well. He rented a flat in Ejipura, just 800 m away from his girlfriend's PG accommodation."

In June, Ghosi became frustrated by his inability to find a job and began engaging in frequent arguments with his girlfriend. These fights escalated into abuse and harassment. In July, Kumari helped her move to a location unknown to Ghosi. Angered by this, Ghosi made several unsuccessful attempts to find out his girlfriend's new location from Kumari. When these efforts failed, on the morning of July 23, Ghosi decided to murder Kumari, according to the police. He vacated his flat and moved into a PG facility near Kumari's. In the evening, he purchased a knife for Rs 65 and tried to enter Kumari's place around 8 pm but was turned away by the security guard. Ghosi then waited for an opportunity and, at 11.15 pm, entered the building when the guard went upstairs, and allegedly killed Kumari. After the murder, Ghosi returned to his PG facility, changed clothes and took an autorickshaw to the Yeshwantpur railway station. Along the way, he allegedly disposed of the knife. On reaching the station, he changed his mind and headed to Majestic, but again sensed danger and travelled to Baiyappanahalli, where he boarded a train to Betul in



Madhya Pradesh.Meanwhile, the police had tracked Ghosi's estranged girlfriend's location and gathered key information about him. On July 26, Ghosi was arrested as soon as he arrived at Begamganj in Madhya Pradesh's Raisen district by bus from Betul, roughly 290 km away.The 1,205-page chargesheet, which was filed on Saturday, includes 85 witness statements. Thirteen of the witnesses have given their statements before a magistrate under section 164 of the Code of Criminal Procedure



The flight crew received complaints from another passenger about the objectionable imagery on the man's t-shirt and asked the latter to change. The man turned the shirt inside out for a while. "Next thing I know, right before take-off, a Delta employee comes on the plane and escorts him off the flight, he had flipped his shirt back to the decal side," a Reddit user wrote under the video posted on the platform, the New York Post reported. The shirt flaunted a graphic of former president Donald Trump wearing US flag-coloured glasses and a text above and below him referencing a viral video of a girl explaining oral sex. The video of the incident posted on Reddit has garnered over 900 upvotes and comments."I am getting kicked off because of my shirt," the man can be seen declaring, while being escorted off the plane. He also abuses a flight attendant. Although the reaction seemed extreme to a slew of people on Reddit, the airline was well within its right to make the passenger deplane. According to Delta Air Lines' policies, which notes that passengers can be removed if their "conduct, hygiene, attire or odour creates an unreasonable risk of offence or annoyance to other passengers," according to

Health official says polio vaccine campaign begins in war-torn Gaza

A health official said a polio vaccination campaign began in Gaza on Saturday (August 31, 2024), while an aid worker said a large-scale rollout would begin on Sunday (September 1, 2024), coinciding with a "humanitarian pause" agreed by Israel and Hamas. The vaccination drive was announced after Gaza recorded its first polio case in a quarter of a century earlier this month. Local health officials along with the UN and NGOs "are starting today the polio vaccination campaign", Moussa Abed, director of primary health care at the health ministry in Hamas-run Gaza, told AFP on Saturday (August 31, 2024). An unspecified number of children received the first dose of the vaccination, which involves two doses and is administered orally, at Nasser Hospital in the southern city of Khan Yunis. Among them was Amal Shaheen's three-year-old daughter, who was already in the hospital being treated for pneumonia ."We have been in the hospital for 17 days... I spend all my days worrying about her," Mr. Shaheen said. "Today she was vaccinated against polio to protect her, like all the children in the hospital have been vaccinated.

The World Health Organization (WHO) said on Thursday (August 29, 2024) that Israel had agreed to a series of three-day "humanitarian pauses" in Gaza to facilitate vaccinations, though officials had earlier said the campaign was expected to start on Sunday (September

An international aid worker told AFP that Palestinian authorities had organised a launch event on Saturday (August 31, 2024) and that the vaccination campaign was still expected to begin in full on Sunday (September 1, 2024).COGAT, the Israeli defence ministry body which oversees civilian affairs in the Palestinian territories, said on Saturday (August 31, 2024) that vaccines would be given daily from 6:00 a.m. (0300 GMT) until 2:00 p.m. for three days in central Gaza, three days in souther and three days in northern Gaza. At the end of each regional vaccination campaign, a situational assessment will be conducted for the area," it said. The Palestinian health ministry distributed a slightly different schedule, with the vaccine programme lasting four days in each location. The ministry identified 67 vaccination centres -mostly hospitals, smaller health centres and schools -- in central Gaza, 59 in southern Gaza and 33 in northern Gaza. Poliovirus is highly infectious and most often spread through sewage and contaminated water - an increasingly common problem in Gaza as the Israel-Hamas war drags on. The media office of the Hamas-run government



in Gaza said on Saturday (August 31, 2024) that the vaccination campaign required an "immediate ceasefire". Israeli Prime Minister Benjamin Netanyahu has said measures to facilitate polio vaccination in Gaza are "not a ceasefire". The campaign aims to cover more than 640,000 children under 10 years old.

Michael Ryan, WHO deputy director-general, told the UN Security Council this week that 1.26 million doses of the oral vaccine had been delivered in Gaza, with another 400,000 still to arriveThe Ramallah-based Palestinian health ministry said earlier this month that tests in Jordan had confirmed polio in an unvaccinated 10-monthold baby from central Gaza. Poliovirus is highly infectious and most often spread through sewage and contaminated water -- an increasingly common problem in Gaza as the Israel-Hamas war drags on. The disease mainly affects children under the age of five. It can cause deformities and paralysis and is potentially fatal'100% safe'Bakr Deeb said on Saturday (August 31, 2024) that he brought his three children — all under 10 — to a vaccination point on Saturday (August 31, 2024) despite some initial doubts about its safety."I was hesitant at first and very afraid of the safety of this vaccination," he said. Three killed after small plane crashes into row of townhouses in Oregon, TV station reports



Azerbaijan holds a parliamentary election expected to retain the presidential party's dominance

Azerbaijan on Sunday (September 1, 2024) is holding a snap parliamentary election that is the first for the country since it regained full control of a former breakaway territory in a lightning offensive last year. Previous elections since independence from the Soviet Union have not been regarded as fully free or fair, and the vote for the Milli Mejlis parliament is not expected to bring significant changes to the body that is dominated by the New Azerbaijan party of President Ilham Aliyev.

Under the constitution, the election would have been

held in November, but Mr. Aliyev decreed it to take place two months early because the capital of Baku will host United Nations climate talks known as COP29 that same month.Mr. Aliyev and his late father, Heydar Aliyev, have led Azerbaijan with their heavy-handed rule since 1993, suppressing dissent as the country of almost 10 million people on the shores of the Caspian Sea basked in growing wealth from its huge oil and natural gas reserves. New Azerbaijan holds 69 of the 125 seats in the parliament, and most of the rest belong to small pro-government parties or independents. The Musavat party, the major opposition formation, put forth 34 candidates for Sunday's election but only 25 of them were registered. The Republican Alternative opposition party will run 12 candidates. The election comes just short of a year after Azerbaijani forces routed the remains of the self-declared government in the Karabakh region, which since 1994 had been under the control of ethnic Armenian forces backed by Armenia. Most of the region's 120,000 Armenian residents fled the region the the face of the offensive. The national election commission says 50 organizations will conduct observer missions. The largest observer contingent, from the Organization for Security and Cooperation in Europe, is scheduled to present its preliminary assessment of the election on Monday.

Venezuela sends hundreds to maximum security jails after election: NGO

More than 700 people arrested during protests that erupted after Venezuela's disputed presidential election have been transferred to maximum security prisons, a human rights group said Saturday, August 31, 2024. The detainees, who had been held at police stations around the country, were transferred over the past week to two notorious prisons that were previously controlled by gangs, the Venezuelan Prisons Observatory said. "In many cases, the transfers were conducted under questionable circumstances, with detainees' relatives not informed of the moves to Tocuyito and Tocoron prisons," the group said."They were conducted with many irregularities," the NGO said in a press release. More than 2,400 people were arrested after the protests that broke out after President Nicolas Maduro was declared winner of the disputed July 28 election. The Opposition claims it won by a andslide and has voting records to prove this

The leftist Maduro government, brushing off accusations of authoritarianism, has resisted intense international pressure to release vote tally numbers to back up its claim of victory. The United States, the European Union, and several Latin American countries have refused to recognize Maduro as having won without seeing detailed voting results. Violence that accompanied the protests left



27 people dead and 192 injured. Venezuelan Prisons Ob servatory said none of the people transferred to maximum security facilities have been allowed to contact their families or attorneys. Of the 2,400 detainees, 1,581 have been listed as political prisoners by another advocacy group, called Penal Forum.Penal Forum said 114 of the total are adolescents and at least 40 of them were released on bail Saturday. Sixteen were freed from detention on Thursday. Some of those arrested are as young as 13 and have been sent to prisons with older, common criminals, opposition leader Maria Corina Machado said

Vice-President Kamala Harris calls Donald Trump's appearance at Arlington a 'political stunt' that 'disrespected sacred ground'

Vice President Kamala Harris said former President Donald Trump "disrespected sacred ground" in his recent appearance at Arlington National Cemetery, where the Republican nominee took and distributed images de spite a federal prohibition on campaign activity on the grounds.Ms. Harris, in a statement posted Saturday on the social media platform X, cited reports that Mr. Trump's campaign aides created an altercation with a cemetery staffer and proceeded to take photographs and film the former President, including at the graves of Afghanistan war veterans, after being warned about rules at the site. As Vice President, I have had the privilege of visiting Arlington National Cemetery several times. It is a solemn place; a place where we come together to honor American heroes who have made the ultimate sacrifice in service of this nation."Let me be clear: the former President disrespected sacred ground, all for the sake of a political stunt," Ms. Harris said, calling Arlington a "solemn place where we come together to honor American heroes .. not a place for politics."

The original incident stemmed from Mr. Trump's and Republicans' continued criticism of President Joe Biden and now Ms. Harris for the chaotic U.S. withdrawal from Afghanistan. Putin gifts 24 purebred horses to Kim Jong-un in return for arms for Ukraine war

Nineteen stallions and five mares of the Orlov Trotter breed, said to be Kim's favourite, arrived in Russia on Sunday as partial payment for North Korean artillery shells sent to Russia amid the ongoing conflict with Ukraine, The Times reported. Two years ago, Pyongyang also received 30 Orlov Trotters, and Kim was seen riding a white horse in a propaganda video. Kim's picture riding a white stallion on Mount Paektu during a snowfall, released by state media in 2019, attracted significant attention on the internet. The horses Kim rode also symbolise North Korea's heritage, as the country named its post-1950-53 Korean War economic recovery effort after the mythical winged horse, Chollima. One of North Korea's rocket boosters is also named Chollima-1. According to analysts who talked to news agency Reuters, the imagery of Kim astride a white stallion was designed to instil confidence in North Koreans that they have a man of strength and destiny holding the reins of power.



Putin has also been famously photographed riding a brown horse while wearing wrap-around sunglasses, a gold chain, and army trousers. Private corporate sector sales up 6.9%; net profits rise 14.2% in April-June: RBI data

Aggregate sales growth of listed private non-financial companies in the April-June quarter of the current fiscal (FY25) stood at 6.9 per cent (year-on-year) compared to a growth of 2.1 per cent in the year-ago period, the Reserve Bank of India's (RBI) data showed.

Net profits of listed non-government non-financial companies rose 14.2 per cent, compared to 9 per cent in the year-ago period, and 6.4 per cent in Q4 FY24, the data on performance of the private corporate business sector for Q1 FY25 showed. The analysis is based on the quarterly financial results of 2,934 listed non-government non-financial companies. All major sectors, manufacturing (67.5 per cent share in total sales), information technology (IT) (10.1 per cent), non-IT services (12.8 per cent) construction (5.3 per cent) electricity (2.9 per cent) and mining (1.1 per cent) recorded higher sales when compared to the corresponding quarter of last year. Within the manufacturing sector, sales of cement, iron and steel, fertilisers, paper products and glass products declined,

In FY24, annual sales growth rate of listed private non-financial companies slowed to 4.7 per cent from 19.8 per cent in FY23. On expenditure front, manufacturing companies' expenses on raw material increased by 6.4 per cent (y-o-y) in consonance with their sales growth, whereas their staff cost recorded higher increase of 10.7 per cent during Q1 FY25; staff cost of IT and non-IT services companies increased by 2.4 per cent and 12.8 per cent, respectively. Staff cost to sales ratio for manufacturing, IT and non-IT services companies stood at 5.8 per cent, 49.1 per cent, and 11 per cent, respectively, during Q1 FY25. Operating profit of the private corporate business sector rose by 9.6 per cent in Q1 FY25, as against 5.3 per cent in the same quarter of the previous fiscal.

Operating profits of manufacturing, IT and non-IT services companies rose by 9.3 per cent, 5.1 per cent and 6per cent, respectively, during Q1:2024-25 and their operating profit margin stood at 14.6 per cent, 22.5 per cent and 21.4 per cent, respectively. The interest coverage ratio (ICR) of manufacturing and non-IT companies improved marginally to 7.9 and 1.8 per cent, respectively, during the latest quarter. The ICR for IT companies remains elevated at 42.9 per cent. ICR, which is a ratio of earnings before interest and tax to interest expenses, is a measure of debt servicing capacity of a company. The minimum value for a viable ICR is 1.

India's growth story intact, polls brought govt expenditure down: RBI governor day after GDP slips to 5-quarter low

As India's real Gross Domestic Product growth slipped to a five-quarter low of 6.7 per cent in April-June 2024-25, Reserve Bank of India governor Shaktikanta Das Saturday said the country's "growth story is intact".

Addressing the national CA conference in Bhubaneswar, Das said the one component which pulled down the country's growth is a dip in government expenditure (capital expenditure) by both the Centre and state governments. "The model code of conduct was in force because of elections. Therefore, government expenditure has come down. It's minus 0.2%," said Das.He said that among all the drivers of growth, the growth rate is 7 percent-plus, and exuded confidence that the country would achieve 7 percent-plus in the current financial year. "Going ahead, whatever growth projection we have given for the current FY, which is 7.2%, should be materialised,"

Based on his quick analysis of the growth figures, though he is yet to get a detailed report from the monetary policy team of the RBI, Das said that private consumption – a proxy for consumption demand – in the first quarter has grown by 7.4% against 4% in the fourth quarter of the previous fiscal year. "Investment has grown by 7.5%, industries sector has grown by 7.4%, manufacturing has grown by 7%, services sector has grown by 7.7% and construction sector has grown by 10.5%," he said. He suggested accelerating government spending in the remaining period of the fiscal to ensure high growth. Clinical joint diseases in neck, shoulders may be due to vitamin D deficiency: Experts

Hyderabad: Vitamin D deficiency could have a direct link to the development of clinical joint disease, commonly in shoulder and neck joint, according to a study by sports medicine specialist from Hyderabad, Prof. Maj. Dr. S. Bakhtiar Choudhary.

The study titled "Association of Vitamin D Deficiency with Frozen Shoulder Syndrome and Repetitive Strain Injury on Spine', which is under publication, says that incorrect and inadequate nutrition on a long-term basis cause micro-nutrient deficiencies, which in-turn led to subclinical joint disease, commonly in shoulder and neck

"We get around 20 per cent Vitamin D (D2) from our diet. But need 80 per cent of Vit D (D3) from direct exposure to sunlight (exposure to ultraviolet B rays). Urban pollution, UV sensitivity, use of sunscreen, dark skin, clothing, and staying indoors prevent direct contact with the sun for the majority of the time. People do not know these facts and remain under the false assumption that they are adequately exposed to sunlight," he said.

Israel recovers the bodies of six hostages in Gaza including U.S. citizen Hersh Goldberg-Polin



Israel on Sunday said it had recovered the bodies of six hostages in Gaza, including a young Israeli-American man who became one of the most well-known captives held by Hamas as his parents met with world leaders and pressed for his release, including at the Democratic convention last month. The news sparked calls for mass protests against Prime Minister Benjamin Netanyahu, who many of the families of hostages and much of the wider public blame for failing to bring them back alive in a cease-fire deal with Hamas. Negotiations over such a deal have dragged on for months.

Hersh Goldberg-Polin, 23, was seized by militants at a music festival in southern Israel on October 7. The native of Berkeley, California, lost part of his left arm to a arenade in the attack. In April, a Hamas-issued video showed him, his left hand missing and clearly speaking under duress, sparking new protests in Israel urging the government to do more to secure his and others' freedom. The army said he was among six hostages who were killed when Israeli forces were about to rescue them. The bodies were recovered from a tunnel under the southern Gaza city of Rafah. It identified the others as Ori Danino, 25; Eden Yerushalmi, 24; Almog Sarusi, 27; and Alexander Lobanov, 33; who were also taken from the music festival. The sixth, Carmel Gat, 40, was abducted from the nearby farming community of Be'eri.

"According to preliminary information, they were cruelly murdered by Hamas terrorists shortly before we reached them," Rear Adm. Daniel Hagari, the Israeli military spokesperson, told reporters.Mr. Netanyahu has taken a tough line in negotiations and repeatedly said that military pressure is needed to bring home the hostages. According to Israeli media, he has feuded with top security officials who have said a deal should be reached urgently. A forum of hostage families called for a massive protest on Sunday (September 1, 2024), demanding a "complete halt of the country" to push for the implementation of a cease-fire and hostage release. "The entire nation will stand alongside the hostages' families to protest the cabinet's ongoing neglect of the hostages," it said.

President Joe Biden, who had met with the parents, said he was "devastated and outraged." "It is as tragic as it is reprehensible," he said. "Make no mistake, Hamas leaders will pay for these crimes. And we will keep work-

the remaining hostages." The Goldberg-Polin family issued a statement early Sunday, hours after the Israeli army said it had located bodies in Gaza. "With broken hearts, the Goldberg-Polin family is devastated to announce the death of their beloved son and brother, Hersh," it said. "The family thanks you all for your love and support and asks for privacy at this time." Biden said Hersh's parents "have been courageous, wise, and steadfast, even as they have endured the unimaginable.""They have been relentless and irrepressible champions of their son and of all the hostages held in unconscionable conditions. I admire them and grieve with them more deeply than words can express." Goldberg-Polin's parents, U.S.born immigrants to Israel, became perhaps the most highprofile relatives of hostages on the international stage They met with Biden, Pope Francis, and others and addressed the United Nations, urging the release of all hos-

On August 21, his parents addressed a hushed hall at the Democratic National Convention — after sustained applause and chants of "bring him home." "This is a political convention. But needing our only son — and all of the cherished hostages — home is not a political issue. It is a humanitarian issue," said his father, Jon Polin. His mother, Rachel, who bowed her head during the ovation and touched her chest, said "Hersh, if you can hear us, we love you, stay strong, survive." Both wore stickers with the number 320, representing the number of days their son had been held. It had long become part of a morning ritual - tear a new piece of tape, write down another day."I find it so remarkable how nauseating it is every single time," Rachel Goldberg-Polin told The Associated Press in January, ahead of the 100-day-mark. "And it's good. I don't want to get used to it. I don't want anybody to get used to the fact that these people are missing." She asked other people around the world to take up the ritual, too, not only for her son, who moved to Israel with his family when he was 7, but for the other hostages and their families. She and her husband sought to keep their son and the others held from being reduced to numbers, describing Hersh as a music and soccer lover and traveller with plans to attend university since his military service had ended. At events she often addressed her son directly in the hope he could hear her, urging him to live another day. Some 250 hostages were taken on October 7. Before the military's announcement of the latest discovery of bodies, Israel said it believed 108 hostages were still held in Gaza and about one-third of them were dead. In late August, the Israeli military recovered the bodies of six hostages in southern Gaza. Eight hostages have been rescued by Israeli forces, the most recent found on Tuesday. Most of the rest were freed during a weeklong cease-fire in November in exchange for the release of Palestinians imprisoned by Israel. Two previous Israeli operations to free hostages killed scores of Palestinians. Hamas says several hostages have been killed in Israeli airstrikes and failed rescue attempts. Israeli troops mistakenly killed three Israelis who escaped captivity in De-


Brazil blocks X over Elon Musk's feud with judge

Sao Paulo: Brazil started blocking Elon Musk's social media platform X, making it largely inaccessible on both the web and through mobile apps early on Saturday after the billionaire failed to name a legal representative in the country. The move, which escalates a monthslong feud between Musk and a Brazilian Supreme Court justice over free speech, far-right accounts and misinformation, came after Supreme Court Justice Alexandre de Moraes ordered the suspension on Friday. To block X, Brazil's telecommunications regulator, Anatel, told internet service providers to suspend users' access to the social media platform. As Saturday morning after midnight local time, major operators had begun doing so. The company hasn't had a legal representative in the South American nation since earlier this month. Foreign companies that operate in Brazil are required to have local representation to make sure someone can be notified of legal decisions and is qualified to take any requisite action.De Moraes had warned Musk on Wednesday night that X services in Brazil could be shut down if he failed to comply, and established a 24-hour deadline. In response, the entrepreneur has fired back at the judge with insults and accusations of authoritarianism. De Moraes said the platform would remain blocked until it complies.

"Elon Musk showed his total disrespect for Brazilian sovereignty and, in particular, for the judiciary, setting himself up as a true supranational entity and immune to the laws of each country," de Moraes wrote in his decision. The justice gave internet service providers and app stores five days to block access to X, and said the platform will stay suspended until it complies with his orders. He established the same deadline for app stores to remove virtual private networks, or VPNs, and set a daily fine of 50,000 reais (\$8,900) for people or companies using them to access X. .Brazil is an important market for X, which has struggled with the loss of advertisers since Musk purchased the former Twitter in 2022. Market research group Emarketer says some 40 million Brazilians, roughly one-fifth of the population, access X at least once per month.X had posted on its official Global Government Affairs page late Thursday that it expected X to be shut down by de Moraes, "simply because we would not comply with his illegal orders to censor his political opponents.'

"When we attempted to defend ourselves in court, Judge de Moraes threatened our Brazilian legal representative with imprisonment. Even after she resigned, he froze all of her bank accounts," the company wrote. "Our challenges against his manifestly illegal actions were either dismissed or ignored. Judge de Moraes' colleagues on the Supreme Court are either unwilling or unable to stand up to him." X has clashed with de Moraes over its reluctance to comply with orders to block users.

Accounts that the platform previously has shut down on Brazilian orders include lawmakers affiliated with former President Jair Bolsonaro's right-wing party and activists accused of undermining Brazilian democracy. X's lawyers in April sent a document to the Supreme Court in April, saying that since 2019 it had suspended or blocked 226 users. In his decision Friday, de Moraes' cited Musk's statements as evidence that X's conduct "clearly intends to continue to encourage posts with extremism. hate speech and anti-democratic discourse, and to try to withdraw them from jurisdictional control." Musk, a selfproclaimed "free speech absolutist," has repeatedly claimed the justice's actions amount to censorship, and



his argument has been echoed by Brazil's political right. He has often insulted de Moraes on his platform, characterising him as a dictator and tyrant.

De Moraes' defenders have said his actions aimed at X have been lawful, supported by most of the court's full bench and have served to protect democracy at a time it is imperiled. He wrote on Friday that his ruling is based on Brazilian law requiring internet services companies to have representation in the country so they can be notified when there are relevant court decisions and take requisite action — specifying the takedown of illicit content posted by users, and an anticipated churn of misinformation during October municipal elections. The looming shutdown is not unprecedented in Brazil.

Lone Brazilian judges shut down Meta's WhatsApp, the nation's most widely used messaging app, several times in 2015 and 2016 due to the company's refusal to comply with police requests for user data. In 2022, de Moraes threatened the messaging app Telegram with a nationwide shutdown, arguing it had repeatedly ignored Brazilian authorities' requests to block profiles and provide information. He ordered Telegram to appoint a local representative; the company ultimately complied and stayed online.X and its former incarnation, Twitter, have been banned in several countries — mostly authoritarian regimes such as Russia, China, Iran, Myanmar, North Korea, Venezuela and Turkmenistan. Other countries, such as Pakistan, Turkey and Egypt, have also temporarily suspended X before, usually to quell dissent and unrest. Twitter was banned in Egypt after the Arab Spring uprisings, which some dubbed the "Twitter revolution," but it has since been restored. A search Friday on X showed hundreds of Brazilian users inquiring about VPNs that could potentially enable them to continue using the platform by making it appear they were logging on from outside the country. It was not immediately clear how Brazilian authorities would police this practice and impose fines cited by de Moraes.X said that it plans to publish what it has called de Moraes' "illegal demands" and related court filings "in the interest of transparency." Also on Thursday evening, Starlink, Musk's satellite internet service provider, said on X that de Moraes this week froze its finances, preventing it from doing any transactions in the country where it has more than 250,000 customers. "This order is based on an unfounded determination that Starlink should be responsible for the fines levied-unconstitutionally-against X. It was issued in secret and without affording Starlink any of the due process of law guaranteed by the Constitution of Brazil. We intend to address the matter legally," Starlink said in its statement. 





vital stand of 183 runs for the fourth wicket with Australian Peter Handscomb, who was batting on 94 at lunch on the final day of the four-day game. Leicestershire's international pair Rahane and Handscomb got together with an aim to save the game for them after Glamorgan's Colin Ingram had crafted a career-best, unbeaten 257 at Sofia Gardens. At stumps on the third evening, Rahane was 47 not out and Handscomb unbeaten on 33, as Leicestershire ended at 144 for 3, trailing by 155, when bad light stopped play with 21.2 scheduled overs remaining.At the lunch, Leicestershire were 271 for four and needing another 28 runs to make their opponents bat again in the match. Both the Indian and Australian were dropped by Glamorgan leg-spinner Mason Crane, two of his three dropped catches coming off his own bowling, misses that could come in the way of the home team's quest for victory. This was after Glamorgan had declared on 550 for 9, with a lead of 299, Ingram unbeaten on a personal best 257, Crane getting his day off to a better start with 49 runs to his name. When the 36-year-old Rahane came to bat, Leicestershire were 74/3 but he combined with Handscomb to keep the team's hopes of saving the game alive. Rahane employed the cut shot to get back-to-back fours and reach his first century for Leicestershire.Rahane, who has scored 12 Test hundreds and three ODI tons, made 42 off 67 balls in the first innings. Rahane eventually fell to Kiran Carlson.

Sunil Gavaskar predicts India will win Border Gavaskar Trophy by 3-1 margin

India will travel to Australia for the five-match Test series this year. The latter have not beaten the former since the 2014/15 series. (Australia win 2-0). The Men In Blue have won the last two series (2020/21 and 2018/19) against Australia away from home and additionally have also been dominant against them at home (2017 and 2023) beating as many times. Former Indian cricketer Sunil Gavaskar predicted India to win the series once again with a scoreline of 3-1. "It's going to be an exciting series for sure with the talent that is there on both sides and it will also show why Test match cricket is the ultimate format of our beloved game. Oh, and my prediction is a 3-1 win for India," Gavaskar wrote in his column for the mid-day.

"With their opening batting problems exacerbated after the retirement of David Warner and the middle-order also a bit dodgy, the Aussies are ripe for the taking once again," reasoned Gavaskar.Gavaskar would also emphasise that the lack of first-class games ahead of the series might cause India to start slowly yet again. "India being usual slow starters in an overseas series in SENA (South Africa, England, New Zealand, Australia) countries the first Test will be crucial. That they aren't playing proper first-class games before that as well as in the week long gaps between some Test matches could work against



them," he wrote. "That said, it is how schedules are nowadays for most touring sides. It is tough on inexperienced newcomers as Yashasvi Jaiswal found in South Africa last year. He came back brilliantly with over 700 runs against England at home," Gavaskar wrote. India for the first time since 1991-92 with the first Test slated to be played at the Perth Stadium from November 22-26. The second Test, a day-night pink-ball affair, will be held in the first week of December at the Adelaide Oval. The third Test will be held at The Gabba in Brisbane followed by the customary Boxing Day Test at the iconic Melbourne Cricket Ground from December 26-30, 2024 and will conclude with the fifth Test in Sydney in January 2025.

Duleep Trophy: Anantapur's 'Perth' aims to fix India's pace woes before Australia tour

Concealed from premier First-Class cricket for nearly a decade, the contrast of an Indian ground where pace outranks spin has grabbed BCCI's attention this year. Mainstream cricket will return to these badlands, in the drought-stricken southwestern Andhra Pradesh district, with the season-opening Duleep Trophy as India C take on India D, starting September 5. Fifteen seamers have made the honours boards at Anantapur's ACA ADCA ground. Only a solitary spinner (KJ Appanna in 2006) has bagged a five-wicket haul to share that space in this period. The rationale behind the choice of venue (barring one match in Bengaluru) may be derived from this unique pace tryst of Anantapur, as a pivotal Australia tour simmers in the background. The national selectors would be keen to take stock of the front-line batters and the fastbowling reserves behind Jasprit Bumrah, Mohammad Shami and Mohammed Siraj for the Border-Gavaskar Trophy. Poverty and underdevelopment paint the general picture of Anantapur's sandy ethos. But Moncho Ferrer does not overstate the return of high-profile cricket for the sport bleeds through the region throughout the year. "Oh, there's a lot of cricket that happens here. It is just that not a lot of high-level cricket happens. The grounds are occupied almost daily. There are inter-district, inter-state matches, and private matches. There are all kinds of activities. Plenty," says Ferrer, the Director of Programmes at the Rural Development Trust (RDT), the local NGO that set up the Anantapur Cricket Ground. Ferrer believes the BCCI's imminent requirement for 'sporting' pitches has had them turn to Anantapur this season.

Coincidentally, the Anantapur Cricket Ground, run by the RDT with the Andhra Cricket Association's backing, has carried some of the bounciest surfaces in the country. Save for a solitary Ranji Trophy plate group match in 2018, the occasion will mark the first time in 11 years that they will serve in First-Class matches. Between 2004 and 2013, where it hosted 15 matches, the main ground at the facility bore 345 wickets by pace and only 96 by spin. Interestingly, only once has a team folded below 100 runs [80] and only four innings have achieved a 400plus total [highest: 447/8]. "We were one of the first in the country to try to integrate sports into the development sector. Sports can be a tool for many things. For inclusion and gender, etc. And then Anantapur being Anantapur, there was no sports infrastructure at all. So then one was to provide access to decent quality sports infrastructure in rural areas that cities are used to having. "Anantapur Cricket Ground was the motivation 20 years ago for all the other districts in Andhra, to give them the belief that 'Yes we can do it as well," says Ferrer. The RDT's desire for innovation eventually culminated in the modelling of a ground that bore Australian traits, of Perth and Adelaide, regarded among the fastest pitches in the world. "We wanted to experiment with something different and not have the same kind of wickets most of the country has. Since we were a small centre, we could afford that risk, unlike the cities. We tried to use the Australian and South African pitch construction methods. It is hard to find the right kind of soil and the necessary stuff. But we decided to be bold and courageous (laughs)," quips Ferrer.

Born to Spanish reformer Vicente Ferrer and his English wife Anne, who set up the RDT in 1969 in the district, Moncho understands Anantapur more than most. Scant resources have naturally directed to alternative ways of ground water preservation. "Anantapur, of course, is historically a drought-prone district. That is why it has such few resources and is known as one of the poorest regions in the country. So it is important to learn to manage your resources well and be smart in doing things," Ferrer says. It begins with the choice of grass on the strips and the outfield that can survive for days without water before growing back."The Hybrid Bermuda selection 1-grade grass we have for the pitches and the outfield was bred in Australia. It survives temperatures up to 70 degrees," says Madhu Achari, curator of the ACG and secretary of the Anantapur District Cricket Association (ADCA). The honours board at the Anantapur Cricket Ground The honours board at the Anantapur Cricket Ground.

'The climate is generally scorching here, touching high 30s to 40 degrees. We have used pure black soil from Amalapuram near Kakinada, about 850 kilometres away. We got them scientifically tested, and the reports showed similarity to the conditions of Perth and Adelaide. Compared to other pitches in India, the difference here is the high clay content in the soil. The clay makes up nearly 65 per cent of the pitch, five per cent of sand, and the rest is silt," Achari explains. The high-maintenance texture of these pitches makes it imperative to bear more active strips in the centre. The main venue of the facility holds 13 pitches. The 'B' ground, awaiting its First-Class debut, has seven. "It is difficult to manage because these pitches crack excessively. So you have to rotate them frequently. If a pitch is used for a game, it must be rested for nearly 45-50 days. Only then can we expect similar results for the next match. Given the Indian cricket calendar, it is difficult to operate until we have at least 9-11 strips in the square," Achari says. While neutral BCCI curators will overlook the preparations for the Duleep Trophy, Achari is confident the pitches will hold onto their Aussie instincts."I am expecting the same (bouncy pitches). I used to prepare the pitches alone throughout the season. Nowadays, the BCCI sends neutral curators to manage them. The rest will depend on their preparation according to the team conditions. Their methods and experience are better than mine," Achari remarks. Even as the venue hosts several NCA camps and BCCI age-group tournaments, Ferrer remains grounded on the prospect of more top-end tournaments soon at the facility. "Now every district in Andhra has a ground (laughs)," he says.In the meantime, Anantapur will relish the procession of the country's top stars to their backyard. To their own mighty

Badminton's new face France's Alex Lanier reframes the sport with muscle power

The last two Olympics men's singles titles have gone to a European, not an Asian. And the first Tour title immediately after Paris Games, the Janan Onen, a Suner 750 final (that's just one rung below the Big4 like All England and China Open), was won by French teenager Alex Lanier.If Danish Viktor Axelsen's tall, strapping mic-drop game has seen him collect titles at will, peaking for the big events and absolutely crushing opponents in onesided finals, the 19-year-old Lanier brings a different physicality to the sport. Lanier, who is 1.8 metres long, got dubbed the 'Beast', as he brought a very high level of muscularity to the court, combined with quickness of movement and flexibility, that will prove to be a headache in coming years for Asians who have stuck to the lean, quick-footed, fast-reflexed bodytype when playing the sport.

Raw power - the likes that is employed by Axelsen and now Alex Lanier - however, can stub out all nuance of skill, deception and reflex. Once pace and clever placement get countered by intelligent anticipation, it is very easy for power to completely derail speed. Remember how Axelsen squished Lakshya Sen in the semifinals of the Paris Olympics in the second set? He didn't even grant finalist Kunlavut Vitidsarn a 19-19 mirage in the opening set. That's what towering power does. The BWF in describing Lanier's win over World No 1, Chinese Shi Yuqi at Japan, said, the Frenchman "imposed his tempo" on his opponent. Lanier himself talking to the press thereafter, explained he made Yuqi "lose his shot quality with sustained pressure" after the Chinese had looked in control of the opening set. Yuqi conceded Lanier was a 'strong player', by which he meant the muscle on the strokes. The Frenchman's scalps over that week in Yokohoma were Lee Zii Jia, Chico Wardoyo, Kenta Nishimoto, Shi Yuqi and Chou Tien Chen, pretty strongly built themselves in terms of the whip on the smash, but Lanier out-muscled

Lanier's win can either be dubbed a flash in the pan or just a fresh player making the most of an opportunity against those who were returning weary from the Olympics, and not totally quite there. But that would be a folly. The former junior World No 1, who didn't make the French 2 at the Paris draw, has been picking some impressive wins even as attention was on Popov brothers. Lanier had lost to Indian Meiraba Maisnam a couple of seasons ago, but had beaten Priyanshu Rajawat in red-hot form at Canada Open just before Paris Olympics. His growth in the last one year has been quite dizzy, and a Super 750 crown is the reward. Perhaps the biggest compliment came from Axelsen, who within hours of the title was congratulating Lanier – also an acknowledgment of a rival spotted.

The French surge in badminton – driven entirely by Paris hosting the Games – might be starting to chomp into Asians, but their prime opponents remain the powerful Danes, and this is a start of a much-needed European rivalry. Speaking to Olympics.com last year, Lanier had said, "When one French player became stronger, then

Once pace and clever placement get countered by intelligent anticipation, it is very easy for power to completely derail speed. Remember how Axelsen squished Lakshya Sen in the semifinals of the Paris Olympics in the second set? He didn't even grant finalist Kunlavut Vitidsarn a 19-19 mirage in the opening set. That's what towering power does.

the others followed and it was natural. They showed me that we can, from France, win the European titles and we can beat the Danish guys. We can beat everyone in the world; that's not impossible."

Lanier hails from Normandy, and literally started badminton when the racquet was taller than him - at age 2, accompanying both his parents to the indoor barncourts, where the mofussil French spend their winters. He's grown up idolising Lin Dan's mixture of power and 'laziness' ("We think that he's not really moving around the court, but he had a beautiful deception and he didn't really need to move, in fact," he told Olympics.com). But he brings distinct European physicality which can disrupt the Asian order of dominance of this sport.Lanier is just 19 and was determined after not qualifying for Paris, and his opponents at Japan weren't exactly in the best shape - mentally or physically, post Olympics. Soon after winning Japan though, he announced his intent to make a mark at the Paris World Championships in 2025. The likes of Lakshya Sen, Li Shifeng and Kunlavut will continue to max their strengths of lithe speed, tall physicality and endless endurance and compact technique respectively. But as Viktor Axelsen has shown power combined with solid technical prowess can help you dominate badminton and end the Asian hegemony. Hosting the Olympics definitely fast-tracked French badminton. There's another projection on muscled, power-badminton that's a little more scary given where the Games are headed in four years time. Like Indian national coach Pullela Gopichand says, "Now imagine when the Americans get into the mix!"
