Meanwhile, topping the list of tax-paying celebrities for FY24 is Bollywood megastar Shah Rukh Khan, who paid a staggering Rs 92 crore in taxes.

Later, Sanjay will proceed towards Kodad to assess the flood damage in the area at around 4 pm, according to an official release issued here on Thursday.Meanwhile, Union Coal Minister and State BJP chief G Kishan Reddy deputed two teams, led by Bandi Sanjay and party MP Etala Rajendar, to tour the flood-affected areas in the State.Sanjay's team will tour Khammam and Kodad along with former MLA Sankineni Venkateshwar Rao, BJP state general secretary Gujjula Premender Reddy and MLA Paidi Rakesh Reddy.Eatala Rajendar's team will tour Mahbubabad and Mulugu along with the party's legislature party head Aleti Maheshwar Reddy, State general secretary Kasam Venkateshwarlu and MLA Ramarao Patil.

### Drinking water crisis hits Telangana due to lack of power to pump Mission Bhagiratha water

Hyderabad: The disruption of power supply due to heavy rain and strong wind has halted the pumping of drinking water in several habitations across six districts of the State. The heavy rains in the last few days have severely disrupted drinking water supply networks, particularly in the districts of Khammam, Bhadradri-Kothagudem, Mahabubabad, Suryapet, Nizamabad, and Nagarkurnool. According to officials, due to power disruption people in over 5,000 habitations faced drinking water problems after heavy rain lashed the State on August 31. For the first three days people in these districts did not have access to drinking water through pipelines and they had to depend on other sources, the officials added.After restoration of power, drinking water supply has started in over 4000 habitations and efforts are being made by the power officials to restore power in other habitations as well. The power officials informed that drinking water supply was halted as in several places as substations submerged due floods. They claimed that power supply restoration works were going on a war footing and that in the next 24-hours restoration works would be completed in the majority of the affected areas. Telangana State Southern Power Distribution Company Limited(TGSPDCL) Chairman and Managing Director Musharraf Ali Faruqui informed that the company suffered heavy losses in Survapet district due to heavy rains. As many as 2127 electric poles, including 15 33 kv poles, 1074 11 kv poles, 1038 LT poles and 319 transformers were damaged due to rain and strong wind, he said.According to Telangana State Northern Power Distribution Company Limited(TGNPDCL) officials, except for some places in Khammam, Bhadradri-Kothagudem and Mahabubabad districts, the power had been restored in all the other districts under its jurisdiction. They ensured that in the next 24-hours power would be restored in all the areas in these three districts.

New Delhi: Delhi Chief Minister Arvind Kejriwal on Thursday told the Supreme Court that the Central Bureau of Investigation (CBI) made an "insurance arrest in hurry" to prevent his release on bail in the alleged excise policy scam case. Appearing for Kejriwal, senior advocate Abhishek Manu Singhvi said that his client was released on three different occasions in the money laundering case registered under the stringent Prevention of Laundering Act (PMLA), where rigours for of bail are much higher. He referred to the 21-day interim release of the AAP supremo in May this year to campaign for the Lok Sabha elections, the interim bail granted subsequently by the top court on July 12, and the trial court order granting him regular bail, which was stayed later by the Delhi High Court on an "oral mention" made by the Enforcement Directorate (ED). Singhvi contended that the CBI did not arrest Kejriwal for two years since August 2022 but made an "insurance arrest in hurry" in anticipation of his release on bail in the money laundering case.

Hyderabad: Floods in Telangana have caused significant disruptions and dislocation, with preliminary estimates indicating that the irrigation department has suffered losses between Rs 300 crore to Rs 350 crore. The full extent of the damage is yet to be assessed comprehensively. Two crucial pump houses of irrigation projects were severely affected. The Vattemvagu pump house under the Palamuru Ranga Reddy Lift Irrigation Scheme (PRLIS) saw four installed pumping units and one unit under installation submerged. These pump houses, each with a capacity of 145 MW, are considerably larger than the Bahubali pumps used in the Kaleshwaram Lift Irrigation Scheme. The dewatering process is expected to take over a month, with the entire surge pool and tunnel filled with flood runoff from nearby tanks.Fortunately, the power substation and other infrastructure at a higher elevation were spared from flood damage.In a related incident, the Bhakta Ramadasu Lift Irrigation Scheme (BRLIS) pump house in Khammam district also suffered extensive damage as flood waters entered the facility. This scheme, that was part of the first irrigation project completed during the BRS regime, serves an ayacut of 59,000 acres in the tail-end of the SRSP Stage II in Palair constituency. Officials are still assessing the damage to the two pumping units, which have a combined yield of 600 cusecs.

The pump house, set up in a record 11 months and commissioned in February 2017, will require repairs and restoration estimated to cost around ten percent of its original cost.Additionally, the Nagarjuna Sagar left canal developed breaches at three locations in Zones I and II due to the floods. Water releases to the canal have been halted to facilitate urgent repairs. These breaches are attributed to prolonged periods of non-use, with the canal network experiencing significant vegetation growth, weakening the structure and obstructing water flow. Officials warn that more breaches could occur once water is released at full capacity of 11,000 cusecs. The canal systems of SRSP and KLIS, which too had no water flows during the last Rabi season, may face similar issues. In total, 200 tanks developed breaches due to the recent floods, necessitating substantial expenditure for restoration and the number may rise once the enumeration was completed. Authorities are preparing estimates to address these breaches within a fortnight, emphasizing the need for regular maintenance and use of irrigation infrastructure to prevent such occurrences in the future.

The CBI arrested Kejriwal for "his non-cooperation and evasive replies" but there were several apex court judgments that held that cooperation with the probe should not mean that the accused should incriminate himself and confess to the offences alleged, he said.He said that Kejriwal, a constitutional functionary holding the position of Delhi Chief Minister, satisfied the triple test for grant of bail. "He is not a flight risk, he will turn up to answer the questions of the investigative agency, and cannot tamper with documents, running into lakhs of pages,



and digital evidence after two years," Singhvi submitted.Opposing the arguments, Additional Solicitor General S.V. Raju, representing the CBI, said that Kejriwal should first approach the trial court for bail.

He argued that arrest is a part of investigation and ordinarily, an investigative officer will not require any permission from a court to make an arrest. "But, in the present case, there was an order of the court granting the power (to arrest)," he said. The bench of Justices Surya Kant and Ujjal Bhuyan will assemble post lunch to resume hearing Kejriwal's pleas assailing CBI arrest and seeking bail. Meanwhile, a Delhi court on Tuesday took cognisance of the charge sheet filed by the CBI against CM Kejriwal and other accused in the alleged liquor policy scam. Special Judge Kaveri Baweja issued a production warrant for Kejriwal on September 11, apart from extending his custody till the same date.

### Islamic radicals want to make Bangladesh another Afghanistan: Taslima Nasreen

New Delhi: Expressing concern that Bangladesh might go the Afghanistan way, writer-activist Taslima Nasreen has said Islamic radicals are brainwashing and indoctrinating youths to make them "anti-India, anti-Hindu and pro-Pakistan".Nasreen said she and others had initially supported the students' movement in Bangladesh against an "autocratic government".

However, the recent actions such as violence against Hindus, targeting of journalists and the release of "terrorists" from jails showed it was not a students' movement but was "planned and funded by Islamic jihadis", she said."When students protested against the quota system in July, we supported them... people who believe in women's rights, human rights and freedom of expression. Sheikh Hasina was an autocrat who always encouraged fundamentalists and curbed freedom of expression. People were angry with her," she told PTI in an exclusive interview.

She said they had hoped that a fair election would be conducted to democratically form a new government. "But afterwards we realised that it was not a students' movement. It was planned and funded by Islamist jihadis and banned terrorist organisation," said the author, who had to flee Bangladesh in 1994 following death threats from Islamic fundamentalists and faced a ban on her books. "We realised that after they started demolishing everything, all the statues, sculptures, museums. The way Hindus were attacked and killed, it was a nightmare. "Now these people are filing cases against journalists and people who were close to Hasina. They are gradually showing their real faces and motives. All the terrorists, who were in jail, are released. It was not at all a students' movement," said the author. The Lajja author has not returned to Bangladesh since her exile and has been living in India since 2005 (except from 2008 to 2010). She also expressed apprehensions that Bangladesh could become another Afghanistan or Iran, going by the way the current interim government was operating under the guidance of Chief Adviser Muhammad Yunus.

"Yunus says that they are celebrating their victory. People are burning houses of Hindus. What kind of celebration is this? They are destroying everything. All the statues of freedom fighters have been demolished including that of the father of the nation Sheikh Mujibur Rahman."But the Pakistan Army's statues are intact — (the army) which killed 30 million people during the war and raped millions of women," said the 62-year-old writer, who is known for being an outspoken critic of radical Islamic elements.

She said Yunus knew "very well that the country would be ruled by jihadis and he has no problem with it"."While we thought that he would conduct an election. It didn't happen. They are not talking about secularism and they want to make Bangladesh like Afghanistan or Iran which is very scary," she said.Yunus had called for halting attacks on Hindus after he was named the head of the interim government, but Nasreen alleged that he didn't take any action against the violence.

# Telangana govt educational institutions to get free electricity

Hyderabad: The State government on Thursday announced free power supply to all government educational institutions in the State. An order to this effect has been issued by Secretary to Government (Energy department) D Ronald Rose.

For the scheme, which came into force immediately, the Telangana Discoms would create an online portal with logins given to respective departments of all the government educational institutions. As per modalities issued by the Energy department, secretaries of the department concerned would finalise the list of institutions to be covered in the scheme and include the same on the online portal. Monthly billing would be done for each institution and displayed in the department's login. Hard copy of the bill would be given to the respective institution in-charge, showing consumption in units and billed value, the order read.

# Indian Chronicle English Daily Vigilante justice

THE recent killings in Haryana, allegedly at the ands of cow vigilantes, have reignited a critical debate on the dangerous interplay of religious fervour and law enforcement in India. In two incidents within a span of a ew days in the state, a student of Class XII, Aryan Mishra, vas gunned down and a 26-year-old migrant worker, Sabir Malik, beaten to death by self-appointed protecors of the cow. Aryan was out with friends when they vere chased by a group of cow vigilantes, who mistook hem for cattle smugglers. The group was relentlessly pursued for 30 km before Aryan was shot dead in aridabad. In the other tragic loss to senseless violence, Sabir, suspected of eating beef, was lured to a bus stand and then lynched by the vigilantes in Charkhi Dadri.

These incidents are a part of a broader and disurbing trend that has taken root. Cow vigilantism, which stensibly aims to protect an animal considered sacred n Hinduism, has increasingly become a pretext for exrajudicial violence, mostly targeting a minority commuity. Efforts have been made to curb it, including arrests nd legal proceedings, Supreme Court directives for tricter enforcement and pressure on governments to ct. However, inconsistent implementation and the poitical influence of vigilante groups hinder progress, leavng members of the minority community vulnerable to violence. The rise of cow vigilante mobs correlates with he growing influence of Hindu hardliners in the past ecade. These groups operate with alarming impunity ften sidestepping law enforcement and judicial proesses. The fact that several of their leaders have found uccess in local politics in the past seven years raises roubling questions about the erosion of democratic priniples and the protection of minority rights. The governnent must act decisively to curb this menace before it urther destabilises social harmony.

### Ahmedabad Civil Hospital's resident doctors go on strike for higher stipends

Two days after the Gujarat government gave an approximately 20% raise in stipends to intern and resident doctors in all streams of medicine across the state with retrospective effect from April 1, 2024, the Junior Doctors Association (JDA) of BJ Medical College, associated with Ahmedabad Civil Hospital (CHA), has gone on strike to demand a 40% stipend hike instead of the 20%. The resident doctors of the Ahmedabad Civil Hospital have withdrawn all services, including emergency duties, citing the "bad faith" of the government who they claim had assured them a 40% raise in stipend. None of the other junior doctors' associations across 18 different medical colleges appear to have joined this strike. Meanwhile, the state government in a statement Sunday called the demands "unjustified", saying Gujarat is a "leader" in paying stipends to doctors. In a letter issued to authorities on Sunday, the JDA warned the government, "We have lost trust in the government. Hence we, all the students of BJ Medical College have been forced to stay away from all our duties on the path shown by Gandhi, from September

The letter said they had been making representations to the government for the past six months. According to these representations, the stipend of junior doctors is increased by 40% every three years. The last increase was on April 1, 2021 years of which were com three pleted on March 31, 2024. Hence, they said, their demand was for an increase of 40% in the stipend from April 1 onwards."In a meeting with the Health Minister on July 9, 2024, we were assured of a 40% increase in stipend. So the movement was postponed by trusting the democratic government. After 10 to 12 consecutive visits and the last six months of hard work and full faith in the Govt, (it) gave only an unsatisfactory increase of 20%," the letter read.Dr Dhaval Gameti, President of the JDA, remained unavailable for comment despite multiple attempts to reach him.Situation of public sector hospitals in Ahmedabad This has led to a critical situation, not just for patients at the Ahmedabad Civil Hospital which is the largest quarternary healthcare institution in western India, but also for patients at GMERS Sola Civil Hospital in Ahmedabad. GMERS Gandhinagar Civil Hospital and other private hospitals who send critical patients and those in need of super specialty treatment to this facility.Dr Rajnish Patel, the Deputy Superintendent of CHA, told the Indian Express, "We have suspended all non-emergency and postponed planned surgeries. All OTs have been suspended, and staff have been deployed in critical areas such as emergency and OPD areas. We have also advised other hospitals about the resident protest and to curtail the transfer of patients unless it is a very critical situation."Notably, other civil hospitals in Central and North Gujarat depend on Ahmedabad Civil Hospital to provide critical care and super speciality services. These include neurology, cardiology, nephrology, and oncology.Fortunately, the Medicity campus that houses the CHA also has separate, allied hospitals like UNMICRC for cardiology, IKDRC for kidney and liver diseases, and GCRI for cancer treatment. The Indian Express spoke to officials in other tertiary public sector hospitals who said they would manage the patients, but that the protest would impact healthcare in the state. Meanwhile, the state government issued a statement on Sunday night in response to the resident doctors. It stated, "The stipend of the state interns and resident doctors was increased by 20% on Saturday. Following this, the Junior Doctors Association has threatened to go on strike for a 40% stipend increase, which is completely unjustified. Their decision is inhumane at the expense of patient treatment. The practice of taking patients as hostages through this scam is totally unacceptable."The statement added, "The real situation is that among the states that give the highest stipend to resident doctors in the country, Gujarat is the leader compared to other states. In Gujarat, the stipend given to interns and resident doctors is completely tax-free while the salary of the professor teaching these resident doctors is taxed... A stipend of more than R s1 lakh was already given to resident doctors. Now, the government has increased it by 20% to Rs 1,30,000. Additionally, other states have three-year bonds, while Gujarat has a one-year bond."The statement said that the demand of resident doctors to "get a higher stipend than the professor teaching them" was "completely unjustified".

# Karnataka BJP leader Arun Puthila booked for sexually harassing woman

The Karnataka Police on Sunday booked BJP leader Arun Kumar Puthila for allegedly sexually harassing a 47-year-old woman. Puthila refuted the allegations and said it was a political conspiracy against him. In her complaint to the Dakshina Kannada police, the woman said the BJP leader sexually assaulted her at a hotel in Bengaluru between June 1 and 8. She said she had been impressed by the Hindutva ideology and had become his fan. She also said she used to support his words and

actions on social media."In June last year, he asked me to come to a hotel in Bengaluru where he sexually assaulted me. Later, he started blackmailing me and used to call me whenever he wanted. He physically and mentally exploited me, assuring me that he would provide everything needed for the betterment of my daughter's life," she said in her complaint. She also said he used to threaten to leak her photos and videos to get his work done by her. "He assured me to pay for the work that I had done but never paid." she added. Puthila contested as a rebel Independent candidate in the Karnataka Assembly polls last year after the BJP denied him a ticket from the Puttur Assembly seat. He lost by 4,149 votes to the Congress's Ashok Kumar Rai and later rejoined the BJP.The woman said he avoided her after the 2024 Lok Sabha elections. She also said she did not have money to pay rent or have a job. The Dakshina Kannada police registered a case under sections 417 (cheating), 354 (a) (sexual harassment) and 506 (criminal intimidation) of the Indian Penal Code (IPC) against him.A police officer said they consulted the legal team to transfer the case to the Bengaluru city police as the woman claimed that she was sexually assaulted in Bengaluru.

# 93 packets of Afghani charas seized across Gujarat coastal areas in past 22 days

Afghani charas seizure, Tithal beach drugs, Gujarat drug bust, coastal drug trafficking,On August 12 and 13, Valsad police recovered 32 packets of Afghani charas in beach areas near protection walls at Udvada and Dhanti-Bhagal village in Pardi taluka. Each packet weighed 1.18 kg and they were cumulatively worth around Rs. 19 crore. Valsad police seized a kilogram of Afghani charas lying abandoned on the banks of Tithal beach on Sunday. In the last 22 days, police in Surat, Navsari, and Valsad police have seized 93 packets of high-purity Afghani charas valued at over Rs. 56.46 crores from different seashores.

Acting on information from local passersby, Valsad police reached Tithal beach and discovered a packet on the ground beside a protection wall, near Sai Baba temple, on Sunday evening. Accompanied by FSL officials, police checked the material. The seized charas weighed 1.18 kg, being worth Rs. 58.60 lakh. Valsad rural police registered a case under different sections of the NDPS Act against unknown persons and have started a probe.On August 12 and 13, Valsad police recovered 32 packets of Afghani charas in beach areas near protection walls at Udvada and Dhanti-Bhagal village in Pardi taluka. Each packet weighed 1.18 kg and they were cumulatively worth around Rs. 19 crore. The Valsad district has 70 kilometres of coastal areas, and given such seizures recently, police have intensified coastal patrolling.

On August 15, Navsari police found 50 packets of high-purity Afghani charas lying abandoned in a fivekilometre stretch on the sea banks at Onjal village in the district. The value of the seized charas is Rs. 30 crore. Police had registered an offence against unknown persons.On the same day, as well as on August 14, Surat police seized 10 packets of Afghani charas worth Rs. 6.88 crore from the seashore banks in the Hazira area. Hazira police had also registered a case against unknown persons.With such large and frequent discoveries of charas, the state's Anti-Terrorist Squad officials are now coordinating with Special Operation Group police teams of Surat, Valsad, and Navsari in a probe.Valsad police officials said that the Afghani charas may be trafficked to some countries in a boat or ship. Consignment owners may have disposed of the charas into the water after spotting the patrolling of Navy and Coast Guard teams, resulting in these packets appearing on banks across South Gujarat, police said.

The accused were arrested under sections 189(2) (unlawful assembly), 191(2) (rioting), 190 (unlawful assembly in prosecution of common object), 126(2) (wrongful restraint), 115(2) (causing hurt), 324(4)(5) (mischief causing loss or damage), 351(2)(3)(criminal intimidation), and 352 (intentional insult with intent to provoke breach of peace) of the Bharatiya Nyaya Sanhita. They were picked up from Dhule as they had returned from Mumbai after the police recruitment test. The police said they were identifying other members of the group of men who assaulted the senior citizen.


## Daughter of small shop owner in a Punjab village makes it to IIT-Guwahati — with little push from an oil refinery

In 2023, Khushi enrolled in a local college after clearing her Class 12 board examination from a government school in a village in Punjab's Bathinda with flying marks. Khushi, whose father repairs mobile phones at a small shop in the Bhucho Kalan village, dreamt of studying engineering at elite institutions after watching the web series Kota Factory.Despite being a sharp student, she buried her dream due to a lack of resources. One day, on her way to college, she got the message that she had cleared the Super 100 programme run by Guru Gobind Singh Refinery in Bathinda to identify 100 underprivileged students and provide them coaching for the entrance exams to elite institutions. She is now a student of Civil Engineering at the Indian Institute of Technology (IIT), Guwahati.

"While studying in a government school, I never imagined I would get an opportunity to study at an institution like IIT. After being selected for the Super 100 programme, I took a gap year and went to Delhi for 11 months for residential coaching and cracked the exam. The refinery funded my stay, food, and tuition fees. Now, I am studying at ITI Guwahati. My father had a dream that I should become an engineer. Now, I am in a position to become one," said Khushi.She worked hard and cleared Joint Entrance Examination Mains and then JEE Advanced, and during counselling, she secured a seat at IIT Guwahati. She said she would be the first engineer in her family to study at a prestigious institution like IIT Guwahati.

Khushi is not the only one to be selected for Guru Gobind Singh Refinery's Super 100 programme. The refinery partnered with the Centre for Social Responsibility and Leadership (CSRL), Delhi, to participate in the National Super 100 programme for the underprivileged through education. After conducting a competitive exam among 600 students from 22 schools in the Bathinda district, the refinery selected eight students and sent them to CSRL in July 2023, where they received 11 months of residential coaching.



Harpreet Singh from the Burj Gil village was also among the eight students who were selected for the programme. He said after clearing his Class 12 from the government secondary school in Phool town, he dreamt of pursuing engineering, However, due to financial constraints and lack of guidance, he enrolled in a private college.It was a big surprise for him when he got selected for the Super 100 programme. He is now pursuing a Mechanical Engineering course at Dr B R Ambedkar National Institute of Technology (NIT) in Jalandhar. "My father works at a cold store. He has no idea what NIT is. But it was his hard work in life that motivated me to concentrate on my studies and crack the exam," said Singh.Sahil from Maur Mandi in Bathinda and Pawandeep Singh from Hasta Kalan village in Fazilka also have similar journeys. Like Harpreet, they have also selected for NIT, Jalandhar.

# Man who 'stole from Hanuman temple' dies by 'suicide' in police station in Gujarat

Two days after he was allegedly caught trying to steal articles from a Hanuman temple in Dhoraji town of Gujarat's Rajkot district, a 30-year-old man allegedly died by suicide inside Dhoraji police station on Sunday afternoon.The body of Kamlesh Parmar (30), a casual labourer and resident of Dhoraji town, was found inside the women's washroom in Dhoraji police station at around 3.30 pm on Sunday, police said.

"The head constable conducting an enquiry against Parmar noted that the suspect was not where he was asked to sit. He immediately checked the bathroom and found Parmar hanging. He was given CPR (cardio-pulmonary resuscitation) and an ambulance was called. As his pulse was detected, he was rushed to a hospital but doctors pronounced him dead," said Ravi Godham, police inspector (PI) in-charge of Dhoraji police station, to The Indian Express on Monday. The PI said that Parmar's death came two days after he was handed over to people by a group of people on Friday. "One Sandeep Gohil, a resident of Dhoraji, complained that Parmar had lifted tongs and other articles from the temple in the Kadiyavad area," Godham said."Parmar had a habit of drinking and committing petty theft to purchase liquor. During his questioning by Dhoraji police, he didn't get to drink and could have taken the extreme step because of this," the PI claimed.

He said that Parmar had been detained on August 28 in connection with a case of theft of mobile phones and cash, registered at Bhavnath police station in Junagadh. "We had also seized two mobile phones, believed to be stolen, from him. After that, we handed him over to Bhavnath police station. Apparently, he got bail in that case, returned to Dhoraji and attempted theft in the Hanuman temple," said Godham.Later on Friday, Dhoraji police had handed Parmar to his maternal uncle Jayantilal Vinjuda, who reportedly brought him back on Saturday and Sunday for questioning per instructions. Police said that Parmar used to live alone as his parents were no more and his wife had also become estranged from him. The PI said that CCTV cameras inside the police station have recorded Parmar's movement and that an inquest was done by a sub-divisional magistrate of Dhoraji in the presence of Parmar's family.

# Child killed, elderly woman injured in separate incidents of wolf attack in UP's Bahraich

### How a college rivalry escalated to the brutal murder of an IT engineer

On July 28 last year, Saurabh Nandlal Patil, who was working at a software firm in Pune, called his family in Shirdi to tell them that he was coming home. It was the last time the 23-year-old Information Technology (IT) engineer spoke to his family. Around eight days later, a forest guard who was on his night patrol in the Ghat section of the Sandbhorwadi area, off the Pune-Nashik Highway, found a decomposed body at around 5 am on August 5. An Aadhaar card and voter's ID helped the police identify it as that of Patil's. The autopsy showed he died due to injuries from a sharp weapon on his throat, chest abdomen, and blows from a blunt object on the back of the head, the autopsy revealed.Patil was a resident of the temple town of Shirdi in Maharashtra's Ahmednagar district and had completed his engineering degree. Months before he was killed, he appeared for the final exam of the MTech course from an engineering college in Pimpri Chinchwad.

His family members told The Indian Express at the time that Patil was known as a sincere and hardworking young man among his peers. According to the police probe, Patil started working for the private structural designing firm in Hinjewadi on June 6, 2023. However, he decided to leave in the last week of July as the company's work and his interests did not match. When Patil did not reach home and his phone remained reachable, his family contacted his friends, some of whom had been living with him in shared accommodation in Pimpri Chinchwad. When they could not be found, Patil's cousin lodged a missing complaint at the Hinjewadi Police Station on July 29.

The police investigation brought to light a bizarre and gory sequence of events. Patel was brutally mur-

dered by his college mate over their long-standing rivalry that had begun over a trivial incident during their college days. On August 10 last year, the police arrested Patil's college mate Mayur Sandeep Dalvi, 22, who belongs to Kopargaon in Ahmednagar. The next day, the police arrested Dalvi's accomplice Nishant Rajendra Zaware, 23, also from Kopargaon."With hardly any concrete clue from the spot where the body was found, we started meticulously working on the technical leads, mainly the phone records. We checked the call records of the deceased and started questioning some people. Questioning Saurabh Patil's classmate, Mayur Dalvi, uncovered numerous inconsistencies in his responses. His in-depth questioning and our parallel investigation revealed the sequence of events leading to Patil's murder," said an officer from the Khed Police Station who was part of the probe.

"When the two were at Sanjeevani College in Kopargaon, they had a dispute over glaring at each other. This rivalry continues and there were physical altercations too during the college days. The probe revealed that Dalvi and Patil were together on July 28, the day he went missing. Dalvi gave misleading answers initially. But later revealed that he had come to Pune in search of a job not very long before the incident. The two had decided to meet to settle their old dispute. The probe suggests that Dalvi and Zaware took Patio to the secluded place in Sandbhorwadi. During the fight, the two accused allegedly murdered Patil. We subsequently recovered the rock and knife used to murder Patil after the two accused were arrested," the officer addedA senior officer from Khed Police Station said a chargesheet in the case has been filed and court proceedings are underway.

My mother-in-law is a cancer patient; she was operated on four days ago. She is also at my home. I had informed the ED about this. They have been harassing me for two years, slapping false cases. They are harassing our party (AAP). Their objective is to break our party. I appeal to the people of Okhla to pray for me and I promise that we will get all your work done. Don't worry, we will not get scared," he said in the video. In another video, an elderly woman was seen lying on the bed as Khan asked a man at his door why the officials were there when he had sought four weeks to appear before the ED. "My mother-in-law has had surgery," he said. The man at the door asked why he thought they were there to arrest him. Khan said, "Why else are you here?" A woman, purportedly Khan's wife, then said, "What are you looking for in a three-room house... If something happens to my mother, I will take you to court.""This is the only job left for ED. Suppress every voice raised against BJP. Break it. Arrest and put in jail those who do not break or get suppressed," senior AAP leader Manish Sisodia posted on X.

# Karnataka consumer court orders SBI to waive off of **Rs 4.09 lakh transaction, says bank failed to respond to** customer complaint in credit card fraud case

Manikanta then went to Mangaluru's Crime Branch Police station and the police called the credit card department of SBI and enquired about the transaction.Manikanta then went to Mangaluru's Crime Branch Police station and the police called the credit card department of SBI and enquired about the transaction.A consumer court in Karnataka has ordered the State Bank of India (SBI) to quash the credit card transaction and penalty of a customer, saying the bank failed to respond to his complaint of cyber fraud on time. On August 28, the Dakshina Kannada District Consumer Disputes Redressal Commission in Mangaluru observed in its order that service was deficient on the part of the state-run bank.

Manikanta, 36, a resident of Belthangady, said he received a call on April 11, 2023, from an unknown number from a caller claiming to be from the SBI customer care department. According to Manikanta, the caller told him that his SBI credit card was blocked and instructed him to cancel the activation. The caller also asked him for his credit card number, CVV number, and OTP number, said Manikanta.

After Manikanta shared the details, Rs 3.60 lakh was transferred from his account without his knowledge. On April 12, 2023, the same person called him to say that his credit card bills were pending and instructed him to deposit the said amount.Manikanta then went to Mangaluru's Crime Branch Police station and the police called the credit card department of SBI and enquired about the transaction. The SBI staff told the police no such transaction had taken place from the bank. After checking again on April 18 at 6 pm, the credit card department replied that there was no transaction but at 7 pm, the same staff informed Manikanta that there was a transaction.Manikanta later filed a FIR at the CEN Police Station in Mangaluru saying his credit card had insurance of up to Rs 2 lakh but SBI's Belthangady branch had given him a credit card limit of Rs 5 lakh and insured only for Rs 2 lakh instead of Rs 5 lakh. Manikanta also contended that SBI's credit card collection team repeat-



edly called him from different numbers demanding him to pay Rs 4.09 lakh or threatened to release the amount of Rs 11 lakh which he had as a fixed deposit in the same bank.In its submission to the court, SBI refuted Manikanta's claims that it threatened him it would release his fixed deposit money but said the pending repayment was put on hold. The bank also claimed that Manikanta had shared the credentials like OTP due to his negligence and there was no such deficiency in service on its part.

In its order, the consumer court cited the Reserve Bank of India (RBI)'s guidelines of customer protection limiting the liability of customers in unauthorised elec-tronic banking transactions. "Third-party breach where the deficiency lies neither with the bank nor with the customer but lies elsewhere in the system, and the customer notified the bank within three working days of receiving the communication from the bank regarding the unauthorised transaction," said the order.

The court said the credit card department was informed about the calls on April 12, 2023, which was within the stipulated RBI guidelines of three days, and the complainant has 'zero liability'. Citing service was deficient from the bank, Somashekarappa K Handigol, president, said in his order that SBI must quash the alleged transaction in the complainant's account as well as the interest and penalty. He also directed the bank to pay Rs 20,000 for deficiency of service, mental agony, and inconvenience caused and Rs 10,000 towards litigation costs.

# highlights problems faced by DTC workers

Congress leader Rahul Gandhi on Monday released a video of his interaction with the Delhi Transport Corporation (DTC) bus drivers and conductors, highlighting that they were "constantly living under the fear of privatisation" with "no stable income or permanent job"."No social security, no stable income and no permanent job - contractual labour has reduced a job of great responsibility to a state of compulsion," wrote Gandhi on his social media.

"Troubled by this neglect, DTC workers, like government employees across the country, are constantly living under the fear of privatisation. These are the people who run India, who facilitate the travel of millions of commuters every day - but all they have got in return for their dedication is injustice," Gandhi stated on Facebook.The video started with Gandhi taking an Uber ride with a driver whom he had previously met. After introducing him to his mother, Gandhi travelled with him to the Sarojini Nagar Bus Depot, where he had interacted with DTC drivers, conductors, and marshals the previous Wednesday.During the interaction with the Delhi Transport Corporation (DTC) bus drivers, Gandhi inquired about their work hours. The drivers responded that they are supposed to work eight hours, but often end up working around two hours extra.

#### gress leader then asked if they are permanent employees, to which they reply negatively, stating that they are all temporary employees. "How much money do you get and how much does the contractor get?" Gandhi asked.

There is no contractor. It is only us and DTC. But we get Rs 813 per day, which also includes our PF deduction. Additionally, we don't get any rest days, not even on Holi or Diwali. Our salary is cut on days we take rest,' explained one of the DTC drivers.Gandhi inquired about how he can help them, to which the drivers responded with their need for permanent employment and timely salaries. "Our salaries have not been paid for 5 months. The state and centre are playing the blame game,. They say funds have not been released. They have further stated that salaries won't be credited for 2 more months. This is affecting our families; if we can't pay our children's fees or admit them to school, their futures will be destroyed," a DTC driver said.A conductor from the DTC added during the interaction that they work on a contractual basis, with their contracts renewed annually. "If our duty hours are reduced, they don't renew the contract,' he said."Our demand is to make our jobs permanent. Samaan vetan aur samaan kaam hona chahiye (We want equal work, equal pay). "Why is our citizenship permanent but our jobs temporary? Why is there so much privatisation?" another DTC conductor asked.Gandhi questioned, "With all this privatization, who is benefiting?" "Only the job holders," someone replies."Modi ji has worsened the situation. He has eliminated the distinction between a literate and an illiterate person. A labourer earns 18-20k, while an educated person earns 25k. We are common people. Even after educating our children, they are earning only 25-30k," said a worker from the DTC workshop. When Gandhi asked if they are able to save money, they said no.He also inquired if they have bus passes, and they responded that they do not; they have to pay for their travel. He then took a bus ride and asked the conductor present about his family and his job life. The collector mentioned that he is also contract labour, with his contract renewed by DTC every year. "We want to secure our future and need permanent jobs," he concluded.

### They lost 53 students to Wayanad landslides. A month later, 2 schools destroyed in the disaster start classes again

Over a month after landslides destroyed their schools, around 600 students on Monday returned to classes at Meppadi panchayat in Kerala's Wayanad district. Many of them lost loved ones and all their belongings in the disaster. The calamity also claimed several of their schoolmates - 53 students from two schools in the hardest-hit Mundakkai and Chooralmala villages died in the landslides. The two destroyed schools - Government Vocational Higher Secondary School, Chooralmala, and Government Lower Primary School, Mundakkai - have a combined 614 students. Classes for students from the Chooralmala school are now being held at the Government Higher Secondary School at Meppadi. The lower primary students of the Mundakkai school are attending their classes at a Meppadi community hall.

A part of the Government Higher Secondary School in Meppadi, where the classes for the Chooralmala school will be held A part of the Government Higher Secondary where the classes for the School in Meppaai, Chooralmala school will be held. With the students still reeling from the trauma of the disaster, officials said there will be no mention of the landslides in the initial classes. The landslides that struck the area in the early hours of July 30 buried or washed away nearly everything from the villages. They left at least 231 dead and 78 missing.Nobody now lives at Mundakkai and Attamala villages, while a handful of survivors continue to stay in Chooralmala. Most of the survivors from these villages, including the school children, were lodged at relief camps for the large part of the last month. Recently, they have been moved to rented facilities around Meppadi and other nearby panchayats. On Monday, the state Education Department arranged a 'pravesanolsavam', or back-to-school celebration - usually held in schools across Kerala at the beginning of every academic year - for students of the Mundakkai and Chooralmala schools. The classrooms wore a festive look, and many of the students turned up in the new uniforms provided by the government. They also got new study materials as most had lost theirs in the landslides. The Chooralmala school's headmaster, Unnikrishnan, said the resumption of classes would help the students get to grips with their new lives in the aftermath of the loss and trauma of the disaster.

## **Centre approves Rs 2,817-crore mission to create** digital public infrastructure in farm sector

The Centre on Monday approved the Rs 2,817-crore Digital Agriculture Mission for the creation of digital public infrastructure in the farm sector by building AgriStack to provide solutions like an Aadhaar-like unique ID for farmers, a crop sown registry and geo-referenced village maps, and implementing the Digital General Crop Estimation Survey (DGCES).A proposal of this effect was approved by the Union cabinet, which met under the chairmanship of Prime Minister Narendra Modi. The mission will be launched as part of the agriculture ministry's activities planned for the first 100 days of Modi 3.0.

A budgetary allocation of Rs 2,817 crore has been made for the mission, and Rs 1,940 crore of it will be provided by the Centre. The mission will be rolled out nationally over the next two years (till 2025-26). It was initially planned to be launched in the financial year 2021-22 but could not be rolled out because of the Covid outbreak, said a source. Later, the Government announced the building of digital public infrastructure for agriculture in the Union Budgets 2023-24 and 2024-25."Buoyed by the success of the pilot project, our government, in partnership with the states, will facilitate the implementation of the digital public infrastructure (DPI) in agriculture for coverage of farmers and their lands in three years. During this year, a digital crop survey for kharif using the DPI will be taken up in 400 districts. The details of 6 crore farmers and their lands will be brought into the farmer and land registries," Finance Minister Nirmala Sitharaman said, announcing Digital Public Infrastructure for Agriculture in her Budget speech on July 23.According to sources, three DPI projects will be undertaken as part of the mission. These are Agristack, Krishi Decision Support System, and soil profile mapping. AgriStack consists of three foundational registries or databases in the agriculture sector-the farmers' registry, geo-referenced village maps and the crop sown registry, all created and maintained by the state governments or Union Territories

Under AgriStack, farmers will be given a digital identity similar to Aadhaar, which will be linked dynamically to the state's land records, livestock ownership, crops sown, demographic details, family details, schemes and benefits availed of etc.For the creation of unique farmer IDs, pilots have been conducted in six districts-Farrukhabad (Uttar Pradesh), Gandhinagar (Gujarat), Beed (Maharashtra), Yamuna Nagar (Haryana),

Fatehgarh Sahib (Punjab), and Virudhunagar (Tamil Nadu), said a source.

The sources said the Government aims to create digital identities for 11 crore farmers, of which six crore farmers will be covered in the financial year 2024-25, three crore in 2025-26, and two crore farmers in 2026-27. The crop sown registry will have the details of crops planted by farmers. This will be recorded through mobile-based ground surveys, or digital crop surveys, in each season. The Krishi Decision Support System, launched recently, will create a comprehensive geospatial system to unify remote sensing-based information on crops, soil, weather, water resources, etc. Under the mission, detailed soil profile maps on a 1:10,000 scale of about 142 million hectares of the country's agricultural land are envisaged to be completed. A soil profile inventory of about 29 million hectares has already been completed, said a source. The source said the Digital General Crop Estimation Survey would provide yield estimates based on scientifically designed crop-cutting experiments. This will prove very useful in making accurate estimates of agricultural production, the source added

#### There is not a single student unaffected by the tragedy, the headmaster said. Some items from the affected schools survived the landsides, and were brought to the new makeshift premises. These include some library books, lab equipment, and furniture. The government also distributed new 'school kits' to the students, including study material and uniforms.A family's lone survivorOne of the surviving students who did not turn up on the first day was Avanthika Prashob. The class 3 three student was the lone survivor from her family. She lost her parents Prashob and Vijayalakshmi, as well as elder brother Ashwin, who was also a student at the Chooralmala school, in the landslides. Avanthika, who was injured, was discharged from hospital only last week. She is now with Pradeep, her father's brother. "We have not informed her about the loss of her parents and brother. We told her they are at the hospital and can't meet her. She often insists on making video calls to talk to them, but we then distract her attention to some other subject," said Pradeep.He said counsellors had asked him not to inform Avanthika about her parents' death and that they would do it when the time is right. The night of the landslide was traumatic for her, and she does not like it when people speak about it, Pradeep said.

### Couldn't meet Mamata, Abhishek for a year, says TMC's Assam chief while resigning

Assam Trinamool Congress (TMC) president Ripun Bora resigned on Sunday, citing the primary reason being the perception that the state unit was a "regional party of West Bengal", which hindered its progress.Bora had left the Congress to join the TMC in April 2022, as the state party president. In his resignation letter - addressed to TMC national general secretary Abhishek Banerjee — Bora mentioned that "several recurring issues have been hindering" the state party's progress.

Highlighting that he had not been given an audience by either Abhishek Banerjee or Mamata Banerjee to address this issue, Bora wrote: "To counter this perception, we have made several suggestions such as the need for an Assamese leader at the national level, declaring the residence of Bharat Ratna Dr Bhupen Hazarika at Tollygunge a heritage site, and converting the Madhupur Satra at Cooch Behar (from where Assam's greatest social reformer Mahapurush Sankar Dev started the Vaishnavite movement) into a cultural hub. Despite my repeated attempts over the past year-and-a-half to secure an appointment with you (Abhishek Banerjee) and our Chief, Mamata Didi, to address these concerns, I have been unsuccessful."Noting that he was "compelled" to disassociate from the party because of this perception, Bora further said: "Unfortunately, the issues mentioned above have led many people in Assam to continue viewing the TMC as a regional party of West Bengal. The people of Assam are not willing to accept a party that they perceive as being from another state. In the light of these challenges and lack of an adequate resolution, I feel compelled to make a difficult decision... I have decided to disassociate myself from the TMC."Since 2022, Bora has been the only prominent face of the party in Assam's Brahmaputra valley, while another former Congress leader, Sushmita Dev, represents the party in the primarily Bengali-speaking Barak valley. The TMC made its Lok Sabha debut in Assam this year and contested in four seats, bagging the third place in Silchar, fourth in Barpeta and Lakhimpur, and sixth in Kokrajhar.While Bora is from the Brahmaputra constituency, the TMC's focus has also been on building support for itself in the Barak valley.







# Firing reported outside singer AP Dhillon's Canada home, a warning in viral post

The Lawrence Bishnoi gang has claimed responsibility for the shooting outside Punjabi singer AP Dhillon's house in Canada. The attack comes weeks after Dhillon released a music video, featuring actor Salman Khan.A shooting incident was reported outside Punjabi singer and rapper AP Dhillon's house in Canada's Vancouver, sources told India Today TV. Though an official confirmation regarding the same is awaited, sources claimed that gunfire was heard near the singer's home in Victoria Island area on Sunday night.The Lawrence Bishnoi-Rohit Godara gang has claimed responsibility for the shootings.Notably, the attack came weeks after AP Dhillion released a music video "Old Money", featuring Salman Khan. The threat message circulating on social media claimed that on the night of September 1, the gang orchestrated shootings at two locations in Canada — one on Victoria Island and the other in Woodbridge, Toronto.

The gang has also threatened AP Dhillon, referencing his alleged connections with Bollywood actor Salman Khan, and warns him to "stay within his limits, or he will meet a "dog's death". Meanwhile, the Canadian law enforcement agencies are currently investigating the authenticity of the post and the facts surrounding the shootings. No official statement has been released by the police.In November 2023, Lawrence Bishnoi claimed responsibility for a reported shooting incident at singer Gippy Grewal's residence in Vancouver, Canada. The alleged incident occurred in the White Rock neighbourhood.Later in April 2024, two bike-borne men, linked with the Bishnoi gang, opened fire outside Salman Khan's residence at the Galaxy Apartment in Mumbai's Bandra area and fled the spot. The National Investigation Agency (NIA) has revealed that Salman Khan is the top target on a list of ten individuals that jailed gangster Lawrence Bishnoi intended to eliminate. The gangster's motive stems from Salman Khan's alleged involvement in the 1998 black buck hunting incident, which the Bishnoi claims deeply offended his community.

# British-Indian Labour MP accused of renting flats infested with fleas, ants

A BBC investigation found tenants living in dire conditions at 15 properties rented out by Jas Athwal, a 60year-old British-Indian Sikh Labour MP for Ilford South. Athwal has been accused of being a "slum landlord".

A BBC investigation has revealed that tenants in properties owned by Jas Athwal, a British-Indian Sikh Labour MP, were living in dire conditions, plagued by mould, fleas and ants. The newly elected, 60-year-old Indian-origin MP has been accused of being a "slum landlord". The BBC investigation revealed that tenants in some of Athwal's 15 rental properties in London were living in some of the worst conditions possible. As the owner of these 15 flats, Athwal is the biggest landlord in the UK House of Commons.Athwal, who was born in Punjab and moved to Ilford with his family in 1970, has been a councillor since 2010 and previously served as the leader of the Redbridge London Borough Council in the UK.A BBC reporter visited flats owned by Athwal above a shop in Redbridge, East London, and found black mould on bathroom ceilings, ant infestations, broken lights, and fire alarms hanging loose. A washing machine was even dumped near the stairs."The ants are everywhere," one tenant described, pointing to the insects crawling up a door frame. Tenants said their complaints to Athwal and his property agent were ignored, and they feared eviction if they spoke out. Athwal has now acknowledged that his flats lack the proper property licences required under a scheme he himself implemented while leading Redbridge Council.Initially, he had told the BBC that he was in compliance with the regulations.Paul Canal, the leader of Redbridge Conservatives, has called for an investigation into potential breaches of the code of



#### conduct by Athwal.

"I'm proud to rent out homes with secure tenancies at below-market rents. I'm shocked at the reported condition of a number of the properties and have asked the managing agent for an explanation and immediate action to rectify any issues. I'm profoundly sorry that tenants have been let down. Repairs and maintenance will be done swiftly. I am in the process of renewing all licences, Athwal was quoted as saying by the BBC. Ironically, Athwal had previously tweeted in October 2018, "Rogue landlords, we are coming for you."On September 1, Athwal tweeted an apology for the inconvenience. He also stated he would conduct a "survey of my tenants" and "will reimburse every tenant that is out of pocket for repairs or renewals"."I will be reimbursing every tenant that is out of pocket for repairs or renewals they have had to undertake. I will be conducting a survey of my tenants, so that all issues are uncovered and I am confident each one is living in secure, comfortable homes," Athwal added.

# Ukraine claims of destroying Russian missiles, drones, air raid sirens sounded

Ukraine's air defence units destroyed more than 10 cruise missiles and nearly 10 ballistic missiles, the city's military administration said on the Telegram messaging app.Russia pounded Ukraine's capital of Kyiv with missiles early on Monday, while falling debris from the downed weapons injured at least two people, sparking fires and damaging homes and infrastructure, officials said.Ukraine's air defence units destroyed more than 10 cruise missiles and nearly 10 ballistic missiles, the city's military administration said on the Telegram messaging app.

Air raid alerts went out across Ukraine for nearly two

hours before the air force declared the skies clear at 0330 GMT. Neighbouring NATO member Poland activated Polish and allied aircraft to keep its airspace safe during the attacks.A boiler house at a Kyiv water plant was partially damaged as was the entrance to a metro station doubling as a bomb shelter in the Svyatoshynksyi district, Kyiv's Mayor Vitali Klitschko said on Telegram, though the station still operates. The district is home to a cluster of universities and schools. The attack injured at least two people, Klitschko said. Cars were set ablaze across the city as well as a non-residential building in the Shevchenkivskyi district, he added. Emergency services also went to the districts of Svyatoshynksyi, Holosiivskyi, and Solomyanskyi, where debris fell from destroyed missiles, Klitschko added.Solomyanskyi is home to a major train station and Kyiv's main airport. The historic neighbourhood of Svyatoshynksyi is on the city's western edge, while Holosiivskyi is in its southwest.Reuters' witnesses in Kyiv heard a series of loud explosions in what sounded like the work of air defence units, some in the central area.

The attack came exactly a week after Moscow launched more than 200 missiles and drones on Ukraine, killing seven people and striking energy facilities nationwide in what Kyiv called the war's "most massive" attack.Russia denies targeting civilians in the 30-monthold war unleashed by Moscow's invasion of its smaller neighbour.

## **Ex-child care worker in Australia pleads guilty to raping girls for 19 years**

Police accused the 46-year-old of being one of Australia's worst ever paedophiles after the charges against him were made public last year. Accused was first arrested in 2022 for making child sexual abuse content. A year later he was charged with 1,623 offences against 91 children. Former childcare worker Ashley Paul Griffith on Monday pleaded guilty to raping, sexually abusing and exploiting dozens of girls under his care in Australia and Italy.

It took Judge Anthony Rafter more than two hours to read out the 307 charges against Griffith in the Brisbane courtroom where several victims and their families had gathered, according to state broadcaster ABC.Police accused the 46-year-old of being one of Australia's worst ever paedophiles after the charges against him were made public last year.Griffith was first arrested in 2022 for making child sexual abuse content. A year later he was charged with 1,623 offences against 91 children.However, some charges were dropped, and the ABC reported that Monday's charges related to roughly



60 children. Many of the victims were under the age of 12.The offences happened between 2003 and 2022 in twelve different locations across Australia as well as Pisa, Italy.Griffith is in custody and will be sentenced at a later date. The court heard sentencing could take more than two days to give time to read victim impact statements, the ABC reported.

### Nationwide protest in Israel over hostages leads to uneven closures

A rare call for a general strike in Israel to protest the failure to return hostages held in Gaza led to closures and other disruptions around the country on Monday (September 2, 2024), including at its main international airport. But it was ignored in some areas, reflecting deep political divisions. Tens of thousands of Israelis had poured into the streets late Sunday in grief and anger after six hostages were found dead in Gaza. The families and much of the public blamed Prime Minister Benjamin Netanyahu, saying they could have been returned alive in a deal with Hamas to end the nearly 11-month-old war.

# **Canada's 24-hour work limit to strain finances of Indian students**

Indian students in Canada, the largest group of international students, will face financial strain due to a new rule restricting off-campus work to 24 hours a week. This rule, which takes effect this month, would make it difficult for students to cover living costs in cities like Toronto.Canada has introduced a maximum of 24 hours per week for off-campus work for international students. It is aimed at making students prioritise studies over employment opportunities. (Photo: Immigration.ca)ndian students in Canada, who form the largest group of international students, are expected to face significant financial challenges due to a new federal rule limiting them to 24 hours of off-campus work per week. This new rule, which takes effect this month, replaces the temporary waiver of the 20-hour cap on work hours that was introduced during the Covid-19 pandemic to ease labour shortage. The waiver expired on April 30. There are no restrictions on work hours during school breaks, such as summer or winter breaks, in Canada for international students.In 2022, 2.26 lakh of 5.5 lakh international students in Canada were from India, with 3.2 lakh Indians staying in Canada on student visas and contributing to the economy as gig workers.Off-campus jobs help Indian students with paying for their groceries and accommodation.With most standard work shifts being 8 hours long, the new rule

means students can only work up to three part-time shifts per week, making it difficult for them to cover their expenses.Indian students help the Canadian government maintain the minimum wage, which is now set at 17.36 Canadian dollars per hour, effective from May. Before this increase, the minimum wage in 2023 was \$16.65 per hour.However, the 24-hour limit is expected to make it challenging for them to afford living costs in high-expense cities like Toronto.STUDENTS' CONCERNS AND ADJUSTMENTSNeeva Phatarphekar, an international student in Toronto, expressed concerns about managing her rent, groceries, and travel under the new rule."That's going to be hard with the rent in Toronto and the groceries and eating out with friends and travelling. I have to think about all of that," she told CBC News.Phatarphekar has already cut down on expenses and moved in with friends to save on rent. She was studying for a public relations certificate at York University but will now be studying brand management at Seneca College.Deepa Mattoo, executive director and lawyer at the Barbra Schlifer Commemorative Clinic, emphasised that international students work out of necessity."Not every student can afford to go to school without that extra income. In any structure, you have to have an equity framework," Mattoo told CBC News.However, Moshe Lander, an economics professor at Concordia University in Montreal.

But others support Mr. Netanyahu's strategy of maintaining relentless military pressure on Hamas, whose October 7 attack into Israel triggered the war. Municipalities in Israel's populated central area, including Tel Aviv, were participating in the strike, leading to shortened school hours and cancellations for public daycares and kindergartens.Many municipalities, however, including Jerusalem, were not participating in the strike. Israeli media reported that the state appealed to a labor court to cancel the strike, saying it was politically motivated.Demands to Netanyahu

The demonstrations on Sunday appeared to be the largest since the start of the war, with organisers estimating that up to 500,000 people joined nationwide events and the main rally held in Tel Aviv. They are demanding that Mr. Netanyahu reach a deal to return the remaining roughly 100 hostages held in Gaza, a third of whom are believed to be dead, even if it means leaving a battered Hamas intact and withdrawing from the territory. Many Israelis support this position, but others prioritise the destruction of the militant group over freedom for the hostages.Mr. Netanyahu has pledged "total victory" over Hamas and blames it for the failure of the negotiations, which have dragged on for much of this year. Israel said Hamas killed all six hostages shortly before Israeli forces arrived in the tunnel where they were being held. Three of them, including an Israeli-American, were reportedly scheduled to be released in the first phase of a cease-fire proposal discussed in July. The Israeli Health Ministry said autopsies had determined the hostages were shot at close range and died on Thursday or Friday.Mr. Netanyahu blamed Hamas, saying "whoever murders hostages doesn't want a deal."

Hamas blamed their deaths on Israel and the United States, accusing them of dragging out the talks by issuing new demands, including for lasting Israeli control over two strategic corridors in Gaza. Hamas has offered to release the hostages in return for an end to the war, the complete withdrawal of Israeli forces and the release of a large number of Palestinian prisoners, including high-



profile militants. One of the six hostages was Israeli-American Hersh Goldberg-Polin, 23, a native of Berkeley, California, who lost part of his left arm to a grenade in the attack. In April, Hamas issued a video that showed him alive, sparking protests in Israel.He was one of the bestknown hostages, and his parents had led a high-profile campaign for the captives' release, meeting with President Joe Biden, Pope Francis, and addressing the Democratic National Convention last month.Some 250 hostages were taken on October 7. Israel now believes about 100 remain in captivity, including 35 who are thought to be dead. More than 100 were freed during a ceasefire in November in exchange for the release of Palestinians imprisoned by Israel. Eight have been rescued by Israeli forces. Israeli troops mistakenly killed three Israelis who escaped captivity in December.

Russia bombards Kyiv with drones, cruise and ballistic missiles

Kyiv: Russia launched a barrage of drones, cruise and ballistic missiles at Kyiv and possibly other cities, Ukraine's Air Force said early Monday. Several series of explosions rocked the Ukrainian capital in the early hours of Monday, sending residents into bomb shelters.Kyiv Mayor Vitalii Klitschko said emergency services were called to the Holosiivskyi and Solomianskyi districts of Kyiv. One person was reportedly injured by falling debris in Shevchenkivskyi district, Klitschko said."There will be an answer for everything. The enemy will feel it," the head of the Presidential Office, Andrii Yermak, posted on his Telegram page following the attack.According to the air force, Russia fired several groups of cruise missiles accompanied by ballistic missile launches and a few drones, targeting Kyiv.









### Cabinet approves Rs 3,300 crore chip assembly plant by Kaynes Semicon in Gujarat

Gujarat chip assembly plantIndia has ambitions to become a major chip hub on the lines of the United States, Taiwan and South Korea, and has been courting foreign companies to set up operations in the country. The Union Cabinet Monday cleared a semiconductor assembly and testing plant being set up by Kaynes Semicon at a cost of Rs 3,300 crore. This is the fifth semiconductor unit, and the fourth assembly unit, to receive Cabinet approval under India's ambitious Rs 76,000 crore chip manufacturing incentive scheme.

"The capacity of this unit will be 60 lakh chips per day... The chips produced in this unit will cater to a wide variety of applications which include segments such as industrial, automotive, electric vehicles, consumer electronics, telecom, mobile phones, etc." the Ministry of Electronics and IT (MeitY) said in a statement. The plant will be constructed in Sanand, Gujarat. It is understood that the plant was initially to come up in Telangana, but was moved to Gujarat, after the government indicated that Sanand was coming up as a cluster for chip assembly plants. It is also learnt that the government's subsidy towards the plant will be around Rs 1,300 crore.India has ambitions to become a major chip hub on the lines of the United States, Taiwan and South Korea, and has been courting foreign companies to set up operations in the country. Previously, the country has approved a fabrica-

tion plant worth \$11 billion being set up by Tata Electron ics in partnership with Taiwan's Powerchip, and three different chip assembly plants being set up by the Tatas, US-based Micron Technology, and Murugappa Group's Power in partnership with Japan's CG Renesas.Currently, there are more proposals to set up semiconductor units with the government. This includes a Rs 78,000 crore fabrication plant proposed by Israel's Tower Semiconductor, and a Rs 4,000 crore assembly plant by Zoho.After having committed nearly all of the \$10 billion in subsidies under its ambitious semiconductor manufacturing incentive policy, the government has prepared a blueprint for the second phase of the scheme - it could increase the outlay of the programme to \$15 billion, offer capital support for raw materials and gases used in chip manufacturing, and reduce subsidies for assembly and testing plants, The Indian Express had earlier reported. In an internal note prepared with the projections for the renewal of the scheme, the government has also decided to reduce the capex subsidy for assembly and testing plants (ATMP/OSAT) from the current 50 per cent to 30 per cent for conventional packaging technologies, and 40 per cent for advanced packaging technologies. The government also does not want to support technology transfer costs under the new incentive scheme, it is understood. This means that companies partnering with others for using their chip manufacturing technology may have to pay out of their own pocket. Under the new scheme, the government could also offer capital equipment and ecosystem support such as gases, chemicals, and raw materials needed at assembly and testing plants. It could also look at incentivising fabrication of micro-LED displays.It is also learnt that Micron Technology's ATMP plant in Gujarat's Sanand is running 133 days behind schedule, due to the company's inability to hire sufficient construction headcount. The Tatas have sought that the requirement for PSMC to demonstrate capability to manufacture 28 nanometre chips should be exempted for extending fiscal support for the node. The government is considering the company's request, but has not come to a conclusion yet.

# Single filing with exchange to be reality very soon: Sebi chief

Capital markets regulator Sebi Chief Madhabi Puri Buch on Monday said a single disclosure by listed companies on one stock exchange will soon be automatically uploaded on the other bourse. This comes after the Securities and Exchange Board of India (Sebi) recently proposed sweeping changes to disclosure as well as listing requirements by listed companies based on recommendations from a committee led by S K Mohanty, former whole-time member of Sebi.Speaking at a CII event, Sebi chairperson said, "a single filing with the exchange will be a reality very soon". As part of the proposed changes, a filing made on one exchange will automatically collate on the other exchange, she said. A filing made on one exchange will automatically collate on the other exchange.

Additionally, Buch said soon investors will be able to start SIP (Systematic Investment Plan) with as low as Rs 250 per month. "We are on the way of Rs 250 SIP becoming a reality," she said.Buch avoided commenting on Real Estate Investment Trusts (REITs), but said there are regulations simplifying such entities. "If I utter a word on REITs, I will be accused of conflict of interest," she added.The remarks came as US short-seller Hindenburg



Research raised questions about a potential conflict of interest involving Buch and private equity major Blackstone.Her husband Dhaval Buch is a senior advisor with Blackstone, a major player in the REIT space. However, the couple refuted the allegations.Also, Hindenburg alleged that Sebi's recent amendments to REIT regulations 2014 favoured a specific financial conglomerate, which Sebi denied.The Sebi chief highlighted plans to make IPO documents available in multiple languages to remove language barriers and increase investor awareness.



Known as Hindi cinema's 'original glam diva,' the 72year-old faced a failed marriage, and failed relationships. In 1978, Zeenat Aman's name was attached to Sanjay Khan, who was already married and had four children. Their relationship ended publicly in 1979 after he allegedly assaulted her. Later, in 1985, she wed actor Mazhar Khan, but their relationship ended more than a decade later and Mazhar passed away in 1998. The marriage was admittedly thorny.

"Perhaps I have bored you with this pontification, but it is followed by this one earnest wish - that each of you finds meaningful relationships, romantic or otherwise, to add brilliance to your lives," she concluded, extending her best wishes to her fans. ### World No.1 shuttler Nitesh Kumar beats Brit Bethell for first time to clinch biggest title of career

By beating Jimmy Connors in the Masters Championships at Madison Square Garden in 1980, Gerulaitis ended a long streak of losses. Connors had got the better of him 16 times in a row. Gerulaitis said, "Nobody beats Vitas Gerulaitis 17 times in a row."

It is hard to say if something similar came to Nitesh Kumar's mind after he beat Daniel Bethell of Great Britain in the gold medal match of Men's Singles SL3 Badminton at the Paris Paralympics on Monday. But the sentiment could have been similar. Nobody beats Nitesh Kumar 10 times in a row, perhaps. The Indian, who had not defeated Bethell in their nine past meetings, found a way in the biggest match of his life. Nitesh beat Bethell 21-14 18-21 23-21 in an 80-minute thriller to win India's second gold medal of the Paris Games. Intriguingly, world No 1 Nitesh came into this match as the underdog against world No 2 Bethell. Indeed, it was not lost on Nitesh, who had spoken after his semifinal about not being able to find a way against the Brit in the past. "I haven't won against him yet, but we've had some interesting games," he had said. "I don't want to think about the final at all. I don't want to stress myself out or waste the night's sleep thinking about it because that will spoil my recovery."

And whatever he did worked like a treat. For the most part. The final began as most top matches in SL3 para badminton category do. "Standing Lower 3" refers to the category for players with severe lower limb disabilities and matches are played on only half the court,

with the centre line acting as the out-line. In the restricted space, it is not easy to manufacture winners, and it requires a whole lot of patience, fitness and a sprinkling of creativity to find angles. Then came a marathon rally after the mid-game interval when they extended the point to 162 seconds and 122 shots. The point eventually went to Bethell, who let out a big roar, but it proved to be a turning point for Nitesh.

After a brief breather, the 29-year-old Indian switched up his tactics, and started using his variations more. A wonderful stroke-player, Nitesh had been trusting his defence till that point but the smashes and reverse-slice drops kicked in as he raced through to take the opening game 21-14. The second game was much tighter and a proper back-and-forth affair till the very end. Nitesh missed a big chance to take a 19-17 lead with Bethell stranded on the court, but sent a lift long. Bethell then closed it out from there, put up his arm and let out a roar, as the match was back in the balance. The third game too was on a knife edge for the most part but at 15-10 it seemed Nitesh had things under control with Bethell showing signs of frustration. But the Tokyo silver medallist fought back once more, and both men had match point opportunities that were saved. In the end, it was Nitesh who took the decider 23-21.

"Even before stepping onto the court, I knew it was going to be a mental game. I just wanted to keep calm and that worked for me in the first game," Nitesh said after the match. "In the second game, I was leading and then somewhere in between I lost my focus and got too eager to get points. That is when he played some amazing points. In the third, it was very close. I got some good points, he got some good points, but in the end I knew it was going to be mental and I could keep my calm and pull it off."A train accident in 2009 in Vizag left Nitesh bedridden for months and resulted in permanent leg damage. But during his time pursuing Electrical Engineering at IIT-Mandi, he developed a love for badminton. And in Paris, he problem-solved his way like a good engineer, beating his bugbear Bethell when it mattered the most.

# Discus thrower Yogesh Kathuniya was diagnosed with a neurological disorder at 9, now he is a two-time Paralympics silver medallist

Discus thrower Yogesh Kathuniya's parents wanted him to become a doctor, but there was a twist of fate when at the age of 9 he fell in a park and could not stand up. The doctors said he had Guillain-Barre Syndrome, a neurological disorder that hampers body movement and results in muscle weakness . He may not be able to walk again, they felt. But after years of treatment, including physiotherapy, he could stand using a crutch. The 27year-old's second medal in the discus, a silver on Monday at the Paralympics in Paris to go with his silver in Tokyo three years ago, is a testament to his grit and fighting spirit. And of his mother Meena Devi who took him on a scooter, strapped in so her pre-teen son does not lose balance, to meet doctors at the Western Command Hospital in Chandimandir Cantt in Chandigarh. Doctors at the Base Hospital in Delhi were also consulted.

The Kathuniya family were watching Yogesh excel on the world stage at the family home in Ballabgarh. In the men's discus (F56) final, Yogesh threw a distance of 42.22 metres to finish second. F56 is a classification in which athletes compete in a seated position. "Yogesh was a very studious child and we wanted him to become a doctor. But he fell in the park one day and it seemed like most of his body was paralysed. When we took him to the command hospital, doctors told us about the Guillain-Barre syndrome. We did not know anything about it but doctors told us that he may not walk again. The Paralympic medals are due to the persistence of his mother and Yogesh's will power," Captain Gian Chand (Retd), Yogesh's father, who served in the EME in the Indian Army, said. "The only thing on my mind was how can I make my son walk again. From spending hours at Base Hospital Delhi to learning physiotherapy and taking him for massages to different traditional centres in remote villages in Rajasthan and Haryana for months, I did everything," Devi recalls.

Once he got admission at the Kirori Mal College he met other para-athletes and was inspired. Among them was Asian medallist Neeraj Yadav. He also trained with coach Satya Pal and Dronacharya awardee coach Naval Singh at JLN Stadium. After medals at the national level, the youngster made it to the Indian Para team in 2018. "When he was to go for his first international event in 2018, friends like Neeraj Yadav and others helped fund his trip and it motivated him a lot," his mother recalls.Devi also oversees Yogesh's training along with two of his coaches and physiotherapist at the JLN Stadium. Yogesh has also opened an academy to train other para-athletes.

Within six months of his first international tournament, the youngster would finish fourth in 2018 Asian Para Games in Jakarta before winning a bronze medal in World Para Championship in Dubai, where he registered a throw of 42.05m. At Tokyo, Yogesh won the silver medal with a throw of 44.38m behind Rio Olympics champion Brazilian Claudiney Batista dos Santos, who threw 45.59m.In 2022 there was another setback after Yogesh was diagnosed with cervical radiculopathy, a nerve condition affecting the spinal cord. It took him six months to recover."When he came to train with us, Yogesh still used support and he could not hold the discus properly because his fingers were bent due to the syndrome. We worked on that. Then our main task was to find a balance with the sitting position on the wheelchair before he could improve his throwing technique. While the progress was slow, gaining upper body strength and flexibility in arms helped him a lot," Coach Naval said. Over the last four years Yogesh has won a silver medal each in the World Para Championships in Paris and Japan. In 2022, Yogesh also created a new world record of 48.34m at the Open National Para Championship. He then won the silver medal in last year's Hangzhou Asian Para games with a throw of 42.13m."Whenever he feels low he remembers the initial days of struggle. It keeps Yogesh going. He wants young para athletes to emulate him. He has set an example," Devi says. With back-to-back silver medals at the Paralympics, Yogesh has set a high bar.

Nitesh Kumar wins gold medal: Nitesh Kumar, a para badminton player from Charkhi Dadri, Haryana, claimed India's second gold medal at the Paris Paralympics on Monday in Para badminton, after beating Great Britain's Daniel Bethell in the final of men's singles SL3 category. SL3 class players, like Nitesh, compete with more severe lower limb disabilities, requiring play on a half-width court. The 29-year-old Nitesh, who overcame permanent leg damage from a 2009 accident, showed his dominance with a (result) win over Bethell in the final. The IIT Mandi graduate thus ensured that India return with a medal from the SL3 category, after Pramod Bhagat clinched the gold when para badminton made its debut three years ago in Tokyo.Nitesh's journey

Growing up Nitesh's first love was football. However, a tragic accident in Vizag in 2009 shattered his aspirations, leaving him bedridden for months and with permanent leg damage. Despite this setback, Nitesh's love for sports remained unwavering.During his time at IIT-Mandi, Nitesh discovered a newfound passion for badminton. He honed his skills on the court, often challenging able-bodied.In 2016, Nitesh seized the opportu-

nity to represent Haryana at the Para Nationals in Faridabad. His impressive debut earned him a bronze medal, showcasing his immense potential. The following year, he continued his success, clinching silver in singles and bronze in doubles at the national championships.

Nitesh's crowning moment came in 2020, when he defeated Tokyo Paralympic medalists Pramod and Manoj to secure the gold medal at the National Championship. His dominance on the domestic tournament cemented his position as one of India's leading para-badminton athletes.

What are new tiebreak rules for World Chess Championship?

The World Championship match is a 14-game encounter, with each game played in the classical format. The player who scores 7.5 points or more wins the World Championship Match. If the score after fourteen games is equal, then tiebreaks will be played in the rapid format first then the blitz format. In the 2023 tiebreak, the rules stipulated that players will play four games of 25 minutes plus a 10-secondincrement per move. If the score was still level after these four games, the match would proceed to the next tie-brak stage, which was a blitz playoff. But in 2024, if the scores are level after 14 classical games, four games of 15 minutes (rather than 25 minutes) plus a 10-second increment per move. If the score remained level after these four games, a two-game rapid playoff of 10 minutes plus a 5-second increment per move would follow - this is an additional stage added.

In the 2023 world chess championship match between Ding Liren and Nepomniachtchi, the blitz stage of the playoff would see a two-game blitz playoff of five minutes plus a 3-second increment per move. If the score remained level after these two games, another two-game blitz playoff would follow, If the game is still tied, a single game of 3 minutes for each player + 2 seconds increment per move will be played. If this game is drawn, another

But in the 2024 world chess championship match between Gukesh and Ding Liren, if the score remained level after the two-game rapid playoff of 10 minutes plus a 5-second increment per move a blitz playoff would be played. In this stage, there would be a two-game blitz playoff of 3 minutes plus a 2-second increment per move. If this did not yield a champion, a single game of 3 minutes for each player + 2 seconds increment per move would be played. If this game is drawn, another game of 3 minutes for each player + 2 seconds increment per move will beplayed will colors reversed. This will be repeated until there is a decisive result.When is the next World Chess Championship match? The tie-break, if needed, will be held on December 13, followed by the Closing Ceremony on December 14. The 2024 FIDE World Championship Match between Gukesh and Ding Liren will take place in Singapore's Resorts World Sentosa, a premier resort known for its world-class facilities, from 20 November to 14 December. How much is the prize money for World Chess Championship?The total prize fund for Gukesh vs Ding Liren match is \$2.5 million, with specific distributions based on game outcomes. The prize fund will be distributed as follows: Each player will receive \$200,000 for each game they win. The remaining prize money will be split equally between the players. If the winner is decided on a tie-break, the prize money will be divided as follows: the winner receives \$1,300,000, and the runner-up receives \$1,200,000.

## How the OG Armless Archer Matt Stutzman scripted a stunning campaign to finally win archery gold

At the 2023 World Archery Para Championships in Pilsen, India's Sheetal Devi – the archer without arms from Jammu and Kashmir who has become a sensation over the past year or so – got the chance to meet the man who started it all. The OG. The man who goes by "Armless Archer" on his social media handles. Matt Stutzman of USA, who has gone above and beyond just being a popular Paralympian since making headlines at London 2012 by winning silver.

Twelve years ago, he was the only armless archer at the Games. Not anymore. After getting to meet Sheetal in Pilsen, and sharing some of his technical inputs regarding the scope in the bow, Stutzman had told World Archery: "I can retire now and be okay with everything. I've done really well, but the fact that we have other armless archers is way more important. It proves anybody can shoot a bow. You don't need arms to do that. Bows just want to be shot."He had said on a few occa-

sions how inspiring more armless archers was his ultimate prize. But before he moved on from the sport, Stutzman had one final magic trick left to pull off. On Monday, the 41-year-old became the Paralympic champion. On a sensational day of archery that will remain long in the memory for those who witnessed it, Stutzman showed he wasn't in Paris just for a fancy farewell. He was there to win, to add the most important gold medal there is in sport to his resume. And he did so in stunning fashion. 'Couldn't have scripted it better'In a fitting way to begin his knockout round, Stutzman was drawn to face Víctor Sardina Viveros of Mexico, one of the four armless archers in Paris. "My first match was against an armless archer who I was mentoring, and this is the first time in the Paralympics that two armless archers shot against each other. In the round of 16, he was up against Jere Forsberg of Finland, who Stutzman had lost to in the final at London 2012. And what a rematch it turned out to be After the regulation 15 arrows, the two archers were tied 141-141. In the shootoff, Forsberg shot a 10 that was just 19mm off the center of the target, usually enough to win a tiebreak.Stutzman decided: not today. In his signature style, he loaded the arrow while anchoring the bow between his toes, extended his leg to draw, and with his chin-activated release aid, released the arrow towards the target placed 50m away. Bingo. Bull's eye. The arrow was so close to the center, that the scoreboard showed "minus 2mm". Quite possibly, one of the greatest single arrows shot in the history of the Games."I told myself that if I ever get the opportunity again, I'm not going to let him beat me twice. So that happened," Stutzman said with a alint in his eve
