#### Cyclone Dana set to be severe; Armed Forces on high alert in Odisha, Bengal

New Delhi: Cyclone Dana is expected to severely impact the coastal regions of Odisha and West Bengal. In response, the Indian Navy has launched extensive preparations for humanitarian assistance and disaster relief (HADR) operations. The Eastern Naval Command has activated its disaster response mechanism in coordination with naval officers stationed in Andhra Pradesh, Odisha, and West Bengal

Two ships from the Eastern Fleet have been deployed with essential supplies, including rescue and diving teams, to support relief efforts by sea. The Indian Navy remains on high alert, closely monitoring the situation, and has assured full support to those affected by the cyclone. The Ministry of Defence has also stated that medical aid will be provided upon request from state authorities. For this, the Navy is in coordination with units such as Base Victualling Yard (BVY), Material Organisation, and Naval Hospital INHS Kalyani. As part of the preparedness, the Navy has stockpiled essential items such as clothing, drinking water, food, medicines, and emergency supplies. Disaster response pallets have been strategically positioned on roads and key areas likely to face damage from the cyclone. ### Modi-Xi talks on BRICS sidelines carries 'great significance' to improve relations: China

A day after the landmark bilateral meeting between Prime Minister Narendra Modi and Chinese President Xi Jinping on the sidelines of the BRICS Summit in Russia's Kazan, China on Thursday said it carried a "great significance" as they reached "important common understandings" to improve bilateral ties. "They reached important common understandings on improving and developing China-India relations and set the course to steer bilateral relations back on the path of steady development," Chinese Foreign Ministry spokesman Lin Jian told a media briefing in Beijing, Lin further said China "stands ready to work with India to view and handle the bilateral relations from a strategic height and longperspective."He added that China is ready to enhance communication and cooperation, as well as strategic mutual trust, along with handling differences properly and ensuring that bilateral ties are brought back to the path of steady development as and tranquility in the bor-

#### Cabinet approves 2 rail projects covering Andhra, Telangana, Bihar with estimated cost of Rs 6,798 crore

The Union Cabinet on Thursday approved two rail projects covering Andhra Pradesh, Telangana and Bihar with a total estimated cost of Rs 6,798 crore, the government said. The Cabinet Committee on Economic Affairs, chaired by Prime Minister Narendra Modi, approved the doubling of the Narkatiaganj-Raxaul-Sitamarhi-Darbhanga and Sitamarhi-Muzaffarpur section in Bihar covering 256 km and construction of a new line between Errupalem and Namburu via Amaravati covering 57 km.

Both these projects will mainly benefit Andhra Pradesh and Bihar in which the BJP is in alliance with the TDP and the JDU respectively. "The doubling of Narkatiaganj-Raxaul-Sitamarhi-Darbhanga & Sitamarhi-Muzaffarpur Section will strengthen the connectivity to Nepal, Northeast India and border areas and facilitating movement of passenger trains along with goods train resulting in the socio-economic growth of the region," an official release said. "The new rail line project Errupalem-Amaravati-Namburu traverses through NTR Vijayawada and Guntur districts of Andhra Pradesh and Khammam district of Telangana," it said. According to the government, these two projects covering eight districts in the three states of Andhra Pradesh, Telangana and Bihar will increase the existing network of Indian Railways by about 313 km. Highlighting the benefits of these two projects, it said the new line project will provide connectivity to approximately 168 villages and about 12 lakh population with 9 new stations. Besides, it added, the multitracking project will enhance connectivity to two aspirational districts (Sitamarhi and Muzaffarpur) serving approximately 388 villages and about 9 lakh sential routes for transportation of commodities such as agriculture products, fertilizer, coal, iron ore, steel and cement. Talking about the impact on freight operations, it mentioned that the capacity augmentation works will result in additional freight traffic of magnitude 31 MTPA (Million Tonnes Per Annum).

Adilabad: BRS working president KT Rama Rao asserted that he was ready to be jailed for the sake of the people and farmers. Addressing a gathering of farmers at the 'Rythannala Poru Bata' meeting at Ramleela ground here on Thursday, Rama Rao said he was ready to go to jail for the people and farmers. People would revolt against the government and thrash leaders of the Congress soon for failing to fulfill its poll promises soon. Listing out the broken promises of the Congress, he pointed out that even the one tola of gold to promised to the beneficiaries of the Kalyana Lakshmi scheme was not given yet. Stating that farmers would have to lodge a complaint against the government for evading payment of Rythu Bandhu or not initiating the promised Rythu Bharosa scheme and for not extending the crop loan waiver in a full-fledged manner, he said even the unemployed would have to lodge a complaint against the government for not providing 2 lakh jobs per annum. No leader of the Congress would be left in the State if all sections lodged complaints against the government.

Rama Rao cautioned that the BRS would not remain silent if cases were booked against farmers. He stated that none would keep quiet if someone demolished their houses. He cited a case registered against Bodigam Ganganna for allegedly abusing Chief Minister



and permissions during the regime of the Congress. He also asked whether cases be booked against the Congress which claimed to keep its words within hundred days at the office or against the farmers or the poor. Cheating cases should be registered against those who duped the farmers and the public, he said, adding that illegal cases would not be tolerated. #### 31 women, 4 transgenders rescued from street flesh trade in Kukatpally



GNS News Agency, Oct 24 Hyderabad: In a joint operation conducted by Anti-Human Trafficking Unit (AHTU) and teams from Kukatpally and KPHB police to curb street prostitution, 31 women and 4 transgender persons were caught and rescued from a flesh trade on Wednesday night. The operation under the supervision of K Srinivas Rao, ACP Kukatpally, was focused on preventing street prostitution at Bhagyanagar bus stop, KPHB metro station, Kukatpally and vicinities. Following complaints from citizens on street prostitution becoming rampant in these areas, four special teams were formed for the operation. These teams included the ACP, three Inspectors, seven sub-inspectors, two assistant sub-inspectors, and 36 police constables. According to the police, as a result of the operation, 31 women and 4 transgender persons involved in street prostitution were caught. Four cases were registered at Kukatpally police station, and one case was registered at KPHB police station under the Immoral Traffic (Prevention) Act, 1956. "The individuals caught were produced before the Tahsildar in Kukatpally for binding them over to ensure good behaviour. After completing the bind-over procedure, they will be released with notices issued under Section 35 of the BNSS Act," Srinivas Rao said. Earlier this month, a similar operation was conducted with the same special teams during which 22 individuals were caught and cases were booked at Kukatpally and KPHB police stations. The Cyberabad Police said they will strictly enforce laws against prostitution and related activities.

### Sacrilege cases

THE grant of prosecution sanction by the Punjab Government sets the stage for resumption of the trial against the Dera Sacha Sauda chief in three sacrilege cases dating back to 2015. The Supreme Court had ecently lifted the stay imposed by the Punjab and Haryana High Court on proceedings against the self-styled godman. The cases involve the desecration of he Sikh scripture in Faridkot district. Gurmeet Ram Rahim Singh was among those booked for causing reigious hurt following the registration of multiple first inormation reports. The delay in taking the cases to their ogical conclusion has added to the political slugfest. The AAP government has been facing flak for inaction rom within its own ranks. Even after nine years, closure s nowhere in sight.

The dera chief remains a controversial figure over actions considered blasphemous by the Sikh commulity. Ram Rahim is already serving a 20-year sentence or rape and murder in a Rohtak jail. The frequent paole granted to him by the Haryana government is viewed as a sign of the influence he holds. Public perception, hus, started gaining ground of a deliberate attempt to prevent bringing him to justice in the sacrilege cases. For Ram Rahim's followers, such insinuations and enui put him at a distinct disadvantage. As per the special investigation team of the Punjab Police, the dera chief was one of the main conspirators and among the 12 persons indicted for the sacrilege incidents. The way orward is a fair and time-bound trial.

The incidents of sacrilege and the firing on protesters in 2015 continue to rankle. A mature and more nunced vocabulary by political leaders in matters of such sensitive nature would help. Social harmony cannot be held hostage to the alleged misdeeds of an individual.

#### With a free, online journal, Pune and Delhi academics are serving up a different kind of cuisine

While the world knows Gauri Lankesh as a firebrand, it was her neighbour, the eminent artist Pushpamala N, who drew attention to another side of the murdered Bengaluru-based journalist and activist. "The Gauri we knew was also a lively, pretty, gregarious person with a great sense of humour. She used to throw large parties and was a good cook. She had given me several recipes which I use till today," says Pushpamala in an interview published in an online journal, On Eating. Pushpamala also talks about creating a performance around food, Gauri Lankesh's Urgent Saaru, and the short film, Rashtriy Kheer and Desiy Salad (National Pudding and Indigenous Salad), in 2004.

On the other hand, the pathbreaking Dalit writer from Bengal, Manoranjan Byapari, talks about how he used to be a cook and a servant at a tea shop. "I neither made the tea, nor sold it. All I did was work there — washing the dirty glasses," he says in an article published in On Eating. Byapari reveals a little-known side of food politics. "I'd found work at a sweet shop there (Jalpaiguri). They didn't pay me anything — I was just given food... To balance this iniquity, I was driven to polish off ten pieces of sandesh, rosogollas, kalakands and chamchams. Each of them were priced at four annas. That's how I calculated my income," he writes.Pune "I think food is a very important part of human life and experience. I'm not talking of fancy food, or one being a foodie, but just a basic necessity that you need to live," says Ray.

Food is served from a range of perspectives in On Eating, each edition of the magazine peppered with complex sociocultural, political, gender and economic realities that steam up in kitchens and tables across the country. Possibly the only such magazine of its kind in India, On Eating is the brainchild of two academics, Pune-based Kunal Ray and Delhi-based Sumana Roy. "I think food is a very important part of human life and experience. I'm not talking of fancy food, or one being a foodie, but just a basic necessity that you need to live," says Ray.

Both being teachers of the English language with an affinity for words, eating and reading about eating, Ray and Roy decided to start an online magazine, oneating.in, amid the uncertainty of the pandemic when a locked-down world went aggressively online with recipes for coffee, pasta, bakes and more. What the duo decided early was that the magazine would be multilingual and accessible to people who do not read only the English language. Byapari's article was the first, published May 2021. Since then, stories, from original writings and translations to essays and poems, exquisitely illustrated, have been uploaded every month, creating a colourful menu in languages ranging from Bangla to Malayalam to Tamil to Hindi. "Kunal and I are both accidental academics. While both of us are interested in creating an archive of eating cultures of the Indian subcontinent, we are also particular in making this accessible to those without a specialist vocabulary. We like well-written, well-researched essays that reveal unexpected histories," says Roy. Her relationship with food is not unlike her relationship with everything else around her "of interest, wonder, curiosity, like, dislike, remembrance". "Food makes it possible for me to experience the wonder of this world inside my mouth," says Roy. Ray is "not a great cook but you had to cook to eat to survive during Covid". Roy would send him "little recipes and voice notes and I would cook".

The magazine is also unusual in not publishing excerpts or Instagram-style recipes. Instead, it has consistently maintained an intellectual depth and long-form articles that, clearly, target the thoughtful reader in an age of fast reads. Articles are through submissions but, every so often, it is the founders who seek out writers, such as the dancer Leela Samson. "Food is extremely important for a dancer, but there's no writing about what a dancer eats. My only brief to Leela akka was to lead us in understanding this. She constructed an essay giving very interesting insights about her life," says Ray. Another dancer, Mallika Sarabhai, talks about her life in the essay, "Food as Autobiography" while the writer Gita Viswanath talks about nasal feeding of her bedridden mother. Politician Shashi Tharoor, who enjoys eating, starts with "What can a Malayali writer think about when asked to write about food and eating?

### PETA moves Karnataka High Court against holding bullock races outside Udupi and Dakshina Kannada

PETA has requested that the Government be restrained from giving permission to hold bullock races outside the two districts and also be directed to enforce provisions of amended Act as well as Supreme Court directions in any further race. for the Ethical Treatment of Animals, or PETA, has moved the Karnataka High Court against holding bullock races such as kambala outside the districts of Udupi and Dakshina Kannada, where such races are held as part of local culture. As the matter was heard on Tuesday by a bench

of Chief Justice N V Anjaria and Justice K V Aravind, PETA, represented by senior advocate Dhyan Chinappa, submitted that the Karnataka Government had introduced an amendment to the Prevention of Cruelty to Animals Act to allow kambala on the grounds of culture, which was subsequently upheld by the Supreme Court.

The counsel said, "Now they have said they will hold it in Bangalore, in Shimoga... These two places require the animals to be brought by trucks. From Dakshina Kannada to Bangalore travelling 300 km and then, they will be made to run in this race..." Chinappa said that it was argued before the Supreme Court that kambala was of cultural importance in the two districts. "Emboldened by that, you cannot start conducting it in different parts of the state," he added. The kambala race involves two bullocks directed by a driver running with them.

In response to a question by the high court as to whether holding the event would amount to cruelty to the participating animals, the counsel said, "They are brought here in trucks and are made to race. This becomes a commercial event and no longer traditional. There are tickets, food courts, VVIP seats, lakhs of people expected to come for such events.... It cannot be a show. It has to be a traditional function, which is part of the culture of a particular area."The animal rights group also requested that a November 2023 government order giving permission for such races to be declared ultra vires and that action be taken against organisers of such races in Bengaluru.

### Citizens write to BMC seeking Bandra Fort's restoration back to original state, more green cover

A week after writing to the state archeological department over the 'altered' aesthetics of the 400-year-old Bandra fort, residents have now rallied together and written to the Brihanmumbai Municipal Corporation (BMC), raising concerns over the concretisation of the Bandra fort garden, which has significantly depleted the green cover. With nearly 80 signatories, the letter – addressed to BMC officials including the assistant commissioner of H/ward and civic chief, Bhushan Gagrani – has called for the restoration of the Bandra fort garden back to its original glory by removing the newly concretised sections inside the garden and for the plantation of more bushes, shrubs and shade-giving indigenous trees to help combat the heat.

Seeking to restore the Bandra Fort (Castella de Aguada) – built by the Portuguese in 1640 —the state archeological department issued a Rs 70 lakh work order for executing repairs on the structure. Furthermore, the BMC —under whose possession the nearby garden lies, launched beautification works on the garden last year. While repair work on the fort is still underway, the beautified garden was opened to the public earlier this

However, local residents and activists were taken aback to find that not only had the restoration tampered

with the original character of the fort, but also the green cover of the garden had been reduced significantly, owing to the concretisation. On Tuesday, residents submitted a letter to the senior civic officials expressing their dismay at the drastic reduction of greenery and the concretisation work in the garden, deeming it 'unsustainable' and 'anti-nature'. "This 'redevelopment' of our existing green spaces by needlessly uprooting and replacing plants, changing the flooring tiles, and concretising large areas which costs a whopping Rs 18.23 crore of taxpayer's money is absolutely unnecessary and a sheer waste and misuse of funds," read a part of the letter. Natasha Pereira, a local resident who has been frequenting the fort since childhood, told The Indian Express that the recent concretisation has resulted in significant heating of the open space, much to the displeasure of residents. "The once green lawn (near the waterfront promenade) has been replaced with concrete/basalt tiles in which the sun's blazing heat is glaring to one's eyes. Earlier, there used to be one-metre high shrubs, which have been removed and replaced with small bushes instead. Shockingly, even the lotus pond is gone. While the garden used to be nice and cool earlier, it has become very hot owing to concretisation," lamented Pereira.

Besides restoring the greenery, the residents – in their letter – have also appealed to the BMC to restore the lotus pond and install benches beneath trees. For its part, the BMC maintains that the beautification has only been undertaken in the previously undeveloped areas, with more indigenous plantations slated to be undertaken in the next phase of works. A senior official from BMC said that the existing green spaces have remained untouched. "We have carried out some development work behind the amphitheatre near the remains of Byramjee Jeejeebhoy and the temple to make the space more accessible for the disabled. We have put up basalt in the front portion, where there used to be pebbles, but we have also installed a lot of planters. Towards the entrance, we have also planted tall trees to enhance greenery," he said.

### Pimpri MLA Anna Bansode likely to be denied ticket as NCP scouts for 'winnable' candidate

As Maharashtra gears up for Assembly elections in November, the local unit of the Nationalist Congress Party (NCP) on Tuesday hinted that sitting MLA Anna Bansode might be denied ticket in the reserved constituency of Pimpri citing poor health and also because some leaders are upset with his style of functioning."The party is looking for candidate who will ensure a victory...We have several aspirants even from Maha Vikas Aghadi who are trying to get our nomination," Yogesh Behl, the newly-elected president of NCP Pimpri-Chinchwad unit, told reporters.

Bansode who was elected twice from Pimpri has been under fire from voters due to his inaccessibility. He is close to Deputy Chief Minister Ajit Pawar.Behl said that some leaders have complained to party national president Ajit Pawar that Bansode should be replaced."In the last five years, Bansode has been working in the constituency. However, he has not been able to give his cent per cent due to health reasons," he said.

Behl said the party has received applications from leaders such as Jitendra Nanaware, BJP leader Seema Sawale, Republican Party of India (RPI) leader Chandrakanta Sonkamble and even from former MP Gautam Chabuskar of the Shiv Sena."The party has not decided who should be given the ticket. Bansode might be continued. But at the same time, the party is giving a deep thought whether to bring a new face. The party leaders are weighing the options based on the feedback they are getting," he said.Behl said Seema Sawale, a former BJP corporator, has for months been trying to get NCP nomination from Pimpri. "She has been touch with the voters and has been working in the constituency," he

said.Behl said Jiteendra Nanaware is young and his known for taking up public cause. "He has the backing of Shiv Sena MP Shrirang Barne. He is also close to me...," Behl said.8Behl said Chandrakanta Sonkamble is from RPI (A). "She is ready to join our party. Even Ramdas Athavale has contacted our party chief. He however is backing her claim as RPI candidate," he said.When Ajit Pawar had staged rebellion in 2019, Bansode was the only MLA who remained with him till the end. The rebellion fizzled out but Bansode struck close rapport with Ajit Pawar.According to sources in the NCP, Ajit Pawar would not like to replace Bansode who stood by him during difficult time. Although the BJP has denied him the ticket for the Kothrud seat, Balwadkar said he was yet to take a final decision on contesting the election and also that he was not scared of anyone.

I have learnt from my relatives that the income tax officials mentioned my name at least four times saying they will investigate me as well," Balwadkar said."I am not a big leader. The BJP declared its candidate two days ago and I have since been silent, as I am yet to take a decision on whether to contest the polls or not. I am not scared of anyone," he added.

Balwadkar, who said he had worked for the BJP for the last 10 years, had sought the party's ticket to contest Maharashtra Assembly elections 2024. He had alleged that Patil had been putting pressure on the BJP to make him withdraw his demand for the Kothrud seat, adding that the party had sidelined him after he had declared his intention to contest the Assembly election. A day before the BJP declared Patil as its candidate, the ruling party's state chief, Chandrashekhar Bawankule, visited Balwadkar to persuade him not to do anything that would affect the party's performance.

## Migratory falcons spotted in Manipur's Tamenglong district, patrolling for roosting sites intensified

A substantial number of Amur Falcons (Falco amurensis) have been sighted in Manipur's Tamenglong district after completing their remarkable migratory journey, covering several thousand kilometers. In response, the district authorities, along with forest officials, have intensified patrols around the birds' roosting sites.

"A large number of Amur Falcons have been spotted in the district. We have increased patrolling, particularly at night, around the birds' roosting sites," said Kh. Hitlet, Divisional Forest Officer (DFO) of Tamenglong. He added that there are over seven roosting sites in the area. These migratory visitors, locally known as 'Kahuaipuina,' arrive in northeastern India, particularly in Manipur and Nagaland, in large numbers during October. They are on their southbound migration from their breeding grounds in northern China, eastern Mongolia, and far eastern Russia. During their stopover, which lasts three to four weeks, the falcons build fat reserves by foraging on termites before continuing their journey to their wintering grounds in South Africa.

Last year, the forest department recorded around 1.41 lakh falcons at a single roosting site in Chuilon. This year, the district authorities, along with the forest department, are focusing on radio-tagging the birds. "We plan to radio-tag two falcons by the end of November, once they have built up sufficient fat reserves to avoid harming them. As for the census, it will be conducted every two years," explained Kh. Hitlet.

(File photo)India-China Border Agreement: A day after India said that it had reached an agreement with China on patrolling arrangements in the border areas, Beijing said on Tuesday that the two sides "have reached a solution" on "relevant matters" but did not give any details.

The Global Times reported that in response to questions about the reported agreement between India and China on border patrols in disputed areas, Chinese Foreign Ministry spokesperson Lin Jian "confirmed progress".

"China and India have maintained close communication through diplomatic and military channels regarding border-related issues. Currently, the two sides have reached a solution on the relevant matters, which China

views positively. In the next phase, China will work with India to effectively implement the solution plan, spokesperson Lin Jian stated," the Global Times said. On the bilateral meeting between Prime Minister Narendra Modi and Chinese President Xi Jinping on the margins of the BRICS Summit starting Tuesday in Kazan, the capital of Tatarstan in Russia's southwest. Jian reportedly said. "We will keep you updated if anything comes up."The announcement of the agreement was made on Monday by Foreign Secretary Vikram Misri in New Delhi. "Over the last several weeks, Indian and Chinese diplomatic and military negotiators have been in close contact with each other in a variety of forums. As a result of these discussions, agreement has been arrived on patrolling arrangements along the Line of Actual Control in the India-China border areas, leading to disengagement and a resolution of the issues that had arisen in these areas in 2020. We will be taking the next steps on this," Misri had said, briefing reporters. On Monday, during an interaction at the NDTV World Summit, External Affairs Minister S Jaishankar had called it a "positive and good" development. "I think it creates a basis... peace and tranquillity, which should be there in the border areas, which was there before 2020, we will be able to come back to that, he had said.

Jaishankar had referred to Misri's statement, saying, "What foreign secretary has said is what I can also say: That we have reached an agreement on patrolling, and with that, we have gone back to where the situation was in 2020. We can say that the disengagement process with China has been completed... There are areas where, for various reasons after 2020, because they had blocked us, so we had blocked them. So what has happened is we have reached an understanding which will allow the patrolling."This development took place four and a half years after Chinese incursions in eastern Ladakh triggered a military standoff along the Line of Actual Control and sent bilateral ties south.

### 7,000 resident doctors on strike, medical services crippled in Rajasthan, 100 surgeries postponed at Jaipur hospital

Medical services across Rajasthan have been impacted as 7,000 resident doctors from the state's government hospitals went on strike demanding better security, increased stipend, and revision of the mandatory bond policy, among others. The strike, which has been going on since October 19, has severely affected the Sawai Man Singh (SMS) Hospital in Jaipur - one of the state's most important hospitals where people from across districts come for their healthcare needs.

More than 100 surgeries were postponed at the hospital on Tuesday as a result of the strike. The general wards and the ICU were among the worst-hit departments of the hospital.Parshuram Meena (56), from Sawai Madhopur, had come to SMS Hospital for a kidney operation, but could not get an appointment with a doctor."I came to Jaipur on Monday, but I still have not been able to meet a doctor," Meena said Tuesday. "My surgery was supposed to happen on Wednesday, but looking at the situation, I am thinking of going back and returning next week. This is a helpless situation," he said. While the state government has urged the striking doctors to get back to work, they say they have not got any assurances from the government.Dr Saket Dhadhich, media adviser of the Jaipur Association for Resident Doctors (JARD), said: "We do not want to continue with the strike because we know the problem the patients face. But the government has not given us any assurances."On the demands of the doctors, he said: "We have demanded better security and infrastructure arrangements in all medical colleges for doctors' security. Stipend should be increased, because it has not been done for the last four years. Also, junior specialists should be recruited in all branches in which postgraduate degrees are awarded. There are eight total



demands and we want each to be accepted."

Deepak Maheshwari, principal of SMS Medical College, however, criticised the doctors, saving the strike was continuing even though the government had accepted many of their demands. "This is the eighth strike in one-and-a-half years. What problems do these doctors have that they go on strike so frequently? Should we stop attending patients for every small inconvenience? The state government had tried to convince the doctors to call off the strike and even accepted many of their demands. They must talk to the government and find a solution to this," Maheshwari said. He said the doctors currently working at the hospital are doing longer shifts to take care of patients. Government hospitals outside Jaipur have also been impacted, with resident doctors holding strikes in districts including Ajmer, Udaipur, and Sikar. While emergency and trauma wards of most of the hospitals continue to function, surgeries and routine work have been

### Do you own something antique but not sure what to do with it? This firm can help you preserve it

An elderly woman from Mumbai approached Punebased Studio Gestalt with a unique problem; her home was filled with old and valuable books, but with no children or descendants, she didn't know whom to pass them on to. Studio Gestalt, founded by architect couple Prerna Shetty and Shreeamay Phadnis, stepped in to help. They created a digital inventory of her books, ensuring she had a record of all her titles. They then searched for the right client and someone sensitive to heritage acquired the collection and turned it into the pride of his library.In India, heritage conservation is often associated with largescale projects involving museums and historical institutions. However, Studio Gestalt has carved out a niche by focusing on personal valuables, ranging from everyday items like a grandfather's pen to a family heirloom painting. "No one was catering to this sector. We realized that everyone has some form of heritage-something they cherish and want to preserve—but they don't know where to go," explains Phadnis. Studio Gestalt is named after a theory that suggests people perceive objects and situations as a whole, rather than just a collection of parts. Both founders hold postgraduate degrees in conservation. Phadnis has worked at the Chhatrapati Shivaji Maharaj Vastu Sangrahalaya in Mumbai and the Mumbai Metropolitan Region Development Authority as a conservation planner, while Shetty was an architectural researcher with noted architect Brinda Somaya. Studio Ge-

When they started Studio Gestalt in 2018 with partner Apoorva Deshpande, their portfolio included interior design, architecture, and commercial projects. "After a while, we realized our hearts weren't in it," says Phadnis. The COVID-19 pandemic made the architects pause and reflect. While many senior architects and conservationists were working on large-scale projects for the government and international organizations, the duo turned their focus toward preserving the heritage of ordinary people. "We found that people saw heritage in their old bungalows, in treasured letters, books, photographs, and even in the stories passed down from their elders,

The reimagining of Studio Gestalt in 2018 coincided with a growing awareness among Indians about their personal legacies. "We're now at a time when people in India are more conscious of conserving their heirlooms and sentimental assets. With nearly 80 years since Independence, the third or fourth generation wants to cherish their historical artifacts and memories," adds Phadnis.Studio Gestalt engages in a range of activities, including research and publication, inventory and archiving, historic interiors, conservation architecture, and educational outreach. Sometimes, individuals drop by with a cherished object and ask, "Iska kuchh ho sakta hai kya (Can anything be done with this)?"One man owned a painting but wasn't sure of its value or how to care for it. On the other end of the spectrum are large-scale projects, such as one in Maheshwar, Madhya Pradesh, focusing on the River Narmada and her riverbanks. Studio Gestalt is also a consultant to the Holkar Cultural Center, an initiative by the royal family of I"Our architectural and urban conservation projects are large-scale and are our main revenue sources. We also work with private clients from aristocratic or wealthy merchant families for conservation and archiving projects," explains Phadnis. One such project involved a family from Pune with an aristocratic background who owned a mahirap (a traditional wooden partition) in one of their wadas (traditional houses). Though the family no longer lived in the wada, they wanted to preserve the mahirap, which featured glass panels, wooden frames, and intricate Pauranic figurines painted on it."That was a challenging yet unique project. We even had to source squirrel hair brushes from Udaipur to restore the painting," says Phadnis. Though they consulted with art conservationists, the couple also worked on many of the panels themselves. "We love to be hands-on with whatever we're doing," Phadnis adds. As Studio Gestalt celebrates its third anniversary in November, the team is busier than ever. "We want to help people understand their heritage, how to engage with it, and how to con-

### Terrorists who targeted construction firm possibly came from Pakistan via Gurez, then Bandipore, investigators believe

Police in Jammu and Kashmir have picked up around 50 men for questioning from across central Kashmir's Ganderbal district as it probes the terror attack on an infrastructure project near Sonamarg that killed seven employees of a construction firm. As per police sources, initial investigation suggests militants who targeted the employees are likely to be infiltrators from Pakistan who made their way to the district from Bandipore.

Seven employees, including a local doctor, of APCO Infratech were killed on Sunday when terrorists opened fire on their camp at the strategic Z-Morh tunnel, which connects Kangan town and Sonamarg tourist resort on the Srinagar-Leh national highway. Police sources said that while they don't have any credible leads into the attack as of now, they have picked up suspects from different parts of the district. "Each police station in the area has rounded up suspects. They are being questioned to seek any credible lead that could help in a breakthrough,' a police source said. Police sources also said the attack-



ers likely infiltrated into the Valley recently . "Our questioning of the survivors suggest that the attackers were not locals. There is a high likelihood that they were Pakistani terrorists who infiltrated into the Valley recently from the Gurez sector," the police source said. A high mountain range to the rear of Kangan connects Gurez and Bandipore. "The militants seem to have escaped to the forests after the attack," said a source.

### Police bust fake court in Gujarat; conman who posed as 'judge' arrested

Ahmedabad: Police have uncovered a nefarious scheme orchestrated by a man masquerading as a judge in his own fake tribunal and passing 'judgements' since 2019 especially in land deals in Gandhinagar area. Morris Samuel Christian, since arrested, is accused of orchestrating a deception that fooled many into believing they were in a legitimate court. Police said Christian, the mastermind behind this elaborate ruse, wielded his gavel to pass judgments in favour of his clients, all within the fabricated walls of his office. The bogus tribunal, reminiscent of a real courtroom, worked undetected for years, with its roots tracing back to as early as 2019. Initial probe suggested that Christian preyed on unsuspecting individuals entangled in land disputes, promising swift resolutions in exchange for hefty fees.

By assuming the role of a judge, he exploited the vulnerable, manipulating the course of justice for personal gain. The elaborate charade involved Christian's associates posing as court personnel, creating a façade of authenticity to dupe his clients. The elaborate theatrics, complete with a mock courtroom setting in Gandhinagar, lent an air of legitimacy to his deceitful proceedings.

In 2019, Christian passed an order in favour of his client using the same modus operandi. The case was pertaining to a government land under the district collector while his client had staked claim on it and wanted to add his name in revenue records related to the plot in question located in Paldi area, a police release said on

Without an authority or order issued by any court under the Arbitration and Conciliation Act, Christian told his client he has been appointed as the "official arbitrator" by the government. The conman then initiated fake proceedings at his 'court' and passed an order in favour of his client, directing the collector to add his client's name in the revenue records of that land, the release said. To implement the order, Christian, through another lawyer, filed an appeal in the city civil court and attached the fraudulent order passed by him.

The court registrar, Hardik Desai, recently found out that Christian is neither an arbitrator nor is the order of the tribunal genuine. Following his complaint, the Karani police here lodged an FIR under Indian Penal Code (IPC) sections 170 (pretending to hold any office as a public servant) and 419 (cheating by personation). The conman was arrested for allegedly cheating people by posing as a judge of an arbitral tribunal and passing favourable orders claiming he has been appointed as an arbitrator by a competent court to adjudicate legal disputes, the release said. The accused is already facing a cheating complaint filed at the city's Maninagar police station in 2015, it added.

Not losing hope despite not making it to the final merit list on her first attempt in 2020, Bini this time secured 596th rank"I knew that my parents would not be able to afford my coaching. But I decided that would not

hinder me in achieving my dream of becoming a civil servant," the 24-year-old Regarding her preparation, she said, "I started preparing online by watching YouTube videos and other online study material. I followed videos of toppers to learn the examination strategy." Even accessing the internet was not easy. She had to leave her home village, Mudulipada in Malkangiri district, to the nearby town of Govindpali, where internet services are available. Her father, Ram Muduli, works as a cook and caretaker at a government high school, and her mother, Sunamali, is an anganwadi worker. She went to school at a government school in Malkangiri's Bonda Ghat, and then at Jawahar Navodaya Vidyalaya."After completing my post-graduation in Botany from Vikram Devi (Autonomous) College, Jeypore, I started working as an ayurvedic assistant to financially support my studies. After I failed to make it to the interview round (previously), I realised that my preparations were not enough and that I had to work harder. Then I appeared for the online mock tests, which helped me a lot," Bini said. She said her parents and relatives had always been supportive and were even happier than her about her achievement. As a civil servant, Bini said she would work for the overall development of the tribal community, especially in ensuring education for girls. She also said she would work to ensure that benefits of all tribal development schemes of the government reach the intended beneficiaries.

### 3 years after NIA court cleared Assam MLA Akhil Gogoi, he is charged under UAPA in same case

(Express file photo)A Special NIA Court Tuesday framed charges against Sivasagar MLA Akhil Gogoi and three others, including under sections of the Unlawful Activities Prevention Act, for their alleged role in the 2019 anti-Citizenship (Amendment) Act protests in the state. This comes more than three years after an NIA court cleared Gogoi of all charges in the case.

The case against Gogoi, an Independent MLA and leader from the regional outfit Raijor Dal, and his associates had been filed at the Chandmari police station in December 2019. It is one of two cases filed against him during the anti-CAA protests in the state, which had turned violent.On Tuesday, Special Judge S K Sharma framed charges against Gogoi under section 18 of the UAPA, which pertains to conspiracy or attempt to commit a terrorist act, as well as under IPC sections pertaining to criminal conspiracy, promoting enmity between different groups, and assertions prejudicial to national integration. However, the court dropped two significant charges made by the NIA in its chargesheet - section 39 of the UAPA, which pertains to support given to a terrorist organisation, and section 124A of the IPC, which pertains to sedition. The FIR had alleged that Gogoi "secretly merged" his organisation, KMSS, with the Revolutionary Communist Centre and the latter was later merged with the banned CPI (Maoist). Gogoi was in jail for over one-and-a-half years after his arrest on December 12, 2020. On July 1, 2021, he was released after a special



NIA court cleared him of all charges, stating that there was no "prima facie materials to frame charges against the accused persons" and the "ends of justice demands that the accused be discharged, without making him suffer the process of trial". This was appealed by the NIA in the Gauhati High Court and in February last year, and the HC allowed the NIA to frame charges.

"Challenging an oppressive state is very difficult and heavy work. Today's charges make one thing clear: the government is still working against us... The court had given us relief, this court had said that the charges against are completely false charges and that this case cannot be taken up in court. Now again the government is pressing for the case to be taken up," said Gogoi after Tuesday's court proceedings.Gogoi's legal representative Santanu Borthakur said, "Once the court frames the charges, there are two options. Either to face trial or to approach the High Court against this. We are mulling over the matter and after studying the verdict, we will talk to our client."

### Death toll in Bulandshahr cylinder blast rises to 7; rescue ops continue

The death toll in an oxygen cylinder blast in a twostorey house in Sikandrabad of Uttar Pradesh's Bulandshahr district late on Monday mounted to seven after a man succumbed to his injuries on Tuesday even as the National Disaster Rescue Force (NDRF) and local teams continued their rescue operation.

Officials said the blast was so powerful that the house, which had 24 occupants, was reduced to rubble at around 8 pm Monday. "She was nine-month pregnant and our minor daughter too lost her life in the incident," he said.Renu Singh, Sub-Divisional Magistrate, Sikandrabad, said 13 people, including two women and a minor girl, were rushed to the hospital where six of them died on Monday. "Some of them in serious condition while those with minor injuries have been discharged after primary treatment. Chief Minister Yogi Adityanath has expressed shock over the incident and directed officials in Bulandshahr to speed up the rescue mission and also to ensure proper medical treatment to those in the hospital," said Singh.

Chandra Prakash Singh, District Magistrate, Bulandshahr, said their priority is to rescue all those trapped in the debris and ensure immediate medical help to them. "The rescue work is likely to continue till late night today. What caused the blast will be known after the inquiry but our primary probe suggested that the oxygen cylinder was mishandled, causing the blast," said Singh.Shlok Kumar, Senior Superintendent of Police (SSP), said Rijjudin's wife Rukhsana was admitted to the hospital following a complaint of breathlessness for the last few days. She was released Monday evening but her condition deteriorated soon after she reached home. "The family members soon arranged an oxygen cylinder to provide her relief but it exploded somehow as a result the house collapsed," said Kumar.

### Stand by law on madrasas, Uttar Pradesh government tells SC

The Uttar Pradesh government on Tuesday informed the Supreme Court it stands by its law on madrasas and the Allahabad High Court should not have held the entire law as unconstitutional.On Tuesday, a bench comprising Chief Justice of India (CJI) D Y Chandrachud and Justices J B Pardiwala and Manoj Misra posed a specific query to Additional Solicitor General K M Natraj, appearing for the state government, on whether he stood by the validity of the law as it provided the authority to regulate madrasas as well.

"Are you standing by the validity of the Act," the CJI asked the law officer the moment he commenced his submissions on a batch of pleas against the high court verdict. The Uttar Pradesh Board of Madarsa Education Act, 2004 regulates the operation of madrasas in the state and was framed to ensure quality education, while adhering to constitutional principles, in such institutions. On March 22, the Allahabad High Court had declared the Act as "unconstitutional" and violative of the principle of secularism, and asked the state government to accommodate madrasa students in the formal schooling system. The state government had supported the law in

the high court. However, it did not file any appeal against the verdict. After the SC bench posed the query, Natraj said, "I support the validity of the Act. Since, the constitutionality (of the law) has been struck down, we want to say something. We are defending the legislation. The state did not file a SLP (special leave petition)." The state government filed its response in the high court standing by the Act and it cannot deviate from the stand, the law officer added. Striking down the law in its entirety would be incorrect and it was not the case of legislative competence, said Natraj, adding that it was struck down on account of fundamental rights. "Entire legislation need not be struck down," he said.

The bench, in the meantime, noted, "As a state, you have wide powers under Section 20 (of the madrasa law) to ensure basic quality of education in madrasas and as the state if you find that the basic level (of education) is not followed then you always can intervene." Natraj said a law could be struck down if it was either against fundamental rights or lacks legislative competence. Earlier in the day, senior advocate Mukul Rohatgi, appearing for a litigant, assailed the high court verdict. Referring to what HC had said about shutting madrasas and students going to normal schools, Rohatgi said, "My fundamental right is violated as I will not be receiving religious instructions." He added, "Hundreds of people are studying in madrasas and you cannot force somebody, this is not secularism." The hearing is underway. On October 21, the bench said the state had a vital interest in ensuring quality education, other than religious teachings, at government-aided madrasas so that students live a "decent" life after they pass out.n April 5, the CJI-led bench had provided a breather to about 17 lakh madrasa students by staying the verdict of the Allahabad High Court that had scrapped the Uttar Pradesh Board of Madarsa Education Act, 2004, calling it "unconstitutional" and violative of the principle of secularism.

### Supreme Court extends interim anticipatory bail for Malayalam actor Siddique in sexual assault case

The Supreme Court Tuesday extended by two weeks the interim anticipatory bail granted to Malayalam actor Siddique, who is facing allegations of rape. A bench of Justices Bela M Trivedi and Satish Chandra Sharma also allowed the request of Siddique's counsel Senior Advocate V Giri to respond to the status report filed by the Kerala Police. Seeking dismissal of the plea, Senior Advocate Ranjit Kumar, who appeared for Kerala, said Siddique is not cooperating with the rape investigation. "When he is coming (for investigation), he comes with a prepared statement that he won't answer anything more and that he can't recollect. Also, after FIR, he has closed his Facebook account. He does not want us to get access to that. We have to approach third parties to access," Kumar said.

To the bench's query about the delay in lodging the complaint of the incident dating to 2016, the senior counsel said the victim gathered the courage to come out in the open only after the report of the Justice Hema Committee, which exposed the casting couch and other exploitations in Malayalam film industry, was released. There are phases in that also. So this, what I'm saying, has been our stance from April '20."

He added: "As of now, we are trying to restore the trust. How the trust will be restored? It will get restored once we are able to see each other and we are able to convince each other, look the buffer zones which have been created, we are not creeping [into] and both have to reassure each other. Patrolling gives you that kind of advantage...As we restore the trust, the other phases will also follow through."The agreement, announced by Foreign Secretary Vikram Misri on Monday, means India and China have agreed to restore patrolling rights to each other in the Depsang Plains and Demchok region, where the problems existed before April 2020.



### Central Park Five file defamation suit against Trump over debate comments

The Central Park Five -- five Black and Hispanic teenagers wrongfully convicted for the 1989 rape of a white jogger -- have filed a defamation lawsuit against Donald Trump over false statements he made during a September presidential debate. Known widely as the Central Park Five, the defendants spent between five and 13 years in prison before they were cleared in 2002 based on new DNA evidence and the confession of another

Trump, the Republican nominee for the White House, falsely said at the September 10 debate with Democrat Vice President Kamala Harris that the Central Park Five had killed a person and pleaded guilty. The lawsuit, filed in federal court in Philadelphia by Yusef Salaam, Raymond Santana, Kevin Richardson, Antron Brown and Korey Wise, called Trump's statements "demonstrably false". Salaam is now a member of the New York City Council. A spokesperson for Trump's campaign on Monday called the case "just another frivolous, election interference lawsuit, filed by desperate left-wing activists".



A lawyer for the plaintiffs, Shanin Specter, said in a statement that Trump's remarks "cast them in a harmful false light and intentionally inflicted emotional distress on them."Specter denied any political motive in the lawsuit. "I'm not commenting on politics. We are seeking redress in a court of law," he said. The plaintiffs are seeking unspecified monetary damages for reputational and emotional harms as well as punitive damages. Trump has drawn criticism before over his statements about the Central Park Five. After the jogger's assault, he spoke out about the case and took out a full-page ad in several New York newspapers calling for the reinstatement of the death penalty. Trump in 2019 stood by his prior comments about the Central Park Five, and declined to apologise. Trump asked a US appeals court in September to reject a \$5 million verdict finding him liable for sexually assaulting and defaming the writer E Jean Carroll.A different jury in January ordered Trump to pay Carroll \$83.3 million for having defamed her and damaging her reputation in June 2019 after she first accused

### Israel goes after Hezbollah's web of tunnels in south Lebanon

Tel Aviv: Israeli forces have spent much of the past year destroying Hamas' vast underground network in Gaza. They are now focused on dismantling tunnels and other hideouts belonging to Hezbollah militants in southern Lebanon.Scarred by Hamas' deadly raid into Israel last year that sparked the war in Gaza, Israel says it aims to prevent a similar incursion across its northern border from ever getting off the ground. The Israeli military has combed through the dense brush of southern Lebanon for the past two weeks, uncovering what it says are Hezbollah's deep attack capabilities — highlighted by a tunnel system equipped with weapons caches and rocket launchers that Israel says pose a direct threat to nearby communities.Israel's war against the Iran-backed militant group stretches far inside Lebanon, and its airstrikes in recent weeks have killed more than 1,700 people, about a quarter of whom were women and children, according

to local health authorities. But its ground campaign has centered on a narrow patch of land just along the border, where Hezbollah has had a longstanding presence. Hezbollah, which has called for Israel's destruction, is the Arab world's most significant paramilitary force. It began firing rockets into Israel a day after Hamas' attack. After nearly a year of tit-for-tat fighting with Hezbollah, Israel launched its ground invasion into southern Lebanon on October 1 and has since sent thousands of troops into the rugged terrain. Even as it continues to bolster its forces, Israel says its invasion consists of "limited, localised and targeted ground raids" that are meant to destroy Hezbollah infrastructure so that tens of thousands of displaced Israelis can return home. The fighting also has uprooted more than one million Lebanese in the past month. Many residents of southern Lebanon are supporters of the group and benefit from its social out-

### Donald Trump makes more debunked claims about FEMA disaster response: Report

Surveying storm damage in North Carolina, former President Donald Trump on Monday blasted federal emergency responders whose work has been stymied by armed harassment and a deluge of misinformation. Surveying storm damage in North Carolina, former President Donald Trump on Monday blasted federal emergency responders whose work has been stymied by armed harassment and a deluge of misinformation, but he said he was not concerned that the aftermath of Hurricane Helene would affect election results in the battleground state.

Trump was asked whether it was helpful to criticise hurricane relief workers after the Federal Emergency Management Agency recently paused work in the area because of reports they could be targeted by militia. He responded by again assailing the agency and repeating the falsehood that the response was hampered because FEMA spent its budget helping people who crossed the border illegally. That claim was debunked weeks ago by US Representative Chuck Edwards, R-N.C., who stood behind Trump as he spoke.

"Well, I think you have to let people know how they're doing," Trump told reporters in Swannanoa, outside Asheville. "If they were doing a great job, I think we should say that, too, because I think they should be rewarded... If they're doing a poor job, we're supposed to not say it?"Trump's campaign and that of his Democratic rival, Vice President Kamala Harris, are ramping up their campaigns in the final two weeks before Election Day.

Trump had three stops in North Carolina on Monday. After the Asheville area, he held a rally across the state in Greenville and spoke at a faith leaders event in Concord, where he appealed to Christian voters by repeating his criticism of transgender athletes playing on women's sports teams and his proposal to conduct a largescale deportation operation. Trump said that during his administration, he fought for Christians "like no president has ever fought before. "Harris on Monday focused her campaigning efforts on the "blue wall," travelling to suburban Pennsylvania, Michigan and Wisconsin. She held a series of conversations with Republican Liz Cheney moderated by GOP strategist Sarah Longwell, publisher of the Bulwark, a commentary site for anti-Trump conservatives, and conservative radio host Charlie Sykes. Trump won those three states in 2016 and lost them in 2020, and Harris could all but lock up the presidency if she swept them. Cheney, a former Wyoming congressman who lost her seat after she spoke out against Trump following the January 6, 2021, insurrection, offered advice to her fellow Republicans who are uneasy with Trump but not comfortable broadcasting support for a Democrat."You can vote your conscience and not ever have to say a word to anybody," Cheney said.

HURRICANE HELENE DISPLACED THOUSANDS OF VOTERSMany North Carolina counties affected by Hurricane Helene moved Election Day precincts or changed early voting sites. Thousands of voters remained displaced or without power or water as early voting commenced. "I'll go door to door if I have to," she said. State Senator Natalie Murdock, who doubles as political director for Democrats' coordinated campaign in the state, said the party has the apparatus to reach their target voters in the disaster zone. Field workers in some of Democrats' twodozen-plus offices around the state have engaged in recovery efforts, distributing water and other supplies to residents. North Carolina Governor Roy Cooper, a Democrat, urged Trump not to "share lies or misinformation" about the storm recovery. Many storm survivors lost everything, and they want help and truth, Cooper said Monday at a briefing in Asheville."We should work together to give them both," the governor said. "Storm recovery cannot be partisan. "Edwards, who represents Asheville and surrounding areas in Congress, put out a long statement last month debunking "outrageous rumors" that FEMA was halting trucks from bringing in supplies, abandoning rescue efforts to bulldoze Chimney Rock, running out of money and more. He did not defend FEMA from Trump's criticism Monday.Instead, Edwards, who owns McDonald's franchises, presented Trump with what he called a "French fry certification pin" in a nod to the former president's photo opportunity Sunday at one of the fastfood restaurants. White House press secretary Karine Jean-Pierre called Trump's FEMA comments "dangerous" and said they had been debunked on a bipartisan basis. She said 5,500 federal personnel were in North Carolina and Florida after Helene and Hurricane Milton and noted that \$2 billion in federal assistance had been approved for those affected in North Carolina."They are dangerous," Jean-Pierre said of Trump's remarks. "They are unhelpful. It is not what leadership looks like."Democrats are running both Helene and Mark RobinsonEven before Helene, North Carolina was all the more compelling because of its history of split-ticket voting. It's one of the few states that features competitive governor's races concurrent with presidential contests. Democrats have carried the presidential electoral vote just once since 1992 — in Barack Obama's narrow win in 2008. Republicans have won just one governor's race in the same span. Four years ago, Cooper won re-election by 4.5 points despite Trump outpacing Biden. He's prevented by term limit laws from running again. Democrats hope Republican gubernatorial nominee Mark Robinson's latest struggles, centred on CNN's revelations that the state's first Black lieutenant governor once called himself a "Black Nazi" and posted lascivious statements on a porn website, turn thousands of Cooper-Trump voters into supporters of Harris and Democratic gubernatorial nominee Josh Stein. Robinson has denied the allegations and sued CNN, calling its report defama-

### Russian media backs Trump over Kamala Harris in US election despite neutrality

As the US elections approach, Russian state media appear to favour Donald Trump over Kamala Harris, despite official claims of neutrality. This bias is evident in the portrayal of both candidates, raising questions about Moscow's true stance. Russian officials from President Vladimir Putin down say it makes no odds to Moscow who wins the White House on November 5. Yet anyone watching Kremlin-guided state media's coverage of the US election would conclude Donald Trump is strongly

State TV's main Channel One news programme this month showed video of billionaire Elon Musk and TV host Tucker Carlson denigrating Democratic candidate Kamala Harris before zooming in on what it cast as a series of stumbling performances. Harris' tendency to burst into fits of laughter, something Putin himself spoke about sarcastically last month, has featured prominently in broadcasts and state TV has played compilations of her least eloquent statements during the campaign. By contrast, the same Channel One report portrayed Trump and running mate JD Vance as sure-footed and imbued with common sense on everything from transgender politics to immigration, but facing sinister forces as evidenced by assassination plots. The Kremlin says the choice of who becomes the next US president is a matter exclusively for the American people and that it will work with whoever is elected. It has denied steering coverage, although some former state media employees have spoken publicly about weekly Kremlin meetings at which guidance on different issues is given. The state media's apparent preference for Trump may be no surprise. ### **Electronic components subsidy policy:** Centre, industry disagree over job creation

There is a standoff between the electronics industry and the Centre over employment numbers in a new electronic components manufacturing incentive policy currently being drafted — with the industry pushing back on the government's job creation demands, saying that the numbers don't reflect the level of mechanisation available, The Indian Express has learnt. Faced with the employment issue, the government is keen on linking jobs creation to subsidies that companies could avail under the electronic components manufacturing incentive policy, which the Ministry of Electronics and IT (MeitY) is working on. As part of deliberations on the policy last week, the industry said that the government was estimating job creation under the scheme to be higher than by at least 50-60 per cent. This tussle has delayed the formulation of the policy.

"Take printed circuit board assembly (PCBA) for instance. The government is asking that we employ 3-4 people per PCBA unit produced locally. But, we are telling that the process is highly mechanised, and only needs 1-2 people per unit. There are many other components on which there has been a lot of back and forth as far as employment is concerned," an industry executive said.

Incentivising electronic components manufacturing is the next key frontier for India, after it successfully managed to localise assembly of finished electronics products such as smartphones. However, as smartphone companies like Apple and Samsung ramped up their assembly processes, it has resulted in a surge in import of component imports given that India has very little footprint in the domain, which is largely dominated by China. The in-

centive policy for electronic components could have a government subsidy component to the tune of Rs 40,000 crore, with the expected investments in the space to the tune of Rs 82,000 crore. The government is exploring various incentive models, including subsidising either operational or capital expenditure or a combination of the two, depending on the type of component. In an internal assessment, the government has also identified a "huge' demand-supply gap in the electronic components sector to the tune of \$100 billion for domestic consumption alone, and \$140 billion if India wants to export some components. That would be almost ten times of what India's current domestic capacity is. In 2022-23, electronic components production in the country stood at \$10.75 billion accounting for only about 10 per cent of total electronics

In a deck prepared by the IT Ministry, the government has identified three key challenges facing India in terms of electronic components manufacturing. First is the current lack of domestic scale in the country. Second is a high investment to turnover ratio - in terms of finished products such as smartphones, which is what India is currently focusing on, every rupee of investment can bring it around Rs 20. However, in case of electronic components, every rupee worth of investment will bring in between Rs 2- Rs 4. And third is that because India has big domestic demand, a large chunk of components are being imported: electronics imports is the second largest import commodity after oil, and account for nearly 75 per cent of the total electronics production in India. Going by this trend, component demand is expected to reach \$160 billion by 2028-29. "As component imports continue to grow at around 12 per cent, our component production with exports would have to grow by a CAGR of more than 53 per cent to meet demand," the deck prepared by the IT Ministry said. This is why it is critical for the country to work out a domestic manufacturing scheme in the components sector. The deck acknowledges that while post the production linked incentive (PLI) scheme for smartphones has resulted in a near tapering of imports of finished products, import of key components and sub-assemblies, including integrated circuits (ICs) increased from \$29 billion in FY21 to \$46.5 billion in FY23. Under the incentive policy, the government could offer an opex subsidy for non-solder mask passive components, flex PCBA, and sub-assembly display and camera modules. Mechanics, capital goods used in electronics manufacturing, and Lithium cells for electronics may receive capex subsidy. PCBs with more than eight layers, flex PCBs, and solder mask defined passive components could qualify for both an opex and capex

### India set to benefit as global LNG markets head towards supply glut, subdued prices, says ICRA

With major additions in global liquefied natural gas (LNG) production capacity expected to lead to a supply glut over the next few years, India is set to benefit as prices of LNG, or super-chilled gas, are likely to stay subdued for an extended period, according to rating agency ICRA.

"Globally, about 193 MMT million metric tonnes) of the LNG production and liquefaction capacity is slated to cant capacity addition amid expectation of modest demand growth in the global natural gas consumption will keep the LNG prices under check, benefitting India," ICRA said in a note on Wednesday.Liquefaction is the process of converting natural gas into a liquid state at ultra-low temperatures. Transportation of gas as LNG is the most viable and is considered second to only transportation by pipelines. For countries like India, which are not connected with international gas supply pipelines, importing gas in this super-chilled and liquid form is the only feasible op-

Global LNG prices saw high volatility over the past couple of years-2022 and 2023-due to a combination of reasons that included rapid recovery in global demand as the COVID-19 pandemic ebbed and the impact of the Russia-Ukraine war on global energy markets. But with close to 200 million tonnes of liquefaction capacity expected to be added globally between this year and 2028, supply constraints could be a thing of the past, at least in the near to medium term.India, which is among the top importers of LNG, depends on imported gas to meet nearly half of its domestic requirements. With indications that the global LNG market is likely to turn into a buyer's market with additional capacity coming onstream, countries like India stand to gain by saving valuable foreign exchange. This query made us reach out to experts who explained the reason behind the choice of arm, and whether it makes any difference to the blood donated.When donating blood, you can generally use either arm. But "most people use their non-dominant arm for a few practical reasons," said Dr Aklesh Tandekar, head consultant critical care, Wockhardt Hospitals Mira Road.

In simple words, this means that if a person is right-handed, the lab technician would choose the left arm for blood donation, and if a person is left-handed, the technician would likely choose the right arm. According to Dr Dr Tandekar, this practice is followed to minimise the risk of complications and to ensure that the patient's dominant arm is not affected, especially if multiple blood draws are activities needed.Choose the arm that feels more comfortable



and relaxed during the donation. This will help you the maintain a steady position throughout the process, making it easier for the phlebotomist (blood collection specialist) to find a vein," said Dr (Brig.) 

"I had a chance to play the final. I was told to stay ready. I was. However, they decided before the toss that we would go with the same team. I was like, no worries. I was in that type of mood," Samson conceded in a video on Vimal Kumar's YouTube channel."During the warmup, Rohit (Sharma) took me to the side and started to

explain to me why he is making that decision. He was like, 'You understood, na?' You know his way, very casual? I told him, 'Let us win the match and then talk.' You focus on the match. He came back a minute later and said, 'I know you are cursing me in your mind.' I think you're not happy. I feel like you have something on your mind. I told him, 'As a player, I want to play'," he added. The 29-year-old, who has played across 33 T20Is and 16 ODIs for India, went on to praise the Indian captain for providing him with a clarity over the last-minute call ahead of the T20 World Cup Final." I said I totally respect that you came and explained me. I told him, 'I will have a regret; I could not play a World Cup final with a leader like you." This will be a regret in my heart that I missed a World Cup final with a leader like Rohit Sharma. ### Is the future of Commonwealth Games a stripped down and budget-friendly version?

Post-colonial realities of the day, economic pragmatism and irrelevance of the former Empire, effectively mean the freshly proposed 10-sport Commonwealth Games will barely draw a nostalgic sigh.

Glasgow has stepped in to salvage the 2026 edition, after Australia refused the burden. And the bemused member nations, are frankly staring at a future where these Games, if they survive the relevance debate, look headed in the direction of becoming budgeted affairs, cutting down not only on extravagance but also on some staples like hockey, badminton, squash and TT.The big blow to the quadrennial came not when Durban pulled out of hosting the 2022 edition, though it was a sign of things to come. What struck the Commonwealth Games smack in the face was Victoria, Australia throwing their hands up in the air just two years before the 2026 edition, pleading their inability to host. What further drove in the reality was that neither India, Canada nor Malaysia, with some semblance of economic fortitude among the Commonwealth nations, volunteered to take on the responsibility. South Africa and New Zealand weren't even deliberated, and for the second time, UK has opted to pick the tab, to keep the fraying fabric of the Games from coming undone. Future enthusiasm from the mildly well-off countries is not in evidence, though 2030 will be an accurate marker. As things stand, Glasgow will host a severely pared down version, with 4 venues in an 8 mile



radius, athletes put up in hotels, and a hugely restricted number of participants.

Besides the racquet sports being jettisoned, the immediate disciplines getting culled are the team sports like hockey, cricket and rugby, and they will be left wondering if they can ever return to the fold, given tight budgets, and athlete-to-medal ratios considered in this cold calculation. Only netball found favour, though Glasgow has done well to try to integrate the para-sports programme into the able-bodied one, with one eye firmly

For India, the mandate is clear - get started on sports like Athletics, swimming, gymnastics and cycling in earnest, and use the opportunity to scale up these programmes if it has any serious aspirations to hold the Olympics. Inspiration can be found in their BRICS buddy Brazil which raised its Athletics, Gymnastics and Swimming profile from scratch after being allotted the 2016 Olympics. India's medal standing at 2026 might look miserable, but if it can get started on these sports, it will help

Six of the 12 sports in which India won a medal at the 2022 Commonwealth Games have been axed from the 2026

edition. Sports where India managed podium finishes in Birmingham but will be omitted from the Glasgow Games are badminton, cricket, hockey, squash, table tennis and wrestling.

Some other sports in which India have raked in medals in the past editions but which were not part of Birmingham, like shooting and archery, also remain excluded from the Commonwealth Games 'Lite', where only 10 sports will feature due to cost-saving measures. The Games will take place from July 23 to

August 2, 2026. In a statement, Glasgow CWG organisers said the sports programme will include athletics and para-athletics, boxing, bowls and para-bowls, swimming and para-swimming, artistic gymnastics, track cycling and para-track cycling, netball, weightlifting and para-powerlifting, judo, and

It added 'there will be around 3,000 of the best athletes competing from up to 74 Commonwealth nations and territories.'While

badminton has been played in every edition of the CWG since 1966, squash and hockey have been a part of the programme since 1998. Table Tennis has featured at every Games since 2002. The decision also marks a rare occurrence of no racquet sport being included in a multi-discipline event.At the 2022 CWG, India won 61 medals, including 22 gold.

Wrestling (12), boxing and table tennis (7 each), badminton (6), hockey and squash (2 each), and cricket (1) accounted for more than half of the medals - 37. The rejigging of the sports programme will severely affect India's tally, given that apart from athletics and para-athletics, boxing and weightlifting, the country does not have strong gold medal contend-

One of the major reasons for a curtailed programme is that Glasgow stepped in as a last-minute replacement as a part of a rescue deal to ensure the CWG took place in 2026.

### Bengaluru achieve league record; NT head coach bemoans schedule and Bagan run Kolkata derby

The Kolkata Derby between East Bengal and Mohun Bagan SG will always be one of the most eclectic matches in Indian football with an average crowd of 60,000 and a rivalry that spans over a century. The off-field rivalry between fans sets this match up as one of the most soughtafter fixtures in the sport.

On the field though, in terms of results, there seems to be no rivalry. Mohun Bagan have dominated East Bengal, stretching their unbeaten run against their city rivals to nine in the Indian Super League. On Saturday when the two teams met again, Bagan romped to an easy 2-0 victory. Such was their dominance that East Bengal could muster just one shot on target. Bagan controlled the tempo of the match from start to finish, as a goal each from Jamie Maclaren and Dimitrios Petratos in either half was enough for Jose Molina's men to secure their eighth win against the Red & Gold Brigade in ISL.Bagan have arguably the best side on paper this season with a focus on their attack. And it was on full display in front of the capacity crowd. Attack after attack, the Mariners maintained a high momentum and tested the Red and Gold Brigade. Their relentless attacks finally bore fruit in the 41st minute when Manvir Singh, with a sensational cross, found Maclaren in space. The Australian tucked it past Prabhsukhan Gill to hand Mohun Bagan Super Giant the lead.

The second half saw more of the same as Bagan enjoyed majority of possession, but this time, their attack was even more relentless. Bagan's Liston Colaco needs to be singled out for praise. The winger kept finding himself in the right spaces, starting counter-attacks and even trying long-rangers. To have an Indian player with such confidence on the ball is a great sign for the national team. East Bengal need to recover, and fast. They are last on the ISL table with five losses from as many games and things don't seem to be looking upward. Their struggles have also been marked by significant changes off the field. Head coach Carles Cuadrat, who led the team to victory in the Kalinga Super Cup 2023, resigned, leading to the hiring of Oscar Bruzon, former manager of Bangladesh Super League club Bashundhara Kings.

Table-top clashIn the week's top-of-the-table match, 10-man Bengaluru FC held onto their 1-0 lead to beat Punjab FC and maintain their unbeaten run this season and their position as league leaders. Considering their abysmal result last season, they seem to have done a complete turnaround, even setting a new record for most minutes without conceding from the start of an ISL season (481 minutes) overtaking Jamshedpur FC (389 minutes at the start of 2017-18 season). A solitary goal from Naorem Roshan Singh was enough to hand Zaragoza's side their fourth victory of the season. And it was a blinder of a goal.Jorge Pereyra Diaz's cross from inside the 18yard area deflected onto the path of Roshan. The leftback, with a clear view of the goal, bulged the net with a thunderous left-footed drive that gave the goalkeeper no

Punjab have been excellent this season, but against a sturdy Bengaluru defence, they struggled to create inroads and were forced to try long-rangers to no success. With the loss, they slid to fourth on the ISL table though they have a game in hand.ISL scheduling 'complete disaster'Indian national coach, Manolo Marquez, who is also the head coach of FC Goa, came out strongly against the scheduling of the ISL games, saying it's detrimental to both the clubs and the national team. "The breaks are very big because the fixtures are a complete disaster. This is the reality. They don't take care about the national team," Marquez said. "The national team finished (playing on Saturday) then the ISL doesn't start six or seven days later. But they stopped the ISL (on October 5) and the national team has to play in two (three) days."Lebanon withdrew in the end but if Lebanon had played, then we would have had to play them three days after the last ISL game (before the international break), which is not normal." Marquez said he preferred if the games were played on weekends, a solution that could benefit the ISL clubs."I don't want to speak about TV rights, but to play one ISL game every day (is not for me). I prefer all the games over the weekend, if it's possible to play altogether, then better," he said.

### **Mohammed Shami seeks** inspiration from 'fighter' Rishabh Pant

Mohammed Shami says he is inspired by Rishabh Pant's patience and wants to play a couple of Ranji Trophy games before flying to Australia for the Border-Gavaskar Trophy, starting on November 22."I had spent time with Rishabh at the National Cricket Academy, where he was doing the rehab after his injury. I have seen the images, which were so scary. What inspired me the most that I never saw him sad. All his ligaments were broken but he continued his rehab with a laugh on his face. It was a massive learning for me as well. His positive attitude taught me the importance of patience," Shami said on the sidelines of an event in Gurgaon on Monday.

The 34-year-old pacer, who hasn't played for India since the 2023 ODI World Cup, was seen bowling to assistant coach Abhishek Nayar after the conclusion of the first Test between India and New Zealand at the Chinnaswamy Stadium on Sunday"It felt great yesterday. Before that. I had been bowling with a half run-up because I didn't want to put too much load on my body," he said. "We decided yesterday that I would bowl at full intensity for the last two sessions and I gave my 100%. It felt good, the results were encouraging. Hopefully, I'll be back on track soon."

Shami had been sidelined with a left Achilles heel injury for almost a year and the recent setback has derailed his comeback for the Australia tour but the bowler is optimistic about his fitness."I know everyone has been thinking about whether I will go to Australia or not but that series is still far away," he said. "The only thing I want to focus on is how to keep myself fit and how to get as strong as I can for the tour. I know what kind of an attack we want for that Test series, so it's better for me to work on the nuances and spend some more time on the ground before going."If I get fit and I get a gap of eight to ten days, then it's better that I play one or two domestic matches before going to Australia.

"I don't know when I can play next but the day I feel comfortable about bowling 20-30 overs and I get the nod



from the doctors, I'll make a run to play a match. I want to spend as much time as I can on the ground before going for the Australia series. Shami confirmed that he is still unsure about his availability for Bengal's next round Ranji Trophy fixture, beginning October 26. "Not sure about the next fixture but if I would feel that I am ready to bowl 20 overs per day and doctors will give me a go ahead I will run from my rehab," he said. The India fast bowler is also optimistic that the Rohit Sharma-led team will again win the series in Australia. Shami had played a crucial role in India's first-ever Test series win in Australia in 2018-19, when he bagged 16 wickets in four matches. However, he had played just the first Test, in Adelaide, when India toured next in 2020-21 before he returned home with an injury."We can still win. We enjoy the bounce. We won because we have four different fast bowlers. We just need to put some runs on the board and our bowlers can do the job," he said. Shami credited India's pace battery for winning the Test matches abroad. "We have worked as a unit since 2014. "India never had three bowlers at a time who could bowl over 140kph. Maybe two at max. Now we even have some on the bench who can bowl 145kph," he said."Every opponent waits for one easy kind of bowler, but that's how you create fear that all our bowlers are 145kph and have different kind of skills. And we showed how to fight when we toured overseas. Earlier we used to be on the safe side or our pace attack wasn't that aggressive. Abhi it ka jawaab patthar se dete hai (Now we know how to pay it back)."

### Mumbai's top club removes Jemimah Rodrigues over her father's 'religious activity'

Confirming the action, Khar Gymkhana president Vivek Devnani told The Indian Express: "The honorary three-year membership given to Ms Jemimah Rodrigues was revoked pursuant to a resolution passed by the members who attended the general meeting held on October 20, 2024."Khar Gymkhana managing committee member Shiv Malhotra spelled out the reasons. "We came to know that Jemimah Rodrigues's father was attached to an organisation called Brother Manuel Ministries. They booked the presidential hall for almost a year and a half and held 35 events. We all know what was happening



there," he said.

"We hear about conversions all over the country, but it's happening right under our nose. There was dancing, expensive music equipment, big screens. As per Khar Gymkhana's bye-laws Rule 4A of the constitution, Khar Gymkhana does not permit any religious activity," Malhotra said. Former Khar Gymkhana president Nitin Gadekar said he was informed about the "religious activity" by a staff member. "Me, Malhotra and a few other members went to see it. We saw the room was dark, trance music was playing and a lady was saying 'He is coming to save
