RGIA announces commencement of new Air Asia flight services to Bangkok

The flight to DMK, Bangkok FD119, will depart from Hyderabad at 11.25 pm and arrive in Bangkok at 4.30 am local Bangkok time. The return flight FD118 will depart from Bangkok at 08.50 pm local time and arrive in Hyderabad at 10.55 pm. The nonstop flight service will depart every Monday, Wednesday, Friday and Sunday adding 4 new weekly flights from RGIA to Bangkok. Pradeep Panicker, CEO GMR Hyderabad International Airport Limited said, "This development is a significant milestone in our ongoing efforts to enhance international connectivity. 'Tata-Airbus facility will make India a leading exporter of aircraft, create jobs and boost India's MSMEs': PM Modi

sions taken in the last decade" had paved the way for defence manufacturing in India, Prime Minister Narendra Modi, on Monday, expressed confidence that India would soon become a leading exporter of aircraft and meet "growing demand" in the civil aviation sector, thanks to the newly inaugurated Tata-Airbus manufacturing facil-Gujarat's Vadodara.PM Modi said that the project was a step to strengthen the "Make in India, Make for the World" mission of the government. Paying tribute to Late Ratan Tata, he said, "The (Tata-Airbus) facility is a reflection of new India's work culture... The construction of this factory started in October 2022 and is ready for production... Had we not taken definite steps 10 years ago, it would have been impossible to scale these heights. At that time... the priority and understanding was of only importing, but we decided to walk new paths and set new goals. The result is in

KTR slams Revanth Reddy's reign of terror using HYDRAA

Hyderabad: BRS working president KT Rama Rao on Monday said the Congress government was creating a "reign of terror" atmosphere among the poor, with the recent demolition drives forcing vulnerable residents to extreme actions, including suicide. He visited the grieving family of Buchamma, a resident of Kukatpally, who allegedly took her life out of fear that her home would be demolished by HYDRAA. "Buchamma's death is no suicide. It is a murder committed by HYDRAA and Chief Minister A Revanth Reddy," Rama Rao said, condemning an organised but "illegal" demolitions targeting the poor. He reminded that HYDRAA was carrying out demolitions without prior notice, even depriving children of their homes and education. He pointed out that a young girl, Vedashree, was left crying as her home was razed without even allowing her to get her books.

Speaking to mediapersons after providing financial assistance to Buchamma's family, the BRS working presi-

dent asked if HYDRAA's laws applied only to the poor. He asked why Revanth Reddy served demolition notices to his brother who lives in the Full Tank Level (FTL) of a lake, but not to the poor. He denounced the government for harassing the poor, while safeguarding influential people."The government gave permissions, collected taxes and now, is coming to demolish them after all these years. People will remember how many promises you break and how many homes you demolish," he said, adding that the Congress regime was keen to destroy the houses of the poor rather than fulfilling promises to build houses and also provide Rs.5 lakh for thosse owning a

Rama Rao also said the Congress administration was blackmailing builders and alleged that HYDRAA's actions were only an attempt to extort money from them. "Is HYDRAA merely a tool for the Ministers to threaten and extort money from builders by putting the poor at risk?' he questioned, criticising Deputy Chief Minister and Finance Minister Mallu Bhatti Vikramarka's presentations by naming a few builders and ignoring the plight of ordinary citizens. The BRS working president vowed to stand by the victims, whose lives were affected due to the HYDRAA demolitions. He said the BRS would fight alongside the poor and the needy against the Congress government's high-handedness to hold it accountable for its actions. He urged the people of Hyderabad to rise against the Congress government's anarchy.Rama Rao also visited Vedashree at her residence and handed over her books, a school bag and other stationery apart from providing financial assistance to her family. He consoled them and assured all possible support and legal aid on behalf of the BRS.

people's cause and though the party had lost several elections, it continued to be strong. The DMK was built thus, fighting for people's issues, whereas Vijay's party aspires to be in power in 2026, immediately after entering politics. Tit-for-tat strike

ITCHING to retaliate against the October 1 Iranian attack, Israel struck missile manufacturing facilities and other military targets in Iran on Saturday. Though Israeli Prime Minister Benjamin Netanyahu claimed that the parrage "achieved all its goals", it would be naïve of him o assume that Tehran will not respond militarily sooner or later. The fact that the strike took place more than hree weeks after the ballistic missile attack by Tehran ndicates that Tel Aviv preferred to wait and watch beore taking action. Nevertheless, this is a grave provocation that can push West Asia deeper into the mire.

Israel has dismissed reports that it avoided hitting ranian gas and oil facilities because of US pressure, but it is apparent that Tel Aviv is reluctant to start a full-lown war against Iran. Already grappling with Hamas and Hezbollah, Israel has intended to send out a strong nessage to Iran's Supreme Leader and military comnanders. However, even the presumably limited scope of the Israeli operations is enough to infuriate Iran. If srael has the right to self-defence, so does Iran. If this ricious cycle of retaliation and counter-retaliation coninues, regional tensions are bound to escalate.

American President Joe Biden is hopeful that the sraeli strike would mark the end of the confrontation. It is optimism is clearly misplaced as Iran is keen to keep Israel on tenterhooks, either directly or through its military proxies. Exercising restraint is alien to both nations, but they do need to carefully consider the ramifications of this destructive course not only for West Asia but also the world at large. Warmongers such as Israeli Minister of National Security Itamar Ben-Gvir, who called he October 26 strike "a good beginning in order to target Iran's strategic assets, which needs to be the next phase", must not be given free rein by the Netanyahu

Increase in post-doc fellows at IIT Bombay enhances institute's research outcome

IITWhile a vast infrastructural makeover is underway, the institute also spoke about other steps taken for fostering academic and research excellence as recommended in the review-report. The Indian Institute of Technology (IIT) Bombay has seen a considerable jump in post-doctoral fellows on campus — from not being able to fill even 25 seats when it started ten years ago, to a total 400 fellows actively engaged in various research projects at present — indirectly enhancing the institute's

The premier technology institute from the city on Thursday, released its five-year (2018-2022) review conducted by an external agency in two phases over a period of several months of 2023. Noting various observations by the review committee, the IIT Bombay administration also highlighted initiatives already undertaken which align with the recommendations from the report.

While a vast infrastructural makeover is underway, the institute also spoke about other steps taken for fostering academic and research excellence as recommended in the review-report. "While maintaining its overall commitment to academic and research excellence, IIT Bombay should prioritize a few select research directions (like Al. ML, Biotech and the like, as per its own goals) covering both blue sky and applied / translational topics that are poised to drive transformative change on both national and international scales," states the report which further instructs the institute to enhance its post-doctoral programme. It stated, "The Institute must promote a vigorous post-doctoral programme to enhance research output and must plan to arrange accommodation for this class of researchers, who neither qualify as students or faculty, but are well recognized worldwide as a very important segment of an ecosystem that nurtures academic and research excellence."The institute pointed out how the number of post-doctoral fellows on campus is already on the rise. Prof. Neela Natraj, Dean of Faculty affairs at the IIT Bombay, said, "Currently there are 400 post-doctoral fellows with us. This is a considerable increase from not being able to have even 25, which was the capacity allowed when the post-doctoral programmes commenced at IIT Bombay, ten years ago.

One of the important reasons for this surge according to the institute is also because of inclusion of postdoc experience in eligibility criteria for faculty appointment at various academic institutions. Prof. Milind Atre, Deputy Director (Academic, Research and Translation) at IIT Bombay, explained, "Many new IITs and other educational institutions require their teachers to have postdoc experience before they are appointed. Many of our post doc fellows then head to these IITs as faculty members."This requirement of experience, according to the institute administration, can vary from one to three years, as per different academic institutes but it has led to many taking up the postdoc opportunities at IIT Bombay and leaving after having confirmed jobs in desired institutes."Thus, these are continuously floating positions as we witness post-doc fellows leaving as soon as they get jobs. We are continuously recruiting new eligible fellows, simultaneously," said Prof. Natraj while adding that strengthening of post-doctoral programs has further enhanced research outcomes. What is post-doc fellowPost-Doctoral researchers are those who are already PhD holders and wish to continue their research study after the doctorate. These are training positions temporarily acquired by dedicated researchers to gain more experience and acquire new skills to enhance careers, especially in the field of academics.

Evacuated due to cyclone Dana, two pregnant women give birth in West Bengal hospital

Amid Cyclone Dana's impending landfall, Digha State General Hospital welcomed two new lives. Two pregnant women, safely evacuated from their homes, gave birth to a baby boy and a baby girl each. One of the new fathers, Shibu Das, expressed his relief and gratitude. "My wife, Sushmita, was due on October 22. As the cyclone approached, our anxiety grew. Thankfully, the state administration was prepared. An ASHA worker evacuated her in an ambulance, and she was brought here just in time," he told s. Sushmita delivered a healthy baby girl. Overjoyed, Shibu decided to name her "Brishti," meaning "rain." He explained, "It was raining heavily the night she was born. I wanted to remember that special moment forever." Das is a resident of Padima 2, a flood

and cyclone-prone area of Purba Medinipur district. She was brought to the hospital on October 24, the day of her child's birth. "Her full name will be Priyanka, but we'll call her Brishti. It rhymes with her cousin's name, Misti," Shibu smiled.

Remembering how his area was flooded during 2020's Cyclone Amphan, he praised the district administration for their efforts in ensuring safe deliveries during such a challenging time. While he expressed some "concerns" about the behavior of consulting doctors, he acknowledged the overall care and support provided by the hospital staff"Seven pregnant women were evacuated and brought to the hospital. Two of them have safely delivered. The rest are admitted at the Digha State General Hospital," said BDO Ramnagar Puja Debnath.Like Sushmita, 36-year-old Rama Bera also gave birth on October 24, hours after she was brought to hospital. "I am happy that I have a healthy baby... I was very much in tension since the day the weather office alerted us about Cyclone Dana," said Bera. Her husband Laltu Bera is yet to decide on his son's name. He recalled how during Amphan he had to send his father, who is paralyzed, to someone else's house after his home was inundated. "We were waiting for a normal delivery... Suddenly, there was a cyclone alert. Thankfully, my wife was safely brought to hospital," said the resident of Vishwanathpur,

'Sexually harassed, forced to discharge accused in murder case': Punjab woman police officer booked in graft case

Two days after being booked in an alleged bribery case for letting off drug peddlers after accepting bribe of Rs 5 lakh, Punjab Police inspector Arshpreet Kaur Grewal on Friday levelled serious allegations, including sexual harassment, against senior officials in Moga police. Posted as the Station House Officer of Kot Ise Khan police station (under sub-division Dharamkot) in Moga district, inspector Grewal along with two junior police officials, was booked on October 23 under the sections of Prevention of Corruption Act (PCA) for allegedly accepting Rs 5 lakh bribe from two drug peddlers for excluding their names from the First Information Report (FIR) after the recovery of 2 kg opium from them. Grewal had levelled allegation of sexual harassment against DSP (Dharamkot) Ramandeep Singh, a former hockey Olympian. She also alleged that Bal Krishan Singla, Superintendent of Police (investigation) had forced her to discharge the accused in a murder case of a Congress leader.

In a detailed purported Facebook post on Friday, Grewal wrote that "false and frivolous case" was registered against her to "save the DSP" who "attempted sexual harassment at workplace." In another allegation, Grewal further claimed that Moga SP (investigation) had forced her to discharge four accused in the murder case of a Congress leader and when she denied, she was threatened with "dire consequences". Grewal wrote that "she was quiet all this time, taking care of the reputation of her family" and also because "she was a part of the Punjab Police family for 10 years." Commenting on the latest corruption case registered against her for accepting bribe to let off drug peddlers, Grewal wrote that she was neither the investigation officer, nor was present on the spot when the raid was conducted and 2 kg opium recovered. She alleged that the main accused in the case was tortured to record a statement against her, allegedly due to the pressure of SP and DSP. Grewal's family member, requesting anonymity, told The Indian Express that the Facebook post was authentic and posted by her. "She has been framed in a false case and has expressed her side of the story on her FB," he said. Meanwhile, Moga SP (headquarters) Gursharanjit Singh, who also heads the internal committee for sexual harassment cases, said, "We never received any complaint, either verbal or written, from Inspector Arshpreet Kaur Grewal. A probe will be conducted if she submits a complaint.'

'Pressured to discharge accused in murder case'Grewal's allegations against SP Singla relate to the investigation in the murder case of Congress leader Baljinder Singh Balli who was shot dead at his residence in Dala village of Moga on September 18, 2023.Grewal in her post has alleged that in August 2024, when she was posted as SHO of Mehna police station, Singla called her to SSP's office and asked her to give the discharge application of four accused in "high-profile" Balli murder case. Grewal claimed that after she denied doing so, as the accused were named by the wife of the deceased and the case was already in court, the SP threatened her

with dire consequences. "It was a high profile case. One day the then SSP sir Moga, SP-D Bal Krishan Singla and other officials called me at SSP Sir's office and asked me to give the discharge application of 4 accused who were nominated by name in an FIR by the wife of the deceased... I denied and tried to resist that and conveyed to SSP sir and Bal Krishan Singla Sir that charges have already been framed in the Hon'ble court.. but... Singla pressured me and told me that we have ordered you to do this," wrote Grewal in her post. She further wrote that after returning to the police station, she entered a thorough Daily Diary Report (DDR) stating that she was given verbal orders by Singla and then Moga SSP to give the discharge application of four accused stating they are innocent. Grewal said that after senior officials including Singla got to know that such DDR has been registered, "they started harassing me saying "Bakhsha ge nhi tenu" (We will not spare you). She alleged that Singla called her to his office and said, "Tu yaad rkhe gi v DDR entry kive payi di hai." (You will remember how DDR entries are registered).

Grewal alleged that after she put the DDR entry stating the verbal orders she was given to discharge the accused in murder case, she was "mentally harassed by one means or the other." She alleged she was humiliated and scolded in front of her subordinates. Meanwhile, SP Singla told The Indian Express that he was not posted in Moga at the time of the murder, nor was he associated with its investigation. "However, later after my posting here, four accused had applied for bail and they were released on High Court orders. The inspector in question is currently absconding in a corruption case. Any further comments would hamper our investigation. The FIR has been registered against her purely on the basis of a complaint," the officer added.

Sexual harassment allegations against the DSPIn the same FB post, Grewal further wrote that in a recent incident some days ago on a Sunday, she had gone to attend a religious programme in civil clothes. She alleged that when she along with another woman police officer

reached a cafe to have food, Dharamkot DSP Ramandeep Singhh was already sitting there. She alleged that after all officers had food together, the DSP asked her to come to his office and meet him before leaving. Grewal further wrote that when she tried to explain her situation to SSP Moga, she was told that her senior (DSP) had filed complaints against her which were being verified. In ever knew that SP-D and DSP Dharamkot will go to this extent...," wrote Grewal, alleging that false FIR against her has been registered to "teach a lesson" as she registered the DDR against the SP and accused DSP of sexual harassment. Nearly two months after a migrant worker from West Bengal was lynched in Haryana's Charkhi Dadri district over the suspicion that he had consumed beef, the police said on Friday that a lab report showed that the meat was not of cattle. Sabir Malik, 22, was beaten to death in Charkhi Dadri district on August 27. Hours before he was killed, the police had been called to the village by a group of youths, who claimed beef was being cooked and consumed in shanties there. Even as the meat was seized by the police and sent for testing, the accused, the police said, beat Malik to death. "The cooked meat collected from the spot was sent to a molecular lab in Faridabad. It has emerged that the meat was not cattle's," Bharat Bhushan, Deputy Superintendent of Police, Badhra, told The Indian Express. The arrest of six people is pending and they will be arrested soon, he added. Malik's relatives told The Indian Express that the same day, they had been called to the police station and asked if they consumed beef.Pooja Vasisht, Superintendent of Police, Charkhi Dadri, said, "We have arrested 10 people and this report will be submitted in the court along with the challan soon."Malik came to the state to work as a ragpicker and was living with his wife and two-year-old daughter in Hansawas Khurd village. According to investigators, the accused called Malik and his friend Aseeruddin to a shop under the pretence of selling empty plastic bottles and allegedly assaulted them. Gaza faces risk of polio spreading if vaccination continues to delay: UN

United Nations: An immediate ceasefire is needed in the Gaza Strip as the enclave faces the additional threat of polio spreading, if the final phase of a vaccination campaign continues to be delayed, an UN agency warned The third and final phase of the polio vaccination campaign, which was set to start on Wednesday in Gaza, had to be postponed due to the escalating violence, intense bombardment, mass displacement orders, and lack of assured humanitarian pauses. "It is imperative to stop the polio outbreak in Gaza before more children are paralysed and the virus spreads," said Louise Wateridge, spokesperson for the UN Agency for Palestine Refugees (UNRWA). "The vaccination campaign must be facilitated in the north through the implementation of humanitarian pauses."The current conditions, including ongoing attacks on civilian infrastructure, continue to jeopardise people's safety and movement in northern Gaza, making it impossible for families to safely bring their children for vaccination and health workers to operate, Wateridge said. Since the beginning of the second round of the polio vaccination campaign on October 14, 442,855 children under age 10 have been successfully vaccinated in Gaza, representing 94 per cent of the target in these areas, Xinhua news agency reported. To interrupt the transmission, at least 90 per cent of all children in every community and neighbourhood need to receive a second vaccination following the first round, including more than 119,000 children across Gaza

Sushant Singh Rajput death: SC dismisses appeals challenging Bombay HC order quashing Look Out Circulars against Rhea Chakraborty, others

Sushant Singh Rajput caseHearing the appeals, Justice B R Gavai presiding over a two-judge bench cautioned the petitioners that the plea was "frivolous" and was being filed "only because one of the accused is a high-profile person". The Supreme Court Friday dismissed appeals challenging the Bombay High Court order quashing the Look Out Circulars against actress Rhea Chakraborty and others in connection with the Sushant Singh Rajput death case. The Maharashtra Government, CBI, and the Bureau of Immigration had approached the Supreme Court challenging the February 22, 2024, order of the high court quashing the August 2020 circulars.

Hearing the appeals, Justice B R Gavai presiding over a two-judge bench cautioned the petitioners that the plea was "frivolous" and was being filed "only because one of the accused is a high-profile person". "We are warning you... You are filing such a frivolous petition only because one of the accused is a high-profile person... It will be dismissed with exemplary cost. Both persons have deep roots in society," Justice Gavai remarked orally. Justice K V Viswanathan who was also part of the bench did not hide his surprise either. "You issue LOC for all this," he exclaimed.

The immigration authorities had issued the LOCs against Rhea Chakraborty, her brother Showik Chakraborty, their father and army veteran Indrajit Chakraborty, and mother Sandhya Chakraborty at the instance of CBI which probed Rajput's death in 2020. An LOC bars an individual from travelling abroad without prior permission of the court. Rajput was found dead in his apartment in suburban Bandra on June 14, 2020. His father, in July 2020, complained to the Bihar Police that Rajput's girlfriend Rhea Chakraborty and her family members had abetted his son's suicide. Rhea Chakraborty was arrested in September 2020 in connection with a drug case filed by the CBI and granted bail in October 2020. The Centre did not challenge it further before the Supreme Court. Among the conditions of her bail was seeking permission from the court before travelling out of the

In December 2023, the high court suspended the LOC issued against Rhea Chakraborty and allowed her to travel to Dubai for a week (December 27 to January 2) for a pet food company event as a brand ambassador. In September 2023, it suspended the LOC against Showik Chakraborty, permitting him to travel to Australia. The bench held that the submission of special public prosecutor Shreeram Shirsat that the LOCs be kept pending and petitioners can file applications for suspension when they wish to travel abroad, 'cannot be entertained'. The HC noted petitioners were last called in September 2021. The HC observed, "The right to travel is a fundamental right and cannot be curtailed except according to procedure established by law. The LOC cannot be kept pending indefinitely, in this case for more than 3.5 years, though the petitioners have cooperated with the investigation, which fact has not been disputed. There is already a condition imposed on petitioners Showik and Rhea in the NDPS case not to leave the country without the permission of the court."

tive to reduce the need of patients to go outside the state for treatment. India needs more observational capacity for space debris: Isro Chairperson S Somanath

With the increasing numbers of satellites and debris in low earth orbit, Indian Space Research Organisation (Isro) Chairperson S Somanath recently said India needed to create its own observation capability for situational awareness. Situational awareness is a process of tracking the size, velocity, and movement of objects in orbit in order to prevent the collision of satellites or upper stages of launch vehicles in space. "Unless you have strong observational capability, there is no point in working in space situational awareness... while we have perfected our mathematical prediction capability, we need to improve our observational capability," said Somanath, adding that unless observational capability is in space, a country will need to depend on others for orbital data, which they have to believe is correct and think that their satellites are safe. "This may not be true always," he fur-

Space situational awareness may require several technologies including radars, optical telescopes, radio telescopes, geo-locating sensors, lasers, space weather forecasting sensors, and even sensors onboard other satellites. There are 40,500 objects over the size of 10 cm, 1.1 lakh objects of size 1 cm to 10 cm, and 130 million objects of size 1 mm to 1 cm in orbit. The challenge is that these objects all move with different velocities ranging from 7 km per second to 20 or 25 km per second. They move in different directions. And, even small objects such as paint fragments can be dangerous to satellites due to the high velocity. Somanath said the bigger challenge, however, is with objects between 1 cm and 10 cm in size. They are big enough that they cannot be handled by debris shielding but they are so small that they are not easily tracked.

He spoke about the need to move towards automated collision avoidance manoeuvre. Somanath said that even with just over 50 satellites, India needed to

perform 100 collision avoidance manoeuvre in the last one year. "Now think if it needs to be done for thousands - will it be humanly possible? We have to hand over the task to computers to do it autonomously," he said. He added that the change in direction or velocity of the satellites is currently planned carefully after observing the objects for a couple of days to ensure there is no collision and minimum fuel use. Notably, Somanath said that the orbits of the moon and Mars have also started becoming crowded. He said that Isro had to perform a collision avoidance manoeuvre for Chandrayaan-2 when a Korean satellite came close. Prediction of the orbit of the objects in moon orbit is much more difficult than in earth orbit because of less accuracy due to the distance and also the uneven gravitational field of the moon, meaning the satellites change height with time, Somanath said. With large constellations being launched - and the space getting crowded - Somanath said that it is important that countries work towards reducing their debris.

This is the first exam that has been cancelled since the senior teachers' recruitment test in 2022. The development comes two days after 28 people, including 11 government employees, were arrested in connection with the alleged leak following statewide raids. "On the date of conducting the exam May 14, 2023, multiple FIRs related to cheating were registered in Bikaner. After three primary reports were filed regarding cheating of many candidates using Bluetooth and after their investigation, the crime was found to be proven that the integrity and confidentiality of the Revenue Officer Grade-II and Executive Officer Class-IV Examination, 2022 (Exam Date 14 May 2023) has been violated. That is why the Commission has decided to cancel the exams and re-examination will



be done," said RPSC secretary Ramniwas Mehta.Some 1,96,483 candidates had appeared in the Executive Officer Class IV and Revenue Officer Grade-II examination conducted for 11 posts on May 14, 2023. A total of 311 candidates were shortlisted for eligibility check and document verification. Suspicions were raised after candidates allegedly showed a basic lack of knowledge of the subjects involved during document verification in August, leading the commission to write to the SOG. On October 19, the SOG conducted raids in a total of seven districts — Nagaur, Jodhpur, Churu, Hanumangarh, Sikar, Jaipur, and Bikaner. Of the 28 arrested, 17 were produced before a local court, which remanded them in police custody.

Mission 'zero casualty' a success, declares Odisha CM Majhi after cyclone Dana makes landfall

There were reports of damage to thatched houses and disruption of road transportation in some parts of Odisha's northern districts due to trees being uprooted. "Our mission of zero casualty has been successful because of administrative proactiveness and because of timely action taken by the state government. Social media, online ads making sex trafficking easier, report that studied cases in Goa suggests

A majority of women forced into sex trafficking in Goa were from the "source states" of Maharashtra, West Bengal, Delhi and Uttar Pradesh. At the same time, Nepal and Bangladesh continue to be the major "source countries" for crossborder sex trafficking, and East African countries - Uganda and Kenya - are emerging as major "source regions". These were among the major trends highlighted in a new study on sex trafficking in Goa.

Conducted by Anyay Rahit Zindagi (Arz) — an NGO which works with Goa police to combat sex trafficking in the state - the study, titled 'Report on Commercial Sexual Exploitation in Goa - Situation and Intervention (2019-2024)' was released Wednesday at an international consultation event in the presence of Goa chief minister Pramod Sawant in Panaji. It analysed data of 75 rescue operations conducted by the Goa Police between June 2019 and July 2024.A "source state", according to the

authors, is the state from where the victim of sex trafficking was trafficked to Goa and does not necessarily mean the place to which she originally belongs. The study says that a total of 172 women and minor girls were rescued from human and sex trafficking rings between June 2019 and July 2024. Of these, 138 were of Indian origin from over 20 states while 34 hailed from Bangladesh, Bhutan, Kenya, Kyrgyzstan, Turkmenistan, Nepal, Uganda and Uzbekistan.Of the rescued, 157 were within the 18 to 35 age group, while only four were minors. The report savs that the modus operandi and patterns of trafficking have become more "organised" and the advancement of social media sites and online platforms for soliciting and communication has made it easier for the traffickers to

A significant number of women were trafficked to Goa "under the pretence of jobs in clubs, bars, hotels, and casinos, where they were promised roles as waitresses, dancers, or companions to clients, especially tourists" and then coerced into commercial sex activities, it says. "The major source areas - Maharashtra, West Bengal, Delhi, Nepal and Bangladesh - remain unchanged. The newly emerging areas are Uttar Pradesh for internal trafficking and Kenya and Uganda for cross-border trafficking. Goa is becoming a destination for sex trafficking also because the demand is high and the payment and working conditions are good," the report says. It argues that the victims, in most cases, were the primary breadwinners for their families, managing their households on modest incomes, who lost their jobs during the pandemic and were forced to take loans to survive. According to the study, online advertisements for commercial sexual activities in Goa have contributed to the rise in sex trafficking because they "enable" traffickers and buyers to remain anonymous. The Darbar Move is the bi-annual shift of the state secretariat and other government offices from the summer capital Srinagar to the winter capital Jammu. A tradition started during the rule of Maharaja Ranbir Singh in 1872, it continued until 2021, when the UT administration said state secretariats would be maintained in both Jammu and Srinagar.

In an order dated October 23, Commissioner/Secretary General Administration Department Sanjeev Verma said that for effective and efficient conduct of official busi-

ness at civil secretariat, "it is hereby ordered that the Administrative Secretaries and the Union Territory Level Heads of Departments shall ensure their availability at civil secretariat, Jammu, with effect from November 11". But the order also said that these officials will attend the civil secretariat in Srinagar "as per functional requirement", i.e. when needed. It also asks the estates department to provide accommodation to government officers/officials requisition by their administrative departments". According to a senior government functionary, this was not new and was a usual "public friendly" and "good administrative arrangement" that the UT administration has been doing post June 2021 to "ensure availability of administration at the doorsteps of the people at both Jammu and in Srinagar simultaneously". He was referring to the 2021 government order abolishing the Darbar Move and establishing secretariats at both places. However, sources pointed out that even in April 2024, the government had ordered only the administrative secretaries to move from Jammu to Srinagar effective May 1, although requiring them to attend the civil secretariat at Jammu "as per the functional requirement". Both the ruling NC and its alliance partner Congress had promised to reinstate the move. However, what will not be moving are the physical office files and the employees maintaining them. According to sources, this would not impact the government functioning given that official records have already been digitised. The Darbar Move was first suspended in 2020, when the UT administration cited the pandemic. In June 20, 2021, J&K L-G Manoj Sinha announced that the administration had transitioned to e-office, thus abolishing the bi-annual sec-

1.5 degrees Celsius target will be 'gone' in a few years: UN reportIt said the global emissions in 2023 was 1.3 per cent higher than the previous year. Greenhouse gas emissions of China and India, two of the top three emitters, grew by 5.2 per cent and 6.1 per cent respectively in the year 2023, a new UN report revealed on Thursday.It said the global emissions in 2023 was 1.3 per cent higher than the previous year.

The Emissions Gap Report, an annual publication of the UN Environment Programme, warned that the Paris Agreement objective of keeping global rise in temperatures to within 1.5 degree Celsius would be "gone within a few years" and even the 2 degree Celsius threshold would be in danger of being breached, unless countries dramatically scale up their climate actions to reduce global emissions in two years. The report, which is released just ahead of climate change conference every year, said current climate actions, even in the most optimistic scenario, could reduce global greenhouse gas emissions by only 10 per cent by 2030 on 2019 levels, when the bare minimum required to keep the 1.5 degree target in sight was 42 per cent reduction. The reductions must

increase to 57 per cent by 2035. As such, the updated climate action plans which every country has to submit by next year, must be significantly stronger than the current ones, the report said. However, global emissions are still on the rise. The report said a sharp turnaround, with at least a 7.5 per cent reduction every year till 2035, was essential to keep the 1.5 degree target alive. The report called for a massive increase in investment in emissions reductions. It said the emissions gap for 2030 and 2035 could still be bridged at the cost of US\$ 200 per ton of CO2 equivalent. At this cost, about 31 billion tonnes of CO2 equivalent could potentially be reduced from annual emissions by 2030, more than the nearly 28 billion CO2 equivalent that is required for 1.5 degree goal.In three weeks, countries are scheduled to assemble for the annual climate conference in Baku where delegates will discuss a major scale-up of financial resources for climate action. Every fraction of fossil fuel emissions is pushing us closer to catastrophe. The findings of Emissions Gap Report are alarming yet again, while political inaction threatens to lock in irreversible damage," said Harjeet Singh, Climate Activist and Global Engagement Director for the Fossil Fuel Non-Proliferation Treaty Ini-

Rajasthan mother drowns infant son after 8 years of longing for a child: Report

Department in Ratangarh, Rajasthan. He mentioned that the deceased was their first child, born after eight years of consulting doctors and praying at various temples. According to police reports quoted by News18. after arriving at the scene of the incident, the family claimed that an unknown individual had thrown the child into the water tank. However, following discussions with the family and a detailed examination of the area, the police revealed that the child's mother, Suman Saini alias Saroj Devi, was responsible for the infant's death. In an attempt to mislead her family, she pretended to cry and faint. With the evidence pointing to her guilt, the police arrested the mother for her son's murder. The report further said that preliminary investigations indicated the mother was dealing with mental distress, which led her to take her own son's life. She had experienced anxiety about his upbring-

ing and future since his birth.

Rahul Gandhi targets Centre over terror attacks in Jammu and Kashmir

Congress MP Rahul Gandhi on Friday criticised the central government over the recent terror attack on army vehicles in Jammu and Kashmir's Baramulla district, claiming that the Centre has "completely failed" to establish security and peace in the Union Territory."I pay my tribute to the martyrs and express my deepest condolences to all the bereaved families... Contrary to their claims, the reality is that the state is living under a shadow of danger due to continuous terrorist activities, attacks on our soldiers and targeted killings of civilians," Gandhi, who is also the Leader of Opposition in Lok Sabha, said in a post on X (formerly Twitter). He urged the government to take accountability and immediately restore peace in the Valley.On Thursday, two soldiers and two civilians were killed after terrorists ambushed army vehicles in Baramulla's Botapathri, roughly 6km from the tourist hub of Gulmarg. The UT has witnessed several terror strikes since the conclusion of the assembly elections.

Chief minister Omar Abdullah called the attack "unfortunate" and expressed concern over the increase in such incidents."Very unfortunate news about the attack on army vehicles in the Boota Pathri area of North Kashmir which has resulted in some casualties and injuries.

This recent spate of attacks in Kashmir is a matter of serious concern. I condemn this attack is the strongest possible terms & send my condolences to the loved ones of the people who lost their lives. I also pray that the injured make a complete and swift recovery," he wrote on X.Nasir Aslam, advisor to the J&K chief minister, emphasised the importance of statehood to the UT, and said, "Jammu and Kashmir cannot be run under dual control - that the security management is under the Lieutenant Governor's control and the rest is with the CM. We hope the statehood is restored and a unified command can fight against the (security) challenges." J&K Lieutenant Governor Manoj Sinha condemned the acts of terrorism, said the sacrifice of soldiers "will not go in vain." "Spoke to top army officials on heinous terror attack in Butapathri Sector. Directed for swift & befitting reply to neutralise terrorists. Operation in progress. Sacrifice of our martyrs will not go in vain. Condolences to their families. Praying for speedy recovery of injured," Sinha said. National Conference chief and former J&K CM Farooq Abdullah said Kashmir will not become a part of Pakistan and asked the neighbouring country to 'end the promotion of terrorism in the Valley'."Innocent people are being killed, and we will never become a part of Pakistan. So why are they doing this? Is it to ruin our future?" he asked, adding, "They ought to focus on problems facing their nation. I urge them to end this and find a way to be friends... otherwise, it will be very difficult for them."J&K's Bharatiya Janata Party (BJP) chief Ravinder Raina said, "Pakistan's terrorists attacked an Indian Army vehicle which was passing from Baramulla's Gulmarg. They do not have the courage to face the soldiers of Indian Army, and that is why, they attacked them from the shadows. These terrorists will not be spared. NIA has not found any sabotage in recent train derailments: Officials

In past two months, several cases have come to the fore wherein obstructions in the form of gas cylinders, boulders, or broken rails have been placed on tracks. The National Investigation Agency (NIA) has so far not found any angle of sabotage in the recent accidents on railway tracks, people familiar with the development said on Friday. The federal agency is probing at least four accidents as part of a preliminary enquiry (PE), they said, adding that the probe is still on.

An official who asked not to be named said on Friday, "We have so far not found any sabotage in the train derailment incidents but the probe is continuing. We are looking into four such accidents as part of a PE."In the past two months, several cases have come to the fore wherein obstructions in the form of gas cylinders, boulders, or broken rails have been placed on railway tracks with the intent to cause damage to trains or harm passengers. Union railways minister Ashwini Vaishnaw had said last month that the Indian Railways has sought the help of NIA to probe the accidents. "The railway administration has taken the matter very seriously. We are



in constant touch with the state governments and their director generals of police, home secretaries. NIA has also been involved," Vaishnav said on September 24.On September 22, the driver of a goods train from Kanpur to Prayagraj spotted a gas cylinder on the track and managed to stop the train. On September 15, a damaged cylinder and a Molotov cocktail was found on a track that the Kalindi Express was to pass on.

'He's promoting Khalistanis...': Capt Amarinder Singh's big charge at Canada PM Justin Trudeau

Former Punjab chief minister Captain Amarinder Singh on Friday alleged that Canadian prime minister Justin Trudeau is responsible for India-Canada's rocky relationship and alleged that he was promoting the Khalistani propaganda. The BJP leader told ANI, "Canadian PM Trudeau has ruined the relationship between India and Canada. Trudeau is interested in only one thing and that is getting the Sikh votes for his own election. He doesn't care what happens, he has done this earlier also. He is promoting Khalistanis at the moment."Alleging that Trudeau is supporting Khalistanis, Singh said that the Canadian PM is only interested in attracting Sikh votes in Canada given the fact that elections are approaching. "This is something that is not acceptable. When I was in government, the Canadian defense minister was in India visit, I refused to meet him," said Captain Singh on the India-Canada diplomatic row. The ties between India and Canada soured after Trudeau alleged in the Canadian Parliament last year that he has "credible allegations" of Indian government agents' involvement in the killing of Khalistani terrorist Hardeep Singh Nijjar.

India has denied all the allegations, calling them "absurd" and "motivated" and has accused Canada of giving space to extremist and anti-India elements in their country. The recent diplomatic row erupted between the two countries when Canada labelled India's High Commissioner and other diplomats as "persons of interest" in the investigation of Nijjar's death. Canadian Prime Minister Justin Trudeau faces calls for resignation as Liberal leader as Liberal MPs convened on Parliament Hill, according to a report by CBC News. During the closed-door meeting, dissenting MPs conveyed their grievances to Trudeau, reflecting growing discontent within the party. Dissident Liberal MPs also presented a document during the meeting giving Trudeau an ultimatum to decide his future by October 28, however, it didn't specify any consequences if he fails to meet the deadline. TBILISI, Oct 25 (Reuters) - The South Caucasus country of Georgia holds a parliamentary election on Saturday that pits a government seen as leaning increasingly towards Russia against an opposition that champions integration with the West.* A mountainous country of around 3 million people between Russia and Turkey, Georgia gained independence from the Soviet Union in 1991 and has followed broadly pro-Western policies ever since.* Many Georgians dislike Russia, which ruled the country for around 200 years and backs two rebel regions, Abkhazia and South Ossetia, that broke away from Tbilisi's control in the 1990s. Russia defeated Georgia in a five-day war in 2008.RUSSIA VS WEST

Georgian Dream has in the last two years shifted towards pro-Russian rhetoric, accusing Western countries of seeking to drag Georgia into war with Russia. It has also deepened ties with China.* The party is dominated by Bidzina Ivanishvili, a billionaire ex-prime minister who is Georgia's richest man and is generally regarded as its most powerful person.* Opinion polls show that Georgians are broadly supportive of joining the EU and NATO, but are also keen to avoid conflict with Russia, and deeply conservative on issues such as LGBT rights. Georgian Dream has campaigned on keeping Georgia out of the war in Ukraine.* The election comes days after Moldovans narrowly approved EU accession, in a vote Moldovan authorities said was marred by Russia-backed

AUTHORITARIANISM AND PROTESTS* Georgian Dream has passed a series of hotly contested bills, including a law requiring groups that receive funds from abroad to register as "foreign agents".* Opponents staged mass demonstrations, describing the legislation as authoritarian and inspired by similar laws used to curb dissent in Russia.* The bill caused a crisis in relations with the West, with the U.S. sanctioning several Georgians for human rights abuses and threatening to end aid to Tbilisi.* Other legislation has clamped down on gay rights. Israeli strike kills journalists in Lebanon, Blinken sees urgent need for resolution

BEIRUT/JERUSALEM/LONDON ,An Israeli strike killed three journalists in south Lebanon on Friday, Lebanon's health ministry said, and the UN refugee agency warned that Israeli airstrikes on a border crossing with Syria were hindering refugees trying to flee the war.U.S. Secretary of State Antony Blinken said there was an urgent need to get a diplomatic resolution to the conflict, a day after he said Washington did not want to see a protracted campaign in Lebanon by its ally Israel.Israel launched its major offensive in Lebanon a month ago, saying it was targeting the heavily armed, Iran-backed Hezbollah group to secure the return home of tens of thousands of Israelis evacuated from the north due to cross-border rocket attacks.

The conflict was sparked by the Hamas-led Oct. 7, 2023 attack on Israel which triggered Israel's offensive in Gaza, where Palestinian officials said Israeli strikes had killed at least 72 people since Thursday night.Beirut authorities say Israel's Lebanon offensive has killed more than 2,500 people and displaced more than 1.2 million, sparking a humanitarian crisis. The journalists killed in south Lebanon were Ghassan Najjar and Mohamed Reda of the pro-Iranian news outlet Al-Mayadeen and Wissam Qassem, who worked for Hezbollah's Al-Manar, the outlets said in separate statements. Several others were wounded. They had been staying at guesthouses in Hasbaya, a town not previously targeted, when it was hit around 3 a.m. (midnight GMT). Five journalists have been killed in previous Israeli strikes while reporting on the conflict, including Reuters visual journalist Issam Abdallah on Oct. 13, 2023. "This is a war crime," Lebanese Information Minister Ziad Makary said. At least 18 journalists from six media outlets, including Sky News and Al-Jazeera were using the guesthouses.

"We heard the airplane flying very low - that's what woke us up - and then we heard the two missiles,' Muhammad Farhat, a reporter with Lebanese broadcaster Al-Jadeed, said. His footage showed overturned and damaged cars, some marked "Press". There was no immediate comment from Israel, which in general denies deliberately attacking journalists. The U.N. peacekeeping mission in Lebanon said on Friday Israeli forces fired at their troops in an observation post in southern Dhayra on Tuesday, leading them to leave the post though they remained at the base. Israel has denied deliberately targeting the force but its previous strikes on UNIFIL posts have drawn international condemnation.

BORDER CROSSING STRUCKIsrael has used airstrikes to pound southern Lebanon, the Bekaa Valley and Beirut's southern suburbs, and has also sent ground forces into southern Lebanon against Hezbollah. It said Hezbollah used the crossing, controlled by the Syrian military, to transfer



weapons into Lebanon.Lebanon's transport minister Ali Hamieh said the Israeli strike had knocked the Jousieh crossing out of service, leaving the northern route as the only way to Syria. The UN refugee agency said the strikes were hindering refugees' attempts to flee. UNHCR spokesperson Rula Amin said some 430,000 people have crossed to Syria since Israel's campaign started. Lebanon has previously been a major destination for refugees from the Syrian civil war. "The attacks on the border crossings are a major concern," Amin said. "They are blocking the path to safety for people fleeing conflict."

'REAL URGENCY'The Israeli campaign spiralled out of a year of cross-border hostilities with Hezbollah, which opened fire on Oct. 8, 2023, in solidarity with its Palestinian ally Hamas, a day after it launched the Oct. 7 attack. "We have a sense of real urgency in getting to a diplomatic resolution and the full implementation of UN Security Council Resolution 1701, such that there can be real security along border between Israel and Lebanon," Blinken said in London. He said it was important so "people at both sides of the border can have the confidence to... return to their homes". Hezbollah has kept fighting despite painful blows, including the killing of its leader Hassan Nasrallah. Israel said five of its soldiers had been killed in combat in southern Lebanon, after announcing on Thursday the deaths of five others. The Israeli military said it had uncovered an underground command centre in a village close to the border with Israel and a site concealed in wooded terrain where Kornet anti-tank missiles, launchers, hand grenades and rifles were stored. Washington has expressed hope that the death of Hamas leader Yahya Sinwar, a mastermind of thee Oct. 7 attacks, could provide an impetus for an end to fighting.Officials said on Thursday that U.S. and Israeli negotiators will gather in Doha in the coming days to try and restart talks toward a deal for a ceasefire and the release of hostages in Gaza. A Hamas official confirmed to Reuters that a delegation led by the group's chief negotiator Khalil Al-Hayya arrived in Cairo on Thursday for talks with Egyptian officials.

Jordanian Foreign Minister Ayman Safadi, who met Blinken in London, said "ethnic cleansing" was taking place in northern Gaza. Israel denies such accusations, saying it is separating civilians from Hamas militants and moving them to safer areas. Safadi said: "We are at the moment now where nothing justifies the continuation of the wars. Gaza faces risk of polio spreading if vaccination continues to delay: UN

United Nations: An immediate ceasefire is needed in the Gaza Strip as the enclave faces the additional threat of polio spreading, if the final phase of a vaccination campaign continues to be delayed, an UN agency warned on Thursday. The third and final phase of the polio vaccination campaign, which was set to start on Wednesday in Gaza, had to be postponed due to the escalating violence, intense bombardment, mass displacement orders, and lack of assured humanitarian pauses."It is imperative to stop the polio outbreak in Gaza before more children are paralysed and the virus spreads," said Louise Wateridge, spokesperson for the UN Agency for Palestine Refugees (UNRWA). "The vaccination campaign must be facilitated in the north through the implementation of humanitarian pauses.'

The current conditions, including ongoing attacks on civilian infrastructure, continue to jeopardise people's safety and movement in northern Gaza, making it impossible for families to safely bring their children for vaccination and health workers to operate, Wateridge said. Since the beginning of the second round of the polio vaccination campaign on October 14, 442,855 children under age 10 have been successfully vaccinated in Gaza, representing 94 per cent of the target in these areas, Xinhua news agency reported. To interrupt the transmission, at least 90 per cent of all children in every community and neighbourhood need to receive a second vaccination following the first round, including more than 119,000 children across Gaza. The spokesperson said people in North Gaza are experiencing extreme suffering with "harrowing levels of death, injury and destruction.

US news media endorsements for 2024 presidential race: New York Post backs Trump, NYT calls Harris 'the only choice'



With Election Day nearing, US media houses are revealing their candidate picks for the 2024 presidential election. Compared to past elections, this year's race has seen fewer news media endorsements, with just 80 outlets backing Kamala Harris and less than 10 supporting Donald Trump, reported Fox News. The latest American tabloid to announce its candidate pick is New York Post, calling the GOP nominee the "right choice."

Out of the 80 endorsements for the Democratic nominee, a few of the notable ones include Winston-Salem Chronicle, New York Times, Boston Globe, The New Yorker, Denver Post, The Las Vegas Sun, Los Angeles Sentinel, Seattle Times, The Star-Ledger, Tennessee Tribune, Scientific American, and San Antonio Express Meanwhile, media endorsements for Trump include New York Post, The Washington Times, and Las Vegas Review-Journal.Post's endorsement for Trump comes just weeks after New York Times declared its support for the vice president, calling her "the only patriotic choice for president." "This unequivocal, dispiriting truth — Donald Trump is not fit to be president — should be enough for any voter who cares about the health of our country and the stability of our democracy to deny him re-election," the outlet's board said.

Meanwhile, the New York Post editorial board noted "Trump exhibits the same strength and vigor as he did in 2016, despite the unprecedented and disgraceful weaponization of the justice system against him, two assassination attempts and the all-too-familiar constant barrage of hysterical media attacks on him." This year's media endorsements are far fewer than the 2020 election, with 14 newspapers supporting Trump and 120 endorsing Joe Biden.Recently, the Los Angeles Times stirred controversy with its decision not to endorse either candidate in the November election. The outlet refrained from picking sides despite backing Barack Obama in 2008, Hillary Clinton in 2016 and Biden in 2020. North Korea claims 'troop deployment to Russia' conforms to international law

North Korea said Friday that any troop deployment to Russia would be in line with international law, state media reported, but stopped short of confirming it had sent soldiers." If there is such a thing that the world media is talking about, I think it will be an act conforming with the regulations of international law," said Kim Jong Gyu, vice foreign minister in charge of Russian Affairs, according to the official Korean Central News Agency. Seoul and Washington have accused the nuclear-armed North of sending thousands of troops to Russia, with Ukrainian President Volodymyr Zelensky saying they could be sent into battle as early as Sunday. Seoul, which has long accused the North of sending vast shipments of weapons to Russia, has pointed to videos circulating online which appear to show North Korean soldiers in Russian uniforms at military bases in the Far East. North Korea's representatives at the United Nations have dismissed the claims.In the first mention of the issue in North Korean state media, vice foreign minister Kim Jong Gyu said he had "heeded the rumour of the dispatch of Korean People's Army troops to Russia". North Korea's Foreign Ministry "does not directly engage in the things of the Ministry of National Defence, and does not feel the need to confirm it separately," he said. Were it to exist, "it will be an act conforming with the regulations of international



law," he said. "There will evidently exist forces which want to describe it as illegal one," Kim added.

South Korea has slammed the deployment of troops, calling on Russia to stop "illegal cooperation" with Pyongyang, and warned it would review its stance on providing weapons directly to Ukraine in its war with Russia. Domestic policy bars Seoul from selling weaponry into active conflict zones, but the country -- a top arms exporter -- has already sold billions of dollars of tanks, howitzers, attack aircraft and rocket launchers to Poland, a key ally of Kyiv. that China's leader would handle Vice President Kamala Harris "like a baby" if she's elected to the White House, as the former President and his top allies increasingly have moved to infantilise the Democratic nominee. "If somehow Kamala wins, she'd have to deal with Xi Jinping," conservative radio host Hugh Hewitt said of the Chinese President. "How would he handle her?"

"He'd take all the candy away very quickly," Mr. Trump continued. "She wouldn't have any idea what happened. It would be like a grand chess master playing a beginner."Mr. Trump has built his political career around name-calling, inventing jeers for his opponents going back to his first run for President in 2016, when he slammed Republican primary rivals like "Low Energy" Jeb Bush, the former governor of Florida, and "Little" Marco Rubio, the Florida senator. The former President also has a long history of belittling women.

But Mr. Trump has unleashed a special array of personal — often condescending — attacks against Ms. Harris, from calling her "lazy" - a word long used to demean Black people in racist terms — to insisting she's a "stupid person" and asking whether she is "on drugs." He's also called Ms. Harris, the first woman of colour to lead a major-party ticket, "slow" and has accused her of having a "low IQ." The latest line of attack, combining sexism and deeply personal jeers with referring to Ms. Harris as a child, comes with Election Day now barely a week off. His campaign did not immediately respond to a request for comment about the remarks. The former President, who has escalated his already dark and inflammatory rhetoric in the race's final stretch, spoke at a rally later Thursday in Tempe, Arizona, where he criticised Ms. Harris' handling of immigration. He accused Ms. Harris of perpetrating "a wicked betrayal of America" and having "orchestrated the most egregious betrayal that any leader in American history has ever inflicted upon our people," even though crime is down. During an evening event in Las Vegas, Mr. Trump compared Ms. Harris to "a vulture" in the way he characterised her approach to tax increases. "Even after Kamala wrecked your economy with inflation, she came after you with tip income, like sort of like a vulture would do," Mr. Trump said. "If she gets four more years, Kamala Harris will pick your pockets."Mr. Harris has offered her own share of insults against Mr. Trump, calling him "increasingly unhinged and unstable." During a CNN town hall Wednesday she also called Mr. Trump a "fascist." She was set to join a rally Thursday night in the Atlanta suburbs with former President Barack Obama and musician Bruce Springsteen.In his Thursday morning interview with Mr. Hewitt, Mr. Trump said he watched Ms. Harris' town hall on CNN and described her as coming off "like a child, almost." "She's an empty vessel," Mr. Trump said. "But she's beautifully pushed around by a very smart, very powerful, very liberal, viciously liberal but very, very smart, powerful party called the Democrats." Some of Mr. Trump's allies have used similar attack lines. On Wednesday, former Fox News Channel host Tucker Carlson was warm-

ing up the crowd at a Trump rally in Georgia when he



suggested that Mr. Trump was ready to punish the Vice President. "Dad is pissed," Mr. Carlson told the crowd. "And when dad gets home, you know what he says? You've been a bad girl. You've been a bad little girl, and you're getting a vigorous spanking right now."

Israel's Mossad chief to head to Doha for hostage deal talks

Jerusalem: David Barnea, Chief of Israel's Mossad intelligence agency, will head to Qatar's Doha on Sunday to discuss the release of hostages in Gaza, the office of Israeli Prime Minister Benjamin Netanyahu said.

Barnea will meet with US Central Intelligence Agency Director William Burns and Qatari Prime Minister Sheikh Mohammed bin Abdulrahman bin Jassim Al Thani, discussing with them the possibilities of restarting negotiations for the release of Israeli hostages held in Gaza, against the background of the latest developments, the office said in a statement. Meanwhile, Israel's state-owned Kan TV News reported that Hassan Mahmoud Rashad, the new head of Egypt's General Intelligence Service, is also expected to participate in the talks. According to the channel, after Israel assassinated Hezbollah leader Hassan Nasrallah and Hamas leader Yahya Sinwar, Barnea recently said Israel must act flexibly to move forward with the hostage release deal. An Israeli official familiar with the talks told the channel that there are guestion marks regarding Hamas, which insists on its demands for the release of Palestinian prisoners jailed in Israel, withdrawal of the Israeli military from the Gaza Strip, and an end to the ongoing war. Earlier on Thursday, Al Thani, also Qatar's Foreign Minister, said "a negotiating team from the US will visit Doha alongside the negotiating team from the Israeli side to discuss means by which a breakthrough can be achieved," without specifying the timetable. He said the US, Qatar and Egypt are continuing their efforts to broker a ceasefire in Gaza and that the mediators have "re-engaged" with Hamas following the killing of Sinwar

Google's antitrust hearing promises far reaching repercussions for Big Tech



google antitrust caseGoogle legal team members wait outside the courthouse as opening arguments in Google's second antitrust case, where the US Justice Department accuses it of monopolising online advertising technology, in Alexandria, Virginia, US, The widely anticipated hearings in the antitrust case against tech giant Google in the United States began Monday, with the judge in the case likely to deliver a punishment for Google's internet search monopoly by August 2025.

The landmark case promises to strike at the heart of online empires that have conjured up a significant part of the public Internet, and could potentially alter the way digital businesses behave. During the first hearing in the case on Monday, prosecutors made a myriad of allegations against Google - ranging from its dominance in the online advertising market, to eliminating competitors

Last month, Judge Amit P Mehta of the US District Court of the District of Columbia, held that Google is a "monopolist," saying that the company acted illegally to maintain a monopoly in online search. It took the United States four years to bring a case against Google which eventually culminated in the landmark ruling against the company. The ruling could direct as severe a punishment as Google having to break up some of its businesses, restrict the company from signing exclusive deals with other companies to push its products, and it could also set a precedent for similar antitrust cases involving big tech companies like Apple, Amazon and Microsoft. The judgement and the country's subsequent action to address Google's violation of competition laws - which includes proposals to break up the company's various business units, as per media reports - could have a bearing

on the regulatory discourse in India as well. Here, Google has been found to be at odds with start-up founders over its billing policy, for the commision it charges from developers listed on its app store, and for allegedly stifling competition in the online advertising market - the major source of Google's revenues globally. In India, where the legislative ecosystem is slowly evolving to challenge big technology companies in an increasingly online world, competition is pegged to become an important regulatory tool for lawmakers. And the country has proposed a major overhaul of its antitrust landscape to rein in digital empires. Taking a leaf out of the European regulatory handbook, India has proposed a new digital competition law that could stop tech giants like Google, Facebook, and Amazon from self-preferencing their own services, or using data gathered from one company to benefit another group company.

The draft law, called the Digital Competition Bill, 2024, also has provisions to set presumptive norms to curb anti-competitive practices before they actually take place, and promises to impose heavy penalties - which could amount to billions of dollars - for violations. If this were to go in force, it could require big tech companies to make fundamental changes to their various platforms. The proposal is similar to the EU's Digital Markets Act (DMA), which went into complete effect earlier this year, and requires large tech firms like Alphabet, Amazon and Apple to open their services, and not favour their own at the expense of rivals. The law came in on the back of a long history of anti-competitive practices by these companies.Big tech's stronghold over the innovation economyThere is concern within official quarters that in the last decade or so, a majority of the innovation has been confined to within the stables of a handful of big tech companies, mostly from the US. Officials believe that a big reason for this are the high market barriers for new entrants in the sector - in the online market, once a company gets a significant portion of the market, their product becomes the default way to access that particular service, with rivals finding it increasingly difficult to challenge their dominance.Government officials believe that the big tech companies have shown a history of engaging in anti-competitive practices, and a presumptive framework would work better to address this. Last year, Google was fined Rs 1.337 crore by the CCI for its anticompetitive conduct in the Android ecosystem.

Air India Express to phase out business class cabin on its 'white-tail' aircraft starting next year

Air India group's low-cost airline Air India Express has decided to phase out business class seats, which are available on a number of its "white-tail" Boeing 737 MAX aircraft, and plans to refit all such planes to an alleconomy configuration starting next year, according to a senior airline official. Although the airline, like numerous budget carriers globally, has traditionally operated alleconomy cabins, it has around 20 aircraft (of total 84) that came with two cabin classes—economy and business. The business class product is available only on these aircraft. These planes were ordered by and configured for some other airlines but the manufacturer—Boeing in this case-offered them to Air India Express as the original orders were cancelled.

Such planes—that remain unsold to the intended customer—are referred to as white-tail aircraft in industry parlance. Often, other airlines are quick to buy such aircraft as they are readily available off the shelf with the manufacturer, while planes manufactured based on their order can take years to be delivered. So far, Air India Express has inducted 33 white-tail Boeing 737 MAX planes, which were originally meant for other airlines, mainly Chinese carriers. Another 17 such aircraft are likely to join the fleet by the end of this year. Of these 33, around 20 planes came with a two-class cabin. Some of the remaining 17 white-tail planes might also have a dual-class cabin configuration."Having a business class on a part of our fleet really does not fit well with our business model. We have been offering a premium product on these whitetails mainly because the planes already came with business class seats and we wanted to press them into operations at the earliest, instead of spending too much



time on reconfiguring the cabin," said the official, who did not wish to be identified. With the airline's fleet continuously growing at a steady pace, it should have some headroom in a few months' time to start converting such aircraft to all-economy seating. Cabin reconfiguration can be a time-consuming process and keep the aircraft out of operation for some time. Therefore, the refit schedule needs to be planned carefully so that it does not affect the airline's

These white-tail Boeing 737 MAX planes are part of the mammoth 470-aircraft order the Air India group placed with Boeing and Airbus last year. The order included 190 Boeing 737 MAX aircraft—50 white-tails and 140 that will be manufactured based on the order. Deliveries of the remaining 140 Boeing 737 MAX aircraft to start from sometime next year, and AIX Connect (formerly AirAsia India), which is in the process of being merged into the former, currently have a combined fleet of 84 aircraft, mostly Boeing 737s and a few Airbus A320s. With another 17 white-tail planes expected to join the fleet before the end of the year, the operational fleet of the merged Air India Express is expected at 100 aircraft by December-end, said the airline official. By 2028, Air India Express aims to have a fleet of 180 aircraft.

GST Council 'aligned' on the need to cut insurance premiums, specific proposal referred to GoM

The Goods and Services Tax (GST) Council in its 54th meeting held Monday broadly converged on the need to reduce the tax rate for health and life insurance premiums from 18 per cent but the specific proposal has now been referred to the Group of Ministers (GoM) for further discussion, sources said. The GoM on rate rationalisation along with ministers from some states will discuss the issue in further detail, sources said.

The GoM on rate rationalisation will meet in Goa on September 23 and the next GST Council meeting will be held in November. "There was broad consensus for GST on health and life insurance premiums to be reduced, but modalities will be decided in the next Council meeting," a source said.

The existing GoM on rate rationalisation along with some more states will discuss the issue of health and life insurance premiums in detail, the source added. The fitment committee, which includes officials from states and Centre, presented detailed numbers on the proposal to reduce GST on health and life insurance premiums in the Council meeting. The GST Council meeting, chaired by Union Finance Minister Nirmala Sitharaman, is still ongoing.In August, the reconstituted GoM on rate rationalisation under the GST regime had met for the first time and broadly agreed to not make any changes with the existing slabs in the indirect tax regime. State finance ministers, who participated in the meeting, had also said that the issue of reduction of GST rate in health and life insurance premiums was raised in the meeting of the GoM but was being reviewed by the fitment committee.On August 27, Sitharaman had said both rationalisation of



rates and tweaking of slabs under GST are on the discussion table, adding that the discussions will go item-byitem and make a comparison of the current rates with the revenue neutral rate. In 2023-24, the Centre and states had collected Rs 8,262.94 crore through GST on health insurance premiums, while Rs 1,484.36 crore was collected on account of GST on health reinsurance premiums. Opposition leaders including Leader of Opposition in Lok Sabha Rahul Gandhi, Trinamool Congress chief Mamata Banerjee have demanded withdrawal of GST on life and health insurance premiums. Banerjee had also written a letter to Union Finance Minister Nirmala Sitharaman for rollback of GST on life insurance and health insurance premiums. Earlier on July 28, Union Minister of Road Transport and Highways Nitin Gadkari wrote to Finance Minister Sitharaman, saying GST on life and medical insurance premiums amounted to taxing the "uncertainties of life". Sitharaman had last month said that tax was levied on insurance premiums even before the imposition of GST and that GST revenues are shared between

states and the Centre.

As copper mining stalls and imports surge, players eye overseas assets



Copper demand, a key barometer of economic growth, is poised to surge over the next decade across geographies. For India, though, amid stagnant domestic production, copper concentrate imports have doubled to Rs 26,000 crore in FY24 from around Rs 13,000 crore in FY19, and Indian smelters and refiners are now increasingly looking to secure copper assets overseas, bolstered by some government support. Now designated a critical mineral, copper's role in clean energy technologieslike wind turbines and EV batteries—has put India's growing import reliance in the spotlight. From developing new import sources in copper-rich countries like Mongolia to buying equity in Zambian and Chilean mines, major players such as Hindalco's Birla Copper Ltd, Adani's Kutch Copper Ltd, and Vedanta's Sterlite Copper Ltd are collaborating with the Ministry of Mines in securing India's

Increasing reliance on importsIn FY19, copper ore production stood at 4.13 million tonnes (Mt), dropping to a low of 3.27 Mt in FY21, which then partially recovered to 3.78 Mt in FY24, according to data with the mines ministry. Similarly, copper concentrate production dropped by 13 per cent in FY24 compared to FY19.

In the copper value chain, copper concentrate is smelted into copper anode, which is then refined into copper cathode—or refined copper—essential for producing rods, sheets, wires, and other input goods. While domestic production of refined copper grew by 12 per cent between FY19 and FY24-from 454 kilotonnes (kt) to 509 kt-much of the growth was supported by surging concentrate and anode imports. Despite stagnant production in recent years, government-owned Hindustan Copper Ltd (HCL), the only company in India that mines copper ore, ambitiously plans to triple output to 12.2 Mt by FY29 through the expansion of its existing mines. Even then, with the entry of greenfield refining capacities, like Kutch Copper's maiden plant operationalised this year, and the expansion of existing capacities, demand for copper concentrate and anode imports is set to grow in the absence of adequate domestic mining

In India, copper ore reserves stand at an estimated 208 Mt, most of which are of low grade. Copper resources, however, total 1.51 billion tonnes, requiring extensive exploration to convert resources into reserves that are viable for mining. The National Mineral Exploration Trust (NMET), under the mines ministry, oversees mineral block exploration in India. In FY24 and FY23, NMET approved only two copper exploration projects. Experts argue that insufficient exploration and a lack of private sector participation over the last decade have hindered the development of new mines. Last year, the mines ministry modified rules to encourage private exploration agencies to explore critical minerals like copper. These changes come amidst a global slowdown in copper exploration, as new resources are believed to be deep-seated and expensive to explore. Since FY16, only four copper blocks have been auctioned—two each in FY20 and FY24. The blocks in the last fiscal were awarded under a composite licence (CL), which requires licence holders to conduct further exploration before commencing mining operations. Globally, it can take up to 17 years on average to operationalise a copper mine.

While the government put two copper blocks on auction as part of its critical mineral auctions over the past year, they were annulled due to insufficient investor interest. Though the quality of reserves was not in question, potential investors were deterred by the blocks' small size, only 1 square kilometre, The Indian Express has learnt. Since copper is a deep-seated mineral, block sizes must be large for mining operations to be commercially viable. Experts believe India's copper potential is vastly underutilised. Greater allocation of funds to private explorers and the privatisation of HCL—as suggested by Gouranga Sen, top policy executive at Vedanta, in a LinkedIn post in July—could propel copper mining in India.However, in the near future, India may have no option but to strategically engage with copper-rich countries like Zambia, the Democratic Republic of Congo (DCR), and Chile, where equity in copper assets is available for offtake. previously reported that the mines ministry was gauging interest among domestic players in securing overseas mineral resources, including copper assets in Zambia. The ministry also proposed sending an Indian delegation to Zambia, which participated in a joint working group (JWG) meeting held in Lusaka this June. Notably, Vedanta owns a major copper mine and smelter in Zambia, which was seized by local authorities in 2019 before Vedanta regained control last September. The Zambian government holds a 20 percent stake in the project, which has 250 Mt of copper ore reserves.

To protect overseas mining assets amidst growing resource nationalism, the Indian government is exploring bilateral investment treaties with mineral-rich countries to de-risk investments, The Indian Express has learnt. Securing such assets through a bilateral mechanism is crucial for promoting outward investments, as a copper mine abroad can require an upfront capex of at least \$10 billion.Copper assets in Chile and DCR are also under the industry's radar. In June, an Indian delegation led by the mines ministry visited Lubumbashi, DRC, to participate in a mining conference. In addition to acquiring copper assets overseas, the mines ministry is also assisting domestic smelters and refiners in developing new import

"There's not enough scientific research or evidence to back up the correlation between backache and going to bed with a full stomach. If your backache sustains for more than a week or two then consulting experts can help manage the situation. It is crucial to understand the root cause of your back pain to create an effective treatment plan," said Dr Priti Jain, gastroenterologist, Apollo Spectra Delhi. However, Dr Jain added that one shouldn't neglect the fact that immediately falling asleep after dinner can be an unhealthy habit that needs to be paused for the sake of your health. "Sleeping immediately after



eating can negatively impact health. It can lead to reflux of food present in the stomach into the esophagus resulting in problems like heartburn, indigestion, constipation, and gastroesophageal reflux disease (GERD)," said Dr Jain, adding that one can also experience sudden weight gain. Persistently following this habit can affect your sleep, too. "This can lead to sleep disorders like insomnia, parasomnia, sleep apnea, and sleepwalking," said Dr Jain. Try eating 2 to 3 hours before bedtime to aid digestion. "Engaging in healthy habits like going on a long walk after a meal can ensure mobility and potentially reduce the possibility of experiencing problems like bloating, and gas which can be good for your health," said Dr

Is sandesh a healthy mithai? We find out

We (all) wish to enjoy sweets minus the calories and guilt. However, while most mithais are delicious, they do not qualify as 'healthy food.' "But with sandesh, it is a different story. It is more than just a mithai! Glad this humble sweet treat is finally getting the credit it deserves," Komal Patel, a dietitian, told indianexpress.com when asked about the healthiest mithal available.

Made with chhena (Indian cottage cheese), sandesh contains the goodness of calcium and protein. "It also boasts of friendly gut bacteria. It is one of the best companions one can have on their journey to fitness - satisfying, energising and delicious," added Patel. The chenna is basically 'casein,' one of the proteins in milk, and the strained water is whey protein. "Casein is a first-class protein that is superior-quality. Also, chenna is a concentrated source of protein, about 100g would typically give about 20g protein considering it is made from buffalo milk. It also has a moderate amount of fats and relatively lower carbohydrates," said Pooja Shah Bhave, consultant clinical dietician and diabetes educator, Mumbai. "Sandesh is one of the healthiest sweets. It is non-fried, has no refined flour, and is high in carbs, unlike malpua or ghujiya," said Bhave.

Moreover, it is not typically put into sugar syrup like gulab jamun or rasgulla. So, one can add lesser sugar as per their taste, Bhave continued. However, in the commercial environment, with sugar taking center stage, sandesh's health aspect takes a back seat. "Adding cream, artificial flavours, and preservatives might enhance flavours, but they diminish its nutritional value," noted Patel.For the ultimate sandesh experience, Patel suggested making it at home. "Free from preservatives and refined sugars, homemade sandesh offers better control over what goes into it. Adding the natural sweetness of a fruit or dry fruit filling can elevate sandesh to new heights, allowing you to skip sugar altogether," said Patel. Finally, the art of enjoying food lies in balance. Indulging in a mithai occasionally is unlikely to disrupt your overall health, especially when you eat healthy otherwise.Remember, the key to a food's impact on your well-being lies not just in its inherent qualities but also in the quantity you consume and when you eat," said Patel. To help you prepare sandesh at home, here's a recipe from chef Neha Deepak Shah.Ingredients

1 tbsp - Vinegar or Lemon Juice with water

2 tbsp - Coconut milk powder

1 ½ tbsp - Sugar/Jaggery

For filling, use mangoes or lychees. Any pulpy fruit is good, even peaches, said Shah. Some desiccated coconut for coatingMethodSeparate the chenna and wash it with water. Drain excess water. Mash the chenna well.Add rose water and coconut milk powder.Add sugar.Mix well.Take a little mixture. Add mango or choose a fruit pulp of your choice. Coat with desiccated coconut.Garnish with rose pistachios. Enjoy!*You can add cardamom powder for flavour.*Some rose petals and pistachios for garnish.*Make sure chenna is squeezed well to remove all the excess water. Don't make it too dry. Bhave shared another tip. "Don't throw away the strained water while making chenna. It is a precious whey protein. Use the water to make dough for chapati or incorporate it into the dal or curry," said Bhave.

Sai Pallavi's support for Pakistan sparks controversy ahead of 'Ramayana' role



Mumbai: Actress Sai Pallavi, who is set to portray Sita in Nitesh Tiwari's 'Ramayana', has come under fire after an old video of her resurfaced online. In the clip, she remarks that the Indian army is viewed as a "terrorist group" in Pakistan, highlighting a contentious perception that exists between the two nations. Alia Bhatt denies claims of botched Botox procedure in strong response

Mumbai: Bollywood star Alia Bhatt on Friday strongly hit back at claims circulating in online videos and clickbait articles that she had a botched Botox procedure. The "Jigra" actor posted a lengthy statement on her Instagram Stories and said the rumours about her undergoing a cosmetic surgery are "beyond ridiculous" and "damaging".

"Absolutely NO JUDGEMENT towards anyone who chooses cosmetic corrections or surgery-your body, your choice. But wow, this is beyond ridiculous! To the random video floating around literally claiming I've had Botox gone wrong (and to the numerous clickbait articles) – I have a 'crooked smile' and a 'weird way of speaking' according to YOU," she said. "This is your hypercritical, microscopic judgment of a human face. And now you're confidently tossing around 'scientific' explanations, claiming I'm paralysed on one side? Are you kidding me?" she added.

Bhatt, 31, criticised that "serious claims" about her are being "casually thrown out there with zero proof, no confirmation, and absolutely nothing to back it up". "What's worse, you're influencing young, impressionable minds who might actually believe this garbage. Why are you saying this? For clickbait? Attention? Because none of it makes sense," she added. The actor said women are often judged through an "absurd lens" and are objectified on the internet for "our faces, bodies, personal lives, even our bumps". "We should be celebrating individuality, not



tearing it apart under a microscope. These types of judgments perpetuate unrealistic standards, making people feel like they're never 'enough' It's damaging, and it's exhausting," she added. What is even more saddening is that such kinds of judgement is perpetuated by women, Bhatt said. "Whatever happened to 'live and let live'? To 'everyone has the right to their own choices'? Instead, we've become so accustomed to picking each other apart that it's almost normalised. "Meanwhile just another day of even thorougher entertainment with scripts made up by the Internet," she concluded the statement. Bhatt was most recently seen in filmmaker Vasan Bala's "Jigra", which released in theatres earlier this month. She will be next seen in action movie "Alpha" with Sharvari.



But, since he was a star, he was significantly involved in the decision making process of casting the heroine in his films. So when he was doing the comedy film Ram Aur Shyam, producers suggested that he should be paired opposite Saira Bano. At the time, Dilip and Saira were not romantically involved with each other, and Dilip, who thought that Saira looked too "delicate" for a character with a "seductive appeal", rejected the idea. In his memoir, 'The Substance And The Shadow: An Autobiography', Dilip recalled that initially, Vyjayanthimala was cast in the film but was fired because of a "tantrum that was uncalled for." Ram Aur Shyam had Dilip in a double role and there were two female leads in the film. Vyjayanthimala was soon replaced by Waheeda Rehman but the search for the second leading lady was still on. At this point, producer Nagi Reddy suggested Saira's name to Dilip. "Nagi Reddy was all admiration for Saira nd her recent performances and was certain that her pairing with me in the comedy situations would be a huge draw since she possessed a wonderful flair for spirited comedy. Since it was my practice to take an active interest in the making of my film, I voiced my opinion that I did not agree with Nagi Reddy on this issue because I felt she was too delicate and innocent in appearance for a character that had to have loads of seductive appeal and a bold, buxom appear-

Actor Mehmood, however, was of the opinion that Mumtaz should be cast in this role and while Dilip had never worked with either Saira or Mumtaz, he went with Mehmood's suggestion. 'It is so cool to play with my mom and win': Winning mother-daughter team claims top spot at National Badminton tournament

As a child, Noopur Sahasrabudhe admired her mother Manjusha's dedication to badminton, and visiting the court quickly became her favourite part of the day. Little did she know that, years later, the mother-daughter duo would make history by winning a state championship and other tournaments. Post Covid-19 and despite facing surgeries, the Pune based winning mother-daughter team is back and recently claimed the top spot at the national badminton tournament organised by the Uttarakhand Badminton Association. Noopur says she has a natural flair for badminton and would train with her mother, a seasoned player who has represented India multiple times in prestigious Senior World Badminton Championships. She recalled how motivated she would get when she would see her mother play. "She is so senior and so active. I am totally inspired by her. Also, it is so cool to play with my mom and win," Noopur added.

The achievement is noteworthy as this was the sole

mother-daughter pair from Maharashtra to win at the national Doon Smashers Masters badminton tournament held at Dehradun (September 20-22). Women's Doubles 80+ requires the combined age of both participants to exceed 80 years. "In our case, my mother is 62 and I am 36, while most of our opponents were around 40 years old each," Noopur recalled. At the event, Manjusha won a triple crown each across the Women's Singles 60+, Combined Age Group Women's Doubles 80+ (with her daughter Noopur), and Mixed Doubles 120+ (with Hariit Singh, Delhi). Noopur won the Women's Singles 35+, Women's Doubles 80+ (with her mother), and Mixed Doubles 80+.

For the young woman, though an Achilles Tendon repair may have been a setback sometime in 2015, but inheriting her mother's determination and will power made her bounce back to not only compete in badminton tournaments but take on the triathlon challenge, qualify, and finish the Ironman World Championship in Kona, Hawaii in October last year. Manjusha, a Badminton World Federation Asia Accredited Referee and a coach with the Poona District Metropolitan Badminton Association (PDMBA), also suffered shoulder and knee injuries that required surgery in 2019-20. "It was a challenging time but post-surgery, I underwent rehabilitation that included physiotherapy and strength training at the gym," Manjusha said. With Manjusha set to travel as a referee at the Korea Junior International Challenge in November this year and Noopur's work as an HR specialist at a Pune firm, the mother-daughter ensure that they practice at least three to four times a week. Not surprisingly this deep bond creates a powerful connection on the court as this winning team is now gearing up to compete in a major na-

Jemimah Rodrigues' dad Ivan issues clarification after Khar Gymkhana cancels membership

We had availed of the facilities at the Khar Gymkhana for the purpose of prayer meetings on multiple occasions, over a period of a year since April 2023. However, this was done in complete accordance with the procedures that Khar Gymkhana have in place, and in full knowledge of the office bearers. The prayer meetings were open to all and were in no way 'conversion meetings' as is wrongly labelled in articles in the media," Ivan posted in a note on his social media account.Ivan went on to add: "When we were told to stop conducting the prayer meetings, we respected the stance of the Gymkhana and did so with immediate effect. When informed about the difference in rates for members and guests, we readily cleared the arrears. We are honest,



law-abiding people who are grateful that we can practise our faith without it being a cause of inconvenience to anyone else. To then be the subject of false claims and misinformation is disheartening. We have and continue to wish only the best for everyone."

Khar Gymkhana managing committee member Shiv Malhotra had earlier told The Indian Express: "We came to know that Jemimah Rodrigues's father was attached to an organisation called Brother Manuel Ministries. They booked the presidential hall for almost a year and a half and held 35 events. We all know what was happening there... We hear about conversions all over the country, but it's happening right under our nose. There was dancing, expensive music equipment, big screens. As per Khar Gymkhana's bye-laws Rule 4A of the constitution, Khar Gymkhana does not permit any religious activity.'

'Worst shot of his life': Sanjay Manjrekar on Virat Kohli's dismissal vs New Zealand in 2nd Test

Virat Kohli was dismissed for one run in the second Test against New Zealand in Pune on Friday in very unconventional fashion. Trying to slap a full toss from Mitchell Santner across the line, Kohli missed the ball's trajectory completely and it slammed into the stumps.Kohli's stint in the middle had lasted just nine balls. The dismissal, while absurd for the prolific India batter, also highlighted his struggles against spin on Asian conditions

Kohli has been dismissed 21 times in 26 innings against spinners in Asia in the past three years, with an average of 28. Of these, 10 dismissals have been to leftarm orthodox bowlers, against whom he averages 27.10. Understandably, Kohli walked off the ground seething after his soft dismissal. "Virat will know himself that he has just played the worst shot of his career to get out," tweeted former India cricketer Sanjay Manjrekar. "Got to feel for him (Kohli)... cause as always, he came out with solid and honest intent."

Former India coach Anil Kumble opined in an interview on JioCinema that maybe Kohli could have considered playing domestic cricket in the lead up to the New Zealand series. The Indian team find themselves staring down the barrel after two days in the second Test against New Zealand in Pune. Rohit Sharma's men are facing

the realistic threat of their first series defeat at home in 12 years.After New Zealand batted first in the Pune Test, they posted a first innings total of 259. In reply, India were bundled out for 156. The visitors came back on the second day to pile on India's misery: going into the third day of the second Test, the visitors' overall lead stands at 301 with five wickets intact, thanks to Tom Latham's 86 and Mitchell Santner's seven-wicket haul.

'Don't need a fan like you': Glenn Maxwell opens up on soured relationship with Virender Sehwag at Kings XI Punjab

In 2014, when Kings XI Punjab (now Punjab Kings) reached its only IPL final to this day, Glenn Maxwell and Virender Sehwag were crucial pillars to their success. Maxwell - 25 then - was the player of the tournament and finished with 552 runs under his belt. Sehwag on the other hand had scored a big hundred in the 2nd Qualifier to help Punjab inch past Chennai for a place in the final.

While Sehwag played his last IPL game the following season, calling it quits from professional cricket, his paths with Maxwell crossed again when he became Punjab's mentor. It wasn't the reunion the Australian had hoped for. In his new book, Glenn Maxwell The Showman, the Australian looks back at his time with Punjab and how his relationship with the former Indian opener soured. To the point where Maxwell texted Sehwag that he had lost a fan, to which the latter responded, "Don't need fan like you."Going into the 2017 season, Maxwell was appointed as the captain of the franchise, a message that was conveyed to him from Sehwag during Australia's tour of India the same year. "We discussed how the team would operate, and I thought we were all on the same page. How wrong I was," Maxwell writes in his book. "Our coach, J Arunkumar, was coming in for his first season, and it became clear to him that he was coach in name only, with Sehwag pulling the strings."He adds, "When it came to selection, I thought it might be a good idea to bring the coaches into a WhatsApp group to make our decisions. Everyone agreed to this and shared their teams, with the exception of Sehwag. At the end of the process, he made it clear that he would pick the starting

The Australian goes on to add how this affected the franchise in a season where they finished fifth in the eightteam points table - narrowly missing out on the playoffs. "Take poor old Ishant Sharma. At one point he was told not to bother coming to our game that day in Mumbai, having not been picked in a while. We had several other local bowlers, plus the Kiwi quick Matt Henry had just come into the side. Doing the right thing, Ishant did a gym session and came along anyway, bowling at full pace in the warm-up. Then Eoin Morgan was told that he would be a new inclusion that day, taking the last overseas player spot from Matt. Morgs protested that it wasn't fair to drop Matt after only playing one game, so they rejigged again, left out Morgs, and both Henry and Ishant played."The tensions between the captain and the mentor reached a boiling point at the end of the season, when Maxwell volunteered to do the press conference after Punjab were rolled over by Rising Pune Supergiant for 73 in their last game. Instead, Sehwag took to the presser and unloaded on the captain as the 'big disappointment' of the season.

"I texted him to say how much it hurt to read those comments and added that he had lost a fan in me for the way he had conducted himself. Sehwag's response was simple: "Don't need fan like you." We never spoke again." Maxwell says. "I knew my time was at an end and told the owners as much: if Sehwag was going to stick around, they were making a mistake and not to bother with me. He only lasted one more season." Maxwell, who joined Delhi Capitals for the subsequent season before returned back to Punjab, played his last game for the 2014 finalists in 2020 before being signed by RCB in 2021. His final season with Punjab saw Maxwell amass a mere 108 runs in 13 matches - a lackluster display which led to Sehwag quoting him as a '10-crore cheerleader' in a video on his Facebook page. "He has had a bad record of scoring runs over the past few seasons. But this campaign, he went to new extremes. This is what you call a highly-paid vacation," Sehwag would say.

Ranji Trophy: With 46 top players representing India, India A and Emerging side, depleted teams gear up for Round 3

Washington received an India call-up following his player-of-the-match performance against Delhi, where he scored a century and picked up six wickets with the ball. Tamil Nadu stand-in skipper Narayan Jagadeesan is not worried about the "forced changes" as he sees this as an opportunity for others to step in.

"We can't do much about it because you want your teammates to climb up as well. So there will be changes and one has to get used to it. It is not something that has happened when we are least prepared. We knew about it and it is an opportunity for others to step in and fit into the culture," Jagadeesan told The Indian Express.The unprecedented situation has arisen as three Indian teams are playing at the same time. Senior India team is involved in a three-match Test series against New Zealand. India A white-ball squad is playing in the Emerging Asia Cup in Oman, while a red-ball squad of India A is in Australia. A total of 46 Indian cricketers are not available for the third round of the Ranji Trophy. Punjab Ranji Trophy coach Wasim Jaffer calls the situation "challenging." Punjab, who will take on Uttar Pradesh at IS Bindra Stadium in Mohali are missing Abhishek Sharma, Prabhsimran Singh, Nehal Wadhera and Ramandeep Singh — all of them are playing in the Emerging Asia Cup. "It is challenging. We had prepared for the season keeping these players in mind and have selected the squad accordingly. It did surprise me but you got to be ready as we are not the only team who are affected," Jaffer said. "Again at the same time, it gives opportunity to the other players as well. It is obviously something you don't want to happen but also you are happy with the fact that your players are playing in the Emerging. It's a winwin situation for the players but for the coaches, it is a headache. In the crucial games you don't have your best playing XI that can affect your season," added Jaffer.

Bengal coach Laxmi Ratan Shukla, whose side will miss four key players — Akash Deep (Test team), captain Abhimanyu Easwaran, seamer Mukesh Kumar and wicketkeeper-batter Abhishek Porel (India A tour of Australia) for their fixture against Kerala has urged the youngsters to step up. "Look, this is an age-old system. When you play good cricket, you will miss key players on national duty and India A tours. As a team, you become weak once your main players are gone. But again at the same time, it is an opportunity for the youngsters, who are doing well at the U-23 and U-19 level to get the taste of Ranji Trophy and cement their place," said Shukla.

Delhi's coach Sarandeep Singh echoes the sentiments of Laxmi Ratan Shukla. He said: "We are without Ayush Badoni, Anuj Rawat, Hrithik Shokeen and Navdeep Saini. I guess the players who replaced them are equally good. The likes of Sanat Sangwan and Pranav Rajvanshi



showed immense maturity against Tamil Nadu." "What I feel is that these things are not in my hands and I ponder much on these issues. It is good for Delhi that four of our players are selected for the Emerging tournament. It means they are on the selector's radar." Delhi has received a major boost ahead of their tie against Assam as Harshit Rana, who was travelling with the Indian Test team as a reserve has been released to play the Ranji Trophy.In recent years, as NCA head VVS Laxman said recently, the BCCI has been careful about India A programmes don't coincide with the domestic season. But the shadow A tours to South Africa and Australia have been inevitable because of scheduling reasons.

Lando Norris reflects on intense US GP battle with Verstappen

Mexico City: Just days after his intense on-track battle with Max Verstappen at the United States Grand Prix, Lando Norris has been reflecting on the experience, acknowledging areas he aims to learn from.

The McLaren driver engaged in a fierce wheel-towheel contest with Verstappen, starting from Turn 1 on the opening lap. While Norris initially held the advantage, Verstappen soon fought back with a different tyre strategy, resulting in a hard-fought clash for the final podium spot. Although Norris provisionally secured third, he was handed a five-second penalty for overtaking Verstappen while off-track, allowing the reigning world champion to keep his position. Verstappen also went over the track's white lines while defending, prompting Norris to question the ruling. Reflecting on the battle ahead of the Mexico City Grand Prix, Norris explained, "I'd probably approach things in a pretty similar way. Slight tweaks here and there. Of course, I didn't come out on top in the whole battle... Max is probably the best in the world in this style of defense and attacking. I'm going up against the best, and therefore I've got to be at his level," Norris was quoted by F1 as saying.

Acknowledging that he still has progress to make, Norris sees the experience as an opportunity to improve. He added, "At the minute, I would say I'm not quite at the level I need to be. It's a shame to say, but it's probably the truth... I want to be the one that comes out on top. I believe I rightfully was, but obviously, the penalty changed things."The young driver also raised concerns over the current rulings on wheel-to-wheel racing, suggesting there should be clarity for similar scenarios in the future. "I don't believe (the penalty) was correct," Norris shared.
