#### Haryana Govt claims 29% reduction in stubble-burning incidents compared to the previous year

Chandigarh (JAG THAKEN), October 28: The Haryana Govt claims that it has achieved 29% reduction in stubble-burning incidents compared to the previous year. Stating this, a government spokesperson said that the Haryana government is taking significant steps for crop residue management in the state. Following the directives of Chief Minister Nayab Singh Saini, a state-specific scheme has been implemented. This initiative provides financial assistance to farmers for crop residue management while setting zero burning targets for panchayats to curb stubble burning incidents. As a result of these efforts, there have been a total of 713 recorded incidents of stubble burning by ICAR this year, marking a 29 percent reduction compared to last year. The government spokesperson said that burning paddy stubble after harvest not only contributes to air pollution but also diminishes soil fertility and adversely affects farmers' health. Consequently, the government is actively raising awareness among farmers at the village level about the importance of not burning stubble. Thanks to these initiatives, 83,070 farmers have registered to manage 7.11 lakh acres of paddy area as of October 28, 2024. The registration deadline is November 30, 2024.

An official release informed that Incentive amount of Rs 223 crore has been given to farmers from the year 2020-21 to 2023-24. The spokesperson stated that the government is providing subsidized crop management equipment to farmers for both in situ and ex situ management. From 2018-19 to 2024-25, a total of 1,00,882 crop residue management machines have been made available to farmers at a subsidy of 50 to 80 percent. This year, farmers have purchased 9,844 machines.

Last week, a farmer awareness program was organized in the surrounding villages by the Krishi Vigyan Kendra Ambala of Chaudhary Charan Singh Haryana Agricultural University, Hisar. Agricultural scientist Dr. Devendra Chahal advised the farmers of the village not to burn crop residues. Farmers should give as much importance to crop residues as they consider the crop economically useful. Dr. Chahal said that crop residues help in maintaining the fertility of the soil, due to which the quality of the produce also improves. Therefore, farmers should make full use of whatever machinery is available to mix these crop residues in the field. Super-Seeder is also one of these machines, using which farmers can press the residues of paddy crop well in the fields and also sow wheat. Nowadays, it costs about two to two and a half thousand rupees to sow wheat in one acre with a super- seeder. Along with crop residue management, wheat sowing is also done very well, along with this, the farmer's time is also saved and early sowing is done. The government spokesperson further added that the farmers are being given an incentive of Rs1,000 per acre for managing paddy crop residues. In addition, an incentive of Rs 7,000 per acre is provided for adopting alternative crops in paddy areas under the Mera Pani-Meri Virasat Yojana. This year, 33,712 farmers have registered for crop diversification, opting for other crops instead of paddy on 66,181 acres. From 2020-21 to 2023-24, incentives worth Rs 223 crore have been disbursed to farmers.

The spokesperson also mentioned that the government is offering an incentive of Rs 4,000 per acre for adopting Direct Seeding of Rice (DSR) technology. Furthermore, Gaushalas are also being given an incentive of a maximum Rs 15.000 as transportation charges of bales at the rate of Rs 500 per acre. Various industries are being established near villages to utilize stubble, allowing farmers to generate additional income instead of resorting to burning it. The state government has decided that red zone panchayats will be given an incentive of Rs 1 lakh for achieving zero burning target. The spokesperson said that the government has categorized villages into red, yellow, and green zones based on the incidents of paddy stubble burning in the previous year. Panchavats in the red and yellow zones will receive incentives from the government to reduce stubble burning incidents. Red



zone panchayats will be awarded an incentive of Rs 1 lakh, while yellow zone panchavats will receive Rs 50,000 for achieving zero burning targets. He said that despite the government's efforts and incentives to prevent stubble burning, strict action has been taken against law violators.

So far, a total of 334 challans have been issued, and fines amounting to Rs 8.45 lakh have been recovered from farmers. In addition, 418 'red entries' have been recorded in the field records of these farmers, and police cases have been registered against

# In Jharkhand, a jostle for the women vote

Sukhiya Tirkey has never felt so important. After selling vegetables by the roadside in Ranchi for more than two decades, this is for the first time that the 48-year-old feels recognised as a constituency that can influence election outcomes. As campaigning picks up with Jharkhand heading towards a two-phase Assembly poll next month, Sukhiya and several others like her have emerged as an influential voting bloc, prompting political parties to actively solicit their support this year.

On October 14, the Jharkhand Mukti Morcha (JMM)-led coalition government in the State approved an increase in the assistance given to women from families living below the poverty line under the Mukhyamantri Maiya Samman Yojana (MMSY) from ?1,000 per month to ?2,500. The hike was triggered by the Opposition Bharatiya Janata Party's (BJP) promise of giving a monthly allowance of ?2,100 to women in the State if it comes to power. The party has already started distributing forms recording details of the likely beneficiaries. While the raise in allowance is to come into effect from December, Jharkhand's 81 Assembly constituencies will go to polls on November 13 and 20. The vote bankAs per the electoral rolls, the State has a total of 2.59 crore voters -1.31 crore male and 1.28 crore female this year. Women outnumber men in 32 of the 81 constituencies. Of these 32 seats, 26 constituencies are reserved for Scheduled Tribes (STs) and two for Scheduled Castes (SCs). Among these seats are Chaibasa, Ghatshila, Manoharpur, Kharsawan, Kunti, Shikaripara, Majhgaon, Maheshpur Littipara, and Simdega. The State has a total of 28 constituencies reserved for STs and nine for SCs.More women exercised their franchise than men in Jharkhand during the Lok Sabha election held earlier this year, a good enough reason for political parties to woo this segment of the population. According to Jharkhand Chief Electoral Officer K. Ravi Kumar, the reason behind higher women turnout was active participation by them and the migration of men from the State.

Of the 1.7 crore electors who cast their votes in the 14 Lok Sabha seats, 87.11 lakh were women and 83.85 lakh were men, he told reporters after the election, "The number of women voters who exercised their franchise was higher in 12 Lok Sabha seats. The number of male electors who turned up at polling stations was slightly higher in two constituencies, Ranchi and Jamshedpur." he said. "If we look at the figures Assembly segment-wise, women voters outnumbered men in 68 constituencies while the number of men who cast their votes was higher in only 13 Assembly seats," Kumar said. Realising the importance of women voters, soon after the Lok Sabha poll, the Hemant Soren-led government in August this year rolled out its flagship Mukhyamantri Maiya Samman Yojana (MMSY) for women aged 18 to 50. So far, 48.15 lakh women have registered and are receiving the benefits of the scheme. Women of 50 years and above are already



getting ?1,000 per month under the universal pension scheme in the State. The Opposition BJP then announced its own version named Gogo Didi Yojana. Gogo is the Santhali word for mother and didi is sister in Hindi. In the competitive politics roiling the State in the build-up to the poll, the Soren government has now announced the hike to ?2,500 per month — a decision that will entail an additional outgo of around ?900 crore.

What women thinkUnaware of the political tug of war, Sukhiya says, "I never imagined that we will get ?1,000 per month from the government. There are four women in our family and we all are getting ?1,000 each, which means an additional ?4,000 per month. We have heard the government is planning to increase the amount." For 48year-old Neelam Lakra, it is the cash assistance that she owes her independence to. Living in a slum in Ranchi's Namkum, Neelam is happy that she is no longer dependent on anyone else for minor needs. "My husband is a daily wager and his earnings are not enough to run the family of five. This scheme has given us a lot of support to properly feed my three children. Getting ?12,000 annually is a big relief for people like us," she says. As the political parties jostle to win over the women, beneficiaries like Neelam feel the competitive cash handout promises only help their cause. More competition also means more cash, she says. Of late, the promise of financial assistance to women has become a norm in poll-bound States. In the wake of financial distress, cash handouts seem to have helped the BJP tide over anti-incumbency in several States. For instance, the Ladli Behna scheme in Madhya Pradesh, providing ?1,000 per month to women whose household income is ?2.5 lakh, is said to have enabled the party to retain power in the November 2023 Assembly election. After becoming the Chief Minister, Shivraj Singh Chouhan's successor Mohan Yadav raised the monthly amount to ?1,250 and promised to gradually increase it to ?3,000. Hoping to replicate the success in Madhya Pradesh, the ruling Mahayuti alliance — the BJP, the Shiv Sena of Eknath Shinde, and the Nationalist Congress Party of Ajit Pawar — in Maharashtra came out with Mukhyamantri Majhi Ladki Bahin Yojana with an outlay of ?46,000 crore to provide ?1,500 a month to 2.5 crore women between the ages of 21 and 65 earning less than ?2.5 lakh a year. The BJP successfully tried something similar in the recently concluded Haryana Assembly election as well. The Congress had promised ?2,000 to every woman aged between 18 and 60 if it came to power whereas the BJP had promised ?2,100 per month to women under Lado Lakshmi Yojana.

Despite going all out to woo the women vote in Maharashtra, the BJP has been targeting Soren in Jharkhand over the cash assistance scheme and calling it a political stunt before the election. The party's Jharkhand president, Babulal Marandi, had earlier accused the Chief Minister of luring voters by rolling out several schemes in the run-up to the election. "Hemant Soren cheated the people of Jharkhand for five years. Bholi bhali janata ko dana daal rahe hai takey phas jaye (He is laying the bait to trap the innocent public now that the election is nearing)," Marandi said at an event recently. Soren already transferred the third instalment of the scheme earlier this month. In a recent statement, the Chief Minister said, "We have connected half of the State's population with the Samman Yojana, which has created history in this country. Fifty lakh women have been con-

nected with this. We are empowering the mothers and sisters of the State."The first instalment was given on the eve of Rakshabandhan in August, second in September, and the third was rolled out in October. The fourth instalment would be transferred on the eve of Chhath Puja on November 5. Mounting an attack on Soren, Assam Chief Minister Himanta Biswa Sarma, who is also the BJP co-incharge of the Jharkhand Assembly election, accused him of tricking the women of Jharkhand by not giving ?2,500 from the beginning and revising the amount only after the BJP's offer. Before the imposition of the Model Code of Conduct on October 15, around 60,000 women filled the forms for Gogo Didi Yojana, he said. "We are committed towards our promise of Gogo Didi Yojana and whenever the first Cabinet of the BJPled NDA is formed, this scheme will start. Unlike Hemant Soren, we will not wait for five years. If he had the resources for giving ?2,500, why did he start the scheme with ?1,000?" Sarma said. Trying to blunt the Opposition's attacks, the JMM has fielded its Gandey MLA and Chief Minister's wife Kalpana Murmu Soren, who has been leading the JMM outreach, 'Maiya Samman Yatra', in a bid to connect with the State's women population. Kalpana entered politics earlier this year after her husband was jailed in an alleged money laundering case in March. He was later released on regular bail. She went on to contest and win the Gandey bypoll, a seat vacated after Sarfaraz Ahmad's election to the Rajya Sabha, by a margin of 26,000 votes. Despite entering the political arena only a few months ago, the Gandey MLA is the 'star campaigner' that every JMM leader wants to campaign in their favour. So far, she has done over 50 public meet-

### India's Office Space Demand to Reach Record High of Over 70 mn sq. ft. in 2024: Savills India



The office space market in India is set to break records in 2024, with absorption projected to exceed 70 mn sq. ft., according to the latest report from Savills India, a global real estate advisory firm. The demand reached 55.1 mn sq. ft. between January and September 2024, marking a 30% year-on-year (YoY) increase across six major cities.

The Year-To-Date (YTD) leasing activity has set a new benchmark for the January-September period, aligning with 2022's full-year performance. With only 7 mn sq. ft. remaining to surpass 2023's total, 2024 is expected to achieve absorption levels in the range of 70-74 mn sq. ft.

Q3 2024 Surge

The third quarter of 2024 saw office absorption hit 20.2 mn sq. ft., a 28% increase from Q3 2023. Bengaluru, Delhi-NCR, and Mumbai collectively contributed

66% of the overall leasing activity during this period.

The IT-BPM sector led the market with a 29% share in Q3, followed by Flexible Workspaces (23%) and the BFSI sector (22%). Additionally, large deals accounted for 50% of total leasing activity, with Bengaluru, Delhi-NCR, and Pune driving more than 50% of their respective leasing through such transactions. While demand soared, new office completions slowed down during the first nine months of 2024, with a total of 32.6 mn sq. ft. added, reflecting a 12% YoY decline. As a result, vacancy rates decreased to 15.5% by the end of September.

2024 Projections

Savills India forecasts that leasing activity will reach 70-74 mn sq. ft. by the end of 2024, representing a 17% increase from last year. New completions are also expected to accelerate, with a projected total of 60-62 mn sq. ft., a 22% increase from 2023.

### Curbs on social media, protests for Secretariat security personnel

Hyderabad: Stressing that there was a constant surveillance on personnel posted on security duty at Secretariat, the Chief Security Officer (CSO) of the Secretariat has instructed Telangana Special Police personnel and officers not to post, share, like or comment on any messages against the TGSP system, police officers and the State government on social media platforms. Pointing out that Section 144 was

Personnel should exit from such WhatsApp groups," the CSO said in the orders. ### For product consistency, Air India plans to minimise overlap with Vistara aircraft on common routes

Air India, Vistara, aircraft overlap, merger, route-level, product quality, In its nearly 10 years of operations, Vistara had made a mark for itself as the premier fullservice carrier in India that offered a superior product in a market dominated by budget carriers. (Express Archives)Air India plans to minimise the overlap between its older aircraft and Vistara planes at the individual route level after the carriers' impending merger in a bid to provide certainty to flyers regarding the quality of product they are likely to experience, according to sources in the know. Vistara's 70 aircraft-63 narrow-body and seven widebody jets-offer a superior passenger experience than most of Air India's fleet, which still has a number of old legacy aircraft from its government ownership days.

Air India has already announced that after the merger, which will take effect on November 12, the Vistara product will continue as it is for a few months at least and customers will be able to identify flights operated by the Vistara aircraft and crew easily as they will have a four-digit flight number starting with 2, against Air India's three-digit flight numbers. Sources indicated that the product differentiation is likely to continue at least till June, when the retrofit programme for Air India's legacy narrow-body fleet is scheduled to be completed. With new aircraft coming in and

older aircraft undergoing refurbishment, Air India will eventually be able to offer a uniform product across its fleet and the planes will largely become fungible.

In the interim, the Tata group airline will try and ensure that each route has consistency in its product offering, which would mean that the carrier will look to deploy Vistara's aircraft and its own new aircraft on certain priority routes like those connecting metropolitan cities with one another, and deploy Air India's older aircraft on certain other routes, per sources. The idea is to set the customer's expectations right and offer a consistent product on that route irrespective of the flight booked. The rejig will not be limited to just the domestic network of the enlarged Air India, and would include international routes as well where currently both Air India and Vistara operate. Slots at certain international airalso being adiusted are accordingly. "Vistara aircraft and Air India's new aircraft will most likely be used to operate metro-to-metro routes, while the older planes will be deployed on some other routes. The overlap will be minimised on international routes as well, like Delhi-Frankfurt flights are likely to be operated by the Vistara aircraft, while Delhi-Paris may be served only by Air India aircraft...Of course, a few overlaps here and there cannot be avoided," said a source with direct



knowledge of the matter.In its nearly 10 years of operations, Vistara had made a mark for itself as the premier full-service carrier in India that offered a superior product in a market dominated by budget carriers. With the Tata group deciding to merge Vistara into the group's flagship airline Air India—which the Tatas acquired from the government in January 2022—there were concerns about Vistara's product and service quality after the merger. Under government control, Air India was under financial stress, and this reflected in its product and

service quality, which was seen as below the standards expected from a full-service carrier. While the now-privatised airline has undertaken a mammoth fleet modernisation and expansion plan, it still has a large number of legacy aircraft that are in a rundown state. The \$400-million upgradation of the airline's entire narrowbody fleet started last month and is expected to be complete by the middle of next year. As for its legacy wide-body aircraft—Boeing 787s and 777s—Air India expects their retrofit to start early next year.

#### Why this is not just another BRICS in the wall

The Kazan Declaration and leadership interactions marked the success of the 16th BRICS Summit hosted by Russia on the theme of "strengthening multilateralism for just global development and security". Prime Minister Narendra Modi highlighted India's priorities and approach for the expanded BRICS+, which was meeting for the first time at summit level. Not many anticipated that a report by Goldman Sachs on the economic potential of four emerging economies — Brazil, Russia, India and China — would capture the global imagination in the manner it has. The decision to constitute the group was taken when the four leaders met in the margins of G8 Outreach in 2006 in St Petersburg, when Russia was still a member, and their desire was not to break the umbilical cord with the developed world, but to use all levers for their development targets. As a 21st century grouping, BRICS showed the ambition and innovation expected of a Gen Z institution. It developed a broad development agenda and sought reform of global governance with focus on delivery. It incorporated South Africa in 2010, doubled membership in 2024 and set up a new tier of partner countries at Kazan.

Economic slowdown in the West, the widespread impact of Covid and the outbreak of conflict in Europe, West Asia and South China Sea accentuated the divide between the West and Russia-China. The contestation between the two led to narratives from the West that BRICS was anti-West, while BRICS members responded that it was non-West. Bilateral tensions played a role. G7 was seen as representing the West, BRICS representing the Global South and G20 had elements of both. However, BRICS founding members were middle powers with economic and strategic potential. They sought to work in partnership with the West and the Global South to achieve their objectives, but could not be bound in alliance formations. At Kazan, BRICS leaders, many of them close partners of the West, pointed out that BRICS sought partnerships and desired good relations with all countries and was not directed against any. The thrust of the BRICS agenda, since early days, was economic development through intra-BRICS cooperation as well as collaboration with multilateral development banks. It expanded to various sectors of the economy, explored projects for cooperation and negotiated action plans. BRICS countries experienced rapid economic growth with tangible benefits to citizens. In fact, BRICS overtook G7 in terms of GDP, economic growth rate, access to critical materials and population.

BRICS members created new instruments and institutions when the global system did not respond adequately to their aspirations. The new instruments, including the Contingency Reserve Arrangement or the New Development Bank, were not alternatives to MDBs, but rather to supplement their efforts. At Kazan, there was priority on intra BRICS engagement in different economic fields. The expansion of membership gave the group greater heft. Besides, BRICS could engage other members of the Global South. The Russian presidency promoted the decade-old understanding on trade in local currency and new mechanisms of financial settlement. While



this was, in part, a response to sanctions imposed on certain BRICS countries, its broader objective was to achieve flexibility in the exchange of goods and services, new access in BRICS markets and efficiency in financial transactions. There were suggestions for a BRICS currency or a digital currency, but they were premature and would require deeper integration of the diverse economic situations and institutional frameworks. Admittedly, some new trade would be conducted in local currencies, but the dominant presence of the US dollar seems unlikely to be shaken by these measures.

Multilateral institutions such as the UN, WTO and WHO and Bretton Woods structures such as the World Bank and IMF that hold the key to global governance are unable to respond to contemporary challenges on development and security. There is an urgent need for reform, but consensus is lacking and multilateralism is in a coma. Even within BRICS, a founding member has not been helpful, particularly with regard to the reform of UNSC.At Kazan, leaders had wide-ranging discussions on regional and global issues that were reflected in the Declaration. On the key issue of UN and UNSC reform, it is welcome that the expanded BRICS+ continued with the Johannesburg understanding, even though reference to specific countries and concrete measures for reform could not be agreed upon. On terrorism and its financing, there was an urgent call for closer coordination to fight the menace. Admittedly, reform of global governance can only take place within the multilateral system but groupings such as BRICS, G7, G20 can play a role. Consensus on geopolitical issues could be challenging and the expansion of members may bring more complex situations.BRICS does not have a secretariat, it depends on the participation of members and the presidency. A cornerstone of the group's decision making has been its consensus-based approach towards agenda, plan of action and membership.

BRICS' success became a magnet for other countries. Besides, emerging countries desire more space. The recent inclusion of Egypt, Ethiopia, UAE, Iran and Saudi Arabia was on the basis of agreed criteria. Their participation enriched the cooperation agenda and expanded regional reach. At Kazan, there was agreement on the guidelines for admission of a new tier of partner countries. With varying economic levels and political structures, an expanded

BRICS will need strong commitment to its ethos.At Kazan, PM Modi highlighted the importance of citizen-centric development, diplomatic initiatives for security challenges, fight against terrorism and urgent reforms in global governance. BRICS could remain open to new members or partners that subscribed to the BRICS ethos, its consensus-based approach and contributed to BRICS' and global growth. As a founding member of BRICS, the fifth-largest economy and the fastest growing major economy, India plays a unique role within it. It has not only shaped its agenda and priorities but has been instrumental in being the bridge between Global South, BRICS, G7 Outreach and G20

#### LinkedIn fined \$335 million for privacy violations in ad tracking

London: Microsoft-owned professional networking platform LinkedIn was on Thursday fined 310 million euros (around \$335 million) for privacy violations related to its tracking ads business. The Irish Data Protection Commission (IDPC) issued the under the European Union's General Data Protection Regulation (GDPR). The inquiry examined LinkedIn's processing of personal data for the purposes of behavioural analysis and targeted advertising of users who have created LinkedIn profiles. The decision, made by the Commissioners for Data Protection, Dr Des Hogan and Dale Sunderland, concerns the lawfulness, fairness and transparency of this processing. The decision includes a

reprimand, an order for LinkedIn to bring its processing into compliance, and administrative fines totalling 310 million euros, the Irish regulator said in a statement.DPC Deputy Commissioner Graham Doyle commented that the lawfulness of processing is a fundamental aspect of data protection law and the processing of personal data without an appropriate legal basis is a clear and serious violation of a data subjects' fundamental right to data protection. The networking platform had sought to claim (variously) "consent", "legitimate interests' and "contractual necessity" based legal bases for processing people's information - when obtained directly and/or from third parties — to track and profile its users for behavioural advertising.

#### 1968, a John Lennon love story: Beatles Ashram in Rishikesh set for a makeover

In the February of 1968, a lovestruck John Lennon would go on early morning walks to the post office on the premises of Chaurasi Kutiya, a retreat in Rishikesh on the banks of the Ganga where he and the other members of the Beatles band practised yoga guru Mahesh Yogi's Transcendental Meditation. His post office walks, as his wife Cynthia who accompanied him on that India visit would later realise, was to check if singer Yoko Ono, with whom he was in a relationship, had sent him a telegram. Inside one of the meditation huts of the now abandoned Chaurasi Kutiya ashram is a pop art that immortalises this love story - a line from Yoko's telegram to Lennon that reads, "Look up at the sky and when you see a cloud, think of me.

Lennon's fledgling love story, one of the many priceless nuggets from the Beatles' India stay in 1968, will now come to life as the Uttarakhand government plans to renovate the ashram. It hopes to turn the 17-acre space - with a string of concrete, double-storey hobbit houses, pathways overrun by weeds and deserted buildings into an 'International Heritage Tourism destination'.beatles The Beatles during their stay at the ashram in 1968. Standing on the banks of the Ganga, the ashram is now a space frozen in time. Under tall trees and amid patches of wild canna plants are the buildings and meditation centres of Mahesh Yogi's Chaurasi Kutiya, which after the Beatles' 1968 stay became popular as the Beatles Ashram. The iconic British band spent nearly a month here, meditating and writing at least 30 songs, including those from The Beatles (White Album) released later that year. For the Ahmedabadbased HCP Design, Planning & Management Pvt Ltd, which is executing the renovation project, this is the second ashram project after the Gandhi Ashram Redevelopment Project in Gujarat. Helmed by architect Bimal Patel, the firm has handled several high-profile projects, including Central Vista and the new Parliament building in Delhi, and the Kashi Vishwanath corridor project in Uttar Pradesh. According to Anand Patel, project head at HCPDPM, "The project is expected to commence by the end of 2024. It will take about 18 months to be completed at an estimated cost of Rs 90 crore. Inside the ashramPart of the Rajaji Tiger Reserve, on the eastern banks of the Ganga, the ashram was set up by Mahesh Yogi in 1963, with his Transcendental Meditation Teacher Training Course attracting participants from around the world. He is known to have built it with a USD 100,000 grant from American heiress Doris Duke. Among the most famous visitors to the ashram were the Beatles, who were then famously embarking on a journey from psychedelia to transcendence. In February 1968, John Lennon, George Harrison, Paul McCartney and Ringo Starr arrived at the Rishikesh ashram accompanied by their wives and their manager. Here, they wrote some of their most popular songs, including 'Back in the USSR', 'Dear Prudence', 'Julia' and 'The Continuing Story of Bungalow Bill'. Ved Bhavan Constructed in 1976 at Chaurasi Kutiya in Rishikesh, Ved Bhavan was used as a lecture hall and to conduct classes. Chaurasi Kutiya gets its name from the 84 meditation rooms - 42 each on either side of a yoga centre. The complex has nearly 25 buildings, most of which are in a dilapidated state, including the sprawling bungalow that Mahesh Yogi lived in while at the ashram. Though it's unclear when he left the ashram, the spiritual guru died years later, in 2005, in the Netherlands.Among the few buildings that are relatively untouched by time are the unique pyramidshaped Anand Bhavan and Siddhi Bhavan, built in 1976, which served as residences for those training to be teachers of Transcendental Meditation.Inside the ashram, the story of the Beatles is told through a gallery with over 20 photographs taken by Paul Saltzman, a Canadian filmmaker and television producer who chronicled the Beatles' stay. A striking feature of the ashram is the series of concrete huts, which served as meditation caves for "sanyasis and brahmacharis". The walls of the 121 huts, built in 1976-78, are embedded with round pebbles sourced from the river banks. Each of these huts have a narrow, winding stairway that leads to the floor above. As per the renovation plan, at least 20 of these huts will be refurbished for people to use as meditation spaces. Keeping a legacy alivelt was in 1961 that land for the ashram was leased to Mahesh Yogi by the then Uttar Pradesh government. After the 20-year lease expired in 1981, the place was taken over by the state government. While the ashram remained abandoned, its Beatles connection continued to draw visitors. In 2015, the Uttarakhand forest department took over the ashram, which is the only part of the Rajaji Tiger Reserve that is open through the year. That year, the ashram reported 20,000 visitors, which spiked to 35,000 in 2018 when Paul McCartney came to celebrate 50 years of the Beatles' visit to Rishikesh. The ashram saw more tourists in June 2023, when the Uttarakhand government, which had hosted a three-day Infrastructure Working Group (IWG) meeting in Rishikesh as part of the G20 summit, took the delegates to the ashram. That year, the number of visitors rose to 45,000.A vision document for the redevelopment has been readied and is now with the Public Works Department (PWD) of the Uttarakhand government for vetting, a state government official told The Indian Express.Uttarakhand Forest Minister Subodh Uniyal said not much of what is inside the ashram will be disturbed. "The plan is to keep it in as-is condition. The idea is to preserve the legacy of the Beatles," he said. Though the project is being undertaken by the state tourism department, the area falls in the jurisdiction of the forest department as it is part of the reserve forest that is a habitat for tigers and elephants, among other protected species. Conservator of Forests & Director of Rajaji Tiger Reserve, Koko Rose, told The Indian Express, "Around 9-13 buildings will be refurbished - the Maharshi's bungalow, the building where the Beatles stayed, the Vedic kitchen. There will be no new construction and no razing. The idea is to enhance the tourist experience. Being a forest area, nobody will be allowed to stay overnight, play loud music or do anything that could disturb the wildlife." "A cafeteria, a museum shop and administration



office will be housed in the renovated buildings. The other buildings will have exhibitions on the Maharishi, Beatles and the Rajaji National Park. We plan to repair and

restore 12 of the 25 buildings on the site. All the remaining buildings will be left as they are to serve as a memory of the time gone by," he said.

### OpenAl plans to launch new powerful Al model 'Orion' by December: Report



San Francisco: ChatGPT maker OpenAI is reportedly planning to launch its next AI model called 'Orion' in December this year which is potentially up to 100 times more powerful than GPT-4.According to a report in The Verge, unlike the release of OpenAI's last two models — GPT-40 and o1 — Orion won't initially be released widely through ChatGPT.

The report mentioned, citing sources, that the Sam Altman-run Al company is planning to grant access to companies first, in order to help them build their own products and features. OpenAl or its CEO Altman were yet to react to the report. According to the report, Microsoft is "preparing to host Orion on Azure as early as November". Microsoft also declined to comment. "The company's goal is to combine its LLMs over time to create an even more capable model

that could eventually be called artificial general intelligence, or AGI," the report mentioned. The release of Orion comes as OpenAI, which has secured a historic \$6.6 billion funding at a \$157 billion valuation. is restructuring itself as a for-profit entity.Last month, three top executives including Chief Technical Officer Mira Murati - left the ChatGPT developer. Of the 13 people who helped found OpenAl in 2015, only three now remain at the company. According to reports, Murati is raising money from venture capitalists to finance her own AI startup. The new funding in OpenAl was led by previous investor Thrive Capital. The VC firm invested around \$1.3 billion. Microsoft reportedly invested a little less than \$1 billion, while Nvidia pledged \$100 million and SoftBank reportedly put in \$500 million."
