Punjab farmers, arhtiyas to meet CM Mann seeking solutions shortly



GNS News Agency, oct 19, The Samyukt Kisan Morcha-led front of farmers, commission agents and rice millers on Saturday ended their protest over 'tardy' paddy procurement after they got an assurance from Punjab Chief Minister Bhagwant Mann on meeting their demands.CM Mann had on Friday invited the representatives of various unions and associations for a meeting at 4 pm on Saturday.

Farm leader Balbir Singh Rajewal announced to end the protest after SKM-led front members' meeting with CM Mann. Earlier, representatives of various unions held a two-hour long meeting at Kisan Bhawan here.

Paddy procurement in the state remains tardy, with just 14.30 per cent of the total paddy arrivals being lifted from mandis. This has led to a glut in all mandis of the state, with 18.31 lakh metric tonnes of paddy (LMT) arriving in mandis and only 2.62 LMT being lifted. Earlier in the day, Food and Civil Supply minister Lal Chand Kataruchak said that the state government was doing all within its means for the benefit of farmers, rice millers and commission agents. "Their demands are basically from the Centre. I believe the Centre is biased against Punjab, which is creating problems in paddy procurement this year," he said. Kataruchak said that the state government was in regular touch with FCI officials for the movement of stored foodgrains from godowns in the state, so as to create space for the rice to be milled from this year's paddy. "The movement of grains is higher by 4 LMT as compared to previous years. By the end of this month, 13 LMT will be moved out and 9.50 LMT has already been moved out," he said.

GO 29 violative of the Constitution: Harish Rao

Siddipet: Former Minister T Harish Rao said the implementation of GO 29 in the recruitment process of government jobs in the state would do a great injustice to the STs, SCs, BCs and Minority job aspirants because the GO would deny them a good number of jobs for these sections. Speaking to news reporters here on Saturday on the ongoing stir by job aspirants against the GO issued by the Congress government, Rao said number of posts in the reservation category will go down if anyone from that reservation category bagged jobs in the open category according to the GO. "The number of posts will be removed equally to the number of people from the reservation category bagging posts in the open category",

Rao said that the GO was violative of the constitutional provisions since the open category would mean everyone could get the posts based on merit. Saying that the previous BRS government implemented GO 55, Harish Rao said the UPSC was also following a similar pattern that the BRS government implemented. While Congress leader Rahul Gandhi was touring the nation holding the Indian Constitution, he said the same party's government was acting against constitution in Telangana, causing a great injustice to the reservation categories.

Even though Deputy Chief Minister Bhatti Vikramarka, a dalit, was at the helm of affairs, Rao said that it was hurting to see such a GO being implemented. He further lashed out at the Congress government on how they dealt with the protesting students. He said the police had lathi-charged students if they were terrorists. Recalling the Congress promises made during the election campaign, Rao said that Chief Minister A Revanth Reddy had failed to keep the promises even after 11 months. He challenged Revanth to visit Ashok Nagar library now to know the issues of job aspirants like he did when he was in the Opposition. Rao questioned the silence of the MLC Kodandaram and other leaders on the issue. He said that Kodandaram, Riyaz, Chitnapandu Naveen, and Akunuri Murali stayed mum because they got the posts.

INDIA bloc announces seat sharing arrangement in Jharkhand, RJD dissatisfied with 'unilateral decision'

The INDIA (Indian National Inclusive, Developmental Alliance) bloc on Saturday (October 19, 2024) announced the sharing of seats for the upcoming Jharkhand Assembly election between the Jharkhand Mukti Morcha (JMM), the Congress, the Rashtriya Janata Dal (RJD), and the Left parties.Chief Minister Hemant Soren, accompanied by Jharkhand Congress party in-charge Ghulam Ahmad Mir in Ranchi, announced that the JMM and the Congress would contest in 70 seats, and the RJD and Left parties would contest in the remaining 11 seats.

"Every political party is preparing for the Assembly election, and people are keen to know which party will contest on how many seats. We, the INDIA bloc, have taken this election seriously, and every aspect is being scrutinised. In this election, the Left parties are also a part of our alliance. Out of 81 Assembly seats in Jharkhand, the JMM and Congress will contest in 70

More than 30 flights of various Indian airlines, including Vistara, Air India and IndiGo, received bomb threats on Saturday, according to sources. Flights of Air India, IndiGo, Akasa Air, Vistara, SpiceJet, Star Air and Alliance Air have received the threats, the sources said.

So far this week, at least 70 flights of Indian carriers have received bomb threats and most of them turned out to be hoaxes. The sources said more than 30 flights, including domestic and international ones, operated by domestic airlines have received bomb threats through social media since Saturday morning. In at least one of the flights, a note was found in the lavatory saying there was a bomb in the flight. On Saturday (October 18, 2024), Vistara said five of its flights on international routes received security threats through social media while IndiGo said at least four of its flights got security-related alerts. The five flights of Vistara are UK106 (Singapore to Mumbai), UK027 (Mumbai to Frankfurt), UK107 (Mumbai to Singapore), UK121 (Delhi to Bangkok) and UK131 (Mumbai to Colombo). "Following the protocol, all relevant authorities were promptly alerted and all security proce-

dures are being adhered to, as per the guidance from the authorities and security agencies," an airline spokesperson said in a statement. Besides, there was a security concern regarding Vistara flight UK624 from Udaipur to Mumbai, and after landing, the aircraft was taken to an isolation bay for mandatory checks. A note was found in the lavatory of the aircraft saying there is a bomb in the flight, a source in the know said. The airline said it is cognisant of a situation involving flights from Mumbai and

Regarding the Jodhpur to Delhi flight, the carrier said the plane landed in the national capital and customers have disembarked the aircraft. About Hyderabad to Chandigarh flight, IndiGo said that upon landing, the aircraft was isolated and all passengers were safely disembarked. Sources said that the plane was being checked at Chandigarh airport thoroughly by the airport authorities at the isolation bay.

On Friday, three international flights of Vistara received bomb threats which turned out to be hoaxes and one of the flights was diverted to Frankfurt as a precautionary measure.

ED continues raids at MUDA office, crucial records missing

Mysuru: The Enforcement Directorate (ED) sleuths continued raids at the Mysuru Urban Development Authority (MUDA) office on Saturday in connection with the scam involving Chief Siddaramaiah. Sources said the ED was likely to intensify its search as crucial documents related to ownership, denotification and land conversion were missing. The Central Reserve Protection Force (CRPF) personnel and local police were deputed at the MUDA office.

The CRPF personnel stayed at the MUDA building the entire night. The main entrance was locked and only MUDA officers, security personnel and ED sleuths were allowed. As per the instructions of the ED officers, MUDA Commissioner Raghunandan AN and all senior officers arrived at the office early in the morning. The ED officers conducted searches and inspections in the MUDA till 11 pm on Friday and grilled Commissioner Raghunandan and other senior officers about the original documents relating to the land ownership and allotment to CM Siddaramaiah's wife Parvathy. According to sources, major documents of the ownership of the land allotted to CM Siddaramaiah's wife dating back to 1992 were missing from the MUDA. When asked, Commissioner Raghunandan told the ED that he had taken charge of the MUDA recently and didn't know about it.

Yadav's removal

THE removal of Indian official Vikash Yadav, alegedly under US pressure, has ignited fresh concerns about India's international standing and its security oprations abroad. Yadav, now charged by the US Department of Justice, is accused of plotting the assassiation of Gurpatwant Singh Pannun, a US-based Sikh eparatist leader tied to the Khalistan movement. This ase has escalated diplomatic tensions between India and the US, with the broader Five Eyes alliance watchng closely. The US indictment of Yadav underscores Washington's strict stance against foreign interference n its soil. With Pannun designated a terrorist by India he government's security agencies have considered him a serious threat. However, allegations of an extraudicial assassination plot targeting Pannun on US soil ave sent shockwaves through diplomatic channels. The US decision to publicise these charges suggests nounting pressure on India to ensure that its security neasures align with international law. The situation has peen further complicated by India's ongoing diplomatic pat with Canada, following its Prime Minister Justin Frudeau's accusations linking Indian agents to the killng of another Khalistan sympathiser, Hardeep Singh Nijjar. This allegation has drawn in the Five Eyes intelgence alliance — it comprises the English-speaking countries of the US, the UK, Canada, Australia and New Zealand. In particular, the UK has called for India's coperation in investigations, signalling that these nations re scrutinising India's handling of separatist movenents abroad. Yadav's removal from government serrice appears to be a direct consequence of US diplonatic pressure, reflecting a broader international conern over India's counterterrorism practices. New Delhi nust carefully navigate this situation to avoid deeper trains in its relationships

'Not right to compare Haryana with Maharashtra....will dethrone Mahayuti': Maha Congress MLA Dhiraj Deshmukh

With just over a month left for the Assembly elections, the Maharashtra Congress is hoping to move on from the party's Haryana debacle and repeat its Lok Sabha magic in the state. Speaking to The Indian Express, Dhiraj Deshmukh, Congress MLA from Latur (Rural), said that every region has its own issues and the party will highlight issues related to soybean prices, unemployment, and agrarian distress in the state's Marathwada region. Deshmukh, the son of the late chief minister Vilasrao Deshmukh, also said that the Maha Vikas Aghadi (MVA) was determined to defeat the Mahayuti alliance in the upcoming Assembly election.

Q: Will the Haryana results affect Maharashtra? With just over a month left for the Assembly polls, how prepared is the Congress?

Deshmukh: If we are to analyse the Haryana Assembly results, the Congress party has registered a good increase in its vote share. Yes, seat-wise, we were not able to make it but our footprint and vote share has increased. Each state has its own story and to compare one state with the other would not be the right kind of comparison. What is often lost in the media is that BJP went with its abrogation of Article 370 for the polls in Jammu and Kashmir, yet it lost to the INDIA alliance. In Maharashtra, we are ready to fight as the Maha Vikas Aghadi (MVA). Our main aim is to dethrone the corrupt Mahayuti government and bring back the rule of law.

Q: In the Lok Sabha polls, Congress had the best strike rate in Marathwada where it won all 3 seats it contested. Will this be reflected in the seat-sharing? When will it be made public?

Deshmukh: Seat-sharing is being finalised by the MVA seniors. But yes, Congress's performance was the best in Marathwada. In fact, MVA won eight of the nine seats in the region. As MVA, we have surveyed individual seats and have given our feedback to the party leaders. The seat-sharing arrangement will be made public soon. Our main aim is to fight together and win.

Q: Marathwada has been at the centre of the Maratha reservation agitation led by Manoj Jarange Patil. How will this play out in the elections? What are the main issues Congress will raise here?

Deshmukh: Of course, we support reservation for the Maratha community and Jarange Patil enjoys support across the state. Our leader and Leader of the Opposition in the Lok Sabha, Rahul Gandhi, has talked about the caste census. This will be undertaken to show the economic and social status of all castes. The Mahayuti has done politics to divide people and we will ensure people get justice.

Every region has its own issues which will be different from each other. The issues of Konkan and Mumbai will be different from those in Vidarbha. For Marathwada, the low realisation of soybeans, the lack of employment opportunities, and agrarian distress are important. Farmers have not received help from crop insurance, these are the issues we are highlighting.

Q: Leaders are queueing up to join the NCP (SP) before the Assembly polls. What is the scene in the Congress?

Deshmukh: We have seen the Khatgaonkar family rejoining the Congress in Nanded. People who want to fight elections seriously are in touch with us. In some cases, we are taking a call on asking people to join other constituent parties depending on the strength of the parties in those areas.

Stung by KMVSTDC scam, Karnataka Government decides to name Raichur varsity, ST residential schools after Valmiki

Under fire from the Opposition over the Karnataka Maharshi Valmiki Scheduled Tribes Development Corporation (KMVSTDC) scam, the state government Thursday decided to name Raichur University and all Scheduled Tribes residential schools after Valmiki.Valmiki was a legendary poet who is largely considered to have authored the epic Ramayana.

The announcement was made by Chief Minister Siddaramaiah during the Valmiki Jayanthi celebrations

held at Vidhana Soudha. The move is being seen as an attempt to mollify the anger of the Valmiki community – an ST group. The Valmiki community is learnt to be unhappy over the misappropriation of funds at KMVSTDC, which saw the arrest of former minister B Nagendra by the Enforcement Directorate. Siddaramaiah said that there was a demand from the community to name a varsity after Valmiki. "The KMVSTDC chairman has suggested that the university at Raichur should be named after Valmiki," he said. This is to honour Maharshi Valmiki by the state, the CM added.

The KMVSTDC scam, it can be recalled, had come out in June this year following the death by suicide of an employee of the corporation. In his suicide note, he had blamed senior officials of KMVSTDC of illegally transferring funds from its accounts. The state government formed a Special Investigation Team (SIT) to investigate the case, even as CBI and ED registered complaints over the issue. Former Scheduled Tribes Welfare minister B Nagendra was arrested by ED in connection with the scam in July, and was released on bail earlier this week. SIT, meanwhile, had given a clean chit to the minister in connection with the scam.

10 years after man buys 'faulty' laptop, Delhi consumer forum asks Acer to pay Rs 47,000 as compensation

After an eight-year legal struggle, a District Consumer Court on November 29, 2022 sided with him and directed Acer to compensate him with Rs 22,000.After an eight-year legal struggle, a District Consumer Court on November 29, 2022 sided with him and directed Acer to compensate him with Rs 22,000.The Delhi State Consumer Disputes Redressal Commission on Monday directed Acer India to pay Rs 47,000 for a "defective" laptop that a complainant had purchased on June 24, 2014.

Abhishek Bansal, a resident of Delhi, had purchased an Acer laptop with pre-installed Microsoft Windows 8.1 operating system. His laptop ran into multiple issues – the applications and programmes were not working, there was no sound, CDs and DVDs were not being read, and documents took forever to get saved to name a few.

Bansal alleged that he called customer care multiple times and followed the directions that were given to him but to no avail. When his laptop didn't start functioning normally, he was forced to visit the service centre multiple times. He even claimed that he had to reinstall the software in his laptop 24 times.

After an eight-year legal struggle, a District Consumer Court on November 29, 2022 sided with him and



directed Acer to compensate him with Rs 22,000. Dissatisfied with this amount, he moved the Delhi Consumer Commission which advanced the compensation amount by Rs 25,000. Bansal's contention was that the District Consumer Court had not taken into account the mental agony faced by him or his legal expenses. It is clear from the record that the Appellant had fought this case for about eight years before the District Commission and the District Commission failed to compensate adequately with respect to mental and physical agony suffered by the Appellant (Bansal)," the Delhi Consumer Commission noted in its order dated October 14.

Australia offers one-year work and holiday visa for Indians

AustraliaMatt Thistlethwaite, Australian Assistant Minister for Immigration, held a launch event in Blue Tokai at Delhi's Khan Market on Monday to promote the initiative.

Indians between 18 and 30 years of age now have an opportunity to visit Australia for a year under the Working Holiday Maker programme. Under the programme, Australia is offering a one-year work and holiday visa for up to 1,000 eligible Indian citizens. The selected Indians can do short-term work in Australia for three months to help fund their holiday and study for up to four months. They will also become eligible for a second work and holiday visa. Over 40,000 Indians have already applied for the visa. India officially joined the Working Holiday Maker visa programme on September 16, becoming the

50th country to do so. This initiative was a part of the Australia-India Economic Cooperation and Trade Agreement.Matt Thistlethwaite, Australian Assistant Minister for Immigration, held a launch event in Blue Tokai at Delhi's Khan Market on Monday to promote the initiative. "We feel very proud to launch the Working Holiday Maker Visa for young Indians to come to Australia and to experience Australian culture," said Thistlethwaite. "Almost a million Australian citizens claim Indian heritage. The Indian diaspora is the fastest growing in our country. This initiative is another opportunity for Indians to experience our culture. It's a temporary visa but it gives you a taste of what Australia's like," he said, adding that Indians could then come back and apply for a student or work and holiday visa

"There are no restrictions on the jobs that you can do. You can work in any industry. We find that people generally tend to work in the hospitality sector but there are no restrictions at all...," Thistlethwaite added. From October 1, eligible Indian passport holders interested in applying for the visa started registering in a visa preapplication process. To be eligible to apply, one should have an Indian passport and must be between 18 and 30 years old. The selection will be done through a ballot process. Those registered will be randomly selected. The online registration is open till October 31. From October 14, random selections of the registrations will take place till April 30, 2025. Those randomly selected to apply for the visa will be notified via email.

Patna doctors ordered to pay Rs 50 lakh to mother whose newborn had its left leg amputated

The national consumer court in Delhi has ordered two doctors of two private hospitals in Patna to pay Rs 50 lakh to a woman for medical negligence that led to the amputation of the leg of her son, days after his birth in 2007. The child's records at the time of admission to Sir Ganga Ram Hospital in Delhi revealed that his left foot was "gangrenous", a state of tissue death due to lack of blood supply, which demanded amputation below the knee. The National Consumer Disputes Redressal Commission (NCDRC) on October 10 gave relief to Soni Bharti who delivered the baby boy on February 11, 2007 at Manas Nursing Home in Patna. The baby was soon shifted to the Neonatal ICU (NICU) of another nearby hospital, Kids Care Clinic, as it developed chest infection and breathing problems. The consumer court pulled up the doctors of the two hospitals for delay in conducting a doppler test (a test used to detect blood flow) on the newborn. The second hospital conducted the test on the baby only on the sixth day of admission after Bharti noticed blue colouration on the baby's leg.On the 10th day of admission, the child was referred to Sir Ganga Ram Hospital in Delhi. "By delaying the recording of the fact of Peripheral Cyanosis (bluish discolouration of hands, fingertips and toes) and the conduct of the Doppler Test...the

duty of care was breached (by the doctors)...," held the NCDRC in its order.Bharti had told the National Consumer Commission that due to heavy doses of medication, inappropriate treatment and an inordinate delay in treatment by the doctors, her baby's left leg had to be amputated."In the instant case, in view of the fact that the patient who suffered damage of amputation of his left leg within days of birth, quantification of the monetary claim on any available criteria such as loss of income is not possible. For a lifetime of existence as a handicapped person, the claim of Rs 50 lakh cannot, however, be considered as exorbitant or for undue gain, as it would entail various costs for treatment including prosthetics, education and subsequent employment for livelihood," held the National Consumer Commission. The doctors had stated that the child was provided "prudently and diligently with due care and caution". They also said that a paediatrician and cardiovascular surgeon were also consulted who endorsed their line of treatment. Earlier, a state consumer court had sided with the doctors holding that Bharti had failed to bring on record any expert medical opinion to establish that the doctors had been negligent in attending to the patient. The NCDRC, on the other hand, also ruled that the contention of the doctors that the patient was diagnosed correctly cannot be accepted. "

SGPC president Dhami says India, Canada should adopt Iogical approach over Hardeep Singh Nijjar's murder

Amritsar, October 17: Shiromani Gurdwara Parbandhak Committee (SGPC) president Harjinder Singh Dhami Thursday expressed concern over growing differences between India and Canada over the murder of Khalistani separatist Hardeep Singh Nijjar.Harjinder Singh Dhami said both countries should adopt a sincere approach to solve the matter.

"A large number of Indians, and especially Punjabis, live in Canada, who are naturally affected by the deteriorating relations between the two countries. In the case of Bhai Hardeep Singh Nijjar's murder, both the nations should adopt a logical approach instead of levelling allegations," said the SGPC president. Dhami said that there should be no politics on this serious issue. "I appeal to the Government of India to conduct an impartial investigation in this matter, so that the situation can become clear," he added.

Canadian Prime Minister Justin Trudeau recently repeated his allegation that agents of the Indian Government were responsible for the murder of Nijjar on Canadian soil last year. The Indian Government has strongly refuted the allegation and blamed Trudeau for engaging in vote-bank politics.India expelled six Canadian diplomats on Monday, October 14, and also recalled Sanjay Kumar Verma, its High Commissioner to Canada, and other senior diplomats.

'I kept asking them what was my fault': Kolkata doctor arrested at Durga Puja carnival speaks about his detention

The on-duty doctor who was allegedly arrested for sporting a T-shirt and badge in solidarity with the RG Kar protests at the West Bengal government's Durga Puja Carnival said that he wasn't told the reason for his arrest.

"For over three hours inside the police station, before I signed the bail bond, I kept asking what my fault was," Tapabrata Roy, who was arrested Tuesday but released four hours later, told The Indian Express. "Officials said they didn't know the reason," he said.Roy, was on emergency duty as part of the Kolkata Municipal Corporation's medical team, was arrested after he was seen sporting a T-Shirt that said, "Spine is not for sale" and a badge with the words 'Pratiki Anashankari' (observer of symbolic hunger strike), both referring to the doctors' protests and hunger strike in the aftermath the rape and murder of a junior doctor at the RG Kar Medical College and Hospital in August.

Roy's arrest drew protests from fellow doctors, who held a demonstration outside the Maidan police station where he was being held.

Farmers await procurement of cotton produce in Adilabad

Adilabad: Farmers in erstwhile Adilabad district are waiting for procurement of cotton produce by the Cotton Corporation of India (CCI) to begin this year. Officials stated that the cotton crop was raised in 10.15 lakh acres in the region in the Vanakalam season. While Adilabad topped in growing the cash crop by seeing 3.96 lakh acres, Kumram Bheem Asifabad district accounted for 3.30 lakh acres. Both Nirmal and Mancherial districts witnessed raising of the crop by 1.47 lakh and 1.42 lakh acres respectively.

Officials estimated that erstwhile Adilabad district would register a yield of 71.05 lakh quintals this year. The CCI has already fixed Rs.7,521 per quintal as Minimum Support Price, reflecting an increase by Rs.500 when compared to that of 2023. However, farmers are unhappy over the price and expect a higher rate than MSP. "We learnt that CCI was offering MSP of Rs.8,257 per quintal to cotton farmers in Gujarat. We were clueless as to why the same agency did not quote the same price in Adilabad. Public representatives should take steps to ensure justice to the farmers. Else, the growers would register loss at least Rs.700 per quintal," a farmer opined.

How a hole in the wall saw Thane police solve a sensational murder

It's often the seemingly insignificant details that lead the police to achieve a breakthrough in their investigation. In 2011, the Thane police cracked a sensational murder case after an alert inspector spotted a hole in the wall of a suspect's house. By chasing this lead, the police caught the accused and a mastermind nobody suspected. On October 4, the Shanti Nagar police station in Thane received information regarding an unclaimed sack lying in a hilly area. A police team visited the spot and, on opening the sack, they were shocked to discover a man's legs. Police Inspector Janardan Babar, who was leading the investigation, formed a search team and instructed them to search the entire area. In the next few hours, the police found more such sacks — with more than half a dozen body parts inside.

The police put together all the body parts, and it seemed to be of a young man. As the news made headlines, the police were under tremendous pressure to solve the murder. The probe team immediately started making enquiries with neighbouring police stations, asking if any youngster had been reported missing. The police learnt that Rajaram Jadhav had reported his son missing at the Shahpur police station on October 1. When Rajaram was taken to the mortuary to check if the body parts belonged to his son, he burst into tears after he spotted a thread on the right hand of the deceased. He confirmed to the police that the body was of his son Shivaji Jadhav, 23.

While obtaining details about Shivaji, the police

learnt that he had no enemies. The police then contacted his close friend Vijay Pawar, with whom Shivaji spent most of his time. But even he was of no help.Later, the police learned from informers that Shivaji was close to a woman, Kamlabai Wagh, who was in her late 40s. When the police obtained details about Wagh, they learnt that she had married twice and had six kids. But her husbands and kids had left her due to her 'close friendship' with youngsters

The police now shifted their focus to Wagh as her house was also close to the place from where they had found the first sack with Shivaii's dismembered body. The police team inspected her house but failed to find anything suspicious. It was then that Inspector Babar, while carefully observing her house from outside, spotted a hole in a wall. Peeping through the hole, which was at waist height, he realised that one could get a view of Wagh's entire house. Babar had a hunch and decided to follow it. In plainclothes, the police ventured into the village where Wagh resided, and posing as fellow villagers, they started playing with the local kids. Babar's team met an eight-year-old girl who revealed that she stayed in the vicinity of Wagh's house. The police befriended her, cracked jokes, made her laugh, asked her questions and tricked her into talking. The innocent girl responded to their questions and left the police team shocked. The girl said she had watched Shivaji being murdered inside Wagh's house. Peeping through the hole in the wall, she also saw his body being cut into pieces, she said, as per the police. After this, the police arrested four people, including Wagh. Shivaji's father Rajaram was shocked because one of the four arrested accused was none other than Pawar, who was surprisingly also the alleged mastermind behind the murder. Pawar was allegedly having an extramarital affair with Wagh and was not in favour of Shivaji's growing affinity with her. He also suspected Shivaji of having an affair with his wife, the police said. So, he decided to murder Shivaji, the police added. Pawar allegedly convinced Wagh after offering her financial help to build a pucca house. She agreed and, as per their plan, called Shivaji to her place, telling him that she was alone at home, the police said. When Shivaii arrived, two men, Farukh Khan and Lalu Bhaiya, who were hired by Pawar, went inside and allegedly murdered him. To destroy evidence, at Pawar's behest, they allegedly dis-

New Congress state president 'seeking feedback from district heads' before renewing alliance with Left

With by-elections in six assembly seats scheduled to be held on November 13, alliance or seat sharing between the Congress and the Left is yet to be finalised. Subhankar Sarkar, newly appointed Pradesh Congress president, told The Indian Express that input from the party's district presidents has been sought before renewing their alliance with the CPIM. "Opinions have been sought from other leaders too... only after feedback on the ground situation, opinions and discussions, will we be able to take a call on the issue," said Sarkar, speaking over the phone. "I am yet to get a proposal or hear anything from them," he added when asked whether CPIM leaders have contacted him.

Meanwhile, Sujan Chakraborty, CPIM central committee member, said, "Our party's policy is to rally all against BJP in the centre and rally all against the TMC and BJP in West Bengal. There is no change in our stand. It is the right and prerogative of the new state Congress president to seek opinions from his party members and district presidents."On November 13, assembly seats of Sitai (Coochbehar district), Madarihat (Alipurduar district), Taldangra (Bankura district), Natihati (North 24 Parganas district), Haroa (North 24 Parganas district) and Medinipur (Paschim Medinipur district) will go for polls.

In the 2021 Assembly elections, five of these seats were won by the TMC and one by BJP. Neither the Indian National Congress nor the Left Front won a single assembly seat, despite contesting together. "We are in the process of strengthening our organisation. There is an atmosphere of fear. But we will do our best and we still have our organisation in the districts. The law and order situation is bad in the state. We have seen the R G Kar



incident and now the Nadia incident," Sarkar said. The CPIM, Congress, and Trinamool Congress are all partners in the national INDIA alliance, but in the Lok Sabha polls (held from April to June this year), the Congress and Left fought together against the ruling TMC in West Bengal. The then state Congress president Adhir Chowdhury was vociferous against the Chief Minister Mamata Banerjee-led Trinamool Congress.

While the Left could not make a mark, the Congress won just one Lok Sabha seat (Isha Khan Chowdhury from the Maldaha Dakshin seat), while Adhir Chowdhury lost from the Baharampur seat. The Congress had won two seats in the 2019 Lok Sabha polls. This year, out of West Bengal's 42 seats, TMC won 29, while BJP won 12 and Congress won one. In July this year, the Trinamool Congress swept Assembly by-polls in West Bengal after its candidates won all four seats that went to the polls. In all four seats, the BJP came a distant second while Left-Congress alliance candidates lost their deposits in three of the four seats.

Over 26,000 RTE seats in Maharashtra schools lying vacant, parents blame delay in starting admissions

After four rounds of admissions under Right To Education (RTE) in Maharashtra, 26,862 seats are lying vacant, which is over 40 per cent more than the vacancies (18,986) recorded last academic year. Parents blame it on the unprecedented delay in starting the RTE admissions this academic year. The RTE admissions cater to 25 per cent of reserved seats in private unaided schools for children from marginalised backgrounds up to Class

This year, RTE admissions in Maharashtra began on July 23 when schools have completed one month of the academic year due to amendments to the RTE implementation rules and subsequent court cases. When the normal school admissions for an academic year get completed by April-May, the RTE admissions are generally done during May, the RTE admissions generally begin in May. Even as a few parents are demanding for one more special round of admissions, most of the parents are demanding assurance from the school education department that RTE admission for the next academic year will begin in February. According to parents, due to the delay many of them have moved on from the system. "The RTE admissions did not have any clarity until late July when schools have generally completed almost a month of the new academic year. Parents were bound to go ahead with admissions received elsewhere to avoid academic loss for their children," said one of the parents.

According to the government's official website, 1,05,238 seats were available in 9,217 schools for RTE admissions this year in Maharashtra. There were 2,42,516 admission applications. But at the end of four rounds, only 78,376 applicants have confirmed admissions in the allotted schools.

The recent amendment in RTE admissions in Maharashtra stated that private schools with government or aided schools within a one-kilometre radius were not obligated to give RTE admissions. The government be-

gan the process accordingly, but it was soon stayed by the High Court after the amendment was challenged by parents. In July, the High Court ruled in favour of the parents, instructing the Maharashtra government to resume RTE admissions in original format, wherein 25 percent of total seats are reserved in private unaided schools for children from underprivileged sections of society. Parents say that conducting RTE admissions in February would help parents make appropriate choices as it would be around the same time schools conduct admission on their remaining seats. "Over 26,000 students are robbed of their right to free education in schools because of the chaos caused due to unconstitutional decisions taken by the state government which was eventually struck down by the court," parent activist Dilip Singh Vishwakarma, said.

CBI takes over probe of case against Maharashtra cadre IPS officer Bhagyashree Navatake

Bhagyashree Navatake, Navatake, 36, who served as the Deputy Commissioner of Police (Economic Offences Wing and Cyber) for Pune police from 2020 to 2022, led several high-profile investigations during her tenure. The Central Bureau of Investigation (CBI) has taken over the investigation into the case registered by Pune city police against Maharashtra cadre Indian Police Service (IPS) officer Bhagyashree Navatake. This case relates to the investigation conducted in 2020-21 into offences connected to the Rs 1,200 crore scam involving the Jalgaon-based Bhaichand Hirachand Raisoni (BHR) State Cooperative Credit Society. Navatake, 36, who served as the Deputy Commissioner of Police (Economic Offences Wing and Cyber) for Pune police from 2020 to 2022, led several high-profile investigations during her tenure, including probes into government recruitment exam malpractices and a major cryptocurrency scam. She is currently posted as the Superintendent of Police with the State Reserve Police Force. An FIR against Navatake was registered on August 27 at Bundgarden police station based on a complaint filed by Deputy Commissioner of Police (Crime) Nikhil Pingle, following directions from the Maharashtra State Home Department.

Transfer to CBIOn August 30, the Maharashtra government recommended transferring the case to the CBI and issued consent for the same. Subsequently, the Special Crime Unit of the CBI in New Delhi took over the investigation on Wednesday and registered a Regular Case with the CBI in Delhi.During her time with Pune City police, Navatake was involved in investigating three cases linked to the BHR scam, which were registered in Pune district in November 2020. These cases were filed at three police stations: Deccan (under Pune City juris-

diction), Alandi (under Pimpri Chinchwad police), and Shikrapur (under Pune Rural Police).

Following complaints by some of the accused in the BHR scam, the state Criminal Investigation Department (CID) was directed to conduct an inquiry into the registration and subsequent investigation of these offences. The CID submitted its report to the state Director General of Police's office, and subsequently to the Home Department. The government then ordered an investigation into the alleged lapses in the BHR case probe by the police. Consequently, an offence was registered against Navatake at Bundgarden police station, along with unnamed others.

What the Pune police FIR statesThe FIR filed by Pune police against Navatake states: "The three offences were registered following inadequate preliminary inquiry. The complainants in cases at Deccan and Alandi police station were not present when the cases were registered. Set procedures were not followed in the investigation. In the cases registered with Pune Rural and Pimpri Chinchwad police, unnecessary interference and pressure was put to register offences. In these cases, select persons were named as accused, the extent of the probe was shown out of proportion and a person with conflict of interest was appointed as prosecutor."The offence was registered under various IPC sections, including 120B (Criminal conspiracy), 167 (Public servant knowingly disobeying the law), 177 (Furnishing false information), 193 (Punishment for false evidence), 201 (Causing disappearance of evidence), 203 (Giving false information regarding an offence), 466 (Forgery of record or valuable security), and 474 (Possession of forged documents), among others. In 2021 and 2022, Navatake spearheaded a high-profile investigation into malpractices in Maharashtra government recruitment exams. This probe resulted in five cases and dozens of arrests, including those of senior government officials, a serving IAS officer, middlemen, individuals from private entities contracted for recruitment processes, and coaching class

During the same period, she also led a year-long, meticulous investigation by Pune police's Cyber Crime Cell, which uncovered a shocking case of two cyber experts, including a former IPS officer, allegedly siphoning off large amounts of cryptocurrency from the wallets of accused individuals arrested in a multimillion-dollar bitcoin Ponzi scheme in 2018, a case in which they had assisted Pune police.

Daughter asks Karnataka Police to probe mother over 'suspicious death' of businessman father

The recent death of a real estate businessman in Karnataka took a fresh twist after the deceased's daughter Tuesday raised suspicion of murder against her mother. The businessman, Santosh Padmannavar, 47, a resident of Mahantesh Nagar in Belagavi purportedly passed away from a heart attack on October 9. His eyes were donated as per his wish to a private hospital and his funeral was held on October 10.

Sanjana Padmannavar, who is studying in Bengaluru, became suspicious of her father's sudden demise and asked for review footage from 16 CCTV cameras installed at their home. Her mother, Uma Padmannavar, apparently advised her to take a bath first after Sanjana Padmannavar reached their Belagavi home recently. The CCTV footage was later found deleted. Sanjana Padmannavar has claimed that when she questioned her younger brothers, they admitted to deleting the footage at their mother's request.

Thereafter, Sanjana Padmannavar discussed the matter with her uncle and some other relatives and filed an FIR at the Malamaruti police station.

In 2015, an RTI activist was jailed for refusing to stand. A decade-long legal fight just won him an acquittal

In the dimly lit corridors of the Saidapet Magistrate Court, 47-year-old Siva Elango, walked out on Tuesday after a ten-year legal battle. The decade saw his brief arrest, 138 court hearings, and several legal setbacks. But, he persevered. It was in 2012 that Elango, a member of the anti-corruption group, Satta Panchayat Iyakkam, filed an RTI seeking details of then Tamil Nadu Chief Minister J Jayalalithaa's advertisement spending. This was when the state had launched a massive media campaign, with full-page ads featuring Jayalalithaa's image in editions across the country. "The campaign was part of her bid for the 2014 Prime Minister race, paralleling Narendra Modi's rise during the period. I demanded details of how taxpayer money was spent for these ads, and criteria for receiving the ads," Elango said while speaking to .The government refused to disclose the information, and he filed two appeals the same year. In January 2015, the State Information Commission (SIC) finally took up his second appeal for hearing. What should have been a routine hearing quickly became a life-altering ordeal for Elango.

He arrived at the SIC's office, ready to present his case. The chief information commissioner, K S Sripathi, a former state chief secretary, and former district judge S F Akbar presided over the hearing. Elango sat in the room, but just before he could speak, a peon approached him, saying he had been asked by Sripathi to stand. Elango refused, since no law required appellants to stand during quasi-judicial hearings. According to Elango, the hearing was abruptly dismissed and he was asked to leave. Not willing to let his fight end there, Elango staged a sit-in protest, declaring that he be heard. The police were called, and he was arrested, charged with obstructing a public servant and criminal intimidation. "I was thrown into Puzhal Central Prison for three days for not standing," Elango said.

Once out on bail, Elango didn't hire a lawyer, but

decided to represent himself. According to court documents, the prosecution's witnesses were people who hadn't been present during the alleged incident, while peons and clerks were listed as under secretaries.

The complaint against Elango had been filed by the SIC's secretary, Ashok Kumar, based on information relayed by his undersecretary, Gnanavel. But when Gnanavel was cross-examined by Elango, he admitted he wasn't in the room when the alleged incident occurred. "They said I threatened to destroy SIC, and that I spoke while putting my legs on the table," Elango said. During the hearing, Sripathi, the former chief secretary of Tamil Nadu, was added as a witness, but the SIC refused to forward him summons claiming that he was retired and they did not know his address. Elango then sought documents from authorities that paid Sripathi his pension. Even after his address was availed and summons issued, the police dragged their feet for another year.

Four judges changed during the 10 years. Then, in March 2024, Sripathi appeared in court. In a twist of fate, this time Sripathi had to appear before the Saidapet judicial magistrate court on March 14 this year and dispose, standing. After a few minutes of submission, the court allowed Sripathi to sit as he complained of leg pain. The former chief secretary claimed he couldn't recall the incident, and denied ever asking Elango to stand. When Elango questioned him further, asking if he had threatened Sripathi as charged, Sripathi again said he couldn't recall. When contacted, Sripathi said he couldn't recall any such incident during his tenure as SIC. When asked about his court appearance, he said: "Oh yes. But I can't recall the details. I don't even remember his (Elango's) face." About his instruction to stand before SIC during the appeal hearing, Sripathi said there is no such rule. "They can sit. Some people wouldn't sit even if we suggested that they do." On why the original RTI petition was not disposed of, he said, "The reasons can't be discussed here. Only thing I can say is that I have nothing personal

Elango said that when he walked out of the court-room after the acquittal, there was no celebration. "The judge said I am acquitted and that I may leave. But what happened to my original petition? Where is my RTI? I fought another case for 10 years and gained an acquittal, but my original petition remains unanswered," he said. His wife, a schoolteacher, has been the family's only source of income while Elango has thrown himself fully into social activism. Their twins, a boy and a girl, too have grown up watching their father's fight. He said, "My wife and I made an agreement before marriage. That she would take care of the household, and I would fight for society."

Wildlife board defers nod for Vedanta's oil exploration in gibbon habitat, clears road expansion in Rajasthan tiger reserve

The standing committee of the National Board for Wildlife (NBWL), the country's apex body on wildlife conservation, has deferred its nod to a Vedanta subsidiary's proposal for oil exploration in Assam's Hollongapar Gibbon Sanctuary, the habitat of the endangered Hoolock Gibbon. Chaired by Union Environment Minister Bhupender Yadav, the standing committee also appraised and cleared a proposal to electrify a section of an existing 100-year-old broad railway line passing through the sanctuary in Jorhat, subject to the construction of animal passages.

The NBWL also cleared road widening through the buffer zone of the Ramgarh Vishdhari Tiger Reserve in Rajasthan's Bundi, subject to conditions on building animal passages. The Hoolock Gibbon is India's only ape species and the shy, arboreal animals number only between 120-130 in the forests of Hollongapar Gibbon Sanctuary and surrounding Dessoi reserve. Though Cairn Oil and Gas's oil exploration is proposed in the eco-sensitive zone away from the sanctuary, the NBWL decided to defer the proposal until a site visit is carried out. The site inspection committee will comprise representatives of the Union Ministry of Environment, Forest and Climate Change, the Wildlife Institute of India, the Assam forest department and Raman Sukumar, a wildlife scientist and independent member of the board.

Last month, the environment ministry's forest advisory committee, which grants prior approvals for devel-

opment works and industries on forest land, had granted preliminary permissions for oil exploration in the Hoolock Gibbon habitat. The state forest department had recommended the exploration to the Centre citing national interest.

Indian Railway Construction International Limited (IRCON) has proposed 25 KV electrification of a 9-km stretch on the Lumding-Dibrugarh section of the Northeast Frontier Railway. A 1.65 km stretch of railway line fragments the Gibbon sanctuary. With regards to this railway electrification project, the NBWL cleared subject to conditions that train speeds should be restricted based on prescriptions of the state forest department and that adequate animal passage plans should be executed.In May 2023, the Wildlife Institute of India had prepared a report on the animal passages that can be built to allow the Hoolock Gibbons to cross 1.65 km of the old railway track passing through the sanctuary. It had recommended the construction of artificial and natural canopy bridges for the safe passage of Gibbons. The NBWL also asked the railway authorities to not energise the electric wires until wildlife passages are in place.

The road widening in Ramgarh Vishdhari Tiger Reserve, submissions to the NBWL show, would require 28.8 hectares of forest land from the buffer zone of the reserve in Bundi district of Rajasthan. The widening proposal was for National Highway-12 between Laxmipura-Dora-Daba-Ranaji ka Guda.

A site inspection committee comprising members of the National Tiger Conservation Authority, the Rajasthan forest department and the wildlife division of the environment ministry visited the road project site and recommended the plan with conditions. The wildlife board said in its conditional clearance for the project that the Rajasthan Forest department should provide inputs on locations frequently used by wild animals to cross the roads and construct animal underpasses, apart from those proposed at five locations. The wildlife board said that for every kilometre passing through the forest areas in the buffer zones, an underpass shall be constructed for an overall extent of 50-metre span which shall include underpasses of minimum 30-metre spans, box culverts and pipe culverts.

On visit to remote polling stations in Uttarakhand, helicopter with Chief Election Commissioner makes emergency landing

While on a scheduled visit to remote polling stations in Uttarakhand on Wednesday, a helicopter carrying Chief Election Commissioner Rajiv Kumar and two Election Commission officials was forced to make an emergency landing near Ralam village due to bad weather, EC sources said on Thursday.

After spending the night in an empty house in Ralam, Kumar, the EC officers and two pilots were rescued early Thursday morning, an EC source said. Kumar was scheduled to visit polling stations in 14 villages in Pithoragarh to get insight into the challenges faced by polling parties and voters in the high-altitude, remote areas. The helicopter was able to take off after the weather stabilised and the EC team reached Munsyari Tehsil headquarters on Thursday morning, the source said. The team was still in Munsyari and may continue with the scheduled visits, it is learnt.



At an EC event in Delhi last week, Kumar told officials he would like to spend time with the polling and security personnel posted in remote areas for election duty. He said he would like to stay in the tents with them. This isn't the first time that Kumar has gone to visit remote polling stations. Soon after assuming office in 2022, the CEC trekked to one of the remote polling stations in Dumak village of Uttarakhand's Chamoli district to experience the difficulties faced by polling parties.

In a 4:1 majority ruling, Supreme Court upheld constitutional validity of Section 6A of Citizenship Act

In a landmark ruling, the Supreme Court on Thursday upheld the constitutional validity of Section 6A of the Citizenship Act, 1955, which granted citizenship to immigrants who entered Assam before January 1, 1966, and called for stricter implementation of laws against illegal immigration and judicial monitoring of the implementation of immigration and citizenship legislations. While Chief Justice of India D Y Chandrachud and Justices Surya Kant, M M Sundresh, and Manoj Misra upheld the constitutional validity, Justice J B Pardiwala dissented.

The bench ruled, "Immigrants who entered the State of Assam on or after 25.03.1971 are not entitled to the protection conferred vide Section 6A and consequently, they are declared to be illegal immigrants". The provision was introduced in 1985 following the signing of the Assam accord between the Government of India and agitating groups in the state and says that all those who came to Assam on or after January 1, 1966, but before March 25, 1971, from Bangladesh at the time of commencement of the Citizenship (Amendment) Act, 1985, and since then are residents of Assam, can register for citizenship.NRC Official of National Register of Citizens (NRC) check the different documents to keep in systematic way in boxes which are submitted by people for National Register of Citizens (NRC) ahead of the release of the final draft of NRC on 31st August 2019. 'Cut-off date reasonable'Writing for himself, CJI Chandrachud said Section 6A is not violative of Articles 6 and 7 of the Constitution, which prescribe a cut-off date for conferring citizenship for migrants from East and West Pakistan at the "commencement of the Constitution", that is January 26, 1950. "Legislative objective of Section 6A was to balance the humanitarian needs of migrants of Indian origin and the impact of the migration on the economic and cultural needs of Indian States," said CJI Chandrachud. "Though other states share a greater border with Bangladesh, the impact of migration in Assam in terms of numbers and resources is greater. Thus, the yardstick of migration to Assam is reasonable. The cut-off date of March 25, 1971, is reasonable because the Pakistani Army launched Operation Searchlight to curb the

Bangladeshi nationalist movement in East Pakistan on March 26, 1971. Migrants before the operation were considered migrants of the Indian partition; and "both the above yardsticks have a rational nexus with the object of Section 6A". "Undocumented migrants could be registered as citizens under Section 5(1)(a) of the Citizenship Act before it was amended by the Citizenship (Amendment) Act 2003 to exclude 'illegal immigrants'. Thus, the claim of the petitioner that Section 6A is unconstitutional because instead of preventing migration to Assam, it incentivizes migrants in other states to come to Assam to secure citizenship through Section 6A is erroneous," said the Supreme Court bench. Justice Surya Kant, writing for himself and Justices M M Sundresh and Manoj Misra, said, "Section 6A falls within the bounds of the Constitution and does not contravene the foundational principles of fraternity, nor does it infringe upon Articles 6 and 7, Article 9, Article 14, Article 21, Article 29, Article 326, or Article 355 of the Constitution of India." "Section 6A does not clash with the IEAA — Immigrants (Expulsion from Assam) Act, 1950 — or established principles of international law," said the ruling.

Statutory machinery and TribunalsThe court also acknowledged concerns about illegal immigration and said they need to be addressed. "Although Section 6A conferred citizenship rights exclusively to immigrants arriving before this cut-off date, there seems to still be an ongoing influx of migrants through various border States of India. Due to porous borders and incomplete fencing, this unceasing migration imposes a significant challenge" "While the statutory scheme of Section 6A is constitutionally valid, there is inadequate enforcement of the same —leading to the possibility of widespread injustice. Further, the intention of Section 6A, ie, to restrict illegal immigration post-1971 has also not been given proper effect."The court said the "the directions issued in Sarbananda Sonowal" case (Sarbananda Sonowal vs Union Of India & Another) are required to be given effect to for the purpose of deporting the illegal immigrants...". It added that "the provisions of the Immigrants (Expulsion from Assam) Act, 1950 shall also be read into Section 6A and shall be effectively employed for the purpose of identification of illegal immigrants".

26 extradition requests for Lawrence Bishnoi gang members pending with Canada: India amid diplomatic row

In the wake of the murder of Nationalist Congress Party (NCP) leader Baba Siddique last week, being the latest in a number of high-profile crimes in recent years linked to the Lawrence Bishnoi gang, the Ministry of External Affairs Thursday said India had shared requests with the Canadian side for the arrest of those from the gangster's gang, but no action has been taken on these concerns by the Justin Trudeau government. Addressing a press briefing, Ministry of External Affairs spokesperson Randhir Jaiswal informed of Canada's reluctance to extradite members associated with the Lawrence Bishnoi gang. He said as many as 26 extradition requests have been shared with the Canadian government over a decade, as well requests for the arrest of some individuals with terror charges, while also raising security-related concerns. "They haven't taken any action on our core concerns. There is a political motive also behind this," he

The remarks come a day after Canadian Prime Minister Prime Minister Justin Trudeau, testifying before the public inquiry into foreign interference in federal electoral processes and democratic institutions, claimed the Indian diplomats were collecting information on Canadians who are in disagreement with the Narendra Modi government and passing it to the highest levels within the Indian government and criminal organisations like the Lawrence Bishnoi gang. The Royal Canadian Mounted Police (RCMP) had earlier alleged that the Bishnoi gang is connected to the agents of the Indian



government, which is targeting the South Asian community specifically "pro-Khalistani elements" in the country.

From likening his rise in the world of crime to fugitive gangster Dawood Ibrahim to highlighting his links with pro-Khalistani elements, the National Investigation Agency (NIA) has portrayed Lawrence Bishnoi as a don helming a 700-member strong criminal enterprise. In its 128-page chargesheet in the UAPA case against Bishnoi and 15 others filed in March 2023, the counter-terrorism law enforcement agency NIA has said there are 84 cases registered against him in Punjab, Rajasthan, Haryana and Delhi. Bishnoi's criminal empire has "700 operatives, 300 among them from his home state Punjab", it said. The agency also characterised his syndicate as one that "formed an alliance with the pro-Khalistan cause, to satisfy its quest for sophisticated weapons and to further invest the proceeds of terrorism generated through their existing extortion rackets".

Amid 'spitting in food' row, Uttarakhand frames guidelines for eateries — cameras in kitchens, IDs for staff

Compulsory photo IDs and protective gear for food handlers, cameras in commercial kitchens, and boards clearly displaying whether the meat sold is 'halal' or 'jhatka' and hefty fines of up to Rs 1 lakh for transgressions - these are among the Uttarakhand government's new food safety guidelines issued to the hospitality and food industry. Issued by the state's Food Safety and Drug Administration as the festival season rolls in, the Standard Operating Procedure (SOP), issued on the instructions of Chief Minister Pushkar Singh Dhami, food handlers must wear photo IDs, places new responsibilities on food vendors — including restaurants, hotels, dhabas, and meat traders. The guidelines come at a time when reports of food tampering and adulteration have caused health concerns. Significantly, the Dehradun Police arrested two people last week for spitting in a teapot in Mussoorie. It also comes weeks after the government of neighbouring Uttar Pradesh made it mandatory for food establishments to "prominently" display to customers the names of "the operator, proprietor, manager, and other relevant personnel". According to the SOP, masks, gloves and headgears to ensure hygiene standards. CCTV cameras are mandatory in kitchen areas to ensure continuous monitoring. Fines for offenders will range from Rs 25,000 to Rs 1 lakh for offenders. Regular raids and sampling are being conducted across the state to help keep food safety standards, it says. "Recent incidents of adulteration involving human waste and other contaminants



in food and drinks have surfaced in different parts of the state. Such practices are in blatant violation of the Food Safety and Standards Act, 2006," the guidelines, signed by Uttarakhand's Health Secretary and FDA Commissioner R Rajesh Kumar, said, stressing the importance of controlling unhygienic habits such as smoking, spitting, or scratching body parts while handling food. The SOP includes several key measures to ensure better hygiene in food establishments across Uttarakhand. A critical requirement is that food establishments must not employ individuals suffering from infectious diseases in food-related activities. According to the Food Safety and Standards (Licensing and Registration of Food Business Operators) Regulations, 2011, operators are mandated to always maintain a list of employees along with their medical certificates.

Kamala Harris focuses on middle class with new domestic manufacturing plan

Harris is also expected to touch on her plan to work with the private sector and entrepreneurs to help grow the middle class in the speech at 3:15 pm ET (1915 GMT) at the Economic Club of Pittsburgh, according to a senior campaign official who spoke on condition of anonymity. The two candidates have increasingly focused their campaign messaging on the economy, which Reuters/Ipsos polling shows is voters' top concern as Election Day approaches. While Trump has proposed across-the-board tariffs on foreign-made goods to accomplish that goal - a proposal backed by a slim majority of voters - Harris is focusing on providing incentives for businesses to keep their operations in the U.S.Harris in recent months has blunted Trump's advantage on the economy, with a Reuters/Ipsos poll published on Tuesday showing the Republican with a marginal 2 percentage point advantage on "the economy, unemployment and jobs," down from a 11 point lead in late July. Harris has tried to paint herself as the best candidate for the American middle class, citing her own upbringing in contrast to Trump's wealth."For Donald Trump, our economy works best if it works for those who own the big skyscrapers. Not those who build them. Not those who wire them. Not those who mop the floors," she will say on Wednesday, according to

Norway starts probe into company's reported links to exploding pagers in Lebanon

Bulgarian authorities said last week they were investigating Sofia-based company Norta Global Ltd, which was founded by a Norwegian citizen in 2022, after a Hungarian media report that it was involved in facilitating the sale of the pagers.Norway's security police (PST) have begun a preliminary investigation into reports that a Norwegian-owned company was linked to the sale of pagers to Lebanese militant group Hezbollah that exploded last week, a police lawyer

Over a two-day period last week, thousands of pagers, as well as walkie-talkies used by Hezbollah operatives, blew up in Lebanon, killing at least 39 people and wounding thousands. The attacks were widely believed to have been carried out by Israel, which has neither confirmed nor denied its involvement.It is not clear how and when the pagers were weaponised so they could be remotely detonated. Taiwan, Hungary and Bulgaria are already investigating possible links in the supply chain."PST has initiated a preliminary investigation to determine whether there are reasons for starting a (full) investigation on the basis of allegations in the media that a Norwegian-owned company may have been involved in the dissemination of pagers to Hezbollah," PST lawyer Haris Hrenovica said in a text message to Reuters. Earlier he told Norwegian news agency NTB that the police had no specific suspicions at this time. Bulgarian authorities said last week they were investigating Sofia-based company Norta Global Ltd after a Hungarian media report that it was involved in facilitating the sale of the pagers. The



company was founded in 2022 by Norwegian citizen, Rinson Jose, 39, according to Bulgaria's corporate registry. He signed the company's articles of association at the Bulgarian consulate in Oslo, the documents reviewed by Reuters showed. Jose declined to comment on the pagers when reached by phone last Wednesday and hung up when asked about the Bulgarian business. He did not return repeated calls and text messages. When Reuters tried to call him on Tuesday this week, the call was directed to an answering service. Jose's Linkedin profile shows he has been employed by DN Media Group since February 2020. DN Media Group said he worked in the sales department and that he left for a conference in Boston on Sept. 17.He last contacted his colleagues by email on Sept. 18, according to Norwegian media. His employer told Reuters it had not been able to reach him since.

Big threats to my life from Iran, attacker's death wish is to target me: Trump

Former US President Donald Trump has claimed "big threats" to his life from Iran and that the death wish of the attacker was to attack him. "Thank you to Congress for unanimously approving far more money to Secret Service - Zero 'No' Votes, strictly bipartisan. Nice to see Republicans and Democrats get together on something. An attack on a former President is a death wish for the attacker!" he said. Steven Cheung, Trump's Campaign communications director said on late Tuesday night, "President Trump was briefed earlier today by the Office of the Director of National Intelligence regarding real and specific threats from Iran to assassinate him in an effort to destabilise and sow chaos in the US.""Intelligence officials have identified these 'continued and coordinated' attacks heightened in the past few months, and law enforcement officials across all agen-



cies are working to ensure Trump is protected and the November election is free from interference," Cheung said. On July 13, Trump narrowly survived a shooting when a bullet grazed his ear during a campaign rally in Butler, Pennsylvania. The second failed assassination attempt took place on September 15 when the former president was at the Trump International Golf Club in West Palm Beach, Florida. Ryan Wesley Routh (58), who was spotted outside the golf course with a gun, was charged on Tuesday for attempting to assassinate a major presidential candidate. The US presidential election will be held on November 5.Last week, US government agencies claimed that Iranian hackers sent e-mails containing stolen material from Trump's campaign to people involved in US President Joe Biden's then re-election campaign. They alleged it was a part of a broader effort to meddle in the US election. In August, the US accused Iran of launching cyber operations against the campaign of Trump and Harris. Tehran had denied the allegations.

Israel 'carefully plans coming days', to intensify strikes against Hezbollah

Jerusalem: Israeli forces "are carefully planning the coming days" and their attacks against Hezbollah will intensify, Israel Defense Forces (IDF) chief Lt. Gen. Herzi Halevi said. Israeli forces have killed over 600 militants, "including dozens of Hezbollah's top military leaders," since the onset of the Gaza conflict last year, and have struck "hundreds" of targets in Lebanon recently, weakening Hezbollah's launch and combat capabilities, Halevi said on Sunday in a televised speech from the Tel Nof Airbase, a principal airbase of the Israeli Air Force.

"The price Hezbollah is paying is increasing, and our strikes will intensify," Halevi was quoted by Xinhua news agency as saying. "We have many more capabilities yet to deploy, and we are in a very high state of readiness, both offensively and defensively," he said. Meanwhile, Halevi claimed that the Israeli airstrike on a building in Beirut's southern suburb on Friday has

"eliminated" Hezbollah's chain of command. The building was bombed by Israeli warplanes when Hezbollah commanders were planning in it an attack on northern Israel aimed at killing civilians and kidnapping soldiers, he claimed. "We will ensure the safety of those (displaced Israelis) returning (to their home along the border), and if Hezbollah hasn't understood this yet, they will continue to face blow after blow until they do," he said. Tension along the Israel-Lebanon border has escalated sharply following communication device explosions across Lebanon on Tuesday and Wednesday that killed 37 people and injured 2,931, as well as an Israeli airstrike on Friday targeting a building in the Jamous area in the southern suburbs of Beirut that killed 45 and injured dozens more. The Israeli army and Hezbollah, which has deep ties to Hamas in the Gaza Strip, have been exchanging fire across the Israel-Lebanon border since Oct. 8, 2023, raising fears that the nearly one-year-long confrontations could escalate into a full-scale war.

What's Iron Dome's success rate, cost of shooting down missile? 7 FAQs answered

Though the Iron Dome is well known, there are some frequently asked questions (FAQs) like what is its success rate, how much does it cost to shoot down a missile, and how it feels on the ground? Here are answers to some of the FAQs.Israel's Iron Dome anti-missile system operates for interceptions as rockets are launched from Lebanon towards Israel, amid cross-border hostilities between Hezbollah and Israel, as seen from Haifa, Israel. Sirens could be heard in Haifa and nearby areas in northern Israel on September 23 as Hezbollah fired multiple rockets into Israeli airspace. Videos of those rockets being shot down by the Israeli Defence Force (IDF) went viral on social media. Though they seemed like fireworks in the night sky, it was a matter of life and death. The rockets were fired by Hezbollah in retaliation for the IDF's bombing of terror-group the terror group's hideouts in Lebanon. Israel's offensive has killed over 550 people in Lebanon. The Iron Dome intercepted a majority of the rockets fired by Hezbollah, and it was videos of those that went viral. In the last 11 months, Hezbollah has fired over 8,000 rockets into Israel. The Iron Dome is a part of the multi-layered air defence system of Israel, and it is coordinated by central control nodes and consists of three main components, Yehoshua Kalisky from the Institute for National Security Studies

The outer layers include the Arrow-2 and Arrow-3 systems, designed to intercept ballistic missiles from thousands of kilometres away, with Arrow-2 targeting threats in the atmosphere and Arrow-3 capable of engaging them in space. Both aim to prevent debris from damage. David's Sling serves as the middle layer, designed to counter shorter-range ballistic missiles from 100 to 200 km (62 to 124 miles), while also capable of intercepting aircraft, drones, and cruise missiles. The innermost layer is the well-known Iron Dome. It is the final "ring of protection" and is the most widely used. The Iron Dome has shielded Israel from thousands of rockets and missiles fired by Hamas and Hezbollah. It also helped in fending off the hundreds of drones Iran used in its attack on Israel in April. Here are answers to five frequently asked questions (FAQs) about Israel's Iron Dome.

1. WHAT IS IRON DOME AND HOW MANY MIS-SILES CAN IT FIRE?

Iron Dome or Kippat Barzel is part of Israel's air defence system and was made to intercept short-range weapons, and it works in all weather conditions. It has three parts -- A radar tracking station, a control centre, and a missile battery system. The first is a radar that tracks incoming rockets and relays information on them to the control centre. At the control centre, it is analysed if the rockets are headed for inhabited areas. If the centre finds a rocket is headed for an unpopulated area, then it will not be intercepted, reports The BBC. The Iron Dome's third part neutralises the incoming projectiles, and has up to three anti-missile batteries. The Iron Dome has a detection and tracking radar developed by Elta, an Israeli defence company and subsidiary of Israel Aerospace Industries, in collaboration with the IDF. Its battle management and weapon control (BMC) centre is provided by mPrest Systems, an Israeli software firm for Rafael.The missile firing unit launches the Tamir interceptor missile, which has electro-optic sensors and multiple steering fins for enhanced manoeuvrability. Each Iron Dome battery comprises three to four launchers, with each launcher able to fire 20 missiles in 10 seconds. This makes Iron Dome ideal for a scenario where too many missiles are fired at Israel, Rubin, a senior researcher at the Jerusalem Institute for Strategy and Security, told Reuters. "Its radar and battle management systems are designed to handle a huge number of targets simultaneously," Rubin said. "Each launcher can fire its full load of 20 interceptors within 10 seconds or so."

2. WHEN WAS IRON DOME BUILT, AND WHEN WAS IT FIRST USED?

The Iron Dome was made after Israel's 2006 conflict with Hezbollah. Iran-backed Hezbollah had launched thousands of rockets into Israel, killing many and causing havoc. Israel then decided it would need a new defence weapon. This led to the building of an Iron Dome, with the support of the US. In July 2008, the Tamir interceptor missile underwent successful testing, leading to further tests in March 2009 where the missile defence system was verified, though no actual interceptions occurred. Iron Dome first came into use in 2011. It fought a missile fired from Gaza by Palestinian terror group Hamas.

3. WHAT IS THE SUCCESS RATE OF IRON DOME?

Hamas members infiltrated Israel on October 7 and killed hundreds and took dozens hostage. The Palestinian-terror group attacked Israel with several thousand rockets, and the Iron Dome's reported interception rate was 90%. The rockets which evaded the Iron Dome caused several deaths and injuries."The number of Israelis killed and wounded would be far higher if it had not been for the Iron Dome system, which has been a lifesaver as it always is," Israeli military spokesman Lt Col Jonathan Conricus told the BBC.An all-out conflict can strain the supply of any defence system. Here, the Iron Domes can play a vital role. "It's a problem with any type of ammunition," he said. "You have to prepare in advance. You have to prepare for that kind of attack."It has several layers of defence, and it is made specifically with Israel in mind. "Israel I think has the most effective missile defence solution for the threats it faces as a country," said Ankit Panda of the US-based Carnegie Endowment for International Peace. "It's been pretty well established that Iron Dome has a concept of operation that is incredibly effective."With a 90% interception success rate, the Iron Dome is a pretty solid defence system. It has to be kept in mind that swarms of projectiles are fired at Israel, and the Iron Dome tackles those.

4. WHAT DOES IT COST ISRAEL TO SHOOT DOWN MISSILES?

Several cheap and low-cost threats have to be dealt with and this means Iron Dome's interceptors must also be of a reasonable price. Each Tamir missile costs about \$50,000. Generally, two missiles are shot at each incoming target. This is low in comparison to the multimilliondollar price of other missiles. To add to it, the price of not stopping the attacks also needs to be factored in, said Ankit Panda. "It's not that Iron Dome is a 100% effective capability, but you have to consider the alternative," of much more damage from enemy rockets, he said. Though the Tamir missiles used in the Iron Dome are cheaper, intercepting thousands of incoming rockets adds up in times of war.

5. HOW MANY IRON DOME SYSTEMS DOES IS-RAEL HAVE?

Iron Dome was initially built to give a city-size coverage against rockets with ranges of 4 to 70 kilometres, but the range has been expanded. A protective shield is created over Israeli towns and any threats can be spotted. There are 10 Iron Dome batteries in Israel, each has three to four launchers, according to Raytheon and the Center for Strategic and International Studies, reports CNN. The Iron Dome system is easily transportable and needs just a few hours to set up.

6. DOES ISRAEL EXPORT THE IRON DOME SYS-

Rafael stated it had delivered two Iron Dome batteries to the US in 2020. Ukraine also asked for Iron Dome to protect itself in its war with Russia. The US has said it will reinforce Israel's anti-rocket defence by giving over two of the Iron Dome batteries that it operates in Israel. Harini's achievement adds another milestone to our college's rich history."

Nalin Rajan Singh, a Bollywood director and former batchmate of Amarasuriya, shared his memories of their time together at college. "I vaguely remember her, but I recall her active participation in college festivals and debates. It was the 90s, and many of us-people like Imtiaz Ali and Arnab Goswami-were beginning to make our mark. Seeing her rise to prime minister is truly amazing". Singh, who served as the president of the Hindu College student hostel during their time there, believes that Amarasuriya's new role could further strengthen the ties between India and Sri Lanka. He added that the college's alumni circle, known for its close connections, would be eager to invite her to a future alumni gathering. Amarasuriya was sworn in by President Anura Kumara Dissanayake, who also appointed a four-member cabinet, including himself. In addition to her role as Prime Minister, Amarasuriya has been entrusted with the portfolios of Justice, Education, Labour, Industries, Science and Technology, Health, and Investment

US alerts Indian companies on export of defence tech to Russia



US government officials are sensitising Indian companies and exporters to deter them from supplying Russia with items and technology that could end up being used in Russian missiles and other defence equipment, which would attract Western sanctions, a government official said on condition of anonymity. This follows reports of sanctions on Bengaluru-based Si2 Microsystems in November last year for its alleged role in supplying dual-use technology to Russia. Electronic components, machine tools, drones, and software for drones are some of the dual-use items that can be used for both civil and military applications and are included in the sanctions list imposed by the West in the backdrop of the Ukraine war. "They (US government officials) are leading consultation and sensitisation meetings with the industry to make Indian companies more aware of the importance of not exporting specific types of products, such as chemicals, aeronautic parts, and components that can be used in missile systems and other defence equipment," the offi-

Moreover, a US Treasury official had also warned India's banks that financial institutions that do business with Russia's military industrial base risk losing access to the US financial system, Reuters had reported in July this year. "We know that the Russian military relies on importing sensitive goods, like machine tools and microelectronics, and it looks to foreign financial institutions to facilitate these transactions," Deputy Treasury Secretary Wally Adeyemo said in the letter to the Indian Banks' Association, as per the Reuters report. Also, US Treasury Secretary Janet Yellen in June this year had expressed concerns over Chinese exports of dual-use

goods. By placing over 300 companies on an export blacklist, the US said that China is the top supplier of machine tools, microelectronics, and nitrocellulose, which are critical for manufacturing munitions and rocket propellants, as well as other dual-use items that Russia is using to bolster its defence capabilities.

The Ministry of Commerce and Industry in January 2024 had said that the government is working to liberalise export norms for certain products with dual-use applications. However, the official clarified that the items identified by the US are not Special Chemicals, Organisms, Materials, Equipment and Technologies (SCOMET) items, which require licensing for trade. Dual-use goods are categorised under the SCOMET list in India. "There are many items that the US is scrutinising. They are not SCOMET items, but the US believes they are entering the (Russian) defence manufacturing system. The two or three firms identified by the US do not export SCOMET items," the official clarified. India's exports of machines, auto parts, steel and aluminium products, internal combustion (IC) engines, pumps, and other items to Russia are on the rise. Official data from the ministry showed that India's total exports to Russia in 2023 surged by 40 per cent to exceed \$4 billion, largely driven by engineering goods, which nearly doubled to \$1.32 billion in 2023 from \$680 million in 2022. Significant gains were also seen in the drugs and pharmaceutical category, as well as in organic and inorganic chemicals. This increase in exports comes as Russia has ramped up its defence investments. In July, the World Bank reported that economic activity in Russia was influenced by a significant increase in military-related activity in 2023. Russia's military spending grew by 24 per cent in 2023 to an estimated \$109 billion, as per Stockholm International Peace Research Institute (SIPRI) states. "After the initial recessionary impact of sanctions in 2022, the (Russian) economy returned to growth in 2023, supported by fiscal stimulus, including military spending and credit expansion, and by successfully mitigating the impact of the sanctions. Restrictions on trade and financing from the G7 countries and the EU resulted in trade diversion to China, India, Türkiye, Central Asia, and the South Caucasus, as well as investment in new infrastructure and logistics," the World Bank noted. A query emailed to the Ministry of External Affairs on Monday evening remained unanswered till press time.

Cautious monetary policy needed if food price pressures continue: RBI

A cautious monetary policy approach is warranted if food price pressures persist and continue to spill over, a Reserve Bank of India (RBI) report said on Monday. "Monetary policy is the only active disinflationary agent in the economy. The conventional treatment of food price perturbations as transitory in the setting of monetary policy is increasingly becoming untenable," the report authored by RBI Deputy Governor Michael Patra and others said.

"A large part of this increase in persistence is driven by the secular upward drift in food inflation expectations. Past high food inflation episodes — intrinsic persistence — have a bearing in shaping these expectations," the report said. The inelasticity of the demand for food to price shocks makes food inflation persistence all the more worrying, it cautioned. The report, titled 'Are food prices spilling over', said the conventional treatment of food price perturbations as transitory in the setting of monetary policy is increasingly becoming untenable. "A large part of this increase in persistence is driven by the secular upward drift in food inflation expectations," it said.

Headline inflation moderated from its spike in June to 3.5 per cent in July, but this was primarily due to the downward statistical pull of base effects. "If high food inflation persists, however, a more cautious monetary policy approach is warranted to squelch the propagation of food inflation pressures into a more generalised inflation," it said. The Monetary Policy Committee of the RBI had kept the Repo rate unchanged at 6.5 per cent in its review earlier this month. "Past high food inflation episodes — intrinsic persistence — have a bearing in shaping these expectations. The inelasticity of the demand for food to



price shocks makes food inflation persistence all the more worrying," the report said. With spillovers to costs, service charges and output prices, the danger of food inflation surfacing as a more generalised phenomenon has increased," it said. Under these circumstances, the sources of food price shocks may lie outside the realm of monetary policy but when they result in food inflation acquiring persistence and spilling over into other components of inflation and into consumer behaviour, monetary policy must be disinflationary to quell these price pressures in order to achieve its mandate of price stability and thereby retain credibility, the report said. It said failing to act against persistent food inflation risks expectations getting unanchored, generalisation of price pressures and loss of control over inflation, undermining of consumer and business confidence, and erosion of external sector sustainability and competitiveness. The report said persistence in food inflation has increased due to repeated climatic shocks of rising intensity. "The increase in food inflation persistence is driven by the secular upward drift in its time varying trend, signifying rising expectations of higher food prices due to overlapping supply shocks. Empirical evidence points to spillovers to non-food components, which is being offset by disinflationary monetary

Pronounced income gaps evident in case of stigmatised-caste business owners: new study

Business owners from stigmatised groups such as Dalits experience a business income gap of around 16 per cent compared with others, including those business owners who are from communities that are disadvantaged but are not similarly stigmatised, a new study has revealed. This gap increases at higher levels of social capital, reflecting the social processes of stigmatisation that limit the benefits that Dalits can reap from social capital, a research article titled "It's not who you know, but who you are: Explaining income gaps of stigmatized-caste business owners in India" has stated.

The research report published in PLOS ONE journal on August 7 this year is authored by Prateek Raj, Assistant Professor in Strategy at Indian Institute of Management Bangalore (IIMB) along with Thomas J Roulet, Professor of Organisational Sociology and Leadership at Cambridge Judge Business School and Co-Director of the King's Entrepreneurship Lab at King's College; and Hari Bapuji, Professor in the Department of Management and Marketing, Faculty of Business and Economics, The University of Melbourne, Australia. The report, which states human capital and social capital as two potential tools to facilitate economic mobility and to reduce inequalities, has attempted to find out whether these tools work equally well for stigmatised groups, particularly in societies with systemic inequalities.

There is a high income gap for stigmitased groups and instead of getting reduced, this gap increases at higher levels of social capital. However, Dalits can reap similar income benefits as others from human capital, the report said, adding that human capital helps stigmatised groups mitigate the implications of stigma, but social capital does not.Community business, income

We know from past research that social capital benefits people in business. So, it is commonly assumed that they will benefit everyone equally. Our study shows that that is not the case. We were surprised to find that other groups, including groups that are disadvantaged due to caste (e.g., OBCs, STs) and religion (e.g., muslims) benefit from having social capital and improve their incomes. But, for Dalits (SCs), the social capital does not help as much. We argue that this is because Dalits face a stigma that is attached to them as persons and is perpetuated in social interactions," the research paper's author Prateek Raj told The To address income disadvantages faced by the marginalised groups, that is, OBCs, adivasis/STs and muslims, it is adequate to provide them opportunities, for example, in the form of business leads, credit facilities, collaterals for large orders, Hari Bapuji, the co-author of the study, said. While noting that the government has developed several initiatives for the mobility of Dalits and other disadvantaged communities, the study states that the stigmatised groups (Dalits) and other historically disadvantaged-but not similarly stigmatised groups) face different social processes, which need to be considered in designing initiatives to reduce inequalities. There is a need to rethink development strategies involving human capital and social capital, the study said. "Since Dalits/ SCs not only face marginalisation but also experience institutional stigma, it is necessary to counter the social processes that stigmatise them. For example, the destigmatisation strategies can include education (e.g., curriculum that discusses the historical injustices and educates on the ways inclusion is achieved globally),

"But after getting these messages, I have finally decided I will hardly review any Kannada movie. The disappointment is that I am facing problems from such a film industry which I had supported in the past to an extent of going to Bengaluru to watch movies."Sudhakar Gowda, a budding actor and social media influencer, said that he started receiving threat calls after he posted an "honest review" on Martin. "I spoke about what I did not like about the movie but for the next three days, I was getting threatening calls. Emergency has stirred controversy, particularly regarding its portrayal of Sikhs. The trailer provoked strong reactions from Sikh organizations, including the Akal Takht and the Shiromani Gurdwara Parbandhak Committee (SGPC), who raised concerns over the content. Also starring Anupam Kher, Shreyas Talpade, Milind Soman and late actor Satish Kaushik, Emergency was initially scheduled for a November 2023 release. It was later postponed to June 2024 and then to September 6. Now that the film has received CBFC clearance, Kangana has promised to announce the new release date soon.

India Batting Collapse New Zealand 46The battered crowd were content cheering India staving off dubious records, like when they crossed 37 and then 42, or when the last-wicket pair of Mohammed Siraj and Kuldeep Yadav resisted for five overs. When the sun finally broke through the clouds after days in hiding and shone brightly, the lights were already out of India's dressing room. Under glowering forenoon skies of Bangalore, the moving and leaping wreck-ball, surgically directed by New Zealand's pace trio, reduced them to a pile of unflattering records. The 46 they mustered on Day Two in Bangalore was their lowest in the country, the third worst overall and the least a team had ever managed in the continent.

For 31.2 overs and 132 minutes, a nightmare within a nightmare unfolded here. Much of it was self-inflicted. India chose to bat knowing fully that the ball would zip and zap; they were aware that this was New Zealand's strongest suit, (and their own kryptonite). Yet, in the heady over-estimation of their batting prowess or undermining of the conditions, they decide to bat. Perhaps, to challenge their mind and technique against the moving ball released from a trio of bowlers born and raised in similar conditions, who are capable of squeezing every ounce of favourable conditions. Or to show the world that they could conquer arduous climes, or that they are fully equipped to deal with the might of Australia in a month's time, or as preparation for that tour. Whatever be, this was a day India wished had not existed. Tactics mockingly backfired, be it the decision to bat first under cloud cover and accumulated moisture, or the ploy to install Virat Kohli at one drop, or Sarfraz Khan at four, or sacrificing an inform seamer for a third spinner. But none would pain them as much as their shocking batting-a total surrender of mind and technique.

The conditions, undoubtedly, were harrowing and the three seamers furnished diverse challenges. Tim Southee swung the ball away and wobble-seamed it inwardly to the right-handers; Matt Henry combined slippery pace with seam movement either ways; the six feet four inches William O'Rourke released from heavens, shuffled his lengths adroitly and produced disconcerting bounce off hard and good lengths. Rather than getting carried away by the conditions, they stuck to their fundamentals, probed tight lines, pounded difficult lengths and barely gifted a release ball. The siege they laid could not

As relentless and conditions-primed New Zealand's bowlers were, various aspects of India's batting were exposed in varying degrees. India's batsmen failed the technique test. Angled and crooked bats, pokes and prods met the moving ball, some that challenged the principles of geometry. A sturdy defensive shot was rarer than the falcons that usually hover over the arena. Barring Yashasvi Jaiswal, none showed a concerted application. He was India's best batsman of the day, even though he was prone to the odd short of indiscretion. But he stood out the crease, sometimes charged forward to block and left admirably. Southee and Henry beat him multiple times,



he showed the resoluteness to fight back. However, just when he seemed bedded-in, he cut airily to point, triggering a collapse towards the end of the morning session.

His partner Rohit Sharma summoned his white-ball approach to bail out of travails. He survived a Henry dream ball, which swung in, shaped away and hit his back pad, saved narrowly by the umpire's judgement that the ball had hit him high. His response to the lbw nearsave was buffeting down the track to Southee, whose wobble-seamer cut back lavishly to fox him and blast the stumps. Whatever happened to the Rohit of the 2021 vintage in England, when he batted like an old-fashioned graft and grind opener.Later, Sarfraz Khan too perished attempting an expansive stroke-which on the day sounded like a euphemism for poor defensive technique. Half defensive pushes—feet tied on the crease and hands pushing at the ball --- were a recurring feature of India's latest tryst with batting ignominy. The perfect case studies were Rishabh Pant and Ravichandran Ashwin, both departing when defending from inside the line. The batsmen's lack of trust in their defensive technique was ironic in the land that had produced the finest technician of the modern era, Rahul Dravid, whose exploits are pasted all around the stadium. Elegiacally, his inheritance has been misplaced in the team. To gloss over the vulnerability, they tried to counterattack. Eight balls into his torturous stay, Pant attempted reverse-sweeping Henry. He succeeded in just edging onto his own forearm, when the score was merely 13 for 3.

Before the technique had caved in, their mind had wilted. India failed to read through New Zealand's plans. There was a leg gully for Virat Kohli but he couldn't prepare his reflexes to keep the jumping ball down. The inward moving ball smacked his glove to the plunging claws of Glenn Phillips, one of the finest fielders around. O'Rourke's leg-side defeated KL Rahul too, even though it was not as fiendish as the Kohli one. It was a tame indecisive poke. Similarly Jadeja swiped across the line off Henry, to end the first session at 34 for 6. Soon, they were 34 for 7, invoking fears of Adelaide.
