Telangana man found hanging in Qatar after failed business, mounting debt

Dubai: A Telangana expatriate, who had spent nearly two decades in the Gulf, was found hanging on the outskirts of Doha recently.56-year-old Ganta Chinnamutthenna, a native of Armoor mandal in Nizamabad district, had worked in Qatar for nearly 20 years and returned home for good where he was caught in a debt trap after suffering losses in his newly launched dairy business. After a year of unsuccessful entrepreneurship in India, he returned to Qatar to work again with a different employer and was depressed, according to sources. He was preparing to return home following some differences with the new employer, however, Chinnamutthenna was found hanging on the outskirts of Doha city two weeks ago.

Hyderabad: The Hyderabad cybercrime police helped two victims recover funds they had transferred to cyber fraudsters who had duped them with promises of huge profits.

In the first case, a woman had transferred Rs. 4, 22,560 to fraudsters who had assured to arrange a work visa for her in United Kingdom. The woman later realized that she was cheated and approached the police who registered a case and took up the issue with the banks to which the amounts were transferred. The transferred amount was frozen and later reverted to the victim's bank account.

KT Rama Rao slams Congress government for failing Telangana farmers

Hyderabad: With farmers struggling to get financial assistance for their Yasangi (Rabi) crop, BRS working president KT Rama Rao expressed outrage over their plight under the Congress rule. He slammed the Congress government for abandoning farmers and turning its back on welfare schemes. Taking to X on Wednesday, Rama Rao said farmers who were once self-reliant and confident, were now battling despair due to lack of assistance from the State government.

He criticised the State government over its failure to provide Rythu Bharosa financial assistance to farmers for two consecutive crop seasons and providing only partial assistance in the previous Yasangi season.He reminded that even the crop loan waiver which was initially pegged at Rs 31,000 crore was restricted to Rs 17,000 crore, benefiting only a limited number of farmers.

"Farmers and tenant farmers are waiting for Rs 15,000, while farm labourers are seeking Rs 12,000 in aid. But all they get is silence from the State government," he remarked. The BRS working president pointed out the Congress government's failure to provide clarity on Rythu Bharosa investment support for the upcoming crop seasons, and power subsidies."There is no clarity on how many acres will be covered, when assistance will be given, or if it will ever come at all. It is a government of zero Rythu Bharosa, zero loan waiver, and zero Rythu Bima," he said.Rama Rao also blamed the Congress government for heartlessly halting pensions for senior citizens while prioritising vanity projects like the Rs 1.5 lakh crore Musi beautification plan."Who would have thought the money meant for old age pensions would be mercilessly stopped? Which [world] are you living in brother?"The reiteration by Mr. Gandhi comes hours after the Adani Group said the billionaire and his nephew Sagar Adani have not been charged with any violations of the U.S. Foreign Corrupt Practices Act (FCPA) in the indictment filed by U.S. authorities in a court in a bribery case. The duo has been charged with securities fraud that involves levy of monetary penalties."The point is he has to be arrested. As we have said, hundreds of people are being arrested on tiny charges and the gentleman has been indicted in the United States for thousands of crores. He should be in jail... The official guest list includes several prominent leaders including Congress President Mallikarjun Kharge, Leader of Opposition in Lok Sabha Rahul Gandhi, NCP President Sharad Pawar, West Bengal Chief Minister Mamata Banerjee, AAP Convener Arvind Kejriwal, Samajwadi Party President

Akhilesh Yadav, Himachal Pradesh Chief Minister Sukhwinder Singh Sukhu, CPI-ML General Secretary Dipankar Bhattacharya, Shiv Sena-UBT leader Uddhav Thackeray, former J&K CM Mehbooba Mufti, Tamil Nadu Deputy CM Udhayanidhi Stalin, Karnataka Deputy CM D.K. Shivakumar, Leader of Opposition in Bihar Tejashwi Yadav, former Delhi Deputy CM Manish Sisodia, Bihar MP Pappu Yadav, and AAP Rajya Sabha member Sanjay Singh.Meghalaya Chief Minister Conrad K. Sangma, whose National People's Party is a NDA constituent, is also slated to attend. These names have been officially confirmed by the Jharkhand Mukti Morcha. In addition to CM Soren, one minister each from Congress and RJD is likely to be sworn in during the event. 'I am not a hurdle': Eknath Shinde clears way for BJP CM in Maharashtra, says will support top brass's decision

Amid the deadlock over who will become the next Maharashtra chief minister after the Mahayuti's landslide victory in the state, caretaker Chief Minister Eknath Shinde on Wednesday announced that the Shiv Sena would accept and support the decisions taken by Prime Minister Narendra Modi and Union Home Minister Amit Shah on the issue and that there would be "no obstacle" from their side."I spoke to the prime minister and the home minister and said that there will be no obstacle from our side in government formation. Modi ji is the leader of the NDA [National Democratic Alliance] and I said that whatever their decision is and whoever their CM candidate is, the Shiv Sena will fully support him," Shinde said, addressing the media at his residence in Thane.

Shinde said that Devendra Fadnavis, Ajit Pawar and he would attend a meeting with Shah in Delhi on Thursday where a discussion would be held on this issue."I am an open-minded person. For me, Iadla (dear) brother post is bigger than any other position. I am not someone who is withholding the process of government formation. I called PM (Modi) yesterday and reassured him that I am not a hurdle to government formation. I told him that whatever your decision as the supreme leader of NDA and Mahayuti would be acceptable to us. I told him that he should not



think Eknath Shinde is a hurdle. We wholeheartedly support the decision that will be taken by the PM," Shinde said.

Indicating that he was willing to step down as chief minister, Shinde said his party would also support the BJP's decision on the post. "The Shiv Sena will support the BJP and PM Modi's decision. I spoke to Union minister Amit Shah as well as PM Modi about it and conveyed the decision of supporting their decision on the CM post," Shinde reiterated.Shinde thanked the people of the state for Mahayuti's "landslide" victory in the Assembly polls and said that he never considered himself as chief minister but believed that he worked like a common man. i On November 18, Murali met with a road accident when he was hit by a two-wheeler and was declared brain dead in Hyderabad on November 26, 2024. Wife of the brain dead victim, Koripella Swathi give the consent to donate the organs of the brain dead victim. The surgeons retrieved liver, two kidneys and two corneas (in all 5 organs) and allocated them to five needy patients under State-run Jeevandan organ donation initiative. Protest against ethanol factory: Villages block traffic on NH 61 in Nirmal

Nirmal: Tension prevailed when residents of four villages staged a sit-in on the National Highway 61 at Dilawarpur mandal centres protesting against establishment of an ethanol factory, by threatening to kill themselves and carrying bottles of pesticides if the government did not take steps to shift the factory to some other place on Wednesday. The villagers belonging to Dilawarpur mandal headquarters, Gundampalli, Mukundapur, Samundarpalli villages staged the protest on the busy Nirmal-Bhiwandi stretch of the Maharashtra national highway since morning. They raised slogans against the government and establishment of the factory. They said their agricultural farms would be polluted and their lives would be thrown out of gear with the advent of the factory.

As a result, traffic passing on the stretch came to a standstill for several hours. Passengers travelling in TGRTC buses and cars, students of schools faced inconvenience due the protest. They were forced to wait in the vehicles from morning to afternoon.

DISCIPLINE in India is undergoing a transformative hift. In Faridkot, Punjab, a group of rowdy students, who llegedly endangered police officers during a clash reently, were met with an unusual punishment: a week of ssisting the traffic police for two hours daily after school. This innovative disciplinary approach aims to teach civic esponsibility while deterring future misconduct. In Brinagar, a tragic car accident involving underage drivers n mid-November led to a crackdown on violations. The authorities seized vehicles and implemented stricter licensng policies while counselling parents and students to adfress the root causes of rash behaviour. This holistic tacic underscores the need for behavioural reform rather than nere retribution. In schools, innovative methods are gainng ground. For example, rowdy students in UP schools re assigned such tasks as organising books or assisting eers. Meanwhile, creative punishments like rewriting lesons or engaging in debates channel energy construcively and emphasise growth over reprimand. Discipline should not be about just imposing consequences but also uiding young minds toward self-awareness and societal contribution. Restorative justice, community service and counselling are replacing outdated corporal punishment vhich often leaves emotional scars. Nevertheless, these eforms require collective commitment. Policymakers nust institutionalise such practices, educators must adopt empathetic approaches and parents must support these forts. Experts from NIMHANS (National Institute of Menal Health and Neurosciences) have stressed the imporance of balancing love and limits at home to complement chool-based initiatives. Constructive discipline reflects the ociety's recognition that youth's missteps often stem from mmaturity, not malice. By transforming mistakes into learnng experiences, we not only shape better individuals but also foster a more compassionate community.

Himachal HC allows 18 hotels that were ordered shut to function till March

The Himachal Pradesh High Court Monday stayed an earlier order by which it had directed the state government to shut down 18 loss-making hotels run by Himachal Pradesh Tourism Development Corporation (HPTDC) by November 25.A division bench of Justices Vivek Singh Thakur and Rakesh Kainthala, staying a single bench's November 19 order, allowed the hotels to be operated till March 31, 2025. It also directed the HPTDC to clear all pending dues including arrears, dearness allowance (DA), and gratuity of its pensioners by June 30, 2025.

Earlier, hearing a petition regarding unpaid financial benefits to retired HPTDC employees, a single-judge bench of Justice Ajay Mohan Goel on November 19 had ordered to shut down 18 hotels, adding that public resources should not wasted in the upkeep of "these white elephants".On November 22, however, the bench of Justice Goel modified the order and permitted the state's tourism department to continue operating till March 2025 nine of the 18 properties till March 31, 2025.The state had challenged the single

bench's order submitting that HPTDC has received advance payments for bookings for several hotels that have been ordered to be closed. It also contended that financial earning of the 18 properties demonstrates that some of these units having hotel rooms are also providing other facilities of restaurant and banquet hall and of late have started earning from the same. While filed an application praying for a recall or modification of the November 19 order, the HPTDC had also submitted that it "stands chastened" and shall be making "all out endeavours to pull the corporation out of red" besides ensuring that the dues of the retired employees are paid in time. It had also said that the corporation is taking serious steps to ensure that its properties are put to maximum utilisation and they become profit-earning ventures rather than white elephants. Advocate Shilpa Goel, who appeared for the HPTDC in the high court said, "The division bench accepted our plea wherein we submitted that people have already booked rooms in many these hotels. The corporation also assured the high court of making sincere efforts to clear the pending dues of its retired employees. The division bench stayed the November 19 order and allowed the HPTDC to run all the 18 properties till March 31 next year," Advocate Goel told The properties that were ordered to be shut down but will now remain open include the Palace Hotel (Chail), Hotel Geetanjali (Dalhousie), Hotel Baghal (Darlaghat); Hotel Dhauladhar, Hotel Kunal Dharamshala and Hotel Kashmir House (Dharamshala); Hotel Apple Blossom (Fagu), Hotel Chandrabhaga (Keylong), Hotel Devdar (Khajiar), Hotel Giriganga (Kharapatthar), Hotel Meghdoot (Kiarighat), Hotel Sarvan (Kullu); Hotel Log Huts, Hotel Hadimba Cottage and Hotel Kunzum (Manali); Hotel Lihagsa (Mcleodganj), The Castle (Naggar) and Hotel Shivalik (Parwanoo).

After SC rap, Delhi Police urge people to avoid firecracker use in wedding season

Work on central medicine store in Mancherial drags on

Mancherial: Work on a central medicine store (CMS) is dragging on for over three years, indicating laxity of officials and affecting services of government-run primary, community health centres and hospitals. The store was sanctioned to ensure supply of medicines for 17 primary and 4 urban primary, three community health centres, 100 palle Dawakhanas, four Basti Dawakhanas, one area, one district headquarters hospital in the district at an estimated cost of Rs.3.5 crore in 2021. The funds were granted by the National Health Mission.

However, a piece of over an acre was allocated to the store in Naspur mandal centre. The then finance minister T Harish Rao laid the foundation stone to the facility in April, 2023. Work is being monitored by Telangana Medical Services and Infrastructure Development Corporation System (TGMSIDCS). However, the work is being executed at a snail's pace. Foundation and pillars were constructed so far, slab and other civil works were yet be completed.K Shashi Sriam, Additional Director from Directorate of Public Health, expressed displeasure over lethargic progress of the work when she toured the district recently. She instructed officials to take steps to address challenges hindering the progress of the work. She stated that measures would be taken to make sure each district has a store.

Officials of the TGSMIDC said that steps were being taken to expedite the work. They reasoned that the allocation of the land for the facility was delayed. However, it was earnt that the elected representatives were not showing interest to speed up the work since the store was sanctioned during the regime of the BRS government. Meanwhile, a temporary warehouse of medicines was opened on the premises of government ITI. However, it was shifted to the mother and child hospital. It is unable to store large quantities of medicines required for health centres and hospitals. As a result, the health centres and hospitals are facing inconvenience due to severe shortage of medicines Officials of the primary, community health centres and area hospitals said that the dearth of medicines affecting the services. "Around 20 percent of the drugs are being supplied through the temporary store. Importantly, sufficient injections and certain tablets are not being provided to the centres and hospitals as required," an official said.

Even as the Supreme Court said on Monday that emergency measures under Stage 4 of the Graded Response Action Plan (GRAP) to deal with air pollution in Delhi will continue for the time being, Delhi Police officials said they are sensitising people against the use of firecrackers in the ongoing winter wedding season. "We are sensitising the public and briefing owners of marriage venues and banquet halls to avoid firecrackers," Ankit Singh, Deputy Commissioner of Police (DCP), Dwarka, said. Other police officials said they have yet to receive any formal complaints about the use of firecrackers during weddings in the national capital.

Delhi's air quality index (AQI) has fluctuated between the 'very poor' and 'severe' categories ever since the GRAP-IV was enforced on November 18. And despite the ongoing ban on firecrackers in the national capital, fireworks have lit up skies this wedding season. "The widely publicised ban on the storage, manufacturing, and sale of firecrackers...is a total failure. The bursting of firecrackers can be heard by an ordinary person so the enforcement agencies must be aware of them too. Why are these rules and laws not being effectively enforced?" Mohan George, former additional chairman of Delhi Pollution Control Committee (DPCC), said. "We always impose a blanket ban but it is a total failure if we do not enforce it... These violations continue in wedding venues but if police cannot hear them (firecrackers), it is shocking," George added.

Earlier this month, the Supreme Court had directed the Delhi police commissioner to take effective steps to implement an October 14 Delhi government order regarding a complete ban on all categories of firecrackers - including their manufacture, storage, sale, and bursting, as well as online sales and delivery in the National Capital Territory (NCT) of Delhi - until January 1, 2025. The Supreme Court had also pulled up the Delhi Police for failing to implement the firecracker ban completely in the national capital. "We find that the Delhi Police have not taken the implementation of the said order seriously. There is nothing mentioned in the affidavit to show that the order imposing the ban was communicated to those who have been permitted within the limits of the territory of NCT of Delhi to manufacture, store and sell the firecrackers, including those who sell the firecrackers online marketing platforms," the bench said. The apex court said the Delhi Police should have informed all licence holders and those who sell firecrackers on online platforms to stop the sale immediately. "The Delhi Police shall immediately inform those entities which sell firecrackers through online marketing platforms to stop the sale and delivery of the firecrackers within the limits of the territory of the NCT of Delhi. We direct the commissioner of the Delhi Police to set up a special cell for implementation of the order of ban and hold the station house officers of all the local police stations responsible for enforcing the said ban," the court had said After the reprimand the Delhi Police Crime Branch on November 19 wrote to social media and e-commerce platforms seeking an immediate stop to the online sale of firecrackers. The police said an email in this regard was sent to social media and e-commerce platforms that

TMC leader arrested by CBI in Bengal school jobs scam

The CBI arrested a Trinamool Congress leader, a close aide of former Bengal minister Partha Chatterjee, for his alleged involvement in the school jobs scam, an official said. The TMC leader from Behala, Santu Ganguly, was held on Monday evening after marathon questioning by officers of the central probe agency at its city office here in connection with irregularities in recruitment in state-run primary schools, he said."We have evidence of his involvement in the scam. There is proof of his involvement in monetary dealings," the officer told The CBI, during earlier searches at Ganguly's Behala residence, had seized several bankrelated documents pertaining to the case, he said."Ganguly has been close to Partha Chatterjee (former state industry minister). He was summoned today and remained non-cooperative throughout the questioning. We needed to take him in custody as part of the investigation," the officer added. The Enforcement Directorate, too, had earlier quizzed him and conducted search operations at his residence in connection with the scam

Blast outside rapper Badshah's Chandigarh lounge

A blast occurred outside Sevillee, a bar and lounge owned by rapper Badshah, in Chandigarh's Sector 26 during the early hours The incident reportedly took place around 3 AM when two unidentified miscreants threw an explosive substance outside the lounge before fleeing the scene. The blast shattered the glass windows of the establishment, but no injuries were reported.

Police and forensic teams arrived at the scene shortly after being alerted and have begun an investigation into the incident. The Sector 26 police are handling the probe.Following the attack at Sevillee, the miscreants also targeted De Orra Club, located just 30 metres away, throwing a similar explosive device. Both incidents have prompted heightened security measures as the police work to secure the area and investigate the blasts. The blast outside rapper Badshah's Sevillee lounge in Sector 26, Chandigarh, has added to police concerns ahead of Prime Minister Narendra Modi's scheduled visit to the city on December 3Sources revealed that a security team for the PM is expected to arrive in Chandigarh within a day or two, intensifying the alert mode for local authorities.

Telangana High Court reserves order on Patnam's petition

Hyderabad: Justice K. Lakshman of the Telangana High Court today reserved orders on the criminal petition filed by Patnam Narender Reddy, former MLA of Kodangal, in connection with the Lagacherla incident. Justice Lakshman, after hearing both parties at length, raised concerns over the police's actions, particularly questioning under which legal provisions multiple FIRs had been registered for the same offence. The judge also expressed serious reservations about the negligence of police officers in filing these complaints, highlighting that the contents of the FIRs were identical, with only the dates, accused persons, and places of offence altered. He noted that the complaints were drafted by the station writer, rather than by the police officers concerned themselves, a fact that drew criticism from the court.Justice Lakshman remarked, "To copy also, you require some sense", commenting on the lack of diligence in the police work. The petitioner has challenged the registration of multiple FIRs against him for the same cause of action, alleging harassment by the police. The case is related to the violence that occurred during a protest involving landowners and farmers in the Lagacherla village, which led to the registration of several FIRs. The petitioner's counsel, T.V. Ramana Rao, argued that the police had unlawfully registered three separate FIRs for the same incident, despite the legal principle that multiple FIRs on the same cause of action are not maintainable. Rao cited various rulings from the Supreme Court and the High Court on the illegality of registering multiple FIRs for identical allegations and incidents. Patnam Narender Reddy, accused of inciting violence and provoking farmers, was arrested in one of the FIRs (No. 153/2024). However, two other FIRs (Nos. 154 and 155/2024) were also registered for similar charges, despite the fact that the complainants were different individuals, including an MRO and a Dy. SP. The content of the complaints was virtually identical, which led Justice Lakshman to question the legality and motives behind the police's actions

The mayor mentioned that it was serious misconduct. "This is serious misconduct and indecent behaviour towards a government officer. He disturbed the proceedings of the House. His conduct was unacceptable and unbecoming of a councillor. It created a hostile and intimidating environment, making it difficult for others to participate and engage in constructive discussion," Kumar stated."In view of above, hereby recommend that a show-cause notice be issued to Kanwarjeet Singh, councillor, for his misconduct. He shall submit the reply within seven days, failing which he may be suspended from the next meeting of General House as per rule," the mayor added. However, the BJP councillor denied the allegations. "We were just protesting against an agenda item being passed illegally. Mayor should speak of my suspension after taking action against his own councillor who threw and broke bangles at the then mayor," Rana told

Rajiv Sharma, Congress spokesperson and advocate of Punjab & Haryana High Court, said, "If the allegation against the LoP Kanwarjeet Singh Rana and nominated councillor Satinder Singh pertains to damaging the mic and other property of the corporation, they can be removed as councillors in the light of the provisions of section 36 (b) of the Punjab Municipal Corporation Act as extended to Chandigarh, which state that if a councillor has flagrantly abused his position as a councillor or has through negligence or misconduct been responsible for loss of property of the corporation, he can be removed as a councillor."

He added, "Further, Punjab and Haryana High Court in a judgment delivered in August 2017 on a petition filed by Satinder Singh, a councillor elected in December 2011,



stated that nominated councillors cannot vote in the house as originally provided in section 4(3)(ii) of the Punjab Municipal Corporations Act, 1976, as extended to UT Chandigarh. This sub-section providing for voting rights was set aside, being in contravention of Article 243-R of the Constitution. The petitioner, Satinder Singh, had pleaded that the duty of the nominated councillors is to give their expert advice in the running of municipal corporation and for the betterment of the city. They are not nominated just to take part in the election of mayor and indulge in vote politics."

Earlier this month, Dallewal, 70, announced he would sit on a fast unto death from November 26, the fourth anniversary of the farmers' protest, to get the demands of MSP as a legal guarantee implemented. In 2020, farmers started marching towards Delhi on November 26 to protest against the now-scrapped farm laws."The cops came to the Khanauri border at 2.30 am and they broke the fibreglass wall of the temporary room in which Dallewalji was sleeping and took him to an undisclosed location. As he had refused to open the door, they broke the wall of the temporary hut built on the highway where he sleeps," Amrik Singh, from Bharti Kisan Union (Sidhupur), told ."There were over 250 people and they locked all the farmers in their huts. Those in trollies were forcibly held by the police until they took Dallewal along with them," Amrik Singh said.Punjab farmers Farmers gather at Khanauri border. "Everything happened within two minutes, we got no chance to do anything. I sleep along with Pradhan ji (Dallewal). I was held by the cops, and later they took Pradhan ji along. I couldn't even reach my mobile phone to make a video," said Balpreet Singh.

Sarwan Singh Pandher, coordinator, Kisan Mazdoor Morcha (KMM), said, "I have learnt that it was a joint operation of the Punjab Police, Haryana Police, and central forces... We strongly condemn this act of security forces who are preventing our right to protest". "We don't even know where our leader has been taken. The Canadian government is expected to take additional measures to curb illegal immigration following US President -elect Donald Trump's pledge to impose a 25% tariff on all imports from Canada and Mexico unless both nations take stronger action against the flow of drugs and migrants into the United States."On January 20th, as one of my many first executive orders, I will sign all necessary documents to charge Mexico and Canada a 25% tariff on ALL products coming into the United States, and its ridiculous open borders," Trump wrote on Truth Social. He added that the tariff would remain in place "until such time as drugs, in particular fentanyl, and all illegal aliens stop this invasion of our country!" Trump further claimed, "Both Mexico and Canada have the absolute right and power to easily solve this long-simmering problem. We hereby demand that they use this power, and until such time that they do, it is time for them to pay a very big price!"

Delhi had no 'good' air day this year, none expected until December-end

Delhi breathed its cleanest air this year in August when the average Air Quality Index (AQI) was 52. Yet, it fell short by two points required for a 'good' day, as per national standards.According to the Central Pollution Control Board (CPCB), a 'good' air day is when the AQI is below 50. Delhi has not had a single 'good' air quality day so far this year. With the current pollution levels and the air quality fluctuating between 'severe' and 'very poor' so far this month, it is unlikely the Capital will have a good day before next year.after a brief respite, Delhi's AQI returned to the 'very poor' category from 'poor' by noon. With an AQI of 349, the city was the second most polluted, closely behind West Bengal's Durgapur (AQI of 360).Notably, this is the first year

after 2018 when Delhi recorded no 'good' air days. There were no 'good' air days in 2016, too.Since 2016, the lockdown year of 2020 saw the highest number of five 'good' air days - one in March and four in August. However, by 2021, this number had come down to one day in October but improved a tad to three 'good' days - one in September and two in October - in 2022. However, 2023 saw only a single clean-air day, in September. Delhi reports the cleanest air during the monsoon season compared to the rest of the year, according to CPCB data. This explains the concentration of 'good' air days between August and October. Meteorological factors can lead to a lowering of pollution levels in pre-winter months. According to the India Meteorological Department data, Delhi received no rain so far this month. In contrast, there were four rainy days in 2023. Further, since 2016, there have been instances of November rain in 2018, 2019 and 2020. As per AQI trends over the past 10 years, the AQI at best has fallen to around 130, and not less in November and December. As a result, the yearend months record only 'moderate', 'very poor', 'severe' and 'severe plus' AQI days.While a 'good' AQI has minimal health impacts, the index even in the 'satisfactory' range can lead to minor breathing discomforts.A 'moderate' AQI would impact people with existing heart or lung diseases. When it plummets to the 'poor' range, most people would start experiencing symptoms of 'prolonged exposure'. At 'severe' or 'severe plus' levels, pollution does not differentiate between healthy and unhealthy individuals.

Bengal records 4,000 dengue cases in just 2 weeks, rural areas worst-hit

More than 4,000 cases of dengue were recorded in West Bengal in the last two weeks alone, taking this season's total tally of the disease to over 27,000. Also, a concerning shift in the dengue outbreak has emerged, with more cases being reported in rural areas than urban centres, officials said.While cases in the metropolitan areas like Kolkata have shown a decline when compared to the last year, the infection rate in districts like Murshidabad, Malda, and North 24 Parganas has surged dramatically, they added. Of the 27,142 dengue cases recorded till November 18 in the state, Kolkata accounted for 973 cases. Murshidabad district alone has seen a surge in infection with 5,147 confirmed cases."We see such a spike in dengue cases almost every year at this time. The situation is under control," said an official. The rapid



spread to rural areas, where access to healthcare and vector control measures may be limited, is a matter of concern, another official said. The Health Department has urged people to take preventive measures like removing mosquito breeding sites and using mosquito repellents among others.

Delhi-NCR schools must adopt hybrid mode up to Class XII: CQAM

Hours after the Supreme Court asked the Commission for Air Quality Management (CAQM) to decide on reopening schools and other educational institutions in Delhi-NCR, the central air quality panel Monday said classes up to Grade XII in schools and colleges must shift to a "hybrid" mode.In its order, the Commission took into account the lack of resources faced by schools in Delhi-NCR to conduct online classes as well as difficulties faced by students appearing for Board examinations this year. "The option to exercise an online mode of education, wherever available. shall vest with students and their guardians." Other NCR overnments may also consider conducting classes in hy brid mode, as per the order.Meanwhile, emergency measures under Stage 4 of the Graded Response Action Plan (GRAP) to deal with air pollution will continue in Delhi for the time being, said the Supreme Court Monday. The bench, which reviewed a chart of Air Quality Index (AQI) figures for Delhi, said, "It shows that AQI... from November 20-24 ranges between 318 and 419... unless the court is satisfied that there is a consistent downward trend of AQI, we cannot permit the Commission to go down to stage 3 or 2."Fixing the matter for hearing next on November 28, it directed the Commission "to place updated data on" that date "so the court can take a call on GRAP 4 measures" Asking the Commission to consider if the ban on physical classes as part of the emergency measures should continue, the bench said this was necessary because "some students are being deprived of facility of midday meal as schools and anganwadis are closed... a large number of students do not have the facility of attending online education" and "the residences of a large number of students do not have air purifiers. And, therefore, there may not be any difference between children sitting at home and children attending schools."The court said, "We make it clear that we are leaving it to the Commission to decide to what extent



Identify law & order flaws, check BS-IV vehicles: Delhi top cop's directives to police

Two days after Union Home Minister Amit Shah held a high-level meeting on the law and order situation in the Capital, Delhi Police Commissioner Sanjay Arora is learnt to have issued key directives Monday — to identify shortcomings regarding controlling criminal activities and deployment of police personnel to control air pollution in Delhi.Amid rampant criminal activities, Arora, police sources said, expressed his displeasure regarding the law and order situation in the city. He asked all Deputy Commissioners of Police (DCPs) to take action against illegal activities and local criminals and prepare an action-taken report in 25 days.

"All district DCPs have been directed to visit police stations in their district concerned and identify shortcomings," an officer said. Increasing incidents of firing leading to extortion bids, police losing grip on hardened criminals, and poor projection of police's good work in the media - these were some of the key points highlighted by Shah in the meeting. The Commissioner's key directions also included the deployment of district police personnel to take action against BS-IV diesel vehicles in tandem with their counterparts in the traffic department. "Ten prosecution machines have been issued to all 15 district police and they have been asked to start prosecuting BS-IV (diesel) vehicles. Currently, only traffic police are prosecuting these vehicles," a senior police officer said. In addition, police control room (PCR) vehicles have been asked to work in close coordination with traffic police and alert them if any violations are witnessed on the road."At the border areas, from where most heavy vehicles and trucks carrying construction material enter, senior officers have been asked to hold briefings and give written instructions," the officer said. Further, an officer said, Arora also directed the installation of 10 pickets by all 15

district police in areas under their jurisdiction for prosecution and enforcement of the Commission for Air Quality Management's guidelines.

Under pressure to 'repay debt', man steals gold worth Rs 1 cr from Chandni Chowk jeweller; held

On the night of November 17, Amit Verma, 35, who had been working at a jewelry store in Chandni Chowk for 10 years, asked his wife and daughters to switch off their phones. The next morning, as per CCTV footage, he was at Kanha Jewellers asking its owner Pankaj Goyal for some articles — 110 rings and 30 necklaces cumulatively weighing 1.08 kg. Since exchange of jewellery is common among jewellers of Chandni Chowk, Goyal did not suspect anything. "However, Verma fled with the items," said DCP (North) Raja Banthia, adding, that the accused was arrested on November 23 with the stolen items worth Rs 1 crore.

According to police, Verma had been allegedly planning the theft for months. "He had incurred a loan of Rs 80 lakh from multiple lenders and was under pressure to repay. That's when he started to consider a theft at the store he worked at," a police officer said. According to police, since his employer used to send him to fetch jewellery from nearby shops, he thought it was the easiest way to get his hands on some expensive pieces and flee. "He knew a day before that, an important customer was going to visit the shop. He was already told by the owner that he had to go to Kanha Jewellers on November 18 to get some samples to show the customer," an officer said.CCTV footage showed Verma, after fleeing with the stolen articles, boarding an auto from Chandni Chowk and getting off at Azad Nagar, police said. "He entered a house in the East Azad Nagar area. The resident was his friend. When the resident was questioned, he said Verma had come to his room on the day of the incident after committing the offence and left the same day after separating jewellery from the boxes," said Banthia.

"If someone is issued a showcause notice by any of these committees, he or she has to answer it. If a person gets three such show-cause notices, steps will be taken to suspend him or her," Bhattacharya told mediapersons after the meeting. 2020 Northeast Delhi riots: 5 accused in larger conspiracy case to now argue on grounds of delay, parity with those granted bail

Seeking bail, at least five of the accused in the Northeast Delhi riots larger conspiracy case raised grounds of parity with others granted bail in the case, as well as the ground of delay, during the trial before the Delhi High Court Monday. Two other accused — Sharjeel Imam and Shadab Ahmed — will be arguing on the merits of the case, in addition to raising the ground of delay of trial, for their release on bail. With the five accused arguing on grounds of parity and delay in trial, the court posted the matter for further hearing on December 6 after hearing them partly on Monday. Accused Umar Khalid's bail plea, though not taken up on Monday, is due to be heard on December 6 too. Accused Gulfisha Fatima, the only woman in the case in jail to date; Abdul Khalid Saifi of United Against Hate; Athar Khan; Shifa Ur Rehman; and Mohd Saleem Khan, arguing for bail before the bench of Justices Navin Chawla and Shalinder Kaur. were among those to preliminarily raise grounds of parity with other accused and the delay in trial as grounds for bail, while foregoing arguments on merits for the time being. Senior advocate Kapil Sibal, appearing for Fatima, submitted before the bench, "I'm not going to argue on merits... (she is) on bail in three other cases related to (anti-CAA/NRC) protests... (she is the) only woman in custody, four others (co-accused) have been granted bail. (Fatima is) entitled to bail on parity... (Co-accused) Devangana (Kalita) and Natasha (Narwal) with identical or greater roles, have been granted bail."Pointing out that for the role ascribed in the offence, Fatima's co-accused have been granted bail and that the "possibility of a trial is not there in the near future", Sibal added that while the "plea of parity is a narrow one", the "larger plea is I've been in jail for over four-and-half years."While Special Public Prosecutor Amit Prasad emphasised that with the offence alleging larger conspiracy, individual roles have to be gone into, Justice Chawla orally remarked that the same can be gone into at the stage of the trial. Justice Chawla also orally inquired if there were allegations against Fatima of "actual participation in the riots", to which Sibal replied in the negative. Senior advocate Rebecca John, appearing for Saifi, submitted that

NEARLY 100 metres from the Shahi Jama Masjid, where violence during a court-ordered survey killed four persons on Sunday, November 24, is the one-room house of Naeem Ghazi, a 35-year-old sweet-shop owner. A resident of Sambhal's Fatal Sarai, his family says that he had gone to the market, a few metres from home, to get sugar supplies for the shop when he was shot.

Identifying those who died in Sunday's violence as Mohammad Ayan, 19, Mohd Kaif, 23, and Bilal Ansari, 22, besides Ghazi, Sambhal Superintendent of Police Krishna Kumar Bishnoi said the four died of gunshot wounds, while claiming that the bullets were not fired by his personnel. "We have made it clear time and again that the police did not fire at anyone. We used only non-lethal weapons when the crowd resorted to stone pelting. Our own men have suffered injuries... all those who created tension will be severely punished," he said. Bishnoi said a fifth person, Mohammad Roman Khan, too, died on Sunday, but he likely suffered a heart attack. Three shot dead in Sambhal clashes, team at mosque for second survey A resident of Sambhal's Fatal Sarai, his family says that he had gone to the market, a few metres from home, to get sugar supplies for the shop when he was shot.At Ghazi's home, his mother Idris, 55, wife Tehzeeb, 27, and his four children, all under the age of 11, are still in shock. The family denies he was part of the mob that pelted stones at the team that was carrying out the survey at the mosque. "Had I known he would be shot, would have taken the bullet," said Ghazi's mother Idris. She alleged the police didn't take him to hospital after he was shot.

Barely 500 metres away, neighbours crowded outside

the single-storeyed unplastered house of 19-year-old Mohammad Ayan, but his mother remained unaware of his death the previous morning. "They are telling me my son is sick. I made dalia for him last night, but he is still not home. Why are so many people gathered here? Is he that sick?," asked Nafisa, Ayan's 50-year-old mother.

Ayan, a Class 8 dropout, who worked at a dhaba in Chaudhary Sarai area of Sambhal town for Rs 150 rupees a day, was the only earning member of his family. His father died 18 years ago.Ayan's elder sister Reshma says that nearly two hours before his death, he had picked her up from her home near the masjid and brought her to his house in Kot Garbi to be with their mother."We reached home around 10 am and he left for the dhaba almost immediately, she said. Three shot dead in Sambhal clashes, team at mosque for second survey Policemen on guard near Shahi Jama Masjid in UP's Sambhal following the clashes on Sunday. Nearly 5 km from the mosque in Kot West is where 22-year-old Bilal Ansari lived with his parents, four brothers and two sisters. Bilal, who ran a handloom shop, is among the dead. On Saturday night, his family said, he received a consignment from Delhi."The next morning, Sunday, he thought he would take the new clothes to the shop and arrange them. He did not even know that there was a survey going on in the mosque. At 11 am, a neighbour called us to say that a man who resembles my brother had been shot in the back and was bleeding. I rushed there," said Bilal's younger brother Ali. He says they first took Bilal to Hasin Begum Hospital in Chandausi, but the doctor there refused to treat him. "We then took him to the Moradabad District Hospital, but he was dead by then," Ali said. His mother, Sahana Begum, 50, alleges he was killed by the police. "The police killed my son. We will register an FIR against them," she said. His father, Anwar Ansari, 60, said, "The police are saying that we fought among each other and shot at people. It is a lie. My son was shot in the back. He was killed." Also among the dead was Mohammad Kaif, a resident of Sambhal's Tutipur Elha. Kaif, who was being treated for bullet injuries at the Moradabad district hospital, died Monday evening. On Monday, a day after the violence, the area surrounding the Shahi Jama Masjid remained deserted. In the market to the left of the masjid, nearly 30 shops remained shut. Most houses stayed locked as well. "There is no one to buy anything. Who do we open the shops for," said Mohammad Shamim Ansari, 45, a resident of Kot West.

43% jump in tourists visiting state during Diwali break: Gujarat govt

Gujarat saw a 43% rise in the number of tourists visiting 16 popular destinations in the state during Diwali vacation this year, with a total of 61.7 lakh visitors as compared to 43 lakh tourists in 2023 during the same period. Tourists, however, preferred places of religious worship for Diwali vacations over other tourist spots in the state, as per the data released by the Gujarat government on Monday.

While Dwarka Temple grossed highest footfall with over 13 lakh tourists, the Statue of Unity at Ekta Nagar (formerly Kevadia) recorded 4.90 lakh tourists, falling behind the Kalika Mata temple on Pavagadh Hills that saw a footfall of 8.9 lakh devotees. The Gujarat government said that during the 15 days of Diwali vacations, "...places of worship and popular tourist spots in Gujarat, such as Statue of Unity, Atal Bridge, Riverfront flower park, Kankaria Lake, Pavagadh Temple, Ambaji Temple, Girnar Ropeway, Science City, Vadnagar, Somnath temple, Dwarka temple, Nadabet, Modhera Sun Temple, Smrutivan, Gir, Devaliya as well as Dandi memorial saw a huge turnout of tourists..."As per the data shared by the government, the footfall recorded at Dwarka (13 lakh), Ambaji (12 lakh),

An FIR was registered by the Delhi Crime Branch in March 2020 in this regard with the investigation being undertaken by the Special Cell.Notably, the bail pleas of Saifi, Fatima, Rehman and Md Saleem Khan have been argued fully by their lawyers twice before two different benches of the HC, but no verdict was delivered. This is the third time they'll be arguing for bail before the Delhi HC.

Three arrested for strangling man over Rs 10 lakh in Gurgaon

Two women and a man have been arrested in Gurgaon for allegedly murdering a 52-year-old man over Rs 10 lakh that one of them owed the victim, police said The accused were identified as Sushma (42), and her accomplices, Anil and Seema, police said, adding the trio allegedly killed the victim, Rajendra, by lacing his tea and strangling him when he fell unconscious.Rajendra had allegedly given Rs 10 lakh to Sushma for an investment scheme. However, she ended up spending the money and hatched a plan with the other accused to murder him, police said.

"She told Rajendra she had given the money to a woman named Seema. When Rajendra demanded to meet Seema to inquire about the money, Sushma conspired with Anil and Seema to murder him. Sushma also promised Seema Rs 50,000 in return," ACP (Crime) Varun Dahiya said."On Friday, Sushma invited Rajendra to her house in Manesar, on the pretext of introducing him to Seema. When Rajendra arrived, Anil and Seema were also present. Around 6 pm, Anil made tea for everyone, mixing a sedative in one cup," Dahiya said.

"After drinking it, Rajendra fell unconscious, and Sushma strangled him to death. After the murder, Sushma



and Anil sent Seema away and took Rajendra's body in Anil's car to Rewari, where they abandoned it near the Rewari-Narnaul highway," he added.Meanwhile, Rajendra's son filed a complaint Saturday at Manesar police station saying his father, who had left for his workplace at IMT Manesar in his car a day before, had not returned yet.Police soon zeroed in on Sushma and Anil and arrested them after questioning Saturday. They also found Rajendra's body the same day. On Sunday, Seema was arrested from Gurgaon.

Per capita energy consumption in six states far below national average: IIMA report

The per capita energy consumption in six states in the country as on 2019 was found to be below 6 gigajoules (GJ) per annum, far less than the national average of 21 GJ, according to a report commissioned by the office of the Principal Scientific Advisor along with the Nuclear Power Corporation of India Limited, and prepared by the Indian Institute of Management Ahmedabad (IIMA).Per capita energy consumption is a metric for Human Development Index (HDI) for developing countries. The six states comprise large ones such as Uttar Pradesh and Madhya Pradesh besides smaller ones like Bihar, Chhattisgarh, Jharkhand and Assam.

These states, until 2019, also figured in the bottom 33 per cent of the HDI as well as its components EI (Education Index) and II (Income Index), highlighted the report titled "Synchronising energy transitions toward possible Net Zero for India: Affordable and clean energy for all". The objective of the report is to "bring out all aspects for the benefit of the public and policymakers and build scenarios for an energy mix that provides affordable and clean energy for all citizens living in a well developed India," according to authors of the report. Released in April at Vigyan Bhawan, New Delhi, earlier this year, the report further stated that "an immediate scope for moving toward high HDI and, eventually, very high HDI is to reduce the disparity between high-performing and low-performing states, increasing energy access in states that currently consume 50 per cent less per-capita energy compared to the national average."The analysis of 2011 and 2019 state-level data on HDI, EI, II, energy and electrification revealed, "With greater electrification in states like Bihar, Uttar Pradesh, Madhya Pradesh, Rajasthan and Assam — with high population and low energy access there is an opportunity to improve the national HDI to 0.7 by 2025, 0.805 by 2035-40, and 0.9 by 2045-50.'

India's current HDI is 0.645, placing it in the medium HDI group. The investigators recommend: "The most 'bang

per buck' spent may be obtained by investing in education in Bihar, Chhattisgarh, Madhya Pradesh, Jharkhand, Odisha, Rajasthan, Uttar Pradesh and West Bengal along with several northeastern states as these are in the 'elastic' range of growth for education."IIMA Professor Amit Garg, the principal investigator for the report, told The Indian Express, "The smaller states are doing good as compared to the larger ones."According to Prof Garg, who is National Investment and Infrastructure Fund (NIIF) Chair in Environment, Social and Corporate Governance (ESG) at IIMA, the transition has to be "development -led".He said, "For the next five years, (we should) focus on the states lagging behind in higher HDI, finding ways on how energy consumption can be increased."

The report stated that lagging states must work on improving the health index (HI) while pointing out that overall national HDI may not improve by improving the HI alone."While the national mean number of schooling years is averaged at 6.5 years, it is as low as 4.6 years in Bihar. For females, the national mean is 5.4 years, which is 2.9 years in Bihar," it added. The report emphasised that coal cannot be "wished away" for another 20 years in the country, noting that over 15 million people are employed in the sector and there are industries dependent on the fuel."The coal phase-down will require undertaking significant imports of critical minerals to fulfill the needs of renewable energy and battery storage sectors. Therefore, the mining sector is expected to face substantial challenges," the report concluded.For the report, the data for HDIs were obtained from the Global Data Lab's Human Development Indices. To obtain per capita estimates, energy consumption data was divided by state population, thus baseline calculations were done for 2011 and 2019

Trump threatens sweeping new tariffs on Mexico, Canada and China on first day in office

U.S. President-elect Donald Trump is threatening to impose sweeping new tariffs on Mexico, Canada and China as soon as he takes office as part of his effort to crack down on illegal immigration and drugs. The tariffs, if implemented, could dramatically raise prices on everything from gas to automobiles to agricultural products. The U.S. is the largest importer of goods in the world, with Mexico, China and Canada its top three suppliers, according to the most recent U.S. Census data.Mr. Trump made the threats in a pair of posts on his Truth Social site Monday (November 25, 2024) evening in which he railed against an influx of illegal migrants, even though southern border apprehensions have been hovering near four-year lows."On January 20th, as one of my many first Executive Orders, I will sign all necessary documents to charge Mexico and Canada a 25% Tariff on ALL products coming into the United States, and its ridiculous Open Borders," he wrote, complaining that "thousands of people are pouring through Mexico and Canada, bringing Crime and Drugs at levels never seen before," even though violent crime is down from pandemic highs.

He said the new tariffs would remain in place "until such time as Drugs, in particular Fentanyl, and all Illegal Aliens stop this Invasion of our Country!"Both Mexico and Canada have the absolute right and power to easily solve this long simmering problem. We hereby demand that they use this power," he went on, "and until such time that they do, it is time for them to pay a very big price!"Mr. Trump also turned his ire on China, saying he has "had many talks with China about the massive amounts of drugs, in particular Fentanyl, being sent into the United States – But to no avail.""Until such time as they stop, we will be charging China an additional 10% Tariff, above any additional Tariffs, on all of their many products coming into the United States of America," he wrote.

Negotiation tacticlt is unclear whether Mr. Trump will actually go through with the threats or if he is using them as a negotiating tactic before he takes office in the new year.Mr. Trump's nominee for treasury secretary, Scott Bessent who if confirmed, would be one of several officials responsible for imposing tariffs on other nations - has on several occasions said tariffs are a means of negotiation with other countries. He wrote in a Fox News op-ed last week, before his nomination, that tariffs are "a useful tool for achieving the president's foreign policy objectives. Whether it is getting allies to spend more on their own defence, opening foreign markets to U.S. exports, securing cooperation on ending illegal immigration and interdicting fentanyl trafficking, or deterring military aggression, tariffs can play a central role."Border crossingMr. Trump's threats come as arrests for illegally crossing the border from Mexico have been falling. The most recent U.S. numbers for October show arrests remain near four-year lows, with U.S. Border Patrol making 56,530 arrests in October, less than one third of the tally from October last year.

Meanwhile, arrests for illegally crossing the border from Canada have been rising over the past two years. The Border Patrol made 23,721 arrests between October 2023 and September 2024, compared with 10,021 the previous 12 months. More than 14,000 of those arrested on the Canadian border were Indian — more than 10 times the number two years ago.Last week, a jury convicted two men on charges related to human smuggling for their roles in an international operation that led to the deaths of a family of Indian migrants who froze while trying to cross the Canada-U.S. border during a 2022 blizzard.Much of America's fentanyl is smuggled from Mexico. Border seizures of the drug rose sharply under President Joe Biden, and U.S. officials tallied about 21,900 pounds (12,247 kilograms) of fentanyl seized in the 2024 government budget year, compared with 2,545 pounds (1,154 kilograms) in 2019, when Mr. Trump was president.

Challenge to Canada and Mexicolf Mr. Trump were to move forward with the threatened tariffs, the new taxes would pose an enormous challenge for the economies of Canada and Mexico, in particular. During Mr. Trump's first term, his move to renegotiate the North American Free Trade Agreement, or NAFTA, and reports that he was considering a 25% tariff on the Canadian auto sector were considered an existential threat in Canada. Canada is one of the most trade-dependent countries in the world, and 75% of Canada's exports, which include automobiles, go to the U.S.The Canadian dollar weakened sharply in foreign exchange markets immediately following Mr. Trump's post. The tariffs would also throw into doubt the reliability of the 2020 trade deal brokered in large part by Mr. Trump during his first term with Canada and Mexico, the USMCA, which replaced NAFTA and is up for review in 2026.It's unclear from Mr. Trump's social media post how he would legally apply tariff hikes on those two pivotal U.S. trade partners, but the 2020 deal allows for national security exceptions.RetaliationWhen Mr. Trump imposed higher tariffs during his first term in office, other countries responded with retaliatory tariffs of their own. Canada, for instance, announced billions of new duties in 2018 against the U.S. in a tit-for-tat response to new taxes on Canadian steel and aluminum.Many of the U.S. products were chosen for their political rather than economic impact. For example, Canada imports just \$3 million worth of yogurt from the U.S. annually and most of it comes from one plant in Wisconsin, the home state of then-Republican House Speaker Paul Ryan. That product was hit with a 10% duty.

Spokespeople for Canada's ambassador to Washington and its deputy prime minister, Chrystia Freeland, who chairs a special Cabinet committee on Canada-U.S. relations to address concerns about another Mr. Trump presidency, did not immediately comment on the threats.Trump's promise to launch a mass deportation effort is a top focus for the Cabinet committee, Ms. Freeland has said. A senior Canadian official had said before Mr. Trump's posts that Canadian officials were expecting him to issue executive orders on trade and the border as soon as he assumed office. The official was not authorised to speak publicly and spoke on condition of anonymity. Mexico's Foreign Relations Department and Economy Department also had no immediate reaction to Mr. Trump's statements. Normally such weighty issues are handled by the president at her morning press briefings.Last week, a senior Chinese commerce official said higher tariffs on Chinese exports would backfire by raising prices for consumers. Vice Commerce Minister Wang Shouwen also said China can manage the impact of such "external shocks."Mr. Trump in early November had said that, if elected, he would inform Mexico's new president, Claudia Sheinbaum, on day one that she must stop the flow of migrants and drugs into the U.S. or risk a 25% tariff on Mexican imports."If they don't stop this onslaught of criminals and drugs coming into our country, I am going to immediately impose a 25% tariff on everything they send into the United States of America," he told supporters in North Carolina.

Israel to decide on ceasefire with Hezbollah as U.S. says deal 'close'

Israel's security cabinet was preparing to decide whether to accept a proposed ceasefire in its war with Hezbollah, an official said Monday (November 25, 2024), as the White House announced it believed a deal to end the fighting in Lebanon was "close". The United States, European Union and United Nations have all been actively pushing in recent days for a truce in the long-running hostilities between Israel and Hezbollah, which flared into all-out war in late September. Lebanon says at least 3,768 people have been killed in the country since October 2023, most of them in the past few weeks.

Speaking on condition of anonymity, an Israeli official told AFP that the country's security cabinet "will decide on Tuesday evening on the ceasefire deal".U.S. National Security Council spokesman John Kirby expressed optimism over the prospects for a truce but said talks were ongoing.We believe we've reached this point where we're close," Mr. Kirby told reporters, adding "we're not there yet". The United States repeatedly voiced optimism over talks on reaching a truce in the Gaza war this year but Israel is still fighting Hamas militants there even as it battles on the second front in Lebanon.France, which alongside Washington has spearheaded efforts towards a Lebanon truce, on Monday reported "significant progress" in talks on a ceasefire. The French Presidency urged Israel and Hezbollah to "seize this opportunity." The U.S. news site Axios had previously reported the parties were nearing an agreement that would involve a 60-day transition period in which the Israeli army would pull back, the Lebanese army would redeploy near the border and Iran-backed Hezbollah would withdraw its heavy weapons north of the Litani River.

The draft agreement also provides for the establishment of a U.S.-led committee to oversee implementation, as well as US assurances that Israel can take action against imminent threats if the Lebanese military does not, according to Axios.News of the security cabinet meeting came as the Israeli military said it carried out a wave of strikes on Monday, including on Beirut's southern suburbs, a stronghold of Hezbollah that Israel has repeatedly bombed since late September when it escalated its air campaign in Lebanon.The latest strikes targeted "command centres, and intelligence control and collection centres, where Hezbollah commanders and operatives were located", the military said in a statement. They followed an intense salvo of Hezbollah fire over the weekend, with the group claiming 50 attacks against Israel on Sunday, including some deep inside its territory. Recent days have seen rising calls to end the fighting in Lebanon, with a senior U.N. official on Monday urging "the parties to accept a ceasefire".

And in Beirut on Sunday, top European Union diplomat Josep Borrell called for an immediate truce, days after U.S. envoy Amos Hochstein said a deal was "within our grasp".Israeli media reported that Prime Minister Benjamin Netanyahu was likely to endorse a U.S. ceasefire proposal.Asked in New York about the possible ceasefire agreement, Israeli ambassador to the U.N. Danny Danon said "we are moving forward on this front", adding the cabinet would meet soon to discuss it.The war in Lebanon followed nearly a year of limited cross-border exchanges of fire initiated by Hezbollah. The group said it was acting in support of Hamas after the Palestinian group's October 7, 2023 attack on Israel, which sparked the war in Gaza.The Lebanon hostilities have killed at least 82 soldiers and 47 civilians on the Israeli side, authorities say.

Syrian state television reported Israeli strikes on several bridges in the Qusayr region near the Lebanese border on Monday. Israel accuses Hezbollah of using key routes for people fleeing the war in Lebanon to transfer weapons from Syria.Deal a 'mistake'The initial exchanges of fire forced tens of thousands of Israelis to flee their homes, and Israeli officials have said they are fighting so the residents can return safely. Some northern residents expressed fears as to whether that is possible under a ceasefire."In my opinion, it would be a serious mistake to sign an agreement as long as Hezbollah has not been completely eliminated," said Maryam Younnes, 29, an Israeli-Lebanese student from Maalot-Tarshiha. "It would be a mistake to sign an agreement as long as Hezbollah still has weapons."Dorit Sison, 51, a teacher displaced from Shlomi, said: "I don't want a ceasefire, because if they do it along the lines that they've announced, we'll be in the same place in five years.

Israel's far-right National Security Minister Itamar Ben Gvir warned reaching a ceasefire deal in Lebanon would be a "historic missed opportunity to eradicate Hezbollah"."I understand all the constraints and reasons, and still it is a grave mistake," he wrote on X.Ben Gvir has repeatedly threatened to bring down the government if it agrees to a truce deal with Hamas in the Gaza Strip or Hezbollah in Lebanon.Efforts this year by mediators to secure a truce and hostage-release deal in the Gaza war have failed. Qatar early this month said it was suspending its mediation role until the warring sides showed "seriousness". With an intensive Israeli military operation in Gaza's besieged north in its 50th day, remaining residents are left "scavenging among the rubble" for food, Louise Wateridge, spokeswoman for the UN agency for Palestinian refugees, UNRWA, told AFP.Such scavenging puts Gazans at risk of coming into contact with unexploded and unused ordnance that can be found in many populated areas of the territory, the Danish Refugee Council said in a report.

U.K. sees 'generational mission' in Indo-Pacific, not short term shift: U.K. Minister Catherine West

More than four months after the U.K.'s Labour government came to power, it has declared that the U.K.'s engagement in the Indo-Pacific is long term. The U.K.'s Indo-Pacific Minister Catherine West outlined the position of the U.K. government at the second Indo-Pacific Conference organized by the High Commissions of India, Australia and Singapore in London, in collaboration with the International Institute for Strategic Studies. In 2021, the Boris Johnson led Conservative government had said that the U.K. would undertake a "tilt" towards the Indo-Pacific in its defence, foreign and security policy."For us, this is a generational mission, a long term strategic posture, not just a short term shift to the sake of sound bites," Ms. West said at the Indian High Commission in London on Monday (November 25, 2024) morning. The Keir Starmer government is currently undertaking the Strategic Defence Review, led by UK Defence Secretary John Healey. The process is expected to be completed next year. The Indo-Pacific was crucial to the U.K. for three reasons: global growth, tackling climate change and strengthening national and global security."We want a free and open Indo Pacific underpinned by the rulesbased international system, because rules matter," Ms. West said. She also highlighted the "centrality" of the Association of South East Asian Nations (ASEAN) - a concept that is supported by many countries and groups with interests in the region - such as India, the U.S., the other two Quad countries (i.e., Australia and Japan) and the EU."Despite the distance, the security and prosperity of the Indo Pacific and Euro-Atlantic are inseparable," the Minister said, citing the example of North Korea helping Russia in its war with Ukraine. The Labour government confirmed in July that the Royal Navy's Carrier Strike Group would be deployed in the Indo Pacific where it would undertake exercises and visit Japan in 2025. The deployment was announced earlier this year by the Conservative government.

The Royal Navy's Littoral Response Group was deployed to the region earlier this year with two ships docking in Chennai in April.India was uniquely placed to help shift the dialogue and make progress on climate change and sustainable development, said Ms. West, who has just concluded a two-day visit to India last week.In India, she had

discussed climate, technology, education and health, she said, noting that the University of Southampton was opening a campus in India, in New Delhi.Ms. West reiterated U.K. Foreign Secretary David Lammy's position that a U.K.-India trade deal was the "floor, and not a ceiling" of the U.K.'s ambitions for the U.K.-India relationship."There is significant potential for much closer defense collaboration over the coming years," she said, emphasizing that the U.K. was co-leading, with India, the maritime security pillar of India's Indo-Pacific Oceans Initiative.On the U.K.'s approach to China, Ms. West said it would be mixture of 'compete, cooperate and challenge' [i.e., the "three C's approach"]. Where applicable, the U.K. would seek cooperation with China, as a fellow permanent member of the United Nations Security Council (such as in growing trade and on climate action) and challenge Beijing when it felt its security and national interests were being undermined. Ms. West criticised China's actions curbing democratic freedoms in Hong Kong, a British colony until 1997. Countries were increasingly challenged by the fact that notions of security and prosperity were now global in nature, India's High Commissioner to the U.K., Vikram Doraiswami said."We have to talk these challenges in the context of connectedness between the Euro-Atlantic region and the Indo-Pacific region," he said. The High Commissioner described India's 'Act East Policy', its partnerships with Japan and Australia and said it was natural for New Delhi to be looking to deepen partnerships in the Euro-Atlantic. He suggested that the U.K. was a natural partner in this endeavour, owing to its historical connections with India and the region.

Chilly weather conditions grip Telangana; Adilabad's Bela records lowest temperature

Hyderabad: Chilly weather conditions have continued to grip Hyderabad, its outskirts and in multiple districts of Telangana State on Monday night and in the early hours of Tuesday.In Hyderabad, the lowest temperatures were recorded in areas close to BHEL where mercury fell to 11.7 degree Celsius closely followed by 11.8 degree Celsius at Rajendranagar.In districts, the peak cold weather for this spell in Telangana State was recorded at Adilabad and Asifabad districts where the temperature hovered between 8 degree Celsius and 9 degree Celsius.Bela in Adilabad recorded the lowest at 9.2 degree Celsius closely followed by 9.3 degree Celsius at Kohir in Sangareddy district.Minimum temperatures at Sangareddy, Vikarabad, Kamareddy, Medak and Siddipet hovered between 9 degree Celsius and 11 degree Celsius.

Mr. Das has been vocal about the rights of religious minorities, and has come into the spotlight for his advocacy since the fall of the Sheikh Hasina government on August 5. Ever since he has held multiple rounds of dialogues with various political parties, including the Bangladesh Nationalist Party (BNP), to ensure communal harmony in the country.Dhaka Police said that Mr. Das had been arrested on the basis of a complaint that was filed against him, alleging that he and a few others had insulted the national flag of Bangladesh. It was alleged by Firoz Khan, a former BNP leader from Chittagong, that Mr. Das and others had shown disrespect to the national flag of Bangladesh during a rally by the Hindu community in Chittagong on October 25. Mr. Khan was expelled from the BNP subsequently, allegedly because of anti-party activities.

The complaint also mentions 18 others, apart from Mr. Das. Earlier, the police had arrested two individuals in the case. In a press conference earlier this month, Mr. Das had appreciated the support received from political parties, including the Jamaat-e-Islami Bangladesh, in maintaining communal amity, but alleged that the interim government under Prof. Mohammad Yunus, had failed to prevent around 3,000 attacks on the minority Hindus in the country.According to ISKCON's social media handles, protests had also started in Chittagong, where Mr. Das, who is also known as Chandan Kumar Dhar, is based. The Daily Star has reported that Mr. Das had reached the Hazrat Shahjalal International Airport in Dhaka around 3.30 pm to catch a flight to Chattagram when he was arrested by the police. "From his personal assistant, I found out that some plainclothes men, introducing themselves as members of the detective branch, picked him up from the entrance of the airport," a report in The Daily Star said.

Pakistan police fire tear gas as thousands supporting former Imran Khan arrive near Islamabad

Pakistani police Monday (November 25, 2024) fired tear gas canisters at supporters of imprisoned former Prime Minister Imran Khan to stop them from entering the capital, where they hoped to stage a sit-in to demand his release, officials said. The firing of tear gas came shortly after demonstrators - who traveled 150 kilometers (93 miles) from the restive northwest - began arriving and gathering near Islamabad. They defied a lockdown, previous tear gas and widespread arrests despite a ban on rallies in the city. The development came a day after the leadership of Khan's party went ahead with the "long march" even as Belarusian President Alexander Lukashenko arrived for a three-day visit. He was received at an airport near the capital by Prime Minister Shehbaz Sharif on Monday evening. Authorities said at least one police officer was killed and several officers and demonstrators were injured in clashes. The marchers appeared determined to enter Islamabad, where the lockdown, which has been in place for two days, has disrupted daily life. The government was in talks with Khan's party to avoid any further violence, officials said.Interior Minister Mohsin Naqvi told reporters after midnight that the government is willing to allow Khan supporters to rally on the outskirts of Islamabad but he threatened extreme measures if they entered the city to protest. Khan, who has been in jail for over a year and faces more than 150 criminal cases, remains popular. His party, Pakistan Tehreek-e-Insaf, or PTI, says the cases are politically motivated. A convoy of vehicles carrying protesters was expected to enter the capi-

tal Monday night. Security officials say they expect between 9,000 and 11,000 demonstrators, while the PTI says the number will be much higher. Video on social media showed Khan supporters donning gas masks and protective goggles. Travel between Islamabad and other cities has become nearly impossible. Ambulances and cars were seen turning back from areas along the key Grand Trunk Road highway in Punjab province, where shipping containers were used to block roads. Video circulating online showed some protesters operating heavy machinery to remove the containers."We are determined, and we will reach Islamabad, though police are using tear gas to stop our march," PTI senior leader Kamran Bangash told The Associated Press. "We will overcome all hurdles one by one, and our supporters are removing shipping containers from roads."Bangash also said Khan's wife, Bushra Bibi, who was recently released on bail in a graft case, will lead the march along with Ali Amin Gandapur, the chief minister in Khyber Pakhtunkhwa province, where Khan's party remains in power.Earlier, almost 50 kilometers (30 miles) from Islamabad, Bibi, wearing a white head-to-toe burga, addressed protesters while sitting in a truck, urging them to remain determined to achieve their goal and free Khan. She then chanted, "God is great" and left.Khan's main political opponent, Mr. Sharif, heads the current government.Mr. Sharif's spokesperson, Attaullah Tarar, said on Sunday that whenever any high-profile foreign delegation comes to Pakistan

His humility, warmth, and ability to connect with everyone he met, made him a truly exceptional leader," the statement added.An iconic industrialist, Shashikant Ruia, Chairman, Essar group, played a significant role in redefining India's corporate landscape, laid the foundation of the Essar group and made it a global conglomerate, it said."Shashikant Ruia ji was a colossal figure in the world of industry. His visionary leadership and unwavering commitment to excellence transformed the business landscape of India. He also set high benchmarks for innovation and growth. He was always full of ideas, always discussing how we can make our country better. Shashi Ji's demise is deeply saddening," Prime Minister Narendra Modi said in his condolence message on X.Ruia began his career in the family business in 1965 under the guidance of his father, the late Nand Kishore Ruia. Along with brother Ravi, Shashi Ruia laid the foundation of Essar and spearheaded its business strategy, diversification and growth.

Essar journey began in 1969 when Shashi Ruia won a major contract worth Rs 2.3 crore for the construction of an outer breakwater for Chennai Port. In 1991, Essar became India's first Independent Power Producer and started a 515 MW cycle power plant at Hazira.Today, Essar Global Fund Limited (EGFL), which owns the businesses the brothers co-founded, is a global investor, owning a number of worldclass assets diversified across the core sectors of energy, metals & mining, infrastructure, technology and services. The Fund's portfolio companies generate aggregate revenues of US \$14 billion. These companies operate more than 50 assets spread across the globe, while adhering to international standards of health, safety, environmental protection and corporate governance, according to Essar website.

Essar's portfolio businesses in the telecom, BPO and oil & gas sectors have attracted more than US \$40 billion of monetisation proceeds from global majors, like Vodafone, Rosneft, Trafigura and Brookfield, it said. Shashi Ruia's vision saw Essar gain a first-mover advantage in many businesses. When the Indian telecom sector was opened up for private participation, Essar was among the first companies to offer mobile telephony services, it said. He also set up a steel complex, oil refinery and a shipping company. However, two of Essar's big companies set up by the Ruia brothers were sold off a couple of years ago.Essar Steel India Ltd faced financial difficulties and was placed on the defaulter's list by the Reserve Bank of India in 2017. ArcelorMittal won approval from the Supreme Court to take over Essar Steel and pay the creditors with equal rights in November 2019. Essar Oil was acquired by a consortium led by Rosneft, Trafigura, and UCP Investment Group for \$12.9 billion and rebranded as Nayara Energy.

Trump excludes India from initial tariff plans; targets China, Mexico and Canada



donald trumpDuring election campaign, Donald Trump had labelled India a "very big [trade] abuser," suggesting he might renew trade tensions from his first term by imposing higher tariffs on over \$75 billion worth of Indian exports to the US.US President-elect Donald Trump, set to take charge of the White House on January 20, has announced plans to impose tariffs on China, Mexico, and Canada, indicating that his administration will continue to use tariffs in an effort to bring manufacturing jobs back to the country and as a leverage for trade negotiations. However, India does not feature in Trump's initial tariff plans.

In a social media post, Trump stated that immediately after taking office, he would sign an executive order imposing a 25 per cent tariff on all goods from Mexico and Canada, and an additional 10 per cent tariff on Chinese imports until the Chinese government curbs the smuggling of synthetic opioid fentanyl.Notably, Mexico, China, and Canada are the three US trading partners most exposed to potential policy changes under Trump's leadership, according to the Economist Intelligence Unit (EIU), which ranks countries based

on their bilateral trade balance with the US. The EIU places India 8th on its list of 10 such countries."I have had many talks with China about the massive amounts of drugs, in particular fentanyl, being sent into the United States - but to no avail. Representatives of China told me they would enforce their maximum penalty, including the death sentence, for any drug dealers caught doing this, but unfortunately, they never followed through. As a result, drugs are pouring into our country, mostly through Mexico, at levels never seen before. Until they stop, we will charge China an additional 10% tariff, on top of any existing tariffs, on all of their products entering the United States," Trump said on Tuesday."On 20 January, as one of my first executive orders, I will sign all necessary documents to impose a 25% tariff on all products coming into the United States from Mexico and Canada, along with addressing its ridiculous open borders. This tariff will remain in place until drugs, particularly fentanyl, and illegal immigrants stop invading our country," he added.During his campaign, however, Trump labelled India a "very big [trade] abuser," suggesting he might renew trade tensions from his first term by imposing higher tariffs on over \$75 billion worth of Indian exports to the US.In 2019, India lost duty-free access under the Generalised System of Preferences (GSP) programme, of which it was the largest beneficiary. The programme had allowed tariff-free exports worth approximately \$5.7 billion to the US.According to Bernstein Research, a Trump presidency would adversely impact China, but the benefits for India could be "limited," as it may face renewed tariff pressures. The "China-plus-one" strategy could gain momentum, but the inflation caused by trade barriers might disrupt the anticipated interest rate cuts, affecting middle-class consumption in India, the research note highlighted.

'Cautiously optimistic' economic outlook for coming months: Finance Ministry October review

While maintaining a "cautiously optimistic" economic outlook for the coming months for the Indian economy, the Finance Ministry in its monthly economic review for October released Monday stated that agriculture is likely to benefit from favourable monsoon conditions, increased minimum support prices and adequate supply of inputs. The Ministry also underlined that most countries are loosening monetary policy, with a broad consensus that after a successful disinflationary phase, monetary policy will have to be eased to avoid recession.

Commerce Minister Piyush Goyal has also said that the RBI shouldn't factor in food inflation while taking a decision on lowering its policy interest rates, which have been unchanged since February 2023, adding that it is his personal view and not that of the government. The RBI, on the other hand, has termed the 6.2 per cent October inflation number as a "sticker shock", stating that if the current inflation is allowed to run unchecked, it "can undermine the prospects of the real economy". The Ministry also pointed out the emergence of a few downside risks to global growth that may impact developing economies. "Financial assets such as bond prices may be repriced if inflation proves stubborn, driven by global tensions and commodity prices. That can lead to tighter conditions and potential market instability. This may affect developing economies that are vulnerable to higher borrowing costs," it said. Talking about global disinflation, the Ministry pointed out price pressures across economies have abated substantially after peaking towards the end of 2022 on account of central bank policy rate hikes and improved supply chain resilience.

"As inflation approaches the central bank target levels, disinflation seems to have slowed on account of sticky core inflation. This is due to persistence in services price inflation driven by higher nominal wage growth. There are early signs of wage growth moderating, which will aid disinflation...however, IMF (International Monetary Fund) notes that fiscal consolidation across economies between 2022 and 2024 has not played out as planned, thereby contributing to inflationary pressures. Adverse weather events and their effects on food prices may also affect disinflation, particularly in EMEs (emerging market economies)," it said.Retail inflation in India rose to a 14-month high of 6.2 per cent October driven by elevated food inflation, espe-



cially vegetables. The Ministry said tomatoes, onions, and potatoes faced pressure due to supply disruptions due to heavy rains in major producing states and tighter market stock amid lower output last year. Imported inflation drove the increase in oil and fat inflation from elevated international prices of edible oils, it said. However, a continuous easing trend is visible in pulses, spices and sugar, the Ministry said.

Going ahead, a bumper kharif harvest is expected to lower food inflation in the coming months. "Favourable monsoon, adequate reservoir levels and higher minimum support prices are likely to boost rabi sowing and production," it said, adding that bright agricultural production prospects make the inflation outlook benign, despite existing price pressures in select food items. However, the Ministry said geopolitical factors may continue to impact domestic inflation and supply chains even as early November trends show moderation in key food prices. On the employment front, it said, the formal workforce is expanding, with a notable increase in manufacturing jobs and a strong inflow of youth into organised sectors. On the external front, the Ministry said India's export recovery may encounter challenges due to softening demand in developed markets even though trade in the services sector is sustaining momentum. Apart from the emerging indications of domestic growth and stability, the dynamics of global interest rates, earning growth and valuation, geopolitical developments and policy decisions of the next administration in the United States will determine the course of trade and capital flows, the Ministry said.

After being criticised for his acting skills — or the lack thereof — Arjun Kapoor appears to be shifting perceptions with his portrayal of the main antagonist in director Rohit Shetty's multi-starrer actioner Singham Again. Despite making his debut in 2012 with the lead role in director Habib Faisal's romantic actioner Ishaqzaade opposite Parineeti Chopra, Arjun's career was marked by a string of misfires, with his last movie, The Lady Killer (2023), earning just Rs 60,000 against a reported budget of Rs 45 crore.

As he embarks on a new chapter, the actor, son of renowned producer Boney Kapoor and the late Mona Shourie, recently reflected on his career choices. He also shared his initial reservations about the casting of Parineeti Chopra in his debut film Ishaqzaade, mainly because he found her too talkative.Stating that she did a terrific job in the film, he told Mashable India, "I was very against her when the casting happened. I was like, 'Yeh bahut baat karti hai (she talks a lot)' and her readings were also bad. Parineeti Chopra does not like doing workshops and readings; she's a very spontaneous actor. Or perhaps, she saves it for the sets."

"On the first day, I cracked some joke and she looked at me and said 'lol'. I was like, 'Can't you just laugh?' It's not a chat, right? Why are you saying 'lol' (laugh out loud)? Just laugh. I found her irritating since she talked in emojis. Then I thought she was not serious about it despite getting such a big movie. I had been waiting for six months for us to get Zoya (Parineeti's character) and when we finally did, Zoya was doing 'lol lol.' I was like, 'Mera career khatam hogaya (my career is over),' since this girl doesn't have any interest. She was already doing Ladies vs Ricky Bahl, so I thought she doesn't have anything at stake. (At that age) you just judge people, right? I was 24 and wanted to make a career here. I was thinking, 'Yeh abhi aayi hai... pehle YRF mein kaam karti thi, phir ek picture karli Ranaveer Singh ke saath toh usko lagta hai ki bohat badi staar banagayi. Kaha isko acting aata hai? (she has just come... she previously worked at YRF, then did a film with Ranveer Singh and she feels that she has become a big star. What would she know about acting?)," he recalled.

I get a lot of comments saying 'second hand, 'used', and 'wasted life'. You're pushed into a corner where you are supposed to feel like you're a failure that you were once married and now you're not. And I do believe, it can be really hard for families and girls who've gone through," Samantha said in an interview with Galatta India.With her voice filled with conviction, she added that she has healed and in a happy space now. "I'm very happy right now. I've grown so much, and I am doing incredible work, and I'm looking forward to the next stage in my life," she said.Samantha also spoke about how she felt a need to slam those who were passing judgement against her and spreading misinformation during her divorce but she resisted."Many things were said about me that were absolutely untrue. There were many times that I was so tempted to say 'this is not true, let me tell you the truth'. But, what



held me back – when things were crappy and absolute lies being spread – I remember having this conversation with myself. 'Okay, you're tempted to come out with your side of the story. What do you gain from it? You gain a bunch of people who are so fickle. You tell your story, and they love you for a minute and three days later, if you do something stupid, they'll go back to hating you. I wanted to resist that. Can you not live with the fact that your friends and family know the truth?'

(NZC)The Test series between New Zealand and England will be named as Crowe-Thorpe Trophy, New Zealand Cricket (NZC) and England Cricket Board (ECB) said in a statement. The trophy will pay tribute to the legacies of late New Zealand legend Martin Crowe and England great Graham Thorpe

The trophy has been made from the wood sourced from a bat from each player, and will be unveiled on Thursday morning in Christchurch ahead of the start of the threematch series."The bat gifted by the Thorpe family (a Kookaburra) is the one with which Graham scored his first two centuries against New Zealand, in consecutive Tests in 1997, while the one donated by the Crowe family was the GM with which Martin scored his century at Lord's in 1994," read the NZC statement. "Today's generation of players are standing on the shoulders of those who went before them, players like Graham and Martin. It's good that we recognise this and respect their legacy. Both were seriously good batters who understood the game intimately - they commanded respect wherever they went," said New Zealand CEO Scott Weenink. England CEO Richard Gould echoed those sentiments."Martin and Graham are two legends of the game, and it is fitting that Test series between our two men's sides will now be contested in their name," he said. "It's heart-breaking to have lost both men so early, but by



honouring them in this way I hope we can help ensure the memories and legacies of two of our nations' finest cricketers live on long into the future."Both Crowe and Thorpe were hugely successful Test batsmen in their time: Crowe averaging 45.36 and posting 17 centuries with a highest score of 299, and Thorpe averaging 44.66 with 16 centuries and a highest score of 200 not out - against New Zealand in 2002. Thorpe, who debuted in 1993 and played 100 Tests, was a constant needle in the side of the New Zealand teams, against whom he scored four centuries and averaged 53. He died earlier this year, aged 55.Crowe scored five centuries against England, including 142 at Lord's in his last visit. He was enormously brave, scoring runs in the most difficult environments, including 188 in Georgetown against a West Indian attack including Malcom Marshall, Michael Holding and Joel Garner. He died in 2016, aged 53.

In the past, franchises have come out of the auction table with plenty of unanswered questions and imbalanced squads. But at Jeddah they came up with well-laid plans and put together evenly matched squads on paper.

The two most successful franchises with five titles each, they remained in total control, even as others scrambled around. Having retained their Indian core, Mumbai Indians as usual went big for an overseas pacer in Trent Boult and a new ball bowler in Deepak Chahar. For the rest, they relied on their scouting team, which helped them snap Ryan Rickelton and uncapped Kiwi Bevan-John Jacobs to lend lower-order firepower. In Will Jacks, they got their overseas top-order bat and finished another auction without going big on a spinner. Chennai Super Kings plan was simple: First up was to get back their players who ended up in the auction pool. Thereafter, they went in search of experienced players like Rahul Tripathi, Deepak Hooda, and Khaleel Ahmed. After a long time, they pursued local TN players and brought home R Ashwin, Vijay Shankar, Gurjapneet and Andre Siddarth. In Sam Curran, Jamie Overton and Nathan Ellis, they found their overseas allrounder and a pacer.

No to overspendingLikewise, Gujarat Titans, who have been smart with their auction picks, continued the trend this time as well. It meant, they didn't overspend on any of their targets as they got Jos Buttler, Mohammed Siraj and Kagiso Rabada for a reasonable price. Thereafter, like how MI managed Jacks and CSK Curran, GT got lucky to spend less on Washington Sundar, Gerald Coetzee, Glenn Phillips and R Sai Kishore.

Successfully rebuildingPunjab Kings, Royal Challengers Bengaluru, Delhi Capitals and Lucknow Super Giants came with an intent to rebuild their squad by retaining their kev players. In the past, such plans have gone awry, but what stood out was they had a plan and went about it, even though some of the players they passed on (especially RCB) did raise eyebrows. But if one looks at the bigger picture, all four franchises have come out with strong squads.Delhi have assembled one of the strongest attacks which includes Mitchell Starc, T Natarajan, Kuldeep Yaday, Axar Patel, Mukesh Kumar and Mohit Sharma. Unlike the last couple of seasons, they have the batting resources with an excellent blend of local and overseas talents. The divide between the two owners was evident at the table. But they have more reasons to smile.Lucknow, despite spending big on Rishabh Pant, utilised funds to assemble a rounded squad that in-



cludes David Miller, Mitchell Marsh, Shahbaz Ahmed. With Nicholas Pooran, Ravi Bishnoi already in, it is about putting the right combination on the field.

RCB's decision to not pursue KL Rahul and Pant beyond a point was surprising. But given how challenging it is to bowl at Chinnaswamy Stadium, they kept their purse to invest in bowlers who could do the most challenging job in the league. So they got Bhuvneshwar Kumar, Krunal Pandya, Josh Hazlewood and also Thushara, the pacer with a slinging action. For firepower in the middle order, they acquired Tim David and Liam Livingstone. Safe to say they have a strong team on paper

Punjab, kings at the auctionHaving entered the auction with the biggest purse, Punjab's move to rebuild from scratch worked well. In Marcus Stoinis, Glenn Maxwell, and Marco Jansen they have three overseas certainties in the XI and can rotate Azmatullah Omarzai, Josh Inglis and Lockie Ferguson depending on their combination. Even on the domestic front, in Shreyas Iyer, Arshdeep Singh, Yuzvendra Chahal, they have three big name players. If their local uncapped talent comes good, they can dream of a play-off berth. Having retained a maximum of six players, Rajasthan had little money to work with at the auction. Yet, thanks to sharp tactics, they managed to pull off a balanced squad that includes Jofra Archer's pace, Maheesh Theekshana's mystery, and a death-over specialist in Tushar Deshpande. With Yashasvi Jaiswal, Sanju Samson, Riyan Parag, Dhruv Jurel, Shimron Hetymer and Sandeep Sharma already in, they have their XI in hand. Wanindu Hasaranga would provide all-round balance. They have solid back-up options in Nitish Rana, Akash Madhwal, and Fazalhag Faroogi too.Sunrisers Hyderabad, for a change, went after proven Indian names in Ishan Kishan, Mohammed Shami, Harshal Patel, Rahul Chahar, and Jaydev Unadkat to complete their squad filled with aggressive batsmen. It meant they had to settle for lesser known players to complete the squad. Like RR, filled only 20 out of the 25 slots.

Where is the next opener?

Former Australia pacer Brett Lee chipped in saying the decision to go with Nathan McSweeney over an estab-

opportunity as well. It's concerning." Meet Delhi's Priyansh Arya, six-hitting machine who went to Punjab Kings for Rs 3.80 crore

Sanjay Bharadwaj recollects how he had to change his coaching style for Priyansh Arya, who was obsessed with hitting sixes from a very young age. Bharadwaj, who has coached the likes of Gautam Gambhir, Amit Mishra, Joginder Sharma and Unmukt Chand, calls him a product of the T20 era."All my life, I have told my students to play in the V, and If I remember correctly when it came to Priyansh, I never stopped him from playing the aerial shots. Initially, I did give him dressing down but I realised that's his strength and I gave him complete freedom, and he never looked back," Bharadwaj tells On Monday, the 23-year-old from Delhi, who is fresh from hitting a 43-ball 102 against Uttar Pradesh in the Syed Mushtaq Ali Trophy, bagged a Rs 3.80 crore contract by the Punjab Kings on the second day of the IPL mega auction in Jeddah, Saudi Arabia."After the auction, when he called me I told him that they have given you Rs 3.80 crore, you give them back Rs 30 crore with your performances," Bharadwaj adds.Arya, who was the top-scorer for Delhi in last year's Syed Mushtaq Ali Trophy with 222 runs at the strike rate of 166.91, grabbed eyeballs in the inaugural Delhi Premier League. Playing for South Delhi Superstarz, Arya slammed 608 runs in 10 innings with a whopping strike rate of 198.69, with two centuries and

four fifty-plus total."In the DPL he also hit six sixes in one match. Sometimes when you see such talent, you have to give them freedom. He will frustrate you but he will win you matches," says Bharadwaj.Bharadwaj took Priyansh under his wings when he was 7 years old."Sanjay sir is like a god to us. From the time when he joined his academy. At 6 in the morning, Sanjay sir will pick him up from the house and then in the evening drop him off as well. It continued for eight years," says Priyansh's father Pawan Arya, who is a school teacher at Delhi's Government Sarvodaya Vidyalaya, Lancer Road near Vishwavidyalaya metro station. Growing up in Ashok Vihar New Delhi, Priyansh got all the freedom when it came to cricket but his parents, both teachers by profession, made sure that he did well in his studies also."He was seven when he said, he wants to play cricket. I was fine with that but since I am a school teacher and my wife (Radha Bala Arya) is also a school teacher, we made sure that he gets good education," says Pawan.Pawan has no idea how many sixes his son has scored in the last match, but he remembers his son's marks by heart."He has completed BA from Swami Shraddhanand College and scored 67% in the under graduation. It was all his hard work. Now he is pursuing post-graduation from Delhi University," he says.

World Chess Championship: How Ding Liren shocked Gukesh with black pieces in the opening game at the 'fishtank'

World Chess Championship: D Gukesh planted his face in his palms, unable to come to terms with how guickly the momentum had shifted in the first game of the World Chess Championship against Ding Liren.Game 1 of the World Chess Championship began with promise. The 18year-old had swaggered into the playing arena - nicknamed the fishtank, a sound-proof room with mirrored glass that prevented the players from looking outside or hearing noises from outside - exuding the confidence of youth. In the first few moves, he established himself in control. But the day ended with a desperate dash to evade losing on time and then a resignation with white pieces in 42 moves.

Ding Liren, a man who has experienced the anxiety of playing in a World Chess Championship, tried to catch him off-guard with black pieces in the opening by employing the French Defence. But Gukesh had no trouble dealing with Ding Liren's



ploy. So much so, that he forced Ding to do a double take by the seventh move, where the world champion spent 27 minutes thinking. It was an odd time to be forced into a long, hard think, especially when he was the one who had tried to seize the early initiative. By the time Ding made his 7th move, Gukesh had a sizeable advantage on the clock. He had spent under a minute on seven moves. Ding had used up over half an hour. "I obviously surprised him in the opening. I was playing some good chess," Gukesh later said.Caution to the windOn the 10th move, Gukesh threw caution to the wind. His pawn on the g file raced away to g4, abandoning any safe plan to get his own king to cover on the king-side corner. The plan was to put pressure on Ding's pawn on the e file with a f5 pawn push soon. Ding was already 48 minutes down on the clock by this stage. The first games of the World Chess Championship are meant for tepid draws. It's an occasion to get a measure of the other player's current form and confidence. So like pugilists in a prize fight, grandmasters are content to throw a few punches just to see what the opponent's jaw is made out of.Not Gukesh. He had chosen to walk into the game with his guard down, daring his opponent to throw a haymaker. "This game already looks complicated.
