Congress after poll panel calls allegations on EVM batteries in Haryana 'baseless'

Days after the Election

Commission of India (ECI) termed the Congress's allegations over "irregularities during the counting of votes" in the Haryana Assembly elections as "baseless", the party on Friday said that it was not "surprised that the ECI has examined our complaints and given itself a clean chit".A Congress delegation had met the poll panel on October 9 to express concerns over vote counting in Haryana, alleging that EVMs that had 99 per cent battery during counting showed BJP wins, while those at 60-70 per cent charge registered Congress victories.On Friday, in a letter to the Chief Election Commissioner Rajiv Kumar, the Congress said "the answer given to the question of the machines' fluctuating batteries seeks to confuse rather than clarify". "At any rate, the ECI reply is nothing more than a standard and generic set of bullets on how the machines function rather than



specific complaints. In short, while our complaints were specific, the ECI response is generic and focused on diminishing the complaints and the petitioners," the party said. It further added that "the tone and tenor of the ECI's response, the language used, and the allegations made against the INC compel us to subthe counterresponse". The letter also objected to the ECI stating the "exceptional nature of its indulgence" in engaging with the Congress on the issues raised. "We do not know who is advising or guiding the Hon'ble Commission, but it seems that the Commission has forgotten that it is a body set up under the Constitution

and charged with the discharge of certain crucial functions- both administrative and quasi-judicial," the Congress said. It also said that "the recent tone of the Commission's communications to the INC is a matter that we refuse to take lightly anymore". "Every reply from the ECI now seems to be laced with adhominem attacks on either individual leaders or the party itself," it said. Alleging that the ECI's reply is written "in a tone that is condescending", the party said, "If the current ECI's goal is to strip itself of the last vestiges of neutrality, then it is doing a remarkable job at creating that impression. Judges who write decisions do not attack or

the issues. However, if the ECI persists then we shall have no choice but to seek legal recourse to expunge such remarks (a remedy with which the ECI is familiar since it unsuccessfully sought to do the same with a high court's unflattering cess taking years to re-

"The vast majority of issues raised relate to that short period from the announcement of the Model Code of Conduct to the conclusion of the elections i.e. the date of counting. The causes of action arise quickly, in literal minutes, and sometimes only become apparent after the results are declared and sometimes after the information from other booths can be compared," it read. The party also said that if the issues "are not redressed on the ground then they become redundant" and "the only remedy available is an election petition which is a lengthy pro-

Bibek Debroy, Chairman of PMs Economic Advisory Council, dies at 69

Bibek Debroy, Chairman of the Economic Advisory Council to the Prime Minister, passed away on Friday morning. He was 69 years old. A Padma Shri awardee, economist Debroy had earlier served as the Chancellor of the Gokhale Institute of Politics and Economics (GIPE) in Pune."Dr. Bibek Debroy Ji was a towering scholar, well-versed in diverse domains like economics, history, culture, politics, spirituality and more. Through his works, he left an indelible mark on India's intellectual landscape. Beyond his contributions to public policy, he enjoyed working on our ancient texts, making them accessible to the youth," Modi said.

Debroy completed his early education at Ramakrishna Mission School, Narendrapur, and pursued higher studies at Presidency College, Kolkata; Delhi School of Economics; and Trinity College, Cambridge.He had worked at Presidency College, Kolkata; Gokhale Institute of Politics and Economics, Pune; Indian Institute of Foreign Trade, Delhi; and also as the Director of a Ministry of Finance/UNDP project on legal reforms. He was also a member of Niti Aayog up to June 5, 2019. Debroy authored and edited several books, papers and popular articles and has also been a consulting and contributing editor with several newspapers. Known for his far-reaching contributions to economic theory and policy, Dr Debroy was a respected figure in the fields of game theory, law reforms and Indology, as well as an advocate for poverty reduction and social equity. Debroy was also the Chairperson of Finance Ministry's 'Expert Committee for Infrastructure Classification and Financing Framework for Amrit Kaal', guiding strategic policy frameworks for India's long-term growth.

Hyderabad: Amid reports of growing differences between Chief Minister A Revanth Reddy and senior party leaders over his style of functioning, BJP Legislative Party leader A Maheshwar Reddy on Friday claimed that Revanth Reddy would be replaced by a new Chief Minister after June next year. Speaking to the media, Maheshwar Reddy claimed that the Congress high command was not so happy with the style of functioning of Revanth Reddy and was planning to replace him. "My sources say the Congress high command has already started the exercise to choose a new CM. Revanth will be replaced after June next year. Three senior ministers are in the race for the CM post,"he claimed. Even though Revanth went to Delhi seven times, he was not given an appointment by Leader of Opposition Rahul Gandhi and even his sister and senior Congress leader Priyanka Gandhi did not meet him during his visit to Wayanad, this itself was an indication that the party was not happy with him, he said, adding that a large number of Congress leaders had lodged a complaint against Revanth Reddy over his habit of taking unilateral decisions. Congress high command was not happy with the Chief Minister on the issue of demolitions taken up by the Hyderabad Disaster Response & Asset Protection Agency (HYDRAA) and Musi beautification project and that the senior Congress leaders have sent a report on the issue to the central leadership, he said, adding that Congress senior leaders have formed a group to overthrow Revanth Reddy.

Senior citizens' care

THE recent expansion of the Ayushman Bharat radhan Mantri Jan Arogya Yojana (PM-JAY) to proide health coverage to citizens aged 70 and above is a ignificant move in India's public health landscape. However, the rollout on public health has sparked a public spat between the Centre and Opposition-led tates, particularly Delhi and West Bengal. PM Narendra Modi has claimed that these state governments have pted out of the scheme due to "political interests"

This tension raises a pressing question: should public health, especially for vulnerable senior citizens e subject to political manoeuvring? Ayushman Bharat offers an annual coverage of up to Rs 5 lakh per family. is a boon for many elderly individuals whose nealthcare needs are often financially crippling. However, notably, this welfare measure differs from the ones revailing in Western countries. Out-of-pocket expenses n India remain quite high. The scheme's curative aproach lags behind the preventive care systems seen n the west, where comprehensive, tax-funded programmes prioritise proactive health interventions.

In contrast, Delhi's health model has garnered inernational praise for its accessibility and preventive care ocus. However, by refusing Ayushman Bharat, states ike Delhi may deny their elderly residents an additional afety net. For senior citizens facing health crises, any pportunity for comprehensive health coverage can be ife-changing. The political impasse only undermines heir wellbeing. Healthcare for seniors must transcend he political divide. A pragmatic approach could interate elements from both the Delhi and Ayushman Bharat models, ensuring efficient, accountable and acessible healthcare across states. A national framework hat reflects a commitment to all citizens, regardless of tate politics, is needed.

A 19-year-old engineering student was rescued in Karnataka on Monday after being trapped in a narrow, water-filled crevice for 20 hours. Fire and rescue personnel saved the woman who had slipped into the rocky gorge while taking selfies and spent an entire night in waist-deep water. The incident took place in Maidala lake near Mandaragiri Hill in the Tumakuru district, 63 km away from Bengaluru. S Hamsa Gowda, a third-semester chemical engineering student at Siddaganga Institute of Technology, Tumakuru, visited the scenic Mydala Lake channel near the popular Jain pilgrimage centre Mandaragiri Hill with her friend Keerthana Around 2.30 pm, Hamsa and her friend Keerthana went to the lake bed to take selfies. According to the police, Hamsa accidentally slipped away and was swept away by the strong current, but she got trapped in a rocky gorge. Keerthana called the police control room. Initially, a six-member team from the fire and emergency services, along with local police, arrived at the scene by 3 pm. Despite their efforts, darkness forced them to pause the search at 8.30 pm, though they returned the next morning.

Around Monday noon, the search team discovered a dark, cave-like crevice about 25 feet from where Hamsa had initially slipped. The cavity, approximately eight feet long and six feet high, was partially filled with water, where Hamsa was found standing in waist-deep water. Hamsa was rescued by Monday afternoon and shifted to a nearby hospital. Speaking to the media from the hospital where she was admitted, she said, "I reached a dark spot and could only hear the rushing water. I realised I had not drifted far from where I fell but couldn't see or call for help."As she stood there, she conserved her energy by leaning against the rocky wall. "I stayed awake, hoping someone would find me.

As the rescue personnel came to know that there was a chance of her being alive, the team swelled to 60 by Monday morning. The teams tried to divert the water by keeping sandbags near the falls. This allowed firemen to navigate the rocky terrain and search further downstream. Firemen Yogesh, Pradeep, Manjunath, and Annappa carefully manoeuvred through slippery rocks and thick shrubs until they entered what appeared to be a natural cave formation. As the rescue personnel shouted, Hamsa responded in a low voice, which confirmed that she was alive. Later, the rescue team managed to hold her hand and bring her out of the gorge, said a police officer.K V Ashok, Tumakuru district SP said when he visited the spot on Sunday, he was not confident that the woman would come alive because the terrain was challenging. "However, the rescue team risked their lives and managed to enter. I should also appreciate the bravery of the girl who stayed in the gorge with waist-deep water all through the night. It was a team effort. We will also ask the beat police to look into such sensitive places which can pose a danger to the public,"

Dog kept in Noida creche dies, body found 5.1 km away from centre, probe launched after owner alleges foulplay



On October 4, Nivedita Ghosh, a resident of Mayur Vihar Extension in Delhi, left her five-year-old Spaniel, Milo, at a dog creche in Noida, Paws Point. Seventeen days later, when Ghosh returned from vacation, she was informed that Milo had run away while being taken for grooming.On Thursday, October 24, Noida Police registered an FIR against the owner of Paws Point, Swati Sharma, after Milo's body was found 5.1 km from the centre. The FIR was filed under relevant sections of the Prevention of Cruelty to Animals Act at the Sector 113 police station. Upon their return from vacation, the family searched for Milo and found CCTV footage purportedly showing a man riding a motorcycle and a 14-year-old boy pulling the dog by its leash while riding pillion. The footage also showed the dog being thrashed. According to the complaint, both the man and the minor boy work at Paws Point. Initially, the police sided with those involved and were trying to rush the case," Ghosh alleged. Saurav Sharma, the investigating officer on the case, told The Indian Express that the investigation is ongoing. "We have seized the bike of a man involved in this case and have issued him a challan. As we proceed with the investigation, we will add the names of those involved in the dog's death," he said. In her FIR, Ghosh alleged that the creche staff mistreated Milo and misled her about his whereabouts. "My dog suffered severe abuse, was beaten on the head and spine, and was also planned to be sold to another party," Ghosh claimed. Ghosh's daughter Manali said it wasn't the first time they had left Milo at Paws Point. "The centre charges Rs 600 per day. They killed my dog by dragging him by the leash. Later, we found him dead," she said. Meanwhile, Swati Sharma denied the allegations, stating that Milo ran away from a car while being taken for grooming. "I was driving with an assistant who works with me. I forgot to activate the child lock, and Milo escaped and met with an accident," Sharma ex-

As leaders flock to Antarwali-Saraati, Manoj Jarange-Patil holds his cards close: 'Want Marathas, Muslims, Dalits to come together'

Maratha quota activist Manoj Jarange-Patil's efforts to get reservation for his community may not have worked out as he planned but ahead of the Assembly elections in Maharashtra, he is now eyeing the Muslim and Dalit communities too."I want Marathas, Muslims and Dalits to come together. I am making all efforts to unite all the communities so that we can get maximum MLAs elected and get our demands addressed," Jarange-Patil said in Antarwali-Saraati village in Jalna district, adding that he would hold a meeting with gurus and leaders of both communities before picking the candidates he would support. "We were supposed to announce the names of candidates. However, we have decided to hold a meeting with religious gurus and top leaders of Muslim and Dalit communities on October 31 and after that, we will take a decision," Jarange-Patil, who has been besieged by aspirants and supporters from across the state since early Tuesday

Jarange-Patil said he was supposed to announce the names of candidates he would support on Wednesday. "However, we had to postpone the decision as the religious gurus and leaders could not make it to Antarwali-Saraati due to a glitch in their helicopter. Now the meeting has been scheduled for October 31," he said, adding in the same breath that he might not declare the names even on Thursday. "That will be done before November 4," he said. Asked about the identities of the leaders, Jarange-Patil refused to divulge their names. Emphasising that a change can only be brought about when different communities come together, Jarange-Patil said, "When different communities like Dalits and Muslims come to-

gether, it becomes a huge force. They have the power to bring in the change, they will uplift the lives of the poor because they know what poverty is and how it affects

Those who met Jarange-Patil on Tuesday were told that he has neither declared support for any candidate nor the ruling Mahayuti or Opposition Maha Vikas Aghadi. Earlier, at a press interaction at Antarwali-Saraati, Jarange-Patil had hit out at Deputy Chief Minister Devendra Fadnavis alleging he played a key role in depriving the Maratha community of the quota benefit. On Tuesday, it was no different. "Fadnavis never wanted to give reservation to the Maratha community. He tried to destroy the lives of the children of the Maratha community. He kept filing cases against our youth and they are finding it difficult to get jobs now," he said. Asked if Fadnavis had ever invited him for talks, Jarange-Patil said, "Who wants to go? Fadnavis chapter is closed for me...". 'If they support, we will win': Jarange-Patil back in

In the last two weeks, Antarwali-Saraati has come to life again. There is a constant surge of visitors, especially ministers, leaders and aspirants from all major political parties. Meanwhile, Jarange-Patil is holed up in a bungalow deep inside the village. The bungalow belongs to the village sarpanch and Jarange-Patil decides whom to meet. His close associates said the activist has told aspirants to file nominations. "I will decide who will be the candidate the Maratha community would declare (support for)," he said. A group supporting the candidature of Shiv Sena (UBT) leader Ajit Magar travelled from Hingoli to seek Jarange-Patil's support. "We wanted to field our candidate from the Kalamnuri seat in Hingoli district. He finished the runners-up in the last election. In the current survey, his name was on top but he has not got a Sena ticket. That is why we pleaded with Jarange-Patil to support our candidate," Govind Patil, a voter from Kalamnuri, said. Mehraj Qureshi, another resident of Hingoli, said, "If the Maratha community extends support to our candidate, we are confident he will win. The Jarange-Patil factor matters a lot in our area...After meeting him, we hope he will extend his support to our candidate," Qureshi said. Amar Kale, a local villager, said, "In the last few days, minister Uday Samant, leaders Sanjay Shirsat and Imtiaz Jaleel and even Sambhajiraje Chhatrapati met him."Jarange-Patil's team claimed the leaders were desperate to meet him. "Some have met him at midnight, some early morning...Some sit in the farm till he comes out of his room," said Vijay Tarak, a close associate. Jarange-Patil had decided to field 38 candidates in constituencies where the Maratha community has an overwhelming presence. He has also said that the Maratha community would support those who support their demand for reservation.

Bangladeshi man illegally staying in Bengaluru for last 12 years arrested after his first wife tips off police



The arrested has been identified as Ramzan Sheikh, alias Mohammed Ramzan Sheikh, a native of Narail in the Khulna division of southwestern Bangladesh. The police said he had been in Bengaluru since 2012 and was living in Chikka Banahalli.

GNS News Agency, Nov 1The Bengaluru police on Monday said they arrested a 38-year-old Bangladeshi national staying illegally in the city for the last 12 years following a tip-off by his first wife. The arrested has been identified as Ramzan Sheikh. alias Mohammed Ramzan Sheikh, a native of Narail in the Khulna division of

southwestern Bangladesh. The police said he had been in Bengaluru since 2012 and was living in Chikka Banahalli. They said he was involved in a scrap business and had a fake Aadhaar, voter ID, and Indian passport.

The police said he even had a birth certificate showing that he was born

in West Bengal. He had

also obtained a driving licence from K R Puram RTO in Bengaluru.According to the police, Sheikh had his marriage Bangladesh but married again in Bengaluru and

was living with his second wife and children. They said he used to visit Bangladesh using his Indian passport.In January 2023, he was arrested af-

cused of abetment to suicide as there were allegations of torture and nonpayment of salary. He was released on bail. His first wife, Nurjahan Begum, who lived in Bangladesh, learned through acquaintances that Sheikh was in Bengaluru and had been arrested. In February 2023, she travelled to India on a medical visa and met with the Whitefield division police to present documents proving that Sheikh was born in Bangladesh and a citizen of that country. However, after being released from prison on bail, Sheikh was able to deceive the police.Between February 2023 and September of this year, Sheikh travelled to Bangladesh twice using the Indian passport. The Internal Security Division (ISD), monitoring his movements, learned that he had returned to the city. Sheikh was subsequently arrested and taken into police custody for three days

Officers reportedly seized 11 firearms, over 900 rounds of ammunition, and illegal drugs valued at \$20,000, including cocaine and opium. The five accused include Brampton residents Narinder Nagra, 61, and her sons, Navdeep, 20, and Ravneet Nagra, 22, along with Ranveer Araich, 20, and Pavneet Nahal, 21. Together, they face more than 150 charges. Deputy Chief Nick Milinovich highlighted the rise in gun-related incidents, noting Peel police have seized 157 illegal firearms this year-an 87 per cent increase compared to last year. Milinovich called the rise in gun violence in Peel and the Greater Toronto Area a "situation unlike any we ever have seen," with 119 shootings in Peel in the first nine months of 2024, marking an 80 per cent increase over the same

School topper clings to life after fire at Hyderabad home, grandparents who raised her no more

A 15-year-old is battling for her life in Hyderabad, unaware that the grandparents, who raised her in the absence of her parents, died in a fire that engulfed their home in Yakutpura area on Monday night.Sruti Gupta, who topped her school in SSC (Secondary School Certificate) and is now in the first year of Intermediate, is in the ICU after fire and rescue personnel found her unconscious in her room on the first floor of their house.

"I think she was initially unaware of the fire on the ground floor. She inhaled the thick black smoke and fell unconscious. Her phone was in her hand and she was probably trying to call someone," said fire officer M Shaukat.Officials at Yashoda Hospital, where she is ad-

mitted, said she is in a critical condition, and is under observation in the ICU as her lungs are filled with smoke and soot.

Her aunt Gayatri Shivaram told The Indian Express, "Her life turned upside down when she lost her mother as a child. Her father migrated to South Africa several years ago and is not in touch, and her paternal grandparents have been raising her. They were the ones who took care of her all these years, like her own parents, and she is very attached to them. She will be devastated when she comes to know they are no more."Fire officials are still investigating how the fire started. Late Monday evening, they said, the blaze started in the kitchen and the fridge caught fire, before an LPG blast kept there exploded.Officials said that firecrackers the family had bought for Diwali also caught fire, which led to the black smoke. While Mohal Lal Gupta, 58, and his wife Usha Gupta, 55, could not escape, another family living in a separate portion of the two-storey house escaped unharmed."The fire was not as deadly as the thick smoke that engulfed their home. The firecrackers were still going off when fire officers and I reached. The grandparents died of smoke inhalation," said Yakutpura MLA Jaffar Hussain Meraj. Hours after a district court rejected her anticipatory bail application in the case of allegedly abetting the suicide of the Kannur additional district magistrate, CPI(M) leader P P Divya surrendered before police ADM Naveen Babu was found hanging at his official residence on October 15. The previous day, Divya, then president of the Kannur district panchayat, had publicly criticised Babu at his farewell function, allegedly suggesting that he was corrupt.

The ADM's suicide had triggered outrage in Kerala, forcing the CPI(M) to remove Divya from the post of the district panchayat president. Two days after the incident, police had registered a case against Divya, an emerging woman leader in the CPI(M), on charges of abetment. She had said she would prove her innocence in the case. Since the incident, she was away from the public eye, which led to allegations that the party was shielding Divya, a member of the CPI(M) Kannur district committee. The opposition Congress and BJP had been protesting in Kannur, mounting pressure on the government to arrest her. The issue snowballed into an embarrassing situation for ruling CPI(M) at a time by-elections to two assembly seats and the Lok Sabha seat of Wayanad are being held next month. Initially, the CPI(M)'s Kannur dis-



trict leadership tried to defend Divya, saying that what she said at the send-off meeting was "well-intentioned". However, after the anticipatory bail plea was rejected, the issue once again came to the frontburner of political debates, forcing the party to direct her to surrender before the police. Besides, CPI(M) district leadership in Babu's home district of Pathanamthitta stood with the deceased bureaucrat's family and sought to distance themselves from the approach of the party in Kannur. Babu was scheduled to assume office as the Additional District Magistrate in Pathanamthitta district on October 15, and was seven months from retirement. On October 14, Divya had turned up for his farewell meeting in Kannur uninvited and criticised him with regard to granting a no-objection certificate for a fuel outlet application. She then walked out of the event midway.

Coldplay and Diljit Dosanjh concerts: Amid ticket scalping, challenges and the path forward in India

Remember those classic Bollywood films from the 1980s and 90s, where a character whispers, "Das ka bees, das ka bees," while flashing a pocketful of tickets? That playful portrayal of ticket scalping as a quick moneymaking scheme has become a familiar trope. But the reality of scalping today is far from charming — it's a predatory practice that goes unnoticed unless someone falls prey to it. What began as a survival instinct — hoarding — has evolved into a tool for profit. Now, instead of essentials, people hoard access. The frenzy is evident when tickets for events like Diljit Dosanjh's or Coldplay's concerts, sell out within minutes — only to reappear online at exorbitant prices.

From IPL matches to music festivals, online ticket scalping has become a widespread phenomenon. While ticketing platforms and limited regulations attempt to curb the practice, the absence of stringent government intervention has allowed it to flourish unchecked.

Historically, ticket scalping in India was synonymous with black marketing. Outside cinema halls, vendors ran the "Dus-Ka-Bees" scheme, exploiting demand for block-buster films. Over time, the practice has evolved into a more sophisticated operation, migrating online. Scalpers now use bots and automated tools to hoard tickets in bulk, leaving ordinary consumers struggling to secure access to popular events. In some cases, event organisers themselves manipulate supply by withholding a portion of tickets from initial sales. Using bots and auto-refreshers, these tickets are quickly resold through secondary platforms at inflated prices, creating artificial scarcity.

A notable example is the case of Mandeep Singh v. State of Chandigarh (2015), where a seller was arrested for reselling World Cup match tickets on eBay and charged under Section 66A of the Information Technology Act and Section 420 of the Indian Penal Code (IPC) for fraud. The petitioner sought the quashing of the FIR, arguing that Section 66A had been struck down by the Supreme Court in Shreya Singhal v. Union of India (2015), and that no case under Section 420 was made out since there was no intent to cheat.

The Court acknowledged that Section 66A had indeed been struck down and noted that no offence under Section 420 IPC was established, as there was no inducement or deceit involved — the petitioner had openly disclosed the higher price of the tickets, and there was no legal prohibition against reselling them. The Court held that continuing the proceedings would amount to an abuse of the process of law and affirmed that, "In India, there is no legal restriction against reselling match tickets."

Loopholes in regulation and consumer protectionAlthough Rule 4(11) of the Consumer Protection (E-Commerce) Rules, 2020, prohibits e-commerce platforms from manipulating prices to gain unreasonable profits, its enforcement remains weak. In the case of Diljit Dosanjh's Dil-Luminati Tour concert, a legal notice was filed alleging malpractice in the sale of tickets. It was claimed that the organisers opened ticket sales earlier than advertised, resulting in immediate sellouts. This sud-

den availability and ticket unavailability were interpreted as manipulative tactics to inflate demand and prices, potentially constituting an unfair trade practice under the Consumer Protection Act. "Since tax liability can only be imposed on sellers, and most ticket-selling websites are not registered in India, they evade taxes. Events utilising government resources necessitate a legal framework to secure tax benefits and protect consumer rights," says Avush Kaushik, an Advocate at the Supreme Court of India.In a complaint filed by lawyer Amit Vyas regarding ticketing practices for the upcoming Coldplay concert in Mumbai, it was alleged that BookMyShow engaged in unethical practices that obstructed genuine fans from purchasing tickets. The complaint accused the platform of allowing bots to purchase tickets, which then appeared on resale platforms at exorbitant prices, suggesting possible collusion between BookMyShow and third-party resellers. The complaint cited several sections of the Bharatiya Nyaya Sanhita (BNS), 2023, that could be applicable to the alleged scalping activities. These include:

Section 111(2): Organised Crime - If scalping is organised to manipulate ticket prices, it could be viewed as an economic offence under organised crime, especially if coercion or fraud is involved. Section 318(4): Cheating - If consumers are deceived into overpaying due to dishonest practices, this could be categorised as cheating. Section 316(2): Criminal Breach of Trust - If a ticketing platform misuses tickets for resale at inflated prices, it could be seen as a breach of trust. Section 61(2): Criminal Conspiracy - If multiple parties conspire to manipulate ticket availability through illegal means, this could be considered a criminal conspiracy. India's ticket scalping issue is addressed through laws like the Consumer Protection Act, Bhartiya Nyaya Sanhita, and state-specific legislation. For instance, Rajasthan Entertainments and Advertisements Act (1957) and Maharashtra Entertainments Duty Act (1923) prohibit ticket resale for profit and above face value, respectively. Section 3 of the Competition Act, 2002, prohibits anti-competitive agreements and practices. While ticket scalping could theoretically involve collusive behaviour aimed at manipulating market supply and pricing, proving such informal arrangements is inherently difficult. Ticket scalping typically involves individual transactions that are not easily categorised as collusive behaviour, hindering effective legal action. Furthermore, the Act does not specifically target the issue of scalping, limiting its applicability in consumer protection contexts.

The Consumer Protection Act, 2019 includes provisions against unfair trade practices. According to Section 2(47) of the Act, an "unfair trade practice" refers to any method adopted to promote the sale, use, or supply of goods or services that involves deceitful, false, or misleading representations or actions. These practices can include: Misleading the public about the price of goods or services, implying they are sold at a regular rate when they are not. Hoarding or destruction of goods, or refusal to sell goods or provide services in a manner that raises the cost of goods or services (as outlined in Section 2(47)(v)).

Over two months after the alleged mastermind of a multi-crore stock trading scam fled Guwahati, leaving scores of investors in the lurch, he was found and arrested from a homestay in Goa on Sunday evening.

Thirty-year-old Deepankar Barman's disappearance had come to light on August 21 this year, leading to panic and outrage among his clients. According to the police, Barman had claimed to be the director of a company called DB Stock Broking, and had promised clients high returns on investments – as much as 100% yearly. His disappearance and the subsequent protests and police complaints by investors had led to alarm bells among the police. In the next two weeks, a crackdown was launched, and the Assam police arrested 59 people in 28 different cases. Earlier this month, the CBI began an investigation into 41 such trading scam cases from the state.

However, Barman, whose case had led the dominoes to start falling, remained untraceable. On Sunday evening, he was arrested by a Guwahati police team with the assistance of the Crime Branch of Goa police from a homestay in Pernem district. Police also seized Rs 27 lakh in cash from his room, where he was staying alone. According to Guwahati Police Commissioner Diganta Barah, Barman fled Assam on August 18, when some local media outlets began reporting on alleged ir-



regularities in his business."We did not know where he went, but our team ran a technical analysis, which helped us trace his location to Goa. A team from the Guwahati police stayed there for two weeks and looked for him. He had stopped using social media and old contact numbers since August 21. He also changed hotels, resorts and guesthouses frequently," said Barah. Police learnt about his current whereabouts on Saturday, following which a team from Guwahati left for Goa on Sunday morning. "Since the initial case had been transferred to the CBI, we registered a new case in Paltan Bazaar police station and sent this team. He was found in a homestay in an isolated area, far from the town. When we searched the room, we found Rs 27 lakh in his bag apart from his passport and gold jewellery. He was presented in Parnem court today for transit remand and we are going through the necessary formalities to bring him back to Assam,"

'UT status shield only temporary': Omar Abdullah warns J&K bureaucrats after getting 'assurances from highest level'

Jammu and Kashmir Chief Minister Omar Abdullah said Monday that he had got assurances from the highest level that the Union Territory status of J&K is a "temporary phase". Addressing administrative secretaries in Srinagar, he referred to an "integrity pledge" that he administered to them and warned that if "anybody thinks that somehow the fact that we are a UT will shield you from the consequences of practices that go against the pledge, please remember the shield may last temporarily, but it is only temporary".

He also warned them against trying to "exploit" the hybrid system of governance in the UT. "I am acutely aware that we have unfortunately at this moment a rather hybrid system of governance. And I have a feeling, I am going to say it regardless of the consequences, some may feel they can exploit the system to their advantage, that they can find loopholes within this system that we have in Jammu and Kashmir at this moment," Omar said. He was referring to the governance model in J&K where Lt Governor Manoj Sinha has a say in key administrative issues and the administrative secretaries will be working under him. "But please rest assured that this is very much a temporary phase," Omar told the bureaucrats. Regarding the meetings he held in Delhi, he said: "I have just come back from very successful meetings in Delhi. I have received assurance at the highest level that their commitments made to Jammu and Kashmir, particularly with regard to the governance, will

ED conducts searches a 2nd time in Gujarat GST fraud case, accuses Mahesh Langa of EC, seek clarification on quota promises 'controlling benani firm' DA Enterprises

he Ahmedabad Zonal Office of the Enforcement Directorate (ED) conducted a second set of search operations at seven premises across Ahmedabad, Surat, and Bhavnagar districts of Gujarat on Sunday, in connection with a suspected nationwide Goods and Services Tax (GST) scam expected to reveal crores of rupees of losses caused to the government exchequer. During the search operations, "incriminating documents" were recovered and seized, said a statement from the agency on Monday. It alleged that based on their investigations, Mahesh Langa, senior assistant editor of The Hindu, was "controlling" a firm called M/s DA Enterprises, "from whose premises a large quantum of unaccounted cash was seized by the police authorities, and it is further gathered that various other benami transactions are suspected to have happened with shell companies."

The ED's case of money laundering against M/s

Dhruvi Enterprises & others was filed on the basis of an FIR filed by the Ahmedabad Detection of Crime Branch (DCB) of Gujarat Police, which, in turn, had been come after the receipt of a complaint from the Directorate General of GST Intelligence (DGGI) against 220 shell entities of a group of "organised criminals". In the FIR, the complaint reads that M/s Dhruvi Enterprises was allegedly created based on "fake documents" to obtain GST registration. Later, the entity "raised invoices in the name of 12 different entities", including M/s DA Enterprises, who allegedly availed fraudulent Input Tax Credit (ITC) from the government's GST department. The ED statement on Monday further said, "During investigations, inquiries were made from statutory authorities, and various statements were recorded under the PMLA, which could not establish the genuineness of these transactions. Accordingly, searches were conducted at the locations of such persons/entities, to unearth (the) larger conspiracy involved

The ED had previously, on October 17, conducted their first set of searches in the case at 23 locations at Ahmedabad, Bhavnagar, Junagadh, Veraval, Rajkot, Surat, and Kodinar, including the registered addresses of the entities "availing ITC" in this case. This statement from the ED comes just a day after several media associations issued statements calling for a "fair investigation" into cases against Mahesh Langa. Notably, apart from this case, Langa is also named as an accused in an FIR filed by Gandhinagar Police regarding the theft and possession of confidential documents of the Gujarat Maritime Board (GMB).

Meth lab with links to Mexican drug cartel busted in Delhi-NCR; Tihar jail warden, 4 others arrested

The Narcotics Control Bureau (NCB) has busted a methamphetamine factory in Gautam Buddh Nagar and recovered 95 kg of drugs in solid and liquid form. It also arrested five people, including a warden from Tihar jail. The factory was being used to manufacture drugs in partnership with a member of the Mexican drug cartel Jalisco New Generation, known as CJNG, the NCB said. The operation, a collaboration between the NCB and the Special Cell's Counter Intelligence unit, took place on October 25 in a factory located in the Kasana Industrial Area.

Authorities discovered various chemicals including acetone, sodium hydroxide, methylene chloride, premium-grade ethanol, toluene, red phosphorus, and ethyl acetate, along with imported machinery intended for manufacturing. Two of the accused were arrested at the factory, while two others were arrested between October 25 and October 26. An associate was apprehended in Rajouri Garden between October 27 and October 28, as reported by the NCB."A Delhi-based businessman, who was found inside the factory at the time of the raid, along with a Tihar jail warden were instrumental in establishing the illegal factory, procuring chemicals required for manufacturing of methamphetamine from various sources and importing the machinery. The businessman had previously been arrested by Department of Revenue Intelligence (DRI) in a Narcotic Drugs and Psychotropic Substances (NDPS) Act case and had been lodged in Tihar jail where he came in contact with the jail warden who became his accomplice," said NCB Deputy Director General (operations) Gyaneshwar Singh.

According to police sources, the businessman op-



erates in West Delhi and his network is spread across Delhi-NCR. According to NCB officials, the warden and the businessman roped in a Mumbai-based chemist who was to oversee the operations. In order to ensure quality checks, a member of the CJNG drug cartel sent to Delhi was also involved in the operations. The CJNG stemmed out of Mexico's Milenio Cartel, which was at the centre of Mexico's deadly drug wars."It is believed that considering the low cost of production of synthetic drugs like methamphetamine and mephedrone, the drug mafia is increasingly shifting to setting up such clandestine labs in industrial areas so that local law enforcement agencies do not get unduly alerted because of transportation of material and machinery, waste generated from the laboratories and toxic fumes coming out of chimneys during chemical processing," DDG Singh said. According to the NCB, this was the fifth lab bust in 2024. Earlier this month, a similar operation took place in an industrial estate in Bhopal, where authorities seized approximately 907 kg of mephedrone in both solid and liquid forms, along with about 7,000 kg of various chemicals and the machinery used in the operation.

Candy maker, farmer, social worker—meet Marathas who wish to contest polls on Jarange-Patil's signal

Last week, when Sitabai Mohite filed her nomination for the election in Maharashtra's Ghansawangi Assembly constituency, the only thought in her mind was the steep fees she had to pay for her daughter's agricultural degree. Mohite, who runs a successful gooseberry processing and nursery business in her Ghodegaon village in Jalna taluka, said she had to pay over Rs 8 lakh for her daughter's education. "If you ask me, my decision to file nomination is meant to ensure Marathas get the benefits of lower educational fees applicable for the OBC community. I have zero experience in politics, but when Maratha agitation leader Manoj Jarange-Patil asked us to file nominations, I did not bat an eyelid," she said. Former health minister Rajesh Tope of the NCP is the MLA for the constituency and is seeking re-election.

In Maharashtra, for the last 14 months, Manoj Jarange-Patil, or Dada as he is known among his followers, has emerged as a force to reckon with, especially in the Marathwada region. Incidentally, Deputy Chief Minister Ajit Pawar (also from the Maratha community) is also called Dada. Jarange-Patil sharing the same epithet, many say, is more than a coincidence. Sitabai is one of the many from the Maratha community who have decided to jump into the fray after Jarange-Patil announced his decision to field candidates. His announcement, however, has a rider-he said he would take stock of individual constituencies and make a final decision on who would remain in the electoral fray while others would be asked to withdraw their nominations. As frantic parleys

go on around the activists, his supporters have already

filed their papers and expressed their willingness to withdraw if asked to. In Marathwada, Jarange Patil has a cultlike following, with people like Sitabai wholeheartedly supporting him. Laxman More, a 27-year-old farmer from the village of Sonkhed in Loha taluka of Nanded district, will file his nomination for the Nanded North Assembly seat. Over the past 14 months, More, like Sitabai, has been active in the reservation movement, and his decision to throw his hat in the electoral battle is in response to Patil's call."Over the last 14 months, Dada has managed to do the impossible—he has united the Maratha community. We Marathas have to fight for our rights," he said. Jarange-Patil's main demand is the inclusion of the Maratha community under the Other Backward Classes and to implement the reservation using the principle of sage soyare (relations). Jarange-Patil, who hails from Jalna district of Marathwada, has trained his guns against the BJP, especially Deputy Chief Minister Devendra Fadnavis. His decision to field candidates can seriously affect both the Mahayuti and the Maha Vikas Aghadi in many seats. Given that Marathas constitute around 30 per cent of the state's population, Patil has proved to be a major political and social force to reckon with for everyone. Sitabai confirmed that she was offered posts by established political parties, but she refused. "If I have to fight, it should be for someone who understands the roots," she said. When Jarange-Patil was fasting, Santosh Gavane from Kaladgaon village in Ardhapur taluka of Nanded had supported his movement in a very unique way. Gavane had buried himself halfway down to show his support. Now, Gavane has filed his papers for the Bhokar seat in the district. It is the constituency from where Sreejaya, daughter of former Congress chief minister Ashok Chavan, is fighting her maiden election on a BJP ticket. Chavan is now a BJP MP in the Rajya Sabha.

"It was Dada and his movement that got 30 per cent of Marathas in Marathwada the benefit of the Kunbi certificate (Kunbi Marathas are included in the OBC category). Thus, the community is certain that Dada is the only one who can give justice to the community," Gavane said. He is a newbie in politics, but like More and Sitabai, he is certain Dada would be his trump card. All the candidates know that they will have to withdraw their papers if Jarange-Patil tells them to. They said they would abide by his decision because "whatever Dada says would be good for the community".

Pune advocates send legal notice to ahead of Maharashtra polls

(Representational image)Four Pune-based advocates have requested an urgent clarification from the State Election Commission (SEC) on whether promising specific reservations—such as expanding Muslim reservations, increasing OBC reservations, or granting Dhangar and Maratha reservations—could be deemed appeasement based on caste or religion, thus constitut-

ing a violation of the Model Code of Conduct.

In a legal notice, advocates Asim Sarode, Shriya Awale, Balkrishna Nidhalkar, and Ramesh Taru wrote, "The Maharashtra State Assembly Elections 2024 have recently been announced. Campaigning by political parties and candidates has begun, and all are required to adhere to the Model Code of Conduct to ensure a free and fair election process."Sarode explained that the legal notice aims to clarify whether any reservation promises made based on caste, religion, or specific communities during the campaign, for the purpose of vote-garnering, would constitute appeasement. He questioned, "Would such promises amount to a breach of the Model Code of Conduct applicable in the 2024 Maharashtra State Assembly Election, and could they be considered an offense under any other law?"Sarode further emphasized the need for the SEC to provide clarity through a press conference, adding, "It is crucial to know whether political party leaders are allowed, in public speeches during campaigns, to discuss reservations for specific castes or religions, and if such discussions would be considered appeasement."The advocates said they expect a prompt response on whether discussing or promising reservations based on religion and caste during the campaign is permissible. "This legal notice aims to support free and fair elections, and prior clarification on this subject would help prevent criminalization and complaints over related offenses," they stated in the notice.

'Pink ticket' report: 77% of women in Delhi feel unsafe travelling in a bus after 5 pm

A recent report on the free public bus transport in Delhi shows that 45 per cent of women in Delhi never use the bus while 35 per cent of women ride a bus daily or three to five days a week. Titled 'Riding The Justice Route', the report was released by Greenpeace India on Tuesday, the fifth anniversary of the Delhi government's 'pink ticket' policy that made commuting on public buses free for women, after surveying the participants and assessing the impact of the scheme on their lives. As per the report, one in four women have started using buses after travel was made fare-free. After the scheme's introduction, 23 per cent of women have started using buses at least four times a week, and 15 per cent of women, who rarely or never used buses before the scheme, now use them regularly.

When it comes to challenges faced by women, the survey says that a little less than 50 per cent of women bus users feel "mostly safe" while travelling to the bus stop, waiting there, and riding a bus. The survey also suggests that 77 per cent of women feel unsafe while travelling by bus after 5 pm and two in three women find the lighting at the bus stop inadequate. Frequency also remains a challenge as 87 per cent of the women reported waiting more than 10 minutes, while a good 13 per cent waited more than 30 minutes for the bus.

"Of the 510 responses we collected, 95 per cent came from field surveys and 5 per cent from web-based channels, including social media platforms (primarily Twitter and Instagram) and WhatsApp groups," the report states. The impact of the scheme on the perception of women towards public transport across income groups is noteworthy. After the 'pink ticket' was introduced, 88 per cent of women surveyed perceived the scheme as 75 per cent of women bus users in the lowest-income households use the bus at least three to five days a week, whereas 60 per cent of women bus users in middle-income households travel by bus that often. Interestingly, 57 per cent of women in the monthly household income



bracket of Rs 50,000 to Rs 1 lakh ride a bus daily, the highest among all income groups. The survey shows that when asked how often women currently (in the past month) use the fare-free public bus transport in Delhi, 45 per cent said they did not use it even once. The survey also notes that only 75 per cent of women in Delhi said they can use the bus when they typically need to travel. More than two in three (69 per cent) women can use the Delhi Metro when they generally need to travel, and shared auto rickshaws and e-rickshaws are estimated to be the most commonly available mode of transport for women, considered available by 64 per cent of the women in Delhi."This highlights their ubiquity and key role in women's mobility as an important intermediary mode of transport. Their role has become indispensable with the lack of reliable public transport, particularly for making short trips of less than 2 km, which, as the available evidence from transport and time use studies suggests, are the distances women in Delhi most commonly travel in their daily routine. Cabs and taxis were found available by 34 per cent of women," the report says.

Analysing bus use among different age groups, younger women have emerged as travelling more often as compared to middle-aged and older women as 64 per cent of this group ride a bus daily. However, a larger proportion of older women travel regularly by bus. Among women bus users above 45 years, only 6 per cent said they take public transport rarely.

On September 28 (IST), New York-based Dhruv Loya gladly celebrated his professional breakthrough on LinkedIn, sharing his latest achievement that finally greeted him at the end of a challenging journey. "I finally got a job!" Loya announced on the professional social networking site, as he updated his resume, adding Powerwall Technical Support Specialist to his list of experiences under Tesla's banner. He opened up about how the arduous path to the major career destination was overlaid with "three internships, a good GPA, and active extracurriculars." Despite cracking those milestones, making his portfolio heavier than before, he found himself at a dead-end, bringing five long and taxing months of unemployment. North Korea and Russia send political shockwaves with Ukraine war moves



North Korea's foreign minister arrived in Russia on Tuesday for talks as the Russia-Ukraine war appeared to take a dangerous new turn, with NATO and South Korea expressing alarm that North Korean troops could soon be joining in on Moscow's side.

MOSCOW/SEOUL GNS News Agency, Sept 21, North Korea's foreign minister arrived in Russia on Tuesday for talks as the Russia-Ukraine war appeared to take a dangerous new turn, with NATO and South Korea expressing alarm that North Korean troops could soon be joining in on Moscow's side.NATO said on Monday that thousands of North Korean troops were moving toward the front line.

The development has alarmed Kyiv, which has said sanctions would not be enough and called for more weapons and an international plan to keep the North Korean troops at bay.South Korea, which remains technically at war with the nuclear-armed North decades after the 1950-1953 Korean War, also condemned the deployments, with officials in Seoul particularly worried about what Russia may be providing to Pyongyang in return.North Korean Foreign Minister Choe Son Hui arrived in Russia's far east on Tuesday on her way to Moscow, Russian state media said. Russian state news agencies said it was not clear who Choe, making her second visit in six weeks, would meet in Moscow.The Kremlin said Putin had no plans to meet

Ukraine's President Volodymyr Zelenskiy spoke with South Korean President Yoon Suk Yeol on Tuesday and said the North Korean moves were sending the war into an unprecedented phase. "The conclusion is clear - this war is becoming internationalized, extending beyond two countries," Zelenskiy said on X.Yoon told Zelenskiy that if North Korea receives aid from Russia and is able to glean military experience and knowledge from its involvement in the war it would pose a "great threat" to South Korea's security, according to a statement from South Korea's presidential office.South Korea has said it may start supplying weapons to Ukraine if North Korean troops joined Russia's war. The Pentagon also said on Monday it would not impose new limits on Ukraine's use of U.S.

weapons if North Korea

entered the fight.Russian

President Vladimir Putin

has not denied the pres-

ence of North Korean troops in the country.

What role the North Korean troops may play is unclear. Analysts say their small number and possibly limited capabilities are unlikely to be decisive, but they could shore up Russian forces by providing manual labor or manning defensive positions. They are also likely to play a political role for Russia and North Korea, strengthening their hands in relations with China, which has an uneasy partnership with both countries, and sending a message to Washington and its allies, Western diplomats and analysts said."The closer Moscow's ties to Pyongyang, the more leverage it expects over U.S. allies as well as China," Gilbert Rozman, of The Asan Forum, wrote for the U.S.-based 38 North programme. Moscow needed a partner hostile to the status quo, wary of China but unwilling to antagonize it, and helpful in meeting arms or perhaps labor needs, he said.

Russian air attacks kill four in Kharkiv, injure six in Kyiv, Ukraine says



KYIV, GNS News Agency, Nov 1, At least four people were killed and another six injured in Russia's waves of overnight attacks on Ukraine's two largest cities of Kharkiv and Kyiv, Ukrainian officials said Another two were killed and seven injured in Russian shelling on Kherson city in southern Ukraine in the morning, a local governor said.

Russian forces have been attacking Ukrainian regions almost every night with drones, and the Ukrainian military reported that overnight they had shot down 26 out of 48 drones launched. Four people were killed in Kharkiv in the early hours of Tuesday in Russia's bombardment of the city's Osnovianskyi district, Mayor Ihor Terekhov said on his Telegram messaging channel.

A local emergency service published a video showing rescuers removing the rubble of the completely destroyed building under floodlights and carrying a black bag in which the bodies of the dead are usually placed. That attack followed a Russian guided bomb attack on Kharkiv late on Monday that shattered much of the Derzhprom building, one of the most celebrated landmarks in the city, dating from the 1920s. In Kyiv, falling debris from a destroyed Russian drone injured six people and set a residential building on fire, the mayor of the Ukrainian capital said. One of the people injured by debris in Kyiv's Solomianskyi district was taken to hospital, Mayor Vitali Klitschko said on his Telegram channel. He said several cars were also on fire.

A Reuters witness saw smoke rising over the district's residential area, which is located in Kyiv's west. Photos posted by Kyiv's military administration on its Telegram channel showed a residential building and nearby cars burning in the dark. The administration said Ukraine's air defence units were trying to repel a Russian drone attack on the city and that drone debris fell also onto the Sviatoshynskyi district in Kyiv's west, but there was no immediate reports of damage.

In the morning attacks on Kherson, governor Oleksandr Prokudin said on the Telegram messenger that the victims of the Russian shelling were a 62-year-old man and a 66-year-old woman.Kherson region is split by the front line and regularly hit by Russian artillery, drones and missiles.There was no immediate comment from Russia about the attacks.Moscow denies targeting civilians in the war sparked by its invasion of its neighbour Ukraine in February 2022.The 2-1/2-year war has killed thousands of people, the vast majority of them Ukrainians, and it has turned cities and villages into piles of rubble.The Reuters Daily Briefing newsletter provides all the news you need to start your day. China's Xi pressed Biden to alter language on Taiwan

WASHINGTON/BEIJING/TAIPEI, GNS News Agency, Nov 1, Chinese President Xi Jinping asked U.S. President Joe Biden last year to change the language the United States uses when discussing its position on Taiwanese independence, according to two U.S. officials familiar with the private conversation. During last November's Biden-Xi meeting near San Francisco, Xi and his aides asked Biden and his team to tweak the language in U.S. official statements. China wanted the U.S. to say "we oppose Taiwan independence," rather than the current version, which is that the United States "does not support" independence for Taiwan, said the people, who requested anonymity to speak about private diplomatic exchanges they participated in or were briefed on.

Xi's aides have repeatedly followed up and made the requests in the months since, according to two U.S. officials and another person familiar with the exchanges. The White House responded to a request for comment with a statement that repeated the line that Washington does not support Taiwan independence. "The Biden-Harris administration has been consistent on our long-standing One China policy," the statement read.China's foreign ministry said: "You should ask this question to the U.S. government. China's position on the Taiwan issue is clear and consistent."Taiwan's foreign ministry declined comment. The defeated Republic of China government fled to Taiwan in 1949 after losing a civil war with Mao Zedong's communists. The Republic of China remains Taiwan's formal name and the government says it has no plans to change that given they are already a sovereign, independent state and Beijing has no right to claim Taiwan as its own.

For several years, Chinese diplomats have pushed the United States to make changes to how it refers to Taiwan's status, which remains the most sensitive area in U.S.-China relations. The unusually direct and renewed push at the leader level has not been reported previously. The United States severed official relations with the government in Taipei in 1979 but is bound by law to provide democratically governed Taiwan with the means to defend itself. China claims Taiwan as its own territory and has never renounced the use of force to bring the island under its control. It was not clear why Xi chose to raise the issue with Biden, but he has made opposition to Taiwan independence a focus of his time in office and China's military has significantly ramped up its activities around the island in recent years. The Biden administration regards the proposed language change as a non-starter. Taiwan was briefed on the recent overtures at a high level by Washington, said one of the sources.Leaders in Beijing "would love it if Joe Biden said very different things about Taiwan than he says, no doubt." said one senior Biden administration official, adding that Biden would stick with the standard U.S. formulation for talking about Taiwan independence. During his time in office. Biden has upset the Chinese government with comments that appeared to suggest the United States would defend the island if it were attacked, a deviation from a long-held U.S. position of "strategic ambiguity."

A CHANGE THAT WOULD REVERBERATEA change by the U.S. to say that it opposes Taiwanese independence would reverberate through the trade-rich Asia Pacific and with U.S. partners, competitors and ad-



versaries alike.Officials from two governments in the region told Reuters they would interpret any such change in wording as a change in U.S. policy toward less support for Taipei's defense and diplomatic aspirations at a time when Beijing has ramped up military pressure.China has over the past five years staged almost daily military activities around Taiwan. Earlier this month, Beijing held a day of war games using what Taiwan said was a record 153 military aircraft as part of drills simulating blockading ports and assaulting maritime and ground targets.

Any switch in language could also be seen signaling a shift in U.S. policy from supporting the resolution of Taiwan's future through peaceful talks to one suggesting the United States stands against Taiwanese aspirations regardless of the circumstances at play.Opinion polls in Taiwan show most people support maintaining the status quo, neither seeking to join with China nor establishing a new state. In 2022, the State Department changed its website on Taiwan, removing wording both on not supporting Taiwan independence and on acknowledging Beijing's position that Taiwan is part of China, which angered the Chinese. It later restored the language on not supporting independence for the island. The two leaders are expected to speak again before Biden's term in office ends in January, talks that may come by phone or on the sidelines of next month's G20 summit in Brazil or APEC summit in Peru. APEC is one of few international forums where both Taiwan and China take part. Georgia conducts partial vote recount after reports of polling irregularities

TBILISI,- GNS News Agency, Nov 1, Georgia's central electoral commission said it would recount ballots at some 14% of polling stations on Tuesday after independent monitors raised concerns about the conduct of Saturday's parliamentary election. Official results said the governing Georgian Dream party won nearly 54% of the vote, but pro-Western opposition parties and Georgia's president have said the result was rigged. Thousands of people protested on Monday night in the capital Tbilisi. The European Union, NATO and the United States have demanded a full investigation into reports of votebuying, voter intimidation and ballot stuffing raised by monitors from the Organization for Security and Co-operation in Europe (OSCE) and other bodies. The election commission, which previously hailed the vote as free and fair, said it would conduct a recount of ballots in five randomly selected polling stations in each of Georgia's 84 electoral districts. It did not say when the results of the recount would be made public. "To ensure transparency, all authorized representatives are invited to observe the ballot recount process," the commission said in a



statement.Official results showed Georgian Dream won 1.12 million votes - 335,000 votes more than the combined four main opposition parties, which are deeply divided. The party won huge margins of up to 90% in some rural areas, but underperformed in Tbilisi and other large cities.

Rural uptick but urban areas new points of concern in GDP growth



Incipient signs of softening consumption demand, especially in urban areas, reflected in multiple high-frequency indicators and corroborated by the earnings guidance of consumer goods companies, have raised concerns about a weakening of the growth momentum in the Indian economy. While rural demand is seeing an uptick, high food inflation and a moderation in credit growth are possible headwinds that could slow down growth in the second quarter of 2024-25.

Companies in the fast-moving consumer goods (FMCG) sector have already pointed out some early signs. Top executives at Tata Consumer Products Ltd have flagged concerns over "softness" in urban demand while those at Nestle India pointed to mega cities and metros as pressure points, and blamed the indications of "muted demand" partly on high food inflation. Carmakers are pointing to worries on demand for the sector that has largely bucked India's consumption downturn so far, blaming it on heavy rains and the election-induced slowdown. All of this could have repercussions for India's growth story going forward. The sequential decline in underlying growth momentum is discernible. For Nomura India, the growth glass "looks half empty", with its latest coincident activity index — a composite index covering consumption, investment and the external sector - pointing to slower GDP growth in the second quarter of 2024-25 compared with the first quarter. In the first quarter, GDP growth had already moderated to around 6.7 per cent from 7.8 per cent in the previous guarter. During the second quarter of July-September, this could moderate even further to around 6.5 per cent (much lower than RBI's projected 7 per cent) amid a slowdown in investment and industrial activity that could compound the slowdown in discretionary consumption sector, especially in urban centres, that Nestle and Tata Consumer are alluding to.

"Real wage growth for rural agricultural and nonagricultural workers is providing some support to consumption growth. In the urban areas, new demand is not there. It's mostly status quo as urban consumers have broadly consumed a lot in the post-Covid phase and exhausted the pent-up demand," Devendra Kumar Pant, Chief Economist, India Ratings and Research said. According to the Finance Ministry's economic review for September, rural demand continues to improve, as reflected in increasing fast moving consumer goods (FMCG) volume sales and a rise in three-wheeler and tractor sales. However, urban demand appears to moderate due to softening consumer sentiments, limited footfall due to above-normal rainfall, and seasonal periods during which people tend to refrain from new purchases, the Ministry said. Broader data sets clearly point to this: Corporate sector's growth rates in revenue and profits have taken a beating if the initial trends from the financial results of listed companies for the quarter ended September 2024 are any indication, with the growth rate in net profit of 197 companies down to 6.1 per cent at Rs 83,007 crore in Q2 of 2024-25 as against 27.4 per cent (Rs 78,224 crore) in the same period of last year largely on account of a rise in expenses and input costs in the second guarter, according to data compiled by Bank of Baroda Research. The picture weakens further if the 10 banks in the sample are excluded. Rating firm Crisil said revenue growth of 5-7 per cent for Q2 is likely to be the slowest in the last 16 quarters.

Companies are also scaling down their salary outlays. Real salary and wage expenditure growth of listed non-financial corporates –a proxy for real urban wages – has moderated to 0.8 per cent in Q2 FY25 from 1.2 per cent in Q1 FY25, and is down from 2.5 per cent in FY24 and 10.8 per cent in FY23, Nomura said. Adding to these stress signals are worries about high food inflation. The RBI has indicated that food inflation continues to be a

worry and that it could be risky to talk about cutting rates at this point in time. "At this stage of the economic cycle, having come so far, we cannot risk another bout of inflation. The best approach now would be to remain flexible and wait for more evidence of inflation aligning durably with the target," RBI Governor Shaktikanta Das wrote in the minutes of the Monetary Policy Committee (MPC) held from October 7- 9.

The other problem is on the external front, where protectionist measures in the US and sluggish demand in western Europe do not promise much for India's already struggling exports. During the annual meetings of IMF-World Bank in Washington last week, Finance Minister Nirmala Sitharaman said that the output-inflation tradeoff globally has worsened and cooling may slow down the economic momentum — which necessitates continuous data-driven policy adjustments to monitor spillovers. Speaking on the Indian economy at an event organised by the Peterson Institute for International Economics in Washington on Friday, Das remained upbeat and said that improving domestic demand, lower input costs and a supportive policy environment continue to spur manufacturing activity, while the services sector is displaying strong growth.

"The growth outlook reflects the underlying strength of India's macro-fundamentals, with domestic drivers private consumption and investment - playing a major role," the central bank governor said, adding that the government's thrust on capex and healthy balance sheets of banks and corporates are expected to support private investment and that private consumption appears to be on track for a strong improvement due to the favourable agricultural outlook and the pickup in rural demand. So while the lead indicators point to a moderation in growth, certain components of growth, including government spending that had dipped during the election months, could see a pick up in the coming quarters. During April-August, central government expenditure stood at Rs 16.52 lakh crore, down 1.2 per cent from the corresponding period a year ago. Higher government spending along with efforts to bring down inflation could help India's growth in the second half of this year.


Government spending is likely to pick up as that is overdue, but the continuing moderation in credit growth, particularly consumer credit growth means constraint in terms of discretionary activity could continue. That's already reflective on the urban demand side. And on whether private capex is picking up, whether it is broadening out, with demand continuing to be soft, the changes of a pickup, especially a broad-based one, are unlikely. The positives going forward include the festive season demand, and to what extent discounts help boost consumer activity. It would also be crucial to see to what extent government capex picks up and if rural demand will hold. The Finance Ministry has flagged the need to watch the demand conditions at the margin. Citing data from Nielsen IQ, the Ministry said rural demand has strenathened in H1 of FY25, with improvement seen in rising FMCG sales of 5.2 per cent (volume growth) in Q1 FY25 as against 4 per cent seen in the year-ago period. There has also been a pickup in auto sales in rural areas by around 2 per cent in H1 FY24, with a significant increase in three-wheelers (7.4 per cent) and passenger vehicles (4.9 per cent) sales. In urban areas, however, volume growth in FMCG sales has slowed to 2.8 per cent in Q1 in FY25 from 10.1 per cent in Q1 FY24. Auto sales declined by 2.3 per cent in H1 of FY25, mainly due to lower sales in Q2 FY25 in urban areas. Housing sales and launches have also dipped in Q2 FY25, the Ministry

Going ahead, a further monetary easing by the US Fed post-elections are expected to boost India's capital inflows, experts said. A higher real wage growth and above-normal monsoon also augur well for consumption growth going ahead. There is a distinct possibility that government expenditure will be the biggest driver for overall economic recovery, especially if one were to consider the run rate so far and factor in the budget forecast assuming an implied growth in capital expenditure from September to March 25 should be around 40 per cent year on year. Given the contraction seen in April-August, there has to be a big improvement. Revenue expenditures from the government side should also see an improvement, which could have some impact.

Air India gets DGCA greenlight for inhouse modification of aircraft interiors, collaborates with Tata Technologies

Air India has received the regulatory approval that will allow the airline to independently make aircraft interior design changes and modifications in-house and not fully depend on third party service providers. The Design Organisation Approval (DOA) from the Directorate General of Civil Aviation (DGCA) comes at a time when the airline has initiated a multi-million dollar retrofit programme to spruce up the interiors of its legacy aircraft. With the DOA in place, the Tata group airline is also collaborating with another group company—Tata Technologies—to enhance the cabin interiors of its fleet.

"Air India is the first airline in India to attain this level of authorisation, accelerating its ability to execute restoration tasks for continuous improvement of its fleet...The DOA is a transformative step towards enhancing Air India's in-house capabilities, which has been bolstered by decisions to set up its own engineering, maintenance and training facilities. This will enhance operational efficiency and make the airline more self-reliant," the airline said in a release. While Air India's focus currently would be on improving and maintaining interiors of its fleet and that of its no-frills airline Air India Express, the DOA certifies the company as a design organisation, which enables it to offer these services to other airlines. On its part, the airline did not comment on whether it was looking at offering services to other airlines. "Air India has chosen Tata Technologies as its strategic partner to revolutionize its aircraft interiors...Tata Technologies will provide end-to-end solutions, from design and validation to weight optimization and ergonomic considerations. These innovations are set to redefine the passenger experience by ensuring that aircraft interiors are not only functional and safe but also future proof, providing passengers with modern comfort and state-of-the-art technology," Tata Technologies said in a separate release. Tata Technologies said that its deep experience working with leading



aerospace original equipment manufacturers will be crucial in the process. Tata Technologies has expertise in lightweight materials, advanced design, and validation techniques, which it believes will help Air India optimize the fleet's performance, safety, and efficiency. "This collaboration also positions Tata Technologies as a key player in streamlining Air India's operations by integrating innovative digital thread solutions and smart Maintenance, Repair, and Overhaul (MRO) services. These solutions will improve operational efficiency, reduce downtime, and ensure that Air India's fleet remains in top condition, further enhancing passenger safety and operational reliability," Tata Technologies said. Air India was acquired by the Tatas in January 2022 from the government. Under government control, Air India was under financial stress, and this reflected in its product and service quality, which was seen as below the standards expected from a full-service carrier. While the now-privatised airline has ordered hundreds of new aircraft and recently initiated a mammoth fleet modernisation and expansion plan, it still has a large number of legacy aircraft that are in a rundown state. The \$400-million upgradation of the airline's entire narrow-body fleet started last month and is expected to be complete by the middle of next year.

All about Jaya Kishori, the spiritual preacher under fire for carrying Dior Book Tote worth over 2 lakh



A controversy has erupted around spiritual preacher and singer Jaya Kishori after she was spotted carrying a Dior Book Tote worth over 2 lakh. Can the gold-to-silver ratio help you make the right investment choices?



Deciding whether to invest in gold or silver can feel overwhelming during Dhanteras, but content creator Prof. Vinny Arora says that simple tools like the gold-to-silver (GS) ratio might help make that choice easier. "Now one needs to take into different scenarios before making a final purchase decision, but this is a good indicator to help you make an informed investment decision," he mentions in the caption of his post. This ratio measures how many ounces of silver it takes to buy one ounce of gold, offering insight into market trends and helping investors gauge which metal might be the better buy at any given time. Historically, the GS ratio has averaged around 60:1, but in recent years, it has seen significant fluctuations.

With the current ratio above long-term averages, is now the time to invest in silver over gold? We spoke to experts to understand whether the GS ratio can guide investors in making smart decisions and what factors should be considered beyond it.

How reliable is the gold-to-silver ratio as an indicator for deciding between purchasing gold or silver?

Devendra S, financial literacy expert, tells indianexpress.com, "The gold-to-silver ratio (GS ratio) can be a useful gauge for investors in India, particularly in assessing the relative value between these two metals. Traditionally, a higher GS ratio indicates silver may be undervalued than gold. However, this should not be the sole basis for investment decisions. While the GS ratio reflects historical pricing trends, it does not account for industrial demand for silver, which has grown significantly, especially in electronics and solar power." As a financial advisor, Devendra stresses, "I recommend using this ratio as part of a broader analysis, considering factors such as global demand, market volatility, and investment objectives. For instance, during economic uncertainty, gold often performs better as a safe-haven asset, while silver is more sensitive to industrial demand cycles."

With the GS ratio currently above long-term aver-

ages, does this suggest that silver is undervalued? Aditi Khandelwal, co-founder, Kicky and Perky, explains that with the GS ratio being well above long-term averages, often around 65:1, "there is a message that silver may be under-recognised compared to gold." However, many market forces have to be factored in before investing. Industrial demand for is on the increase for silver with its role in many industries such as iewelry. electronics, and renewable energy sources. Thus, silver's price will be supported by growing demand and will not necessarily be dependent on gold. Dishi Somani, founder of Dishi S Designer Jewellery, mentions, "A high ratio, which is usually above 80, suggests that silver might be undervalued and could be a good time to buy it. Conversely, a low ratio nearly around 50, indicates that gold might be more appealing. Historically, this ratio has ranged between 50 and 70 over the past 50 years, reflecting market shifts. Currently, with a ratio of around 85,

silver appears undervalued."

What risks should purchasers know when using the

According to Devendra, while the GS ratio can be a helpful indicator, relying solely on it carries risks. The ratio doesn't consider the market supply-demand fundamentals for each metal. "For instance, if silver demand surges due to technological advancements (e.g., in solar energy or electronics), the ratio might suggest silver is undervalued, even though market forces could drive prices higher." Investors should also consider liquidity risks and market timing, especially since silver is more volatile than gold. One way to mitigate these risks is by diversifying across asset classes, not just precious metals. High-intensity workouts more effective for weight loss in women: Study

New Delhi: Exercising to lose weight? High-intensity physical workouts may be more beneficial, especially for women, according to a study. The study, published in the Journal of the Endocrine Society, showed that more than moderate exercise, and engaging in vigorous physical activity like jumping rope, swimming, and cycling can suppress hunger levels in healthy adults. The small study noted that females may be more susceptible to this re-

Researchers from the University of Virginia in the US showed that the effect is due to ghrelin — a hormone that stimulates appetite. They noted that hunger levels are significantly reduced after high-intensity exercise, as compared to moderate-intensity exercise or control (no exercise). Lead author Kara Anderson, from the varsity, noted that people felt 'less hungry' after high-intensity exercise compared to moderate-intensity exercise. To investigate the effect of exercise intensity and sex on ghrelin levels and appetite in untrained humans the study included eight males and six females. The participants fasted overnight and then completed exercises of varying intensity levels.

The traffic police had received a message stating that the message shouldn't be taken lightly, and if Salman wants to end the feud with Lawrence then he has to pay Rs 5 crore to settle the matter. The message further stated that if Salman fails to do so then he will face a similar fate as slain politician Baba Siddique. The cops traced the origin of the message to Jharkhand.

Baba Siddique, who joined Ajit Pawar faction of NCP, died after being shot at by unidentified persons on October 12. The firing took place outside his MLA son Zeeshan Siddique's office near Colgate ground in Nirmal Nagar in the Bandra area of Mumbai. 

Wicketkeeper-batter Jamie Smith isn't a part of the Test squad after taking paternity leave for the birth of his child. In his absence, Jordon Cox has a chance to don the England whites for the first time. England will be looking to make amends after losing 2-1 to Shan Masood's Pakistan in the away Test series. They won the opening Test in Multan by a margin of an innings, but lost the next two Tests after Sajid Khan and Noman Ali made their batters struggle. England are scheduled to play their first Test against the Black Caps from November 28 at the Hagley Oval in Christchurch. Wellington and Hamilton will host the other two Tests from December 6 and 14 respectively. Before the Test series, Ben Stokes' England will also face New Zealand Cricket XI in a two-day practice match, starting November 23 at the Sir John Davies Oval in Queenstown. The duo share a rich legacy at CSK, having secured four IPL titles together in 2010, 2011, 2018, and 2021. Raina, who retired from the IPL after the 2022 season, remains one of the league's top run-scorers with 5,528 runs in 205 matches, including a century and 39 fifties. Beyond IPL success, he played a key role in India's triumphs under Dhoni's leadership, winning the 2011 ODI

World Cup and the 2013 Champions Trophy.

Their bond runs deep, with both retiring from international cricket on August 15, 2020. While Raina has moved on from the league, Dhoni is expected to return for the IPL 2025 edition. The 43-year-old, who led CSK to five IPL titles, remains a key figure for the franchise. With recent tweaks to the uncapped player rule, Dhoni is likely to continue adding to his 5,243 IPL runs and 24 half-centuries across 264 matches.

The CSK reunionFormer India and Chennai Super Kings (CSK) skipper MS Dhoni has hinted at a possible return for IPL 2025, stating he wants to enjoy "whatever last few years of cricket" he can, amid ongoing speculation about his future with CSK. Questions surrounding Dhoni's plans began when he handed the captaincy to Ruturaj Gaikwad last season and started batting lower in the order. As the October 31 deadline for franchise retention lists approaches ahead of the mega auction, Dhoni's position is still a topic of interest. With a reintroduced rule allowing players who have retired from international cricket for five years to be classified as uncapped, CSK may choose to retain Dhoni under this new provision. Recently, Dhoni shared his current mindset at a promotional event in Goa, stating. "I just want to enjoy whatever last few years of cricket I'm able to play. Like how during our childhood, we used to go out and play at 4 pm, just enjoying the game."

Vishy vs the world: Viswanathan Anand defeats over 60,000 opponents in single online game

Anand was playing with white pieces and ended the game with a checkmate in just 24 moves. The game was organised to mark the 25th anniversary of the Kasparov vs The World match where former world champion Garry Kasparov took on over 50,000 voters on the Microsoft Network (MSN) and won the game after four months and 62 moves. Kasparov later called it "the greatest game in the history of chess."

How Anand defeated 60,000 players of the WorldIn the unique match organised by Chess dot com, the Indian legend's opponents could register to vote for their

next move against Anand. Each side had the whole day to make a single move. This meant that the 60,000+ opponents that Anand faced had 24 hours to cast their vote on their next move with black pieces. The World team had the support of four coaches: IM Tania Sachdev, IM Sagar Shah, IM Kostya Kavutskiy, and FM James Canty. The World's team were able to chat in the system's comments section, exchanging ideas and strategies to try to defeat Anand. The Indian chess legend started by pushing his pawn to the c4 square, opting for an English Opening rather than his usually preferred choice of 1...e4. The English Opening is the fourth most-commonly played opening move in chess which allows the white queen the freedom to attack while also restricting black from responding with 1...d5. The former world champion then brought out his knights for a Four Knights, Kingside Fianchetto Line. By the 15th move, the World was already three pawns up. But from that point on, Anand's queen had started advancing on the World's king, putting it under

Ramiz Raja says dropping Babar Azam was a knee-jerk reaction by PCB management

Former Pakistan Cricket Board (PCB) chief Ramiz Raja maintained that dropping Babar Azam in the middle of the series was a "knee-jerk" reaction from the management and feels the slump in his batting form is not because of his technique but is more to do with his mental side. "He (Babar Azam) should have been asked whether he needed time off from cricket or not," Raja told reporters during a select media interaction ahead of Pakistan's white-ball tour of Australia. "Obviously, his form wasn't great, but even then, I mean, his body of work suggests that there should have been a much better way of easing him out from a Test series. So it was probably a knee-jerk reaction, but I'm sure that he'll come back as a stronger individual

"This is probably the first time that he's been dropped in his career, and he will be eager to prove his point. So let's see how the comeback is or whether he is inspired, whether he has changed his technique, and how motivated he is because such things can spur an individual," he added. The scrutiny around Babar Azam's form has been magnified with each subsequent failure with the bat. The right-handed batter hasn't scored in 18 innings. Since the start of 2023, Babar Azam's average has been below 21 in nine Tests."I think it's a lot to do with his temperament in Test cricket. When his form slumps, then it takes a longer time for him to make a comeback in redball compared to white-ball cricket. So it's a temperamental issue more than anything else.

"From a technical point of view, you see he doesn't stay still to the ball pitched on the back of the length side, so he needs to be just a little bit more side-on. Because



he's been, of late, getting out caught behind to a ball that is moving away. Also, he struggles against spin. You know he bats at number 4 in Test cricket, but in white-ball cricket, I don't think he is going to have a lot of problems against spin. Again, as I said, he needs to tweak his mental game, not his technique," he said. The loss of form during a turbulent time regarding his leadership status has impacted Babar's career. Following Pakistan's group-stage exit from the ODI World Cup in 2023, he was sacked from the captaincy in all formats. However, four months later, the T20I and ODI captaincy were returned to him, with Shaheen Afridi sacked after just one series.

Follow Viv Richards' blueprintBabar Azam's second stint was equally poor. Pakistan cricket team was eliminated from the T20 World Cup in 2024 in the first round after losing to the USA and India. Just six months after Babar Azam was reappointed, he left the captaincy, citing a desire to focus on his batting. Ramiz Raja says the star Pakistan batter has potential like legendary Viv Richards, and he must follow the blueprint of the former West Indies cricketer. "I feel Babar Azam has to achieve a lot more in Test cricket. He plays the white-ball format really well and has an average of 50-plus in both formats (T20I and ODI)... There is so much potential in Babar Azam," he said. "He has been Pakistan's best batsman in the last 10 years. Fans expect him to be a match-winner for Pakistan and, probably he himself wants to be a bigmatch player when there's a lot more at stake. And that's why I compared him with Richards; I think that's a great blueprint for Babar Azam to follow. The bigger the contest, the bigger the innings Richards used to play. Like Richards, Babar Azam too looks to decimate the opposi-

Why Maria Sharapova's Hall of Fame inclusion will continue to annoy and be admired simultaneously

Maria Sharapova was recently announced as the next to be inducted into Tennis' Hall of Fame alongside Bryan brothers. It's a decision that is extremely polarizing just as the tall Russian's career was - winning all Slams and failing a drug test. Sharapova burst onto the scene in the early 2000s, and remained a force to reckon with in an era when Serena Williams ruled the courts. She finished and abysmal 2-20 against Serena, but always kept her chin up in a loss, and pushed herself to go from fast courts to winning on clay. Having caught the eye of great Martina Navratilova, she had moved to Florida with her father in 1994 and in 2001, aged 14 turned a pro. Sharapova's dominating style of play because of her power and height fetched her success and in 2004, she defeated Serena Williams at the Wimbledon for her first Major crown at age 17.In 2005, she made the semifinals of Australian Open, Wimbledon and the US Open, a run which helped her climb to the top of women's single's ranking. It was the first time she was ranked No 1. In 2006, she would clinch her maiden US Open title and in 2008 began the year by being crowned champion at the Australian Open.

After struggling with injuries, rehab and dip in form, Sharapova would come back stronger. Having started 2012 by being a runners-up at Australian Open, she would go on to win the French Open and thus become the 10th woman to complete a Career Grand Slam. After losing the next year's edition in the final, she would again lift the trophy at the Roland Garros in 2014. The grunting and the grinchesSharapova was as cussed by critics as she was celebrated by fans. One thing that her pre-Social Media trolls invariably picked on, ever since her Wimbledon appearance in Girls singles at age 15, was her famous grunt, which was inadvertent given its necessity in generating power, but often cited by trolls to diss her. Tennis.com writes: "In those days, she also hummed as she hit some shots. She did that at maximum volume, too." It was telling that a Nadal grunt was never a problem, but Sharapova's was.

Not considered elegantViewed in cold light of the day, Steffi Graf was as icy ruthless on the court, as they come. But Sharapova copped crinkled noses for her max pro-no-nonsense poker face, the purposeful tiny stomps, the pre-serve habit of walking right back to the boards, turning around and returning to baseline with clenched fists, wasn't to everyone's liking, if they craved cliched elegance. Yet she played each point as if it were her last. The double faults brought out the groans, but there was grudging respect for the pinpoint groundstrokes even as Tennis.com picks the backhand dropshot as immensely likeable. The business forays Topping the Forbes list for the richest woman athlete for 9 years till 2016, Sharapova was pinned as a glamour diva, often forgetting she won each of the Grand Slams atleast once, one of only 10 women in tennis history. She was first Russian woman to reach No. 1 where she spent 21 weeks and won 36 titles. Her 2013 foray into chocolates, candies, gummies and gumbears through the Sugarpova brand was rightly criticised for being unhealthy. It came at a time when she was battling a terrible right shoulder injury, but the business venture for promoting sugar will remain controversial. She did study management and leadership at Harvard in that time, Marca sports reports



Sharapova's doping banSharapova's career was blighted in 2016, after she was suspended after testing positive for meldonium. She contended she had been using it for a decade for a family history of heart conditions and diabetes, but wasn't aware it was banned that January. Its performance-enhancing effects have been debated, but the 15 month ban effectively ended her career, and cast shadow on her performance, even when the drug was legal. What's memorable is the press conference she addressed at a downtown hotel to speak of the doping ban. Speculation raged around whether she was retiring, but in her own spunky defiant style, Sharapova would point to the beat-up worn out carpet and ask the journalists if they thought she would end her career in a room with a decidedly unattractive carpet.

Williamson ruled out of final Test against India, may return with England series

Wellington: Kane Williamson will not travel to India for the third Test in Mumbai to ensure he is fit for the upcoming three-Test series against England, the New Zealand Cricket said on Tuesday. Williamson has been battling a groin complaint he picked up against Sri Lanka last month and hasn't featured for the BlackCaps through their drought-breaking victories in the opening two matches of the series against India. "A cautious approach will instead be taken which will see Williamson continue his groin injury rehabilitation in New Zealand ahead of the first England Test starting at Hagley Oval on November 28," it said in a statement. Head coach Gary Stead said Williamson had made good progress, but the cautious approach would give him time to be fully fit for the England series. "Kane continues to show good signs, but isn't quite ready to jump on a plane and join us. While things are looking promising, we think the best course of action is for him to stay in New Zealand and focus on the final part of his rehabilitation so he'll be good to go for England," said Stead. "The England series is still a month away so taking the cautious approach now will ensure he is ready for the first Test in Christchurch," he added. The wins over India have boosted New Zealand's hopes of reaching next year's ICC World Test Championship
