ister of Maharashtra on Thursday along with two deputy chief ministers, Shiv Sena's Eknath Shinde and Nationalist Congress Party's (NCP's) Ajit Pawar, at a grand event held at Azad Maidan in Mumbai.

The swearing-in ceremony took place in the presence of Prime Minister Narendra Modi, Union Home Minister Amit Shah and several chief ministers, deputy chief ministers and Union ministers representing the BJP and its alliance partners in the National Democratic Alliance (NDA). Despite the Mahayuti getting an absolute majority of 230 seats out of 288 in the Assembly polls, the oath of office was only administered to the chief minister and two deputy chief ministers. In a sign that discussions over portfolios were still on, no candidate from the three parties that constitute the coalition government – the BJP, Shiv Sena and NCP – was sworn in on Thursday.

The Maharashtra Cabinet can have a maximum of 43 ministers, including the chief minister, as per rules. Fadnavis, who was elected as the state BJP legislative party leader at the meeting on Wednesday, took charge as the chief minister for the third time. In 2014, Fadnavis was handpicked by Prime Minister Modi for the post after he led the party to its highest victory of 122 seats and completed five years at the helm. Five years later, in 2019, Fadnavis took oath as chief minister along with Ajit Pawar as deputy chief minister. But the government lasted for barely 72 hours. Shinde's decision to take charge as the deputy chief minister came at the eleventh hour just minutes before Shah landed in Mumbai. Shinde, who was the chief minister from 2022 to 2024, had made his displeasure known after being denied the post last week.

President Droupadi Murmu emphasies on adoption of natural farming methods

President Droupadi Murmu on Thursday stressed on the adoption of natural farming methods to mitigate the negative impacts of excessive use of fertilisers and pesticides. Speaking at the 40th convocation ceremony of Odisha University of Agriculture and Technology (OUAT), President Murmu said: "Excessive use of fertilizers and pesticides have posed a new challenge to our agriculture sector. Everyone is concerned over the negative impacts this has on the soil, water and environment. Keeping in view the present situation, we have to give emphasis on adoption of natural farming methods, promotion of indigenous technical knowledge, and appropriate use of locally available natural resources."The President also added that it is impossible to achieve all-round development of the country without development of the agriculture sector and farmers. Murmu said that she is of the firm belief that the economy of the country can be strengthened through the development of agriculture, fisheries and animal husbandry sector. She said that culture and agriculture are among the several distinguishing features of India. Murmu further added that it is rightly said about India that 'Agriculture is Culture is our culture'. "For the last couple of decades, our country has achieved unprecedented success in the sector of agricultural production. Once, we were dependent on other countries for food items, but now we are exporting food items and other agricultural products to different countries. It became possible only because of the guidance of our agricultural scientists and the untiring labour by our farmers," President Murmu said.

ISRO PSLV-C59 successfully launched with European Space Agency's Proba-3 satellites

After being rescheduled for a day due to an anomaly detected, the Indian Space Research Organisation (ISRO) on Thursday successfully launched the European Space Agency's (ESA) Proba-3 mission aboard the Polar Satellite Launch Vehicle (PSLV)-C59 rocket. The vehicle took off with a powerful roar, precisely at 4.04 p.m. from the first launch pad at the Satish Dhawan Space Centre, Sriharikota, the home to several rocket launches in India. "The PSLV-C59/ PROBA-3 mission is successfully accomplished. The spacecraft has been placed in the right orbit," ISRO Chairman S. Somanath said. ISRO said the mission had successfully achieved its launch objectives, deploying ESA's satellites into

their designated orbit with



precision.

Josef Aschbacher, Director General of the ESA, said: "The latest member of ESA's family of in-orbit demonstration missions, Proba-3 comprises two spacecraft launched together which, once safely in orbit, will separate to begin performing precise formation flying... Almost instantaneously after separation, Yatharagga station in Australia started to receive the spacecraft's signal. Telemetry is flowing to ESA's mission control cenin Belgium,"

added.Artificial eclipsesThe ESA on its site mentioned: "A pair of spacecraft were launched together today from India with the potential to change the nature of future space missions. ESA's twin Proba-3 platforms will perform precise formation flying down to a single millimetre, as if they were one single giant spacecraft. To demonstrate their degree of control, the pair will produce artificial solar eclipses in orbit, giving prolonged views of the Sun's ghostly surrounding atmosphere, the corona.'

satellites separated from their upper stage about 18 minutes after launch. The pair will remain attached together while initial commissioning takes place, overseen from mission control at the European Space Security and Education Centre, in sion manager Damien Galano said, "Today's liftoff has been something all of us in ESA's Proba-3 team and our industrial and scientific partners have been looking forward to for a long time. Details shared by the ESA show that if Proba-3's initial commissioning phase goes to plan then the spacecraft pair will be separated early in the new year to begin their individual check-outs. Congress demands BJP MP Nishikant Dubey's apology for remarks targeting Rahul Gandhi

Hitting out at BJP MP Nishikant Dubey for drawing linkages between a foreign investor and Leader of Opposition Rahul Gandhi, the Congress on Thursday (December 5, 2024) said "agents of Adani" have been given only one task of defaming and abusing those who expose the conglomerate's "mega corruption".Lok Sabha proceedings were adjourned twice on Thursday (December 5) following certain remarks made by Mr. Dubey, who drew some linkages between a foreign investor and a section of opposition leaders and claimed an international conspiracy was afoot to derail India's success story under Prime Minister Narendra Modi. Congress MPs protested on the steps of the Makar Dwar in Parliament and raised slogans against the use of "derogatory language" against Rahul Gandhi. Congress general secretary, in-charge organisation K.C. Venugopal, said, "Most unfortunate incident happened in Lok Sabha when the entire Opposition was raising the issue of travel ban on the leader of Opposition to Sambhal, the Speaker allowed Dubey to speak in Zero Hour and he used the most defamatory words against the LoP, Wayanad MP and the entire Congress party.""This type of derogatory remarks have never been used. We are totally pained. Before that the Speaker was talking about customs and conventions of the Lok Sabha and was giving advice on how to deal with matters and how to come to the House. The speaker also allowed Dubey to speak," Mr. Venugopal said."From the day Rahul Gandhi stood against the corruption of Adani, agents of Adani started to abuse Rahul Gandhi. Come what may, Rahul Gandhi would keep raising these allegations," the Congress leader said.

In a post on X, Mr. Venugopal said "agents of Adani" have been given only one task - to defame and abuse those who expose their "mega corruption". "We do not tolerate the objectionable words used against LoP Rahul Gandhi ji by adani agent Nishikant Dubey on the floor of the House," he said. Congress' deputy leader in the Lok Sabha Gaurav Gogoi said whenever Rahul Gandhi speaks against Adani, the "sleeper cells of Adani" in Parliament get activated. "We have spoken with the Speaker and it is our demand that the person should take back his words, apologise and the Speaker takes strong step on it," Mr. Gogoi said.Mr. Dubey's remarks targeting Rahul Gandhi and seeking to link him to a U.S.-based multi-billionaire, triggered an uproar in the Lok Sabha, leading to adjournment of proceedings. Raising the issue during Zero Hour, Mr. Dubey claimed that the Congress-led Opposition had tried to derail Parliament proceedings based on reports in a French publication which had alleged links to the billionaire investor. He alleged the U.S.based investor, investigative media platform Organised Crime and Corruption Reporting Project (OCCRP) and the Congress were trying to derail India's success story under the leadership of Prime Minister Modi.Mr. Dubey said the Congress had sought to derail Parliament on various issues published by OCCRP, including the Pegasus spying row, questioning the efficacy of vaccines against COVID-19 developed in India and the Hindenburg reports. Mr. Dubey said several Opposition leaders raised the issues flagged in media reports, many of which were published on the eve of Parliament sessions in India. Congress members were up on their feet protesting against Dubey as he tried to put questions to Rahul Gandhi and Priyanka Vadra. Earlier.

Sri Lankan Navy arrests 14 Indian fishermen from Tamil Nadu; 2 trawlers impounded

The Sri Lankan Navy arrested 14 fishermen from Thangachimadam and Rameswaram in Ramanathapuram district of Tamil Nadu while they were fishing in the Palk Bay. According to reports, over 425 boats received tokens from the Fisheries Department on Tuesday (December 3, 2024), and several fishermen ventured into the sea from Rameswaram jetty. Fourteen fishermen in two boats, owned by Michael Raj and Nijo of Thangachimadam, were fishing somewhere near Neduntheevu islet at around 2 a.m. They were set to return to the shores by 6 a.m., but the Sri Lankan Navy personnel on surveillance arrested them claiming they crossed the International Maritime Boundary Line (IMBL). Fisheries Department officials said the arrested fishermen and the two trawlers were taken to the Sri Lankan Navy Port at Mannar. As the news of the arrest reached the fisherfolk in Ramanathapuram, fishermen leader Sesu Raja

Sewadar Sukhbir

A rap on the knuckles — that's what the Sikh clergy as given to Sukhbir Singh Badal and other Shiromani Akali Dal (SAD) leaders for the 'sins' committed by their overnment in Punjab from 2007 to 2017. The token punshment — washing dishes and cleaning shoes as well as vashrooms at the Golden Temple — has been awarded nearly three months after the former Deputy CM was delared 'tankhaiya' (guilty of religious misconduct) by the Akal Takht. The five high priests have stopped short of aking drastic action, such as excommunication, despite he gravity of the misdeeds that Sukhbir and the others are accused of. Making them perform 'sewa' as atonenent may not be enough to pacify the Panth, which coninues to be angry with the Badals and the SAD over the umultuous events of 2015.While Sukhbir has been granted an opportunity to revive his political fortunes, the withdrawal of the Panth Rattan Fakhr-e-Quam title — bestowed on hen CM Parkash Singh Badal by the Akal Takht in 2011 - is a setback to the Badal family. With this extreme step he clergy has done what it failed to do when the senior Badal was alive. The high priests have also asserted their authority by directing the SAD working committee to acept Sukhbir's resignation as party chief and form a panel o hold organisational elections. This indicates that the lergy won't desist from intervening in party affairs. Both Sukhbir and his party are desperate to shed their ignoninious baggage — the failure to punish the perpetrators of the sacrilege incidents and the pardon granted (later evoked) to Sirsa dera chief Gurmeet Ram Rahim in a plasphemy case. The SAD wants the Panth, its traditional vote bank, to forgive and forget. Admission to master's in architecture in Maharashtra will now be based on national level entrance test PGETA

architectureAccording to the circular issued last week on the Maharashtra Common Entrance Test (CET) Cell, the national-level entrance exam PGETA, conducted by the Council of Architecture in New Delhi, was started this academic year (2024-25). The Maharashtra Common Entrance Test (CET) Cell has announced that it will no longer conduct the state-level entrance exam for admission to the Master of Architecture (MArch) course. Instead, MArch admissions in the state will now be based on the Post Graduate Entrance Test in Architecture (PGETA), a national exam, starting from the academic year 2025-26. This is an important development for aspirants seeking admission to the MArch course in Maharashtra starting next academic year. According to the circular issued last week on the Maharashtra Common Entrance Test (CET) Cell, the national-level entrance exam PGETA, conducted by the Council of Architecture in New Delhi, was started this academic

The circular stated that the number of candidates appearing for the state-level MArch entrance test is relatively low, so the CET Cell has decided to consider the PGETA score for MArch admissions in Maharashtra instead of conducting a separate entrance test. Even as the PGETA was introduced this academic year, MArch admissions in the state were conducted based on the traditional practice of a state-level entrance test for the academic year 2024-25. However, the new change will be applicable from the next academic year as the Maharashtra CET Cell has decided to discontinue the state-level M Arch entrance exam.

According to the website of Maharashtra CET Cell, close to 600 seats were available for admission to M Arch in Maharashtra last year. "Instead of conducting a separate entrance test for these candidates, it is convenient to consider their scores from PGETA, a national-level entrance exam, for admissions," said an official from the Maharashtra CET Cell while also emphasising that the move is expected to reduce the burden on aspiring architects. He said, "This also relieves students from appearing for two separate entrance exams. Furthermore, a national-level common entrance exam broadens their opportunities of seeking admissions to the colleges of their choice across the country."


Bomb scare at Taj Mahal, turns out to be hoax

BJP MLA accuses party's Karnataka chief Vijayendra of 'anti-party activities', threatening Dalit legislators

BJP MLA Ramesh Jarkiholi on Tuesday accused party state president B Y Vijayendra of "anti-party activities" and alleged that he was threatening Dalit leaders to support him. Jarkiholi and other members of the faction under MLA Basangouda Patil are currently camping in Delhi and have sought time to meet the party's top brass."As state president, he is the first to do anti-party activities. During the wagf land protest, they (Vijayendra faction) tried to scuttle it," Jarkiholi said. Vijayendra also had an internal understanding with Congress leaders, the former minister alleged. Karnataka BJP is split over the waqf land issue in the state as factions under Vijayendra and Yatnal have held separate protests and campaigns

Hitting out at Vijayendra, Jarkiholi alleged that he was threatening Scheduled Caste and Scheduled Tribe (SC/ST) leaders to back him. Dalit ex-MLAs are called to attend meetings chaired by Vijayendra. "But no sitting or former Lingayat or Vokkaliga MLAs are present as they are not bothered about him... They demand SC/ST MLAs to be present by threatening that they will be denied tickets in the next election or that they will not get benefits from the party,' Jarkiholi said. On the notice issued by the BJP's Central Disciplinary Committee against Yatnal, Jarkiholi said that the party leader would respond to the notice, adding that it was "not that serious. We are working within the bounds of the party." Committee member secretary Om Pathak had issued a notice to Yatnal on December 1, seeking explanation over the legislators' "continuing tirade against the statelevel party leadership."Yatnal is scheduled to meet Pathak on Wednesday, Jarkiholi said, pointing out that Yatnal and other leaders have sought to meet top BJP leaders to raise their concerns regarding the functioning of the state BJP under Vijayendra. The leaders in Delhi, including former MLAs Kumar Bangarappa and Arvind Limbavali, met during the day. The faction maintained that they were in the capital to brief the Joint Parliamentary Committee on The Waqf Amendment Bill, 2024 about the findings of their campaign against Waqf. Meanwhile, the core committee of the state BJP held a meeting in Bengaluru under national general secretary Tarun Chugh. Speaking to reporters after the meeting, Vijayendra said its agenda was restricted to the membership campaign being carried out by the BJP.

'Nation's harmony not so fragile': Delhi HC grants interim protection to activist Nadeem Khan

Underscoring that the nation's harmony was not so fragile, the Delhi High Court on Tuesday granted protection from arrest till December 6 to activist Nadeem Khan in an alleged case of promoting enmity. Justice Jasmeet Singh orally remarked that the nation's harmony was not "fragile" and "faith" should be reposed in the intelligence of the common man. "We are in a democratic country. The harmony of the nation is not so fragile. Common man isn't so fragile that merely one exhibition will shake his conviction," said Justice Singh.

The judge went on, "The country places great pride in our fundamental rights. Article 19(1)(a) is to be protected. If

you think the common man will get incited by this, the common man does not have the IQ to understand what is right for them.. please have some faith in the common man." Senior advocate Kapil Sibal appeared for Khan and argued that the FIR was malafide. He said the FIR did not disclose any cognisable offence and was merely based on conjectures, without any foundation. The counsel for the police alleged that the petitioner was "trying to raise a war inside the country" and he should have filed an anticipatory bail plea if he wanted protection from arrest. The judge subsequently issued notice to the Delhi police on Khan's petition seeking to quash the FIR registered on November 30 and asked him to join the investigation and not leave the national capital without the permission of the investigating officer. "The FIR is based on the opinion of the complainant. The material which formed the basis of the opinion has not been placed before me and will be placed along with the reply proposed to be filed by the respondent along with the material collected till date. For the said reason and till the next date of hearing, the petitioner shall not be arrested," the court ordered, posting the hearing on December 6The police registered the FIR against Khan over a "viral video" that was purportedly causing enmity and could have led to violence at any time. The court, however, said the right to freedom of speech and expression under Article 19(1)(a) of the Constitution had to be "protected" and directed the investigating

'Be discreet, avoid tilak and saffron in public... lives are at risk': ISKCON Kolkata vice president's advice to devotees in Bangladesh

As ISKCON alleged that lawyers in Bangladesh representing Hindu monk Chinmoy Krishna Das were assaulted, ISKCON Kolkata vice president and spokesperson Radharamn Das on Tuesday urged devotees and monks in the neighbouring country to be discreet and not wear tilak or saffron garb in public. "We are getting so many phone calls from monks and devotees in Bangladesh regarding incidents of assaults on them on the streets after they are identified by their tilak and saffron. So, I have personally advised devotees and monks to be discreet. They should avoid saffron and tilak in public. They should hide their tulsi beads and cover their heads. This is so that they are not identified," Radharamn Das told The Indian Express. "Their lives are at risk in Bangladesh. They should practice (religious activities) discreetly at home and inside centres. It is a question of their lives now," he said. Protests have broken out in West Bengal and other parts of India over the arrest last month of ISKCON monk Chinmoy Krishna Das in Dhaka. Das, who was accused of treason, had been leading protests in Bangladesh against alleged atrocities on minorities in the country.

On Tuesday, he was brought to a court in Chattogram for bail hearing, but none of his lawyers were present, leading to the hearing being postponed to January 2.ISKCON alleged that lawyers representing Das had been assaulted, and that one of them is in ICU in critical condition. Houses and chambers of lawyers defending Das were also ransacked by miscreants, it has been alleged.Leader of the Opposition in West Bengal, Nandigram BJP MLA Suvendu Adhikari, has called on international human rights groups to intervene in Bangladesh. "Fundamentalists ransacked houses and assaulted lawyers defending the monk, Chinmoy Krishna Das... They are worse than Taliban and ISIS... On the other hand, police have slapped cases against Hindu lawyers who defended him in court," said Adhikari.

"None of the 51 lawyers who defended him (in court on November 26) could appear in court today. I appeal to all international human rights organisations to intervene in Bangladesh. The situation is only getting worse. There are no human rights for minorities in Bangladesh... I appeal to ISKCON for a strong reaction internationally," he said.ISKCON's Radharamn Das appealed to the Bangladesh government to provide protection to the lawyers. "We had feared this would happen. Now, in an atmosphere of fear, how will advocates, who are assaulted and their homes ransacked, appear in court? Cases are slapped against them, too. We appeal to the Bangladesh government to provide protection to lawyers defending him. In a democratic country, it is shocking to see lawyers could not appear for their clients, fearing for their own lives," he said. Apart from Das, ISKCON has alleged that two more monks, including Das's assistant, were also arrested. Besides, 63 monks with valid visas were stopped by Bangladesh authorities at the border and not allowed to enter India, the organisation said.

12-year-old boy dies at school in Delhi's Vasant Vihar, probe launched

The Delhi Police have launched an investigation after a 12-year-old boy died at a Vasant Vihar school on Tuesday morning. A statement from the school indicated that the student collapsed after a "scuffle". Officials said the Class 6 student was rushed to Fortis Hospital where he was declared dead around 10.15 am. According to investigators, the doctors think the child may have suffered a seizure. Deputy Commissioner of Police (South West) Surendra Choudhary said the boy had no visible injury on his body. "Some foam-like material was oozing out of his mouth... Inquest proceedings are being done. School boys and teachers are being examined and necessary legal ac-

tion will be taken," he added. The statement from the school principal said they were "deeply saddened" over the "tragic incident that occurred on (the school) premises during a class transition" while extending "its heartfelt condolences and support to the bereaved family." It added, "A scuffle between two Class 6 students of similar age has resulted in the unfortunate collapse of one student. The school administration has taken prompt action, informed the authorities and is extending full cooperation to all concerned." The police said the post-mortem will likely be conducted on Wednesday to determine whether the child had any internal injury. Officials are also examining CCTV footage from the school to rule out the possibility of foul play.

26-year-old IPS officer dies in Karnataka road accident, probe finds police jeep's airbags didn't open

The investigation into the road accident where a 26-year-old probationary IPS officer, Harsh Bardhan, died in Karnataka's Hassan district has revealed that the police jeep he was travelling in did have airbags but they did not open when the vehicle overturned.

Harsh Bardhan, a Karnataka-cadre IPS officer from Madhya Pradesh, died after the police jeep toppled multiple times before crashing onto a coconut tree around 4 pm on Sunday on the Holenarasipura-Hassan road.Constable Manjegowda was driving the jeep while Harsh Bardhan was sitting next to him in the front seat. Bardhan succumbed to the injuries four hours after the incident. On Monday, the body was handed over to his family members after a postmortem.

A police officer said the vehicle bearing the registration number KA-13G 1386 is a 2020-model jeep and that it did have airbags for both front seats. However, when the jeep toppled they failed to open. Experts say the airbags open when a crash happens in a certain way. "A report will be submitted soon. On top of it, we have found that the jeep probably was speeding at 70-80 km/hr but we are ascertaining why the jeep drifted towards the left side of the road. Both occupants were wearing seatbelts. There was no tyre burst that could have led to the incident," the officer added. Hassan MP Shreyas Patel said he would take up the issue to ensure the quality and safety of police vehicles.

It can be recalled that former Tata Sons chairperson Cyrus Mistry died in a road accident in September 2022 when the Mercedes he was travelling in hit a concrete barricade. Though there were seven airbags, none of them opened. Investigations revealed that Mistry was not wearing a seatbelt when the incident took place. Dr Abdul Basheer V K, president of Janapriya Hospital, said that Harsh Bardhan was in a bad state when he was brought to the hospital. "We tried our best to save Harsh Bardhan but the injury was severe. A lot of doctors from other parts of the country reached out to me to suggest the treatment. He died because of diffuse axonal damage." Diffuse axonal damage is when the brain shifts or rotates inside the skull, causing the nerve fibres (axons) to tear. The police have booked a case after Rohith Kumar H, a villager who witnessed the incident, filed a complaint. They have booked the driver of the jeep, Manjegowda, under sections 281 (rash driving), 125 (a) (endangering life or personal safety of others by causing hurt) and 125 (b) (endangering life or personal safety of others by causing grievous hurt) of the Bharatiya Nyaya Sanhita (BNS). He is undergoing treatment.It was like a movie scene: eyewitness

Local villagers who witnessed the accident said the jeep was speeding and hit a coconut tree, preventing it from falling into a house.Santosh, a youth from Kittanegadi village, said he was with his friends Puneeth and Rohith when the incident took place. "It all happened in a few seconds. The police jeep that was heading rightwards suddenly drifted towards left and hit cement pillars (barricades) and toppled for nearly three or four times for 40 metres before hitting the coconut tree," he said. Santosh said he, along with his friends and other villagers, rushed to the spot. "We dragged both occupants. We called an ambulance and also informed the police. At that point, we did not know that it was an IPS officer but he was severely injured on his head," he added.antosh also said the tragedy could have worsened if it was a working day. "The coconut tree that the jeep hit is near a bus stop and there would be some villagers and children usually at 4 pm. As it was a Sunday, there were none at the place," he said.

State-run UP hospital ousts cardiologist after he 'failed to show up' following bail in corruption case

The Uttar Pradesh University of Medical Sciences (UPUMS) in Saifai (Etawah) has terminated the services of 43-year-old cardiologist Dr Sameer Saraf who was previously suspended over allegations of financial irregularities and corruption. Dr Saraf, who was recently released from jail, previously served as the Head of the Department of Cardiology. In 2023, the Etawah police arrested Saraf in the case. He got bail in January this year and had not joined office since then.

"The university's Executive Council decided to terminate his services as Dr Sameer Saraf failed to join the Department of Pharmacy, where he was attached following his suspension, despite repeated reminders," said registrar Dr. Chandraveer Singh.

Dr Sameer was put under suspension after he was arrested. As per Singh, in 2022, an FIR was registered against Saraf over allegations of financial irregularities and corruption, including unnecessary arbitrage, pacemaker fraud, and unauthorised foreign trips.

The case was filed by Dr Adesh Kumar — the then chief medical superintendent — based on a report by a five-member committee, which reportedly found that Dr. Saraf had approved unnecessary purchases worth nearly Rs 1 crore, despite "sufficient" stock for nearly a year being available at the university. A detailed probe report submitted by the inquiry officer to the disciplinary authority reportedly found Dr Saraf "guilty" of these charges. The report also alleged that Dr Saraf defrauded numerous patients under the Ayushman Bharat Yojana by charging inflated prices for incorrectly placed pacemakers. Additionally, it accused him and his family of undertaking unauthorised foreign trips funded by private companies whose consumables and pacemakers he allegedly favoured.

In Maharashtra village, winning candidate and some residents plan repoll using ballot papers, backtrack after police step in

A plan to "hold re-election using ballot papers" in Markadwadi village of Maharashtra's Malshiras assembly constituency – to "verify" polling done through EVMs – was cancelled after the police warned of action citing orders of the administration. The "polling" was to start at 8 am, but the police issued prohibitory orders to prevent people from gathering. Elected NCP (SP) candidate Uttamrao Jankar, who

led the call for re-polling, claimed the plan was cancelled following police pressure. The village is considered Jankar's stronghold. In the November 20 state polls, the results of which were declared on November 2, Jankar defeated sitting BJP legislator Ram Satpute by 13,147 votes.

Jankar won the seat, but Markadwadi residents claimed he polled fewer votes in their village against Satpute, which was implausible. Jankar got 843 votes, while BJP candidate Satpute got 1,003 votes in the village. After the administration raised objections about the re-polling, heavy police deployment was arranged in the village. Some villagers printed ballot papers with the names of all candidates and party symbols in the same sequence as they appeared on EVMs. Five "booths" were prepared, and electoral rolls were kept ready. "The police were visiting every house in the village, warning them of action if they participated in repolling. A few people had come out, but many preferred to stay home fearing police action," he claimed, citing this as the reason re-polling was cancelled. The newly elected NCP (SP) legislator said they would continue their protest by other means. "We will take this issue up with the Election Commission and the judiciary," he said.

"My Mother Pramila Joshai, Actress/ Producer Is NOT part of any committee which has been formed recently. She is currently the Vice president (producer sector) of Karnataka Film Chamber of Commerce. Using her name without her consent in relation to committees which are still under discussion is not Fair and will not be taken lightly but us," she said in an Instagram post.

The most important thing is the safety of yourself and your family," he wrote on X.

***CBI officer Ravi Kumar speaking*: Elderly Pune doctor duped of Rs 28 lakh with threats of Supreme Court, ED notices**

A 76-year-old doctor from Pimpri Chinchwad was allegedly duped of Rs 28 lakh by cyber criminals, one of them posing as a CBI officer, who threatened to arrest him in a credit card fraud case. The fraudsters told him that the Supreme Court and Enforcement Directorate (ED) had also issued notices against him. According to the septuagenarian, he received a WhatsApp call on November 28 while examining patients and the caller, a 'CBI officer' who identified himself as Ravi Kumar, warned the doctor that he was under surveillance and "digital arrest".

The caller said that the doctor's name was flagged in a credit card fraud as he had received a Rs 20 lakh commission on a transaction of Rs 1 crore. "The caller told him that if the he did not pay Rs 20 lakh, an arrest warrant will be issued against him. Though the complainant denied any involvement in any such case, he was told that two notices — one from the Supreme Court and another from ED had been issued against him. The fraudster posing as a CBI officer told him that since he was a senior citizen and a doctor, senior lawyers of the Supreme Court will help and he will have to take actions as instructed," said an officer. The 'CBI officer' then connected the call with a fraudster posing as 'Supreme court lawyer' who sought all financial and personal information from the complainant on the pretext of getting his case details, said the police. The complainant was later told that as he was being placed under surveillance and 'digital arrest' he was prohibited from discussing the case with anyone or even talking to anyone, the police said. The doctor was asked to answer a call every two hour and give updates.

"The next day he again received a call and was asked to deposit Rs 28 lakh to particular accounts saying it was for clearing his name from the case. The complainant was instructed to go to the bank keeping his phone on and then transfer Rs 28 lakh to two separate accounts. The complainant did so as instructed and told the caller he had made the transfer," the police said adding that the doctor realised that he was cheated after his son got to know about the developments.

ED raids multiple private medical colleges in West Bengal

1. Harjinder Singh Dhami

Harjinder Singh Dhami, 68, is the 30th president of the Shiromani Gurdwara Parbandhak Committee (SGPC) and has been at the helm since November 29, 2021. The SGPC is an organisation of Sikhs responsible for the management of gurdwaras in Punjab, Himachal Pradesh and Chandigarh. Dhami has been an elected member of the SGPC from Sham Chaurasi in Punjab's Hoshiarpur district since 1996.

2. Iqbal Singh Jhundan

Iqbal Singh Jhundan, 62, is a two-time former SAD MLA who is a part of the party's core committee. In April 2022, it was a committee under Jhundan's leadership that had conducted a survey in 100 constituencies in Punjab and suggested a change in party leadership. Several rebel leaders have been demanding the implementation of the Jhundan committee report but to no avail. Jhundan was an MLA from Dhuri constituency in Sangrur district from 2007-2012. From 2012-2017, he served as an MLA from Amargarh constituency in Malerkotla district. In 2017 and 2022, he contested elections from Amargarh but lost. In 2024, he contested from the Sangrur Lok Sabha seat but lost his security deposit, finishing fifth.

3. Manpreet Singh Ayali

Manpreet Singh Ayali, 49, is the sitting SAD MLA from Dakha constituency in Ludhiana district. In 2022, he was the lone SAD MLA to win from Malwa Punjab despite a huge wave in the Aam Aadmi Party's favour. An agriculturist and a realtor, Ayali won his first election in 2012 from Dakha by defeating Congress's Jasbir Singh Khangura. In 2017, he lost to AAP's Harvinder Singh Phoolka from the same seat. However, Phoolka resigned in 2019, necessitating a bypoll that Ayali won, defeating Congress's Captain Sandeep Sandhu by over 15,000 votes. In 2022, he defeated Sandhu again. Known for speaking his mind, Ayali was a part of the Jhundan committee and has been advocating its implementation for a long time. In protest, he had been skipping party meetings. He had hit the headlines in July 2022 when he ignored the party decision to vote for the NDA-backed then president candidate Droupadi Murmu. He had abstained from voting saying that he had listened to his conscience and the Centre had ignored issues related to Sikhs. He has been at loggerheads with the party since.

4. Gurpartap Singh Wadala

Gurpartap Singh Wadala, 61, is a two-time SAD MLA from Nakodar constituency, a seat he won in 2012 and 2017. His father Kuldip Singh Wadala was also an Akali Dal MLA.

It was in July this year that he along with other leaders formed a rebel faction called Akali Dal Sudhar Lehar. Wadala was appointed convenor of the faction. On November 16, when Sukhbir Singh Badal resigned as SAD president, when Sukhbir Singh Badal resigned as SAD president.

Before this, during the SAD-BJP tenure in the state from 2012 to 2017, he had served as chairman of the Punjab Subordinate Services Selection Board, a post he resigned from in November 2016, two months ahead of the 2017 Assembly polls. Umaidpuri had also served as SAD rural president and SAD Ludhiana district president in the past. After SAD's dismal performance in the 2022 elections, he has not been very active politically. In July this year, he became a part of the rebel Sudhar Lehar faction.

6. Satwant Kaur

Satwant Kaur, who is in her early forties, is the daughter of Amrik Singh, the former president of the All India Sikh Students Federation. Amrik was killed on June 6, 1984, in Golden Temple during Operation Blue Star. Satwant is the deputy director of 59 schools being run under the SGPC. Satwant's grandfather Giani Kartar Singh Bhindranwale was the 13th chief of the influential orthodox Sikh group Damdami Taksal. Satwant too is connected with the group.

The Maharashtra State Road Transport Corporation (MSRTC) has clarified that there are no plans to shut down the air-conditioned Shivshahi bus service, dispelling criticism that the luxury buses are plagued by technical issues ever since their launch in 2017. However, soon after the clarification, MSRTC faced backlash as social media users posted pictures and videos highlighting the alleged technical issues in Shivshahi buses. Widespread rumours of closure of bus services arose amidst increasing reports of accidents and the deteriorating condition of Shivshahi luxury buses in various regions of Maharashtra.

A senior official with the Pune division of MSRTC told The Indian Express, "People are spreading false news that Shivshahi buses will be shut down due to technical issues. This is incorrect. We will continue operating the service, and there are no significant technical faults in our buses."The MSRTC that operates 792 Shivshahi bus services in the state posted on X that it has no intention of discontinuing the services and that the buses have no technical fault.

Commuters reacted on the X handle of MSRTC by



sharing pictures of Shivshahi running with technical issues. One user, Suraj Arya, shared a picture of a driver keeping a large stone in the cabin to prevent gear malfunctions. "What is this then? The driver is driving with a big stone in the cabin. I took this photo myself, showing the stone near the gear! The driver even drives with the cabin door open. What is the use of AC? Shivshahi buses are forced to turn off the AC," he wrote. Another user, Mohammad Afzal, posted a video allegedly showing a Shivshahi bus experiencing brake failure while carrying passengers.

Tamil Nadu's Villupuram reels under unprecedented flooding

Chennai: Villupuram continues to reel under unprecedented flooding, while the depression, the remnant of cyclonic storm Fengal over north coastal Tamil Nadu and Puducherry, weakened into a Well Marked Low Pressure Area on Monday, the India Meteorological Department said. Villupuram town, nearby towns and villages, have borne the brunt of the rain fury and raging flood water gushed to-

wards low-lying areas. With water rising above the danger level on an arterial bridge between Vikravandi and Mundiyampakkam in Villupuram, Southern Railway on Monday morning announced suspension of operations in that key stretch, leading to cancellations, diversion and short termination of services, which includes express and superfast trains.

'Urgent action needed against open waste burning cases in Pune': Report submitted to PMC

pune open waste burning caseThe survey that was part of the report prepared by the Pune Air Action Hub and recently submitted to the Pune Municipal Corporation showed that there has also been a considerable delay in response to waste burning complaints. As winter has set in, waste burning has become rampant in most areas of Pune city, with a survey report suggesting lack of awareness among public on complaint mechanisms. The survey that was part of the report prepared by the Pune Air Action Hub and recently submitted to the Pune Municipal Corporation showed that there has also been a considerable delay in response to waste burning complaints. The report, that identified chronic burning spots, highlighted the increasing menace of open waste burning contributing to air pollution and subsequent health risks. "We need a dedicated force to address waste burning," said Shweta Vernekar of the Pune Air Action Hub.The findings and recommendations have also been shared with the Maharashtra Pollution Control Board (MPCB)

"Even so, citizens seem unaware of the complaint mechanisms, pointing to the need for awareness about the same. An independent analysis of complaints lodged showed delay in response to waste burning complaints and other gaps in the process," Hub members have also said in their letter to Prithiviraj B P, Additional Municipal Commissioner (General), Pune Municipal Corporation. The report relied on two main sources of information: a ward-level citi-

zen survey to capture the incidence of waste burning (292 citizens were surveyed across 15 wards) and a recent analysis of complaints about waste burning.

In the citizen survey, 75 per cent said that they have observed chronic burning spots in their area, and 33 per cent said they experience waste burning everyday. Another 42 per cent said they observe waste burning 1-2 times a week. In the citizen survey, 55 citizens out of 292 said that they had lodged complaints for waste burning in their ward. In the complaints analysis, over 75 per cent of complaints were marked resolved after more than two days from the date of complaint being lodged. Surprisingly, no fine was imposed on any of the 59 complaints analysed. On checking the status of complaints from the token numbers, it was observed that often the complaints were forwarded multiple times before they reached the correct authority, wherein time was lost

Hub member Pushkar Kulkarni said that a recent National Green Tribunal (NGT) judgment mandated PMC to put monthly reports of waste burning cases and measures taken on their website. "Even after 6 months, this has not been done. Information about mobile squads which are supposed to provide timely response to waste burning complaints, is also not readily available. It is often found that burning happens in the evenings and throughout the night at some chronic spots so there is a need for effective night time vigilance and response systems" Kulkarni said. Vernekar said that during the survey it was found that certain wards like Hadapsar Mundhwa, Aundh Baner and Wanowrie Ramtekdi showed more cases of burning. However, an important inference was that hardly 20 per cent of residents who observed waste burning have never complained about it. "There is definitely a need to let citizens know what action they can take when burning happens, which is a punishable criminal offence to do so," she said. Among key recommendations, include setting up a dedicated 24×7 complaint number for waste burning, dedicated response squads for immediate action after complaints are lodged, review of the line of action of complaints lodged, to find out where the gaps exist, to speed up response and enforcement/action on waste burning cases

Bunny chow misal or pizza misal for lunch? This restaurant fought pandemic and trolls to innovate with Maharashtra's much-loved dish

In South Africa, a unique dish called bunny chow holds a special place in the local cuisine. This dish consists of a loaf of hollowed-out white bread filled with curry, which can be made with either meat or vegetables. The origins of bunny chow, a topic of interest for passionate foodies, trace back to the migration of labourers from India to the sugarcane fields of South Africa. Craftspeople and other artisans also undertook the passage to South Africa. How would these workers carry their food or eat in jobs that left them with only time to grab a bite? The solution was to transport sabji in bread. The name bunny chow is said to be inspired by the word "bania", an entrepreneurial community in India.

This dish, made of scooped-out loaves stuffed with curry, has made its own journey up the culinary ladder to become a must-try in South African cities, especially Durban. One can eat it in Pune as well—in yet another innovative form called bunny chow misal at Bappa's Misal on Tilak Road.

Vivek Kulkarni, the founder of the eight-seater Bappa's Misal, is a serial restauranteur with a penchant for quirky ideas. One of his previous spaces was called Cafe Gossip in Vadgaon. Bappa's Misal started in Dattawadi and had a branch in Karve Nagar before the Covid lockdown forced Kulkarni to down shutters. In low spirits and suffering from Covid, he decided to fight on with the support of his family. "I was experimenting with misal, a traditional food in Pune, Kolhapur, Solapur and other parts of this region. South Africa's bunny chow turned out to be so delicious with sprouts that I made it the mainstay of my restaurant when I relaunched after the first lockdown. The misal made the dish healthier," says Kulkarni. Many said I was ruining Maharashtra's food culture Bappa's Misal is known for its unique experiments, offering items like pizza misal, which

has become a favourite among children and women. Then, there is a pahalwan vada, Kulkarni's answer to the traditional vada for health buffs. Pahalwan vada is not made of besan but differenttypes of dal and has a crispy coating.

"In the initial days, we did not know the market's response as there were a lot of restrictions on movement. I could barely afford to pay the cook. I survived because there was support from home," he says. People who were coming to the new restaurant enjoyed the dishes."I felt that this idea would work out. I fought out the pandemic," he says. Kulkarni says that foreign dishes like burgers and pizzas are hot sellers at restaurants, while the traditional vada pav and misal do not seem cool enough. Urged Bangladesh monks, devotees to practice faith discreetly: ISKCON Kolkata spokesperson



ISKCON Kolkata spokesperson Radharamn Das on Tuesday said he has urged its monks and followers from Bangladesh to avoid wearing saffron robes and 'tilak' in public, advising them to practice their faith discreetly amid safety concerns following targeted attacks against Hindu minorities in the neighbouring country. This suggestion comes in the wake of escalating violence against the Hindu community in Bangladesh after the fall of the Sheikh Hasina government earlier this year, which has heightened anxieties among devotees and their families. "The situation in Bangladesh is alarming. The monks and devotees, who have been calling us, we have told them to hide their identity as ISKCON followers or monks publicly. We have asked

them to practice their faith discreetly inside homes or inside the temples. We have advised them to dress in a manner that does not draw attention," Das, who is also ISKCON Kolkata vice-president, told PTI.He emphasised that the measure was temporary and aimed solely at ensuring their safety.

"This is not any advisory or generic guideline but my personal suggestion to monks and devotees who have been calling us frantically over the last few days," he said. "Many of our devotees and their families are facing threats and intimidation," Das added, referring to incidents of vandalism of temples and attacks on religious gatherings. Death of Unnao rape victim's father: Delhi HC seeks CBI reply on Kuldeep Sengar's plea

The Delhi High Court on Tuesday asked the CBI to respond to expelled BJP leader Kuldeep Singh Sengar's plea seeking suspension on medical grounds of the 10-year jail term awarded to him for the custodial death of the Unnao rape victim's father. The high court also asked jail authorities to file a report on Sengar's medical condition and listed the plea for further hearing on January 13 next year. "Issue notice limited only to medical grounds," Justice Manoj Kumar Ohri said. The court was informed by the CBI's counsel that the high court had in June this year refused to suspend Sengar's sentence during the pendency of his appeal against conviction.

The counsel for Sengar submitted that he was seeking suspension of sentence on medical grounds as his health was deteriorating and it was a medical emergency. He added that Sengar's appeal challenging the trial court's conviction and sentencing order has not been heard for a long time and he has been in jail for the last eight years, while the maximum punishment awarded to him was 10 years in the case. Sengar has already been convicted of raping the minor daughter of the deceased man and sentenced to imprisonment for the remainder of his life in that case. Sengar's appeal challenging the trial court's verdict in the main Unnao rape case is already pending in the high court.

He has sought quashing of the December 16, 2019, judgment of the trial court, which convicted him in the rape case. Sengar has also sought to set aside the December 20, 2019, order sentencing him to imprisonment for the remainder of his life. The girl was kidnapped and raped by Sengar in 2017 when she was a minor.



On March 13, 2020, Sengar was sentenced by the trial court to 10 years of rigorous imprisonment, besides a fine of Rs 10 lakh, in the case of the death of the rape victim's father in custody. The trial court had said "no leniency" can be shown for killing a family's "sole bread earner". It had also awarded a 10-year jail term to Sengar's brother Atul Singh Sengar and five other people for their role in the custodial killing of the father of the rape victim. The girl's father was arrested at the behest of Sengar under the Arms Act and died in custody on April 9, 2018, owing to police brutality. The trial court, which did not hold the accused guilty of murder under the IPC, awarded the maximum sentence for the offence of culpable homicide not amounting to murder to the convicts under section 304 of the IPC after holding that there was no intention to kill. The case was transferred to Delhi from a trial court in Uttar Pradesh on the directions of the Supreme Court on August 1, 2019.

Days after an FIR was registered against 10 to 15 CISF personnel for allegedly assaulting a doctor, his brother, and a friend in a road rage incident in Kharghar on November 29, the central force said it has ordered an inquiry into the incident.

A Non-Cognisable (NC) complaint was also registered against the doctor and two others for allegedly hurling abuses at the CISF personnel and attempting to assault the driver of the bus in which they were being ferried to Navi Mumbai from the Mumbai airport. "An internal inquiry has been initiated to investigate the incident thoroughly. CISF remains committed to ensuring the safety and security of its personnel and the public and will take appropriate action based on the findings of the inquiry," CISF said in a statement Monday. The CISF said the driver of the car overtook the bus and abruptly stopped his vehicle ahead of the bus. It also alleged that the car driver was aggressive, abused the bus driver, and attempted to assault him.

As per the police FIR, the incident took place last Friday at around 10.15 pm when some buses were ferrying



CISF personnel to their quarters in the Kharghar area of Navi Mumbai. While moving towards Sector 36 in Kharghar, a speeding bus came dangerously close to a car between Utsav Chowk and Central Park, an officer said. The car owner, a doctor and also a local functionary of a political party, chased the bus and asked its driver to stop the vehicle, he said. The car owner objected to the bus driver's rash driving, following which an argument broke out. By that time, five to six CISF personnel stepped out of the bus, confronted the doctor and allegedly assaulted him, the doctor alleged in his complaint. He also alleged that some CISF personnel hit his brother and friend and broke the windshield of his car. Later, the doctor lodged a complaint against the CISF personnel at the Kharghar police station. The police also registered an NC complaint against the doctor.

Lebanon asked U.S., France to press Israel to halt truce breaches, say sources



BEIRUT, GNS News Agency, Dec 5, Top Lebanese officials have urged Washington and Paris to press Israel to uphold a ceasefire, after dozens of military operations on Lebanese soil that Beirut has deemed violations, two senior Lebanese political sources told Reuters on Tuesday. Deadly Israeli strikes on south Lebanon and Hezbollah rocket launches on an Israeli military post on Monday have put a U.S.-brokered ceasefire between the two in an increasingly fragile position less than a week after it came into effect.

Lebanon's caretaker Prime Minister Najib Mikati and Speaker of Parliament Nabih Berri, a close Hezbollah ally who negotiated the deal on behalf of Lebanon, spoke to officials at the White House and French presidency late Monday and expressed concern about the state of the ceasefire, the sources said. Neither the French presidency nor the foreign ministry were immediately available to comment. French Foreign Minister Jean-Noel Barrot spoke to his Israeli counterpart Gideon Saar on Monday, saying both sides

should adhere to the ceasefire.U.S. State Department spokesperson Matt Miller told reporters on Monday that the ceasefire "is holding" and that the U.S. had "anticipated that there might be violations". The truce came into effect on Nov. 27 and prohibits Israel from conducting offensive military operations in Lebanon while requiring Lebanon to prevent armed groups, including Hezbollah, from launching attacks on Israel. It gives Israeli troops 60 days to withdraw from south Lebanon. A monitoring mechanism chaired by the United States is tasked with monitoring, verifying and helping enforce the truce, but it has yet to begin work.

Berri on Monday urged it to "urgently" ensure Israel halts its breaches, saying Beirut had logged at least 54 Israeli violations of the ceasefire so far. Israel says its continued military activity in Lebanon is aimed at enforcing the ceasefire and does not violate its obligations under the truce. Mikati on Monday met in Beirut with U.S. General Jasper Jeffers, who will chair the monitoring committee, and stressed the need for Israeli troops to swiftly withdraw. Two sources familiar with the matter told Reuters that France's representative to the committee, General Guillaume Ponchin, will arrive in Beirut on Wednesday and that the committee would hold its first meeting on Thursday. "There is an urgency to finalise the mechanism, otherwise it will be too late," the source said, referring to Israel's gradual intensification of strikes despite the truce. Miller said the monitoring mechanism would begin its work "in the coming days." At least 12 people were killed in Israeli strikes on Lebanon on Monday, Lebanese authorities said, in the deadliest day since the ceasefire came into effect. They included six people in the southern town of Hariss and another four people in the southern town of Taloussa, according to Lebanon's health ministry

As sabotage allegations swirl, NATO struggles to secure the Baltic Sea

TURKU, GNS News Agency, Dec 5, On Nov. 18, hours after two communication cables were severed in the Baltic Sea, 30 NATO vessels and 4,000 military staff took to the same body of water for one of northern Europe's largest naval exercises. The 12-day 'Freezing Winds' drill was part of a push to step up the transatlantic defence alliance's protection of infrastructure in waters that carry 15% of global shipping traffic and are seen as increasingly vulnerable to attack. The Baltic Sea is bordered by eight NATO countries and Russia. There have been at least three incidents of possible sabotage to the 40-odd telecommunication cables and critical gas pipelines that run along its relatively shallow seabed since 2022, when Russia invaded Ukraine."NATO is stepping up patrols, ... allies are investing in innovative technologies that can help better secure these assets," said Commander Arlo Abrahamson, a spokesperson for NATO's Allied Maritime Command. Yet the ease with which a ship's anchor can slice through a cable, coupled with the often-treacherous sea conditions, makes actual prevention of such attacks almost impossible.On day three of the exercise, German Navy commander Beata Król tried to launch an underwater drone from her de-mining vessel, the Weilheim, to inspect the seabed as a winter storm raged. After a 30-minute delay in launching it, the drone had frozen and could not operate."The batteries got cold," she said, shrugging, as she waited for the equipment to warm up. Having spent years detonating World War Two-era mines on the Baltic seabed, NATO is repurposing its six-vessel minehunting fleet to also monitor suspicious underwater activity, with its hull-mounted sonar scanning the seabed, drones able to take pictures and video under the water, and specialist divers on hand. But its powers are still limited."We are a defensive alliance, so by conducting training and exercising, also in areas which are crucial with underwater infrastructure, we show presence and prevent rather than actively engage," Król said.

CAUSES OF CABLE DAMAGE HARD TO PINPOINTSecurity sources say the Chinese bulk carrier Yi Peng 3, which left the Russian port of Ust-Luga on Nov. 15, was responsible for severing the two undersea cables in Swedish economic waters between Nov. 17 and 18 by dragging its anchor on the seabed. As of Monday, it was stationary in Danish economic waters, being watched by NATO members' naval ships, having been urged by Sweden to return to be investigated. Some politicians had accused it of sabotage, but no authority had shown evidence that its actions were deliberate. China has said it is ready to assist in the investigation, while its ally Russia has denied involvement in any of the Baltic infrastructure incidents.

The case is similar to an incident last year when the Chinese ship NewNew Polar Bear damaged two cables linking Estonia to Finland and Sweden as well as an Estonia-Finland gas pipeline. China made similar promises to assist, but the ship was not stopped and, a year on, Finnish and Estonian investigators have yet to present conclusions. Damage to cables is not new. Globally, around



150 are damaged each year, according to the UK-based International Cable Protection Committee. The telecoms cables, power lines and gas pipes in the shallow Baltic are particularly vulnerable due to its very intense ship traffic, the U.S.-based telecom research firm TeleGeography said.

If any of the recent incidents are proven to be sabotage by another country, it would mark a return of a type of warfare not seen for decades."You should go back to World War One or the American-Spanish war to find a state-sponsored sabotage of a submarine cable," said Paul Brodsky, a senior researcher at TeleGeography. To counter this potential threat, NATO in May opened its Maritime Centre for Security of Critical Undersea Infrastructure (CUI) in London, which wants to map all critical infrastructure in NATOcontrolled waters and identify weak spots. In Rostock, on Germany's Baltic coast, a multinational naval headquarters opened in October to protect NATO members' interests in the sea. "What I think we can achieve is to place the responsibility after an incident," CUI's Branch Head, Commander Pal Bratbak, said onboard the Weilheim, stressing the growing power of technology.NATO's Centre for Maritime Research and Experimentation in Italy is launching software that will combine private and military data and imagery from hydrophones, radars, satellites, vessels' Automatic Identification System (AIS) and fibres with Distributed Acoustic Sensing (DAS), which private telecom companies use to localise cuts in their cables.

"If we have a good picture of what's going on, then we can deploy units to verify what the system tells us," Bratbak said.German Lieutenant-General Hans-Werner Wiermann, who led an undersea infrastructure coordination cell at NATO Headquarters until March, said no pipeline or cable can be guarded all the time. "The right response to such hybrid attacks is resilience," he said, adding that companies were already laying cables to add "redundancies" spare routings that will allow critical pieces of infrastructure to keep working if one cable is cut. On board the Weilheim, Król's second drone is finally able to brave the storm to continue the inspection drill underwater.

South Korea to approve more paternal leaves amid low births

Seoul: South Korea's presidential committee on population policy on Tuesday unveiled plans to have up to 70 per cent of fathers take parental leave by 2030 as the government intensifies efforts to tackle the nation's pressing demographic challenges. The figure would mark a sharp increase from just 6.8 per cent recorded in 2022, according to the Presidential Committee on Ageing Society and Population Policy. The rate for mothers stood at 70 per cent in the same year. The data represents the ratio of people who take parental leave among eligible workers with children aged eight or younger. The latest announcement comes amid anticipated changes in the parental leave policy starting next year.

Currently, both mothers and fathers can each take up to one year of parental leave, which can be divided into three periods. Starting in February, however, if both parents take at least three months of leave, each parent's total leave period can be extended to 18 months, which can be split into four periods. Also, the cap on compensation for parents taking time off from work will be raised to 2.5 million won (\$1,782) a month from the current 1.5 million won for the first three months of their leave. The monthly compensation will gradually decrease to 2 million won for the following three months and to 1.6 million won for the next six months. The detailed amount will vary depending on workers' ordinary

The country also aims to reduce the proportion of women experiencing childbirth-related career interruptions

to 10 per cent by 2030, compared with 22.3 per cent recorded this year.

The government has been unveiling a series of measures to address the country's chronic demographic challenges including the world's lowest birth rate. The committee said the government has already taken action for 143 out of 151 related tasks as of November. The total fertility rate, which refers to the average number of expected births per woman in her lifetime, came to 0.76 in the third quarter, far below the 2.1 births per woman needed to maintain a stable population without immigration. The government plans to raise the fertility rate to 1 by 2030. "We have prepared various policies, including offering short-term parental leave, raising the ceiling on monthly subsidies, and allowing men to take leave when their spouses are pregnant," a committee official said.

The government also plans to support fertility tests for 210,000 people in 2027, up from 80,000 in 2022. The committee announced detailed measures to support premature babies as well, aiming to establish two new emergency centers dedicated to treating critically ill mothers and newborns next year.

Premature babies refer to those born before 37 weeks of pregnancy or weighing less than 2.5 kilograms. Approximately 28,000 babies were born prematurely in 2023, accounting for over 10 per cent of newborns, according to government data. The country will launch a 24-hour transport support system to ensure timely care for mothers and babies in critical conditions, the committee added.

Fuel oil smuggling network rakes in \$1 billion for Iran and its proxies



DUBAI, GNS News Agency, Dec 5,A sophisticated fuel oil smuggling network that some experts believe generates at least \$1 billion a year for Iran and its proxies has flourished in Iraq since Prime Minister Mohammed Shia al-Sudani took office in 2022, five sources with knowledge of the matter told Reuters. The operation exploits a government policy under which Iraq allocates fuel oil to asphalt plants at heavily subsidised prices and involves a network of companies, groups and individuals in Iraq, Iran and Gulf states, according to the five people and three Western intelligence reports, two from August this year and one which was undated. Under the scheme, anywhere from 500,000 to 750,000 metric tons of heavy fuel oil (HFO), including high sulphur fuel oil (HSFO) - equivalent to 3.4 million to 5 million barrels of oil - is diverted from the plants each month and exported, mostly to Asia, two of the sources said. The extent of the fuel oil smuggling since Sudani came to power and the involvement of multiple entities within Iraq in the illicit trade have not previously been reported.

Iranian and Iraqi officials did not respond to detailed requests for comment about the findings in the Reuters story. Iran views its neighbour and ally Iraq as an economic lung and wields considerable military, political and economic influence there through the powerful Shi'ite militias and political parties it backs. It also sources hard currency from Iraq through exports and avoids U.S. sanctions via its banking system, Iraqi and U.S. officials say.

While Baghdad has been delicately balancing its role as an ally of both Washington and Tehran for years, with President-elect Donald Trump expected to take a hard line on Iran's attempts to skirt U.S. sanctions, its activities in neighbouring Iraq are expected to come under increasing scrutiny. Of the two main routes the fuel oil takes out of Iraq, one involves blending it with similar product from Iran and passing it off as purely Iraqi, helping Tehran evade tough U.S. sanctions on energy exports, said the five sources, who declined to be named due to the sensitivity of the matter. The other involves exporting the fuel oil that was originally meant for the subsidy programme using forged documentation to mask its origins.

Iran benefits directly from the first route. Iranian fuel oil typically sells at a discount due to sanctions but it can sell it for a higher price if it is passed off as Iraqi. The second route, meanwhile, benefits the Iranian-backed militias in Iraq that control the smuggling scheme. Three sources estimated how much both routes were bringing in based on assumptions about the volumes traded and relative prices. Their estimates ranged from \$1 billion a year to over \$3 billion. The illicit trade potentially puts Iraqi institutions and officials at risk of U.S. sanctions for helping Iran and some Iraqi officials are concerned a Trump administration could target them, the three sources said. However, Iraqi leaders rely heavily on the support of influential Iranian-backed Shi'ite groups to stay in power, making it difficult for them to crack down on illicit activities, such as the fuel oil smuggling, the sources said. Sudani's office did not respond to requests for comment about the trade, the risk of sanctions or government attempts to curb the business.

ON WASHINGTON'S RADARThe lucrative smuggling and its links to Iran and individuals under U.S. sanctions are already on Washington's radar. The subject came up in discussions between U.S. officials and Sudani when the Iraqi prime minister visited the United States in September, one of the sources said. Asked by Reuters whether smuggling had been raised, a State Department official said: "While we do not comment on specific discussions, we can affirm the Department has emphasized with our Iraqi counterparts the harms of illicit trade and our support for bringing oil transparently to market."

The U.S. Treasury did not respond to questions about the fuel oil trade or whether Iraqi entities and officials were at risk of sanctions.U.S. sanctions on Iran are chiefly in response to its nuclear programme and its support for groups across the Middle East that the U.S. sees as terrorist organisations, including Hamas in Gaza, Hezbollah in Lebanon and the Houthis in Yemen. While Washington has put pressure on Iraqi officials to clamp down on activities benefiting Iran, Tehran's influence runs deep. Central to the smuggling operation is Iraqi Shi'ite group Asaib Ahl al-Haq (AAH), a paramilitary force and political party that was an early backer of Sudani and a key member of the bloc that nominated him to be prime minister, according to the five people with knowledge of the matter and the three reports. The findings in the reports seen by Reuters are based on a broad range of sources in Iraq and its government departments who were not identified. Sudani's office and AAH and its leader Qais al-Khazali did not respond to questions posed by

Backed by Iran's Islamic Revolutionary Guard Corps (IRGC), AAH was folded into Iraq's security apparatus in 2018 and now also has 16 members of parliament.in 2019 for AAH's alleged role in serious human rights abuses, related to the killing of protesters in Iraq that year and other violence, including a 2007 attack that killed five U.S. soldiers.Khazali mocked the sanctions, saying in a video posted on X two days later that he was personally hurt it had taken Washington so long to sanction him.

HOW IT WORKSWhile fuel oil smuggling existed before Sudani came to power in October 2022, it has grown in complexity and become more formalised since he took office, the five sources said. Iraqi fuel oil exports are on track to hit an all-time high above 18 million tons this year, according to industry sources and ship-tracking data, more than double exports in 2021. To create surplus fuel oil for export, some of the asphalt plants involved in the network overstate their needs when requesting official fuel oil allocations. Others exist in name only, meaning their entire allocations can be diverted for export, according to the five sources and intelligence reports. Central to the scheme is the State Company for Mining Industry, which operates asphalt plants as a joint venture with private companies, the sources said. It was originally established to boost local industries, such as flancoat production, an asphalt waterproofing material used in construction. The state firm was singled out in one of the Western intelligence reports as coming under tight AAH control during Sudani's tenure and being used for the export of large quantities of HSFO. Al-Thager Asphalt Industries Factory, one of the state mining company's ventures according to its website, is used by AAH as a site for storing fuel oil, the intelligence report said. Some of the plants allegedly involved are controlled by AAH or Kataib Hezbollah, another Iraqi militia backed by Iran's Revolutionary Guards and

designated as a terrorist organisation, opens new tabby Washington, the intelligence report said. The State Company for Mining, Al-Thager and Kataib Hezbollah did not respond to detailed requests for comment. In a previous attempt to clamp down on the trade, Sudani's predecessor Mustafa al-Kadhimi ordered a review of the actual operating capacity of asphalt plants, cut their allocations and raised the price of subsidised fuel to \$220 per ton from \$70, according to two of the sources and the intelligence reports.

In January 2023, a few months after Sudani took over the price was lowered to \$100-\$150 a ton, far below the market price for exports, estimated at anywhere between \$300 and \$500. The lower the price of the subsidized fuel, the higher the profit margin when exporting it on the international market. Sudani's government also expanded licensing for asphalt plants to include 37 new projects, a neardoubling of the industry almost overnight, one of the sources said. All of the sources said some of the projects were fictitious, suggesting they were just ploys to get fuel oil allocations for export. The allocation of fuel oil is determined by Sudani's office through its National Operations Command (PM-NOC). The Oil Products and Distribution Company (OPDC) is then tasked with processing fuel movement requests, which include vehicle numbers, cargo volumes and specifications, and identifying information for each driver and truck. The fuel oil movements are reviewed by the PM-NOC and approved with memos that let trucks pass through various checkpoints manned by Iraq's oil police, three sources said PM-NOC, OPDC and Irag's state oil marketing company SOMO, the body responsible for exporting Iraqi fuel oil, did not respond to requests for comment.

BLENDED WITH IRANIAN FUELOnce diverted from the plants, the fuel oil takes one of the two routes, both involving forged documentation, the five sources said. Some of the Iraqi fuel is exported directly through Iraq's southern ports with falsified documents listing it as other products, such as vacuum residue or flancoat, both byproducts of refining that can be shipped legitimately. The state mining company, which owns a network of heavy fuel oil blending facilities across Iraq, is authorised to transport fuel oil between them and export flancoat, one of the intelligence reports said

The second route involves blending the illicit fuel oil with similar Iranian fuel and passing it off as purely Iraqi, again with falsified documents, to help Tehran skirt tough sanctions Western nations have imposed on its energy exports. The southern Iraqi city of Basra has emerged as the heart of the blending operations, with Khor Al Zubair and Umm Qasr ports key export points for the illicit fuel, the five sources said.Reuters was unable to determine whether the authorities in the ports were aware of the smuggling operation. The blending is done by Iraqi engineers, typically during ship-to-ship transfers, and the fuel oil is then shipped to clients mainly in Asia, two of the intelligence reports said. The operation is made easier by the similarity between Iraqi and Iranian fuel oil grades and it is difficult to determine scientifically that blending has occurred after the fact, one of the people said. Irag's port authorities did not respond to requests for comment. In July, Sudani's government ramped up the price of subsidised fuel oil to \$369 per ton, recommended cutting asphalt plant allocations to about 60% of their capacity and also ordered a review of their actual capacity. Reuters was unable to determine why the government launched the review, or the outcome. Three of the sources said the move was an attempt by the government to distance itself from the smuggling operation. Sudani's representatives did not respond to requests for comment. India to get \$1.17 billion worth helicopter equipment from US

Washington: The Biden Administration on Monday notified the Congress of its decision to approve the sale of MH-60R Multi-Mission Helicopter Equipment and related ones at an estimated cost of \$1.17 billion.

The proposed sale will improve India's capability to deter current and future threats by upgrading its anti-sub-marine warfare capabilities, the Defense Security Cooperation Agency said in a notification to the Congress. The Biden administration's approval of sale of major defense equipment to India comes weeks ahead of its completion of its four-year term. President-elect Donald Trump would be sworn in as 47th president of the United States of America on January 20, 2025. According to the notification, India has requested to buy 30 Multifunctional Information Distribution System-Joint Tactical Radio Systems (MIDS-JTRS).

It also included advanced data transfer systems; external fuel tanks; AN/AAS 44C(V) forward looking infrared (FLIR) systems; an operator machine interface assistant; spare containers; facilities study, design, construction and support; support and test equipment; munitions; and integration and test support. The principal contractor will be Lockheed Martin Rotary and Mission Systems. Implementation of this sale will require travel of up to 20 US Government or up to 25 contractor representatives to India on a temporary basis for program technical support and management oversight, it said.

Japanese firms keen to set up semiconductor units in India: Deloitte



Japanese firms are keen to set up semiconductor units in India and they have all the expertise and specialisation to partner with domestic firms, Deloitte has said. It also said that skilled workforce, funds and continuation of support measures are key to push growth of the semiconductor sector in India. Japanese firms are "super enthusiastic" about India, Shingo Kamaya, Deloitte AP and SRT Leader, Deloitte Japan said. In July, Japan became the second Quad partner after the US to sign an agreement with India for the joint development of the semiconductor ecosystem and maintain the resilience of its global supply chain.

The two countries signed the memorandum for semiconductor design, manufacturing, equipment research, talent development and to bring resilience in the semiconductor supply chain. With around 100 semiconductor manufac-

turing plants, Japan is among the top five countries to have a semiconductor ecosystem. Japan houses companies that are global leaders in raw form of semiconductor wafers, chemical and gases, lenses that are used in chip manufacturing equipment, and display technologies. India aspires to have 10 semiconductor manufacturing plants in 10 years. "Given the technology, given the specialization, there is no better partner to get on to developing such an ambitious and a critical ecosystem of semiconductor than Japan," Rohit Berry, President - Strategy, Risk and Transactions, Deloitte India, said. He said that the semiconductor story in the country is not just about setting up one factory, but it is about that entire ecosystem. "And that is where many Japanese companies who have set up such ecosystems in Japan or in any other places are going to be absolutely critical to set it up (in India). So this is the vision. This is a grand plan. This is the investment. This is the commitment," he added. Berry also said that developing the right kind of partnerships between Indian and Japanese firms are fundamental for the growth of the sector. "This is not a one year game, it's not a two year game. This will basically benefit us and Japan for generations," he noted. He also emphasised that the government incentive program on a sustained basis will also be a key factor for the sector's growth in India. When asked if Japanese firms are looking for any specific support measures from states, he said that a "centre-state partnership, together with the private and Japanese partnership, all four of them coming together will be a prerequisite to create a once in a lifetime setup".

India tops global list for mobile malware attacks: Zscaler Report

In a startling revelation, India now tops the list for mobile malware attacks globally, surpassing the United States and Canada, with a disappointing step-up from its previous third-place ranking, according to a report. The Zscaler ThreatLabz 2024 Mobile, IoT, and OT Threat Report analysed a dataset comprising over 20 billion threat-related mobile transactions and associated cyber threats, between June 2023 to May 2024. "India has become the top global target for mobile malware attacks, accounting for 28 per cent of the total, surpassing the United States (27.3 per cent) and Canada (15.9 per cent). This significant jump from its 3rd place ranking last year underscores the critical need for Indian enterprises to adopt robust security measures, especially amid the rapid digital transformation and increasing cyber threats," the report said.

With nearly half of mobile attacks being trojans (malware that tricks users into downloading and running malicious software), the financial sector is particularly vulnerable. The report revealed a 29 per cent increase in banking malware attacks and a staggering 111 per cent rise in mobile spyware attacks. "Most financially motivated malware attacks are highly capable of bypassing Multifactor Authentication (MFA) and frequently leverage phishing vectors, such as fake login pages for different financial institutions, social media sites, and crypto wallets," it said.

Phishing attempts targeting mobile customers of major Indian banks, such as HDFC, ICICI, and Axis banks, have increased, according to ThreatLabz analysts. These clever attacks deceive mobile users into disclosing critical bank information by using phoney banking websites that closely mimic the real ones, it said. Previously, similar tactics were used to spread Android-based phishing malware through fake card update sites, leading to widespread financial fraud. The Indian postal service has also become a



target for attackers. Using SMS messages, they direct mobile users to phishing sites that prompt them to input credit card details. These fraudulent schemes often exploit common scenarios like missing packages and incomplete delivery addresses, capitalising on the urgency created by such messages, the report noted. "Legacy systems and unprotected IoT/OT (Internet of Things/Operational Technology) environments are becoming prime targets for cybercriminals. We see a significant rise in hacking campaigns targeted at these environments.

"It is necessary for Indian enterprises to adopt a robust zero-trust security framework to secure their core operational environments. This will not only protect critical systems but also ensure business continuity in an increasingly connected world," said Suvabrata Sinha, CISO-India, Zscaler. The report also indicated a concerning global trend, with over 200 malicious applications discovered on the Google Play Store and a 45 per cent year-over-year increase in IoT malware transactions, underscoring the pervasive nature of cyber threats today.

Home price index rises by 4.3% amid high interest rates, inflation: RBI

Home prices are on the rise in India despite high interest rates in the banking system and inflation. The All-India Home Price Index (HPI) of the Reserve Bank of India rose by 4.34 per cent to 322 as of September 2024 as against 308.6 in September 2023, indicating that price rise is continuing across the metros, according to Reserve Bank of India data. HPI has gone up by nearly 67 per cent in the last ten years from 193.05 in 2014-15 amid the pandemic, high inflation and interest rates.

The annual HPI growth varied widely across the cities, ranging from a high growth of 8.76 per cent (Bengaluru) to a decline of (-)2.0 per cent (Kanpur). On sequential (quarter-on-quarter) basis, all-India HPI decreased by 0.1 per cent in September 2024-25. Ahmedabad, Lucknow, Kolkata and Chennai recorded a sequential rise in house prices during the latest quarter, RBI data shows. Home price index for Mumbai rose by 2.95 per cent to 303.62 in September 2024 as against 294.92 a year ago, Delhi increased by 3.31 per cent to 350.40 from 339.16 and Bengaluru by 8.76 per cent to 360.11 from 331.08. The RBI's home index is based on transaction-level data received from the registration authorities in top ten major cities.

Average housing prices across the top eight markets in India rose 11 per cent year-on-year at Rs 11,000 per sq ft during Q3 of 2024, led by sturdy demand and positive market sentiments, industry body CREDAI said. Interestingly, average housing prices have increased for the 15th consecutive quarter since 2021. All the eight major cities saw an annual increase in housing prices with Delhi NCR witnessing the highest rise at 32 per cent, followed by Bengaluru at 24 per cent rise during the quarter. After registering record high sales over the last two years, the demand momentum across the top cities is stabilizing. Nevertheless, with anticipation of healthy residential activity in the last quarter, 2024 is likely to end on a strong note, it

However, overall unsold inventory continued to witness a quarterly drop for the third consecutive quarter, led by healthy uptake in housing units. At the end of September 2024, unsold inventory stood at over 10 lakh housing units across the eight major cities, with Mumbai Metropolitan Region (MMR) accounting for a majority at about 40 per cent share. Unsold units in Hyderabad saw a modest dip on a sequential basis despite a yearly increase of about 28 per cent.

"The ongoing rise in housing prices is another validation of positive homebuyer sentiments and the highly conducive nature of the real estate market. We are seeing more and more aspirational homebuyers come to the fore – resulting in bigger homes that are also being reflected in the rise in prices as homes continue to get more expansive, truly reflecting the current market dynamics and consumer preferences," said Boman Irani, President of CREDAI National. "While the housing market is gradually stabilizing,



the outlook for the residential segment remains positive supported by strong underlying market fundamentals. Developers are recalibrating their strategies, particularly in the price-sensitive segments, by offering compact size units," said Badal Yagnik, Chief Executive Officer, Colliers India. "We expect this robust momentum to continue going into the new year and are hopeful of rate cuts in the impending future," Irani said.

"Although average housing prices have continued to increase steadily, witnessing a 11 per cent YoY growth during Q3 2024, the likely easing of monetary policy and anticipated repo rate cuts can potentially bring financial relief to homebuyers in the near term. Moreover, flexible payment plans and freebies to attract homebuyers will continue to aid in residential sales momentum," Yagnik said.

lic statement.In an Instagram post, Rozlyn wrote, "This is to inform you that Mr Navjot singh siddu is recommending a diet based on his on wife's journey, but he forgets that it is tried and tested that every cancer patient has a different journey, please dnt follow the empty stomach haldi ,apple cider, cinnamon, and intermittent fasting etc, as chemotherapy leads to nausea, diarrhoea, low platelets, low wbc, mucositis, bleeding gums, and internal bleeding in my case ..his statement was sansational line to grab eyeballs and he succeeded to get attention public figures who are dealing with cancer are roaming around just after chemotherapy, posting everything else but not a single awareness word comes out of their mouth is a trend now ..!."

She added, "No one is ready to openly share reports or discussing their own case on social media... the word cancer is used for getting media and public attention..! I request all the medical professionals to take strict legal action on the misinformations..'m doing what best | can do for my cancer survivor and warriors.! Let's boycott all attention seekers and create best environment for cancer to eradicate from our life and their minds."



Indian squash legend Raj Manchanda dies at 79 in New Delhi



Legendary squash player Raj Manchanda, the Arjuna Award recipient and winner of six national titles, died at the age of 79 on Sunday, sources close to his family said. Manchanda, one of the most recognisable faces in the Indian squash fraternity, was the undisputed

national champion from 1977 to 1982 and won an unprecedented 11 titles for the Services. He also represented India in the Asian Championships and world-level tournaments during this period and made his presence felt through his patented use of the lob accompanied by a nagging accuracy of shots all around the court. He was awarded the Arjuna Award in 1983. He started to make his presence felt when he was captain with the Electrical and Mechanical Engineer Corps (EME) of the Indian Army, winning his first national title at the age of 33

In 1981, at the Asian Championships, he faced the legendary Jahangir Khan who would go on to dominate the world stage in the 1980s. He captained the Indian team on several occasions, including when the country won silver at the 1981 Asian Team Championships in Karachi. His best individual performance was a fourth-place finish at the 1984 Asian Championships in Jordan where the team, led by him, won a bronze medal.

Sir Don Bradman's 'baggy green' cap gets auctioned for Rs 2.63 crore in Sydney

Legendary Australia cricketer Sir Don Bradman's 'baggy green' cap was sold at an auction in Sydney at Bonhams auction house on Tuesday, December 3. The cap which was worn by Bradman during his last Test series in Australia played against India in 1947-48, was bought for a price of \$390,000 (Rs 2.14 crore). The fee was further increased to \$479,700 (Rs 2.63 crore) after buyer's premium was added. Bradman is considered as the greatest batter to have played the game having scored 6996 runs from 52 Test matches with 29 hundreds and 13 fifties. The legendary batter holds the record for most double hundreds in the longest format (12) and also the joint highest triple centuries (2). The auctioned cap was worn by the legendary batter during India's first tour to Australia after independence. Bradman was seen in imperious form during the series as he brought up his 100th first class hundred. The right-handed batter scored 715 runs from six innings at an average of 178.75 registering three centuries out of which one was converted into a double century. The cap is also the only known Baggy Green surviving from the series which was gifted by Bradman gave to the then Indian team manager who handed it to the wicket keeper on that tour. The cap was purchased by a collector decades later who loaned it to the Bradman museum.Legendary India cricketer Sunil Gavaskar also shared an incident when his club captain came to Australia and insisted on meeting Bradman and revealed how much is the legendary batter revered in



India Bradman has been an inspiration for everybody And for those in India he was the ultimate cricketing god. (He) insisted on his host to take him to Adelaide because he said, 'How can I come to heaven and not meet god?' So he came here, met Sir Don, and I think that for him was the ultimate. That's how (Bradman) was revered in India, and continues to be revered in India. Honestly, getting the Australia cap from the greatest is something really special. He gave it to the wicket keeper, I believe, the wicket keeper on that tour, and it is a prized possession, it would be a prized possession for anybody," Gavaskar told 7NEWS.Bradman played his last Test against England in 1948 at the Oval and needed to score just four runs in his final Test innings to finish with a career average of 100. However, he was dismissed for a two-ball India.Gavaskar shares how Bradman is reverred in duck in his final outing and finished his career with an

At just 22, Jaiswal showcased remarkable poise and courage, even sledging veteran pacer Mitchell Starc by cheekily claiming he was bowling "too slow," a moment that became one of the highlights of India's commanding win in the first Border-Gavaskar Trophy Test.

Jaiswal's second-innings heroics came after a tough start, where he was dismissed for a duck by Starc in the first innings. In a stunning turnaround, Jaiswal delivered a sensational 161 off 297 balls, standing tall against Australia's formidable bowling attack on a challenging Perth surface. Speaking to TEN Sports, Cook highlighted the young batter's mental fortitude, describing his ability to shine under pressure and in hostile conditions as "classy", and that even seasoned players might shy away from."And sledging Mitchell Starc, saying at a certain stage, I think he wasn't on 100, he wasn't on anything on a major score, but he's telling him you're bowling slow...and I've faced Mitchell Starc, and he certainly doesn't bowl slow. And if he was bowling slow, I'd keep my mouth shut and not wind him up,



but have the confidence to do that as a 22-year-old... Cook said." I think he scored the most runs has any Indian player up to after 15 Test matches at the top of the order, which I'll keep saying it, no one else believes me, it's the hardest place to bat. What a classy player he is," he added.India's victory in the Perth Test was a comprehensive team effort. After a disappointing first innings, where they were bowled out for just 150, India clawed back with stand-in captain Jasprit Bumrah leading the charge. "Gilchrist said that for Labuschagne it's all about not letting any self-doubt creep in and understanding that he has still got the skills."Most players that have played long enough will have been in this situation at some point in time and it's about not letting any selfdoubt creep in and understanding you don't lose that skill you don't lose that edge — (and) certainly not in a short space of time.""Trust your training, get out there, see the ball and play it."Australia batters need to stay at the crease longerGilchrist also advised the Australian batters to stay at the crease for a long time to nullify the threat from the Indian bowlers." Marnus had the onus to do that (stay at crease) and tried at good effect to nullify 50-odd deliveries. So, if you face an average of 50 deliveries every Test innings, you're probably going to be on the right side of the ledger more than you're on the wrong side of it," Gilchrist was quoted as saying by Nine's Wide World of Sports."He just couldn't find a way to score and maybe that's what (the Australians) as a collective will

Shardul Thakur returns form with 4 wickets after most expensive T20 spell

Shardul Thakur roared back to form with a stunning four-wicket haul for Mumbai against Services, silencing critics after a tough week that saw him go unsold in the IPL auction and deliver a record-expensive spell in the Syed Mushtaq Ali Trophy.India pacer Shardul Thakur snapped straight back into form with a stunning four-wicket haul in Mumbai's clash against Services on December 3 in the Syed Mushtaq Ali Trophy, after having faced two big blows only days prior. The fiery spell marked a triumphant return to form for Thakur, who endured a challenging week that included going unsold in the IPL 2025 mega auction and bowling the most expensive spell in Syed Mushtaq Ali Trophy history. Services, chasing 193 runs, were dealt a massive blow early in their innings as Thakur's searing pace and accuracy dismantled their top order. His spell of 4/25, along with a 3/40 spell from Shams Mulani were instrumental in tilting the match heavily in Mumbai's favor, and ultimately played one of the most pivotal roles in giving his side a 39run win. The week began on a sour note for the 32-year-old all-rounder. Once a sought-after name in the IPL, having represented Chennai Super Kings, Kolkata Knight Riders, and Delhi Capitals, Thakur was left without a bid during the IPL 2025 mega auction. Adding to his woes, he bowled a 1/ 69 spell against Kerala in the Syed Mushtag Ali Trophy, setting the unwanted record for the most expensive spell in the tournament's history.



However, Thakur was determined to turn the tide. Facing Services, he was relentless with the ball, dismantling their top three batters within just two overs of his spell. His performance showcased his ability to rise above setbacks and deliver when it mattered the most. Mumbai's innings had already been bolstered by brilliant performances from Suryakumar Yadav and Shivam Dube. Yadav smashed a fluent 70, while Dube remained unbeaten on 71, ensuring Mumbai set a daunting target of 193 runs. Thakur's devastating spell further cemented their dominance, leaving Services reeling and with little chance of recovery. While the IPL setback may have raised questions, his performance against Services answered them emphatically, reaffirming his value as a toptier all-rounder in Indian cricket.

The T20 World Champion duo stitched a 130-run stand to help Mumbai post a challenging total of 192/4. Batting first, Mumbai lost Prithvi Shaw for a duck and skipper Shreyas Iyer and Ajinkya Rahane also managed to contribute only 20 and 22 runs respectively.

The par of Dube and Suryakumar came to Mumbai's rescue as they launched a barrage of boundaries and maximums. Suryakumar scored a 46-ball 70 and Dube struck 37-ball 71 at a staggering strike-rate of 191.89. Suryakumar was retained by Mumbai Indians for Rs 16.35 crore ahead of IPL 2025 mega auction. Meanwhile, Chennai Superkings also retained Dube for Rs 12 crore.India's T20I captain Suryakumar was back in action for Mumbai in SMAT on December 3, Tuesday. He returned to the field after taking a two-week break for a family wedding. Suryakumar is expected to play the remainder of the tournament for Mumbai and will also feature in the 50-over Vijay Hazare Trophy, starting December 21.

Shreyas Iyer, who was announced as Mumbai's captain for SMAT continued to lead the side despite Suryakumar, India's T20I captain's inclusion in the team. It was understood that Suryakumar was fine with Iyer leading the team and was comfortable to bat at any position for his team. Suryakumar recently led India to an emphatic 3-1 series win ove South Africa at their home soil. Meanwhile, Dube, India's white-ball specialist, was not part of India's squad for the tour. Placed fourth in Group E, Mumbai have won two of their three games so far and have two league games left after Sunday, when they play against Nagaland. The ongoing SMAT has seen a number of highprofile names participate after the T20I tour of South Africa, such as Hardik Pandya, Iyer, Tilak Varma, Rinku Singh, Yuzvendra Chahal, Varun Chakravarthy, and others. Suryakumar had also played one round of the Ranji Trophy in October before leaving for South Africa.
