### Student Electrocutes to Death Amidst Hostel Management Negligence

WANAPARTHY: A heartbreaking incident has unfolded in Wanaparthy district, where a 15-year-old student lost his life due to negligence on the part of school management, raising serious questions about the accountability of educational institutions. The tragic event occurred on Saturday when Harish, a Class 9 student from the Radiant School hostel, was electrocuted by electric wires planted in a nearby groundnut field. Reports indicate that Harish and a fellow student, Gautam, were exploring the adjacent peanut field when Harish inadvertently came into contact with the live wires, leading to his untimely death at the scene. Although another student promptly informed the school management, it was too late; Harish had already succumbed to the shock.

### Death toll in Jaipur LPG tanker crash rises to 14

Jaipur: The death toll in the LPG tanker accident on the Jaipur-Ajmer highway rose to 14 on Saturday, an official said here. He said more than 30 people who suffered burn injuries in the massive crash are undergoing treatment.

"Five charred bodies were received yesterday. Eight others have died. Total 14 deaths have been reported so far. Twenty-seven patients are admitted to SMS hospital and undergoing treatment. Seven are on ventilator support," Dr Sushil Bhati, Sawai Man Singh (SMS) Hospital Superintendent, said.

## Allu Arjun attended 'Pushpa-2' screening despite police denying permission: CM

Hyderabad: GNS News Agency, Dec 21:Despite police permission being denied, top Telugu actor Allu Arjun attended the theatre where 'Pushpa-2' was screened on December 4, Telangana Chief Minister A Revanth Reddy charged on Saturday. Even after the death of a woman in a stampede, the actor did not leave the cinema hall, prompting the police to force him out, CM alleged. Responding to the issue after AIMIM MLA Akbaruddin Owaisi raised it in the Assembly, Reddy, referring to videos in circulation, found fault with Allu Arjun for holding a roadshow and waving to the crowds in spite of the heavy crowd. Reddy further said the theatre management gave a letter to the police on December 2 seeking security for the visit of top actors and others on December 4. However, the police rejected the application, citing difficulties in crowd management.

Before entering the theatre and exiting, the actor stood through the sunroof of his car and waved to the crowds leading to thousands of fans jostling to get a glimpse of him, he said. He slammed film personalities for making a beeline for Allu Arjun's residence to meet him after his arrest but not showing empathy to visit the boy who is undergoing treatment in hospital after suffering injuries in the incident. "I appeal to the top film personalities that they should not be inhuman," he said. He also said there won't be any special privileges when untoward incidents like death in a stampede happen and said the government would not spare those who troubled common people. A 35-year-old woman died and her eight-year-old son was hospitalised on De-



cember 4 during a stampede-like situation at the Sandhya Theatre in Hyderabad when thousands of fans jostled to have a glimpse of the actor at the premiere of the block-buster 'Pushpa 2,'.

Following the incident, the city police registered a case against Allu Arjun, his security team, and the theatre management under different sections of Bharatiya Nyaya Sanhita (BNS) at the Chikkadpally police station based on the complaint lodged by the deceased woman's family. Allu Arjun was arrested by the city police in connection with the death of the woman on December 13. The Telangana High Court granted him a four-week interim bail on the same day and he was released from the prison here on December 14 morning.

## PM Modi arrives in Kuwait on a historic visit

Kuwait City: Prime Minister Narendra Modi on Saturday afternoon arrived in Kuwait, becoming the first Indian Prime Minister to visit the Gulf nation in 43 years. The PM received a grand welcome upon his arrival as he began his historic two-day visit at the invitation of the Amir of the State of Kuwait, Sheikh Meshal Al-Ahmad Al-Jaber Al-Sabah, that is expected to take India's close ties with the Gulf countries to another level.

PM Modi will be accorded a ceremonial guard of honour at the Bayan Palace, following which he will be holding separate meetings with the Amir of Kuwait and the Crown Prince of Kuwait. Delegation-level talks with the Prime Minister of Kuwait will be held thereafter during which the Prime Minister will review with the leadership of Kuwait the entire spectrum of bilateral relations including in areas such as the political, trade, investment, energy, culture and peopleto-people ties, and the steps that both sides need to take to further enhance them.

The Crown Prince will be hosting a banquet in honour of the Indian PM who is also scheduled to interact with the Indian diaspora at a community event besides also visiting a labour camp. During his visit, PM Modi will also attend the opening ceremony of the 26th Arabian Gulf Cup as a special guest of the Amir of Kuwait."Today, I am embarking on a two-day visit to Kuwait at the invitation of His Highness Sheikh Meshal Al-Ahmad Al-Jaber Al-Sabah, the Amir



of the State of Kuwait. We deeply value the historical connection with Kuwait that has been nurtured over generations. We are not just strong trade and energy partners but also have shared interest in peace, security, stability and prosperity in the West Asia region," the Prime Minister said in his departure statement, earlier in the day. "It would be an opportunity to chalk out a road map for a futuristic partnership for the benefit of our people and the region. I eagerly look forward to meeting the Indian diaspora in Kuwait who have immensely contributed to the strengthening of bonds of friendship between the two nations," the statement added. PM Modi also said that he remains confident that his visit will further strengthen and reinforce the special ties and bonds of friendship between the people of India and Kuwait.

## Telangana Assembly sees resignation challenges as BRS, Congress argue over 24x7 power supply

Hyderabad: Amidst the short discussion on Rythu Bharosa in the Assembly on Saturday, members threw challenges of tendering resignations if their claims were proved wrong on different issues. It all began when BRS working president KT Rama Rao said the previous BRS government had supplied sufficient water and 24 hours free power supply to farmers.

Countering his statement, Roads and Buildings Minister Komatireddy Venkat Reddy alleged the BRS government had supplied power for only 11 to 14 hours a day. Even this supply was disrupted five to six times a day, he alleged, adding that he had personally checked the logs books at sub-stations. "Let us visit Nalgonda soon after the

House is adjourned and check with farmers. If I am proved wrong, I will tender my resignation in Speaker format," Komatireddy venkat Reddy challenged. He also said irrespective of the opposition by BRS and BJP MLAs, the Congress government would take up River Musi rejuvenation project. As Congress MLAs continued to cheer the Minister, the BRS working president reminded that as per the White Paper submitted by Deputy Chief Minister Mallu Bhatti Vikramarka in the House, it was clearly declared that the BRS government had on an average supplied free power for 19.2 hours in a day. Countering the Congress party claims that it had patent for 24 hours free power supply to farmers, Rama Rao challenged them to check the log books at sub stations in Nalgonda district alone."If it is proven that 24 hours free power supply is being extended to farmers, all the BRS MLAs will tender their resignations," Rama Rao said. Pointing out that the barren lands in Palamuru were transformed into fertile lands by the BRS government by completing pending projects, he said availability of water and power had triggered reverse migration in the district.

In reply, Tourism Minister Jupally Krishna Rao alleged that the BRS government had failed to complete the Palamuru Rangareddy Lift Irrigation scheme. "If I am proved wrong, I will submit my resignation," Krishna Rao announced. Responding to him, the BRS working president said Rs.4000 crore was spent by the KCR government to complete pending projects, including Kalwakurthy, Bheema, Nettampadu and others and water was supplied to 6.5 lakh acres in the Palamuru district.

#### Chief Minister Revanth Reddy Raises Concerns Over Dharani Portal's Data Breach, Promises New Land Records ...

Telangana Chief Minister Revanth Reddy expressed deep concern over the breach of sensitive land records through the Dharani portal, a platform introduced by the previous government. He revealed that the highly confidential land-related information of Telangana's farmers, including Aadhaar cards, bank account details, and phone numbers, had been exposed to foreign entities, potentially reaching criminal organizations involved in financial crimes. Speaking in the legislative assembly during a discussion on the Telangana Bhoobharthi (Land Rights) Act, 2024, the Chief Minister detailed the problems created by the Dharani portal. He emphasized that despite the portal's intent to safeguard land records, it had inadvertently allowed critical data to cross national borders, potentially endangering the privacy of Telangana's farmers.

"The information collected from transactions since 2020, including Aadhaar numbers, bank accounts, and phone numbers, has been compromised. This breach has led to personal data falling into the hands of entities in foreign countries, including those involved in economic crimes," the Chief Minister said, highlighting the grave implications of the situation. The Telangana Bhoobharthi Act, passed in 2024, aims to provide secure and reliable land records, covering 1.52 million acres across the state. It aims to not only preserve land ownership details but also protect the rights of landowners. Chief Minister Revanth Reddy assured the assembly that the new law would strengthen the land records system and restore public trust.

The Chief Minister further criticized the previous government's handling of the Dharani portal, which saw critical data being outsourced to foreign companies, including those based in tax haven countries like the Cayman Islands and British Virgin Islands. He revealed that the portal's management shifted from one company to another, with foreign entities, such as Falcon SG (Philippines) and Falcon Investments, gaining access to Telangana's land data. The government also discovered that private companies had changed land ownership details, including government, temple, and private land records, without proper authorization. This unauthorized transfer of sensitive data, including the manipulation of records, has raised serious concerns about the integrity and safety of the information. After



found that agreements between the previous government and foreign companies had violated regulations, allowing sensitive data to be accessed by foreign players. The Chief Minister emphasized that these breaches were severe, as companies like Falcon Investments, which had access to the Dharani portal, were not only uncooperative but also obstructed the transfer of records to the National Informatics Centre (NIC). "We decided to move the management of the Dharani portal to NIC to ensure secure and confidential handling of land records. However, we faced resistance from these private entities, which had illegally held on to the data," Revanth Reddy stated.

Despite the setbacks, the Telangana government has introduced the Bhoobharthi Act to rectify the problems caused by the Dharani portal and to ensure that land records are secure and protected under state supervision. The Chief Minister also noted that while the process was delayed due to careful consideration, the government's efforts to rectify these issues would ultimately benefit the people of Telangana. The Chief Minister concluded by stressing that the new legislation, Bhoobharthi Act 2024, would be a step toward transparency and trust, aiming to bring relief to the people who have suffered due to the mismanagement of land records. He assured the people that his government would continue to work towards safeguarding their rights and interests, taking all necessary steps to ensure that the trust placed in the government is never broken again.

## ACB Case Filed Against KTR in Formula E-Race Controversy

Hyderabad: The Anti-Corruption Bureau (ACB) has registered a case against former Telangana IT Minister K.T. Rama Rao (KTR) in connection with alleged irregularities during the Formula E-race event. The case came to light during court proceedings, where the Advocate General (AG) highlighted suspicious payments made to Formula E Operations (FEO). According to the AG, the Hyderabad Metropolitan Development Authority (HMDA), which was not directly involved in the event, paid ?55 crores to FEO. This sparked questions from the judiciary regarding the purpose and beneficiaries of these transactions. The court specifically inquired about any personal benefits that KTR might have gained from the payments. Responding to the court's queries, the AG clarified that the investigation would determine who benefitted from the alleged misappropriations. The judiciary stated that the case did not qualify as an urgent



petition, allowing it to proceed under standard investigative protocols. This development has raised concerns about the transparency of financial dealings in high-profile events and the accountability of public funds in such initiatives. Further updates on the investigation are awaited.

## Hyderabad High Court Denies Interim Relief to Mohan Babu in Journalist Assault Case

The Telangana High Court has refused to issue interim orders in the case concerning an assault on TV9 journalist Ranjith. The case is related to the alleged attack on the journalist by individuals associated with actor Mohan Babu.

Mohan Babu, who is seeking anticipatory bail, had requested the court to prevent his arrest until the case is heard further. His legal counsel had urged the court to grant an order restraining the police from taking any action against him until Monday.

#### Delhi Lieutenant Governor gives nod to ED to prosecute Arvind Kejriwal

#### IAF training hiccups

THE highlight of the Indian Air Force's (IAF) 92nd Raising Day celebrations in October this year was a typially spectacular air show, whose theme was 'Bhartiya Vayu Sena — Saksham, Sashakt, Atmanirbhar (potent owerful and self-reliant)'. Those three words were suposed to reflect the IAF's "unwavering dedication to safe juarding the nation's airspace". The ground reality, howver, is not all that rosy. In a report tabled in Parliament on Vednesday, the Comptroller and Auditor General (CAG) of India has flagged deficiencies in the training of IAF piots. Under intense scrutiny is the Pilatus PC-7 Mk-II airraft, which is being used to impart Stage-1 flying training ince 2013. The performance audit has noted that 25 per ent of these aircraft reported 38 snags due to engine oil eaks between 2013 and 2021. No less worrying are the lelays in the IAF's aircraft modernisation plans that have affected stages 2 and 3 of pilot training for transport and

Outdated equipment is another area of concern. The vorld's fourth-largest air force cannot afford to compronise on the upgrade of training simulators and aircraft. Trainee pilots need state-of-the-art technology to hone their skills. Issues such as engine oil leaks can dampen the spirits of aspirants who want to soar high and protect ndia's skies. Lowering the bar can prove to be a recipe or disaster.

There are problems not only in terms of quality but also quantity. The shortage of pilots has risen from 486 to 596 in about six years, as the recruitment has fallen short of the targeted intake. The CAG has done its job. Now it is up to the IAF and the government to take corrective action on priority. This vital pillar of India's defence edifice must not be allowed to lose its much-touted potency and

#### Delhi HC notifies 'Equal Opportunity Policy' for people with disabilities 7 years after Act

delhiAs per the policy, the Delhi HC should "prepare a list of the identified posts in all groups - A, B and C for PWDs in respect of the work which could be easily performed by them" and the posts should be identified for PWDs within a period of two months from the date of issuance of the policy The Delhi High Court on Monday notified the framing of 'Equal Opportunity Policy for Persons with Disabilities' for itself in compliance with the mandate provided under the Rights of Persons with Disabilities Act, 2016.

Section 21 of the Act mandates that every establishment should "notify equal opportunity policy detailing measures proposed to be taken by it" for skill development and employment of people with disabilities (PWDs). The Act came into force on April 19, 2017, which means the Delhi High Court has notified the policy more than seven years after the enforcement of the Act.The policy includes employment safeguards and organising "job specific post-recruitment training" programmes for PWDs, as well as ensuring training programmes at the time of introducing "any

As per the policy, the Delhi HC should "prepare a list of the identified posts in all groups – A, B and C for PWDs in respect of the work which could be easily performed by them" and the posts should be identified for PWDs within a period of two months from the date of issuance of the policy (December 16). The policy covers PWDs as prescribed under the Rights of Persons with Disabilities (RPWD) Act, 2016, which includes contractual employees, employees who acquire a disability during their work tenure and will apply to "all aspects of employment, be it recruitment, training, working conditions, salary, transfers, employee benefits and career advancement".

"The Establishment of Delhi High Court would encourage candidates with different disabilities to apply... All vacancy advertisements will include an appropriate short statement on equal opportunities for persons with disabilities... Application forms shall be made available in alternate accessible formats... An inclusive valuation process shall be followed by ensuring that a PWD is provided with any suitable flexibility and reasonable accommodation that may be required so that she/he may be evaluated fairly. Any information shared by an employee on disability/medical condition shall be kept confidential," the policy states. "If an employee acquires a disability during her/his employment tenure, she/he can return to work at the same rank and with the same service conditions as before. In case the employee is unable to perform the current job, the organisation shall invest in reskilling the employee for another position/ job at the same rank and if the same is not possible, the employee shall be posted on supernumerary post until a suitable post is available or he attains the age of superannuation, whichever is earlier," it adds. The policy further states that "as far as possible, the PWDs may be exempted from the rotational transfer policy/transfer and be allowed to continue in the same job, where · they would have achieved the optimum performance," and subject to availability, the Delhi HC should "provide accessible accommodation to the PWDs near their place of posting and they will be preferred for allotment of ground floor accommodation".PWDs employed in Delhi HC can also seek reimbursement for assistive aids and devices from the department from which they draw their salary under the policy. The policy also stipulates that any new facility that is built or renovated in Delhi HC "will be evaluated for compliance with accessibility standards at different stages of the building construction". The policy highlights that the buildings of Delhi HC already comply with the RPWD Act. This includes features such as ramps, grab bars, wider doorways for accessibility, lifts, tactile paths, and provisions for wheelchair access.

## Gateway of India to Elephanta Caves: the tourist route on which Mumbai ferry accident took place

Hundreds of tourists come to Mumbai in December, with many choosing to visit Gateway of India, which was built in the 20th century to commemorate the landing of King George V and Queen Mary in India in 1911. Its location on the waterfront, overlooking the Arabian Sea, also makes it a popular tourist choice, and many opt for a ferry ride. The tourists can choose between a quick joyride nearby or travel to Elephanta Caves or Mandwa jetty to the coastal town of Alibaug. The Mumbai ferry accident on Wednesday took place while the vessel was on its way to Elephanta Caves. At least 13 people, including four women and two children, were killed when an Indian Navy speedboat "lost control" during "engine trials" and crashed into the private ferry heading from Gateway of India to Elephanta Island.

Elephanta Caves or the island of GharapuriElephanta or Gharapuri is an island in the Arabian Sea about nine nautical miles or 11 km from Gateway of India, designated as a Unesco heritage site in 1987. The 7th-century caves, cutting into the granite hills, are the tourist attraction on the island which has a population of over 1,200. Its name comes from the large elephant-shaped sculpture on the island found by Portuguese navigators, and Gharapuri means a city of caves. To the east, is Stupa Hill with a small brick Buddhist

monument at the top, with two caves, and to the west, is a larger group of caves consisting of five rock-cut Hindu shrines, the ministry says. According to the Ministry of Culture and Tourism, the caves, "constitute one of the most striking collections of rock art in India". "The main cave is universally famous for its carvings to the glory of Shiva, who is exalted in various forms and actions," the ministry website says. Tourists usually take an hour-long ferry ride to Elephanta Caves from Gateway of India, with ferries operating every 30 minutes to an hour, usually from 9 am, with the last one departing from the island at around 5 pm. After alighting at Elephanta, tourists can take a toy train to the foot of the village or walk. Once in the village, tourists can walk over 100 steps to reach the caves. Many groups offer day-long trips to the island, with estimates that a million tourists visit the island per year. The ferries from Gateway of India are the most popular way of reaching the island. Another route is from Belapur to Navi Mumbai. Since Gateway of India is a popular tourist spot, most of the visitors to the island take this route. Most of the ferries which ply to the island are wooden boats, which usually offer an affordable fare of Rs 100, and above, depending on whether people choose the upper or lower decks. En route, tourists can see commercial ships, including tankers or cargo ships. While returning, tourists get a complete view of the Apollo Bunder, including the Taj Hotel. Around 80 wooden boats operate on routes to Elephanta and Mandwa, accommodating an average of 2,000 passengers daily — a number that goes up on weekends and holidays. While life jackets are mandated to be on the ferries for emergencies, passengers are not asked to wear those during the ride, unlike in many tourist boats elsewhere where they are mandatory at the time of boarding. There have been no incidents of boats capsizing on the Elephanta route recently. In 2020, a boat on the way to Mandwa capsized but all 88 passengers

Naidu's Telugu Desam Party (TDP) and Kumar's Janata Dal (United) are key BJP allies. "Babasaheb is not just a leader but the soul of our nation. After this statement by the BJP, people expect you to deeply reflect on this issue...," Kejriwal said in the letter. The Opposition has been demanding Shah's "removal" from the Cabinet, accusing him of "insulting" Ambedkar in his remarks in Rajya Sabha. Prime Minister Narendra Modi reacted to the row by hitting out at the Congress "and its rotten ecosystem" for "their malicious lies". In a post on X, Kejriwal shared the letter and said, "BJP has insulted Babasaheb in Parliament. People feel that those who love Babasaheb cannot support BJP. You should also think about

In his letter, Kejriwal said, "Recently in Parliament, a statement made by the Home Minister of the country, Amit Shah Ji, regarding Babasaheb has left the entire nation stunned. His remark that 'chanting Ambedkar-Ambedkar longer support the BJP."



has become a fashion these days' is not only disrespectful but also reveals the BJP's perspective towards Babasaheb and our Constitution."Kejriwal further pointed out that Ambedkar was honoured with a 'Doctor of Laws' degree by Columbia University, had authored the Indian Constitution, and championed equal rights for the most marginalized sections of society. "How did the BJP have the audacity to make such a comment about him?" Kejriwal said.Saying that Shah's remark in Parliament had hurt the sentiments of millions of people across the country, Kejriwal said, "Instead of apologising for his statement, Amit Shah Ji justified it. The Prime Minister publicly supported Amit Shah Ji's remark, which added insult to injury...People are beginning to feel that those who revere Babasaheb can no longer support the BJP."

## RG Kar rape and murder victim's parents move Calcutta High Court, seeking fresh investigation

RG Kar hospital rape and murder case, calcutta high court, indian expressIn court, their counsel stated that the parents of the deceased doctor do not have confidence in the current investigation, which is being led by the Central Bureau of Investigation The parents of the R G Kar rape and murder victim have moved the Calcutta High Court, seeking a fresh investigation into the murder of their daughter. In court, their counsel stated that the parents of the deceased doctor do not have confidence in the current investigation, which is being led by the Central Bureau of Investigation (CBI). They appealed to the court to order a fresh investigation "soon" as all the evidence "has disap-

peared in the name of this investigation". A single bench of Justice Tirthankar Ghosh has asked the CBI to be made a party in the case and ordered the matter to be taken up again on Monday. The day-to-day trial has already commenced in the case in a lower court and statements are already being recorded. Sandip Ghosh, former principal of R G Kar Medical College and Hospital, and Abhijit Mondol then officer-in-charge of Tala police station, were granted bail in the case by a court in Kolkata on December 14 after the CBI failed to submit a charge sheet within 90 days.On September 14, the CBI had arrested them for allegedly tampering with evidence in the case and allegedly trying to "hush up" the incident. Three days after a civic volunteer working for Kolkata police was arrested on suspicion of committing the August 9 crime, the Calcutta High Court transferred the investigation to the CBI, stating that the Kolkata Police's investigation did not inspire confidence. Junior doctors in West Bengal undertook a strike action for 42 days demanding a thorough probe of the incident and security at hospitals. The trial in the rape and murder case of a doctor commenced in a Kolkata court on November 11, three months after the body was found inside the state-run RG Kar Medical College and Hospital. The proceedings were held oncamera at the court of additional district and sessions judge

The Karnataka High Court on Tuesday passed an interim stay on criminal proceedings initiated against Arnab Goswami, Republic TV editor-in-chief and managing director, in a fake news case. The matter was heard on Tuesday afternoon by a bench consisting of Justice M Nagaprasanna of the Bengaluru bench, in response to a petition by Goswami to quash the proceedings. The case pertains to a complaint regarding a news report broadcast by Republic Kannada channel on March 27 which said that traffic on Bengaluru's MG Road was stopped to clear the way for Chief Minister Siddaramaiah, resulting in an ambulance getting stuck in the traffic. had earlier reported that Congress member Ravindra in his petition filed against Goswami and Republic Kannada editor Niranjan had pointed out that Siddaramaiah was actually in Mysuru at the time of the alleged incident. The complaint filed under Section 505

(2) (for creating enmity) of the Indian Penal Code (IPC) alleged that fake news had been broadcast ahead of the Lok Sabha elections to mislead the public. Goswami's counsel stated, "505 (2) is not attracted assuming entire material (is correct).....only by a few minutes oversight it was on air and then there was an apology". "The petitioner is hauled into these proceedings for offence punishable under 505 (2) of the IPC....the crux of the allegation is a news item aired on Republic TV Kannada where the information about public suffering due to....movement of the CM. The news appeared to be a canard. Immediately after, the news is deleted. All this happens within 24 hours. By then the respondent has sought to register the crime against the petitioner....it is ununderstandable as to how 505(2) could spring as to its remotest sense in the case at hand. If such reckless registrations were permitted to be continued, it would be an abuse of process of law," the bench stated.

## Mumbai boat accident: With 2 passengers still missing, search ops continue

mumbai boat accident, indian expressA military helicopter flies over a ferry during a rescue operation after a passenger boat capsized off the coast of India's financial capital Mumbai. A day after 13 people were killed after a Navy speedboat "lost control" and crashed into a private ferry off the Mumbai coast, search operations continued on Thursday as two passengers, a man and a child, were still reported missing. Coast Guard rescue teams along with other authorities are trying to locate the missing passengers, a defence spokesperson said on ThursdayOn Wednesday, the ferry, Neel Kamal, capsized off Karanja, Mumbai, at around 4 pm after a Navy speedboat, which was undergoing trials for a newly fitted engine, collided with it. At least 100 people were rescued by the Coast Guard and other security personnel. The accident took place after the new engine was fitted and six individuals — including four Original Engine Manufacturer representatives — began the trial. The rider allegedly lost control, leading to the collision with the ferry transporting passengers from Gateway of India to Elephanta Island, a popular tourist destination. While the exact cause of the incident is still unknown, it is suspected that engine malfunction led to the incident, the police sources said. Navy officials said that a board of inquiry would be held to understand the cause of the incident. "We will investigate how the engine malfunctioned and determine if any other factors contributed to the mishap," an official said. The Mumbai police have registered an FIR under relevant sections of negligence, among others, against the occupants of the speedboat, including the Navy boat driver, on the complaint of ferry passenger Natharam Chaudhary, who also shot a video of the incident

#### Haryana Agri minister Shyam Singh Rana plans to increase farmer incentive to stop stubble burning

Haryana Agriculture and Farmers' Welfare Minister Shyam Singh Rana (76) has stated that they (the government) will try to increase the incentive being given to the farmers for not indulging in stubble burning. Currently, the state government gives Rs 1,000 per acre for managing leftover paddy crop residue. The officials say this initiative is one of the chief factors which has reduced the stubble burning incidents by 47% this year in comparison to 2023. Talking to The Indian Express, Rana said: "We will try to increase this amount of incentive to the farmers.... It will be increased and then it would be the responsibility of the farmers to incorporate the leftover crop residue into their fields instead of burning it."

Rana, who comes from agriculture background, says during his farming days he used to incorporate the paddy crop residue into the soil as it enhances its (soil) tertility apart from increasing the crop production. "The right place for the leftover crop residue is the agricultural fields itself. Such a step would reduce the requirement of fertilisers and would make the soil self-reliant," he adds. The financial incentive of Rs 1,000 per acre to the farmers is one of the key initiatives of the state government to stop farm fires. Till now, as many as 1.87 lakh farmers have registered their 16.31 lakh acres to avail of the benefit of Rs 1,000 per acre with an undertaking that they would not indulge in stubble burning. This year paddy was sown in about 38.87 lakh acres in the state. In the financial year 2023-24, the state government had allocated Rs 120 crore to 1.10 lakh farmers under this scheme. Rana also urges the farmers not to burn the crop residue stating "if there is air pollution, it affects the farmer concerned and his family first".

The agriculture minister also shares the plans of the government to link the distribution of fertilisers, especially DAP (Di-ammonium phosphate), with the 'Meri Fasal-Mera Byora' portal of the government. At several places this year, the farmers had to stand in long queues to get bags of DAP for their mustard and wheat crops. At some places, the police were called to control the crowd of the farmers gathered to get DAP while the tokens for the fertiliser were distributed from Tosham police station after it (fertiliser) could not be distributed from a cooperative society as the farmers outnumbered the bags of the fertiliser. The officials claimed the shortage was the outcome of the panic and rush among Haryana farmers to take DAP bags as early as possible following reports of paucity of the fertiliser in other parts of the country.

Explaining about the new plan, Rana says: "The 'Meri Fasal-Mera Byora' portal has details of landholdings of all the farmers. It will be expanded to make a provision under which the farmers will be able to get fertiliser directly from the distributors as per their landholdings. With this, the farmers need not stand in queue and the problem will be solved forever."

Rana, who also looks after the animal husbandry, dairying, and fisheries portfolios, says services will be expanded in pet hospitals to ensure better care for pet dogs. He adds that the state government will formulate a comprehensive plan for stray dogs to ensure proper management and welfare. He insists that there will be no shortage of funds for the welfare of animals.

Political journey of RanaAn agriculturist by profession, Rana has been elected from Radaur constituency this time. He was Chief Parliamentary Secretary during the first BJP government led by Manohar Lal Khattar in Haryana. Rana was among four BJP leaders who had announced their support to the farmers agitating against the now-repealed three central farm laws in 2020. Rana had then left the BJP over the contentious issue of farm laws and joined the Indian National Lok Dal (INLD). However, in July this year, he returned to the saffron party and contested the election from Radaur. Earlier in 2014 too, Rana was elected to the Haryana Assembly from Radaur on a BJP ticket. In 2019, the BJP had fielded the then minister and sitting MLA (from Indri), Karan Dev Kamboj, from Radaur in place of Rana but Kamboj had lost the elections.

#### 'Platelet-rich plasma helps in early stages of knee osteoarthritis'

osteoarthritisDr. Patel's study has established crucial insights into the therapeutic potential of PRP, paving the way for enhanced treatments for knee osteoarthritis.Dr Sandeep Patel, Associate Professor at the Department of Orthopaedics, Postgraduate Institute of Medical Education and Research (PGIMER), Chandigarh, has recently been honoured with the Gold Medal for Best Published Orthopedic Research of 2024 at the 69th National Conference of the Indian Orthopaedic Association (IOACON). The accolade celebrates Dr Patel's research on the Chondroprotective Role of Single Platelet-Rich Plasma (PRP) Injection for Osteoarthritis (OA) in guinea pigs. His study has established crucial insights into the therapeutic potential of PRP, paving the way for enhanced treatments for knee osteoarthritis. He has published three studies in internationally reputed journals, elucidating the role of PRP in knee osteoarthritis. His extensive body of work includes defining the ideal PRP dose for knee osteoarthritis, termed as Superdose PRP, investigating the variables critical to PRP efficacy, such as injection protocols, dose optimisation and the use of activators, and conducting experimental research using guinea pigs to explore PRP's dual mechanism of action in reducing inflammation and protecting cartilage by delaying apoptosis. Dr Patel talks about the latest advancements in the field and how PRP is used in patient care at the PGI. Please share key points of your three studies on the role of PRP in knee osteoarthritis. In the past 10 months, we have had three international publications on PRP and OA in various journals. Another landmark paper. which we published in February 2024 is on the ideal dose of platelets required for knee OA which we refer to as a Superdose PRP. Another Clinical trial (RCT) published in May 2024 addressed the need for an activator, along with PRP. We found no advantage of adding an activator. We aim to understand the product PRP better, how it acts for knee OA, and work on improving it to give the best results

What is regenerative orthopaedics and how are we using it on patients in PGI?

Regenerative orthopaedics involves using cells derived from our body to accelerate the repair of damaged tissues and possibly some regeneration. It's still in a nascent stage and a lot of research is happening across the globe to understand tissue healing better. PRP, bone marrow-derived mesenchymal stem cells, and gene therapy are some options. At PGI, we are using some of these for

How does PRP work and what are its benefits? What is superdose PRP?

PRP works for knee OA and provides relief from pain and better function primarily by decreasing inflammation responsible for pain. Symptoms of early knee or Grade 1 OA include recurrent and persistent knee pain and inflammation. This is when the joint has not worn out and pain is the first indicator, with a simple X-Ray needed to grade it. A clinical trial conducted by the department, studying the effects of administering PRP in the treatment of early arthritis indicates using a super dose PRP of 8 ml jumpstarts the healing of tissues as PRP gives signals to the body\tissues to start healing and working. The PRP has anti-inflammatory and regenerative properties and is used for knee arthritis. In place of 4 ml, an 8 ml dose of PRP, which contains 5 billion platelets helps in the repair. As the knee is a big joint, the super dose PRP is used for it, and it is most effective in early knee arthritis. PRP is a clinical decision and not a painkiller, and a signal for the body to stimulate and heal. As part of the PRP therapy, blood is drawn from a patient and platelets are separated from the blood and concentrated. Endowed with cytokines and growth factors, this helps in the repair and regeneration of tissues.

Your research mentions dual action.

Chondral remodelling means decreasing cartilage wearing, another important mechanism of PRP. It works by decreasing the death of cells (chondrocytes) found in the cartilage, improving collagen and other extracellular matrix substances. The challenge is to ensure a continued supply of these growth factors to knees for more prolonged action of these products. That is where repeated injection (12-18 months' gap) could be an effective option to ensure continued long-term effects.

What are the indications for using it?

Early stages of OA in young patients (45-60) and no mechanical malalignment are important. PRP is a biological solution for inflammation and cartilage cells. However, addressing other aspects like obesity, genetic predisposition and previous trauma is equally important. Giving a realistic expectation to the patient is important rather than promising wonders and expecting total regeneration, which helps decrease pain and improves functions. It should be used only as an adjunct, along with a multimodal management strategy, including lifestyle modification, weight loss

What are you working on these days?

We are working on different routes and sites of PRP injection into knees to target other areas responsible for OA pathogenesis. We are also looking at the growth factor profile and composition of Superdose PRP to understand it

What are your suggestions for keeping our knees healthy? Osteoarthritis, which refers to degeneration, is typically present from 50 years onwards. But at the PGI, we see many patients between 45 and 50 years with more degeneration. Lack of exercise weakens your muscles, but when you move, your circulation improves. Eat a healthful diet, keep your weight in control, don't self-medicate and

#### Indian pleads guilty in Florida court for 'trying to engage minor in sexual activity'

A 24-year-old Indian national from Gujarat, Kirtan Patel, pleaded guilty to "attempting to entice a minor to engage in sexual activity", according to a statement from the US Attorney's Office, Middle District of Florida, on Thursday. Patel, who was arrested in July this year, faces a minimum penalty of 10 years, up to life, in federal prison. A sentencing date is yet to be decided. He was among 33 men of various nationalities arrested after a sting operation by the Marion County Sheriff's Office (MCSO), along with assistance from the Ocala Police Department, Chiefland Police Department, and the Department of Homeland Security.Indian national from Gujarat, Kirtan Patel, gujarat news, indian express Indian national from Gujarat, Kirtan Patel was among the 33 men of various nationalities arrested after a sting operation by the Marion County Sheriff's Office (MCSO)Patel allegedly approached an undercover officer, posing as a minor online, "seeking to engage in sexual activity". According to officials of the Marion County Sheriff's office, in online interactions, Patel allegedly engaged in "sexually explicit conversations and graphically described the sexual acts"

According to the indictment, between May 22 and 24, Patel knowingly attempted to persuade and coerce an individual he believed had not yet attained 18 years of age to engage in sexual activity. This case was investigated by HSI Orlando and the MCSO. Patel was arrested on July 18 when he traveled to a location in Marion County to engage in sexual activity with the child. According to the indictment of the 33 men caught in the sting, nine, including Patel, had "actually travelled to have sex with minors". The MCSO re-



lease said, "Many of these (arrested) men arranged to meet with what they thought was a child between the ages of 13-15 years old. Some of them even travelled from outside of Florida to arrange meeting places. Deputies and detectives seized guns, drugs, cash, and vehicles from these offenders, and more arrests are expected as detectives follow up with various cases."The case is being prosecuted by Assistant United States Attorney Sarah Janette Swartzberg. "This case was brought as part of Project Safe Childhood, a nationwide initiative launched in May 2006 by the Department of Justice to combat the growing epidemic of child sexual exploitation and abuse. Led by United States Attorneys' Offices and the Criminal Division's Child Exploitation and Obscenity Section (CEOS), Project Safe Childhood marshals federal, state, and local resources to locate, apprehend, and prosecute individuals who sexually exploit children, and to identify and rescue victims," the release from the US Attorney's Office from Middle District, Florida,

#### School boys abused sexually opened up to fellow students during a game of drawing chits: Cops

Police who are investigating the case sexual abuse of two boys by a dance teacher at a city school said that the 10 and 11 year olds first opened up to fellow students while playing a game of drawing chits. The students then approached the school counsellor who in turn alerted the authorities. Police said that they were also investigating if any other students were subjected to abuse by the 39-yearold teacher who had been working with the school for the past two years. Officials said that the services of the teacher have been terminated as the incident came to light.

Two separate First Information Reports have been registered against the teacher under the provisions of the Protection of Children from Sexual Offences (POCSO) Act at a police station in the city. The two boys aged 10 and 11 are students of class 4 and 6 at the school. The accused teacher was arrested on Tuesday afternoon in connection to one of the two offences. On Wednesday the teacher was produced before a court in Pune and was remanded to police custody of four days. He will be arrested for the second case after his questioning in the first case gets over, offi-

Deputy Commissioner of Police Sambhaji Kadam said, "We now know that a group of students was playing a game

of drawing chits on Monday. The student who drew the chit had to speak or do something about the word that was in the chit. While talking about one of the words, the discussion shifted to the lessons learnt during the group counselling sessions on the concept of good touch and bad touch. It was at this point that the two boys opened up to the fellow students about the abuse by the accused teacher. The group of students then approached the school counsellor and the counsellor alerted the school management. The school authorities approached us and within less than an hour we arrested the accused teacher." DCP Kadam added, "Almost all the schools conduct group counselling sessions on 'good touch and bad touch' and other related concepts. Staff and officials from police stations also hold sessions at the schools in jurisdiction on these topics. We believe that because the students were sensitised in this regard and showed the courage to come forward and report, we could apprehend the accused.""We will now be establishing the sequence of events of the crime. Probe suggests that the accused teacher has abused the two students multiple times in the past with the latest incident being around a week ago. We will be speaking to other students and teachers and also looking at the CCTV cameras installed in the school as part of the investigation." an officer from the police sta-

#### 'Not improper or perverse': Kerala HC upholds panel's decision to hand over Communist leader's body for medical research

A Division Bench of Kerala High Court Wednesday dismissed the appeals filed by daughters of late Communist Party of India (Marxist) veteran MM Lawrence against handing over his body for medical research.Lawrence's daughters Asha and Sujatha Boban wanted to give a Christian burial for the Communist, but his son ML Sajeevan wanted to hand over the body to the Government Medical College, Ernakulam. Upholding the directive of the court's Single Bench, which ratified the decision to hand over the body for academic purposes, the Division Bench of Chief Justice Nitin Jamdar and Justice S Manu said: "Given the regrettable disagreement at the heart of the litigation, it is also preferable that quietus be reached in this case as soon as possible".

However, the daughters lawyer R Krishna Raj said

they would appeal the ruling in the Supreme Court in the next two days. In its ruling, the Division Bench noted that Asha's case wasn't that the deceased had expressed a desire to have his body buried following the Christian funerary practices. Instead, her claim is only on the basis of an inference she attempts to draw from the fact that her father had followed certain religious practices."That by itself is not a sufficient reason in our view to reject the more probable case of Sajeevan in the facts and circumstances of this

The court said Sajeevan had "rightly" submitted that there is no contradiction in as much as the deceased could be a devout Christian and yet wished to donate his body to science. The purpose of Section 4A of Anatomy Act, according to the court, was to enable persons to donate the body to institutions conducting studies in medical science and make the bodies other than unclaimed bodies available for furtherance of science. "This enactment does not contemplate adjudication of disputed questions," it said. "The decision of the government medical college (which examined the claims of the children of Lawrence and stood for donation of the body), cannot be termed improper or per-

Lawrence died in Kochi on September 21, at the age of 95. After Asha opposed the move to hand over the body for medical research, the high court, acting upon her petition, directed the government medical college to conduct a hearing. During the hearing, Lawrence son Sajeevan filed an affidavit claiming that on 9 March, 2024, when his mental faculties were intact, his father had told him and two other witnesses that he wanted his body donated for medical research. While an advisory council set up for the purpose recommended handing the body for medical research, Asha announced she would appeal the decision in court. Her sister Sujatha too eventually became a party in the case and

#### Behind extortion calls in Delhi, two 'gang members' passing info on targets from Rajasthan prison'

Over the past few weeks, a spate of extortion calls to businessmen in Delhi and NCR had kept citizens as well as the police on their toes. Police knew that gangsters, some of them in jail, were behind them but couldn't ascertain how they knew whom to target. Police have now solved the puzzle. It was two members of different gangs, lodged in the district jail at Rajasthan's Dausa, who were passing on the information that they got from a man on the outside, said officers. One of the men was Mehtab Kana, a member of the erstwhile Mukim Kala gang, said a senior police officer said Wednesday. The second was Sumit Yadav, an associate of gangster Lawrence Bishnoi.

Lodged in Dausa jail, the officer said, Kana has allegedly been providing the Lawrence Bishnoi syndicate tip-offs about businessmen who could be extorted in Delhi-NCR, he added. Hailing from Balwa Gurjan village in UP's Shamli, 31-year-old Kana — who also goes by the aliases Jeeva and Pradhan — has been booked in cases of murder, attempt to murder and robbery in UP and Rajasthan and is serving a life term in one of the cases, the officer added. Police said Kana was arrested in 2015 in connection with a November 2014 murder. He was lodged in a jail in Jaipur till early 2023, before being shifted to Dausa district jail. "In the interim, in 2021, Mukim Kala was killed in a Chitrakoot jail during a gang war. Since then, Kana has taken charge of the gang," the officer said. It was at Dausa jail in 2023, the officer claimed, that Kana allied his gang with the Lawrence Bishnoi-Hashim Baba syndicate. "During this time. he came in contact with Yadav who was initially lodged at a high-security prison in Ajmer in connection to a murder case before being shifted to the Dausa jail," the officer said. Police also found that the information was being passed on by Kana's relative.

"The relative, Irfan, lived in Delhi's Kabir Nagar, Kana asked Irfan to visit prominent places and markets in Delhi and get details of businessmen making huge profits. Irfan would get phone numbers of these businessmen and give



them to Kana, who, in turn, would share them with Yadav, the officer said, adding that Yadav would then forward the details to Rohit Godara, an aide of Lawrence Bishnoi, Police said Irfan's role came to light when a school owner at Jamia Nagar filed a complaint at Shaheen Bagh police station on November 5, claiming he received a call from Godara demanding Rs 2 crore. "Irfan and his associate had passed on the details of the school owner to Kana. Technical surveillance revealed Irfan used to contact Kana and Yadav in Dausa jail frequently," the officer said. On November 30, Irfan and his associate were arrested by a team of the Special Cell (New Delhi Range), police said. This was the second businessman whose information Irfan had passed on to Godara, said police. "In September, a jeans trader in Vikaspuri received an extortion call from Godara, which was also based on Irfan's information," the officer said. Police said Irfan (27), who was in the jeans trading business, didn't have a previous criminal record. "His brother is currently lodged in Mandoli jail, and was in contact with members of the Bishnoi-Baba gang. Through him, Irfan got in touch with Kana and Yadav," the officer said. After Irfan's arrest, Delhi Police has requested for production of Kana from Rajasthan, a police officer said. The officer said Kana was also instrumental in facilitating an alliance between Mukim Kala and gangster Anil Dujana in 2015; the latter arranged weapons, including AK 47, for the gang.

#### How will the AAP govt's free healthcare scheme for the elderly work?

Aam Aadmi Party (AAP) chief Arvind Kejriwal's latest announcement of free healthcare for Delhi voters aged 60 years and above poses a counter to BJP's allegations of neglecting the elderly population in the Capital by not adopting the Centre's Ayushman Bharat health insurance scheme.On Wednesday, Kejriwal announced that the 'Sanjeevani Yojana', which promises free medical care in government and private hospitals for all citizens above 60, will not have an income cap or upper limit for eligibility. "Chahe ameer ho ya gareeb, sabka ilaaj free mai karvaya jayega (Whether one is rich or poor, treatment will be free). We will bear the entire cost of the treatment," he said.

Earlier in the year, the AAP came under fire from Prime Minister Narendra Modi as he spoke about Delhi and West Bengal being the two states that were yet to implement the scheme. He said that he felt apologetic that he could not help the people of these two states. While a concrete policy is yet to be drafted, officials said, 'Sanjeevani Yojana' is being seen like an extension of the Delhi government's surgery referral scheme. Under this scheme, if a particular surgery cannot be performed at a government hospital, or if the waiting time for surgery is more than a month, the patient is referred to a private hospital and the cost is borne by the government. Over 12,000 people have availed of the scheme between 2022-24, as per government data. "We are already paying for surgeries in empanelled private hospitals as per the scheme's eligibility. This can be seen like an extension of that. Earlier, people would have to get referred to a private hospital by a government hospital doctor. Now that process will be eliminated," said Delhi Health Minister Saurabh Bharadwaj. At present, 81 hospitals are empanelled with the government for the implementation of the surgery scheme. These do not include hospitals run by Max Healthcare, Fortis Healthcare and Apollo Hospitals. "The number of empanelled hospitals can be increased if need be," Bharadwaj added.

Asked about the financial implication of the new scheme, officials said a detailed document was yet to be



drafted but the Health Department had prepared a preliminary report. "We have seen that under the Ayushman Bharat scheme, the expenditure per patient is not too high. We expect that the case will be the same in Delhi," the health minister added. A reply by Union Health Minister J P Nadda in the Lok Sabha on December 6 contained expenses incurred under the Ayushman Bharat scheme in districts in Gujarat and Tripura. In Ahmedabad district, in 2023-24, data shows, an average expenditure of Rs 28,773 was incurred per patient under the scheme. The number of beneficiaries that availed the benefit in the duration was over 1.49 lakh. Senior AAP leader, Jasmine Shah, meanwhile, posted on X that Delhi's expenditure on health schemes was higher than that allocated by the Centre for Ayushman Bharat. "The AAP government in Delhi spends Rs 9,000 crore annually on its health schemes whereas the annual budget of Ayushman Bharat scheme for the entire country is Rs 7,000 crore...," he wrote. When asked if the Delhi government still plans to find a way for the Ayushman Bharat scheme and its now proposed schemes to run parallelly, Bharadwaj said the government was not averse to it. "We are not against adopting the scheme. If it is a good fit for Delhi, we will consider it for sure," he told The Indian Express. Delhi Chief Minister Atishi in November said she had directed health department officials to see if there was a way for the Delhi government to adopt the Ayushman Bharat Scheme while not compromising on its free healthcare model.

## Invest in Bengal's Silicon Valley, has Rs 27k cr potential

I will return to my country and continue fighting for justice and release of ISKCON monk Chinmoy Krishna Das," says 75-year-old Rabindra Ghosh seated in the terrace of his son's Barrackpore residence as a stream of visitors crowd the house.

Ghosh, a Supreme Court lawyer of Bangladesh, however, feels that he is no longer able to recognise his country. "The interim government of Mohd Yunus claims that they are the new government, but this is not Bangladesh born in 1971. It's another Bangladesh, born on August 8, 2024 (the day the government of Sheikh Hasina was overthrown by a students' movement). The intention is to destroy the country. They are trying to create a new Bangladesh, and a new Pakistan," Ghosh, who reached Kolkata two days ago for medical treatment at AIIMS, Kalyani, tells The Indian Express. Ghosh, who is also the chairman of Bangladesh Minority Watch, twice tried to appear at the Chittagong metropolitan sessions judge's court to file a bail application for the ISKCON monk Das, arrested on sedition charge, but could not. "Chinmoy Krishna Das is a monk, with a very dedicated personality. He was doing very good work in Bangladesh, for the society and the country. He has been arrested on flimsy and false cases. It is not a sedition case. It is a concocted and motivated case. The sedition case was filed against him as his popularity was increasing in Bangladesh and that was not liked by a section of people. This arrest is an instigation by other political parties," Ghosh says, adding he received death threats for representing the monk in the court.

"It is a difficult situation. Most of the lawyers trying to defend Chinmoy Krishna Das have been implicated in murder cases... I, being a lawyer of the Supreme Court of Bangladesh, have been debarred from going to Chittagong to represent the monk in the court there. I have been told to



employ another lawyer from Chittagong Bar Association. Why? Many lawyers cannot go as they are afraid that they could be arrested. Since I have been representing Chinmoy Krishna Das in the court, many lawyers, especially those of the prosecution, are annoyed with me," says Ghosh. "When I went to the court and tried to argue in my client's' defence, most of the lawyers, belonging to the BNP (Bangladesh Nationalist Party), threatened me, heckled me. On the second day, the police saved me. The lawyers chanted slogans, calling me 'dalal of India'. In trying to meet Chinmoy Krishna Das in jail, I was harassed at every step," he says. "It is unfortunate as I am a citizen of Bangladesh. We achieved Independence in 1971, and I am a freedom fighter. But in spite of it, this discrimination continues. We are fighting against discrimination," he adds.

According to Ghosh, following the fall of the Hasina government, atrocities on people, particularly on religious minorities, have increased. "There is no law and order in the country. Minorities are being tortured and displaced from their homes... During Sheikh Hasina's rule, there was security of life, but now there is no security... Bangladesh has forgotten its past.

The country was liberated with the help of India. So many soldiers were killed by the Pakistan Army. The contribution of India is enormous, but the people have forgotten it... Everyone has to unite and decide that a peaceful existence is required. Only then, Bangladesh can reestablish democracy and secularism," he adds. Though his family worries about his safety and wants him to stay back in Kolkata, Ghosh says he is determined to return. "I am not afraid of death. I will return to my country and continue fighting for justice," he adds.



These efforts aim to equip officers with comprehensive knowledge and skills to handle every aspect of their duty effectively.

UP Director General of Police Prashant Kumar, emphasised the significance of preparedness, saying "Maha Kumbh will present a variety of challenges for police personnel. To address this, comprehensive training and



examinations are being conducted to ensure every officer understands their duties and can handle any situation confidently."SSP Kumbh Mela, Rajesh Kumar Dwivedi said, "Mandatory training classes are being conducted for all personnel deployed for Kumbh Mela duty. The sessions focus on diverse areas, including security, disaster management and practical on-ground challenges. Post-training, the personnel are tested on their knowledge, with questions covering topics such as disaster identification and resolution, route familiarity, Kumbh's spiritual and religious heritage, and geographical considerations." Deputy Superintendent of Police (Training) Sandeep Verma said that the examination follows a multiple-choice format, comprising 20 questions with a total of 100 marks. He said, "The exam duration is set at one hour. However, with most of its leaders allegedly detained a night ago, a group of party workers, led by UP Congress chief Ajay Rai, marched from the party office to the Assembly. Stopped by the police, the Congress workers tried to barge in, leading to a clash. The Congress alleged that Pandey, who was also taking part in the protest, died after he was injured in the



clash with police. "During the scuffle with police, Youth Congress worker Prabhat Pandey died... The responsibility for this lies with the Yogi Adityanath government and the state police," said Ajay Rai and demanded a financial aid of `1 crore to Pandey's family and a government job to the kin. The police said that the post-mortem will be conducted by a panel of doctors and it will be videographed.

#### Israel hits Yemen's ports, tells Houthis 'will reach you'

Israel's military said it "conducted precise strikes on Houthi military targets in Yemen -- including ports and energy infrastructure in Sanaa, which the Houthis have been using in ways that effectively contributed to their military actions.""I warn the leaders of the Houthi terrorist organisation: Israel's long arm will reach you too," Israeli Defence Minister Israel Katz said. Al-Masira, a media channel belonging to the Houthis, said a series of "aggressive

On December 9, a drone claimed by Houthis exploded on the top floor of a residential building in the central Israel city of Yavne, causing no casualties. In July, a Houthi drone attack in Tel Aviv killed an Israeli civilian, prompting retaliatory strikes on the Yemeni port of Hodeidah.

The Houthis have also regularly targeted shipping in the Red Sea and the Gulf of Aden, leading to retaliatory strikes on Huthi targets by United States and sometimes British forces. Israeli military spokesman Daniel Hagari said the group had become a "global threat," pointing to Iran's support for the rebels. "We will continue to act against anyone, anyone in the Middle East, that threatens the state of Israel "he said

## Elon Musk's possible meddling in U.K. politics stirs concern

Concerns are growing in the U.K. as tech billionaire Elon Musk takes an increasingly close interest in Britain's political scene, appearing to cosy up to hard-right firebrand lawmaker Nigel Farage. With Mr. Musk named to a new position in the incoming U.S. administration of Donald Trump, there are fears the world's richest man could seek to influence London's future ties with Washington.On Wednesday, Mr. Farage, who leads the upstart anti-immigration Reform U.K. party, said he was in talks with Mr. Musk about making a donation to his party. Writing in the Telegraph newspaper, Mr. Farage said "the issue of money was discussed" when he met the X owner at Trump's Mara-Lago resort in Florida on Monday. "There will be ongoing negotiations on that score," the arch-Eurosceptic wrote, in comments that will likely unnerve the ruling Labour party and main Conservative opposition. Newspaper reports have suggested that Mr. Musk is preparing to donate up to \$100 million to Reform but Mr. Farage told the BBC the pair did not discuss figures

Mr. Musk "described the Labour and Conservative parties as the uniparty, and left us in no doubt that he is right behind us", Mr. Farage added.Mr. Farage said they would have to find a way to ensure any donation from Mr. Musk was made "legally through U.K. companies" but the idea which emerged a few weeks ago has already sent shivers down the spines of U.K. lawmakers.Reform U.K. won five seats in the 650-seat U.K. parliament in July's general election, draining support from both Labour and the Tories.Police stateMr. Farage is already eyeing the next general elections, which have to be held by 2029 at the latest.Conservative party co-chairman Dominic Johnson said any such donation by Mr. Musk would be "basically buying" one of the U.K.'s political parties. "People like Elon Musk, like Donald Trump, like Nigel Farage ... the sort of the new right, they really hate the old right" which is seen as having become too liberal, said Russell Foster, senior lecturer in British and International politics at King's College. This old right "were not killed off by the left or centre. They're killed off because a more right-wing movement comes along". So far, Mr. Musk has contented himself with taking aim at the Labour government of Prime Minister Keir Starmer, launching a series of searing comments on his social network X."The people of Britain have had enough of a tyrannical police state," he stormed in November. At the height of this summer's anti-immigrant riots — the UK's



worst unrest in years - Mr. Musk wrote in X that "civil war is inevitable" and accused the government of dealing with the rioters too harshly. It won him support among UK social network users and influencers on the far-right.Mr. Musk also advised people in September not to visit the UK when "they're releasing convicted pedophiles in order to imprison people for social media posts". "He appears to believe that he is on some sort of a mission against the establishment," said Mr. Foster.PragmatismSome observers believe Mr. Musk is also up in arms about U.K. government plans to toughen legislation regulating social networks.Mr. Starmer said the riots had been fuelled by online content and later did not invite Mr. Musk to an investors' conference - something the SpaceX and Tesla CEO had taken as an insult, sources close to him said. Since the U.S. Presidential elections, Mr. Musk and Mr. Trump have become inseparable. and their "bromance" could complicate Labour's efforts to boost its ties with the Republicans.

Labour has historically been closer to the Democrats but Mr. Starmer, who met Mr. Trump in New York in September, has been seeking to open a new chapter in the party's relations with Republicans."The Prime Minister looks forward to working with President Trump and his whole team including Elon Musk," a Downing Street spokesman said last month. "Starmer is very aware that he can't alienate the incoming U.S. President," said Mr. Foster. "We think that we have to maintain that special relationship. So it doesn't matter who's in the White House, we're always going to be nice towards Washington."Labour politician and former cabinet minister Peter Mandelson said it would be "unwise" for the UK to ignore Musk, calling on the Labour party to "swallow your pride. "He described Mr. Farage as a "bridgehead, both to President Trump and to Elon Musk and others. You've got to be pragmatic, practical about this".

## Trump brings chaos back by attempting to kill bipartisan budget deal with Musk's help

President-elect Donald Trump criticised the bill in his statement with Vice President-elect Vance and advocated for extending the debt ceiling with President Joe Biden in office. FilePresident-elect Donald Trump delivered a likely death blow to bipartisan congressional budget negotiations on Wednesday (December 18, 2024), rejecting the measure as full of giveaways to Democrats as billionaire ally Elon Musk whipped up outrage toward the bill and cheered on Republican lawmakers who announced their opposition.

Mr. Trump's joint statement with Vice President-elect JD Vance, which stopped the bill in its tracks, punctuated a daylong torrent of social media posts by Mr. Musk attacking the budget legislation as full of excessive spending. "Kill the Bill!" Mr. Musk wrote on his social media platform X as he dangled primary challenges against anyone who voted for the budget deal, a threat Mr. Trump later echoed in a post of his own. The episode showcased the growing political influence of Mr. Musk, whom Mr. Trump has selected alongside entrepreneur Vivek Ramaswamy to spearhead the Department of Government Efficiency, a nongovernmental task force formed to find ways to fire federal workers, cut programmes and slash federal regulations. Mr. Musk, the world's richest man, spent around \$200 million to support Mr. Trump's candidacy this year. In his statement with Vance, Mr. Trump criticised the bill and advocated for extending the debt ceiling with President Joe Biden in office. "Increasing the debt ceiling is not great but we'd rather do it on Mr. Biden's watch. If Democrats won't cooperate on a debt ceiling increase now, what makes anyone think they would do it in June during our administration? Let's have this debate over the debt ceiling now." Mr. Trump's opposition to what was considered must-pass legislation reinjected a sense of chaos and political brinkmanship that was reminiscent of his first term in office. It was a dramatic turn of events for House Speaker Mike Johnson, who negotiated the bill and has been under-

mined by Mr. Trump as he faces reelection for his post in



just a couple of weeks. Republicans have a slim majority, raising the possibility of a replay of leadership disputes that paralysed the House a year ago. President Joe Biden's administration criticised the possibility of a shutdown."Republicans need to stop playing politics with this bipartisan agreement or they will hurt hardworking Americans and create instability across the country," said White House press secretary Karine Jean-Pierre. Grover Norquist, president of Americans for Tax Reform and a veteran of Washington's budget battles, was concerned about the lack of a clear plan for how to resolve the dispute. "There's got to be a second part of the strategy," he said. But others were thrilled, particularly with Mr. Musk's involvement. "In five years in Congress, I've been awaiting a fundamental change in the dynamic," posted Rep. Dan Bishop, a Republican from North Carolina. "It has arrived." Mr. Musk began criticising the measure as soon as it was released on Tuesday (December 17, 2024) evening, and he continuously posted about it on Wednesday (December 18, 2024). "Stop the steal of your tax dollars!" he wrote. He also called it "one of the worst bills ever written". Sometimes he amplified false claims, such as the idea that the legislation included \$3 billion for a new football stadium in Washington. In reality, the legislation would transfer ownership of the land from the federal government to the city, paving the way for eventual development.

### Chinese national cyber centre says U.S. hacks stole trade secrets from tech firms

China's national internet emergency response centre said on Wednesday it had found and dealt with two incidents of U.S. cyber attacks on Chinese tech firms to "steal trade secrets" since May 2023. The National Computer Network Emergency Response Technical Team/Coordination Centre of China (CNCERT/CC) said in a statement published on its website that an advanced materials design and research unit and a large-scale high-tech company focused on intelligent energy and digital information were "suspected of being attacked by a U.S. intelligence agency",

without naming the agency.

The hacks led to the theft of "a large amount of trade secrets" in both cases, said CNCERT/CC, which says it is a non-governmental technical centre that serves as China's "national computer emergency response team", with the aim of preventing and detecting cybersecurity threats to the country. After years of being accused by Western governments of cyberattacks and industrial espionage, in the past two years several Chinese organisations and government organs have accused the United States and its allies of similar behaviour. The CNCERT/CC statement echoes accusations from the United States and its allies that China engages in state-led campaigns to steal trade secrets. It also comes at a time when China is dealing with a growing number of U.S. export controls targeting its domestic semiconductor and artificial intelligence industries. The U.S. Department of State did not immediately respond to a request for comment on CNCERT/CC's statement.In March 2022 CNCERT/CC said China had faced a wave of cyberattacks, mostly traced back to the United States but with a few from other countries such as Germany and the Netherlands. These attacks took control of computers in China and used them to carry out cyberattacks on Russia, Ukraine and Belarus, it said.

## U.S. lawmaker seeks targeted sanctions against Bangladesh

Expressing a sense of urgency on the escalating crisis of human rights violations in Bangladesh, an influential American Congressman called on the US Departments of Treasury and State on Wednesday to impose and enforce sanctions on those perpetrating these heinous acts against minorities in the South Asian country."I call on the Departments of Treasury and State to impose and enforce sanctions on those perpetrating these heinous acts against minorities in Bangladesh," Indian American Congressman Shri Thanedar said in front of the US Capitol on Wednesday (December 18, 2024) in the presence of Hindu Americans who had come from various parts of the country. Since July, he said, Bangladesh has experienced a spike in political violence, leading to the resignation and departure of former prime minister Sheikh Hasina. "Since then, we have seen Bangladesh plunge into political turmoil, with its Hindu, Buddhist and Christian minorities bearing the brunt of violent acts towards their people and places of worship by a majority Muslim population," Mr. Thanedar said. "The creation of a new government with Prime Minister Muhammad Yunus is yet another attempt in their history to obtain lasting peace and stability for the country. While I have my concerns regarding this new government, I am hopeful that with our assistance, Bangladesh will finally find a peaceful resolution to these conflicts," he said. The United States has a storied history of championing the oppressed and this issue should be no different, he noted. "When we receive a global call for help, we must respond appropriately as the world's bellwether of human rights. We must urge Prime Minister Muhammad Yunus to fulfil his promise of restoring peace and rebuilding the nation on the principles of equality and justice," Mr. Thanedar said.

Attack on Hindu temples "Hindu temples have been vandalised, burned and desecrated. Just this month, the



Iskcon Namhatta centre was burnt to the ground in a coordinated attack upon the Hindu people in Dhaka district of Bangladesh. Prior to that, over 70 temples throughout Bangladesh suffered similar attacks from mobs seeking to persecute Hindu minorities. Hindu religious leaders are regularly arrested on dubious charges and vulnerable communities have been forced to flee their homes in fear," he said.

Utsav Chakrabarti, executive director of HinduACTion, said what has happened in the last five-and-a-half months in Bangladesh clearly reflects that "Muhammad Yunus has failed to contain" his allies in the Jamaat-e-Islami who are now running around the country, burning temples, killing people, raping women and indulging in atrocities against priests and leaders from the Hindu community by incarcerating them. "It is incumbent upon our current administration as well as the upcoming administration to put sanctions on Bangladesh, as Congressman Thanedar has pointed out," Chakrabarti said. "It is important that we clearly chart out a path for safe autonomous zones for the Hindus, all 15 million (1.5 crore) of them, along with the Buddhists and Christians within the boundaries of Bangladesh," he said.

### Mumbai terror attack case: U.S. govt urges Supreme Court to dismiss Rana's petition for writ of certiorari

The United States government has urged the Supreme Court to dismiss "the petition for a writ of certiorari" filed by Mumbai-attack convict Tahawwur Rana, a Canadian national of Pakistani origin, against his extradition to India. India is seeking the extradition of Rana as he is wanted in the Mumbai terror attack case. Having lost the legal battle in lower courts and several federal courts, including the U.S. Court of Appeals for the North Circuit in San Francisco, Rana on November 13 filed a "petition for a writ of certiorari" before the U.S. Supreme Court.In a long battle, this is Rana's last legal chance to not be extradited to India. "The petition for a writ of certiorari should be denied," U.S. Solicitor General Elizabeth B. Prelogar said in its filing before the Supreme Court on December 16, 2024. "Rana is not entitled to relief from extradition to India in this case," she argued in a 20-page submission.

In his "petition for a writ of certiorari to review the judgment of the United States Court of Appeals for the Ninth Circuit", Rana has argued that he was tried and acquitted in the federal court in the Northern District of Illinois (Chicago) on charges relating to the 2008 terrorist attack on Mumbai. "India now seeks to extradite him for trial on charges based on the identical conduct at issue in the Chicago case," the plea has said. "The government does not concede that all of



the conduct on which India seeks extradition was covered by the government's prosecution in this case. For example, India's forgery charges are based in part on conduct that was not charged in the United States: petitioner's use of false information in an application to formally open a branch office of the Immigration Law Centre submitted to the Reserve Bank of India," the U.S. Solicitor General said. "It is not clear that the jury's verdict in this case — which involves conspiracy charges and was somewhat difficult to parse — means that he has been 'convicted or acquitted' on all of the specific conduct that India has charged," Ms. Prelogar said

### Pelicot trial: Verdicts are due in the historic French rape trial that turned Gisèle Pelicot into a feminist hero

French judges plan to deliver hugely anticipated verdicts on Thursday (December 19, 2024) in a historic drugging-and-rape trial that has turned the victim, Gisèle Pelicot, into a feminist hero. Everything about the trial in the southern French city of Avignon has been exceptional, most of all Ms. Pelicot herself. She has been the epitome of steely dignity and resilience through the more than three months of appalling testimony, including extracts from her now exhusband's sordid library of homemade abuse videos. Dominique Pelicot carefully catalogued how he habitually tranquilized his wife of 50 years during their last decade together, so he and dozens of strangers he met online could rape her while she was unconscious. Staggeringly, he found it easy to recruit his alleged accomplices. Many had jobs. Most are fathers. They came from all walks of life, with the youngest in his 20s and the oldest in their 70s. In all, 50 men, including Dominique Pelicot, stood trial for aggravated rape and attempted rape. Another man was tried for aggravated sexual assault. They regarded me like a rag doll, like a garbage bag," Gisèle Pélicot testified in court. Sifting through the charges, the evidence, the backgrounds of the accused and their defenses took so long that Dominique and Gisèle Pelicot had birthdays

That also set the case apart from many others in which sexual violence is unreported or isn't prosecuted because the evidence isn't as strong. Gisèle Pelicot and her lawyers fought successfully for shocking video and other evidence to be heard and watched in open court, to show that she bore no shame and was clearly unconscious during the alleged rapes, undermining some defendants' claims that she might have been feigning sleep or even have been a willing participant. Her courage — one woman, alone, against dozens of men — proved inspirational. Supporters, mostly women, lined up early each day for a place in the court-

### Banks report spike in bad loans in personal loans, credit cards



Banks Bad LoansAccording to RBI data, credit card NPAs have shot up by 136 per cent from Rs 2,404 crore (1.82 per cent of advances) since March 2020 to Rs 5,679 crore (2.04 per cent) by June 2024.

Indian banks have touted their success in reducing non-performing assets (NPAs), or loans defaulted by borrowers, over the past two years. However, a closer look reveals an uneasy trend: a significant rise in NPAs within the personal loan and credit card segments. This spike coincides with a worrying increase in borrower indebtedness, casting a shadow over the sector's progress.NPAs in the personal loans segment have gone up by 51 per cent from Rs 7,422 crore, or 0.93 per cent of advances, in March 2023 to Rs 11,210 crore (1.16 per cent) in June 2024, the Reserve Bank of India (RBI) said in its reply to a Right to Information (RTI) request filed by The Indian Express. The quantum of rise in NPAs in the three months up to June 2024 was even higher by Rs 1,522 crore from Rs 9,688 crore in March 2024, RBI data shows. This has happened at a time when banks managed to bring down overall gross NPAs from Rs 6.97 lakh crore (5.89 per cent of advances) in March 2022 to Rs 4.56 lakh crore (2.79 per cent) by March

According to RBI data, credit card NPAs have shot up by 136 per cent from Rs 2,404 crore (1.82 per cent of advances) since March 2020 to Rs 5,679 crore (2.04 per cent) by June 2024. NPAs in the credit card segment rose by 39.46 per cent from Rs 4,072 crore in March 2023 by June 2024. Both personal loans and credit card outstanding are unsecured in nature and carry high interest rates. A loan account becomes an NPA when the interest or principal instalment is more than 90 days overdue.

cardsWhen a customer delays repayment of his credit card bill beyond the billing cycle, the bank charges a high interest rate of 42-46 per cent interest per annum on the outstanding dues and his credit score also plummets. In November 2023, the RBI had increased risk weight on the exposure of banks towards consumer credit, credit card receivables and non-banking finance companies (NBFCs) by 25 per cent up to 150 per cent. The move was aimed to address build-up of any risks in these segments. "Even as inquiry volumes remain robust, the impact of increase in risk weights on certain segments of consumer credit pulled down the rate of growth in overall consumer credit, especially personal loans and credit cards," the RBI's FSR report said.

The unsecured business loans segment has started showing early signs of stress in asset quality, possibly due to the increasing competitive intensity among lenders, continuing pressure on cash flows in certain end-borrower segments, on-field attrition, lower-than-expected recoveries leading to higher write-offs and overleveraging of borrowers, India Ratings said in a report. Credit card use is rising rapidly in the country if the customer spends through this route, are any indication. The value of credit card transactions tripled in the last three years to Rs 18.31 lakh crore during the year ended March 2024 from Rs 6.30 lakh crore in March 2021 with the economy coming out of the problems created by the Covid pandemic and consumer confidence increasing steadily over the last several quarters.

The value of credit card transactions rose from Rs 6.30 lakh crore to Rs 9.71 lakh crore during the year ended March 2022 and Rs 14.32 lakh crore as of March 2023, according to Reserve Bank of India data. The monthly spends by card users are now above Rs 1.50 lakh crore and remained at Rs 176,202 crore in the month of September this year. It was Rs 72,319 crore in March 2021. The number of credit cards issued by banks also rose rapidly to 10.61 crore as of September 2024 from 9.3 crore in September 2023, 7.36 crore in March 2022 and 6.20 crore in March 2021, RBI data shows. However, credit card outstanding has gone up to Rs 281,392 crore as of October 2024 as against Rs 249,635 crore in 2022. Card outstanding is the amount due from customers after the interestfree period offered by banks. What have lured customers to the credit card segment are incentives like rewards on higher spending, loan offers and lounge benefits. "Customers should realise that if they keep card dues beyond the interest-free period, they end up paying an interest rate of up to 42 per cent in some cases. It will put them in a debt trap,"

## Adani, under bribery scrutiny, pressed by Bangladesh to reopen power deal

Bangladesh's interim government has accused energy supplier Adani Power of breaching a multi-billion-dollar agreement by withholding tax benefits that a power plant central to the deal received from New Delhi, according to documents seen by Reuters. In 2017, the Indian company controlled by billionaire Gautam Adani signed an agreement with Bangladesh to provide power from its coal-fired plant in eastern India. Dhaka has said it hopes to renegotiate the deal, which was awarded by then-Prime Minister Sheikh Hasina without a tender process and costs Bangladesh far more than its other coal power deals, according to Bangladesh power agency documents and letters between the two parties reviewed by Reuters, as well as interviews with six Bangladesh officials.

Dhaka has been behind on payments to Adani Power since supply started in July 2023. It owes several hundred million dollars for energy that has already been supplied, Bangladesh's de facto power minister Muhammad Fouzul Kabir Khan told Reuters the country now had enough domestic capacity to cope without the Adani supply, though not all domestic power generators were operational. Nobel peace prize laureate Muhammad Yunus took power in August after a student-led revolution ousted Hasina, who critics accuse of stifling democracy and mismanaging the economy. She ran Bangladesh for most of the last two decades and was a close ally of Indian Prime Minister Narendra Modi. Reuters is reporting for the first time that the contract came with an additional implementation agreement that addressed the transfer of tax benefits. The news agency is also revealing details about Bangladesh's plan to reopen the 25-year deal, and that it hopes to use the fallout from U.S. prosecutors' November indictment of Adani and seven other executives for their alleged role in a \$265 million bribery scheme to press for a resolution. Adani Power has not been accused of wrongdoing in Bangladesh. A company spokesperson said in response to Reuters' questions that it had upheld all contractual obligations and had no indication Dhaka was reviewing the contract. The company did not answer questions about the tax benefits and other issues raised by Bangladesh.

The company said the Bangladesh deal helped further Indian foreign policy objectives and Delhi in 2019 declared the plant part of a special economic zone. It enjoys incentives such as exemptions on income tax and other levies. The power supplier was required to inform Bangladesh swiftly of changes in the plant's tax status and to pass on the "benefit of a tax exemption" from India's government, according to the contract and implementation agreement signed on Nov. 5, 2017 between Adani Power and the state-run Bangladesh Power Development Board (BPDB). But Adani Power did not do so, according to letters sent by BPDB on Sept. 17, 2024 and Oct. 22, 2024 that urged it to remit the benefits. The agreements and letters are not public but were seen by Reuters. Two BPDB officials, who spoke on condition of anonymity because they were not authorised to talk to the media, said they did not receive responses.

BPDB estimates savings of roughly 0.35 cents per unit of power if the benefit was passed on, the officials said. The Godda plant supplied 8.16 billion units in the year to June 30, 2024, according to an undated Bangladesh government summary of power purchases seen by Reuters, suggesting potential savings of about \$28.6 million. Power minister Khan said the savings would be a key part of future discussions with Adani Power. 'Negotiated hastily' Bangladesh in November scrapped a 2010 law that allowed Hasina to award some energy deals without a competitive bidding process. The absence of tenders is unusual, said Tim Buckley, director of Australia's Climate Energy Finance think-tank, adding that auctions ensure "the best price possible."

In September, Yunus's government appointed a panel of experts to examine major energy deals signed by Hasina. A Bangladesh court has separately ordered a probe of the Adani deal. Another panel asked to study the economy said in a white paper submitted to Yunus on Dec. 1 that the US




charges against Adani meant Bangladesh should "scrutinise" the power deal, which it described as "negotiated hastily." Hasina, who has not been seen in public since she fled to India, could not be reached. Her son and adviser Sajeeb Wazed told Reuters he was not aware of the Adani Power deal but that he was "sure there was no corruption." "I can only assume the Indian government lobbied for this deal so it was made," he said in response to allegations of political interference. Modi's office and other Indian officials did not respond to requests for comment HardballOn Oct. 31. Adani Power halved the power supply from Godda in response to the payment dispute with Bangladesh. The company in a July 1 letter seen by Reuters also rejected a request from BPDB to extend a discount it had offered until May - resulting in savings of about \$13 million for Bangladesh. It said it would not consider further discounts until payment was cleared. Adani Power contends it is owed \$900 million, while BPDB says arrears are about \$650 million. Bangladesh suffers from a dollar shortage and BPBD officials told Reuters they haven't been able to obtain sufficient foreign currency for payment. The halving of supply particularly angered Bangladesh, BPDB Chair Md. Rezaul Karim said, because it came after Dhaka in October remitted \$97 million to Adani Power - its highest monthly payment this year. The dispute revolves around how power tariffs are calculated, with the 2017 agreement pricing off an average of two indices. The unit cost of energy from Godda was 55% above the average of all Indian power sold to Dhaka, according to the summary of Bangladesh's power purchases. Bangladesh is pressing for Adani Power to use other benchmarks that would lower the tariff after one of the indices was revised last year, said three BPDB sources. Adani Power has rejected that, one of them said, adding the two sides were meeting soon. The agreements stipulate that arbitration be carried out in Singapore, but Khan said Bangladesh's next move depended on the outcome of the court-ordered investigation. "If it is proven that bribery or irregularities had happened, then we will have to follow the court order if any cancellation happens," he said.

# Indian markets slump in early trade as US Fed indicates fewer rate cuts next year

Mumbai: Benchmark indices Sensex and Nifty slumped in early trade on Thursday following weak global market trends after the US Federal Reserve indicated fewer rate cuts next year. The 30-share BSE benchmark Sensex tanked 1,162.12 points to 79,020.08 in early trade. The NSE Nifty tumbled 328.55 points to 23,870.30.

All 30 blue-chip stocks were trading lower. Infosys, State Bank of India, Tata Steel, Asian Paints, JSW Steel, Bajaj Finserv, Bajaj Finance and Mahindra & Mahindra were the biggest laggards. In Asian markets, Seoul, Tokyo, Shanghai and Hong Kong were trading lower. Wall Street ended

## Is the viral Parkinson's Challenge Finger Test accurate?



Can you really test your risk for developing Parkinson's disease? Well, if some social media posts are to go by, you can with the help of the Parkinson's Challenge Finger Test. "Please ask adults over 50 years to perform this test to check their 10-year risk of getting Parkinson's disease," said Dr Siva Sundar, general medicine, demonstrating the practice along with his mother. The finger test, first demonstrated by neurosurgeon Dr Arun L Naik, requires one to be able to lock the index and middle finger of each hand, then touch the ring finger and thumb together while flapping the little finger for at least 60 times in 30 seconds.

Does it work?

Dr Pawan Ojha, director, neurology, Fortis Hiranandani Hospital, Vashi contested that the finger test, which according to the video can predict the risk of Parkinson's disease over 10 years, is not accurate. "Parkinson's disease does not simply entail a slowdown of body movement, it has a host of other symptoms too, such as tremors in the limbs, difficulty in walking, postural instability resulting in sudden falls, speech, cognitive and sleep disturbances. Hence to diagnose this condition a comprehensive test is needed, and the finger test is not comprehensive at all, as it relies

solely on one symptom i.e slowdown of movements," said Dr Ojha.Dr Sudhir Kumar, consultant neurologist, Apollo Hospitals, Hyderabad too mentioned that this test can not predict the future risk of Parkinson's disease. "In fact, there is no clinical test that can predict the risk," added Dr Kumar.

The finger-tapping test is part of a more comprehensive tool (PREDICT PD, published in 2014) aimed at predicting Parkinson's disease in Western countries. "PRE-DICT PD is an online test (including family history, nonmotor symptoms, and lifestyle factors), a keyboard-tapping task and a Smell Identification Test. One of the components of this test is the distal finger-tapping test," said Dr Ojha. However, it's important to note that the version of the distal finger-tapping test used in the Predict PD program differs from the one shown in the video. According to Dr Ojha, the Predict PD program deploys the keyboard tapping test, where individuals are asked to tap a keyboard for 30 seconds, those with Parkinson's will be less coordinated and slower than those without the condition. "Slowness is a common symptom associated with a lot of health conditions like arthritis, stroke, neuropathy, and muscle weakness," said Dr Ojha. Another test — PREDIGT — also incorporates genetic studies, such as identifying mutations in DNA. "Data is continuously being collected to improve these predictions over time. Therefore, one should avoid rushing to take the test shown in this video to assess one's risk of Parkinson's disease, as it could lead to confusion and unnecessary fear among the general public. Instead, one might consider taking the online survey PREDICT PD to understand the predisposition for Parkinson's disease. It should however be followed by a visit to a neurologist for verification of diagnosis and treatment if necessary," said



R Ashwin called it a day on his international career on Wednesday. The off-spinner has scalped 537 Test wickets and is regarded as one the best among his generation. Recalling conversations with him in Ashwin's early days at Chennai Super Kings former Australian cricketer Mathew Hayden said the "transference of information" was similar to the one he had with the late Bishan Singh Bedi. "I've been very privileged to share many a bus-side seat on the way to the ground in Tamil Nadu, at the beautiful Chepauk Stadium, and with the Chennai Super Kings. As a young kid, as I was coming to the end of my career, he'd cuddle up, and we'd talk about the gamehow he could counteract the sweeper and why I swept. So, in many ways, it was a transference of information, much like what I had with Bishan Bedi years ago. He's a lovely human being and a very enjoyable character to play with as well," Hayden said speaking on Star Sports.

In addition to the impeccable craft of bowling offspin, Ashwin was also a thinking cricketer and always had a plan up his sleeve to get the better out of the batsman. "A very smart cricketer. And you know, he's a cricketer who just stays on task, always working out a cunning plan. He's got great belief in his own ability. He's quite



polarizing in many ways when it comes to the cricketing public, and even to his own team—he's a very strong-minded person. But I personally want to wish Ashwin a wonderful retirement," Hayden said. Ashwin made his debut in 2011 against West Indies on the back of impressive stints for CSK in IPL. In addition to 537 Test wickets Ashwin also has scalped 156 ODI wickets and 72 T20I wickets. The 38-year-old said that despite retiring from international cricket he would continue to be part of domestic cricket in India and was also brought by CSK in the recent auction after Rajasthan Royals decided to let him go.

## 'Thanks for not running me out this day:'Aaron Finch's cheeky retirement message to R Ashwin

with the picture on his Instagram story. The incident occurred during the 2020 IPL when Finch was playing for Royal Challengers Bengaluru and Ashwin was representing Delhi Capitals. What made Ravichandran Ashwin retire in the middle of the Border-Gavaskar series? Beyond his troubling knee, events also seem to have prompted the decision over the last few months. When the Test season began with the home series against Bangladesh - in which he picked up the Man of the Series award - Ashwin still seemed to have at least a couple of years left in him. Although the series against New Zealand didn't go along the expected lines in terms of wickets, he still seemed to be in his element. That series defeat, as Ashwin admitted on his YouTube channel. was hard to overcome in the sense that a proud unbeaten home record had been dented. He would even search for answers with his two daughters. The Australia tour was supposed to be a means to get back on track, once he decided to join the tour. But once there, the writing seems to have been on the wall with the team management hinting that even if they played two spinners, Ashwin may not get a look-in. With the top order not putting up enough runs, India seems to be inclined towards Ravindra Jadeia and Washington Sundar, Ashwin spent compiling 537 Test wickets, 37 five-fors, 11 Man of the Series performances, six Test centuries and 14 fifties.

## Staging big athletics events can help boost India's credentials for Olympic bid: Sebastian Coe

Hosting a Continental Tour athletics event next August in Bhubaneswar and bidding to stage the 2028 Under-20 World Championships are good signs even as India prepares to bid for the 2036 Olympics, World Athletics president Sebastian Coe has said. Successful staging of major events can help India 'demonstrate a track record of sporting delivery at the international level' which will be helpful for the country in its quest to become the 2036 Summer Games host, according to Coe, who has thrown his hat in the ring for the post of the International Olympic Committee (IOC) president.

The AFI's 2025 calendar includes a bronze-level Continental Tour event in the Odisha capital on August 10 next year. During Coe's recent visit to India, the AFI also submitted a letter of intent to host the Under-20 World Championships. "First of all, I am very grateful to Indian athletics that they are showing the ambition to stage more of our events. I think if any country has Olympic ambitions, I certainly know India does, being able to demonstrate a track record of sporting delivery at the international level can only be helpful," the two-time Olympic 1500m champion said during a select roundtable interaction. "Evaluation teams and the sport need the confidence that events that are going to

be delivered at an Olympic level have been delivered at a world championships or global-competition level. That track record is important for any city that is wanting to present their credentials for delivering a very complicated and complex sporting event. There is nothing more complex than the Olympic and Paralympic Games."Talking about the country's chances of hosting big international events, Coe said: "India has some very important assets, it has a young population, a vibrant commercial market for sport and you have political will and recognition from the prime minister down that sports plays an essential role in nation-building and creating healthy communities, mentally and physically."India could host more international track and field events over the next few years with the Athletics Federation of India (AFI) in discussion with World Athletics about relay and road events. "AFI is ambitious, they have talked about relays and they have talked about world road championships. Their focus is more on the track than it is on the road. I never take lightly the ambition of a member federation that wants to stage our world championship events. I have received, on my recent visit to the Indian athletics federation, a letter of intent to stage the under-20 world championships which is good news and that now sits with our bidding team alongside other bids," Coe added.

## After R Ashwin's sudden retirement, Ravi Shastri opens up on MS Dhoni's shock retirement

When Ravichandran Ashwin chose to call time on his India career out of the blue on Wednesday after the third India vs Australia Test ended in a draw, former India coach Ravi Shastri could not help but draw parallels with the shock announcement from MS Dhoni in the dressing room that he was retiring from Tests. Just like Ashwin retired from Tests in the middle of the series, Dhoni too said goodbye with one Test remaining. Dhoni, in fact, was captaining the team and his retirement meant that Virat Kohli had to take over the reins for the final Test in Sydney for a series which was already lost by the Indian team.

Dhoni's retirement was a shock because India had managed to draw the Test at the MCG.

Narrating the scene on SEN Radio, Shastri said: "Dhoni didn't wait. I was the coach. He said, Ravi, I need to have a chat with the boys for five minutes. Since we drew the game at the MCG, I said, sure. I thought he would say, 'Boys, well done'. Instead, he just said, 'Thank you. I'm done with this." Shastri spoke of his shock at that announcement. "There's one Test match to go back. He just, you know, just walked up there. Five-minute speech. No tantrums, no shenanigans. 'I'm done. Thank you very much for your support. You know, I won't be there in Sydney, but my total support for you guys.' Because after that was the World Cup. And he was the captain of the World Cup side."Shastri then added: "I looked around the dressing room. I asked players if he had had a chat with them. No one had a clue. Even the guys who went out or spent time with him three days before that. No one had a clue he's going to come and say what he did. And he had played 94 or 95 Test matches. Normally, you know, in India, a player of his stature, if he plays his 100th Test match and they had given that Test match to say Ranchi, the whole town would have been there at the ground to celebrate that 100th Test... But none of that stuff for him. He just said, 'I want to pack my bags. I'm done with

"Now deservedly in Vini's hands, it means much more than his decisive role in the games and the extraordinary numbers in the 2023/24 season. His talent would be enough to win the award, but his power goes far beyond the field," Ronaldo wrote on Instagram.

"We are talking about one of the most valuable players today, a victim of televised racism with inconceivable frequency. How many anonymous Viniciuses does he represent? How many victims spread all over the place? A symbol of resistance and resilience, today Vini also leads the anti-racist struggle in world football, where impunity is as pernicious as the attacks. And those who remain silent are no less racist. The omission – especially by entities and authorities that have the legal power to confront and punish such practices – further reinforces the culture of erasure and disrespect towards black people. They tried to



erase you, my friend. And you rocked. THE BEST PLAYER IN THE WORLD IS BLACK AND BRAZILIAN!" he added in the post.On Tuesday, Real Madrid star Vinícius finally got his hands on a big global player award as he pipped Rodri by five points to win The Best award. "I don't even know where to begin," Vinícius said in Portuguese after receiving the award on stage. "It was so far away that it seemed impossible to get here. I was a kid who only played football barefoot on the streets of São Gonçalo, close to poverty and crime. "Getting here is something very important to me. I'm doing it for many children who think that everything is impossible and who think they can't get here."

#### The off-spinner who extricated his craft from the web of doosras and mystery deliveries

Ravichandran Ashwin Legacy retirementIndia's Ravichandran Ashwin shows the ball as he celebrates with teammates after taking 5 wickets on the fourth day of the first Test cricket match between India and Bangladesh at M. A. Chidambaram Stadium, in Chennai. In the grand pantheon of India's spinners, Ravichandran Ashwin would inhabit a rarified space, all unto himself. There have been wizards and magicians, artists and artisans, but few explored the craft with the zeal of a scientist, the curiosity of a child, or the industry of a sculptor like Ashwin. He was the greatest off-spinner his country has seen — and among the finest the world has produced, rubbing shoulders with Muttiah Muralitharan and Jim Laker, Harbhajan Singh and Ashwin's own contemporary Nathan Lyon.

His biggest legacy — apart from the numerical peaks was how he re-instilled the lost mystique to the art form. He did not glamorise the field like Shane Warne did legspin, or romanticise it like Muralitharan, or revolutionise it like Saglain Mushtag, but he instilled the soul back in offspin bowling, made it a riveting spectacle again, liberating it from the dubious doosra and mystery fixation of the aughts, expanded its scope and range, tessellated more layers, embellished it with post-modern syntax and diction. So much so that he is off-spin's renaissance man. There would be a clear demarcation as to how off-spin was before and after Ashwin. He was a classicist in a neo-classical age; he was neo-classical among classicists too. He made connoisseurs purr with his enticing flight and devilish drop; off his marvellously dexterous digits, the ball side-spun and overspun. He entrapped batsmen with both the simplest and complex set-ups. He evoked the envy of new-age spin tyros with his practised knack of flicking the ball with the index finger, in his expertise to use different grips. He bowled seam-up with as much dexterity as he deployed the square seam. No bowler possessed as many variations as Ashwin did since the departure of Shane Warne. On that scale, he was one of the game's originals, an irreproducible act. He was the perfect Indian spinner, assembled with a fearful symmetry. He blended the grace of Bishan Singh Bedi with the guile of Erapalli Prasanna, the brain and heart of Anil Kumble and the chutzpah of Harbhajan. That he batted better than all of them and could barge into a team as an allrounder was a dimension that the colossal shadow of his feats with the ball would overshadow. Facing Ashwin was akin to entering a labyrinth. There were variations within variations, snares within snares, subtleties within subtleties. Like Glenn McGrath, he often foxed the best batsmen of the visiting side. He consumed Joe Root seven times, Steve Smith eight and Kane Williamson on five instances. Left-handed virtuosos invoked the devil in him. Among his most prolific victims were Ben Stokes (12), David Warner (11), Alastair Cook (9) and Kumar Sangakkara four times in the space of 23 balls in the Sri Lankan's farewell series.

There was a ubiquity about the dismissals—bowling from around the stumps, drifting inwards, landing suddenly and deviously, a few metres behind the batsman's presumptions, the kiss of the edge, the snap of the stumps. A heavy dose of them would comprise any highlight reel tribute. But Ashwin's duels with right-handers were equally legendary. Two dismissals illustrate his command over his craft. One was Williamson in Kanpur in 2016, a ripping off- break from a good length area after a two-over tease of lengths. Another was the straighter one that nailed Smith in Adelaide in 2020, one that was plotted months in advance with video analyst Prasanna Agoram and polished to perfection in the intervening months. Method before magicHe rigorously studied batmen and dissected their flaws and strengths. Minute observations like Sangakkara doesn't get LBW to off-spinners or that Smith is more vulnerable outside the off-stump than on his pads, despite the massive shuffle. He once explained his thought patterns to this paper: "My preparation is whether I can disturb the tempo of a batter. Whether Smith would go to off-stump after 10 balls or 12 balls. Or Joe Root, when you go round the stumps in the first eight balls, he would reverse you once. There are two ways of skinning it, do I want to stop Joe Root from reversing or do I want Root to reverse or get him out?"The deconstruction of a batsman doesn't end here. "That will depend on where Root is in his career, how confident he is. Has he got a hundred in the first two Tests? Is he in confident space, is he coming from Sri Lanka after making mountains of runs? So I will try and make a plan because I want that early blood," he explains. Some misconstrued this as overthinking. But Ashwin stuck to his essence. "I come from a school where even before a particular method is broken, I want to make sure I stitch it up and don't get to a point where it's broken. Why is it happening? That's the question that people fail to recognise. I am addressing something before they believe I should address it," he detailed. He constantly fiddled with his action, experimenting with release points, grips and seam position. He picked new tricks from spinners far younger, he kept his senses open to the game's ceaseless evolution. He was content with his body of work, but kept the windows of perception open to add new dimensions. It was as though bowling spin was a spiritual, timeless quest. When he ambled in off his four-step stroll of a run-up, the arms whirling, the face a portrait of calm focus, he did not seem so much his country's greatest ever match-winner with the red ball as a philosopher in a pursuit of the deepest meaning and purpose of his vocation.
