Delhi liquor policy case: Centre's nod to ED to prosecute Arvind Kejriwal, Manish Sisodia

New Delhi: The Centre has given the go-ahead to the Enforcement Directorate (ED) to prosecute Aam Adami Party convenor and former Delhi Chief Minister Arvind Kejriwal in a money laundering case, sources have said, adding that it has also okayed the agency's prosecution push in the case against senior AAP leader and former Deputy CM Manish Sisodia. The Union Home Ministry has granted permission to the ED to prosecute Kejriwal under the Prevention of Money Laundering Act (PMLA) for alleged money laundering connected to the 2021-22 liquor scam case. The policy was later scrapped by the then-AAP government led by Kejriwal.

The move comes after the Supreme Court in November 2024, ruled that the ED also has to take prior sanction like the Central Bureau of Investigation (CBI) for prosecution under section 197 (1) of the Criminal Procedure Code (now section 218 of Bharatiya Nagarik Suraksha Sanhita) in money laundering cases. A special PMLA court in Delhi had paused framing of charges against Kejriwal after he moved the Delhi High Court challenging the trial court to take cognisance of the charge sheet in the absence of specific sanction for prosecution under PMLA.Lieutenant Governor V.K. Saxena last month gave the nod to the agency to prosecute Kejriwal.The CBI, which has filed a charge sheet under the Prevention of Corruption Act, got the requisite sanction in August 2024 in its parallel corruption case related to the excise policy. The ED arrested Kejriwal, who is out on bail and named him in a charge sheet claiming that bribes were



taken for favouring certain liquor traders for AAP's Goa election campaign. The probe agency had said that Kejriwal was ultimately responsible for funds being used and generated as the national convenor and member of AAP's national executive.Sisodia, who was the Excise Minister when the policy was framed, was also arrested in the money laundering case.Kejriwal and AAP have been accused of receiving bribes from the 'South Group', a cartel that controlled the sale and distribution of liquor

The veteran actor, who is also a former member of Rajya Sabha, had landed in further trouble attacking a television reporter after snatching the mike from his hand.Mohan Babu was booked for an attempt to murder. Mohan Babu and his sons were booked under BNS sections 329 (4) (criminal trespass and house trespass) and 115 (2) (voluntarily causing hurt) r/w 3 (5) in connection with the incidents that occurred at the house.Vishnu, who is backing his father and Manoj had separately appeared before Rachakonda Police Commissioner Sudheer Babu in response to the summons issued to them.

Doping continues to cast a long shadow on sports in ndia. The country has earned the dubious distinction of being second among nations with the most number of athetes currently ineligible to participate in international events. Adille Sumariwalla, outgoing president of the Athletics Federation of India (AFI), believes there is a silver lining to this lark cloud — more cheats are getting caught because greater testing is being done. However, the risk of being named, shamed and penalised is not outweighing the emptation to enhance one's performance fraudulently. The evel of deterrence remains low, even as unscrupulous elements keep trying out new ways to game the system.

It's not enough for the national federation to have zero olerance for doping. Strictness and transparency must percolate down to the district level, where the menace videly persists. If Sumariwalla is to be believed, district coaches are themselves supplying banned substances o up-and-coming players for short-term gains. It is comnendable that the Haryana Sports Department, roused to action by

The Tribune's damning report on drug use during a poxing championship in Hisar, has warned that federaions or associations would be suspended if doping occurs at any event organised by them. The message is oud and clear: sports bodies must face the music if they ail to weed out the black sheep.Unfortunately, once sportspersons get used to taking drugs and getting away with it, they rarely try to mend their ways. Hard work and self-belief — two of the most potent tools to excel in sports – are sacrificed at the altar of unfair means. The state of affairs can improve if the evil is nipped in the bud; the earier the clean-up happens, the better. A country aspiring to nost the Olympics can't afford to suffer the fate of Russia, which has become a global outcast in the sporting arena nainly due to rampant doping.

India's first robotic system performs complex cardiac telesurgeries

New Delhi: The made-in-India surgical robotic system SSI Mantra has successfully performed two robotic cardiac surgeries via telesurgery over a distance of 286 kilometres. The surgeries were performed remotely by Dr Sudhir Srivastava from Gurugram to Manipal Hospital Jaipur, using the SSI Mantra 3 Surgical Robotic System. The Telerobotic-assisted Internal Mammary Artery Harvesting procedure was conducted remotely in just 58 minutes. The surgery demonstrated exceptional precision with an incredibly low latency of just 35-40 milliseconds (1/20th of a second). This groundbreaking procedure was followed by another world-first, a robotic beating heart totally endoscopic coronary artery bypass (TECAB) — a procedure known as one of the most complex cardiac surgical procedures. This was also performed via telesurgery, connecting from Gurugram to Jaipur, with an incredibly low latency of just 40 milliseconds. "We are extremely thrilled to have advanced surgery capabilities to benefit humanity, especially in areas that need it the most. By enabling telesurgery, we can bridge gaps in access to medical expertise and deliver the highest standard of care, regardless of geographical barriers. For a country like India, with its vast rural population and significant healthcare disparities, this innovation is transformative," said Dr Sudhir Srivastava, SS Innovations founder, chairman, and CEO. This groundbreaking inter-state robotic cardiac telesurgery marks a significant leap in enhancing patient care through innovation. The remote robotic-assisted CABG on an elderly patient from Jaipur exemplifies how technology is bridging geographical gaps to provide accurate and timely medical interventions," said Dr Lalit Malik, chief of cardiac surgery at Manipal Hospital, Jaipur. Developed by SS Innovations, the SSI Mantra 3 Surgical Robotic System is the only robotic system in the world to have received regulatory approval for telesurgery and tele-proctoring. The recent approval of SSI Mantra 3 by the Central Drugs Standard Control Organization (CDSCO) opens the door to remote surgeries and medical education, enabling healthcare professionals to collaborate across distances. -IANS

After two postponements in maiden space docking mission, Isro says it will now 'dock and inform'

With the Indian Space Research Organisation's (Isro) SpaDeX space docking experiment missing two publicly announced schedules on January 7 and January 9, the space agency has decided to complete docking before making a public announcement. Isro had earlier announced that the docking would be a public event but after two consecutive postponements, a senior Isro official said that the docking "is on track" but the space agency will now "dock and inform" the public about the exercise. The postponement of the SpaDeX docking schedules has come amid the announcement of a change of guard at Isro with the Centre announcing V Narayanan as the new Isro chairman.Current Isro chairman S Somanath is set to hand over charge of the space agency to the new chairman on January 14. The SpaDeX (Space Docking Experiment) mission is intended to be a technology demonstrator for the docking of two small spacecraft launched by the Polar Satellite Launch Vehicle (PSLV) on December 30. Space docking is considered essential technology for India's space ambitions such as bringing back a sample from the moon (2027-28), the building of a space station - Bharativa Antariksh Station (BAS) - and a possible human landing on the moon. Isro launched two small spacecraft - SDX01 (the Chaser), and SDX02 (the Target) - in a low-Earth circular orbit on December 30 and set them apart at a distance of around 20 km in space to facilitate a gradual rendezvous through the closing of the distance for a final docking.

As part of the mission, after the initial 20 km inter-satellite separation, the Chaser spacecraft will approach the Target spacecraft by reducing the distance to five km, 1.5 km, 500 m, 225 m, 15 m, and 3 m before the ultimate docking of the two spacecraft. "After successful docking and rigidization, electrical power transfer between the two satellites will be demonstrated before undocking and separation of the two satellites to start the operation of their respective payloads for the expected mission life of up to two years," Isro said ahead of the launch of the mission.

After the successful launch and release of the two SpaDeX spacecraft into orbit, Isro had initially reported that the docking would take place on the morning of January 7.The agency, however, announced a postponement on January 6 saying, "The SpaDeX Docking scheduled on 7th is now postponed to 9th."The space agency said on January 8 that it had "initiated the drift on the Spacecraft to move closer from 500m to 225m."On January 9, the space agency announced that "the drift has been arrested and spacecraft put in a slow drift course to move closer to each other. By tomorrow, it is expected to reach initialisation conditions."Isro officials said that following the two postponements of the publicly announced docking exercise, the agency has decided to finalise the exercise before making any announcement.

"The docking experiment is called for on account of many reasons. The immediate one is Chandrayaan 4 but later for the space station planned for India," a former Isro official said. The Chandrayaan 4 mission involves several docking and undocking exercises both in the Earth orbit and the lunar orbit."Two modules launched by two launch vehicles will dock in the GTO and both modules will travel together to the moon and one of the modules will stay in the moon orbit and the others will go to the moon's surface and collect the sample."One of the modules that lands on the moon will also take off from the moon to the lunar orbit and will dock with the module that is parked in the lunar orbit," P Veeramuthuvel, Isro scientist and project director on the successful Chandrayaan 3 moon landing mission from 2023, said in October 2024 at the International Astronautical Conference in Milan."The samples collected will be transferred from the ascent module to the transfer module and finally the ascent module will get undocked and the transfer module will come out of the sphere of influence of the moon and travel to re-enter the Earth's orbit through a trans-Earth injection. Finally, the transfer module will eject the re-entry module and only the re-entry module will return to the Earth's atmosphere to a targeted landing site," he

king m' n inter-satvo km, 1.5 mate dock-'Zombie journey': Week after Delhi-Pune Air India Express flight was delayed by 10 hours, passengers recount ordeal

What began as a normal Delhi to Pune journey for passengers aboard Air India Express (AIX) flight IX 1176 last week, slowly turned into a nightmare as they were left waiting for over 10 hours in cramped seats, denied basic facilities and subjected to what they called "inhumane" treatment by the airline crew before finally taking off. The flight, scheduled to depart at 9.40 pm on January 3, took off at 8.10 am the following day. During the extended delay, passengers were kept onboard without food, water, or proper communication. A week has passed since and passengers continue to demand a written apology from the pilot and crew members of the flight for their ordeal.

"My hands and feet were swollen so badly. I was not able to walk. The moment I landed, I rushed to the Command Hospital in Pune to take an injection. I'm on medication though," said Hema Chhimwal, an autoimmune disease patient from Pune who was traveling with her daughter.Chhimwal, who was traveling from Jammu to Pune via Delhi, called her experience an "unforgettable zombie journey" and said, "You can imagine sitting, hanging your legs down all the time."

She added that after an entire night of sitting like that, she joined the queue of passengers in the hope of boarding an alternative aircraft. "Abruptly, we were asked to walk again to the security checkpoint, take off our jackets, shoes, and everything, only to return to the same aircraft," she said."It was a quarter to six when we were deboarded and underwent security checks again. That wasn't enoughwe still didn't fly after that," said Hema's daughter Gauri Shashikant, who was unwell for the next four days due to exhaustion.Geeta Arora, a banker from Delhi who was traveling to Pune for a meeting at her office headquarters, complained that as soon as she reached, she had to head to the meeting and join it without a break."The aircraft was literally on the runway the whole night and when we asked about food, the crew member was clueless...citing a certain timeline to distribute food. After some time, when an old woman shouted, they served biryani in the morning at around 4," Arora said.

Chhimwal recalled the chaos on the aircraft, with children crying and aged passengers coughing. She said that after around four hours onboard, an elderly passenger who protested the lack of facilities was reprimanded by the crew. "He was coughing and asked for help, but the air hostess shouted at him. They refused to offer anything, citing company policies," she said. Shashikant added that she could not bear to see her mother's condition, knowing how serious it was. "The pilot was too rude. He threatened us with blacklisting and security action. We understand their pressure, but they come from a hospitality background. The treatment was inhumane," she said.Chhimwal said that after much confrontation, a crew member approached the pilot, who shouted from the cockpit: "Now this flight is not going to go ahead. We are going to call security.""How can they bully us in the name of security personnel? What were the crew members fighting with us for? Just because they have a weapon called 'security'?" she asked. Showing her frustration, Arora told the crew that since they belonged to the service sector, they should have humanity. "The pilot and the other crew members were rude. It was surprising that the pilot was yelling at the public from the cockpit. He didn't have the courtesy to show up and say that 'yes they are with us'...nothing," she added. Shashikant also pointed out the unhygienic condition of the lavatory, saying it was "not meant for such a long duration." She added, "I had to reach my college by 9 in the morning to attend important lectures. I missed them, and was on bed rest for the next four days."

The three women said they were not demanding compensation for their mental and physical exhaustion but

As the vibrant harvest festival of Makar Sankranti falls on January 14, sustainable gifting ideas are adding a refreshing twist to the celebrations. Araatrika, a Pune-based start-up, has come with a 'paper kite kit' giving a green twist to the traditional Sankranti gift box that is exchanged by married women at the time of the festival that is also marked by kite-flying.Designed in the shape of a kite, the paper kit infused with Tulsi (basil) and marigold seeds contains biodegradable haldi-kumkum (turmeric and vermilion) shells made of vegetable protein.

As the gift kits mostly come in boxes made of plastic and synthetic materials, Araatrika founder Jagruti Jain says her products are affordable and totally environment friendly to the extent that the kits once thrown to the soil germinate into tulsi and marigold saplings."With the increasing use of plastic and synthetic materials during Sankranti has been an increasing carbon footprint. To address this we have designed Tulsi seed-infused 'plantable kites' which can be planted after use. The bio-degradable haldi-kumkum shells dissolve in water and are crafted to prevent littering of plastic containers. These pocket-friendly green products can be used as a giveaway alternative," said Jain, an architectturned-eco-entrepreneur, Araatrika was started in 2017 to promote sustainable living through eco-friendly products. 'To encourage 'vocal for local' all our products are made inhouse. The production is carried out majorly by women from Pune's under-sourced communities who work from their



homes," noted Jain, explaining her commitment towards reducing carbon footprint.Araatrika also has other customisable eco-friendly products such as seed pencils, upcycled diaries, seed raakhis, calendars with plantable papers, khunn toran and zero-waste birthday gifts among others.Sankranti traditionsMakar Sankranti is celebrated as a harvest festival that marks the transition of the Sun into the Capricorn zodiac (Makara Rashi). It marks the end of winter and the start of longer days with the Sun moving northwards. The celebrations are deeply rooted in traditions, such as the exchange of sesame seeds (til) and jaggery (gud), kite flying and 'haldi-kumkum' gatherings, where married women exchange turmeric and vermillion powder as a gesture of goodwill and social bonding.

Aspirants who dropped out between Nov 5-18, 2024 eligible for JEE-Advanced

New Delhi: The Supreme Court on Friday allowed petitioners, who dropped out from their courses between November 5 and November 18, 2024, to register for Joint Entrance Examination (JEE)-Advanced.

A bench of Justices BR Gavai and Augustine George Masih passed the order while hearing the pleas against bringing down from three to two, the attempts given to JEE-Advanced aspirants. The apex court noted the joint admission board (JAB), entrusted to conduct the JEE-Advanced exam, had issued a press release on November 5 last year which said students who appeared for the class 12 examination in academic years 2023, 2024 and 2025 would be eligible to appear for the JEE-Advanced. The bench further said on November 18, 2024, another press release was issued restricting the eligibility only to two academic years — 2024 and 2025.

"If the students, acting on the said representation (of November 5), have dropped from their course with an understanding that they would be entitled to appear for JEE examination, the withdrawal of the promise on November 18, 2024 cannot be permitted to act to their detriment," the bench held.

Meerut murders: Family of five wiped out, children's bodies found in bed box

Five members of a family, including three children aged eight, four and one whose bodies were stuffed in sacks and kept in a bed box, were found killed in their home, police said on Friday (January 10, 2025). Two persons were detained for the sensational murders that shocked this Uttar Pradesh town.Several suspects have also been taken into custody for the killing that came to light on Thursday (January 9, 2025) night. The bodies of the parents were wrapped in bedsheets. And all five had deep head injuries and slash marks on their necks.

Senior Superintendent of Police (SSP) Vipin Tada said, "Based on a complaint filed by the relatives of the deceased woman, a case has been registered against three named accused and some unidentified persons. Two named suspects and several others have been taken into custody for questioning."Police said the bodies of the husband and wife were found wrapped in bedsheets, while those of their three children were stuffed in the storage compartment of a bed at the family's home in the densely populated Suhail Garden neighbourhood in the Lisari Gate police station area. Tada added that one named suspect is absconding, and police teams have been deployed to arrest him. "All pieces of evidence are being gathered, and the case will be solved soon," he said. The deceased were identified as Moin alias Moinuddin (52), his wife Asma (45), and their daughters Afsah (8), Aziza (4), and Adeeba (1). The bodies of the children were found stuffed in sacks and hidden in the bed's storage, the police said, adding all the victims had deep head injuries and slash marks on their necks. According to the Lisari Gate police, Asma's brother, Shamim, lodged a formal complaint late at night. He accused Asma's younger sister-in-law, Nazrana, and her two brothers of involvement in the suspected murders. The SSP, who visited the crime scene Thursday night along with other senior officers, said the family's house was locked from outside when locals and neighbours checked it in the evening."After gaining access through the roof, they found the bodies," Tada told reporters. "The manner in which the house was locked suggests that the individual involved in the crime may have been someone known to the family."

Delhi International Airport Limited (DIAL) has unveiled an ambitious plan to refurbish Terminal 2 or T2 of the National Capital's Indira Gandhi International Airport which was built by the Airports Authority of India (AAI) four decades ago. T2 will undergo a comprehensive refurbishment to prepare for projected growth in air travel demand, said officials. The refurbishment work is set to commence in the 2025-26 financial year, with completion targeted by the second quarter, said officials. During the renovation, T2 will temporarily close for four to six months, with operations shifted to the newly expanded Terminal 1 to minimise disruption.With domestic air traffic witnessing unprecedented growth, the renovation will ensure that T2 meets increasing demand while enhancing passenger experience through better infrastructure, design and operational efficiency. The refurbished terminal will see six new Passenger Boarding Bridges (PBBs) sourced from South Korea which will be operated with autonomous docking technology for the first time in India. These bridges will also have elevated ramps for wheelchair accessibility, swing doors for better operator safety, and cushioned side covers for added aesthetics and safety. Additionally, significant upgrades to heating, ventilation and air conditioning (HVAC) systems and fire safety mechanisms will ensure security throughout the terminal. Aesthetic improvements to T2 will include the installation of modern ceilings and skylight designs, contributing to a more welcoming ambiance, said officials. Smart washrooms, advanced flooring, and enhanced road connectivity will further bolster passenger con-

improved real-time flight tracking capabilities with the installation of high-resolution Flight Information Display Systems (FIDS) alongside revamped signage for clearer communication, particularly for persons with reduced mobility.Simultaneously, airside and apron refurbishments will address infrastructure wear from four decades of service, ensuring smooth operations for increased traffic volumes, said officials. Airport aprons are areas where aircraft is parked, unloaded or loaded, refuelled, boarded, or maintained. Mega dams and Indigenous communities

Media reports on China's bid to build a big dam over the Chinese part of Brahmaputra, and India's exploration of the development of a large hydropower dam and reservoir on Siang River in Arunachal Pradesh "to mitigate the adverse impact of the Chinese dam projects" have raised much concern among environmentalists.

The news of China building new dams in Tibet on the Yarlung Zangbo River and on a tributary of the Ganga, close to the tri-junction of its borders with India and Nepal, that could be used to control the flow of water downstream has been published in news outlets since the last few years. Finally, on 25 December 2024, putting all doubts to rest, the Chinese government approved the construction of a hydropower project in the lower reaches of the Yarlung Zangbo River, the Tibetan name for the Brahmaputra, raising concerns about the displacement of communities in Tibet and environmental impacts downstream in India and Bangladesh.

India has expressed concerns that the dam could give China control over the river's flow and allow it to release large amounts of water in times of conflict, potentially flooding border areas due to the scale of the project. China defended its decision. The \$137-billion project, touted as the world's largest, is being constructed in the ecologically fragile Himalayan region along a tectonic plate boundary. Although the Chinese authorities have stressed that the Yarlung Zangbo project would not have a major environmental impact, they have not indicated how many people it would displace. The Three Gorges Dam required the resettlement of 1.4 million people. It is learnt that China has built several dams in Tibetan areas - a contentious subject in a region tightly controlled by Beijing ever since it was annexed in the 1950s. Tibetan activists have termed these dam as the latest example of Beijing's exploitation of Tibetans and their land. Chinese researchers have also flagged concerns that such extensive excavation and construction in the steep and narrow gorge in the eco-sensitive Tibet region would increase the frequency of landslides.Siang Indigenous Farmers' Forum has alleged that India's proposed hydropower dam on Siang River will render over 1,00,000 members of the Adi tribe landlessDespite the competitive showdown of building mega dams on the river that flows from Mount Kailash through Tibet to India and Bangladesh, changing its names, both India and China established the Expert Level Mechanism (ELM) in 2006 to discuss issues related to trans-border rivers under which China provides India with hydrological information on the Brahmaputra and Sutlei rivers during the flood seasons Data sharing of trans-border rivers figured in the talks between India and China Special Representatives (SRs) on December 18

India is all set to build an 11,000 Mw hydropower project on the Siang River in Arunachal's Upper Siang district. According to strategic analysts, India's move comes in response to China's plan to build the world's largest hydropower project. China has a history of using its dams to carry out transnational aggression. It is to be noted that in 2021, China cut the water flow of the Mekong River by 50% for three weeks without any warning. The flow was cut ostensibly for power-line maintenance but this affected millions of people living along the waterways in the Southeast Asian countries of Cambodia, Laos, Myanmar, Thailand and Viet-

The hydropower project India is building on Siang includes a "buffer storage" of over 9 billion cubic metres of water during peak monsoons. This would act as a reserve when water flow is reduced. It will also act as a buffer for downstream areas of Arunachal and Assam if China releases sudden water. However, the proposed Siang mega dam in Arunachal Pradesh, a bordering State to China, has been a subject of organised protest and resistance from the indigenous communities residing in the region like the Tibetans in China. The Siang Indigenous Farmers' Forum has alleged that the project would render over 1,00,000 members of the Adi tribe landless, threatening their survival and forcing them into poverty. These local communities view the dam as a potential disruption to their traditional governance systems and community-based ways of life. Local community leaders argue that the Siang River holds immense ecological significance, and its alteration could jeopardize the fragile balance of the region's biodiversity. The Brahmaputra basin has an area of 5,80,000 sqkm, which covers China (50.5%), India (33.6%), Bangladesh (8.1%) and Bhutan (7.8%). The length in India is 916 km. The Brahmaputra basin spans the States of Arunachal Pradesh, Assam, West Bengal, Meghalaya, Nagaland and the whole of Sikkim in India. This means that China does not contribute more than 50 per cent to the Brahmaputra flow. If is it so, the Chinese intervention in the water flow of Brahmaputra may affect only half. The fear of Bangladesh, the lowermost riparian country for the part of Brahmaputra, being affected by at least two mega dams - one at Tibet in China and the other one at Arunachal Pradesh of India - should also be considered while we study Brahmaputra.

Climatic change plays a crucial role in affecting the basin hydrology. Throughout the year, there is a significant rise in hydrograph, with a broad peak between July and September. The river flow is strongly influenced by snow and melting of the glaciers, which are located mainly in the eastern Himalayas regions in the upstream parts of the basin. The contribution of the snow and glacier melt to the total annual runoff is about 27%, while the annual rainfall contributes to the remaining amount. All these factors must be considered before hurriedly jumping to a conclusion. For both India and China, the focus should be on the benefits of mega dams vis a vis environmental challenges and their effect on the local communities, their livelihood tradition and culture. The local Indigenous communities should not fall victim to the competitive building of mega dams on rivers across the LAC which ultimately benefits big power companies and big businesses. The dispute between countries over the sharing of river water is nothing new. These should be resolved through dialogue, sharing of river data and involving the local communities of the regions with a practical scientific perspective. Political play infused with ultranationalism and big business interests should not intervene in the conflict-resolving mechanism.


The journey to Bowral is a leap back in time. The train swerves past rolling hills, scythes through jungle, slithers into tunnels, weaves across undulating plains with cattle grazing and horses stomping, tiny stations blur on the window, and the odd country home pops into view. Two hours away from Sydney, the Australian hinterland is even more pretty. Ancient churches, gnarled trees and the old post office are part of the mix. And Bowral, the land of Sir Don Bradman, is high on aesthetics and staggering history, all centred on one man with a Test average of 99.94, an Everest that can never be scaled.Past Cashmere Essentials and a bakery where the town's people gather for coffee, pies and gossip, the road turns left. Every step retraces a past when a lad hit a cricket ball and then became a colossus in the cricketing universe. "He used to smack the ball all over the park, didn't he?," an elderly gentleman pipes up

Hearing a 'who?', he says: "Bradman, who else?" Every individual seems to have a Bradman connection; in a sense they all own him, nurse his memory passed by awestruck grandparents, and they are mighty proud of him. All roads lead towards the Bradman Oval, the turf where the great man worked on his craft and became so good that his name had to be embossed on the venue. Inside, a lady walks her dog, two youngsters sprint, a few mimic the cover drive and pose for pictures, some make video calls back home. The ground is tree-fringed and in the distance, a green hill looms. The pavilion is woody and stately while Bradman's statue in the back garden, is charming. And just around the corner is the Bradman Museum.

This is not a place focussed on one man even if the name suggests that. It is a spot that celebrates cricket, that old game accidentally shaped by bored shepherds striking a ball with a clump of wood in the English countryside. Yes, the hat-tips to Bradman are there, his life and career are chronicled. There are old photographs, scorecards, a video on the Bodyline series and references to the squads he played in. Yet, there is no hint of narcissism. The history of the game, the Kerry Packer years, Ashes, the evolution of cricket gear, the laws of the sport and the mighty players all find space. On the walls, Sunil Gavaskar, Viv Richards and many others stare back. A section is earmarked for women cricketers. And in crisp videos, Ian Chappell, Dennis Lillee, Sachin Tendulkar and Rahul Dravid speak about the game, its past, the present and the road ahead.

Cricket's financial angle is touched upon too as one wall has a collage of advertisements featuring players hyping commercial products, be it a soft drink or protective sporting gear. It also reveals fashion trends of the past, crowbar moustaches and side whiskers, big collars and flared trousers. There are second-hand books to be picked, memorabilia to buy, and in this temple of cricket, one wall is extra special as it has pictures of the volunteers, who helped in the evolution of this museum. That human touch matters. It always does. And the man, who passed away in 2001, aged 92, endures. His is a legacy that would remain undimmed.

Lesson from Japan: A model for a hero in Indian textbooks

Most Japanese learn about Sontoku Ninomia in school. His statues are common in front of elementary schools in Japan and show him carrying firewood but reading a book.From business through health, Japanese concepts often enlighten and set the course for nations and cultures across the world. Japan's success in post-war reconstruction has led many to see pathways for their own potential success in the Japanese. Therefore these concepts come attached with much value.

Among the more recent ones is Ikigai – based on a book that spotlighted long living Okinawans. But Mayuko Kataoka, former journalist and presently in charge of international publishing at IRH Press Co. (Happy Science Group) of Japan, disputes that ikigai is central to Japanese life. "Kinben which stands for hard work and diligence is more basic to the Japanese. The kinben spirit helped Japan become industrialized," she says.Symbolizing the kinben spirit With responsibilities come challenges and adversities, however. Epiphanic moments in this journey of success include Sontoku asking himself if his lack of virtues made people turn away from him and if he wasn't running away from failure to dodge his responsibilities.Mayu says most Japanese grow up with Sontoku as a reference point. "As a child, I couldn't fully understand Sontoku since I didn't experience the kind of adversities he did," she says.

Mayu was 18 years old when she had a severe skin disease. She was ill for nearly a year. "When I went out, people would stare at me. Blood used to come out from my skin," she says, adding that's when Sontoku's life lessons resonated with her. The illness abated and Mayu made it to the university in Osaka where she learned Hindi.Adversity was part of local folklore for Mayu, however. Her origins are in Hiroshima. Mayu recalls how all the banks there were destroyed along with all the records by the atom bomb. But residents came together and truthfully recounted how much they had saved and deposited and how much they owed. In the end, all the accounts tallied. There was no dispute, she says.Sontoku was always mindful of others around him and shared generously. As a child, since he couldn't do farmwork as part of flood remediation, he chose to make sandals so those working in the fields could wear them. Mayu says the Sontoku way is Japanese capitalism that is not founded on individual avarice and a get-rich-quick approach.Sontoku is part of growing up in Japan. While Mayu bemoans falling values and individualism taking over in today's Japan, she feels the kinben spirit is still there. Most visitors observe how frugal the Japanese are. At work, the Japanese often make it a point to write on both sides of

Jimmy Carter was celebrated Thursday (January 9, 2025) for his personal humility and public service before, during and after his presidency in a funeral at Washington National Cathedral featuring the kind of pageantry the 39th U.S. president typically eschewed. It was followed by an intimate hometown funeral near where he was born a century ago. All of Carter's living successors attended in Washington, with President Joe Biden, who was the first sitting senator to endorse his 1976 run for the White House, eulogising his longtime friend. Mr. Biden and others took turns in the morning praising Carter's record — which many historians have appraised more favourably since he lost his bid for a second term in 1980 — and extolling his character.

The dual ceremonies in Washington and Plains, Georgia, provided a moment of national comity in a notably partisan era and offered a striking portrait of a president who was once judged a political failure, only for his life ultimately to be recognized as having lasting national and global impact. "He built houses for people who needed homes," said Joshua Carter, a grandson who recalled how Carter regularly taught Sunday school in Plains after leaving the White House. "He eliminated diseases in forgotten places. He waged peace anywhere in the world, wherever he saw a chance. He loved people."Jason Carter, another grandson, wryly noted his grandparents' frugality, such as washing and reusing Ziploc bags, and his grandfather's struggles with his cellphone.

"They were small-town people who never forgot who they were and where they were from, no matter what happened in their lives," said Jason, who chairs the Carter Center, a global humanitarian operation founded by Jimmy and his late wife, Rosalynn Carter.Former presidents in attendanceAt the national service, former President Barack Obama and President-elect Donald Trump, who have mocked each other for years going back to Trump fanning conspiracy theories about Obama's citizenship, sat next to each other and talked for several minutes, even sharing a laugh.Former President Barack Obama talks with President-elect Donald Trump as Melania Trump listens and as former President Geroge W. Those comments echoed Mr. Biden's typical criticisms of Mr. Trump.Eulogies

In Plains, Carter's personal pastor, Tony Lowden, touched on the political as well, saying Carter was "still teaching us a lesson" with the timing of his death as a new Congress begins its work and Mr. Trump prepares for a second administration. Lowden, who did not name Mr. Trump or others, urged the nation to follow Carter's example: "not self, but country.""Don't let his legacy die. Don't let this nation die," Lowden said. "Let faith and hope be our guardrails."The funeral procession of former President Jimmy Carter passes by on January Carter died December 29 at age 100, living so long that two of Thursday's eulogies were written by people who died before him - his vice president, Walter Mondale, and his presidential predecessor, Gerald Ford."By fate of a brief season, Jimmy Carter and I were rivals," Ford said in his eulogy, which was read by his son Steven. "But for the many wonderful years that followed, friendship bonded us as no two presidents since John Adams and Thomas Jefferson."Carter defeated Ford in 1976, but the presidents and their wives became close friends, and Carter eulogized Ford at his own funeral.Days of formal ceremonies and remembrances from political leaders, business titans and rank-and-file citizens have honored Carter for his decency and using a prodigious work ethic to do more than obtain political power.

At Fukashima after the nuclear accident, they lined up patiently to get supplies – never trying to get ahead or jump the queue.

Contemporary role modelsIt may well pay for India to look for Sontoku-type stories for elementary school textbooks. The heroes we celebrate in our textbooks are often kings and warriors. They fought battles – against the British and other oppressive rulers. Shivaji is standard in Maharashtra, for instance.

There is even mythmaking in our textbooks. Not too long ago, children in Tamil Nadu learned in school that the ancient Tamil woman could drive away a marauding tiger with a winnow. While warrior kings and freedom fighters are inevitable in India, we could also flesh out more recent heroes who brought prosperity to themselves and others. We are often ignorant of thrifty business communities until much later in life. The story of J. N. Tata's steel plant in Jamshedpur is fascinating for its ingenuity such as in how the capital was raised. The benign aspects of the town are worth recounting as an example of contemporary India.

Why geography matters to Abraham Verghese, author of The Covenant of Water

In his fourth and latest work, The Covenant of Water, published last year, Verghese narrates an epic story spanning three generations in Kerala. Oprah Winfrey has bought the rights to adapt the book info a film. Ahead of The Hindu Lit for Life 2025, which the author will inaugurate in Chennai on January 18, Verghese discusses why he always wanted to write fiction and the difficulty of mining one's own life for material. Edited excerpts from an email interview:

You have written two memoirs. Why did you feel the need to document your life?

In the mid-1980s, when I was living in a small town in Tennessee, working as an infectious diseases specialist, I saw more patients with HIV than was predicted for a rural town of 50,000. I realised I had stumbled onto an American paradigm of migration: young men who had left their small towns because they were gay were now returning decades later, having contracted the virus, and having cared for partners who had passed. At the time, AIDS was considered an urban phenomenon. I wrote a scientific paper describing the paradigm, but I felt it never quite captured the heartache of their journey, or the grief of their parents, or my own grief at seeing this again and again. I became a writer to tell that story — through fiction, or so I thought. But it turns out that non-fiction is much more in demand by publishers than fiction, because non-fiction sells predictably: if something really happened, we all have an inherent interest. So that story became my first book, My Own Country (1994). I thought I was telling the story of the small town and HIV, but inevitably, since I was a character, it was also a memoir.

At the time I was writing the book, I was also living through an experience with one of my medical students, another extraordinary true story. Publishers were anxious for me to write another non-fiction book when I finished the first one, and the story that became The Tennis Partner (1998) seemed an easy way to do so. However, I really always wanted to write fiction, so after two memoirs I have not gone back to non-fiction. It isn't easy to mine your own life for material. Memory is a tricky thing. In memoir writing, how do you ensure that you have got things right, especially when you're writing about emotional episodes from your life?I think readers understand that memory is unreliable, and that all writing is in a sense a kind of artifice. If you confine yourself not to your memories but to what can be documented to have happened, and only to dialogue exactly what was said ... well you have a very dry book, or else it is a newspaper account. Instead, just as when you are sitting with friends and recounting what happened to you, your listeners get your best recollection and they know it comes with all your biases, and with your propensity to exaggerate or else to under-report. You often talk of how every change in geography changed your destiny. What other factors do you think changed your destiny? And can destiny be changed at all?Geography matters greatly.

Illegal high-rise buildings, officers who allowed construction under scanner

After the collapse of a multi-storey building at Sohana village, the illegally constructed high-rise buildings and the role of the officials who let the rampant construction happen have again come under the scanner. At Sohana alone, at least 10 buildings have about seven to eight storeys each. Locals said that officials of the Municipal Corporation (MC) allowed the construction to happen in the area due to which hundreds of paying guest houses had come up in the area and illegal buildings housing gyms, grocery stores and hotels.Sarbjit Singh, a local resident, said that due to the proximity of Sohana with Mohali city, their village had seen an uneven growth of high-rise buildings in the past few years. He added that the water pumps operate illegally and paying guest (PG) accommodations are running without registration. "Who would take action against this illegal business? Many high-rise buildings house PGs," Sarbjit added.Former sarpanch of Sohana Parwinder Singh Sohana said that he had raised the issue in the MC house meetings but in vain.

Municipal Commissioner T Benith told The Indian Express that they had already conducted a survey in the city to identify the illegally constructed high-rise buildings and the process to seal these buildings to be carried out with immediate effect."We have identified the PGs and the illegally constructed hotels. Soon, we will be sealing all these buildings," the Commissioner added. While taking stock of the post-rescue operation activities in the late evening, Deputy Commissioner Aashika Jain said that the district administration will ensure justice to the deceased, Drishti and Abhishek, who lost their lives due to gross human negligence. She said that stringent steps would be taken to ensure no excavation in the district is to be conducted without appropriate precautions. The competent authorities will monitor the situation so that any such tragedy may be averted from occurring in the future. A First Since 1996: In major fairs in Kolkata, omnipresent Bangladesh traders missing this year

For the first time, stalls from Bangladesh are missing in two of Kolkata's major fairs - the International Kolkata Book Fair and the Bidhannagar Mela Utsav, which is organised by the Bidhannagar Municipal Corporation (BMC). Every year since 1996, when the Sheikh Hasina government came to power in Bangladesh, the neighbouring country has featured in every edition of the city's book fair. In 1999, Hasina herself attended the fair when Bangladesh was the theme country

Even when Bangladesh was governed for five years by Begum Khaleda Zia's Bangladesh Nationalist Party and was then under military rule between 2001 and 2008, there was no break in tradition. Last year, the Bangladesh pavilion was around 2,500 sq ft with over 50 stalls each.Guild President Tridib Chatterjee told The Indian Express, "Given the current geo-political situation between the two nations: until we get a go-ahead from the Ministry of External Affairs, we cannot allot any stalls to Bangladesh. Till now, the Ministry has not given any go-ahead in this matter.'

Chatterjee said that if there is any breach of law and order, such as any attack on a stall of the neighbouring country, then the Guild would be held responsible. With 1, 050 stalls, the countries participating in the book fair this year include UK, USA, Russia, Iran, Japan, France, Spain, Peru, Italy, Argentina, and Colombia — with Germany as the focal theme.Meanwhile, the annual Bidhannagar Mela Utsav held at the Salt Lake Central Park fairground started without any stalls from Bangladesh. Every year, around six to seven stalls of Bangladeshi Dhakai and Jamdani sarees would draw large crowds. According to sources, the agency managing the stall and pavilion booking for the fair had decided to refund the advance paid by Bangladeshi traders.



According to the official, this decision was reached to "prevent any untoward incident or law and order situation" with the current tension between the two countries. Stalls from countries like Turkey and Afghanistan are already ready.Sources in the BMC said that asking the Bangladesh traders not to come was a "precautionary step" as their presence "may create trouble". According to sources in the agency who allot stalls, many Bangladeshi national traders are interested in setting up stalls and do not want a refund. Around 500 stalls are being set up at the Bidhannagar Mela Utsav this time, including the food court and amusement rides. This year, Bangladesh did not have any representation at the 30th International Film Festival in Kolkata as well due to visa problems. A two-day Bengali literary festival at Visva-Bharati University's Bangladesh Bhavan also saw no participation from Bangladesh this year. This was after several poets and writers from Bangladesh were reportedly denied visas amid rising political tensions between India and the neighbouring country. Sources from the programme organiser, Khowai Sahitya Samiti, said that almost 20 poets and writers wanted to attend the festival.

In race for Ludhiana mayor, ruling AAP walks a tightrope; here's what rules say

With the results for Ludhiana Municipal Corporation delivering a hung house verdict with no party winning a clear majority, all eyes are now on the process to elect the new Mayor. Even though AAP has won the highest number of seats, it could still be anybody's game in Ludhiana MC.Of 95 wards in Ludhiana, AAP won 41, Congress 30, BJP 19, SAD 2 and 3 others have been won by Independents. AAP is seven seats short of the half-way mark. However, apart from the 95 councillors who are the elected members, Ludhiana MC also has seven urban MLAs as ex-officio members, all of them currently belong to the AAP (north, south, east, west, central, Atam Nagar and Sahnewal).

According to the Punjab Municipal Corporation Act, 1976, ex-officio members of the House "comprise the members of the Punjab Legislative Assembly representing the constituencies in which the City or any part thereof falls."However, AAP would still be walking the tightrope even if votes of seven MLAs are added to its kitty. According to experts, if all 95 elected councillors along with 7 MLAs are present on the day of voting for the Mayor, the total members would be 102, and the votes of at least 52 members would be required to elect the new Mayor, while AAP's total votes would be 48.In the other possible scenario, things can become easier for AAP if some members from other parties give voting day a miss. In yet another possibility, Congress with 30 seats, BJP with 19, SAD with 2 and 3 independents (total 54) can get together to keep ruling AAP out of the race for Mayor's post.

Ashok Bajaj, former additional director (local government) who has also served as Ludhiana MC joint commissioner and legal advisor for the civic body, said that as per rules, what matters is not the overall majority but the number of votes secured by the mayoral candidate on the voting day."The candidates who get the highest votes will be elected mayor, the senior deputy mayor and deputy mayor. For instance, even if only 40 members vote that day, the candidate with the highest number of votes will win. So a lot depends on how many members are present on voting day. The ex-officio members (MLAs) are also allowed to vote as per the rules," said Bajaj.Rules for electing a Mayor in Punjab

According to The Punjab Municipal Corporations Mayor, Senior Deputy Mayor and Deputy Mayor Election Rules, 1991, "A meeting of the [members and ex officio members] of a Municipal Corporation shall be convened by the Divisional Commissioner to elect a Mayor, Senior Deputy Mayor and Deputy Mayor."The rules add that there would be no election in case there is only one candidate proposed for Mayor's post but there would be a proper elec-

tion if there is more than one candidate, and the one getting the highest votes would be declared the winner."In the case of election to the office of the Mayor,- (i) if there is only one candidate he will be declared to have been elected; (ii) if there are more than one candidate, the candidate who obtains the largest number of votes shall be declared to have been elected," reads the rule.

Baiai added that while 1991 rules said that the election for three posts should be conducted via secret ballot papers, this was amended in 2001. "The election is now held by show of hands as per the amendment notified by Punjab government on April 19, 2001. It is not even binding on all members that they must vote, it's their choice and they can even opt out," he added. A legal expert in civic affairs, said that the AAP can now try to bring three Independents on their side, or enter "arrangements" with councillors of other parties to ensure that they do not attend the voting. If AAP proposes their Mayoral candidate, and Congress-BJP-SAD together propose theirs, the one getting the highest votes will win.Sanjay Talwar, Congress's district president for urban Ludhiana, said that they can consider going with the BJP to propose a Mayoral candidate. He said that AAP was already trying to lure their elected councillors with posts but "none of them want to go with them."

"Our councillors want to go with BJP. AAP has disrespected every opposition party, so we can go with the BJP and SAD but will never support AAP," he said.AAP MLA Madan Lal Bagga said: "The divisional commissioner will be inviting us to propose Mayor candidate as we have the highest numbers and MLA votes." Rajnish Dhiman, district president, BJP said that they can ponder over going with the Congress "for the betterment of Ludhiana city and its people." "We can go with the Congress if our high comhand allows but won't be supporting AAP," he said

For next year's Delhi Assembly polls, AAP has fielded many new faces across the 70 constituencies to beat antiincumbency - including those associated with the Municipal Corporation of Delhi. Seven of them are sitting councillors and at least 20 others have close familial ties to individuals currently serving or previously associated with the civic body.Like every other candidate, AAP sources said these 27 were chosen based on popularity and winnability. When the second candidate list was announced on December 9 — five sitting councillors made it to the list — AAP Delhi Convener Gopal Rai had said: "Councillors actively working in constituencies were chosen based on their performance, as the party has been consistently gathering micro-feedback from the public in every seat... Based on public feedback and the positive performance of these councillors, the party has decided to field them as candidates."

Among the sitting councillors, prominent names include Leader of the House Mukesh Goel who is contesting from Adarsh Nagar. Rakesh Jatav Dharamarakshak, currently Deputy Chairman of Rohini Zone, will represent Mangolpuri. Pradeep Mittal, councillor from Rohini A ward; Punardeep Singh Sawhney, representing Chandni Chowk; and Prem Chauhan, councillor from Dakshinpuri Extension and a member of the Standing Committee are among others. Then there are candidates whose spouses currently hold significant municipal roles. For instance, Mundka candidate Jasbir Karala's wife, Manisha Jasbir Karala, is the sitting councillor from Rani Khera. Similarly, Ramesh Pehelwan, a former BJP member now contesting from Kasturba Nagar, is married to Kusumlata Ramesh, the councillor from Kotla Mubarakpur. Naveen Chaudhary, representing Gandhi Nagar, is backed by his wife, Somwati Chaudhary, the Gokalpuri councillor.

Even late changes to the candidate list reflect this trend, as seen in Mahender Chaudhary's nomination from Mehrauli. His wife, Rekha Chaudhary, is a councillor from the Mehrauli ward. However, the list isn't limited to sitting councillors and their husbands. Veteran leaders like Shoaib Iqbal, a six-time MLA and the party's candidate from Matia Mahal, whose son, Aaley Iqbal, recently served as the Deputy Mayor of the MCD, is in the race. The AAP's twoyear tenure in the MCD though has not been smooth; since coming to power in 2022, it has locked horns with the Opposition BJP over Mayoral polls as well the Standing Committee elections. Multiple attempts to form the Standing Committee — an 18-member body that manages the purse strings of the corporation, without whose approval no civic services costing over Rs 5 crore can be approved - have failed, leading to civic issues going unaddressed and discontent among residents.Asked how the party is going to address potential anti-incumbency caused by stalling of municipal services, an AAP source said, "Our teams are on the ground; in every ward, there is a team collecting data on civic issues being faced. We then categorise them: 'severe' for issues that would take a long time to resolve such as the existence of a landfill in the area's vicinity, issues that can be solved within a week like broken roads, or within 24 hours such as garbage piles on roads. We are then directing the agency concerned to resolve it within the stipu



lated period."In a statement, the AAP also blamed the BJP and its dirty politics for trying to delay and obstruct certain projects. "However, (AAP chief) Arvind Kejriwal personally ensured their completion at record speed. Roads are being repaired on a war footing, the issue of medicine shortage has been resolved, and water supply problems have been addressed," it said. Asked if he will face issues during campaigning, Mukesh Goel said, "Everyone knows, the whole of Delhi knows, how work in the municipal corporation has been stopped due to planning and plotting by the BJP. So, I think, we are unlikely to face issues."Prem Chauhan said: "We have deployed some of our own workers, along with the MCD staff, to get the work done. The MCD's basic task is sanitation and we are focusing on that. I am a two-time councillor and I have managed to get all the work done in my ward." Chauhan is a former leader of the opposition and has been fielded from Deoli.

Sebi suspends trading in Bharat Global Developers over financial misrepresentation

New Delhi: Markets regulator Sebi on Monday suspended trading in Bharat Global Developers Ltd (BGDL) for financial misrepresentation, misleading disclosures, price manipulation, and offloading shares at inflated prices.Additionally, the regulator has barred the company, its managing director Ashok Kumar Sewada, CEO Mohsin Shaikh and directors -Dinesh Kumar Sharma and Nirali Prabhatbhai Karetha — and several preferential allottees of shares among the 18 entities from the securities market. Also, Sebi, in its interim order, has frozen illegal profits to the tune of Rs 271.6 crore made by preferential allottees through the sale of shares. This came after the Securities and Exchange Board of India (Sebi) initiated an investigation into Bharat Global Developers following social media posts and a complaint on December 16, 2024. The inquiry was triggered by a dramatic 105-fold increase in BGDL's share price, which surged from Rs 16.14 in November 2023 to Rs 1,702.95 in November 2024. The regulator examined the matter to determine whether the company violated securities laws, including the Sebi Act.

Inflation, elections and war dominated 2024



Angered by the hefty ramp-up in prices for everything from eggs to energy over the past few years, they punished incumbent parties at almost every opportunity. The pain of inflation lingers, and ruling parties took the blame in election after election

In the United States, higher costs helped Donald Trump win a second term as president four years after he was voted out of the White House and then falsely claimed election fraud. His supporters failed in their bid to overturn Trump's defeat by storming the U.S. Capitol on Jan. 6, 2021. This year, they made their voices heard at the ballot box, ushering in a new American leadership likely to test democratic institutions at home and relations abroad. The infla-

tion-driven anti-incumbent sentiment also ushered in new governments in Britain and Botswana, Portugal and Panama. South Korean voters put the opposition into power in its parliament, a check on President Yoon Suk Yeol. In early December, the president imposed martial law, a move the National Assembly quickly reversed. Elections also shook up France and Germany, and Japan and India.One place there was no change: Russia, where Vladimir Putin was re-elected president with 88% of the vote, a record in post-Soviet Russia. Moscow continued to prosecute its war against Ukraine, grinding out notable territorial gains. The big question is what impact Trump's return to the White House will have on the conflict. He has promised to end the war in a day. Many in Ukraine and elsewhere in Europe fear that will mean siding with Putin and freezing the status quo. In the Middle East, Israel continued its war against Gaza and extended it to Lebanon, where it left Iran-backed Hezbollah damaged and in disarray. In Syria, a well-coordinated collection of rebel groups toppled Bashar al-Assad and now seeks to run the country. In business, companies around the world grappled with how to adapt to artificial intelligence. The dominance of tech companies for investors can be summed up in this simple fact: seven tech firms the so-called Magnificent Seven - now account for more than one-third of the S&P 500's market cap.Elon Musk, who runs one of those companies, Tesla, is an adviser and financial backer to President-elect Trump. Looking ahead, that combination of tech bro mojo and political power could well define 2025.

Trump threatens to retake control of Panama Canal

WEST PALM BEACH. Florida. President-elect Donald Trump threatened to reassert U.S. control over the Panama Canal on Sunday, accusing Panama of charging excessive rates to use the Central American passage and drawing a sharp rebuke from Panamanian President Jose Raul Mulino.Speaking to a crowd of supporters in Arizona, Trump also said he would not let the canal fall into the "wrong hands," warning of potential Chinese influence on the passage

After the event, he posted an image on Truth Social of an American flag flying over a narrow body of water, with the comment: "Welcome to the United States Canal!""Has anyone ever heard of the Panama Canal?" Trump said at AmericaFest, an annual event organized by Turning Point, an allied conservative group. "Because we're being ripped off at the Panama Canal like we're being ripped off everywhere else."Trump's comments were an exceedingly rare example of a U.S. leader saying he could push a sovereign country to hand over territory. They also underlined an expected shift in U.S. diplomacy under Trump, who has not historically shied away from threatening allies and using bellicose rhetoric when dealing with counterparts."It was given to Panama and the people of Panama, but it has provisions," Trump said of the canal, which was once owned by the United States but was handed over to Panama decades ago." If the principles, both moral and legal, of this magnanimous gesture of giving are not followed, then we will demand that the Panama Canal be returned to us, in full, quickly and without question."In a recorded message released by Panama's President Mulino on Sunday afternoon, the nation's leader said that Panama's independence was non-negotiable and that China had no influence on the canal's administration. He also defended the passage rates Panama charged, saying they were not set "on a whim". The United States largely built the canal and administered territory surrounding the passage for decades. But the United States and Panama signed a pair of accords in 1977 that paved the way for the canal's return to full Panamanian control. The United States handed over control of the passage in 1999 after a period of joint administration."Every square meter of the Panama Canal and the surrounding area belongs to Panama and will continue belonging (to Panama)," Mulino said in his statement, which was released on X.Trump then responded to Mulino: "We'll see about that!"

South Korean opposition threatens to impeach Han over martial law counsel



SEOUL, GNS News Agency, Jan 15South Korea's main opposition party threatened on Monday to impeach acting president Han Duck-soo if he failed to proclaim a law to launch a special counsel investigation into President Yoon Suk Yeol's failed bid to impose martial law.Prime Minister Han has taken over from the suspended Yoon, who was impeached on Dec. 14 and faces a Constitutional Court review on whether to oust him

With a majority in parliament, the opposition Democratic Party passed a bill this month to appoint a special counsel to pursue charges of insurrection, among others, against the conservative Yoon and to investigate his wife over a luxury bag scandal and other allegations. The party,

which has accused Han of aiding Yoon's martial law attempt and reported him to police, said it would "immediately initiate impeachment proceedings" against the acting president if the legislation was not promulgated by Tuesday."The delays show that the prime minister has no intention of complying with the constitution, and it is tantamount to admitting that he is acting as a proxy for the insurgent," Democratic Party floor leader Park Chan-dae told a party meeting, referring to Yoon. Han is a technocrat who has held leadership roles in South Korean politics for 30 years under conservative and liberal presidents. Yoon appointed him prime minister in 2022. Han's office could not immediately be reached for comment. He has previously said he had tried to block Yoon's martial law declaration, but apologised for failing to do so.Park also accused Yoon of hampering the Constitutional Court trial by repeatedly refusing to accept court documents.

"Any delay in the investigation and impeachment trials is an extension of the insurrection and an act of plotting a second one," Park said.A joint investigative team including police and the Corruption Investigation Office for Highranking Officials has made a second attempt to call Yoon in for questioning on Dec. 25, though it was unclear whether he would appear. Woo Jong-soo, investigation chief of the national police agency, told parliament on Monday that police had tried to raid Yoon's office twice but the presidential security service denied them entry. Makers of Taiwan's 'Zero Day' TV series set around invasion fear backlash from China

TAIPEI, A Chinese war plane goes missing near Taiwan. China sends swarms of military boats and planes for a blockade as Taiwan goes on a war footing. Panic ensues on the streets of Taipei. The premise of "Zero Day", a new Taiwan TV drama envisioning a Chinese invasion, is a topic that has for years been considered too sensitive for many Taiwan filmmakers and television show creators, who fear losing access to the lucrative Chinese entertainment market.But as China steps up military threats, including the large massing of naval forces last week and daily military activities close to the island, the upcoming drama confronts the fear by setting the 10-episode series around a Chinese invasion of Taiwan. "We thought there is freedom in Taiwan but in film and TV production we are restricted by China on many levels," said Cheng Hsin Mei, the showrunner on "Zero Day". China, which claims Taiwan as its own territory over the objections of the government in Taipei, is a much larger market for film and television. Taiwanese entertainers are popular there partly due to language and cultural similarities. Cheng said creators in free and democratic Taiwan, however, are indirectly confined by Beijing's powerful state censorship.Beijing has regularly called out Taiwanese artists seen as violating China's political ideology and has threatened to blacklist those unwilling to cooperate. China pressured a popular Taiwanese rock band to make pro-China comments ahead of Taiwan's presidential vote early this year, sources told Reuters. Beijing denied pressuring the group Mayday.China's Taiwan Affairs Office did not respond to a request for comment.

Israeli order to evacuate Gaza hospital 'next to impossible' to obey, say medics

CAIRO, GNS News Agency, Jan 15 Israel ordered the closure and evacuation on Sunday of one of the last hospitals still partly functioning in a besieged area on the northern edge of the Gaza Strip, forcing medics to search for a way to bring hundreds of patients and staff to safety. The head of the Kamal Adwan hospital in Beit Lahiya, Husam Abu Safiya, told Reuters via text message that obeying the order to shut down was "next to impossible" because there were not enough ambulances to get patients out.

'We currently have nearly 400 civilians inside the hospital, including babies in the neonatal unit, whose lives depend on oxygen and incubators. We cannot evacuate these patients safely without assistance, equipment, and time," said Abu Safiya."We are sending this message under heavy bombardment and direct targeting of the fuel tanks, which if hit will cause a large explosion and mass casualties of the civilians inside," he said

The Israeli military did not respond to a request for comment on Abu Safiya's remarks. It said that on Friday it had sent fuel and food to the hospital and helped evacuate more than 100 patients and caregivers to other Gaza hospitals, some in coordination with the Red Cross, for their own safety. The hospital is one of the few still partially functioning in the once crowded northern edge of Gaza, an area under intense Israeli military pressure for nearly three months in one of the most punishing operations of the 14month-old war.Abu Safiya said the military had ordered patients and staff to be evacuated to another hospital where conditions are even worse. Photos from inside the hospital showed patients on beds crammed into corridors to keep them away from windows. Reuters could not immediately verify those images. Israel says its operation around three communities on the northern edge of the Gaza Strip - Beit Lahiya, Beit Hanoun and Jabalia - is targeting Hamas militants. Palestinians accuse Israel of seeking to permanently depopulate the area to create a buffer zone, which Israel denies

FIGHTING AT CLOSE QUARTERSHamas released a video on Sunday that it said had been filmed in northern Gaza. It showed fighters positioned in blown-out buildings and in piles of wreckage, clad in civilian clothing and firing projectiles at Israeli forces. The Israeli military said on Sunday forces operating in Beit Hanoun had struck Hamas militants and infrastructure. Hamas and the allied Islamic Jihad

group said they caused casualties among Israeli soldiers.Separately, Israel allowed the Catholic bishop of Jerusalem, the Latin patriarch, into Gaza on Sunday, according to a statement on the Latin Patriarchate website and COGAT, the Israeli defence agency that coordinates with the Palestinians, after Pope Francis said on Saturday that the patriarch had not been allowed in.Elsewhere, Israeli military strikes across the Gaza Strip killed at least 29 Palestinians, eight of them - including some children - at a school sheltering displaced families in Gaza City, medics said. Two children were killed in another airstrike that hit an Israeli-designated humanitarian zone in southern Gaza, killing a total of at least five, medics said. In both those incidents, the Israeli military said it had targeted Hamas militants operating from within those areas and that it had taken precautions to reduce risk of harm to civilians. Hamas denies it operates among civilians.Mediators have stepped up efforts in recent weeks to secure a ceasefire in Gaza after months when talks were frozen. Israel began its assault in Gaza after Hamas-led fighters attacked Israeli communities on Oct. 7, 2023, killing 1,200 people and taking more than 250 hostages, according to Israeli tallies. Around half of the 100 hostages still being held are believed to be alive.Authorities in Gaza say Israel's campaign has killed more than 45,200 Palestinians. Nobel laureate Malala Yousafzai to visit native Pakistan for girls' summit

Nobel Peace Prize Laureate Malala Yousafzai will attend a summit on girls' education hosted by her native Pakistan, where she was nearly killed by militants as a schoolgirl.Ms. Yousafzai was evacuated from the country in 2012 after being shot by the Pakistan Taliban, who were enraged by her activism, and she has returned to the country only a handful of times since. A spokesperson for the Malala Fund charity confirmed Yousafzai will attend the conference in person.

"I am excited to join Muslim leaders from around the world for a critical conference on girls' education," she said Friday in a post on X."On Sunday, I will speak about protecting rights for all girls to go to school, and why leaders must hold the Taliban accountable for their crimes against Afghan women & girls."Pakistan's neighbour Afghanistan is the only country in the world where girls and women are banned from going to school and university.

Since returning to power in 2021, the Taliban government has imposed an austere version of Islamic law which the United Nations has called "gender apartheid". Girls are only allowed to attend primary school, while women are largely restricted to working in segregated environments in health or education. The Taliban administration claims that Islamic law "guarantees" the rights of Afghan men and

The two-day summit will be held in Pakistan's capital Islamabad on Saturday and Sunday, focusing on girls' edu-



cation in Muslim communities. It will be inaugurated by Pakistan Prime Minister Shehbaz Sharif and bring together ministers and ambassadors from 44 countries as well as representatives from the UN and World Bank. The summit will confirm "the shared commitment of (the) Muslim community to empower girls through education", according to a government statement.Ms. Yousafzai became a household name when she was attacked in 2012 by Pakistani Taliban militants on a school bus in the remote Swat valley near the border with Afghanistan.Militancy led by the Pakistani Taliban erupted in the region as the war between the Afghan Taliban and NATO forces raged across the border. She was evacuated to the United Kingdom and went on to become a global advocate for girls' education and the youngest ever Nobel Peace prize winner at the age of 17.

India retains title of world's fastest-growing large economy with growth projected at 6.6 pc says UN

Adani Green says Gautam Adani, nephew Sagar Adani not charged with violation of US anti-corruption law



Adani Green Energy (AGEL) Wednesday said that the group's chairman Gautam Adani, his nephew Sagar Adani, the company's managing director Vneet Jaain have not been charged with the US Foreign Corrupt Practices Act (FCPA). Adani Group founder and chairman Gautam Adani is the chairman of AGEL, while Sagar Adani is its executive director. The clarification from AGEL came following reports that the trio have been charged with violations of the US FCPA. Separately, senior lawyer and former attorney general Mukul Rohatgi, who has represented the Adani group in a few cases, also said that Gautam Adani and Sagar Adani have not been charged in the more serious counts one and five of the five-count indictment by US prosecutors."Such statements are incorrect. Gautam Adani. Sagar Adani and Vneet Jaain have not been charged with any violation of the FCPA in the counts set forth in the indictment of the US DOJ or civil complaint of the US SEC," AGEL said in a statement on Wednesday in response to media reports that said the group has been accused of violating the US FCPA.

The US FCPA makes it unlawful for certain classes of persons and entities to act corruptly in furtherance of an offer, promise, authorisation or payment of money or anything of value, directly or indirectly, to a foreign official for the purpose of obtaining or retaining business for, or directing business to, any person. On November 20, the US prosecutors, in a criminal indictment, had alleged that Gautam Adani and seven others offered or promised to offer Rs 2,029 crore (US \$265 million) in bribes to Indian state government officials for securing "lucrative solar energy supply contracts" with state electricity distribution companies. Apart from Gautam Adani, Sagar Adani, and Vneet Jaain, the indictment named five others who were associated with Azure Power and the Canadian pension fund Caisse de dépôt et placement du Québec (CPDQ). The Adani Group has denied all allegations and termed them baseless.AGEL further said Gautam Adani, Sagar Adani, and Vneet Jain have been charged on three counts in the criminal indictment - alleged securities fraud conspiracy, alleged wire fraud conspiracy, and alleged securities fraud.

On expected financial implications, if any, due to pen-

alty, AGEL in a separate filing said, "The indictment does not specify any quantum of any fine / penalty."Following the AGEL's clarification, its shares were trading at Rs 933.45 a share, up 3.79 per cent on the BSE in morning trades. Adani Enterprises was up 3.53 per cent and Adani Ports and Special Economic Zone gained 1.26 per cent. Adanis not charged in more serious counts: Senior lawyer Mukul Rohatgi

Rohatgi said Tuesday that Gautam Adani and Sagar Adani have not been charged in the more serious counts one and five of the five-count indictment in the US. Count one pertains to an alleged conspiracy to violate the FCPA, and count five pertains to the allegations of conspiracy to obstruct justice. Rohatgi, who said he was giving his personal views as a lawyer, also said that US prosecutors' indictment does not mention specifics of the alleged bribery scheme, specifically who all were purportedly bribed and in what manner."It is very important to note that count one and count five are more important than the others. But...neither in count one nor in count five is Mr Adani or his nephew charged," said Rohatgi, while clarifying that he was not a spokesperson for the Adani group but has represented the conglomerate in a few cases."So, count number one contained in para 124 onwards of the indictment is against certain other persons, minus the two Adanis...that is the conspiracy to violate the Foreign Corrupt Practices Act...It is somewhat similar to the Prevention of Corruption Act in India... In the last count, which is a very important count, it is a count relating to obstruction of justice. In that count, namely, count number five, the Adanis are not named...their officers are not named, but certain other people are named, including a foreign party," Rohatgi said. To be sure, while the indictment does not specifically name the Adanis in counts one and five, the opening paragraphs of all the counts has the statement: "The allegations contained in paragraphs 1 through 123 (all the paragraphs in the indictment preceding the five counts) are realleged and incorporated as if fully set forth in this paragraph." Those specifically named in counts one and five are individuals who were associated with Azure and CPDQ. The three counts in which Gautam Adani, Sagar Adani, and Vneet Jaain are directly named pertain to alleged securities fraud and wire fraud conspiracies."

I would like to say something which has been troubling me. When you look at a charge sheet, you have to be specific to say that so and so has done such and such act. So and so has bribed certain individuals, because this is the charge sheet alleging that these people, including Adanis, have bribed Indian officials in Indian entities relating to supply and purchase of power. But I do not find a single name or a single detail in the charge sheet as to who has been bribed, in what manner has he been bribed, and the official belongs to such and such department," Rohatgi said."This charge sheet is completely silent. I don't know how one can respond to these kinds of charge sheets, but I'm sure the Adanis will take legal opinion, including from American lawyers, etc.," the senior lawyer added.

Trump picks another China sceptic for key role, taps Jamieson Greer as trade representative

US President-elect Donald Trump has named another China sceptic, Jamieson Greer, as his choice to take charge of a key role of the US Trade Representative (USTR). Greer, a former officer in the armed forces and an international trade attorney, would oversee Trump's tariff battles, as he has indicated extensive use of tariffs in his second term, starting with China, Mexico, and Canada on his first day in office. This announcement comes amid speculation that Trump's tariff war architect, Robert Lighthizer, could have a second term as USTR.

However, Greer, known as Lighthizer's protege, is expected to play a similar role as he served as the chief of staff to Lighthizer during Trump's first term. Lighthizer was the USTR in Trump's first term."Jamieson will focus the Office of the US Trade Representative on reining in the country's massive trade deficit, defending American manufacturing, agriculture, and services, and opening up export markets everywhere," Trump said on Tuesday.He added that Greer "played a key role during my first term in imposing tariffs on China and others to combat unfair trade practices, and replacing the failed NAFTA deal with USMCA, making it much better for American workers."Greer has long believed that China stole American intellectual property rights (IPR) to build a manufacturing base in China, which resulted in loss of American jobs and that "Chinese ambitions are existential threat to the US"."I view Chinese ambitions as currently articulated and pursued - as an existential threat to the American way of life: our physical safety, our personal privacy and freedom, our economy and jobs, and even our system of government," Greer had said in a written testimony to the US House of Representatives Judiciary Committee last year.



So many days lost at the doctor's office

Deana Hendrickson sometimes feels daunted by the demands of the medical system. "Every body part has a doctor," she lamented. "I hate it."Hendrickson reeled off a long list of her health care providers: a primary care doctor; a cardiologist because she has mild heart disease and a concerning family history; a lung surgeon and a pulmonologist who oversees an annual scan because of her family history of lung cancer. Plus an ophthalmologist, a gynecologist, a urologist, a podiatrist, a gastroenterologist "and I just came back from the dentist."

She estimates that with scans, imaging, and tests, she spends two dozen days a year engaged with some sort of provider. Most of them, she added, practice in Santa Monica, California, where she used to live, now an hour's drive from her home.At 65, providing five-day-a-week care (with her husband) for three grandsons under 5, she's reasonably healthy and active. But her regimen "makes me feel like a sick person," Hendrickson said."I'm like an older car that always needs more maintenance. There's so many other things I'd rather be doing." Researchers call such encounters "healthcare contact days," and they are starting to quantify their toll on older adults.

"More people are thinking about time and health care," said Dr. Ishani Ganguli, a physician and researcher at Harvard Medical School. "It identifies a key way we ask a lot of patients."Doctors, she added, "underestimate the burdens and negative trade-offs of health care." Analyzing data from traditional Medicare for 2019, her team reported that beneficiaries older than 65 averaged about 17 contact days that year for ambulatory care, which included doctors' visits, tests, imaging, therapy, and procedures - but not time spent in hospitals or nursing homes. (And not dentistry, since Medicare rarely covers it.)"More people are thinking about time and health care," said Dr. Ishani Ganguli, a physician and researcher at Harvard Medical School. "It identifies a key way we ask a lot of patients." However certain groups of seniors spent considerably more time with the medical system. Among those with 10 or more chronic conditions - an eye-opening 14% of the total - contact days for ambulatory care rose to 30 a year. Eleven percent of patients clocked 50 such days or more."My clients are going to doctors two or three times a week," said Kathleen Carmody, who owns Senior Matters Home Care and Consulting in Columbus, Ohio. "Physical therapy. Follow-up appointments. Blood draws."For both her clients and the caregivers who accompany them, she said, "it can be exhausting.'

The understanding that medical care can become a wearying treadmill for older patients has led researchers to look more closely at the consequences of the so-called burdens of treatment.Patients can experience treatment cascades, for instance — a series of if-this-then-that results in which "the downstream care is even more burdensome," Ganguli said. She recently wrote in The New England Journal of Medicine about an example in her own family, after her father agreed to prostate cancer screening at 79."My heart sank," she said in an interview, noting that "there's a reason that test is not recommended" at advanced ages. "More often than not, it leads to diagnostic testing and treatment whose harms outweigh the good."Indeed, her father later began radiation for prostate cancer, scheduled five days a week for eight weeks. Generally, prostate cancer is slow-growing and may never trouble older patients if it goes undetected, but testing for it can contribute to a cascade of contact days. Then "there are the opportunity costs," Ganguli said. "You'd rather be spending time with friends or going for a walk."Treatment burdens can also lead people to abandon remedies that prove too demanding, ultimately harming their health

The work of being a patient is a massively long list, and it continues to expand," said Dr. Victor Montori, an endocrinologist and researcher at Mayo Clinic.He ticked off tasks like preparing for, confirming, attending, or rescheduling appointments; taking and refilling prescriptions; monitoring insurance paperwork; and perusing nutrition labels at the supermarket."You don't have infinite time, energy, and attention," he said, and as the challenges add up, "some treatments that are helpful you will discontinue or delay because it is simply overwhelming."But slowing the health care



treadmill — an approach Montori has called "minimally disruptive medicine" - is possible."If doctors and clinics and health care systems paid attention to ways to lessen the burden, we'd all be better off," Ganguli said. "And some are fairly simple."One strategy: reducing what experts call "lowvalue care." Her research has confirmed what critics have pointed out for years: Older people receive too many services of dubious worth, including prostate cancer screening in men older than 70 and unneeded tests before surgery. Decreasing them would save patients time and energy, prevent treatment cascades, and reduce spending, including out-of-pocket charges."I'd encourage patients to bring it up," Ganguli said. If I follow this treatment plan, how many days would I have to go to a facility? If this medication requires regular lab testing, is there a less taxing alternative?

And why can't providers, particularly in larger healthcare systems, coordinate and consolidate care? Office visits, lab tests, and vaccinations could be scheduled on the same day."It's thinking about the person holistically: Let's be efficient and get this done while they're here, Ganguli explained.David Gans, 71, a musician and author in Oakland, California, has spent months coping with "mild but intractable" urinary tract infections, as well as surgery to repair the fistula (an abnormal connection between body parts) that apparently caused them."I've probably had 20 or 30 urine tests in the last two years," he said. But he's a member of Kaiser Permanente, the highly integrated health organization that pays its doctors salaries, reducing the incentives to add low-value services. The urologist, the surgeon, and the infectious disease specialist Gans saw were all Kaiser doctors who coordinated visits."I didn't have to call another practice and do intake," he said. He had access to a test lab whenever he experienced symptoms, without appointments. "I walk in, show them my card, they hand me the jug," he said. While there, he can pick up medications at the Kaiser pharmacy or receive them by mail within two days. And he can take advantage of walk-in clinics for flu shots and COVID-19 vaccines."My friends keep talking about what a pain health care is, but I'm a happy customer," Gans said.More care could shift to patients' homes, too.More than 17% of older Medicare beneficiaries report difficulty traveling to doctor's offices, and more than half of those beneficiaries are accompanied by someone else — doubling the burden. Home care, hospital-at-home programs, and telehealth eliminate some of the inconvenience. Telehealth spiked during the early COVID years: In 2020, almost half of traditional Medicare beneficiaries had at least one telehealth visit. By late last year, less than 13% did — still a higher proportion than before the pandemic. But without congressional action, some of Medicare's policies expanding telehealth will expire Dec. 31.Healthcare systems themselves have a major role to play in reducing treatment burdens. They could put specialists in the same building, for example, and adopt payment models that reduce incentives to schedule additional visits and tests. In the meantime, Deana Hendrickson is looking for ways to preserve her health while cutting back on burdensome care. She tries to schedule two appointments on the same day and sometimes succeeds cardiologist twice a year instead of four times. Manufacturing and IP go together. It should come as no surprise that, after China joined the WTO in 2001, corporations took advantage of a Chinese economy with permanent access to

the US and other Western markets and invested heavily in the country," he said. The Economic Policy Institute reports that the United States lost approximately 3.7 million manufacturing jobs to China in the years following China's accession to the WTO, and the towns and regions hardest hit by this have not recovered, he added.

Novo Nordisk shares rise as Biden proposes obesity care coverage

Shares of Danish weight-loss drug maker Novo Nordisk rose 1.3% on Tuesday as US President Joe Biden proposed expanding coverage of anti-obesity drugs for millions on Medicare and Medicaid."This is an important step forward for patients," Novo Nordisk said in a statement commenting on the proposal, adding that the coverage could become effective in 2026.

The stock pared initial gains of as much as 4.9% to trade 1.3% higher at 1236 GMT.Current rules for the Medicare and Medicaid government health insurance programmes cover the use of drugs such as Mounjaro, Ozempic and Wegovy for certain conditions like diabetes, but not for obesity as a condition on its own. The White House said in a statement the proposal could lower out-ofpocket costs for weight-loss drugs by up to 95%, expanding access to millions of Americans.Nordnet analyst Per Hansen said Novo's share move came on the back of the proposal, with US peer Eli Lilly also rising in premarket trade.Separately, a would-be challenger in the fast-growing obesity therapy market, Amgen, said its experimental drug MariTide led to an average weight loss of up to 20% in a mid-stage trial with overweight or obese participants. Amgen's shares were down nearly 8% ahead of the US market open, however, as the data fell short of investor expectations.

It might be time for a dress code overhaul in sports

What do Serena Williams' catsuit, Magnus Carlsen's jeans, and the Norwegian beach handball team's shorts rebellion have in common? No, it's not a new Netflix drama, though it could be. They all exemplify athletes confronting outdated, often bizarre, and occasionally discriminatory dress codes in sports. From pristine tennis whites to buttoned-up chess suits, the rules governing athletic attire often seem like relics from an era when corsets were considered workout gear. Imagine enduring the heat of competition under glaring lights or braving the elements, only to have your outfit spark more controversy than your performance. The world of sports isn't solely about physical feats and strategy; it also involves navigating a tightrope of social norms, cultural politics, and power dynamics. Some of these rules are as rigid as the starched collars they enforce.

Recently, the spotlight fell on world chess champion Magnus Carlsen, who was disqualified from the World Rapid and Blitz Championships for wearing jeans-a garment deemed unfit for the "gentleman's game". This incident has reignited debates about the relevance of dress codes and their impact on sportsmanship and inclusivity

Origins of dress codes in sportsAccording to Mehendi Sharma, Assistant Professor of Fashion Design at Pearl Academy, sports dress codes often arise from practicality, tradition, and, at times, prejudice. She says, "Tennis whites symbolised purity in Victorian England, while gymnastics leotards prioritised movement. Chess adopted semi-formal attire to project its image as a refined and intellectual pursuit." However, these codes frequently uphold exclusivity and rigid traditions. "Like museum exhibits, dress codes preserve the past while questioning the present. Are they about discipline, or do they silently referee culture?" Sharma asks.Carlsen's jeans scandal drew global attention not because dress code violations are rare, but because Carlsen is the "Messi of chess," as Grandmaster Subbaraman Vijayalakshmi observed. Woman International Master Bommini Mounika Akshaya concurred, saying, "There are always many incidents related to dress code at the World Rapid and Blitz championships. Sometimes, even Grandmasters were not allowed to play the game because they



did not follow the dress code."Carlsen's disgualification wasn't the only controversy at the recent Blitz. Zhu Jiner, a Chinese Grandmaster, was fined \$200 for wearing boots during the same tournament. In a public letter, she said the incident disrupted her focus and cost her a match.Sexism continues to cast a long shadowAre these dress codes perpetuating systemic biases? Take Serena Williams, for instance—an icon not just for her storied career but also for her battles against discrimination, on and off the court. At the 2018 French Open, her choice of a functional catsuit designed to prevent blood clots post-pregnancy faced public criticism and an outright ban by the French Tennis Federation. The backlash carried racial and gendered undertones, sparking global outrage. Williams and her sister Venus Williams have faced relentless scrutiny over their attire, which many argue reflects implicit racial bias rather than genuine concern for the game's decorum. Sexism continues to cast a long shadow over the world of sports, shaping dress codes that often prioritise optics over equity. At the 2021 Tokyo Olympics, the German women's gymnastics team made a powerful statement by donning full-length unitards, rejecting the sport's traditional leotards, often criticised for their overly sexualised designs. Meanwhile, the Norwegian women's beach handball team protested against mandatory bikini bottoms in 2021, further spotlighting the gendered double standards embedded in athletic attire.A 2020 study published in Psychonomic Bulletin and Review found that the type of clothing worn-revealing versus concealing-can significantly affect women's performance on cognitive tasks. Furthermore, a 2024 study published in Sport, Education and Society revealed that 75 per cent of women surveyed had witnessed girls dropping out of school sports due to concerns about uniforms or body image

Game Changer Movie Review & Rating: When one looks at Shankar's filmography, it is interesting how his mind doesn't gravitate towards the easiest way to elevate the hero. Almost all of his leading men could have been typical straightforward police officers who take on the system. But instead, he makes them a small-time entrepreneur moonlighting as a Robin Hood, a young lover fighting for his love, an old revolutionary who wants to eradicate corruption, a journalist who becomes the chief minister, an NRI who returns to his homeland to weed out societal ills, and even a robot. But never a cop.

In a way, it is to remove the idea of servitude among his heroes or have them play characters that might still be part of the system, but be above it. It is almost like nothing can stop his heroes from delivering the utopia people crave to see unfold on the biggest of screens. Not even logic. But the law of averages caught up with Shankar, and despite his brand of cinema still making waves across the country, he seemed to have lost the touch. Probably why, his hero in Game Changer is a lot of things. He is a young lover changing his core behaviour to win his love. He is a smalltime reformer and a revolutionary who goes against the might of the system and wants to eradicate corruption. He is an IPS officer. He is an IAS officer. He becomes involved in electoral politics. It is almost like seeing a Shankar showreel, albeit with the magnetic presence of a star like Ram Charan, who could be all of these things, and a lot more in a film that allows him to be anything he wants to be.

Game Changer is essentially a lot of nice segments that are stitched together in the hope that it would make a good film. Now, individually, these segments have a sense of purpose, but together, they sometimes become incoherent due to the lack of focus. For instance, the entire relationship arc between Ram Charan's Ram Nandan and Kiara Advani's Deepika is quite impressive. But the way the story unfolds and how it saunters around for a while before randomly becoming important all over again isn't good enough. However, when these portions work, they are actually pretty impressive. In fact, both Kiara and Anjali get wonderful scenes, and powerful dialogues that shape the journey of the two Ram Charans in the film.

Shankar's brand of films is all about instant justice. In fact, Deepika tells Ram Nandan to not become an IPS officer because his anger would mean extra-judicial killings would become commonplace. But, as an IAS officer, Ram's actions are instant too. One sign, and the corrupt official is vacuumed out of his position and thrown into the stratosphere. One gesture, and entire malls come crashing down. One stroke, and he eradicates corruption surrounding ration shops. One monologue, he changes the mind of an entire village to not vote for money. Honestly, most of these segments are interesting because he goes about all of this by the book, but let's be honest, cynicism has creeped into the society. We want to see utopia, but one that appears possible. Here, one man changes everything, but the irony is... throughout Shankar's filmography, such solo warriors have constantly been changing society, and if another solo warrior in 2025 is again going to eradicate the same problem that was taken care of in 1993, 1996, 1999, and 2007, then it is less utopia, and more of just a gag. That is the real problem of Game Changer because the hangover of Shankar's filmography weighs too much on the film, and even an energetic Ram Charan can only shoulder it for a while. Oh yes, the story... An IAS officer takes on the corrupt political class, represented by Mopidevi (the inimitable SJ Suryah) and Manikyam (a funny Jayaram forgetting that he deserves better). There is a flashback that connects all of them, which is quite impressive for the narrative turns it takes, and the results it delivers. However, this flashback is bookended by the clashes between Ram and Mopidevi that threatens to snowball into something very sinister and diabolical, but is content in just being a shouting match, and a quick class on political etiquette and the powers of India's bureaucracy.Ram Charan and SJ Suryah in Game Changer Ram Charan and SJ Suryah are pitted against each other in Shankar's Game Changer

Just like how a lot of scenes are cramped in the name of elevation, the flashback is also too rushed to register a solid impact. Even before we can understand the magnitude of a sacrifice, we are thrown back into the present. It is disappointing to see Ram Charan and Suryah give it all for the portions that don't do justice to their histrionics. Also, their tug of war gets stale too soon because the chips are never really down for Ram, and the dialogues and expressions of Mopidevi are more menacing than his actions.

In such commercial potboilers, the melodrama is an integral part of the narrative. And despite a few scenes that had the potential to be much more, Shankar reins it all in, and these feel like mere afterthoughts rather than a soulcrushing experience. Also, many strong actors like Naresh and Achyuth Kumar are criminally wasted in the film. Even Sunil, who gets a rather interesting character trait, isn't allowed to go bombastic with the idea, and is underutilised. Also, it is disappointing how this trait is 'funny' in Sunil's case, but when it is an important facet of another character, we are expected to empathise. Why? How? Why this confusion? How do we deal with this dichotomy?

Despite the film blowing hot and cold with an erratic consistency, Game Changer is truly held together by consistently good performances. Ram Charan as Appanna and Ram Nandan is wonderfully earnest, and delivers an impressive performance in a role that definitely needed more layers. Anjali also gives all in a role that doesn't give her much. On the other hand, Kiara, with an impressive lip sync, manages to get an important character in Game Changer that cannot be brushed off as just 'hero's support system.' She does well too, but again, after a while, is underserved by writing that conveniently forgets her. I quite enjoyed Srikanth's arc, but it needed more space for it to become the emotional anchor between the timelines. Also, it is painful that Ram's 'family' doesn't get to do anything, except in the starting when his mother says,"You have become IPS, IAS... but when will you get married?" Come on! Oh, apart from the performance, another striking aspect of Game Changer is Thaman, who ensures there is never a moment where we are not invested in the proceedings, and the visuals of Tirru, which not only fits the world of Shankar but elevates it. Even if the writing falters, which it does in quite a few places, Thaman shifts gears to bring us back right into the groove. But even Thaman, Tirru, and the starcast lead by Ram Charan can only do so much when Shankar's writing doesn't follow his own rules of his own world, and showcases a final act that is outlandish even for his standards. It gets too verbose after a while that it almost undoes the goodwill the film received for its dialogues till then. Even the action sequences, which were measured and to the point, get all loud and too over the top. I can forgive Ram Charan dangling from the helicopter or slashing the ropes of henchmen tied to the track just before an incoming train zooms past them. But a line must be drawn somewhere, right? Right?It is intriguing how Shankar, who remains steadfast in his belief that songs must be a visual spectacle, and even delivers like few filmmakers can, didn't trust his instincts about other scenes. Shankar has been criticised for his previous films, and worked on the feedback to deliver a film that might be right on a few levels. In fact, for all intents and purposes, it is fair to call Game Changer his comeback of sorts. However, the OG game changer of Indian cinema, finds himself facing his biggest dilemma — to go with his gut instinct or what he thinks/is told works with the audience of today? In this case, wanting to please both, he has ended up cooking a film that might be a lot of things, but it is no game changer.

Anupam Mittal instructs Shark Tank India 4 pitcher to 'show some respect' to Varun Dua, tells him his 'business is dead'



A pitcher who has already raised Rs 16 crore in funding faced universal rejection on the latest episode of Shark Tank India, which debuted its fourth season this week. Entrepreneur Nitin Chawla from Ghaziabad pitched his onestop complaint registering app, OneDios, to a panel of five 'sharks' – Anupam Mittal, Aman Gupta, Vineeta Singh, Peyush Bansal, and Varun Dua, who has experience in the field of warranties and insurance, as CEO of Acko. Nitin asked for Rs 75 lakh in exchange of 1.5% equity, valuing his company at Rs 50 crore.

He told the 'sharks' that he's projecting revenue of around Rs 7 crore this year, but is still operating in losses. The 'sharks' were interested in learning more about Nitin's services, but didn't seem to understand what he was saying. Nitin introduced OneDios as a platform that decreases the amount of time that a customer spends registering complaints with a company, and promised that they would be able to register complaints within 60 seconds on his platform, regardless of which company they purchased their faulty product from. He then said that he also sells extended warranties on his platform, and also earns from the brands that have registered with him.

Varun said that as someone with first-hand experience in this field, he has 'burned a lot of money' on the extended warranty business. "There are too many variables in this, what you're saying is oversimplified," he said. But Nitin had an answer for everything. Anupam, however, seemed to catch onto his schtick. He said, "You are taking us all over the place without getting to the point. When one of us tries to dig deeper, your attitude suggests that you're laughing on the inside and waiting to put us in our place, as if we don't know what we're talking about. Show Varun some respect," and added, "If you want to continue lying to yourself, go ahead. But your business is over, it's been killed by AI. Have you heard the saying, 'If you can't convince them, confuse them'? I'm not confused, and I'm certainly not convinced. I'm out."

Tarak Mehta Ka Oolta Chashma actor Gurucharan Singh is 'facing financial difficulties, wants to die': Bhakti Soni

Gurucharan Singh, best known for playing Sodhi in the popular TV show Tarak Mehta Ka Oolta Chashma, was recently admitted to a hospital in Mumbai. Now, his friend Bhakti Soni has revealed that Gurucharan has stopped eating and is "very weak."Bhakti said, "I have been trying to get in touch with him and his family for the last couple of days, but their phones are switched off. So, right now, I don't have an update on his health. Three days ago, when he was hospitalised, I spoke to his mother. Gurucharan se meri koi baat chit hui nahi hai abhi (I haven't spoken to Gurucharan). I don't know what's happening with him, but from what I heard last, he is not even able to talk. He is very weak, I think."

Bhakti Soni revealed that Gurucharan Singh had stopped eating solid food three months ago and was only consuming a liquid diet. "He had stopped eating ever since he got back (home) three months ago. I don't exactly know when he did. He had stopped eating; he was not consuming a solid diet. After that, in the last few days, he did not have any water either, so he fell unconscious. Anyway, he had stopped eating food. He was only on some liquid diet, some milkshakes, coconut water type... He has been following this diet for some time," she said in an interview with SCREEN.

Bhakti also mentioned that Gurucharan's family had asked her to request him to have water at least, but he was not listening to anyone. "Even though doctors prescribed medicines he seems to not have had any medicines. I den't

Time to put past behind, Carlos Alcaraz and Jannik Sinner are men's tennis's new protagonists

If Jannik Sinner, the 23-year-old World No. 1 and heavy tournament favourite, defends his Australian Open title this month, he will become only the third player in the Open Era – after Roger Federer (06-07) and Novak Djokovic (15-16) – to win three consecutive hard court Majors.If Carlos Alcaraz, already the second most successful active men's tennis player at 21, lifts the seasonopening Major trophy, he will become only the sixth player to complete the career Grand Slam – winning all four Major titles at least once – in the Open Era.

The narrative of Djokovic, with former rival Andy Murray now in his camp, attempting to script more history and continue to keep his place among tennis's elite at the age of 37, may dominate headlines. But there is little doubt that Alcaraz and Sinner are the main protagonists of the men's draw in Melbourne this month.Nostalgia can be a powerful tool for keeping sport relevant. But the record-breaking success of Alcaraz and Sinner, who swept all four Majors last year, has ushered in the new guard seamlessly despite coming on the heels of the most universally adored generation of tennis players. They are doing it in a style that is earning them a reputation of being dominant-yet-popular athletes; they have built a resonant inter-personal rivalry that has produced some of the best tennis in recent years; they have, in a sense, deemed nostalgia redundant. The now retired, much loved duo of Federer-Nadal must make way for the emerging Sinner-Alcaraz rivalry. The previous generation, outside of the still-active, still-enthralling Djokovic, now belong to the priceless vault of internet compilations. Their presence is of more value to the statesman-like addresses they will make at public appearances than to modernday tennis.Perhaps, in a slice of fortune for the sport, Alcaraz and Sinner have allowed that transition to be smooth rather than awkward.Leading the tour

It may be a product of the eccentric tennis ranking system that Sinner and Alcaraz are not the top two seeds at the Australian Open, but they proved in 2024 that they are a league above the others in the matches that matter. Being on opposing sides of the draw opens up the possibility of them extending their already famous rivalry by facing off in a Major final for the first time. It is not a stretch to say the duo have produced the very best that men's tennis has to offer, arguably playing out the match of the year in each of the last three seasons. Their contrasting approaches and personalities have made for plenty of enthralling contests already.

Sinner comes into the tournament with uncertainty persisting over a potential ban. The Italian was exonerated after failing two doping tests in March after he successfully appealed his case of accidental contamination, but the World Anti-Doping Agency (WADA) has appealed to the Court of Arbitration of Sport (CAS), the hearing for which is yet to be scheduled. The storm that has swirled around him has not been a deterrent to his form on the court. He put together one of the greatest seasons of the ATP era last year after winning two Majors, six other titles including the year-end Finals and a title defence at the Davis Cup, and finishing his year with a whopping win-loss percentage of 92.4%. He arrives in Melbourne as the big tournament favourite again, even if he has a slightly tricky route, with a first-round encounter against the big-hitting Nicolas Jarry, against whom he has struggled in the past. A potential quarterfinal against home favourite Alex de Minaur also awaits.

Sinner's refined aggressive baseline playing style may be dominant, but it is a subtler niche compared to the overwhelming version of it played by Alcaraz, who is all energy, elasticity and charisma. Alcaraz's ever-expanding highlight reel gained him a hefty fan following even before he followed it up with four Majors, but he lacks consistency. The Spaniard had a banner year in 2024 - finishing with the French Open-Wimbledon double and silver medal at the Olympics - but he ended it on a tame note with early losses at the US Open and ATP Finals. Alcaraz may seek Sinner's steadiness, but the high points in his game - the ceiling of the level he can produce - are considerably higher than that of his Italian counterpart. That is part of the reason why Alcaraz leads their head-to-head 6-4, winning each of their three encounters last year; and why the Spaniard has won Majors across the three surfaces. The Spaniard has a history of peaking on the big stage, and if he is seeking time to get match sharpness and fitness before the business end of this tournament, he may be blessed with an easier route to the second week in Melbourne, where a lurking Djokovic may await in a potential blockbuster quarterfinal.Djokovic is entering what could be the most intriguing phase of his career - having established himself as the best of the previous generation, he wishes to be an equal of this one. His favourite tournament may be the perfect venue to rebuild himself after a poor 2024, but his path, as the seventh seed, is a perilous one. Promising Czech Tomas Machac, bigserving Reilly Opelka who just beat him in Brisbane, and old foe Grigor Dimitrov are waiting before he may face the Spaniard.For the Serb to extend his record to 25 Majors, it looks likely that he will have to go through at least one, if not both, of Sinner and Alcaraz. No player on tour, not even a history-maker like him, has looked capable of doing so recently

(File)Once regarded as one of India's fastest bowler before injuries curbed his promise, Varun Aaron on Friday announced his retirement from 'representative cricket'. "For the past 20 years, I have lived, breathed, and thrived on the rush of bowling fast. Today, with immense gratitude, I officially announce my retirement from representative cricket," Aaron posted on Instagram.

"Over the years, I've had to push both my physical and mental limits to recover from numerous career-threatening injuries, having to come back time and again, this was only possible thanks to the relentless dedication of the physios, trainers, and coaches at the National Cricket Academy," he continued. Before his India call-up, Aaron caught the eyes of the cricketing world when he bowled a 153kph delivery against Gujarat in the 2010-11 Vijay Hazare Trophy final. With his ability to constantly bowl over 150kph caught the attention of the Indian team management. One of the most infamous moments in an Indian jersey was when his bouncer broke England's Stuart Broad's nose in a Test in 2014.

Despite not making the Indian team since 2015, Aaron continued to bowl in domestic cricket. He picked 141 wickets at an average of 26.47 and an economy rate of 5.44 in 88 List A matches. He also snared 93 wickets at an economy rate of 8.53 in the 95 T20s he played. Aaron also played nine seasons of the IPL between 2011 and 2022, turning out for with Delhi Daredevils, Kings XI Punjab, Kolkata Knight Riders, Rajasthan Royals, Royal Challengers Bangalore and Gujarat Titans. In his final season, he won the title with Gujarat Titans in 2022.

Rahul likely to skip white-ball series at home against England

New Delhi: India batter KL Rahul is likely to be rested for the white-ball series against England beginning in Kolkata on January 22. The home series comprises five T20s and three ODIs which will be more significant considering it precedes the Champions Trophy starting February 19. However, Rahul will be available for selection for the Champions Trophy. India will play all their games in Dubai while the rest of the matches will be held in host nation Pakistan.

"He has sought a break for the England series but he will be available for selection for Champions Trophy," a BCCI source said.While the high-profile India batting crumbled in the Test series in Australia, Rahul was among the few batters who got runs. He was the third highest run getter for India with 276 runs in 10 innings at an average of 30.66.Though ahead in the pecking order, Rahul is fighting for the wicketkeeper batter's slot in the Champions Trophy squad alongside Rishabh Pant and Sanju Samson. Rahul had also sought rest from Karnataka's matches in the Vijay Hazare Trophy. Their quarterfinal will be played over the weekend.It remains to be seen if he will be available for Karnataka's Ranji Trophy campaign with head coach Gautam Gambhir highlighting the need to play domestic cricket for all India cricketers post the series loss in Australia

How Andy Murray was persuaded to coach Novak Djokovic 20 minutes after telling golfing partner, 'can't think of anything worse than coaching to do right now'

Novak Djokovic and Andy Murray first crossed paths as 12-year-olds, but one coaching the other wasn't in anyone's wildest imaginations. Murray in fact said he had waved aside the idea just 30 minutes before taking up the Djokovic offer in November. Speaking at length to BBC Sport, Murray recalled, "I was playing golf, and we'd been exchanging messages. Novak had messaged me, just wanting to chat. Then I was on the 17th hole of the golf course and the guy I was playing with said: 'Do you know what's next?'. I was like: 'No, not really'. He said: 'Do you have any plans to do any coaching?' And I said, 'Honestly, I can't think of anything worse to do right now'."

Adding ge just could not turn down the unique opportunity to coach long-time rival at the upcoming Australian Open, he told BBC: "Then 30 minutes later, I was in the car and called Novak, and we had a conversation."The duo would trial out the arrangement at Spain in December before Melbourne this week. "It made sense to trial it and see if it works. And then we said we'd make a more definitive decision after the tournament," said the 37-year-old Scotsman speaking for the first time about the gig to BBC. This is how the conversation went as narrated to BBC: "Novak asked if I would be interested in helping, which I obviously wasn't expecting. I said to him: 'Look, I need to think about it and talk to my family.' So I spoke to them, and after a couple of days, I thought that it was a pretty unique opportunity and experience.I thought it would be a good idea to try it."Murray retired last year after the Paris Olympics, while the Serbian legend is aiming to win a record-extending 11th Australian Open title, as well as a 25th major which would put him ahead of Australia's Margaret Court in terms of all-time victories.It wasn't expected to be all joy and fun given the two intense personalities, and BBC wrote, 'There will be little, if any, japing around in Melbourne.'Murray, otherwise known for his quips, got a little grinchy when asked if there would be lots of laughs. He told BBC: "At times it's very enjoyable. But high performance is not supposed to be laughs and jokes and messing around. In all the times I've been on tour, I haven't seen that from any of the best players in the world. I've seen it from some of the lower ranked players, and that's one of the reasons why they're not there."BBC noted that 'during Djokovic's open practice sessions against Carlos Alcaraz, Jack Draper and Arthur Fils on Rod Laver Arena, Murray watched every movement intently. Stood close behind Djokovic and sometimes in the doubles alley, Murray constantly offered feedback, shouted praise after winners and made notes during the practice sets.'Expected to work alongside Boris Bosnjakovic, who runs Djokovic's training centre in Belgrade, Murray told BBC: "It's about making small changes to things and trying to help him and improve with the whole team."He expects tempers to flare. "I know it's not easy out there it's stressful and at times he's going to want to vent towards his team and his box. Providing that he's giving his best effort and trying as hard as he can,
