

Ahead of New Year, tipplers guzzle liquor worth Rs. 402 crore on Monday in Telangana

Hyderabad: In what is dubbed as a record sale, liquor worth Rs.402.62 crore was sold across the State on Monday, in the run-up to the New Year's eve. According to excise officials, 3,82,265 cases of liquor and 3,96,114 cases of beer were sold on Monday. Hyderabad and surrounding districts of Ranga Reddy and Medchal recorded the highest liquor sale in the State, added officials. An average of Rs 70 crore to Rs 100 crore of liquor is sold in the State daily, while liquor worth Rs. 402 crore was sold in a single day. In December alone, the government had billed the shops a record Rs. 3523.16 crore as against the Rs 2,764 crore it did in the same month last year.

Inter first year student found hanging in BC Gurukul in Khammam

Khammam: An intermediate first year student died, allegedly by suicide, at the BC Gurukul College at Krishnapuram in Madhira mandal in the district. According to police, the deceased, Sai Vardhan of Mudigonda, came back to the college on Monday after four days of leave. He was found to be moody after he returned from home and during midnight hours he told his friends that he would go to the dormitory upstairs, but did not return to his hostel room. On Tuesday morning when the college students tried to open the door of the dormitory, they found that it was locked from inside. After a while they opened the window doors and found Sai Vardhan hanging from the ceiling fan in the dormitory.

SC grants additional time to Punjab govt to hospitalise Dallewal

New Delhi: The Supreme Court on Tuesday deferred till January 2 the hearing on a contempt plea seeking action against the Chief Secretary of Punjab for not complying with its earlier orders, where the Punjab government was directed to hospitalise farmer leader Jagjit Singh Dallewal. The 70year-old cancer patient has been fasting at Khanauri, the border point between Punjab and Haryana, since November 26 in support of their long-pending demands, including a legal guarantee for Minimum Support Price (MSP) for crops, loan waiver and reforms to improve conditions in the agricultural sector.

A Vacation Bench headed by Justice Surya Kant decided to defer the hearing after Punjab's Advocate General (AG) Gurminder Singh sought additional time to comply with its December 20 decision, where the Punjab government was directed to ensure the stable health condition of Dallewal, who is on a fast unto death."It is entirely the responsibility of the State of Punjab to ensure the stable health condition of Mr Jagjit Singh Dallewal, for which if he requires hospitalisation, the authorities must ensure to do so. The State Government, therefore, will take a call as to whether Mr Dallewal can be shifted to the makeshift hospital (temporary hospital, which is said to have been set up at a distance of 700 metres from the site) or to any other wellequipped hospital," the SC had ordered.AG Gurminder Singh submitted before Justice Kant-led Bench that a proposal has been submitted before the Union government stating that if the protesting farmers are invited to hold talks, Dallewal will likely accept medical aid. Adjourning the hearing to January 2, 2025, the Bench, also comprising Justice Sudhanshu Dhulia, said that it was only concerned with the compliance of its judicial orders and nothing else. In a special sitting on Saturday, the top court pulled up the Punjab government over its failure to ensure the stable health condition of Dallewal. After the Punjab government stated that other protesting farmers were obstructing the medical aid to Dallewal, Justice Kant-led Bench suggested that it could direct the Union government to provide logistical aid. The apex court ordered the Punjab Chief Secretary and Director General of Police (DGP) to comply with its directions within two days and posted the matter for hearing on December 31.It cautioned that if orders are not followed, the Supreme Court will consider framing charges of contempt



of court against the officials on the next date of listing.

Earlier, the Supreme Court had issued notice on a plea seeking contempt action against the Chief Secretary of Punjab for not complying with the apex court's orders.It said, "Medical aid has to be given (to Dallewal) and the impression is that you (Punjab authorities) are not following our orders."Expressing concern over Dallewal's life and safety, it had ordered the Punjab government to comply with its direction to get him hospitalised.Before this, the Justice Kant-led Bench said that protesting farmers were free to put their grievances directly before the top court after it was told that the farmer leaders did not attend the meeting with the court-appointed panel.

Remarking that the court's doors were always open, it said that farmers could put forth their demands directly before the apex court or through their authorised representative. In September, the Supreme Court ordered the formation of a committee to amicably resolve the grievances of the farmers protesting at the Punjab-Haryana border. It had suggested the panel headed by Justice Nawab Singh, a former judge of Punjab and Haryana High Court, to hold negotiations with the protesting farmers for the removal of their tractors, trolleys, etc., from the National Highway for the ease of the general public. Further, the apex court had granted liberty to farmers to shift their peaceful protests to an alternative site. Apart from Justice Nawab Singh, the panel comprised former Haryana DGP B.S. Sandhu, agricultural analyst Devender Sharma, Prof Ranjit Singh Ghuman, agricultural economist Dr Sukhpal Singh, and Prof Baldev Raj Kamboj as a special invitee.

Telangana High Court reserves judgement on KTR's quash petition

Hyderabad: The Telangana High Court on Tuesday reserved its judgement on the quash petition filed by BRS working president KT Rama Rao against the case filed by the Anti-Corruption Bureau in connection with the Formula-E race. Justice K Lakshman also extended the interim orders prohibiting an arrest till the court gave its judgement.Earlier, senior advocate Siddhartha Dave, appearing for Rama Rao, argued that there was no evidence of any misappropriation of funds in the case.There was no instance of funds being used for personal purposes and there was not a single rupee's benefit for Rama Rao, he said, pointing out that even the Sections under which the case was registered on December 9 by the ACB were not applicable.Also stating that the case was registered after



one year as if an afterthought, Dave argued that the case was nothing but an instance of political vendetta.

The state government of Andhra Pradesh has achieved significant milestones in its NTR Bharosa social pension program, ensuring that 91 percent of pensions were distributed within just 12 hours on Tuesday. In a noteworthy development, 93 percent of these pensions were delivered directly to beneficiaries at their homes, showcasing a commitment to accessibility and efficiency. The government has allocated a substantial Rs. 2,717 crore for the January pension disbursement, benefiting approximately 6.38 million individuals. This initiative is a part of the coalition government's broader efforts, which have seen over Rs. 20,000 crore spent on pensions since its inception. Notably, provisions are in place to provide immediate widow pensions to eligible recipients when a family's pension holder passes away. This month alone, 5,402 new widow pensions were granted, alongside a one-time distribution for 50,000 individuals who had not received pensions for three months.

Utilizing advanced technology, the state has actively geo-tagged the homes of 6.33 million pension beneficiaries. This innovative approach allows real-time monitoring of pension distribution, ensuring that funds are delivered directly to households. In instances where distribution does not meet expectations—such as beneficiaries receiving pensions more than 300 meters away from their homes due to connectivity issues—officials are taking corrective measures.Chief Minister Chandrababu Naidu has emphasized the importance of beneficiary satisfaction in the pension distribution process. In adherence to his directives, secretariat employees have been instructed to utilize social media platforms to address and resolve complaints



related to home delivery of pensions. The real-time analysis of geo-coordinates aids in identifying areas where pension distribution is lacking and helps officials implement necessary improvements swiftly.

The recent reporting indicates that as of noon on December 31, 91 percent of pensions had been distributed, with a commendable 93 percent delivered within 300 meters from beneficiaries' residences. Officials acknowledge that some distribution delays are attributed to signal problems in remote agency districts, such as Alluri Seetharama Raju. However, the administration remains committed to achieving the goal of delivering pensions directly to beneficiaries at their homes, with ongoing efforts to overcome any technological obstacles.In concluding remarks, government sources reaffirm that they are diligently working to enhance the pension distribution system, ensuring that every eligible resident can receive their entitlement in a timely and efficient manner.

Police serve notice to former BRS MLA Patnam Narender Reddy

On October 26, tension had prevailed at Rotibanda thanda under Dudyala mandal in Kodangal constituency as farmers and villagers declared that they would not part with their lands for pharma village. A public hearing programme was organized in the village on the day



and Congress mandal president A Shekar was obstructed by the villagers from entering the village. As the Congress leader entered into arguments with the villagers, they locked him up in the panchayat office.

Telangana police on high alert to tackle drug abuse during New Year parties in Hyd

Hyderabad: As Hyderabad gears up to bid adieu to year 2024 and usher in the New Year on Tuesday, revelers are under the close radar of the authorities for possible use of drugs.Telangana police has geared up to tackle the drug abuse during New Year parties at recreational hubs of the city. The Telangana Anti-Narcotics Bureau, in association with the Prohibition and Excise Department and local police formed 19 teams to conduct checking at pubs, bars, hotels, farm houses and places where New Year events are scheduled.

The police are deploying sniffer dogs to assist them in finding substances hidden at secret places by the drug addicts and smugglers. "Intelligence network is activated and basing on inputs special teams will conduct raids or search operations to check drug abuse in parties," said the official.In last three days, the police had intensified its checking at the pubs, bars, resorts, farm houses and places where events are planned. The police officials said they would not hesitate to check the events in gated communities, if they get any information about revelers using drugs.



Telangana Anti-Narcotics Bureau (TGANB) and Cyberabad Police raided on Sunday raided a party and subjected 14 persons to advanced drug testing out of which 8 tested positive. A case is registered against them.Meanwhile, the traffic police teams will conduct drunk driving checking from 8 pm onwards till the wee hours next day to curb accidents. The traffic police across the State have formed special teams for taking up the exercise.

Green corridor to shift toxic waste from Bhopal's UCIL to Pithampur

Bhopal: Over 12 containers, carrying around 337 tonnes of toxic waste, from the premises of Union Carbide India Limited (UCIL) will drive to Indore's Pithampur area from Bhopal, for which a green corridor has been created. All the containers will move together through a green corridor of around 250 km between the UCIL site to the dumping point in Pithampur. The process of packing and loading hazardous waste, which began on Sunday, was underway.

The authorities will move the waste to Pithampur Industrial Waste Management Pvt. Ltd. The Bhopal Gas Tragedy Relief and Rehabilitation Department officials suggest that containers will move once the loading work is completed. Waste packing is being done in airtight bags and containers amid tight security and under the supervision of senior officials, ensuring the safety of workers enrolled for it. All roads leading towards defunct UCIL premises have been banned. The waste is expected to be moved to Pithampur in Dhar district any day now as the state government has to submit an affidavit in the High Court's Jabalpur bench on January 3. The process for disposal of



toxic waste is being started following the Madhya Pradesh High Court's order on December 3. The court granted three weeks to the state government to complete the disposal process.Notably, the waste has been lying at the UCIL premises since the Bhopal gas tragedy on the intervening night of December 2 and 3 in 1984 when a highly toxic gas, methyl isocyanate, leaked from the factory killing 5,479 people, as per the government estimates.

Multi-state collaboration is imperative to liminate this toxic menace. Advanced surveillance techologies, such as geospatial mapping and drone patrols hould be deployed to monitor activities in the Aravallis. In ddition, stringent penalties and swift legal action are esential to deter culprits. Empowering local communities vith resources and platforms to report violations could olster enforcement efforts. The Aravallis are a lifeline for nillions of local residents. They are crucial to regulating proundwater recharge and mitigating urban heat. Allowing heir destruction for short-term gains is an environmental njustice that future generations will not forgive. Resolute ction is needed to save this irreplaceable treasure

Maharashtra asks primary govt schools to implement 'Aamche Guruji' again, teachers to not comply with order

A circular issued by the Nandurbar district education officer in Maharashtra on Monday to implement 'Aamche Guruji' (Our Teacher) initiative has sparked a controversy wherein the government primary school teachers have been directed to display their photos in schools.

The circular, which is applicable to all schools irrespective of medium and management, has asked the schools to submit a compliance report by January 2, 2025, to ensure that the initiative is fully implemented before the deadline of January 5.It referred to a virtual review meeting held by the state Directorate of Primary Education that gave directions for the orders, indicating that other districts are likely to follow suit

"All primary schools are instructed to prepare flexboards having photos of their permanent teachers in size of 6X4 inch along with information such as their names. educational qualifications, and subjects they teach. These flex-boards should be displayed prominently outside of the school-principals' office. This is expected to provide visitors with information on teachers working in the school and their subjects," it read. No state-wide circularEven as there is no state-wide circular in this regard, Sharad Gosavi, director of primary education, confirmed that his office has given orders to all education officers to implement 'Aamche Guruji'. "This is a Central government initiative and is applicable in different states," he added. The Nandurbar district education officer's circular has, however, triggered a row with the teachers planning to continue with their earlier stand of non-compliance. The state government first launched the initiative in July last year and sought compliance in December 2024."There is no clear objective of this initiative which definitely has no significance in academic activities. This is just another way of keeping teachers busy in unnecessary activities when clearly all students and parents - and in case of interiors of Maharashtra, the entire village - personally know their school-teachers," said Mahendra Ganpule, former head of the Maharashtra School Principals' Association. Teaching community ridicules motiveEven as the objective of the initiative is unclear, many have linked it to stem instances where 'bogus' teachers were found working in government schools. However, the motive has been ridiculed by many from the teaching community. "If bogus teachers are working, it is the failure of the system to keep a strict vigil. Putting up photos of teachers is not the solution." said Vijay Kombey, head of Maharashtra Rajya Prathamik Shikshak Samiti, an association of primary school teachers.

Masked men fire dozens of shots at 3 men outside gym in Haryana's Yamunanagar; 2 dead

gym shootingThe shooting took place in the morning in Kheri Lakha village of Yamunanagar when three to four masked men, who were wearing shawls and headgear, reached outside the gym and started indiscriminate firing at the men who came out of the gym after their workout. A group of masked men fired indiscriminately at three men after they came out of a gym after their morning workout in Haryana's Yamunanagar Thursday, killing two of them on the spot and leaving the third injured, in a suspected gang war. The Yamunanagar police said a gang war between the two groups could be one of the reasons behind the shootout, adding they were investigating the crime from all possible angles. The shooting took place in the morning in Kheri Lakha village of Yamunanagar when three to four masked men, who were wearing shawls and headgear, reached outside the gvm and started indiscriminate firing at the men who came out of the gym after their workout. All three men were shot at from point-blank range, said the police

When they were heading towards their Mahindra Scorpio, the three masked men approached them and opened fire. While Golani village's Virender Kumar and Pankaj Kumar of Barot village in Uttar Pradesh died on the spot, Unheri village resident Arjun is battling for his life. It is suspected that the total number of assailants could be more than three. So far, the exact motive behind this killing is not yet known," one of the investigating police officers said.

According to the police and eyewitnesses, the assailants fired dozens of gunshots before they fled on a motorcycle. The police recovered over 40 empty cartridges, and CCTV footage in which assailants could be seen firing multiple gunshots. "In the CCTV footage, it can be seen that the moment the victims opened their SUV's doors to get in, the assailants closed in and fired at them. The route and the vehicle on which the assailants fled are being ascer-

Pune International Airport records this year's highest passenger traffic in November

Pune International Airport recorded the highest passenger traffic of the year in November, with a 44 per cent growth in international passengers and approximately five per cent growth in domestic flyers compared to October. With 20,554 international flyers, November saw a significant increase of 6,316 more travellers compared to October, which recorded 14,238 international passengers. This rise has helped Pune Airport surpass 1.70 lakh international passengers from January to November. In contrast, domestic passenger traffic grew by five per cent, reaching 8.80 lakh flyers, up from 8.44 lakh flyers in October. However, while the Airport Authority of India's data shows a percentage growth for international passengers, the overall increase in numbers is more notable in domestic traffic. More than 35,000 additional flyers contributed to the airport's growing traffic, which is expected to continue rising in December.

The previous highest passenger traffic this year was 8.94 lakh passengers, recorded in May. But November broke the record, surpassing 9 lakh passengers in a single month, including both domestic and international traffic.Airport Director Santosh Dhoke attributed the increase in passenger numbers at Pune Airport to the launch of new flights and the commencement of operations under regional connectivity initiatives. In November, IndiGo launched two direct flights to Dubai and Bangkok. The Pune-Dubai flight



departs daily at 5.40 pm, arriving in Dubai at 10.10 pm, with the return flight leaving Dubai at 12.15 am. The Pune-Bangkok flight operates three times a week—on Wednesdays, Fridays, and Sundays-departing Pune at 11.10 pm, with the return flight from Bangkok departing at 01.15 am. According to the airport director, December is expected to see an increase in international flyers as Air India Express has launched a direct flight from Pune to Bangkok starting December 21. Five international flights operate from Pune Airport across three routes: Singapore, Bangkok, and Dubai. IndiGo operates flights to Dubai and Bangkok, SpiceJet serves Dubai, Air India (formerly Vistara) operates flights to Singapore, andnow connects Pune to Bangkok.

Deolankar mentioned even though the state rolled out NEP 2020 in autonomous colleges last year and in all colleges this year; there was still confusion among stakeholders on the types of changes it brings to higher education.

"We have already launched a School Connect campaign which is targeted to improve the Gross Enrolment Ratio (GER) and also educate participants on NEP. Apart from this, many NEP awareness activities are being held



across universities. These sessions with experts will help individuals understand NEP better," said Deolankar, issuing a circular in this regard on Tuesday. The higher education department is also in the process of creating a curriculum for NEP training for professors. "The plan is to offer seven-day online training for all professors. The higher education department is working with the Maharashtra State Faculty Development Academy (MSFDA) to create a curriculum for this training. The curriculum will then be shared with all universities in the state with instructions to ensure that all professors from their departments and affiliated colleges complete this seven-day training online," said Deolankar.

Police intensify security in Delhi's border areas for New Year eve celebrations

The Delhi Police has intensified security arrangements and increased deployments in the border areas of the national capital for New Year celebrations, officials said More than 10,000 police personnel, including traffic police are expected to be on the ground to rein in hooliganism and traffic violations, they said."After Christmas, we have made a robust plan for the security arrangements for New Year eve. We want everyone to welcome the new year with great zeal but no one will be allowed to breach the law," a senior police officer said. According to police, additional pickets, barricades and personnel - including paramilitary deployment — will be made at the borders to tackle nuisance by people from the adjoining states, said the officer. Delhi shares borders with Haryana and Uttar Pradesh and lies close to Rajasthan. A large number of people from these three states arrive in the national capital for New Year celebrations. The police said they have already deployed police personnel at more than 10 locations for Christmas, but now they have intensified their security and heavy deployment has already

been done on more than 15 locations from where vehicles enter the national capital."The traffic police has already chalked out a plan to combat motorcycle stunts and drink driving. Additional forces from different police stations will be deployed to help the traffic police," another senor police officer said. According to the police, there will be shift duties and SHOs have been ordered to be on the road with their teams to maintain law and order on New Year Eve. Teams will impound two or four wheeler immediately if anyone is found indulging in stunt-like activities. Strict action will be ensured, said the police officer."For New Year celebration, our teams are checking bus stands, railway stations, hotels, dharamshalas, night shelters and other locations to verify if anyone is staying without providing proper documents. We have already launched our special drive to identify those who are staying illegally in the national capital," said the officer. More than 10,000 police personnel from traffic and other units of the Delhi Police will maintain vigil. A senior police officer of the Delhi Traffic Police said traffic personnel will be deployed in adequate strength.

Police said the father of the victims is a conservancy staff and mother a labourer. The police registered a case against the accused man at a police station in Pune district under sections of the Bharatiya Nyaya Sanhita (BNS) and Prevention of Children from Sexual Offences (Pocso) Act.

'Act against Ajay Maken in 24 hours': AAP hits back over his 'anti-national' remark, says Congress working with BJP

With the Delhi Assembly elections around the corner, the ruling AAP accused the Congress, its INDIA bloc partner, on Thursday of helping the BJP and said the saffron party was funding Congress candidates' poll campaigning. Taking strong exception to senior Congress leader Ajay Maken's remarks about Arvind Kejriwal, the AAP demanded the party take action against Maken within 24 hours, warning that it would otherwise consult other INDIA parties to remove Congress from the national Opposition bloc.

"Yesterday, he (Maken) crossed all limits. He called our leader, the country's most loved leader, Arvind Kejriwal, anti-national. Till date, Ajay Maken or any other Congress leaders have not called any BJP leader anti-national. But we are anti-national? What kind of statement is this?... I saw yesterday they are also lodging an FIR against Kejriwal... He is the person who campaigned for Congress leaders during Lok Sabha polls even in Chandigarh," AAP Rajya Sabha MP Sanjay Singh said at a press conference."Congress in Delhi is standing tall with the BJP. The party here is doing everything to help the BJP in the upcoming polls. They have a leader here in Delhi, Ajay Maken, who reads the scripts prepared by the BJP, follows all the directions of the BJP and targets the AAP with statements against AAP leaders," he said. Maken made the remarks at a press conference on Wednesday where the Congress released a "white paper" on the "unfulfilled" promises of the both AAP government and the BJP-led Centre. "Making an alliance with the AAP for Lok Sabha polls was one of the biggest strategic blunders," he said.He reportedly called Kejriwal "anti-national" citing the AAP's stance on issues such as the Uniform Civil Code, abrogation of Article 370 and the Citizenship (Amendment) Act.AAP sources said Kejriwal was very upset over Maken's remarks.

"During the Haryana election, we tried till the end to contest the polls together, but they were not ready and went alone. But we did not say a word against Congress... But today, you see they are making such statements against us and Arvind Kejriwalji just to harm the AAP in the upcoming polls," Sanjay Singh said. The Raiva Sabha MP further attacked the Congress also over its Assembly poll candidates. "Just look at their list... They have brought in people like Sandeep Dixit and others to just harm the AAP in Delhi. They have fielded a person like Sandeep Dixit against Kejriwal from New Delhi... Now all the limits have been crossed. I request the Congress to take action against Maken within 24 hours, or we will speak with other parties in the INDIA alliance to remove Congress from the alliance," he said. Singh added that if the Congress leadership does not take action against Maken, "it will be clear that the AICC is also part of this plan". Congress getting crores of rupees from BJP: Atishi

Chief Minister Atishi asked if the Congress had ever called the BJP anti-national. "No, but today you are calling AAP and Arvind Keiriwal anti-national: you filed an FIR against me and Kejriwal ji... It is very clear that the Congress is siding with the BJP to cut our votes in the Assembly polls. Because if they cut our votes, who will benefit? BJP...," she said. Atishi further alleged that the BJP was funding the election campaign of Congress candidates. "The BJP is funding all Congress candidates. Top of the list is Sandeep Dixit and Farhad Suri, who have been fielded against Kejriwal and Sisodia. They are getting funds in crores from the BJP... Why did you make an alliance with us if you think we are anti-national? Why did you take help from Kejriwal for campaigning for your candidates? It is very clear that Congress leaders in Delhi are helping the BJP win the upcoming Assembly polls. They have made some pacts with the BJP to make them win the polls and harm the AAP," she said. Atishi also demanded action against the Youth Congress. The Congress and the AAP had an alliance in Delhi for the Lok Sabha elections and contested three and four seats respectively. However, both parties were defeated by the BJP.Soon after the polls, the AAP announced it would not make any alliance with the Congress for the Assembly polls, while Congress said that vote transfer did not happen in its favour despite the alliance.

Squid Game Season 2: The Pink Guards are watching you!



What causes red-eye effect in photographs?



Hyderabad: In a world, where selfie-clicking and posting them online is the happiest pass time, imagine a scenario when your best friend posts a picture of yours in which your eyes are blood-shot red and you have the crazy zombie look.So, what makes eyes look red in photographs? The answer is simple; it all concerns the camera flash reflecting off the eye at a specific wavelength.

The eyes enable us to see the world around and that's why it is one of the five senses to perceive the world. Light

comes into the eye through the cornea. The retina then perceives the light and its images are sent to the brain via the optic nerve. The pupil controls the amount of light that gets to the retina. If it's a sunny day, the pupil constricts and allows a small amount of light in. During night-time, the pupil dilates and becomes quite large to allow as much light as possible. Sitting between the retina and the sclera (the white part of the eye) lays a layer of connective tissue called the Choroid, an extremely vascular area containing many blood vessels. When the light from a camera flash goes off, the pupils do not have time to constrict, so a large amount of light is reflected off of the Fundusmelanine (the eye's interior surface). Due to the large amount of blood in the Choroid, the light picked up by the camera lens appears red. The closer the flash is to the camera lens, the greater the chance the lens sees the reflected light. The darker the environment a person is in, and thus the wider their pupils are, the greater the chance of having blood-shot eyes. Other factors for the red-eye effect are the amount of melanin behind the retina and the person's age. The red-eye effect is stronger in light-skinned people with blue eyes than in dark-skinned people with brown eyes. Children also tend to get a red-eye effect more as a child's pupil will dilate faster than adults in low-light situations.

Which disease has the potential to turn into epidemic in 2025?

Hyderabad: Since the emergence and killing of millions of people around the world by COVID-19, most people have been nervous about the emergence of the next big infectious disease – be that a virus, bacterium, fungus, or parasite.With COVID-19 in retreat, the three infectious diseases causing public health officials the greatest concern are malaria (parasite), HIV (virus) and tuberculosis (bacterium). Between them, they kill around 2 million people each year. And then there are the watchlists of priority pathogens – especially those that have become resistant to the drugs usually used to treat them, such as antibiotics and antivirals.

Scientists must also constantly scan the horizon for the next potential problem. While this could come in any form of pathogen, certain groups are more likely than others to cause swift outbreaks, including influenza viruses. One influenza virus causing great concern right now is influenza A subtype H5N1, sometimes referred to as "bird flu". This virus is widely spread in both wild and domestic birds. Recently, it has also been infecting dairy cattle in the US States and is found in horses in Mongolia. When influenza cases start increasing in animals such as birds, there is always a worry that it could jump to humans. Indeed, bird flu has infected humans in the US this year, mostly resulting from farm workers and people drinking raw milk. Luckily, H5N1 bird flu doesn't seem to transmit from person to person, which greatly reduces its likelihood of causing a



pandemic in humans.Influenza viruses have to attach to molecular structures called sialic receptors on the outside of cells to get inside and start replicating.A recent study showed that a single mutation in the flu genome could make H5N1 adept at spreading from human to human, which could jump-start a pandemic. Even without the potential ability to spread between humans, bird flu is likely to affect animal health even more in 2025. This not only has large animal welfare implications but also the potential to disrupt food supply and have economic effects as well.The governments also must not forget about the continuing "slow pandemics" in humans, such as malaria, HIV, tuberculosis and other pathogens. Tackling them is paramount alongside scanning the horizon for any new diseases that might yet come.

Of human greed and vanishing mountains

India's oldest mountain range — Aravalli — had long become the victim of human greed, with 31 out of the 128 hillocks vanishing. The environmental degradation of the three-billion-old Aravalli range, which straddles the States of Rajasthan, Haryana, Delhi and Gujarat, exposes the apathy of successive governments towards the open plunder of mineral resources. Once a thriving ecosystem of hills, forests, fauna, aquifers and natural drainage, the Aravallis now carries the dubious distinction of being the country's most degraded forest range. Taking advantage of the jurisdictional ambiguities, miners have ravaged the hills, particularly in villages along the Harvana-Raiasthan border. leaving flattened landscapes and staggering losses. In 2023 alone, over eight crore tonnes of minerals vanished from the hills due to relentless assault from illegal mining, reducing their majestic peaks to rubble. Despite repeated FIRs and complaints by the affected villagers, no action to halt the destruction is visible. The loss is not just economic - it has devastated local habitats, displaced communities and disrupted groundwater recharge zones critical for the Delhi-National Capital Region's ecology. The Haryana government has estimated a Rs 2,500-crore loss over the last two years due to illegal mining by contractors from Rajasthan, who, it alleges, exploit the lack of demarcation to expand their activities unchecked. To counter this menace, Haryana has planned to use LiDAR (light detection and ranging) technology for boundary demarcation and intends to recover costs from Rajasthan. However, this jurisdictional tussle only underscores deeper governance failures. Collabora-

tive action by the two States is essential to resolve disputes and implement the Supreme Court directives banning mining in the Aravallis.

A 2023 study shows that nearly 8% of the Aravalli mountains have disappeared since 1975, with projections indicating a 22% loss by 2059 if rapid urbanisation and mining continue. However, the focus must shift to preventive measures - deploying advanced surveillance technologies, imposing strict penalties on unscrupulous miners and bolstering enforcement. The ambitious Aravalli Green Wall Project, an eco-restoration initiative by the Centre, gives some hope. It has the potential to become a turning point in combating land degradation and desertification. Covering over 1.1 million hectares across Haryana, Rajasthan, Gujarat and Delhi, this 1,400-km-long and 5-km-wide green corridor aims to restore the Aravalli hills' ecological vitality. It seeks to reverse the destruction. Haryana's proactive measures, such as reviving 75 water bodies and restoring 35,000 hectares of degraded land, exemplify the potential of collaborative efforts among States to tackle this environmental crisis. The World Bank is supporting the project with funding for initiatives like afforestation, water conservation and pollution control. Notwithstanding the lofty goals, the project's success, however, depends on enforcing conservation laws to prevent illegal mining and encroachments. The States must transcend political boundaries to protect these shared ecological treasures. The Green Wall Project is a fight to reclaim the Aravallis and reverse decades of destruction

One wonders, will future Mood Indigo festivals feature slogans even bolder, or will they find their way back to the timeless simplicity we cherished?As someone who cherished the 1987 edition, I'm reminded of how diversity of thought and expression defined the festival's spirit. By all means, let the sponsors support the show – but maybe next time, they could tone down the condescension. After all, some legacies deserve a softer lens.

Mumbai's BEST workers' union protests over BMC's neglect, calls for revival steps

BEST buses, BMC, mumbaiA silent protest was staged by workers of Brihanmumbai Electric Supply & Transport (BEST) across Mumbai, demanding reforms and better support from the Brihanmumbai Municipal Corporation (BMC) in light of the growing discontent with the cashstrapped public transport undertaking. A section of workers at Brihanmumbai Electric Supply & Transport (BEST) staged a silent protest across Mumbai by wearing black armbands on Thursday, to highlight their growing discontent with the Brihanmumbai Municipal Corporation's (BMC) approach towards the cash-strapped public transport undertaking.Workers affiliated to the Shiv Sena (UBT)backed BEST Kamgar Sena staged the protest in depots of Mulund, Colaba, Oshiwara, Malwani, Malad, Bandra, and Poinsur to highlight the need for reviving the public transport system. Their key demands include halting the privatisation of BEST services, ending the wet lease system for buses, procuring self-owned buses, recruiting new staff, and clearing pending gratuity and Covid-19 allowances

for employees. The union argued that these steps are important to revive BEST buses from financial loss, shrinking fleet, and rising accidents. The protest follows BMC Commissioner Bhushan Gagrani's reported statement that BEST does not come under the civic body's responsibility. However, Suhas Samant, president of BEST Kamgar Sena, hit back saying that BMC is BEST's parent body and hence responsible for its condition. "The Commissioner speaks of cooperation, but responsibility means guardianship, not mere assistance," Samant said on Thursday After the BEST bus accident on December 9 that killed eight people, Kamgar Sena representatives had demanded Gagrani for a more proactive approach and urged BMC to take full control of BEST operations instead of offering just financial aid."This is a fight for the survival of BEST. The current approach is unsustainable, and systemic reforms are urgently needed," added Samant.On the other hand, the BMC has refuted allegations of neglecting BEST, stating it has provided Rs 11,232 crore financial aid over the last decade, including Rs 850 crore this year.

Kolkata doctorsWomen march towards the CBI (Central Bureau of Investigation) office in protest against the alleged rape and murder of a woman medic at the RG Kar Medical Collage and Hospital, in Kolkata, The crime scene in the RG Kar case "was not in well-preserved condition, there were evidences of disturbances evident on the scene", a team from the Central Forensic Science Laboratory (CFSL), Delhi, has said in its report, which is now part of a Central Bureau of Investigation chargesheet in the rape and murder of a junior doctor at the hospital. The 12-page report is dated September 11. The report, compiled by a 14-member multi-institutional medical board (MIMB) comprising senior doctors, scientists and forensic experts who visited the crime scene several times, came days after the August 9 rape and murder of the junior doctor in the seminar room of the hospital, triggering massive protests by doctors in the state

Sanjoy Roy, a civic volunteer working for Kolkata police, was arrested in connection with the crime on August 10.Significantly, former RG Kar director Sandeep Ghosh has been accused of having ordered renovation at the hospital just after the rape and murder came to light. This was after a memo, allegedly issued on the West Bengal government's letterhead to its Public Works Department and calling for urgent repairs at the hospital a day after the rape and murder, led to allegations of a "cover-up" and "evidence tampering" against Ghosh.

"Here one demolished wall was evidently corresponding pre-presence of a door area, another demolished wall area was having fixed and functional electric peripherals and as such did not correspond to pre-presence of a particular passage. The concrete materials, building materials, broken tiles were found scattered on the floor of the said rooms and corridor also evaluated forensically by the CFSL team. The adjacent room (meant for inhouse doctors' rest purposes) was also found to be demolished in unprofessional manner. Its wall was found smashed that was corresponding to an entry gate," the report said."In this restroom, some patient beds and wooden furniture with dirty mattresses/bedsheets were kept haphazardly, whereas, demolished concrete material was not found. The two wooden gate frames (stated to be removed) were found to be kept in front of the demolished wall of the Room 1 (seminar room) in the corridor area," it said. Evidence of possible struggle "shown by the victim to the assailant or fight in between them found missing in the shown area of occurrence," the report states. "There is less possibility that someone (in the presence of the official attendees present in the 24×7 operational hospital corridor, doctor's duty-nursing station area) can enter into the seminar hall unnoticed, for committing offence," it states. The findings have come into the public domain at a time when the parents of the victim moved the Calcutta High Court seeking a fresh investigation into the case, saying they didn't have faith in the current investigation led by the Central Bureau of Investigation, which took over investigation into the case in August from the Kolkata Police on the directions of the Calcutta High Court. The parents' decision to move the HC comes days after a local court granted bail to Ghosh and Abhijit Mondol, the former officer-in-charge of Tala police station after the CBI failed to submit its chargesheet against them within the mandated 90 days.

After sexually assaulting Chennai university student, roadside vendor took her number, threatened her to keep meeting him

'Exchanged 36 calls (with accused), kept requesting police to act': Brother of sarpanch brutally killed in Maharashtra's Beed

Extortion, murder and a political slugfest that forced even the CM to respond – the murder of a beloved sarpanch in Maharashtra's Beed district has led to anger that refuses to die down.At the village of Santosh Deshmukh (45), the sarpanch of Massajog in Kaiz tehsil, posters demanding justice for his killing are ubiquitous. Since his murder on December 9 – allegedly by local strongmen with links to the NCP – his family has seen a constant stream of visitors, from well-wishers to politicians and social activists.The family, which hails from Barshi tehsil around 80 kilometres from Massajog, shifted here around 50 years ago and settled at Deshmukh's uncle's home.

When The Indian Express visited the village, a pandal had been erected alongside a local temple, where Deshmukh's brother Dhananjay sat on the ground, receiving those who came to pay their condolences.On a table was a garlanded photo of Deshmukh and text in Marathi that read: "Nyay pahije (need justice)." Another poster in the village read, "Aamcha rajala nyay pahije (justice for our king)."santosh deshmukh, sarpanch murder, maharashtra beed news, indian express A pandal had been erected alongside a local temple, where Santosh Deshmukh's brother Dhananjay sat on the ground, receiving those who came to pay their condolences.

"He was known to help anyone who approached him. He never cared for what the post of sarpanch would get him; only the development of the village. That is why he held the post for 15 years," said Mihi More, 70, a resident.On December 9, Deshmukh was kidnapped in broad daylight, shoved into a black Scorpio, and allegedly assaulted for around three hours before he succumbed. His body was dumped on a road near his village. The post-mortem indicates he died "due to haemorrhage and shock due to multiple injuries".

He is survived by his elderly parents, wife, and two children aged 13 and 17. Four people have been arrested so far – NCP's former Beed tehsil president Vishnu Chate, Jairam Chate, Mahesh Karad and Pratik Ghule. Following his arrest, Vishnu Chate was expelled by the Ajit Pawar-led NCP on December 14. Three others are absconding – Sudarshan Ghule, Krushna Andhale and Sudhir Sangle. The family has also alleged the involvement of Walmik Karad, a relative of the main accused Vishnu Chate. Karad is a group leader in Parli Nagar Parishad, president of the Ladki Bahin Yojana in Beed, and NCP's member of the Beed district planning committee. Both Karad and Chate were named in an extortion FIR filed just days before the murder.

Dhananiay, the victim's brother, claimed Deshmukh

Munde, Chief Minister Devendra Fadnavis announced a judicial probe and transferred the Beed district superintendent of police. He also said the murder would be probed by a Special Investigation Team headed by an Inspector General-level rank officer. Fadnavis informed the assembly that Karad has been booked for extortion under the Maharashtra Control of Organised Crimes Act and would also be booked in Deshmukh's murder if his role is found.Meanwhile, Maharashtra minister Dhananjay Munde, who belongs to the Beed district, met Fadnavis Thursday. Talking to reporters after the meeting, state Food and Civil Supplies Minister Munde said a meeting of his department was around the same time as the chief minister's meeting at the Sahyadri guest house in Mumbai. The minister said that from the very beginning, he had been demanding that Deshmukh's killers be "hanged to death" and also accused the media of "trying to finish him off". "Even if the killers may be close to anyone including me, I have said the accused must be punished. Still, if I am being targeted, one can make out what kind of politics this is," he said. "What can be the objective of the media trial against me... (but) to finish me off politically."The case

According to the FIR, six persons with rods, stones and beer bottles exited the SUV, assaulted both of them and forced Deshmukh into their vehicle. Shivraj said he informed Deshmukh's brother Dhananjay over the phone and asked him to reach the police station to lodge a complaint. Around 6:30 pm, the police found Deshmukh's body dumped in the area."As soon as we got to know about the abduction, I rushed to the police station. The police team started looking, but they could not trace him. Meanwhile, since Shivraj had recognised the accused as supporters of Vishnu Chate, I called him directly. He initially said he would look into it and later called me saying my brother would return in some time," Dhananjay claimed."In two hours, we spoke 36 times over the phone but my brother did not return. During this time, I kept requesting the police to trace my brother, but they took it lightly. They said I should continue to be in touch with Chate and inform the police once he returns. After four hours, we received information that my brother's body had been found. It was only then that the police took the official complaint," Dhananjay alleged.

Mumbai's BEST workers' union protests over BMC's neglect, calls for revival steps

BEST buses, BMC, mumbaiA silent protest was staged by workers of Brihanmumbai Electric Supply & Transport (BEST) across Mumbai, demanding reforms and better support from the Brihanmumbai Municipal Corporation (BMC) in light of the growing discontent with the cashstrapped public transport undertaking.

A section of workers at Brihanmumbai Electric Supply & Transport (BEST) staged a silent protest across Mumbai by wearing black armbands on Thursday, to highlight their growing discontent with the Brihanmumbai Municipal Corporation's (BMC) approach towards the cashstrapped public transport undertaking.Workers affiliated to the Shiv Sena (UBT)-backed BEST Kamgar Sena staged the protest in depots of Mulund, Colaba, Oshiwara, Malwani, Malad, Bandra, and Poinsur to highlight the need for reviving the public transport system.

Their key demands include halting the privatisation of BEST services, ending the wet lease system for buses, procuring self-owned buses, recruiting new staff, and clearing pending gratuity and Covid-19 allowances for employees. The union argued that these steps are important to revive BEST buses from financial loss, shrinking fleet, and rising accidents. The protest follows BMC Commissioner Bhushan Gagrani's reported statement that BEST does not come under the civic body's responsibility. However, Suhas Samant, president of BEST Kamgar Sena, hit back saying that BMC is BEST's parent



body and hence responsible for its condition. "The Commissioner speaks of cooperation, but responsibility means guardianship, not mere assistance," Samant said on Thursday.After the BEST bus accident on December 9 that killed eight people, Kamgar Sena representatives had demanded Gagrani for a more proactive approach and urged BMC to take full control of BEST operations instead of offering just financial aid. "This is a fight for the survival of BEST. The current approach is unsustainable, and systemic reforms are urgently needed," added Samant.On the other hand, the BMC has refuted allegations of neglecting BEST, stating it has provided Rs 11,232 crore financial aid over the last decade, including Rs 850 crore this year. It emphasized its continued support with plans for substantial provisions in the upcoming budget.

How a blood-soaked shirt, CCTV footage helped Mumbai police arrest accused in actor Kritika Chaudhary's murder case

Nearly a month later, officers from the Amboli Police Station managed to nab the two accused, including a delivery person for a drug peddler and his fruit vendor friend, with the help of a blood-stained shirt found at the crime spot, blurred CCTV footage, and Chaudhary's contacts. The police arrested the two accused on July 10 that year for killing the television and film actor hailing from Haridwar allegedly over a dispute over Rs 6,000 she owed to the accused.

After neighbours complained of a foul smell emanating from inside her home, the police on June 12, 2017, reached the Bhairavnath SRA building near the Regional Transport Office (RTO) where Chaudhary lived and found her body. They said Chaudhary had been killed at least two to three days earlier. The police said they recovered a bloodsoaked shirt belonging to foreign brand 'Royal Premium' near her body, along with a pair of brass knuckles allegedly used to kill her. They also found that her jewellery was missing.As the police started their instigation into the murder, blurred CCTV footage revealed that two men entered Chaudhary's building on June 8. The police also inquired with all major retailers about the shirt's origin, but could not find any clue. They said the security guard, a witness in the case, identified one of the men in the CCTV footage as Shakeel Nasim Khan (then 33), who was wearing the said shirt. The police claimed the shirt was a crucial piece of evidence to prove Khan's involvement in the crime. Besides CCTV footage, the police also scanned her cellphone contacts and guestioned those who were in touch with her, and zeroed in on Khan from the Govandi area, who had been in contact with Chaudhary for more than a year. Khan had been arrested by the Mumbai police's Anti-Narcotics Cell in August 2016 in another case for delivering Mephedrone and was released on bail in November of that year. Before his arrest in that case, Khan had allegedly supplied drugs to Chaudhary and she owed him Rs 6,000 for the same. As per the police, demonetisation had come into effect when he was released on bail, and as he faced a cash crunch, Khan had started visiting Chaudhary's house seeking money. They said she was allegedly stalling the payment.On the day of the incident, Khan allegedly asked his friend Badshah alias Basudas Makamlal Das (then 40) a fruit vendor from Nalasopara who was also in need of money, to accompany him to Chaudhary's house. As per police, when Chaudhary said she would pay him later, Khan hit her on the head with brass knuckles, changed his bloodsoaked shirt by leaving it on the floor, and wore a fresh one that he was carrying with him.Before leaving, the accused allegedly switched on the air conditioner to mask the smell of the decomposing body. Khan then moved from Nalasopara to other places and later stayed with a relative in Panvel, from where he was arrested, after which Das was detained from Govandi. The police found the jewellery belonging to Chaudhary in Khan's possession and also recovered the key with which they locked the door of the actor's flat from Das





COP29 U.N. Summit: Civil society protests against climate finance proposal, calls for 'no deal' over 'bad deal'

Civil society members staged a silent march at the U.N. climate summit, condemning the developed nations' proposal to increase annual climate finance to a meagre \$250 billion by 2035. They called on the developing world to reject what they described as an "insulting" and "unjust" deal. With their arms crossed in defiance, protesters walked silently through the summit venue, where chanting is prohibited"We urge you to stand up for the people of the Global South, and we insist: no deal in Baku is better than a bad deal, and this is a very, very bad deal because of the intransigence of developed countries," said Climate Action

Network (CAN), a global coalition of more than 1,900 civil society organisations, in a letter to G77 and China, the largest bloc of developing nationsThe letter urged negotiators to abandon weak agreements, saying, "If nothing sufficiently strong is forthcoming at this COP, we urge you to walk away from the table to fight another day, and we will fight the same fight."Shailendra Yashwant, senior advisor at CAN South Asia, denounced the proposal, saying, "The NCQG (New Collective Quantified Goal on climate finance) number of \$250 billion in the latest ministerial text is not a joke, it's an insult to the people of the Global South salvaging their belongings and trying to rebuild their lives from floods, heatwaves, cyclones, landslides or forest fires and other climate change-induced disasters."Harjeet Singh, Global Engagement Director for the Fossil Fuel Non-Proliferation Treaty Initiative, called the proposal "a disgrace"

He said, "Developed countries are fully aware of the cost of climate action, which is running into trillions of dollars annually. Yet they had the audacity to offer this paltry amount." Renowned activist Greta Thunberg also slammed the draft text on climate finance, calling it "a complete disaster" and a "death sentence" for millions already vulnerable to the climate crisis.At the U.N. climate conference in Baku, countries are required to reach an agreement on a new climate finance package to help developing countries cut greenhouse gas emissions and adapt to the warming world. The summit was scheduled to conclude on Friday (November 22, 2024) but spilt into overtime as developed nations only presented a concrete climate finance figure in the closing hours. The \$250 billion amount they have offered is a far cry from the trillions required to tackle the escalating climate emergency. Developing nations have been demanding at least \$1.3 trillion annually -- 13 times the \$100 billion pledged in 2009 -- starting in 2025 to address their escalating climate challenges. They have said that a significant portion of this \$1.3 trillion should come directly in public funding from developed countries.

Israeli strikes kill dozens in Gaza over 48 hours, damage hospital in north, Palestinian medics say



GNS News Agency, Dec 31CAIRO, Israeli military strikes across the Gaza Strip have killed at least 120 Palestinians over the last 48 hours and hit a hospital on the northern edge of the enclave, wounding medical staff and damaging equipment, Palestinian medics said on Saturday. Among the dead were seven members of one family whose house was hit overnight in the Zeitoun suburb of Gaza City, the health officials said. The rest were killed in separate Israeli strikes in central and southern Gaza. At the same time, Israeli forces deepened their incursion and bombardment of the northern edge of the enclave, their main offensive since early last month.

Israel's military says it aims to prevent Hamas fighters from waging attacks and regrouping in the area. Local residents say they fear the aim is to permanently depopulate a strip of territory as a buffer zone, which Israel denies. At Kamal Adwan Hospital, one of three medical facilities on

the northern edge of Gaza that is barely operational, director Hussam Abu Safiya said the ongoing Israeli bombardment appeared aimed at forcing hospital staff to evacuate something they have refused since the incursion began."Yesterday (Friday), from the afternoon until midnight, the bombardment directly targeted the entrance to the emergency and reception area several times," he said in a statement, adding that 12 staff members including doctors and nurses were injured. The strike also caused significant damage that disrupted the electrical generator, oxygen supply network and water supply, he added. Asked to comment on Abu Safiya's statement, the Israeli military said that following an initial review it was "not aware of a strike in the area of the Kamal Adwan Hospital".

"The IDF (Israel Defense Forces) ... is doing everything possible to avoid causing harm to civilians," it added.Israel says Hamas uses hospitals and civilians as human shields, and has made public videos and photos to support that claim. Hamas rejects the allegations and says it does not use the civilian population or facilities for military purposes.Israel's 13-month campaign in Gaza has killed more than 44,000 people and displaced nearly all the enclave's population at least once, according to Gaza officials. The war was launched in response to an attack by Hamas-led fighters who killed 1,200 people and captured more than 250 hostages in Israel on Oct. 7, 2023, according to Israeli tallies. Months of attempts to negotiate a ceasefire have yielded scant progress and negotiations are now on hold, with mediator Qatar having suspended its efforts until the sides are prepared to make concessions. Hamas wants a deal that ends the war, while Israeli Prime Minister Benjamin Netanyahu has said the war can end only once Hamas is eradicated.

Powerful Israeli airstrike in central Beirut kills 11, Lebanese health ministry says

BEIRUT, GNS News Agency, Dec 31,A powerful airstrike killed 11 people in central Beirut on Saturday, the health ministry said, shaking the capital as Israel pressed its offensive against the Iran-backed Hezbollah group.An eight-story building was struck with four missiles, including bunker-penetrating types designed to hit underground targets, said a Lebanese security source.Israel has used bunker-busting weapons to kill senior Hezbollah figures, including its veteran leader Hassan Nasrallah in a strike on southern Beirut in September.Saturday's blasts shook the capital at around 4 a.m. (0200 GMT) and left a deep crater. Beirut smelled strongly of explosives for hours afterwards.Rescuers searched through rubble, in an area of the city known for its antique shops.

It was the fourth Israeli airstrike this week targeting a central area of Beirut, in contrast to the bulk of Israel's attacks on the capital region, which have hit the Hezbollahcontrolled southern suburbs. On Sunday an Israeli airstrike killed a Hezbollah media official in the Ras al-Nabaa district of central Beirut. The Israeli air force also struck Hezbollah targets in the southern suburbs of Beirut, the group's stronghold, the Israeli military said. In a statement on actions on Saturday, it did not mention the strike on central Beirut. It accused Hezbollah of embedding its infrastructure in civilian areas and using the population as human shields, allegations the group denies.

The figures do not distinguish between combatants and civilians. Hezbollah and the Lebanese government accuse Israel of indiscriminate bombing that kills civilians. Israel denies the allegation and says it takes numerous steps to avoid the deaths of civilians. Hezbollah strikes in the same period have killed more than 100 people in northern Israel and the Israeli-occupied Golan Heights. They include more than 70 soldiers killed in strikes in northern Israel and the Golan Heights and in combat in southern Lebanon, according to Israel. The conflict began when Hezbollah, Tehran's most important ally in the region, opened fire in solidarity with its Palestinian ally Hamas after it launched the Oct. 7, 2023 attack on southern Israel.A U.S. mediator travelled to Lebanon and Israel this week in an effort to secure a ceasefire. The envoy, Amos Hochstein, indicated progress had been made after meetings in Beirut. before going to meet Israeli Prime Minister Benjamin Netanyahu and Defence Minister Israel Katz.

Hungary's Orban vows to disregard international arrest warrant for Netanyahu

Hungarian Prime Minister Viktor Orban on Friday denounced the International Criminal Court's issuing of an arrest warrant for Israeli Prime Minister Benjamin Netanyahu, saying he would defy it by inviting him to Hungary. In comments to state radio, Mr. Orban accused the International Criminal Court (ICC), the world's top war crimes court based in The Hague, of "interfering in an ongoing conflict for political purposes," saying the decision to issue the warrant for Mr. Netanyahu over his conduct of the war in Gaza undermined international law and escalated tensions.Member countries of the ICC, such as Hungary, are required to detain suspects facing a warrant if they set foot on their soil, but the court has no way to enforce that. The ICC issued the arrest warrant on Thursday for Mr. Netanyahu as well as for his former defence minister and Hamas' military chief, accusing them of crimes against humanity in connection with the 13-month war in Gaza. The warrants said there was reason to believe Mr. Netanyahu and former Defence Minister Yoav Gallant used "starvation as a method of warfare" by restricting humanitarian aid and intentionally targeted civilians in Israel's campaign against Hamas in Gaza

charges Israeli officials deny. In his comments Friday, Mr. Orban, a close Netanyahu ally, called the arrest warrant "outrageously impudent" and "cynical." He said he would invite Mr. Netanyahu to Hungary later Friday and vowed to disregard the warrant if the invitation is accepted."We will defy this decision, and it will have no consequences for him," Mr. Orban said. Hungarian Foreign Minister Peter Szijjarto earlier criticised the ICC's warrant as "absurd." Israel and its top ally, the United States, are not members of the court. But other Israeli allies, including some of its close European friends, are put in an awkward position by the warrants.Several, including France, welcomed the court's decision and signalled they might arrest Mr. Netanyahu if he visited. White House press secretary Karine Jean-Pierre said President Joe Biden's administration was "deeply concerned by the prosecutor's rush to seek arrest warrants and the troubling process errors that led to this decision."Mr. Netanyahu on Friday praised Hungary for its stance on the warrant, saying in a statement: "Against the shameful weakness of those who stood by the outrageous decision against the right of the State of Israel to defend itself.

Rich countries boost COP29 climate finance offer as developing nations seethe

BAKU, GNS News Agency, Dec 31The European Union, U.S. and other wealthy countries at the COP29 summit have agreed to raise their offer of climate funding to \$300 billion per year by 2035 to help developing nations grapple with climate change, sources told Reuters on Saturday, after a previous proposal was dismissed as insultingly low. The summit had been due to finish on Friday but ran into overtime as negotiators from nearly 200 countries who must adopt the deal by consensus - tried to reach agreement on a climate funding plan for the next decade.

A \$250 billion proposal for a deal, drafted by Azerbaijan's COP29 presidency on Friday, was deemed woefully insufficient by developing countries. It was not clear if the wealthy countries' revised position had been formally communicated to developing countries at the gathering in the Azerbaijan capital Baku, and whether it would be enough to win their support. The COP29 talks have laid bare the divisions between wealthy governments constrained by tight domestic budgets and developing nations reeling from the soaring costs of storms, floods and droughts fuelled by climate change.Past failures to meet climate finance obligations have also made developing countries mistrustful of new promises. The new goal is intended to replace developed countries' previous commitment to provide \$100 billion in climate finance for poorer nations per year by 2020. That goal was met two years late, in 2022, and expires in 2025. Five sources with knowledge of the closed-door discussions said the EU had agreed it could accept the higher number of \$300 billion a year. Two of the sources said the United States, Australia and Britain were also on board.A European Commission spokesperson and an Australian government spokesperson both declined to comment on the negotiations. The U.S. delegation at COP29 and the UK energy ministry did not immediately respond to requests for comment.With no formal update yet of the deal draft from the COP29 presidency, the mood was tense among negotiating groups."There is no clarity on the way forward. There is no clarity on the political will that we need to get out of this," said Panama's lead negotiator, Juan Carlos Monterrey Gomez. Three negotiators described the mood in the room as angry.Sierra Leone's environment minister, Abdulai Jiwoh, declined to comment on the \$300 billion figure, saying: "We're still working on the number with other parties."Marina Silva, Brazil's minister of the environment and climate change, had said on Friday that the Amazon rainforest nation - which is set to host next year's COP30



climate summit - was pushing for \$390 billion annually from developed countries by 2035."We cannot leave Baku without a decision that lives up to the challenge we are facing," she said via a translator. "We need to reach \$300 billion by 2030, then \$390 billion by 2035 so we can achieve this goal."Delegates were awaiting a new draft text of the deal after negotiators worked through the night to bridge wide gaps in their positions. Any deal would require agreement on more than just the headline amount.Negotiators have worked throughout the two-week summit to address other critical questions on the target, including who is asked to contribute and how much of the funding is on a grant basis, rather than provided as loans. The roster of countries required to contribute - about two dozen industrialised countries, including the U.S., European nations and Canada dates back to a list decided during U.N. climate talks in 1992. European governments have demanded others join them in paying in, including China, the world's second-biggest economy, and oil-rich Gulf states. Donald Trump's U.S. presidential election victory this month cast a cloud over the Baku talks. Trump, who takes office in January, has promised to again remove the U.S. from international climate cooperation, so negotiators from other wealthy nations expect that under his administration the world's largest economy will not pay into the climate finance goal.A broader goal of raising \$1.3 trillion in climate finance annually by 2035 - which would include funding from all public and private sources and which economists say matches the sum needed - was included in the draft deal published on Friday.





Cost of borrowing very stressful, banks need to make interest rates affordable: FM



Union Finance Minister Nirmala Sitharaman on Monday said bank interest rates are very stressful for some people, and steps are needed to make them affordable.Amid widespread concerns about a possible slowdown in economic growth, the finance minister assured that the government is fully aware of the domestic and global challenges, and added that there is no need to have "undue concerns".

What is important is when you look at India's growth requirements, and you can have so many different voices coming out and saying the cost of borrowing is really very stressful, and a time when we want industries to ramp up and move (to) building capacities, bank interest rates will have to be far more affordable," Sitharaman said. Speaking at the annual business and economic conclave organised by SBI, the minister also asked banks to concentrate on their core function of giving loans and added that the "misselling" of insurance products also indirectly adds to the cost of borrowing for an entity.

After slow start to capital expenditure in FY25 due to elections, Capex recovery likely in H2FY25, but 40-52% push needed to meet targets

After a slow start to capital expenditure by both states and the Centre during the ongoing financial year 2024-25 that has been primarily attributed to the general elections earlier this year, a pickup in the second half of the fiscal is predicated on an increase in government spending. This expected pickup comes amid concerns over a general moderation in domestic consumption demand and flagging of other growth indicators. While a belated government spending push would be a major impetus to flagging economic momentum, the prospect of getting government spending up to speed could mean a daunting 40-52 per cent increase in government capex during October-March, the second half of the financial year, to come anywhere close to the budget targets

Given the likely contraction of over 10 per cent in the capex in the first half of FY25, states would require an over 40 per cent expansion in capex during the remaining six months to meet their budget targets. As per rating agency ICRA, data for 15 major states shows that the combined revenue receipts, revenue expenditure and capex are required to expand by 30 per cent, 26 per cent and 40 per cent, respectively, in the second half (H2) of FY25, to meet the budgeted target for the fiscal. The flagging pace of capex has also been a concern for the Centre, which has already nudged departments and ministries to speed up the pace of spending in the ongoing quarter as much as possible. The government has nudged the ministries to expedite the pace of capital expenditure to avoid bunching up of capex in the January-March quarter, with the government expected to relax the cash management limits for the last quarter.As per the latest data by Controller General of Accounts, the Centre's capital expenditure during September stood at Rs 1.14 lakh crore, down 2.4 per cent from the year-ago period. Cumulatively, during April-September, the first half of the financial year, capex was down 15.4 per cent year-onyear to Rs 4.15 lakh crore. The second half of the financial year will pose a challenge to the Centre as capex will have to grow by 52 per cent to achieve the FY25 Budget target of Rs 11.11 lakh crore

States are facing a similar challenge to boost their capex. The combined capital spending and net lending of 15 major states declined by 7.5 per cent in H1 FY25 as against a 21 per cent year-on-year expansion pegged in the budget estimates, ICRA said. Amid the compression in capex, the fiscal deficit of the 15 states stood at Rs 3.5

lakh crore in the first half (H1) of FY25, or 42 per cent of the budget estimates."While we expect a pick-up in the growth of the revenue receipts in H2 FY25 led by states' own tax revenues, the required rate of 30 per cent seems challenging, led by various domestic and global factors as well as our assessment of continuing contraction in grants. Additionally, notwithstanding highly back-ended capex in FY25, we expect it to undershoot the levels indicated in FY25 BE (Budget Estimates)," ICRA said. In the first half, revenue receipts for these 15 states have been slower, rising by 7.3 per cent as against the 20 per cent expansion estimated in the BE, led by lower-than-budgeted growth in the states' own tax revenues reflecting moderation in consumer demand amid elevated inflation, elections and climate-related disruptions in economic activity in H1, it said. Investment announcements which are indicative of the investment intentions of the business enterprises in the economy were lower by 29.5 per cent in the first half of FY25 whereas investment projects completed dropped by 53 per cent yearon-year (YoY) in the same period, according to CMIE data. Not only were the investment announcements and completions lower than a year ago period, but they also fell short of the half-yearly (H1) average seen over the last decade. This is mainly because of poor data for Q1 of FY25 due to election related restrictions and uncertainties.Project investment announcements during first half of FY25 till October 2024 were down at Rs 8.9 lakh crore as against Rs 12.6 lakh crore in the first half of FY24 while projects completed were Rs 1.6 lakh crore in the first half FY25 till now as against Rs 3.5 lakh crore in the same period of last year, as per CMIE data. As per CareEdge Ratings, state government capex for 20 major states contracted 10.5 per cent in H1, while aggregate capex by major central public sector enterprises (CPSEs) contracted by 10.8 per cent at Rs 3.4 lakh crore, which is around 43.6 per cent of the annual target."Centre has achieved 37 per cent of its budgeted capex target in H1, while 20 major states, at an aggregate level, have achieved only 28 per cent of their budgeted target. It is crucial to monitor the trajectory of the public capex going forward. Any further slowdown in subsequent quarters could result in a shortfall relative to budget estimates. Hence, the possibility of a downward revision in the capex target remains," CareEdge Ratings said in a note. India Ratings and Research expects states' aggregate capex to increase to 1.4-1.5 per cent of GDP in H2 FY25.

You will not believe how many tiny plastic particles plastic-coated paper cups can release when exposed to tea, coffee for just 15 minutes

Drinking hot beverages like tea or coffee in disposable paper cups is common. However, some people claim that doing so can lead to the ingestion of microplastic particles, which are a health hazard. Recently, in Maharashtra's Buldhana city, its district collector, Dr Kiran Patil, passed a directive to ban paper cups. In a statement, he claimed that paper cups "are the main reason behind the rising cases of cancer." So, we decided to verify from experts.Acknowledging that there's a debate going on regarding the safety of paper cups, especially for those using them daily, Dr Tirathram Kaushik, consultant oncosurgeon, Wockhardt Hospitals Mira Road, said that while paper cups are not directly associated with cancer, the chemicals used in their linings, such as microplastics or perfluoroalkyl substances (PFAS), could cause cancer.Microplastics are minute particles made out of plastics that have embedded themselves in our natural environment. Their interaction with human's biological ecosystem is under scrutiny, said Dr Mridul Malhotra, consultant, medical oncology, Manipal Hospital Dwarka, New Delhi.- Chemical composition contamination: Microplastics may carry and deliver chemicals containing carcinogens to the tissues in the human body.-Inflammation: Microplastics can induce cellular changes that can lead to cancer in the body.- Disrupting the mucus layer: Microplastics can disrupt the mucus layer, particularly of the gastrointestinal tract, and further compromise the protective barriers of the human body. It is also a fact that when any hot beverage is served in a paper cup, some substances may get absorbed into the beverage, raising concerns about prolonged exposure over time, which can impact one's well-being in the long run, asserted Dr Kaushik.



"It's important to note that current research hasn't definitively proven that the occasional use of paper cups causes cancer. There is no evidence available to back up this claim," said Dr Kaushik.Citing an August 2024 study, Dr Malhotra said that exposure to hot liquids in plastic-coated paper cups for just 15 minutes can release approximately 25,000 tiny plastic particles. "Individuals drinking near to three cups of hot beverages in their daily routine may ingest around 75,000 invisible plastic particles," said Dr Malhotra. The pros of paper cups include convenience and lightweight design. "The disadvantages would be that the cups may contain chemicals that can raise environmental concerns from single-use waste. For safer use, opt for paper cups labeled BPA-free and consider using reusable alternatives like ceramic cups to minimise exposure and environmental impact," said Dr Kaushik.According to Dr Malhotra, there are a few precautionary measures to avoid microplastics in food:- Using glass or stainless steel vessels- Avoiding food to be heated in plastic containers- Choosing microwave-safe container-Reducing single-use plastics- Drinking water from filtered sources

I still remember the first time I read the book Parinayavum Mattu Thirakkathakalum, featuring three screenplays — Parinayam, Kadavu and Sadayam — written by MT Vasudevan Nair. I had watched all three films growing up, probably more than once, but reading their texts was a truly defining experience for me. As a teenager, it was then that I realised films are much more than just actors and their performances. Soon, I managed to find a copy of the film Sadayam (1992) and revisited it, keeping the book beside me, soaking in the magical way in which written words transformed into visuals, moving images, and eventually a complete film.

The literary flow of the work, paired with the outstanding characterisations — where each person has sharp and strong arcs — further enriched by vivid imagery and meticulous descriptions, taught the young me, who was already enamoured with movies, valuable lessons on cinema. At the same time, I also couldn't help but marvel at how MT, renowned for his exceptional novels and short stories, wherein one has the space and luxury to delve into inner thoughts and character backgrounds, could craft such remarkable screenplays - where one needs to show more than tell. Well, that was MT Vasudevan Nair; whatever the medium was, if it involved language, he aced it, whether it was written or visual.As much of a doyen of Malayalam literature as he was, MT was also one of the path-breaking figures in the cinematic landscape, redefining the grammar of the medium at a time when it was still largely influenced by the traditions and style of professional drama. By facilitating the marriage between literature and cinema in Malayalam, MT, alongside other legendary authors like Vaikom Mohammed Basheer, Thakazhi Sivasankara Pillai, Uroob, P Kesavadev and Malayattoor Ramakrishnan, ushered in a new era in the industry, defined by stories that evoked humanism and ensured realistic portrayals of the lives, struggles and redemptions of ordinary people.

Born on July 15, 1933, in Kudallur village of Palakkad district, by the time he ventured into cinema, MT had already won the hearts of countless Malayalees through his impactful and poignant short stories and novels, including Naalukettu, Pathiravum Pakalvelichavum, Asuravithu, Manju and Olavum Theeravum, which were instrumental in shaping modern Malayalam literature.Remarkably, MT refused to confine himself to a single style or genre and explored a wide array of themes and narratives. Cinematographer Vincent, Chandrathara Productions' RS Prabhu, Ramu Kariat, K Parameswaran Nair, MT Vasudevan Nair, Adoor Bhasi, film distributor Chandran and K Padmanabhan Nair. Living up to the hype surrounding his arrival, MT made a spectacular entry into cinema with Murappennu, directed by legendary cinematographer-director A Vincent, which became an immediate success, earning widespread acclaim. Centred around the practice of cousin marriage, Murappennu also exposed the arbitrariness of blood relations, emphasising that financial worth often dictates one's place within familial structures. Interestingly, the movie, starring Prem Nazir, Sharada, Madhu, KP Ummer, PJ Antony and Jyothi Lakshmi, also exposed the hollowness of the so-called prestige and the "value of a word" that the savarnas often glorify and wear as a badge of honour, showing how these ideals are, in fact, up for sale. MT's literary mastery and command over the Malayalam language made an instant impression on both filmmakers and audiences alike. Thus, he continued to receive projects one after the other and he delivered exceptional works, with notable titles such as Pakalkkinavu (1966), Iruttinte Athmavu (1967), Nagarame Nandi (1967), Asuravithu (1968), Nizhalaattam (1970), Olavum Theeravum (1970), Mappusakshi (1971), Kuttyedathi (1971), and Vithukal (1971), many of which were based on his own literary works. As much of a doyen of Malayalam literature as he was, MT was also one of the path-breaking figures in the cinematic landscape. MT Vasudevan Nair was born on July 15, 1933, in Kudallur village of Palakkad dis-Both MT's literary works and films delved deeply into the fabric of society and human nature, exposing the grey within too. He also consistently challenged conformist ideologies, distancing himself from the dirt of his time. While many filmmakers often resorted to portraying rape victims as outcasts or even killing such characters off - a trope that persisted until recent years - MT took a radically different approach, asserting that survivors should never carry the burden of shame for crimes committed against them. In Olavum Theeravum, the protagonist Baputty (Madhu) declares without hesitation that his lover Nabeesa (Ushanandini) has not lost even a drop of her dignity or worth due to the rape she faced. Confronting the perpetrator Kunjali (Jose Prakash), he proclaims, "She did not consent to what happened. Not even a small part of her heart agreed to it. Knowing fully well that you violated her, I will marry Nabeesa." For a society that treats women as lesser mortals — let alone survivors of sexual violence — and worships gods who abandon their wives over accusations of promiscuity, this dialogue and Baputty's stance are a powerful, groundbreaking statement.

Two years later, when he made his directorial debut with Nirmalyam (1973), MT broke further away from conventional cinematic and societal norms. He crafted a film that critically examined theism, exposing the futility of blind devotion and questioning the time people spend praying for a better life instead of actively pursuing it. What set MT apart was his ability to weave such strong political commentary into his work without sacrificing its aesthetic value. In one of Indian cinema's most iconic and evocative scenes, Nirmalyam ends with the protagonist, an oracle (PJ Antony), performing a traditional dance before the goddess and in an act of defiance, he spits blood at the deity, condemning the god for ignoring his suffering and ruining his life despite his unwavering devotion.Not just MT but others also received prestigious accolades, including both National and State Film Awards, for their contributions to movies written by him. Remarkably, MT refused to confine himself to a single style or genre and explored a wide array of themes and narratives. Yet, all his works carried his unmistakable signature — authentic, deeply rooted characters, particularly women, whose inner lives were meticulously explored, as evident in films like Kanyakumari (1974), Neelathamara (1979) and Oppol (1981). In the 1980s, MT forged impactful collaborations with filmmakers and actors, partnerships that significantly shaped his career and integrated him deeper into mainstream cinema. During this period, he joined forces with filmmakers IV Sasi and Hariharan, delivering remarkable films such as Uyarangalil (1984), Aalkkoottathil Thaniye (1984), Adiyozhukkukal (1984), Anubandham (1985), Panchagni (1986), Nakhakshathangal (1986) and Abhayam Thedi (1984).

Many of these films featured emerging actors Mammootty and Mohanlal, for whom collaborating with MT proved transformative. One of the hallmarks of MT's scripts was his ability to create opportunities for both actors and technicians to excel. His films were not just about his writing prowess but collaborative efforts where every cast and crew member was given the space to shine. Films like Amrutham Gamaya (1987) and Oru Vadakkan Veeragatha (1989) were pivotal not only in establishing Mammootty and Mohanlal as exceptional actors but also in enhancing the careers of all involved. Not just MT but others also received prestigious accolades, including both National and State Film Awards, for their contributions to movies written by him. While PJ Antony became the first Malayalam actor to win the National Film Award for Best Actor for Nirmalyam, Balan K Nair (Oppol), Mammootty (Oru Vadakkan Veeragatha) and Monisha (Nakhakshathangal) also earned National Awards for their performances in MT's films.MT's cinematic brilliance became even more evident through his partnership with Bharathan. As a painter-turned-director, Bharathan ensured visually stunning storytelling and the director masterfully translated MT's evocative narratives into striking visuals, creating unforgettable cinematic experiences in films like Vaishali (1988) and Thazhvaram (1990). During this time, MT also ventured into new territories, creating folklore-inspired films such as Perumthachan (1990) and Vaishali while also exploring genres he had not previously tackled, as exemplified by the mystery thriller Utharam (1989), considered one of the finest Malayalam films in that genre. In the 1990s, MT shifted his focus to darker and more introspective themes, producing some of Malayalam cinema's most emotionally intense films, including Kadavu (1991), Sadayam and Sukrutham (1994). MT's cinematic brilliance became even more evident through his partnership with Bharathan. MT Vasudevan Nair with Babu Antony, Asokan, Bharathan, Nedumudi Venu, MM Ramachandran, Krishnamurthy and Madhu Ambat on the sets of Vaishali. However, MT's repertoire wasn't limited to political themes or hard-hitting dramas as he also crafted deeply touching films that explored the intricacies of human relationships and the yearning for companionship in movies like Ennu Swantham Janakikutty (1998), Oru Cheru Punchiri (2000) - one of the most genuine love stories in Malayalam cinema - and Theerthadanam (2001).By the 2000s, MT had largely stepped back from cinema, having achieved unparalleled success. His only major original work during this time was Kerala Varma Pazhassi Raja (2009), an epic period drama directed by Hariharan and starring Mammootty. In 2013, MT and Hariharan reunited and revived their shelved 1982 project Evideyo Oru Shathru. The narrative was reworked and filmed anew as Ezhamathe Varavu, featuring Indrajith Sukumaran, Vineeth and Bhavana in key roles.Notably, 2024 also marked the release of Manorathangal, an anthology streaming series comprising nine segments based on MT's short stories. The series served as a heartfelt tribute to the legendary Jnanpith awardee, celebrating his unparalleled contributions to Malayalam literature and cinema. Yes, the passing of MT Vasudevan Nair has created an irreplaceable void in the realms of Malayalam literature and cinema. Yet, it is not a loss, for he departed only after gifting his people, us, every story he had within him, leaving no tale untold or unshared. Thank you, MT, for teaching us that a story sans a soul is no story at all.

Ravi Shastri on Australian batting order: 'I think it's been pretty brittle'

With most of the Australian batsmen struggling in the first three Test matches of the Border-Gavaskar Trophy with the exception of Travis Head, former Indian coach Ravi Shastri had called the Australian batting 'brittle' and believes Indian bowlers will be exploiting that. While Head leads the most runs scored list in this series, only two Australian batsmen including Alex Carey and Steve Smith have crossed the 100-run mark in the series."I think it's been pretty brittle. When you look at this Australian lineup, it's been a long time since l've seen an Australian line-up where the top order is that brittle. India have exploited that and continue to exploit it," Shastri told news.com.au when asked about Australian batting.While Travis Head has hit two centuries and one half-century in the series, the only Australian batsman showing consistency in the series has been wicket-keeper Alex Carey.

None out of Australia's top three in the three Tests so far have crossed the 50-run mark. Openers Usman Khawaja and now-excluded Nathan McSweeney have struggled mostly with the new ball with Marnus Labuschagne too struggling in terms of runs. The trio has a total of 217 runs among themselves in the three Tests so far in the series and Shastri counts youngster Sam Konstas to do the work for Australia. "As far as Konstas goes, I think he's very refreshing. He's got flair, he's got flamboyance. But Test cricket is Test cricket. I think his technique will tighten up and he will be the future for Australia. McSweeney was very unfortunate. I thought he did the hard yards but he's a middle order batsman. I see him travelling to Sri Lanka when the Australian team go there and rebuild his career from there. But I think it's a good move getting Konstas in because you need someone who can take the attack to the Indian team, because the punches were coming from nowhere," said Shastri.

With Indian pacer Jasprit Bumrah leading the wickettakers list in the series with 21 wickets, the spotlight once again will be on Bumrah during the Boxing Day Test at MCG. If India is able to win the series, the feat will also make India just the third touring country to win three consecutive series in Australia with West Indies and South Africa being the other two sides. "India is 1-1 in the series and that man (Bumrah) has almost single-handedly got India into that position. Australia hammers sides when they come here. For India to pull off three on the trot will be something special. But they'll have to play good cricket. I see Australia coming hard in this Test match, especially with the bowlers. It's the batting that'll be the challenge for Australia more than anything else. India have come here to win, they haven't come here to fill in the numbers. Even when I was the coach, our mantra was to play extremely hard, fair and to win, said Shatri. The former coach and now commentator also put his weight behind the opening day of the Boxing Day Fest in determining the rest of the series. "You have to think of a method to beat Australia and not just compete. You've got to plan properly, how to take your 20 wickets. India have done that and been very aggressive. They've been in the face of Australia and give as good as they get. It's been entertaining and feisty stuff. India have their nose ahead. I think the first day of the Boxing Day Test will determine which way the series will go," said Shastri.

Pat Cummins on MCG pitch for Boxing Day Test: 'There's a bit of grass coverage, feels nice and firm'

While the series has seen the pace bowlers dominating the series with spinners only getting six wickets out of the total 93 wickets to fall so far in the series so far, the MCG pitch too is expected to support pace and bounce. Australian skipper Pat Cummins feels the MCG pitch is 'nice and firm'. "The pitch looks really good. (It is) quite consistent to what it has been here for the last few years. (There is a) bit of grass coverage and it feels nice and firm. They've done a great job here for ... probably the last five to six years with their pitches and I suspect (it will be) the same this year. (But we will see) how the heat changes it. We'll get to the ground tomorrow and kind of assess it, but it looks like it is a good wicket," said Cummins while talking with the media.

While the third Test at Brisbane saw constant rains interrupting the match, it also saw temperatures reaching around 35 degrees during the sunny phase. With the ongoing Australian summers seeing occasional rains this month, Melbourne though is expected to see hot weather and Cummins was of the view that heat is one of the factors in the MCG Test. "(We will) look at the pitch and get a bit of a



sense of what the day is going to feel like, and then you kind of make a decision from then. So I think (the heat) is a factor. Last week in Brisbane was hot, which is kind of a bit of a tick. Starcy and I bowled a lot in the heat, and (Nathan) Lyon as well, and got through it fine, so I don't think it scares us too much. But we wait and see. 39 can get pretty hot," said Cummins.

MCG curator Matt Page too had shared his views on the pitch curated for the Boxing Day Test. Page, who has been the curator at the MCG since 2017, shared that the fast bowlers will get excited about the pitch on offer. "All the good bowlers get excited when they come here now. It gets through well for us. We're never going to be as quick as Perth and Brisbane, but over the last few years, we've managed to get some pace in it, which has created that excitement. There's a bit of grass on it. If you're a fast bowler,

Cummins, who had made his debut in South Africa in 2011, remembered days prior to his debut and told Sam Konstas to 'enjoy the moment'."I think you always want to do well (but) I was saying this to Sam (Sam Konstas) the other day, I remember that as an 18-year-old, I was thinking I got a lot more leeway because I was young. It almost felt like if I didn't have a great game, it wasn't my fault. It was the selectors' fault for picking me. I was like, 'Well, they're the idiots who picked an 18-year-old'. You're so young starting out your career (and) it's Boxing Day. It doesn't get any better than this, so just enjoy the moment," Pat Cummins told the media ahead of the Boxing Day Test.

The 19-year-old opener has made his way into the Australian Test squad after the exclusion of Nathan McSweeney. While McSweeney could only manage 72 runs in six innings in the three Tests in the series, Australia's constant struggles at the top led them to call up Sam Konstas. The 19-year-old has so far played in 11 First Class matches in his career amassing 718 runs. Last week, the youngster also became the youngest player to hit a half-century on debut in Big Bash League. Cummins believes that the young opener will have to deal with the call up coming up so early in his career and the team has been backing him up. The pacer had a talk with Sam Konstas and shared how he talked about his early inclusion in the game too in South Africa. "It's pretty awesome. I spent a bit of the time wondering



why or how I was there (because) it happened so quickly. I just remember being really excited and I think, similar to Sammy this week, there's a level of naivety that you just want to go out and play like you do when you're a kid in the backyard. You just want to take the game on and have fun and ... not overthink it. So that's the message of Sam. That's definitely how I felt as an 18-year-old. I was just really excited. And once the kind of game started, you go into game mode and it's just like any other game," Pat Cummins added.Sam Konstas became the youngest player since Ricky Ponting's feat in 1993 to hit two centuries in a Sheffield Shield match when he hit a century against South Australia in a Sheffield Shield match early this year. Cummins too had spent time with Sam Konstas during the domestic oneday Cup, which has been named after late Australian cricketer Dean Jones. "He didn't play, but he was down there, so I spent a bit of time with him (and) he was great. He was guite relaxed and good fun. (He was) happy to ... roll along with the jokes and take the mickey out of himself and others. We will just always encourage him to be himself. But he seems ... like he's got a good head on his shoulders for a 19-year-old, so we're there backing him up," recalled Pat Cummins.

England coach blames Women's Premier League for 'rammed' Ashes schedule

In the space of just three weeks, the England women's team will play three ODIs, three T20s and a four-day Test in Australia. The reason for the 'rammed' schedule, according to England coach Jon Lewis, is the Women's Premier League (WPL) in India.The women's

Ashes begins on January 12 in Sydney and will be played across five Australian cities. The WPL begins on February 21, forcing the authorities to compress England's tour to Australia. Lewis was miffed with the cramped schedule, especially with a four-day gap between the third T20 and the four-day pink-ball Test at the Melbourne Cricket Ground."My preference would be that there's more space between the games, and the players' preference would be as well," Lewis was quoted as saying by The Guardian. "I'm pretty sure we would have requested more space between the white ball [games] and the Test match, but the schedule came back as it was. It won't be straightforward. The schedule is pretty rammed close together. There's no flexibility because of WPL and Christmas."The report added that while the WPL begins on February 21, the players would be needed in India earlier for acclimatisation and media commitments. Six England players who are a part of the Ashes squad will also be competing in the five-team WPL. They include Alice Capsey, Nat Sciver-Brunt, Danni Wyatt-Hodge, Kate Cross, Sophie Ecclestone and Dani Gibson.

Hyderabad's Trisha, Drithi in India's U-19 WC squad

Hyderabad: Hyderabad cricketers G Trisha and Drithi Kesari have been named in the India Under-19 women's cricket team, which will take part in the next year's ICC Under-19 Women's T20 World Cup to be played in Kuala Lumpur, Malaysia from January 18 to February 2.

The Women's Selection Committee of the BCCI announced the squad to be led by Niki Prasad, while Sanika Chalke will be the vice-captain. The squad has two wicketkeepers Kamalini G and Bhavika Ahire, while three standby players, Nandhana S, Ira J and Anadi T, have also been included. The 16 competing teams have been divided into four groups. India are the defending champions, and are placed in Group A alongside hosts Malaysia, West Indies and Sri Lanka. The tournament will be hosted by Bayuemas Oval. India will begin their campaign against West Indies on January 19, followed by matches against Malaysia (January 21) and Sri Lanka (January 23).Following the group phase, which runs from January 19-23, the top three teams from each group will advance to the Super



6 stage — two groups of six –, which will take place from January 25-29. Group 1 in Super 6 will include the top three teams each from Group A and D, while Group 2 will have the top three teams each from Group B and C. The top two sides from the two Super 6 stage groups will qualify for the semifinals, slated for January 31 while the final will be played on February 2.

Pat Cummins was running after his young son, with his pregnant wife all smiles trailing behind them. Marnus Labuschagne scooped his little daughter in his left hand and chatted with his wife to his right. All around them are kids, playing, diving, lying, and laughing at the Melbourne Cricket Ground, bathed in warm sunshine. It's about 9am, Christmas Day, on the eve of the Boxing Day Test and the Australian cricketers are having a family time. "It's absolute chaos," says Cummins with a smile. "On average, two kids per member and everyone running around with presents and hyper!"

In the outdoor nets, where Travis Head would have a stint after his successful fitness test, coach Andrew McDonald was throwing to his spectacled son and the assistant coach Michael Di Venuto was watching his teenage son unfurling gorgeous cover drives - almost as good as the old man's. A glimpse of a flamboyant cover drive on a bent knee, the father's signature shot, would have been the cherry on top; perhaps it shall come next Christmas Day. All around happy laughing faces.MCG has always had that kind of happy association with the outside world, especially the Indian fans. Never mind this generation which hasn't seen India lose a Test here since 2011, or the end 70's when Bhagwat Chandrasekhar sent 12 bewildered Aussies on their way and Sunil Gavaskar hit a hundred to win a Test here. This happy association has been present despite the results, though the good ones certainly have helped. Like Ravi Shastri driving his Audi at the MCG after the triumph at the World Championships in 1985. Even Gavaskar walked off, threatening to take his partner Chetan Chauhan with him, before better sense prevailed from the manager at the G. Though in revisionist history that moment of regret from him has now been turned around by Fox Sports of all people as the moment India began standing up for themselves. They started with that visual in their promo for this current series, the narrator Justin Langer saying 'And it all began here with Sunny'.

But above all for generations of Indians waking up to

old-fashioned specialist alarm clocks to watch the cricket in Australia, MCG was the happy space. It didn't trigger the tremors up the spine as the old hot and spicy WACA could. It wasn't the Gabbatoir where the visiting batsmen used to struggle with seam movement and bounce, and stood no chance. It wasn't the almost subcontinental tracks at Sydney or the flat track of Adelaide where the oldtimers would murmur dismissively about good knocks 'Yeah good, but it was just Adelaide or SCG' as if tons were flooding for Indians overseas, even in those venues.But there was something about MCG, especially once the Boxing Day instant tradition set in from 1980 on. It was still typically Australian pitch, a wholesome Australian venue with 90,000 sunscreened and often intoxicated fans hollering, and where the sun and light bounce off the seats and cast a charming hue to the proceedings – be it day or night.

One of the more famous and familiar photographs, a regular centre spread feature in sports magazines of the past, was of the long shot of MCG from outside, with its light towers on, wrapped in this ethereal orange-ish hue. A perfect poster to fumble with cello tapes and plaster on the bedroom walls as kids. MCG and SCG were the acronyms that Indian kids were aware of pretty early in their lives. And MCG could be further shortened and just called the 'G', and they would still know and recognise it.

Above all, the fans at the stadium: the sheer number of the people boxed in together, the notorious barracking crowd of Bay 13 which has been romanticised and vilified – the romance emerging from it being the personification of the burly surly drunk abusing Aussie fan and the vilification coming from the fact that the posh card-carrying members who get plied with free drinks all day can at times be more obnoxious than paying members of the 13, who are caught in the perception-bubble about them and feed it further.

"One significant factor about this Test is that the Aussie fans can't 'other' the Indians as people from a faraway exotic land," says Dr Thomas Heenan, who teaches Sports Studies at Monash University in Melbourne. "The days of that kind of 'othering' are gone. Not because of the cricket and IPL, that may be more so for the players. For the regular fans, the reason is the large number of Indian population who live in this country, especially more in the bigger cities. They are constantly interacting, working, socialising, partying or observing with the Indian-origin people for a while now. The Indian population has exploded in recent years; the last cricket series was during the pandemic crowd-less affair. This series has been different in that regard and I am interested to see how that plays out on the Boxing Day Test."
